Ex-J&K Bank CMD Parvez Ahmad Arrested Accused Of Tender Fraud In Housekeeping

SRINAGAR: The anti-corruption bureau (ACB) on Saturday arrested former chairman of Jammu and Kashmir Bank, Parvez Ahmad Nengroo in connection with a case of tender fraud in housekeeping.

former Nengroo, Chairman and Managing Director of J&K Bank was arrested for causing a loss of crores to the bank with illegal allotment of tenders for housekeeping to a Mumbai based company SILA, an ACB spokesperson said Saturday. He said that the ex-CMD had not followed proper tendering norms as provided in the contract to the firm despite not falling into the criteria of any such allotment and his arrest was executed in connection with investigation of a case registered by the agency last year.



"Due to not following the proper tendering processes, improper ATM cleaning, undue addition of the management fee and other omissions and commissions detected during the course of investigation, the J&K Bank has suffered losses worth crores of rupees from the date of award of contract," the ACB spokesperson said. Besides this case, he said, charge sheets have also

Six other cartons are being sent to New Delhi for Dr. Singh and Mrs.Gandhi before both leave for Srinagar to inaugurate the historic bus service next week.

The bus service is being seen as one of the most tangible signs of a fledgling peace between the nuclear rivals after decades of enmity. It will travel 170 km on the highway between Srinagar and Muzaffarabad in the Pakistani sector.

Ghulam Rasool, the President of Fruit Growers Association here, said with the opening of the bus service, there it hope it would revive trade links.

"Kashmir is known in, the world for its fruits. So this time we will gift baskets of apple to Pervez Musharraf, Shaukat Aziz and the Indian High Commissioner in Pakistan. When we had a good trade in apples 1947 the wholesale market was in Rawalpindi and we used to send aples to Amritsar, Delhi Karachi etc front there and when we heard about this (the bus service), we decided then itself that we will gin six basket of apples to Pakistan and seven basket of apples for our Prime Minister Manmohan Singh and other leaders which includes Ghulam Nabi Azad and Sonia Gandhi," he said

India had said on Friday it hoped free trade with its nuclear-armed neighbour Pakistan would happen within one to

Iran Says 'No Step-**By-Step Plan' For** Lifting US sanctions

TEHRAN, IRAN: Iran's foreign ministry has said there will be "no step-by-step plan" to lift layers of American sanctions and restore the country's 2015 nuclear deal with world powers.

"The definitive policy of the Islamic Republic of Iran is the lifting of all US sanctions," foreign ministry spokesman Saeed Khatibzadeh told state-run PressTV on Saturday.

He said that includes all sanctions imposed and reimposed by former US President Donald Trump.

Trump in 2018 unilaterally abandoned the nuclear deal, also signed by China, Russia, Germany, France, and the United Kingdom, and imposed harsh economic sanctions that have only escalated since.

The Iranian foreign ministry spokesman's comments come as US State Department deputy spokeswoman Jalina Porter said on Friday the focus of in-person talks in Vienna next week on reviving the nuclear deal would be on "the nuclear steps that Iran would need to take in order to return to compliance".

Iran had previously said it was open to a step-by-step approach, but changed its position after US President Joe Biden refused to lift any sanctions for months, insisting Iran would need to act first to come back into full compliance with all its commitments under the deal.

Supreme Leader Ayatollah Ali Khamenei has since said Iran's "definitive policy" on the nuclear

Foreign Minister Mohammad Javad Zarif also said on Friday there will be no direct or indirect meetings between Iran and the US during the Vienna talks, calling it "unnecessary". He said in a tweet the aim of the talks will be to "rapidly finalise

sanction-lifting and nuclear measures for choreographed removal of all sanctions, followed by Iran ceasing remedial measures". Last week, President Hassan

Rouhani said Iran has seen "no serious efforts" from the US to lift sanctions.

"The Americans are lying that they require time [to lift sanctions]. They can do it in an hour and we will only need a moment. There are a few screws we need to twist and untwist," he said.

7 Deaths In UK From Blood Clots Among Millions Who Got AstraZeneca Shot

LONDON: The UK medical regulator said Saturday that out of 30 people who suffered blood clots after receiving the Oxford-AstraZeneca vaccine, seven have died.

The British acknowledgement of deaths comes as several European countries have paused the use of the AstraZeneca jab over a potential link to blood clots.

The UK's Medicines and Healthcare products Regulatory Agency said in a statement that "Out of the 30 reports up to and including 24 March, sadly 7 have died." The Netherlands on Friday halt-

ed vaccinations with the AstraZeneca jab for people under the age of 60 after five new cases among women, one of whom died

Germany took a similar decision earlier this week.

The European Medicines Agency (EMA), which like the World Health Organization previously declared the AstraZeneca vaccine safe, is expected to announce updated advice on the issue on April 7.

The EMA said again on Wednes day it believes the vaccine is safe and that experts have found no specific risk factors such as age, gender or medical history. The UK regulator said that the

Job Loss A Concern For 40% Workers Worldwide: WEF Report

GENEVA: Close to 40 per cent of workers worldwide think their job could disappear in five years, six in 10 are worried that machines would take over their jobs, and by 2025 humans and machines are predicted to spend equal amounts of time at work, according to a report published by the World Economic Forum (WEF).

Based on a survey of 32,000 workers conducted by consulting giant PwC in 19 countries, Xinhua news agency quoted the report as saying on Thursday that half of the respondents were optimistic about their future.

The survey also highlighted that 60 per cent of the respondents were worried about the effects of automation and 56 per cent

thought that fewer people would obtain long-term employment in the future.

This prompted 61 per cent of the people surveyed, most of them young, to agree that governments should protect jobs.

The survey also found that 40 per cent of workers used the Covid-19 lockdown last year to hone their digital skills, and that 77 per cent were ready to learn new skills or to retrain.

Furthermore, 80 per cent were confident in their ability to adapt to new technologies.

According to a previous WEF report, 85 million jobs may be at risk of disappearance due to the growing reliance on machines and artificial intelligence (AI), but 97 million new jobs might emerge in such a scenario.

Myanmar Protesters Defy Crackdown, Five Killed; **Junta Hunts Critics**

yanmar security forces opened fire on pro-de-Lmocracy protests on Saturday killing at least five people, a protester and media said, as the military reinforced its bid to end dissent with arrest warrants for online critics and internet blocks.

Despite the killing of more than 550 people by the security forces since the Feb. 1 coup, protesters are coming out every day, often in smaller groups in smaller towns. to voice opposition to the reimposition of military rule.

Security forces in the central town of Monywa, which has seen big protests day after days for weeks, fired on a crowd killing at least four people and wounding several, two media organisations said.

"They started firing non-stop with both stun grenade and live rounds," the protester in Monywa, who declined to be identified, told

"People are still protesting every day because we believe strongly that this is a fight between good and evil," protest leader Tayzar San said in an audio message to Reuters.

The authorities are also waging a campaign to control information. They had shut down mobile data and on Friday ordered internet providers to cut wireless broadband, depriving most customers of access, though some messages and pictures were still being posted and shared on social media.

Authorities issued warrants for 18 celebrities, including social media influencers and two journalists, under a law against material intended to cause a member of the armed forces to mutiny or disregard their duty, state media reported late on Friday. The charge can carry a prison term of three years.

Actress Paing Phyoe Thu, regularly attended rallies in the main city of Yangon in the weeks after the coup, said she would not be cowed "Whether a warrant has been issued or not, as long as I'm alive I'll oppose the military dictatorship who are bullying and killing people. The revolution must prevail," she said on Facebook. Her whereabouts were not immediately known.

WASHINGTON: A police officer was killed after a person rammed his vehicle into barriers surrounding the US Capitol complex, according to authorities. The driver, identified as Noah Green, a 25-year-old man from Indiana, was shot by police at the scene on Friday afternoon and died in hospital, reports Xinhua news agency.

Green is a Nation of Islam follower, according to MSNBC, citing Facebook content that was thought to be posted by him.

The authorities have not yet specified a motive.

The slain police officer was identified by Capitol Police as 18-year veteran William "Billy" Evans.

"It is with profound sadness that I share the news of the passing of Officer William 'Billy' Evans this afternoon from injuries he sustained following an attack at the North Barricade by a lone assailant," acting Capitol Police Chief Yogananda Pittman said at a news conference.

"This has been an extremely difficult time for US Capitol Police," Pit-



tman said, noting the attack underscores that the Capitol Hill remains a potential target for violence.

After ramming his car into the barricade, the suspect exited the vehicle with a knife, started lunging at and was killed by the police, he said.

"The suspect entered what we refer to as the north barricade of the Capitol. The suspect rammed his car

into two of our officers and then hit the north barricade barrier. "At such time the suspect exited

the vehicle with a knife in hand. Our officers then engaged that suspect. He did not respond to verbal commands," Pittman added.

The attack occurred about 91 metres from the entrance of the building on the Senate side of the Capitol.

Immediately after the attack the complex was placed under a lockdown. It was lifted two hours later.

White House Press Secretary Jen Psaki told reporters that President Joe Biden, who landed at Camp David on Friday afternoon to spend the Easter weekend, is "aware" of the Capitol incident.

House Speaker Nancy Pelosi or-

dered the flags at the Capitol to be flown at half-staff to mourn the death of the police officer.

Following the attack, there was a heavy police response outside of the Capitol, including a helicopter landing on the premises.

Washington Field Office of the Federal Bureau of Investigation said it also provided support to the Capitol Police. The D.C. National Guard also deployed an Immediate Response Force to the complex to support the Capitol Police.

It was the second line-of-duty death in the Capitol Police this year.

Capitol Police officer, Brian D. Sicknick, died a day after the January 6 riot staged by supporters of former President Donald Trump.

He passed away "due to injuries sustained while on-duty".

Two other Capitol Police officers have died by suicide in the wake of the riot. Barbed wire fencing has been set up around the Capitol complex since the riot.

Several thousands of the National Guard troops still remain in Washington, D.C. over security concerns.

The Assistance Association for Political Prisoners activist group, in a statement earlier in the day, said the security forces had killed 550 people, 46 of them children, since the military overthrew an elected government led by Aung San Suu Kyi. The demonstrations that drew

tens of thousands of people in the early days of defiance in big cities have become more rare with opponents of the coup adopting "guerrilla rallies" - small, quick shows of defiance before security forces can respond

SILENCING THE VOICES? State broadcaster MRTV announced the warrants for the 18 with screenshots and links to their Facebook profiles.

While the military has banned platforms like Facebook, it has continued to use social media to track critics and promote its message.

The United States condemned the internet shutdown.

"We hope this won't silence the voices of the people," a State Department spokeswoman, Jalina Porter, told a briefing.

The United States and other Western countries have denounced the coup and called for the release of Suu Kyi, who won the Nobel Peace Prize in 1991 for her campaign against military rule. She has been charged with violating an official secrets act that is punishable by up to 14 years in prison.

Russian Doctors Complete Open-Heart Surgery As Tsarist-Era Hospital Burns

ussian doctors stayed behind in a burning, tsarist-era hospital in the country's Far East on Friday to complete open-heart surgery after a fire broke out on the roof while they were operating.

Firefighters who took more than two hours to put out the blaze in the city of Blagoveshchensk said they used fans to keep smoke out of the operating room and ran in a power cable to keep it supplied with electricity.

A group of eight doctors and nurses completed the operation in two hours before removing the patient to another site, the emergencies ministry said.

"There's nothing else we could



do. We had to save the person. We did everything at the highest level," surgeon Valentin Filatov was quoted as saying by REN TV.

He said it had been a heart bypass operation. The ministry said 128 people were immediately evac-

uated from the hospital as the fire broke out on the roof. "The clinic was built more than

a century ago, in 1907, and the fire spread like lightning through the wooden ceilings of the roof," the ministry said.

SpaceX Rocket Debris Lands On Man's Farm In US

SAN FRANCISCO: In a bizarre incident, a farm owner in the US was left in shock when a pressure vessel from a SpaceX Falcon 9 rocket fell on his property in Washington state, leaving a "4-inch dent in the soil".

In a normal course, most second stage parts either hang out in orbit for years or re-enter Earth over the ocean. The debris was identified as Composite-Overwrapped Pressure Vessel (COPV) from the break-up of a Falcon 9 second stage over Oregon and Washington state on March 26, reports The Verge, quoting local officials.

The stage re-entered the atmosphere in an unusual spot in the sky after sending a payload of SpaceX's Starlink satellites to orbit.



The farm owner in Grant County, Washington state, found the pressure vessel and reported it to the Grant County Sheriff's Office. "Neither the property owner

nor our sergeant is rocket scientist, of course, but judging from what had happened a few days prior, it looked to them like it was possibly debris from the Falcon 9 reen-

try," Grant County Sheriff's Office spokesperson Kyle Foreman was quoted as saying in the report.

A sergeant then called Elon Musk-run SpaceX, which confirmed the remnant of the rocket belonged to the company and dispatched its workers to retrieve the debris.

"Of course, we didn't have a protocol for this, so we just erred on the side of returning someone's property to them," Foreman said.

The COPV is a part of the Falcon 9's second stage, the smaller section of the rocket that detaches from the main stage at the edge of space and boosts satellites farther from Earth

It stores helium at pressures of nearly 6,000psi, which is used to pressurise the second stage's large tanks of propellant.

SRINAGAR: Even as the PDP faces crisis of sorts, the party is learnt to be grooming younger faces to create an alternative leadership and fill the vacuum created by the recent exodus of top members. Sources said, that Peoples Democratic Party (PDP) president Mehbooba Mufti is revamping the party's organisational structure by bringing wholesome change.

The party is set to put up new faces in many constituencies and is considered imperative after Centre stripped the former state of its special status and downgraded it into two Union Territories. By bringing political debutants, they said, the party wants to tap "democratic space which is still intact."

Youth remains the driving force and the party has felt that there was lack or inadequacy in the particular space, they said. Political veterans keep calling for millennial to join their political parties in public events but a very few young names are registered.

Even if the young guns do join politics, the chances of them representing their party in Assembly or parliament are low due to the presence of "more experienced" candidates waiting in line for the ticket, and those who do, are either carrying some kind of legacy or coming from an influential background, they said. Nonetheless, it is their potential and attitude that makes a difference to public approach towards them.

In the last several years, world over many dynamic youngsters have become the "voice of the nation" by addressing sensitive issues, the sources said. PDP is going to take credit to put more new young faces for future politics including few from political family back ground, the sources said.

The new faces are expected from many constituencies including Kulgam, Shopian, Barmulla, Sangrama, Kupwara, Ganderbal, Rafi abad and Uri etc, they added.

A PDP leader who wished not to be named said that "these new faces in PDP can bring change and strengthen the party and have potential to become leaders to end dynastic politics of Kashmir," the leader said, adding, "Since 1947, high-profile families brought their children into politics." (GNS)

ZEPO Purportedly Calls Bearded Muslim Teacher 'Biggest Militant' In Poonch, Explanation Sought

SRINAGAR: A senior officer of Education department in Surankote area of Poonch has purportedly called a bearded Muslim teacher the "biggest militant" and allegedly desecrated the mosque in the vicinity of the school on her visit to the institution.

Sub-District Magistrate Surankote has sought an explanation from the officer for her unwarranted behaviour.

According to the letter the incident took place at Yaseen Public School, Dundhak Khanikhodi on April 1.

"This man is the biggest militant. Just look at his face...," Kumari who is Zonal Education Planning Officer (ZEPO) is seen yelling in the video.

A local Imam of a mosque Farooq Ahmad Misbahi in his address to the media alleged that Kumari besides calling Faroog a militant, she had desecrated the Madrassa and two mosques in the vicinity of the school by going inside wearing shoes.

"If wearing a beard makes you a militant, then even the PM (Narendra Modi) won't escape," Misbahi said

Saying that all the communities in Poonch district are living with communal harmony, Imam urged DC Poonch and SSP Poonch for strict action against Kumari besides her immediate transfer. Misbahi said that Kumari is known for her rude behavior in the area.

According to a letter issued by SDM Surankote, Saleem Ahmad, ZEPO has been asked to submit her explanation within two days.

"A video is viral on social media in which you are seen using derogatory language during [a] visit of [the] Yaseen Public School, Dundhak (Khanikhodi) on April 1," reads the explanation letter.



"A deliberate and malicious act, intended to outrage religious feelings of any class by insulting its religious beliefs is not expected from a government officer/ public servant," the letter reads, adding, "You are seen uttering, using words, etc., with deliberate intent to wound the feelings of a particular person."

It said that Kumari's action "has caused public mischief and enmity, hatred and ill-will in the public at large."

"It is also viral on social media that during your visit to Yaseen Public School, Dundhak (Khanikhodi) on 01/04/2021, you also entered the Mosque without removing your shoes."

The SDM's letter says that the ZEPO also "forced the Head of Institution to open a specific room of school whose keys were lying at Poonch at the headquarters of the School". The letter further alleged that Kumari

was not wearing a face mask and violat ed COVID-19 SOPs

It said that the ZEPO "harassed the school management on the pretext of inspection and used very harsh and derogatory language against a particular person of school management which has caused hatred and unrest in the society.' The SDM asked the ZEPO to explain her

position within two days "as to why disciplinary action may not be recommended against you to the competent authority." In case of non-receipt of reply within

two days, the SDM said that it shall be presumed that she has nothing to say in her defence and "action under rule shall be recommended to the competent authority." (KNS)

Thiago Silva Sent Off As Chelsea Slumps To A 5-2 Defeat Against West Brom Agencies

LONDON: Struggling West Bromwich Albion caused a big Premier League shock on Saturday by winning 5-2 at fourth-place Chelsea after the home team had Thiago Silva sent off in the first half at Stamford Bridge.

The experienced Brazilian defender Silva was back in the side, following an injury absence, for the first time in 10 matches, but was shown the red card in the 29th minute following two bookings. Christian Pulisic had put Chelsea in front two minutes earlier, only to see Matheus Pereira strike twice in two minutes in first-half stoppage time to give second-bottom West Bromwich, which almost needs a miracle to avoid relegation, a 2-1 lead at the interval. Callum Robinson grabbed a third goal for West Bromwich when he swept home a cross from Darnell Furlong in the 63rd minute.

Mason Mount tapped in from close range after good work by Timo Werner to give Champions League quarter-finalist Chelsea hope. But Mbaye Diagne drilled in a low shot to put West Bromwich 4-2 up and Robinson clipped the ball over goalkeeper Edouard Mendy to complete a surprise scoreline in the closing stages.

Two Hr Sec Schools Closed In North Kashmir After **Students, Staff Members Test COVID-19 Positive**

BARAMULLA: The authorities on Saturday ordered closure of two Government Girls Higher Secondary School in Sumal and Sopore area of North Kashmir districts after some students and staff members were tested positive for COVID-19.

An official told the news agency-Kashmir News Observer (KNO), that the two students were tested positive for COVID-19 at Government Girls Higher Secondary School Sumbal after which the decision to close the school has been taken by the administration. The official said that concerned schools shall remain closed for the next five days from today while the duo infected students will remain in quarantine as per the standard operating procedure.

Similarly, the four staff members were tested positive for CO-VID-19 at Government Girls Higher Secondary School Sopore in Baramulla district following which it was closed for one week.

The official said that the concerned school shall remain closed for one week from today.

An order issued by Additional Deputy Commissioner Sopore in this regard, reads that in view of reported COVID-19 positivity of four staff members in Girls Higher Secondary School Sopore and to pre-emt further spread of the virus, the institution will remain closed for a period of seven days w.e.f 03/04/2021.

The order has been issued under the ambit of Disaster Management Act, it added. Currently, COVID-19 cases are increasing for the last one week in educational institutions. In view of this, the authorities in many districts have started closing schools as a precaution. According to an official, the ongoing surge of CO-VID-19 positive cases has prompted health officials to ask school authorities in Kashmir to keep extra vigil and strictly implement the coronavirus protocol.

Naib Tehsildar Held With Rs 30,000 Bribe



SRINAGAR: The Anti Corruption Bureau (ACB) on Saturday arrested a revenue department official from Tangmarg area of Baramulla district for demanding and accepting bribe. Naib Tehsildar, Bashir Ahmad Hajam was caught red-handed by the personnel of the antigraft body while accepting a bribe of Rs 30,000, an ACB spokesperson said Saturday. The ACB, he said, had laid a trap for the corrupt revenue official after receiving a complaint alleging that he was demanding a bribe of Rs 30,000 for issuing revenue extracts to the complainant whose mother had sold six kanals of land from a 12 kanal patch at Chandil, Tangmarg, Baramulla.

On the receipt of the complaint, the ACB spokesperson said that a case FIR No. 05 u/s 7 of Prevention of Corruption Act, 1988 was registered in Police Station ACB North Kashmir.

"Subsequently, a trap was laid and the accused was caught red handed while demanding and accepting bribe Rs. 30,000 from the complainant. The accused was arrested and taken in custody by ACB," he added.

This province is located in the northwestern part of China. It was previously known as East Turkistan and was a Muslim majority region when Mao Zedong invaded it in 1949. The Uighur constituted about 76% of the population of this region, a recent survey shows their population has dwindled to 42%. Uyghur's, who are part European and part Central Asian have a distinct culture, language, and cuisine.

According to the Australian Strategic Policy institute, about 82 Global brands including Apple, Nike,H&M, GAP, Adidas, Coca-Cola, and Tommy Hilfiger use raw materials from the Xinjiang province. About 87% of China's cotton comes from Xinjiang province.

The allegations of forced labour and human rights violations in the Xinjiang province by the Uyghur diaspora and human rights activists prompted the US Congress to pass the "Uighur Forced Labour Prevention Act", this act banned the products made in Xinjiang and asked these companies to disclose information related to Xinjiang. This act pressurised the global brands to seek transparency about the supply chains. The communist party and its

mouthpiece Global Times have dismissed the allegations and termed it as a smear campaign against China. Several Chinese actors have terminated their partnership with these International brands as a mark of protest.

However, Uyghur's demands to seek independence have been similarly dismissed and crushed by China. China Is brutally assaulting basic human rights. This community is being dehumanised

 to an unimaginable extent especially for their religion — Islam, which is framed as a "mental illness".
 leaving no stone unturned to force assimilate this region with China. York Times has described Xinjiar

The same old trope of Islamophobia is used against them where they're deemed to be radicalised. This prejudice and pretext is then used against them. They are subjected to mass surveillance, forced sterilisation, and detention on the pretext of tackling terrorism.

The abuse doesn't stop there. China is attempting to erase Uyghur identity by adopting settler colonial policies that enable the Chinese Han community to settle in the Xinjiang province and establish their businesses therw. The Han community now constitutes 40% of the region's population. Xinjiang is an asset to China as it provides a major chunk of its fossil fuels and raw materials, it is also of strategic importance to China's Belt and Road Initiative, this is why it is leaving no stone unturned to forcefully assimilate this region with China. New York Times has described Xinjiang as a 'virtual cage and an incubator for increasingly intrusive policing systems'.

Only a handful of leaders have spoken against China's treatment of the Uyghur's. Trump's administration called it a genocide and a systemic attempt to destroy Uighur's by the Chinese party-state. Other western leaders like Boris Johnson and Justin Trudeau have denounced China but refrained from calling it genocide.

Despite the criticism from International organisations and western leaders, the atrocities committed against Uyghur's are unabated. What is more appalling is the nonchalance of the Muslim nations who otherwise claim to be the spokespersons and torchbearers of Islam.

In fact, in October 2020, 39 coun-

tries issued a joint statement censuring China for the Uyghur genocide, these attempts to penalise China were rendered futile by 45 other countries which include several Muslim majority nations like Saudi Arabia, Iran, Turkey, Morocco, UAE, and Palestinian Authority. These countries backed China, refuted the allegations of human rights violations, and defended China's actions as necessary to thwart terrorism and tackle religious extremism in the country.

The tacit approval of China's genocide by the Muslim world can be explained on account of their economic dependence on China. These countries are indebted to China and benefit from its Belt and Road Initiative.

Even International organisations like UNHCR are incapable of indicting China as it occupies a powerful position in the UN — it is a permanent member of the UNSC and that gives it immense powers to veto any sanction imposed on it.

In this schema, only International retailers are powerful and capable to some extent to reprimand China. Their decision to impose a ban on imports from China will cause some disruption in their supply chains and the angst of Chinese citizens will prove costly as China is a major market for these brands. But the losses China will suffer are much greater. It is the bigger loser here as it will lose out on Foreign Direct Investments which has been the backbone of Chinese economic boom.

o the great Indian tamasha (festival) of democracy has begun once again, as the electorate exercise their right to choose their leaders in a number of states for the next five years. Festoons, caricatures, slogans, posters — and as technology progresses — memes, photoshopped pictures, gifs are filling our everyday lives as the states go to the polls.

While there are a number of contenders in the fray for the political rewards that follow the elections, one common theme is apparent across all the states — the virtual disappearance of India's Grand Old Party — the Indian National Congress — from a position of being a serious player on its own merit in any state.

When India gained independence from Britain seven decades ago, the Father of the Nation Mahatma Gandhi suggested that the Congress — which was the main political party dominating the country at the time — be disbanded and turn into a social organisation for charitable activities.

Like many of his suggestions, the political leaders of the day chose to ignore this advice. Now, it seems that the Mahatma's advice would have at least helped to save the party from the humiliating situation it faces across the country today.

Let us take the states one by one.

Reduced to a bystander

In West Bengal, the Congress, out of power since 1977, has been reduced to a basic bystander in the polls. Its mantle of principal opposition has also now been taken over by the Bharatiya Janata Party, which is throwing everything it has in the ring to wrest the state from the incumbent Trinamul Congress.

The Congress has reached such a situation that it has been forced to join hands with the Left Front — also a power-that-was — to gain some semblance of respectability in garnering a few seats.

Looking further east, to Assam, the BJP is the incumbent party in power, teaming up with the Asom Gana Parishad. The Congress, again once the dominant party, was reduced to just 26 seats in the 2016 polls.

One major handicap for the party will be the absence of Tarun Gogoi, its longest-serving chief minister, who passed away last year. The Congress has joined

Has the Congress Still Got It?

a 'Mahajot' — a term to denote a motley group of opportunistic regional parties to prevent the split in opposition votes.

Moving south, in Tamil Nadu, the Congress has been out of power for almost five decades — since 1967. Allied with the DMK, one of the two principal Dravidian parties in the state, it serves the function of a poor cousin, too timid to upset the balance to ensure it gets some seats during the federal parliamentary elections.

In fact, local media reports suggest that the party is in such a state that it does not even have the manpower to place agents across all the polling booths.

Advantage down South?

Kerala, Congress' heir apparent Rahul Gandhi's home constituency, is the only place where the party has a modicum of respectability. The party leads the United Democratic Front, and has alternately held power at the state along with the Left Democratic Front, led by the CPI (M), which is, ironically, and stinking of opportunistic politics, its ally in West Bengal.

power. If that happens, it will be another nail in the Indian GOP's coffin.

Let us take a peek through the pages of history to understand how this situation has come to pass.

During the initial days of the Congress, it was, as the name suggests, a congress — a group of different people with different points of view, with the broader aim of achieving more rights for the natives from the British Empire. There were several people, including prominent leaders, who had their own separate units while remaining members of the Congress. As the independence movement gained momentum, these groups merged into the party, providing the groundswell of support that finally broke the shackles and freed the country from colonial rule.

In the initial period after independence, as it has been observed in other newly-liberated countries as well, the Congress held sway across the country due to the virtual absence of any other political force, barring the Left in some pockets.

At this juncture, the large landowning classes, who were prominent members of the party, provided the backbone of its vote bank. The party consciously allied itself to the dominant castes across the region to ensure success in the polls.

As the country matured politically, these alliances started shifting too. Regional forces, who felt that their issues and problems were not being given due consideration by the federal powers, began to drift away from the Congress.

These parties gradually started gaining prominence, culminating in the first electoral setback of the party in 1967 when the United Front was set up. Atul Kohli's Crisis of Governability, published in 1991, gives us a detailed account of the power shift that was taking place during this period.

A new era of coalition politics began in the country, as the opposition, while gaining prominence, remained fragmented. This culminated in the successive elections and minority governments at the Centre during the 1990s.

As a result of the rise of these regional forces, coupled with the explosion of caste-based politics for which the Congress was itself to blame as it aligned with the dominant castes in the early 1950s, India's GOP, since then, entered into a steady stage of perennial decline, a trend that continues to this day.

The alternatives?

To top this all, of course, is the obsession of the old guard in the party that no one except the 'first family' of the party, the Nehru-Gandhi dynasty, can lead it forward. The so-called Group of 23, the senior dissident voices who are calling for change, have remained unheard till now.

This obsession has already cost the party a host of young leaders in the states, who could have been its future faces. But even those losses do not seems to bother those at the helm.

So, what next?

The first issue that the Congress needs to do, if it is serious about being a serious contender for political power in the country and not just somehow form alliances to cobble a few seats here and there, is to reinstate the system of internal elections, free from the nepotism and sycophancy that marks the selection of party officials. This will ensure that the various voices are heard within the party to take it forward.

Next, the Congress will have to seek to create a voter base from scratch, without having to resort to factional and caste politics. This is obviously going to be a long-term project, but can yield results if done properly.

There would still be large number of Indians, in general, who would wish to shun the current trend of divisive politics and give a chance to the politics of inclusion once again.

Also, since the caste-ridden politics of several states are already dominated by regional players, there is not much hope that this form of voters would switch allegiances back to the party they shunned once already.

The Congress once already played this game and lost, when it projected Rahul Gandhi as a 'janaudhari' (one who wears the sacred thread — the symbol of a high-caste Hindu) before the 2019 federal elections.

Thus a new inclusive agenda, bereft of caste, creed and religion, can be the Congress' saviour, if it is scripted and executed well.

But does the Congress have the fire in its belly to go for such a project? Or will it go belly up again? Time will tell.

FAQ: Should You Get an Antibody Test After COVID Vaccination?

What will this test tell you? How will it help? Here's all you need to know.

n essential tool to prevent the spread of coronavirus is to 'test, test, test.' According to experts, it's essential to test extensively to understand the spread of the disease among the population. New variants of SARS-CoV-2 and COVID-19 vaccines have increased the curiosity around testing for antibodies.

This curiosity around whether we already have COVID-19 antibodies, or to know if the the vaccine is effective, has led to an increase in antibody testing. In some cases, elderly patients are being advised to test for antibodies by doctors before taking the second dose.

So, should you get an antibody test done after you take your vaccine jab? What will this test tell you? How will it help?

FIT speaks with Dr Shahid Jameel, virologist and director, Trivedi School of Biosciences, Ashoka University to understand.

What does an antibody test tell you?

Antibody tests or serological (serum related) tests are done by taking a blood sample.

When infected, our immune system produces antibodies to neutralise the virus in the body. These antibodies remain present in the body for some time even after the virus infection is completely eradicated. This helps doctors identify whether the patient was infected earlier.

A similar reaction occurs in the body after taking the vaccine.

"Whether we have got the disease or not, if our antibody test is positive, then we get to know whether we have come in contact with the virus or not. Our body produces antibodies in response to exposure to the virus," said Dr Shahid Jameel.

Is it necessary to have antibodies after taking the vaccine?

Antibodies are usually prepared in large quantities after taking the vaccine, and after taking the complete dose, you get protection from the disease. It is to be noted that these antibodies will protect against disease and not from infection.

There is a misconception among people that af-



ter taking the vaccine, if specific amount of antibodies are not produced, then they'll not be protected from the infection. Dr Jameel says, it's rare for antibodies to not be formed after vaccination, but it's known to happen and can be attributed to some genetic abnormalities.

In an earlier story on FIT, we had explained that there is a threshold of an antibody test.

"Antibodies in the blood are measured in the International Unit (IU). Its range is from 0 to 1,000. Usually 10 IU per ml is considered a cut off. Levels between 10 and 1000 are considered protective. However, it may not always be correlated. People with count below 10 can also avoid the disease through cell immunity which is not measured by antibody test."

The average count comes from 300 to 1,000 after the second shot of the vaccine.

Does a higher count indicate more protection?

Dr Jameel says that whether the count is 100 or 1,000, the vaccine provides equal protection. However, according to the science of vaccinology, for the best response, we should take the booster dose or the second dose of the vaccine when the antibody level comes close to the baseline.

"For the best immune response, it is advised to allow the antibody to drop after reaching the threshold level 10. The second booster dose is then most effective. Although this applies equally to all people, it is not necessary. Antibody tests are mostly performed commercially in large pathology labs. But in the private domain, its cost is almost double the cost of the vaccine," he adds.

However, Dr Jameel also says that it is not feasible for common people to have their antibody level checked repeatedly after infection, or after taking the first dose of the vaccine and wait for the antibody levels to drop, before deciding to take the second dose. This cannot be recommended at population level.

Can an antibody test indicate the efficacy of a vaccine?

No, vaccine efficacy can only be tested in a proper placebo-controlled clinical trial. No antibody test can measure vaccine efficacy.

What's the difference between a sero survey and an

antibody test?

Dr Jameel explains, "For example, we conduct a sero survey in some area and we find that antibodies were found in 57 percent of the population there. This does not mean that 57 percent of the people have had the disease, some may have only been exposed to the virus."

Antibody test, on the other hand, consists of qualitative and quantitative tests. The qualitative result indicates whether there has been an exposure to the virus or not. A quantitative test, which is called an ELISA test, tells us if we have developed antibodies and to what extent.

Confused with all this information? Don't be.

Dr Jameel explains, "Viruses have two different types of proteins – spike protein (S Protein) and nucleocapsid protein (N Protein). The S protein is on the surface of the virus and the N protein is found inside the virus. Most vaccines against coronaviruses are based on the S protein. Covishield, the vaccine used in India, is based on the S protein and this vaccine will produce S antibodies. Covaxin, on the other hand, is a whole virus vaccine, so it will produce both S and N antibodies."

But this does not mean that a vaccine that produces both S and N antibodies will offer more protection.

Antibodies neutralise the virus by binding to the surface of the virus. Since the N protein is not present on the surface of the virus, it will not be able to neutralise it.

In addition, there are neutralising antibodies that prevent the virus from binding to the cell. These are a part of the S antibody. Suppose you have 100 molecules of S antibody in the body, then there will be 10 neutralising antibodies in them.

Therefore, it makes little sense to obsess over antibody count and let it impact your decision to get vaccinated. Especially, amidst increasing COVID cases, it is important that the elderly, who are more vulnerable, take the complete dose and don't avoid it. It's important that we get protection as soon as possible, and that will happen only after you've got your two doses.

The Story of Biryani is rich and royal. Here's a glimpse - and a recipe

umtaz Mahal, the legendary wife of Shah Jahan, was a creative person and truly left her mark on history. Among her many interests, she was an accomplished pook and as legend has it she invented biryani

The story of biryani is rich and royal, and here's a glimpse.

Recent history of biryani dating to the 18th and 19th century tells us many a stories as to how the rice dish gained popularity far and wide in the region.

The story of biryani from the Mughal kitchen to the 21st century and how it gained popularity far and wide in the region

Lucknow was called Awadh and, since the Mughals were ruling at the time, the royal palace introduced the subcontinent to the Awadhi Biryani. And we can thank Wajid Ali Shah, the Nawab of Awadh, for adding the rustic potato to this culinary gem.

The spud is a fabulous addition to the rice dish; it adds texture and a delicious complementary flavour to the meat and rice. Can you imagine, if Wajid Shah had not come up with the potato epiphany, how boring this particular variation of biryani would be?

Despite all the different twists to the dish, such as the Sindhi Biryani with potatoes, the Memoni Biryani with tez masala, the Kachay Gosht ki Biryani that is cooked in garam masala spices without tomatoes and the Bohri Biryani, popular in Karachi and Bombay, it is actually Lucknow that lays the ultimate claim to it.

Biryani is a celebratory dish in more ways than one; it is cooked at a time of celebration, and when it is cooked it is time to celebrate. Where the variety of pulao dishes are known for their aroma, the different kinds of biryani platters are known for their spices, masala and unique fiery flavour.

Having lived in Karachi all my life, I know the taste of a deliciously spicy Sindhi Biryani and can also distinguish between most styles of biryani. The cooking style is somewhat different from other regional biryanis and there is no use of rose or kewra water, as is common in most Mughlai dishes.

However, the Awadhi Dum Biryani must wear the crown out of the many dozen varieties out there on the desi platter. It was only during Shuja-ud-Daula's, and his successor Asaf-ud-Daula's, reign in the 1750s that Awadh's dastarkhwan was overwhelmed with culinary delights and money was being spent voraciously in lieu of sublime grandeur in culinary delights.

The royal paraphernalia included half-a-dozen kitchens, where hundreds of chefs drained the royal exchequer preparing hundreds of meals. Thus emerged the Awadhi variety of biryani from long experiments of experienced chefs.

We may rightfully conclude here that, while the Nawabs drained the treasury in lieu of extravagance while playing chess, of course, the Europeans aimed at, and were successful in taking over the subcontinent. And a century later, when Wajid Ali Shah, sacked from his throne, was sent to Calcutta by the



imperialists, his entourage brought the Awadhi Biryani to the city of palaces.

The Calcutta Biryani's defining mark is the invariable chunk of a large potato. There is really no documented evidence, but it is assumed that with rising expenses, over generations, meat was reduced and potatoes added.

A true biryani lover today would rightfully complain if a plate of Kolkata Biryani, like the Sindhi Biryani, was served without the potato chunk.

Biryani reached Hyderabad Deccan with Aurangzeb's southern aspirations. He had left behind Nizam-ul-Mulk as his representative in the Ara Kadu area. It is said that the Nizam's chefs developed 47 varieties of biryani, and among them is the famed tahiri.

We can safely assume here that the meatless biryani may be a result of forced austerity. However, today I share a sublime biryani fare, one that is bound to leave a mark. Here it is, from my kitchen to yours.

Kachay Gohst Ki Biryani Ingredients

3 to 4 lbs. mutton (leg meat) 3 mugs basmati rice 6 oz. to 10 oz. oil 3 to 4 large onions, sliced 4 teaspoons freshly chopped garlic and garlic Salt to taste Red chilli powder to taste 10 green cardamoms ½ to ¾ teaspoon, peppercorns ½ to ¾ teaspoon, cloves 2 to 4 cinnamon sticks 5 black cardamom pods

- 16 oz to 20oz yogurt 6 to 8 green chillies ½ bunch coriander leaves Orange food colour (a pinch) 8 oz to 16 oz water Dash of lemon juice Ingredients to be added to boiling rice: Salt to taste 4 bay leaves 4 cinnamon sticks 3 black cardamom pods ¼ teaspoon black peppercorns
- 1/4 teaspoon cloves

Method

Heat oil and add meat, one-and-a-half sliced onions, ginger-garlic paste, salt, red chillies and whole garam masala. Cook until half done, adding brown onions (fried earlier) yogurt and lemon juice. Once meat is tender, set it aside. The biryani masala is ready.

In a separate pot (colander) boil water adding whole garam masala and bay leaves. Once water comes to boil add pre-soaked rice, keeping the rice to a tender crisp phase, since we only cook the rice completely in the dum phase. Drain rice; layer the pot with rice, topping with a layer of biryani masala, adding a second layer of rice. Top with fried onions, sprinkle food colouring, cilantro, mint, a pinch of garam masala powder and two teaspoons kewra. Seal pot with foil and lid. Keep full heat for five minutes and medium to low heat for 15 minutes, to complete the dum. Let sit for 10 minutes, mix and serve.

Garnish with green chillies, mint and chopped cilantro. Serve with a side of kachumer (chopped onion, tomato and green chillies salad) and raita.

Study on Covid-19 mask finds layering, material choice matter

earing a face mask can protect yourself and others from Covid-19, but the type of material and how many fabric layers used can significantly affect exposure risk, found a new study from the Georgia Institute of Technology.

The study measured the filtration efficiency of submicron particles passing through a variety of different materials. For comparison, a human hair is about 50 microns in diameter while 1 millimetre is 1,000 microns in size.

"A submicron particle can stay in the air for hours and days, depending on the ventilation, so if you have a room that is not ventilated or poorly ventilated then these small particles can stay there for a very long period of time," said Nga Lee (Sally) Ng, associate professor and Tanner Faculty Fellow in the School of Chemical and Biomolecular Engineering and the School of Earth and Atmospheric Sciences.

The study was conducted during spring 2020 when the pandemic triggered a global shutdown of most institutions. Communities faced massive shortages of personal protective equipment, prompting many people to make their own homemade masks. Georgia Tech quickly set up the study since it already had "a great system for testing filtration efficiency using existing instruments in

the lab," Ng recalled.

The study's findings were used to shape homemade face mask recommendations here last April, with the comprehensive study findings published on March 22 in the journal Aerosol Science and Technology.

In all, the researchers tested 33 different commercially accessible materials not limited to cloth fabrics, including singlelayer woven fabrics such as cotton and woven polyester, blended fabrics, nonwoven materials, cellulose-based materials, materials commonly found and used in hospitals, and various filter materials.

"We learned there was a lot of variability infiltration performance even in the same type of material," Ng said.

"We found commercially available materials that provide acceptable levels of submicron particle rejection while still maintaining airflow resistance similar to a surgical mask," said Ryan Lively, an associate professor and John H. Woody Faculty Fellow in the School of Chemical and Biomolecular Engineering. "These materials combine fabric fibre density, a maze-like structure, and fibre surface chemistry to effectively reject submicron particles.'

The best-performing materials for homemade masks were blackout drapery and sterilization wrap widely used for packing surgical instruments. Both materials are



commercially available.

The researchers said people should avoid using filters such as a HEPA/MERV or vacuum bags unless they are certified to be fibreglass-free since often such filters on their own may release glass fibres that can be inhaled. Other materials to avoid for masks include loose-knitted material, batting fabric, felt, fleece, or shiny, reusable shopping bags.

Multilayered samples performed much better than single-layer samples, but people should pay attention to breathability. The two-layered and three-layered samples tested show an overall filtration efficiency of about 50 per cent for submicron particles. Mask fit is also important since particles can easily escape through gaps at the nose or through the sides of the mask.

The analysis showed that properly fitted and multilayer masks reject 84 per cent of particles expelled by a person when one person wears it. Two people donning these types of masks reduces particle transmission by 96 per cent.

A final takeaway of the research was the importance of universal mask-wearing.

'The best way to protect ourselves and others is to reduce exhaled particles at the source, and the source is our face," Ng said, adding, "That really gets amplified when everyone starts wearing masks."

She expressed optimism that the findings will motivate people to more widely embrace mask-wearing if they are sick and need to be in public.

"Not everyone understands the importance of airborne virus transmission, and the importance of wearing a mask," she said.

She concluded, "I hope that the practice will continue to help reduce the release of these viral particles into the environment and help protect others.

urther surge in global commod-◄ity prices will have serious implications for India's economy which is still struggling to come out of the Covid-19 impact, ratings agency Ind-Ra said.

As per Ind-Ra, a higher retail inflation not accompanied by a commensurate increase in wage growth will adversely impact the consumption demand and in turn investment revival in the economy.

"Though a spike in global agricultural commodity prices could benefit India, it may not move the needle favourably because India, despite the world's biggest exporter of Basmati rice, exported just \$6.59

Consequently, energy commodity prices over the past six months have increased by 55.4 per cent, the increase in non-energy commodity prices is 19.3 per cent.

Google Wifi App Getting Rolled Into Google Home App: Report

SAN FRANCISCO: Google is reportedly shutting down its dedicated Google Wifi app for managing its routers and rolling that functionality over to the Google Home app to help users control and manage all their connected products in one place.

The switchover to the Google Home app will come in two phases first, Google will disable most of the functionality of the Google Wifi app on May 25, The Verge reported on Friday.

Starting then, users will only be able to view the current status of their networks, but any changes, including adding new routers or access points, will have to be done in the Google Home app.



Then, Google will remove the Wifi app from the Play Store and iOS App Store, funneling all users to exclusively use the Google Home app in June, the report said.

Google has been working on this

change since 2019, when it launched the Nest Wifi routers, which could only be configured in the Google Home app

Google points out that migrating existing Wifi setups to the Google Home app will offer some new benefits, including the ability to use Google Assistant for things like pausing the Wi-Fi connection, testing your current internet speed, and showing a guest Wi-Fi password on a Google Nest Hub or Nest Hub Max display.

Migrating a network setup seems to be a relatively simple process, although Google's how-to warns that once a user switch over to the Google Home app, they can't go back.

Chenab Bridge Project In J&K On Course, Construction Of Arches To Be Completed Soon: Officials

NEW DELHI; The construction of the iconic Chenab Arch Bridge, which will soar 359 metres above the bed of the river and will be 30 metres higher than the Eiffel Tower in Paris, will reach another milestone with the completion of its majestic arches in a couple of days, officials said on Saturday.

Recently, Railway Minister Piyush Goyal announced that the bottom ends of the main arch were connected. With the completion of the upper arch, the two will now be closed. Next, the tracks will be laid.

The bridge, which will be the world's highest bridge once completed in December, will provide all-weather connectivity to Kashmir with the rest of the country seamlessly.

It is part of an ambitious 272km rail link project in Kashmir, which is being constructed by the Northern Railway at an



estimated cost of Rs 28,000 crore to connect the valley to the rest of the country.

Railway officials said the bridge can withstand earthquakes with a magnitude of up to eight and high-intensity blasts. It will have a design speed of

around 100 kilometres per hour with a lifespan of 120 years. It will include a 14-metrewide dual carriageway and a

1.2-metre-wide central verge. The bridge will include 17 spans with a 469-metre main arch across the Chenab river and viaducts on either side and according to officials, steel was chosen to construct the bridge as it will be more economical and able to resist temperatures of minus 20 degree Celsius and wind speeds of above 200 kilometre per hour. Preparations for a rail link

in the Kashmir valley began in 2002 when the government planned to connect Baramulla, Kashmir's northernmost city, to New Delhi. But despite being prioritised by the Atal Bihari Vajpayee government as a "project of national importance", the construction was delayed. The biggest setback was the construction of the Chenab bridge, which faced several delays, mostly due to inclement

weather conditions and contractual issues.

While the work on the bridge started in July 2017 with a target of completing its construction by the end of 2019, it came to a halt due to contractual issues in 2018. The revised deadline is now December 2021. The cost of constructing the bridge is Rs 1,300 crore.

With the threat of terrorism to be considered, the bridge, which is located just 60 km from the Line of Control (LoC) with Pakistan, was planned in such a way that even if one of the 17 piers supporting it were to be blown up, it will not collapse. Officials said a ring of aerial security is also a part of the plan along with online monitoring systems.

The last remaining section of the rail link, Katra-Banihal (111 km), is currently under execution. It is targeted for completion in December 2022. Work on 126 km of the 174 km of tunnels on the section has already been completed.

COVID VACCINATION Govt Asks States/UTs Not To Allow Fresh Registrations Of Healthcare Workers

NEW DELHI: The Centre on Saturday directed the states and UTs that no fresh registrations of healthcare and frontline workers will be allowed since some ineligible beneficiaries were getting their names enlisted for vaccination against COVID-19, under this category, in violation of rules.

Union Health Secretary Rajesh Bhushan, in a letter, said registration of persons aged 45 years and above will continue to be permitted on Co-WIN portal, and asked the states/UTs to ensure universal vaccination of already registered healthcare workers (HCWs) and frontline workers (FLWs) at the earliest. The countrywide vaccination

drive was rolled out on January 16 with HCWs getting inoculated and the vaccination of FLWs started from February 2. The next phase of COVID-19

vaccination commenced from March 1 for those over 60 years of age and for people aged 45 and above with specified comorbid conditions.

In the letter, Bhushan said all efforts have been made in close collaboration with states and UTs to saturate vaccination of HCWs and FLWs.

While tracking the progress, timeline for completing vaccination of all HCWs and FLWs with first dose of COVID-19 vaccine has been extended multiple times and was finally fixed at February 25 for HCWs and March 6 for FLWs, he stated.

Around one month has elapsed since these timelines and even after starting the vaccination of the population above 60 years, provision was made to register and vaccinate HCWs and FLWs with a view to ensure optimal coverage, he underlined.

Chhattisgarh: Five Jawans, One Naxal Killed In Encounter Press Trust of India

RAIPUR: Five security personnel were killed and 12 others injured on Saturday in an encounter with Naxals in a forest along the border between Bijapur and Sukma districts in Chhattisgarh, police officials said.

The body of a woman Maoist was also recovered from the encounter spot, they said.

A senior police officer claimed, prima facie, Maoists have suffered a "huge loss" in the gunfight.

"Separate joint teams of security forces, over 2,000 in number, had launched a major anti-Naxal operation from Bijapur and Sukma districts in the South Bastar forests, considered as the Maoist stronghold, on Friday night," state's Deputy Inspector General (antinaxal operations) OP Pal said.

Despite COVID-19 Spike, **Bullish BCCI Wants To Stage** IPL 2021 Matches In Mumbai

MUMBAI: The Board of Control for Cricket in India (BCCI) is bullish about holding the 10 IPL games in Mumbai between April 10-25 despite an enormous spike in CO-VID-19 cases in the city, saying creating a bio-bubble at an alternative venue would not be feasible at a short notice.

Delhi Capitals' Axar Patel, 10 members of the ground staff at Wankhede stadium and six event managers, deployed by the BCCI, have added to the growing list of positive cases in the Indian Premier League (IPL), starting April 9.

Hyderabad and Indore have been kept as stand by venues for the IPL in case the COVID situation spirals out of control but as of now, the BCCI is confident about holding the games in Mumbai.

"Yes, Hyderabad is one of the stand-by venues but for all practical purposes, we are still not thinking about shifting games from Mumbai. It will be difficult to create another bio-bubble at such short notice," a senior BCCI official told PTI on Saturday.

The organisers are worried about the growing number cases at the Wankhede stadium. The number was 8 till Friday evening but now it's 10.

If that wasn't enough, around six members of the event management team have also tested positive for COVID-19 and have been sent to isolation.

"Yes, it was 8 positive cases yesterday as far as ground-staff are concerned. Today two more positive cases have emerged and all 10 have been sent back home and are isolated.

"We are bringing fresh groundstaff from the Mumbai CA ground in Kandivali for preparations. Also 6 to 7 event management staff hired by BCCI have also tested positive," a senior Mumbai Cricket Association official told PTI.

In the afternoon, Delhi Capitals issued a statement that their spin all-rounder Axar Patel has been shifted to a COVID isolation facility after testing positive.

"Delhi Capitals all-rounder Axar Patel has tested positive for COVID-19. He had checked into the team hotel in Mumbai on March 28, 2021, with a negative report. His report from the second COVID test, came positive," the DC statement said.

Hundreds Of French Sports Figures Accused Of Sexual Violence

PARIS: A year-long, nationwide French effort to uncover and combat sexual violence in sports has identified more than 400 coaches, teachers and others suspected of abuse or covering it up.

Most of the victims were under 15, according to data released Fridav by the sports ministry. The alleged abuse included sexual assault, harassment or other violence.

Sixty people have faced criminal proceedings, more than 100 have been temporarily or permanently removed from their posts, and local investigations are under way into other cases, the ministry said.

The abuse reached across the country and across the whole sector, with accusations targeting a total of 48 sports federations.

Of those accused, 96% are men. Of the victims, 83% were women, and 63% were under 15, the ministry said. The fact-finding probe was

launched in February 2020 after 10time French skating champion Sarah Abitbol said in a book that she was raped by coach Gilles Beyer from 1990-92, when she was a teen. Beyer was handed preliminary charges of sexual assault and the investigation is ongoing.

In the wake of Abitbol's accusations, more skaters spoke out to denounce alleged sexual violence from coaches. The sports ministry set up a dedicated platform for athletes" testimonies and conducted a year of hearings.

In its statement, the ministry called Abitbol's testimony "a historic moment for French sport" that raised awareness and has pushed authorities to crack down on abuse.

A new law on tougher screening of sports educators, including volunteer coaches, went into effect Friday, and the French government and sports federations have pledged to respond faster and more effectively to reports of abuse.

Sourav Ganguly 'Obsessed' With Rishabh Pant, Calls Him 'An Absolute Match-Winner'

NEW DELHI: BCCI president Sourav Ganguly says he is "obsessed" with Rishabh Pant's game and calls the swashbuckling India wicketkeeperbatsman "an absolute match-winner".

The former India captain added that he loves watching the likes of Virat Kohli and Rohit Sharma bat.

"There are some fantastic players and I think as President of the Board I should not say who is my favourite player. All are favourite to me but I enjoy Kohli, I enjoy Rohit Sharma," Ganguly said during an interactive session organised by Classplus, a platform for educators to go digital.

"I am obsessed with Rishabh Pant because I think he is just an absolute match-winner. Jasprit Bumrah is good, Mohammed Shami is good, I like Shardul Thakur a lot because he has got the courage and guts.

"There is immense cricketing talent in India. When (Sunil) Gavaskar was there people used to think what will happen after him, then came (Sachin) Tendulkar, (Rahul) Dravid. Anil Kumble. When Tendulkar, Dravid left, Virat Kohli, Rohit Sharma, Rishabh Pant took over," he said.

"There is so much talent for cricket in India that I think it will



produce world beaters in every generation."

Ganguly, who was picked for India's tour of Australia in 1992 but didn't get a single game, recalled how that experience Down Under and the hard work that followed in the subsequent years made him a better cricketer.

"I consider my 1992 series as a failure. To be honest I didn't get much opportunities to play and I came back from the tour of Australia, but I was young,. That (series) actually helped me to become a better cricketer.

"I came back stronger mentally. I was not fitter, I understood what international cricket was all about. I started to train myself over the period of 3-4 years not

just physically but mentally also

on how to handle the pressure," he recalled.

"My series in Australia in 1992 actually helped me become a better cricketer. When I went to England in 1996, I was much stronger. I knew what it takes to score runs in international level.

"I had another four years of domestic cricket under my belt where I kept scoring runs. Those four years I think was a blessing in disguise for me. Failures makes you better cricketer."

Attack On My Convoy Pre-Planned By BJP Workers: Tikait

haratiya Kisan Union (BKU) leader Rakesh Tikait claimed Don Saturday that the attack on his convoy of vehicles in Raj-asthan''s Alwar was "pre-planned by BJP workers" and said it should serve as a reminder to the farmers protesting against three new agriculture laws of the Centre about the travails and challenges they are going to face in the days to come.

Addressing a "kisan mahapanchayat" at Bhaimalkheda village in this Uttar Pradesh district, Tikait said such attacks "are, in fact, strengthening our resolve to further intensify our struggle, which is a battle for our existence".

Talking to reporters after the "mahapanchayat", he said, "We are mentally prepared for more such incidents.

Stones were allegedly pelted at the convoy of Tikait, an influential farmer leader, in Rajasthan"s Alwar district on Friday, damaging the rear windshield of his car. Police had detained a student leader, who the BKU claimed belonged to the Akhil Bharatiya Vidyarthi Parishad (ABVP), the student wing of the Bharatiya Janata Party (BJP), and accused the saffron party of being behind the attack.

Addressing the "mahapanchayat" here, Tikait issued a call to the protesting farmers to be mentally pre-

pared to continue with their agitation at least till the end of the year, when they would taste victory. He urged them to be mobile phone savvy so that they can be ac-

tive on social media. Tikait, who held a "mahapanchayat" in Aligarh for the first time after the farmers" agitation was launched in November last year, alleged that corporates had fully entrenched themselves in the present ruling dispensation, including the

Prime Minister"s Office (PMO). He said how else can one explain the construction of huge grain depots and godowns in several parts of the country "even before the controversial farm laws came to existence". The BKU leader said this itself provides conclusive evidence of the

government"s intentions. He warned the farmers that even more draconian measures are on the anvil as far as the farm laws are concerned, including stringent regula-

tions regarding crop seeds. Tikait alleged that under the proposed measures, farmers would be liable to be bound by pernicious terms and conditions, which would place them at the mercy of the seedselling firms.

He said the three laws would make it impossible for the farmers to enjoy the right to use the seeds of their choice and frustrate them to such an extent that they would be compelled to sell their land to corporates.

Study: Sunlight Destroys Covid 8 Times Faster **Than Scientists Believed**

team of scientists is calling for further research into how Sunlight inactivates SARS-CoV-2 after noticing a glaring inconsistency between the most recent theoretical and experimental results, Science Alert reports.

Mechanical engineer Paolo Luzzatto-Fegiz and colleagues from UC Santa Barbara noticed the virus was inactivated as much as eight times faster in experiments than the most recent theoretical model predicted. "The theory assumes that inac-

tivation works by having UVB hit the RNA of the virus, damaging it," explained Luzzatto-Fegiz. However, the inconsistency suggests there's something more going on than that, and figuring out what is necessary as it can help

manage the virus. According to the researchers. there are certain nucleic acid bases in DNA and RNA which can easily absorb UV light or the ultraviolet part of the spectrum. It can cause them to

bond in ways that are hard to fix. However, not all UV lights are effective. Longer UV waves, called UVA, don't have quite enough energy to cause problems. It's the mid-range UVB waves in sunlight that are primarily responsible for killing microbes and putting our

cells at risk of sun damage. Short-wave UVC radiation has been proved to be effective against viruses such as SARS-CoV-2, even while it's still safely enveloped in human fluids.

Luzzatto-Feigiz and team compared those results with a theory about how sunlight achieved this, which was published just a month later, and saw the math didn't add up. This study found the SARS-

CoV-2 virus was three times more sensitive to the UV in sunlight than influenza A, with 90% of the coronavirus's particles being inactivated after just half an hour of exposure to midday sunlight in summer. However, in winter light infectious

particles could remain intact for days. A separate team of researchers made Environmental calculations and concluded the virus's RNA molecules are being photochemically damaged directly by light rays.

This is more powerfully achieved by shorter wavelengths of light, like UVC and UVB. As UVC doesn't reach

Assam Minister Summoned By Police For Allegedly Threatening Journalists

MORIGAON: Assam minister Pijush Hazarika, who allegedly threatened two journalists, has been issued a notice to appear before police and his call recordings have been sent to forensic lab for examination, officials said today.

Two cases filed at Jagiroad police station by the journalists have been merged, and Mr Hazarika has been booked under Sections 500 (defamation), 506 (criminal intimidation) and 341 (wrongful restraint) of the IPC.

The minister, who is contesting from the Jagiroad constituency where polling took place in the second phase on Thursday, had allegedly threatened the two journalists for reporting about a controversial campaign speech by his wife.

The statements of the journalists were recorded and a notice was issued to the minister in connection with the case. He has been asked to come to Jagiroad PS for recording his statement," Morigaon District Superintendent of Police Nanda Singh Borkala said.

Mr Hazarika, the Minister of State for Health and Family Welfare, said he will come to the police station on Sunday to give his statement, the official said

Mr Borkala said the mobile phones of the scribes and that of Mr Hazarika have been seized and the voice recordings of the conversation sent to a forensic laboratory in Guwahati. "As per law and procedure, we will

proceed in the case," he added. In the first information report,

the two journalists - Nazrul Islam and Tulsi Manta - of Assamese news channels claimed that Mr

Hazarika had threatened them with dire consequences at 1 pm on Thursday, when they were busy in poll coverage of the second phase in Morigaon district.

The police have also provided personal security cover to both the journalists. Meanwhile, the IG (Law and Order) Deepak Kumar Kedia, who is the nodal officer of the state police for the ongoing Assam assembly elections, has sought a report from the district police on the case.

Assam Congress chief Ripun Bora has also filed a complaint with the state's chief electoral officer, demanding Mr Hazarika's disqualification from the polls.

Other opposition parties like the AIUDF, Raijor Dal, Assam Jatiya Dal, AASU, AJYCP and several social groups also called for immediate disqualification of Mr Hazarika from the elections.

The Gauhati Press Club (GPC) condemned the "act of intimidation" by Hazarika.

In an audio clip telecast by an Assamese news channel on Thursday, the minister can be heard threatening the scribes of dragging them out of their homes and making them "vanish".

The minister also said in the telephonic conversation, which has now gone viral, that he was "sad" because the news was related to his wife Aimee Baruah, who while campaigning for her husband a few days ago had made a controversial comment on the Citizenship (Amendment) Act.

Ms Baruah, at a recent public meeting in Jagiroad, had allegedly said the people from the Bengali community will be thrown out of the country if the CAA is not implemented.

DMK Chief's Family, Others Raided To Check Illegal Political Cash: Report

NEW DELHI/ VELLORE: The Income Tax Department's raids on DMK chief MK Stalin's daughter Senthamarai and others on Friday were aimed to check "political cash distribution" in poll-bound Tamil Nadu, sources in the Central Board of Direct Taxes (CBDT) said.

Till now, 28 premises in Chennai, Coimbatore and Karur have been covered as part of the action, they said.

"Several incriminating material on tax evasion have been found so far" during the raids which are underway, claimed the sources in the CBDT, which frames policy for the tax department. The searches are being conducted on three different groups and a few individuals in the state, they said.

Tamil Nadu will vote for its 234-member assembly in a single phase on April 6.

"These groups and individuals are involved in businesses ranging from running distilleries and breweries, real estate, local financing, solar power EPC to handling cash of politically exposed persons for the ongoing elections," a senior tax department officer said.

"Part of these groups and individuals are alleged to have been actively assisting in political cash distribution. Searches have been conducted to verify and unearth such activities too," the officer said.

The DMK has condemned the central government for this action and alleged that it had a "political objective"

Party general secretary Duraimurugan said when parties are on the verge of completing campaigning and are looking forward to the day of polling, the income tax searches in the residence of Senthamarai was done with a "political objective".

The Centre has made a "wrong calculation" that raids just ahead of the election would shock Stalin, his family and the party, and also weaken poll preparations, he claimed while speaking to reporters in Vellore.

"The DMK is not a party that can be scared by such searches," he said adding that the party had already faced similar instances and it would not be deterred.
