Bandipora Authorities Faces Flak, Withdraw **Controversial Order**

SRINAGAR: Authorities in the Bandipora district of Jammu and Kashmir withdrew within hours a controversial order making it mandatory for persons above 45 to get themselves vaccinated against COVID-19 to collect their government ration. An order issued by the Assistant Director, Food, Civil Supplies and Consumer Affairs, Bandipora, earlier in the day had asked consumers above 45 to get themselves vaccinated against COVID-19 or forego their ration.

'Please remember that without producing covid-19 vaccination certificate, ration will not be issued in any case," the order said. However, it was withdrawn within hours.

Plants help reduce toxic mercury from our environment: Study

lants absorb a vast amount of toxic mercury gas in the atmosphere and help reducing the pollutant worldwide by depositing the element into soils, said researchers.

The process is similar to the absorption of carbon dioxide emissions by plants, said the team from University of Massachusetts Lowell. in the US.

Hundreds of tons of mercury each year are emitted into the atmosphere as a gas by burning coal, mining and other industrial and natural processes.

When the plants shed leaves or die, the mercury is transferred to soils where large amounts also make their way into watersheds, threatening wildlife and people who eat contaminated fish, the researchers explained, in the study published journal Nature Reviews Earth & Environment.

Exposure to high levels of mercury over long periods can lead to neurological and cardiovascular problems in humans, according to Daniel Obrist, Professor at UMass Lowell.

There is no safe level of mercury for humans, according to the World Health Organization. Exposure to the hazardous element



can lead to irritability, speech and visual impairment, hypospermia, kidney failure and Alzheimer's disease, among others

For the study, the team collected 200 published studies with data on mercury levels in vegetation from more than 400 locations around the world.

They found about 88 per cent of the mercury found in plants originates from plants' leaves absorbing gaseous mercury from the atmosphere.

Globally, vegetation can take up more than 1,300 tonnes of mercury each year, accounting for 60 to 90 per cent of it being deposited over land, according to Jun Zhou, Research Associate at UMass Lowell.

The study represents the largest comprehensive review of the uptake of mercury in vegetation and its impact on mercury cycling around the world. The work moves scientists toward a greater understanding of how mercury cycling works, Zhou said.

Srinagar Admin Warns Passengers, **Drivers As Covid SOPs Go For A Toss**

Srinagar: Public transport in Srinagar and elsewhere in Kashmir is posing a serious threat to passengers as Covid-SoPs are going for a toss forcing the authorities to issue a serious warning for passengers and drivers. The Srinagar administration has also warned of slapping a fine on the passengers and drivers. who are found violating the Covid-guidelines.

A number of passengers who frequently travel in public vehicles said that one among 10 passengers use face mask during travel.

"Simply, Covid guidelines are going for a big toss in Kashmir. People are least bothered about Covid resurgence in Valley, especially Srinagar which is worst hit. This is strange. People are travelling without face masks and there is no monitoring at all," said Shazia Bashir, who travels regularly to her office in Srinagar from Pampore area. Other frequent travellers echoed similar views and demanded a monitoring mechanism by the transport department or the district administration.

Regional Transport Officer (RTO) Kashmir, Ikram-Ullah Tak said, "we have already deputed our squads to check the Covid -19 Sops violation and fines have also been imposed on the violators.

He said that in coming days, the drive for the strict enforcement of the Covid-19 SoPs in public transport will be intensified and those found violating will be dealt with strictly.

Interestingly, Covid guidelines read: "Individuals must maintain a base distance of six feet (2 Gaz ki Dori) in public places". However, this is hardly seen on ground.

Additional Deputy Commissioner Srinagar Dr. Syed Haneef Balkhi said that the Covid-19 SoPs and guidelines are already in place and they have been repeatedly asking people associated with trade or transport, to adhere to the guidelines, and before that people are being penalised for violating the Covid-19 guidelines.

"I appeal people to show a responsible approach and follow Covid-19 guidelines in spirit," he said. "We conduct random sampling and inspection also in and around the city. People found violating the Covid-19 guidelines are being fined, wearing of masks and maintaining of physical distance at public places is what is need of the hour," he said—(KNO)

house of one Ghulam Mohammad Sheikh, son of Mohammad Ramzan Sheikh of Dogerpati Haftchinar, which engulfed into another residential houses during intervening night of Sunday-Monday.

In the incident, Ghulam Mohammad Sheikh's wife identified as Ajmeera (40), her son Mohammad Abbass Sheikh (6), died on the spot.

Pak Court Jails 5 Hafiz Saeed Aides In **Terror-Funding Case**

LAHORE: A Pakistani anti-terrorism court has sentenced five leaders of Mumbai attack mastermind Hafiz Saeed's Jamaat-ud-Dawah (JuD) to nine years of imprisonment each in a terror financing case.

Three of them – Umar Bahadar, Nasarullah and Samiullah – have been convicted for the first time since the Anti-Terrorism Court (ATC) Lahore pronounced its ver-

dict some time ago in the terror financing cases registered by the Counter-Terrorism Department (CTD) of the Punjab police. The other two - JuD spokesperson Yahva Mujahid and senior leader Prof Zafar Iqbal – had already been convicted for many years in other terror financing cases.

ATC Lahore Judge Ejaz Ahmad Buttar on Saturday handed down nine-year imprisonment to each five of them. – PTI

Pakistan Judge, Family **Members Shot Dead**

ISLAMABAD: A Pakistan anti-terrorism court judge, his wife and two children were killed after unidentified gunmen opened fire at his vehicle in Swabi district, Khyber Pakhtunkhwa province, police sources said.

The judge was on his way to the national capital Islamabad when the militants ambushed him and killed him with his family members near an interchange at the

motorway on Sunday, the sources told Xinhua news agency. Two policemen, including the judge's driver, were wounded in

the attack, the sources added. "The judge, his 10-year-old son, wife and six-year-old daughter were killed on the spot, and the policemen are also in a very critical condition," the sources said. The attackers fled the scene before police arrived.

No group or individual has claimed the attack yet.

Saudi Arabia's Scramble For An Exit Strategy In Yemen

he Saudi Arabia-led alliance's military intervention in Yemen has not only failed in its objective to rout the Houthi rebels, but the kingdom finds itself in a position in which it might be

forced to capitulate. Saudi Arabia has failed its primary objectives of defeating the Houthis and restabilising the internationally recognised government in Yemen.

"The Houthis have proven to be a formidable fighting force. Saudi Arabia does not have a comparable ground game that can match their adversaries'," Nader Hashemi, director of the Center for Middle East Studies at the University of Denver,

told Al Jazeera. This reality is far from what Saudi Arabia had initially anticipated when it entered into the war via Operation Decisive Storm in March 2015.

"Saudi Arabia thought it would win this war via a bombing campaign, and it would all be over in a few weeks. We have now entered the seventh year of this war with no clear end in sight," Hashemi said.

In fact, the Houthis have been on the advance ever since, and Saudi Arabia is in a position where it is

As it stands, Saudi Arabia and its allies could potentially be forced to withdraw without the Houthis having to make any concessions. Hence, their initial rejection of the proposal did not come as a surprise, particularly as it offered "nothing new".

The latter is an accurate statement, according to Steven Hurst, department head of history, politics and philosophy at the Manchester Metropolitan University.

Bangladesh Imposes 7-Day Nationwide Lockdown Amidst Spike In COVID-19 Cases

angladesh on Monday clamped a week-long nationwide lockdown, suspending public transport and shutting markets to combat the surge in coronavirus cases in the country, amidst demonstrations by small business owners against the move.

According to a government circular issued on Sunday, the directives will remain in effect from 6am of April 5 till 12 midnight of April 11, the Dhaka Tribune reported. People have been asked not to move out from their homes from 6 pm to 6 am, the report said.

The decision was taken in light of the current situation in the country where the rate of infections and deaths have increased in recent weeks. The government has said that they are increasing the number of COVID-19-designated hospitals and ICU beds to deal with the rising number of patients, it said.

Bangladesh has registered 7,087 fresh COVID-19 cases, taking the tally to 637,364, in the last 24 hours until Sunday which is the highest number of infections since the start of the pandemic, the United News of Bangladesh reported.

Besides, the deaths due to coronavirus rose to 9.266 with 53 news fatalities during this period. The mortality rate fell to 1.45 on Sunday from Saturday's 1.46 per cent. All public transport services (roads, river, railway and domestic flights) were suspended and only emergency services remained operational.

He said it was important for societies to protect themselves against "fahasĥi" (vulgarity), reported Geo News.

Moreover, in February, in an insensitive move, the Forensics Department of Khyber Medical College University proposed a plan to charge rape victims Pakistani Rs 25,000 for medical examination and Rs 5.000 for an autopsy for the local residents of Peshawar.

Singapore Blogger Crowdfunds \$99,000 **To Pay PM Damages in Defamation Case**

SINGAPORE: A Singaporean blogger said on Monday he had raised \$\$133,000 (\$98,840) via crowdfunding on social media to cover damages he was ordered to pay Prime Minister Lee Hsien Loong in a defamation case filed by the citystate's leader.

Lee had sued Leong Sze Hian, a financial advisor, after he shared on Facebook an online news article that linked the premier to a financial scandal at Malaysia's state fund 1MDB.

Lee's lawyers have said such links were "false and baseless". Leong had deleted the November 2018 Facebook post within three days of sharing it, complying with a government request.



The Singapore high court on March 24 ordered him to pay Lee \$133.000.

"I am very happy, very grateful," he told Reuters on Monday.

Leong made the announcement on Facebook late on Sunday, when he posted: "It is finished. All paid for." As the head of a government that has pledged zero tolerance of

corruption, Lee, 69, is no stranger to seeking to protect his reputation via legal channels.

Senior figures in the ruling People's Action Party, including Lee's late father and the founder of modern-day Singapore, Lee Kuan Yew, have previously sued foreign media, political opponents and online commentators for defamation.

Nasa's Ingenuity helicopter dropped on Mars' surface ahead of flight

Tasa's Ingenuity mini-helicopter has been dropped on the surface of Mars in preparation for its first flight, the US space agency said.

The ultra-light aircraft had been fixed to the belly of the Perseverance rover, which touched down on the Red Planet on February 18.

"MarsHelicopter touchdown confirmed!" Nasa's Jet Propulsion Laboratory tweeted on Saturday.

"Its 293 million mile (471 million kilometer) journey aboard @ NASAPersevere ended with the final drop of 4 inches (10 centimeter) from the rover's belly to the surface of Mars today. Next milestone? Survive the night."

A photograph accompanying the

tweet showed Perseverance had driven clear of the helicopter and its "airfield" after dropping to the surface. Ingenuity had been feeding off

the Perseverance's power system but will now have to use its own battery to run a vital heater to protect its unshielded electrical components from freezing and cracking during the bitter Martian night.

"This heater keeps the interior at about 7°C through the bitter cold of the Martian night, where temperatures can drop to as low as -90°C," Bob Balaram, Mars Helicopter Project chief engineer at the Jet Propulsion Laboratory, wrote in an update on Friday.

"That comfortably protects key components such as the battery and some of the sensitive electronics from harm at very cold temperatures." Over the next couple of days, the



helicopter's solar panels are working properly and recharging its battery before testing its motors and sensors ahead of its first flight, Balaram said. Ingenuity is expected to make its first flight attempt no earlier than April 11, the Jet Propulsion Laboratory tweeted.

Ingenuity will be attempting to fly in an atmosphere that is 1% the density of Earth's, which makes achieving lift harder -- but will be assisted by gravity that is one-third of our planet's.

The first flight will involve climbing at a rate of about 3 feet per second to a height of 10 feet, hovering there for 30 seconds, then descending back to the surface.

Ingenuity will be taking highresolution photography as it flies. Up to five flights of gradual difficulty are planned over the month.

The 1.8-kilogram rotorcraft cost Nasa around \$85 million to develop and is considered a proof of concept that could revolutionize space exploration. Future aircraft could cover ground much quicker than rovers, and explore more rugged terrain.

A good step

he Jammu and Kashmir administration on Sunday announced that all schools for students up to Class 9 will remain closed for two weeks from April 5 in view of the rising number of coronavirus infections in the union territory. Similarly, physical classes for students from classes 10 to 12 will also be suspended for a week. Earlier, the administration had asked all district magistrates to take a call on the continuation of physical classes in schools amid a spike in COVID-19 cases.

Closing the schools is a good decision. In recent past, several schools across the Valley had witnessed cases of infection. Ironically, the government had decided to reopen schools at a time when the coronavirus pandemic is once again spreading through J&K like a wild fire and the number of deaths is rising. So, how did government expect there would be no infections in schools.

Reopening schools runs the grave risk of exposing children to the infection. Schools lack the adequate infrastructure to protect the children. It would also be impossible to make the students follow the safety precautions. This is therefore not the conducive time to reopen schools. Government should wait for the contagion to be reigned in before children can go back to school.

If we evaluate the situation objectively, the government's decision to start schools was premature. On ground the exercise was not only not going to serve its desired purpose but also disrupt the ongoing online classes and leave a majority of students without education. Considering the pandemic is not going to go away any time soon and we might even see fresh spurt in the cases, the government should wait for a month or so before allowing the schools to reopen.

It is true that schools had been closed since mid-March last year when Coronavirus was declared a pandemic around the world. This was barely fifteen days after the schools had reopened following seven month closure in the wake of the revocation of Article 370 in August 2019. This had already taken a massive toll on the education in Kashmir. More so, in Kashmir where the schools have now been closed for nearly two years. Education has been the worst victim of the lingering political turmoil and now that of the pandemic. A virulent third wave of the Covid-19 has made the education a tricky trade-off between re-opening schools and the health of children. But given the existing situation, it is important that the schools remain closed for now.

Indian Agriculture: Maladies and Remedies

A more holistic and pragmatic approach needs to be adopted by the policy makers to make Indian agriculture sector more competitive and profitable

Since Independence agriculture sector has remained the main source of national income and occupation in India. In 1947, 72 per cent of the total working population was engaged in agricultural sector, but still a majority of India's poor (some 770 million people or about 70 per cent) inhabit the rural areas.

Though due to the high growth rates of the industrial and services sectors, the share of agricultural share in India's economy has progressively declined to less than 15%, yet its importance in India's economic and social development can't be denied.

On road to self-sufficiency

The Green revolution of 1960s witnessed a drastic increase in total agricultural production, particularly wheat and rice. The second phase of the Green revolution further boosted it in 1980s, which was accelerated further by the liberalisation policy of the late 1990s.

However, the results of the Green revolution were not uniform over the entire country. It particularly resulted in enhanced cultivation and production of wheat and rice in the northern states, and other cash crops such as cotton and onion in the western and southern states. But it neglected the cultivation of pulses and other cereals.

Though India is considered to be a global

need increasing yields, diversification to higher value crops, and developing value chains to reduce marketing costs.

The sharp rise in food-grain production during India's Green revolution of the 1970s enabled the country to achieve self-sufficiency in food-grains and stave off the threat of famine. Agricultural intensification in the 1970s to 1980s saw an increased demand for rural labour that raised rural wages and, together with declining food prices reduced rural poverty. However agricultural growth in the 1990s and 2000s slowed down, averaging about 3.5% per annum, and cereal yields have increased by only 1.4% per annum in the 2000s. The slowdown in agricultural growth has become a maior cause for concern. India's rice yields are one-third of China's and about half of those in Vietnam and Indonesia. The same is true for most other agricultural commodities

change catalyst through a partnership approach to help rural communities develop their own solutions and engages with them to bring the vision to reality. Its inclusive approach ensures participation of women and youth, a must in finding sustainable and profitable solutions, besides contributing to several of the UN SDGs.

n a large and lively democracy, the Election Commission has a job both delicate and difficult: To be scrupulous and visibly so about following processes and protocols which have firmed up, over the decades, its reputation for fairness.

In a large and lively democracy, the Election Commission has a job both delicate and difficult: To be scrupulous and visibly so about following processes and protocols which have firmed up, over the decades, its reputation for fairness. It may be, as Prime Minister Narendra Modi has said in a poll speech, that when players blame the umpire, it means they are afraid of impending defeat. And yet, the EC must not only answer questions that are raised by those who are competing in the arena, it must also transparently abide by the high standards it has set for itself. In this context, it has done well to take immediate action after an EVM was found in a BJP vehicle in Assam — four officials were suspended, a re-poll ordered. But in another instance, its decision has invited doubts that continue to linger. By promptly relaxing the ban it imposed on Assam minister Himanta Biswa Sarma for open threat-making against an opponent from 48 hours to 24, the EC has taken an unusual step without giving a convincing explanation. That Sarma is himself a candidate in the poll was known to the EC before it slapped him with the penalty, and merely his apology could surely not be enough to bring on what amounts to a near reversal of its own decision and what could look like leniency to the party that rules at the Centre.

In West Bengal, a close contest is playing out between Trinamool Congress and BJP, the incumbent in the state is being challenged by the incumbent at the Centre, the prime minister leading the charge. Amid soaring political temperatures, there are accusations and counter-accusations. Much like the BJP's star campaigners, Mamata Banerjee has a penchant for the dramatic, she is adept at striking the exaggerated poll pose. The EC's strong rebuke to her — it has called her allegations of disruption of polling at a booth in Nandigram as "factually incorrect" and "devoid of substance", and suggested she could be guilty of "misdemeanour" — carries moral and institutional weight precisely because it is seen to be coming from an evenhanded place.

That's why it is also on the EC to take note of a disquieting pattern in the poll playbook: Ahead of elections, in the states and in the Lok Sabha, central agencies, from the ED to CBI to I-T, knock on the doors of the Opposition leaders in the states they control. A report in this newspaper has stitched together several instances, across states — from Maharashtra to West Bengal, from Chhattisgarh to Tamil Nadu. It's nobody's case that the law should suspend its course once the model code of conduct kicks in, but many of these cases are dusted up and weaponised just in time during the campaign. The EC must be vigilant, it must take note. In times when non-elected institutions seem unable to hold firm against political pressures, much depends on the poll monitor stepping up to its own formidable record of independence. The EC has set a high bar for itself, it has its task cut out.

agricultural powerhouse, yet the sector suffers from serious maladies. According a World Bank report of 2010, India is the world's largest producer of milk, pulses, and spices, and has the world's largest cattle herd (buffaloes), as well as the largest area under wheat, rice and cotton. It is the second largest producer of rice, wheat, cotton, sugarcane, farmed fish, sheep & goat meat, fruit, vegetables and tea. But in spite of this the Indian farmer remains poor, though he contributes a lot to the economy.

As per experts' opinion the factors which contribute to the poor performance of the Indian agricultural sector are multi-dimensional, such as: poor access to reliable and timely market information to the farmers, absence of supply and demand forecasting, poorly structured and inefficient supply chains, inadequate cold storage facilities and shortage of proper food processing units, large intermediation between the farmers and the consumers, besides regional disparities are some of the major causes of the losses for the farmers.

The WB report lists that one of the biggest issues facing the agricultural sector in India is low yield: India's farm yield is 30-50% lower than that of developed nations. Average farm size, poor infrastructure, low use of farm technologies and better farming techniques, decrease in soil fertility due to over fertilisation and sustained pesticide use, are leading contributors to low agricultural productivity.

Thus, measures to increase productivity will

What we need is a pragmatic, realistic and holistic approach to be adopted by the policy makers to address the maladies faced by the Indian agriculturists. Besides resolving the regional disparities in crop patterns, the government also needs to promote cultivation and change in eating habits of the populace. One route to this could be propagating the inclusion of millets and other high nutritious cereals, in the eating habits of the populace. This besides increasing the earning potential of the farmers in the drought prone or less irrigated areas will also result in making better use of the cultivable area across the country.

Further action in this regard could be taken by the government by supporting and collaborating with international institutions like International Crops Research Institute for the Semi-Arid Tropics (ICRISAT), which are engaged in popularising the cultivation and use of highly nutritious crops like millet and sorghum.

The strategy adopted to achieve this should involve and ensure that small farmers and rural communities benefit by receiving on-farm support, connecting farmers to value chains, linking smart food with health activities on the ground, and advocacy for policy support, research and development.

Policy makers will thus need to initiate and accomplish policy actions and public programmes to shift the agricultural sector away from the existing policy and institutional regime that appears to be no longer viable and build a solid foundation for a much more productive, internationally competitive, and diversified agricultural sector in the country. In addition, we'll have to promote increased cultivation of those crops, which besides being nutritious and profitable are also able to counter the environmental challenges.

Why nationalism is a threat to multilateralism

Collective intelligence and astute leadership required to counter isolationist forces

oving your country is considered a virtue, and for a patriot, love for the country should not have any limit. Blind love has its own pitfalls, and there is no convincing argument except emotional ones to justify that. However, patriotism has been in the past and still continues to be used by political and social entrepreneurs to build nation-states.

In regular intervals in recent history, the 'patriotic' passive love by countrymen is not even seen as enough. There are calls for the love for the country to be enthusiastically displayed, That sometimes is accompanied by hatred towards the country's perceived enemy, both outside and within.

There is a very thin line between being a patriot and displaying love and pride for your land and becoming a nationalist and carrying the notion of your country's pre-eminence and its culture over others. Though commentators try to give a positive pitch to patriotism compared to nationalism, there is only a subtle difference. It is easy to interchange depending upon the whims and expediency of someone at the top.

By creating false pride and a notion of superiority, nationalist leaders often claim to unify their nations, but the creation of "us" vs. "them" attitude also leads to prejudices and intolerances against not only other countries but also people and political parties opposing them. People and groups who oppose these nationalist leaders are not seen as policy critics or political opposition but as antinational forces.

Nationalists take pride in hurting others, people of other countries, and also anyone who is branded as "them'. Politicians continue to lie and distort history to create an illusion of superiority among "their" people. The ambition of nationalist forces to regain that illusory glory of the past results in justifying the control of media, dominating the judiciary and dismantling the rule of law.

Facts lose relevance, and emotions take the pre-eminent position. Any opposition at home is crushed, and the ego of a powerful majority group that is pro-one party gets regularly massaged. Nationalists believe they have the right to dominate others as they are superior. Thus, nationalism often leads to militarism and conflicts with other countries, and in its crude form, it can also lead to ethnic cleansing and genocide inside the country.

With the idea of being unique and superior to others, nationalists don't see themselves as responsible members of the community of nations. Short-term selfish gains and show of power become the main driver of the foreign policy. Moral obligations, long-term stability, and commitment to international agreements are easily superseded by the so-called national interest seen through narrow lenses. Nationalism as a political strategy goes against the idea of globalism and multilateralism.





Populists have been rising to power advocating economic nationalism, which asks for protectionist policies and promoting political nationalism through xenophobic rhetoric. They frame the national interest outside global peace and inclusive development in this interconnected interdependent world. The nationalistic view looks at international institutions with scepticism and rejects the importance of global cooperation. With its 'superiority' mindset, nationalists advocate isolationism as the best and safest way of achieving lost glory.

Unfortunately, the world is now swamped with nationalist forces. Particularly, when confronted with challenges like a once-in-a-century pandemic, it has lost its way for survival against an unprecedented climate change, passing through the third wave of large-scale human migration and facing the worse economic recession since World War II. There is a need for multilateralism more than ever, but unfortunately, it has lost its way.

The UN Secretary-General, Antonio Guterres, on November 9, 2018 told the Security Council that the world needs to strengthen international relations and join hands to combat complex global threats. He stressed that the rising nationalism has put multilateralism under severe stress and threatened its seven decades of achievements in saving lives and generating economic and social progress.

Even there has been a defeat of nationalist ad-

ministration in the US, the threat of nationalism to multilateralism is still severe. Vaccine national ism has almost been a norm. Nationalism has also stopped the Security Council from taking a distinct position on the coup in Myanmar, civil war in Tigray, and considering global climate change as a security threat.

The rise of nationalism has pushed the countries to take unilateral positions and actions, and it has also guided them not to adhere to rules and norms of multilateralism. While the world is coming under increasing pressure from a lingering pandemic, climate change, economic recession, and migration issues, an effective multilateralism only, not unilateral or bilateral approach, can provide a powerful platform to tackle global and local challenges that appear to grow in scale and complexity.

Multilateralism is critical to maintaining international legal order, and a "go-alone" approach of nationalists is not sustainable to global peace and security. Multilateralism is not an end in itself, but it is a necessary means to collective peace and collaborative progress. Collective intelligence and astute leadership needs to be developed to counter isolationist, nationalist forces

The world must reconfirm multilateralism's primacy to steer the global idea of commons.

What To Eat Before And After Your **COVID-19 Vaccine To Lessen Side Effects**

Eat and drink these foods and beverages, and you'll give your immune system the best chance to respond well and recover quickly.

y May 1, all Americans will be eligible for a COVID-19 vaccine. Five states (Alaska, Arizona, Mississippi, Utah and West Virginia) have already opened vaccines to all adults over 16, with others planning to follow.

According to the Centers for Disease Control and Prevention, side effects of the vaccines can include pain, redness and swelling at the injection site, as well as possible fever, headache, tiredness, nausea, chills and muscle pain. These symptoms are actually a good sign that your body is building immunity, and they will usually pass in a few days (if they do not, call your doctor), the CDC advises.

But there are small steps you can take to lessen those side effects, and many of them have to do with vour diet.

Helpful foods and beverages for dealing with vaccine side effects

Obviously, it's not fun feeling under the weather for a few days, which is especially possible after your second dose of the Pfizer or Moderna vaccine. "Budget for adequate rest and sleep when taking the vaccine, and maybe going easy on exercise," advises Dr. Ronald Hoffman, a New York City integrative physician. Beyond that, he said, there are some simple do's and don'ts in terms of food and drink.

Do: Try ginger tea for nausea

Ginger has a reputation as an excellent and safe traditional remedy for gastrointestinal complaints. Ginger tea is easy to make, and a simple recipe can be found here.

Don't: Fast or do anything "drastic like juicing or detox"

"The development of immunity depends on the body 'reading' instructions from the vaccine and synthesizing antibodies and white blood cells, which requires adequate protein in the diet," Hoffman said.

Do: Hydrate with healthy fluids

From water to tea to your favorite flavored sparkling water, drink up. The fever a vaccine may induce can lead to dehydration.



Do: Eat a healthy, Mediterranean-style diet

Try to start eating especially healthy a few weeks ahead of your appointment for a vaccine. A Mediterranean-style diet is known to have anti-inflammatory effects, but it'll take a few weeks to kick in.

"Preconditioning your body for a few weeks beforehand makes more sense than just being abstemious in the immediate aftermath of the shot," Hoffman said.

The diet emphasizes vegetables, fruits, whole grains, healthy Omega-3 and monounsaturated fats (like those in olive oil), fish, poultry, beans and eggs Dairy and red meat are limited. One study found that individuals over 65 years of age who ate five or more servings of fruit and vegetables per day had a stronger immune response to a pneumococcal vaccine than peers who ate two servings or fewer

Do: Consider eating a low glycemic index diet for at least a few days after the vaccine

A low glycemic index diet will keep your blood sugar steady. Research centered around diabetes has shown that lower glucose levels tend to be anti-inflammatory. In general, foods that keep blood sugar at healthy levels include green vegetables, most beans, whole grains and multigrain breads, fruits like berries and apples, and of course healthy lean proteins, eggs and nuts.

Do: Turn to that favorite remedy of all time, chicken soup

A nice healing broth with many well-cooked veggies is easy to digest and nourishing.

Do: Fine-tune your gut health to increase your immune response

Across the human population, immune response to vaccines varies. Some of this depends on age - as

we get older, our immunity wanes. Some of it depends on individual variation. And some of it depends on the type of vaccine you receive.

An important aspect of vaccine response, and of immunity in general, is a healthy gut microbiome, said Dr. Todd Born, a naturopathic physician and certified nutrition specialist in Washington. Not only are vaccine responses variable, but Born said that a healthy gut microbiome has been shown in scientific studies to increase immune response to vaccines.

"A diverse and healthy microbial community in the gut will influence the immune system directly,' Born told HuffPost.

Born recommends a high-fiber diet and fermented foods, and to "start two weeks before the vaccine and continue for a minimum of two weeks after.'

"Fiber-rich diets encourage the growth of beneficial bacteria that support the immune response,' he explained. And fermented foods from yogurt and kefir to kimchi and sauerkraut can help enhance the gut microbes that support immune response.

Studies have actually shown that some common probiotic organisms, such as lactobacillus rhamnosus, can improve the antibody response to vaccines. This and other healthy lactobacilli can be found in products in your supermarket these include kefir, yogurt, and some fermented beverages.

Born also likes a homemade "immune support" soup, which he often recommends to patients during cold and flu season. He recommended adding chopped onion and garlic, grated ginger, juice from half a lemon, fresh minced parsley and one grated carrot to a quart of miso, chicken or mushroom broth. Simmer for 15 minutes and add the parsley and lemon juice at the end.

While you sip that nourishing soup and let your immune system do its work, play some uplifting music and make a gratitude list. Thirty years of research has shown that stress, depression and loneliness can impair the immune system's response to vaccines.

So, nourish your body with healthy food and drink, stay hydrated, rest well and be of good cheer. You'll be giving your immune system the best chance to respond well to the vaccine and to recover quickly.

'Drinking beetroot juice can result in healthy ageing'

he findings of a recent study suggest that drinking beetroot juice promotes a mix of mouth bacteria that are associated with healthier brain function and blood vessels.

The findings of the study were published in the journal 'Redox Biology'.

Beetroot - and other foods including lettuce, spinach, and celery - are rich in inorganic nitrate, and many oral bacteria play a role in turning nitrate into nitric oxide, which helps to regulate blood vessels and neurotransmission (chemical messages in the brain).

Older people tend to have lower nitric oxide production, and this is associated with poorer vascular (blood vessel) and cognitive (brain) health.

In the new study, by the University of Exeter, 26 healthy older people took part in two ten-day supplementation periods: one with nitrate-rich beetroot juice and another with nitrate-free placebo juice, which they drank twice a day. The results showed higher levels of bacteria associated with good vascular and cognitive health, and lower levels of bacteria linked to disease and inflammation.

Systolic blood pressure dropped on average by five points (mmHg) after drinking the beetroot juice.

"We are really excited about these findings, which have important implications for healthy ageing," said lead author Professor Anni Vanhatalo, of the University of Exeter.

"Previous studies have compared the oral bacteria of young and older people, and healthy people compared to those with diseases, but ours is the first to test nitrate-rich diet in this way," added Vanhatalo.

Vanhatalo further noted, "Our findings suggest that adding nitrate-rich foods to the diet - in this case via beetroot juice - for just ten days can substantially alter the oral microbiome (mix of bacteria) for the better. Maintaining this healthy oral microbiome in the long term might slow down the negative vascular and cognitive changes associated with ageing."



The researchers ran tests to identify clusters or "modules" of oral bacteria that tend to thrive together in similar conditions. A module (Prevotella-Veillonella) that has been associated with

inflammation was reduced after nitrate supplementation, including a decrease of Clostridium difficile (which can infect the bowel and cause diarrhoea).

Professor Vanhatalo stressed that more research is needed to confirm the findings and see whether similar effects are found in other groups.

"Our participants were healthy, active older people with generally good blood pressure," she said. "Dietary nitrate reduced their blood pressure on average, and we are keen to find out whether the same would happen in other age groups and among people in poorer health." "We are working with col-

"We are working with colleagues in the University of Exeter Medical School to investigate interactions between the oral bacteria and cognition to better understand how diet could be used to delay cognitive decline in older age," Vanhatalo added.

Much research has been conducted into the benefits of a healthy gut microbiome, but far less is known about the oral microbial community, which plays a crucial role in "activating" the nitrate from a vegetable-rich diet.

Here's how harmful chemicals in plastic up risk of postpartum depression

omen exposed to endocrine-disrupting chemicals commonly found in plastics during pregnancy are at a higher risk of experiencing postpartum depression, suggested a new study. The findings of the study were published in the Endocrine Society's Journal of Clinical Endocrinology and Metabolism. The study also found that these harmful chemicals may influence hormonal shifts during pregnancy

Postpartum depression is a serious and common psychiatric disorder that affects up to 1 in 5 childbearing women. The cause of postpartum depression is not well understood but hormonal changes during pregnancy have been found to be an important factor. Harmful chemicals such as bisphenols and phthalates that are found in plastics and personal care products are known to affect sex hormones "We found that phthalate exposure was associated with lower progesterone levels during pregnancy and a greater likelihood of developing postpartum depression," said study author Melanie Jacobson, Ph.D., M.P.H. of the NYU Langone Medical Center in New York, N.Y.

Low-calorie diet, exercise may improve survival for leukemia adolescents: Study

ccording to a new study, overweight children and adolescents receiving chemotherapy for treatment of leukemia are less successful battling the disease compared to their lean peers.

In some cancers, including leukemia in children and adolescents, obesity can negatively affect survival outcomes. Obese young people with leukemia are 50 per cent more likely to relapse after treatment than their lean counterparts.

Now, a study led by researchers at UCLA and Children's Hospital Los Angeles has shown that a combination of modest dietary changes and exercise can dramatically improve survival outcomes for those with acute lymphoblastic leukemia the most com-



more likely to be found in overweight individuals, are associated with worse survival and a higher risk of relapse, often leading to more intense treatinsulin sensitivity and an increase in the beneficial hormone adiponectin, which is involved in regulating glucose and breaking down fatty acids.

Most importantly, the researchers found a 70 per cent decrease in the chance of having lingering leukemia cells in the bone marrow -known medically as a minimal residual disease -- when compared with a historical control group.

"We hoped the intervention would improve outcomes, but we had no idea it would be so effective," Mittelman said.

Mittelman noted, "We can't really add more toxic chemotherapies to the intense initial treatment phase, but this is an intervention that likely has no negative side effects. In fact, we hope it may even reduce toxicities caused

by chemotherapy." "This is the first trial to

Jacobson added, "This re-

search is important because phthalates are so prevalent in the environment that they are detectable in nearly all pregnant women in the United States. If these chemicals can affect prenatal hormone levels and subsequently postpartum depression, reducing exposure to these types of chemicals could be a plausible avenue for preventing postpartum depression."

The researchers measured the levels of bisphenols and phthalates in urine samples and sex hormones in blood samples from 139 pregnant women. They assessed these women at four months postpartum using the Edinburgh Postnatal Depression Scale (EPDS) and found women with higher were

levels of phthalates in their urine were more likely to develop postpartum depression. The women also had lower levels of progesterone, a hormone that plays an important role in the menstrual cycle, in maintaining the early stages of pregnancy and in modulating mood.

"These results need to be interpreted with caution as this is the first study to examine these chemicals in relation to postpartum depression and our sample size was small," Jacobson concluded. mon childhood cancer.

The findings of the study were published in the American Society of Hematology's journal Blood Advances.

The researchers found that patients who reduced their calorie intake by 10 per cent or more and adopted a moderate exercise program immediately after their diagnosis had, on average, 70 per cent less chance of having lingering leukemia cells after a month of chemotherapy than those who did not go on the diet-and-exercise regimen.

Mittelman added, "But even with these mild changes in diet and exercise, the intervention was extremely effective in reducing the chance of having detectable leukemia in

'People with severe gum infection have increased blood pressure'

ccording to a study published in Hypertension, an American Heart Association journal, people, with severe gum infection called periodontitis, may have more chances of higher blood pressure compared to individuals who had healthy gums.

Previous studies have found an association between hypertension and periodontitis, however, research confirming the details of this association is scarce. Periodontitis is an infection of the gum tissues that hold teeth in place that can lead to progressive inflammation, bone or tooth loss.

Prevention and treatment of periodontitis are cost-effective and can lead to the reduction of systemic markers of inflammation as well as improvement in the function of the endothelium (thin membrane lining the inside of the heart and blood vessels).

"Patients with gum disease often present with elevated blood pressure, especially when there is active gingival inflammation or bleeding of the gums," said lead study author Eva Munoz Aguilera, D.D.S., M.Clin.Dent., senior researcher at UCL Eastman Dental Institute in London, United Kingdom.

"Elevated blood pressure is usually asymptomatic, and many individuals may be unaware that they are at increased risk of cardiovascular complications. We aimed to investigate the association between severe periodontitis and high blood pressure in healthy adults without a confirmed diagnosis of hypertension," Aguilera added.

The study included 250 adults with generalised, severe



periodontitis (50 per cent of teeth measured with gum infection) and a control group of 250 adults who did not have severe gum disease, all of whom were otherwise healthy and had no other chronic health conditions.

The median age of the participants was 35 years and 52.6 per cent were female. The research was completed in collaboration with the department of dentistry at the Universitat Internacional de Catalunya in Barcelona, Spain.

All participants underwent comprehensive periodontal examinations including detailed measures of gum disease severity, such as full-mouth dental plaque, bleeding of the gums, and the depth of the infected gum pockets.

Blood pressure assessments were measured three times for

each participant to ensure accuracy. Fasting blood samples were also collected and analyzed for high levels of white blood cells and high sensitivity C-reactive protein (hsCRP), as both are markers of increased inflammation in the body.

Additional information analysed as confounders included family history of cardiovascular disease, age, body mass index, gender, ethnicity, smoking, and physical activity levels.

57% Indian Businesses Experience Unexpected Downtime In 2020 Due To Data Loss

Tith a majority of businesses shifting to online work options due to the coronavirus pandemic, organisations now have additional aspects to factor in - data loss, data protection and privacy. And, many are failing.

A global survey by security firm Acronis found that 57 percent of Indian organisations experienced unexpected downtime due to data loss in 2020, the Hindu BusinessLine reported.

Notably, this is despite 70 percent of Indian companies running as many as 10, and the remaining 30 percent running more than 10 simultaneous solutions to meet their cybersecurity and data protection requirements, the Cyber Protection Week survey found.

The survey had 4,400 respondents from 22 countries, including India. As per the survey report, investing in more solutions did not deliver more protection but in many cases "created greater complexity and less visibility for the IT team.'

Rustom Hiramaneck, General Manager – South Asia at Acronis said the survey "clearly illustrates that using separate tools to address individual types of exposures is complicated, inefficient, and costly."

He added: "These findings confirm our belief that the smarter approach is cyber protection, which unifies data protection, cybersecurity, and end-

India Gold Lenders Cut Tenor, Seek **More Collateral As Prices Plunge**

Tndian firms that lend against gold are cutting tenors and seeking more collateral to protect against the plunge in prices of the precious metal.

Market leader Muthoot Finance Ltd. has been offering discounts on interest rates and other incentives to borrowers who chose to repay monthly or more frequently. Rival Muthoottu Mini Financiers Ltd. is mostly lending for 90 days 270 previously and most large firms are disbursing amounts well below regulatory limits, which was 75 per cent of the metal's value for shadow lenders and 90 per cent for traditional banks through March 31. Gold loans had boomed over the past year as small businesses tried to revive themselves from lockdowns by pledging family jewelry that's a staple of almost all Indian households. Muthoot Finance, for instance, saw such lending increase 25 per cent over the period and the company holds 146 tons of gold, higher than the official reserves of Singapore and Sweden. "People are sentimental about their jewelery," said George Muthoot Alexander, managing director at Muthoot Finance. "They will never want to default despite a fall in gold prices as they intend to get back their pledged ornaments." Gold posted its first quarterly drop in more than two years amid improving expectations for the global economy and fading demand from exchange-traded funds. The metal has fallen more than 9 per cent in 2021 as investors trade their havens for assets

Further, 35 percent of Indian users and 41 percent global users said they did not update their device at least for a week, even after being notified of a patch.

An Indian tax intelligence unit in mid-March ordered HSBC and Citibank in Mumbai to freeze bank accounts of ByteDance India as it probed some of the unit's financial dealings. ByteDance has challenged the freeze on the four accounts in a Mumbai court.

Blocking accounts "during the process of investigation amounts (to) applying undue coercion," Byte-Dance argued. It is "intended, improperly, to harass the petitioner."

Trai's New Survey To Assess Tariff Plans

NEW DELHI: Telecom regulator Trai is planning to conduct a consumerfacing survey to assess if tariff plans offered by operators are meeting actual requirements of varied catego-

ries of users, a top official said. Telecom Regulatory Authority of India (Trai) may rope in an agency to conduct the survey for it. The survey is expected to start soon, said a Trai

official privy to the development. While telecom tariffs are under forbearance, the sector regulator will assess if plans currently being offered in the market are consumer-

The tariffs plans need to cater to actual needs of consumers, those looking for voice as well as those who have data requirements. The idea is to ensure that consumers are not being nudged towards a particular type of tariff plan. The concern is whether certain packs in market tend to be similar, despite require-



ments being very different, for different categories of users, including feature phone users.

Trai may rope in an agency to conduct the survey, which is expected to initially focus on consumers in small pockets. The modalities, including medium of conducting the survey, will be worked out in coming days.

Asked about the trigger for the survey and if TRAI had noted any ambiguities, the official said overall the role of the regulator is to keep a watch on the market to ensure that the sector is functioning smoothly, and consumer interests are being addressed. At present, the tariffs are under forbearance, meaning that operators virtually have a free hand in fixing the rates and report plans to Trai in seven working days of launch.

Rupee Slumps 31 Paise to 73.43 Against USD in Early Trade

MUMBAI: The Indian rupee slumped 31 paise to 73.43 against the US dollar in opening trade on Monday amid concerns over rising COVID-19 cases.

Besides, losses in domestic equity markets also weighed on investors' sentiment. At the interbank forex market, the domestic unit opened at 73.38 against the US dollar, then fell further to 73.43, registering a decline of 31 paise over its previous close.

On Thursday, the rupee had settled at 73.12 against the American currency. The forex market was closed on April 2, on account of Good Friday.

The Indian rupee started weak this Monday and may weaken further against the dollar on concerns over India's economic outlook following a further increase in coronavirus infections. Reliance Securities said in a research note. India recorded an alltime high of 1,03,558 coronavirus infections in a day pushing the nationwide COVID-19 tally to 1,25,89,067,

according to the Union Health Ministry data updated on Monday. Asian currencies were range-bound, and volumes were lower than usual with China, Hong Kong, UK and Australian markets shut, the note said.

The major driving factor this week will be the Reserve Bank of India's (RBI) monetary policy meeting.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, fell 0.02 per cent to 92.99.

Brent crude futures, the global oil benchmark, declined 0.89 per cent to USD 64.28 per barrel.

On the domestic equity market front, the 30-share BSE benchmark Sensex was trading 1,309.3 points lower at 48,720.53, and the broader NSE Nifty fell 367.40 points to 14,499.95.

Foreign institutional investors were net buyers in the capital market as they purchased shares worth Rs 149.41 crore on Thursday, according to exchange data.

'Please, Release My Father', Appeals Daughter Of CoBRA Commando Kidnapped By Naxals

JAMMU: "Please, release my father", pleaded five-yearold Shragvi, the daughter of a CoBRA commando held hostage by Naxals after an ambush in Chhattisgarh.

This is all a sobbing Shragvi could utter as she wiped away her tears. The family of Commando Rakeshwar Singh Minhas was in deep shock after the news of the deadly ambush on Saturday and his disappearance broke out.

At least 22 security personnel were killed in the attack on the CoBRA battalion of CRPF by the Naxals who claimed that they had abducted Minhas after the ambush

"We came to know about the

attack and that he went missing

during action from news channels. Nobody from the government or the CRPF informed us about the incident," Meenu, the wife of Minhas, told reporters at her residence in Barnai area

on Jammu-Akhnoor road. She said she made frantic efforts to reach out to the CRPF headquarters in Jammu to know the whereabouts of Minhas. "I was told that there is nothing we can share with you. Once we get a clear picture, we will come to you," Meenu said as having been told by the CRPF officers.

With her daughter in her lap who also pleaded for the safe return of her father, she said an officer also visited her house and repeated the assurance.

She said Minhas had not picked up the phone since "we talked for the last time" on Friday at 9.30 pm when he was leaving for duty. Meenu said it was the government's duty to ensure his safe return to his family.

"My husband served the country for the last 10 years and now it is the turn of the government to ensure that he returns to us hale and hearty," she said surrounded by relatives who were there to support the family through the ordeal

"Minhas joined the CRPF in 2011 and he has been serving the nation for the last 10 years. He was transferred to Chhattisgarh only three months back from Assam," she said, holding back her tears.

"I got a telephone call from a person who introduced himself as a local reporter from Chhattisgarh. He wanted me to send a picture of my husband along with an appeal to the Naxals," Meenu said.

However, she did not respond to his calls after discussing the matter with her family. Meenu appealed to Lt Governor Manoj Sinha to take up the matter with the Union government and urge the prime minister and home minister for his safe return.

'We Wake Up To See

"We're living in a continuous state of fear from last two year because these landslides keep no calendar.

No wonder why, he says, people have grown paranoid and panicky in Shripora.

The crumbling life has also redefined the rustic routine and disrupted its ties with the neighbouring villages.

"Our tragedy is now isolating us from others," Ashraf says, walking through the derelict structures. "Mindful of our precarious situation, people from other parts are now refusing to wed their wards in our village."

Some hours into the conversation and an old man with a long flowing grey beard starts detailing Shripora's sliding situation.

With his wrinkled face and sunken eyes, Mohammad Jamal Dar has an ageless feel about him. Yet, his concern for his dispersing community is aging him fast. Like others, he's also seeking closure to the home crisis

Dar takes me to the other side of the village where cracks on the walls are widening, so are worries and woes. His endless destitution detailing clearly makes a case for the village desperately waiting for an intervention.

"People aren't doing well economically here," says Dar, a village patron figure. "Over the years we've toiled hard to construct these houses, but destiny is rendering us homeless."

Besides losing their homes to the loose land, Dar's tribe is equally facing official inertiamaking them feel abandoned and agonized lots of Baramulla's northern heights.

But this gloomy situation hardly stops weary townspeople from frequenting this haunted village for an escape route. While Shripora is a retreat zone for sightseers, it's a "bottomless pit" for the natives.

Dar says that landslides started some two years back and till today, they're far from over.

"Natives are fighting nature here," he adds. "We can't explain why it's happening to us. But the idea of losing homes is making all of us restless.

Out of almost 300 families, the villagers say, fifty have completely lost their homes, while over hundred have suffered damages.

Many homeless families are now

it," says Mohammad Akbar, a shopkeeper in Shripora.

"We're cut from the rest of the other villages for almost two months now due to this sliding ground situation here. But then, since it's the season of farming, we're compelled to take our children to farms in a fearful state of mind to earn our livelihood.'

Although a few families were lately compensated, the far cry remains that the whole village should be rehabilitated to avoid any untoward incident.

Amid all this, none seems to have any clear clue about Shripora's landslide situation.

"Call it nature's wrath or some yet to be unearthed phenomenon, but whatever it is, we're ending up homeless in the process," says Akbar.

Down the hill, some earth science experts are calling for detailed geo-technical studies to map and mitigate Shripora's landslide situation.

"As far as I know, this area is prone to landslides due to Karewas," says Mohammad Sartaj, Geology and Mining officer in Baramulla.

"An official expert team is currently studying this sinking situation there. But while the land is continuously crumbling and the study likely to take some time to unearth the situation, the villagers must be shifted to some other places for a time being for their safety.'

But at sundown, as I leave Ashraf behind at the crumbling heights, his fear arises from the ruins of Shripora: "What if all of us fall into the bottomless pit tonight!'

tin sheds. This past winter, Dar says, the vale's classic cold almost froze families inside those tin sheds.

But while some stayed and fought the vagaries of weather, many migrated to other places. Some are living with their relatives here and there.

One of the tin-shed dwellers, Abdul Khaliq Lone takes me to the place where once he shared laughter and lively moments with his family. But now, the home is a tumbledown structure on the caved-in courtvard.

"We've been witnessing this crestfallen situation over the years," Lone says, as he stares at his lost home, "but it hardly creates any hue and cry in the official circles. Our plight is yet to move them."

As desperate dwellings, even those makeshift sheds make life highly uncertain for the villagers.

"As landslides strike frequently and crumble a sense of calm here, chaos and confusion is engulfing our lives," Lone laments.

"We don't even have an option of migration because we're dependent on our orchards and paddy fields here. If we move out, our family will starve.'

Shripora's shaky ground situation only turns dangerous when it rains.

A week before my arrival, the rain had swept the village and created another wave of destruction.

Many villagers are now collecting bits and pieces of what used to be their home barely seven davs ago.

"Whenever it rains," Lone says, "we end up losing everything. Though these heavenly waters are needed for our farms, we keep praying against it now. Nothing hurts more than losing your home to a blessing!

Even in its visibility, the commoner's life torn asunder by the crumbled earth is harrowing. Besides a growing sense of destitution, Shripora is full of native narratives of despondency today.

To capture the crisis in detail, I climb a rickety flight of steps inside an abandoned home to get to the terrace. From that vantage point, the village looks a dreamy spot mired in an unending nightmare.

Dented land, poor drainage, sweeping destruction and distressed souls together torment Shripora's simpletons.

And while the crisis persists, the absence of crisis-managers is making the villagers feel as if they're "children of a lesser god".

"The successive governments have totally overlooked this village in terms of development and now we're bearing the brunt of

"During checking, incriminating material including letter pad of TRF outfit has been recovered from his possession," the police spokesperson said.

"In this regard, a case vide FIR No. 82/2021 under relevant sections of law stands registered at police station and further investigation into the case is in progress and more arrests are expected," he added.

After Fakhar Zaman's **Controversial Run-Out, MCC Says** It's Up To Umpires To Decide

LONDON: Pakistan's Fakhar Zaman's contentious run-out in the second ODI against South Africa has sparked a debate on spirit of the game with Marylebone Cricket Club saying it was "up to the umpires to decide" if Quinton de Kock had attempted to mislead the batsman.

In a stiff chase of 342, Zaman smashed a spectacular 193 in a losing cause as the batsman was run out in a controversial fashion involving South Africa wicketkeeper de Kock.

The stumper pointed his finger towards Lungi Ngidi but the ball was, in fact, thrown by Aiden Markram towards the keeper's end and it was a direct hit. Zaman had slowed down his pace at the end of his second run and could not make it back into his crease.

Replays showed that de Kock had seemed to convince Zaman into believing that the throw was going to the non-striker's end.

"Law 41.5.1 states: It is unfair for any fielder wilfully to attempt, by word or action, to distract, deceive or obstruct either batsman after the striker has received the ball," the MCC, custodians of the game, tweeted.

In another, the MCC wrote, "The Law is clear, with the offence being an ATTEMPT to deceive, rather than the batsman actually being deceived. It's up to the umpires to decide if there was such an attempt. If so, then it's Not out, 5 Penalty runs + the 2 they ran, and batsmen choose who faces next ball."

The debate around de Kock's gesture was whether he was intentionally attempting to deceive Zaman into thinking that the throw was headed for the other end, leading to the batsman slowing down his pace while going for the second run at the Wanderers on Sunday.

Many in the Pakistan cricket circles blamed de Kock for "deliberately distracting" Zaman, leading to his dismissal.

Former captain Waqar Younis and fast bowler Shoaib Akhtar questioned the South African's act. "What a master inning by @ FakharZaman. Treat to watch. Single handedly brought the game here. Sad end to the inning. Deserved a 200. Was the spirit of the game compromised by South Af-

rica & @QuinnyDeKock69 in that run out?" Akhtar asked in a tweet. Wagar wrote on his twitter handle, "Record breaking inning. Simply Outstanding @FakharZamanLive. What about this cheeky giggle from Quinton tells you?"

Pakistan lost the game by 22 runs as the hosts levelled the three-match series 1-1.

ICC Law 41.5 says: "Deliberate distraction, deception or obstruction of batsman. 41.5.1 in addition to 41.4 states it is unfair for any fielder wilfully to attempt, by word or action, to distract, deceive or obstruct either batsman after the striker has received the ball." However, the Pakistani opener,

who achieved the highest score by a batsman in an ODI chase, refused to blame de Kock.

"The fault was mine as I was too busy looking out for Haris Rauf at the other end as I felt he'd started off a little late from his crease, so I thought he was in trouble. The rest is up to the match referee, but I don't think

it's Quinton's fault.' "I played a very good innings but it would have been better if we had won the match," Fakhar said after the game.

South African captain Temba Bavuma said de Kock's act was "auite clever".

"You've always got to look for ways especially when things are not going your way, got to find ways to turn momentum around.

KARACHI: Pakistan all-rounder Shadab Khan was on Monday ruled out of the remainder of the South Africa tour due to a toe injury that will keep him out him out of action for four weeks.

'PSL 6 Bio-Bubble Broken And Compromised On Several Occasions,' Reveals PCB

KARACHI: An independent fact finding committee of the Pakistan Cricket Board (PCB) has confirmed that the bio-bubble set up for the PSL 6 was broken and compromised on several occasions.

The two-member committee of infectious diseases experts was constituted by the PCB to probe what went wrong with the bio-secure bubble in PSL 6 The final report of Dr Syed Faisal Mahmood and Dr Salma Muhammad Abbas was submitted to the PCB chairman Ehsan Mani on March 31. The PCB chief will now study the report and share the details with the board members before any final decision is taken. But a source privy to the findings of the committee said that while it had not blamed any particular individual, the report had confirmed that there were several occasions when the bio-secure bubble was compromised during the tournament in Karachi.

The source said the committee had also made recommendations on how the board can ensure a safe and secure bio-secure bubble for stakeholders when the PSL 6 resumes in June.

The PSL 6 was postponed by the PCB in early March after just 10 of the 34 matches were completed following a rise in CO-VID-19 cases in the event.

The PCB had to postpone PSL 6 bruptly after several players. cluding foreigners Fawad Ahmed, Tom Banton, Lewis Gregory and some local players and officials had contracted the virus despite remaining in a bio-secure bubble. Interestingly, the source said the experts had mentioned that some stakeholders had even brought to notice of some PCB officials about the bio-secure breaches but they didn't respond

Betting Can Lead To Match-Fixing, Govt Right In Not Legalising It: New BCCI ACU Chief

NEW DELHI: The BCCI's new Anti-Corruption Unit chief Shabir Hussein Shekhadam Khandwawala doesn't want betting to be legalised in India as it "encourages" matchfixing and feels his biggest challenge will be stamping out "shady activities" from smaller leagues.

There is a school of thought that legalising betting will bring in massive revenues for the government at a time when most of it is going unchecked. But Khandwawala looks at it differently.

"Whether the government legalises betting or not that is a different matter but deep inside, I feel as a police officer that betting can lead to match fixing. The government, so far, has rightly not legalised betting," the 70-year-old told PTI.

"Betting encourages match fixing. So there should not be any change on this, we can make the rules more strict. We will work on that. It is a matter of great prestige that cricket is largely free of corruption. Credit should go to BCCI for that."

In the words of outgoing BCCI ACU chief Ajit Singh, legalising betting is another way of controlling corruption in the game.



Union minister and former BCCI president Anurag Thakur, too, had suggested legalising underground betting and gambling sporting activities last year.

However, Khandwawala, a former DGP of Gujarat, feels otherwise on the subject.

"Betting might be legal in some countries but the people who go into stadiums to watch the game and watch it on television they believe in this game and don't go to grounds

thinking this game could be fixed. We need to protect their belief that game is free of all corruption." While the game at the highest

level remains more or less clean, corruption cases have come to light

in the local and state T20 leagues. With the shortest format thriving, Khandwawala said detecting and preventing "shady" practices in these leagues will be his team's biggest challenge.

"Our top players are so well paid that they are miles from the menace of match-fixing. We should feel proud about that. "Rooting out corruption from

smaller events and leagues is a big challenge and we need to put an end to it. We need to ensure there is nothing shady happening at all levels of cricket being played in the country. Besides detecting, preventing any shady activity is very important," he said.

Khandwala feels his love for the game should help him immensely in this new role.

"During my time as a police officer, I organised many (police) tournaments in Gujarat. I have loved the game since childhood.

"A lot of good work has been done in the past and I need to carry that forward. New players coming into the scene are most vulnerable. We need to protect them."

Khadwawala's first assignment with the BCCI will be the IPL beginning April 9.

Data Of 61 Lakh Indian Facebook Users Allegedly Leaked Online: Expert

NEW DELHI: Personal details such as phone numbers of around 6.1 million (61 lakh) Indians on Facebook have allegedly been leaked online and posted on hacking forums, according to a cybersecurity executive. According to Alon Gal, co-found-

er and chief technical officer of cybersecurity firm Hudson Rock, personal data of 533 million Facebook users globally - including names, phone numbers and other details - was allegedly leaked online and posted for free on hacking forums. "All 533,000,000 Facebook re-

cords were just leaked for free. This means that if you have a Facebook account, it is extremely likely the phone number used for the account was leaked," Mr Gal has said in a tweet flagging the issue. A list of countries that was

shared in the tweet, showed that information of 6.1 million users from India. 32.3 million from the US, 11.5 million from the UK and 7.3 million from Australia, was part of the leaked data.

When contacted, a Facebook company spokesperson said: "This is old data that was previously reported on in 2019. We found and fixed this issue in August 2019". Mr Gal said in early 2020, a vul-

nerability - which enabled seeing the phone number linked to every Facebook account - was exploited, creating a database containing the

The total electorate in the state includes 1.32.83.724 male voters. 1,41,62,025 female voters and 290 transgenders, according to Election Commission figures.

As the high-octane public campaign drew to a close last night, the southern state is now witnessing silent electioneering in which candidates and party workers are busy visiting homes and institutions to seek votes at the last minute. An array of ministers and sev-

eral sitting MLAs from both the traditional coalitions- the CPI(M)-led Left Democratic Front (LDF) and the Congress-headed United Democratic Front (UDF) are seeking another term in the April 6 polls.

Chief Minister Pinarayi Vijayan, health minister K K Shailaja, Devaswom Minister Kadakampally Surendran, Power Minister M M Mani and Higher Education Minister K K Jaleel are among the prominent personalities trying their electoral luck from the ruling side.

Opposition leader Ramesh Chennithala, former Chief Minister Oommen Chandy, senior leaders K Muraleedharan, PTThomas and Thiruvanchoor Radhakrishnan are among those contesting from the UDF fold.

The election is crucial for an array of BJP leaders including former Mizoram Governor Kummanam Rajasekharan, 'Metroman' E Sreedharan, who joined the saffron party recently, state president K Surendran, senior leader Shobha Surendran, Rajya Sabha members Suresh Gopi and K J Alphons and others.

The April 6 poll is equally significant for Kerala Congress (M) chief Jose K Mani who recently snapped decades-long ties with the UDF and joined hands with the Left front.

It would be a litmus test especially for Congress leader Rahul Gandhi personally as he had camped in the state for several days and taken part in dozens of corner meetings and rallies across Kerala to campaign for the UDF.

To consolidate votes of majority community and keep devotees with them, the BJP even promised in their manifesto a law to contain alleged 'love jihad' and even a state legislation to protect the customs and traditions of the Sabarimala temple.

The topics of faith, religion, development and welfare have taken a centre-stage throughout the campaigns.

The state witnessed how the ruling LDF strived hard to bring focus of the poll debate on the agovernment's achievements in the development and welfare fronts in the last five years and its much celebrated COVID-19 and flood management.

But, the Congress-UDF and BIP-NDA have tried their best to make a topic of discussion the Sabarimala women entry issue and the controversial gold and dollar smuggling cases, in which the Chief Minister's office, Speaker P Sreeramakrishnan and some other ministers were facing allegations.

The LDF, who projected themselves as the sole saviour of minority communities especially in Muslim-dominated Malabar (north Kerala) districts during the campaign, is calculating that their votes would be consolidated enmass in their favour.

They also accused the Congress of adopting a soft stand towards the Hindutva agenda to pick a hole in their vote-bank.

The Congress was seen reaching out to prominent figures and institutions related to Hindu, Christian and Muslim religions to ensure their support. Besides wooing the majority community votes by promising a law to check 'love jihad' and protect the tradition of Sabarimala, the BJP also tried to reach out to the Christian community during the campaign.

Recently, the Indian government tightened rules governing social media, requiring them to take down contentious content quicker. appoint grievance redressal officers and assist in investigations.

The rules, announced in February, have been designed to curb misuse of social media platforms, mandate that platforms appoint executives to coordinate with law enforcement remove contentious content flagged by the government or legal order quickly and that user grievances be resolved within 15 days.

The government is also crafting data protection law to ensure privacy, safety and security of user data. These include provisions around the handling of data of adults and minors, storage within the Indian borders and penalties for non-compliance.

NEW DELHI: March was third warmest in 121 years in terms of monthly average maximum temperature, the India Meteorological Department on Monday said.

The IMD, in its review for the month, said the observed monthly average maximum, minimum and mean temperature for the country as a whole during March this year are 32.65 degrees Celsius, 19.95 degrees Celsius and 26.30 degrees Celsius, respectively, against the normal 31.24 degrees Celsius, 18.87 degrees Celsius and 25.06 degrees Celsius based on the cli-

matology period 1981-2010. "The all India average monthly maximum temperature during March 2021 with 32.65 degrees Celsius is the warmest in the last 11 years, and third warmest in the last 121 years with 2010 and 2004 as the ever warmest and second warmest month with 33.09 degrees Celsius and 32.82 degrees Celsius, respectively," the IMD said. Several parts of the country had recorded temperatures above 40 degrees Celsius in March.

Take Money Being Distributed by BJP And Vote For TMC: Abhishek Banerjee Tells People

rinamool Congress MP Abhishek Banerjee, on Monday, accused the BJP of distributing cash for votes in West Bengal and asked the people to accept the money but exercise their ballot for TMC instead.

There will be anarchy in the state if the saffron party assumes power in West Bengal, Banerjee cautioned the voters.

The BJP is distributing money to the people and asking them to cast their votes for the party. I ask you (the people) to accept the money and not return it, but cast your votes for the smaller flower, referring to the grass flower which is the symbol of TMC and the much larger lotus, the emblem of the saffron party."

"It is your money. The money is from the tax you have paid to the government," Banerjee said addressing different rallies held in Hooghly and Howrah districts in support of party candidates contesting for the phase four of polling slated for April 10.

"If the BJP comes to power in Bengal, there will be anarchy throughout. I will urge you not to vote for them if you want to live without any fear. Look at what is happening in UP and other

states where they are in power. It is time for you to realize the ground situation and cast your vote. Do you want to have biryani a single day or have rice and dal for the next five years ...

It depends on you to decide," he said. Polling will be held in 44 assembly seats spread over the districts of Howrah (Part II), South 24 Parganas (Part III). Hooghly (Part II), Alipurduar and Coochbehar in the fourth phase. Banerjee also accused the BJP of giving grants of Rs 10,000 to each club in West Bengal and asking them to or-

ganise feasts and vote for the party. If the BJP comes to power in the state, it will stop the Swasthya Sathi (cashless health) scheme initiated by TMC chief Mamata Banerjee and in-

stead implement Ayushman Bharat for which only a few will be enrolled as per the central scheme's eligibility, he said. "You will not get free health service then. As per the eligibility criteria of Ayushman Bharat scheme even a person who has a refrigerator is not eligible for it."

Challenging the saffron party to come out with its performance report of the last seven years, Banerjee said "You (the BJP) are claiming to be the world's biggest political party, but if you compare your report card and that of ours we will beat you by 10-0 goals. I will quit politics if I am lying.

"The common people had faced a lot of hardship due to demonetization and the "unplanned" lockdown to check COVID-19 in 2020. Prime Minister Narendra Modi had forced people to stand in queues outside banks, while Mamata Banerjee made them wait for their turn outside ration shops for free rice and wheat," the TMC MP said. He also accused the BIP of selling

the country in its bid at privatisation of Railways as well as the nationalised banks.

Lambasting the Modi government at the Centre, he said "The BJP is selling the country. Look what they (the BJP) have done to it; prices of LPG and fuel have shot up. Is this acche din?... The same leaders are asking for votes to turn Bengal into Sonar Bangla (prosperous Bengal) ... Sonar Bangla has been already built by Mamata Banerjee and that is why she has been internationally acclaimed for her Kanyashree scheme.

The Kanyashree Prakalpa is a conditional cash transfer scheme to improve the status and well being of the girl child in West Bengal by incentivizing schooling of all teenage girls and delaying their marriage until they attain the age of 18. The scheme has won national and international recognition for its design and features of good governance.

Hitting out at BJP's Chuchura candidate and BIP MP Locket Chatterjee, Banerjee said, "I have never heard her speaking about her plans to develop Hooghly district. Her only job is to criticise Mamata Banerjee and to appease the party leadership."

The saffron party knows nothing of the state or its culture, he said referring to BJP's allegations that Durga Puja and Saraswati Puja are not allowed to be held in West Bengal. "The BJP is alleging that Mamata Banerjee does not allow Durga Puja to be held in West Bengal. Do they have any knowledge that under Didi's leadership how many Durga Pujas are organised in the state? The clubs get special encouragement fund from the government to do so.'
