We Support **Direct India**, Pak **Dialogue: US**

WASHINGTON; The United States on Tuesday said that it encourages India and Pakistan to have a direct dialogue between them on issues of concern.

However, the State Department refrained from commenting on the recent decision of the Pakistani Cabinet not to import sugar and cotton from India.

"I wouldn't want to comment on that specifically," State Department spokesperson Ned Price told reporters at his daily news conference.

"What I would say is that we continue to support direct dialogue between India and Pakistan on issues of concern," Price said in response to a question.

In a volte-face, Pakistan's Cabinet on April 1 rejected the proposal of a high-powered committee to import cotton and sugar from India, with Foreign Minister Shah Mahmood Qureshi asserting that there can be no normalisation of ties until New Delhi reverses its decision to revoke the special status of Jammu and Kashmir.

Kashmir's Medicinal Plants Withering

Rehind those quiet visits of god-men or roaming foreigners in DKashmir jungles, a paper in Shodhganga (a reservoir of Indian thesis) reveals, were around 3,000 medical plant species dotting the length and breadth of the valley.

The hunt for natural antidotes in the woods of the region are still underway and sustaining the medical industry. "Kashmiri forests are valued for their rich medicinal plant species,"

says Rafiq Khan, an environmentalist. 'No wonder why in the times of yore those Indian Sadhus would frequent our jungles to take home Jadibuti."

Apart from jungles, the larger landscape houses many plant species found in many ancient treatises. For example, Kusthah (Saussurea Costus) is mentioned for its anti-fever properties.

As a well-known medicinal plant of Kashmir, Kusthahis are found in high mountains. It's a ro-bust, perennial 3-4 feet tall shrub,

with membranous and irregularly toothed leaves that require a humid and cool climate.

Hyundai Says Its New Electric Car Can Power Devices, Cook Dinner

yundai Motor Co. is pitching its new Ioniq 5 as being able to do more than the average EV.

In a series of promotional videos on YouTube, a camper is shown running on a treadmill hooked up to the car's battery, listening to their favorite tunes on a bank of speakers, and even rustling up a roastchicken dinner in a portable oven. The car can supply up to 3.6 kilowatts of power, enough to run appliances like refrigerators and stoves.

It's part of a push by Hyundai to appeal to a younger audience as it plays catch-up in the EV market. The South Korean automaker is behind EV pioneers such as Tesla Inc. and established brands like Volkswagen AG and BMW AG, only introducing its electric car in 2016.

"We looked at the wider meaning of space that would include outdoor and daily activities that consumers can do with their cars," Heung Soo Kim, a senior vice president and head of product and EV businesses, said in an interview last

month. "We are constantly looking into new features that will appeal to users.

Hyundai says it's the first major electric-car maker to offer bidirectional charging, which means owners can power electronic devices from the car battery. While conventional car batteries can be used to charge laptops and phones, they drain quickly if hooked up to anything more powerful, like a portable fridge or sound system, meaning serious campers need to install a dual-battery system or lug around heavy, noisy generators to power their home comforts.

The Ioniq 5 also comes with the option to install a solar-panel roof that will charge the battery pack, giving the vehicle additional driving range of about 1,300 kilometers (800 miles) annually.

U.S.-based EV start-up Rivian Automotive Inc. is also looking to attract buyers who love the great outdoors, but with some creature comforts. It has developed a slideout camp kitchen for its Sedona SUV complete with an induction cooktop powered by the car battery.



'New Era'

Hyundai in the next few months is set to start sales of the Ioniq 5, its first EV built on a dedicated platform called the Electric-Global Modular Platform, or E-GMP. The flattened chassis allows the automaker to create more spacious interiors. another drawcard to entice drivers to switch from convention gasolinepowered vehicles. "This year will be the start of a new era for Hyundai and Kia as its full EVs go on sale." said Lee Jae-il. an analyst at Eugene Investment & Securities Co. in Seoul. "Hyundai has come a long way from being one of the latecomers to the EV market to offering a very competitive prod-

uct with the Ioniq 5.' Still, demand for the Ioniq 5 is

expected to be slow initially. Hyundai received orders for just more than 20,000 of the vehicles in South Korea on the day pre-orders opened. The automaker aims to sell 26,500 of the EV model in its home market this year, a fraction of its total sales target of 741,500 vehicles.

The Ioniq 5 will start at 52 million won (\$46,000) before subsidies, according to Hyundai's website. The smaller Kona EV starts at 49 million won before subsidies, and its Palisade SUV starts at 36.4 million won.

Hyundai shares rose 0.4% in early Seoul trading Wednesday. They have risen 20% this year, making them one of the best-performing auto stocks behind the likes of VW, General Motors Co. and Ford Motor Co.

Another features Hyundai says sets it apart from rivals is its charging speed. The platform enables EVs to charge up to 80% capacity from 10% in 18 minutes and add as much as 100 kilometers of driving range in just 5 minutes. They'll have a top range of 500 kilometers on a single charge. It will also charge at 800 volts and 400 volts, allowing owners to access more charging infrastructure, Kim said.

That compares with Volkswagen's ID.4, which takes about 38 minutes to charge up to 80% from 5% in about 38 minutes and add 100 kilometers in about 10 minutes. It falls short of the Porsche Taycan, which can add enough charge for 100 kilometers in 4 minutes, and has a total range of 450 kilometers. Tesla markets the Long Range version of its Model 3 at about 515 kilometers.

Hyundai's Kia Corp. unit last month also unveiled its new EV6 model that will be assembled on the same E-GMP platform and is expected to go on sale in July.

"We also focused on having a modular platform that will enable us to offer various types of vehicles on the same platform," Kim said.

Hyundai is also working to build charging infrastructure to encourage more people to buy EVs. The conglomerate unveiled plans in March to provide ultra-high-speed charging stations through its E-pit brand. It plans to open 20 stations in South Korea this year and will work with potential partners overseas to build the infrastructure.

There was wide geographical variation, with 60 per cent of heart disease patients in Gulf countries having diabetes compared to 20 per cent in Europe.

"Obesity and lack of exercise are common risk factors for both diabetes and heart disease and our results highlight the urgent need to improve nutrition and raise activity levels globally," said study author Dr Emmanuelle Vidal-Petiot of Bichat-Claude Bernard Hospital, Paris. France.

Vidal-Petiot added, "Countries worst affected by diabetes are also at the epicentre of the obesity epidemic, which can be in part attributed to urbanisation and associated changes in physical activity and food intake.

This was an analysis of the CLARIFY registry, which included 32,694 patients with chronic coronary syndromes from 45 countries in Europe, Asia, America, the Middle East, Australia, and Africa, Patients were enrolled from 2009 to 2010 and followed up yearly for five years.

All adverse clinical outcomes measured in the study occurred more frequently among heart patients with diabetes compared to those without diabetes. When the researchers compared the likelihood of poor outcomes in those with diabetes compared to those

stable coronary heart disease, those with diabetes had a 38 per cent higher rate of death during the five-year follow-up.

Dr Vidal-Petiot said, "Diabetes was linked with worse outcomes even in areas with the lowest prevaof healthy eating and living cannot be overemphasised. Facebook: Hackers Scraped Data Of 533M Users In 2019 Leak

acebook said on Tuesday that hackers "scraped" personal data of some half-billion users back in 2019 by taking advantage of a feature designed to help people easily find friends using contact lists.

A trove of information about more than 530 million Facebook users was shared over the weekend at a hacker forum, prompting the leading social network to explain what happened and call on people to be vigilant about privacy settings.

"It is important to understand that malicious actors obtained this data not through hacking our systems but by scraping it from our platform prior to September 2019," Facebook product management director Mike Clark said in a post.

"This is another example of the ongoing, adversarial relationship technology companies have with fraudsters who intentionally break platform policies to scrape internet services."

The data included phone numbers, birth dates, and email addresses, and some of the data appeared to be current, according to US media reports.

A study published last October found that about 4 of 5 patients hospitalized with Covid-19 suffer neurological symptoms, including muscle pain, headaches, confusion, dizziness and the loss of smell or taste. Another study from Wuhan, China, where the virus first appeared, found that 36% of patients had neurological symptoms ranging from headache to impaired consciousness.

A limitation of the Oxford study is that the researchers only analyzed records of patients diagnosed with Covid, which does not take into consideration people who were infected but had no symptoms.

Some of patients in the control cohort "might have also had Covid." said Max Taquet, a study co-author. "We didn't know that." It means the findings could have underestimated the relative risk of developing neurological or mental health disorders.

Backlash After Imran Links Rape To How Women Dress

akistan rights campaigners have accused Prime Minister Imran Khan of "baffling ignorance" after the former cricketer blamed how women dress for a rise in rape cases.

In a weekend interview on live television, Oxford-educated Khan said an increase in rapes indicated the "consequences in any society where vulgarity is on the rise."

"The incidents of rape of women... (have) actually very rapidly increased in society," he said.

He advised women to cover up to prevent temptation.

"This entire concept of purdah is to avoid temptation, not everyone has the willpower to avoid it," he said, using a term that can refer to modest dress or the segregation of the sexes.

Hundreds have signed a statement circulating online on Wednesday



calling Khan's comments "factually incorrect, insensitive and dangerous."

"Fault rests solely with the rapist and the system that enables the rapist, including a culture fostered by statements such as those made by (Khan)," the statement said.

The Human Rights Commission of Pakistan, an independent rights watchdog, said on Tuesday it was country where victims of sexual abuse are often viewed with suspicion and criminal complaints are rarely seriously investigated.

Much of the country lives under an "honour" code where women who bring "shame" to the family can be subjected to violence or murder. It regularly ranks among the worst places in the world for gender equality.

Nationwide protests erupted last year when a police chief admonished a gang-rape victim for driving at night without a male companion.

The Franco-Pakistani mother was assaulted in front of her children on the side of a motorway after her car ran out of fuel.

Last year, Khan was also criticized after another television appearance where he failed to challenge a Muslim cleric's insistence that coronavirus had been unleashed because of the wrongdoings of women.

Fresh Covid-19 Wave Could Be Lethal, Warns DAK

SRINAGAR: With Kashmir valley facing second wave of Covid-19. Doctors Association Kashmir (DAK) on Wednesday warned that the new wave could be worse than the first.

"Second waves of pandemics have been harsher," said DAK President Dr Nisar ul Hassan.

"We have witnessed in the past how second wave of 1918 Spanish flu pandemic was deadlier than the first one. The first wave occurred in the spring which was relatively mild. A far deadlier second wave erupted in the fall months which infected 500 million and killed 50 million people globally. Covid-19 is following the same suit."

He said the second waves of coronavirus in United States and Europe were uniformly worse than the first. "Kashmir is currently under the grip of a second wave and the cases are rising and hospitalisations too, he said. "And if countermeasures are not

put in place, we could end up having a situation that could be worse than what we saw last year." This is because, he said, a vast

Paused detente

Akistan Foreign Minister Shah Mahmood Qureshi has said that India and Pakistan cannot afford to engage in an all-out war, as both countries are nuclear armed. He reiterated that "all issues could be resolved through dialogue" and called on New Delhi to create "a conducive environment".

Earlier, Pakistan deferred a decision made by the country's top economic decision-making body to allow imports of cotton and sugar from India until it reviewed August 5, 2019 decision to revoke the special status of Kashmir. Over the last one and a half month, the two countries have witnessed some positive movement in their relations. Pakistan Prime Minister Imran Khan also wrote to Prime Minister Narendra Modi saying that durable peace and stability in South Asia was contingent upon resolving all outstanding issues between the two countries, "in particular the issue of Jammu and Kashmir". The letter was a response to the PM Modi's greetings to Khan on Pakistan Day.

After the decision to put on hold the trade, the prospect for further normalization of the relationship looks moot. It depends on what Pakistan wants New Delhi to do by way of creating "an enabling environment" and what is it that New Delhi wants in return. Significantly, India-Pakistan thaw is taking place amid shifting geo-politics of the region. Russian foreign minister Sergey Lavrov who was in India is now in Pakistan for a two day visit for delegation-level talks on a number of important issues from enhancing bilateral cooperation to the Afghan peace process. In a tweet, Qureshi said that "building multi-dimensional relations with Russia is a key priority for Pakistan". Lavrov will also hold meetings with the country's top political and military leadership, including Prime Minister Khan and Chief of the Army Staff General Qamar Javed Bajwa. This is the first visit by a Russian foreign minister to Pakistan since 2012. According to Qureshi, the two leaders also discussed "worsening human rights situation" in Kashmir.

These are very significant developments and reflect the changing geo-politics in South Asia. The war in Afghanistan is certainly the top priority for the neighbouring countries including the US. The US, as the president Joe Biden has also re-affirmed, is on its way out of Afganistan. This is likely to pave way for Taliban to regain power in Kabul, a development of profound import for the region. India-Pakistan detente assumes some significance in this context. A normal relationship between the neighbours would go a long way to usher in the regional peace.



Blow The Whistle, Milord: On Electoral Bonds

he Supreme Court, after a short hearing, refused to stay the sale of electoral bonds on March 26, ahead of the Assembly elections in some crucial parts of India. For nearly two and a half years, electoral bonds have been the major source of political party funding through the corporate lobbies in India. Behind the electoral bond scheme underlies the issue of corruption and subversion of democracy through illicit funding of political parties and opaqueness in the accounts of all political parties which eventually jeopardizes the very edifice upon which the Indian democratic set-up rests.

An electoral bond, like a promissory note, is a bearer instrument payable to the bearer on demand. It can be used by individuals and corporations incorporated in India to make donations to political parties. The details of donations made to the political parties are not reported or recorded. This is the creation of an obscure funding system. The structure of corporate funding has been made equally secretive by removing the requirement of disclosure of the names of political parties to whom funding have been made. To all intents and purposes, neither the contributor nor the recipient of the fund is supposed to reveal the identity of the other. The inevitable consequences and cumulative effect of the aforementioned provisions is that any legal person, plus a company owned by a foreign corporation can finance a political party in India to a limitless range unaccompanied by either the name of the donor entity or the donee political party being disclosed to anyone in the public sphere. The Electoral Bond, therefore, is a mellowed and fitting way to ensure that all kinds of quid-pro-quo orchestration are made by the ruling party with all kinds of body without any public scrutiny. The constitutional challenge to the Electoral Bonds is on the deck that it takes no notice and makes light of the "right to know" in parliamentary democratic set-up of the polity recognized under Article 19(1)(a) of the

Constitution, is arbitrary and thus violative of Article 14 of the Constitution and has been passed by perpetrating 'a fraud on the constitution' by passing it as a money bill, even though it does not qualify as a Money Bill under

Article 110 of the Constitution. In defending the electoral bonds scheme, the government has argued that electoral bonds reduce the amount of 'black' money in elections, as contributions are routed through the State Bank of India which performs 'Know-Your-Customer' checks on contributors.

The government's defence, however, falls short of the constitutional test of proportionality.

fteer a month of moves and messages that indicated a détente, events last week appear to have slammed the brakes on the India-Pakistan dialogue process. Mr. Qureshi led a charge of Cabinet Ministers who opposed a move by Pakistan's Economic Coordination Committee to reopen imports of Indian cotton and sugar, arguing that it would violate Pakistan's commitments on Kashmir. Subsequently, Mr. Khan announced he was dropping the import proposal he had made in his capacity as Commerce Minister, and that ties with India would not be normalised unless the Modi government revoked its steps of August 2019, on Jammu and Kashmir and Article 370. New Delhi, which has chosen not to comment on the events of the past month, and has not denied reports that claimed India-Pakistan moves were part of a backchannel dialogue facilitated by other countries, has also made no comment on Mr. Khan's U-turn.

While such swings have been common in the India-Pakistan engagement, the present scenario poses questions. If talks are indeed under way behind the scenes, it is unclear why Pakistan's import decision was not better coordinated before being publicly announced. The move followed a speech by Pakistan's Gen. Bajwa where he stressed the need for geoeconomics, trade and connectivity to be prioritised for regional prosperity. So, if it is not the all-powerful Army Chief or the 'Pakistani establishment' that is playing the "spoiler" the Khan government must identify who it is. It is significant that New Delhi has chosen not to press its advantage over the embarrassing confusion in Pakistan's stand, or react to its unworkable demand on Article 370, which has drawn India's sharp comments in the past. This might indicate that the dialogue that has reportedly been on for months has been paused and much will depend on whether any other outlooked steps, including the restoration of High Commissioners in each other's capitals and LoC trade that was suspended for security reasons in 2019, or commitments from Pakistan on cross-border terrorism, are announced next. If the nascent re-engagement is to have any chance, there must also be more clarity on what the two governments have decided to embark upon and hope to achieve from it.

The introduction of Electoral Bond does not bear a rational relationship to curbing "black money", as the confluence of uncapped down the fever is to kill the patient'. In any constitutional de-

mocracy, every decision of any constitutional functionary must pass through the touchstone of the Constitution, and the body to adjudicate that is the judiciary. By adopting the way of Money Bill, the government already side-lined the role of Parliament to have a check upon its work. To make the situation worse, the Supreme Court has also given up its fundamental role of 'sentinel on the qui vive', and on several occasions it has only tried to maintain the status quo.

Online RTI Portals

went through an article, "Information under RTI through an online mode" by Raja Muzaffar Bhat (Kashmir Observer 7/4/2021). I have myself been trying my best to get information through digital mode but there is not a single Govt department which receives or provides information digitally. Only recently I sent an RTI application to District Panchayat Officer (DPO) Budgam through email and attached my PHH Ration card with it as I am exempted from paying Rs 10 application fees. The only thing I did was called the officer and updated her about my emailed RTI. The application was immediately transferred to the Block Development Office Nagam who provided me information within 10 days only. The information about swachh bharat mission is although incomplete but I appreciate the efforts of DPO Budgam. Some time back the Forest Department also sent me a reply by email

If the Govt cannot create online RTI portals at least applicants can send their RTI applications through email. Let all the offices open a separate RTI account where Rs 10 application fees can be transferred through digital mode as is done during online transactions. The PHH or BPL applicants can attach a copy of the ration card with the email. The ration card can be in their name or in the name of parents. Govt officers actually want to deny the information to the public. They don't want to be questioned. They are public servants only on papers but exhibit bossism. It is otherwise not a big deal to receive or provide information digitally using basic techniques like email.

India, New Covid Variant and Response

C To combat the consequences of mutations in India, its pandemic response will have to incorporate several measures. Genomic surveillance will have to be proactive and coincide with the epidemiological investigation of the cluster of cases for early identification and swift actionaction

fter genome sequencing of over 10,000 COVID-19 cases in India, researchers have discovered a new variant with two new mutations which may be better at evading the immune system.

In 15-20% of samples from the Indian state of Maharashtra (the state accounting for 62% of cases in the country) a new, double mutation in key areas of the virus has been detected. These are now known as the E484Q and L452R mutations.

What makes the variant different?

Both these mutations are concerning because they are located in a key portion of the virus – the spike protein – that it uses to penetrate human cells. Spike proteins attach via a "receptor binding domain", meaning the virus can attach to receptors in our cells.

These new mutations include changes to the spike protein that make it a "better fit" for human cells. This means the virus can gain entry more easily and multiply faster. Given what we have seen with other similar mutations, it might also make it harder for our immune system to recognise the virus due to its slightly different shape. This means our immune system may not be able to recognise the virus as something it has to produce antibodies against.

The emergence of these new variants has only been possible because of the continued viral replication in areas with high circulation.

Though the Indian government has said the data on the variants circulating in India (including this new Indian variant and others including the UK strain) are not sufficient to link them to the rapid increase in the number of cases in the country, we think it's the most likely explanation. The country had managed to bring down the rate in February, but a sudden increase in the number of reported cases is now being reported.

Implications

The implications of these developments are greatly concerning – not just for India, but for the rest of the world. Mutations can result in 20% more in-hospital deaths, as we witnessed during the second wave in South Africa. This is because some mutant variants have the ability to spread faster, resulting in sudden surges and, therefore, an overburdened health system

dened health system. But there's hope. Places around the world with higher vaccination coverage such as the UK and Israel are witnessing a steady decrease in cases



Most of the currently approved vaccines around the world have been found to evoke an immune response to some extent against multiple variants. But no trials have yet been undertaken on the effectiveness of vaccines against these new Indian mutations.

To make it difficult for the mutant strains to develop vaccine resistance, we have to ensure wider and faster vaccine coverage across the world.

What has to happen now?

Apart from vaccine manufacturers' efforts to update the composition of vaccines to better deal with new strains, it is important to contain transmission across the world. Countries can use the World Health Organisation's SARS-CoV-2 Risk Monitoring and Evaluation Framework to help identify, monitor and assess variants of concern, swiftly.

To establish a direct link between a variant and a steep rise in cases in a short time, it is important to use genomic sequencing to link clusters together. But unless contact tracing is done meticulously, it isn't easy to do so.

It is also important to understand the mechanisms involved in the infectiousness and virulence of the newer variants. For this, lab models are needed to mimic spread and virulence mechanisms efficiently.

To combat the consequences of mutations in India, its pandemic response will have to incorporate several measures. Genomic surveillance will have to be proactive and coincide with the epidemiological investigation of the cluster of cases for early identification and swift action.

As some variants can escape naturally induced immunity, vaccine manufacturers in India will need to develop better vaccines to cover these new variants. Ongoing surveillance and containment measures need to be strengthened to prevent the emergence of new variants by minimising viral replication.

And finally, swift and rapid vaccine coverage is not only necessary but essential for ensuring any modest levels of success in tackling this pandemic.

t did not matter that I am a journalist or whether my English is "perfect", I had to give the language test to qualify as a registered immigration consultant.

"You may be a reporter with the BBC or had done your Master's in the English language, you still have to give the IELTS exam," said an executive on a YouTube video explaining about the course.

"It is a moneymaking con, " said my wife, sounding like one of the characters in a TV serial we would watch in Saudi Arabia.

I remember eagerly waiting for the serial to start after breaking the daylong fast during Ramadan. It was a very funny show about an English teacher trying to teach English to a bunch of foreigners from various countries.

Surely my English is better than this poor guy trying to be nice to a local politician, I said to myself.

He had put up posters all over the city proclaiming, "Happy Birthday Horible Chief Minister", and 'horrible' was spelt with a single R by the signwriter, who had stumbled on the abbreviation for the word, "Honourable".

Indians are very polite and show deference to politicians, especially if you are trying curry favours and get a national award. The poor man had to pull down all the posters after someone pointed out the mistake.

Incidentally, the same signwriter must have migrated to an Arab Gulf country that I had worked in earlier, as I could see his signs all over the emirate, announcing proudly, "Punctures made here", or "Hairkating Sailoon".

shooting, throwing of chairs and smashing mirrors, whenever I go for a quiet, sleepy haircut).

There was just no way of getting away from doing the International English Language Test as it is now designed to "help you work, study or immigrate to a country where English is the native language".

I suddenly started getting doubts whether I would pass the test, even though I used to read a lot when young, especially crime pulp novels by James Hadley Chase, who used expressions such as, "He shot out of the living room like a

bat out of hell".

There are various 'bands' and one has to get 9 CLB (Canadian Language Benchmark) in Speaking, and 7 in Reading, Writing and Listening.

I hate giving tests and usually get jittery and tense (even after taking several deep breaths and pretending that I am sitting somewhere in the Himalayas) and make mistakes like the time I was taking driving lessons from a burly Sardar.

"I say take left,", he would suddenly snap at me, rapping on my wrist that was gripping the steering wheel. Despite his help I failed the driving test four times, because I had to learn driving all over again, after driving for a decade in Saudi Arabia.

The main hurdle for many new immigrants and international students to get into Canada is the English language, with its crazy spelling, unintelligible grammar and the way nobody speaks English like the 'Masterji' in the coaching class in the village.

"Are you OK?" asked my wife, alarmed at catching me speaking to myself in the bathroom mirror. "I am enunciating," I said. "I have to practice speaking to get 9," I said.

"You sound like Mary Poppins," said my wife. "Nobody speaks like that. I don't think your thick Hyderabadi accent matters. Just speak slowly and first gather your thoughts in your head," she said.

"Oh, God, I won't be able to understand what the British professor is saying. I am sure he speaks like your relative who was in the army," I said.

RBI holds interest rates amid Covid surge, pledges to buy **Rs 1 lakh crore govt bonds**

Mumbai, April 7: The Reserve Bank of India (RBI) on Wednesday kept key interest rates unchanged at record lows while pledging to buy Rs 1 lakh crore of government bonds this quarter to cap borrowing costs in a bid to support an economy facing a resurgence of the pandemic.

In the first monetary policy of the 2021-22 fiscal, the central



bank stuck to its accommodative stance as long as necessary, amid concerns of rising infections that could derail the nascent economic recovery.

RBI's key lending rate, the repo rate, which was cut by a total of 115 basis points last year to soften the blow from the pandemic, will stay at 4 per cent while the reverse repo rate or the central bank's borrowing rate will be unchanged at 3.35 per cent.

Governor Shaktikanta Das said the six-member monetary policy committee (MPC) voted unanimously "to continue with the accommodative stance as long as necessary to sustain growth on a durable basis and continue to mitigate the impact of COVID-19 on the

economy while ensuring that inflation remains within the target going forward".

Just as the economy started to recover after being pummelled by the pandemic and the lockdowns, India is witnessing a record jump in CO-VID-19 infections, threatening the nascent recovery.

"The recent surge in infections has, however, imparted greater uncertainty to the outlook and needs to be closely watched, especially as localised and regional lockdowns could dampen the recent improvement in demand conditions and delay the return of normalcy," he said.

The Governor announced a second market G-sec acquisition programme or G-SAP 1.0 wherein the RBI committed to open market purchase of government securities.

In April-June, it is committed to buy Rs 1 lakh crore bonds, with first debt purchases starting from April 15.

The RBI had bought Rs 3 lakh crore of bonds in the last fiscal (2020-21) and planned similar or more spending in the financial year April 2021 to March 2022.

We are now better prepared to meet the challenges posed by this resurgence in infections," he added.

While retaining its GDP growth outlook for FY22 at 10.5 per cent after a 7.5 per cent contraction in 2020-21, the RBI revised the outlook for inflation, with price rise seen at 5 per cent in the fourth quarter of last fiscal year. It is projected to rise to 5.2 per cent in the first half of the current fiscal.

Besides achievements made under other Government sponsored schemes including JKREGP, NRLM, Pradhan Mantri Mudra Yojana and enrollment under Social Security Schemes.

The meeting was informed that credit disbursement of Rs 555.65 crore has been provided to 24714 beneficiaries under Pradhan Mantri Mudra Yojana, besides Rs 41.94 crore were disbursed among 9812 beneficiaries under Kissan Credit cards scheme.

Similarly, under Pradhan Mantri SVANIDHI schemes Rs 3.38 crore were disbursed among 3389 registered street vendors in the district under which urban street vendor are eligible to avail a loan of Rs 10000 with tenure of one year with interest subsidy of 7 percent to handholding of youth.

Further the chairman ordered enquiry against Ellaquai Dehati Bank for sanctioning only 6 out of 1509 cases under Kisan Credit card scheme and keeping 1503 KCC cases pending/undisposed thereby making the eligible beneficiaries deprived of the intended benefits.

Evidence Of Normalisation Of Economic Activity In India: IMF Chief Economist Gita Gopinath

New Delhi: The chief economist of the International Monetary Fund on Wednesday said that there is evidence of normalisation of economic activities in India. "The evidence we were getting in the last couple of months in terms of the normalisation of economic activity," IMF's chief economist Gita Gopinath said ahead of the annual spring meeting of the IMF and the

World Bank. On Tuesday, the IMF predicted an impressive 12.5 per cent growth rate for India in 2021, stronger than that of China, the only major economy to have a positive growth rate last year during the Co-

vid-19 pandemic. In its annual World Economic Outlook, the IMF said the Indian economy is expected to grow by 6.9 per cent in 2022. In 2020, India's economy

contracted by a record eight per cent.

However, compared to the previous projections early this team, the change in 2021 forecast is pretty small, she noted.

"In the case of India, we have a pretty small change. It's 1 percentage increase for growth for 2021. This came in with high frequency," she said in response to a question.

Malhar Nabar, Division Chief of the research department at the IMF, told reporters that the current forecast that the IMF has for India already takes a fairly conservative view on the sequential growth for the Indian economy for this year.

"But it's true that with this very worrying uptick in cases that that poses very severe downside risks to the growth outlook for the economy," Nabar said.

India has world's 3rd highest number of billionaires, says Forbes report

ndia has the third highest number of billionaires in the world after the U.S. and China, according to a new list by the prestigious Forbes magazine, which said **Reliance Industries Chairman** Mukesh Ambani reclaimed his spot as Asia's richest person, dethroning Chinese business tycoon Jack Ma who was the richest person in the region a year ago.

Forbes' 35th annual list of the world's billionaires is topped by Amazon CEO and Founder Jeff Bezos for the fourth year in a row.

His net worth is \$177 billion, up \$64 billion from a year ago as a result of surging Amazon shares. Forbes said.

On the second spot is SpaceX founder Elon Musk, who was the biggest gainer in dollar terms. Mr. Musk's



fortune ballooned to \$151 billion, a whopping \$126.4 billion more than a year ago, when he had ranked 31 and was worth \$24.6 billion, it said.

"The main reason: a 705% the richest person in Asia, climb in Tesla shares," Forbes ranked Number 10 and worth an estimated \$84.5 billion. He said.

Mr. Ambani, the richest nudges out Jack Ma of China, person in India and also the wealthiest in Asia, is ranked

26 (from 17 last year) despite a nearly \$10 billion jump in his fortune to \$48.4 billion," Forbes said.

Adani Group Chairman Gautam Adani, the second richest person in India, is ranked 24th on the global list of billionaires with a net worth of \$50.5 billion.

Chairman of the Poonawalla Group and founder of the Serum Institute of India, the world's largest vaccine manufacturer, Cyrus Poonawalla is ranked 169th on the Forbes list of the world's billionaires with a net worth of \$12.7 billion.

EW DELHI: Facebook-owned instant messaging plat form WhatsApp on Wednesday expanded its offerings for business users. The company announced two new features that make WhatsApp Business--the new e-commerce side of the platform--more effective and friendly for business es. The features include better support for WhatsApp Catalogs on desktops, and the ability to hide items that are out of stock.

The instant messaging platform had introduced its Catalogs feature back in 2019, allowing businesses to create a storefront and menus for products they sell. The company says it has over 8 million business catalogs worldwide, including one million in In-



dia. But businesses can only create and manage these from mobile right now.

The second update allows businesses to temporarily hide items that are unavailable from customers. The feature is common amongst e-commerce platforms, grocery delivery and food delivery services, where a dynamic storefront is required. It essentially lets sellers change their menus on the go, and avoid delays in delivery or taking orders for products that may not be immediately available.

The feature updates bring WhatsApp Business more up to speed with competing platforms. While the company has been trying to get more small businesses on board, it competes with virtually every delivery service on the market today. WhatsApp does have a large user base already, but a well rounded feature set will be just as important.

The company is just about a month away from enforcing its new privacy policies, which landed it in trouble with users and the Indian government. The new policies allow the company to share some data with partnering business, which the Indian government has asked the Delhi High Court to block.

Centre Rejects Claims Of COVID Vaccine Shortage After Maha And Other States Complain, Allows Jabs At Workplace

New Delhi: As COVID-19 cases in India hit a record high lending urgency to scale up vaccination, the Centre on Wednesday allowed the jabs at workplaces with about 100 eligible beneficiaries from April 11 and rejected as baseless allegations of shortage of the injection by Maharashtra and some other non-BJP ruled states.

The central government also wrote to Maharashtra, Punjab and Delhi governments flagging below-par inocu-lation of eligible beneficiaries, including healthcare workers, after they demanded that vaccination be opened to all.

India recorded 1,12,389 new cases on Wednesday, according to a PTI tally, taking the overall count to 1,29,14,174. The single-day rise in coronavirus cases breached the one-lakh mark for the third time in four days. India saw a record daily rise on Tuesday, with over 1.15 lakh new infections.

Maharashtra Health Minister Rajesh

Tope said that many inoculation centres are being shut due to the shortage of vaccines in the state, the worst affected by the coronavirus outbreak in the country, and they have 14 lakh doses which would last just three days.

"We need 40 lakh vaccine doses every week. We can then administer six lakh doses every day in a week. The doses we are getting are not enough," he said, adding the Centre should ensure that those in the 20-40 age group are vaccinated on priority.

The Odisha government said it has vaccines for another three days and that it had written to the central government on Tuesday urging it to provide 15 to 20 lakh doses of the 'Covishield' vaccine to continue the inoculation drive smoothly.

Congress leader Rahul Gandhi also batted for the COVID-19 vaccine for all, saying every Indian "deserves the chance to a safe life". Similar demands for relaxing the age restriction have been made by Punjab Chief Minister

Amarinder Singh, Rajasthan Chief Minister Ashok Gehlot, Maharashtra Chief Minister Uddhav Thackeray and Delhi Chief Minister Arvind Kejriwal. However, Union Health Minister Harsh

Vardhan alleged that the states were trying to cover their "failures" and spread panic among the people by demanding vaccination for all without first inoculating enough of the eligible beneficiaries. People above the age of 45 are currently eligible for vaccination.

Vardhan also said the allegations of

vaccine shortage are utterly baseless and the states, including Maharashtra and Chhattisgarh, need to improve the implementation of their testing and containment strategies and vaccination drive.

He said the "lackadaisical" attitude of the Maharashtra government has "singularly bogged down" the entire country's efforts to fight the virus.

Maharashtra recorded the highest daily count of 59,907 cases and 322 deaths on Wednesday.

Saffron is a powerful antioxidant that protects cells against free radicals linked to carcinogens and oxidative stress.

Also mentioned as "sunshine spice", saffron is found effective in the treatment of depressive symptoms according to studies.

Kashmir is the largest producer of saffron in the world.

Another medicinal plant found in Kashmir is trillium(Trillium grandiflorum), locally known as nagchatri.

It's a perennial 20 cm tall bulbous herb with a snow-white flower atop a whorl of leaves.

It's found in the continents of North America and Asia (Gulmarg in Kashmir) and is used for traditional medicines.

Rhizome, the underground part of nagchatri is used to prepare steroids.

Trillium is used to treat boils, dysentery, inflammation, menstrual and sexual disorders. It also finds its use as an antiseptic in wound healing.

Tethwan (Artemisia Absinthium) is short perennial herb, also known as wormwood, found in Gulmarg, Sonmarg, Gananpeer, and several parts of Budgam and Kupwara. There're eight to ten species of the herb that grows in the valley.

Wormwood has greenish-silver stems, yellow-green leaves and bulbous flowers of bright or pale-yellow color. Traditional medicines used all parts of the plants for medical practices.

Water boiled with tethwan leaves can be used as an insect repellant. The leaf extracts are used to relieve intestinal worms, diabetes, and obesity. A poultice of the plant is used for tendon inflammation.

The herb should not be applied directly to the skin because its compounds are concentrated and can cause painful burns.

Tethwan also has antioxidant properties that help to combat oxidative stress in the body associated with cancer, heart disease, and Alzheimer's.

In the list of medicinal plants of Kashmir is datura (Datura Stramonium), a poisonous species whose seeds, leaves, and roots are used in traditional medicines. The seeds are purified before use.

Medicines containing datura are used in the treatment of respiratory diseases especially cough and asthma. Inhaling smoke from burned datura leaves is helpful for asthma patients. Vapor infusion of datura leaves boiled in water is used to relieve arthritis.

The oil extracted from seeds of the herb is used to treat baldness and the extract of the whole leaf is applied on hair to control dandruff.

Datura is always used in low dosages under strict medical supervision. A high dosage of the herb can cause adverse side effects

with a consignment of drugs, the Punjab police team led by SSP Dhruv Dahiya along with Border Security Force (BSF) troops launched a ioint operation at the Kakkar border outpost (BOP), the officials said.

During the operation, the movement of a Pakistani smuggler was noticed. The smuggler fired at the Indian troops and was killed when they returned the fire under Lopoke police station area, a senior police official said.

A joint combing operation was launched at the site and 22 packets of heroin (weighing 22.660 kg), one SAIGA - MK Rifle (semi-automatic rifle) along with two magazines and 24 live rounds of 7.50 mm. one AK - 47 rifle along with two magazines and 21 live rounds of 7.62 mm, Pakistani currency, one mobile phone along with two Pakistani SIMs (Telenor and Jazz), and a pipe which bore a 'made in Pakistan' marking were recovered, the Punjab police said in a statement.

During preliminary investigation, it was found that the smuggler was known to his two Indian associates, it said.

The police have registered an FIR against the two associates -- Jagdish Bhura, who is a militant of Khalistan Zindabad Force and currently based in Belgium; and Jaspal Singh, a resident of Ferozepur's Gatti village, who has been arrested.

Singh was in close contact with Bhura and was involved in the smuggling of composite drugs and weapon consignments across the border in Amritsar sector, according to the statement.

Singh is learnt to have close links with Pakistan's ISI, the statement quoted SSP Dhaiya as saying

A case has been registered under the Narcotic Drugs and Psychotropic Substances Act, the Arms Act, the Foreigners Act and the Indian Passport Act at the Lopoke police station, the statement said.

Director General of Police (DGP), Punjab, Dinkar Gupta said follow-up action is being taken to unearth the entire network of border couriers and Bhura's associates who are active on the India-Pakistan border, as well as to establish the entire network of his foreign and Indian associates.

Indian Judo Team Withdraws From Olympic **Qualifiers After Two Players Test COVID-19 Positive**

NEW DELHI: A 15-member Indian judo team was forced to withdraw from the ongoing Asia-Oceania Olympic qualifiers in Bishkek, Kyrgyzstan after two judokas -- Ajay Yadav and Ritu -- tested positive for COVID-19 just before the start of the tournament.

Yadav, a 73kg class judoka, and Ritu (52kg) tested positive in the second test conducted after landing in Kyrgyzstan and both are asymptomatic. It became the first instance of an Indian contingent's campaign being derailed at an Olympic qualifier because of the dreaded virus.

All the 15 judokas and four coaches had returned negative in the first test conducted after landing in the central Asian country. The entire 19-member contingent is currently in quarantine at a hotel in Bishkek.

"After landing in Kyrgyzstan on April 4, there was a test done and all of us returned negative. But in the second test on April 5 just before the start of tournament, Ajay and Ritu returned positive," team coach Jiwan Sharma told PTI from Bishkek.

"Ajay and Ritu are asymptomatic and they are self isolating at their respective rooms. They are in high spirits and we have been talking and giving encouragement to them through phone," he said.

The Asia-Oceania Championships in Bishkek started on Tuesday and will end on Saturday.

36 Persons, Including 24 Athletes, Test Positive For COVID-19 At SAI Bhopal

NEW DELHI: As many as 24 sportspersons and 12 support staff members have tested positive for the coronavirus at the Sports Authority of India's (SAI) Bhopal centre but none of the athletes are Olympics-bound.

According to SAI, the positive cases came to light during two rounds of precautionary tests on April 3 and 6.

The SAI Bhopal Center doesn't house any Olympic probable. "In the two rounds of testing, a

total of 36 people have tested positive for Covid, out of whom 24 are athletes, and the other 12 who are staff of NCOE (National Centre of Excellence)." a SAI official told PTI when enquired about the tests.

"None of the athletes who have tested positive are Olympic-bound. Some of the athletes who tested positive had returned from wushu and judo competitions. In order to contain the spread of

the virus, the athletes, who have tested positive, have been shifted to a hospital as a precautionary measure.

"None of the athletes are critical." The SAI had further instructed all the NCOEs to strictly follow its existing Standard Operating Procedures (SOPs) with stress on conducting regular precautionary tests.

On March 31, 30 sportspersons and support staff across disciplines were found to be COVID-19 positive after 741 precautionary tests were conducted at the National Centres of Excellence in Patiala and Bengaluru.

However, the positive results in both the centres did not include any Tokyo Olympic-bound athlete.

His inexperience might also cost the Royals dearly in crunch situations.

The team won matches on the back of some brilliant individual performances but struggled to work as a cohesive unit last season. Consistency will be the key.

The team is heavily dependent on Archer. While they have Morris to rely on, the pace attack seems weak in the 26-year-old England pacer's absence. The franchise would desperately hope Archer joins the side at the earliest.

With a weak Indian cor gent, comprising several rookies and over-reliance on their foreign recruits, there is real threat the Royals would once again not qualify for the playoffs.

Sams was traded to the RCB this season from Delhi Capitals. He became the second RCB player to test positive for the infection after left-handed opening bats-

Padikkal, however, came out negative in the latest round of testing. The 20-year-old had been in home guarantine since March 22 after being infected. He was RCB's highest scorer last season with 473 runs from 15 matches.

"Devdutt Padikkal, has joined the team on 7th April 2021 with negative reports for COVID-19 as per BCCI protocols, RCB medical team was in constant touch with Devdutt to ensure his safety and well-being," the franchise stated in a separate release.

Sams has played in only three IPL games. He made his league debut last season for Delhi Capitals.

On Tuesday, Mumbai Indians' wicket-keeping consultant and talent scout Kiran More had also tested positive for the virus, but all other members of the defending champions' squad returned negative reports.

IPL 2021 has been hit hard by the coronavirus even before its start as a number of groundstaff at the Wankhede Stadium in Mumbai, broadcast crew event management officials, and some cricketers, including the likes of Axar Patel and Nitish Rana, have contracted the infection.

Pak Army Chief Bajwa Discusses **Defence Regional Security** With Russian FM Lavrov

Anil Ambani's Son Anmol Lashes **Out Against Lockdowns; Says It Is Only About Control Not Health**

NEW DELHI: Anmol Ambani, the eldest son of industrialist Anil Ambani, has lashed out against a new round of lockdowns being imposed amid the surge in COVID-19 cases, saying such restrictions do not concern health but control and that they destroy the very backbone of the society and economy.

The 29-year-old former executive director of Reliance Capital Ltd in a series of tweets lambasted the new semi-lockdown rules hurting small businesses and daily wage earners.

"Professional 'actors' can continue shooting their films. Professional 'cricketers' can play their sport late into the night. Professional 'politicians' can continue their rallies with masses of people. But YOUR business or work is not ESSENTIAL. Still don't get it?" he said in a tweet. He had in the past too voiced opposition to such restrictions and retweeted videos and comments denouncing them.

"What does essential even mean? EACH INDIVIDUALS WORK IS ES-SENTIAL TO THEM," he said tweeting with hashtag #scamdemic.

Lockdowns, he said, are key in "continuing and enabling greatest wealth transfer in human history.'

"The mistake is that the people think this is simply inefficient governance. it's not. It's a coordinated, thought out set of policies designed to enable a new world order to be brought in," he said.

For an economy that was seeking nascent recovery after the world's strictest lockdown last year pummelled business, a resurgence of the pandemic is posing a serious

threat. States have announced partial lockdowns in response to infections rising by record levels.

While Maharashtra has shut all non-essential services through April, the national capital has started night curfew.

The specter of another lockdown is now the biggest headwind for local businesses.

"These lockdowns were never about and have nothing to do with health," Ambani tweeted. "They destroy the very backbone of our society and economy, from the daily wage workers, self-employed and SMEs to the restaurants and dhabas, fashions and clothing stores." Lockdowns also destroy and diminish health by closing gyms, sports complexes and playgrounds, he said, adding that exercise, sunlight and fresh air are some of the strongest pillars of good health and strong immunity.

"And don't forget the psychological damage this is doing to children who are growing up through this madness and are being programmed to believe this is normal," he said.

Stating that lockdowns worsen inequality, he said shutting down of brick-and-mortar stores benefits digital and e-commerce companies, farmland is corporatised and colonised and data and privacy are sold to new-age empires.

"This is not about health. This is about control, and I would think most of us are unknowingly and unconsciously falling into the trap of a much larger and very sinister plan," he said. "To control every aspect of your life - A technocracy exactly like China - A totalitarian bio-surveillance fascist state-controlled from the outside."

ooch Behar (West Bengal): Lashing out against the rival Bharatiya -Janata Party (BJP), Chief Minister Mamata Banerjee today termed herself "Bengal tigress", who will "not bend" in front of the BJP.

Speaking at a public gathering in Cooch Behar, Ms Banerjee said: "They (BJP) will bring goons from Assam. They will explode bombs and threaten people. Do not be afraid. They do not want our mothers and sisters to vote. Central forces are blocking ur mothers and sisters from voting."

She claimed that if the BJP comes to power in the state, they will build detention camps like in Assam. "They have kept 14 lakh Bengalis in detention camps, who have no future. We are fighting for those poor people. They were not even voting, police made raids on them." "BJP cannot do anything to me with their money. I am a Bengal tigress, I break but I do not bend," she further remarked.

Ms Banerjee appealed to the people to vote for the Trinamool Congress (TMC) if they did not want to see "Gujaratis capturing Bengal". She also raised slogans such as "BJP hatao" and "BJP ke chai na" (We do not want BJP).

"We will not let Gujaratis capture Bengal. Bengal will stay in Bengal, we will not let goons from Gujarat take over Bengal," she said.West Bengal has witnessed three out of the eight phased polls so far to the 294-member state Assembly. Counting of votes will be held on May 2.

The fourth phase of the elections is set to commence on April 10. A total of 373 candidates will contest for 44 constituencies in the upcoming phase, which will encompass five districts of West Bengal - Cooch Behar, Alipurduar, South 24 Parganas, Howrah and Hooghly.
