### 'India, Pak May Stumble Into Large-Scale War'

SRINAGAR: In a sensational disclosure, a United States intelligence report has warned about the possibility of an unintentional large-scale war between India and Pakistan though none of the two nuclear countries would want so.

"India and Pakistan may stumble into a large-scale war neither side wants, especially following a terrorist attack that the Indian government judges to be significant,"



says the Global Trends report, which is produced every four years by the US government's National Intelligence Council. The report was released in Washington on Wednesday and takes a longer-term, strategic look, trying to peer 20 years ahead to examine how current changes could transform the world of the future.

A similar report was released by the Obama administration in 2017, highlighting the risk of a pandemic and the vast economic disruption it could cause — a prescient prediction in hindsight. The ability of some • More On P10



# 'He Stabbed Me Like A Bollywood Villain': Kashmir's Dagger Account

n ward number 18 of Srinagar's Shri Maharaja Hari Singh Hospital (SMHS), a youth lying on a hospital stretcher – bandaged and bloodied – still wonders how he's alive.

"Miracle it was," he told Kashmir Observer in a quivering voice. "The attacker looked from a gang the way he stabbed me.' The injured youth is Najmu Sakib Dar of Chinkral Mohalla Habba Kadal,

He was stabbed with a dragger over a dozen times by another youth inside his home on the evening of 5 April, 2021. "The attacker ensured that I would

be dead," the knifed person said. On Monday, Dar was alone at his home when a person known to him allegedly trespassed his house and stabbed him from left, right and centre, in a vengeful huff to settle the

"personal grudge".
Dar was rushed to SMHS by his neighbours after hearing the hue and cry. He's under medical observation in the hospital and is stable, but unable to move, breathe, and eat properly. "I've received over 60 stitches on my different body parts," he said. "The

dagger was nearer to my lungs. It's Allah's mercy that I'm still alive!' The attack came a week after two persons were stabbed by a group

of persons in Babademb locality of Srinagar's Fateh Kadal on March 28.

The injured were identified as Shafat Ahmad Sofi (35), son of Bashir Ahmad Sofi, a resident of Batamaloo and Danish Nazir, son of Nazir Ahmad, a resident of Bemina.

The condition of both the injured is said to be stable. Similarly, on 12 January this year, the entire city was shocked after a boy was stabbed to death and another was injured near Dastgeer Sahib shrine (RA) at Khanyar area of Srinagar.

The slain was identified as ZiyaanChisti, son of Mohammed Ashraf Chisti, resident of Rainawari, Srinagar. While the injured

accompanying him was identified as FaizanFida Bhat, son of Fida Ahmad Bhat, a resident of EllahiBagh area of

The police investigation in the case revealed that the murder was carried out for the sake of a small amount of

money, which the "accused" owed to the slain youtwh. Old Srinagar residents allege that a few "gangs" carry out these piercing

attacks to settle personal scores. "Most of the people are druggies and roam around the city in jeep brandishing hockey sticks and sometimes knives," said Mohammad Irfan, a resident of Khanyar. "None dares to tell them anything." ● More On P10



# **Study suggests outside** factors may help children develop internal control

he ability to control your own behaviour, known as executive function, might not exist all in your head. In a novel study, researchers are applying the theory of executive function to children and they revealed that the function affects everything from children's readiness for school to social relationships with long-term outcomes for adulthood.

The theory, detailed in Perspectives on Psychological Science, draws on dynamic systems theory which originated in mathematics and physics and has been used to describe complex organising phenomena like cloud formation and flying patterns of birds. Now, a research team led by Washington State University human development assistant professor Sammy Perone is applying it to executive function, which has been shown to play a role in everything from children's readiness for school to their social relationships. Its development is also tied to long-term outcomes for adulthood.

'We propose that executive function is really about using cues from the environment to guide your behaviour." said Perone.

"As humans, we use our experience and norms to decide what's the appropriate path to take, so to encourage executive function development, we want to help children build those connections between cues and appropriate behaviours," added Perone.

In a classroom, these cues might include things such as decorations on the wall, verbal instructions or the way tables are set up. Eliminating environmental distractions may also help children control their behaviour like having sharpened pencils on hand or resolving a tottering desk chair. In addition, physical things normally thought of as peripheral, like whether a child has adequate sleep or enough to eat, also influence executive function, Perone said.

Previously, the dominant view held that executive function was three distinct neurocognitive processes: working memory, inhibitory control, which is the ability to stop yourself from doing something, and cognitive flexibility, which allows you to transition from one activity to the next. This perspective has been

called into question, Perone said. "If these different cognitive processes are what makes up executive

function, you would think you could just train those processes, and then, you can then use them everywhere," he said.

"Turns out, that doesn't work, and that's been shown over and over again. People think and behave in an environment, so we can't just train executive function by say doing computer exercises on working memory," he added.

The new theory builds on the work of cognitive scientist Sabine Doebel who called for a redefinition of executive function in 2020 as the "development of skills in using the control in the service of behaviour."

Perone and his co-authors from the University of Kansas and the University of Tennessee expand on that new definition by bringing in dynamic systems theory to help explain how humans use a variety of external factors to organise their behaviour.

"We need to think more about executive function as it operates -- as goal-directed behaviour in the real world," Perone said.

"When you take that perspective, all of the sudden, it becomes much more practical to childcare providers and parents, because that's where kids are thinking and behaving and developing," Perone concluded.

Musharraf Says, Positive Signals From India To Resolve Kashmir

ISLAMABAD - Pakistani President Pervez Musharraf today said he would discuss the Kashmir issue with-Indian leaders during a two-day visit to New Delhi next week. Reports suggest there is more to watching cricket than what is

said to on cards during Musharraf's visit to New Delhi on April 16. Originally billed as a visit to watch the last one-day match in New Delhi on April 18. General Musharraf has said (hat the main purpose of his visit was to use the opportunity for talks

Musharraf told a gathering of students here that he is more interested in talks on Kashmir than watching cricket.

"I am going to India on April 16 to watch the cricket match. I will discuss Kashmir. It is more important," he said.

Cricket match will not have that much importance, as that of a dialogue on Kashmir." said die General, while addressing convention at Jinnah Convention Centre at Islamabad today.

In his address, general Musharraf did not seem to attach too much importance to the Muzaffarabad-Srinagar bus service. "It is a small step towards confidence building and a small con-

tribution for the happiness of people." he said. He asserted the people should "appreciate good things" before

"condemning" them outrightly. "When something good is being done, it should not be negated." he said observing that the bus service was a good confidence building measure (CBM) but not a solution to the Kashmir issue.

"CBMs are a contribution towards the progress of the people. It is not total. You cannot say it is nothing or a zero. They are something, not enough but. I also say that more needs to be done^" he said to a female student from Pakistan controlled Kashmir wH§

Before the bus service began, extensive "consultations" were held with Kashmiris in Jammu and Kashmir and A/ad Kashmiri to find out whether they favoured it or not. Musharraf said.

"It is not for Pakistan and India but for Kashmiris on both sides who wanted to meet and travel. This is a right step. You should support it. The effort would be to resolve the Kashmir j dispute." he added.

The ICC's chief prosecutor anhad opened a full investigation into the situation in the Israelioccupied territories, infuriating Israel, which not a member of The Hague-based court.

March 9, giving Israel and the Palestinian Authority (PA) a month Hamas Islamists who have conto inform judges whether they are investigating crimes similar to those being probed by the ICC.

Had Israel informed the court that it was carrying out its own probe into alleged war crimes acts of "resistance." perpetrators, it could have asked for a deferral.

Prime Minister Benjamin Netanyahu's office issued a statement saying the government had agreed "to not cooperate" with the ICC.

Israel would instead send a letter to the court "completely rejecting the claim that Israel commits war crimes," it said.

The letter would also "reiterate Israel's unequivocal position that The Hague tribunal has no authority to open an investigation against it.

"The state of Israel is committed to the rule of law... and expects the court to refrain from violating its sovereignty and authority," the statement reads. 'Hypocrisy'

The PA, based in the occupied West Bank, has been a state party to the ICC since 2015.

The Palestinians have welcomed the investigation and said

## **How Worried Should We Be About Links** Of Blood Clots To Astrazeneca's Vaccine?

ZURICH: Europe's drug regulator on Wednesday said it had found a possible link between AstraZeneca's COVID-19 vaccine and very rare blood clots in adults who received the shot. Britain recommended people under 30 get an alternative CO-VID-19 vaccine if possible. Here's what we know so far:

WHAT HAS HAPPENED? The EMA said its vaccine side

By comparison, four women out of 10,000 would get a blood clot from taking oral contraception.

Key to the EMA's assessment that benefits continue to outweigh risks are its conclusions about likelihood of an increased risk from clotting, compared with the benefits of preventing COVID-19 and reducing hospitalizations and deaths.

The EMA said that unusual blood clots with low blood platelets should be listed as very rare side effects and countries should decide on how to pro-

Among possible causes for these rare cerebral sinous vein clots being investigated are that the vaccine triggers an unusual antibody in rare cases.

The EMA said the vaccine may trigger an immune response leading to the unusual clotting, though it acknowledged that scientists have yet to identify any risk factors that might predispose somebody to clotting combined with low platelets.**Reuters** 

# Explosives Found Near Kabul Airport, Plane With Pak Lawmakers Turned Back

# Britain's Prince Philip, Husband Of Queen Elizabeth, Dies At 99

**LONDON:** Prince Philip, the husband of Queen Elizabeth and a leading figure in the British royal family for almost seven decades, has died aged 99, Buckingham Palace said on Friday.

The Duke of Edinburgh, as he was officially known, had been by his wife's side throughout her 69-year reign, the longest in British history. During that time he earned a reputation for a tough, no-nonsense attitude

and a propensity for occasional gaffes. "It is with deep sorrow that Her Majesty The Queen announces the Royal Highness The Prince Philip, Duke of Edinburgh," the palace said in a statement.

"His Royal Highness passed away peacefully this morning at Windsor Castle. Further announcements will be made in due course. The Royal Family join with people around the world in mourning his loss."

India and Bangladesh has been finalised. Citing an example under the legal

procedure for the deportation of foreign nationals, the AAG said that, "When there is a pending case an accused (he/ she) cannot be brought out of the jail Court."

"We have taken the case and if we take it back that particular person (accused) will be free as under litigation any country won't take that personally. Also, a proper procedure has to be followed including the filling up of form for repartition," the AAG said while citing the legally required procedure.

"It has also to be looked that the persons should not be involved in any criminal case and for the same, I have received a request from the government of Jammu and Kashmir to withdraw Rohingyas," Sawhney said.

Sawhney said that he didn't exactly remember how many among the group of 5 to 6 people are Rohingyas and Bangladeshi but they are all foreign nationals.

"The communication I have received has termed them as Bangladeshi nationals. The letter calls them Bangladeshi at every place," the AAG said.

Notably, the Jammu and Kashmir government over a month back started the verification process of Rohingyas in the Jammu division putting up in different parts for further deportation process.

Earlier, the Home Ministery in a written reply filed in Parliament said that central government has been vested with powers under relevant sections of the Foreigners Act to detain and deport foreign nationals staying illegally in the country.

"Detection and deportation of illegal migrants including Rohingya migrants from Myanmar after due process of nationality verification is a continuous process," MHA said in a reply—(KNO)

# The Fate of Swachh Bharat Abhiyan in Rural Areas

lthough Swachh Bharat Abhiyan has been successful to a great extent in changing attitudes, mindsets and behaviours of people towards cleanliness and sanitation. COVID 19 pandemic made us realise the importance of personal as well environmental hygiene to prevent communicable /zoonotic diseases.Swachh Bharat Abhiyan (SBA) or Swachh Bharat Mission (SBM) is a nation-wide campaign in India that is aimed at cleaning up the streets, roads and infrastructure of Indian cities, towns, and rural areas. SBM involves the construction of latrines/ lavatories, promoting sanitation programmes in the rural areas, cleaning streets, roads and changing the infrastructure of the country to lead the country ahead. This campaign was officially launched by the Prime Minister, Narendra Modi on 145th birth anniversary of the Mahatma Gandhi on 2nd of October in 2014 at New Delhi (SBM Website). The mission has two thrusts: Swachh Bharat Abhiyan (Grameen or Rural), which operates under the Ministry of Drinking Water and Sanitation; and Swachh Bharat Abhiyan (urban), which operates under the Ministry of Housing and Urban Affairs. Some important objectives of the Swachh Bharat Abhiyan (Source SBM Urban Website) are:

- To eradicate the system of open defecation in India.
- To convert the insanitary toilets into pour flush toilets.
  To remove the system of manual scavenging.
- To make people aware of healthy sanitation practices by bringing behavioural changes in people.
- To link people with the programmes of sanitation and
- public health in order to generate public awareness.
  To build up the urban local bodies strong in order to design, execute and operate all systems related to
- To completely start the scientific processing, disposals reuse and recycling the Municipal Solid Waste.

#### Fate of SBA in Rural Areas

Even though this campaign has been able to create awareness about different types of wastes, benefits in



use of toilets, importance of personal hygiene to prevent various diseases, school children about various hygienic practices, waste segregation but as far as rural populace is concerned there seems nothing on ground. All these activities like taking the broom to sweep the streets, cleaning up the garbage, focusing on sanitation and maintaining a hygienic environment will have an impact when there is no rural and urban divide. Let us look at some real life situations that cause hindrances in implementation. Both rural and urban populace is aware about the hazards of throwing waste in open but in rural areas even if the people collect garbage in homes, after segregation/collection they remain in dilemma Where to put the garbage? and throw that on roadsides, alleyways and even in water bodies like streams, rivulets or ponds due to non-availability of garbage collectors/sites and established dumping sites thereby the very motive of this campaign gets vanished .Nowhere we can find any garbage collection unit in villages or for that matter in educational institutions where even

emptying a dustbin at times becomes a matter of debate. In contrast, urban populace has the option of collecting the waste in dustbins even segregating and then putting it in garbage collecting bins (Refuse Collector) of SMC whereby it is then transported to garbage dumping sites.

Disposable nappies and sanitary napkins are thrown in drains, waterbodies or on roadside which not only has become a nuisance in rural areas but has also been slowly mixing with agricultural land. It is pertinent to mention here that the government is responsible for this whole mess as rural populace have no option but either burn the waste generated which will lead to air pollution or throw that waste on roads or water bodies.

Erecting sign boards and hoardings of ODF (Open Defecation Free)in and around panchayats is not going to serve any purpose if government does not rethink about employing a concrete mechanism/policy of dumping the waste generated in rural areas like they do in urban areas as the use of plastic bags/diapers has overwhelmed every corner of the globe and our villages are no exception.Moreover the piles of garbage accumulated is more dangerous than the actual faecal matter.

#### Suggestion

The people concerned at the helm of affairs or executing agencies need to review their basic approach of implementation in view of the already discussed flaws wherein at least one garbage collecting bin (Refuse Collector) like in Municipalities is kept in every village which is emptied every fortnight at least so that the very motive of sensitization and ultimately this campaign is upheld not just taking a broom to pose for a photograph as has been the case. Despite approaching the concerned authorities through social/print media, nothing seems to be happening on ground in rural areas.

Similarly cleaning one area to make the life of people living in and around other areas (dumping sites) hell, the clear case of which is Achan Dumping Site due to non-scientific and rudimentary way of disposing of the waste needs to have a relook as that is becoming a health hazard and pose serious threat to the inhabitants.

Waste accumulation in inconceivable places like fresh water springs/rivers, school premises, crossways, grazing lands, graveyards etc. in rural habitations can have serious repercussions in near future if some immediate and practical steps on ground are not taken.Government has not yet framed any Solid Waste Disposal/Treatment policy that has also created the chaos.

In previous decades, it was "Islamo-fascism" that was all the rage: connoting Islam's purported affinity not with the left, but the farright. For centuries before that, it was what might now be called "Islamo-Judaism": the recurrent conspiracy theories conjoining Jews and Muslims as threats to European Christendom, so that "the two infidel races were [treated] as halves of a single body of Semitic aliens," as analysed by medieval literature scholar Geraldine Heng.

As the political sands shift, the bogeyman is perpetually reconfigured to fit the current landscape. To quote 19th-century French Orientalist Ernest Renan, Islam is imagined as "the most complete negation of Europe" – however Europe happens to see itself at the time.

When Europe was gripped by homophobia and sectarianism, Muslim societies were criticised for being too non-heteronormative and multicultural – signs of Muslim "degeneracy" remedied through the imposition of colonial rule

edied through the imposition of colonial rule.

Now that the signifiers of "civilisation" have switched, public "intellectuals" like French philosopher Pascal Bruckner complain that Islamo-leftism is curtailing their ability to freely demonise Muslims for being too intolerant. In anti-racism's "permanent war of all against all," accusations of Islamophobia are a "weapon of mass intimidation." Bruckner insists.

Meanwhile, the non-metaphorical state of "permanent war" against Muslims persists, and those documenting its atrocities and critiquing its underpinning ideology continue to be subject to marginalisation, suppression and punishment by the state and other institutions of power.

For example, the Collectif contre l'islamophobie en France (Collective Against Islamophobia in France) was liquidated by the French government in November.

Prominent Islamophobia expert Professor Farid Hafez's home was raided by counter-terrorism police in Austria, also in November – part of a series of raids against Muslim academics and activists.

And in February, the eminent philosopher and anti-racist, Palestine solidarity activist Professor Cornel West was denied tenure at Harvard University.

It seems Bruckner's "weapon of mass intimidation" inhabits the same plane of unreality as Iraq's "weapons of mass destruction". And it serves an analogous function – of depicting the targets of systemic aggression as the aggressors.

# "Islamo-Leftism" or Islamophobo-Leftism?

Across the political spectrum, a common collection of narratives is rationalising, minimising and invisibilising violence against Muslims.

Bruckner is frequently described as a man of the left, highlighting the incoherence of the term "Islamo-leftism", which obfuscates the Islamophobia within the left itself.

Even the very party accused by French political leaders of being an epicentre of Islamoleftism, France Insoumise, has hosted speakers claiming that "one has the right to be Islamophobic," and could barely muster any representatives to participate in a march against anti-Muslim hate after an attack on a French mosque in 2019.

The enduring power of Islamophobia is that there's something in it for almost everyone, from right to left.

In March, the right-wing Swiss People's Party managed to break its losing streak in citizens' referendums, with its victorious proposal to banish Muslim women's face-veils from public space – which attracted twice the vote share as the party won in the general election. As did its similarly successful 2009 campaign to prohibit minaret construction, which appealed to feminists by portraying minarets as a symbol of women's oppression. This from the same political organisation that previously fought against a motion to recognise gender equality in marriage.

In countries like Germany and France, left-wing parties and activists have been on the frontlines of initiatives to impose state coercion on Muslim women's clothing. For the sake of "liberating" Muslim women, there are now five times more European states legally forcing women to unveil as there are Muslim-majority states requiring women to veil.

The Inquisition obsession with stripping Muslims of their head coverings and minarets lives on. In the 15th-century, the problem was said to be the "uncleanliness" of Muslim (and Jewish) blood. Now, it's the incompatibility of Muslims with "our" culture and values. As Black American novelist Toni Morrison wrote, when it comes to racism, "there will always be one more thing".

Islamophobia is a great unifier, transcending even the ideological divide between China and "the West". Since 9/11, China has repackaged its settler-colonial assault on the Muslim Uighurs of Xinjiang as a "war on terror" exercise: pathologising Islam as a "virus" to be eradicated with mass surveillance and bio-

metric collection, forced labour, forced sterilisation, child separation, criminalisation of religious practices and "re-education" in concentration camps.

Yet in the name of resisting Western imperialism against China, some on the left act as denialists and apologists for China's genocidal imperialism, the most damning evidence of which emanates from China's own official documents. At a recent seminar organised by Canadian anti-war groups to "debunk" the Uighur genocide, China's Consul General showed a PR video of Xinjiang that was predominantly images of empty landscapes. Even in China's genocide-denying propaganda, the Uighurs are largely scrubbed out of the picture.

To invoke the language of the US military, Islamophobia is a system of "full-spectrum domination": not the purview of one segment of the political field, but a common frame of reference across the field as a whole.

This treatment of Muslims as a "universal enemy" is deeply rooted in history. In the famous 16th-century Valladolid debate on the colonisation of the Americas – considered a foundational event in the (Eurocentric) history of international law – Spanish legal scholars debated Indigenous peoples' humanity by deciding whether they were like Muslims and therefore to be massacred (the "conservative" position), or unlike Muslims and therefore to be missionised into Christianity (the "liberal" position).

Erasmus, one of the "fathers of humanism," urged Europeans to stop fighting each other and "let loose [this evil passion] upon

the Turks" instead. "Father of free speech" Voltaire opined that Muslims were the greatest curse on Earth and "should be destroyed." "Mother of feminism" Mary Wollstonecraft advocated for the emancipation of European women by distinguishing them from "subordinated" and sub-humanised Muslim women (although it wasn't "Mahometan" law but European law that barred women from independent personhood and owning property).

Freedom, peace, rights and equality for those within the West's "zone of being" has long been premised on war, domination and dispossession outside of it.

Some 19th-century liberal writers sought to shunt off European responsibility for Europe's foundational atrocities – the Crusades, the Inquisition, and genocide in the Americas – by blaming Christians' alleged internalisation of "the principle of Islamism: extermination".

In the present, progressive commentators refer to neo-Nazis as "vanilla ISIS," Trump's officials as "mullahs," and Trump himself as "Osama bin Laden's revenge" on America. As if a social order that continues to reap the spoils of the brutalisation of Black, Indigenous and Muslim lives and the theft of Indigenous lands needs to search outside itself for explanations of White supremacism.

"Our" violence is rendered an aberration or a reflection of "their" violence; "their" violence is depicted as essential to who they are.

Within this framework, Muslims are easily normalised as objects of abuse – explained away as presumptively guilty, or ignored as collateral damage. As academics Arun Kundnani and Deepa Kumar pointed out, domestic opposition to the US's mass surveillance program dropped off precipitously when it was revealed the targets were mostly Muslims.

In the recent debates over expanding counterterrorism to address right-wing extremism, we read in socialist magazine Jacobin that the primary objectionable feature of terrorist listings is that they might be used in the future against left-wing activists – not that such listings have already been used for almost two decades overwhelmingly against Muslims, including charities for donating to humanitarian work in Palestine.

Similarly, in the "principled and progressive" Nation magazine, we are told that the

problem with militarised policing of American anti-racism protests is that tactics and weapons appropriate for "Iraq and Afghanistan" are now being wielded in places like Portland – where "protesters carry skateboards, leaf blowers, lacrosse sticks, and cardboard signs [as opposed to rockets and guns]" and "some are pregnant".

"No one should be treated this way," proclaimed author Andrew McCormick. Except, apparently, all the Afghans and Iraqis who have not been spared from military brutality for being pregnant and/or unarmed.

A few weeks ago, the Nation even featured a piece praising the "characteristic erudition" of notoriously Islamophobic Canadian journalist Robert Fulford, celebrating him as "the nation's finest cultural critic".

Unmentioned in the Nation's panegyric, some gems of "erudition" from Fulford's steady stream of vitriol include excoriating the Palestinians under occupation as "terrorists" and "indiscriminate murderers," exalting anti-Muslim idealogue Ayaan Hirsi Ali as a "Muslim Martin Luther," and exhorting a few months after the Quebec mosque shooting – the most fatal act of political violence in Canada at the time since 1989 – that "we should begin by retiring the word Islamophobia in the interest of a franker attitude to terrorism"

The issue isn't Islamo-leftism, but Islamo-phobo-leftism. Across the political spectrum, a common collection of narratives rationalises, minimises and invisibilises violence against Muslims: pitching Islamophobic policies as progressive, projecting Muslims as the paradigm of barbarism, and expurgating the racism of its own past and present.

This spectrum offers a series of false choices: between Euro-American imperialism and China's alter-imperialism; between conservative, right-wing racism and liberal and left-wing racism; between being subjugated violently and subjugated slightly more gently (with violence always in reserve).

Thinking and working beyond this artificially-restricted consensus are those Muslims who, in solidarity and collaboration with other peoples and movements, are drawing on Islam's prohibition of worshipping anything other than God to challenge human-made hierarchies of oppression: of human over non-human, white over non-white, coloniser over colonised, man over woman, heteronormative over queer, and the wealthy over the dispossessed. "Like sunflowers that only the sun can subjugate," in the words of French-Algerian decolonial writer and activist Houria Bouteldia.

Perhaps this is the real danger posed by "Islamo-leftism": the possibility not of a more "violently radical" world, but one radically more equal and just.

It's a shocking dereliction of duty by those in government and the ruling class but their sins will be forgotten and forgiven on the road to power. The ruling class will go unpunished and blame will be pointed at some regional governments and even the hand of fate. The ordinary citizen, meanwhile, is bearing the worst of the suffering because the lust for power is greater than the common good. The health of the nation of 1.3 billion is at stake with politicians busy doling out freebies and brandishing promises to woo the electorate who come out to listen to them in thousands — the perfect setting for the pathogen to spread. Super-spreader events are being held in the country in plain sight but winning is all that matters in the charged political climate where charges and counters are being hurled.

Only two months ago cases had ebbed (and people had grown complacent). New Delhi was sending vaccines abroad as vaccinations at home got off to a slow start (it has picked up since). Experts rushed to conclusions about herd immunity setting in early and the government slapped itself on the back for the stellar leadership it had shown in times of crisis. Vaccine diplomacy was the song on everyone's lips while viral dangers continued to lurk at home. Others said Indians had it in their genes to fend off the virus that still remains mysterious, its origins unclear, though bats may have been the first host.



he COVID vaccine rollout is underway, with Australians lining up to get their jabs. But what if you have already had COVID-19? Is it still a good idea to get vaccinated?

Although natural exposure to the virus stimulates immunity, we don't yet know how long this immunity will last. And people will vary in their ability to mount a protective im-

Even if you've had COVID-19, you should still get vaccinated. A COVID vaccine may offer more reliable and sustained immunity than a previous infection. At the very least, it will add an extra layer of targeted protection.

Here's how our immune response works after a natural infection versus a vaccine.

#### From B cells to neutralising antibodies

Soon after becoming infected with SARS-CoV-2 (the virus that causes COVID-19), our immune cells (T cells and B cells) activate. Activated B cells produce so-called neutralising antibodies. These antibody-secreting cells defend our bodies against the infection by making antibodies that bind to spikes on the virus surface, and block the virus from entering our cells.

Neutralising antibodies spill over into the bloodstream and travel around the body looking to mop up virus. After the infection has resolved, these activated B cells calm down and transition to a resting state. They move from our blood to our lymph nodes and bones. These so-called memory B cells survive for decades, along with help from memory T cells.

But they need a nudge once in a while to ensure they're ready to kick into gear if we're exposed to an infection.

#### Our immune cells rely on memory

When we're re-exposed to a virus, or receive a vaccine booster, these memory cells awaken, become activated and produce large amounts of antibodies much faster. This immune mem-

ory reduces the risk we'll become infected with SARS-CoV-2. But if we do, it allows for quicker healing from COVID-19

Sustained neutralising antibody levels indicate a good degree of protection against SARS-CoV-2. How long we hang onto natural immunity after COVID-19 is variable and depends on viral, human and environmental factors. For example, the viral variant can make a difference, along with our genes, underlying health conditions, and age

These factors can affect our neutralising antibody levels, which can wane over time to dip below protective levels.

As COVID-19 hasn't been around for a particularly long time, it's difficult to know how long natural immunity generally lasts. However, antibodies and immune memory appear to last for at least two months.

For patients who have recovered from SARS. a related coronavirus, research has shown they maintained antibodies for up to two to three years following infection.

#### Immune responses to a vaccine

Again, because of the short time frame, we have limited data on sustained antibody responses following vaccination. But immunity appears to be strong three months after the Oxford/Astra-

With COVID-19 vaccines, certain variable factors have been targeted, in a way they can't with natural infections. For example, considerations like the dose size and the time between doses are all established to confer optimal immunity.

As we continue to monitor people who have received the COVID vaccines, we'll develop a better understanding of protective immunity and its longevity.

#### Staying on top of variants

Natural immunity from infection may protect against other variants to some degree, but vaccines will play a crucial role as the virus continues to mutate

It may be necessary to get regular boosters of the COVID vaccine until the pandemic is under control. This will provide protection against variants our pre-existing antibodies may not be able to neutralise.

Boosters enhance our broad immunity to parts of the spike proteins shared between different virus variants. Antibodies produced to these common regions can neutralise the virus and

We saw this to a limited extent in people who had common cold infections with other coronaviruses before COVID-19.

#### Only one jab? Vaccines as a cure for long COVID? There's been some research suggesting peo-

ple who have had COVID may only need one dose of the vaccine to be protected.

For people who have had COVID, one dose may serve to top up their antibodies to protective levels. This is because they're starting on a stronger footing in terms of their antibody levels and immune memory, compared to people who haven't had the virus.

But experts in Australia still recommended two doses, regardless of whether you've had COVID.

Meanwhile, reports have indicated people experiencing long COVID may also benefit from vaccination. We're not sure how this happens, but symptoms may improve with clearance of any hidden virus reservoirs from the body. Research into this phenomenon is ongoing.

At the end of the day, when the vaccine is available to you, you should get vaccinated, even if you've had COVID-19. While the vaccine is likely to protect you, it's also important to protect others, as we look towards a goal of

**Earth receives over 5K** tonnes of extraterrestrial dust each year

Micrometeorites have always fallen on our planet. These interplanetary dust particles from comets or asteroids are particles of a few tenths to hundredths of a millimetre that have passed through the atmosphere and reached the Earth's surface.

very year, over 5,000 tonnes of extraterrestrial dust fall to Earth each year, scientists have determined. Our home planet encounters dust from comets and asteroids. These interplanetary dust particles pass through our atmosphere and give rise to shooting stars. Some of them reach the ground in the

form of micrometeorites Micrometeorites have always fallen on our planet. These interplanetary dust particles from comets or asteroids are particles of a few tenths to hundredths of a millimetre that have passed through the atmosphere and reached the Earth's surface.

An international programme conducted for nearly 20 years by scientists from the French National Centre for Scientific Research (CNRS), the Universite Paris-Saclay and the National museum of natural history with the support of the French polar institute, has determined how much of these micrometeorites reach the ground.

To collect and analyse these micrometeorites, six expeditions led by CNRS researcher Jean Duprat have taken place over the last two decades near the Franco-Italian Concordia station (Dome C), which is located 1,100 kilometres off the coast of Adelie Land, in the heart of Antarctica.

Dome C is an ideal collection spot due to the low accumulation rate of

snow and the near absence of terrestrial dust.


These expeditions have collected enough extraterrestrial particles (ranging from 30 to 200 micrometres in size), to measure their annual flux, which corresponds to the mass accreted on Earth per square metre per year

If these results are applied to the whole planet, the total annual flux of micrometeorites represents 5,200 tonnes per year, according to the study which will be available in the journal Earth & Planetary Science Letters from April 15.

This is the main source of extraterrestrial matter on our planet, far ahead of larger objects such as meteorites, for which the flux is less than ten tonnes

A comparison of the flux of micrometeorites with theoretical predictions confirms that most micrometeorites probably come from comets (80 per cent) and the rest from

The results could help scientists better understand the role played by interplanetary dust particles in supplying water and carbonaceous molecules on the young Earth.



# Late-night snacks may affect workplace performance: Study

recent study has found that unhealthy eating behaviours at night can make people less helpful and more withdrawn the next day at work. The findings of the study were published in the Journal of Applied Psychology. "For the first time, we have shown that healthy eating immediately affects our workplace behaviours and performance," said Seonghee "Sophia" Cho, corresponding author of the study and an assistant professor of psychology at North

report having physical problems the next morning. Problems included headaches, stomachaches and diarrhea.

In addition, when people reported unhealthy eating behaviours, they were also more likely to report emotional strains the next morning - such as feeling guilty or ashamed about their diet choices. Those physical and emotional strains associated with unhealthy eating were, in turn, related to changes in how people behaved at work through-

Essentially, when people reported

Not only were emotionally stable people less likely to have physical or emotional strains after unhealthy eating, their workplace behaviours were also less likely to change even when they reported physical or emotional strains.

"The big takeaway here is that we now know unhealthy eating can have almost immediate effects on workplace performance," Cho said.

Cho added, "However, we can also say that there is no single 'healthy' diet, and healthy eating isn't just about nutritional content. It may be influenced

Cho added. "It is relatively well established that other health-related behaviours, such as sleep and exercise, affect our work. But nobody had looked at the short-term effects of unhealthy eating."

Fundamentally, the researchers had two questions: Does unhealthy eating behaviour affect you at work the next day? And, if so, why?

For the study, researchers had 97 full-time employees in the United States answer a series of questions three times a day for 10 consecutive workdays. Before work on each day, study participants answered questions related to their physical and emotional well-being.

At the end of each workday, participants answered questions about what they did at work. In the evening, before bed, participants answered questions about their eating and drinking behaviours after work.

In the context of the study, researchers defined "unhealthy eating" as instances when study participants felt they'd eaten too much junk food; when participants felt they'd had too much to eat or drink; or when participants reporting having too many late-night snacks.

The researchers found that, when people engaged in unhealthy eating behaviours, they were more likely to

physical or emotional strains associated with unhealthy eating, they were also more likely to report declines in "helping behaviour" and increases in "withdrawal behaviour."

Helping behaviour at work refers to helping colleagues and going the extra mile when you don't have to, such as assisting a co-worker with a task that is not your responsibility. Withdrawal behaviour refers to avoiding work-related situations, even though you're at your

The researchers also found that people who were emotionally stable meaning people who are better able to cope with stress because they're less emotionally volatile - suffered fewer adverse effects from unhealthy eating.

by an individual's dietary needs. or even by when and how they're eating, instead of what they're eating.

"Companies can help to address healthy eating by paying more attention to the dietary needs and preferences of their employees and helping to address those needs, such as through on-site dining options. This can affect both the physical and mental health of their employees - and, by extension, their on-the-job performance," Cho further said.

The researchers also pointed to a variety of research questions that could be addressed moving forward.

"One confounding variable is that the way our questions were phrased, we may be capturing both unhealthy eating behaviours and unhealthy drinking behaviours related to alcohol," Cho said.

"That's something we will want to tease out moving forward. And while we focused on evening diet, it would be interesting to look at what people are eating at other times of day. Are there specific elements of diet that affect behavioural outcomes - such as sugar or caffeine content? Can there be positive effects of unhealthy eating, such as when people eat comfort foods to help cope with stress? This promises to be a rich field of study," Cho concluded.

# **Second Covid Wave Heightens** Risks For India's Banks: Fitch

**NEW DELHI:** India's second wave of Covid-19 infections pose an increased risk to the country's fragile economic recovery and its banks, Fitch Ratings said.

Accordingly, Fitch expects a moderately worse environment for the India's banking sector in 2021, but headwinds would intensify should rising infections and follow-up measures to contain the virus further affect business and economic activity.

Lately, India's active Covid-19 infections have been increasing at a rapid pace; new infections have exceeded 100,000 a day in early April 2021, against 9,300 in mid-February 2021.

Fitch forecasts India's real GDP growth at 12.8 per cent for the financial year ending March 2022 (FY22).

# India's Fuel Consumption Contracts 9.1 Pc In FY21; First Since 1998-99

NEW DELHI: India's fuel demand contracted by a massive 9.1 per cent in the financial year ended March 31, the first in more than two decades, as a stringent lockdown imposed to curb the spread of the pandemic pummelled economic activity, government data showed on Friday.

# Army Working On Two-Pronged Strategy In Kashmir: GoC 15 Corps

# 'Will Take All Measures To Ensure Smooth Amarnath Pilgrimage This Year'

General officer Srinagar: Commanding (GoC) of Srinagar based 15 Corps Lieutenant General D P Pandey said that the army is working on a twopronged strategy in Kashmir—to prevent the local militant recruitment and to squeeze the OGW and social media network used for radicalization of youth. He, however, said that anyone who picks up arms will be dealt strictly-local militants will be offered surrender if they refuse, they will be killed.

GoC 15 corps was addressing his maiden presser at Police Control Room (PCR) Srinagar along IGP Kashmir Vijay Kumar and GoC Victor Force Rashim Bali about two encounters—Shopian and Tral, Pulwama in which seven militants including the Ansar Gazwatul Hind (AGH) chief were killed.

GoC 15 Corps said that the army is working on a two-pronged strategy which entails preventing the local militant recruitment and to block the OGW and social media network which is used for radicalization of youth in the Valley.

"This is my first media interaction and I can feel that there is a new change and new energy. One and all want J&K to be a peaceful region. While rest of Kashmir is peaceful, South Kashmir and some parts of Central Kashmir are witnessing

cycle of violence,"GoC Pandey said. "Our efforts are on to address the situation. We need cooperation from the general public. Our youth are being radicalized and people must help us in stopping the trend."

He asserted that some parents whose youth have joined militancy have approached army and requested it to "get their children back and rehabilitate them even if they need to be lodged in jails."

### India And China Hold 11th Round Of Military Talks; Focus On Further Disengagement In Eastern Ladakh

NEW DELHI: India on Friday pressed for early disengagement of troops in the remaining friction points like Hot Springs, Gogra and Depsang in eastern Ladakh at the 11th round of military talks with China, people familiar with the negotiations said.

The fresh round of Corps Commander-level dialogue began around 10:30 am at the Chushul border point on the Indian side of the Line of Actual Control (LAC) in eastern Ladakh and it was continuing till around 10 pm, they said.

Indian delegation

insisted on completing the disengagement process at the remaining friction points at the earliest, said one of the people.

The 10th round of the military dialogue took place on February 20, two days after both militaries concluded the withdrawal of troops and weapons from the North and South banks of the Pangong lake. The talks lasted for around 16 hours.

Indian delegation at Friday's talks is led by Lieutenant General PGK Menon, the Commander of the Leh-based 14 Corps.

Late last month, Army Chief General MM Naravane said the threat to India has only "abated"

following the disengagement in the Pangong lake areas, but it has not gone away altogether.

The border standoff between the Indian and Chinese militaries erupted on May 5 last following a violent clash in the Pangong lake areas and both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

As a result of a series of military and diplomatic talks, the two sides completed the withdrawal of troops and weapons from the North and South banks of the Pangong lake in February, in line with an agreement on disengagement.

The encounter in Shopian town broke out on Thursday evening and giving an update about the operation on the same day, police had said that three militants have been killed and four security forces personnel injured.

Inspector General of Police, Kashmir Zone, Vijay Kumar told reporters that AGuH chief Imtiaz Shah, who was active since 2019, was actually killed in the gunbattle at Tral in Pulwama district.

"While laying a cordon in Shopian, two militants managed to escape after hurling a grenade." Kumar said.

He said acting on inputs that the militants had moved towards orchards in the Tral area, another operation was launched in Nowbug and the two ultras were killed. One of the slain militants was identified as Imtiaz Shah, Kumar

The officer said three people, who hurled stones on security forces when they were laying the cordon, suffered pellet injuries.

The army's 15 Corps' Commander, Lt Gen D P Pandey, said the security forces had conducted the Shopian operation with utmost restraint and respect for the place of worship where the two militants were hiding.

"It was ensured that there was no disrespect to the place of worship (the mosque)," he said. Lt Gen Pandey said security forces gave ample opportunity to the militants to surrender.

"We want the misguided youth to comeback," he said, but warned that anyone who takes to arms against the state will be neutralised.

On the orders asking the media not to cover live encounters and law and order situations, IGP Kumar said he had written to all senior superintendents of police, keeping in mind the safety of journalists and to ensure media coverage does not hamper operations. "I have directed the district SSPs concerned to brief the media after the operations are over," he added

coverage of encounters will be allowed. A stray bullet can hit any media men if you go closer to the operation site. Covering live encounters can pose threat to the journalists."

The IGP said that live coverage of encounters can instigate people in other adjoining areas of the operational site and lead to law and order situation. "I have directed district SSPs to brief media men about encounter updates in their respective areas, whenever there is any encounter," he said.

"I have been talking to the senior players like Shikhar Dhawan, Ravichandran Ashwin and Ajinkya Rahane about the fields we can set and other strategic decisions for the team," Pant was quoted as saying in a press release on the eve of DC's opening game against Chennai Super Kings.

"I have been talking to Ricky and our bowling coach James Hopes as well. There's a good mix of seniors and juniors in our squad and I think with the help of Ricky, we can do something different this year."

Pant wants to keep things simple and believes that his peripheral vision as a keeper would help while leading the side from behind the stumps.

"I haven't thought about the fact that it's my first match as captain in the IPL. I am just going to keep things simple and give my 100 percent. You get a good idea about setting fields as a wicketkeeper and now as captain I will be making the changes in the field directly.

"So, there's not going to be much of a difference for me," said Pant. For Ponting, facing a team like

CSK, with a proven record, is always a tough challenge and he expects the "right attitude" from each and

every member of his side. "Although we've got a slightly different squad, we expect to play better as a group and achieve some better results. So, for us, Chennai Super Kings is just game one. We need to approach it with the right attitude and play well.

"Hopefully, win that game and move onto the second game. But we know that we'll have to play well to win," said Ponting.

Suresh Raina's absence last season did hamper CSK's chances, feels the former Australian skipper.

"The Chennai Super Kings have been one of the most successful teams in the history of the IPL. They have got a great leader and a great squad of players. They have always managed to play consistent cricket.

"Last year, they were probably disappointed with the way their season worked out, but I think a lot of that had to do with the fact that Suresh Raina wasn't there for the entire tournament. He comes back to the squad this year, which is almost like a new recruit for them."

Ponting feels that 10-11 days of training before the first game is good enough preparations and there is no place for any excuses.

"I am really happy about how our last 10-11 days have gone. There will be certainly no excuses from us about how we perform in Game 1.

"We've got a great group of players, who are hungry and excited for another challenge for us as a franchise and a team. So, I am excited to

MUMBAI: It will be a battle between the "young apprentice and his master" when Rishabh Pant's Delhi Capitals and Mahendra Singh Dhoni's Chennai Super Kings square off in an IPL match here on Saturday, with both sides aiming for a winning start to their campaign.

The Delhi franchise ended runners-up last season in the UAE and would be aiming to go one better this time and a good start would be what they will be looking for.

Three-time champions CSK had a forgettable season last year, finishing at seventh out of eight teams and they would also be seeking a winning start in their bid to make amends of a poor IPL 2020.

Keeper-batsman Pant, anointed to captaincy in the absence of injured Shreyas Iyer, has said recently that he would put his learning from Dhoni to use in DC's season opener.

"My first match as captain will be against Mahi bhai (MS Dhoni). It will be a good experience for me as I have learned a lot from him. I'll apply my own experience and learning from him," Pant had said recently.

Delhi's strong batting line up of Shikhar Dhawan, Prithvi Shaw, Ajinkya Rahane, Steven Smith and Pant himself will look to fire on all cylinders right from the opening game.

Dhawan (618 runs) was the second highest run-scorer in IPL 2020 and looked in good touch in the recent ODI series against England. He would be raring to go this season.

Shaw will be itching to prove his worth after amassing 827 runs in the Vijay Hazare Trophy. It is most likely that Shaw and Dhawan would open. Captain Pant, a hard-hitting

batsman, is in the form of his life, having emerged as a match-winner for India in the series against Australia and England. He would like to continue his good run.

The Delhi team also possesses the likes of all-rounder Marcus Stonis, Shimron Hetymar and Sam Billings but will have to get their team combination right, as only four overseas players can feature in the playing XI.

They have enough options to choose from the battery of pacers comprising Ishant Sharma, Kagiso Rabada, Umesh Yadav, Chris Woakes and Anrich Nortje.

Even if the South African duo of Rabada and Nortje misses out the first game as they joined the team just a few days back, DC have enough firepower and experience in the bowling department.

Also, playing a key role on a sluggish Wankhede track would be the spinners -- Ravichandran Ashwin and Amit Mishra, though Axar Patel will not be available as he tested positive for COVID-19 last Saturday.

On the other hand, Chennai will be bolstered by the return of the experienced batsman Suresh Raina, who is their all-time leading run-scorer, with 5,368 runs.

Raina will strengthen the toporder, which has the likes of young Ruturaj Gaikwad, South African Faf Du Plessis and Ambati Rayudu.

With the likes of young Sam Curran, who almost pulled off a win for England in the final ODI against India, and Moeen Ali, along with great finisher Dhoni, Chennai also have a stable middle-order.

"I will never stop banging the drum for investment in our city and bringing the Indian Premier League to London would not only guarantee a home crowd for every country but boost tourism and generate muchneeded revenue to help get our capital back on its feet," Khan said.

# **Jhye Richardson Plans To Deal** With IPL Pressure With A 'Smile'

**NEW DELHI:** The T20 format can be unforgiving for the bowlers and Australian pacer Jhye Richardson plans to deal with high pressure situations in his maiden IPL with a "smile" before his delivery stride.

A smile before starting his run up worked for him in the Big Bash ague, where he ended up as the leading wicket-taker, and he feels sporting a grin even after he is hit for a six should help him deal with the extreme pressure that comes with playing in the world's biggest T20 league.

The 24-year-old, who has played two Tests, 13 ODIs and 14 T20Is for Australia, was bought for a whopping Rs 14 crore by Punjab Kings at the IPL auction. Along with pace spearhead Mohammad Shami, Richardson is expected to put an end to the team's death bowling woes this season.

"The key to my game is to just go out and have fun. It's easier said than done, because you're bowing to the best in the world but for me if I can just stand at the top of my mark, and smile, that is a big one for me," Richardson, who is set to complete his quarantine in Mumbai, told PTI.

"I actually started doing that (smile) during the Big Bash at the top of my mark, just to put a smile on the top, just to remind myself every ball that T20 is fun."

Back to playing regularly after

undergoing a shoulder surgery last year, Richardson said at times he puts too much pressure on himself when he is being taken to the cleaners.

Richardon has replaced West Indian Sheldon Cottrell in the Punjab Kings squad. Cottrell was smashed by Rahul Tewatia for five sixes in an over last season and Richardson is well aware that it can happen to him and he plans to overcome that by staying in the moment.

"Sometimes you can bowl a good ball and it goes for six. The key to deal with that is finding a way to get over that moment. The good thing for me is that in Big Bash, I was probably the person who was required to bowl all the difficult overs. With that comes experience.

"I am certainly becoming more confident about myself and backing my ability to bowl in the death," said the fast bowler, who is looking forward to working with fellow Punjab teammate Chris Jordan again, having played alongside him in the Big Bash.

The pressure of a huge price tag is bound to be there but Richardson is feeling a lot better after a candid chat with head coach Anil Kumble.

"I started putting pressure on myself (thinking about the price tag). But, I had a good conversation with Anil yesterday, and he said, you know, 'we didn't pick you up for the price tag we just picked you up for your services and what you do on the cricket field'.

"For me that was really important to hear, to know that the coach has picked me up for a reason and knows what I'm capable of.

"So for me, now it's not to worry about the price tag. I know all that coach wants from me is to perform my best and back myself w ever skill that may be, whether it's opening the bowling or trying to hit some runs in the lower order."

Playing in bio-bubbles comes with its own set of challenges, especially for someone like Richardson who comes from a place where CO-VID-19 situation is not as alarming as India. Fellow Australian Daniel Sams, who is with RCB this season, has also tested positive for the virus.

"It's hard not to think about all of those things, especially coming from a place where bubbles have sort of calmed down a little bit, so to come into another bubble is unfortunately what we're going to have to get used to moving forward.

"But it's certainly difficult to get your head around. It's just about distracting yourself and trying to keep yourself busy, and making sure that you're in the present and not thinking too far forward.

"If you start to think too far ahead, the bubbles can just drag on for what seems like forever," he added.

#### **India Records Highest Daily Spike** Of Over 1.31 Lakh COVID-19 Cases; **780** Deaths Take Toll To 1,67,642

India registered a record singleday spike of 1,31,968 new COV-▲ID-19 cases on Friday, pushing its infection tally to 1,30,60,542, while the death toll increased to 1,67,642 with 780 more fatalities in a day, highest since October 18, the Union Health Ministry data showed.

Registering a steady increase for the 30th day in a row, the number of active COVID-19 cases increased to 9,79,608, which is 7.5 per cent of the total infections, according to the data updated at 8 am.

The recovery rate in the country has further dropped to 91.22 per cent, it added.

The active COVID-19 caseload in the country was recorded at its lowest of 1,35,926 on February 12, comprising 1.25 per cent of the total infections.

The number of people who have recuperated from the disease surged to 1,19,13,292, while the case fatality rate has dropped to 1.28 per cent, the data stated.

India's COVID-19 tally had crossed the 20-lakh mark on August 7 last year, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16.

It went past 60 lakh on September 28 last year, 70 lakh on October 11, 80 lakh on October 29, 90 lakh on November 20 and the one-crore mark on December 19.

According to the Indian Council of Medical Research (ICMR), 25,40,41,584 samples have been tested for COVID-19 in the country so far, including 13,64,205 on Thursday.

The 780 new fatalities include 376 from Maharashtra, 94 from Chhattisgarh, 56 from Punjab, 39 from Uttar Pradesh, 36 from Karnataka, 35 from Gujarat, 27 from Madhya Pradesh, 24 from Delhi, 19 from Tamil Nadu, 18 from Kerala and 11 from Harvana.

A total of 1,67,642 deaths due to the disease have been reported so far in the country. The figure includes 57,028 fatalities from Maharashtra, 12,840 from Tamil Nadu, 12,767 from Karnataka, 11,157 from Delhi, 10,370 from West Bengal, 9,003 from Uttar Pradesh, 7,334 from Punjab and 7,268 from Andhra Pradesh.

The Union Health Ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the ICMR," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

### **Sunni Board To Challenge ASI** Survey Order for Gyanvapi Mosque



**¬**he Uttar Pradesh Sunni Central Waqf Board has said that it will challenge the Varanasi court order, allowing archaeological survey to take place at the Kashi Vishwanath-Gyanvapi mosque site, in the higher court.

Asserting that the status of Gyanvapi Masjid is beyond question, the Board chairman Zufar Farugi said the order violates the Places of Worship (Special Provisions) Act, 1991 which has been upheld by the Supreme Court on many occasions.

A civil court in Varanasi, on Thursday, had given its approval for survey of Gyanvapi Mosque and Kashi Vishwanath temple Mosque complex by the Archaeological Survey of India (ASI).

The court further directed the Uttar Pradesh government to bear the cost of the survey. The ASI is likely to set up a five-member team that will visit the campus soon.

In a statement, Zufar Faruqi, Chairman, UP Sunni Central Waqf Board, said the order of the Civil Judge, Varanasi ordering a survey by the Archaeological Survey of India will be challenged before the Allahabad High Court.

NEW DELHI: India reported another record number of new CO-VID-19 infections on Friday and daily deaths hit their highest in more than five months, as it battles a second wave of infections and states complain of a persistent vaccine shortage.

"There is no other option for me except to return because cooking is the only skill I brought to Mumbai," said Mr Puri, 31, as he waited to board a train back to his village in the country's east.

# **Mumbai Tax Inspector** Drops ₹5 Lakh Bribe, Triggers Dramatic Chase



**NEW DELHI:** A Bollywood-style foot-chase for over a kilometre on the streets of Mumbai by a CBI official led to the arrest of bribery-accused Income Tax Inspector Ashish Kumar who had abandoned ₹ five lakh cash on the road before his unsuccessful dash.

The event unfolded on Thursday around 10 pm at Goregaon East in front of Dindoshi Fire Station where the CBI team had laid a trap after getting a complaint that Ashish Kumar and two other Income Tax inspectors -- Dilip Kumar and SN Rai -- have allegedly demanded ₹ 15 lakh the bribe from a person whom they had raided recently, officials said.

All the three accused posted at Ballard Pier office of Income Tax were separately demanding bribes from the person to cover up his alleged tax violations, they said.

During the verification process, the CBI concluded that all the three were assuring the person that they can manage his case in exchange of

According to CBI officials, Ashish Kumar and the complainant had agreed the bribe amount will be paid in the latter's car in front of Dindaushi Fire Station in Goregaon.

On Thursday night, Kumar entered the vehicle, took the money, kept it in his bag and as soon as he came out spotted the CBI officers approaching him. Sensing that his imminent was imminent, he threw the bag containing ₹ five lakh on the road and started running, they said.

CBI PSI Vineet Jain gave a chase through the traffic and busy street for over a kilometre before outrunning the Ashish Kumar. He has been taken into custody, the officials said.

Another Income Tax Inspector Dilip Kumar was also arrested redhanded while allegedly receiving a bribe of ₹ 10 lakh from the complainant. The third inspector, S N Rai, has also been booked but not arrested yet, they said.

"Searches at two places in Mumbai and one place in Delhi at the residential and office premises of accused are being conducted. This led to the recovery of cash of 7 lakh and incriminating documents relating to an investment in commercial and residential properties from one of the accused," CBI spokesperson RC Joshi said.

# 3 Elderly Women Given Anti-**Rabies Vaccine Instead Of** Covid-19 Jab In Uttar Pradesh

SHAMLI: A probe has been ordered in the shocking incident in which three women were allegedly administered anti-rabies injections instead of the Covid vaccine at a government hospital in Shamli district.

Three women-Saroj, 70, Anarkali, 72 and Satyavati, 60-had gone to the government community health centre in Kandhla on Thursday to get vaccinated against the coronavirus.

After the vaccination, the women were handed anti-rabies vaccine slips, which led to a protest by their family members at the facility.

The condition of Saroj began to deteriorate, and she complained of nausea. Her family members took her to a private doctor who was aghast to see that she had been given the anti-rabies vaccine instead of the Covid vaccine.

The families have lodged a complaint with the Chief Medical Officer Sanjay Agarwal. Brijendra Singh, in-charge of the health centre has said that an inquiry would be conducted into the incident.

He said that strict action will be taken against those found guilty.

## Three Day-Old Student **Passes Class 8, Shows Bihar School Certificate**

notification that Chakraborty is to be removed from his post with "immediate effect" in accordance with the Election Commission's directions, as per reports. Chakraborty is posted as the officer on special duty (OSD) in an ex-cadre post

in the rank of a superintendent of police (SP) in the directorate of security.

Earlier in the day, the commission issued a notice to Mamata Banerjee asking her to explain her stand by April 10 regarding her statements against central forces on March 28 and April 7. Banerjee alleged that the central forces favoured the Bharatiya Janata Party (BJP) during the first and second phase polling of the West Bengal assembly elections. She was issued another notice over her remarks on April 3 when she appealed to Muslim voters to not let their vote split among different political parties.

The fourth phase of the high-stakes West Bengal assembly elections will see 373 candidates contesting for 44 constituencies spread across five districts. The first three phases of the eight-phase West Bengal polls have already taken place. Counting of the votes will take place on May 2.
