
Govt Defers Durbar Move Over Covid-19 Surge

India, Pak Held Secret Talks On Kashmir: Report

SRINAGAR: Before a surprise ceasefire announcement by India and Pakistan on February 25, the top intelligence officers from the two nuclear countries held secret talks in Dubai in January in a new effort to calm tensions over Kashmir, the Reuters news agency reported.

Quoting two unnamed people with close knowledge of the matter, the report said that officials from India's Research and Analysis Wing, the external spy agency and Pakistan's

Inter-Services Intelligence (ISI) travelled to Dubai for a meeting facilitated by the United Arab Emirates government. "There is a lot that can still go wrong, it is fraught," one of the people in New Delhi told Reuters. That is why nobody is talking it up in public, we don't even have a name for this, it's not a peace process. You can call it a re-engagement," one of them said.

Both countries have reasons to seek a rapprochement.

The report also said that the Indian foreign ministry did not respond to a request for comment. Pakistan's military, which controls the ISI, also did not respond.

1141 More Test Positive, Four More Die

SRINAGAR: Jammu and Kashmir on Thursday recorded 1,141 new coronavirus infections that pushed the number of active cases in the union territory past the 10,000-mark for the first time this year, officials said.

With the fresh cases, Jammu and Kashmir's cumulative tally has risen to 1,42,877. The death toll climbed to 2,046 with four new

fatalities, they said. Of the fresh cases, 707 were reported from the Kashmir division and 434

from the Jammu division. The officials said Srinagar district recorded the highest number of fresh cases at 418, including 71 travellers, followed by 215 in Jammu and 136 in Baramulla.

A twitter account, claiming to be the official handle of Geelani,

posted a press release allegedly issued by the separatist leader wherein he purportedly called for a general shutdown against what he alleged as "killing of children and desecration of religious places".

The press release, allegedly signed by Geelani, was referring to the killing of 12 militants in four encounters since last Friday. One of the encounters took place inside a mosque which was extensively damaged during the operation.

SRINAGAR: The National Investigation Agency (NIA) on Thursday arrested a school teacher for his alleged involvement in recruiting young boys for Lashikar-e-Taiba (LeT) in north Kashmir's Bandipora district.

Altaf Ahmad Rather, a resident of Jammu and Kashmir's Bandipora district, was wanted in a case registered in West Bengal last year following the arrest of a woman, Tania Parveen, for her association with the group, a spokesman of the NIA said.

Investigation has revealed that Rather is a school teacher in Bandipora and was a sympathiser of the LeT. Parveen had come in contact with him over social media platforms and he was instrumental in introducing her to LeT members based in Pakistan. in pursuance of a conspiracy to radicalise, motivate and recruit youths for violent Jihad (holy war) on India, he said.

spokesman said Parveen was arrested by the West Bengal Police last year for her association with the LeT.

Global warming making Indian monsoon seasons stronger, more chaotic: Study

limate change will make summer monsoon rainfall in India stronger and more erratic, according to a study that predicts extremely wet years in the future, with potentially grave consequences for over a billion people's well-being, economy, food systems and agriculture.

The study, published in the journal Earth System Dynamics, compared more than 30 state-of-the-art climate models from all around the world.

"We have found robust evidence for an exponential dependence: For every degree Celsius of warming, monsoon rainfalls will likely increase by about 5 per cent," said study lead author Anja Katzenberger from the Potsdam-Institute for Climate Impact Research (PIK) in

"Hereby we were also able to confirm previous studies but find that global warming is increasing monsoon rainfall in India even more than previously thought. It is dominating monsoon dynamics in the 21st century," Katzenberger said.

The researchers noted that more rainfall is not necessarily a good thing for the farming sector in India and its neighbouring countries.

"Crops need water especially in the initial growing period, but too much rainfall during other growing states can harm plants—including rice on which the majority of India's population is depending for sustenance," said study co-author Julia Pongratz from Ludwig-Maximilian University (LMU) in Germany.



"This makes the Indian economy and food system highly sensitive to volatile monsoon patterns," said

A look into the past underlines that human behaviour is behind the intensification of rainfall, according to the researchers.

Starting in the 1950s, human-made forcings have begun to overtake slow natural changes occurring over many millennia, they said.

At first, high sun-light blocking aerosol loadings led

to subdued warming and thus a decline in rainfall.

However, from 1980 onwards, greenhouse gasinduced warming has become the deciding driver for stronger and more erratic Monsoon seasons.

We see more and more that climate change is about unpredictable weather extremes and their serious consequences," said group leader and co-author Anders Levermann from PIK and Columbia University in the US.

"Because what is really on the line is the socio-economic well-being of the Indian subcontinent," Levermann said.

He explained that a more chaotic monsoon season poses a threat to the agriculture and economy in the region and should be a wakeup call for policymakers to drastically cut greenhouse gas emissions worldwide.

The nature of offences was mainly use of unstamped commercial weights and measures. The use of un-reverified weights and measures is illegal under the Legal Metrology Act.

Frequent Power Outages In Srinagar, Irk Residents

People Resort To Overloading: CE

Srinagar: The Kashmir Power Distribution Corporation Limited (KPDCL) has failed to adhere to the power schedule even in the holy month of Ramadan, leaving the residents across Srinagar to suffer

People in most parts of Srinagar have complained of inadequate electricity, saying that the department has failed to ensure adequate electricity even in the holy month of Ramadan.

"We are facing erratic power cuts despite being assured adequate electricity in the ongoing holy month of Ramadan," the lo-cals from different Old City and Uptown areas like Natipora, said. 'The department has even failed to ensure the electricity during Sehri and Iftari time," the locals residents from Old city areas said.

Jehangir Ahmad, a local resident from Natipora said that unscheduled power cuts especially at the time of Sehri and Iftar has added to the miseries of people. "Despite being promised high and tall, the local consumers are being pushed to the wall by forc-

ing them to reel under darkness. Meanwhile, Chief Engineer KPDCL Aijaz Ahmad Dar said the department could have provided uninterrupted power supply to the consumers in case

there would have been cooperation from their (consumers) side.

"We are being forced to go for a curtailment as the people resort to overloading especially during Sehri and Iftar times," he said, adding that they have limited capacity to provide electricity and thus people should understand and cooperate.

"They must not resort to the overload so that the department is able to provide adequate electricity especially in the ongoing holy month of Ramadan.'

He said that against the agreement load of 250 MW in Srinagar, the department is providing 650 MW for the district—(KNO)

Pervez Visit To Begin With Prayers

India to fire new CBMs At Pak

ew Delhi - Pakistan President Pervez Musharraf will begin his two day India visit Saturday with prayers at dargah of Sufi saint Khwaia Moinudin Chisti at Ajmer before commencing extensive talks with Prime Minister Manmohan Singh on all outstanding issues, including Kashmir, on Sunday

Seeking to break fresh ground. Prime Minister Manmohan Singh is expected to place new confidence building measures to carry forward the peace process in his talks with Pakistan President, who visits India on his first visit after the failed 2001 Agra Summit

Singh, who will hold parleys with Musharraf after witnessing the last one-day Indo-Pak cricket match for over an hour in the morning, is likely to suggest opening of additional bus routes and ways to promote tourism in Kashmir to enable people-to-people contacts. A joint statement after the talks is not ruled out.

Official sources said that Musharraf, who will he accompanied by his wife Sebha and a 40-member delegation, has been conveyed Singh's suggestion that providing full security to the Srinagar-Muzaffarabad bus service-was the "joint responsibility" of the two countries and signals from that side have been "positive"

On the eve of Musharraf's visit, the Prime Minister told a Chief Ministers' conclave here that "it is the joint responsibility of the Governments of India and Pakistan," to provide full security to the bus passengers. The two countries should fight the scourge of terrorism in the region, he added. FIGHTING TERROR TOGETHER:

India and Pakistan can work together in fighting the sources of terrorism in the region making it clear it was their joint responsibility to ensure full security to the passengers of Srinagar-Muzaffarabad bus service.

He said "I do believe that it is the joint responsibility of the Governments of India and Pakistan, and of the local authorities on both sides of the line of control, to work together in providing full security cover to the bus service which is a service for peace and for promotion of reconciliation.

"I sincerely hope we can work together in protecting the lives of innocent people and in lighting the sources of terrorism in the region," Singh said.

ARAB EMIRATES — Iran's supreme leader on Wednesday dismissed initial offers at talks in Vienna to save Tehran's tattered nuclear deal as "not worth looking at," attempting to pressure world powers after an attack on the country's main nuclear enrichment site.

The comments by Ayatollah Ali Khamenei, who has final say on all matters of state in the Islamic Republic, came after a day that saw Iran's president similarly ratchet up pressure over the accord. European powers meanwhile warned Tehran its actions were "particularly regrettable" and "dangerous."

Johnson & Johnson's Covid-19 vaccine remained in limbo on Wednesday as a US health panel called for more data before making a decision on how and whether to resume use of the one-dose shot, putting off a vote for a week or more.

"Time To End Forever War": Joe Biden To Begin US Afghanistan Exit On May 1

President Joe Biden said on Wednesday he will begin withdrawing US troops from Afghanistan on May 1 to end America's longest war, rejecting calls for US forces to stay to ensure a peaceful resolution to that nation's grinding internal conflict.

In a White House speech, Biden acknowledged that US objectives in Afghanistan had become "increasingly unclear" over the past decade. He set a deadline for withdrawing all 2,500 U.S. troops remaining in Afghanistan by Sept. 11, exactly 20 years after al Qaeda's attacks on the United States that triggered the war.

But by pulling out without a clear victory, the United States opens itself to criticism that a withdrawal represents a de facto admission of failure for American military strategy.

"It was never meant to be a multi-generational undertaking. We were attacked. We went to war with clear goals. We achieved those objectives," Biden said, noting that al Qaeda leader Osama bin Laden was killed by American forces in 2011 and saying that organization has been "degraded" in Afghanistan.

"And it's time to end the forever war," Biden added.

The war has cost the lives of bers and consumed an estimated \$2 trillion. U.S. troop numbers in Afghanistan peaked at more than 100,000 in 2011.

The Democratic president had faced a May 1 withdrawal deadline, set by his Republican predecessor Donald Trump, who tried but failed to pull the troops out before leaving office in January. Instead, Biden said the final withdrawal would start on May 1 and end by Sept. 11.

In withdrawing, Biden is embracing risks at the start of his presidency that proved too great for his predecessors, including here to the deal the group reached that al Qaeda might reconstitute with Trump's administration.

"I am now the fourth American president to preside over an American troop presence in Afghanistan. Two Republicans. Two Democrats," Biden said. "I will not pass this responsibility on to a fifth."

Meeting NATO officials in Brussels, Secretary of State Antony Blinken said foreign troops under NATO command in Afghanistan will leave in coordination with the U.S. withdrawal by Sept. 11, after Germany said it would match American plans.

Blinken also spoke by phone with Pakistan's army chief on Wednesday and discussed the peace process, the media wing of Pakistan's military said.

Afghan President Ashraf Ghani wrote on Twitter that he spoke with Biden and respects the U.S. decision. Ghani added that "we will work with our U.S. partners 2.448 American service mem- to ensure a smooth transition" and "we will continue to work with our US/NATO partners in the ongoing peace efforts."

A conference is planned on Afghanistan starting on April 24 in Istanbul that would include the United Nations and Qatar.

The Taliban, ousted from power in 2001 by U.S.-led forces, said they would not take part in any meetings involving decisions about Afghanistan until all foreign forces have left. Taliban spokesman Zabihullah Mujahid on Wednesday called on the United States to ad-

Nearly Half Of Women In 57 Developing Countries Denied Bodily Autonomy

Nearly half of women in 57 developing countries are denied the right to decide whether to have sex with their partners, use contraception or seek healthcare -the three dimensions of bodily autonomy, according to a UN report.

Only 55 per cent of women in those countries are fully empowered to make choices over all three dimensions of bodily autonomy, according to the annual flagship State of World Population Report of the UN Population Fund (UNFPA) released on Wednesday.

"The fact that nearly half of own decisions about whether or not to have sex, use contraception or seek health care should Director Natalia Kanem as saying in the statement.

"In essence, hundreds of millions of women and girls do not own their own bodies. Their lives are governed by others." The report is based on re-

sponses to questions posed to women aged 15 to 49 years in mographic and health surveys in 57 countries, most of which are in sub-Saharan Africa.

Percentages vary across regions. The villages designated as 'Micro Containment Zones' include Khawaja Bagh lower petrol pump to jetty road, Chak Kanispora, Sangri colony, Kanli Bagh, Dewan Bagh, Delina (Qazi-Mohalla) Rawatpora, Delina ghat, Milat colony, Sherwani Colony and Lone-Mohalla Farozpora.

An order issued by Deputy Commissioner Baramulla in this regard, reads that whereas, in view of emerging situation due to COVID, the state Executive Committee of Department of Disaster Management, Relief Rehabilitation & Reconstruction vide Government Order No 11-JK (DMRRR) of 2021 dated 30/3/2021, has empowered the District Magistrate to take local preventive measures for checking spurt in infections.

Afghan endgame

he United States President Joe Biden on Wednesday announced that all American troops would be withdrawn from Afghanistan by September 11 this year, thus bringing to end America's longest war, spanning two decades. The North Atlantic Treaty Organisation which has aided US war effort is also pulling out its troops from Afghanistan.

The US decision to withdraw comes in the wake of a deal with Taliban in Doha on February 29, 2020. Under the pact, the U.S. agreed to withdraw all its soldiers from Afghanistan in 14 months. Now, the deadline to do so has been extended by a few months more.

Biden has asked the countries neighbouring Afghanistan, "especially Pakistan", to play supportive roles. He also sought cooperation from Russia, China, India and Turkey but conspicuously omitted mention of Iran. Around 2,400 US soldiers have lost their lives in the war, along with tens of thousands of Afghan troops, Taliban militants and Afghan civilians.

However, as underlined by Biden himself, eventually the peace and stability in Afghanistan will have to be the responsibility of the regional powers. And it is unlikely to happen if the regional powers pursue their disparate interests in the war-torn country. The US will also need to make some subtle adjustment in its Afghanistan policy to make it work in the long term. In its current form, the policy almost entirely neglects the regional geo-politics, prevailing issues and the contending interests of the neighbouring countries like India and Pakistan which also keep the conflict going in Kabul. So rather than an exclusively Afghanistan-centric policy, US also needs a broader regional approach to work for an integrated solution to the conflicts and the competing interests that in turn fuel the war.

The conflict in Afghanistan is now so much enmeshed with the regional rivalries and the issues that it appears improbable that there would be long term stability in Kabul unless steps are taken to get the regional countries co-operate to end the forty year long bloodshed in the country. The deeply challenging project of a peaceful Afghanistan, therefore, demands a broader regional cooperation, more so, between India and Pakistan. It is only to be hoped that New Delhi and Islamabad realizing the momentous changes sweeping through region will co-operate to not only steer the region through the fraught transition of a post-US Afghanistan but also take concrete steps to address their lingering differences which alone will be the guarantee for a sustainably peaceful South Asia and the broader region. It is here that a renewed engagement between the two neighbours offers some promise. Here's hoping that it lasts.

Crack the Virus

n Tuesday, the Pune-based National Institute of Virology shared a significant piece of information on the recent surge of the coronavirus in Maharashtra. Sixty-one per cent of the COVID-19 samples, collected from the state by the premier virology institute between January and March had the double mutation, now classified as the B.1.617 lineage.

Mutation is quintessential to viruses. Such changes in the pathogen can be inconsequential, deadly or even beneficial. Genome sequencing can help us understand how fast the virus will spread and how lethal it could turn out to be. Even if a mutant is not more virulent, it could be more infectious and that could put pressure on an area's health infrastructure. We know, for example, that healthcare facilities in most of the COVID hotspots in the country, including Maharashtra, are badly stretched. It also seems that the infection is spreading faster than last year. But we need to track the virus's genome sequence to understand if this is because the pathogen turned more infectious. Hospitallevel analyses can help ascertain if the mutant is deadlier or more debilitating then the virus's exiginal events.

It's now apparent that getting the better of the coronavirus will require multiple strategies. Inoculation, of course, remains the best bet against the scourge. Studies indicating that the South African variant can evade vaccines do point to a new challenge. Vaccine developers have reported early signs of success in plugging this gap. Also, a negligible number of people in India have, so far, been infected by this mutant. The potency of the vaccines currently in use in the country against B.I.617 is another cause of assurance. Even then, the need to be vigilant cannot be overstated. There can, therefore, be no compromise on COVID-appropriate behaviour.

ammu and Kashmir has witnessed an unprecedented spike in Covid-19 cases since the past two weeks. Yesterday, the Union territory recorded a total of 1086 cases and 5 Covid-19 related deaths. Of all the districts in the region, Srinagar has had the highest number of cases and is also the district that hosts tourists as they arrive.

The rising covid-19 cases has a contender in numbers— the rising number of tourists that have arrived in Kashmir since the abrogation of Article 370. Kashmir has hosted about 1 Lakh tourists since December alone. What has given a tough time to covid-19 in making the news is the "news-worthy" arrival of popular faces from the Indian entertainment industry. Additionally, tulips are being touted as the panacea to the pandemic. In only the first week after being opened to the public, Kashmir's tulip garden hosted over 50,000 visitors.

Additionally, mega events are being organised even as Kashmir is at war with the second wave. These events have interestingly invited criticism especially the infamous fashion show that was recently organised in SKICC. People on each side of the debate are busy weighing the merits and demerits of this enterprise without sparing a thought at the sheer grotesque ness of having organised such avoidable indulgences. Schools have been closed down in Kashmir which undoubtedly is a more pressing institution than recre-

ation, tourism and entertainment.

The contradiction in tourism and avoidable events still having the green signal from the adminis-

tration is quite disappointing. But it isn't perplexing.

Tourism as an industry isn't merely relevant because of its economics. Its reputation is as dark as history. Even following SOPs are only individual efforts which will ultimately prove wanting in the absence of systematic measures by the administration. The government needs to evaluate if it can risk the lives of Kashmiris as well as the tourists in the absence of ensuring access to health care for all. It also needs to proactively regulate the industry and leave no scope for complacency at any stage. This urgency is cardinal and overlooking it is likely going to prove deadly.

Fasting and Health in Ramadan

In addition, the fasting in Ramadan is voluntarily taken and is not a prescribed imposition from the physician

amadan is a month of self-regulation and self-training. Muslims fast in accordance with our religious requirements, but there are medical benefits as well. Generally, fasting has been used by patients for weight management, to rest the digestive tract, and for lowering lipids. There can be adverse effects of both total fasting and crash diets.

Islamic fasting is different from these diet plans because in Ramadan fasting, there is no malnutrition or inadequate calorie intake. The calorie intake of Muslims during Ramadan is typically at or slightly below the nutritional requirement guidelines. In addition, the fasting in Ramadan is voluntarily taken and is not a prescribed imposition from the physician. And there is hope that this training will last beyond the end of Ramadan.

The difference between Ramadan and total fasting is the timing of the food; during Ramadan, we take an early pre-dawn breakfast and do not eat until dusk. The fast is from both food and liquid intake. Abstinence from water for eight to 10 hours is not necessarily bad for health. In fact, it causes concentration of all fluids within the body, producing slight dehydration. The body has its own water conservation mechanism. It has even been shown that slight dehydration and water conservation, at least in plant life, improve their longevity.

The physiological effect of fasting includes lowering of blood sugar, lowering of cholesterol, and lowering of the systolic blood pressure. In fact, Ramadan fasting could be an ideal recommendation for the treatment of mild to moderate, stable, non-insulin diabetes, obesity, and essential hypertension. It is important to note that patients who are suffering from severe diseases, such as Diabetes or coronary artery disease, kidney stones are exempt from fasting and should not be allowed to fast.

There are psychological effects of fasting as well. There is a peace and tranquility for those who fast during the month of Ramadan. Personal hostility is at a minimum, and in areas of the world where Muslims are living in large numbers, the crime rate decreases. This psychological improvement could be related to



better stabilization of blood glucose while fasting; hypoglycemia after eating can aggravate behavior changes.

There is a spiritual beneficial effect of extra prayer at night. This not only helps with better utilization of food, but also helps in energy output. It has been calculated that there are 10 extra calories output for each unit of the prayer. This would particularly be connected to the extra prayers that are performed during the last 10 nights of Ramadan, when the believer is seeking the night of power, when worship during this night is said to be worth a thousand months.

It is important to emphasize that Muslims are not performing prayers for exercise, but a mild movement of the joints with extra calorie utilization can be a better form of exercise. Similarly, recitation of the Quran not only produces a tranquility of heart and mind, but it has also been shown to improve memory.

Fasting is a special act of worship which

is ultimately between the believer and the Creator Himself, as no one else knows for sure if this person is actually fasting. In a hadith of the Prophet Muhammad, peace and blessings be upon him, Allah says, "Fasting is for Me and I only will reward it." In another hadith, the Prophet reminds us, "If one does not give up falsehoods in words and actions, Allah has no need of him giving up food and drink.

Fasting not only purifies a Muslim's soul but also his body. Fasting helps reduce weight and rejuvenate the body as food consumption is modified and the body gets a chance to cleanse itself of unwanted impurities and toxins.

Ramadan brings with itself countless blessings and benefits. Observe fasting in Ramadan to be rewarded in this world and the Hereafter.

'Social Isolation May Reduce **Face Recognition Ability'**

solitary lifestyle can have profound effects on the brains' abilities to recognise faces, finds a study on wasps with implications on humans facing social isolation due to the coronavirus pandemic.

Paper wasps -- a social insect -- recognises the brightly coloured faces of other paper wasps. But, when reared in isolation, they tend to lose the ability, according to researchers from Cornell University in New York, US. The wasps' ability to remember faces is similar to primates and humans, but unlike other social insects, they noted.

The findings, published in the journal Biology Letters, revealed that when adult wasps are housed in solitude, visual areas of their brains -- especially



those involved with identifying nuanced colour patterns and shapes -- are smaller

and less developed than their peers who

"The wasps provide us with a simple insect brain that offers a system for understanding the basic constructs of how neural circuits work and how social interactions shaped the brain," said Michael Sheehan, Assistant professor at the varsity's College of Agriculture and

"To my knowledge, this is the first empirical study to propose a candidate brain region in an insect that is involved with individual identity processing," said Christopher Jernigan, a postdoctoral researcher in Sheehan's lab.

The study has implications on human patients forced to isolate themselves from family and friends due to the coronavirus pandemic, which has so far infected 138 million people and claimed 2.97 million lives globally.

Study discusses impact of chemotherapy on immune cells

The findings of recent research from Queen Mary University of London revealed novel insights into the effects of chemotherapy on the tumour microenvironment (TME).

The study, published today in Cancer Immunology Research, a journal of the American Association for Cancer Research, found that chemotherapy enhances the anti-tumour actions of immune cells within the TME and their ability to support immune responses

Cancers are not just a mass of cancerous cells but are rogue organs made up of many different cell types, including cells that form connective tissue and blood vessels, and immune cells. These non-cancerous cells have been recruited and corrupted by cancer to help it grow and spread, and constitute what is known as the TME.

When treating cancer cells with chemotherapy, the cells within the TME are also impacted and previous research has shown that chemotherapy may activate immune cells within the TME to fight against cancer. In this study, the team, led by Professor Fran Balkwill, investigated the effects of chemotherapy on immune cells called macrophages, which are associated with poor survival across a variety of cancer types. The study focused on high-grade serous ovarian cancer (HGSOC) - the most common type of ovar-

Chemotherapy switches immune cells to anti-tumour mode

By comparing biopsy samples taken from the omentum (most common site of cancer spread in HG-SOC) of 26 patients prior to and after chemotherapy,

the team found a significant reduction in the number of macrophages present in the tissues following treatment. Further investigations in samples from other HGSOC patients revealed that chemotherapy switched the remaining macrophages from a pro-tumour to an anti-tumour mode, which may stimulate the patient's immune response against cancer.

The effects of chemotherapy on macrophages ob-



served in patient samples were also seen in preclinical mouse models of HGSOC previously developed by the team, which recapitulate many aspects of the human

As macrophages are associated with poor survival in cancer, the team took their research a step further to determine whether eliminating all macrophages from the TME after chemotherapy could prolong diseasefree survival in the preclinical mouse models. To their

surprise, removing all macrophages shortly after the completion of chemotherapy caused the mice to relapse quicker. Following three doses of chemotherapy, the macrophages had switched to an anti-tumour mode, and so eliminating the macrophages from the TME actually inhibited the immune response against the tumour and resulted in poorer survival outcomes.

The research was funded by Cancer Research UK, the Wellcome Trust, and Wellbeing of Women

Implications for ovarian cancer treatment

Chemotherapy and surgery are currently the main treatment options for patients with ovarian cancer. Despite chemotherapy working well initially, many patients experience relapse due to the development of resistance against these drugs.

Professor Balkwill from the Queen Mary University of London said: "This study enhances our understanding of the impact of chemotherapy on macrophages and other aspects of the immune response. As our work was driven by results first obtained in patient samples and we were able to replicate the findings in our mouse models, we could investigate hypotheses and obtain data that have translational significance.

'We now have effective preclinical models of treatment and relanse that can be used to help identify treatments that build upon the tentative immune response triggered by chemotherapy.'

Ultimately, the team hopes that their models could help to identify new drug combinations that harness the initial immune-boosting effects of chemotherapy to reduce the number of required chemotherapy doses, minimise toxic side effects and improve survival for patients with ovarian cancer.

Study reveals glaucoma may be more than eye pressure issue

new study conducted in rats shows that chemical known to protect nerve cells also slows glaucoma, the leading cause of irreversible

Led by researchers at NYU Grossman School of Medicine, the study centers on the watery fluid inside the eye on which its function depends. Fluid pressure can build up in patients with glaucoma, wearing down cells in the eye and the nerves connecting them to the brain, researchers said.

However, past studies have shown the condition to continue to worsen even after eye pressure has been controlled. The connection between pressure buildup and impaired vision remains poorly understood.

Published in Neurotherapeutics, the new study showed that ingesting the compound citicoline restored optic nerve (neural) signals between the brain and eye to near-normal levels in the study rats. Naturally produced in the brain but also available commercially, citicoline is a major source of choline, a building block in the membranes that line nerve cells and enhance nerve



While the study results confirmed past findings that elevated eye pressure contributes to nerve damage in glaucoma, it also showed that citicoline reduced vision loss in rats without reducing fluid pressure in the eye.

"Our study suggests that citicoline protects against glaucoma through a mechanism different from that of standard treatments that reduce fluid pressure," said senior study author Kevin Chan, PhD, an assistant professor in the Department of Ophthalmology at NYU Langone Health. "Since glaucoma interrupts the connection between the brain and eye, we hope to strengthen it with new types of therapies.'

According to the National Glaucoma Foundation, over 3 million Americans have glaucoma, but only half know they actually have it. In the US, more than 120,000 individuals are blind from the disease. In addition, the World Health Organisation (WHO) estimates that over 60 million individuals suffer from glaucoma worldwide.

The findings are helping scientists better understand how glaucoma works and add to past evidence that citicoline may counter the disease, said Chan, also the director of the Neuroimaging and Visual Science Laboratory at NYU Langone. Previous studies had showed that humans and rodents with glaucoma have lower than normal levels of choline in the brain. Until now, Chan said, there has been little concrete evidence of the effectiveness of choline supplements as a therapy for glaucoma or why choline occurs in lower levels in glaucoma patients.

Chan and his team tested whether increasing levels of that chemical would slow or even stop the degradation of the optic nerve and other regions of the brain involved in vision. Using a comprehensive study of the eye-brain connection in glaucoma, his team found that giving rats oral doses of citicoline over a three-week period protected nerve tissues and reduced vision loss sustainably even after the treatment stopped for another three weeks.

mazon India on Thursday launched a \$250 million venture fund that will invest in startups and entrepreneurs focused on technology innovations in agriculture, healthcare and digitising small and medium businesses (SMBs).

"The venture fund will independently invest in startups, building solutions to empower SMBs to launch, manage, and grow their business online, automate and digitise their operations, and expand their business globally by exporting to customers worldwide. These investments will help seed and scale up innovation in the sector," the e-commerce giant said.

The fund will also be investing in healthcare and agri startups. It aims to invest in companies that are making agri-inputs more accessible to farmers, offering soclinics among others.

The first such investment by the fund will be in M1xchange, a startup focusing on invoice discounting marketplace exchange for micro, small and medium enterprises. M1xhange is raising \$10 million through the funding round in which BEENEXT and existing investor Mayfield are also participating, apart from Amazon.

As a part of its push to digitise SMBs, Amazon runs a Local Shops on Amazon platform, for onboarding thousands of small merchants. The company is scaling up this programme and aims to bring 1 million retailers and neighbourhood stores online by 2025.

The programme was launched in April 2020 at a time a complete lockdown had been announced in India in the wake of the COVID-19 pandemic. Last month, Amazon had said that over 50,000 offline retailers and neighbourhood stores were now a part of this programme.

This oversight allows the existence that of status monitoring services that allow you to see who is online by just entering their phone number. As reported on by Traced, there are several services that take advantage one of which allows you to spy on a spouse or give frequent updates to parents on a child's WhatsApp activity.

You can even enter a second phone number and compare the times the two were 'Online' to figure out if they were messaging each other.

A Reddit user going by the handle 'lollygagme' tried this out and watched her partner's activity for a week. She found that she was able to pick up on "patterns where he's actually hav-

ing an in-depth back and forth conversation with someone versus him checking in over and over to see if she's replied back yet."

High Inflation Adds To Lockdown Worries

NEW DELHI: The wholesale price index (WPI) inflation rate stood at 7.39 per cent for March 2021, the highest since October 2012, when it was 7.4 per cent, according to the provisional data released by the Department for Promotion of Industry and Internal Trade of the Commerce Ministry.

Besides WPI inflation touching a 96-month high, most of its subsets also touched recent highs. Primary articles inflation jumped to a 13-month high of 6.4 per cent; fuel, power, light inflation rose to 28-month high of 10.3 per cent;

and manufactured products inflation was at a nine-year high of 7.3 per cent.

But the Ministry said the WPI for March last year was computed with a relatively low response rate and, therefore, the difference between the corresponding period this year has recorded a larger gap.

Inflation related woes, that are likely to last till August, come on top of a second Covid wave sweeping the country. Besides the badly affected Gujarat, Madhya Pradesh, Maharashtra and UP, news is coming of the elections having acted as super spreaders. West Bengal has recorded a 450 per cent increase in active caseload in a fortnight, Tamil Nadu 309 per cent and Kerala 111 per cent.

The day also saw the rupee turning into Asia's worst-performing currency and is poised for more losses as localised lockdowns and restrictions begin hitting the economy.
As a result, Goldman Sachs has

downgraded the GDP growth forecast for 2021 to 10.5 per cent from 10.9 per cent.

The ministry said the prices of crude oil, petroleum products and basic metal substantially increased last month as compared to the corresponding month of last year.

SBI Clarifies On Transaction Charges In Zero-Balance Accounts

he State Bank of India (SBI) on Thursday released a clarification on the recent media reports based on the outcome of a study by IIT Bombay. A study by IIT-Bombay has claimed that State Bank of India and several other banks in the country have been imposing excessive charges on certain services which are provided to those with zero-balance accounts or Basic Savings Bank Deposit Accounts (BSBDA), according to reports. SBI collected over 300 crore by accounts w.e.f 15.06.2016 with prior intimation to the customers." India's largest lender clarified.

During August 2020, the Central Board of Direct Taxes (CBDT) advised banks to refund the charges collected, if any, on or after 01.01.2020 on transactions carried out using the digital mode and not to impose charges on future transactions carried out through such modes.

Following the directives, SBI has refunded the charges recovered in respect of all the digital transactions to the BSBD customers w.e.f. 01.01.2020 to 14.09.2020, the lend-



levying service charges during the period 2015-20, the study claimed.

In August 2012, Reserve Bank of India said that banks are free to levy charges in BSBD accounts beyond four free transactions. The availment of such additional services shall be at the option of the customers.

"Accordingly, SBI introduced charges for debit transactions beyond four free transactions in BSBD

"SBI has stopped recovering charges in such accounts on all digital transactions w.e.f. 15.09.2020, while retaining charges on cash withdrawals over and above four free withdrawals allowed per month," the bank said.

"The objective is also to encourage BSBD account holders including PMJDY account holders to adopt digital payment through the prescribed modes vis-à-vis the cash transactions," it added.

Airlines Gain Altitude, But Will Fly Into Losses This Fiscal, Too

NEW DELHI: Domestic airlines are expected to log net losses in FY22 on the back of lower domestic air traffic compared with pre-pandemic levels, together with high fuel prices, ratings agency Crisil said.

However, the agency said that these net losses will be 35-40 per cent below the ones reported for fiscal 2021 mark at Rs 9,500- Rs 10,000 crore.

A Crisil Ratings study of the top three airlines, which account for 78 per cent of total passenger traffic, noted: "A resurgence of Covid-19 infections across the country -- especially in Mumbai and Delhi, which account for 36 per cent of overall air traffic - is expected to stall the recovery seen over the past six months.'

"In fact, average daily de passenger air traffic has fallen in April by almost 20 per cent to 2.35 lakh compared to February 2021." Nonetheless, it said that domes-

tic traffic, which accounts for 75 per cent of airline revenues, is expected to surge 120-130 per cent this fiscal on a low base though it will still be significantly lower at 70 per cent of fiscal 2020 level.



"Domestic traffic fell 85 per cent in the first half of last fiscal due to lockdowns and restrictions on operations," said Gautam Shahi, Director, Crisil Ratings.

"Despite the second waveduced fresh curbs which will temper recovery, domestic traffic in the first half of this fiscal is likely to be 3.5-4 times higher on-year, on a low base. The second half should see good recovery in traffic, supported by acceleration in the vaccination drive and people gradually taking to travel after

prolonged stay at home." Besides, a gradual recovery in international operations in the second half of fiscal 2022 will also boost traffic, it said. But, airlines have also seen their

cost of operations spurt due to a rise in the price of aviation turbine fuel (ATF), a key cost head for them.

"The price, which remained low until November 2020, limiting their losses, has shot up 30 per cent since then," the report said.

"This will offset the benefits from some of the initiatives the carriers undertook to reduce cost - employee costs, rentals, etc. - last fiscal, and which are being carried forward into the current fiscal."

Spot gold rose by \$10.24 to \$1,746.62 an ounce at 1202 GMT in London trading.

MCX Bulldesk increased 55 points or 0.38 percent, at 14,660 at 17:33. The index tracks the realtime performance of MCX Gold and MCX Silver futures.

"Gold prices rose as a weaker dollar and U.S. yields boosted the safe-haven metal's appeal, while investors awaited the release of weekly jobless claims and March retail sales data in the U.S. later in the day. The dollar held near a three-week low against a basket of currencies on Thursday, as U.S. bond yields levelled off following a surge last month", said Navneet Damani, Vice President, Motilal Oswal,

Governor Powell mentioned in his speech yesterday that the U.S. economy accelerated into the spring based on rising consumer sentiment and the country is on track for faster growth and hiring in the coming months. US health panel called for more data before making a decision on whether to resume Johnson & Johnson's. Gold futures for June delivery gained Rs 263, or 0.56 percent, at Rs 46,871 per 10 gram in evening trade on a business turnover of 11,668 lots. The same for August jumped Rs 247, or 0.53 percent, at Rs 47,078 on a business turnover of 2,021 lots.

The value of June and August's contracts traded so far is Rs 1,801.55 crore and Rs 51.74 crore, respectively.

Similarly, Gold Mini contract for May edged higher Rs 263, or 0.57 percent at Rs 46,580 on a business turnover of 17,356 lots.

Gold prices traded higher on dollar decline which fell to threeweek lows despite some uptick in bond yields. The higher inflation concerns and worries over rising virus cases have supported buying in the yellow metal.

We expect gold prices to trade sideways to up for the day with CO-MEX spot gold support lies at \$1,730 and resistance at \$1,760. MCX Gold June support lies at Rs 46,500 and resistance lies at Rs 47,100.

Residents while expressing their resentment against the Development Authority told the news agency, that even after spending a hefty amount of money from the government exchequer for the construction of huts for tourists and visitors, it has failed to serve the purpose as many of the huts are left unattend-

ed for a long time now. Official sources said that the LBDDA has its huts in Diver Lolab, Chandigam, Lalpora, Khumriyal, Zangli, Reshwari, Gaddaji, Sunmulla, and Drangyari but are closed for a long now without generating any revenue.

Locals said the concerned developmental authority is acting as a mute spectator and has not initiated any concrete steps to promote these places. A local contractor said that the LBDDA recently issued very high bidding charges for the huts that have not opened for long now and even people of this district are not well aware of those structures.

These assets need the attention of authorities at the earliest since they have not served any purpose by far. Many of them are out of bounds for locals. The administration must promote these places to give tourism a flip," he said

A student said, "this is high time for the government to promote tourism on this frontier district which has high potential to generate revenue," he said.

Meanwhile, the Additional Deputy Commissioner (ADC), Nazir Ahmad, who holds the additional charge of LBDDA Chief Executive Officer (CEO), said that the huts can only generate revenue when tourists visit the district.

He maintained that all these huts are functional—(KNO)

LG Calls For Institutionalizing Transparent, Efficient; Pro-People Administrative Set Up Across The UT

JAMMU: Lieutenant Governor, Manoj Sinha chaired a meeting with all Deputy Commissioners and Senior Superintendents of Police of the Jammu Division to review the developmental scenario, law and order situation, besides assessing the Covid containment and mitigation efforts across the districts, at the Civil Secretariat here on Thursday.

Outlining the agenda of establishing a transparent, efficient, pro-people administrative set up across the Union Territory, the Lt Governor called upon the district officers to be sensitive towards the issues, problems and needs of the common public, an official spokesperson said.

The LG, he said, exhorted them to make on-ground assessment of areaspecific developmental needs of the district and formulating realistic District Development Plans that touch the lives of ordinary citizens and focus on the broad contours of enhancing employment, augmenting health and education sector, besides ensuring availability of basic amenities of a progressive society.

"At the outset, the Lt Governor was briefed by every Deputy Commissioner and Senior Superintendent of Police regarding the COVID situation in the district viz. - the status of testing, containment, vaccination, availability of oxygen and required medicines etc; progress on the establishment of offices, staff, residences and security of DDCs and other PRIs; progress of works taken up under Back to Village programme; status of Languishing projects; status of available online services among certain specific issues of the districts," the official spokesperson said.

While reviewing the preparations made by the districts regarding the ongoing festival season, the Lt Governor directed the officers to ensure proper supply of water, electricity and ration items to the public so that people can observe their religious activities smoothly.

Taking stock of the mechanism put in place by different districts to deal with the second wave of Covid and the progress of vaccination drive, the Lt Governor called for intensifying the testing, besides vigorous tracing and tracking of Covid contacts.

The Lt Governor directed the Health Department to share all data related to Covid with the Deputy Commissioners so as to facilitate district-wise achievement of vaccination and other targets. "Scaleup the vaccination drive in all the Districts by sensitizing people and providing every possible assistance", he added.

The Lt Governor also took a districtwise assessment of the availability of medicines, oxygen supply, and number of beds. He also called upon the officers to make dynamic plans as per the evolving situation.

While taking stock of the status of online services, the Lt Governor impressed upon the Deputy Commissioners for implementation of latest online technologies and best practices in citizencentric governance for improving the public service delivery, and making the administration effective, transparent, accountable, and citizen-friendly.

The Lt Governor directed the Deputy Commissioner, Poonch for constructing Toilets on Mughal road and asked him to identify viable spots for the same at the earliest. He also directed the Deputy Commissioners of other districts for proper maintenance and upkeep of Community toilets that are coming up along the National Highway.

Regarding the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) SEHAT scheme, the Lt Governor asked the Deputy Commissioners to speed up the registration process and called for the promotion of the scheme in each and every district for public welfare. "Ensure 100% coverage and delivery of SEHAT cards to the public", he asserted.

While hearing the matter on April 7, by a single Bench Court headed by Justice Ali Mohammad Magray, the Court had observed, "Prima facie there appears to be a consensus over the fact that while adhering to the provisions of law, the Competent Authority can seek such response from the owners whose vehicle remains in the State other than the one from where the vehicle is purchased for a period exceeding 12 months, but the question is raised as to who that Competent Authority is?"

"Feeling it appropriate", the court asked that to file their response so that the controversy is set at rest by or before April 15.

LONDON: India captain Virat Kohli has been named Wisden Almanack's ODI player of the 2010s, while England all-rounder Ben Stokes was declared the 'Cricketer of the Year' for a second successive time by the highly-rated annual publication.

The 32-year-old Kohli, who made his ODI debut in August 2008 against Sri Lanka, is among the finest batsmen of all time, and has amassed a staggering 12,169 runs from 254 ODIs.

"To commemorate the 50th anniversary of the first One-Day International, five ODI cricketers of the decade have been named in the 2021 edition of the Wisden Cricketers' Almanack," the reference book, often described as Bible of Cricket, stated.

"One cricketer has been named

for each of the decades between 1971 and 2021, with India captain Virat Kohli taking the award for the

2010s," Wisden said on its website. Kohli, who was part of the 2011 World Cup winning Indian team, made more than 11,000 runs in the 10-year stretch, averaging over 60 and scoring 42 centuries.

Apart from Kohli, Wisden also named legendary Sachin Tendulkar as the ODI Cricketer of the 1990s. The right-handed India opener, in 1998, made nine ODI hundreds, more than any other batsman in a single calendar year.

India's World Cup winning former captain Kapil Dev, too, featured on the list when he was named as the ODI Cricketer for the 1980s.

Kapil led India to its first ODI World Cup win in 1983. He also claimed more wickets than any other in the decade and scored at

the highest strike rate of any batsman with over 1,000 runs.

Meanwhile, Stokes was declared the 'Leading Cricketer in the World' for the second year in a row.

"His haul of 641 Test runs at 58 in the calendar year was more than anyone else, while his 19 wickets cost just 18 apiece. He did it all against a backdrop of personal tragedy: his father, Ged, died in December at the age of 65," Wisden editor Lawrence Booth said.

Dom Sibley, Zak Crawley, West Indian Jason Holder, Mohammed Rizwan and Darren Stevens were named Wisden Cricketers of the Year in the 2021 edition of Wisden Almanack.

Also, Australia's Beth Mooney was awarded 'Leading Women's Cricketer in the World' while West Indian all-rounder Kieron Pollard was named the Leading

IPL 2021, PK VS CSK, PREVIEW **CSK Eye Improved Bowling Effort Against Formidable Punjab Kings**

MUMBAI: Chennai Super Kings would look for inspiration from skipper Mahendra Singh Dhoni and a much-improved bowling effort when they take on a power-packed Punjab Kings in the IPL here on Friday.

The two sides experienced contrasting fortunes in their respective tournament opener.

While CSK lost by seven wickets against Delhi Capitals, Punjab Kings eked out a four-run win over Rajasthan Royals in a highscoring thriller.

With the dew playing a crucial role at Wankhede, the side winning the toss would want to bowl first.

In their first match here, CSK posted a competitive 188 for seven, riding on fine contributions from Suresh Raina (54), Moeen Ali (36), Sam Curran (34), Ravindra Jadeja (26) and Ambati Rayudu (23).

Despite failures from the opening duo of Rituraj Gaikwad and Faf du Plessis besides skipper Dhoni. CSK managed to put up a decent total on the board.

But the Chennai outfit's bowling unit looked completely out of sorts and clueless against the DC opening duo of Shikhar Dhawan and Prithvi Shaw, who were ominous from the word go and stitched a 138-run stand to take the game away from CSK.

The likes of Deepak Chahar, Sam Curran, Shardul Thakur, Jadeja and Moeen Ali all went for big runs and looked rusty.

And come Friday, the onus would be on master tactician Dhoni to inspire his teammates to lift their performance and give Punjab a run for their money But for that to happen, the CSK skipper himself needs to lead from the front after failing

to score against DC. Punjab Kings, on the other hand, had a narrow escape against RR the other despite posting a

mammoth 221 for 6 on the board. Opening the batting, KL Rahul played a captain's knock of 91 off just 50 balls. He was ably supported by big-hitting Chris Gayle (40 off 28) and Deepak Hooda (64 off 28).

For Punjab Kings and Rahul, batting is not at all area of concern as they showed with their performance in the opener, but just like CSK, the bowling unit remains a major worry despite spending big money at the auction.

RR skipper Sanju Samson almost single-handedly took the game away from Punjab Kings with his whirlwind 63-ball 119run knock in their opener, but fell short just by four runs in the end.

'Bitcoin Transactions New Challenge For Anti-Corruption Unit,' Says ICC's Integrity Head

NEW DELHI: Former Zimbabwe captain Heath Streak's shocking admission of cricket corruption has also shone a light on cryptocurrency finding a place in the bookies' list of enticements -- a brand new challenge for the ICC's Anti-Corruption Unit, which claims to be ready for

Streak was on Wednesday banned by the ICC for eight years after admitting to disclose inside information to a suspected Indian bookie during his coaching stints in Zimbabwe, Bangladesh as well as the IPL, Afghanistan Premier League and the Bangladesh Pre-

mier League. Till date cash has been the most preferred mode of payment for bookies, who also pay in kind with cars, jewellery and high-end

phones. However, Streak's case has thrown up the use of bitcoin in corrupt payments. The ICC's detailed judgement in the case has revealed that Streak once received two "bitcoins" from a corruptor in 2018, valued at USD

"It is a new phenomenon for us. but we have staff capable of investigating it. Corrupters try to use all modes including cash and 'hawala', which are not easy to trace either. Bitcoins pose a similar challenge," ICC ACU General Manager Alex Marshall said in an email reply to PTI's query on Thursday.

So what is cryptocurrency?

In layman's language, 'Cryptocurrency' is virtual money. It is the purchase of a digital asset based on an

The bitcoins that are generated aren't regulated by any central banking authority in any country (like the Reserve Bank of India) and in many countries like India, it is still an illegal tender.

In simpler words, it is a "Blockchain Industry" where a financial transaction between two people sitting in two different parts of the world will not have any interme-

The valuation of one bitcoin is staggering. One bitcoin's INR value currently stands at Rs 46.83 lakh or

However, the bigger challenge is that coding of "cryptocurrency" is believed to be watertight. There are elaborately programmed vaults (digital) and the tracking can be infinitely more difficult when compared to paper tenders like INR, USD or GBP.

ev or been involved in graft in any form, once you start investigation, you are able to reach that," he said. He, in fact, played down the prospect of cryptocurrency gain-



US, NATO Pull-Out Of Afghanistan Raises "Tremendous Concerns" For India: Experts

WASHINGTON: After the withdrawal of the US and NATO troops from Afghanistan by September 11, India will have tremendous concern on the resurgence of the Taliban and Afghanistan being used as a safe haven for terrorists, according to experts in Washington.

US President Joe Biden on Wednesday announced that all American troops would be withdrawn from Afghanistan by September 11 this year to end the country's longest war. Following suit, the North Atlantic Treaty Organisation (NATO) said it will also pull out its troops from Afghanistan.

President Biden said his administration will ask other countries in the region to do more to support Afghanistan, especially Pakistan, as well as Russia, China, India, and Turkey. "They all have a significant stake in the stable future for Afghanistan," Joe Biden said.

"We will not conduct a hasty rush to the exit. We'll do it responsibly, deliberately, and safely. And we will do it in full coordination with our allies and partners, who now have more forces in Afghanistan than we do," he said.

But, US experts said regional countries, especially India will view the complete withdrawal of American troops from Afghanistan with tremendous concern and the role of the Taliban terrorists after the pull out of the Western forces from the war-torn country.

India has voiced grave concern over the volatile situation in Afghanistan. "Violence and bloodshed are daily realities and the conflict itself has shown little sign of abatement, whatever may be the promises," External Affairs Minister S Jaishankar said at the Ministerial Conference of Heart of Asia - Istanbul Process on Afghanistan in Dushanbe on March 30.

"For a durable peace in Afghanistan, what we need is a genuine double peace', that is, peace within Afghanistan and peace around Afghanistan. It requires harmonising the interests of all, both within and around that country," he said at the conference hosted by Tajikistan.

Over 1,700 Test COVID-19 **Positive At Haridwar Kumbh Over 5 Days: Official**

HARIDWAR: A total of 1,701 people have tested positive for CO-VID-19 in the Haridwar Kumbh Mela area from April 10 to 14 confirming fears that one of the world's largest religious gatherings may contribute further to the rapid rise in coronavirus cases.

The numbers include both RT-PCR and Rapid Antigen Test reports of devotees and seers of different akharas (ascetic groups) over the five-day period in the entire Mela Kshetra extending from Haridwar to Devprayag, Haridwar Chief Medical Officer Shambhu Kumar Jha said today.

More RT-PCR test reports are awaited and the trend shows that the number of infected persons in the Kumbh Mela Kshetra is likely to climb to 2,000, he said.

The Kumbh Mela area is spread over 670 hectares covering parts of Haridwar, Tehri and Dehradun districts, including Rishikesh.

A majority of the 48.51 lakh people who took part in the last two royal baths (Shahi Snan) held on the occasion of Somwati Amavasya on April 12 and Mesh Sankranti on April 14 were seen openly violating COVID norms like wearing of face masks and

social distancing. Despite their best efforts, the police could not impose the standard operating procedures (SOPs) on the seers of akharas and the ash-smeared ascetics thronging Har Ki Pairi ghat on the two major bathing days due to severe time

As the 13 akharas had to take their holy dip at Har ki Pairi in accordance with their allotted time slots before sunset, the police and paramilitary personnel were hard-pressed to ensure each of them vacated the ghat before the arrival of the next akhara in line to prevent chaos

As seers were averse to undergoing RT-PCR tests till the Mesh Sankranti Shahi Snan of April 14, both testing and inoculation in the Kumbh Kshetra including the areas allocated to the akharas are likely to be stepped up in the coming days, Mr Jha said.

Arvind Kejriwal Announces Weekend Curfew In Delhi

NEW DELHI: Delhi Chief Minister Arvind Kejriwal on Thursday announced sweeping restrictions, including a weekend curfew and the closure of malls, gymnasiums, spas and auditoriums, in a bid to break the chain of the COVID-19 infection in the national capital.

He also said there is no shortage of hospital beds in Delhi and over 5,000 are still available for COVID patients.

There will be no in-house dining in restaurants and cinema halls will be allowed to operate with only 30 per cent capacity, the chief minister said at an online press conference a day after the city recorded the biggest single-day jump of 17,282 COVID-19 cases.

Kejriwal said the essential services and weddings will not be affected by the weekend curfew and passes will be provided to those attending weddings.

Those going to hospitals, railway stations and airports will also be issued curfew passes, he added. Kejriwal said the reason behind the weekend curfew was that on these days, people often indulged in recreation and other such activities that could be "curtailed" and "curbed" without much inconvenience to them.

"Therefore, the weekend curfew is being imposed to break the chain (of COVID-19) and prevent contact among people.

"But we will not allow any inconvenience to those involved in essential services like going to hospitals, railway stations or airports and also weddings. We will issue passes for their movement quickly and without harassment," he said.

The government has already imposed a night curfew in the city from 10 pm to 5 am till April 30 in a bid to check the spread of the coronavirus.

Kejriwal also said there is no shortage of hospital beds in Delhi and over 5,000 are still available for COVID patients.

Efforts to increase the number of beds on a large scale will be made, he said and appealed to people not to "insist" on beds in particular hospitals.

Restaurants will be allowed to do home delivery, Kejriwal announced, adding that only one weekly market in a zone will be allowed to open per day and steps will be taken to control the crowds in those.

The government scaled down the occupancy of restaurants and cinema halls to 50 per cent of their seating capacity last week in view of the rising number of COVID-19 cases. Kejriwal said the number of cases is rising every day in Delhi and the restrictions were needed to check the spread of the virus.

Google Pledges Funds For 250K Vaccinations Towards Vaccine Delivery In Low, Middle Income Countries

WASHINGTON: Google on Thursday pledged funds for 250,000 COVID-19 vaccinations and technical assistance towards vaccine delivery in low- and middle-income countries amidst a surge in infections across the world.

The internet search giant also announced that it is helping to fund pop-up vaccine sites in the US and committing an additional USD 250 million in Ad Grants to connect people to accurate vaccine information.

"We're also announcing that Google Cloud is launching a virtual agent where people without internet access can schedule vaccine appointments and ask questions about eligibility and availability over the phone – in up to 28 languages and dialects," it said.

The announcement came as Google's Chief Health Officer Dr Karen DeSalvo ioined an event co-hosted by Gavi - the vaccine alliance - and the US Secretary of State Antony Blinken to kick off a campaign to fund vaccines for low and middle income countries.

In a blog post, Google said more people have access to the COVID-19 vaccine, it is making it easier to learn why, when and where one can get immunised.

'Today, you can now find vaccination locations on Google Maps and Search in the US, Canada, France, Chile, India and Singapore," it said.

Acknowledging that overcoming the pandemic will require a coordinated effort on a global scale, Google said that to do its part it is providing 250,000 COVID-19 vaccines to countries in need, helping fund pop-up vaccine sites in the US, and committing an additional USD 250 million in Ad Grants to connect people to accurate vaccine information.

The announcement came as Gavi, The Vaccine Alliance, launched a drive for addi-



tional funding to secure vaccines for people in low and middle-income countries.

Google.org is funding 250,000 vaccinations and providing Gavi with pro bono technical assistance to accelerate global distribution.

"We're also kicking off an employee giving campaign, and both the Gavi Matching Fund and Google.org will match each donation to triple the impact," it said. Since the beginning of the pandemic,

hundreds of Google employees have

helped organisations connect people with up-to-date information - particularly in communities that are not typically reached by mainstream public service announcements.

"For example, we're working with UnidosUS on a bilingual vaccination campaign that to date has reached more than two million people in hard-hit communities in Miami, Chicago, Houston, NYC and LA. We've conducted research with the World Health Organisation on what information improves vaccine confidence, and governments worldwide are using these insights to inform their public service announcements," Google said.

To expand this work, Google said that it is committing an additional USD 250 million in Ad Grants to governments, community and public health organisations, including the WHO, that will fund more than 2.5 billion vaccine-related PSAs. This brings Google's total commitment for COVID-related public service announcements to more than USD 800 million. "As we've learned throughout the pan-

demic, no one is safe from COVID-19 until everyone is safe. Getting vaccines to evervone around the world is a challenging, but necessary, undertaking. We'll keep doing our part and working together until we get there," Google said.

The World Health Organisation has warned that the world needs a "reality check" on the state of the pandemic, as countries abandon restrictions despite four weeks of rising deaths and seven weeks of rising cases globally.

Over 4.4 million COVID-19 infections have been recorded across the world last week. New deaths have increased by 11 per cent, the WHO said.

There have been 138,284,275 confirmed COVID-19 cases globally and the death toll stands at 2,973,179, according to Johns Hopkins University.
