Here's why both underweight, overweight women are at higher risk of miscarriages

new study led by a team of researchers at the University of Southampton has shown that underweight and overweight women are at a significantly higher risk of experiencing recurrent miscarriages compared to those of average weight. The systematic review and meta-analysis study is published in the journal Scientific Reports. The research team assessed the link between women's lifestyle and risk of recurrent pregnancy loss defined as women having two or more consecutive early miscarriages.

Miscarriage is the most common complication of early pregnancy, affecting 15 -- 20 per cent of all pregnancies. Recurrent pregnancy loss is a complex disease and although often attributed to numerous medical factors and lifestyle influences, the cause

3 LET MEN AMONG KILLED IN JK

SRINAGAR - Seven persons, including six militants - three of them from the Lashkar-e-Taiba -were killed in separate incidents of violence in Jammu and Kashmir since Monday evening.

Unidentified gunmen sprayed bullets on a released militant of Jammu and Kashmir Liberation Front (JKLF) Abdul Ahad Chak at Tangmarg Bazar, 45 kms from here in Baramulla district today. Chak, a resident of Qazpora and now working as a contractor, was shifted to hospital where he was declared dead.

Three militants of the LeT outfit identified as. Abu Abdullah Umar alias Delta-2, Abu Katlal alias Ronico-2 and Abu Jabran alias Juliet-1 were killed in an encounter with security forces and police at Naliyan-Shiudhara top in Poonch sector last evening.

Three AK rifles, 9 magazines. 78 rounds. 3 hand grenades, a wireless set, a recovered from the slain militants.

Another militant, yet to be identified, was shot dead by security forces in a gunfight at Hari Wala in Gool area of Duahmpur, reports said.

Two Hizb-ul-Mujahideen militants identified as Waqqas Ahmad of Pakistan and Javaid Ahmad Peer of Kandi area of Kupwara were killed in a gunbattle with security forces at village Dardpora Khas in Kupwara distric.

A defence spokesman said that Javaid Ahmad Peer was a divisional commander of the Hizb-ul-Mujahideen and was long wanted by the security forces.

Covid Survivors May Need Just One Shot Of 2-Dose **Vaccines, Say Studies**

he Covid-19 situation across the country is taking on a grim turn. We are on way to witness three lakh cases a day. This is taking a toll on the healthcare infrastructure which is on the verge of breaking down. It is difficult for infected people to find a bed in the hospitals.in Jammu and Kashmir too we are already past the peak of the infections recorded last year.

It is therefore time that the government pays more attention to vaccination with Srinagar which has been consistently recording the maximum number of cases being prioritised in the effort. The need is to set up more vaccination centres in the city to make it easier for people to receive jabs. It is also important to highlight the safety of vaccination through advertisements placed in newspapers and other media to address the vaccine hesitancy among a section of people.

Government has to also strictly implement the Standard Operating Procedure in public, which is something that is not being done. The wearing of mask has to be made mandatory and those violating the SOP in public should be taken to task. What the administration can do and which is eminently possible is to create more awareness about social distancing norms and take action against the people and the businessmen who violate it. It is time people are made responsible for their own health. We have to ensure that both life and livelihood are saved.

And to this end, the government will have to run an aggressive awareness campaign about the disease. Government should also enlist the youth for the purpose. This will go a long way to make a redeeming difference to the attitude of the people towards the contagion and in turn arresting its spread. Government should resist the temptation to go for yet another lockdown. Considering its disastrous fallout on the economy, lockdown is a bad word. It is not possible for people to remain in a perpetual state of paralysis. This has already wrought havoc with the economy. More so, in Valley which has been under lockdown for the past twelve months. This has led to a loss of employment for thousands of people. The vital sectors of our economy like tourism. horticulture. handicrafts have been hit hard. So, resorting to lockdown is not an option

"I have received hundreds of such slaps from my teacher, but thanks to all of them for bringing me on the right path and helped me to achieve my goal"

My revolutionary greetings to people like these who came out to support and justify the beating of a student by a teacher at a private tuition centre. Perhaps such beatings did help them to achieve their goal which perhaps was about increasing the threshold of their tolerance to pain. Very divine!

In the last few days, we all came across this video that went viral on social media. While my sympathies and support to those who cared to raise their voice against the incident, I am equally appalled by the reaction of those who chose to defend the act of beating, taking a very patronising stand. Some chose to justify the act of beating by the teacher on social media, while some chose to publish articles in support of such heinous acts. In one such mention, it appears that the student enters the class without the teachers' permission and some have taken offence, alleging that it goes against our moral values. One wonders, how?

One is free to access knowledge and it is entirely the students' responsibility to follow through by will. You can neither teach nor correct students through fear, for fear is the instrument of tyranny. not education. No one has the right to reprimand any student on such issues, let alone beating them blue. It is ingenious to see how people had reservations with the students raising their voice against such incidents and they compared it with their times when they would submit to such beatings! Now do we have to glorify pain and slaps and insults as the trade-offs for getting a decent education? This is morally flawed, pedagogically erroneous and psychologically shattering to say the least

While the mere act of publishing such an article is worthy of collective condemnation, but to see the kind of support it received to the contrary, points to the urgency of a collective rethinking.

Let us go back to basics and ask ourselves not only why the beating is problematic but also why is justifying the act also equally problematic. Firstly, no teacher is entitled to the concession on account of beating the students which in other cases would be intolerable to us, had it not been for a teacher. Secondly, if your teaching requires the support of beating, then your teaching is empty and lacks convictionin other words you do not deserve to be called a teacher. Thirdly, irrespective of what mistake the student commits, if you being the teacher are comfortable raising your hand on the student, then it is you and not the student who should be removed from the respective position because instead of creating a safe atmosphere for learning, you are being a threat to the students' safety and well-being both physical and emotional. In other words, in spaces of learning there should not be any room for any kind of abuse. In a region where conflict already takes a toll on our general well-being, and the pandemic has added to the woes of students, the teachers ought to act more sensitively and responsibly instead of contributing to the trauma-cycle. Now, let us come to the more difficult part and see why defending such acts is equally problematic. If one reads the kind of arguments given in support of the teacher, one can infer that the people defending the teacher have not quite sensed what the issue

is. It does not matter what character certificate you produce to testify the greatness of the teacher if that greatness is only for a few to witness and benefit from while others are harassed on account of that greatness. It is therefore important to ask what is the role of educational spaces like schools and tuition centres and also the role of the teachers in such spaces. I am bringing this in, because many arguments ran to justify the act in the name of corrective measure and to inculcate morals in the student community. While such a line of thinking is patronising to say the least, what is even more problematic is that there is an added nuance which many people choose to ignore, which is this: there is a fine line of difference between moral education and moral policing. While we can still be comfortable with the teachers addedly working as moral educators, they cannot use this position as a license to moral police the students. If one is to extend the logic of such arguments that justify the beating, then you will also have to contend with the kinds of acts carried out in some reputed educational institutions in the valley in the name of moral policing. This would much to your delight include hairstyle-discipling that could also involve pulling and tugging at the students' plaits and ponies and sideburns; denying the students the right to dress smartly, especially girls, because well, that could attract boys and they do that on purpose to attract boys, as if girls don't dress for themselves and to their liking. Then you also must extend your zeal to justify the moral policing carried out arguably in some oldest missionary schools running in the valley which have embraced slut-shaming as their mode of policing the students. Add to the list the corrective measures which include making students lick the floor as punishment or calling them names and rebuking them by demeaning their families, backgrounds, commenting on their length of tunics. invading their private space- all in the name of inculcating morals! The student in question could also be your own child, I wonder even then are we going to be comfortable with this kind of abuse. While many educationists have been demanding for counselling centres to be opened in educational institutions to care for the students' emotional health, it is nothing less than ironical that the teachers are the ones to trigger the cycle of trauma for the students. We must understand that a teacher is no God, they can be wrong as well and there is no point eulogising any teacher when

learning is a two-way process. I cannot see any wisdom in the supposed precept which calls the slap by a teacher as a blessing! If anything, it is demeaning to the students' self-esteem and we must do away with the feudal norms which place the providers of knowledge as infallible and on a moral high ground. Yes, basic respect is the deal, but it has to be mutual and this is no trading point for inviting physical assault. If people condemning this incident are being called "irresponsible" and "illiterate", one wonders how is beating up the student being responsible in any sense of the term and is not such a vocabulary of insults in itself very elitist in that it looks down upon those who have differing opinions, only furthering the perception that knowledge and learning is your area of entitlement and some hegemonic asset.

Now then, having made these points, one final remark regarding the beating. It is overwhelming to see a section of people coming forward to condemn such acts. However, there is one important question that I leave you with: does only physical violence warrant our collective condemnation? Should we not also extend it to the mental abuse and harassment that the students face and are made to put up with in schools, tuition centres or colleges?

Covid-19: India at War

ovid-19 has come home to India's urban centres, to middle class homes, to the elite, to the working class, in ways that diminish what happened last year when the pandemic first struck. There's a waiting list everywhere and for everything for tests, admission to hospitals, even at crematoriums and graveyards (with on-ground reports suggesting a disjunction between official fatality figures and these). And there is a shortage of everything – oxygen, ICU beds, and remdesivir. And everywhere and for everything, getting care has become dependent on who you know, as public health systems collapse, automatically excluding the majority.

It did not have to be this way. The government may have made an error of judgment in not anticipating the intensity of the second wave, though there were adequate warnings. But, the current situation does highlight a clear policy failure on varied counts — from not using the past year to boost India's health infrastructure enough to deal with current numbers to slipping into business-as-usual mode when it came to events (including large elections), from a painfully slow rollout of the vaccination (only absolute numbers as a proportion of the population, not relative to the rest of the world, matter here) to the delay in imposing curbs. What's important now is to fix the crisis, and be prepared in case there is another wave after this one (remember the United State's third wave was its worst, although it came before the vaccine drive began). This requires the State to pump all its resources into beat the second wave. It is war, and nothing short of a war effort is needed.

knowledge dissemination, then the invisible pockets and forms of violence too will have to be pointed as well. Because at the end, students require spaces where they can feel welcomed, loved, safe and secure — emotionally, mentally and physically. This is the foundational stone for any kind of learning, anywhere in the world. And given the tests of the time, it is evermore contingent upon the teachers to provide their students with such harbours of safety and security, where their private space is respected and they can with respect wade or sail through the ocean of learning.

On a concluding note, next time when we wish to evaluate the role of a teacher, let these lines by Tagore be the qualifier for our pedagogy and learning:

'Where the mind is without fear and the head is held high; Where knowledge is free".

Are COVID-19 vaccines safe?

While most respond well, some people can have side effects such as lowgrade fever, fatigue, tiredness, swelling, pain and redness at the injection site. Sometimes one can have a fever which can last for a few days but in the end, it is better than getting Covid and dying in the hospital he increasing number of COVID cases and a barrage of information available across the various channels on COVID-19 vaccines can alarm anyone. It has raised plenty of questions.

Should we take COVID vaccination? Which COVID vaccine should one opt for? Are COVID-19 vaccines 100% safe? What are the side effects of COVID vaccines? What precautions should one take? Is it possible to get COVID even after vaccination? Here are answers to all your questions. Should you take the vaccine?

Taking a vaccination is the first step towards protecting yourself. While certain side effects are there depending on individual cases, this shouldn't dissuade people from taking the vaccine in the first place, as per the doctors.

Covishield or Covaxin - Which vaccine to take?

Currently in India, the Covishield vaccine and the Covaxin vaccine are the two available for commercial use. Explaining in detail about the vaccination, Dr Sameer Gupta, Director, Cardiac Cath Lab, Metro Group of Hospital, MD, Aurum Senior and Assisted Living said, "The Covishield is a DNA vaccine which codes for the spike protein whereas the Covaxin produces antibodies against many regions of the complete virus. This is a fully inactivated virus. Both the vaccines do an effective job of preventing severe infection, hospitalization and we should be ready to take whichever one is available to us when the time comes."

Are COVID vaccines safe?

Vaccines have helped in the eradication of multiple diseases for years but are COVID vaccines safe? "Now once you get the vaccine are you 100% safe, the answer is no. But the risk of transmission presumably goes down and secondarily the risk of you getting complications goes down drastically to 85% to 90%," Dr Shriram Nene, Healthcare Innovator and Cardiovascular Surgeon told us.

What Are The Side Effects?

In most cases, people have adjusted well to the vaccination. However, depending on your body some can have an after effect. "While most respond well, some people can have side effects such as low-grade fever, fatigue, tiredness, swelling, pain and redness at the injection site. Sometimes one can have a fever which can last for a few days but in the end, it is better than getting Covid and dying in the hospital," explains Dr Gupta.

Things to keep in mind when getting vaccinated

First and foremost, if you have an immune-compromised condition, make sure to inform the doctor. Also, individuals with comorbidities (a person who has multiple underlying health-related conditions present at once) are at more risk of getting infected and should prioritise receiving the vaccine. "I often get asked if it is safe to get the vaccine if a person has comorbidities (such as diabetes, high blood pressure). For such individuals, the potential benefits offered by the vaccine far outweigh the minuscule risks that have been reported after millions of doses all over the world. Those on blood thinners need to consult their physicians and would be advised to apply pressure on

the site of the vaccine for 3-5 minutes after receiving the vaccine," says Dr. Lancelot Pinto, Consultant Pulmonologist, P.D Hinduja Hospital & MRC.

Things to follow during first and second vaccine shots

It is important to understand the core requirement of the vaccination. The goal of vaccination is to prevent severe hospitalisation and deaths. Elaborating on the vaccination, requirements, interval shots and more Dr Gupta points out, "For the vaccine to be effective, we need adequate antibodies which will be achieved after both the doses and typically after 2-3 weeks of the second dose. The duration between the first and second doses of the vaccination of Covishield is intended to be four weeks. However, new data has come out that shows better immunogenicity if there is a 6 to 8-week interval between the two doses. This is also being recommended by the government. With Covaxin, the dosing interval is still four weeks. It is important not to mix and match your vaccine and stick with it as recommended by the government and health authorities.

What are the chances of getting Covid post vaccination?

You think COVID can't touch you after vaccination? Wrong. "There are chances of getting COVID post both the first and second doses. However, across the world, and for all vaccines that have been used, the chances of getting severe COVID or dying from COVID after vaccination seem to have significantly reduced. One must not assume that being vaccinated equates to letting one's guard down. One must continue taking all the precautions as before," says Dr Pinto.

Precautions post vaccine

- Take rest and don't exert yourself
- Do not engage in strenuous physical activity for a couple of days
- Keep yourself hydrated
- In case you feel feverish, take paracetamol or crocin
- Sleep well to prevent exacerbating the potential adverse effects such as body aches, fever and soreness
- Don't stop your regular medications (hypertension, diabetes and more) until advised by the doctor
- Wear masks everywhere you go
- Wash and sanitise your hands regularly

Top Ten COVID-19 Anxiety Reduction Strategies

During this time of national crisis, we must manage two things simultaneously: 1) Protect ourselves from the Coronavirus, and 2) Protect ourselves from anxiety. If your anxiety, fear, and worry has been overwhelming, put these ten strategies into practice.

Media Distancing: To stop the spread of COVID-19, we've had to practice social distancing. But to stop the spread of anxiety, we must distance ourselves from the media. All anxiety stems from uncertainty and an active imagination which produces catastrophic thoughts. The media, which is 24/7 Coronavirus and virtually all negative, is the driver of those thoughts. My patients who are the most anxious about the Coronavirus are those who are consuming the most news from social media, online, and traditional outlets. The more anxious you feel, the more you should distance from the media. And if you are extremely fearful, stop altogether. Do no Google or research. Stop checking the latest news about the virus. Any vital information you need to know, you will find out.

Do Not Engage with Worry. Take Action: Whether you are worried about contracting the virus, your struggling business, or being unemployed, the more your mind focuses on worst-case scenarios, the more anxious you feel. You can't stop thoughts from entering your mind, but you can choose to stop dwelling and you can choose to take action to solve problems. There is a huge difference between worrying and problem solving. When your mind tries to bait you into worry, don't take the bait. If you do, like a fish in a lake, you will



be caught. Anxiety will try to bait you with many "what if" questions. Don't answer them.

Focus on Present Odds: All deaths are tragic and the coronavirus can be deadly but maintaining proper perspective can reduce your anxiety. No doubt the symptoms of COVID-19 can be horrible but the vast majority of people infected with COVID-19 have mild to moderate symptoms or no symptoms at all. The Infection Fatality Rate (IFR) is the total number of deaths divided by the total number of people that carry the infection, regardless of them having clinical symptoms or not. Do Not React to Physical SympMy patients who are the most anxious about the Coronavirus are those who are consuming the most news from social media, online, and traditional outlets. The more anxious you feel, the more you should distance from the media. And if you are extremely fearful, stop altogether. Do no Google or research. toms: If you cough, it does not mean you have the COVID-19. The same is true for others who cough. Allergies, bronchitis, post-nasal drip, and the cold are more common and a more likely explanation. Accept uncertainty as you do in other areas of life and assume what is most likely. Do not scan your body looking for symptoms. This behavior reinforces your worries and will increase anxiety.

Focus on Being Productive and New Ways of Enjoying Life: Although we have no control over the national crisis, we must focus on where we do have control – our response to the crisis. This is an opportunity to try something new and do things we haven't had time for. Organize a messy room, paint a fence, clean the garage, edit the photos on your phone, clean a rusty bike and take it for a ride, and play a board game — remember those? You can also learn a new skill or start a new hobby from videos on You Tube or various apps and websites.

Engage in Stress Reduction Activities: Focusing on what you are grateful for, exercising your body, and relaxing your mind will help give you the peace you desire. Guided meditation, yoga, exercise, and a gratitude journal are all practices that lower stress. Select one or two, learn about them so you do them correctly, and practice each day. If you and your loved ones are not severely sick or experiencing dire financial hardship, be grateful. Once this crisis has passed, perhaps we will all appreciate what we take for granted: a healthy society, freedom to gather, dinner with friends, a night at the movies, and a simple haircut.

Unhealthy lifestyle only explains a small part of socioeconomic health inequity

recent study on UK and US adults states that unhealthy lifestyles alone only explain a small proportion of the socioeconomic inequity in health.

This is the suggestion of a large study published in the BMJ.

The findings show that the poorest individuals with the least healthy lifestyle are 2.7 to 3.5 times more at risk of death than the most affluent people with the healthiest lifestyle.

While healthy lifestyles play an important role in reducing disease burden, the researchers warn that healthy lifestyle promotion alone "might not substantially reduce the socioeconomic inequity in health, and other measures tackling social determinants of health are warranted."

It is well known that disadvantaged socioeconomic status (the measure of a person's social and economic standing) and unhealthy lifestyles are linked to poor health.

Lifestyle factors are commonly viewed as mediators between socioeconomic status and health, but it's not clear to what extent healthy lifestyles might alleviate the socioeconomic inequities in health.

To explore this further, an international research team used data from the US National Health and Nutrition Examination Survey (US NHANES) and UK Biobank to evaluate the complex relations of lifestyles and socioeconomic status with death and heart disease.

Their findings are based on 44,462 US adults aged 20 years or older and 399,537 UK adults aged 37-73 years.



Socioeconomic status was defined using family income, occupation or employment status, and education level in both groups, and health insurance in US participants. A healthy lifestyle score was derived using the information on smoking, alcohol consumption, physical activity and diet.

Medical records were then used to track deaths from any cause ("all-cause mortal-

ity") among both US and UK adults, as well as cases of cardiovascular disease (CVD) and CVD deaths in UK adults.

Over an average follow-up of 9-11 years, US NHANES documented 8,906 deaths and UK Biobank documented 22,309 deaths and 6.903 CVD cases.

Among adults of low socioeconomic status, the age-adjusted risk of death was

22.5 and 7.4 per 1000 person-years in US NHANES and UK Biobank, respectively, and the age-adjusted risk of CVD was 2.5 per 1000 person-years in UK Biobank.

The corresponding risks among adults of high socioeconomic status were 11.4, 3.3, and 1.4 per 1000 person-years.

Compared with adults of high socioeconomic status, those of low socioeconomic status had consistently higher risks of mortality and CVD, and lifestyle factors only explained 3 per cent to 12 per cent of the excess risks. The highest risks of mortality and CVD were seen in adults of low socioeconomic status and with the least healthy lifestyles.

For example, compared with adults of high socioeconomic status and three or four healthy lifestyle factors, those with low socioeconomic status and no or one healthy lifestyle factor had 2.09-fold to 3.53-fold higher risks of mortality and CVD.

This is an observational study, so can't establish cause, and information on the socioeconomic level and lifestyle was selfreported, so may not have been completely accurate. Nevertheless, strengths included the large sample size from two well established nationwide databases, and results were similar after further analyses, suggesting they are robust.

Unhealthy lifestyles mediated a small proportion of the socioeconomic inequity in health in both US and UK adults; therefore, healthy lifestyle promotion, although essential, alone might not substantially reduce the socioeconomic inequity in health, and other measures tackling social determinants of health are warranted, say the researchers.

They call for government policies "to tackle upstream social and environmental determinants of health" but also point out that healthy lifestyles were associated with lower mortality and CVD risk in different socioeconomic groups, "supporting an important role of healthy lifestyles in reducing disease burden."

Study suggests older adults more likely to help others than younger ones

he findings of a new research from the University of Birmingham suggest that older adults are more willing to make an effort to help others in comparison to younger adults.

The findings of the study were published in the journal 'Psychological Science'.

The study, led by researchers in the University's School of Psychology, is the first to show how effortful 'prosocial' behaviour, intended to benefit others, changes as people get older. In particular, it focused on people's willingness to exert physical effort, rather than to give money or time, since attitudes to both these are known to change with age.

In the study, the research team tested a group of 95 adults aged between 18-36 and a group of 92 adults aged 55-85. Each participant made 150 choices about whether or not to grip a handheld dynamometer, a device for measuring grip strength or force, with 6 different levels of how hard they had to grip.

Before the experiment, the researchers measured each person's maximum grip strength, so they could make sure that the effort people had to put in was the same for everyone, and not affected by how strong people were.

For each decision, participants were told whether they would be working to gain money for themselves, or for another person. First, they were asked to decide whether they would be willing to put in the effort to gain money or not. If they accepted the offer, they had to grip hard enough to get the money.

The results showed that when the task was easy, young and older adults

were equally willing to work for others, but, when the task was more effortful older adults were more willing to work to help others. In contrast, younger adults were more selfish and were much more likely to put in higher levels of effort to benefit themselves.

The team also noticed a correlation between the willingness to put effort into tasks that benefited other people and positive feelings towards other people. But it was only in younger people that this 'warm glow' feeling also related to them completing tasks for themselves.

Senior author, Dr Matthew Apps, explained, "Past research had suggested that older adults were more prosocial than young adults because they donate more money to charity. But, the amount of money or time people have available changes a lot as we get older, as such older adults might just appear more prosocial. We wanted to focus simply on people's willingness to exert effort on behalf of someone else, as this shouldn't depend on your wealth or the time you have available. Our results showed very clearly that participants in our older age group were more likely to work harder for others, even though they would gain no significant financial reward for themselves.

Lead author Patricia Lockwood added, "A lot of research has focused on the negative changes that happen as people get older. We show that there are positive benefits to getting older too, in particular, older adults seem to be more willing to put in the effort to help others. These 'prosocial behaviours' are really important for social cohesion. Understanding how prosocial behaviour changes as people get older is critical as we predict the impact of an ageing society."

Study claims good dental health may help prevent heart infection from mouth bacteria

ccording to a new study, maintenance of good oral health is more important than the use of antibiotics in dental procedures for some heart patients to prevent a heart infection caused by bacteria around the teeth.

The new American Heart Association (AHA) scientific statement was published in the association's flagship journal, Circulation.

Infective endocarditis (IE), also called bacterial endocarditis, is a heart infection caused by bacteria that enter the bloodstream and settle in the heart lining, a heart valve or a blood vessel. It is uncommon, but people with heart valve disease or previous valve surgery, congenital heart disease or recurrent infective endocarditis have a greater risk of complications if they develop IE.

Intravenous drug use also increases the risk for IE. Viridans group streptococcal infective endocarditis (VGS IE) is caused by bacteria that collect in plaque on the tooth surface and cause inflammation and swelling of the gums. There's been concern that certain dental procedures may increase the risk of developing VGS IE in vulnerable patients.

The new guidance affirms previous recommendations that only four categories of heart patients should be prescribed antibiotics prior to certain dental procedures to prevent VGS IE due to their higher risk for complications from the infection:

1. those with prosthetic heart valves or prosthetic material used for valve repair;

2. those who have had a previous case of infective endocarditis;



3. adults and children with congenital heart disease; or

4. people who have undergone a heart transplant.

"Scientific data since the 2007 AHA guidelines support the view that limited use of preventive antibiotics for dental procedures hasn't increased cases of endocarditis and is an important step at combating antibiotic overuse in the population," said Walter R. Wilson, M.D., chair of the statement writing group and a consultant for the Division of Infectious Diseases, Department of Internal Medicine at Mayo Clinic in Rochester, Minn.

It has been over a decade since recommendations for preventing infective endocarditis were updated amid concerns of antibiotic resistance due to overprescribing. The American Heart Association's 2007 guidelines, which presented the biggest shift in recommendations from the Association on the prevention of infective endocarditis in more than 50 years, more tightly defined which patients

should receive preventive antibiotics before certain dental procedures to the four high-risk categories. This change resulted in about 90% fewer patients requiring antibiotics.

The scientific statement writing group reviewed data on VGS IE since the 2007 guidelines to determine if the guidelines had been accepted and followed, whether cases of and mortality due to VGS IE have increased or decreased, and if the guidance might need to be adjusted.

The writing committee reports their extensive review of related research found:

1. There was a good general awareness of the changes in the 2007 guidelines, however, adherence to the guidelines was variable. There was about a 20% overall reduction in prescribing preventive antibiotics among high-risk patients, a 64% decrease among moderate-risk patients, and a 52% decrease in those patients at low- or unknown-risk.

2. In a survey of 5,500 den-

tists in the U.S., 70% reported prescribing preventive antibiotics to patients even though the guidelines no longer recommend it, and this was most often for patients with mitral valve prolapse and five other cardiac conditions. The dentists reported that about 60% of the time the antibiotic regimen was recommended by the patient's physician, and 1/3 of the time was according to patient preference.

3. Since the stricter 2007 antibiotic guidelines, there is no convincing evidence of an increase in cases of VGS IE or increased mortality due to VGS IE.

4. The writing group supports the 2007 recommendation that only the highest risk groups of patients receive antibiotics prior to certain dental procedures to help prevent VGS IE.

5. In the presence of poor oral hygiene and gingival disease, VGS IE is far more likely to develop from bacteria attributable to routine daily activities such as toothbrushing than from a dental procedure.

6. Maintenance of good oral hygiene and regular access to dental care is considered as important in preventing VGS IE as taking antibiotics before certain dental procedures.

7. It is important to connect patients with services to facilitate access to dental care and assistance with insurance for dental coverage, especially in those patients at high risk for VGS IE.

8. It is still appropriate to follow the recommendation to use preventive antibiotics with high-risk patients undergoing dental procedures that involve manipulation of the gum tissue or infected areas of the teeth, or perforation of the membrane lining the mouth.

SC Stays Proceedings Before Delhi HC In Amazon Future Case "random", "inequitable and unfair". by Singapore International Arbitra-

NEW DELHI: The Supreme Court Monday stayed the ongoing proceedings before the Delhi High Court in the case related to the amalgamation of Future Retail Ltd (FRL) with Reliance Retail.

A Bench of Justices R F Nariman. B R Gavai and Hrishikesh Roy posted the matter for hearing on May 4 and directed that all pleadings be completed in the matter.

Amazon had moved the apex court on April 8 challenging the Delhi High Court's Division Bench order that had vacated a stay on Kishore Biyani-led Future Group asset sale to Reliance Industries.

J&J Seeks Permission For Phase-3 **Trial Of Its Single-Shot COVID** Vaccine In India, Import Licence

NEW DELHI: Multinational pharma giant Johnson & Johnson has applied to India's drug regulator seeking permission to conduct phase-3 clinical trial of its single-dose COVID-19 vaccine in India as well as import licence, sources said.

They said the company has sought an early meeting of the subject expert committee on COVID-19 of the Central Drugs Standard Control Organisation (CDSCO) to take a decision on

its application. This comes close to the heels of the central government last week deciding to fast-track emergency approvals for all foreign produced coronavirus jabs that have been given a similar nod by the World Health Organization or regulators in the United States, Europe, Britain or Japan. Such vaccines will be given

emergency use approval mandating the requirement of post-approval parallel bridging clinical trial in place of conduct of local clinical trial under the provisions of the New Drugs and Clinical Trials Rules 2019, the health ministry had said. According to sources, Johnson & Johnson had applied

on April 12 in the Global Clinical Trial Division through the Sugam online portal, instead of applying to the biological division which deals with vaccines and other biologicals.

"Due to the technicalities involved, Johnson & Johnson has resubmitted its application on Monday," a source said.

Johnson & Johnson's vaccine is a single-dose jab, whereas the three vaccines cleared by India so far are of doubles doses.

So far, two vaccines --Oxford/Astrazeneca vaccine COVISHIELD manufactured by Serum Institute in India and indigenously developed COVAXIN by Bharat Biotech -- are being administered in India, while a third vaccine Sputnik V -- developed in Russia and to be imported and sold in India by Dr Reddy's Laboratories -- has also been approved by the Indian drug regulator.

The government, meanwhile, on Monday decided to expand its vaccination drive by allowing everyone above 18 years of age eligible to be vaccinated from May 1 and permitted state governments, private hospitals and industrial establishments to procure the doses directly from manufacturers.

Dialogue And Not By Unilateral Actions: Army Chief Amid Border Standoff With China **Press Trust of India NEW DELHI:** In a veiled reference to the border standoff with China, Army Chief Gen MM Naravane on Monday said

legacy issues and differences need to be resolved through mutual consent and dialogue, and not by unilateral actions. In his address at a symposium, Gen

MM Naravane, however, noted that there were positive developments with China along the Line of Actual Control(LAC) that led to disengagement of troops in Pangong lake areas in eastern Ladakh.

The Army Chief also said that the recent comments of Chinese Ambassador Sun Weidong "to avoid relapse and jointly safeguard peace and tranquillity in border areas" augurs well for the future of India-China relations.

Talking about regional developments, he referred to the renewed commitment by the armies of India and Pakistan to follow the 2003 ceasefire on the Line of Control(LoC), saying it bodes well for the future.

"We have recently entered into a ceasefire understanding with Pakistan Army in February this year, and since then there has been no exchange of fire on an otherwise active LoC. This bodes well for the future," he said.

"With China too, there have been positive developments along the LAC, an area where both countries have differing perceptions on the alignment of the land borders. This has led to disengagement of troops in eastern Ladakh," he added.

Gen Naravane also mentioned about the 11th round of Corps commander-level talks between the armies of India and China, and hoped to "settle other border"issues through further negotiations.

The military standoff between India and China that erupted on May 5 last at multiple friction points in eastern Ladakh has significantly strained bilateral ties. As a result of a series of military and

diplomatic talks, India and China completed withdrawal of troops and weapons from the North and South banks of Pangong lake in February.

The two sides are now engaged in talks to extend the disengagement process to the remaining friction points.

"Legacy issues and differences need to be resolved through mutual consent and dialogue and not by unilateral actions," he said.

Talking about new challenges being thrown up by the changing character of war, he said "our own region" is also witnessing that wars are no longer confined to the customary hard core kinetics but being increasingly contested in the am-

biguous grey zone. "However, even as we move to a technology empowered Army, the peculiar unsettled nature of our borders means that the requirement of 'boots on ground' cannot be simply wished away."

Gen Naravane reiterated that India looked to maintain peace and harmony with all its neighbours and in the region.

He said that health care workers were given the facility to vaccinate "but a number of them have not vaccinated themselves so far."

" I appeal all the health care workers as also above 45 years of age, whether government employees or not, to vaccinate themselves immediately," he added.

Based on ICMR data, the current variants are also being picked up by the RT-PCR tests. The RT-PCR test has sensitivity of around 80 per cent and therefore 20 per cent of the cases can still be missed out.

"Also, if the sample is not properly taken or if the test is done too early when the viral load is low, it may come out negative. So, if a person is symptomatic, a combination of clinical features, laboratory reports, CT/chest X-ray can be used for presumptive diagnosis of COVID-19 and treatment should be started accordingly. The test should also be repeated after 24 hours," AIIMS Director Dr Randeep Guleria told

Dr Samiran Panda, the Head of Epidemiology and Communicable Diseases at the Indian Council of Medical Research, said the mutants -- variants from the UK, Brazil and South Africa -- are not able to evade the diagnostic RT-PCR testing that is being conducted in India.

"In India, we have to be able to detect two or more genes of virus so if mutation happens on one area then the RT-PCR test kits will be able to capture it and it is capturing. However, some of the infections will remain undetected irrespective of the mutations happening," Dr Panda said.

On the steep rise in COVID-19 cases, Bhatnagar said that all the preparations are being made to tackle the situation.

PSG, Bayern Some Of The Big Names Missing From Super League Proposals

DUSSELDORF: The new Super League football competition in Europe is, surprisingly, missing the names of Bayern Munich and Paris Saint-Germain.

Last year's Champions League finalists were noted absentees from the elite clubs announced in the league's formation on Sunday.

Bavern would face difficulties convincing its fans and members, who have a majority say in club business. PSG's Qatari owners could be wary of disrupting next year's World Cup – which will be played in Qatar – and a lucrative UEFA broadcast deal if there's a civil war in European football.

The Super League has signed up 12 clubs from England, Spain and Italy and left open three more spots for founder members, who will get permanent places in the competition. Bayern, PSG and Borussia Dortmund have been linked with those founder places. However, Dortmund said Mon-

day that it and Bayern reject the Super League in favor of reforming the existing Champions League.

They are both on the board of the European Club Association. which held an emergency meeting Sunday after representatives of the Super League clubs quit the organization.

The clubs want to implement the planned reform of the UEFA Champions League. It was the clear

opinion of the members of the ECA board that the plans for founding a Super League are rejected," Dortmund CEO Hans-Joachim Watzke said in a statement. "Both of the German clubs which

are represented on the ECA board, FC Bayern Munich and Borussia Dortmund, put forward 100% identical views in all conversations."

Germany's rules on fan ownership, known as 50%+1 for the voting stake which members must have, pose a problem for the Super League. Fan organizations at the English clubs have risen up in revolt at the plans but have little or no say in how their clubs are run. The Super League waited until after recent elections of club presidents at Real Madrid and Barcelona to launch its plans.

German fans could in theory block their clubs from being involved. Bayern was due to have its annual general meeting last week but it was postponed to the end of the year because of the coronavi-

As COVID Cases Rise, NRAI Requests **Government To Vaccinate Athletes Soon**

NEW DELHI: The National Rifle Association of India (NRAI) has requested the government to vaccinate its Olympic-bound shooters at the earliest, taking into account the unprecedented spike in CO-VID-19 cases.

As per the data updated by the union health ministry, India reported 2,73,810 new positive cases in the last 24 hours, the highest single-day surge taking the country's caseload past the 1.5 crore mark.

As many as 1,619 people succumbed to the disease in the last 24 hours.

Considering the grim situation, the NRAI is keen that its athletes are

vaccinated soon. "The federation has been insisting on the athletes getting vaccinated as soon as possible. It has again requested the government to vaccinate its shooters," a source close to the NRAI said.

"We understand that it is a personal choice but if the government takes the lead and is able to convince the athletes, they will probably come forward and get the jabs. With cases rising at such a fast rate, there is no other way around at this time." he added. The NRAI stepped up its call for vaccination after three of its Olympic-bound shooters contracted the nighly contagious virus recently, forcing the federation to cancel the national camp for the rifle team that was to start in the national capital from Tuesday. It is instead arranging for a training-cum-competition trip abroad, including participation in the European Championships.

The NRAI had announced a 15-member Indian shooting contingent for the upcoming Tokyo Games in the first week of this month.

Keeping the threat posed by the COVID-19 in mind, two reserve shooters for each event have been picked alongside the main team. They will be trained on par with the Olympic-bound shooters and will be kept on standby for the Tokyo Games. Last month, India finished with 30 medals including 15 gold in the ISSF World Cup in Delhi.

India Witnesses 2.73 Lakh **Covid Cases In A Day**

New Delhi: India's total tally of Covid cases crossed 1.5 crore with a record single-day rise of 2,73,810 new coronavirus infections, while the active cases surpassed the 19-lakh mark, according to the Union Health Ministry data updated on Monday. The total tally of Covid cases mounted to 1,50,61,919 and the

death toll increased to 1.78.769 with a record 1,619 daily new fatalities, the data updated at 8 am showed. Registering a steady increase for the 40th day in a row, the active

cases have increased to 19,29,329 comprising 12.81 per cent of the total infections, while the national Covid recovery rate has dropped to 86 per cent.

The number of people who have recuperated from the disease surged to 1,29,53,821, while the case fatality rate has further dropped to 1.19 per cent, the data stated.

According to the ICMR, 26,78,94,549 samples have been tested up to April 18 with 13,56,133 samples being tested on Sunday. The 1,619 new fatalities include

503 from Maharashtra, 170 from

Chhattisgarh, 161 from Delhi, 127 from Uttar Pradesh, 110 from Gujarat, 81 from Karnataka, 68 from Punjab, 66 from Madhya Pradesh, 50 from Jharkhand, 42 each from Rajasthan and Tamil Nadu, 29 from Haryana, 28 from West Bengal and 25 from Kerala.

A total of 1,78,769 deaths have been reported so far in the country, including 60,473 from Maharashtra, 13,351 from Karnataka, 13,113 from Tamil Nadu, 12,121 from Delhi, 10,568 from West Bengal, 9,830 from Uttar Pradesh, 7,902 from Punjab and 7,410 from Andhra Pradesh. PTI

Allocation Of Remdesivir Has To Be Need-Based: **Bombay High Court**

MUMBAI: The Nagpur bench of the Bombay High Court on Monday said the distribution of Remdesivir injections has to be on the basis of need and asked the Centre and the Maharashtra government what parameters are followed while allocating the drug to different states and districts

A division bench of Justices Sunil Shukre and SM Modak said if Maharashtra was contributing to 40 per cent of the COVID-19 cases in India. then the allocation of Remdesivir injections to the state should also be in the same percentage.

Remdesivir is listed for use in serious COVID-19 patients. In view of a sudden spike in demand of the drug due to the surge in COVID-19 cases, the Centre last week banned its export till the situation improves. "If contribution towards

COVID-19 cases is 40 per cent from Maharashtra, then it is only right to say that 40 per cent of Remdesivir injections are allotted to this state. The allocation has to be need-based and not on any other factors that are not relevant," Justice Shukre said The court directed the Union and the state governments to file their affidavits by April 21, pointing out the parameters followed for the regulation and distribution of Remdesivir vials. The court was hearing a bunch of petitions on the issue of the COVID-19 pandemic, lack of facilities in hospitals and the hurdles being faced by the public. The court also pulled up the Maharashtra government for "disparity and arbitrariness" while allotting vials of Remdesivir to different districts in the state.

"There appears to be a disparity and some arbitrariness in the distribution of Remdesivir vials to Nagpur district. The vials are not being released in proportion to the requirement," the court said.

The bench further said it did not understand the logic behind allotting over 5,000 vials of Remdesivir for around 2,000 beds in Thane, but allotting only about 3,000 vials of the drug for over

8,000 COVID-19 beds in Nagpur. It noted that on April 13 and April 18, not a single vial of Remdesivir was allotted to Nagpur and on April 17, only 500 vials were allotted.

"This has severely affected the administration of health care to COVID-19 patients in Nagpur. The possibility of mortality because of lack of Remdesivir cannot be ruled out. It is the solemn duty of the state government to save and preserve each precious life," the

Second Covid Wave In Delhi Likely To Peak Within A Week: Experts

NEW DELHI: The second wave of coronavirus in Delhi is likely to peak within a week after possibly hitting a positivity rate of 50 per cent before the numbers start to go down, senior medical experts said on Monday.

Dr Jugal Kishore, the head of community medicine at Safdarjung Hospital, said, "The virus spreads from person to person in close proximity. Over the last few months, people have been meeting each other at a greater pace without following Covid-appropriate behaviour. The results are before us."

Citing the findings of a serosurvey conducted in February, he said around 50 per cent of Delhi's population has already been exposed to coronavirus, and there are "very few" cases of re-infection.

Domino's India hacked? Credit card data of 10 lakh users on 'sale' for Rs 4 crore

NEW DELHI: In what could add to latest string of cyber breaches at India-based entities, a cyber security researcher on Sunday claimed that credit card details of nearly 10-lakh people who purchased online on Domino's Pizza India is allegedly being sold for over Rs 4 crore on the Dark Web.

According to Alon Gal, CTO of security firm Hudson Rock, a threat actor has claimed to have hacked Domino's India database worth 13TB.

The threat actor is looking for around \$550,000 (approximately Rs 4 crore) for the database and saying they have plans to build a search portal to enable querying the data, Gal claimed.

"Information includes 180,000,000 order details containing names, phone numbers, emails, addresses, payment details and a whopping 1,000,000 credit cards," Gal claimed in a tweet.

"Plenty of large-scale Indian breaches



lately, this is worrying," he added. Domino's India was yet to react to Gal's tweet. Independent cyber security researcher

Rajshekhar Rajaharia told IANS that he had alerted about this possible hack to the CERT-in (India's national cyber defence agency) on March 5.

"I had alerted CERT-in about a possible Domino's Pizza India hack where the threat actor got data access with details like 200 million orders and personal data of the users too. The hacker, however, did not provide any sample," Rajaharia said.

There have been a string of hacking incidents involving Indian firms in the recent past, including Bigbasket, BuyUcoin, JusPay, Upstox and others. Gal earlier this month claimed that personal data of nearly 533 million (53.3 crore) Facebook users, including 61 lakh Indians, were leaked online after a hacker posted the details on a digital forum.

he leaked data included Facebook ID numbers, profile names, email addresses, location information, gender details, job data, and other details. Facebook said the data was old.
