J&K Logs Highest Single-Day Spike Of 2,030 Cases

8 More Deaths Push Fatality Count To 2071

SRINAGAR: Jammu and Kashmir recorded its highest single-day spike of 2,030 COVID-19 cases on Tuesday, which includes 352 travellers, taking the infection tally in the union territory past 1.50 lakh, officials said here.

They said eight more fatalities were registered in a span of 24 hours, pushing the death toll to 2,071.

Of the fresh cases, 944 are from Jammu division and 1,086 from Kashmir division, the officials said, adding that the union territory's total caseload now stands at 1,50,238.

They said Srinagar district recorded the highest number of 647 new cases, including 58 travellers, followed by 501 in Jammu district and 143 in Reasi.

World Press Freedom Index

India Ranks Low At 142

NEW DELHI: India has ranked 142nd out of 180 countries on a global press freedom index in the annual Reporters Without Borders analysis released on Tuesday.

A report by Reporters Without Borders says there has been a dramatic deterioration of press freedom since the onset of the pandemic. The report said that countries have used the pandemic to limit journalist's access to information, sources and reporting in the field.

There has been a particular increase in these incidents in Asian, Middle East and European nations. India, ranked 142 of the 180 polled nations, remains one of the most dangerous nations for journalists. Nepal is ranked at 106, Sri Lanka at 127, Pakistan at 145 and Bangladesh at 152. Overall, in 2021, just 7 per cent, of the index's 180 countries offered a favourable environment for journalism.

The tops ranking countries include Finland at 2, Sweden at 3, Denmark at 4, the Netherlands at 6, Portugal at 9, Belgium at 11, Ireland at 12 and Germany at 13.

In India, the report reads, critical journalists are labelled 'anti-state or 'anti-national' by BJP supporters. In 2020, four journalists were killed in connection with their work. Journalists in India have also been subjected to physical attacks by BJP activists, often with the complicity of the police.

Pak Returns Kashmiri Teen To Authorities

SRINAGAR: Pakistan Army on Tuesday handed over to the Indian authorities an 18-year-old youth who had inadvertently crossed the Line of Control into Pakistancontrolled Kashmir (PcK) last year.

Mohammad Sayeed Mohiuddin was handed over to the Indian authorities at Titwal crossing point in Tangdhar sector along the LoC, a defence spokesman said

"Inadvertent crossings across the Line of Control by locals on either sides of it have been an occurrence due to rugged terrain. In one such crossing...Mohammad Saveed Mohinuddin belonging to Gurez in forward areas of Bandipora crossed into forward areas of Pakistan controlled Kashmir in September last year," the spokesman said.

He said the proactive coordination by the Indian authorities has enabled repatriation of the vouth.

The spokesman said interactions with the locals of Titwal revealed that there has been a marked decrease in the inadvertent crossings over a period of time due to strict vigil along the Line of Control.

Another Wet Spell In J&K from Today

SRINAGAR: Mercury plunged by a few notches in Kashmir valley ahead of the weather department's forecast of more rains in plains and fresh snowfall on higher reaches, including the famous skiing resort of Gulmarg.

"Scattered to widespread rain/thunderstorm and snowfall over higher reaches like Gulmarg, Zojila, and on higher reaches of Leh-Manali Highway is likely during April 21-22. Thereafter, mainly dry weather is expected till ending April," Director Meteorological Department, Sonam Lotus said.

Advisory for Apple growers of Kashmir Valley

Due to incessant rains following measures are suggested to prevent the further spread of disease:

- For areas where the apple orchards are at Pink bud stage, spray any one of the following fungicides:
 - Zineb 68% + Hexaconazole 4%72WP @ 100gm/100 Litres of water. Dodine 65 WP @ 60g/100 Litres of water.
 - Dodine 40SC @ 90ml/100 Litres of water. Fluxapyroxad (250g/1)+Pyraclostrobin (250g/1) 500 SC @ 20ml/100 Litres of water.
 - Difenaconazole 25 EC @ 30ml/100 Litres of water.
- 2. For areas where the apple orchards are at Bloom/Petal fall stage, spray any one the following fungicides:
 - Flusilazole 40EC@20ml/100 litres of water.
 - Trifloxystrobin 25% + Tebuconazole 50% 75WG@40g/100 litre of water.

Important Instructions

- Spray at bloom stage be conducted if scab lesions are observed and the previous spray has been conducted more than 10 days ago.
- Low volume (Mist type) sprayer needs to be used for spraying during bloom.
- In case of heavy rains (within 12 hours of spray) the spray is to be repeated immediately.
- Stickers (Sandovit@ 50-75ml/100 litre of fungicide suspension) may be added except with Dodine, for better efficacy of fungicides.
- Ensure proper drainage to avoid water stagnation in the orchards.
- Ensure orchard sanitation by destruction of weeds/grasses. Same fungicide should not be repeated continuously in two sprays.

PAK, INDIA MUST SEIZE 'HISTORIC OPPORTUNITY': MUSHARRAF

MANILA - Pakistan and India must seize the "historic opportunity" for peace in the wake of the recent meeting 'of the two countries leaders, Pakistan President Pervez Musharraf said here today.

Addressing the Philippine Congress following his trip to New Delhi. Musharraf said that he was "encouraged by my interaction" with Indian Prime Minister Manmohan Singh and other Indian leaders.

"Both sides realise the historic opportunity created by the improvement in bilateral Relations must be seized to address the. Long standing Kashmir dispute squarely with determination, courage and

flexibility." he said. He said success in this area would "usher in a new era of durable peace, trust and confidence that would ensure a bright

future for the region. Musharraf, who is on a three-day state visit to this country remarked that East and Southeast Asia had left South Asia behind in economic growth, remarking that "our neighbourhood has remained disturbed due to the turmoil in Afghanistan and the Kashmir issue between India Pakistan.

The Pakistan President said with the improvements in Afghanistan and the warming of ties between İndia and Pakistan, the situation in the South Asian region should improve.

He expressed hope that Pakistan could use its strategic location as a crossroads between South Asia, Central Asia and West Asia to "promote economic cooperation within these regions through special arrangements and development of infrastructure. (AFP)

Pakistan Parliament To Vote On French Envoy's Expulsion After Protests



ISLAMABAD: Pakistan's government will seek a vote in parliament on Tuesday on whether to expel the French ambassador after violent anti-France protests by Islamists demanding action over cartoons depicting Prophet Mohammad, the interior minister said.

Prime Minister Imran Khan warned his nation in a televised address late on Monday that Pakistan risked paying a price that had been snatched during a if it expelled the French envoy, as half the country's exports are sold to the European Union.

Relations between Paris strained after President Emmanuel Macron paid tribute late last year to a French teacher who was beheaded by a man of Chechen origin for showing cartoons depicting the Prophet in a class on freedom of speech.

Muslims consider such drawings of their Prophet to be blas-

The Centres for Disease Control and Prevention (CDC) on Monday released travel recommendations by destination. It uses sciencebased Travel Health Notices to alert travellers to health threats around the world and advises on how to protect themselves.

Power Woes: Panzgam Residents Reel Under Darkness

PULWAMA: The residents of area in South Kashmir are reeling under darkness as the electricity transformer of the area has developed a technical snag for the third time in the last month.

Vaccine and SOP

s the coronavirus cases are surging once again in Jammu and Kashmir, the doctors are asking people to observe a civil imposed civil curfew. This is a good suggestion as the fight against Covid-19 pandemic has to be fought by the people. They can choose to exercise caution in their public behaviour, wear mask and wash hands. This alone is the least detrimental way out of the current crisis. Other option and which is the complete lockdown has proved more disastrous than the pandemic, leaving thousands unemployed. J&K has witnessed a 10-fold increase in COVID-19 infections over the last three weeks. However, it is still relatively less than the runaway surge in some other parts of the country. On Tuesday India's total tally of COVID-19 cases climbed to over 15 million with 2,59,170 new coronavirus infections. The active cases, as a result, have surpassed the 20-lakh mark. The death toll has increased to 1,80,530 with a record 1,761 new fatalities. This is a scary situation. The videos of the burning of pyres in some states have gone viral. The states like Maharashtra, Uttar Pradesh, Delhi, Chhattisgarh, and Karnataka have contributed most to the rising cases of coronavirus in the country. This has forced many countries to put India on no-travel list. The UK Prime Minister Boris Johnson has cancelled his scheduled India visit.

India has already approved the use of more foreign vaccines in the country. The single-dose multinational pharma giant Johnson & Johnson has applied to India's drug regulator seeking permission to conduct phase-3 clinical trial of its vaccine as well as import license. licence.

The union government on Monday announced that all persons above 18 years of age will be eligible to get COVID-19 vaccine doses from May 1. This will go a long to arrest the spread of the contagion as even young people will be eligible for the inoculation. But the new "double mutant" strain will be certainly a challenge to the government. It is thought to more visitors virulent than the previous strain. So, along with the vaccine it will even more important for people to exercise self restraint and observe Standard Operating Procedure. Government, on its part, needs to enforce some discipline among people who choose to go out for some work. For example, the people not wearing masks should face some penal action. The science of the second wave

ndia has now taken the global spotlight as the worst hotspot for Covid-19. The surge has triggered a key question. Is a variant of Sars-Cov-2 to blame? The question stems from the experiences of several other countries. The B.1.1.7 variant, first found in the United Kingdom, appears to trigger an entirely new wave of infections when it takes hold — this happened with England, then the rest of the island, followed by parts of Europe and the United States (US). Having gained an ability to spread more readily, B.1.1.7 has often required nothing less than a lockdown to slow it down

Now, a new variant has been spotted in India - B.1.617. Where it was found and how frequently it has been spotted are worrying indicators for what it may be able to do. It arose in Maharashtra, which began bucking the national trend of flat case trajectories almost a fortnight before infections began to rise elsewhere. The state was eventually forced into a lockdown. The variant is now popping up in other countries. where calls are growing to ban flights from India. Western scientists spotted a tell-tale trend in genome sequences submitted from India to the global GISAID repository — the variant was popping up more frequently in samples. These patterns reinforce the fear that B.1.617 may be fuelling India's wave, although there is also a strong possibility the B.1.1.7 may have also taken hold. On March 24, health ministry officials said B.1.1.7 was found in large numbers in community samples in at least one state, Punjab.

Russia-US Rapprochement?

The telephonic conversation between Biden and Putin has raised hopes of a breakthrough in strained relations between the two superpowers

he recent announcement by the White House sources that President Joe Biden has proposed that he and Russian President Vladimir Putin hold a summit in a third country in the coming months, has increased hopes of a rapprochement between the two old rivals

This personal invitation was extended during a telephonic conversation between the two leaders trying to address deep differences, including Russia's recent troop build-up near Ukraine.

Mr Biden during the call with Mr Putin stressed his commitment to Ukraine's sovereignty and territorial integrity, while expressing concern over a Russian troop build-up on Ukraine's borders.

The White House said Mr Biden also made clear that the U.S. would defend its national interests in response to Russian actions including "cyber intrusions and election interference."

The call took place as Secretary of State Antony Blinken was in Brussels to meet Ukrainian officials and North Atlantic Treaty Organisation (NATO) allies. NATO has called on Russia to end the military build-up. The Russian move has sparked concerns of a major escalation in the conflict between the two countries, which has simmered since the Kremlin invaded it in 2014.

Meanwhile, the Kremlin confirmed the two leaders discussed a possible summit, saying Mr Biden "expressed interest in normalising the state of affairs on the bilateral track."

Russian Manoeuvres

The Russian build-up along Ukraine has been impossible to be ignored by the international community. In response there were reports of two US warships reportedly heading for the Black Sea and Russia's foreign ministry warning them off "for their cum good"

As the hostile rhetoric and military moves around Ukraine have intensified, Western politicians have begun fearing an open invasion and urging Russia's Vladimir Putin to "de-escalate".

In response Russia has refused to oblige. The Russian defence ministry insisted that its moves were in response to "threatening" NATO exercises in Europe.

However, a rational analysis of the recent and past events leads one to surmise that it is all a part of the political brinkmanship, by both the Americans and the Russian establishment. And in this game Biden has blinked first, giving advantage to Putin.

The invitation for a summit con-

trasts to Biden's earlier actions and statements and his overall political ideology, which observers describe as being built on the principles of American pre-eminence.

This invitation comes just weeks

after the US president agreed with an interviewer that the Russian leader was "a killer". A comment which sparked international concern.

President Biden's new move has

President Biden's new move has started a new debate – whether it is disaster prevention or a mistaken concession - but in reality, now the risk of a major military action by Russia has certainly waned.

Russia's recent ostentatious troop movement always looked like grandstanding by a country that has given up trying to be liked by and now wants the West to fear it instead.

When Vladimir Putin sent troops and hardware into eastern Ukraine seven years ago, those were secret operations that are still denied to this day. However, this time, Russia seems more intent on sending signals rather than soldiers.

Another angle to the whole issue is the recent reinforcements in eastern Ukraine by Kiev government and the recent Russian actions are seen to avert any move to retake areas controlled by Russian-backed militants, by Kiev.

One senior Kremlin official has warned that such military action would be "the beginning of the end of Ukraine", whose government was children "playing with matches".

Moreover, Russia has another excuse to intervene in the region: some half a million people in the self-proclaimed "People's Republics" of Donetsk and Luhansk in eastern Ukraine have been issued with Russian passports since fighting broke out in 2014. And it would be plausible for Russia to come to their rescue if these 'republics' faced any threat.

Russian Message

However, one is led to infer that the real aim of troop amassing on the Ukrainian border is not the real intention. Instead the goal is somewhat different.

It seems that Russia is trying to avert the tough, new sanctions that the Biden administration is threatening in retaliation for Russia's election meddling, hacking attacks and more.

Last week, the US president signed an order to introduce sanc-

tions against Russia. In particular, the US prohibits its companies from buying Russian state bonds issued by the Central Bank, National Wealth Fund or the Finance Ministry after June 14, 2021. Washington also imposed sanctions against 16 organisations and 16 individuals allegedly involved in meddling in US elections. The sanctions also covered eight people and companies, connected to Crimea, including members of the regional government. Besides, the US expelled 10 diplomats working in the Russian Embassy in Washington. Which started a series of expulsions by Russia and Czech republic, as tit for tat.

This game of sanctions and offer to hold a summit simultaneously is perplexing for Moscow and the international community, both. Moscow considers it strange to impose sanctions and simultaneously offer to deepen the dialogue on strategic stability.

Mr Putin's intentions may become clearer next week when he's due to make his annual "state of the nation" address, a podium he's often used for sabre-rattling against the West.

But the call from Joe Biden may have given him a chance to pull back from this particular fight. The US has also decided to cancel sending two US warships to the Black Sea, a move which is seen as being conciliatory.

Kremlin spokesman Dmitry Peskov has said that Moscow will act out of the principle of reciprocity towards Washington and its sanctions. According to Peskov, the new sanctions will not facilitate the summit proposed by Biden.

In the end a lot depends on how the two leaders interact at the summit and what more conciliatory and mollifying steps are taken by the two to deescalate the regional tension and work towards normalising the bilateral relationship. However, chances of a rapprochement seem too far-fetched, as each rival wants to lead the new world order.

Are Examinations a Fair Way of Examining Our Knowledge?

any students dislike exams and children of all ages seem to have a diet of more and more exams that they have to take. Coursework is being discredited as a way of demonstrating knowledge as it is becoming easier to plagiarise or even buy coursework over the internet. This leaves exams as the only obvious choice, but do they accurately & fairly test students' knowledge?

Academic competence and intelligence are not straightforward to measure and no method will fully capture the scope of a student's ability, but the fact remains that we need at least some formal system, otherwise the academic system will not work. We need divisions between ability levels and the amount of experience and knowledge students actually possess, otherwise students will be in environments unsuited to them and won't be able to learn properly. There is no other way to divide them than by testing them in a fair and impartial manner. Exams are good at this because they are not vague – they have clear, measurable guidelines.

Guidelines are neither clear nor measurable. Students are duped into believing their innate abilities and potential are being tested whilst they are largely being tested on test-taking ability, confidence and pushiness.

Intellectual exploration is impeded with constant pulls towards mastering guess work and memorising 'standard' methods of answering 'repeated types' of questions that were originally set to test a student's response to unfamiliar problems. Subjective/qualitative papers with essay questions are not as easy to measure as mathematics or other quantitative papers. There are times when different examiners grade the same paper by the same student/pupil very differently.

Exams test memory more than analysis, creativity, or real understanding. If you have a good memory you can get away with doing very little work throughout

the course and still get very good grades. As well as causing personal problems, pressure can lead many bright students to under-perform. Exams test your ability to keep your cool more than they test your intelligence. Pressure is a fact of life and children must be prepared for it. Pressure only increases at university and in the workplace and we must teach children how to perform well in these conditions rather than protect them from them. Examination results depend on the opinion of the individual examiner.

Lose The Virus, Keep The Mask

Back then, I never would have expected that maskwearing was to become mandatory. Then, at the beginning of the pandemic, industrious home sewers churned out fabric masks with rapid alacrity. Then massmarket clothing companies, such as Old Navy and Uniglo, started offering multi-pack masks in their stores. Later, even luxury houses have followed suit, with brands like Burberry and Louis Vuitton offering facial coverings for consumers at exorbitant prices.

hen I immigrated to the United States, I brought a cotton mask with me, and on a crisp fall day, I decided to wear it to my elementary school.

I grew up in South Korea, where mask-wearing was an accepted norm. Individuals would don face coverings for a myriad of reasons: when they were feeling sick; when they didn't have enough time to put on makeup; when the air was so cold it chapped their skin; and when high-speed winds kicked up dense dust storms in the deserts of China and Mongolia that wrought havoc on neighbouring countries.

When I immigrated to the United States, I brought a cotton mask with me, and on a crisp fall day, I decided to wear it to my elementary school. The mask immediately drew the attention of my concerned classmates and teacher, who asked if I was feeling OK. I stopped

Back then, I never would have expected that mask-wearing was to become mandatory. Then, at the beginning of the pandemic, industrious home sewers churned out fabric masks with rapid alacrity. Then mass-market clothing companies, such as Old Navy and Uniqlo, started offering multi-pack masks in their stores. Now that the United States is starting to lift the restrictions and mandates placed to stem further transmission of Covid-19, I hope that the trend of maskwearing will continue among the public.

The primary reason for continued mask-wearing is for our continued safety. Even with the influx of vaccinations, Covid-19 and its variants will continue to be a vexing health concern in the future. For example, Pfizer's Chief Executive Officer Albert Bourla recently stated that those who received Covid-19 vaccinations would still likely require annual booster doses to update their immune systems against variants, like yearly flu vaccines. Continuing to don masks provides an extra layer of protection for some time to come



Speaking of the flu, masks are also likely to pre vent the transmission of diseases that we know well. In the 2019-2020 influenza season — a less deadly flu season than most — the Centers for Disease Control (CDC) estimated that 38 million individuals caught influenza, leading to 22,000 deaths. Now, nearing the end of the 2020-2021 season, flu mortality has been reduced to 595 cases thus far, making this season a non-event. While the impact of the masks is challenging to parse from the other interventions against Covid-19, such as maintaining social distancing, closing schools, and washing hands, previous researchers have also noted masks will reduce the transmission of respiratory vi-

Furthermore, Covid-19 will not be our last pandemic. Severe Acute Respiratory Syndrome, Middle East Respiratory Syndrome, Ebola, avian influenza,

swine flu, Zika, and Dengue fever have occurred or recurred within the last 20 years. With the growing increase in global travel, climate change, and increased human-animal contact, the rise of new epidemics and pandemics will become more common

Ultimately, the case for masks will be a matter of personal choice. However, I hope that the normalisation of masks this past year will allow them to take their rightful place in our wardrobes as an article of clothing with a specific purpose, akin to gloves and scarves. A mask may not be appropriate for all seasons or occasions, but it will be an article of clothing with an essential role in our self-expression and protection against the elements.

Is Double-Masking Better?

University Of North Carolina Health Care

study published on April 16, 2021, in JAMA Internal Medicine shows that wearing two face coverings can nearly double the effectiveness of filtering out SARS-CoV-2-sized particles, preventing them from reaching the wearer's nose and mouth and causing CO-VID-19. The reason for the enhanced filtration isn't so much adding layers of cloth, but eliminating any gaps or poor-fitting areas of a mask.

"The medical procedure masks are designed to have very good filtration potential based on their material, but the way they fit our faces isn't perfect," said Emily Sickbert-Bennett, PhD, associate professor of infectious diseases at the UNC School of Medicine and lead author

To test the fitted filtration efficiency (FFE) of a range of masks. UNC researchers worked with James Samet, PhD, and colleagues in the USEPA Human Studies Facility on the campus of UNC-Chapel Hill. There they filled a 10-foot by 10-foot stainless-steel exposure chamber with small salt particle aerosols, and had researchers don combinations of masks to test how effective they were at keening narticles on of their breathing space.

Each individual mask or layered mask combination was fitted with a metal sample port, which was attached to tubing in the exposure chamber that measured the concentration of particles entering the breathing space underneath the researcher's mask. A second tube measured the ambient concentration of particles in the chamber. By measuring particle concentration in the breathing space underneath the mask compared to that in the chamber, researchers determined the FFE.

"We also had the researchers in the chamber un-



dergo a series of range-of-motion activities to simulate the typical motions a person may do throughout their — bending at the waist, talking, and looking left, right, up and down," said Phillip Clapp, PhD, an inhalation toxicologist in the UNC School of Medicine who has been testing mask FFE with Sickbert-Bennett since the pandemic began.

According to their findings, the baseline fitted filtration efficiency (FFE) of a mask differs person to person, due to each person's unique face and mask fit. But generally, a procedure mask without altering the fit, is about 40-60% effective at keeping COVID-19-sized particles out.

A cloth mask is about 40% effective.

Their recent findings on doubling of face masks. shows that when a cloth mask is placed over a surgical mask, the FFE improved by about 20%, and improved even more with a snug-fitting, sleeve-type mask, such

When layered over procedure masks, cloth

masks improve fit by eliminating gaps and holding the procedure mask closer to the face, consistently covering the nose and mouth. When a procedure mask is worn over a cloth mask, FFE improved by 16%

"We've found that wearing two loosely fitted masks will not give you the filtration benefit that one, snug-fitting procedure mask will," Sickbert-Bennett said. "And with the current data supporting how effective maskwearing is at preventing the spread of COVID-19, the best kind of double-masking is when you and the person you are interacting with are each correctly wearing a very snug-fitting mask.'

The oxygen reading on the device wavered between 98 and 99.

a doctor. If your oximeter has alarms, atypical readings will set them off.

The mechanism clips onto the user's forefinger, though some oximeters have been known to be clipped onto one's big toe or even the ear, depending on the model.

According to the World Health Organization's Pulse Oximetry Training Manual, one must use the oximeter with patience. Once clipped on, it requires about 10 seconds to get an accurate reading.

A pulmonologist based in Jaipur and chief editor of Lung India, Dr Virendra Singh points out that pulse oximeters are not COVID-19 detectors. He states, one cannot use the pulse oximeter as a sole detector for any respiratory issues. It is only meant to give readings for a small time interval

When buying an oximeter, do be wary of the brand names. There are oximeters selling on e-commerce platforms that will work for a month at most before giving out, and may cost as much as about 2,000.

Here's how you can help reduce exhaustion from video conferences

he findings of a new study suggest that videoconferences might be less exhausting if participants feel some sense of group belonging. The study found that being on video didn't have an impact on feelings of fatigue. As remote work and the use of videoconferences have dramatically increased during the coronavirus pandemic, more people are fatigued from meeting through computer screens instead of in person. The research was published online in the Journal of Applied Psychology.

In this study, 55 employees in various fields in the United States were surveyed about their feelings about videoconferences. The researchers thought longer meetings and being on video would cause the most fatigue, but their findings surprised them, said lead researcher Andrew Bennett, PhD, an assistant professor at Old Dominion University. "We expected that aspects of being on video would be related to fatigue, such as watching everyone's faces closely on a screen or even watching yourself, but we didn't find this to be true in our study. Longer meetings also didn't impact fatigue," Bennett said. "However. the importance of feeling a sense of belonging or connection with the group really minimized fatigue after a videoconference.

Bennett's team decided to study videoconference fatigue, or "Zoom fatigue," because they all felt exhausted after their first videoconferences together when they began working remotely during the early days of the pandemic. The study participants received nine hourly surveys every day for five consecutive working days last year. Out of the surveys sent, participants completed more than 1,700 surveys and participated in an average of five to six videoconferences during the week. The majority of participants were male (58 per cent) and white (73 per cent) with an average age of 33.

One participant said videoconferences "can



be taxing on the mind and spirit," while another was "tired of being in them" and "extra tired after being in them." Only 7 per cent of the participants didn't report any signs of videoconference fatigue. Watching oneself on a webcam or turning the webcam off had no statistically significant impacts on post-meeting fatigue, the study found. Participants reported conflicting feelings about using the webcam, with some saying it was exhausting always to be staring at the screen while others felt it was impersonal when participants

switched off their webcams. "Everyone just wants to get in and get out, log in and log off," one participant reported. "There's very little chatter before and after the meeting like there would be in real life." That chatter may help build a sense of group belonging, which had a marked effect in reducing videoconference fatigue, the researchers said. There also appeared to be a sweet spot in the early afternoon when videoconferences caused less fatigue than at other times of the day.

Based on their findings, the researchers made some recommendations to help reduce videoconference fatigue: Hold videoconferences in the early afternoon.

Enhance perceptions of group belongingness, including time for small talk before or after the meeting or breakout rooms where people could talk about their interests (sports, movies, etc.). Establish basic meeting rules, such as whether to keep webcams on and refraining from doing other work.

Take breaks by looking away from the screen, standing up, and walking around. "We know videoconferences are helpful," Bennett said. "We get more emotional and nonverbal information from them, but that doesn't mean everything needs to be done in a videoconference. Sometimes a phone call or email is more effective and efficient.'

Research finds autism develops differently in girls than boys

he findings of a new study shed light on how autism spectrum disorder (ASD) manifests in the brains of girls. This prompted scientists to warn that conclusions drawn from studies conducted primarily on boys should not be assumed to hold true

The research published in the journal Brain discovered that there is a significant difference in the genes and "genetic burden" that underpin the condition in girls and boys. They also identified specific ways the brains of girls with ASD respond differently to social cues such as facial expressions and gestures than do those of girls without ASD

"This new study provides us with a roadmap for understanding how to better match current and future evidence-based interventions to the

underlying brain and genetic profiles so that we can get the right treatment to the right individual," said lead investigator Kevin Pelphrey, PhD, a top autism expert at the University of Virginia School of Medicine and UVA's Brain Institute.

Pelphrey added, "This advances our understanding of autism broadly by revealing that there may well be different causes for boys vs. girls; this helps us understanding the heterogeneity within and across genders."

Understanding Autism-Spectrum Disorder

The new insights come from a sweeping research project, led by Pelphrey at UVA, that brings together expertise from Yale; Harvard; University of California, Los Ans Children's National; University of Colorado, Denver; and Seattle Children's. At UVA, key players included both Pelphrey, of the School of Medicine's Department of Neurology and the Curry School of Education and Human Development, and John D. Van Horn, PhD, of the School of Data Science and UVA's Department of Psychology.

The research combined cuttingedge brain imaging with genetic research to better understand ASD's effects in girls. Those effects have remained poorly explored because the condition is four times more common

Pelphrey and colleagues used functional magnetic resonance imaging (fMRI) to examine brain activity during social interactions. They found that autistic girls used different sections of their brains than girls who did not have ASD. And, most surprisingly, the difference between girls with and without autism was not the same as the difference in the brain seen when comparing boys with and without autism, revealing different brain mechanisms at play in autism depending on a person's gender.

Likewise, the underlying ge netic contributors were quite different, the researchers found. Girls had much larger numbers of rare variants of genes active during the early development of a brain region known as the striatum. This suggests that the effects on the striatum may contribute to ASD risk in girls (Scientists believe a section of the striatum called the putamen is in volved in interpreting both social interaction and language.)

"The convergence of the brain imaging and genetic data provides us with an important new insight into the causes of autism in girls," Pelphrey said. "We hope that by working with our colleagues in UVA's Support ing Transformative Autism Research (STAR), we will be able to leverage our findings to generate new treatment strategies tailored to autistic girls."

Heart health of shift workers linked to body clock: Study

rorking hours that deviate from an individual's natural body clock are associated with greater cardiovascular risk, according to a new research. The research was presented at ESC Preventive Cardiology 2021, an online scientific congress of the European Society of Cardiology (ESC).

"Our study found that for each hour the work schedule was out of sync with an employee's body clock, the risk of heart disease got worse," said study author Dr Sara Gamboa Madeira of the University of Lisbon, Portugal.

At least 20 per cent of European employees work atypical hours or shifts, and growing scientific evidence associates these with deleterious cardiovascular outcomes. A number of explanations have been proposed, including sleep disruption and unhealthy behaviours. This study focused on the role of circadian misalignment, which is the difference between the "social clock" (e.g. work schedules) and the individual "biological clock".

Dr Gamboa Madeira explained, "We all have an internal biological clock which ranges from morning types (larks), who feel alert and productive in the early morning and sleepy in the evening, to late types (owls), for whom the opposite is true - with most of the population falling in between. Circadian misalignment occurs when there is a mismatch between what your body wants (e.g. to fall asleep at 10pm) and what your social obligations impose on you (e.g. work until midnight)."

The study included 301 blue collar workers, all performing manual picking activity in the distribution warehouses of a retail company in Portugal. Staff always worked either early morning (6am-3pm), late evening (3pm-midnight), or night (9pm-6am) shifts. Participants completed a questionnaire on sociodemographic factors (age, sex, education), occupational factors (work schedule, seniority), and lifestyle factors and had their blood pressure and cholesterol measured.

The Munich ChronoType Questionnaire was used to assess sleep duration, and to estimate each individual's internal biological clock (also called chronotype). It was also used to quantify the amount of circadian misalignment (i.e. the mismatch between an individual's biological clock and working hours) - referred to as social jetlag. Participants were divided into three groups according to hours of social jetlag: 2 hours or less, 2-4 hours, 4 hours or more.

The researchers used the European relative risk SCORE chart which incorporates smoking, blood pressure and cholesterol to calculate relative cardiovascular risk. Relative risk ranges from 1 (non-smoker with healthy blood pressure and cholesterol) to 12 (smoker with very high blood pressure and cholesterol). In this study, a relative risk of 3 or more was considered "high cardiovascular risk". The researchers then investigated the association between social jetlag and high cardiovascular risk.

The average age of participants was 33 years and 56 per cent were men. Just over half (51 per cent) were smokers, 49 per cent had high cholesterol, and 10 per cent had hypertension. One in five (20 per cent) were classified as high cardiovascular risk. Some 40 per cent had a short sleep duration on workdays (6 hours or less). The average social jetlag was nearly 2 hours. In most workers (59 per cent), social ietlag was 2 hours or less, while for 33 per cent of staff it was 2-4 hours, and in 8 per cent it was 4 hours or more.

A higher level of social jetlag was significantly associated with greater odds of being in the high cardiovascular risk group. The odds of being classified high cardiovascular risk increased by 31 per cent for each additional hour of social jetlag, even after adjusting for sociodemographic, occupational, lifestyle, and sleep characteristics and body mass index.

Dr Gamboa Madeira said, "These results add to the growing evidence that circadian misalignment may explain, at least in part, the association found between shift work and detrimental health outcomes. The findings suggest that staff with atypical work schedules may need closer monitoring for heart health. Longitudinal studies are needed to investigate whether late chronotypes cope better with late/night shifts and earlier chronotypes to early morning schedules, both psychologically and physiologically."



India Likely To Waive Customs Duty On Covid-19 Vaccine Imports

HC Lays Down Guidelines For Ensuring Quick Removal Of Offensive Content From Internet

NEW DELHI: The Delhi High Court on Tuesday laid down guidelines to be followed by courts while dealing with cases related to removal of objectionable content from the internet to ensure access to such offensive material is restricted at the earliest and it is not re-posted anywhere else by others.

The guidelines or template of directions were laid down by Justice A J Bhambhani while dealing with a matter in which a woman's photographs were uploaded on a pornographic website by some miscreants and despite court orders the content could not be removed in entirety from the world-wide-web and "errant parties merrily continued" to re-post and redirect the same to other sites.

The court directed the police to ensure the offending content was removed and directions were also issued to search engines, like Google, Yahoo and Bing, "to globally de-index and de-reference" the offending content from their search results. It directed search engines to en-

deavour to use automated tools, to proactively identify and globally disable access to any content which is exactly identical to the offending content, that may appear on any other websites/online platforms

"The internet never sleeps and the



internet never forgets," the court said referring to the case and added that it cannot resign itself to "a cat-andmouse game of errant parties evading orders by re-posting offending content across the world-wide-web, in an act of defiance and contumacy".

According to the template of directions, when such a matter comes before a court and it is satisfied that an immediate redressal was required at the interim stage, it may issue a direction to the website where the offending content is hosted to remove the same forthwith and maximum within 24 hours of receiving the judicial order.

"A direction should also be issued to the website or online platform on which the offending content is hosted to preserve all information and associated records relating to the offending content, so that evidence in relation to the offending content is not vitiated, at least for a period of 180 days or such longer period as the court may direct, for use in investigation," the court said.

It said a direction should be issued to the search engine(s) to disabled access to the offending content by 'de-indexing' and 'dereferencing" it in their listed search results and the intermediary ought to comply with such a direction within 24 hours of receiving the same.

'The directions issued must also mandate the concerned intermediaries, whether websites/online platforms/search engine(s), to endeavour to employ pro-active monitoring by using automated tools, to identify and remove or disable access to any content which is exactly identical to the offending content that is subject matter of the court order," it said.

It said for an order directing the removal or access disablement of offending content to be effective even within India, a search engine must block the search results throughout the world since no purpose would be served by issuing such an order if it has no realistic prospect of preventing irreparable harm to a litigant. The court said search engines are already employing requisite automated tools to prevent generating links to child pornography and hate speech, which tools can equally well be used in making a court order, such as the one in the present case, implementable and effective. "None of this would impose upon

the website, online platform or search engine(s) any obligation to generally monitor content or to adjudicate the illegitimacy of any content or operate as a prior restraint or a blanket ban or censorship of content generally," it said.

The guidelines said directions should be issued to the law enforcement agencies to obtain, within 72 hours, from the concerned website all information and associated records, relating to the offending content.

It said aggrieved party should also be permitted, on the strength of a court order, to notify the law enforcement agency to remove offending content from any other website, online platform or search engine(s) on which same or similar offending content is found to be appearing.

"Upon such notification by the

aggrieved party, the law enforcement agency shall notify the concerned website, online platform and search engine(s), who would be obligated to comply with such request..

"..and, if there is any technological difficulty or other objection to so comply, the website, online platform or search engine(s) may approach the concerned court which passed the order, seeking clarification but only after first complying with the request made by the aggrieved party," the court said.

It said if an intermediary fails to fulfil the conditionalities and obligations cast upon it, it was liable to forfeit the exemption from liability available to it under the Information Technology (IT) Act. In the instant case, it said posting of photographs in a pornographic site prima facie amounts to an offence under the IT Act and directed the petitioner to furnish in writing to the Investigating Officer, of the FIR lodged on her complaint, all available information relating to the offending content within 24 hours of receiving the instant judgment, if not already done so.

The Delhi Police are directed to remove/disable access to the offending content, the Web URL and Image URL of which would be furnished by the petitioner as above, from all websites and online platforms, forthwith and in any event within 24 hours of receipt of information from the petitioner. PTI

PDP Slams Govt Over Detention Of Party Leaders

SRINAGAR: The Peoples Democratic Party (PDP) on Tuesday hit out at the Centre for the alleged inhuman and illegal incarceration of senior party leaders and other political prisoners in and outside Kashmir.

Immediate release of all the political prisoners and those being held under detentions on other frivolous charges, including PDP youth president Waheed ur Rehman Parra would be a good start, he said.

COVID: Govt waives import duty on Remdesivir, its APIs

NEW DELHI: Amid surging COVID-19 cases in the country, the government on Tuesday waived customs duty on Remdesivir, its raw materials and other components used to make the antiviral drug.

The move would help augment domestic availability and reduce cost of the injection.

Remdesivir is being used in the treatment of coronavirus.

In a notification, the Department of Revenue said "the central government, on being satisfied that it is necessary in the public interest to do, hereby exempts the goods...when imported into India, from the whole of the duty of customs leviable".

The items on which the duty has been waived include Remdesivir active pharmaceutical ingredients (APIs), injection Remdesivir, and beta Cyclodextrin used in manufacture of Remdesivir.

This import duty exemption would remain in force till October 31 this year.

and Industry Commerce Minister Piyush Goyal tweeted, "In line with PM @NarendraModi's priority to ensure affordable medical care for COVID-19 patients, imports of Remdesivir API, injection and specific inputs have been made import duty free. This should increase supply and reduce cost thus providing relief to patients.'

Earlier on April 11, in view of increased demand for Remdesivir, the Centre banned export of the injection and its APIs till the situation improves. The National Pharmaceutical Pricing Authority (NPPA) had last week said various drug companies had cut the prices of Remdesivir injection on the intervention of the government.

Cadila Healthcare has reduced the price of its REMDAC (Remdesivir 100 mg) injection to Rs 899 from Rs 2,800.

Similarly, Syngene International has cut the price of its brand RemWin to Rs 2,450 from Rs

Hyderabad-based Dr Reddy's Laboratories has cut the price of REDYX, which used to cost Rs 5.400. to Rs 2,700 now. Similarly, Cipla has reduced the price of its CIPREMI brand to Rs 3,000 from Rs 4,000.

Mylan has also reduced the price of its brand from Rs 4,800 to Rs 3,400. Similarly, Jubilant Generics has cut the price of its Remdesivir brand to Rs 3,400 from Rs 4,700 earlier.

Hetero Healthcare has cut the price of its brand COVIFOR from Rs 5,400 to Rs 3,490.

WTC Final To Go Ahead As Planned, Says ICC After UK Adds India To Travel 'Red List'

DUBAI: The International Cricket Council on Monday said the World Test Championship final, to be contested between India and New Zealand in Southampton from June 18, will go ahead as planned after Britain added India to travel "red list" after COVID-19 caseload surge.

India's entry into the "red list" effectively bans all travel from the country and makes a 10-day hotel quarantine compulsory for UK residents arriving back home.

However, the ICC expressed confidence in staging the WTC final in a bio-secure environment.

"The ECB and other members have demonstrated how we can stage international cricket safely in the middle of a pandemic and we are confident that we can continue to do that and that the WTC Final will go ahead as planned in June in the UK," said the ICC in a statement on Monday night.

"We are currently discussing with the UK Government the impact of countries being on the 'red list'," it added.

A BCCI source told PTI that it's difficult to say anything at this point in time and the Board is hoping that India will not be in the 'red list' by the time the team leaves for UK in early June for the WTC final.

"We still don't know how the situation will pan out in June. The travel related SOPs are always dynamic as per COVID situation.



When India leaves for UK at the start of June, it might be that the country is not in red list which requires 10 days of hard quarantine.

"But, if it is needed, it would be done. The situation is too fluid right now," the source said on conditions of anonymity.

Media reports in the UK said that in case it is required, the Rose Bowl in Southampton and it on-site hotel could be cleared for 'red list' arrivals by reverting to the full bio-secure set up that saw it successfully stage international fixtures last season.

"We are currently discussing with the government the impact of countries being on the 'red list'. By working collaboratively we demonstrated how we can stage international cricket safely in the middle of a pandemic and hope to be able to do so again this year," an

ECB spokesperson was quoted as saying by 'Guardian' newspaper.

The Indian women's cricket team is also scheduled to tour UK in June while the men's team is to play five Tests in England starting August 4.

There is also concern about how the inclusion of India in the 'red list' will impact the England and New Zealand cricketers who are currently playing in the IPL and intend to fly to the UK for the twomatch Test series between the two countries that starts at the Lord's on June 2.

The IPL will conclude on May 30 with the summit clash scheduled in Ahmedabad.

The breakaway league could potentially launch as early as next season, rendering meaningless the race for Champions League qualification that currently involves Liverpool, Chelsea and Tottenham three of the six rebel English clubs. Liverpool stayed in sixth place, outside the Champions League places, after Spain defender Diego Llorente scored with a header from an inswinging corner to earn Leeds a point that the team's second-half fightback might have deserved.

Sadio Mane on Monday stroked the ball into an empty net in the 31st minute from a squared pass from Trent Alexander-Arnold to give Liverpool the lead and put the deposed champion on course for a fourth straight victory.

A win would have lifted Liverpool above West Ham and into fourth place.
