Entrepreneurs Becoming Labourers, As Kashmir Awaits Consumer Court

he recent Comptroller and Auditor General of India (CAG) report censuring the government for the pending 2014 flood relief in Kashmir reminded Tanveer Ahmad of his own battle with the Consumer Court consumed by the 2019 summer shift along with the hundreds of cases.

"I was so near yet so far," Tanveer sums up his struggle with his pending flood case misplaced two years ago.

After losing his home in the devastating fall of 2014, Tanveer was banking on his insurance policy for the full recovery of losses suffered in the massive floods.

A resident of Hygam in north

Kashmir's Sopore town, Tanveer approached his insurer-HDFC Urbo-in post-flood phase.

But when his claim wasn't entertained, he decided to move to the Consumer Court for justice.

"My case was on its final Tanveer says. "All the stage,' witnesses were heard in the court and the final decision was around the corner when New Delhi abrogated Article 370 in August 2019."

In the ensuing communication blockade spanning months, Tanveer lost the track of his case he was rigorously pursuing for half a decade.

thus leaving hundreds of litigants in lurch. Among them is Mohammad Maqbool Tambay.

In 2015, Magbool lost his shop in a fire turning his world upside down.

"After that fire incident, I was hopeful to restart business with my insurance policy," he says.

"But when I made the claim, I was denied full insurance payment. The company was not even ready to provide me 10 percent of the losses I had suffered in the fire.'

To seek justice, Magbool took his case to the Consumer Court. But till date, the fate of his case remains unknown due to the changed equations on the ground. With the result, the yesterday's entrepreneur has now become a labourer.

"I work as a daily worker in construction sites now," Maqbool says.

"I had borrowed money from the bank to set up my shop. But after the incident and subsequent denial of insurance claim, I had to sell land to pay off the credit and to cope up with other losses."

Advocate Sujood, a consumer lawyer, told Kashmir Observer that there're hundreds of cases, majority of them related to the pending flood relief, in the consumer court which were at the final stage.

"But since 2019, when the J&K Consumer Protection Act was repealed and the commission was shut, there is uncertainty among clients now," the lawyer said. "People fear

Teslas Can Be "Easily Tricked" To Run With **Vacant Driver Seat: Research Body**

onsumer Reports engineers said they "easily tricked" a Tesla Inc. vehicle to drive via its Autopilot feature without anyone in the driver's seat, just days after a fatal crash in Texas where police said they found no one behind the steering wheel of a Tesla car.

In a test conducted this week, test drivers took several trips on a closed half-mile track in a Tesla Model Y sport utility vehicle, the nonprofit research or-

details remain unresolved, including whether Autopilot was being used when the vehicle traveled a short distance before hitting a tree. The authorities said that one man was found in the front passenger seat and a second in one of the rear seats -- with no sign anyone was behind the wheel.

Tesla Chief Executive Officer Elon Musk took to Twitter earlier this week to say the vehicle's driver-assist features weren't to blame.

"Data logs recovered so far show Au-



ganization said in a statement Thursday. The vehicle -- with Autopilot technology engaged -- was able to steer itself along painted lines but at no time displayed a warning that the driver's seat was empty. The engineer who conducted the test placed a small weighted chain on the steering wheel to simulate the weight of a driver's hand.

"In our evaluation, the system not only failed to make sure the driver was paying attention, but it also couldn't tell if there was a driver there at all," said Jake Fisher, Consumer Reports' senior director of auto testing. Fisher was able to reach over from the passenger seat and accelerate the car using a dial on the steering wheel.

Tesla, which reports earnings April 26, didn't respond to a request for comment. The company has come under scrutiny for the way it markets Autopilot, which is a driver-assistance feature. Tesla has rolled out a feature it calls FSD. or Full Self Driving, to early customers who are "beta testing" the technology in advance of a wider release.

topilot was not enabled & this car did not purchase FSD," Musk tweeted, referring to the company's trial Full Self Driving software. "Moreover, standard Autopilot would require lane lines to turn on. which this street did not have.

Two federal agencies -- the U.S. National Transportation Safety Board and the National Highway Traffic Safety Administration -- are investigating the incident. Local authorities were also seeking warrants to inspect the car.

In a statement, NHTSA said "the information presented in CR is concerning, and we'll take action if we find it poses an unreasonable risk to safety." The agency said that all state laws hold the human driver responsible for vehicle operation.

Also Thursday, Democratic Senators Richard Blumenthal of Connecticut and Ed Markey of Massachusetts sent a letter to NHTSA expressing concerns.

Study finds co-workers influence our food choices

he findings of a new large study on hospital employees suggest that people in our social networks influence the food we eat, both healthy and unhealthy. These findings may help guide efforts to improve population health.

The findings of the research were published in the journal titled 'Nature Human Behaviour'.

The foods people buy at a workplace cafeteria may not always be chosen to satisfy an individual craving or taste for a particular food. When co-workers are eating together, individuals are more likely to select foods that are as healthy--or unhealthy--as the food selections on their fellow employees' trays.

"We found that individuals tend to mirror the food choices of others in their social circles, which may explain one-way obesity spreads through social networks," said Douglas Levy, PhD, an investigator at the Mongan Institute Health Policy Research Center at Massachusetts General Hospital (MGH) and first author of new research published in Nature Human Behaviour.

Levy and his co-investigators discovered that individuals' eating patterns can be shaped even by casual acquaintances, evidence that corroborates several multi-decade observational studies showing the influence of people's social ties on weight gain, alcohol consumption and eating behaviour.

Previous research on social influence upon food choice had been primarily limited to highly controlled settings like studies of college students eating a single meal together, making it difficult to generalize findings to other age groups and to realworld environments.

The study by Levy and his co-authors examined the cumulative social influence of food choices among approximately 6,000 MGH employees of diverse ages and socioeconomic status as they ate at the hospital system's seven cafeterias over two years.

The healthfulness of employees' food purchases was determined using the hospital cafeterias' "traffic light" labeling system designating all food and beverages as green (healthy), yellow (less healthy), or red (unhealthy).

MGH employees may use their ID cards to pay at the hospitals' cafeterias, which allowed the researchers to collect data on individuals' specific food purchases, and when and where they purchased the food.

The researchers inferred the participants' social networks by examining how many minutes apart two people made food purchases, how often those two people ate at the same time over many weeks, and whether two people visited a different cafeteria at the same time.

"Two people who make purchases within two minutes of each other, for example, are more likely to know each other than those who make purchases 30 minutes apart," said Levy. And to validate the social network model, the researchers surveyed more than 1,000 employees, asking them to confirm the names of the people the investigators had identified as their dining partners.

"A novel aspect of our study was to combine complementary types of data and to borrow tools from social network analysis to examine how the eating behaviors of a large group of employees were socially connected over a long period of time," said co-author Mark Pachucki, PhD, associate professor of Sociology at the University of Massachusetts, Amherst.

Based on cross-sectional and longitudinal assessments of three million encounters between pairs of employees making cafeteria purchases together, the researchers found that food purchases by people who were connected to each other were consistently more alike than they were different. "The effect size was a bit stronger for healthy foods than for

unhealthy foods," said Levy.

A key component of the research was to determine whether social networks truly influence eating behaviour, or whether people with similar lifestyles and food preferences are more likely to become friends and eat together, a phenomenon known as homophily.

"We controlled for characteristics that people had in common and analysed the data from numerous perspectives, consistently finding results that supported social influence rather than homophily explanations," said Levy.

Why do people who are socially connected choose similar foods? Peer pressure is one explanation. "People may change their behaviour to cement the relationship with someone in their social circle," said Levy. Co-workers may also implicitly or explicitly give each other license to choose unhealthy foods or exert pressure to make a healthier choice.

The study's findings have several broader implications for public health interventions to prevent obesity. One option may be to target pairs of people making food choices and offer two-for-one sales on salads and other healthful foods but no discounts on cheeseburgers.

Another approach might be to have an influential person in a particular social circle model more healthful food choices, which will affect others in the network. The research also demonstrates to policymakers that an intervention that improves healthy eating in a particular group will also be of value to individuals socially connected to that group.

"As we emerge from the pandemic and transition back to in-person work, we have an opportunity to eat together in a more healthful way than we did before," said Pachucki.

"If your eating habits shape how your co-workers eat--even just a little--then changing your food choices for the better might benefit your co-workers as well," concluded Pachucki.

"My talks (in New Delhi) with Prime Minister Manmohan Singh yielded positive results and led to a joint statement which reflected a clear resolve to address all issues and a resolve to move towards a final settlement at the Kashmir issue," the president said in an interview with state- run APP news agency.

"A breakthrough has been achieved in the peace process between the two countries," the president said.

"Prime Minister Singh has unambiguously expressed the resolve to solve all issues, including Kashmir, as also stated in the joint statement.

'The Indian prime minister also committed himself to resolving all disputes at the"

multi-lateral forum of the Asian-African Summit in Iakarta when he said we want to resolve all issues in an amicable manner," the president said. He said he was hopeful of progress towards a fair resolution of the Jammu and Kashmir dispute. "I am optimistic - there is sincerity as it has been accepted that all issues should be addressed- we have to address the Kashmir issue."

Musharraf said the general environment between Pakistan and India had improved "substantially" after his visit

Musharraf, who also watched the final India-Pakistan oneday cricket match in New Delhi April 17 before his talks with Manmohan Singh, said he was pleased with Pakistan's victory in the series. The president said he told UN Secretary General Kofi Annan during a meeting on the sidelines of the Jakarta summit that the expansion of the Security Council should be only in the non-permanent category.

A people-driven effort

he social media video of Mufti Nazir Ahmad Qasmi urging people to offer nimaz at home should be welcomed by all. The role of religious leaders in ensuring Covid-appropriate behaviour among the people amid the ongoing runaway surge of the pandemic cannot be over-emphasised. They have a large following and people look up to them for guidance and take them seriously. So, it was sensible of Mufti Qasmi to come out with a video message to people to not attend mosques. More religious leaders in the Valley need to follow the example of Mufti Qasmi and urge Muslims to observe Covid-19 protocol. Not only Muslims, Hindu, Sikh and Christian leaders need to the same. This will go a long way to jolt the community into engaging in a responsible behaviour in public to ensure we also defeat the virulent second wave.

And why only religious leaders, the society, as a whole, needs to contribute. The administration should seek the support of the civil society to create awareness and urge observance of Covid-19 protocol. Let mohalla be a unit for this initiative where a mosque committee, elders or a group of youth can take the lead in promoting a Covid appropriate conduct.

The administration can certainly play a role in encouraging this community effort. This is because, a long term lockdown as a measure to control the contagion is now ruled out. The devastation that lockdown wrought on the economy last year makes its repetition unthinkable. The administration has now imposed weekend curfew to at least restrict widespread social contact for two days. This will make some redeeming difference. For the rest of the days, the administration, however, needs to check its instinct to lock things down.

So what should the government be doing instead? Many things other than an easy recourse to a curfew. For one, there's an urgent need to enforce the safety precautions in order to contain the pandemic. And to start with, there has to be an aggressive campaign to enforce the use of masks. More alarmingly, the masks are still absent from the faces of most of the people walking on the streets or those of the passengers using public transport. And none of these violators is taken to task.

The administration needs to urgently work on two fronts: one, run an earnest awareness campaign alerting people to the deadliness of coronavirus and the urgency of observing safety precautions. Second, take strict action against the people who go out without masks or participate in large gatherings. These are the only pragmatic and hopefully helpful tools to tackle the contagion. That too, with

ome actions are normalized and engraved into our society in such way that even if it's physical abuse, it's okay. Earlier in the times when our parents used to be children, they were subjected to certain correctional methods and corporal punishment was one of the most used methods. It was a norm back then to spank, beat or even use harsh words for children who misbehaved. It was considered necessary to incorporate fear in a child's mind in order for them to behave in a certain way. Corporal punishment is still practiced in the 21st century in most Indian schools. The Delhi high court banned its use in Delhi schools in 2000. Many schools claim to apply the ban - though the enforcement is lax.

Corporal punishment often turns into serious physical abuse. It also lends itself to the wrong messaging that is, it teaches the children that violence is an acceptable way of dealing with issues. It teaches them it's okay to use violence.

Children face many emotional and social hurdles growing up especially when they are in their adolescence; this is when they become very sensitive to their environment and the way people treat them. They face the wrath of an unmitigated identity crisis and confusion. With this pain of growing up, they only see two figures from whom to seek guidance - parents and teachers. The image of a teacher or a parent is carved as an ideal and a perfect picture in a child's mind. Every action taken to solve a situation by them is considered the right way of handling them. Many times when a child feels his or her needs are not being met such as the need for attention, he or she misbehaves and causes a fuss; the lack of skill to handle it makes many

of the teacher and parents strike out at children and use corporal, verbal ,mental or other forms of emotional punishment.

There is a very thin line between correcting a child and abusing a child, very often authority is misused by a teacher or an elder who uses dictatorship methods over a child. Violence in many forms has been accepted in the society in such a way that it feels normal. It's widely used by teachers and parents regardless of its evident lack of effectiveness. Therefore, layers of beliefs and practices that cloak corporal punishment under the guise of love care and protection- when in reality its abuse of authority that harms the child.

Many studies have shown that Physical punishment including spanking, hitting and other means of causing pain can lead to increased aggression, antisocial behaviour, physical injury and mental health problems in children. Corporal punishment is associated with a variety of psychological and behavioural disorder in children and adults like anxiety, depression, withdrawal, low self-esteem impulsiveness, delinquency and substance abuse.

It is globally recognised that punishment in any form or kind in school comes in the way of the development of the full potential of children. When adults use corporal punishment it teaches children that hitting is an acceptable means of dealing with conflict. Corporal punishment leads to adverse physical, psychological and educational outcomes- increase aggressive, destructive behaviour, vandalism, poor school achievements, poor attention span, increase dropout rates, low self-esteem, anxiety, somatic complains retaliation against teachers. Many people support the use of corporal punishment and recall their childhood days where getting beaten up by teachers and extreme physical punishments were a part of teaching. But change is a law of nature and with the advancement of time and growing field of research we know now what effects such type of punishment leaves on a child's mental health.

There are a number of alternative methods of dealing with a child or an adolescent that include Distraction, removing them from the situation, moral conversations, loss of privileges etc. The not wanting to change the old traditional methods of teaching attitude is found in many teachers and parents who now have become a source of distress instead of comfort. These distressful children then grow up to become abusive adults and also show aggressive behaviour towards their spouses as well. Our society is currently suffering from domestic violence, assaults and many other aggressive crimes, and the offenders most usually have a history of being victims of such aggression themselves. Corporal punishment and other cruel and degrading forms of punishment are forms of violence and states must take all appropriate, legislative, administrative, social and educational measures to eliminate them.

that requires records and data accuracy. Sound records management is more important than ever before with governments initiating unprecedented steps to deal with the COVID-19 pandemic."

Stating that Mr Nayak has asked relevant information which must be disseminated, he observed in his order, "keeping in view the facts of the case and the submissions made by all the stakeholders and in the light of the decisions cited above as also the observations made in the previous paragraphs, the Commission observed that very pertinent information pertaining to the COVID-19 pandemic situation was sought by the complainant which could not be made available by any of the respondents."

He qualified his directive to appoint a nodal officer by stating, "the fact that the application shuttled from one division of the public authority to another indicates that there is a very urgent requirement for notifying a nodal authority in the MoHFW/DGHS to compile, collate and consolidate the information sought in the RTI application and suo motu up load the same on the website of the public authority. Mr Julka went a step further to state that transparency in this vital public issue matter is important even for scientific and academic data. He stated, "there is an immense necessity to evolve a strong. robust and effective documentation mechanism and its continuous updation which will be mutually beneficial not only for the government but also for the scientists, researchers, academicians, historians, law makers, etc for future. Therefore, the Commission advises the secretary, MoHFW to designate an officer of an appropriate seniority as a nodal officer to examine the matter and suo motu disclose the information sought in the RTI application on the website of the public authority within a period of 15 days from the date of receipt of this order in the larger public interest." However, several months down the line after this order, there has been no attempt to make anything transparent so far, leave alone voluntarily uploading information on the website. Every RTI application is stonewalled, in the name of secrecy! Dangerous for transparency and good governance, isn't it?

ver since the advent of the CO VID-19 pandemic in March 2020, an array of information has been sought under the Right to Information (RTI) Act, from users and activists across the country. They are demanding transparency in various aspects of COVID-19 management, administration and dispersal of vaccines-like the constitution of the National Expert Group on Vaccine Administration for COVID-19 (NEGVAC), the nodal agency, which coordinates with states; details of the vaccine rollout; the security of the cowin app, essential for your vaccination appointment; the finalisation of pricing of vaccines; safety and clearances of vac cines, details of export of vaccines and dispersal in the domestic market and so on. To date, the ministry of health and family welfare (MoHFW) and related public authorities have declined most of the information

In what can be safely termed as the biggest national secret of a public issue of epic proportions where each Indian needs to know the facts that directly affect him or her, public authorities, particularly MoHFW, is warding off most requisitions under RTI. The common reply that seems to be mechanically doled out is, "information sought is exempted under Section 8(1) (a) of the RTI Act. 2005 as this may prejudicially affect the strategic, scientific and economic interest of the State. As such no information can be provided.' One of the latest RTI applications was filed by Aniket Gaurav, member of the the Legal Squad organisation. He sought information on whether any ministry under the government of India (GoI) is maintaining the records of the number of people who tested positive for coronavirus, even though they have already received one or more doses of a COVID-19 vaccine. His RTI application sought details on "the number of people who tested positive after the first dose as well as after the second dose of COVID-19 vaccine till date; out of the total number of people who tested positive after the first dose as well as the second dose of the vaccine till date. a) the number of people who got infected but had a mild or moderate form of the disease b) the number of people who got infected but suffered from a severe form of the disease. The reply he got from the MoHFW was, "Health being a state subject this

cell/office i.e COVID-19 Vaccine Administration Cell (CVAC) of the MoHFW does not have such specific data. However, for statistics/data as available you may visit Ministry of Health & Family Welfare's website mohfw.gov.in. or Arogya Setu App (refer link https://dashboard.cowin. gov.in) or `mygov.In/COVID-19' or `mygov.app'."

RTI applicant Mr Gaurav states that, while none of these links or apps has any relevant information, "Ministry of Health said that it does not have such specific data but yesterday in the press briefing they came out with some data. While the ministry replied to me under RTI that health is a state subject, then how come they suddenly gave selective information at the press briefing? This is rather strange and unjust." meeting in which the matter of National Health ID was discussed and; all file notings, correspondences, internal communications, minutes and memos relating to them.

The reply from the CPIO of the ministry parroted the same exemption clause under the RTI Act. Overwhelmed

Aking suo motu cognizance of the 'national health emergency', the Supreme Court directed the Centre to come up with a feasible plan within 24 hours to address some of the glaring paucities that have been exposed by the lethal second wave of the coronavirus pandemic. The apex court's energy has, however, caused some dismay. This is perhaps because as many as six high courts were examining — critically — some of the shocking instances of administrative failure; India's highest court is likely to transfer these issues to itself to avoid 'confusion'. Clarity is, indeed, a virtue. It must be made clear that the government of the day is to be held accountable for its monumental lapses. There is a view that it has got away rather lightly on several occasions in the course of this pandemic. The horrors suffered by India's migrant workers on account of myopic policy decisions are just one example.

There can be no doubts about the scale of the 'national emergency'. Each passing day, data bear out both its enormity and its cruelties. On Thursday, India logged over three lakh new cases and witnessed over 2,000 deaths: this is yet another grim milestone globally. The human suffering has been amplified by other raging crises. In several states — Gujarat and Haryana are examples — the demand for oxygen has outstripped supply even though an Empowered Group of Officers had raised a red flag last year. Health institutions are running short of not just oxygen but also beds and even life-saving drugs. Laboratories — the first line of response in a medical crisis — have been equally overwhelmed; the delay in diagnosis has added to citizens' woes. India's health apparatus is under unprecedented strain.

What is shameful is that this crisis was entirely avoidable. The Narendra Modi government had smugly declared victory over the virus instead of preparing for a lethal second wave that was already lashing many other parts of the world. This criminal hubris encouraged non-compliance among the people. Even as the need to curb mass gatherings — religious and political — was ignored, people let down their guard, refusing to wear masks or adhere to other safety protocols. Mr Modi's government did not pay attention to Bangladesh — a smaller country with finite resources —which reinforced Covid regulations by combining public awareness campaigns with shaming mechanisms. Equally inexplicable has been the Centre's refusal to keep the health infrastructure battle-ready and the snail's pace of the vaccination programme. Did Mr Modi's government have a robust strategy in place to deal with an unexpected turn of events?

Hindsight, of course, offers some advantages. The virus can be expected to return, again and again, with newer mutations and it is to be hoped India will not repeat the mistakes it committed that made the second wave possible. But this government needs to be asked tough questions. If the vanguards of democracy desist from doing so, the powers that be would no longer think it is answerable to the people for their sufferings.

Puducherry-based Saurav Das, journalist and transparency activist, who has filed a series of RTI applications related to COVID-19 since the past several months, has been denied information without exception.

For example, one of his RTI applications was addressed to MoHFW from which he sought details on its COVID vaccine administration cell. His RTI application requisitioned the exact dates on which the expert group has met till date; certified true copies of detailed agenda of meetings till date; certified true copies of presentations made before the group and detailed information about each of them; the certified true copies of minutes of meeting of each and every meeting that has been held till date ; a certified true copy of notification or office order by which the group was formed; a certified true copy of the list of names and designation of every person of the group; certified true copies of each and every file noting and correspondence related to the formation of the group and certified true copies of each and every noting and correspondence related to the presentations made at each meeting; details of every

various countries; the vaccine purchase agreements with various states in the domestic market and; on the setting of and the working of the COVID Pandemic Joint Monitoring Group (JVG).

In fact, Mr Nayak, had filed an RTI application in April 2020 to the MoHFW, seeking information, including the district-wise number of hospitals and healthcare facilities designated as CO-VID-19 treatment centres and the postal addresses and telephone numbers of such facilities. His RTI application was pushed around from one public authority to another.

He filed a second appeal with the information commission. In July 2020, chief central information commissioner CIC Bimal Julka had given a stern order and advised the MoHFW to appoint a nodal officer to put up all details on the website in a chronological manner.

He rightly observed in the order, "It is well recognised that the impact of CO-VID-19 pandemic will be far reaching and that all the stakeholders need to be cognizant of the importance of proper data and record management. Such records could also be useful for research and educational institutions involved in tracing the disease, mapping and analysing the pathogens genome to develop vaccines

Covid-19 In India: An Unfolding Humanitarian Crisis

It is the mixing of susceptible populations that ultimately drives the transmission of respiratory infectious diseases. There were bold declarations from senior political figures, with Health Minister, Harsh Vardhan, saying in early March that India was in "the pandemic end game" here have been many predictions about how many people have had COVID-19 and whether or not this or that country has reached herd immunity. We have seen this before in Manaus, Brazil, and in India. The optimism is alas always misplaced and occasionally used irresponsibly.

We have seen approaches to naturally acquired herd immunity proposed as high-profile ideas for public policy in the UK and internationally, such as the Great Barrington declaration. These proposals have been widely decried by health experts, including in the John Snow memorandum. The World Health Organization described the idea as "scientifically problematic and unethical".

There is no doubt that a humanitarian emergency is unfolding in India right now. India is a catastrophic example of a population that has certainly not reached herd immunity against COVID-19. The stories of a collapsing health system are numerous, with reports of a lack of oxygen for hospitalised patients and bodies burning on pyres in the streets.

India has locally made vaccines, which are being rolled out, including the AstraZeneca vaccine. But the proportion of the population that is immunised is still very low, and alas, there are more than enough susceptible people for the virus to keep spreading.

The numbers are stark too. The Financial Times put together a sobering review of the data, with unwanted new world records being set for new confirmed cases in one day. One of the most worrying aspects is the level of under-counting that will be happening.

The test positivity rate (the proportion of people tested for COVID that return a positive test) in India is high – around 18%. This is well above the WHO threshold of 10%, suggesting that a lot of positive cases are being missed because of a lack of testing capacity and timely reporting.

Indeed, one of the key concerns is the lack of highquality real-time data to give an informed picture of the scenarios that are unfolding in India. The numbers of deaths are starting to rise on a steep trajectory, and that graph will surely soar further over the next few weeks.

When there was speculation around a possible reaching of herd immunity, India was relatively becalmed with much lower levels of COVID-19, vaccines becoming available and a pandemic that was appeared to be under control in South East Asia.

So what changed all that? There has been a lot of focus on the B1617 variant, which was first detected in India. There is still a lot to learn about this variant, such as whether it is more transmissible and thus contributing to an increased community transmission. It is a plausible theory, but as yet unknown.

But it is the mixing of susceptible populations that ultimately drives the transmission of respiratory infectious diseases. There were bold declarations from senior political figures, with Health Minister, Harsh Vardhan, saying in early March that India was in "the pandemic end game".



Super-spreading events

Since then, there have been mass gatherings in India. In March and April, there were state-level elections across several Indian states, which comes with associated campaigning and population mixing. Fans attended the international cricket matches between India and England, with full stadiums and few wearing masks. And there have been several large religious festivals, such as the Kumbh Mela, an event that occurs once every 12 years and is attended by millions.

There are recent examples from China, Saudi Arabia and Israel where key religious calendar events have been cancelled or scaled-back, to reduce the mixing of infectious and susceptible people during the pandemic. This includes the Hajj and Chinese New Year.

India may have scaled back on their celebrations a little, but millions have been gathering for Kumbh Mela across different sites, and thousands of new coronavirus cases are already confirmed in revellers.

Knock-on effects

The Serum Institute of India is one of the most important buildings in the world at the moment. It is producing the AstraZeneca vaccine in large numbers, and is a key provider to many countries including the Covax Initiative. However, exports from India have fallen in recent weeks and it would not be a surprise to see the Indian government move to keep even more of the precious vaccines within India.

This will affect the supply for other lower-income countries. There will be a significant knock-on effect from the humanitarian crisis within India that sustains the pandemic for even longer. It shows how reliance on few manufacturing sites for such vital products is vulnerable to lethal consequences.

This highlights the importance of global preparedness. When the fire service is summoned to the burning building, it has already bought and fitted the hose beforehand. Public health fire-fighting during the pandemic is close to impossible when the main tool to put out the fires (vaccines) is not available for the first 12 months and in short supply thereafter.

The world needs all the vaccines it can get, so factors such as equity of distribution and public confidence have to be addressed to ensure that AstraZeneca and other vaccines are made available far and wide and not just to wealthy countries.

For while countries around the world look on, we may easily have "the next India" just around the corner. How much excess death must we see before global cooperations overcome the "me first" approaches from the wealthier countries?

Explained: Infections

after the Covid-19 vaccination

'Breakthrough infections' are expected in a small number of people after vaccination. No vaccine is 100% effective. Some may have been infected before the jab; also, some strains may evade vaccine protection.

oronavirus vaccines are supposed to protect the individuals from getting infected. In the last few days, however, there have been several cases of vaccinated people, even those who have received both doses, testing positive for the virus. Such cases are referred to as "breakthrough" infections, indicating that the virus has been able to break through the defences created by the vaccine.

Very few cases of breakthrough infections have been reported, but these have led to some doubts being expressed about the effectiveness of the vaccine, and contributed to the already prevailing vaccine hesitancy. Earlier this week, the Indian Council of Medical Research (ICMR) released data that showed breakthrough infections were extremely rare in India's vaccinated population, with an incidence rate of less than 0.05%.

Full protection not possible

It is very well understood that no vaccine offers 100% protection from any disease. That means that there are breakthrough cases for all kind of vaccines — including Covid-19 vaccines. According to the Centers for Disease Prevention and Control (CDC) in the United States, vaccinated people are much less likely to get sick, but it is never entirely ruled out.

During trials, various Covid-19 vaccines have been shown to be between 60% and 95% effective. In actual use scenarios, a vaccine is usually less effective than what is reported in the trials. It is not surprising, therefore, that some vaccinated people do get the infection.

Also, it typically takes about two weeks for the body to build immunity after being vaccinated, so the chances of a person falling sick during this period are as high or as low — as the chances for any person who has not been vaccinated. Then there is



the emergence of new variants of the virus. Some are able to evade the human immune response, and therefore have a greater chance to break through the defences created through the vaccine.

Breakthrough cases in India

In a bid to settle doubts about the effectiveness of vaccines in the wake of reports of breakthrough infections, the ICMR last week released data from the Indian population that showed that only about two to four people from a vaccinated group of 10,000 had so far been detected to be infected.

Until then, 11.6 crore doses of the Covishield vaccine had been administered. Among 10.03 crore people who had taken only the first dose, 17,145 had got infected. That translates into a 0.02% prevalence. Among the 1.57 crore people who received the second dose as well, 5,014, or about 0.03%, had got infected later.

Again, about 1.1 crore doses of Covaxin have been administered until now. Of the 93.56 lakh who took only the first dose, so far 4,208 have got the infection. That is about 0.04% of the total. Among the 17.37 lakh who have taken the second shot, only 695 had been infected, again 0.04%.

As can be seen, the numbers are very small, and we do not know how many of these got the infection within a few days of receiving the vaccine dose. Also, those in the priority list of vaccination, such as healthcare workers and frontline workers, have been prone to getting infected due to the prolonged occupational exposure to the virus, according to Dr Balram Bhargava, director general of ICMR. Bhargava also suggested that the new, faster-transmitting mutant strains could be contributing to the breakthrough infections.

Breakthrough infection milder

Vaccines protect not against the infection, but against moderate or severe disease and hospitalisation. Most breakthrough infections are mild, according to Dr Ashish Bawdekar, principal investigator of the Covishield vaccine trial at KEM Hospital in Pune.

Dr Shashank Joshi, expert on the Maharashtra state Covid 19-task force, pointed out that the vaccines currently in use are early generation emergency use authorisation vaccines. "In a conventional vaccine timetable, it would take years to develop a vaccine but these are early generation fast track vaccines and we need more data and strong pharmacovigilance to get a better insight on their effectiveness. Better and more effective vaccines would eventually be developed that would reduce the rate of breakthrough infections," he said.

According to CDC data that was released this week, over 87 million Americans were fully vaccinated and 7,157 cases of Covid-19 were reported among them. (See table)

The CDC said breakthrough infections are expected and not happening at an alarming rate. Experts said it is possible that mutated variants of coronavirus infection may be finding ways of escaping the vaccine.

According to a new US study reported on April 21 in the New England Journal of Medicine, the risk of contracting Covid-19 after having two doses of vaccine remains low. In their study, two rare cases of Covid-19 from 417 fully vaccinated people were reported. The participants had been vaccinated with Pfizer or Moderna jabs. The two who tested positive, both women, had mild symptoms and recovered quickly.

"These patients got vaccinated, had great immune responses, and nonetheless broke through with a clinical infection," Robert B Darnell, investigator at Howard Hughes Medical Institute Laboratory of Molecular Neuro-oncology, said in a news update from Rockefeller University.

"Given the scope of the pandemic, there's a huge amount of virus in the world right now, meaning a huge opportunity for mutations to develop and spread. That is going to be a challenge for the developers of vaccines over the next months and years," he said.

Pakistan deploys Army to help enforce COVID-19 SOPs

ISLAMABAD: Pakistan on Monday deployed army across the country to help civil institutions in implementing the standard operating procedures against the coronavirus, amid the surge in the COVID-19 cases. spokesman Major Army

General Babar Iftikhar said that enhanced deployment was done in 16 major cities with "very high positivity rate". include

These cities Peshawar, Mardan, Nowshera, Swabi (in Charsadda and Khyber Pakhtunkhwa prov-Rawalpindi, Lahore, ince),

Faisalabad, Multan, Bahawalpur, Gujranwala (Punjab), Karachi and Hyderabad (Sindh), Quetta (Balochistan), Muzaffarabad (Pakistan-occupied Kashmir) and Islamabad.

"The primary purpose of deployment of army troops is to help civil institutions and law enforcement agencies," he said while addressing a press conference in Rawalpindi.

He said that the positivity ratio is more than 5 per cent in 51 cities and soldiers have been sent to those cities also to help the civil administration implement the official guidelines. Maj Gen Iftikhar said army

teams would be led by brigadiers at the administration division level and by lieutenant colonels at the district level. "In this testing time, Pakistan Army will use all its capabilities

to take every possible step for the protection of citizens and their lives. [We] will go to every corner of Pakistan to ensure the protection of citizens," he said. Talking about the challenges of COVID-19, he said that the third wave was more dangerous and fatal and the death rate was

increasing, putting the healthcare infrastructure under stress. He said that 75 per cent of Pakistan''s oxygen production

was dedicated to the healthcare sector currently but it would be enhanced if required by reducing the share of industry.

"The monthly average of corona deaths has been the highest in April. The worldwide fatality rate is 2.12 per cent while the fatality rate in Pakistan has risen over the world fatality rate for the first time during this pandemic to 2.16 per cent," he said. Earlier, interior ministry on

Sunday issued a set of notifications to deploy the army after Prime Minister Imran Khan said the armed forces would be called to implement the coronavirus related gudelines.

The army deployment comes as Pakistan's coronavirus tally crossed 800,000 on Monday after 4,825 new cases were detected, while another 70 people succumbed to COVID-19, taking the number of deaths to 17,187, according to the official data.

The Ministry of National Health Services said 4,862 patients were in a critical condition and the number of active patients was 89,219.

Pakistan is scrambling to control the spread of the virus by imposing smart lockdowns and increasing vaccination. Pakistan has imposed smart lockdowns and ramped up vaccination programmes.

India sinks deeper into COVID mire, battle for Bengal goes on

KOLKATA: As the country sank deeper into its worst humanitarian crisis triggered by the COVID-19 carnage, West Bengal Monday celebrated the 'festival of democracy' amid cacophonous cries for more votes for a poll three days away.

A robust 75 per cent of the 85 lakh electorate had cast their ballots by 5 pm for the 34 seats that went to poll in the 7th and penultimate phase of polling for the 294-member state assembly. Voters in 35 remaining constituencies will exercise their franchise on April 29. The voting happened on a day

when the Madras High Court poured scorn on the Election Commission, "singularly" blaming it for the second surge of the pandemic and calling it "the most irresponsible institution" whose officials may be booked for "murder".

But, as the country faced an unprecendented health crisis in living memory, the politically turbulent state not only saw men and women, young and old, throng the polling stations guarded by burly central forces personnel in camouglage, but also fusillade of firecounterfire between the BIP and the TMC.

Director Health Services Kashmir suggested the strict compliance of the SoPs and the ceiling on the number of people permitted to attend gatherings/functions set by the government for lowering the risk of spread of Coronavirus.

The Principal of GMC Srinagar informed the Lt Governor that Corona Curfew was effective in curbing the unnecessary movement of people and the same needs to be continued for some time in the future.

Similarly, Senior Doctors and HoDs from Jammu, Baramulla, Anantnag, Kathua, and Doda also put forth their suggestions for the effective controlling of the second wave of coronavirus. The suggestions included meticulous inoculation of all people, intensifying covid precautions and measures, following covid appropriate behaviour, effective policy of admissions through referrals from Sub hospitals and health centers to GMCs, and regular awareness among the people, besides morale-boosting of corona warriors.

The Principles of various Government Medical Colleges and Hospitals also apprised the Lt Governor regarding the daily admissions of Covid patients, oxygen consumption, and availability of beds in their respective hospitals.

Rajeev Rai Bhatnagar, Advisor to the Lt Governor; BVR Subrahmanyam, Chief Secretary; Atal Dulloo, Financial Commissioner, Health and Medical Education also attended the meeting.

SRINAGAR: Doctors Association Kashmir (DAK) Monday said people who have recovered from Covid-19 infection should also get vaccinated for the infection. In a statement, DAK Presi-

dent Dr Nisar ul Hassan said those who have contracted the disease should also get inoculated two weeks after their recovery.

"Earlier, individuals who tested positive for the virus required to wait for 3 months between recovery and vaccination. However, that has changed now." Under the new guide-lines, he said, Covid-19 pa-

tients only need to wait for 2 weeks to get the shot. He said people who re-

cover from Covid-19 are getting infected with the virus again. "We were under the impression that if a person gets infected with the virus, he/she will develop antibodies and will not get the disease again. "But, many people who recover from Covid-19 do not develop antibodies," he said adding "even those who mount adequate antibody response, their antibodies fade within a few months and they become susceptible again."

"Some have second bout of Covid-19 as soon as one month after their first infection and some people have been hospitalised and even died," he said, adding, "and, the new variants put the recovered patients at risk of reinfections.

The DAK president said that people who have recovered from Covid could get infected with a mutated strain of the virus.

Congregational Prayers In Tangmarg Village Prohibited

SRINAGAR: Amid rising covid-19 cases, authorities prohibited congregational prayers in mosques in a village in Tangmarg area of north Kashmir after it was reported that the residents do not follow the covid-19 SOPs

"In the larger interest of lives of General public of Village Ferozpora, it is hereby ordered that the congregational prayers in all mosques of the said village shall be strictly prohibited, for a period of one week in the first instance," reads an order issued by SDM.

It mentions that the District Magistrate Baramulla (Chairperson DDMA) on April 22 declared Village Ferozpora in Tehsil Tangmarg as Micro-containment zone for containment of Covid-19 disease.

"The mass sampling of the Village was carried out by Medical Block Tangmarg and it has been detected that 21% residents have tested positive for Covid-19 infections which reflects a sharp surge in the Covid positive cases," the order reads, adding, "It has been reported that the inhabitants of the village do not follow SOPs/guidelines during the indoor gatherings viz congregational prayers."

The SDM has underlined that any violation to order shall invite punitive action.

"The Tehsildar Tangmarg and SDPO Tangmarg shall implement the order in letter and spirit," the order added.

To Operate With 50 Percent Capacity Not Viable: Kashmir Transporters

Talking to reporters, the Hazratbal wing of Transporters said that from August 05, 2019, they have been continuously off the roads and no assistance was provided to them by the Government.

NEW DELHI: Anxiety pierced through IPL's bio-secure bubble on Monday with leading Indian offspinner Ravichandran Ashwin and some Australian players withdrawing from the league amid the escalating COVID-19 crisis in India even as the BCCI insisted that the glitzy league will go on.

The 34-year-old Ashwin, competing for Delhi Capitals, decided to take a break saying that his family is currently "putting up a fight against COVID-19" and he wants to support them. He hopes to return to the side "if things go in the right direction".

However, Andrew Tye (Rajasthan Royals) and the duo of Kane Richardson and Adam Zampa (both Royal Challengers Bangalore) withdrew as apprehension set in after a couple of weeks went by smoothly for the league being held in front of empty stands across six venues.

While Zampa and Richardson have not yet spoken about their "personal reasons" for leaving, Tye

wWhile leg-spinner Zampa was bought for Rs 1.5 crore, RCB spent Rs 4 crore to buy pacer Richardson at the players' auction.

Richardson featured in one match for RCB, returning figures of 1 for 29 in three overs against Rajasthan Royals in Mumbai, but Zampa couldn't make it to the playing XI this season.

The 34-year-old Tye had also not got a game with the Royals so far and his contract with the franchise was worth Rs one crore.

Hit Hard By Foreign Pull-**Outs, Royals Seek To Loan Players From Other Teams**

NEW DELHI: Rajasthan Royals have approached fellow IPL teams to loan players after the departure of their four foreign players due to various reasons that include injuries, bubble fatigue and COVID-19 fear.

Ben Stokes and Jofra Archer are out of the IPL due to injuries while Liam Livingstone had gone back home citing bubble fatigue. On Sunday, Andrew Tye left for Australia, citing fear due to surge of COVID-19 cases in India, making Royals the worst affected team from player pull-outs.

"The team is looking to loan

players and has written to other

franchisees but nothing is decided at this point," a source close the team management told PTI.

The IPL loan window started on Monday and will end with the conclusion of the league stage

Tye, who had not played a game this season, flew back home on Sunday fearing being locked out of his own country with India reporting record COVID-19 infections for the past few days.

IPL rules state that a player who have played less than two matches in the season can be loaned and cannot play against his home franchise.

Royals have two wins from five games and play their next game in Delhi on Thursday.

Ashwin Leaves IPL To Support Family In Fight Against COVID

CHENNAI: Senior Indian off-spinner Ravichandran Ashwin has decided to take a break from the ongoing IPL, saying his family is currently "putting up a fight against Covid" and he wants to support them.

The 34-year-old is competing for the Delhi Capitals this season and hopes to return to the side "if things go in the right direction". "I would be taking a break from

this years IPL from tomorrow. My family and extended family are putting up a fight against #CO-VID19 and I want to support them during these tough times," Ashwin posted on his Twitter page after DC's game against Sunrisers Hyderabad here on Sunday night.

"I expect to return to play if things go in the right direction. Thank you @DelhiCapitals," added the Chennai-based player.

It is learnt that a very close member of his family has tested positive for the virus.

His franchise promised full support to him in a twitter post of its own.

"Extending our full support to you in these difficult times, @ashwinravi99. Sending you and your family all the strength and prayers from all of us at Delhi Capitals," DC said.

Ashwin has become the first Indian player to pull out of the league because of a Covid situation in the family.

Given that the IPL is being held in a bio-bubble, Ashwin will have to be in quarantine for some days if he decides to come back and compete, which would also impact his availability going forward in the tournament.

In an earlier tweet, Ashwin had expressed concern about the pandemic ravaging the country right now.

"Heart breaking to see what's happening around my country! I am not in the healthcare fraternity, but my sincere gratitude to each of them. I would also like to make an earnest appeal to every Indian to exercise caution and stay safe," he had said.

Man City Beats Tottenham 1-0 To Win 4th Straight League Cup

LONDON: A rare goal from Aymeric Laporte produced a familiar outcome: Manchester City winning the League Cup. For the fourth successive season, Pep Guardiola's side triumphed in the final of the competition on Sunday with a 1-0 victory over Tottenham.

With Tottenham proving hard to find a way past despite City's domination, it needed Laporte to head in his second goal of the season in the 82nd minute from Kevin De Bruyne's free kick.

"We have to keep this rhythm, this way to win more titles," center-back Laporte said.

What was less familiar for the finalists was officially being allowed to play in front of supporters from both teams. That hasn't happened since March 2020, but pandemic restrictions were eased to allow a crowd of 7,773 inside Wembley to see the first piece of silverware of the season handed out.

"It was good for us to share it with our people," Guardiola said.

"There was some good noise. We did it for them. They represented the people at home."

There was also an unfamiliar sight on the touchline, with 29-year-old rookie coach Ryan Mason managing Tottenham following Jose Mourinho's firing on Monday. A change in manager couldn't end Tottenham's trophy drought since lifting this cup in 2008.

The pain in the dressing room was all-too-familiar for Mason, who was in the Tottenham side that lost the 2015 League Cup final to Chelsea before a head injury ended his career.

SCHOLAR OF REASON **MAULANA MUSTAFA HUSSAIN ANSARI**

n erudite scholar, Maulana Mustafa Hussain Ansari would always stress the Limportance of rational thought in removing cobwebs of ignorance and modernising Muslim society.

Born on March 21, 1945 in Srinagar, Maulana Mustafa Hussain Ansari went on to become one of the top religious scholars of Kashmir till date. One of the best orators, his religious insights helped many to understand the complexities of religion better. Unlike many of his contemporaries who rely heavily on arousing sentiments, Maulana Mustafa always made it a point to talk logic.

During sixty three years of his eventful life Maulana waged an unrelenting battle with the verbal and written word, which the history will record in golden letters, to dispel doubts from the minds of believers and to create a pious society. Known for his forceful and penetrating discourse, Maulana Mustafa has scores of specialist treatises to his credit, including the first ever Kashmiri commentary of the Holy Quran, and biographical works on Prophet Muhammad (pbuh) and Imam Hussain (AS). Maulana was always logical. He was a preacher, who never believed in playing with the sentiments of the Muslim ummah.

Having dedicated his life to scholarly pursuits, the Maulana was a highly sought-after figure in society at home and outside the country, and was often called in to defuse grave crises involving confrontations arising between sects due to misunderstandings.

By tackling "unthinkable" domains such as the problems associated with the rise of 'establishment clergy' within Muslim community of Kashmir, Maulana embarked on topics that have preoccupied Muslims for most of the past 1,400 years.

Maulana has about forty scholarly works to his credit, among them a commentary on the Holy Qur'an, both in Urdu (Minhaaj-ul-Qur'an) and in Kashmiri (Misbah-ul-Qur'an) the latter being unpublished except for the

first two chapters titled Kashaf-ul-Aneeq-fe-Sharh-e-Qanoon-al-Ameeq. The first-ever Kashmiri translation and commentary of the Nahj-ul-Balagha is another of his noted achievements. The Maulana has also penned down the biography of the Blessed Prophet, Pbuh, (Aftab-e-Nabuwat, his first work after his return from Iraq, and the life of Hazrat Imam Hussain, AS, (Qateel-e-Nainava) which was published after he passed away.

Maulana Mustafa was also a remarkable novelist and debuted three highly successful historical novels (Integaam, Qabeelah, and Saazish) based on events in the tumultuous course of Islam. Some of his well-know write ups include Aakhri Tabassum, Mujrim, Al Meezaan, Khayaban, Islam Mein Haqe-Talaq, Ameed-e-Madni Bajawab Kaleed Ludni, Mere Jigar Ka Lahu, Noor-se-Naar Tak and so on.

His final work, Rakht-e-Safar, which he wrote two years before he passed away, deals with a human-beings final journey. As if to indicate that his time was near, the Maulana had concluded his long tryst with the world of thought and letters with a treatise on the hereafter.

Throughout his lifetime, he was busy in shaping up the future of the modern youth and he never failed in his endeavours. The religious and tireless efforts in working for unity among the Muslims and addressing misunderstandings between various sects will always be remembered.

His forceful expression, better understanding of Islam, history and his logical approach were his main assets. He was a preacher belonging to a particular community but was not communal in approach and conduct. He was deeply entrenched in Qur'an and Sunnah and was well aware of the basics of Islam. His speeches were very impressive and interesting no matter which topic he was talking on.

The tireless, dynamic and knowledgeable Maulana will always be remembered with moist eyes throughout our lives.
