MeT Forecasts Erratic Weather Till Friday


SRINAGAR: The Meteorological department has predicted erratic weather conditions across Jammu and Kashmir till next week, even as most parts of the Valley received light rainfall on Friday

"Erratic weather conditions would continue till next Friday. The intermittent light rainfall as per the forecast would occur in the afternoon like today," Deputy Director of Meteorological department (MeT), Mukhtar Ahmad said.

A meteorological department official said Friday that Srinagar recorded a low of 11.4 degree Celsius against 11.6 degree Celsius on the previous night. The temperature was 2.1 degree Celsius above normal for this time of the season in the summer capital of J&K, he said.

Qazigund recorded a low of 8.2 degree Celsius against previous night's 8.6 degree Celsius and it was above normal by 0.4 degree Celsius in the gateway town of Kashmir, the official said.

Mercury settled at 4.2 degree Celsius against 5.7 degree Celsius on the previous night in Pahalgam. The temperature was below normal by 0.2 degree Celsius during this time of the season in the famous tourist resort in South

Coronavirus Tightens Grip On J&K

Cases Hit Record High, 3532 **Test Positive, 30 More Die**

SRINAGAR: Coronavirus cases continue to show no sign of decline as Jammu and Kashmir reported on Friday the biggest ever single day spike of 3532 fresh cases even as the deadly infection claimed the lives of 30 more people across the Union Territory during the last 24 hours.

While 2360 new cases

were reported from Kashmir Valley, 1172 were detected in Jammu division thus taking the total number of people infected by the virus since last year in J&K to 176083. The active case tally soared to 28359-10660 Jammu

and 17699 Kashmir Valley.

Kashmiri Teacher's Blood Campaign Comes In Handy In Pandemic

s siren-blaring ambulances are declaring a deafening health Lemergency in Kashmir, Sajad Hussain is marshalling his troupe to avert the blood crisis in the valley grappling with the contagion groundswell

His crucial initiative is coming at a time when major health centres have once again become Covid- designed hospitals – tackling a warlike situa-

tion created by pernicious pandemic. In his Magam home in central Kashmir's Budgam district, Hussain's cell phone is buzzing with distressing 'blood' calls. He answers with an assuring tone—knowing well that his battery of 'blood brothers' in Budgam is just a phone call away to handle



the crisis.

As someone who has witnessed a lot of bloodshed during his lifetime, Hussain knows how an ounce of blood can save someone's life.

But since the current circumstances are once again challenging noncovid healthcare operations in the valley, Hussain is focusing on supplying the vital fluid with the help of his

Before becoming Kashmir's fullfledged blood campaigner, Hussain himself was an active donor. He hanged his boots 20 years ago to start Imam Sajad Blood Donors Group tackling the emergency situations in "I'm into blood donation from the

last 30 years now," Hussain says with his modest gaze. "I donate blood to please Almighty

and not for any fame. I've donated blood irrespective of the caste, class, religion, and race. I've saved eighty one lives with my individual donations.'

The blood drive started in 1990 when Hussain's homeland had become a raging conflict theatre. As the low-scale warfare left many bleeding, Kashmir hospitals at once felt the need of blood.

It was then college-goer Hussain decided to donate his blood for his bleeding brethren.

"In 1990, I first donated my blood to a child in critical condition," Hussain recalls his life-changing moment. "He needed O-Positive blood. And since it matched with my blood group, I rushed to the hospital swiftly.'

Once done with donation, Hussain went to see the child in his ward.

"I saw happiness on his mother's face and for the first time I felt peace inside me," emotional Hussian recalls.

The moment he started walking out of that ward, the child's mother stopped him and put something in his pocket.


"I resisted, but she was unrelent-

"I checked and it was a five rupee coin. I realized then, that if she had got all the wealth in the world she would have happily • More On P10



Alephia 2053 **Animated Thriller Strikes A Chord In Arab World**

lephia 2053, an Arabic-language animated feature set in a bleak future, has struck a chord in a region all too familiar with autocratic rule and bold, bloody resistance.

Released on YouTube on March 21, 10 years after the Arab Spring uprisings, the Lebanese-made 60-minute thriller has already garnered more than eight million views. It is "proof that the movie reflects people's thoughts", says Rabih Sweidan, the film's Lebanese creator and executive producer. "Everyone sees it from their perspective and they see themselves and their communities in it," Sweidan added.

The storyline, set in 2053 in the fictional Arab state of Alephia, follows a group of undercover agents plotting to take down hereditary ruler Alaa Ibn Ismail and his oppressive regime, described as the most tyrannical in

Through a meticulous operation led by operatives who have infiltrated top government

ranks, the "resistance" succeeds in toppling the dictator in a coup and ending a century of despotic rule.

They are buoyed by crowds taking to the streets chanting the now-famous Arab Spring refrain - "the people demand the fall of the regime" – in the face of heavily armed security forces who respond with live fire.

The movie closes with a familiar scene: Fists thrown into the air as a euphoric crowd pulls down the statue of the fallen leader with

Sweidan says Alephia 2053, with its uncannily familiar-looking dictator figure, is "a fictional movie but it is based on reality, it is a description of social reality" It is not inspired by any single Arab coun-

try but depicts conditions familiar to many across the world, he says. "The world has become a small village, where

the situation is the same in more than one place," Sweidan said. "Alephia could be the 23rd country in the Arab League", which has 22 members

Brighter future

Though the movie is highly reminiscent of the 2011 uprisings, Sweidan says it is an attempt to break away from what he calls an obsession with the past.

"There is always a tendency in the Arab world to imagine what might have happened in the past, but there is no theatrical or cinematic work that imagines what the Arab world will be like in the future," says Sweidan. "The idea for the film came from a question: What will the Arab world look like in 20 or 30 years?'

According to Sweidan's vision, the future holds more promise.

The film tries to express this through colour grading: the closing scenes incorporate a livelier gradient than the dim and dusty scheme that dominates the first chunk of the film, says Sweidan.

"Things can't always remain dark," he adds. "What this film wants to imagine is a future that's not as bad as the past or the present."

Like bees, wasps 'valuable' for ecosystems, human health

Wasps deserve to be just as highly valued as other insects, like bees, due to their roles as predators, pollinators, and more, according to a new review paper led by UCL and University of East Anglia researchers.

The study, published in Biological Reviews, compiles evidence from over 500 academic papers to review how roughly 33,000 species of stinging (aculeate) wasps contribute to their ecosystems, and how this can benefit the economy, human health, and society.

Lead author Professor Seirian Sumner (UCL Centre for Biodiversity & Environment Research, UCL Biosciences) said: "Wasps are one of those insects we love to hate -- and yet bees, which also sting, are prized for pollinating our crops and making honey. In a previous study, we found that the hatred of wasps is largely due to widespread ignorance about the role of wasps in ecosystems, and how they can be beneficial to humans

"Wasps are understudied relative to other insects like bees, so we are only now starting to properly understand the value and importance of their ecosystem services. Here, we have reviewed the best evidence there is, and found that wasps could be just as valuable as other beloved insects like bees, if only we gave them more of a chance." Wasps are top predators of other insects. Predation by insects -- as biocontrol to protect crops -- is worth at least \$416 billion per year worldwide. Yet, this figure almost completely overlooks the contributions of hunting wasp predation. The review highlights how wasps' role as predators makes them valuable for agriculture. Wasps regulate populations of arthropods, like aphids and caterpillars that damage crops. Solitary wasp species tend to be specialists, which may be suited to managing a specific pest, while social wasps are generalist predators, and may be especially useful as a local source of control for a range of crop-eating pests.

The researchers say that wasps could be used as sustainable forms of pest control in developing countries, especially tropical ones, where farmers could bring in populations of a local wasp species with minimal risk to the natural environment.

Professor Sumner and colleagues recently published a study finding that common wasp species are effective predators that can manage pests on two high-value crops, maize and sugarcane,

in Brazil.

The review also highlights the pollination services provided by wasps. Pollination by insects is vital for agriculture, and its economic importance has been valued at greater than \$250 billion per year worldwide.

The researchers found evidence of wasps visiting 960 plant species. This included 164 species that are completely dependent on wasps for pollination, such as some orchid species that have evolved adaptations to attract the wasps they rely on, such as an appearance that mimics the back end of a female wasp.

Many wasps are also generalist pollinators that visit a wide variety of plants, so the researchers say they could serve as 'backup pollinators' if a plant loses its local primary pollinator.

The review also describes other uses for wasps such as wasp-derived medications, as their venom and saliva have



antibiotic properties, while yellowjacket wasp venom has shown promise in treating cancer.

Wasps may even be a valuable food source, as their larvae are already harvested in some tropical countries for food.

Co-author Dr Alessandro Cini (UCL Centre for Biodiversity & Environment Research, UCL Bioscience and University of Florence) said: "The value of wasps in supporting our crops remains poorly understood; we hope that by rehabilitating their bad reputation, we can collectively get the most value out of these fascinating creatures." The paper's first author, Ryan Brock (University of East Anglia) said: "Alongside other insects, many wasp species are declining from factors such as climate change and habitat loss. As such, there is an urgent need to address their conservation and ensure that habitats continue to benefit from the far-reaching ecosystem services that wasps provide." The research was supported by the Natural Environment Research Council and a Marie Curie fellowship from the European Commission.

SOLVING KASHMIR KEY BETTER INDO-PAK TIES: MUSHARRAF

ISLAMABAD - Briefing top army commanders on the outcome of his India visit, Pakistan President Pervez Musharraf has said settlement of the Kashmir issue is the key to betterment of bilateral ties and the confidence building measures (CBMs) have to move in tandem with the progress on the dispute resolution.

"The key to Pak-India relations is die resolution of Kashmir dispute 6m- which Confidence Building Measures and dispute resolution will have to move at tandem," he told the officers at the 58th Formation Commanders conference here last night.

The Formation is regarded as the most influential body in the current power structure in Pakistan. The body meets once in a year to discuss a host of issues relating to policy as well as

defence preparedness and promotions at top level. Musharraf also elaborated on his assertions in New Delhi that the "era of conflict management is over and conflict resolution has to be done with sincerity," according to an official release. He dwelt at .length on the prevailing environment encompassing international, regional and national issues, their impact on Pakistan, which preferred both challenges and opportunities and said the time has come for conflict resolution. These issues offer both challenges and opportunities to us," it quoted him as saying. With pragmatic policies and careful utilisation of the nation's potential, Pakistan could play an important role and become an important geo-strategic location. Riyadh cut its diplomatic ties with Tehran in early 2016 after the kingdom's execution of senior Saudi Shia cleric Sheikh Nimr al-Nimr prompted angry protests in front of Saudi diplomatic missions in Iran.

44 Crushed To Death In **Israel Pilgrimage Stampede**

MERON: A massive stampede at a densely packed Jewish pilgrimage site killed at least 44 people in northern Israel on Friday, blackening the country's largest Covid-era gathering.

The nighttime disaster struck in Meron at the site of the reputed tomb of Rabbi Shimon Bar Yochai, a second-century Talmudic sage, where mainly ultra-Orthodox Jews flock to mark the Lag BaOmer holiday.

Closed last year due to coronavirus restrictions, this year's pilgrimage was expected to be a celebratory event in a nation that has largely re-opened thanks to a evacuate the wounded. successful vaccination effort.

It had been "a tragic night," Shimon Lavi, northern Israel's police commander, told AFP, adding his officers did all they could to save lives, helping to ferry the injured to hospital.

The pilgrimage was the largest public gathering since the pandemic broke out, with reports of three times more participants, including children, than authorised by police.

Initial reports indicated the carnage began when a section of stadium seating collapsed but rescue workers later linked the casualties to a stampede.

A spokesman for the Magen David Adom, Israel's rescue service, told AFP "there were 38 dead at the scene but there were more at the hospital."

A source at the northern Ziv hospital, one of several receiving casualties, told AFP it had recorded at least six deaths, taking the overall toll to 44.

The rescue service said it was treating 150 injured, six of them in serious condition.

"They crushed each other" "It was chaos as people tried

to save themselves but they crushed each other," Dov Maisel of the United Hatzala rescue services told army radio.

Prime Minister Benjamin Netan-



vahu called it a "heavy disaster" and said he was praying for the injured.

"The whole of Israel is praying for the recovery of the survivors, said opposition leader Yair Lapid.

The army and emergency services deployed helicopters to

Scenes from Meron hours after the accident showed an ultra-Orthodox Jewish crowd in distress, with debris scattered across the ground.

Some survivors had lit candles for the victims while other prayed nearby. Israeli media published an image of a row of bodies covered in plastic bags on the ground.

'Terrible disaster'

"This is one of the worst tragedies that I have ever experienced," said Lazar Hyman of the United Hatzalah volunteer rescue service, who was at the scene.

"I have not seen anything like this since I entered into the field of emergency medicine," he added.

Yehuda Gottleib, one of the first responders from United Hatzalah, said he saw "dozens of people fall on top of one another during the collapse".

"A large number of them were crushed and lost consciousness.'

Israel has fully vaccinated more than half of its 9.3 million population against the coronavirus, but restrictions on massive public gatherings remain in place to stem the spread of the virus.

Authorities had authorised 10.000 people to gather at the site of the tomb but organisers said more than 650 buses had been chartered from across Israel, bringing 30,000 pilgrims to Meron.

NATO Says Afghanistan Withdrawal Has Begun

BRUSSELS, BELGIUM: NATO has started the withdrawal of its mission from Afghanistan following a decision by President Joe Biden to bring US forces home, an alliance official said Thursday.

The NATO official said the safety of the alliance's troops "will be a top priority every step of the way, and we are taking all necessary measures to keep our personnel from harm".



Under and in these extraordinary times, it is imperative and incumbent upon society to rise to the occasion.

What does this mean?

Parsed and pared to essence, it means attempting to feel the pain of others as one's own. By way of a digression here, it must be pointed out the Covid 19 and its mutant variants are totally and absolutely non-discriminatory: the rich, the poor, the healthy or the ailing ad so on are all vulnerable to this blighted pandemic. But, of course, when, God willing, the gale of this pandemic will be over, there will be both survivors and victims. Under these conditions and scenario, at the risk of repetition, to underscore and reinforce the point, our society, instead of turning inward in a measure of a selfish focus on survival of the self must dig deep into its collective reservoirs of resilience and care for others, draw on empathy as the central redeeming focus and feature, with more vehemence, under conditions of the pandemic.

Broadly speaking and yet again, by way of a digression, we, as a society have, over time, gyrated to a crude, vulgar and warped form of capitalisma capitalism that would be unrecognizable in the lands where it originated. (This is not to suggest the author's absolute aversion to capitalism: in relative terms, and bound within a moral framework, capital and its abundance,



distributed mor or less equally (and with equity) to the extent it can be, capital can have a redemptory impact, in economic terms). This should neither be confused with socialism or with its economic extreme: conspicuous consumption- a bane and blight that our society has, over time, become afflicted with. The nature of conspicuous consumption in Kashmir like capitalism here flows from a social dynamic, more or less, where conspicuous consumption, serves to elevate prestige and pride(both false and meretricious) to its garish consumers.

Consider an illustrative example here. The typical Kashmiri , all other things held equal and other variables considered, focuses his life's energy to the duo of owning a palatial house and extravagant weddings(nowadays one or two motor vehicles are thrown in the mix). This obsession besides breeding moral corruption also becomes the

breeding ground of other toxic social evils. As a consequence, broadly society and its moral compass becomes the victim and the less privileged suffer. One social blight of this is zero sum selfishness that puts paid and gives short shrift to what was once a hall mark of our society: empathy.

But, the times we are going through, are extraordinary: these call for an extraordinary push by society to recover and reclaim this noble ideal of empathy, defined here in narrow terms as , 'the ability to feel others' pain as one's own'. This ideal is one that is also emphasized in vigorous by our religion.

In practice, what would empathy in Covid 2.0 times mean?

Among other things, because of the economic hardship that this bout of the pandemic will exact, especially on the vulnerable segments of society, empathy would mean curtailing not

just conspicuous consumption(which would be, in any case, difficult under the conditions), curtail our consumption- individually and collectivelythink of those who live by the day, who will lose livelihoods and whose savings will either take massive dip or vanish. It means reaching out to these victims of the pandemic, quietly, so that their dignity is maintained, and helping them and their children, to ward off economic and financial pain, effectively helping them survive. Many, it must be said, will be victims of this pandemic and many, out of shame and embarrassment will not ask for financial help. But, our collective and individual empathy must factor this into our consideration and reach out, preferably quietly but if need be a collective response might even be warranted.

This is not charity. It is a duty of compassion that we owe not to the victims of the pandemic but to ourselves. We have empathy in us. It has been somewhat obscured by a degree of selfishness and self centredness. The very nature of Covid 2.0 calls for rediscovering our empathetic nature, and rise to the occasion. It is said that adversity is a tough task master. It can either bring the best or the worst in societies and individuals. We must also remember that, 'this too shall pass' but from the ashes of this adversity, we, as a society, must rise to the occasion and help those who need it.

n case India's ruling Bharatiya Janata Party wins the all-important West Bengal assembly election on May 2, it may try to suggest the victory is an endorsement of its handling of the devastating second wave of Covid.

In case the BJP loses Bengal, the party's critics might suggest the result is a reflection of public anger about the BJP's poor handling of the Covid second wave. Some from within the BJP might suggest this as well, so as to deflect attention away from the real causes of the defeat.

The West Bengal assembly election was held in 8 phases from 27 to March to 29 April. The incumbent Trinamool Congress' strong areas, such as Muslim-dominated regions, polled in the latter phases.

By the time Covid second wave story overwhelmed the Bengal election story in the media and in public consciousness, the BJP's strongest areas had already polled. It was after phase 5 that Prime Minister Modi cancelled his rallies.

No matter how many seats the BJP wins in Bengal, they will have no relation whatsoever to the first or second wave of Covid.

The hub of Kolkata

Most seats in the city of Kolkata also polled in these last three phases. Kolkata is also where Covid cases, the fear and panic of the second wave, is the highest.

Like elsewhere, it is the large metropolitan city that's the hub of Covid. Again, Kolkata is a TMC stronghold and if the BJP does poorly here it won't be because of Covid. It was anyway going to do poorly here.

Outside Kolkata, in the predominantly rural districts, Covid has, even now, not become an overwhelming story to cause the sort of resentment that Kolkata might be feeling about Modi's poor handling

BJP should hope it loses Bengal

In the never-ending saga of Indian elections, up next is Uttar Pradesh in February 2022. That's just 8 months away. It's closer than it looks. UP is the second most important election in In-

UP is the second most important election in India after the general election. This is the state from where Narendra Modi is elected into Parliament.

Until two months ago, it seemed the BJP could not lose UP. The tsunami of Covid second wave has opened Uttar Pradesh up for a real political contestation. The BJP's anxiety about UP is already showing, with chief minister Yogi Adityanath threatening to seize the property of those who spread "false rumours" about oxygen shortage in the state.

The real test of how the BJP performs politically after Covid second wave will be UP, not Bengal.

Yogi versus Akhilesh

Over the next few months, UP will be the primary battlefield. All eyes will now be on Yogi Adityanath and his chief opponent, Akhilesh Yadav of the Samaiwadi Party.

In UP now, the BJP will drown out anti-incumbency noises with high-pitched propaganda, some intimidation and lots of resources. It will be fascinating to watch how they defend their record on Covid second wave, which is being felt too widely to be covered up with mere data fudging.

It will be a do-or-die election for both Yogi Adityanath and Akhilesh Yadav. If Yogi Adityanath can ride this storm, he will emerge larger than life. And if Akhilesh Yadav can't win even after this, he will be history

Living through the merciless second wave of covid-19 in New Delhi

I was out reporting in January and February, driving through towns in central India. No one — and I mean no one, including police officers — was wearing a mask. It was like the country had said to itself. while the second wave was looming: Don't worry, we got this



EW DELHI — Crematories are so full of bodies, it's as if a war just happened. Fires burn around the clock. Many places are holding mass cremations, dozens at a time, and at night, in certain areas of New Delhi, the sky glows

Sickness and death are everywhere.

Dozens of houses in my neighborhood have

One of my colleagues is sick.

One of my son's teachers is sick.

The neighbor two doors down, to the right of

Two doors to the left: sick.

"I have no idea how I got it," said a good friend who is now in the hospital. "You catch just a whiff of this...." and then his voice trailed off, too sick

He barely got a bed. And the medicine his doctors say he needs is nowhere to be found in India. I'm sitting in my apartment waiting to catch the disease. That's what it feels like right now in New Delhi with the world's worst coronavirus

crisis advancing around us. It is out there, I am in here, and I feel like it's only a matter of time before

India is now recording more infections per day as many as 350,000 — than any other country has since the pandemic began, and that's just the official number, which most experts think is a vast underestimation.

New Delhi, India's sprawling capital of 20 million, is suffering a calamitous surge. A few days ago, the positivity rate hit a staggering 36 percent — meaning more than one out of three people tested were infected. A month ago, it was less than 3

How to Help IndiaDonors are giving money for meals, medical expenses, P.P.E. and oxygen tanks, among other essential supplies, amid the Covid

The infections have spread so fast that hospitals have been completely swamped. People are turned away by the thousands. Medicine is running out. So is lifesaving oxygen. The sick have been left stranded in interminable lines at hospital

gates or at home, literally gasping for air.

Although New Delhi is locked down, the disease is still rampaging. Doctors across this city and some of Delhi's top politicians are issuing desperate SOS calls to India's prime minister, Narendra Modi, on social media and on TV, begging for oxygen, medicine, help.

Experts had always warned that Covid-19 could wreak real havoc in India. This country is enormous — 1.4 billion people. And densely populated. And in many places, very poor.

What we're witnessing is so different from last year, during India's first wave. Then, it was the fear of the unknown. Now we know. We know the totality of the disease, the scale, the speed. We know the terrifying force of this second wave, hitting everyone at the same time.

What we had been fearing during last year's first wave, and which never really materialized, is now happening in front of our eyes: a breakdown, a collapse, a realization that so many people will die.

Ramadan – a feast for spirit and soul

In Islamic mysticism, Ramadan is more than just a period of prescribed abstinence, signifying an opportunity for inner contemplation. Marian Brehmer explores the spiritual dimensions of the month of fasting against the background of Sufism

amadan is the month in which, with the communication between God and the Prophet, a new light and lifeline between Allah and mankind emerges. Anyone who is willing to receive a piece of it may benefit." In a calm voice, Muhyiddin Shakoor, a retired American professor of psychology who lives between Turkey and the U.S., talks about the blessings of the fasting month. He pauses frequently while the consecutive translator beside him searches for the best Turkish equivalents for his words.

The audience consists of several hundred viewers who, at half past nine, have just begun digesting their iftar. The desire for spiritual uplifting is strong during the second Ramadan of the pandemic, which the Turkish government heralded with curfews and bans on public gatherings. Using the live TV feature of the social platform Instagram, thousands of Turkish spiritual seekers have been appeasing their hunger for soul food every evening since the beginning of the fasting month; a function that otherwise would be fulfilled by communal fast-breaking or gatherings at dergahs and Sufi centres.

On Instagram, spiritual masters, academics and explorers of mysticism speak on topics such as spiritual fasting, self-improvement and contemporary Koranic interpretation. The format is based on a particular culture of conversation that springs from Sufism - sohbet. The word sohbet is derived from the Arabic suhba (companionship) and describes the practice of inspired discourse within the circle of a spiritual community. Sohbet combines group communication and knowledge sharing with an atmosphere of unconditional love, which the Sufis seek to cultivate in their hearts

COVID-19 has taken this conversational culture, which has characterised Anatolian Sufism for centuries, into the virtual realm. The Instagram account of Sufi Kitap – an Istanbul publishing house that has been releasing classical Sufi literature and works by contemporary teachers from the tradition for 16 years - possesses a following of nearly thirty thousand users. Sufi Kitap hosts sohbets several times a week, including the conversation with Shakoor, who has brought out two diaries about his spiritual path with the publisher.

Purification of mind and soul

Anyone who has ever fasted - even if it was only to lose weight - has experienced the decelerating effect of this practice. Not only does our digestive system shut down, but also the ever-spinning carousel

of thoughts in our heads. But while the modern wellness industry with its detox recipes completely lacks any spiritual framework, Ramadan fasting is primarily intended as a purification of mind and soul.

After returning from Syria, the famous Sufi saint Rumi was sent into retreat by his mentor Borhanuddin Tirmidhi. Instead of one week, as instructed by his teacher, Rumi is said to have spent forty days fasting in prayer and meditation. The retreat prepared the young Jalal ad-Din Mohammad (at that time he was not yet called "Rumi"), who had studied Islamic jurisprudence and Koranic exegesis at a renowned academy in Aleppo, for the mystical path. Book learning alone, the Sufis emphasise, is not only insufficient on the spiritual path, it can sometimes even prove an obstacle for those seeking true knowledge - knowledge which is the fruit of direct mysti-

cal experience and brings with it a certainty of heart. Decades later, Rumi, now at the height of his human potential, spoke in the Masnavi: "Man's original food is the Light of God: animal food is improper for him / But, in consequence of disease, his mind has fallen into this, that day and night he should eat of this water and clay."

Now, Rumi is far from the asceticism of the world-weary and frugal exponents of early Sufism, who devoted their lives to strenuous religious exercises. After all, joy, hope, and divine ecstasy predominate in his verse, especially in the love-intoxicated ghazals of the Divan-e Shams, which tell of Rumi's metaphysical experiences.

And yet Rumi recommends abstaining from physical food more clearly than any other spiritual practice. Fasting, as the U.S. scholar of Sufism William Chittick writes in his book The Vision of Islam, is the most personal and spiritual of the five pillars

of Islam, a test of people's sincerity in their religion. Many Muslims around the world, who are currently abstaining from food and drink from dawn until sunset, see their abstinence as more than just a prescribed test of patience. They take Ramadan as a precious opportunity to turn their senses, that are otherwise outwardly directed, inward and - in Rumi's words - make them receptive to God's light.

The "fasting of the mind", which Al-Ghazali calls the "fast of the elect", requires close observation of one's thoughts and patterns of behaviour. The Sufis speak of fasting with the eyes, ears, tongue, and hands: they turn their eyes and ears away from anything that weakens their remembrance of God, refrain from gossip and negative words, avoid quarrels, and use their hands to serve their fellow hu-

Honing one's awareness of God The goal of this month-long abstention is not to humiliate the body, but to hone one's awareness of God by turning the focus inwards. In fact, the word "Ramadan" derives from the Arabic root r-md, which describes the heat of the blazing sun. The "heat" of Ramadan, according to the etymological interpretation, causes the "immature" individual to boil from within - a verb Rumi likes to use for man's spiritual development process.

In addition to cultivating patience, contentment and empathy for those suffering from hunger, Ramadan is an invitation to leave one's ego behind. In Islamic mysticism, the ego is sometimes compared to an insatiable animal. Withdrawing physical food deprives the "commanding soul", the nafs al-'ammara, of some of its fuel and puts a stop to its ploys. In Sufi psychology, the nafs is regarded as an idol that we place next to God on a daily basis. As idol worshippers in the clutches of our indwelling tyrant, we live in a state of separation from God, when in fact, as the Koran asserts, he is closer to us than our own jugular vein. So close that the sole obstacle can only be ourselves.

Fasting interrupts this habitual rut, it pulls us out of the "sleep of ignorance" (kh b-e gheflat in Persian). While the thoughts of the fasting person keep wandering to food, during this time of contemplation the unrecognised ego patterns - our "shadow", as Carl Gustav Jung called it – begin to surface more clearly. Ramadan, when consciously experienced, is an invitation to introspection; it helps to discover and correct negative thought structures and selfish tendencies. The Sufis call this muhasaba, a form of self-accounting.

Fasting lowers blood pressure by reshaping gut microbiota, here's how

or the first time researchers demonstrate that intermittent fasting can reduce hypertension by reshaping the gut microbiota in an animal model. Nearly half of adults in the United States have hypertension, a condition that raises the risk for heart disease and stroke, which are leading causes of death in the U.S.

At Baylor College of Medicine, Dr David J. Durgan and his colleagues are dedicated to better understand hypertension, in particular the emerging evidence suggesting that disruption of the gut microbiota, known as gut dysbiosis, can have adverse effects on blood pressure.

"Previous studies from our lab have shown that the composition of the gut microbiota in animal models of hypertension, such as the SHRSP (spontaneously hypertensive stroke-prone rat) model, is different from that in animals with normal blood pressure," said Durgan, assistant professor of anesthesiology at Baylor.

The researchers also have shown that transplanting dysbiotic gut microbiota from a hypertensive animal into a normotensive (having a healthy blood pressure) one results in the recipient developing high blood pressure.

"This result told us that gut dysbiosis is not just a consequence of hypertension, but is

actually involved in causing it," Durgan said. "This groundwork led to the current study in which we proposed to answer two

questions. First, can we manipulate the dysbiotic microbiota to either prevent or relieve hypertension? Second, how are the gut microbes influencing the animal's blood pressure?" added Durgan.

Can manipulating the gut microbiota regulate blood pressure?

To answer the first question, Durgan and his colleagues drew on previous research showing that fasting was both one of the major drivers of the composition of the gut microbiota and a promoter of beneficial cardiovascular effects. These studies, however, had not provided evidence connecting the microbiota and blood pressure.

Working with the SHRSP model of spontaneous hypertension and normal rats, the researchers set up two groups. One group had SHRSP and normal rats that were fed every other day, while the other group, called control, had SHRSP and normal rats with unrestricted food availability.

Nine weeks after the experiment began, the researchers observed that, as expected, the rats in the SHRSP control had higher blood pressure when compared to the normal control rats. Interestingly, in the group that fasted every other day, the SHRSP rats had significantly reduced blood pressure when compared with the SHRSP rats that

"Next, we investigated whether the microbiota was involved in the reduction of blood pressure we observed in the SHRSP

rats that had fasted," Durgan said. The researchers transplanted the mi-



crobiota of the rats that had either fasted or fed without restrictions into germ-free rats, which have no microbiota of their own.

Durgan and his colleagues were excited to see that the germ-free rats that received the microbiota of normally fed SHRSP rats had higher blood pressure than the germfree rats receiving microbiota from normal control rats, just like their corresponding microbiota donors.

"It was particularly interesting to see that the germ-free rats that received microbiota from the fasting SHRSP rats had significantly lowered the blood pressure than the rats that had received microbiota from

SHRSP control rats," Durgan said. "These results demonstrated that the alterations to the microbiota induced by fasting were sufficient to mediate the blood pressure-lowering effect of intermitting fasting."

How the microbiota regulates blood pressure

The team proceeded to investigate the second question of their project. How does the gut microbiota regulate blood pressure?

'We applied whole-genome shotgun sequence analysis of the microbiota as well as untargeted metabolomics analysis of plasma and gastrointestinal luminal content. Among the changes we observed, alterations in products of bile acid metabolism stood out as potential mediators of blood pressure regulation," Durgan said.

The team discovered that the SHRSP hvpertensive animals that were fed normally had lower bile acids in circulation than normotensive animals. On the other hand, SHRSP animals that followed an intermittent feeding schedule had more bile acids in the circulation.

"Supporting this finding, we found that supplementing animals with cholic acid, a primary bile acid, also significantly reduced blood pressure in the SHRSP model of hypertension," Durgan said.

Taken together, the study shows for the first time that intermittent fasting can be beneficial in terms of reducing hypertension by reshaping the composition of gut microbiota in an animal model. The work also provides evidence that gut dysbiosis contributes to hypertension by altering bile acid signaling

"This study is important to understand that fasting can have its effects on the host through microbiota manipulation," Durgan said.

'This is an attractive idea because it can potentially have clinical applications. Many of the bacteria in the gut microbiota are involved in the production of compounds that have been shown to have beneficial effects as they make it into the circulation and contribute to the regulation of the host's physiology. Fasting schedules could one day help regulate the activity of gut microbial populations to naturally provide health benefits," added Durgan.

Researchers find avocado may offer route to leukemia treatment

new University of Guelph study suggests that a compound in avocados may ultimately offer a route to better leukaemia treatment. The compound targets an enzyme that scientists have identified for the first time as being critical to cancer cell growth, said Dr Paul Spagnuolo, Department of Food Science.

Published recently in the journal Blood, the study focused on acute myeloid leukaemia (AML), which is the most devastating form of leukaemia. Most cases occur in people over age 65, and fewer than 10 per cent of patients survive five years after diagnosis.

Leukaemia cells have higher amounts of an enzyme called VLCAD involved in their metabolism, said Spagnuolo. "The cell relies on that pathway to survive," he said, explaining that the compound is a likely candidate for drug therapy. "This is the first time VLCAD has been identified as a target in any cancer."

His team screened nutraceutical compounds among numerous compounds, looking for any substance that might inhibit the enzyme. "Lo and behold, the best one was derived from avocado," said Spagnuolo.

Expenditure

The Centre on Friday announced decision to provide an addi-Rs 15,000 crore to states as interest-free 50-year loan for spending on capital projects.

The Department of Expenditure has issued fresh guidelines in this regard for finanan official statement released by the Ministry of Finance.

Capital expenditure creates employment, especially for the poor and unskilled, has a high multiplier effect, enhances the future productive capacity of the economy, and results in a higher rate of economic growth.

Thus despite adverse financial position of the Central government, it was decided last year to launch a scheme for special assistance to states for capital expenditure.

Under the scheme, financial assistance is provided to state governments in the form of 50-year interest free loan. An amount not exceeding Rs 12,000 crore was earmarked for 2020-21 and a sum of Rs 11,830.29 crore was released.

This helped to sustain state level capital expenditure in the pandemic year. "In view of positive response to the scheme and considering requests of state governments, the government has decided to continue the scheme in 2021-22.

The first part of scheme is for North-east and hill states and an amount of Rs 2,600 tional amount of upto crore has been earmarked. Assam, Himachal Pradesh and Uttarakhand will get Rs 400 crore each while remaining states in this group have been allocated Rs 200 crore each.

The second part of scheme cial year 2021-22, according to is for all other states with an amount of Rs 7,400 crore. This amount has been allocated among states in proportion to their share of central taxes as per the award of 15th Finance Commission for 2021-22.

The third part of scheme is for providing incentives to states for monetisation or recycling of infrastructure assets and disinvestment of state public sector enterprises. An amount of Rs 5,000 crore is allocated. States will receive interest-free 50-year loans ranging from 33 to 100 per cent of the amount realised by them through assets monetisation, listing and disinvestment.

Monetisation of assets unlocks their value, eliminates their holding cost and enables scarce public funds to be deployed to new projects, thus speeding up the implementation of the National Infrastructure Pipeline.

Funds provided to the states will be used for new and ongoing capital projects. The funds can also be used for settling pending bills in ongoing capital projects. ANI



Jaishankar calls for full implementation of Moscow pact on Ladakh row during call with Chinese FM

NEW DELHI: Asserting that it was necessary to complete the process of disengagement in eastern Ladakh "at the earli-est", External Affairs Minister S Jaishankar on Friday conveyed to his Chinese counterpart Wang Yi the need for "full and sincere" implementation of an agreement on restoration of peace and tranquility in the

The issue figured during a phone conversation that was initiated by Wang to convey China"s sympathies to India on the COVID-19 situation.

Also on Friday, Chinese President Xi Jinping expressed his "sincere sympathies" in a message to Prime Minister Narendra Modi over the pandemic situation in India and offered to provide support and help to deal with the current surge of COVID-19 cases in the

After his conversation with Wang, Jaishankar tweeted "also discussed the issue of full and sincere implementation of the Moscow Agreement of complete disengagement at all friction points along the LAC and full restoration of peace and tranquility in Eastern Ladakh. Agreed to continue discussions in this respect.'

The Ministry of External Affairs said the two ministers discussed the outstanding issues related to disengagement from all friction points along the Line of Actual Control (LAC) in eastern Ladakh.

"The External Affairs Minister conveyed that while the process of disengagement had commenced earlier this year, it remained unfinished. He emphasized that it was necessary that this process be completed at the earliest," it said in a statement.

"Full restoration of peace and tranquility in the border areas would enable progress in the bilateral relationship. The two Ministers agreed to continue further dialogue at the official level on this matter," the MEA

India and China reached a five-point agreement to resolve the eastern Ladakh border row during talks between Jaishankar and Wang at a meeting in Moscow on September 10 on the sidelines of a Shanghai Cooperation Organisation (SCO)

The pact included measures like quick disengagement of troops, avoiding action that could escalate tensions, adherence to all agreements and protocols on border management and steps to restore peace along the LAC

India and China were locked in military standoff at multiple friction points in eastern Ladakh since early May last year. The two sides completed withdrawal of troops and weapons from the North and South banks of Pangong lake in February following a series of military and diplomatic talks.

Both the militaries are now engaged in talks to extend the disengagement process to the remaining friction points.

There was no visible forward movement in disengagement of troops in the remaining friction points as the Chinese side did not show flexibility in their approach on it at the 11th round of military talks with the Indian Army on April 9.

About his talks with Wang, the external affairs minister said he also highlighted the importance of supply chains and openness to air flights in these circumstances.

"Welcomed his assurances in that regard, as also more openness to Indian chartered flights. Discussed the international cooperation aspects of the public health response to this difficult situation," he said.

Canada To Start To Get **Pfizer Vaccines From** The US Next Week

Toronto: Canada will start getting Pfizer COVID-19 vaccines from the United States next week, a company spokesperson said Friday, in what will be the first time the U.S. has allowed that company's vaccine exported to Canada.

Despite Canada's tightly woven commercial ties with the US, it has been getting Pfizer's vaccines from Belgium until now because US authorities had kept supplies made in the U.S. for domestic use.

Prime Minister Justin Trudeau repeated Friday that starting next week, Canada will be receiving 2 million doses a week from Pfizer alone.

Vaccinations have ramped up in Canada in recent months. Every adult in Quebec will be eligible to make a vaccine appointment on May 14 and in Ontario, Canada's largest province, every adult can book an appointment starting May

Trade-dependent Canada previously lagged on vaccinating its population of 38 million because it lacks the facilities to manufacture the vaccine itself.

Trudeau's government bet on seven different vaccines manufactured elsewhere and secured advance purchase agreements enough to get 10 doses for each Canadian.. Regulators have approved the Pfizer, Moderna, AstraZeneca and Johnson & Johnson vaccines.

But initial supply chain difficulties forced Canada to extend the time between the first shot and the second by up to four months so that everyone can be protected faster with the primary dose. The hope is to get all adults at least one shot by the end of

HC asks Delhi govt to explain why COVID-19 testing has drastically gone down

New Delhi: The Delhi High Court Friday cited data to ask the AAP government to explain why COVID-19 testing has gone down drastically in the national capital.

A bench of justices Vipin Sanghi and Rekha Palli noted that while earlier the testing was around one lakh, now it has reduced to 70-80,000 per day.

"Your testing has gone down drastically...," the bench said and asked the Delhi government to explain it.

Advocate Ankur Mahindroo, representing a petitioner, said there was no headway in testing and the government can start with RAT at mohalla clinics and mobile clinics but the testing shall not be stalled.

He added that mobile vans for testing can be set up in containment zones and hospitals and such tests can be undertaken by the attendants of the patients.

The court asked the government to examine this aspect



and inform it on Monday.

Delhi government counsel Satyakam said these are suggestions where the government cannot have an adversarial view.

He said, "We are testing 70 to 80,000 per day... We were testing around one lakh before the curfew. We were going to market places...so those 30,000 were reduced.'

He added that this was not the final explanation and they have also written to all the labs asking them not to stop the testings. Meanwhile, the counsel for

one of the oxygen refillers, 'Seth Air' raised the issue of running out of funds and that the allocation of oxygen made to him was much higher that its capacity and he was unable to supply it, which the court said the Delhi government has to sort out.

Advocate Abhinav Tyagi said the refiller's payment was stuck and his outstanding bills were not being paid by the hospitals, to whom he supplies oxygen, and Delhi government and now he was not in a position to lift oxygen supplies from the supplier.

US delivers large shipments of medical supplies to India

NEW DELHI: Two American military aircraft on Friday brought to India large amounts of emergency medical supplies as part of the Joe Biden administration's support to the country's fight against a devastating wave of the coronavirus pandemic.

The first consignment of the supplies was brought to Delhi in a C-5M Super Galaxy, one of the largest strategic airlift aircraft of the US Air Force, while the second shipment was delivered by a C-17 Globemaster.

The medical supplies included 423 oxygen cylinders with regulators, 210 pulse oximeters, 17 large oxygen cylinders, 8,84,000 Abbott rapid diagnostic test kits and 84,000 N-95 face masks, officials said.

Hours after the shipments were delivered to India, External Affairs Minister S Jaishankar held a telephonic conversation with US Secretary of State Antony Blinken, focusing on India's requirements of medical supplies.

In a couple of tweets, Jaishankar said his discussions with Blinken focussed on Indian requirements to address the COVID-19 challenge

"more effectively".

"Reviewed the flow of equipment and material from the US. Highlighted the importance of strengthening oxygen supply, expanding vaccine production and increasing Remdesivir supply. Appreciated the forthcoming response of the US in this regard," he tweeted.

On his part, Blinken said he reiterated to Jaishankar continued US support for COVID-19 relief efforts in India.

"Spoke with DrSJaishankar to share my condolences and reiterate continued US support for COVID-19 relief efforts in India. The US government has stepped up to help our

partners, just as the American private sector, NGOs, and citizens have also helped to meet this challenge," he tweeted.

External Affairs Ministry Arindam Spokesperson Bagchi said healthcare partnership between India and the US can help effectively tackle the global pandemic.

"A strategic partnership of global significance! Our healthcare partnership can help effectively tackle the global pandemic. Deeply appreciate gift of 423 oxygen cylinders with regulators and other medical supplies from the USA," he said after landing of the first US aircraft.

As India battles a devastating second wave of coronavirus pandemic, countries around the world have announced sending medical supplies to help it tide over the situation.

Several other countries also delivered to India medical supplies that included 280 oxygen concentrators and 40 ventilators from the UK and 700 oxygen concentrators and 365 ventilators from Ireland. Romania too supplied 80 oxygen concentrators, 75 oxygen cylinders and 20 highflow humidify oxygen therapy devices, officials said.

Several other countries including France, Germany, Australia, Belgium, Luxembourg, Sweden, New Zealand and Kuwait are also sending assistance to India.

On Thursday, Russia delivered to India 20 tonnes of medical supplies mainly comprising oxygen concentrators, ventilators and medicines.

According to European Union officials, Italy, Finland and Austria are also sending medical supplies to India.

"We are working around the clock to channel EU assistance to India. It is in everyone's interest to support efforts at tackling the latest outbreak in the country," said EU's Commissioner for Crisis Management Janez Lenarci.

The IPL is currently on in separate bio-secure environments but BCCI will face perhaps its biggest test of managing a big-ticket ICC tournament in adverse circumstances.

"We are still hopeful that with five months left and significant population being vaccinated, we will be in a position to host World T20. Yes, one of the options could be curtailing the nine venues to a maximum four or five," a senior BCCI office bearer told PTI on Friday.

An ICC recce team was supposed to reach Delhi on April 26 to inspect the bio-secure arrangements for the IPL, keeping in mind the World T20 but the travel bans imposed on India led to the postponement of the trip.

NEW DELHI: Delhi Capitals (DC) captain Rishabh Pant said Prithvi Shaw is a talented player and he can do wonders if he is confident about himself.

"I was only telling him to play the normal game. In this kind of match we can afford to think of run rate. Only thing we talk with youngsters is to just enjoy cricket, do your best," Pant said.

Shaw hit 41-ball 82 and added 132 runs for the opening stand with Shikhar Dhawan (46 off 47) to help last season's finalist cantered to a seven-wicket win over Kolkata Knight Riders (KRR) in the 25th match of Indian Premier League (IPL) 2021 in Ahmedabad on Thursday.

Asked how he is managing the ups and downs as a captain, Pant also said that he is enjoying the stint.

I knew where Shivam will bowl, we've played (in agegroup) together for four-five years," Shaw said at the post-match presentation. "The first four-five balls he bowled were half-volleys, so I was prepared for the short ball but he didn't bowl."

He scored most of the runs on the off-side and asked about it, Shaw said, "On this wicket especially when the spinner is bowling it wasn't coming very nicely onto the bat. It was stopping a little.

"So, I was waiting for them to bowl at me on off stump or outside so I can free my hands.

"When I'm in there, I keep playing and don't think about the score. Don't think about myself, just want the team to win," said the 21-year-old who was named Man of the Match.

Asked about the ups and downs he has faced recently. Shaw said, "My dad has supported very well. After getting back from Australia, I wasn't happy with myself. My dad just asked me to play my natural game.

"All these words set a target on me and I worked hard. In cricket the graphs are going to go up and down, a lot of failures are going to come my way.

Asked if he has ever spoken to former India opener Virender Sehwag, with whom he has similarities in batting approach, Shaw said, "No. I haven't spoken vet but if I get a chance I'd like to because he's the one who likes to score off the first ball."

The win helped Delhi moved to second place in the IPL 2021 points table with 10 points from seven matches. Chennai Super Kings and Royal Challengers Bangalore also have ten points each, but both the teams have a game each in hand.

Delhi next play Puniab Kings in the 29th match of the season at the same venue.

Treat Available Oxygen **As Critical Commodity: Centre To States**

NEW DELHI: The Centre on Friday said it has asked the states to treat the available oxygen as a critical commodity and undertake an oxygen-consumption audit at all hospitals, including private ones, amid a shortage of the life-saving gas in several parts of the country.

Addressing a press conference, Joint Secretary in the Ministry of Health and Family Welfare Lav Agrawal said from the start of the pandemic, the government had identified oxygen-supported beds as major clinical interventions.

He said the government had procured 1,02,400 oxygen cylinders at the national level in April-May 2020 and distributed those among the states.

"We have requested the states to treat the available oxygen as a critical commodity and also to ensure a rational use of oxygen," Agrawal said.

Listing out the steps taken by the Centre to augment the supply of oxygen, he said the National Pharmaceutical Pricing Authority (NPPA) has issued instructions for fixing the price of liquid medical oxygen.

Agrawal said 162 pressure swing adsorption (PSA) plants of 154-MT capacity each have been sanctioned across the country. Of these, 52 plants are already installed, 87 have been delivered and work to commission these plants at the earliest is on.

The PSA plants can enable hospitals for in-situ generation of

Agrawal said the states have been allotted 8,593 MT of oxygen. "An order for 1,27,000 oxygen cylinders was placed on April 21 and the deliveries are expected to start in a couple of days. These include 54,000 jumbo cylinders (D type) and 73,000 regular cylinders (B type).

"Additionally, 551 PSA plants have been sanctioned to be implemented by the Union health ministry. These plants will be installed in different public health facilities," he added.

The states have been advised to ensure a rational use of oxygen, prohibit abnormal use by monitoring non-closure of valve during no-use, stop unnecessary oxygen administration to patients who may not require it clinically and for monitoring private health facilities that indulge in pushing oxygen cylinders as part of home-based COVID care packages, Agrawal said.

In the second wave of the pandemic, the rate of rise of the infection has been rapid, which has put an immense strain on the health infrastructure. The doubling of COVID-19 cases has also been rapid, which should ease if the turnover time reduces, he added.

The pandemic is spreading to tier-2 and tier-3 cities, so it is very important to train doctors about treating this new disease, AIIMS Director Randeep Guleria said while underlining that misuse of drugs like Remdesivir and Tocilizumab has to be avoided. PTI

No Coercive Action Against Citizens Airing Concern On Social Media, SC Tells States

NEW DELHI: The Supreme Court on Friday said states could not take coercive action against people sharing distressing information on social media to seek medical help for their dear ones during Covid pandemic.

"I flag this issue at the outset... We want to make it very clear that if citizens communicate their grievance on social media and internet then it can't be said it's wrong information. We don't want any clampdown on information," a Bench led by Justice DY Chandrachud said during hearing on a suo motu PIL on Covid management.

"We will treat it as a contempt of court if such grievance is considered for action," said the Bench, which also included Justice LN Rao and Justice SR Bhat.

The UP government had reportedly ordered strict action against those creating panic by making



false appeals for help on social media for Covid patients.

However, the top court said, "Let a strong message go to all the states and their DGPs...Clampdown on information is contrary to basic precepts."

The top court last week had

taken suo motu cognisance of the Covid management and asked the Centre to present a national plan to deal with the health crisis with regard to supply of oxygen and essential drugs, method of vaccination and lockdown.

'Stay In Touch With People, Take Feedback': PM To **Ministers Amid Covid**

NEW DELHI: Amid the COVID-19 crisis, Prime Minister Narendra Modi urged Union ministers on Friday to stay in touch with the people of their respective regions, help them and keep getting their feedback on the situation.

Chairing a meeting of the Union Council of Ministers, PM Modi also stressed upon the "need to ensure that issues at the local level are promptly identified and addressed", according to an official statement.

The meeting was held virtually to discuss the situation arising out of the second wave of COVID-19 in the country. It noted that the pandemic has led to a "once-ina-century" crisis and thrown a big challenge to the world, the statement said.

The council was briefed about the steps being taken to ramp up the number of hospital beds, oxygen facilities and resolve issues related to the availability of oxygen and essential medicines, it added.

The support measures for the vulnerable population in the form of free foodgrains and financial support to Jan Dhan account holders were also discussed at the meeting, the statement said.

The meeting was informed that 15 crore anti-COVID vaccine doses have so far been administered to people, while it was also pointed out that the country could successfully produce two vaccines and there are many vaccine candidates at various stages of approval and induction.

The council of ministers also highlighted the importance of COV-ID-appropriate behaviour -- wearing masks, maintaining a physical distance of six feet with others and washing hands frequently.

Emphasising that the participation of the society is a key aspect to accomplish the gigantic task ahead, the ministers expressed confidence that the country will rise to the occasion and defeat the virus.

This was the first meeting of the council of ministers in the aftermath of the second wave of the pandemic in the country.

NITI Aayog member VK Paul gave a presentation on COVID-19 management.

After him, Union ministers Piyush Goyal and Mansukh Mandaviya briefed their cabinet colleagues on the availability of oxygen and medicines respectively.

The prime minister has held several rounds of meetings with chief ministers and top government officials to deliberate on the COVID-19 situation.

He has also been holding meetings with pharmaceutical industry leaders, oxygen suppliers, the heads of the three-armed forces and other dignitaries to discuss how to tackle the pandemic.

Tarun Bhatnagar, a scientist at the ICMR-National Institute of Epidemiology in Chennai, called the attempts to make homemade oxygen "untested and unreliable methods." He told Reuters: "Such an ap-

proach could even be deleterious if it leads to delays in seeking appropriate healthcare." With India scrambling to find

supplies of oxygen, many hospitals are turning away patients for lack of the gas. That has led to purported coronavirus cures circulating on social media, such as videos showing men inhaling steam from

pressure cookers or kettles "to kill Covid-19 infection".

The World Health Organization says about coronavirus cures that scientists around the world are working to find and develop Covid-19 treatments and the agency does not recommend self-medication with any medicines as a prevention or cure. The Health Ministry was not immediately available for comment.

The Indian government issued a public statement on Thursday dismissing as "misleading" a post circulating on social media that touted a homeopathic medicine which it claimed could immediately balance

Covid-19 patients' oxygen levels. India reported a record 386,452 new cases in the past 24 hours, while deaths from COVID-19 jumped by 3,498, according to the Health Ministry.

India Extends Ban On Int'l Flights Till May-End

NEW DELHI: The coronavirusinduced suspension of scheduled international passenger flights has been extended till May 31, aviation regulator DGCA said on Friday.

"However, international scheduled flights may be allowed on selected routes by the competent authority on a case-to-case basis," the Directorate General of Civil Aviation added.

Scheduled international passenger services have been suspended in India since March 23, 2020, due to the coronavirus pandemic. But special international flights have been operating under the Vande Bharat Mission since May and under bilateral "air bubble" arrangements with selected countries since July.

India has formed air bubble acts with around 27 countries, including Kenya, Bhutan and France. Under an air bubble pact between two countries, special international flights can be operated by their airlines between their territories.

The DGCA circular said the suspension does not affect the operation of international all-cargo operations and flights specifically approved by it. PTI

Singhvi said that COVID-19 positive Sorabjee was taken to the Max hospital a week ago, where he was stable, as per his wife Zena.

"Suddenly, heart stopped last night and could not be revived. Long association," Singhvi wrote on micro blogging site Twitter. He said, "Briefed Soli as a youngster,

worked with him and opposed him in innumerable cases. Remember our private mimicry sessions. Soli"s success in law was a loss of both jazz and mimicry."

The senior advocate said that even though Sorabjee was frail, he was mentally alert till the end and fully cognisant at his warm and

cosy 91st birthday a few weeks ago. "[He] had a zest for information and a view on everything. Speech slurred, frail in body but mind fully alert and memory largely intact." Singhvi said, recollecting how he sat with Sorabjee in his lawn about a month ago

Senior Advocate H S Phoolka called Sorabjee his "mentor" and said that "he will be sorely missed".

"Soli Sorabjee played a pivotal role in fight for justice for 1984 Sikh genocide, formed CJC (Citizen"s Justice Committee) in 1985, an umbrella organization of Human Rights groups and led team of lawyers before Ranganath Misra Commission.

"Throughout he kept encouraging me not to give up fight for Justice. He was very happy on conviction of Sajjan Kumar. His contribution towards fight for getting justice for victims will always be remembered," Phoolka

He added that Sorabjee always said that "we have to prove that our country is governed by rule of law and no one here is above the law.

Senior AajTak TV anchor Rohit Sardana passes away



ournalist Rohit Sardana, who was one of the top anchors of Hindi TV news channel AajTak, assed away on Friday. According to reports, Rohit had contracted COVID-19 and is unclear whether he had fully recovered. He is said to have succumbed to a heart attack.

The journalist was with Zee news for several years, before he joined AajTak in 2017. His most popular show 'Dangal', featured debate panels but had also been controversial for its rhetoric. He was awarded the Ganesh Shankar Vidyarthi Puraskar by the Indian government in 2018.

Several people took to Twitter to express their condolences.

India's total active caseload has reached 31.70 lakh and now comprises 16.90% of the country's total infections. A net increase of 85,414 cases have been recorded in the total active caseload in a day.

The meeting of the council of ministers is the first in the aftermath of the second wave of COVID-19 in the country. Sources said the pandemic and the response of the government is likely to be discussed in the virtual meet.

Bihar Chief Secretary Arun Kumar Singh dies of Covid



PATNA: Bihar Chief Secretary Arun Kumar Singh on Friday died of Covid-19, health officials said.

Singh was admitted to a private hospital here on Thursday after he had tested positive for coronavirus. The doctors said that he had developed complications in breathing a

few days back. The 1985-batch IAS officer of Bihar cadre was recently appointed as the Chief Secretary on February 27. He was scheduled to retire this year on August 31.
