3733 More Test Positive for Covid-19

SRINAGAR: Jammu and Kashmir reported on Monday 51 coronavirus related deaths, the highest single day fatalities so far, even as 3733 more people across the Union Territory tested positive for the deadly infection during

the last 24 hours.

Among the victims, officials said, thirty five were residents of Jammu division and the remaining 16 hailed from different parts of the Valley. Most of the victims who died of Covid-19 in Valley were residents of Srinagar city.

Among others, the victims included a 55-year-old man from Sanat Nagar, who died at JVC hospital, a day after he was admitted at the one of the facilities for the management of the covid-19 patients. Besides him, an 80-year-old man from Rawalpora was • More On P6

ormal life in Jammu and Kashmir remained crippled for the fourth consecutive day Monday in wake of a lockdown imposed by the administration to combat the spread of coronavirus. It seems clinical inertia among physicians treating Covid patients in Kashmir is a contributory factor to rate of decline in recovery of such patients.

No defined and unified treatment protocols exist in hospitals and every physician is trying to treat by his own understanding of medicine, which is wrong practice and is not evidence based. Since Covid-19 is new medical entity with evolving knowledge there is no tailored management. However evidence based guidelines will definitely help

and minimise harm.

If unified protocols are devised by responsible physicians at higher level and ensure strict trickle down mechanism, the rate of decline will definitely be checked.

Clinical inertia and lack of confidence in decision making among treating physicians is definitely contributing to this decline.

'Please Save My Father': Cries For ICU Beds Grow Louder

ne of the rattling visuals of the second wave of Covid in Kashmir came on the night of April 29 when a video of a young man pleading the SKIMS authorities to shift his father "struggling to breath" to critical ward went viral on social media.

ward went viral on social media.

The young man along with his sister cried and begged for help—"Please save my father"—until a social-media storm finally reached the ears of SKIMS officials and patient Mohammad Maqbool Wani of Srinagar's Baghi Mehtab area was shifted to ICU (Intensive Care Unit) bed.

"ICU bed is basically for

complete monitoring of a sick patient. It doesn't mean only ventilator, it means everything including a ventilator," Dr Nisarul Hassan, an influenza expert, told Kashmir Observer. "Most of the Covid-19 patients can't be on regular beds and need complete monitoring which is possible only in ICU."

However, hours after shifting to the ICU bed, Wani breathed

"He could've been saved if shifted to ICU earlier," Waqar, the deceased person's son, told Kashmir Observer.

As no ICU was vacant in the hospital that night, some attendants present in the ward said the medical staff was so helpless



that "they were literally waiting for any patient on ICU bed to

die" so that the deceased man could've been shifted there.



"What can we do," a doctor expressing his helplessness told have any beds available at ICU."

Amid this critical care crisis, Wani's condition deteriorated and his oxygen level dipped to 40.

"The patient's condition panicked us all," said Junaid Ahmad, an attendant whose father was in the same ward. "We requested the authorities and doctors to shift the patient first to ICU. However, there was no response. The patient eventually died at 5:30 AM on April30."

This incident happened hours after the government claimed that Jammu and Kashmir is one of the best places managing the current Covid situation.

Study: Post-pandemic world will demand extra care

team of scientists at the University of Waterloo found that designing smaller, more homelike spaces would minimize the spread of viruses while promoting better health and quality of life for residents in the post-pandemic world.

Protecting long-term care residents from outbreaks requires different infrastructure, proper staffing conditions and a culture of quality assurance, researchers found.

"Community outbreaks and lack of personal protective equipment were the primary drivers of outbreak occurrence in long-term care homes, and the built environment was the major determinant of outbreak severity," said George Heckman, a professor in Waterloo's School of Public Health and Health Systems and Schlegel Research Chair in Geriatric Medicine with the Research Institute for Aging.

"We need to distinguish between small-scale living and small-scale housing, using architectural features to create uncrowded and home-like spaces - but within a sufficiently resilient infrastructure to avoid critical staff shortages such as those experienced by some very small homes in Italy and the United States."

In the U.S., data from geospatial analysis and cellphone tracking showed that outbreaks were more likely when staff commuted from neighbourhoods with high viral circulation, and in large homes with more staff traffic. The researchers said that in the case of Ontario, simulations found that 31 per cent of infections and 31 per cent of deaths could have been prevented if all Ontario long-term care residents had had single rooms. However, 30,000 new private rooms would have been needed.

"Policymakers need to reimagine longterm care infrastructure in a post-pandemic world, keeping in mind that smaller homes support better resident outcomes and are more resilient against infectious outbreaks," Heckman said. "New largescale long-term care home developments should be strongly discouraged."

Other factors that would improve resident well-being and curb the spread of viral infections include a dedicated infection control officer in all long-term care homes, proper staffing conditions and high-quality assurance frameworks.

Hong Kong, for example, learned from the 2003 SARS outbreak and implemented several policies that led to success when it ame to COVID-19

They developed guidelines for the prevention of communicable diseases in long-term care, including that all homes have an infection control officer, conduct annual outbreak drills and have a permanent stockpile of personal protective equipment and establish visitation rules that address hygiene and PPE use.

In addition to robust infection control and communication technologies used in Hong Kong, Heckman believes full-time positions, paid sick leave and mental health and well-being support for staff would make a big difference.

The Hong Kong experience underscores the critical importance of learning health systems, of which a culture of quality assurance is an intrinsic component. Ontario, and most Canadian provinces, already have the required information infrastructure to achieve a learning health system.

Based on standardized international Resident Assessment Instrument systems, developed by an international consortium of which Waterloo is a principal leader, their use by communities of practice has led to reductions in inappropriate antipsychotic use and better health outcomes for long-term care residents.



Study links fish oil supplements with heart rhythm disorder

ccording to a new analysis by the European Society of Cardiology, omega-3 supplements are associated with an increased likelihood of developing atrial fibrillation in people with high blood lipids.

The findings were published in European Heart Journal - Cardiovascular Pharmacotherapy, a journal of the European Society of Cardiology (ESC).

Author of the study, Dr Salvatore Carbone of Virginia Commonwealth University, US said, "Currently, fish oil supplements are indicated for patients with elevated plasma triglycerides to reduce cardiovascular risk."

"Due to the high prevalence of elevated triglycerides in the population, they can be commonly prescribed. Of note, low-dose omega-3 fatty acids are available over the counter, without the need for a prescription."

clinical trials have suggested that omega-3 fatty acids may be associated with an increased risk for atrial fibrillation, the most common heart rhythm disorder. People with the disorder have a five times greater likelihood of having a stroke.

These studies tested different formulations of omega-3 fatty acids at different doses. The authors, therefore, performed a comprehensive meta-analysis of randomised controlled trials to answer the question of whether fish oils were consistently related to a raised risk for atrial fibrillation.

The analysis included five randomised controlled trials investigating the effects of omega-3 fatty acid supplementation on cardiovascular outcomes.

Participants had elevated triglycerides and were either at high risk for cardiovascular disease or had established cardiovascular disease. A total of 50,277 patients received fish oils or placebo and were followed up for between 2 and 7.4 years. The dose of fish oils varied from 0.84 g to 4 g per day.

The researchers found that omega-3 fatty acid supplementation was associated with a significantly increased risk for atrial fibrillation compared to placebo with an incidence rate ratio of 1.37 (95 per cent confidence interval

Dr Carbone said, "Our study suggests that fish oil supplements are associated with a significantly greater risk of atrial fibrillation in patients at elevated cardiovascular risk."

"Although one clinical trial indicated beneficial cardiovascular effects of supplementation, the risk for atrial fibrillation should be considered when such agents are prescribed or purchased over the counter, especially in individuals susceptible to developing the heart rhythm disorder," Carbone added.

Here's how scrolling through your phone before bed disrupts sleep

recent study explores how scrolling through your mobile phone and its blue light makes it harder to fall asleep. It's widely believed that the emitted blue light from phones disrupts melatonin secretion and sleep cycles. To reduce this blue light emission and the strain on the eyes, Apple introduced an iOS feature called Night Shift in 2016; a feature that adjusts the screen's colours to warmer hues after sunset.

Android phones soon followed with a similar option, and now most smartphones have some sort of night-mode function that claims to help users sleep better.

Until recently, claims of better sleep due to Night Shift have been theoretical. However, a new study from Brigham Young University (BYU) published in the journal Sleep Health, challenges the premise made by phone manufacturers and found that the Night Shift functionality does not actually improve sleep.

To test the theory, BYU psychology professor Chad Jensen and researchers from the Cincinnati Children's Hospital Medical Center compared the sleep outcomes of individuals in three categories: those who used their phone at night with



the Night Shift function turned on, those who used their phone at night without Night Shift and those who did not use a smartphone before bed at all

"In the whole sample, there were no differences across the three groups," Jensen said. "Night Shift is not superior to using your phone without Night Shift or even using no phone at all."

The study included 167 emerging adults ages 18 to 24 who use cell phones daily. They were asked to spend at least eight hours in bed and wore an accelerometer on their wrist to record their sleep activity. Individ-

uals who were assigned to use their smartphone also had an app installed to monitor their phone use.

The measured sleep outcomes included total sleep duration, sleep quality, wake after sleep onset and the time it took to fall asleep.

After not finding significant differences in sleep outcomes across the three categories, the researchers split the sample into two separate groups: one which averaged about seven hours of sleep and another that slept less than six hours each night.

The group that got seven hours of sleep, which is closer to the recommended eight to nine hours a night, saw a slight difference in sleep quality based on phone usage. The individuals who did not use a phone before bed experienced superior sleep quality relative to both those with normal phone use and those using Night Shift.

Within the six-hour group, which had the least amount of sleep, there were no differences in sleep outcomes based on whether the participants used Night Shift or not.

"This suggests that when you are super tired you fall asleep no matter what you did just before bed," explained Jensen. "The sleep pressure is so high there is really no effect of what happens before bedtime."

The results suggest that it is not blue light alone that creates difficulty falling or staying asleep. The psychological engagement experienced when texting, scrolling and posting are also important factors that affect sleep outcomes.

"While there is a lot of evidence suggesting that blue light increases alertness and makes it more difficult to fall asleep, it is important to think about what portion of that stimulation is light emission versus other cognitive and psychological stimulations," said Jensen.

Night Shift may make your screen darker, but Night Shift alone will not help you fall or stay asleep.

Study examines association between lifestyle patterns, BMI in early childhood

n the first of its kind study, researchers used multi-trajectory modelling to examine the longitudinal relationship between concurrent changes in lifestyle patterns and BMI z scores in early childhood. The study was published online in Obesity, The Obesity Society's (TOS) flagship journal.

"The findings will inform early childhood obesity prevention intervention and policy, and will be of great interest to pediatricians, researchers, policymakers and the general public," said Miaobing Zheng of the Institute for Physical Activity and Nutrition, School of Exercise and Nutrition Sciences, Deakin University, in Geelong, Australia. Zheng is the corresponding author of the study.

Experts explain that longitudinal studies investigating the association between lifestyle patterns and obesity in children are scarce. An association between a healthy lifestyle pattern and lower obesity risk has, however, been previously reported in a few cross-sectional studies.

In the present study, the co-occurrence of stable healthy lifestyle patterns along with a concurrent normal BMI z score trajectory of one unit from 18 to 60 months in about half of the children provides new longitudinal evidence supporting that children with healthy lifestyles were more likely to concurrently have nor-



mal BMI z score development.

Data of 439 children were used from the Melbourne Feeding Activity and Nutrition Trial (InFANT) program. This longitudinal cohort of children commenced in 2008 as a 15-month parent-focused cluster randomized controlled trial aiming to reduce obesity risk behaviours in children until 18 months. Additional follow-ups without interventions occurred for children aged 42 and 60 months. Multi-trajectory modelling identified groups of children following similar lifestyle patterns and BMI z score trajectories and multi-nomial logistic regression assessed the determinants of the trajectory groups.

Three trajectory groups of child

lifestyle patterns and BMI z scores were identified and distinguished, showing a mixture of healthy and unhealthy lifestyle behaviours and

BMI z scores. Compared to Groups 1 "Unhealthy lifestyle pattern, Low BMI z" and 3 "Unhealthy lifestyle pattern, High BMI z", Group 2 "Healthy lifestyle pattern, Mid BMI z" revealed the most distinctive trajectories across lifestyle patterns and BMI z scores.

Group 2 comprised nearly 53 per cent of children and followed a stable and low trajectory for an unhealthy lifestyle pattern characterized by energy-dense and nutrient-poor discretionary food consumption and television viewing time and a high and rising trajectory for a healthy lifestyle pattern of fruit and vegetable intakes and time outdoors, along with a mean BMI z score of 1 unit over time.

Groups 1 and 3 shared similar high trajectories for an unhealthy lifestyle pattern of discretionary food consumption and television viewing time, and low trajectories for a healthy lifestyle pattern of fruit and vegetable intakes and time outdoors. The two groups however differed in BMI z score trajectories, showing stable patterns but at mean scores of 0 and 2 units, respectively. Child sex, breastfeeding duration and maternal physical activity were not associated with the identified trajectory groups.

The study's authors note that the co-occurrence of stable lifestyle patterns and BMI z score trajectories in early childhood highlight the importance of initiating lifestyle obesity prevention early in life, and such interventions could target both children and the mother. A multi-behaviour approach to simultaneously target healthy diet, physical activity and sedentary behaviours could be adapted.

"Young children learn by imitating that which they see daily. There is no doubt that children copy the behaviours observed in the presence of parents: healthy and unhealthy," said Liliana Aguayo, PhD, MPH, a childhood obesity expert, TOS member and research assistant professor from the Hubert Department of Global Health at Emory University in Atlanta. VIOLENT UPSURGE CLAIMS 11

SRINAGAR - In stepped up attacks on political activists in Jammu and Kashmir, the head of the Pattan municipal committee, a block president of the Pradesh Congress- Committee and three policemen were shot dead on Tuesday, even as the security forces claims to have killed 6 militants on Monday night in foiling an infiltration-attempt in Poonch. Fifteen people, including two STF personnel, were injured in a grenade blast in Pulwama district today.

Gunmen, who police said were militants, opened fire on. the chairman of the Pattan Municipal Committee, Muhammad Ramzan Mian, in the town market at around 11:30 a.m., critically injuring him, his two security guards, a civilian, and a policeman who was standing nearby.

The injured were rushed to hospital, where Mian and his two personal security, guards, Zahoor Alunad and Riyaz Ahmad were declared brought dead. The police constable, Altaf Hussain, succumbed to his injuries later. A civilian Basheer Ahmad Bhat with whom Mian had been in

conversation at the time of the attack, was also injured in the firing. He has been shifted to the SKIMS in a critical condition. Mian had been inspecting developmental works in the market and had stopped for a chat at the shop of Pattan beopar

mundal president when the attack took place, the CNS said. According to one report, the attackers made off with two

service rifles of Mian's security guards after the firing.
Security guards deployed with political workers have been put on alert following the killings.
In another incident, a group of unidentified gunmen intruded into the house or one Abdul Ahad Ganai at Shangran near Doom in Anantnag district in the wee hours today and shot dead the block president of

Pradesh Congress CommitteeJabbar Ahmad Khanday. A contractor by profession, Khandav died instantly and his

gunmen fled the scene. Gunmen also shot at and critically injured the village head

of Zainapora, Ali Muhammad Wani outside his house in Shopian area of Pulwama district this morning.
Another civilian Bashir Ahmad Dar was also injured in the

firing and both were hospitalized. The security forces shot dead six suspected militants as they were trying to sneak into Jammu and Kashmir through the Line of Control (LoC) in what is being called the biggest infiltration attempt this year.

lection results in the four states and one union territory have Trinamool Congress Party have gone along both expected lines and contrary to expectations. Perhaps nowhere more so than in West Bengal where the BJP had deployed its vaunted electoral machinery to dislodge the redoubtable Mamata Banerjee, the leader of Trinamool Congress Party, that finally carried the day. Despite losing Nandigram, Banerjee led her party to one of its biggest political victories in the past three decades by halting the BJP juggernaut. This is her third successive win. The loss in the important state is a serious setback for the BJP currently battling a serious backlash due mainly to its shoddy response to the virulent second Covid-19 wave which has led to record infections and deaths across the country. Top BJP leaders including the Prime Minister Narendra Modi and the home minister Amit Shah had campaigned vigorously in the state holding several public meetings and road shows.

This is so far the biggest victory of the Trinamool Congress with over 48 % of all votes polled. In the 2016 Assembly polls, the percentage of votes polled by the party was about 44.9%. The TMC has a strong cadre and has been in power since the last ten years. The party certainly was facing some anti-incumbency issues but it didn't mean that the party was on a weaker wicket.

However, the significance of the Bengal election is beyond the BJP-TMC rivalry. Its outcome is a profoundly important development. The TMC wins is likely to arrest the disarray among the secular forces and give them confidence to stand up to the PM Modi in the upcoming state elections. This has once again underlined that only a broad secular front could confront the BJP with a credible challenge. As things stand, there is no dislodging the PM Modi yet. That is, if no credible political rival emerges from the shadows in the near future, a prospect for which

The likes of Nitish Kumar, Akhilesh Yadav and Mayawati who once showed signs of shaping up into credible national rivals have too paled into insignificance. The caste based parties in Uttar Pradesh who were only hope to stop Modi juggernaut have bitten the dust. And they are unlikely to recover from the beating they took in polls after polls. Modi's appeal has only grown stronger. The BJP under him has set itself up as a formidable force which won't be easy to beat. While the broader opposition is reeling from the abject defeat, the BJP is busy setting up its base in the states where it lacks the presence like Tamil Nadu, Karnataka and Kerala, even though it may still not be in a position to credibly challenge the local parties. Things can still turn around for the opposition and also for India if the opposition too develops a potent narrative that offers a persuasive alternative to the one being peddled by the BJP.

The Return of Federalism

Tith the Trinamool Congress (TMC) winning West Bengal for a third time, the Dravida Munnetra Kazhagam (DMK) returning to power in Tamil Nadu after a decade, the Left Democratic Front (LDF) breaking a four-decade-old electoral pattern to retain power in Kerala, the Bharatiya Janata Party (BJP) retaining Assam, and the National Democratic Alliance coming to power in Puducherry for the first time, there is a mandate both for continuity and change in the different regions that went to polls. But the results will also have an impact on

national politics in five different ways. One, there will be a restoration of a degree of balance in Indian federalism — which is good — and greater tension between the Centre and states, which needs careful management. In recent years, espec-ially after the BJP's 2019 win, there has been a perception of the Centre undermining the powers of the states. The fact that three important states, Bengal, Tamil Nadu and Kerala, will be governed by parties which are politically and ideologically opposed to the BJP means that there will be a greater assertion of federal rights. The Centre has a choice — it can either double down or continue with its curr-ent approach where the BJP's political aims often supersede the principle of cooperative federalism or it can be more collaborative. The states have a choice too they can either become more confrontational for the sake of it or adopt a strong but constructive approach. Harmony would be a wiser course of action for both

Fatal Ambition

ow that the BJP has suffered a debacle in the West Bengal elections and is unable to form a government in the state, here are a few questions to ponder over. Were all the election rallies that led to a huge spike in corona cases, and even led to the death of some candidates who contested the elections, worth it? Was it necessary for the elections in West Bengal to be held in eight phases? Is the Election Commission so compromised that it does not have a will of its own, but has merely to kowtow to the wishes of the union government? Small wonder, then, that the Madras High Court recently ruled that the Election Commission should be held accountable for mass murder, a verdict against which the Election Commission has filed an appeal in the Supreme Court. Mamata Banerjee herself plans to drag the Election Commission to court over the Nandigram result. Those of us who were around when the independentminded T. N. Seshan was the Chief Election Commissioner can see, with a sense of dismay, how the Election Commission has completely lost its autonomy.

The Delhi High Court has warned the central government that contempt proceedings will be initiated against it, if it fails to explain the capital's oxygen shortage. This is a welcome move, for it isn't enough for the higher judiciary to merely go after the Election Commission. They need to gun for the central government itself which misled the nation in March by declaring that India had won the fight against corona, and that the dreaded disease had been more or less eradicated from the country. But did the PM consult doctors before he spoke? Did he not know that other countries had experienced a second wave, and this would sooner or later hit India as well? Did nobody tell him that there were mutant strains of the virus, such as the UK strain, the Brazil strain and the South Africa strain, and that there could soon be an Indian strain that made its appearance?

The current Covid tragedy has led India to go round with a begging bowl, no offence meant, to other countries for help. America has rushed aid to India to the tune of 100 million dollars. The United Kingdom, France, Germany, Belgium, Ireland, Italy, Australia,

Switzerland. Sweden. Norway. Finland, Luxembourg, Portugal, Rumania, Hong Kong, Thailand, Saudi Arabia and the UAE have all come to India's rescue. Even 'enemy' countries like China and Pakistan, and tiny principalities like Bhutan, have offered to contribute their mite.

But do these countries know that while India has asked them for help, the central government continues to go ahead with Parliament's Central Vista Tower project, the cost of which is Rs. 20,000 crore? Do they know that Delhi's present lockdown restrictions do not apply to construction workers at the project site, who go up and down as if all is hunky dory, risking their lives? But, in a month when workers of the world unite, is the government really concerned about the lives of the poor? If it was, we would not have witnessed last year's migrant labour tragedy.

Someone rightly said on Twitter that before the world rushes aid to India, it must formulate strict eligibility criteria for receiving the aid. Speaking of social media, Facebook allegedly removed a post that called for Modi's resignation, and restored it only when there were protests.

If things weren't as bad as reported by the media, except of course the godi media (one godi TV channel did not cover the election results, ostensibly because of the covid crisis, but really because it knew the BJP was losing in Bengal). India would not be isolated by the world today. The US has asked all its citizens in India to leave the country at once. Many other countries have banned flights to and from India. The foreign media has come down heavily on the Modi government. The Australian Financial Review carried a cartoon by David Rowe that showed the Prime Minister blissfully riding an elephant that was dead, without knowing that it had died. This was the cartoonist's way of demonstrating how cut off from ground realities the Prime Minister is. A friend who lives in Canada wrote to say that they are shocked by the invisibility of the political opposition during the present crisis.

The most haunting and terrifying image for the world to see on their television screens is that of dozens of funeral pyres simultaneously burning in all our crematoriums and graveyards. We seem to have receded into the Dark Ages!

Yet religion takes precedence over everything else. The recently concluded kumbh mela threw social distancing and the wearing of masks for a toss, leading to the deaths of many who attended it, including the deaths of some well-known people. like music director Shravan Rathod. But hardly is it over, then the Uttarakhand government now speaks of conducting the Char Dham festival in the middle of May. Whether this other super-spreading event will finally be held or cancelled still remains uncertain.

Two years ago, the BJP was returned to power at the centre with a thumping majority. Can they be sure of the same success if general elections are held today? Many of the party's own members and their families have succumbed to Covid.

Everything is in short supply, from hospital beds to ventilators to oxygen cylinders to vaccines. In the circumstances, is the claim that vaccines will now be available to everyone above the age of 18 anything but a political gimmick to give the government brownie points? Most states have made it clear that they will be unable to vaccinate all adults for now. I myself am stuck, having had my first jab in March, but being turned away wherever I go for my second jab today, six weeks later. It would have been much better if the drive was conducted phase-wise, in accordance with the availability of vaccines. Seniors should have been vaccinated first, then everyone between the ages of 45 and 60, and only then should have the vaccines been thrown open to all, by which time more manufacturers would have entered the fray. This is how most countries han their vaccination drive.

As of now, we need to retain our optimism in the face of all odds, and hope to see better days in the future. That is, if tomorrow, death does not knock on our door.

Understanding The Science Of Landslides-Part I

⁻The landslide hazard poses a consistent threat to people in Jammu and Kashmir, and it usually intensifies during rainy seasons. Proper scientific approach and technology needs to be used to counter any future threat. This will also guide us in understanding why some areas in Jammu and Kashmir are more prone to such hazards and what can be done to avoid or minimize such hazards.

ATURAL disasters like earthquakes, tsunamis, landslides, wildfires, cy-clones, droughts, floods etc. continuously pose constant threats to our young, 10,000-years-old, civilization. It is estimated that these hazards have increased recently, in the decade from 1976 to 1985, close to one billion people were affected by disasters and this number had more than doubled in the decade from 1996 to 2005, in which nearly two and a half billion people were affected. In the last decade about 3 billion people were affected and it killed around 750,000 people and cost around US\$ 600 billion.

To cope with the natural disasters it is required to understand the science behind these events and plan a comprehensive program to educate the masses. It is important to put more emphasis on pre-disaster planning, rather than on post-disaster reaction. There are ample evidences to demonstrate that lack of scientific awareness has proved fatal in most of the natural disasters we have witnessed so far in the past. For example, the earthquakes in New Orleans and Port au Prince, which had long been recognised as a catastrophe waiting to happen, but somehow even that awareness did not produce the desired effect! Similarly, there are several places in the world, for example South East Asia, where knowledge about earthquakes, tsunamis, landslides, cyclones, floods etc. is still in its infancy. This has caused colossal loss to life and property. For example in Muzaferabad and Aceh (Indonesia) the tragic examples, in which basic scientific ignorance and the inability to translate the acquired knowledge into timely planned action clearly shows the challenges earth sciences face today.

Landslide is the movement of a mass of rock or debris down a slope. The dimensions of a landslide may be very small or huge, and its movement can be sluggish or very swift. There are various reasons for such movements; for example precipitation (rainfall), topography, geology (rock and soil types) and human activities, can all trigger landslides. Anything affecting slope conditions can cause slope failure, potentially in an area, which is prone to landslides. This includes human induced slope failures, especially during construction, mining etc. Earthquakes are one of the main causes, which trigger landslides and volcanic eruptions also contribute to these movements. One of recent examples of an earthquake induced landslides occurred in Muzaffarabad Pakistan, when a 7.6 magnitude earthquake struck this region in 2005. It is estimated that more than 87,300 people lost their lives and several millions were rendered homeless. This has affected an area of more than 30,000 Kilometre square and triggered thousands of landslides.

The landslide hazard poses a consistent threat to people in Jammu and Kashmir, and it usually intensifies during rainy seasons. Proper scientific approach and technology needs to be used to counter any future threat. This will also guide us in understanding why some areas in Jammu and Kash



mir are more prope to such hazards and what can be done to avoid or minimize such hazards

Gravity, the driving force for slope failure

Slopes are generally unstable over a long period of time and therefore, they tend to stabilise by moving to a new and stable condition. This is achieved through the force of gravity, which is the driving force and will always act on the slopes to drag them down. There is always a tug of war between the driving force (gravity) and the resisting force, which is the strength of the rock-mass to upload against the gravity. A slope may fail, if the driving force exceeds the resisting one.

Gravity makes it possible for us to walk on the surface of Earth. When a surface is flat, it is quite easy to walk, because the gravity acts perpendicular to our feet. However, if the surface is inclined, it is hard to walk, because the force of gravity in this condition has two components (see Figure). For example the figure (c) shows these two components acting on a slope, one is parallel to its surface and the other one is perpendicular. The slope parallel component (Gs) will always try to make anything resting on its surface inherently unstable and cause a shear stress parallel to the slope, which pulls the object in the downward direction. However, the perpendicular component of gravity (Gp) helps to hold the object in place on the slope.

Friction and Cohesion

The forces resisting movement down the slope are grouped under the term shear strength which includes frictional resistance and cohesion among the particles that make up the object. For example, when we want to push an object over a slope, we need some force to do that and that applied force must overcome the resistance due to friction (which is the area of the object in contact with the sloping surface). In natural conditions, the applied force is from the gravity and it has to overcome the friction and the cohesion among the particles. If the surface is rough, the friction will be more, because the particles of the object are tightly held to the surface. However, when a surface is slippery or polished, it is easy to slide down. Water, makes slopes slippery and therefore, reduces friction, which facilitate the sliding, that is one of the reasons why there is more sliding in wet seasons. Cohesion is the force that keeps material (e.g. a rock) intact. When you pick a rock (e.g. granite) and look at it carefully, you can observe that it is made-up of a number of minerals of different colours. These are held together or in-

terlocked by the forces of cohesion. When the frictional and cohesive forces become smaller than the shear stress, the object on a slope slips down the slope. Alternatively, when the cohesive forces, which hold rock particles or soil together, are weaker than the shear strength, the rock will fall apart under the influence of gravity.

Slope stability can be measured through the Safety Factor, which is the ratio of the resisting force (Shear Strength) to the driving force (Shear

Fs = Shear Strength/Shear Stress

If this ratio is slightly more than 1, the slope is close to being unstable, however, if it is significantly greater than 1, (1.5 or 2), then the slope is stable, because the shear strength (resisting and cohesive forces) is much greater than the driving force.

The Pandemic Within the Pandemic

lobally, antibiotic use in hospitals has surged since the start of the COVID-19 pandemic, and over-the-counter sales, legal in many countries, have soared. This is further fueling the global crisis of antimicrobial resistance, as bacteria evolve and become immune to

NAIROBI - Fear of COVID-19 is driving increased over-the-counter (OTC) sales and in-hospital prescriptions of antibiotics - and fueling a silent pandemic in its wake.

Globally, antibiotic use in hospitals has surged since the start of the COVID-19 pandemic. Even though studies show that only 8% of patients admitted to hospital with COVID-19 also have an infection requiring antibiotics, more than 70% receive them. In addition, many people worried about possible or actual COVID-19 symptoms, and alarmed by global reports about the pandemic, have turned to buying antibiotics without seeing a health-care worker.

This is further fueling the global crisis of antibiotic resistance, as bacteria evolve and become immune to these drugs. We must move quickly - with international policy, national laws, and local action - to control what the World Health Organization has identified as one of the ten leading health threats to humanity.

Antibiotics treat infections caused by bacteria, and have no impact on a virus such as SARS-CoV-2, which causes COVID-19. Overusing them merely accelerates the emergence of antibiotic resistance, which will undercut our ability to treat common diseases. Simple infections such as pneumonia or urinary tract infections, which currently can be quickly cleared by common antibiotics, may prove impossible to treat and become deadly.

This is particularly true in many African, South American, and Asian countries, where access



to health-care workers is limited and there are no restrictions on antibiotic sales. In India, antibiotic sales have risen astronomically in recent years, largely driven by unregulated OTC purchases, including of unapproved drugs. Likewise, in Kenya, all antibiotics can be purchased without a prescription.

Bacteria that develop resistance to multiple antibiotics are responsible for causing difficult-to-treat infections, which are up to three times more likely to kill people than infections caused by non-resistant bacteria. And data from several countries - including China and Egypt - indicate that up to 50% of bacteria-causing infections in criticalcare units are resistant to several antibiotics. In the United States, it is estimated that close to three million people get an antibiotic-resistant infection each year, leading to more than 35,000 deaths annually.

Drug-resistant bacteria are also more likely to spread from person to person, and have been known to cause large disease outbreaks in hospitals.

In India, antibiotic sales have risen astronomically in recent years, largely driven by unregulated OTC purchases, including of unapproved drugs. Likewise, in Kenya, all antibiotics can be purchased without a prescription

Many COVID-19 treatment wards around the world are currently grappling with this problem.

As an infectious-disease specialist working on the COVID-19 management front line and also leading the treatment of drug-resistant infections in Kenya, I have often struggled to treat patients with severe bacterial infections that had developed resistance to all available antibiotics. Many of the recently developed drugs that could potentially treat resistant bacteria are often extremely expensive and not available in many countries. A ten-day course of one such antibiotic in Kenya, for example, costs almost \$10,000, putting it beyond the reach of most patients.

In fact, many patients entering the hospital for COVID-19 treatment say that they have already taken one or more antibiotics at home in an attempt to address some of their symptoms. Often, using these drugs had made them feel that they were being treated, so

they delayed going to the hospital. Some may argue that allowing unrestricted use of antibiotics can enable access to treatment for those unlikely to be able to see a doctor, and may be cheaper for the poor. But the resulting antibiotic resistance is expensive to treat and potentially costs lives.

What must we do to forestall this next pandemic? For starters, the WHO and other global agencies must speak out much more strongly and explicitly against the use of antibiotics in cases of COVID-19, unless these drugs are specifically indicated for another bacterial infection.

In addition, national governments must tighten restrictions on OTC antibiotic purchases. Evidence suggests that introducing and enforcing laws to limit such sales can be effective if these efforts are sustained over time. Requiring pharmacies to display a notice stating that it is illegal to sell antibiotics to customers without a doctor's prescription also has been associated with reduced antibiotic sales.

Hospitals should adopt so-called antibiotic stewardship strategies to reduce unnecessary prescriptions. These measures can lead to reduced antibiotic use and cost, and decrease the risk of antibiotic-resistant infections in hospitals. Effective strategies could include developing guidelines for managing common infections, restricting antibiotic use in viral infections, strengthening laboratory capacity - especially in low- and middle-income countries - to help clinicians identify the correct bacteria to treat, and providing continuing education for all clinicians.

Finally, individuals - despite their understandable fears of COVID-19 should not risk harming themselves by using antibiotics unnecessarily.

The message is clear: if we do not act now to curb antibiotic use, we will invite a new pandemic. And, unlike COVID-19, no vaccine will save us.

LG Announces Special Financial Incentives for Covid-19 Warriors

JAMMU: Lieutenant Governor, Manoj Sinha on Monday approved special Financial Incentives for Covid-19 Warriors of Health and Medical Education Department of J&K.

Frontline workers of Health & Medical Education Department, J&K are rendering valuable services in the challenging Covid pandemic times for saving precious lives of the patients, observed the Lt Governor.

Although, the services rendered by these Covid warriors cannot be compensated, still the UT Government has decided to incentivize their efforts, the Lt Governor added.

Incentives are exclusively for those frontline workers who directly deal with Covid-19 patients. The decision will benefit more than 17,000 Corona warriors Resident Doctors, Medical including Paramedical/Nursing staff, Drivers and Class IV employees.

The incentive will be Rs 10,000 p.m. for Resident doctors, PGs and Medical Officers; Rs 7,000 p.m. for Nursing and Paramedical staff, and Rs 5,000 p.m. for Drivers, Sweepers and Attendants. The tenure of these incentives shall be initially for a period of 03 months and will be paid from May 2021 onwards.

In view of surge in Covid-19 cases and to give a fillip to available medical services at this crucial juncture, the Lt Governor also granted extension up to 31st December, 2021 in favour of the Faculty Members, Consultants, Doctors

working in SKIMS, Soura, Srinagar/ Bemina; Government Medical Colleges and Health department who are going to retire from May, 2021 to November, 2021.

Oxygen Supply

Chief Secretary, B V R Subrahmanyam on Monday sought a detailed audit of oxygen demand across all hospitals and medical institutions, an official spokesperson said.

The CS, he said, directed constitution of divisional level teams to conduct the audit within two days and specify the requirement of gaseous oxygen to meet the needs of patients in COVID facilities, non-COVID hospitals, private hospitals, and Army hospitals.

He further said that in the meeting it was also impressed upon the concerned to also include in the audit the estimation for future increase in COVID dedicated beds taking the existing tally from 4200 to 7000; and facilities to be provided at COVID care centres with at least 7000 oxygen-supported beds.

"Similarly, to precisely assess the availabilty of oxygen in the Union territory through in-house production and imports, Divisional Commissioners were asked to constitute divisional level expert committees to conduct the audit of oxygen generation and storage at various pressure levels. The oxygen supply audit will depict available resources, as well as arrangements, being made to increase supply in

the future," he added. According to the official spokesperson, Subrahmanyam also directed establishment of an oxygen war room headed by the Principal Secretary, Industries & Commerce with subsidiary war rooms under respective Divisional Commissioner to monitor and manage supply and distribution of oxygen in Jammu and Kashmir by coordinating with suppliers and user agencies.

Meanwhile, the Health & Medical Education Department was asked to ensure optimal uses of oxygen across the hospitals with minimal

"Further, Divisional Commissioners were directed to establish 24X7 call centres in Srinagar and Jammu for proper patient management and strict implementation of hospital referral policy. They were asked to advertise the helpline numbers in print, electronic and social media, besides, circulating them among the larger population through bulk text messages by using Swasthya Nidhi data," the official

spokesperson said. He said that the meeting was informed that COVID call centres will be operated by a team supported by medical professionals. They will collect vital information from patients and suitably direct them to triage points for seeking medical advice and assistance.

'The COVID triage points will be established at district hospitals, CD hospitals at Jammu and Srinagar, and at the emergency blocks of GMC, Jammu/Srinagar, and SKIMS, Srinagar," he added.

The official spokesperson further said that the Chief Secretary reiterated strict implementation of hospital referral policy for efficient patient management across the hierarchy of COVID care hospitals with access to tertiary healthcare reserved for critically ill patients.

"Accordingly, Divisional Commissioners were asked to ensure optimal utilization of resources, wherein the tertiary hospitals would only admit critical COVID patients being referred from district hospitals and walk-in patients would first be evaluated at triage points and suitably referred to proper healthcare facilities based on the severity of infection," he added.

Emphasizing that only vaccination will retard the rate of COVID transmission, the CS, as per the official spokesperson said that vaccination rate should be maintained. He directed Director, Health Services, Jammu/Kashmir in consultation with Commissioner, Jammu/ Srinagar Municipal Corporation to establish mobile vaccination centres with arrangements for AEFI management closer to the residential areas and vaccinate the eligible population amidst ongoing restrictions.

"The terms of reference of the Special Task Force shall be to scrutinize cases of employees suspected of activities requiring action under Article 311(2)(c) of the Constitution of India," the order had said.

The order had also empowered the STF to compile records of such employees, wherever necessary and to refer it to the Committee constituted vide Government Order No. 738-JK(GAD) of 2020 dated 30.07.2020. It also orders STF to engage with other members of the Terror Monitoring Group (TMG) for identifying such other employees, as necessary besides taking the assistance of other Agencies and Department(s) in this regard, as necessary.

The letter said the proceedings would be done expeditiously and the report will be submitted to J&K BIP president within two weeks positively.

Earlier during the day, Randhawa said he had not rebelled against the party or the leadership, but wanted the facts to reach the high command including Prime Minister Narendra Modi. Randhawa alleged that the registered stone

Pregnant Women More Affected By Second Wave Of COVID-19: DAK

'Should Get Vaccinated Immediately'

SRINAGAR: Doctors Association Kashmir (DAK) Monday that pregnant women should also be vaccinated on priority basis for Covid-19 as expecting mothers are now considered a high risk group.

In a statement DAK president Dr Nisar ul Hassan quoting a new study published in American Journal of Obstetrics and Gynaecology, said Covid-19 vaccine has been found to be safe for both mother and the baby.

Dr Hassan said the study showed that the vaccine generates a robust immune response in pregnant women, equivalent to the general population. "Additionally, protective antibodies were also isolated in umbilical cord and breast milk, implying protection to the unborn and the newborn." he said.

He said the CDC recommends that vaccines should be given to pregnant women. "While the Union health ministry is not recommending vaccines to pregnant women at this time as there was no data available to ensure safety in pregnancy," he said.

"But, now we have evidence. And, we should offer vaccines to them," he added.

Foreign players, who were already anxious about getting home with travel restricted from India, are a more worried lot.

"There is no going back now with half of the tournament done. The news (positive cases in KKR) makes the BCCI's job more challenging," a franchise official told PTI.

"We have been hearing that a player got infected because he was taken outside the bubble for scans. So, it could have happened outside the bubble. As far as I know, everyone is strictly following the protocols laid out by the BCCI and there was no breach there," he added.

Another team official said the tournament should continue as long as more teams are not affected by the virus

"Even if you have to pause the tournament, how long can you hold back? The only way is to keep isolating the positive cases and keep playing. The players are naturally more anxious now but it is mainly because they are not sure about how they would get back home," said the official.

India 2nd In T20, Drop To 3rd In ODI After **Updated ICC Rankings**

DUBAI: India retained the second place in the ICC Twenty20 team rankings but dropped a rung to third in the ODI chart following the annual update carried out on Monday.

India are trailing top-ranked England (277) by five rating points in the T20 team rankings.

During this period, England drew a three-match series against Pakistan 1-1, defeated Australia 2-1 and South Africa 3-0 before losing an away series to India by a 2-3 margin.

New Zealand have also gained in the annual T20I update, moving up from fifth to third after series wins over the West Indies, Pakistan, Australia and Bangladesh. Australia have moved the other way, down from third to fifth.

In other movements at the top of the T20I rankings table, Sri Lanka and Bangladesh have gained one place each to reach eighth and ninth positions, respectively, while the West Indies have dropped two places to 10th.

According to the ICC, these updates eliminate results from 2017-18 and halve the weighting of matches played in 2019-20, which includes the 2019 World Cup.

In the annual update of the ODI Team rankings, India dropped a place to third behind Australia and new table toppers New Zealand.

The Kiwis have replaced reigning world champions England as the number one ranked side in the ODI rankings.

New Zealand, who defeated Bangladesh 3-0 in their only ODI series during the past year, have advanced two slots after gaining three rating points to reach an aggregate of 121.

Australia are second with 118 points while India and England are both on 115, with the former ahead on deci-

mal points. England's slip down to fourth position comes in the second annual update since they won the ICC Men"s Cricket World Cup at Lord's in

the summer of 2019. In the past 12 months, England have suffered 1-2 series losses to Australia and India, as well as an ODI lost to Ireland.

The latest update, that rates all matches played since May 2020 at 100 per cent and those of the previous two years at 50 per cent, sees Australia move up two places from fourth to second and India drop one place to third. The West Indies have overtaken Sri Lanka to ninth position.

The Netherlands have been allowed to retain their ranking despite only having played four ODIs during the new rating period, since their scheduled fixtures were postponed as a result of the COVID-19 pandemic.

There has been no change of places in either format for Afghanistan, Pakistan or South Africa, Afghanistan are 10th in ODIs and seventh in T20Is, Pakistan are sixth in ODIs and fourth in T20Is while South Africa are fifth in ODIs and sixth in T20Is.

Despite the pandemic, 80 countries have played the requisite six T20Is over the past three years to remain in the rankings. Five countries have lost their ranking after the update -- Gambia, Ghana, Hungary, Sierra Leone and Sweden.

The annual update to the Test rankings will be carried out following the conclusion of the ongoing Pakistan-Zimbabwe series.

'Not Letting Us Get Back Home A Disgrace' Slater **Lambasts Aus PM Morrison**

NEW DELHI: Cricketer-turnedcommentator Michael Slater, who is currently doing commentary in the IPL here, has launched a scathing attack on his country's Prime Minister Scott Morrison for not allowing its citizens to return from COVID-19 hit India, calling the travel ban a "disgrace"

Australia has shut its borders and not allowing any commercial flights from India because of the massive COVID-19 surge here which has led to all the players, support staff and commentators, who might have wanted to leave the IPL in a fix.

The government has made it clear that Australians who are engaged in the IPL will have to make their own arrangements. "If our Government cared for

the safety of Aussies they would allow us to get home. It's a disgrace!! Blood on your hands PM. How dare you treat us like this. How about you

Threatening a five-year jail term or hefty fine, the Australian government temporarily barred its citizens from entering the country if they happened to be in India within 14 days of their intended arrival.

The decision was announced after a meeting of the National Cabinet last Friday and came into force from Monday.

The move aims at keeping the COVID-19 spread in check in Australia as India is facing a surge in cases.

Protesting Man United Fans Storm Old Trafford, Force Match Postponement

MANCHESTER: In an unprecedented moment for the world's richest football competition, the Premier League was forced to abandon one of the biggest matches of the season after an invasion of Old Trafford by Manchester United fans.

The storming of the stadium shut to fans during the pandemic came hours before United was due to host Liverpool. As fans protested on the field against United's owners - the Glazer family flares were set off and thousands more supporters filled the concourse outside Old Trafford.

Ugly scenes erupted as police clashed with supporters who are enraged by 16 years of lack of engagement by the Glazers which peaked with their decision to take



United into a breakaway European Super League which collapsed two weeks ago inside 48 hours.

The players didn't even attempt to make it to the stadium, with United's squad unable to leave its central Manchester hotel due to another outbreak of protests.

The Manchester United Supporters' Trust raised the possibil-

ity of a gate being opened to let fans enter the stadium. The only communication from the club was via an unnamed statement rather than the Glazers.

"We completely acknowledge

the right to free expression and peaceful protest," United said. "However, we regret the disrup-

A victory for deposed champion Liverpool over second-place United would have clinched the title for Manchester City. There have been smaller protests

at Arsenal and Tottenham since those clubs were part of the six English clubs who tried to join the breakaway European competition.

But there was no significant anger in north London before Tottenham played Sheffield United, winning 4-0 after Gareth Bale scored a hat trick and Son Heung-min also netted to take the team fifth.
