52 Deaths, 4716 Fresh **Cases Reported In 24 Hours**

Srinagar: Jammu and Kashmir on Wednesday reported 52 coronavirus related deaths, the highest ever single-day spike so far, even as 4716 fresh cases of infection were reported across the Union Territory during the last 24 hours.

According to the officials, 28 more people succumbed to the virus in Jammu division and 24 others at different healthcare facilities in Kashmir Valley, raising the fatality count since the outbreak of pandemic in J&K last year to 2510.


Shabir Shah Moves Delhi Court Seeking Bail

The agency has already sent a letter to the Jammu and Kashmir Revenue Department seeking sanction to prosecute one of their officers in connection with the case, they said.



Screening healthcare workers may act as early warning system for future viruses



ew research has shown that COVID-19 infections in healthcare workers during the first wave of the pandemic provided an accurate sample of the general population. The study suggests that data from healthcare workers could be used to estimate the severity of future viruses more quickly.

The study, led by researchers from RCSI University of Medicine and Health Sciences in collaboration with IBM Research, is published in PLOS ONE.

The researchers analysed the infection data from healthcare workers and the progression of the first wave of the COVID-19 outbreak using the reported daily

Using similar data in four other countries (Germany, UK, South Korea and Iceland), computer models showed how the disease progressed in different countries related to their approach to testing, tracing and lockdown restrictions.

Healthcare workers in Ireland made up 31.6% of all test-confirmed infections while only representing 3% of the population. However, the researchers found that the healthcare worker data closely related to that of the entire population after using software to create a more accurate picture of how widespread the disease was.

This suggests that governments could use data from only healthcare workers to inform decisions on whether to implement restrictions, wide-scale testing and contact tracing for future viruses.

"As we have seen with the COVID-19 pandemic, implementing countermeasures early can save lives and reduce the spread of the disease," said RCSI Professor of Chemistry Donal O'Shea, who led the work.

"However, wide-scale testing can take time to set up, delaying decisions and costing lives. While the healthcare population is no longer an accurate sample of the general population for COVID-19 due to different vaccination rates, governments could use data from their healthcare worker population to make informed decisions on what measures to implement earlier when future viruses emerge.

The research noted that very few nations were able to set up effective systems that tested the entire population, carried out con-

tact tracing and quarantined those infected with COVID-19.

"Setting up wide-scale testing systems for healthcare workers is much easier than setting up a similar programme for everyone since the infrastructure for testing for diseases is always in place in healthcare settings," said Dr Dan Wu, honorary lecturer in the RCSI Department of Chemistry and first author on the paper.

"A screening programme that tested all healthcare workers would have the additional benefit of catching asymptomatic spread of the disease since all healthcare workers would be tested. If governments could catch highly infectious diseases and implement countermeasures early, this could possibly prevent new viruses from erupting into another epidemic/pandemic.

Study finds ways to improve scholarly writing

esearchers from the University of Arizona and the University of Utah recently examined why most scholarly research is misinterpreted by the public or never escapes the ivory tower and suggested that such research gets lost in abstract, technical, and passive prose.

The study, forthcoming in the Journal of Marketing, is titled "Marketing Ideas: How to Write Research Articles that Readers Understand and Cite" and is authored by Nooshin L. Warren, Matthew Farmer, Tiany Gu, and Caleb Warren.

From developing vaccines to nudging people to eat less, scholars conduct research that could change the world, but most of their ideas either are misinterpreted by the public or never escape the ivory tower.

Why does most academic research fail to make an impact? The reason is that many ideas in scholarly research get lost in an attic of abstract, technical, and passive prose. Instead of describing "spilled coffee" and "one-star Yelp reviews," scholars discuss "expectation-disconfirmation" and "postpurchase behavior.'

Instead of writing "policies that let firms do what they want have increased the gap between

the rich and the poor," scholars write sentences like, "The rationalization of free-market capitalism has been resultant in the exacerbation of inequality." Instead of stating, "We studied how liberal and conservative consumers respond when brands post polarizing messages on social media," they write, "The interactive effects of ideological orientation and corporate sociopolitical activism on owned media engagement were studied."

Why is writing like this unclear? Because it is too abstract, technical, and passive. Scholars need abstraction to describe the theory. Thus, they write about "sociopolitical activism" rather than Starbucks posting a "Black Lives Matter" meme on Facebook. They are familiar with technical terms. such as "ideological orientation," and they rely on them rather than using more colloquial terms such as "liberal or conservative."

Scholars also want to sound objective, which lulls them into the passive voice (e.g., the effects... were studied) rather than active writing (e.g., "we studied the effects..."). Scholars need to use some abstract technical and passive writing. The problem is that they tend to overuse these practices without realizing it.

When writing is abstract, tech-

nical, and passive, readers struggle to understand it. In one of the researchers' experiments, they asked 255 marketing professors to read the first page of research papers published in the Journal of Marketing (JM), Journal of Marketing Research (JMR), and Journal of Consumer Research (JCR). The professors understood less of the papers that used more abstract, technical, and passive writing compared to those that relied on concrete, non-technical, and active writing.

As Warren explains, "When readers do not understand an article, they are unlikely to read it, much less absorb it and be influenced by its ideas. We saw this when we analyzed the text of 1640 articles published in JM, JMR, and JCR between 2000 and 2010. We discovered that articles that relied more on abstract, technical, and passive writing accumulated fewer citations on both Google Scholar and the Web of Science.'

An otherwise average JM article that scored one standard deviation lower (clearer) on our measures of abstract, technical, and passive writing accumulated approximately 157 more Google Scholar citations as of May 2020 than a JM article with average

Twitter Spaces available for users with at least 600 followers

aking on invite-only audio chat app Clubhouse, Twitter has announced to make its live audio conversation app Spaces available to users with 600 followers or more on both iOS and Android platforms.

The company said it is also working on 'Ticketed Spaces' feature for hosts to be rewarded for the experiences they create by getting monetary support, while providing listeners with exclusive access to the conversations they care about most.

Hosts can set ticket prices and how many are available to sell.

A limited group will be able to host Ticketed Spaces in the coming months. Hosts earn the majority of the revenue from ticket

sales and Twitter will keep a small amount as well.

To make it easy to track what's happening and when, you'll also be able to schedule and set reminders for upcoming Spaces in the coming weeks. On Twitter for iOS and An-

droid, when someone you follow starts or speaks in a Space, it'll appear at the top of your timeline as a purple bubble for as long as it's live. 'When you join a Space as a

listener, you can react to what you hear with emojis, check out any pinned Tweets, follow along with captions, Tweet or DM the Space, or request to speak," the company said in a statement late on Monday.

After first testing Spaces with a small group of people on iOS, Twitter in March expanded the test to Android users in India, to give them a chance to join, listen, and speak in live, host-moderated audio conversations.

According to the company, when you join a Space as a speaker, in addition to talking, "you can pin Tweets to the Space, turn on captions so everyone can follow along with what you're saying, and Tweet the Space so your followers can join"

"Invite people to join by Tweeting or DM'ing them to jump in and then invite them to speak directly from your Space. From there, talk about whatever is happening in your world," Twitter said.

Twitter has also provided safety controls to hosts and speakers.

A host can mute speakers and take away their mic, or remove them from the Space completely if they are found misbehaving.

TSUNAMI THEORY HAS "SUPPORT" IN KASHMIR

SRINAGAR - The report on April 17 that a retired Atomic Energy Department scientist had attributed the Asian tsunami to planetary alignment has come as a boost for those who believe that cosmic changes influence events on earth. A Kashmiri Nagash Ghulam Jeelani who says he has written

about the phenomenon of interplanetary and cosmic forces having a bearing on what happens on earth as far back as IW1, feels vindicated by the report. Also, he takes issue with the view by some scientists

I hat (he earthquake which caused the Asian tsunami might have changed the earth's spin, Naqash says: "My point is that if at all there is a connect ion between earth's spin, wobble, axial till and the tsunami, then the wobble, or change in spin or axial tilt must have occurred first, causing the Asian tsunami.'

"Because, primarily my opinion is based on the observation that cosmic changes or forces, and interplanetary changes affect intra-planetary activities and phenomena.'

Nagash says that he has neither the resources nor the equipment to collect data about natural disasters but his opinion stems, among other things, from "observations" about the varying frequency of incidence of events such as earthquakes, appearance of comets, cyclones and formation and extinction of geographical features, "which have sometimes occurred at a high rate of movement and sometimes at a comparatively low rate.

Paramahatnsa Tewari, the retired Atomic Energy Department scientist, had said that his conclusion about the causes of the tsunami stems from his theory that all spinning cosmic objects including the sun develop electric fields that repel each other.

According to Tewari on December 26, 2004 when the Saturn, Moon. Earth and the Sun were perfectly aligned, there was an imbalance of these electrical forces on Earth, because the repulsive force due to Sal urn was reduced as it as shielded by the Moon which does not spin, while the Sun, which was on the other side exerted its force on Earth.

Tewari had said that the imbalance pushed solid earth away from the sun causing sc water to overflow due to its fluidity, causing the tsunami.

Runaway surge

ith daily coronavirus cases on Tuesday reaching a record 4650, Jammu and Kashmir government has extended the lockdown till May 10 in five districts of J&K. The districts are Srinagar, Baramulla, Budgam, Srinagar and Jammu. Kashmir Valley itself continues to post a new record every day. Out of 4650 cases, Kashmir Valley had 3187 cases and Jammu 1463.

Also, 37 COVID-19 deaths have been reported, so far 25 from Jammu Division and 12 from Kashmir Division. J&K has now 37,302 active positive cases to date while 1,52,109 have recovered. The UT has recorded 2458 deaths so far. As already reported there has been 700 percent rise in new infections in the UT and that too in a matter of few weeks. Going forward, the curve is unlikely to flatten, despite the strict "corona curfew" and its extension. The reason for this is that there's now a full blown community transmission. So, the spread could mainly be triggered inside homes, where people don't use masks and sit close to one another. And with the new variant of the virus alleged to be thrice more infectious than that of last year, it will take a community driven effort than the government measures alone to reign it in. And as we have time and again advocated in this space, the lockdown extended beyond a point will do more harm than good. More so, in a place that has largely been shut down over the last two years. So, the government has to think of more imaginative ways to get a grip on the runaway pandemic.

The administration needs to focus its attention on the stupendous challenge on hand. Any further rise in the cases could plunge Kashmir into a deeper chaos. That is, if it hasn't already. So, the government has to step up. It doesn't have many options. For example, the lockdown can't be extended endlessly after the economic devastation it caused last year. Government has to resort to innovative measures to ensure that the rising curve of the cases is flattened and that the healthcare infrastructure is upgraded to deal with the fresh cases. This can be done if the administration involves civil society and NGOs in the effort. Under the circumstances, a deliberately promoted culture of self-restraint by people and the widespread observance of the Standard Operating Procedures will see us through. Second, the administration has to take firm action against the people who go out without masks or participate in large gatherings. These are the only pragmatic and hopefully helpful tools to tackle the contagion. That too, with least damage to the economy.

2021-22 needs a new economic blueprint

t is now clear that the second Covid-19 wave will continue to inflict great destruction across India in the coming weeks, as it has done in the past month. It is also clear that unless this second wave can be tamed and infections brought under control, economic activity in the country will continue to shrink. There are localised restrictions in various states and cities in order to curb the spread of the disease. But alongside, there is a deep sense of fear among citizens — who, remember, are also the primary economic agents as producers and consumers. Till the health crisis is addressed, the fear won't diminish, and till fear doesn't diminish, the possibility of the resumption of any kind of normal economic life is dim.

And that is what makes it incumbent on the State to step in with a new economic plan. Given how badly the first quarter has been hit, optimistic projections of economic recovery this year will not hold. Within a month of fiscal year 2021-22, it is also clear the Union budget numbers will not hold, tax revenues will dip, expenditure requirements will increase, pushing through contentious structural reforms will become more difficult (and may not even be advisable), and the State's

responsibility for welfare of the vulnerable will only increase. The central government must draw up a new economic blueprint for the year — this can retain a degree of flexibility given the fluidity of the situation, but it needs to be based on realistic goals, timelines and numbers. This will also allow the Union government to assess the urgent needs of the time particularly income support to the poor, concessions to the middle class, and perhaps policy tweaks to help the private sector, especially micro, small and medium enterprises, survive and stay the course — and find the required resources

Israel, an Apartheid State

Indeed, as Israel's Jewish supremacism became more explicit in recent vears, it has become harder to argue against its classification as an apartheid state. How can a rights organisation, or anyone else continue to deny that Israel is an apartheid state after the Israeli Prime Minister, Benjamin Netanyahu, proudly stated that "Israel is not a state of all its citizens ... Israel is the nation-state of the Jewish people and them alone"?

n April 27, the leading international NGO Human Rights Watch (HRW) issued a 213-page report, titled "A Threshold Crossed", condemning Israel for "committing the crimes against humanity of apartheid and persecution against Palestinians" in the occupied Palestinian territories (OPT) and in

Israel itself. The report undoubtedly marks the crossing of a threshold for the rights group, which has long been shying away from such overt and comprehensive criticism of Israel, to the frustration of Palestinians and advocates of Palestinian

But the threshold that the report's name ostensibly refers to is a legal one that, in HRW's analysis, Israel has finally crossed. "While much of the world treats Israel's halfcentury occupation as a temporary situation that a decades-long 'peace process' will soon cure, the oppression of Palestinians there has reached a threshold and a permanence that meets the definitions of the crimes of apartheid and persecution," said Kenneth Roth, executive director of HRW.

So, according to the group, Israel's crimes against Palestinians have reached such severity that they can now be considered as crimes against humanity - crimes deemed by the international community to be some of the most serious, potentially warranting the most serious punishment.

But the designation of Israel's settler-colonial endeavour as a form of apartheid is nothing new. "anartheid The legal term long been used to characterise Israel's actions against Palestinians.

The 1973 Apartheid Convention and the 1998 Rome Statute of the International Criminal Court define apartheid as systematic and institutionally entrenched domination and repression by one racial group over another through "inhumane acts". Among such acts are: "arbitrary arrest and illegal imprisonment of the members of a racial group"; measures "designed to divide the population along racial lines by the creation of separate reserves and ghettos for the members of a racial group or groups"; "forcible transfer"; "expropriation of landed property"; and denial of "the right to leave and to return to their country, [and] the right to a nationality". All these have been part and parcel of Israel's settlercolonial project in Palestine since the very beginning. And UN diplomats, legal scholars and activists have applied the concept of apartheid to Israel since at least

In 1975, the United Nations General Assembly passed Resolution 3379, which declared Zionism to be a form of racism - later rescinded due to Israeli pressure. Although not defining Israel as an apartheid state, the Resolution made that association explicit. It based its equation of Zionism with racism on previous resolutions, including the 1963 Resolution 1904 (XVIII), which affirmed that "any doctrine of racial differentiation or superiority is scientifically false, morally condemnable, socially unjust and dangerous". Resolution 3379 also drew a line tying Israel to "the racist regimes in Zimbabwe and South Africa", which were "organically linked in their policy aimed at repression of the dignity and integrity of the human being" Other UN debates in this period also recognised the "collusion" of Israel, Zionism, and South Africa's apartheid regime, as in Resolution 3151 of 1973.

After visiting the Holy Land in 2002, Archbishop Emeritus Desmond Tutu, widely regarded as "South Africa's moral conscience" said what he saw in Israel's treatment of Palestinians reminded him "so much of what happened to us Black people in South Africa". an observation he has since reiterated. Since 2005, student activists on campuses across the globe have been organising educational events during "Israel Apartheid Week". These events are staged to raise awareness of the Palestinian liberation struggle and to highlight the similarities between Palestinians' efforts and the South African anti-Apartheid movement. And in 2017, ESCWA, a UN body, issued a report on Israel's apartheid practices against Palestinians.

Although the HRW report refers to some other applications of the concept of apartheid to define Israel's actions against Palestinians, it focuses on presenting "a detailed legal analysis based on the international crimes of apart heid or persecution". More than

just a legal category, however, the notion of apartheid is a moral and political designation, and this is what makes it so contested and powerful. By giving their report announcement the hashtag #Courage2FightApartheid, HRW acknowledged how political this legal analysis really is, perhaps also hinting at why it has taken the group so long to publicly accept a reality recognised by so many across the world for decades.

Whether HRW's decision to recognise Israel as an apartheid state will be a watershed moment in the decades-old Palestinian struggle and instigate political change remains to be seen. Recent events - such as the February 5 International Criminal Court decision affirming its territorial jurisdiction over the OPT, the January report by Israeli NGO B'Tselem also labelling Israel an "apartheid state", and pitched battles over the International Holocaust Remembrance Alliance's definition of anti-Semitism that seeks to silence criticism of Israel – already suggest that a tipping point may be approaching.

Indeed, as Israel's Jewish supremacism became more explicit in recent years, it has become harder to argue against its classification as an apartheid state. How can a rights organisation, or anyone else continue to deny that Israel is an apartheid state after the Israeli Prime Minister, Benjamin Netanyahu, proudly stated that "Israel is not a state of all its citizens ... Israel is the nationstate of the Jewish people and them alone

How can they deny that Israel is committing the crime against humanity of apartheid after the Israeli parliament passed the Jewish Nation-State Basic Law which denies the rights of Palestinian citizens of Israel, who make up 20 percent of the country's population?

The HRW report is undoubtedly a positive development and a step in the right direction. But the question we are facing today is not whether Israel is an apartheid state. The question is, when will the international community act in concert to put an end to its obvious and obviously reprehensible system of oppression?

Corporal Punishment — Taking the Debate Forward

s the ghost of the COVID-19 virus continues to sleep Kashmir to nightmares exacerbated by the scenario in India, an issue that had somehow managed to give people something else to the debate was the rude behaviour of the teacher, who in a video, that went viral on social media, was seen slapping his student thirty-one times.

The incident tempted many people to share their views, many of which revealed a strong criticism and resentment against the teacher, while some flagged their defence in his favour. In the spirit of taking this debate forward, two articles, one on Kashmir Life and the other on Kashmir Observer were published. The former was written under the title 'Why jailing a teacher is the real tragedy for the society," and the latter titled "Why defending a jailed teacher is the real tragedy for the society" appeared after few days, countering the arguments rather the narrative put forth by the first piece in support of the teacher.

The second article skillfully exploited the loopholes of the first narrative and looked as right as rain. The author, while deconstructing the first write up, had also pointed out the flawed terminology used in it. The second article makes it easy to side with it given the way the author has tackled and interpreted the notion put forth by the former write up.

But having said all this, there are few things which deserved a place in both the articles. We see the author of the later write-up "Why defending a jailed teacher is the real tragedy for society," at the beginning of the piece spoke of violence and its ability to transude into the lives of the people. Thus, touching the very nature of the place we live in. However, throughout

the article, the political implications of this move remained untouched, if at all they exist. The author further used an autobiographical account at the end of his response which was again political, wherein he described the army man's incident. But, that seemed to have found a place in the article only to further crush the initial narrative.

The later article, despite citing an incident around politics, hasn't bothered to reflect on the political motivations or implications the move might have. The laws whose implementation by their nature is discriminatory didn't deserve a debate. Despite the mighty display of the law execution by the enforcing agencies, the action by its very nature doesn't free itself from the violence, which according to the author, by the very nature of the society sieves into the minute aspects of our lives. Because the implementation of such discriminatory laws are fundamentally a form of violence for the condemnation of which a debate should have been conceived

Conflict may have gifted us a certain degree of dementia but incidents like these must wake us up to the true nature of the society we have been living in. Awakening to an only certain set of stimulus would only wrap us in the apparels of the bodies that see all as equals but some as more equal.

Qazi Alif Din: The Great Arbitrator and Reformer of Poonch

Qazi Alif Din passed away in Dardunia village in Poonch on December 29th 2020 at the age of 105



he article 39-A of the constitution provides for free legal aid to the marginalized and disadvantaged communities with an aim to promote justice. Articles 14 and 22(1) of the Constitution also makes it compulsory for the State to guarantee equality before the law. In 1987, the Legal Services Authorities Act was enacted by the Parliament, which came into force on 9th November 1995 to establish a nationwide uniform network for providing free and competent legal services to the weaker sections of the society who cannot afford to hire lawyers to plead their cases in courts. In addition to it, the Government has also provided a mechanism called Lok Adalat which is one of the alternate dispute redressal mechanisms where cases or disputes incomplete in the court of law are compromised cordially in presence of Judicial officers. The lok adalat finds its basis in the preamble of the constitution wherein securing social, economic and political justice is right of every citizen. The Lok Adalat has a chairman, two members, and one social worker. The chairman must be a sitting or retired judicial officer. The other two members should be a lawyer. From a tehsil to district to state to national level there are various legal services authorities. Under the Legal Services Authorities Act. 1987 Lok Adalats have been given statutory status and the decision made by the Lok Adalat is considered to be a verdict of a civil court and is ultimate and binding on all parties. There is no provision for an appeal against the verdict made by Lok Adalat.

In addition these legal services authorities or lok adalats there are public many spirited citizens in the society who do similar work but they are the unsung heroes of society. These people whom God has bestowed with great acumen and cleverness do the arbitration in their respective communities. In this alternate disputes redressal mechanism the arbitrator's decision is accepted by both parties. Through this article I am paying my tribute to one such great arbitrator and social worker of Poonch district who had devoted his life towards addressing public issues and above all fighting against social evils in the society.

Who was Qazi Alif Din ?

Qazi Alif Din was one of the great arbitrators of Poonch district. He was given the title of Qazi by his community. Qazi is an Arabic word which means judge. Qazi sahib was born in the year 1915 in village Kalai of district Poonch to the family of Abdul Haleem. During the partition of 1947, Qazi sahib migrated to Pakistan but came back to his ancestral village after living in Rawalpindi for some years. Family condition and non-availability of formal schools those days around his village didn't allow him to acquire any school education. But this didn't deter him in seeking knowledge and informal education. When he was around 26



or 27, Qazi Alif Din started learning urdu and he went on to become one of the finest hands in urdu handwriting. He also learnt Quran when he was in his 30's and memorized a major portion of it as well. He studied Quran exegesis by various exegete of repute and acquired great knowledge of Muslim

Alif Din as an arbitrator

The Tribal method of adjudication of disputes mostly relate to family, property and land. He was far and wide known for making informal dispute resolution methods by way of arbitration most attractive in Poonch. The modern method of lok Adalat as mentioned above in many ways is similar to tribal arbitration. There are cases which are certainly less effective in terms of final dispute resolution but as for Qazi Ali Din is considered, his style of arbitration used to be the best among other tribal arbitrators. Because of this god gifted arbitration acumen Qazi sahib was known for his abilities and wits not only in district Poonch but even in other parts of Pir Panjal region vis a vis adjudication of property and matrimonial disputes. On numerous occasions he was called by executive and judicial officers to seek his opinion and ground situations about various issues

Crusade against money lenders

One of his major services to the poor and underprivileged people of Poonch was relieving them from the menace of compound debt. Rural informal credits were supplied at very high rates making the return extremely difficult for poor peasants. There was a group of people involved in providing

credits on huge interest and then they would ruthlessly exploit the poor. On many occasions the land of these people would be taken away by these money lenders. He helped many aggrieved by way of arbitration by bringing down the interest rates to the banking system and sometimes helping them in paying back the principle amount only. This brought him in conflict with informal money lenders and things became very ugly as well on some

Caste neutrality

During the time of the worst division of society along caste lines, he was able to maintain a caste neutral image for himself that helped him engage with all sections of society to maintain an environment of understanding and mutual respect. He was particularly famous among the poorer and those still on the margins of society. Qazi sahib was always prepared to help them in all matters. He was among very few people who remained uninfluenced by multiple waves of divisions that swept the region. During high days of militancy, he had become a point man to represent people who were sandwiched in insurgency. In matters of politics, he always advocated against voting for a person of his caste if he didn't have merit to his side. He always supported a person or persons who have had an attitude for public relations and stood above caste prejudices.

Qazi Alif Din didn't associate himself to any of the sects of Islam. He remained equidistant to all sects. He always believed that all sects carry a certain amount of truth and it is the clergy that make artificial difference look real. According to him, there is no difference in the basics, it is only the specifics where clerics differ and that common masses have nothing to do with those differences. Throughout his life he stood rock solid against fake faith healers who would loot and exploit people. There are many anecdotes where he personally chased away fake Pir's from villages and ran a campaign against them. His campaign was particularly successful as he could adequately maintain a reputation of being totally sect neutral. Qazi Alif Din passed away in Dardunia village in Poonch on December 29th 2020 at the age of 105. He was laid to rest at his ancestral graveyard where hundreds participated in his funeral

n the past several weeks, the world has looked on in horror as the coronavirus rages across India. With hospitals running out of beds, oxygen and medicines, the official daily death toll has averaged around 3,000. Many claim that number could be an undercount; crematoriums and cemeteries have run out of space.

The majority of India's population are Hindu, who favor cremation as a way of disposing of the body. But the Muslim population, which is close to 15%, favors burying its dead.

Generally, tradition holds that the body is to be cremated or buried as quickly as possible – within 24 hours for Hindus, Jains and Muslims, and within three days for Sikhs. This need for rapid disposal has also contributed to the current crisis.

Hundreds of families want their loved ones' bodies cared for as quickly as possible, but there is a shortage of people who can do the funerals and last rites. This has led to a situation where people are paying bribes in order to get space or a furnace for cremation. There are also reports of physical fights, and intimidation.

Do you value independent, non-profit news?

As a scholar interested in the ways Asian societies tell stories about the afterlife and prepare the deceased for it, I argue that the coronavirus crisis represents an unprecedented cultural cataclysm that has forced the Indian culture to challenge the way it handles its dead.

Cremation grounds and colonial rule

Many Americans think of cremation happening within an enclosed, mechanized structure, but most Indian crematoriums, known as "shmashana" in Hindi, are open-air spaces with dozens of brick-andmortar platforms upon which a body can be burned on a pyre made of wood.

Hindus and Sikhs will dispose of the remaining ashes in a river. Many shmashana are therefore built near the banks of a river to allow for easy access, but many well-off families often travel to a sacred city along the banks of the river Ganges, such as Hardiwar or Benares, for the final rituals. Jains - who have traditionally given significant consideration to humanity's impact on the environmental world – bury the ashes as a means to return the body to the Earth and ensure they do not contribute to pol-

The workers who run shmashana often belong to the Dom ethnicity and have been doing this work for generations; they are lower caste and subsequently perceived as polluted for their intimate work with dead bodies.

Altered Mourning



The act of cremation has not always been without controversy. In the 19th century, British colonial officials viewed the Indian practice of cremation as barbaric and unhygienic. But they were unable to ban it given its pervasiveness.

However, Indians living in the United Kingdom, South Africa and Trinidad often had to fight for the right to cremate the dead in accordance with religious rituals because of the mistaken and often racist belief that cremation was primitive, alien and evironmentally polluting.

Rituals and a long history

The earliest writings on Indian funerary rituals can be found in the Rig Veda - a Hindu religious scripture orally composed thousands of years ago, potentially as early as 2000 B.C. In the Rig Veda, a hymn, traditionally recited by a priest or an adult male, urges Agni, the Vedic god of fire, to "carry this man to the world of those who have done good deeds.'

From the perspective of Hindu, Jain, and Sikh

rituals, the act of cremation is seen as a sacrifice, a final breaking of the ties between the body and the spirit so it may be free to reincarnate. The body is traditionally bathed, anointed, and carefully wrapped in white cloth at home, then carried ceremonially, in a procession, by the local community to the cremation grounds.

While Hindus and Sikhs often decorate the body with flowers, Jains avoid natural flowers for concern of inadvertently destroying the lives of insects that may be hidden within its petals. In all of these faiths, a priest or male member of the family recites prayers. It is traditionally the eldest son of the deceased who lights the funerary pyre; women do not go to the cremation ground.

After the ceremony, mourners return home to bathe themselves and remove what they regard as the inauspicious energy that surrounds the cremation grounds. Communities host a variety of postmortem rituals, including scriptural recitations and symbolic meals, and in some Hindu communities the sons or male members of household will shave

their head as a sign of their bereavement. During this mourning period, lasting from 10 to 13 days, the family performs scriptural recitations and prayers in honor of their deceased loved one.

The changing times of COVID-19

The wave of death from the COVID-19 pandemic has forced transformations to these long-established religious rituals. Makeshift crematoriums are being constructed in the parking lots of hospitals and in

Young women may be the only ones available to light the funerary pyre, which was previously not permissible. Families in quarantine are forced to use WhatsApp and other video software to visually identify the body and recite digital funerary rites.

Media reports have pointed out how in some cases, crematorium workers have been asked to read prayers traditionally reserved for Brahmin priests or people from a higher caste. Muslim burial grounds have begun to run out of space and are tearing up parking lots to bury more bodies.

The work of the dead

While other important rituals such as marriage and baptism may take on a new appearance in response to cultural changes, social media conversations or economic opportunities, funerary rituals change slowly.

Historian Thomas Laqueur has written on what he calls "the work of the dead" – the ways in which the bodies of the deceased participate in the social worlds and political realities of the living.

In India's coronavirus pandemic, the dead are announcing the health crisis that the country believed it had conquered. As recently as April 18, 2021, India's Prime Minister Narendra Modi was holding crowded political rallies, and his government allowed the massive Hindu pilgrimage festival of Kumbh Mela to proceed a year early in response to the auspicious forecasts of astrologers. Authorities began to act only when the deaths became impossible to ignore. But even then, the Indian government appeared more concerned about removing social media posts that were critical of its functioning.

India is one of the world's largest vaccine-producing nations, and yet it was unable to make or even purchase the needed vaccines to protect its

States' power to identify backward classes abrogated by 102nd Constitutional amendment: SC

by a majority 3:2, on Wednesday held the 102nd Constitutional amendment, which also led to setting up of National for Backward Commission Classes (NCBC), took away states' power to identify socially and educationally backward classes under their territory for grant of quota in jobs and admissions.

102nd Constitution amendment Act of 2018 inserted Articles 338B, which deals with the structure, duties and powers of the NCBC, and 342A which deals with power of the President to notify a particular caste as SEBC and power of Parliament to change the list.

A five-judge Constitution bench headed by Justice Ashok Bhushan, in their four separate verdicts, however, was unanimous on other key issues such as the Maratha quota law was invalid and the 1992 Mandal judgement, capping total reservation to 50 per cent, did not need a relook or reference to larger bench.

While Justice Bhushan wrote 412-page long verdict for himself and Justice Nazeer and was in minority on the point whether the 102 Constitutional amendment takes away the right of states to identify SEBC.

Justice S Ravindra Bhat wrote 132-page long verdict and Justices L Nageswara Rao and Hemant Gupta, in their separate judgements, concurred with Justice Bhat and his reasoning in holding that states have lost their power to identify SEBC under their territory after 102nd Constitutional amendment.

Writing the majority judgement on this aspect, Justice Bhat, said, By introduction of Articles 366 (26C) and 342A through the 102nd Constitution, the President alone, to the exclusion of all other authorities,

is empowered to identify SEBCs and include them in a list to be published under Article 342A 1), which shall be deemed to include SEBCs in relation to each state and union territory for the purposes of the Constitution.

The states can, through their existing mechanisms, or even statutory commissions, can only make suggestions to the President or the Commission, for inclusion, exclusion or modification of castes or communities in the SEBC list, Justice Bhat said.

The states' power to make reservations, in favour of particular communities or castes, the quantum of reservations, the nature of benefits and the kind of reservations, and all other matters falling within the ambit of Articles 15 and 16 except with respect to identification of SEBCs, remains undisturbed, the judgement, endorsed by two other judges, said.

All the five judges of the bench, however, held the 102 Constitutional amendment as valid and it did not affect the federal polity and did not violate the basic structure of the Constitution.

Article 342A of the Constitution by denuding States power to legislate or classify in respect of 'any backward class of citizens' does not affect or damage the federal polity and does not violate the basic structure of the Constitution of India, Justice Bhat said.

All judges also concurred on aspects such as the Indra Sawhney judgement, also known as the Mandal verdict, did not require to be referred to a larger bench.

They also concurred on the issue that the Maharashtra State Reservation (of seats for admission in educational institutions in the State and for appointments in the public services and posts under the State) for Socially and Educationally Backward Classes (SEBC) Act granting 12 and 13 per cent reservation for Maratha community in addition to 50 per cent social reservation is not covered by exceptional circumstances as contemplated in Mandal judgement.

The state government, on the strength of the Maharashtra State Backward Commission Report chaired by M C Gaikwad has not made out a case of existence of extraordinary situation and exceptional circumstances in the state to fall within the exception carved out in Indra Sawhney judgement, Justice Bhat said.

All judgements said the appointments made in government jobs and admissions in post graduate courts after the Bombay High Court verdict of 2019 upholding Maratha quota and September 9, 2020 order of the top court staying the implementation of quota will not be affected.

Body Of BJP Leader's Mother Lies In **Morgue As Family Goes Into Hiding**

BURDWAN (WB): Kakali Kshetrapal, mother, was killed in post-poll clashes in West Bengal's Purba Bardhaman but her body has been lying in the morgue for two days as her family members went into hiding after police started a hunt for them in connection with the murder of two TMC workers.

Clashes broke out in Nabagram in the Jamalpur police station area between the supporters of the TMC and BIP on Monday, a day after the election results were announced.

Kakali (47), the mother of BJP's Nabagram area chief Ashish Kshetrapal, was allegedly killed in the clashes. TMC workers Shajahan Shah (30) and Bibhash Bagh (27) were also allegedly killed, police said.

Soon after the incident, central forces were deployed in the area and police started a manhunt, following which Kakali's family members along with several local BJP leaders went into hiding.

Police said on Wednesday that they have arrested 11 people in connection with the incident based on the complaints filed by both the parties.

Even as Kakali's body was lying in Jamalpur Hospital for a long time on Monday none of the BIP leaders went there, local party workers said.

Later, police took the body to Jamalpur police station. On Tuesday, the body was sent to the police morgue in Burdwan Medical College and Hospital for post-mortem and it has been lying there ever since.

Venting frustration, local BJP workers said that none of the party's leaders went to the hospital even for once.

On the other side, several TMC leaders visited the village after the clashes and were through out with the family members of the two party workers killed.

The officials said while the restrictions are being implemented strictly, essential and emergency services are allowed.

The officials said shops, fuel stations and other business establishments were shut across the valley, while public transport was off the roads.

On April 29, the Jammu and Kashmir administration imposed a curfew in 11 districts in a bid to tackle the surge in COVID-19 cases, which was subsequently extended to all the 20 districts the next day.

The curfew, which was supposed to end at 7 am on May 3, was extended in the twin capitals of Jammu and Srinagar besides Budgam and Baramulla till 7 am on Thursday.

However, the authorities in other districts of the valley also ordered the extension in the restrictions till Thursday.

The state on Tuesday recorded its biggest single-day spike with 4,650 fresh COVID cases, taking the tally to 1,91,869, even as 37 fatalities over the last 24 hours took the toll to 2,458, officials said.

Out of the fresh cases, 1,463 were from the Jammu division and 3,187 from the Kashmir division of the union territory, they said.

The officials said Srinagar district recorded the highest of 1,311 cases, followed by 598 in Iammu district and 417 in Anantnag district.

The number of active cases has reached 37,302 in the union territory, while 1,52,109 patients have recovered so far, the officials said.

The death toll in the union territory due to the pandemic rose to 2,458 as 37 fresh deaths -- 25 in Jammu region and 12 in Kashmir valley -- were reported in the past 24 hours.

The authorities in Jammu issued an order on Wednesday deferring routine surgeries in government and private health institutions in the division, owing to the ongoing surge in COVID-19 cases.

Issued by Divisional Commissioner Raghav Langer, the order, however, said emergency services and critical care required for co-morbid and dialysis patients, and maternal and child health services would continue as usual.

"In view of the prevailing situation of COVID-19 pandemic in Jammu Division which demands optimal utilisation of available resources so that the existing infrastructure/ healthcare facilities are not overburdened, the elective/routine surgeries are required to be deferred," Langer said in the order.

He said the main focus of the healthcare system at this juncture was the management of COVID-19 cases.

"All elective/routine surgeries shall be deferred in government as well as private health institutions in the division; unless there are pressing medical reasons and the benefits of such procedure outweigh the risk related to COVID-19 situation and its fallout," the order said.

Langer directed district magistrates and chief medical officers to conduct random inspections and audits of healthcare institutions to enforce compliance of the order.

"The order shall be reviewed periodically based on the evolving COVID-19 situation," he

across the Kashmir Valley.

The directions in this regard were passed by the Lt Governor Manoj Sinha in a series of meetings with senior Doctors and Chief Medical Officers of Kashmir Division here at Civil Secretariat, in which he reviewed the Covid-19 situation and containment measures put in place to effectively control the spread of coronavirus, an official spokesperson said.

The LG, he said, directed the health department officials to increase additional 1050 oxygen beds in Kashmir division within a week to ensure immediate treatment for the people requiring hospitalization. Sinha said that the move will substantially improve the health infrastructure and help out patients in the hour of crisis.

According to the official spokesperson, the LG emphasized on taking comprehensive measures for better patient care management and directed CMOs of Kashmir Division to ensure triaging and judicious referrals. He said that District Hospitals are fully equipped to handle Covid cases with present deployment of best

"The Lt Governor further directed for effective and prompt availability of Ambulance services so that Ambulances are made available to needy, as and when required," the official spokesperson said.

He further said that the LG asked the Doctors to talk to people at religious gatherings and create awareness regarding Covid-19 SOPs. besides highlighting the information related to Covid control measures through various communication media.

"Our priority is to break the chain of virus for which combined & collective efforts need to be taken to save precious human lives," said Sinha, as per official spokesperson.

"Vaccination must be done on war footing to reduce the mortality rate. Focused attention needs to be given towards Covid-19 testing and contact tracing, besides speedy completion of the process of the first dose of vaccination," he added.

In order to reach out to the people with vaccination, the LG instructed for starting vaccination in each municipal ward through dedicated teams. He further called for deployment of more mobile vans for vaccination purpose.

As per the official spokesperson, SMC Commissioner, Athar Amir Khan informed the meeting that mobile vans are operating in 36 municipal wards, which will be increased in coming days.

The official spokesperson said that the LG asked the Health Officers to put in all out efforts to further improve the functioning of health institutions. Senior Doctors must reach out to every patient admitted in the hospitals, he maintained.

"The Lt Governor also received the first hand appraisal about the functioning of Oxygen generation plants and passed specific directions for ensuring sufficient availability of Oxygen supply in all health institutions. It was informed that a few oxygen plants will become functional by the end of this week," he added.

He further said that Sinha instructed the concerned officers to ensure that all newly installed Oxygen plants have a back up buffer stock of oxygen cylinders. He further called for rational utilization of oxygen supply in all hospitals so that patients do not face any inconvenience.

"The Lt Governor directed the CMOs to utilize maximum available resources for patient care at their respective health institutions, besides extending online consultation of doctors to patients to overcome the unnecessary rush of patients in hospitals," the official spokesper-

"The Lt Governor asked the CMOs to hire meritorious medical graduates to strengthen human resources in the health sector. He further asked them to identify the doctors and other paramedical staff who have retired from government services and keep close liaison with them," he added.

As per the official spokesperson, the LG lauded the Medical fraternity for their tireless efforts in fight against the deadly virus and urged them to work with added zeal and dedication in a well coordinated manner to defeat

According to the order, Prem Singh has been posted at GMC, Jammu; Mushtaq Ahmad Simnani at SKIMS, Soura; Shabir-ul-Hassan at GMC, Srinagar; Hamida Akhter at Chest Disease Hospital, Kashmir; and Rakesh Kumar Gupta at Chest Disease Hospital, Jammu

The order stated that these officers will be responsible for coordinating the work in triage centres and ensure that appropriate medical guidance is provided by doctors in sending patients to the correct facility for treatment. They will also assist the hospital managements (director/principal) in monitoring and managing the oxygen supply and utilisation.

The officers would also ensure compliance of decisions taken by the recently formed COVID Apex Management Group headed by the chief secretary and those of respective divisional commissioners, it said.

SKIMS/Principal, "Further, Director College Government Medical (Jammu/ Srinagar) shall delegate certain powers/authority to the officers as may be required for managing COVID pandemic," the order said.

Earlier, on May 2, the Jammu and Kashmir administration had deployed 41 junior scale officers at various places, including airports and railway stations, across the union territory for assisting in coronavirus mitigation efforts.

Jammu and Kashmir reported a record single-day rise of 4,716 COVID-19 cases on Wednesday that pushed the infection tally to 1,96,585 while 52 more fatalities took the death toll to 2,510, according to officials.

lockdown ahead of the revocation of special status to Jammu and Kashmir and its bifurcation into two union territories in August 2019. He was finally arrested under the PSA from his Barzaulla residence in Srinagar in July last year. Same year Sehrai's son Junaid Sehrai was

killed by Indian armed forces in an encounter in Srinagar. Junaid had joined the Hizbul Mujahideen group in March 2018 and was later killed in an encounter with government forces in Srinagar

on May 19, 2020. Sehrai was Geelani's main supporter and aide when he launched the Tehreek-e-Hurriyat in 2004 after parting ways with the Jamaat. He was appointed as acting chairperson by Tehreek-e-Hurriyat in March 2018 and was later elected as chairperson for three years after Geelani stepped down from the post.

Born in 1944 in Tekipora village of Lolab Valley in Kupwara district Mohammad Ashraf Khan, alias Sehrai completed his primary education in his hometown and secondary education from Lolab High School in 1959. After clearing secondary examination, he moved to Uttar Pradesh where he did Bachelors from Aligarh Muslim University.

Political parties across the spectrum in Jammu and Kashmir mourned the death of Sehrai with Peoples Conference president and former minister Sajad Lone saying, "Sehrai Sahib was a political leader not a terrorist".

In a series of tweets, Lone remembered his meeting with the leader and asked, "And why did he have to die in incarceration and not at his home amongst his kin and loved ones. Have we become so weak that an old infirm dying person is a threat to the state? I am not being critical. But please introspect '

Peoples Democratic Party (PDP) president Mehbooba Mufti said numerous political leaders continue to be under detention in Jammu and Kashmir "purely" for their ideology and said "in today's India one pays a price with his life for dissent".

"The least GOI can do in such dangerous circumstances is to immediately release these detainees on parole so that they return home to their families," she wrote on twitter.

The Jammu and Kashmir Pradesh Congress Committee (JKPCC) expressed grief over the separatist leader's death in Jammu and said he was a well-known religious and scholarly figure of Kashmir.

Senior CPI (M) leader Mohammad Yousuf Tarigami said in view of the prevailing COVID-19 crisis, it would be appropriate if cases of prisoners are reviewed and those who are not involved in heinous crimes are released.

NIA Charges Pak Woman, 2 LeT Workers

NEW DELHI: The National Investigation Agency (NIA) Wednesday filed the first supplementary chargesheet against three Lashkar-e-Taiba (LeT) operatives, including an absconding Pakistani woman, in an online recruitment case registered last year in West Bengal.

The chargesheet was filed in the NIA special court, Kolkata against Tania Parveen alias Isranoor and Refite of Malayapur-Baduria (North 24 Parganas), Sayyad M Idris alias Munna of Anganavadi (Karnataka), and absconding accused Ayesha alias Ayesha Burhan and Ayesha Siddiqi of Gali Brahwali village of Sargoda in Punjab (Pakistan), an NIA spokesperson said.

The spokesperson said the case was initially registered on March 18 last year at the Baduria Police Station in North 24 Parganas district following the arrest of Parveen, a member of the proscribed Pakistan-based terrorist organisation. The NIA had re-registered the

case after taking over the investigation on April 5, 2020 and had already filed a chargesheet against Parveen under various sections of the stringent UA(P) Act. "Parveen was a college stu-

dent and was radicalised and named in the chargesheet as recruited in cyberspace by Pak-istan-based cadres of LeT. She is still going on, officials said.

The PCB had to postpone PSL-6 abruptly on March 4 with just 10 out of 34 matches completed due to COVID-19 cases among players and officials.

The tournament is scheduled to resume on June 1, with the final slated for June 20.

A letter from all six teams asking to move the remaining games of the rescheduled 2021 edition of the tournament out of Karachi to the UAE was sent to the board last week, according to a report in 'ESPNcricinfo'

The report added that the PCB is "believed to be considering the request and reviewing current plans." As per the original plan, all

teams are to assemble in Karachi by May 23 and begin their mandatory seven-day quarantine. 16 league stage matches will be played between June 2-14.

The playoffs are slated to be played between June 16 and June 18. Pakistan has witnessed a surge in cases recently and there is a partial lockdown in parts of the country.

Last week, the Pakistan government announced it will reduce the number of international flights by 80 percent to help curb rising COVID-19 cases. Last month, the PCB had appointed a two-person fact-finding panel to review the biosecurity protocols, bylaws and arrangements for the PSL-6 and make recommendations on how to better ensure implementation of a bio-se-

cure environment for future events. After the date of resumption was revealed, the teams participated in a replacement draft as several foreign players had pulled out of the event.

IPL 2021: 8 Englishmen Reach Back Home, Aussies **Await Flight To Maldives**

NEW DELHI: The Englishmen were the first ones out with eight of them landing in London, while the Australians awaited an escape to Maldives as IPL's foreign recruits charted their way back home assisted by the BCCI on Wednesday.

Jos Buttler, Jonny Bairstow, Sam Curran, Tom Curran, Sam Billings, Chris Woakes, Moeen Ali and Jason Roy landed in London to begin a 10-day quarantine before heading to their respective homes.

England skipper Eoin Morgan Dawid Malan and Chris Jordan are expected to board a flight to London within the next 48 hours. "I can confirm that 8 of the 11

England players in India managed to get on a flight to Heathrow last night and have landed this morning," an England and wales Cricket Board spokesperson told PTI.

"They will now quarantine in government approved hotels. The remaining three - Jordan, Malan, Morgan – should leave India within the next 48 hours," he added.

The Australians, on the other hand, were still waiting to know when they can fly out to Maldives, where they will stay for a few days before flying home. The detour has

been forced by the Australian government's travel ban on India till May 15 because of the explosion of COVID-19 cases here. Their Prime Minister Scott Morrison has refused to consider an exemption and Cricket Australia has also ruled out seeking one from the government.

"All Australians are assembling in Delhi and from there they will head to Maldives by a charter flight," a franchise official told PTI. CA's interim chief Nick Hockley

said the BCCI is helping in every possible way to ensure a smooth return for the 14 players, members of the coaching staff and commentators, who are in India right now. "What the BCCI is working to

do is to move the entire cohort out of India where they will wait until it's possible to return to Australia, Hockley told reporters in Sydney.

"The BCCI has been working on a range of options. That's now narrowed down to the Maldives and Sri Lanka. The BCCI is committed not only to the first move but also to putting on a charter to bring them back to Australia," he added.

IPL also featured cricketers from South Africa (11) and New Zealand (10) West Indians (9), Afghanistan (3) and Bangladesh (2).

Former Australia Spinner Stuart McGill Kidnapped **And Then Released: Police**

NE W DELHI: Former Australia leg-spinner Stuart MacGill was allegedly kidnapped from his home in Sydney and then released after an hour-long ordeal last month, New South Wales police said on Wednesday.

Quoting Australian police, the country's media reported that four men were detained in connection with the alleged kidnapping following a raid.

The incident took place on April 14 when he was bundled into a car and driven to a remote location, after which he was assaulted and threatened with a firearm.

"I know it was only an hour that he was held but it would have been a horribly frightful hour to endure," NSW Police superintendent Anthony Holton was quoted as saying by the local media.

In a press release, New South

Wales state police said an incident was reported to them on April 20.

The statement said "detectives from the robbery and serious crime subsequently commenced an investigation and four men -- aged 27, 29, 42 and 46 -- were arrested" in the early hours of Wednesday.

The police said the kidnapping was financially motivated.

"He was seen as someone that they could get money from, although no money was paid prior to him being released."

MacGill, a former leg-spin bowler, ended his international career with 208 wickets in 44 Test matches for Australia between 1988 and 2008.

His stint in top-flight was overshadowed by fellow Australian great Shane Warne, who is second on the list of all-time leading wicket takers in Test cricket

The 50-year-old MacGill retired from cricket in 2008.

'Favouritism In Pakistan Cricket,' Discarded Pacer Junaid **Khan Makes Sensational Claim**

KARACHI: Discarded left-arm pacer Junaid Khan believes players remain insecure about their future in Pakistan cricket, alleging that most cricketers get a proper run in the national team if they are close to the captain and team management.

The 31-year-old, who has picked up nearly 190 wickets in 22 Tests, 76 ODIs and 8 T20 matches, has not been selected for any format for his country since May, 2019.

"It is like if you are on good terms with the captain and team management then you will probably get a proper run in all formats to prove your worth," he said in an interview to the CricketPakistan.com website.

"If you don't have close relations with them then you are in and out." He lamented that he wasn't given a long run despite being a

consistent performer. "I used to be part of the national team in all three formats. I used to ask for rest but I wasn't given rest.

"Then came a time when I got in the bad books and was being ignored due to likes and dislikes. I was performing but was not being given a proper chance," he said. Junaid said despite being the

second-highest wicket-taker after Hasan Ali in the Champions Trophy in 2017, he was excluded from the squad, including for the World Cup 2019, after being initially named in it.

"I just got into the bad books of selectors that is all."

Junaid, however, made it clear he had not given up hope of playing for Pakistan again and was very much active on the domestic front for his province.

"I am regularly playing domestic cricket and I believe if selection is done justly I should be in consideration.

Junaid said selection in Pakistan cricket depend on which city the player belongs to.

"If you belong to a big city, then people raise their voice for you. People like me and Yasir Shah are from Swabi. There is no TV channel or media person from Swabi, so there is no pressure on selectors regarding our selection from the media," he said.

Junaid said he had "got a great offer from the United States of America (USA)" but he refused.

"I am being offered more money than what I earned while playing for Pakistan during my peak. However, I refused the offer as I still want to represent Pakistan," he said.

Bookies Tried To 'Fix' IPL Match At Kotla, Reveals Anti-Corruption Boss

NEW DELHI: The recently-suspended IPL witnessed potential corruptors plugging an accredited cleaner at Delhi's Feroz Shah Kotla ground for doing "pitch-siding" which helps ball-to-ball betting, **BCCI** Anti-Corruption Unit chief Shabbir Hussain Shekhadam Khandwawala has revealed.

The new modus operandi was observed during one of the IPL games at New Delhi where a designated cleaner was using the time lag between actual match action and live TV coverage to help in ballby ball betting, which is also known as court-siding or pitch siding.

Pitch-siding is the practice of transmitting information from sporting events for the purpose of gambling, or directly placing bets.

"One of my ACU officers caught a person and handed over the details to Delhi Police. While that particular offender managed to flee leaving behind his two mobile phones, ACU lodged a complaint with the Delhi Police," Hussain, a former DG of Gujarat Police, told PTI on Wednesday

"We are thankful to Delhi Police that in a separate incident they caught two other persons from the Kotla on ACU tip-off."

The Delhi Police arrested two people with fake accreditation cards during the IPL match between Rajasthan Royals and Sun-Risers Hyderabad on May 2.

"So on two separate days, these people managed to get access to Kotla. The one who fled came in the garb of a cleaner. However, we have all his details as he was employed for the tournament. His Aadhar Card details have been handed over to Delhi Police," Hussain said.

"I am confident that he will be nabbed in a day or two. He is a small fry working for a couple of hundred or some thousand bucks may be," the ACU supremo said.

But he did agree that lowerrung staff might be used by a big-



ger syndicate since, because of CO-VID-19, there is no access to hotels given the bio-secure measures.

'...as situations and circumstances change, so does the modus operandi of crime. But we are up for it." Hussain said

So how did cleaning staff come under the ACU radar?

"He was standing (inside Feroz Shah Kotla premises) in a secluded area all by himself and so one of our officers approached and asked him 'What are you doing here?'

"He said: 'Main apne girlfriend se baat kar raha hoon.' (I am talking to my girlfriend).

'My officer then asked him to dial the number he was talking to and then asked him to hand over the phones. Just when he was going through the contents of his phone, the guy fled from the spot," Hussain revealed but did not divulge during which match the incident took place.

What was more interesting was that he was wearing the IPL accreditation card which all the class IV staff are given during the tournament from bus drivers, to clean-

ers, porters etc. "It was one of the evening matches in Delhi. He was wearing an I-card. Also what raised suspicion was he had two mobiles." he

"The information he may be supplying could be to someone more influential among bookmakers and so we needed to inform the Delhi Police. Delhi Police has responded positively and thus next instance two people were arrested."

Hussain also confirmed that the ACU didn't receive any complaint of corrupt approaches being made to players or support staff involved in IPI during the 29 games that were held.

"Obviously with bio bubble and no crowd around, it certainly becomes a bit easier to manage as there is no physical proximity of (face to face meeting with players) questionable characters. When there is crowd, it becomes difficult to check anyone and everyone,'

Hussain said. He also said that during the Mumbai leg, the hotel in which SunRisers Hyderabad team was staying had three people with questionable past record and whose names were there in ACU database. However, they couldn't come in contact of the players.

"The moment we had information, we got in touch with Mumbai Police. The Police Commissioner of Mumbai took immediate cognisance and the Mumbai Police got hold of those three." he added.

Mary Kom, 2 Other **Olympic-Bound Female Boxers To Train At ASI Pune**

NEW DELHI: Six-time world champion M C Mary Kom, along with two other Olympic-bound boxers, will train at the Army Sports Institute in Pune leading up to the Tokyo Games after the national camp for women in Delhi had to be disbanded owing to COVID-19 cases among pugilists and support staff.

Mary Kom (51kg) will join another Olympic-bound boxer Lovlina Borgohain (69kg), who is already at the facility. Simranjit Kaur (60kg), also bound for Tokyo, will train there too but after completing the COVID-19 post-recovery isolation. The boxers will be placed in three separate groups with two sparring partners each to ensure that the risk of infection is minimal.

However, Pooja Rani (75kg), who

has qualified for the Games too, will continue to train at Bellary's Inspire Institute of Sports, which is her current base. Mary Kom will not have immediate company of her coach and former boxer Chhote Lal Yadav, who continues to be in isolation after testing positive for the dreaded infection last month. Yadav is expected to join the camp after returning a

negative test in the next few days. "I am leaving today, looking forward to it. Chhote will come in a while so it will be fine. I hope to get vaccinated also during my time there." Mary Kom told PTI.

'The training was thrown haywire after the suspension of Delhi camp but, hopefully, it will now get back on track. I might even train with the men boxers who are there at ASI, I routinely train like that to be in good shape," she said.

Now City could win the competition it tried to leave in what could be an all-English final on May 29 in Istanbul if Chelsea overcomes Real Madrid on Wednesday. Chelsea and Madrid played to a 1-1 draw in the first leg.

"Of course, we've invested money in the last decade since Sheikh Mansour took over the club, but it's not iust about this," City manager Pep Guardiola said.

"If you want to think it's just about money, it's OK. But there is a lot of incredible things behind the scenes."

It's not just City that's endured frustration in its quest to win the biggest prize in European football. Guardiola, a Champions League winner as Barcelona coach in 2009 and 2011, has been waiting a decade

"To reach the Champions league final is so difficult," Guardiola said.

"It's the toughest one, but we did it." City is now accustomed to success — sitting on the brink of its third Premier League title in four seasons after already collecting the League Cup last month. But its only continental title came with the now-defunct European Cup Winners' Cup in 1970.

"This club needed the final, these players needed the final," City defender Kyle Walker said. "For these players to not be in a Champions League final is a disappointment every year."

PSG missed out on a second shot at lifting a first European Cup after losing last season's final to Bayern Munich, and Mauricio Pochettino's lineup is even struggling to defend the French title.

"Disappointed and very sad," said Pochettino, who lost the 2019 Champions League final as Tottenham manager. "We played well but we didn't have the luck that you

could find no way past a defense that had Rúben Dias proving such a robust barrier. The PSG back-line was easier to

breach, which happened again in the 63rd minute. There was a surging run down the left flank by Phil Foden before a combination with De Bruyne and a cross delivered for Mahrez to sweep into the net.

"We fought to the end," PSG midfielder Marco Verratti said. "When you play against big teams, it's impossible to attack for 90 minutes without suffering. We have to accept that."

The frustrations of PSG were clear, even without any crowd to create any intimidating atmosphere. The visitors finished the game with 10 men just like in the first leg after Di Maria was sent off with 20 minutes to go for kicking at Fernandinho.

PSG turned on the referee, with midfielder Ander Herrera in a postmatch interview accusing Bjorn Kuipers of directing an expletive at PSG teammate Leandro Paredes. It wasn't heard by Pochettino.
