### Talks Only After India Reverses Aug 5 Move: Pak



**ISLAMABAD:** Prime Minister Imran Khan said on Tuesday that Pakistan would not hold talks with India until New Delhi reverses its decision of scrapping the special status of Jammu and Kashmir.

India abrogated the special status of Jammu and Kashmir under Article 370 on August 5, 2019 and bifurcated it into two Union territories.

"Unless India retreats from the steps taken on August 5, the Pakistani government will not talk to India at all," Khan said while responding to questions from the public during a live broadcast session.

illustrious career spanning 30 years as a commercial pilot.



# **How is MEDICAL OXYGEN**, vital for COVID-19 patients, produced?

edical oxygen has become one of the most important lifesaving commodities in the fight against COVID-19 during which patients develop pneumonia and hypoxaemia – a low blood oxygen level. Dozens of COVID-19 patients in India have died due to the acute shortage of oxygen, bringing the production and supply of this critical medical item into the global

When is medical oxygen used? How is it administered? Which countries produce the most of it? And how is it produced? We answer these questions in four graphics.

#### The impact of COVID-19 on the lungs

The Sars CoV-2 virus in many cases targets the respiratory system, leading to an inflammation of the lungs. In severe cases, this may lead to hypoxaemia, which is the leading cause of death among CO-VID-19 patients.

A blood oxygen saturation level (SpO2) above 95 percent is a healthy range for children and adults. Oxygen saturation levels below 90 percent are considered dangerous. According to the World Health Organisation (WHO), about 20 percent of COVID patients will require oxygen therapy to prevent respiratory failure.

#### Types of oxygen therapy

Oxygen can be administered in a variety

of ways. For low to moderate oxygen deficiencies, patients can be put on either a nasal cannula – a medical tube that goes through both nostrils – or on a simple or reservoir face mask. In these cases, one to 15 litres (3.3 gallons) of oxygen per minute is delivered to supplement a patient's regular breathing.

If higher volumes of oxygen are required, patients may then be placed on a highflow nasal cannula, a Continuous Positive Airway Pressure (CPAP) machine, or a ventilator. In these cases, up to 100 percent of the oxygen a person inhales comes from the oxygen cylinder. In the case of a ventilator, a continuous supply of oxygen may be required to keep a patient alive.

#### Where does medical oxygen come from?

Several countries, particularly those with low to middle incomes, are facing oxygen shortages. In India, which has seen a record number of cases in the past several weeks, an estimated 17 million cubic metres (600 million cubic feet) of oxygen is required daily.

According to the Indian Ministry of Health, only about seven million cubic metres of oxygen is being produced. This shortfall has meant that thousands of people in critical need of oxygen have been turned away and have died as a result. In 2019, according to the World Bank, out of 102 countries that are part of the medical oxygen export-import trading chain, 10 countries exported up to 80 percent. Belgium was the leading net exporter at

cent, then Portugal with 8 percent.

The air we breathe is about 78 percent nitrogen, 21 percent oxygen and 1 percent other gases, including carbon dioxide. Medical oxygen is at least 82-percent pure oxygen and is produced at industrial facilities before being delivered to hospitals in pressurised gas cylinders or in liquid form in large tanks. Over the past 30 years, most medical oxygen has been produced using the economical Pressure Swing Absorption (PSA) process which consists of three main phases:

Pressurisation: Air from the atmosphere is compressed and stored in a high-pressure vessel.

Adsorption: Air passes through molecular sieves where the nitrogen is absorbed by aluminium and silicon compounds known as zeolite. The remaining air is sent through an air buffer tank.

Depressurisation: Air passes through alternating tanks in a series of cycles to remove unwanted gases. The resulting gas is up to 96-percent pure oxygen. This oxygen is stored in a tank and can then be delivered in oxygen cylinders.

# Scientists improve method to stop viruses causing respiratory infections in children

esearchers have improved a method in rodent models intended to help keep children healthy by engineering a short chunk of protein, or peptide, that can prevent the attachment of human parainfluenza viruses

Human parainfluenza viruses, or HPIVs, are the leading cause of childhood respiratory infections, responsible for 30% to 40% of illnesses like croup and pneumonia. The viruses also affect the elderly and people with compromised immune systems. The researchers published their findings in the Journal of the American Chemical Society

To sicken people, HPIVs must latch onto cells and inject their genetic material to start making new viruses. HPIV3 is the most prevalent among these viruses. There are currently no approved vaccines or antivirals for HPIV3 infection in people. In a study led by the Sam Gellman lab in the chemistry department at the University of Wisconsin-Madison, and the lab of Anne Moscona and Matteo Porotto at Columbia University, researchers built upon years of work on peptide treatments to generate one capable of blocking the HPIV3 attachment pro-

To enter host cells, HPIVs use specialized fusion proteins that resemble three corkscrews laid side-by-side. Earlier work by the Moscona-Porotto lab showed that scientists could a partial chunk of this corkscrew protein from HPIV3, introduce this peptide to the virus, and prevent the corkscrew from driving the infection process. The peptide, itself a corkscrew, essentially zippers up with the virus's corkscrews, creating a tight bundle of six corkscrew shapes.

The new peptide persists longer in the body, making it about three times more effective at blocking infection in rodent models of disease than the original form.

The research team started by trying to engineer the original peptide to be more resistant to protein-digesting enzymes in the body, which can easily shred proteins and make them useless. So, the Gellman lab turned to unusual building blocks to create a hardier peptide.

Cells build proteins out of alpha-amino acids. But chemists can create beta-amino acids, which are similar but have an extra carbon atom. When peptides use these beta-amino acid building blocks, they often take a different shape because of the extra atom. This can help a peptide hide from protein-digesting enzymes and survive longer

However, the researchers also knew that if the peptide's shape changed too much as a result of these unusual building blocks, they might not lock together with HPIV's corkscrew fusion protein.

That's where the Gellman lab's decades of experience testing and modifying beta-amino acid-containing peptides became critical. "We know which side of the peptide is binding to its protein target. So, we (knew that we) can modify only residues that are not directly involved in binding the viral protein," says Victor Outlaw, a postdoctoral researcher in the lab and one of the co-first authors of the report. In lab tests, they saw that the carefully modified peptide still bound strongly to the virus's protein.

# BLOODY START TO MAY, 52 DEAD IN FIRST WEEK

**SRINAGAR -** New spurt in militant violence has left at least 52 people dead in the first week of May. The dead include lop militant commanders and a senior Army officer. Scores of people mostly civilian pedestrians were wounded during the week in various grenade attacks across the strife-torn state.

A total of 33 militants, 11 security personnel and 8 civilians were killed in the week that saw a string of militant attacks in the Valley. A large cache of arms and ammunition was also seized. Atequilah Shah, Chief Minister Mufti Mohammad Sayeed's

nephew, became the first victim of the week when he was fired upon by militants at Bijbehara in south Kashmir district of Anantnag on May one.

Militants killed Mohammad Ramzan Mian, the Chairman of the Pattan Municipal Committee, and another politician Jabbar Khanday at Doru in Anantnag on May 3.

Same day troops gunned down six top Lashkar-c-Taiba (LeT) militants, including four Pakistani nationals, in a six-hour-long gun battle near the Line of Control (LoC) in Poonch district of Jammu region. With this, about 22 infiltrators had been killed by the Army and the

Border Security Force (BSF) during the past two weeks in the state On May 4, Security forces achieved a major success when it killed 14 commanders of the Hizbul Mujahideen mililants in a fierce encounter at Lawaypora in north Kashmir's Bandipora area. The gunfight erupted after security forces cordoned off the

village where a meeting of Batallion and Company commanders of the Hizb was going on. Five houses were also damaged in the fierce gun-battle. Two minor girls were killed in a militant attack at a marriage party at Lohad Malah in Jammu's Udhampur district on May 5.

# **China Records Slowest Population Growth In Decades**

BEIJING, CHINA: China's population has grown at its slowest pace in decades, reaching 1.41 billion, census results showed on Tuesday.

The growth of 5.4 percent since the last census in 2010 reflects fears of a looming demographic crisis amid an ageing society and slowing birthrates, with a sharp drop in the number of working-age citizens in the world's second biggest economy.

The growth rate was the slowest since the 1960s, according to official data.

Beijing changed family planning rules in 2016 to allow families to have two children amid fears grew about China's fast-ageing population and shrinking workforce -- but it is yet to produce the expected



baby boom to help offset the country's ageing population.

"The adjustment of China's fertility policy has achieved positive results," said Ning Jizhe, an official from the National Bureau of Statistics.

But he added that the "ageing of the population imposed continued pressure on the long-term balanced development of the population in the coming period."

The number of people aged between 15 and 59 population dropped nearly seven percent, while those aged over 60 was up more than five percent.

China's birthrate has been in steady decline since 2017, despite the relaxation of the decades-old 'one-child policy"

This is partly due to falling marriage rates in recent years, couples struggling with the high cost of raising children in major cities, as well as women naturally delaying or avoiding childbirth due to their growing empowerment.

### **US Authorises Pfizer Vaccine** For 12-15 Year Olds

**WASHINGTON:** The United States on Monday authorized the Pfizer-BioNTech Covid-19 vaccine for children aged 12 to 15 years old, while the devastat-

ing outbreak in India raged on. The US Food and Drug Administration previously had granted an emergency use authorization for the jab to individuals aged 16 and older.

"This is a promising develop-ment in our fight against the virus," said President Joe Biden. But the World Health Organization in Geneva warned the B.1.617 variant spreading in India appears to be more contagious, classifying it as a "variant

of concern at the global level." The virus is still surging in many countries and the pandemic has killed close to 3.3 million people worldwide since late 2019, upending normal life and

# 9 Dead In Russia School Shooting; Students Jump From 3rd Floor To Escape

MOSCOW, RUSSIA: At least nine of mourning for Wednesday people, most of them children, were killed Tuesday when a lone teenage gunman opened fire at a called for new gun laws. school in the central Russian city of Kazan, officials said.

President Vladimir Putin ordered a review of gun control laws after the shooting -- one of the worst in recent Russian history -- which occurred on the first day back to school following annual May holidays.

The spree started around 9:30 local time (630 GMT), sparkteachers at the School No. 175 in predominantly Muslim republic of Tatarstan.

Amateur footage on social media, apparently filmed from a nearby building, showed people escaping from the school by jumping from second- and third-floor windows, with sounds of gunshots echoing in the schoolyard.

Police said they detained the gunman approximately one hour after initial reports of shooting.

Seven of the dead were children in the eighth grade, Tatarstan regional leader Rustam Minnikhanov told reporters. he was respectful of fellow stu-He said two adults, including a teacher, also died.

Another 20 were hospitalised, including 18 children. Six of them were in intensive care, Lazzat Khaidarov, a spokesman for the regional authorities, told AFP.

# 20 Oxygen Plants Installed, 17 In Offing, 9 In Transit: Govt

**SRINAGAR:** After the onset of 2nd wave of Covid-19 pandemic, the hospitals associated with covidcare in Kashmir have witnessed a steep rise in requirement of medical oxygen as more number of patients who have tested Covid-19 positive are turning up to the hospitals after their saturation level decreases in home isolation.

To give an information about the supply position of medical oxygen in Kashmir, Chief Engineer, Mechanical Engineering Department Kashmir, Rashid Ahmad gave an in-depth details about the status of oxygen both in terms of generation capacity and in the form of bulk cylinders available to cater to the needs of Covid hospitals in Kashmir.

The C.E said that the role of MED has been very important vis-à-vis ensuring the generation of oxygen in patients and the department is doing its best to live up to the expectations.

He said the oxygen supply may be in the shape of liquid medical oxygen, cylinders or in the form of Captive PSA Medical Oxygen generation. "We have an issue regarding supply of liquid medical oxygen here due the logistics involved which would be cumbersome to procure from outside the state on a consistent and reliable basis" the C.E said.

"The position of oxygen has become hospitals to make it available to the better as we were prepared to deal with it and we had fixed our contracts in time, we had made order for 37 plants in October-November, the bulk of this order has already arrived and we have so far installed 20 plants and 17 plants are in the offing" he said.

# Saudi push

n yet another proof that Saudi Arabia and the UAE are playing a role in easing India, Pakistan tension and helping them reach some understanding on Kashmir, the Saudi-Pakistan joint statement has explicitly called for resolution of Kashmir through dialogue. The statement issued during Pakistan prime minister Imran Khan's visit to the kingdom also welcomes the decision by the two countries to observe a ceasefire along the Line of Control (LoC). Earlier, Foreign Minister of Saudi Arabia Prince Faisal bin Farhan Al-Saud had said his country could play a role in reducing tensions between Pakistan and India. Before him, the United Arab Emirates' envoy to Washington confirmed the Gulf state is mediating between India and Pakistan to help the nuclear-armed rivals reach a "healthy and functional" relationship.

But the fact remains that all the talk about the thawing of the relationship between the two neighbours is emanating mostly from Pakistan. New Delhi has largely been tight-lipped about it. One could attribute it to the ongoing Covid-19 catastrophe in India that has overwhelmed the government, leaving it little bandwidth to respond or talk about the relationship with its western neighbour. Things could, however change in near future as India gets a handle on the runaway surge in Covid-19 cases. As and when that happens, the two countries are expected to announce more Confidence Building Measures to improve their relationship and may be take steps to institute a formal dialogue.

But as is apparent there are some reservations as for as conducting an open dialogue. The reasons for it are both historical and the recent. The relations between the two neighbours have plunged to their lowest low since New Delhi withdrew Article 370 on August 5, 2019. Until before dramatic re-affirmation of the ceasefire agreement a month ago, it appeared unthinkable that the two countries would come anywhere near to resumption of dialogue. But they have done it, even moving a few baby steps further towards talks.

Now, both countries are putting onus on each other to take the first step towards resuming dialogue. And what that step would be is still unknown. Islamabad had earlier made any re-engagement with India conditional to New Delhi reversing the August 5 move. But Pakistan seems to have given that up, so has New Delhi its insistence on end to cross-border terrorism before talks begin. Anyways if the last year's figures for infiltration and the killings of foreign militants in Kashmir are anything to go by, Islamabad has held back from supporting the local militancy. New Delhi, it seems, is unlikely to reverse the revocation of J&K autonomy. It remains to be seen whether it restores statehood anytime soon. A sustained, meaningful dialogue between the two countries has the potential to lead to a positive outcome. So, the neighbours should restore it sooner than later.

## Vaccine skirmishes

he Biden administration's announcement that it would support a waiver on intellectual property rights (IPR) for the production of COVID-19 vaccines appeared to catch the world off-guard, on both sides of the argument. The original proposal for the relaxation of TRIPS for such vaccines in the context of the ongoing pandemic was drafted at the WTO by India and South Africa last year. Now that his administration has proclaimed its intent to fulfil that promise, it must come as a bitter realisation that what sounds like a well-intentioned, pro-developing-countries policy stance has been rebuffed by major EU nations and met with counter-suggestions that might make even the most liberal U.S. Democrats uncomfortable.

There are merits to the argument that an IPR waiver, even if it were to become a reality, may not entirely resolve the vaccine deficit issue in countries suffering the worst of the pandemic now. First, the grant of a waiver would have to be accompanied by a "tech transfer" that provides generic pharmaceutical manufacturers with the requisite trained personnel, raw materials and hi-tech equipment and production know-how. Second, there must be a scientifically convincing answer to the question of how any vaccine then produced by these generic manufacturers — in all likelihood, years from now — would pass the tests of safety, immunogenicity and protective efficacy. Third, the impact on global supply chains for vaccine production should be examined so major disruptions might be avoided. Finally, alternative options to urgently address vaccine shortfalls should be considered, including developed nations sharing a significantly greater part of their vaccine stockpiles, particularly in cases where the latter exceed projected domestic need. Indeed, there is speculation that the intention behind Mr. Biden's waiver proclamation might be in favour of the last outcome, essentially a tactic to persuade pharmaceutical companies to accept less painful measures including sharing some of their technology willingly, agreeing to joint ventures to increase global production expeditiously, and simply produce more doses at affordable prices to donate directly to where the need is most severe, especially India.

Now let's take a cue from Economics of Information to understand how the industry of advertisements In modern times, advertising is one of the obvious methods of identifying potential buyers and sellers in a market. In the age of Information and communication Technology, from business to politics, almost everything is advertised through digital media. It is not surprising when year after year, it is found that the money spent by BJP on advertising is increasing. During 2019-20, the amount spent on advertising stands around 1.95 crore per day in a country where according to the United Nations Food Programme: levels of poverty, food insecurity, malnutrition, inequality and social exclusion are extremely high. The major part of the amount spent on advertisement goes to the coffers of people who are on higher steps of political and economic ladder

The revenue model of media in India is mostly advertisement driven. This becomes more problematic when the majority of advertisements either come from the government or from companies which are close to it. This symbiotic relation between media houses, government and business houses cons the system. By doing so, an essential check to the system is eroded.

It has become lucrative for star anchors to act as propaganda agents and question the opposition leaders rather than the government itself. Similarly the business houses close to the government have found their fortunes doubled. They have also been able to flout the rules without any costs. Some corporates even promoted their business with the Prime minister as brand ambassador though they later apologised. In any other functioning democracy this would have been considered scandalous.

Raghuram Rajan in his book, "Third Pillar" notes that major business magnates largely applaud the government policy. They live in what is a give-take relationship.

The Judiciary too is sitting on some issues like the final verdict on Article 370, the CAA-NRC debacle and the issues around electoral bond opaque-

The conferment of awards is the other mechanism by which the NDA furthered its anti-people agenda. Awards are means to provide recognition to those persons who are thought to best possess some distinguishing qualities when compared to peers. Awards play an important signal with regard to capabilities of individuals or institutions. The other major report which provides the state of democracy worldwide is The Economist Intelligence Unit's Democracy Index In its 2020 report it characterised India a a flawed democracy. Though on electoral process and pluralism, India maintained its score of 8.67 but the report mentions pressure on democratic norms since 2015. These reports take a diversion from indigenous reports and awards mentioned

The society is also to be blamed for much of the decline in accountability and democratic norms. Citizens remained so disorganised and divided on parochial lines that the government felt no significant backlash towards its policies. It is however naïve to argue that there was no opposition from society to anti-government policies. There were many groups which tried to put pressure on the government but those voices never metamorphosed into a majority. Infact, these voices were criminalised with new jargons like "antinationals" and "tukde tukde gang". However, it has been seen that the same people have been on the frontlines now. # Vaccines Reduce Transmission

since COVID-19 vaccines began rolling out across the world, many scientists have been hesitant to say they can reduce transmission of the virus.

Their primary purpose is to prevent you from getting really sick with the virus, and it quickly became clear the vaccines are highly efficient at doing this. Efficacy against symptoms of the disease in clinical trials has ranged from 50% (Sinovac) to 95% (Pfizer/BioNTech), and similar effectiveness has been reported in the real world.

However, even the best vaccines we have are not perfect, which means some vaccinated people still end up catching the virus. We call these cases "breakthrough" infections. Indeed, between April 10 and May 1, six people in hotel quarantine in New South Wales tested positive for COVID-19, despite being fully vaccinated.

But how likely are vaccinated people to actually pass the virus on, if they do get infected? Evidence is increasing that, not only do COVID-19 vaccines either stop you getting sick or substantially reduce the severity of your symptoms, they're also likely to substantially reduce the chance of transmitting the virus to others.

But how does this work, and what does it mean for the pandemic?

#### Vaccinated people are much less likely to pass on the virus

Early evidence from testing in animals, where researchers can directly study transmission, suggested immunisation with COVID-19 vaccines could prevent animals passing on the virus.

But animals are not people, and the scientific community has been waiting for more conclusive studies in humans.

In April, Public Health England reported the results of a large study of COVID-19 transmission involving more than 365,000 households with a mix of vaccinated and unvaccinated members.

It found immunisation with either the Pfizer or AstraZeneca vaccine re-



duced the chance of onward virus transmission by 40-60%. This means that if someone became infected after being vaccinated, they were only around half as likely to pass their infection on to others compared to infected people who weren't vaccinated.

One study from Israel, which leads the world in coronavirus vaccinations, gives some clues about what's behind this reduced transmission. Researchers identified nearly 5,000 cases of breakthrough infection in previously vaccinated people, and determined how much virus was present in their nose swabs. Compared to unvaccinated people, the amount of virus detected was significantly lower in those who got vaccinated.

More virus in the nose has been linked to greater infectiousness and increased risks of onward transmission. These studies show vaccination

If COVID-19 vaccines reduce the chances of transmitting the virus, then each person who is vaccinated protects not only themselves, but also people around them. Breaking chains of transmission within the community and limiting onward spread is critical to help protect people who may respond poorly to immunisation or may not be able to get vaccinated themselves, such as children, some older people, and some people who are immunocompromised.

This also greatly increases the opportunity to achieve some degree of population (or "herd") immunity, and a faster easing of social restrictions.

Right now, the global pandemic is complex. Many countries are quickly rolling out available vaccines, and there are a wide variety of lockdowns and social measures in place. Yet, the number of new infections each day across the world is at an all-time high and concerning variants are circulating.

While vaccinated individuals most likely have a smaller chance of passing on the virus, it's still important to keep up responsible behaviours into the immediate future to protect those who have not, will not, or cannot be immunised.

# **Here's How City People Get Health Boost From Nature**

he findings of a recent study by researchers from Stanford University suggest that even your local city park may be improving your health.

The research, published in Proceedings of the National Academy of Sciences, lays out how access to nature increases people's physical activity - and therefore overall health - in cities. Lack of physical activity in the U.S. results in USD 117 billion a year in related health care costs and leads to 3.2 million deaths globally every year.

It may seem like an intuitive connection, but the new research closes an important gap in understanding how building nature into cities can support overall human wellbeing.

"Over the past year of shelter-in-place restrictions, we've learned how valuable and fulfilling it can be to spend time outdoors in nature, especially for city-dwellers," said study lead author Roy Remme, a postdoctoral researcher at the Stanford Natural Capital Project at the time of research. "We want to help city planners understand where green spaces might best support people's health, so everyone can receive nature's benefits."

In cities, nature provides cooling shade to neighborhood streets, a safe harbor for pollinators, and rainwater absorption to reduce flooding. It's widely understood that physical activity improves human health, but how parks, lakes, trees and other urban green spaces boost physical activity and overall wellbeing is an unsolved piece of the puzzle.

The team combined decades of public health research with information on nature's benefits to people in cities. They considered how activities like dog walking, jogging, cycling and community gardening are supported by cities' natural spaces. They also factored in things like distance to urban greenery, feelings of safety and accessibility to understand how those elements can alter the benefits of nature for different people. From tree-lined sidewalks to city parks and waterfronts, the team created a model framework to map out urban nature's physical health benefits.

The researchers' framework explores how people might choose to walk an extra few blocks to enjoy a blooming garden or bike to work along a river path, reaping the health benefits of physical activity they may have missed if not motivated by natural spaces.

In Amsterdam, city planners are currently implementing a new green infrastructure plan. Using the city as a hypothetical case study, the researchers applied their framework to understand how Amsterdam's plans to build or improve new parks might affect physical activity for everyone in the city. They also looked at the effects on different sub-populations, like youth, elderly and low-income groups. This example illustrates how the city could invest in urban nature to have the greatest physical activity benefits for human health.

The research will ultimately serve as the basis for a new health model in Natural Capital Project software - free, open-source tools that map the many benefits nature provides people. The software was recently used to inform an assessment of 775 European cities to understand the potential of na-



ture-based solutions for addressing climate change. Eventually, the new health model software will be available to city planners, investors and anyone else interested in new arguments and tools for targeting invest-

ments in nature in cities.

Nature's contributions are multidimensional - they can support cognitive, emotional and spiritual well-being, as well as physical health. Previous work from the Natural Capital Project has shown many of these connections, but the new research

adds an important link to physical health that had been missing from the equation.

"Nature experience boosts memory, attention and creativity as well as happiness, social engagement and a sense of meaning in life," said Gretchen Daily, senior author on the paper and faculty director of the Stanford Natural Capital Project. "It might not surprise us that nature stimulates physical activity, but the associated health benefits from reducing cancer risks to promoting metabolic and other functioning - are really

quite astonishing.'

As our world becomes more urbanized and city-centric, the ability to easily access outdoor natural spaces becomes increasingly challenging, especially for overburdened communities. Identifying where urban nature is missing in vulnerable or overburdened communities - then working to fill those gaps - could provide people with valuable new opportunities to improve their health. The researchers hope the new study will equipurban planners with a more complete understanding of the benefits nature can provide their communities.

"Our ultimate goal is to create more healthy, equitable and sustainable cities," said Anne Guerry, co-author and Chief Strategy Officer at the Natural Capital Project. "This research is actionable - and gets us one big step closer."

# Study unveils how proteins control information processing in brain

complicated interaction between different proteins is needed for information to pass from one nerve cell to the next. A team of researchers now managed to study this process in the synaptic vesicles, which play an important role in this process.

The study led by a team at the Martin Luther University Halle-Wittenberg (MLU)T appeared in the journal Nature Communications.

Several billion nerve cells communicate with each other in the body so that humans and other living beings can perceive and react to their environment. A host of complex chemical and electrical processes occur within a few milliseconds. "Special messenger substances - known as neurotransmitters - are released at the synapses of the nerve cells. They transmit information between the individual nerve cells," explains Dr Carla Schmidt, an assistant professor at the Centre for Innovation Competence HALOmem at MLU.

The messenger substances are packed into small vesicles called synaptic vesicles, which fuse with the cell membrane in response to an electrical impulse and release the

messenger substances. The messenger substances are then recognised by special receptor proteins in the next nerve cell. For this to succeed, numerous proteins have to work together, meshing like cogs in a clockwork mechanism. However, too little is currently known about how this process precisely works,

says Schmidt.

The researchers have used a special form of mass spectrometry to investigate the process. Crosslinking mass spectrometry helps identify the interaction sites of the proteins. These are mixed with a substance that binds together nearby proteins. This substance

reacts at different places depending on how the proteins interact with one another. The mass spectrometer analyses the binding patterns, which can be used to draw conclusions about the arrangement of the proteins. This enables researchers to examine different stages of the vesticles and to detect which protein

networks have formed.

The study from Halle enables a more thorough understanding of the process of signal transmission in nerve cells. Knowledge about normal processes helps scientists recognize and understand malfunctions that could trigger diseases such as Alzheimer's.

## **COVID-19** | India's Smartphone **Market To Slowdown In 2Q21**

he smartphone indus-April-June quarter due to the second wave of the coronavirus pandemic even as the sector saw a healthy year-onyear growth of 18% to 38 million units shipments in the first quarter (January-March) of 2021, according to International Data Corporation (IDC).

However, when compared to strong October-December 2020. the Indian smartphone market declined by 14% in the first quarter.

"The April-June quarter is expected to face growth challenges under the weight of the second wave of infections. However, the high shipments from the first quarter should be able to suffice for the immediate demand," Navkendar Singh, Research Director, Client Devices & IPDS, IDC India, said.

While he added that the impact is estimated to be less pronounced compared with last year, with factories being operational today, only limited restrictions on logistics/ transportation and State-level lockdowns instead of a nationwide lockdown, the recovery in 2021 "might not be as smooth as expected earlier, with uncertainty around the lasting impact of the second wave in next few months."

IDC expects a rebound in consumer sentiments in the second half of 2021, resulting try in the country is in a single-digit growth anexpected to witness nually. However, the degree growth challenges in of growth will be restricted due to reduced discretionary spending, supply constraints, and anticipated price hikes in components in upcoming quarters, Mr. Singh said.

As per IDC, Xiaomi led the smartphone market during the quarter with 27.2% market share, followed by Samsung (19% market share), vivo (17.3% market share), OPPO (12.2% market share) and realme (10.7% market share).

"Online channels continued their growth momentum ahead of the overall market at 25% YoY, despite a slip in its share to 46% quarter-over-quarter (QoQ), while offline channels grew at 13% YoY. However, both the channels started to face higher channel inventory towards the second half of the quarter," it said.

Additionally, almost 7% of overall shipments were 5G, leading to a 3% YoY increase in average selling price (ASP) to USD 176. The premium segment (over \$500), grew 143% YoY, with 71% of those based on 5G. "Apple, Samsung, and OnePlus continued to dominate in that space; the iPhone 11 and 12 together accounted for 28% of shipments; followed by the dewave and a possible third but of the Galaxy S21 series and the OnePlus 9 series," IDC said.

# India projected to grow at 10.1% in 2022 but outlook for 2021 highly fragile: UN

**UNITED NATIONS:** India is forecast to grow at 10.1 per cent in 2022, becoming the fastest growing major economy in the world, the United Nations said on Tuesday, but cautioned that the growth outlook of 2021 was "highly fragile" as the country was the "new hotbed of the pandemic.'

The United Nations, its mid-year update of the World Economic Situation and Prospects (WESP) which was first released in January 2021, projected that the Indian economy would grow at 10.1 per cent in the calendar year 2022, nearly double the 5.9 per cent growth forecast for the country in the January report.

At a growth rate of 10.1 per cent in 2022, India will be the fastest growing major economy in the world, ahead of China, which is projected to grow at 5.8 per cent, a slowdown from 8.2 per cent in 2021.

The mid-year update said that India will register a 7.5-per cent growth rate in calendar year

2021, after an estimated contraction of 6.8 per cent in 2020.

The mid-year update provides an upward revision for growth projections for India from the UN forecasts released in January.

The January World Economic Situation and Prospects report had estimated that the Indian economy will contract by 9.6 per cent in 2020, and projected a 7.3 per cent growth rate in 2021 and a 5.9 per cent GDP growth in 2022.

The report however noted that the growth outlook is "bleak" for a large number of countries in Africa, South Asia as well as Latin America and the Caribbean, where the pandemic is still raging.

India, with daily new infections averaging over 300,000 during the third week of April, is now the new hotbed of the pandemic. The worst is far from over for Brazil, Argentina, Peru, and Colombia," it said, adding that for a vast majority of developing countries, economic output will remain below 2019 levels for most of 2021.

Amid insufficient fiscal space to stimulate demand, many of these countries will face low and stagnant growth and the prospect of a lost decade," it said.

India has been particularly affected by a brutal second wave, which is overwhelming the public health system in large parts of the country. The country has expanded vaccine eligibility and is ramping up supply in every possible manner, but access to vaccines is unequal and insufficient to meet the massive demand. Given the fluid situation, India's growth outlook in 2021 is highly fragile, it said.

In an overview of the global progress on COVID-19 vaccination, the report said that in India the number of doses administered is low at a ratio of 10 per 100 people, as compared to 68.2 per 100 people in the US, 12.4 in Russia and 13.6 in Latin America and the Caribbean. In 2020, investment growth in India fell to 10.2 per cent, the third highest contraction among selected G20 economies after Mexico (-18.2 per cent) and South Africa (-17.5 per cent).

The mid-year update noted that South Asia -- already one of the hardest hit regions in the

COVID-19 crisis well into 2021.

While a few smaller countries in the region have managed to roll out vaccinations, the largest economies continue to struggle to contain the increasing waves of infections," it said.

Economic growth in South Asia will return in 2021 at 6.9 per cent against a 5.6 per cent drop in 2020, but the recovery will be very uneven, and the scarring effects will run deep, it said. Indeed, South Asia's regional

economic growth in 2021 will still be insufficient to undo last year's 6.7 per cent loss in GDP per capita. Many of the region's households that have fallen into extreme poverty will thus remain trapped in their precarious condition, it said. Cautioning that risks are further-

more exceptionally high for the region, the report said South Asia was already lagging in economic performance before the pandemic, with regional economic growth as low as 3.1 per cent in 2019.

According to the World Economic Situation and Prospects mid-2021 report, following a sharp contraction of 3.6 per cent in 2020, the global economy is now projected to expand by 5.4 per cent in 2021, reflecting an upward revision from the UN forecasts released in January.

Amid rapid vaccinations and continued fiscal and monetary support measures, China and the United States the two largest economies are on the path to recovery. While the global growth outlook has improved, led by robust rebound in China and the US, surging COVID-19 infections and inadequate vaccination progress in many countries threaten a broad-based recovery of the world economy, it said.

Vaccine inequity between countries and regions is posing a significant risk to an already uneven and fragile global recovery, said UN Chief Economist Elliott Harris. Timely and universal access to COVID-19 vaccinations will mean the difference between ending the pandemic promptly and placing the world economy on the trajectory of a resilient recovery, or losing many more years of growth, development and opportunities.

# Chinese Loan App Cases: ED Attaches Over Rs 76-Cr Assets

New Delhi; The ED has attached assets of over Rs 76 crore, including of some fintech companies "controlled" by Chinese nationals and fintech major Razorpay, as part of a money laundering probe against certain Chinese 'loan app' companies whose bullying tactics are alleged to have forced many debtors to end their lives during the stressful times of COVID-19.

The central probe agency said in a statement that its criminal investigation, under provisions of the Prevention of Money Laundering Act (PMLA), is based on multiple FIRs filed by the criminal investigation department (CID) Police in Bengaluru after they received "complaints from various customers, who had availed loans and faced harassment from the recovery agents of these monev lending companies".

Numerous reports of blackmail and extortion by these

"loan sharks" leading to death by suicide of gullible debtors were reported last year after the coronavirus infection and the resulting lockdown began in the country

This is the first case of criminal attachment of assets by the ED in these instances which is probing some other cases of this nature in other states too.

The amount attached by the Enforcement Directorate (ED), the statement said, "pertains to seven companies out of which three are fintech (financial technology) companies namely Mad Elephant Network Technology Private Limited, Baryonyx Technology Private Limited and Cloud Atlas Future Technology Private Limited which are controlled by Chinese nationals and three NBFCs (non banking financial companies) registered with RBI."

The NBFCs are X10 Financial Services Private Limited, Track Fin-ed Private Limited and Jamnadas Morariee Finance Private Limited, the ED said.

"Cough, cold, fever, body ache and diarrhoea are the symptoms of Covid infection among children. Oxygen saturation of children should be above 94. However, the O2 saturation reading between 94 to 90 is a symptom of mild infection and below it indicates severity of infection." Dr Ian said.

However, Dr Jan maintained that Covid vaccination for children was not allowed because the issue is under trial, yet.

"Although, the USA has allowed vaccination for children above 12 year old just a day before, Covid vaccination for children has not been permitted in other countries till now," Dr Jan

Regarding breast feeding, he said that Covid positive mothers can breastfeed children while properly following SOPs particularly with wearing face masks and sanitizers applied on hands after washing.

"Besides, other routine immunisation to children after their covid infection can be given two weeks after the child becomes asymptomatic. However, if the child has received steroids or tocilizumab then routine immunisation should be deferred by 3 months," he said.

He also advised that children should be kept away from elderly people because old age people are prone to get covid infection and also have high morbidity risk to them.

when he was elected as the President of the Indian Commercial Pilot Association, Kapil Raina sought ways to leverage the power and responsibilities bestowed upon him by the position to the benefit of local Kashmiris.

### Some Indian Players Didn't **Like COVID-19 Restrictions: MI Coach Pamment**

AUCKLAND: Mumbai Indians fielding coach James Pamment has claimed that some senior Indian players did not like being subjected to restrictions inside the currently-suspended IPL's biobubble but it felt completely safe till the time cases from participating teams hadn't come to light.

Pamment did not elaborate on his assertion about the Indian players and did not take any names either. The IPL was suspended on May 4.

"Some of the senior Indian guys don't like being restricted and told what to do," he was quoted as saying by stuff.co.nz.

"But we did feel safe at no point did we feel the bubble would be compromised ... We felt the travel was always going to be a challenge,"

The New Zealander, a former Northern Districts coach, said he and the MI players started to feel apprehensive shortly before the competition was halted.

"It was when cases started to come with the teams. They were a little more fearful, a little more apprehensive," said the 52-year-old, who returned home on Saturday.

"Chennai (CSK) announced their cases and we'd played Chennai at the weekend, so straight away, the dynamic changed. I certainly noticed from within my group. I'd spend most of my time with the Kiwis and the Aussies, their mindset had changed.

"We started to get Indian guys in our environment whose families were sick. There were be-

reavements as well and we were taking a bit of a cue from those guys who were saying 'no, we want to carry on' and the messages were coming back that this is a good distraction."

Pamment said at no stage did he feel his health was going to be put in jeopardy within the bubble set up by MI at a Mumbai hotel.

"You felt as long as everyone was disciplined and people weren't tempted. You did feel confident you'd be fine, and everybody around you would be fine...an extremely safe bubble being formed."

He said long before the suspension of IPL, he was aware of the pandemic getting worse in India and the event should not have been spread across six venues.

"If it (IPL) had been held solely in Mumbai, perhaps it'd have been easily managed, but once cases rise in Mumbai, you're looking at ground staff, you're looking at different service-type people that it's going to be hard to manage," he said.

"We had a case ourselves on our first travel to Chennai it was a support staff member, fortunately picked up very quickly and he was isolated, and none of the people considered close con-

tacts to him were infected. "It was a very early reminder that your bubble's not impenetrable. We probably got even stricter around how we operated."

He also said that allowing 70,000 spectators in Ahmedabad for Test matches against England "was a little irresponsible and now Ahmedabad is a hot-bed of COVID".

# **India's Tour Of Sri Lanka:** Hardik Pandya, Shikhar Dhawan In Line For Captaincy

NEW DELHI: Veteran opener Shikhar Dhawan and flamboyant allrounder- turned specialist batsman Hardik Pandya will be locked in a two-way fight for India captaincy if Shreyas Iyer doesn't get fit in time for the white-ball tour of Sri Lanka in July

old Dhawan, who has had good "one and half IPLs" in last two seasons and Pandya junior, who is one of the most accomplished match-winners. "Shikhar has had two very good IPL including this curtailed

one and being the senior most among those who are available for selection, he is a very strong contender. Also he has been a solid performer for India for past eight years," an official said. As far as Hardik is concerned, his

reputation as a white-ball matchwinner can't be discounted either.

"Yes, Hardik hasn't been regularly bowling for MI or India in recent times. However, he is the man with x-factor and among options available. He is miles ahead of his peers in terms of being an impact performer. And who knows, may be extra responsibility brings the best out of him."

Pandya was included in the four-Test series at home against England so that his bowling workload is increased keeping the England tour in mind but it is learnt that the Baroda man is unlikely to bowl more than an odd over or two in the shortest format or ODI in near future.

"Hardik, after his back surgery to cure stress fracture, is not the same bowler anymore. He was a fast medium bowler before injury but to bowl at a brisk 135 kmph plus pace consistently, it could impact his back.

"So he is focussing more on his match finishing skills," a person in the know of things said.

# **England Players Unlikely To Be Available For Re-Scheduled IPL: ECB**

**LONDON:** England have a busy international schedule from June onwards and the players are unlikely to be available for the remainder of the suspended IPL if the T20 tournament is rescheduled this year, says ECB Director of Cricket Ashley Giles.

The IPL was suspended last week after multiple COVID-19 cases inside its bio-bubble. There are two windows for the T20 event to be resumed this year — one is in the second half of September and before the T20 World Cup (October-November ) and the other is after mid-November.

But England's top i in action at both times. They have tours to Bangladesh and Pakistan in September and October, while they will compete with Australia at the Ashes right after the T20 World Cup.

"We're planning on involvement of England players in England matches. We've got a full FTP schedule. So if those tours to Pakistan and Bangladesh are going ahead, I'd expect the players to be there," Giles said as quoted by ESPNcricinfo.

ious franchises in the suspended IPL.

"None of us knows what a rearranged IPL looks like at the moment, where it's going to be or when. But from when we start this summer against New Zealand, our programme is incredibly busy," Giles said.

"We've got a lot of important, high-profile cricket including the T20 World Cup and the Ashes. And we're going to have to look after our players.'

Giles dismissed suggestion that this signals a change in approach from the ECB as the management had earlier allowed up to a dozen players to miss the Test series against New Zealand at the start of June due to their involvement in the IPL.

"The New Zealand scenario very different. Those Test matches were formalised at the end of January, by which time all those contracts and NOCs (no objection certificates) were signed for full involvement in the IPL.

Giles expressed hope that players would be allowed "a bit more freedom" from bio-bubbles as the England summer progresses. The Test players are likely to enter their latest bubble from around May 28.

### MCC Rejects Bamboo Bats, Says It Will Be Illegal

LONDON: The Marylebone Cricket Club (MCC) has shot down the idea of bats made from bamboo, saying it would be "illegal" under the current set of rules governing the game.

The guardians of the laws of cricket, however, said they will deliberate on the matter during their laws sub-committee meeting.

According to a study by Darshil Shah and Ben Tinkler-Davies from the University of Cambridge, bats made from bamboo are economically sustainable and are also stronger than the ones made from willow, which is traditionally used.

"Currently, law 5.3.2 states that the blade of the bat must consist solely of wood, so for bamboo (which is a grass) to be considered as a realistic alternative to willow would require a law change." MCC said in a statement on Monday.

"Importantly, the law would need to be altered to allow bamboo specifically, as even if it were to be recognised as a wood, this would still be illegal under the current law, which bans lamination of the blade, except in junior bats."

The researchers found the bamboo bat to be "stiffer, harder and stronger than those made of willow, although more brittle" and also sup-



posed to have a larger "sweet spot, closer to the toe of the bat.'

"The sweet spot on a bamboo bat akes it much easier to hit a four of a Yorker for starters, but it's exciting for all kinds of strokes." Shah had said in the report.

MCC, however, said it needs to tread carefully to ensure that the balance of bat and ball remains intact.

"MCC's role as Guardian of the Laws includes maintaining the balance between bat and ball, and any potential amendments to the Law would need to carefully take this into consideration, particularly the concept of the bat producing greater The apex body said it will discuss

KINGSTON: Pace legend Curtly Ambrose believes the current lot of Caribbean youngsters doesn't really understand what cricket means to the West Indies and so the two-time world champions will never be able to relive the glory days again.

West Indies had lifted the first two World Cup titles in 1975 and 1979 and it took 33 years for the team to claim another ICC title when Darren Sammy had guided them to the 2012 T20 World Cup crown and repeated the feat four years later.

"Most of the youngsters we have now probably don't quite understand what cricket means to West Indians in the West Indies and abroad because cricket is the only sport that really unites Caribbean people," Ambrose told Talk Sports Live.

"This is no disrespect to the players we have now because we have a couple of guys who have some quality in them and can become great, but what we have to understand is that I don't think we will ever see those great, exceptional glory days again."

The 57-year-old, who claimed



405 wickets in 98 Tests between 1988 and 2000, said it is difficult to find talented cricketers from the island nation nowadays.

"It's going to be difficult to find another Viv Richards or a (Demond) Haynes and (Gordon) Greenidge, a Brian Lara, Richie Richardson, you know, a Malcolm Marshall, Curtly Ambrose, Courtney Walsh, Michael Holding, Andy Roberts, and the list goes on and

**NEW DELHI:** The Olympic-bound Indian shooting team on Tuesday left for Croatia for a two and a half months training-cum-competition tour, its final tune-up to the upcoming Tokyo Games.

With coaches and support staff in tow, a 13-member Indian shooting team took off for Croatian capital Zagreb, where it will undergo a training camp before leaving for Osijek to take part in the European Championships (May 20 to June 6) followed by the combined ISSF World Cup (June 22 to July 3).

"Team India takes off in 20 mins. Bon Voyage, Get the nose to the ground and work hard for your inevitable success team," Raninder Singh, president of the National Rifle Association of India (NRAI) tweeted just before the team's departure.

The two Olympics bound skeet shooters Angad Vir Singh Bajwa and Mairaj Ahmad Khan will be based in Italy. The Indians, including Gur-
