

'New hydrogel can protect against resistant bacteria, may treat wounds'

team of researchers at Chalmers University of Technology, Sweden, has developed a new material that prevents infections in wounds - a specially designed hydrogel, that works against all types of bacteria, including antibiotic-resistant ones.

The new material offers great hope for combating a growing global problem.

The World Health Organization describes antibiotic-resistant bacteria as one of the greatest threats to global health. To deal with the problem, there needs to be a shift in the way we use antibiotics, and new, sustainable medical technologies must be developed.

"After testing our new hydrogel on different types of bacteria, we observed a high level of effectiveness, including against those which have become resistant to antibiotics," says Martin Andersson, research leader for the study and Professor at the Department of Chemistry and Chemical Engineering at Chalmers University of Technology.

Research and development of the material has been ongoing for many years at Martin Andersson's group at Chalmers, growing in scope along the way, with a particular focus on the possibilities for wound care. Now, the important results are published as a scientific article in the journal ACS Biomaterials Science & Engineering.

The main purpose of the studies so far has been to explore new medical technology solutions to help reduce the use of systemic antibiotics. Resistant bacteria cause what is referred to as hospital-acquired infection - a life-threatening condition and is increasing in incidence worldwide.

Mimicking the natural immune system

The active substance in the new bactericidal material consists of antimicrobial peptides, small proteins which are found naturally in our immune system.

"With these types of peptides, there is a very low risk for bacteria to develop resistance against them since they only affect the outermost membrane of the bacteria. That is perhaps the foremost reason why they are so interesting to work with," says Martin Andersson.

Researchers have long tried to find ways



to use these peptides in medical devices, but so far without much success. The problem is that they break down quickly when they come into contact with bodily fluids such as blood. The current study describes how the researchers managed to overcome the problem through the development of a nanostructured hydrogel, into which the peptides are permanently bound, creating a protective environment.

"The material is very promising. It is harmless to the body's own cells and gentle on the skin. In our measurements, the protective effect of the hydrogel on the antimicrobial peptides is clear - the peptides degrade much slower when they are bound to it," says Edvin Blomstrand, a doctoral student at the Department of Chemistry and Chemical Engineering at Chalmers, and one of the main authors of the article.

"We expected good results, but we were really positively surprised at quite how effective the material has proven," adds Martin Andersson.

According to the researchers, this new material is the first medical device to make successful use of antimicrobial peptides in a clinically and commercially viable manner. There are many varied and promising opportunities for clinical application.

Startup company Amferia takes the research from lab to market

In recent years, foundational research into the antimicrobial peptide hydrogel has run in parallel with the commercial development of the innovation through the spin-off company Amferia AB.

The company was founded in 2018 by Martin Andersson together with Saba Atefyekta and Anand Kumar Rajasekharan, who both defended their dissertations at Chalmers' Department of Chemistry and Chemical Engineering.

The material and the idea, which is currently developed as an antibacterial wound patch, has generated interest around the world, attracting significant investment and receiving several awards. The company is working intensively to get the material to market so that it can benefit wider society.

Before the new material can benefit hospitals and patients, clinical studies are needed, which are ongoing. A CE marking of the material is expected to be completed in 2022. Furthermore, the wound patch version of the new material is undergoing trials in veterinary care, for treating pets. The company Amferia AB is already collaborating with a number of veterinary clinics around Europe where the hydrogel is now being tested.

"Amferia has recently entered into a strategic partnership with Sweden's largest distributor of premium medical & diagnostic devices to jointly launch these wound care products for the Swedish veterinary market during 2021" says Martin Andersson.

More about antimicrobial peptides and the new material

The beneficial properties of antimicrobial peptides have been known for some decades, and thousands of different varieties occurring in the natural immune systems of humans, animals and plants have been discovered. Researchers have long tried to mimic and use their natural function to prevent and treat infections without having to use traditional antibiotics. However, because the peptides are broken down as soon as they come in contact with blood or other body fluids, successful clinical usage has proved elusive.

The researchers knew that smart new solutions were needed to protect the peptide from degradation. The new material in the study has been shown to work very well, allowing the peptides to be applied directly to wounds and injuries on the body, with the effect of both preventing and treating infection. The material is also non-toxic, so it can be used directly on the skin. The potential of this new material can also be seen in the flexibility that it offers for different types of products.

How to avoid sun damage after months in lockdown

fter a winter of lockdown and with coronavirus restrictions beginning to lift across the UK, many will be hoping for good weather this summer. Restrictions on foreign travel have meant that more people plan to stay within the UK for their summer holidays than ever before.

This shift, along with our social lives increasingly being based outside, makes it particularly important that people don't underestimate the risks posed by the sun in the UK.

Skin damage caused by the sun is associated with both skin cancer and premature ageing of the skin. The culprit in both cases is ultraviolet radiation (UV). Invisible to human eyes, although it can be seen by many animals, including reindeer, UV sits just beyond the purple end of the visible light spectrum.

One reason that it is so harmful is that its energy can be absorbed by our cells' DNA, causing it to become damaged. If the cell isn't able to repair this DNA damage, this can lead to genetic changes, or mutations, which in turn can cause cancer. Because of their location on the surface of the body, skin cells are the main target for UV damage.

The body does have some protection against these harmful effects. Molecular mechanisms within our cells are able to detect and repair the DNA damage before it can cause mutation. When skin cells detect DNA damage, they activate alarm signals that get passed on to pigment-producing cells to tell them to start producing more pigment to help protect against further damage. It's the production of this pigment, melanin, that causes a suntan.

A tan is therefore a sign that your skin has been damaged. The protection it provides has been estimated to be equivalent to an SPF of around 4. This means that although it will take four times longer in the sun to do so, you can still burn.

If you're exposed to lots of UV, then the amount of DNA damage can overwhelm cells' defences. All is not lost though, because a damaged cell has a final line of defence where it can activate death programmes, "choosing" to die by a process called apoptosis. This means that badly damaged cells, which could go on to become cancerous, are eliminated from the body before they can cause harm.

Anyone who's ever had sunburn has experienced this process in action. Huge amounts of dying cells in the skin leads to inflammation, causing the characteristic painful reddening of the skin that can be an unpleasant end to a day out in the sun.

MOVE TO SHIFT CAPITAL

SRINAGAR - Even as the proposal to shift the summer capital of Jammu and Kashmir is yet to take off, controversy dogs the idea with debate rag¬ing for and against the govern¬ment move.

Giving vent to the opposi-tion to shifting of the capital, several political parties, includ-ing main opposition National Conference, said the massive expenditure needed for moving the secretariat and other offices could be diverted to building schools, hospitals and roads in the state.

"We need no new capital at an exorbitant expenditure of Rs 3.500 crore which could be uti-lized for the betterment of Kashmiris by constructing schools, colleges, hospitals and roads which are in a dilapidated condition across the valley." NC President Omar Abdullah told PTI.

Ridiculing the idea, another senior leader of the party Ali Mohammad Sagar said "instead of finding ways and means to mitigate the problems of the people the PDP-led coalition government is trying to squan-der the funds for unproductive projects."

He asked the coalition gov-ernment to desist from changing the capital for "petty politi-cal gains."

CPI(M), which supports the coalition government from out-side, opposes the idea. State Secretary of CP1(M) M Y Tarigami said "1 don't think it is a very serious move yet.

The government complexes should be moved a little away from the market and the beauti-ful city but not relocated in any other place. Why go there (Parihaspora) to Lalitaditya. The kings are buried there let them rest in peace.

'It is wrong to assume that government wants to benefit villagers by moving the capital city. The government has in fact done very little for the upliftment of rural areas," he said.

Author of the proposal to shift the capital and Finance Minister Muzaffar Hussain Baig said the basic objective behind a new capital was to decongest and develop Srinagar as an exclusive tourist resort 'with heritage villages and other amenities to make it among the most attractive tourist destinations on the globe.

The proposal for a new capital has received the Centre's nod which would be ready within next three years at an. estimated cost of Rs 3.500 crores, he said.

Opposing the idea, Chair-man of National Democratic Front and former MP Abdul Rashid Kabuli accused the gov-ernment of not attending to the problems of Srinagar, a city of 15 lakh people.

Shifting capital from Srinagar to Parihaspora and moving government offices to rural areas is like shifting of Union capital from Delhi to South India, Kabuli said.

The city of great antiquity has had a chequered history which dates back to 250 BC when king Ashoka founded Srinagar as capital which occupied the site of the present Pandrethan about five runs from Srinagar and named it as Srinagari.

The place was the venue of the Buddhist conference during the reign of Kanishka and Muslim preachers, Syed Sharifuddin Bulbul and Mir Syed Ali Hamdani chose this place to spread Islam, he said, adding the latter capitals of Kashmir founded by successive rulers lost their importance to the city.

It was during the Dogra rule (1846-1947) that Srinagar besides being the capital of Kashmir was elevated to the status, of the summer capital.

Travellers and tourists have been drawn in numbers to see symbol of the paradise on earth and pilgrims and preachers have found the city a place for attainment of ultimate spiritual contentment.

How can District Administration Bandipora or Baramulla give permission for setting up a garbage dump site around the wetlands ?

J & K Pollution Control Board (PCB) which has now been named as J&K Pollution Control Committee (PCC) a few months back imposed a huge penalty on Municipal Council (MC) Bandipora. The Pollution Control Committee acted after the National Green Tribunal (NGT) took notice of this case as the municipal institution was constantly dumping solid and liquid waste near the Wullar lake at Zalwan village just outside the town. This was viewed as gross violation of

Municipal Solid Waste Rules 2016 (MSW Rules 2016) by NGT and Pollution Control Committee. The municipal council which was earlier a municipal committee has been dumping all the untreated municipal solid waste near the Wullar catchment area and for this illegal act, several notices were issued to MC Bandipora by NGT as well as PCC. Pertinently, the National Green Tribunal (NGT) had taken a serious note of this illegal waste dumping when this author filed a petition before the tribunal more than 2 years back.

Misleading NGT

Last year, NGT had issued orders directing the Divisional Commissioner Kashmir and J&K Pollution Control Board to stop the illegal practice of waste dumping by MC Bandipora at Zalwan. Municipal Council Bandipora in its written response last year had misled the tribunal by saying through a written response that it was not dumping municipal waste at Zalwan. In my counter response submitted through my counsels Advocates Rahul Chowdhary and Saurabh Sharma, I apprised the NGT that Municipal Council Bandipora was "lying". I produced photographic evidence and videos plus written statements of the locals. A local social activist from Bandipora Mushtaq Ahmad Mir had also made a video at the Zalwan dumping site refuting the claims of Municipal Council Bandipora.That video went viral on social media.

NO HOLDS BARRED



It is unfortunate that municipal institutions who are supposed to enforce laws like Solid Waste Management Rules (SWM Rules 2016) , Biomedical Rules and Plastic Waste Management Rules are violating them themselves. Order not in public domain ?

It is heartening to see the order issued by the Pollution Control Committee (PCC), but I am unable to understand why this order was not put into public domain for almost three months. The PCC had given 45 days to MC Bandipora to deposit the compensation money into the Environmental Compensation Fund (ECF) but even after 2 months the concerned Executive Officer hasn't deposited the money. The PCC earlier called PCB needs to take up the case with District Magistrate Bandipora who will do the necessary recovery under J&K Land Revenue Act as he is empowered to do so.

Targeting another wetland

After being slapped a penalty of more than Rs 64 lakhs by Pollution Control Board now called Pollution Control Committee (PCC), the Municipal Council Bandipora as per media sources has identified another shore of Wullar to dump its municipal waste. This is being done to show that municipal waste was no-more dumped at Zalwan. The newsreport says that the new site at Nadihal village also happens to be a wetland area. I am yet to visit the area. According to news agency Kashmir News Observer (KNO), the Nadihal garbage dumping site is also part of Wullar catchment area and tons of garbage emitting foul smell has been dumped at the place causing a lot of inconvenience to the local population. Dozens of stray dogs are also seen at the site which is threatening the lives of young and old of the village.



waste is being unscientifically dumped is a panchayat land which was encroached without the consent of the panchayat committee, the locals told this author when I visited the spot on 10th April this year . In addition, the authorities are now planning to encroach upon a huge chunk of forest land near the encroached Panchayat land where a permanent dumping site would be set up. Five village panchayats through a joint gram sabha held on April 10th 2021 Dharnamhal Tarzoo Sonore passed a resolution against the unscientific waste dumping. The authorities were directed to stop the illegal practice. It seems there is no one to listen to these elected representatives. On the one side the Government claims that panchayat representatives are empowered to decide their developmental issues but when decisions are taken through a democratic process in a gram sabha it has no takers. The copy of the resolution has been sent to Deputy Commissioner Baramulla, Additional DC Sopore and Municipal Council Sopore around 2 weeks back , but Municipal Council Sopore continues to dump the waste at Dharnambal.

Last year, the MC Sopore was dumping its waste near Ninglee tourist huts which is part of Wullar catchment area. That illegal work was stopped after I brought the matter into notice of National Green Tribunal (NGT) and locals filed a PIL in J&K High Court through Advocate Shafqat Nazir, a noted environmental lawyer. The then Chief Justice JK High Court Geeta Mittla made a personal visit to the spot last year in October and the site was finally shut down. Unfortunately the old garbage which contains

Biomedical Rules and Plastic Waste Management Rules are violating them themselves. Wetlands like Wullar are under threat from the Municipal Council of Bandipora, Sopore and Hajin. There are three wetlands in Jammu & Kashmir and one in Ladakh which have been declared as Ramsar Sites. Wullar, which is one among them, was declared as a Ramsar site almost 30 years back. Sunisar Mansar in Jammu and Tsomoriri lake in Ladakh are also designated Ramsar sites. A Ramsar site is a wetland area designated to be of international importance under the Ramsar Convention. In Spite of such a great international importance of these wetlands, authorities at the helm are leaving no stone unturned to destroy these instead of looking after its conservation. Wullar lake is a live example as this wetland is dying a silent death due to constant dumping of Municipal Solid Waste (MSW) from its East, West and Southern areas. The dumping of this municipal waste has been institutionalized by authorities as Municipal garbage dump sites have been created within the wetland area. Locals are resisting but authorities are least bothered to listen to their woes.

Conclusion

The Wetland Conservation and Management Rules 2017 has listed out activities prohibited within notified wetlands. Wullar is not only a notified wetland but a wetland of international repute (Ramsar site) which is under serious threat. Under wetland conservation rules setting up of any industry and expansion of existing industries, manufacture or handling or storage or disposal of construction and demolition waste, solid waste dumping, discharge of untreated wastes and effluents from industries is completely prohibited. How can District Administration Bandipora or Baramulla give permission for setting up a garbage dump site around the wetlands ? The penalty money of Rs 64,12000 is also not recovered from MC Bandipora. If the penalty money is recovered, it will send a signal to other municipal institutions who will be forced to manage the municipal solid waste (MSW)on scientific lines as guaranteed under MSW Rules 2016.

Problem in Tarzoo Sopore

The Municipal Council Sopore also continues to violate the MSW Rules 2016 by dumping the municipal solid waste collected from Sopore town at Dharnambal in Tarzoo area. The land where this even hazardous waste continues to be there which was earth filled in haste on the eve of Chief Justice's visit.

Law enforcers turn violators

The job of municipal institutions is to ensure better sanitation and health of citizens in cities and towns. When legislations were enacted governing the environment and municipal solid waste, the municipal institutions were empowered to enforce and implement these rules and regulations. The Fallacy Of The Colonial 'Right To Self-Defence'

Colonial powers have long demanded the 'right to self-defence' against the people they have colonised.

he violence convulsing the Middle East has produced heartrending images and statistics. As I write this, at least 160 people, the vast majority of them Palestinians, including at least 41 children – the vast majority Palestinian – have been killed as the Israeli military carries out bombing raids in densely populated Gaza and armed Palestinian groups hurl rockets at Israeli cities. Meanwhile, inter-communal violence has broken out across Israel.

In response, Western governments, led by US President Joe Biden, have been quick to unequivocally condemn Palestinian groups for the rocket barrages, but have been much more circumspect about condemning Israel's attack on Palestinian civilians.

Lukewarm expressions of "dismay" and "grave concern" at Palestinian deaths have been interspersed with declarations of "unwavering support for Israel's security and for Israel's legitimate right to defend itself". They have also included appeals for "moral clarity", implying that the actions of Palestinian groups, though causing a tiny fraction of the death and

destruction that Israeli bombardment has wreaked, were nonetheless much more objectionable.

While some progressive politicians – such as US congresswoman Alexandria Ocasio-Cortez – have pointed out the hypocrisy of a blanket assertion of the Israeli right to self-defence, even they have balked at outright rejection of Israeli justifications.

Colonial occupiers have long claimed a "right" to defend themselves from the resistance of native communities, including by committing mass murder. The history of African colonisation is littered with the corpses and mass graves of those who dared to resist the militarily superior Europeans.

In her book, the British Gulag, historian Caroline Elkins describes a "murderous campaign" by the British in colonial Kenya following the 1950s Mau Mau peasant uprising, including the establishment of concentration camps for 1.5 million Kikuyu civilians and a brutal system of torture camps that may have claimed the lives of tens, perhaps hundreds, of thousands of those suspected to have pledged themselves to the rebellion.

The idea that imperial land grabbers

have the right to terrorise, brutalise, torture and murder those whose land they steal under the rubric of "self-defence" flies in the face of UN General Assembly Resolution 37/43 of 1982 which recognised "the legitimacy of the struggle of peoples for independence, territorial integrity, national unity and liberation from colonial and foreign domination and foreign occupation by all available means, in-

That resolution specifically reaffirmed this right in the case of the Palestinian struggle.

Thus, today in Gaza, rather than seeking "moral clarity", the West is using moral obfuscation to justify attacks on a refugee population by a colonial power that has evicted them from their land, blockades them in what is, in essence, an open-air prison, and then claims the right to do so in peace and quiet.

When Western media speaks of a "cycle of escalation", it equates oppression to the resistance to oppression, presenting the violence as a conflict between two sides with equal claims to security and land. It ignores that the Palestinians are engaged in a struggle for national liberation against a decades-long illegal and immoral occupation, and the imposition of a regime of racial and ethnic discrimination which Human Rights Watch, in a report the media pointedly refuses to bring up, says fits the definition of the international crime of apartheid.

In interviews, Israeli spokespeople repeatedly stress the difficulty that Israel's self-declared "most moral army in the world" has in finding and killing what are in essence Palestinian resistance leaders, who, they say, are hiding behind civilians.

The Western press is happy to accept that the leaders of Hamas and other groups are legitimate targets, and with it, the implication that while its tactics may be somewhat unsavoury, Israel is nonetheless waging a legitimate war. Uncritically accepting this framing makes Western media complicit in the delegitimisation of Palestinian resistance to colonial domination and dispossession by the Israeli state.

As Ocasio-Cortez pointed out, regurgitating the line that "Israel has a right to defend itself" without including the context of oppression simply excuses and legitimates even more oppression. But she should have gone further. If Western media, politicians and diplomats truly seek moral clarity, it behoves them to reject outright as gaslighting and bothsidesism, the outrageous proposition that colonial states such as Israel have a right to defend themselves from those they oppress.

"Similarly, following the decision in the earlier meeting, medical and nursing students are being deployed for ward work, which will reinforce the patient care and also build confidence among the patients' relatives, said Singh, the Minister of State in the Prime Minister's Office (PMO). He is the parliamentarian Udhampur constituency in Jammu and Kashmir. The minister was informed during the meeting that Chopra Nursing Home, affiliated to the GMC, will start functioning with 100 bed capacity to begin with. At the same time, it will be ensured that the senior consultants take regular rounds of the wards and are available as and when

At present, GMC Hospital is having 893 oxygen-supported beds out of its total capacity of 1,111.

In view of the spike in COVID-19 cases, it is proposed to make all the 1,111 beds as oxygen-supported beds, Singh said.

'Where're Vaccines'

valley's virtual space where anxious Kashmiris are deconstructing the official response

It's good that the government has set the deadline, said a Kashmiri netizen, "but how they're going to execute it, as there've been a total number of zero vaccines administered in South Kashmir barring Shopian in the last 16 days and the percentage of people of 45+ age group who've received the first dose is below 50%

This vaccine shortage is further escalating due to Covid curbs.

Last week, when 24-year-old Abubakar from Srinagar's HMT locality stepped out to take his parents to a local health community centre for the vaccination, he was sent back by the cops outside his home.

"I told them my parents have to get vaccinated and showed them the booking slot but they said we can't allow you because of Covid curfew," Abubakar said.

"We aren't against the curfew but the administration should facilitate people for the vaccination," said another local Mohammad Aijaz.

"Government is encouraging people for vaccination, but at the same time isn't allowing us to go to hospitals/ community centres for the same," said Ĥilal Ahmad, a trader from Srinagar.

"We're literally caught between devil and deep sea! What're we supposed to do in this situation?'

However, the administration is saying that it's doing everything possible to slow down the spread of coronavirus. In this regard, it has now extended the Covid curfew till May 24.

"The health department has set up the vaccination centres in the vicinity where people don't have to travel," said Dr Mir Mushtaq, spokesperson of the Govt. Health Department.

"People should go one by one, not in groups, he added."No one will stop them from getting vaccinated."

Earlier, voicing concern over the curbs in the valley, journalist Gowher Geelani wondered: "Is strict Corona Curfew a cover to hide shortage of vaccinations?"

Reacting to Geelani's take on the vaccination situation, senior scribe Mufti Islah said, "Strict or not so strict curfew, fact is there are no vaccines available in Kashmir. A top official was pleasantly surprised to know 500 plus shots were available in Valley yesterday. Can well imagine. One hopes vaccine shortage is over."

In another tweet on Sunday, Mufti Islah said: "Vaccine is a key in fighting Covid but unfortunately not a single jab received in Kashmir today. The shortage of vaccines is a concern, 28 lakh of 1.3 crore souls have been innoculatedmostly single shots - so far." As the vitriol over vaccination turned vexed, many more Kashmiri newsmen detailed the crisis further and held the government responsible for the dose delay.

600 people daily on an average," said Tajamul Rashid, an admin officer at J&K government.

Vaccinations literally stopped in the valley, on Saturday, with many districts, including Srinagar-with only two active vaccination centres, including the one in SMHS Hospitalreporting zero doses.

"Till date," an official said, "only 1,98,783 people have received Covidshots in Srinagar, which is much lower than Jammu.'

Already, the administration has drawn flak over the handling of second Covid wave, and the slow-vaccination process leading to shortage in Kashmir.

But as the debate raged on, some political figures joined the chorus on Sunday, stating that if immediate remedial measures aren't taken, the scarcity of vaccines can put the lives of millions of people from J&K at risk.

'There is a wave of mounting anger and frustration due to tardy vaccination rollout in J&K with some high-risk groups crying out for protection," Imran Reza Ansari, former J&K minister said, adding how health centers across the valley are battling the shortage of COVID-19 vaccines and that many centers have been closed due to the unavailability of vaccines.

"The vaccine is the only bulwark available against the current calamity and denying the populace such a facility amid the present peak is deplorable and inexplicable.

Interestingly, the valley is grappling with the vaccine shortage when experts are warning against the vicious impending third wave.

In fact, the shortage of Covid vaccine has created a crisis-like situation with almost everyone being turned away from the government designated vaccination centers across Kashmir, National Conference said Sunday.

"The scarcity of vaccines is not only affecting both the first dose seekers but second time vaccine beneficiaries as well," said NC's Party Provincial President Nasir Aslam Wani. "Even those people who have already registered and got the confirmation SMS are being turned away.'

This besides putting the people to undue trepidation is also jeopardizing their wellbeing, he said.

"If the vaccines are not available why is it then people are asked to flock to these designated vaccination centers in the first place," NC leader said.

"The authorities have been maintaining that adequate viles are available with them but the ground situation is contrary to what is being claimed. Even the priority groups aren't able to

get their first and second dozes done." To avoid jumbling at vaccination cen

Giving district wise break up of vaccination on Sunday, the official data says that in Jammu district 3093 people, in Udhampur 1157, in Rajouri 986, in Kathua 40, in Poonch 661, in Ramban 887, in Doda 731, in Kishtwar 360, in Reasi 524 and in Samba district 311 people above 45 years received vaccine jabs.

The official date further says that till Sunday, 2,814,272 doses of vaccine have been administered in the Union Territory. Among them, Kashmir division has received 1.335.954 vaccine shots and Jammu division 1,478,318 jabs of Covishield and Covaxin.

Pertinently, on Saturday J&K LG had set the timeline of 10-days for achieving the target of 100% vaccination of the above 45 years age group with the first dose of Covid vaccine. He announced this decision during a series of meetings with the member of Covid Task Force and Deputy Commissioners, SSPs, and other concerned officers of the Union Territory. J&K Govt Fully

We are still in a better position than many developed countries when it comes to health infrastructure. Nevertheless, I believe that there is a need to improve primary health centres right now, the Lt Governor said.

Addressing the people of J-K, Sinha shared the slew of measures recently announced by his administration to help those who lost their loved ones to COVID-19.

Along with the entire country, Jammu and Kashmir is also going through the challenging times of coronavirus. In the last few weeks, many families in the Union Territory have lost their loved ones to the epidemic. The administration is with them in this hour of grief, he said.

He said, I know no human life can be compensated for. But it is the responsibility of the government to take care of its people and to stand with them in these tough times.

Sinha said his administration has taken many such decisions to provide relief to the families affected by the catastrophe.

Senior citizens who have lost the only earning member of their families will be provided with a special pension for life while children, who have lost their parents to COVID-19 pandemic, would be provided with special scholarships, he said.

He said every family who has lost their near and dear ones due to COVID-19 will be provided with financial assistance for self-employment through the Jammu and Kashmir Bank.

Further, detailing the crisis, senior newsman Shuja ul Haq said that only around 500 people were vaccinated in Kashmir, while around 14000 vaccinations were held in Jammu on Saturday. "This is visibly a very slow pace," he said.

Taking the debate forward, another senior Kashmiri journalist Samaan Lateef said that there are no vaccines for Kashmiris.

"What's NarendraModiGovtupto?" he asked. "In Jammu 14000 were vaccinated and in Kashmir only 500. Lt. Governor's office has failed to improve Kashmir's healthcare even during pandemic."

Commenting on the administration's inabilitv to manage Covid-19 crisis, many netizens petitioned the other state governments for help.

"NitishwarKumar! There's a shortage of vaccine in Jammu & Kashmir! Kindly use your influence and help in vaccination! 100 plus vaccination centres have been closed due to shortage of vaccine," said netizen Sanjay Koul.

The current vaccination shortage, many officials told Kashmir Observer, has been triggered by the 'insufficient stock' delivered to J&K last week

"We received the last vaccine supply last Saturday," a senior official said. "That stock has already been consumed and now there're no vaccines available in the UT right now.'

Amid the criticism, New Delhi Sunday said that more than 1.84 crore Covid-19 vaccine doses are still available with states and UTs, while nearly 51 lakh doses are in the pipeline and will be received by them within the next three days.

But in the valley, beneficiaries are complaining that even after registering for vaccines online and reaching the centres, they are being told there are no vaccines.

"I was supposed to get my first dose on Saturday," said Idrees Bhat, a Srinagar resident. "But I was sent back saying that the health centre has no dose."

Even the official executers are saying that the Covid-19 vaccination drive has slowed down in J&K.

"Since last one week not a single person was vaccinated by our teams due to shortage of jabs at four facilities where we used to vaccinate leader emphasized door-to-door and walk-ins vaccination drives, to achieve the goal of universal vaccination in a hassle free manner.

But with health centres literally running dry of doses and batons regulating the public movement, many Kashmiris summed up the situation with the classic Koshur sarcasm: "Vaccine registration toukar lo ge, vaccine kaha se laoge? [Even if you manage registration, how will you get vaccine?]"

It said 50,95,640 vaccine doses are in the pipeline and will be received by states and UTs within the next three days.

Vaccination forms an integral component of the comprehensive strategy of Government of India of containment and management of the pandemic (including Test, Track, Treat and Covid Appropriate Behaviour).

The Centre has been supporting the nationwide vaccination drive by providing Covid vaccines free of cost to states and UTs, in addition to several efforts to ramp up its production and supply, the ministry stated.

Implementation of the Liberalized and Accelerated Phase 3 Strategy of COVID-19 Vaccination has started from May 1 as part of which the government has opened up inoculation for all aged above 18.

Under the Strategy, every month 50 per cent of the total Central Drugs Laboratory (CDL) cleared vaccine doses of any manufacturer would be procured by the Centre. It would continue to make these doses available to state governments free of cost as it was being done earlier. (PTI)

9000 Vaccinated

NEW DELHI: Indian journalist bodies including the Editors Guild of India (EGI) on Sunday strongly condemned the "brazen" Israeli airstrikes on a building in Gaza that housed the offices of the Associated Press, Al Jazeera and other news media outlets.

The EGI said in a statement that given the recent background of the "escalating conflict" in this region, it sees this airstrike as "a de facto attack on the news media by the Israeli government" that can disrupt the flow of news from this highly volatile region and have global security implications.

"The Editors Guild of India strongly condemns the brazen airstrikes on a building in Gaza that housed the editorial offices of Al Jazeera and the Associated Press," the EGI said.

It also demanded that the Israeli government give "a detailed justification" of the decision-making behind this attack "along with evidentiary proof".

"The Guild also calls for the Israeli government to facilitate an UN-monitored investigation into this bombing raid," it added.

Rescuers Dig For Survivors As Gaza Suffers 'Most Intense' Bombing

escue workers frantically Researched for survivors under the rubble on Sunday as Israel's bombardment of the besieged Gaza Strip entered its seventh consecutive day.

An hour-long rain of 150 rockets pounded the territory overnight on Sunday in what a Palestinian security source said was the "most intense" shelling since the second intifada, or uprising, that began in 2000.

Emergency teams worked to pull out bodies from vast piles of smoking rubble and toppled buildings as relatives wailed in horror and grief. Nearly half of the rockets targeted the Gaza City district of al-Wehda where residential houses, infrastructure and roads were destroyed or partially damaged.

The ministry of health confirmed 33 people were killed overnight - including Dr Ayman Abu al-Ouf, head of internal medicine at Shifa hospital – following Israeli bombardment on their homes. Five children were

found alive under the debris. "We can still hear people shouting from under the rubble," said Medhat Hamdan, a civil defence worker who came from Khan You-

nis to Gaza City and worked nonstop for 11 hours to save lives. "For me, working in this field has numbed me to any fear. I'm no longer shocked by what I see, but one can't help get emotional when we reach the bodies of children and remove them," said Hamdan, adding he pulled three dead chil-

dren from under the rubble. Translation: Rescue team still searching for missing persons at the scene of the massacre that took place on al-Wehda Street in Gaza City.

"Our entire neighbourhood from Tel Shubeir to Palmera intersection - was bombed," said Ramzi Eshkuntana, who was at home when



he said 40 successive air raids fell on the area in just a few minutes.

"We ran out of the house and saw the destruction of most the buildings around us, including my brother's house. His wife and four children were killed as they were sleeping," said Eshkuntana.

"My brother's wife was pulled out with her arms around her children," he added. "These weren't F-16 missiles; these were bombs from F-35 warplanes."

'These are children' A rescue worker gave his account as he was trying to rescue people from under the debris.

We heard the screams of a young girl. We also heard the ringing of a mobile phone. We followed the sound and for hours, using a bulldozer and other light devices, we got to the girl, who is alive," he said.

'The woman, along with her children – two boys and two girls are dead. Were these children firing rockets? Isn't it enough they were denied the joy of Eid? These are children! The oldest one was in the fourth grade."

"What happened here in al-Wehda is clear evidence that Israel is carrying out crimes against humanity and purposely targeting civilians," he said.

India's Covid Active Caseload Drops To 36,18,458; Positivity **Rate Below 16.98%**

NEW DELHI: India's COVID-19 active cases count has decreased to 36,18,458 with a net decline of 55,344 cases being recorded in the active caseload in a span of 24 hours, while the daily positivity rate dropped to 16.98 per cent, the Union health ministry said on Sunday.

The total active caseload now comprises 14.66 per cent of the country's total infections, it said.

Ten states--Karnataka, Maharashtra, Kerala, Rajasthan, Tamil Nadu. Andhra Pradesh, Uttar Pradesh, West Bengal, Gujarat and Chhattisgarh--cumulatively account for 74.69 per cent of the country's total active cases, the ministry said.

A declining trend in the positivity rate is also observed which has dropped to 16.98 per cent (May 16) from 24.47 per cent recorded on May 3, it said.

NEW DELHI: The Union health ministry on Sunday clarified that already booked online appointments for second dose of Covishield vaccine will remain valid and the same will not be cancelled on Co-WIN platform.

It, however, said requisite changes have now been done in the Co-WIN digital portal, as a result of which further online or on-site appointments will not be possible if the period after first dose date for a beneficiary is less than 84 days.

The Centre had on May 13 extended the gap between the first and second doses of Covishield vaccine to 12-16 weeks based on the recommendations by the Covid Working Group chaired by N K Arora.

"The Government of India has communicated this change to states and UTs. The Co-WIN digital portal has also been reconfigured to reflect this extension of interval for two doses of Covishield, manufactured by Serum Institute of India (SII) to 12-16 weeks," the ministry said.

"However, there have been reports in a section of the media suggesting

that people who had pre-booked their appointments for the second dose in less than 84 days on Co-WIN are being turned back from vaccination centres without getting the second dose of Covishield," it said.

"Additionally, already booked online appointments for second dose of Covishield will remain valid and are not being cancelled by Co-WIN. Further, the beneficiaries are advised to reschedule their appointments for a later date beyond the 84th day from the date of first dose of vaccination," the ministry added.

The Union government has reiterated to the states/UTs that online appointments booked for second dose of Covishield prior to this change of the interval between the two doses of Covishield, must be honoured.

It advised the states/UTs that the field staff may be instructed that, if such beneficiaries do come for vaccination, "the second Covishield dose must be administered and they must not be turned away".

They have also been asked to undertake awareness activities to inform the beneficiaries about this change. PTI

tims from the debris of destroyed buildings, many of those rescued could not reach the hospital as the main road leading to al-Shifa - the largest medical centre in the Gaza Strip – had been hit as well.

Dr Midhat Abbas from the Gaza health ministry said 1,200 Palestinians had been wounded during the seven days of attacks, about half of whom were women and children. He accused the Israeli military

of deliberately targeting health facilities with air strikes and bombing the roads surrounding al-Shifa. "They are targeting mainly ci-

vilians, these are the victims of this aggression," said Dr Abbas. "[Israeli Prime Minister] Benjamin Netanyahu wants to save himself from jail and so he decided to kill Palestinian children.' Israeli air raids killed 33 Pales-

tinians, including 13 children, in Gaza on Sunday, Gaza health officials said. The attacks brought the death toll in Gaza to 181, including 52 children. Israel has reported 10 dead, including two children.

There was no immediate comment from the Israeli military on the raids.

'Capacity very limited' Dr Abbas said staff were setting up beds in reception areas as the hospital filled up, adding that there were shortages of medicine and equipment as a result of the 15-year siege of Gaza by Israel and the coronavirus pandemic.

"We hope patients will be going to Egypt [for medical care] because our capacity is very limited," Dr Abbas told Al Jazeera.

Nurse Amal Badawi described the overcrowding as more wounded were brought in.

"The hospital is filled with people and relatives. It was difficult to work and conduct the needed treatment in light of this overcrowding. The number of injured or killed is huge and they just keep arriving," Badawi told Al Jazeera.

Among those killed in Sunday's air raids was Dr Ayman Abu Auf, a physician at al-Shifa, the health ministry said.

Fahad al-Haddad, an emergency medicine specialist at al-Shifa, said most of the dead brought to the hospital showed no external signs of injuries, meaning they were killed by the rubble that collapsed on them while they were still alive.

Egypt has opened the Rafah border crossing a day earlier than planned to allow the passage of students, people needing medical treatment and other humanitarian cases, two sources at the border told Reuters on Sunday.

The border had been closed for the Eid al-Fitr holiday and was due to reopen on Monday

Egypt has so far sent 16 ambulances into Gaza to pick up casualties of Israeli bombardments for treatment in Egyptian hospitals, a medical source said.

The source said a bus with 95 people on board had arrived from Gaza on Sunday morning.

NEW DELHI: The Centre on Sunday asked the state governments to keep ration shops, also called fair price shops, open for a longer duration and on all days to ensure timely and safe distribution of both subsidised and free foodgrains to the poor.

An advisory in this regard has been issued by the Union Food Ministry following representations that during the current lockdown in some states/UTs, ration shops' timings have been curtailed due to which the intended beneficiaries might not be getting adequate time

to lift their entitled foodgrains. "In view of ongoing lockdown in some States/UTs. that may curtail the functioning hours of Fair Price Shop (FPS), an advisory has been issued on 15th May, 2021...to keep the FPSs open, preferably on all days of the month," the ministry said in a statement.

The Centre is distributing highly monthly subsidised foodgrains of 5 kg per person at Rs 1-3 per kg via ration shops to over 80 crore poor under the National Food Security Act (NFSA).

Over and above this, additional 5kg of free grains are being distributed to the same beneficiaries under the PMGKAY (Pradhan Mantri Garib Kalyan Anna Yojana) scheme for two months -- May-June in order to minimise economic hardships being faced by the NFSA beneficiaries during the second wave of the Covid-19 pandemic.

In the advisory, the Centre has asked states to keep the ration shops open for distribution of foodgrains under the NFSA as well as PMGKAY scheme in a staggered manner throughout the day, maintaining proper social distancing and adhering to all CO-VID-19 protocols, it said.

To facilitate this, states have been requested to ensure that FPSs are exempted from the restricted hours of opening of regular markets as foodgrains are covered under essential items, it added.

Further, the Centre has asked states to take necessary steps for timely distribution of foodgrains at their FPSs without causing hardships to the beneficiaries, and to give wide publicity to the measures undertaken in this regard.

Iran Unveils Its Strongest Domestic Supercomputer

TEHRAN: Iran has unveiled a supercomputer - its strongest till date developed domestically by Tehran's Amirkabir University of Technology (AUT), according to the state-run news website IRNA.

The supercomputer is said to be wholly designed and built by a team of Iranian engineers, who developed the country's first supercomputer a decade ago, but some of its hardware has been imported.

The supercomputer will offer large-scale data analysis services for a variety of state-run and private scientific research, according to its developers. Among other things, it will be used in analysing artificial intelligence, crunching traffic and weather data, and image processing.

Amirkabir President Ahmad Motamedi said in addition to servicing the government, the supercomputer aims to provide a reliable infrastructure to companies with a focus on private firms. "At the moment, knowledge-based companies have offered good platforms but they don't have good infrastructures inside the country, which leads them to use infrastructures

'Will Not Be Silenced': Qatari Broadcaster Al Jazeera After **Gaza Office Destroyed**

DOHA: Al Jazeera said Saturday it would not be silenced, after an Israeli air strike on Gaza demolished the building housing the Qatar-based broadcaster as well as US news agency The Associated Press.

"It is clear that those who are waging this war do not only want to spread destruction and death in Gaza, but also to silence media that are witnessing, documenting and reporting the truth of what is happening in Gaza," said Walid al-Omari, Al Jazeera's Jerusalem bureau chief.

"But this is impossible," he said

on air shortly after the 13-storey Jala Tower in Gaza was obliterated.

This is a crime among a series of crimes perpetrated by the Israeli army in the Gaza Strip."

Al Jazeera broadcast footage showing the building collapsing to the ground after the Israeli air strike, sending up a huge mushroom cloud of dust and debris. Jawad Mehdi, the owner of the Jala Tower, said an Israeli intelligence officer warned him he had just one hour to ensure the evacuation of the building.

Al Jazeera's correspondent in Gaza, Safwat al-Kahlout, tweeted his despair over the destruction.
