52% of students want to opt for tech as career: Report

New Delhi: As India recently celebrated the National Technology Day on May 11, a new survey released on Wednesday indicates that 52 per cent of Indian students are interested in building a career in technology. According to the online learning platform Brainly, an overwhelming majority of students (72 per cent) said that tech-based subjects such as product engineering, data analytics and coding should be a part of the school curriculum. Another 47 per cent of students decisively said that studying technologies has become critical irrespective of anyone's stream.

"Technology can be learned the best if it is taught with real-world examples in a funlearning manner. It's good to see that so many students in India have developed a keen interest in learning technological concepts," Rajesh Bysani, Chief Product Officer, Brainly, said in a statement.

"Students are heading towards a digital future and must be provided with a favorable environment to explore technology. Hence, it is important to encourage them to follow a skill-oriented learning approach," he added.

More than half of the students (54 per cent) said that they had enrolled themselves in tech-related courses during the lockdown, the survey indicates, which included over 1,500 participants. Brainly has a commu-

Concern Over Nature Loss Surging In Developing Nations, Online Trends Show

n awareness of nature loss and calls to address it are growing in developing nations, not just richer parts of the world, researchers said on Tuesday, urging governments and businesses to speed up efforts to make economies more eco-friendly.

Research by the Economist Intelligence Unit (EIU) analysed the popularity of nature loss and biodiversity terms and topics in Google search trends, social media mentions and news coverage in 54 countries covering about 80% of the world's population The study, which covered the period from 2016 to 2020, showed that Google searches on nature loss and biodiversity increased by 16% worldwide, driven by growth in Asia, with searches up 190% in India, Pakistan 88% and Indonesia 53%.

Marco Lambertini, director-general of green group WWF International, which commissioned the research, said understanding of the problem had evolved.

"It is no longer an issue related to care about nature but about the concern that nature loss is having an impact on people's livelihoods," he told the Thomson Reuters Foundation.

One million animal and plant ing for COVID-19 recovery plans species are at risk of extinction due to humankind's relentless pursuit of economic growth, ally dominating the news and the



scientists warned in a 2019 landmark report on the devastating impact of modern civilisation on the natural world.

The world lost tropical forest equivalent to the size of California over a 13-year period, largelv due to commercial farming, WWF said earlier this year, callto revitalise conservation efforts. "Until now, climate has been re-

public debate, and nature not so much," said Lambertini.

That is now changing as harm to nature - whether extinction, deforestation or over-fishing - rises as a concern, he noted. The EIU research showed that

nature-loss conversations on social media had grown, with annual nature-related posts on Twitter rising from 30 million in 2016 to 50 million in 2020. The trend was strongest in Latin

America, where the number of Twitter messages soared by 136% between 2016 and 2019.

Major influencers - including political figures, celebrities and religious leaders - are using their platforms to amplify nature issues, with messages reaching a combined audience of almost 1 billion people worldwide.

With that jump in concern, demand for change is increasing - and it is becoming an issue not just for consumers in highincome countries, as commonly thought, Lambertini said.

More than 159 million signatures for biodiversity-related campaigns have been collected since 2016, the study found.

Lambertini pointed to an expansion of media coverage, social media and internet access as key drivers of the overall trend.

News coverage of the links between the coronavirus pandemic, wildlife and nature destruction, as well as reporting on forest fires, had highlighted how humans are impacting the planet, he added.

Other studies have found that people have developed a deeper appreciation for nature due to COVID-19 lockdowns, said Antonia Kerle, the EIU's manager for public policy consulting.

Ahead of October's delayed U.N. biodiversity summit, Lambertini urged policymakers there to set new ambitious global goals on nature protection, similar to the 2015 Paris Agreement on climate. Fixing the ways the world supplies and consumes food to make them more sustainable will also be vital for businesses at July's U.N. Food Systems Summit, he added.

"Nature is the other side of the ecological crisis of today - climate and nature are interconnected but nature is far behind in terms of clarity on direction and targets," said Lambertini.

'ANGELS IN APRON': Guiding Light In Kashmir's Gloom

Before trying some sleep at night, Sheeraza Akhtar, 24, takes an anx-iety-allying pill called Petril. The mind-altering medicine became a new normal for this jovial nurse when her workplace, a hospital ward, became a "madhouse", stormed by swarms for an emergency oxygen treatment.

As the crisis-manager of a hospital ward, she had never seen Kashmir as breathless as the unseen bug made it in its second coming.

"I'm suffering from hysteria," Sheeraza says in a PPE-gear heaved voice. "I feel suffocated to attend this crisis and often lose peace of mind due to frequent deaths in my ward. I crave



to see my family but can't while doing this grueling duty.'

Working as junior staff nurse at government tertiary care hospital, SMHS, Sheeraza is witnessing an "unspeakable" crisis in the ward.

She may be leading from the front and hailed as "the guiding light in the gloom" for the lockdown-plagued society, but Sheeraza says, it's a daily razorwalk for her tribe.

The doctors at the hospital told me lately that I'm mentally disturbed and need psychiatrist help," she says.

"Whatever I witness in my ward, be it the death of young people, or the terrible conditions of Covid patients, ends up haunting my sleep.

I get up in the middle of the

night- panting and with sweat beads on my forehead. This is not normal. None of us had signed for this!"

But this challenging task and perils involved in it hardly discourage these frontliners from performing their task. Honouring their role, this year's International Nurse Day, observed on May 12, was celebrated with the telling theme: "Nurses: A Voice to Lead - A vision for future healthcare".

Mindful of this medical wall's importance in the current health crisis, Delhi on May 3 surged their ranks by recruiting the final-year nursing students for the Covid combat.

But those holding the fort during the "unprecedented situation" are decrying disparity and apathy.

'Colourful Weapons' To Quell Protests Now

SRINAGAR - All protesters welcome to Srinagar. For moving away from batons and bullets, the police here Tuesday introduced cannons that spray coloured water on mobs and leave the stain -on clothes as "criminal" evidence.

The first to face this new' weapon against violent demonstrations were hundreds of local traders who staged a protest against value added tax (VAT) in the state.

Police turned the cannons on as the group marched, shouting slogans against the Mufti Muhammad Saveed government. "The cannon throws water of various colours at the protesters. It is not easy' to remove the stains from the clothes." said a senior police officer laying down the advantages of the new weapon.

There is no chance of pro-testers' death unless there is a subsequent stampede. And once the colours stain the clothes they cannot claim they didn't participate in the demonstration" he told IANS.

Police had to think of the cannons as unruly mobs on streets have become a daily routine here.

"Under section 144 of the criminal procedure code (CrPC), an assembly of five or more people is unlawful. Thus dealing with demonstrations is something the local police have to live with," another police officer said.

For over 1 years now because of insurgency, magisterial orders under section 144 of CrPC have been in force in all cities and towns of Kashmir.

Police firing at crowds has often stepped up public anger and created political controversies.

Now, the cannons purchased for Rs 2. I million are expected to come in handy.

Spraying cold water, these will be specially effective in the winters when temperatures drop below zero.

A cannon can easily disperse a crowd of up to 4,000 people. There is an additional facility of throwing rubber bullets if the water fails to do the trick." Javaid Mukhdoomi, inspector general of Kashmir said.

KO VIEW **Covid-hit tourism**

ith second Covid-19 wave wreaking havoc across the country, the tourism in Kashmir is one of the sectors that has been hit the hardest. Already reeling from over two years of constant disruption, the resurgence of the pandemic has made the prospect of revival of the sector even more bleak.

One of the factors that led to surge in Covid-19 cases in the Valley is the tourism itself. In the absence of the permission for international travel, a large number of domestic tourists came to Kashmir. In the process the administration also overlooked the Standard Operating Procedures in case of incoming holiday makers which, in part, led to the second wave spreading through the Valley. And this, in turn, has killed one more season of tourism.

This has prompted the administration to announce a Rs 3 crore relief package for people employed in the industry. According to the package, Rs 2,000 financial assistance will be provided to registered 'shikara' owners, tourist guides, ponywalas and others, including those who rent palanguins for yatris. The money will be paid for the next two months to tide over the peak of the ongoing wave.

But as is apparent this money is peanuts and will hardly compensate for the massive loss due to loss of tourists. And that too during the spring and the most probably during the upcoming summer season. Given its ferocity, the second wave is likely to last until early autumn. And until then the Covid-19 related restrictions would not only have impacted the tourism but also crushed the other businesses, leaving once again thousands of people unemployed.

This is why the government needs to think for the longer and prepare in advance for the coming three months. One question to ask would be if continuing the lockdown would be in the interest of the already battered economy. And whether denying people a chance to earn livelihood wouldn't be a cure worse than the disease? There is a large section of people living at the bottom of pyramid who have largely been jobless over the last two years. Their savings have already been depleted. For example, the transporters: the drivers and conductors have now very little to survive on. This includes also the people associated with tourism. So, while the government plans ahead, it has to take this reality on board. If the lockdown can't be done without, the administration has to come up with a reasonable economic package that at least takes a modest care of the people rendered without livelihood as a result.



The Writing on the Wall

here is no gainsaying that the pandemic and the lockdowns have affected the blue-collared class more than anyone else. We, of the white-collared class, retain our monthly salaries even as we work from home. But can an auto driver work from home? Can a printer work from home? Can a barber work from home? In the circumstances, they will do anything to earn a few rupees to feed their families. Even put up posters on walls. The posters were right in referring to children. But it isn't just vaccines that the children of the poor are deprived of. They are deprived of food, the very means of sustenance.

Though Article 19 of the Constitution of India grants our citizens freedom of speech, this is observed more in its breach than in its adherence. Not just the present dispensation, but even governments in the past have arrested citizens who have been critical of it. India, which prides itself on being the world's largest democracy, hasn't learned lessons from other major democracies in the world. such as the USA, the UK and Canada; where citizens are not generally arrested for expressing views that are unflattering to the government. The latest group of people in India to be arrested are neither CAA, NRC and farm law protestors; nor JNU students; nor urban Naxals. No, they are blue-collared workers in Delhi who put up posters in the city in Hindi and English, asking the Prime Minister why he had exported vaccines meant for their kids to countries like Iran, Iraq and Bangladesh. The arrests this time round are not under the infamous sedition law, but are under other sections of the Indian Penal Code that deal with disobedience to orders promulgated by a public servant; negligent acts dangerous to life; defacement to property; and the Epidemic Act. The irony, however, is that the men who put up the posters have nothing to do with writing them. They are poor printers, auto-rickshaw drivers, daily wage earners, and other such working class people, whom Covid, and the lockdowns associated with it have rendered jobless. They agreed to put up the posters only because

they were offered a paltry sum of Rs. 600 for every poster that they pasted. And not all of them were young. One of them was a 61-yearold frame maker. Forget his children, it is doubtful whether he, entitled to the vaccine as a senior citizen, got it in the first place.

Even if the government intended to make arrests, shouldn't they have attempted to find out the brains behind the posters, rather than arresting the have-nots who put them up? As it turns out, opposition parties like the Congress and the Aam Aadmi Party are so outraged by the arrests, that they have taken the blame for the posters, and dared the government to arrest them, instead of arresting dispossessed subaltern people.

Let me deconstruct the posters. To my mind, the wording of the posters is faulty. The government may be guilty of exporting vaccines, when there aren't enough vaccines available for our own 100 crore adult population; to fully vaccinate whom the government would need 200 doses. But the vaccines weren't meant for the children of those who printed the posters. Children haven't as yet been brought under the government's vaccination drive, though they may be later this year, with doctors warning that the third Covid wave might be detrimental to children. The government at the centre seems to overlook the fact that the proletarian people whom they arrested may have been the very people who voted for them in 2014 and 2019, giving them an absolute majority in Parliament. They fail to realize that the men they have arrested belong to the very class of people who are so poor that they cannot even afford wood to cremate their dead; as a result of which hundreds of unburned, decomposed dead bodies have been found floating in the Ganges in Bihar and Uttar Pradesh. The arrested men are probably the kin of migrant workers who trekked all the way home from Bombay, Delhi and Bangalore last summer. "We eat just once a day," Kailash, the gardener who looks after my Lonavla home, and has two school-going sons, said to me. The plight of the working class confirms my view that communism is better than capitalism.

I may be a writer and a professor, but I have friends who are drivers, motor mechanics, technicians, barbers, delivery boys, waiters, and so on. I have had many conversations with them. And the refrain of all of them is that they are on the verge of starvation. Yet, unlike us, the bourgeoisie, they are civil enough not to bear a grudge against the government. "What can the govern-ment do?" they say. "It's not their fault." They don't hold the government responsible for election rallies, religious gatherings, and strict lockdowns during the time of the pandemic. They are more apt to blame themselves, and people like them, for being careless and not following the rules. And it is such kind and considerate people who have now been arrested in Delhi

The government would do well, however, not to tax the patience of the common man. They must not drive the common man to use the John Heywood phrase 'Enough is enough'. They must see the writing on the wall, symbolised by the posters put up on the walls of Delhi's streets. The phrase 'writing on the wall', incidentally, for those who do not know, means something that will fail, or cease to exist. RBI's reading of the economy

he Reserve Bank of India (RBI) has said, in its monthly bulletin released on May 17, that "the biggest toll" of the ongoing second wave of Covid-19 is "demand shock". It listed other negatives — "loss of mobility, discretionary spending and employment, be-sides inventory accumulation" — but emphasised that "ag-gregate supply is less impacted". Perhaps because of this, RBI concluded that "the resurgence of Covid-19 has dented but not debilitated economic activity in the first half of 2021-22" and that the economy hasn't been as badly hit as it was last year (the central bank has added the caveat that this is a tentative assessment).

RBI is partly right. Last year, during the first wave, the 68-day lockdown and the subsequent graded (and gradual) easing of more restrictions meant a significant disruption in supply. This year, the Union government, burnt from its experience last year, has steered clear of announcing a national lockdown, leaving it to the states to impose localised lockdowns. Many states did resort to these measures in April as the second wave threatened to overwhelm their health systems, but ensured that there would not be too much of a disruption in industrial activities. The Nomura India Business Resumption Index for the week ended May 16 was 61.9 (100 indicates a pre-pandemic level of activity), a sharp fall from February, when it almost reached pre-pandemic levels. This level was last seen in June 2020, after the hard lockdown ended and industrial activities started resuming. It may fall again this week and next, with many states expected to extend lockdowns as the second wave shows the first signs of ebbing, but it is unlikely it will go down to the levels of around 45 seen last April.

'It's not a War in Palestine. It's a Genocide'

In Conversation with Political Analyst Dr Waiel Awwad

To understand the trick of terminologies, the tyranny of narratives and the possibility of resolution around the ongoing situation in Palestine, Kashmir Observer interviewed senior Arab journalist, writer and political analyst Dr Waiel Awwad.

ow did the current hostilities begin? The dominant narrative has been that Palestinians fighters firing rockets inside Israel triggered it

The problem started in the east Jerusalem neighbourhood of Sheikh Jarrah which Israeli's have tried to occupy since 1948 without any success. Ever since East Jerusalem and West Bank were annexed by Israel in the 1967 war, Jewish settlers increased ten fold. So, building activities of settlements never stopped with a sole aim of engineering a demographic change and Judaizing the holy city in clear violation of International law that considers it an Israeli occupied territory and any changes of its demography illegal.

So Sheikh Jarrah enclave has been a main target for the Jewish settlers who are calling for extermination of Arab populations and confiscation of Palestinian houses. Israel's draconian laws give only the Jews the right of citizenship, ownership of housing and other civic rights. Palestinians, especially in the old quarter of Jerusaelm are forced to leave their ancestral homes. Some cases are in the court and difficult to be solved by any law since there is no historical evidence except in the Torah as they claim.

Moreover Benjamin Netanyahu, the

killing machine to continue crimes against humanity. Trampling international law by blocking UN Security Council resolutions against Israel is a main job of the US at the world body. The former president Donald Trump went a step further and recognized Jerusalem as the eternal capital of Israel and gifted him the occupied Syrian territory of Golan disregarding all international laws. So Netanyahu is using US support to the full advantage of right wing Israeli settlers who reject even a two state solution.

Do you agree that the blatant approval or complicity voiced or signaled either through silence or lukewarm 'neutral' statements by much of the international community like the US, EU and UN has emboldened Israeli regime to carry on with its expansionist policies?

Palestine is a victim of colonialism, and Britain is chiefly responsible for creating the state of Israel through the Balfour Declaration of 1918. During the British mandate on Palestine from 1918-1947, a number of Jews migrated from Europe where they were persecuted. Colonial Britain had promised a homeland for the Jews in Palestine and so it helped ensure Jewish domination, started arming European Jewish settlers, shielded their crimes and turned blind eye to the massacres they committed of local peoples to facilitate the influx of settlers from all across the world.

The sufferings of Palestinians have never ended ever since. War after war has led to Israel capturing more Palestinian territories and using truce and peace deals to swallow and annihilate the whole of Palestine. The world is watching this horror — the second Nakba happening now after 73 years of the first exodus of Palestinians.

I will not be surprised if another massacre is committed in Sheikh Jarrah as a collective punishment for its residents or resisting the forcible

stream media. How are people across the Arab and wider world taking it?

If you are following the events in occupied Palestine, you will notice the gradual changes of terminology dictated to media personnel by the Israeli authority — from "occupied territory" to "disputed" and now to "legitimate Jewish state" where the Palestinians are not welcome!

The challenge for Israel now will be to change public opinion that there's no two-state solution, it is a Jewish state surrounded by radical Islamic elements. Through this narrative they will justify the possession of nuclear weapons and shift their focus on Jordan as an alternative to a Palestinian state temporarily, before creating a Palestine in Iraq as per the first Zionist organization plan in their meeting a century ago where they set up the objectives of greater Israel from Euphrates to Nile.

Is there any credible alternative media available in the Arab world? If yes, what is their reach?

Unfortunately, most of the Arabic channels are least independent in their reporting and mostly reflect the opinion of the country where these channels are based. However, it is getting more transparent in telecasting from the ground and disseminating news all over. It is up to the media houses whether to use it or not. Many strategic study centers have conducted lots of studies in English. Credibility is relative, and you can rely on local reporters, bloggers, and others available on social media. We need to diversify our sources and make our own assessment and judgment based on facts and reliability.

How much support is there for a two-state solution in Palestine? Do Hamas and like minded parties, who do not recognize Israel's right to exist offer any realistic solution?

As per International law Israelis cannot call it a defensive war. It's not a war in Palestine. It's a genocide. This is not a war but continued massacres of defenceless Palestinians.

Despite growing international outrage against Israeli actions in Palestine, Prime Minister Benjamin Netanyahu has pledged that the offensive against the Gaza Strip will continue. What in your view makes him disregard international laws and public opinions with such contempt?

It is nothing but an aggression on people by a politician who doesn't believe in peace and has never recognized Palestinian's right of existence in the holy land. Benjamin Netanyahu is not a man of peace nor is he helping Israelis to live in peace and co-exist with Palestinians and Arab neighbors.

Why Netanyaoo disregards International law is because Israel enjoys total backing of the United States. Its wars on innocent people are fought with sophisticated arms and arsenal provided by the US and its allies. It won't be wrong to say the US is solely responsible for allowing the Israeli Jerusalem as its capital. But the peace initiative was then rejected by Israel.

Yes, you are right. It did give more incentives to the Prime Minister of Israel to take on the 1948 Palestinians and continue with ethnic cleansing policy and by extension, complete the project of turning historical Palestine into an Israeli Jewish state and expel remaining Palestinians.

The world community has to wake up and end the oldest war in the world.

It is up to the Israeli's to make peace with the Palestinians and not force Arab countries to normalize relations by applying US pressure without finding a solution to the Palestine cause.

The Palestinians love their homeland and will never abandon it as they are sacrificing their lives to protect it and get their freedom. The world is changing; the regional changes after this assault no longer favor the right-wing government. We must join hands with the minority in Israel who are interested in peace with the Arabs, otherwise, it is an all-out war. This will be a lucrative opportunity for terrorist organizations and certain regional leaders to ride the wave and aggravate the situation and make it impossible to reconcile and live in peace and harmony.

The region is full of natural resources and more discoveries in the Mediterranean Sea of oil and gas that can be shared equally among neighbors. This is merely a wish in a greedy world. Denying the Palestinians their share of wealth is also part of the objectives to control the Gaza strip once again and re-occupy it at the cost of its long suffering people.

Study finds people are persuaded by social media messages, not view numbers

People focused more on self-related factors - how they felt about the video - when considering how much influence it would have on others

eople are more persuaded by the actual messages contained in social media posts than they are by how many others viewed the posts, a new study suggests.

Researchers found that when people watched YouTube videos either for or against e-cigarette use, their level of persuasion wasn't directly affected by whether the video said it was viewed by more than a million people versus by fewer than 20. The study will appear in the June 2021 issue of the journal Media Psychology.

The study involved 819 demographically diverse American adults aged 18-35.

Most of them were shown two YouTube videos either for or against vaping. The pro-vaping videos were commercials for e-cigarette brands. The anti-vaping videos were public service announcements produced by anti-smoking nonprofit organizations.

The researchers, though, ma-

they rated them as more truthful and believable. The number of views that the video had did not have a direct impact on how much they were persuaded.

Participants were also asked how much they thought the videos they watched would influence other young adults, Cho said.

Results showed that how participants themselves viewed the videos - whether they thought the videos were believable and truthful - was directly related to their estimation of the videos' impact on social media would.

Some participants saw the videos in a mock TV condition rather than in the YouTube condition. Overall, participants in the TV condition estimated the videos would have fewer views than did the participants in the YouTube condition.

"Social media may be seen as more pervasive than mass media like television because sites like YouTube do not have the same geo graphic boundaries as mass media may have." Cho said Overall, the results suggest that people should not equate the popularity of YouTube videos and other social media posts with how many people find their messages persuasive or are persuaded by them, Cho said "We may choose to watch a YouTube video because it has a lot of views, but that is different from whether we are persuaded by the message," she said.



What mattered for persuasion was viewers' perception of the message as truthful and believable.

"There wasn't a bandwagon effect in which people were persuaded by a video just because a lot of other people watched it," said Hyunyi Cho, lead author of the study and professor of communication at The Ohio State University. "The message itself was most important for persuasion." nipulated the view numbers that participants saw for the videos. Participants saw view numbers either around 10, 100, 100,000 or 1,000,000.

Participants rated how persuasive the videos were to them: whether they affected their curiosity about e-cigarettes, positive attitude toward e-cigarette use, and susceptibility to using e-cigarettes in the future.

Results showed that participants were more persuaded when

"They concentrated less on other-focused factors - such as view numbers - as a reason why a video might be persuasive."

Researchers reveal where memories of familiar places are stored in brain

new study from Dartmouth College reveals that three regions of the brain in the posterior cerebral cortex, which the researchers call 'place-memory areas', form a link between the brain's perceptual and memory systems, which helps the brain to store in memories of familiar places.

The findings are published in Nature Communications.

"As we navigate our surroundings, information enters the visual cortex and somehow ends up as knowledge of where we are—the question is where this transformation into spatial knowledge occurs. We think that the place-memory areas might be where this happens," explains lead author Adam Steel, a Neukom Fellow with the department of psychology and brain sciences in the Robertson Lab at Dartmouth.

"When you look at the location of the brain areas that process visual scenes and those that process spatial memories, these place-memory areas literally form a bridge between the two systems. Each of the brain areas involved in visual processing is paired with a place-memory counterpart," Adam said. For the study, an innovative methodology was employed. Participants were asked to perceive and recall places that they had been to in the real world during functional magnetic resonance imaging (fMRI), which produced high-resolution, subject-specific maps of brain activity.

Past studies on scene perception and memory have often used stimuli that participants knew of but had never visited, like famous landmarks, and have pooled data across many subjects. By mapping the brain activity of individual participants using real-world places that they had been to, researchers were able to untangle the brain's fine-grained organization.

In one experiment, 14 participants provided a list of people that they knew personally and places that they have visited in real life (e.g., their father or their childhood home).

Then, while in the fMRI scanner, the participants imagined that they were seeing those people or visiting those places. Comparing the brain activity between people and places revealed the place-memory areas. Importantly, when the researchers compared these newly identified regions to the brain areas that process visual scenes, the new regions were overlapping but dis-



vestigated whether the place-memory areas were involved in the recognition of familiar places. During fMRI scanning, participants were presented with panning images of familiar and unfamiliar real-world locations downloaded from Google Street View.

When the researchers looked at the neu-

ral activity, they found that the place-memory areas were more active when images of familiar places where shown. The sceneperception areas did not show the same enhancement when viewing familiar places. This suggests that the place-memory areas play an important role in recognizing familiar locations.

"Our findings help explain how a generic image of a clock tower becomes one that we recognize, such as Baker-Berry Library's tower here on Dartmouth's campus," says Steel.

"It's thrilling to discover a new set of brain areas," says senior author Caroline Robertson, an assistant professor of psychological and brain sciences at Dartmouth. "Learning how the mind is organized is at the heart of the quest of understanding what makes us human."

"The place-memory network provides a new framework for understanding the neural processes that drive memory-guided visual behaviours, including navigation," explains Robertson.

The research team is currently using virtual reality technology to explore how representations in the place-memory areas evolve as people become more familiar with new environments.

Police Gets Hi-End Command Vehicles For Anti-militancy Ops

SRINAGAR: The Jammu and Kashmir police on Wednesday inducted hiend command vehicles to its fleet which will be used as a communication and operational hub during emergency situations, particularly in anti-militancy operation.

The command vehicles are bullet proof and fully air conditioned and are equipped with high resolution CCTV/PTZ cameras providing 360' view of the area to the cops and officers while sitting inside the vehicle. The vehicle can also provide a comfortable stay of officers during the time of operations.

The vehicle comes with a threelevel power supply system which can sustain for a long duration. Another feature of the vehicle is an additional powerhouse (Genset).

"It shall be used as a communication/operational hub during any emergency particularly in anti- militancy operations," a police spokesper-

son said Wednesday. He said that the Director General of Police (DGP) Dilbag Singh on Wednesday dedicated operations command vehicles, equipped with modern technology to Jammu and Kashmir Police in a function held at Police Headquarters Jammu.

According to the police spokesperson, the DGP on this occasion inspected the command vehicles and appreciated the suggestions made by officers for further upgrading of these vehicles.

"He said that command vehicles are equipped with all modern gadgets

which will be extremely useful during different anti- insurgency operations," he said.

"He said that safety of our officers and jawans is on our top priority and added that providing additional secure mobility and safety gears would surely increase the efficiency and capabilities of our dedicated force, working on anti-militancy front," he added. Singh, as per police spokesperson

also chaired a meeting of top officers wherein he reviewed the response of police to the 2nd wave of COVID-19. "He directed the officers to take all

the necessary measures in assisting the administration and implementing the government directives on ground to prevent its spread. He expressed his satisfaction over the ongoing vaccination drive. He also directed the officers to provide COVID care facilities to the family members of the personnel who get infected by COVID," he said.

Adv Bhatnagar Suggests Door-To- Door Survey In Kashmir To Trace Symptomatic Patients

Advisor to Lieutenant **JAMMU:** Governor, Rajeev Rai Bhatnagar today stressed that it is important to efficiently manage the monitoring and treatment of COVID patients from home isolation through the public healthcare system right up to the tertiary care stage.

The Advisor stated this while chairing a meeting of senior officers and doctors through video conferencing to review COVID-19 Containment and treatment Management in urban, semi urban, rural and tribal populated areas of Jammu and Kashmir and future strategies for management of the Pandemic including preparation required for the future.

"There should be clear responsibility, accountability and follow up at each stage and we must improve contact tracing, identification of symptomatic patients so that there is targeted testing and timely isolation and treatment", Advisor Bhatnagar said.

The Advisor also emphasized on effectively enforcing the Corona curfew to reduce spread.

Advisor Bhatnagar while highlighting that door-to-door survey is being conducted in Jammu division to trace symptomatic patients, asked the Divisional Commissioner Kashmir to consider a similar exercise

He also directed all Deputy Commissioners and Chief Medical Officers to improve the functioning of Covid control rooms in their respective districts so that home isolated COVID positive patients are contacted regularly and can be monitored and given medical care as well as teleconsultation.

Bhatnagar further Advisor

directed the officers that the facilities at District Hospitals Community Health Centers (CHCs), triage centers and PHCs should be upgraded and made effective so that appropriate level of patient care is provided depending on the severity of the disease there itself and referrals to tertiary hospitals be done on need basis.

He also called upon all the Principals of GMCs, Directors of Health Services Jammu/Kashmir to ensure that treatment protocols are followed with proper delineation of responsibility and accountability so that best outcomes are achieved.

He complimented them for the outstanding work being done by them during the pandemic and said that the second wave has presented new challenges.

Earlier, Financial Commissioner Health and Medical Education, Atal Dulloo gave a detailed presentation over COVID-19 Containment and Management in periurban, rural and tribal population across the Union Territory.

He informed the meeting that a gradual ingress of Covid-19 infection is now being seen in peri-urban, rural and tribal Population, so it is important to ensure that community-based services and primary level health infrastructure in these areas are wellequipped to manage the situation.

He proposed a two way strategy for the containment of the Corona Virus in these areas which include: Surveillance, screening, isolation & referral and Monitoring of Active Cases in Home Isolation.

He informed that symptomatic cases could be triaged at village level by tele-consultation with Medical officer in charge or Mid Level Health Provider MLHP) besides MLHPs and ANMs to be trained in performing RAT. It was

given out that RAT should be made available at all public health facilities including Sub-Centres (SCs)/ Health & Wellness Centres (HWCs) and Primary Health Centres (PHCs).

He said that contact tracing of cases in community settings should be done while all those persons who have a travel history should be followed up after 5 days for any symptoms and tested if suspected.

Mobile Testing Vans can be utilized for covering 3-4 villages a day; active monitoring of Home isolation cases in rural areas; home Isolation kit including required medicines (as prescribed) and detailed pamphlet should be provided along with oximeter to all COVID Positive cases.

He said that a regular follow-up of home isolation patients through visits and telephone by frontline worker/ volunteers/ teachers duly following IPC practices should be done with immediate referral of patients to higher centers if there is difficulty in breathing, SpO2 < 90%, chest pain or mental confusion.

FC also informed that rural areas may plan a minimum of 30-bedded Covid Care Center (CCC) with makeshift facilities under supervision of PHC's/CHC's in schools, community halls or Panchayat buildings.

With regard to training of staff, he informed that training of the nodal officers, support staff and volunteers on basics of COVID, infection prevention control, use of PPE's, Medical waste management, use of infrared thermo-meters etc should be imparted on regular basis

for better management of Covid. On Clinical Management front, Dulloo said that people at CCC should be given basic advice of management of fever, cough and running nose besides warm gargle and steam

inhalation should also be advised twice a day and consult PHC doctor for treatment with low dose oral steroid if symptoms persist beyond 7 days.

"In case of oxygen saturation level less than 90% or shortness of breath, patient should be put on oxygen support immediately and transport for referral should be arranged", he maintained in the meeting.

The FC further said that Telemedicine services may also be utilized for providing post-covid followup care and mental health support.

On Community mobilization and Behavior Change communication, he added that the key stakeholders within the village community be mobilized for COVID-19 management and a checklist for community preparedness for COVID-19 response can be referred to, which is shared by MOHFW, GOI and health department.

He added that Block Development Officers (BDO) will identify mentors from health, ICDS to mentor the team at Gram Panchayat level, mobilization and involvement of SHGs for creating awareness for COVID appropriate behaviors and for providing essential services in their respective blocks.

Preparations for rapid COVID vaccination were also discussed during the meeting and it was highlighted that high coverage of vaccination is a pivotal strategy for preventing future surge. It was also said that appropriate strategies for achieving high coverage with COVID vaccination in rural areas need to be devised.

The meeting was informed that ASHA / AWW along with community leaders can mobilize beneficiaries for vaccination and proper IEC efforts to be made to address vaccine hesitancy of public.

rest of the family to prevent its spread. "They should immediately get their RAT done, and if it turns negative despite being symptomatic they should then go for the RT-PCR test. Till the time results are out, they should undertake medication, check temperature after every six hours and also check saturation levels after four hours and keep themselves hydrated besides taking a protein rich diet" he said.

He also said that if any of a patient's family members develops symptoms, they too should get tested "Otherwise if they develop no symptoms, they should undergo testing after a gap of five days and till that period even if they are asymptomatic their test can come as positive," Dr Singh said. Talking over the isolation period and its protocols, the senior doctor said that the patients should isolate themselves for 10 days to two weeks and till that period remain in touch with the concerned doctor and apprise him of the recorded temperature and saturation levels. He said in case the saturation levels decrease below 90, the doctor's advice will be to visit a triage centre where after proper check-up and testing (in case required) the patient shall be discharged or referred to hospital (as per health status) for further treatment. "The people suffering from decreased saturation levels and having the facility of Oxygen Concentrator and Cylinder at home, upon consultation with a doctor can maintain saturation level in between 93 and 94 for stable saturation levels," he said. Dr Singh further said that the Coronavirus is a biphasic disease, the first phase comes in the first week after contracting the virus and during this period some of the patients develop fever and other related symptoms. "While in second phase that commences with the beginning of second week, fever recurs in most of the patients and some of the patients also develop hyper inflammation (inflammation or swelling in veins) and there remains risk of blood clots and lung injury,' he said, adding that in such case if saturation levels also drop in patients the patients are advised to visit hospitals where X-ray/ CT Scan is conducted and accordingly treatment is started. "The patients that are discharged after their Oxygen saturation levels are normal and no longer have fever should still wear double masks at home and avoid direct contact with family members till they recuperate fully," Dr Singh said. He also advised that people should adhere to three basic protocols of Covid-19 viz. hand washing, maintaining social distance and wearing masks to avoid transmission/ contracting of virus. 'Wearing double surgical masks or N95 masks is more effective to prevent contracting of virus besides using a face shield while in crowded places is also very important to prevent contracting virus through eyes" he added. Strongly advocating for early vaccination, Dr Singh said that the last course of action through which we can control this pandemic is vaccination and everybody above 18 years of

age should undergo vaccination.

Regarding the third wave, he said if we do not adhere to SOPs, undergo vaccination and achieve herd immunity through vaccination, the virus may come again in a different form which can have more dangerous consequences.

"It's difficult to wear PPE kits in the ward because you can't fret critical patients by making them assume that they've landed in a Covid ward."

However, people are duly recognizing these valiant nursing efforts in the current crisis situation.

"After seeing patients, doctors just prescribe redicines, but nurses execute the rest of the process and take care of them until they get stabilised completely," says Mushtaq Misgar, an attendant of a Covid patient in SMHS hospital.

counsel, Syed Tassaduq Hussain, has challenged the "legality" of the PSA and seeks its scraping. "PSA is illegal because it contravenes 44th (1979) amendment to the constitution of India, Union of India was bound to bring this amendment into force," the PIL highlights.

While the PIL points out that for last 48 years amendment to Article 22 has not been brought into force, it seeks direction from the court to the Union of India for bringing into force the same.

"Section 8 of the PSA should be declared illegal because the government has to approve the detention but it cannot approve without hearing the (detainee)," the petitioner pleads.

Underscoring that "power to detain is power of the state" the petition says that a "divisional commissioner or district magistrate cannot detain a person"

Moreover the senior lawyer submits that the detainee cannot be moved from one place of detention without show cause. The petitioner is relying on a judgment of the House of Lords in England which, he submits, still holds good

The petitioner has also raised the issue of legal aid and according to him the state is bound to provide it to a detainee booked under PSA.

'Where the state detains a person under PSA, it has a duty under article 22 of the constitution read with articles 20 and 21 to provide legal aid to the (detainee)," the senior advocate says. (GNS)

'Angels In Apron'

Most of the nurses working in different hospitals in Kashmir capital have been reportedly engaged on academic arrangement basis many of them working for decades.

"Not that we're complaining about it when we're supposed to take care of our people, but working hard in these unprecedented times should be duly respected," says Sheikh Gowhera, another nurse catering a 'warlike situation' in Kashmir today.

"At the back of our distressed minds, job insecurity keeps haunting us. We remain at the forefront of this crisis and yet there's no basic facility like bus service for the nurses. It becomes very difficult to travel in the lockdown."

Most of these nurses, including males, work four days a week, and then go for isolation. They hardy visit home for the fear of infecting their family members.

"Last year, I infected my mother with my home visits," Gowhera says. "My mother gasped for breath for over 15 days in hospital. Those were the worst days of my life."

But despite these personal pains and perils, they stand strong to tackle another pandemic phase in the valley.

"Sometimes patients get stable and within no time their conditions get worse and they die before you," Gowhera continues to detail her daily duty.

"As a healthcare specialist, you get frustrated when you can't save lives!"

And what's equally adding to this mental breakdown situation is the packed wards of Kashmir hospital today where attendants are

"Even if a patient needs immediate attention or just a few encouraging words, nurses are there for them round-the-clock. They're saving breaths with their efforts in the hospitals today. For me, they're angels in apron and the backbone of the hospitals who remain at the service of the society at this crucial juncture."

Back in her ward, Sheeraza is feeling another anxiety attack with the demise of another patient. She takes Petril to stabilize her condition and carry on with her job.

"When you nurse patients, you naturally tend to develop bonds with them," the numb nurse says.

"And when some of them can't make it, they feel a personal loss to you and shake you beyond words."

Tragedy At Sea: 22 Dead, 65 Missing From Barge; 186 Rescued

t least 22 personnel on board accommodation barge P305 **L L that went adrift in Cyclone** Tauktae fury before sinking in the Arabia Sea off Mumbai coast are dead and 65 still missing, a Navy official said on Wednesday.

The Navy said its personnel, battling extreme weather, have so far rescued 186 of the 273 people who were onboard barge P305 and also two from tugboat Varaprada.

"Search and rescue operations are still on and we haven't lost hopes of bringing them ashore," an official said.

However, the chance of finding survivors is getting bleaker as the hours pass by, he added.

All personnel on board two other barges and an oil rig rendered adrift hours before the "very severe cyclonic storm" made landfall on the Gujarat coast are also safe, a Navy spokesperson said.

The 22 bodies, which the spokesperson called Brave Nature's Victims (BNV), were brought

ll India Institute of Medical Sciences (AIIMS), Delhi, is reporting more than 20 cases of 'Black Fungus' (Mucormycosis) disease on a daily basis, said Dr MV Padma Srivastava, Head, Department of Neurology, AIIMS. "In Delhi's AIIMS, there are

more than 20 cases of mucormycosis reported in emergency today. Mycormycosis was always there in those who are immunocompromised, diabetic, high steroid dose, but it was never in this number," Dr Padma, Head, Neurology Department, AIIMS, told ANI.

"She said that earlier the number was in single-digit. But, now we have crossed three-digit mark and are getting more than 20 cases of the infection every single day. We have made mucor wards separately at AIIMS Delhi, AIIMS Trauma Centre, and AIIMS Jhajjar," Dr Padma added.

She further informed that the index of suspicion of contracting Black Fungus is very high because of low immunity. If COVID happens to diabetic people, sugar should be strictly controlled and there should

be rational use of steroids.

Used to curb the spread of Covid-19, masks are exacerbating another pandemic: plastic pollution. Around 129 billion disposable masks are used every month around the world, according to the Ameri-

can Chemical Society. Made out of polypropylene plastic material, elastic and metal, used masks are usually thrown out in garbage bins, destined for landfills. or incinerated. They are also littering streets, rivers and oceans, harming wildlife. But researchers and companies are looking for ways to put masks to good use, though it is not a very profitable venture at the moment.

In Britain, several hospitals have acquired a compactor made by Cardiff-based Thermal Compaction Group which melts protective gowns and surgical masks into blue slabs. The material is then used to make

garden chairs or tables. In France, Tri-o et Greenwishes, a

recycling company, picks up masks tossed in special bins used by some 30 customers, including Parisian hospitals, TV network TF1 and building materials giant Saint-Gobain.

'We had a lot of demand from our clients" to offer mask recycling services, said company president Matthieu de Chanaleilles.

The company charges fees starting at 250 euros (\$300) per month to collect the trash

At its recycling plant, staff wearing protective gear stand behind plexiglass to sort through paper tissues, gloves and cups that are thrown in mask bins by accident. Afterwards, the workers are sprayed down with disinfectant.

The sorting area is sterilized with ultraviolet lamps. Masks are kept in guarantine for a week before being handled.

Two companies based in northern France then shred the masks, disinfect them and extract the polypropylene, which is transformed into pebbles that are used to make floor carpets or other plastic parts in a car.

Tri-o et Greenwishes has recycled one tonne of masks so far and hopes

In Trenton, New Jersey, Terra-Cycle sells a "zero waste box" for disposable masks for \$88.

The masks are then sent to partner facilities to be recycled into plastic granules that are sold to manufacturers that make other products such as benches, flooring surfaces or shipping pallets. TerraCycle chief executive Tom Szaky said recycling personal protective equipment is costlier than aluminium.

"Why is, say for example, a dirty diaper, or PPE not recyclable? It's because it costs much more to collect and process and the results are worse. So no one would bother doing it because there's no money to be made," Szaky told AFP.

"So Terracycle's business says 'Well, if someone's willing to pay those actual costs, then we can perform such a service'," he said.

In Australia, researchers at the Royal Melbourne Institute of Technology are experimenting with other solutions after being inspired by the sight of masks littering the streets.

Once disinfected and shredded, masks can be mixed with processed building rubble to create a flexible and robust material to help build roads, according to the scientists.

The researchers are now investigating their use in construction cement. Three million masks are need to make one kilometre (half a mile) of road.

"The facemask have a good tensile strength; they can provide tensile strength to the concrete, which is very important," Mohammad Saberian, a post-doctoral research fellow at RMIT University, told AFP.

"We're currently looking for partners to use the face masks in real-world applications and to make kind of a pilot road," Saberian said.

Since publishing the research earlier this year, several industries have expressed interest, and the team was now applying for funding to further investigate the findings, which could take one to two years, he said.
