



# **Study reveals a gentler strategy for** avoiding childhood dental decay

new therapeutic strategy could help wash away the build-up while sparing oral tissues by targeting the bonds between bacteria and yeast that can form a sticky dental plaque, suggest the findings of a new study led by researchers from the University of Pennsylvania.

The combination of a carb-heavy diet and poor oral hygiene can leave children with early child-hood caries (ECC), a severe form of dental decay that can have a lasting impact on their oral and overall health.

A few years ago, scientists from Penn's School of Dental Medicine found that the dental plaque that gives rise to ECC is composed of both a bacterial species, Streptococcus mutans, and a fungus, Candida albicans. The two form a sticky symbiosis, known scientifically as a biofilm, that becomes extremely virulent and difficult to displace from the tooth surface.

Now, a new study from the group offers a strategy for disrupting this biofilm by targeting the yeastbacterial interactions that make ECC plaques so intractable. In contrast to some current treatments for ECC, which use antimicrobial agents that can have off-target effects, potentially harming healthy tissues, this treatment uses an enzyme specific to the bonds that exist between microbes

The work builds off findings from a 2017 paper by Hwang and colleagues, including Hyun (Michel) Koo of Penn Dental Medicine, which found that molecules call mannans on the Candida cell wall bound tightly to an enzyme secreted by S. mutans, glycosyltransferases (Gftb). In addition to facilitating the cross-kingdom binding, Gftb also contributes to the stubbornness of dental biofilms by manufacturing gluelike polymers called glucans in the presence of sugars. ful microscopy, they also observed

of the surrounding medium was higher when exposed to the enzymes, indicating an environment that is not as acidic and thus less conducive to tooth decay. They also measured how easy it was to break up the biofilm after treatment, using a device that applies a stress, akin to tooth brushing.

"The biofilm structure was more fragile after the enzyme treatment," Hwang says. "We were able to see that the biofilms were more easily removed."

To confirm the mechanism of their approach--that the mannandegrading enzymes were weakening the binding between yeast and bacteria--the team used atomicforce microscopy to measure the bonds between Candida and Gftb. The therapy, they found, reduced this binding force by 15-fold. Finally, they wanted to get a sense

of how well-tolerated these enzymes would be when used in the oral cavity, especially since children would be the patient group targeted.

Applying the enzymes to human gingival cells in culture, they found no harmful impact, even when they used a concentrated form of the enzymes. In addition, they observed that the treatment didn't kill the bacteria or yeast, a sign that it could work even if the microbes developed mutations that would lend them resistance against other types of therapies.

## Dementia risk factors similar for men and women, not high blood pressure: Study

While the link between several mid-life cardiovascular risk factors and dementia was similar for both sexes, for blood pressure it was not-find George Institute researchers -in a study of just over half a million people.

The study showed that both low and high blood pressure were associated with a greater risk of dementia in men, but for women, the risk of dementia increased as blood pressure went up.

Lead author Jessica Gong said that while more research was needed to verify these findings, they may point to better ways of managing risk.

"Our results suggest a more tailored approach to treating high blood pressure could be more effective at preventing future cases of dementia," she said.

Dementia is fast becoming a global epidemic, currently affecting an estimated 50 million people worldwide. This is projected to triple by 2050 - mainly driven by aging populations. Rates of dementia and associated deaths are both known to be higher in women than men.

In 2016, it overtook heart disease as the leading cause of death in Australian women and it is the second leading cause of death for all Australians.

In the absence of significant treatment breakthroughs, the focus has been on reducing the risk of developing the disease and cardiovascular risk factors are increasingly recognised as contributors to different types of dementia.

To examine sex differences in major cardiovascular risk factors for dementia, George Institute researchers used the UK Biobank, a large-scale biomedical database that recruited 502,489 Britons aged 40-69 years (free from dementia at

study initiation) between 2006 and 2010. They found that current smoking status, diabetes, high levels of body fat, having had a prior stroke, and low socioeconomic status were all associated with a greater risk of dementia to a similar degree in women and men.

But when it came to blood pressure, the relationship with dementia risk between the sexes was different. Although the reason for this wasn't clear, the authors proposed some possible explanations.

"Biological differences between women and men may account for the sex differences we saw in the relationship between blood pressure and the risk of dementia," said Ms Gong.

"But there may also be differences in medical treatment for hypertension. For example, women are less likely to take medication as prescribed by their healthcare provider than men and may be taking more medications and experiencing more side effects.

While there are no effective treatments for dementia, trying to reduce the burden of the disease by encouraging healthier lifestyles is the priority, and the strongest evidence points to blood pressure management.

"Our study suggests that a more individualised approach to treating blood pressure in men compared to women may result in even greater protection against the development of dementia,' said Professor Mark Woodward, study co-author.

"It also shows the importance of ensuring sufficient numbers of women and men are recruited into studies and that the data for women and men should be analysed separately," he added.

'Researchers suggest using urban city design to promote heart health'

ities harbour a dangerous cocktail of environmental stressors which politicians must tackle to save lives and preserve health- says the conclusion of a new paper. The paper was published in the Eu-

ropean Heart Journal, a journal of the European Society of Cardiology (ESC).

'By 2050, three in four people will live in cities, where up to 80% of energy is consumed and 70% of greenses are emitted " sa author Professor Thomas Munzel of the University Medical Centre Mainz, Germany. "There are limited actions that individuals can take to protect themselves from pollutants so politicians and policymakers need to take on this responsibility." Cardiovascular diseases are the leading cause of mortality in Europe, accounting for 47% and 39% of all deaths in women and men, respectively.2 The World Health Organization (WHO) regional office for Europe has advocated urban planning which supports cycling and walking and improves air quality. The proposal, supported by the ESC, is a step towards meeting the WHO's target of a 25% relative reduction in premature mortality from cardiovascular disease by 2025 (compared to 2010).

Air pollution is responsible for around 800,000 fatal illnesses per year in Europe, of which around half are heart attacks and strokes. Transport emissions are the largest contributor to air pollution in cities around the world. Similarly, the dominant source of noise is road traffic, which increases the risk for ischaemic heart disease. It has been estimated that long-term exposure to transportation noise is responsible for 48,000 new cases of ischaemic heart disease each year in the EU. Nocturnal light pollution has been linked with hospitalisation and death from coronary heart disease. Meanwhile, concrete urban areas absorb and re-emit the sun's heat, leading to rising temperatures.

These heat island effects have been connected with deaths during heatwaves, which can be mitigated with vegetation.

Environmental stressors cluster together and actions are needed which combat them all. "Transitioning to cities that promote local living and active and sustainable mobility is increasingly recognised as providing co-benefits for health and the environment by creating more sustainable and liveable cities," states the paper.

City planning is now recognised as one way to tackle adverse health outcomes. Designs include car-free areas and compact cities which shorten travel distances. Limiting car use while increasing public and active transportation (walking and cycling) would promote heart health by reducing air pollution, noise, and heat island effects and increasing physical activity.

Major Among 3 Soldiers Killed

JAMMU - An Army Major was among three soldiers killed and an equal number injured when militants ambushed their patrol party in Rajouri district Friday afternoon.

Brigadier General Staff (bgs) 16 corps, Brig. Dhruv Katoch, told reporters the militants ambushed a patrol at Mouhla area in Rajouri district, 160 km north of Jammu, at 11 a.m. "The attack left Major Satyajet Shinde and three soldiers dead." Katoch said.

The attack took place when an army patrol party of 14 Maratha Light Infantry was on its way for an operation in Dharamshal area of the district following a tip off that militants were present in the area, the sources said.

Militants had set-up ambushes at Bandri area in Kalarara forests in the belt and as the troops led by Major Shinday reached the place militants hurled the grenades and opened indiscriminate fire around 1300 hours, they said

Troops took positions and fired back, they said adding that in the subsequent fire fight four army personnel were killed and four others injured.

The bodies of dead and injured were ferried in a helicopter to military hospital in Rajouri, reports said. The condition of two injured jawans is reported to be serious, they said. Hizbul Mujahedin has claimed responsibility for the attack. Brig Katoch was quoted by reports Friday evening saying that additional troops have been sent to the area and a fierce gunbattle was going on.

Meanwhile in a separate incident in the same district an army jawan was critically in-jured in a landmine blast near the Line of Control (LoC) to-day. Army sources said Sepoy Ajay Kumar inadvertently stepped over a landmine near LoC in Rajouri while he was on routine patrol in the area. In the explosion, Ajay sustained critical injuries. He was airlifted to army command hospital in UIdhampur

Another soldier was injured when militants triggered a powerful Improvised Explosive De-vice (I ED) at Komoh Kulgam in south Kashmir today.

## 'Share Dollars And Doses': **Richer Nations Try To Tackle Vaccine Inequalities**

ajor drugmakers and rich nation leaders faced up on Friday to the startling global imbalance in fighting COVID-19 and made big pledges to up supplies of cut-price vaccines to poorer regions. Lavishly-funded mass inocu-

lation campaigns are helping the West and others slash infections, but few shots have reached poorer nations where the virus is still raging, sometimes uncontrollably, drawing accusations of "vaccine apartheid".

More than 80% of the first billion shots went to wealthy countries, compared to just 0.2% for low-income nations, US philanthropist Bill Gates told a special Group of 20 summit focussing on the global health crisis. 'If we do not close this im-

mense gap, more people will die needlessly. There are two immediate actions countries can take: share dollars and doses," he said.

The summit was to call for voluntary licensing and technology transfers to boost vaccine production, but will sidestep a push from the United States and other nations to waive valuable patents, a joint declaration showed. The European Union promised

to invest 1 billion euros (\$1.2 billion) to set up vaccination manufacturing hubs in Africa.

At the Italian- and EU-hosted virtual summit, Pfizer and BioN-Tech also pledged to make available 1 billion cut-price doses this year to poorer nations. Another 1 billion vaccines would be provided next year, Pfizer boss Albert

Bourla told the summit. Johnson & Johnson promised to COVAX, a vaccine-sharing es in an emergency.REUTERS

"As we prepare for the next pandemic, our priority must be to ensure that we all overcome the current one together. We must vaccinate the world, and do it fast," Italian Prime Minister Mario Draghi said.

China's President Xi Jinping pledged \$3 billion in aid over the next three years to help developing countries recover from the pandemic and proposed setting up an international forum to promote fair distribution of vaccines. US President Joe Biden was

not among the speakers, organisers said. His administration has backed calls from many developing countries for a waiver of patents for COVID-19 vaccines, in the hope that would boost production and allow for more equitable distribution.

However, the final declaration seen by Reuters did not mention such a mechanism. It has been contested by some European nations, who have instead called for the removal of US trade barriers that they consider the main bottleneck preventing a ramping up of vaccine production.

They also need to manually brake or accelerate as necessary to ensure safety and keep trains on schedule.

# **Modi is Here to Stay**

Why Covid-19 catastrophe in India may not dent the PM's popularity

**There are** still three years to go before another general election. The PM has ample time to not only resurrect his battered image but also rally people around a new crisis, manufactured or otherwise s India descends into chaos following runaway Covid-19 surge, many people foresee the eventual unraveling of the charisma of the country's strongman leader Narendra Modi. But there are reasons to believe that the virulent second wave may not be enough to dent the PM's popularity. His 21 years in power - six of them as prime minister of the country - prove it.

From 2001 to 2013, he won three successive elections in Gujarat despite getting a bad press in the country and being shunned internationally. The PM was banned from setting foot on the US soil for his alleged role in Gujarat riots that led to death of over 1000 Muslims. But despite the controversies surrounding his rule, Modi's popularity in Gujarat rose and soon spilled over its borders. He began to be seen as a tough and an efficient guy, a one-stop solution for country's ills. Soon, the myth around and about him caught on. Later he diversified his image and added to it the dimensions of a good organizer, administrator and the promoter of Gujarat's economic development. By the time, Modi won his third Gujarat election, he was a nifty package of all the ideal qualities that a critical mass of Indian population in 2014 wanted in its leader.

As prime minister with an absolute majority in the parliament there has been no looking back for Modi. With a penchant for dramatic measures that create a false impression of being a magic bullet for the country's problems, the PM in 2015 announced demonitization of high denomination notes. The move triggered nation-wide chaos. The entire population of the country was forced to stand in long queues outside banks in the heat of harsh Indian summer to deposit old notes - scores of people perisged while doing so. Demonitization also set back the small-scale business sector, a fallout that was further reinforced by the subsequent implementation of uniform tax regime for the country.

But Modi became only more popular. He turned the massive suffering into a moral experience for people. Soon after, he won the all-important polls in Uttar Pradesh, India's most populous and politically very important state. The victory in Uttar Pradesh was of profound significance not only for the future of the state but also for India as a whole. At stake was not only the mundane question of who ruled the UP over next five years but where the India was headed as a country. Modi's win in the UP was also a ringing public endorsement of demonitization and mandate to the PM to go ahead with similar radical measures. Thereafter followed surgical strike against Pakistan. But by the time, 2019 elections drew around, Modi's chances of re-election looked diminished. This is when Pulwama attack that killed over 40 CRPF personnel took place. The PM once again launched an attack against Pakistan, this time deep inside the country on alleged terror camp at Balakot. This fired up his support base, winning him election with a landslide majority. Pakistan's swift retaliation, the loss of a fighter plane and the cap-

ture of its pilot did nothing to affect his chances.

Soon after, the re-elected PM embarked on far-reaching moves like repeal of Article 370 that granted J&K its semi-autonomous status under India's constitution. The move per se didn't invite any adverse international reaction. Even Pakistan, the country most affected by the move, restricted its response to diplomacy and the downgrading of the bilateral relationship.

The Article 370 move was followed by measures

But, yes, ahead of 2024, the election in Uttar Pradesh next year would be crucial for the PM's future. A loss in the country's most populous state would certainly cast shadow over his re-election.

Similarly, last year when lakhs of daily wage labourers in major metropolises lost their jobs and were forced to walk hundreds of kilometres to their homes following the sudden announcement of nationwide lockdown, few expected Modi to win more elections - at least not in the home states of these labourers like Bihar. But the BJP, Modi's party, increased

**B**RISBANE – Almost one-quarter of humanity lives on the Indian subcontinent. That fact is easily forgotten elsewhere, as world leaders focus on combating outbreaks of COVID-19 and its new variants within their own countries. While not a silver bullet, this initiative, coupled with the removal of restrictions on related supplies and equipment, would help India's sizable pharmaceutical industry to increase production, thereby reducing vaccine shortages domestically and in the region.

It is also incumbent on countries with excess vaccine supplies – particularly those in the developed world – to share the wealth. Earlier in the pandemic, India set an example by sending more than 66 million doses of vaccines to 95 countries around the world when it could have vaccinated its own people more rapidly. It is time to return the favor.

Equally important, more must be done to counter the scourge of misinformation. In an environment where fraudulent miracle cures are being propagated widely on social media, the world should help fund and support vaccine-literacy programs. Campaigns to increase the acceptance of masks, vaccines, social distancing, and other measures are needed especially in rural parts of the subcontinent, where complex sociocultural factors and linguistic diversity pose additional challenges.

Finally, there is the problem of insufficient oxygen – canisters, concentrators, and tankers to transport them. Of all the requests we have heard from our friends in the region, the plea for more oxygen has been the most urgent. India has only around 1,600 cryogenic tankers capable of transporting oxygen from production facilities to hospitals. And that includes the tankers it already supplied to Nepal, which itself has such a paucity of oxygen canisters that it is now asking mountaineers returning from Mount Everest to donate their empty ones.

Shipping cryogenic tankers and oxygen canisters to South Asia will help save the lives of those threatened by the shortage, rather than by COVID-19 itself. Here, developed countries with ample production capacity can help in ways that local nongovernmental organizations cannot – and help they must.

Ultimately, this pandemic, and the legacy of our global response, belongs to all of us. Each generation is confronted by challenges great and small, and this one is ours. Unless we can truly protect people everywhere by arresting the virus and slowing its mutations, we may find ourselves facing the prospect of a permanent pandemic

# Israel-Palestine: Nine days that shook the world

The contours of the new struggle have already been determined. It has Jerusalem at its geographical centre, and Palestinian citizens of Israel as its foot soldiers

am getting lots of messages from my Israeli friends," a Palestinian citizen of Israel said over Signal. Presumably because she thought Shin Bet could not monitor the call. "They tell me not to worry. Things will soon be back to normal.

"I think to myself: "the normal for you is to go back to the beaches. The normal for us is to go back to our cages. What is normal like for a Palestinian in Gaza, the West Bank, and Jaffa? To smile as we serve you falafel and humus, to laugh as we sell you our vegetables or repair your cars cheaper than you would do at home, or to labour on your construction sites?

"We are scared at the bloodshed that could take place. But we are happy. For the first time in my life I see something that has been dormant for decades, stirring, coming alive.

"I see a new generation stepping up. They are younger than me. They take orders from no-one and they are rising. I am fucking happy not to consider myself an "Israeli Arab". I am Palestinian, and for the first time in my life I can see light at the end of our long tunnel."

#### Fuelling the resistance

The speaker has an Israeli passport, a good job, a flat - actually a house which was once appropriated from a Palestinian family in Jerusalem. She travels regularly to Europe. Her Hebrew is perfect, better than many Jewish immigrants. In fact, she is often mistaken for a Jew.

Hers is only one, in a cacophony of voices, and I do not select it because it suits the way I think. But as each day passes, the sentiments she has expressed, and that of other Palestinians like her who do not say it out loud, will do more to determine the future of this conflict than any contorted statement by US President Joe Biden or his Secretary of State Antony Blinken.

In fact, every apartment block Israeli jets demolish in Gaza, every family evicted from their home, every house given by the courts to a Jewish settler, now becomes an act of war. It will not produce defeat or resignation. It will

occupied West Bank under the nominal rule of an unelected Palestinian leadership; Palestinians in Jerusalem, who have residency permits; Palestinian citizens of Israel who have passports. The Palestinians in the diaspora do not appear to exist, according to Israel.

This struggle has been characterised by long periods of quiet and submission. Each time this happens, Israel mistakes quiet for acquiescence

Each had different issues. For Gaza, it was electricity, water, and concrete. For the West Bank, it was salaries and jobs. For Jerusalem it was houses; for Palestinian citizens of Israel, it was equality and policing. But each was dependent on Israel, to open and close gates in the wall, to have access to tax income, or medical care. The security apparatus of the Palestinian Authority (PA) was designed and trained as an extension of Israel's security. Jerusalem had called for Gaza to intervene and chanted for Mohammed ad-Deif, the head of al-Qassam Brigades, to come to their support.

#### The unpalatable truth

The Israeli security establishment said this was because the organisers of the al-Aqsa protest were members of Hamas.

They gave the militant group too much credit. It was not just Hamas members chanting "Mohamed ad-Deif". It was a new generation of Palestinians in search of their Saladin. The unpalatable truth is that Hamas does not appear to have made a mistake by firing those missiles at Jerusalem when Israel refused to withdraw from the al-Aqsa complex.

By firing missiles not in defence of Gaza, but of al-Aqsa, Hamas pushed the conflict past a tipping point, triggering the revolt among the Palestinians of 1948 and the West Bank too. Had rockets not been fired, the situation could have returned to calm, after the end of Ramadan, and that is what the Israeli media were expecting. After Ramadan, Israeli authorities could have resumed their evictions of the Palestinian residents of Sheikh Jarrah in particular and Palestinian residents of Jerusalem in general. As a consequence, the events that followed have created a broad Palestinian front, a phenomenon not seen since 1948. A revolt of these dimensions has not come out of the blue. It has been decades

its paymasters in Israel. It is telling that a general strike was first called by the leadership of the 1948 Palestinians, to be endorsed by Palestinians in the West Bank. This led to the biggest general strike since 1936.

There are grounds to be sceptical about this newfound unity. The Palestinian leaders are past masters at shedding their political skins and slithering back to the opposite camp. But they are not the drivers of this movement. They are being driven by it.

#### Palestinians and Arabs

The second major strategy to have been dented, if not undermined, in the last nine days was the sustained attempt to separate Palestinians from their Arab backers. This culminated in the Abraham Accords in Washington last year, but had started with Egypt's and Jordan's peace treaties with Israel. southern Lebanon at Israel has yet to be determined and verified. So far, it suits Hezbollah to license missile launches rather than launch its own much deadlier rocket arsenal at Israel.

#### Palestinian diaspora

The third plank of the status quo was to isolate Palestinians worldwide. A whole ministry, the Ministry of Strategic Affairs, was created by Israel to combat BDS, delegitimisation, and deal with Western politicians who would not play ball with their narrative.

Irrespective of the now ritual statements of support from the political elite, the feeling of popular outrage over and support for Gaza is overwhelming

The ministry succeeded in its tactical battle to conflate opposition to Zionism, and opposition to Israel, with antisemitism. It succeeded in bullying and terrifying a generation of politicians on both sides of the Atlantic, making the former Labour leader Jeremy Corbyn an object lesson of what happens to a politician when he refuses to play ball.

But these were tactical victories, not strategic ones. Irrespective of the now ritual statements of support from the political elite, the feeling of popular outrage over and support for Gaza is overwhelming. Large demonstrations took place in London, New York, Berlin and Paris.

Israel has lost a battle that is being played out on unfamiliar territory: Tiktok and Instagram. The IDF social media accounts are a joke. When Paris Hilton retweeted Middle

When Paris Hilton retweeted Middle East Eye's interview with a 10-year-old girl in Gaza expressing in fluent English her incomprehension at the bombing: "I am just ten. Why do we deserve this?", her anguished plea of pain went around the world several times.

The Israeli army is a past master at manipulating the truth. It hoodwinks the mainstream western media into believing a ground incursion into Gaza had started (to flush out Hamas fighters entering their tunnels). Its air force may bomb the building housing AP and Al Jazeera.

But the conflict of the last nine days was not played out in the mainstream media, which was slow to start and reluctant to report it all the way along. It was fought on social media and Israel can not prevent videos of anguished Gazan children from spreading like wildfire over social media. Furthermore Pal-

fuel the fire of resistance.

The Israeli Zionist left prefers to see the status quo upended by "extremists on both sides" putting Jewish settlers and Hamas in the same bracket. The status quo, if you follow the logic of the speaker quoted above, is extremist and only benefits one side in this extremely unequal struggle.

Nine days have changed the conflict in a way most people outside the mixed cities of Haifa, Lod, Ramle, Acre and occupied East Jerusalem have yet to realise.

The realities of the relationship between Israelis and Palestinians that

Separation became so dominant that, for years, it was internalised by the Palestinians. They had difficulty thinking that it could be otherwise. When fighting erupted between Israel and Gaza in 2009, 2012, 2014, Palestinians in the West Bank were, mostly, passive spectators. Cars were not burnt in Lod. There was no general strike. The residents of areas threatened with



nine days ago appeared set in concrete - all 25-foot high and stretching for over 400 miles - have tumbled down with a speed that no one (least of all the speaker quoted above) could have predicted. Bear with me while I go through them.

#### United we stand, divided we fall

For decades, the strategy of Israel, under a left or right-wing government, was divide and rule.

Palestinians lived separate lives in enclaves under different regimes, enjoying different privileges: Gaza as an enemy state under siege with just enough calories and electricity to survive; the eviction like Sheikh Jarrah fought their own lonely, local battles for decades.

For nine days, unity has been coursing through Palestinian veins. It was caught live on Al Jazeera, which at one point a week ago carried split screen of scenes at the Damascus Gate where Palestinians were arriving to enter the old city, and at the Hebron Gate, where Jewish settlers were arriving with Israeli flags.

At first, I did not realise what I was seeing. A rocket from Gaza flew overhead. The settlers fled in panic. The Palestinians stayed where they were, waving and cheering. Palestinians in in the making. It has come precisely at the time when the Israeli right boasted that the conflict was over. They said so openly in the US media and at the UN. On Monday, Fatah flags were seen to be flying alongside Hamas flags in protests in Nablus and it is a long time, too, since that was seen. Fatah has to be seen to be responding to the prevailing mood.

Similar unity was expressed at the start of the Second Intifada, but as soon as Yasser Arafat was dealt with, Fatah returned to security cooperation with Just a few short weeks ago, it looked as if Saudi Arabia would come on board, to be followed shortly afterwards by Oman and Qatar. Within a matter of months, the boycott of Israel by the major GCC powers would have been reversed, the Arab Peace Initiative (the last major offer to settle this conflict) would have been over, and the Palestinians would have effectively become a migrant workforce without a state, relegated to the status of the Kurds.

While this scenario has not disappeared, and while the Saudi and Emirati influencers and bots are still pumping out Israel's narrative, this strategy is being overwhelmed by mass demonstrations of protesters in Jordan trying to cross the border with Israel; incursions too, from southern Lebanon into Israel; and Egypt being forced to open its border at Rafah and take in wounded Palestinians in Gaza.

President Abdel Fattah el-Sisi is no fan of Hamas or the Muslim Brotherhood. He destroyed a whole city, the Egyptian side of Rafah, and forcibly removed its inhabitants so that tunnels running under the border could be flooded and destroyed.

If any Arab leader has enforced the siege of Gaza more zealously than the Israelis, it has been Sisi. And yet he has been forced now to open the border he spent so much energy in shutting. Of course, political messages are being sent. After the unpleasant shock of a Saudi-sponsored attempt at a palace coup, Jordan's King Abdullah is no doubt using the turmoil to remind Netanyahu that Israel has its longest and most vulnerable border with Jordan.

Little happens in the kingdom without the permission of the Jordanian mukhabarat, and particularly not in the sensitive border area, so the pictures of crowds of Jordanians marching on the Israeli border would not have happened without state license. It is telling how eastern Jordanians were in the forefront of this protest. This is another sign that the divisions, which kept the status quo in place, are dissolving.

The exact identity of the group responsible for launching missiles from estinians can now express themselves in good English.

Hilton deleted her tweet. Bella Hadid did not delete hers. Irrespective of the pressure on A-listers to conform to the status quo, the damage has been done.

#### A new dawn

It will be for history to judge whether the events we are witnessing turn into a full intifada, or an al-Quds or Jerusalem intifada. The debate now among Palestinians is how a third intifada could continue after the ceasefire which will inevitably happen in the next few days.

But let's say an exhausted quiet descends on the region after a ceasefire is negotiated between Israel and Hamas. Will everything go back to normal?

I doubt it. The contours of the new struggle have already been determined. It has Jerusalem at its geographical centre, and Palestinian citizens of Israel as its foot soldiers.

They will be backed by a generation with nothing to lose. They have no leaders, no state, no Arab countries backing them, no rights, no arms, and no hope of getting any of them. Having deprived them of their own state, and declared in the Nation-State Law that the state of Israel is the expression of self-determination for its Jewish citizens only, a revolt can not come as a surprise.

The power-drunk lords of the land have left this generation of Palestinians with few viable alternatives. This struggle has been characterised by long periods of quiet and submission. Each time this happens, Israel mistakes quiet for acquiescence. It deludes itself into thinking the conflict is over.

But each time a new leadership emerges from the bottom up. This is how Yasser Arafat came to the fore. This is happening again and the world should wake up to it.

# Workplace COVID-19 safety protocols impact employee behaviour outside work'

mployer COVID-19 safety measures influenced worker precautions even when they were not on the clock, according to a new study from Washington State University. The results of the study were published

in the Journal of Occupational and Environmental Medicine.

The study found that workplace cultures that adopted COVID-19 prevention measures, such as daily health checks and encouraging sick workers to stay home, resulted in less "sickness presenteeism" or going places when feeling ill.

The effect was found both inside and outside of work - meaning fewer employees with COVID-19 symptoms showed up to work and other public places like grocery stores, gyms, and restaurants.

The same held true for attitudes toward the COVID-19 prevention measures recommended by the Centers for Disease Control and Prevention such as maskwearing and social distancing: employees working for companies with strong

COVID-19 prevention measures were more likely to have positive attitudes toward the CDC guidelines.

"The workplace COVID-19 climate had a direct effect on shaping employee attitudes towards the personal, preventative health actions that the CDC recommends," said Tahira Probst, WSU psychology professor and lead author of the study.

"Public health officials and employers should be aware of the impact that organizations and workplaces can have on stemming the tide of the pandemic. It's not just that employers have an impact on the transmission that occurs within the workplace, but they are also influencing those same employees' attitudes and behaviours outside of the workplace," added Probst.

For the study, the researchers surveved more than 300 working adults recruited on the Amazon Mechanical Turk crowdsourcing website in three waves dur ing the pandemic holiday surge.

They first surveyed the workers in October 2020 to assess the COVID-19 climate of their workplaces; then in December 2020, about their attitudes toward the

CDC prevention guidelines, and finally in February 2021, about their work and nonwork behaviours when sick or exposed to COVID-19.

The study found a significant connection between the workplace COVID-19 climate, employee attitudes toward the pandemic prevention measures, and ultimately whether they showed up to work or other public places while feeling ill with COVID-19 symptoms or following known exposure to the virus.

The respondents came from 44 U.S. states and Washington D.C. While the survev did not use a nationally representative sample, the respondents' demographicswith a median age of 40, 59 per cent male and 76 per cent white-aligned well with the general labour force with a median age of 40-44, 53 per cent male and 78 per cent white. However, the survey group was generally more highly educated with 67 per cent reporting having a college degree or higher, compared to 40 per cent in the general labour force.

During the survey period, about half of the respondents were working on site and half remotely. Interestingly, the study found that even the remote workers were influenced by their employers' COVID-19 workplace climate. Remote workers were less likely to frequent public spaces after exposure to the virus or while ill when working for a company with strong prevention measures in place.

The researchers noted that many U.S. organizations have long-standing cultures stigmatizing sick leave and encouraging sickness presenteeism. The good news, the authors point out, is that workplaces can help curb the spread of COVID-19 by actively encouraging sick employees to stay home, instituting daily health checks, and adopting other CDC workplace health and safety precautions.

The pandemic has forced some organizations to examine their culture around sick leave, and Probst is interested to see if this will become a long-term change.

'One of the more enduring conse quences of the pandemic might be that organizations not only offer more sick leave but also encourage employees to stay home if they're sick," said Probst.

"Frankly, prior to COVID-19, a lot of our culture has been: 'unless you're gravely ill and can't get out of bed, you should be at work.' That behavior spreads diseases and ultimately reduces productivity. We're hopeful that the pandemic might institute a re-thinking of this norm moving forward," concluded Probst.

Study finds new, much effective treatment for Vitamin D deficiency

new study demonstrates 25-hydroxyvitamin D3 is an effective treatment for vitamin D deficiency in some specific patients.

There are several million people worldwide with various fat malabsorption syndromes including those who have undergone gastric bypass surgery and those with obesity. These patients often have a difficult time absorbing vitamin D and both groups of patients are at an increased risk for vitamin D deficiency and therefore at higher risk for osteoporosis and osteomalacia (softening of the bones).

Patients with obesity are also susceptible to vitamin D deficiency as vitamin D derived from intestinal absorption and cutaneous synthesis is diluted in a larger body

pool of fat. These findings appear online in the American Journal of Clinical Nutrition.

According to the researchers, approximately one-third of adults are obese and require much larger doses of vitamin D to satisfy their requirements. "This vitamin D metabolite is better absorbed in patients with fat malabsorption syndromes and since it is not as fat-soluble, it does not gets diluted in the body fat and is effective in raising and maintaining blood levels of 25-hydroxyvitamin D in obese people," explained corresponding author Michael F. Holick, PhD, MD, professor of medicine, physiology and biophysics and molecular medicine at Boston University School of Medicine.

Healthy adults, adults with a fat malabsorption syndrome and obese adults were compared to evaluate if a more water-soluble form of vitamin D3 known as 25-hydroxyvitamin D3 was more effective than the same dose of vitamin D3 in improving their vitamin D status. The researchers observed that compared to healthy adults only about 36 percent of orally ingested vitamin D3 was found in the blood of patients with fat malabsorption syndromes including patients who had gastric bypass surgery.

When the same adults ingested 25-hydroxyvitamin D3 the patients with fat malabsorption syndromes were able to absorb it as well as the healthy adults thereby raising their vitamin D status to the same degree. A similar observation was made in the obese subjects compared to the healthy controls. "Therefore using 25-hydroxyvitamin D3 could be a novel approach for treating vitamin D deficiency in patients with fat malabsorption syndromes and obese adults," added Holick.

uncontrolled diabetes", she said. "The patient had Mucormycosis apparently due to long term use of steroid drugs."

The "Covid-triggered" black fungus infection is rising in India. So far, over 7,000 people have been infected with the disease and over 200 have lost their lives.

The doctors in Kashmir maintain frequent use of steroids during Covid treatment, impure water for humidifiers during the oxygen therapy are the major cause behind this infection.

They also added that patients who are diabetic or Covid positive and the people with weak immune systems have an increased chance of contracting the infection.

Dr. Shafqat-ul-Islam, senior consultant ENT at Jawahar Lal Nehru Memorial Hospital (JLNM) told Kashmir Observer that one of the main reason for the spreading of the fungus during pandemic is the industrial oxygen, which has been directed for medical use, could be one of the main sources of contamination.

"They use impure water to make o2 (Oxygen) and the same is being supplied to people and in hospitals. The water carries fungus so that is why it is spreading rapidly this time," Dr. Shafqat told Kashmir Observer.

He says the misuse of steroids can also be one of the reasons but at the same time argues that it is being given throughout the world, however no country witnessed the fungus.

"My point is the diabetic and weak immune system patients are throughout the world and people used steroid frequently so why wasn't the disease reported anywhere," he says adding that it is because of the industrial oxygen that use impure water to make oxygen, that is why more and more cases are reported in India.

However, the leading ENT specialists maintain that Black fungus disease was there, even before the pandemic and was mostly found in Diabetic patients.

Dr. Shafqat warned that if the disease is not detected at the early stage, the fungus reaches to the brain resulting in the death of the patient. He noted that a patient has to maintain his

blood sugar and has to be "vary cautious" about it. According to Influenza expert Dr. Nisar

ul Hassan, also president of the Doctors Association Kashmir (DAK) one of the factors through which COVID-19 positive can contract this disease is the humidifiers, streamers which they use.

"If the water of these medical equipment is unchanged frequently, it will become a breeding ground for the fungus," Dr. Nisar said.

He noted the fungus is COVID-19 patients have higher chances of contracting the fungus because these medical equipment including the wall oxygen aren't cleaned for weeks and months.

"The recommendation is that you have to use sterilised water for the equipment and change it frequently and yes this is the big factor of the disease," he added.

According to doctors, black fungus is a rare fungal disease and is considered more deadly with a mortality rate of 50 per cent.

According to reports, in many states of India, Doctors removed people's eyes and jaw bones, trying to stop the spread before it reached their brains but leaving the patient permanently disfigured.

Dr. Nisar told Kashmir Observer he has seen just five fungus cases in his 30 years of medical profession till this disease was declared on May 20.

He said the fungus is present everywhere be it soil, plants, air, manure, construction or dusty areas, hospitals (if kept unclean) and decaying fruits and vegetables.

Dr. Nisar said, patients with immunocompromised (having an impaired immune system) are usually found if somebody has a chronic disease like cancer, kidney failure, diabetes, liver disease etc.

"So because of the these chronic disease, the fungus becomes invasive or deadly for those patients usually," he said adding that "It is also seen now in the covid-19 recover patients even after days of recovering," the components of the humidifier should be soaked in a mild antiseptic solution for 30 minutes, rinsed with clean water and dried in air," the advisory said.

Furthermore, Chief Medical officers are directed to ensure that the sale of steroids by retail medical shop owners is regulated and dispensed only under a valid medical prescription.

Dr Mir Mushtaq, spokesperson to the Health Department at Directorate of Health Services Kashmir urged people to follow the health advisories issued by the department.

"If people find any symptoms related to this disease, they need to report to the hospital immediately and avoid self medication including use of steroids," he said.

"Take prompt action on covid related issues and regularly brief the media providing factual and accurate information to the public," the LG said.

Emphasizing on regulating the movement of people during the restrictions, the LG, as per the official spokesperson, directed the Divisional Commissioners and DCs to streamline the process of issuance of passes.

The LG also set timelines for establishment of 5-bedded Covid Care Centres at panchayat level across J&K while reviewing the districtwise status of preparations being made to contain the spread of Corona virus in rural areas.

According to the official spokesperson, the LG directed for prioritizing far flung areas for establishing these centres, besides ensuring availability of all requisite facilities for the patients including proper ventilation, beds, oxygen support, necessary medical kits, linkage with nearest healthcare centres, referral linkage with dedicated Covid health centres & hospitals, availability of tele-medicine facilities, power backup and other basic facilities.

"We are decentralizing the Covid management, which is essential for an effective and efficient public health system. Focus on strengthening primary health care in rural areas. There is a need to increase the availability and accessibility of healthcare support systems in far flung areas," the LG said, as per the official spokesperson.

He also instructed the Principal Secretary, Rural Development Department to lay a comprehensive mechanism for monitoring the operationalization of Covid care centres in Panchayats.

The LG, he said, also laid stress on proper training of ASHA and Anganwadi workers, besides mobilizing PRIs & volunteers and utilizing SDRF funds for effective management of Covid care centres at panchayat level. Health department was directed to proactively engage in functioning of these Covid care facilities.

"Community health workers ASHA/ ANMs are the foundation of health services. Panchayat Covid Centre to help people adopt Covid protocol. The need for hospital services can be reduced with effective implementation of preventive and promotive protocols by the community health workers," Sinha said, as per official spokesperson.

He further said that the LG underlined the need for spreading massive awareness in villages regarding oxygen saturation level and educating the people on when to seek medical attention.

"Reiterating the directions issued in earlier meetings, the Lt Governor called for ensuring timely payments under MGNREGA, and continuous extension of benefits of various beneficiary oriented schemes. He further asked the Rural Development and Social Welfare Departments to put a close monitoring on the implementation of welfare measures like special pension for life and scholarships for children being taken by the Government to help those who unfortunately lost their loved ones to Covid-19," the official spokesperson said.

On the development front, the LG, he said, directed the DCs for early submission of the District Plans. The District Plan must reflect the participation of all stakeholders, besides replicating the developmental aspirations of the people, he added.

He said that humanity has been struggling with Covid pandemic for one and a half years now and all efforts are being made to bring life back on the track of normalcy and overcome the challenges posed by the virus particularly in the wake of the second coronavirus wave and the surge in positive cases.

"As viruses have eclipsed the health sector in both developed and developing countries, many countries have gone back to the basic planning and strategizing as to how to undertake manufacturing of vaccines on a mass scale. Having done that, the stocks are getting diminished due to huge demand and consumption," he said, while emphasizing on following the precautions and Covid appropriate behaviour for remaining safe from the deadly infection.

He also called for getting vaccinated to increase the defence mechanism of the body against virus.

However, he said that effective anti-Corona virus therapy is not available yet, so people should take Covid protocol seriously which includes wearing masks, maintaining physical distance and disinfecting contaminated hands frequently.

While describing and enumerating the common symptoms of the infection like cold, cough, sore throat, loss of smell and taste, loose motion, body aching, chest pain and breath-lessness, Dr Koul advised to consult doctors as soon as these symptoms are noticed by an individual.

He also suggested continuous monitoring of oxygen saturation of family members at home, which according to him should not recede below 92 percent. In case of decrease in oxygen saturation, below 92 percent, the person should be admitted to a hospital.

Dr Koul further said that physical distance and pandemic has created mental stress among people which according to him can be overcome through virtual interaction and communication with friends, family and other colleagues.

While advising people to stay indoors and avoid venturing out aimlessly, Dr Koul asked people to keep perseverance and patience till the worst spell of Covid is over.

Besides, he said everybody should get tested for Covid by RAT or RTPCR test to clear any confusion regarding symptoms.

"Covid test will clarify presence of infection in an individual," he added.

#### **Covid-19 Could Become**

The research, published in the journal Viruses, makes this likely prediction based on mathematical models that incorporate lessons learned from the current pandemic on how our body's immunity changes over time.

"This shows a possible future that has not yet been fully addressed," said Fred Adler, a professor of mathematics and biological sciences at the University of Utah in the US.

"Over the next decade, the severity of COVID-19 may decrease as populations collectively develop immunity," Adler said.

The study suggests that changes in the disease could be driven by adaptations of our immune response rather than by changes in the virus itself.

Although the SARS-CoV-2 virus is the bestknown member of the family, other seasonal coronaviruses circulate in the human population, and they are less dangerous.

The researchers noted that some evidence indi-

#### The symptoms

The Doctors advised that it is important for the people to understand the disease and know about the symptom earlier.

The symptoms, according to doctors for the black fungus are, headache ( for the COVID-19 recovered patients) swollen eyes, pain or numbness over half the face, nasal blockage and a blackish nasal discharge, black crusts in the nose, black scars under the eyes and nose and vision loss are some early signs of mucormycosis. Dr. Nisar said, if it goes into the brain, the patient can go into coma and if it goes into lungs—the patient can have similar symptoms that of covid-19.

The patient needs to consult the ENT specialist immediately, if these symptoms are found and the early diagnosis can save him, the doctor noted. He said to prevent this life-threatening disease in COVID patients, doctors should use steroids judiciously and ensure there is no misuse of steroids.

#### Cases reported last year

According to a report, some cases of Mucormycosis were found in Kashmir division in the first wave of pandemic , among them three patients died.

Dr. Rouf Ahmad Professor and head ENT at SMHS Hospital, who operated on a few patients with Mucormycosis confirmed to Kashmir Observer that they had witnessed some cases of black fungus last year.

"The disease has different stages and accordingly the treatment is done. In any case you have to do the endoscopic surgery," Dr. Rouf said. Follow Health advicory.

Follow Health advisory

On 19 May, the Directorate of Health Services Kashmir issued an advisory for the prevention of Black Fungus after such cases were reported in Covid-19 patients in many parts of India.

"Better control of the sugar levels during COVID with or without steroids. Judicious use of steroids observing correct timing, correct dose and correct duration," the advisory said.

It said there should be judicious use of antibiotics or antifungal drugs.

"To use clean, sterile water for humidifiers during the oxygen therapy, use distilled or sterile water, never use unboiled tap water or mineral water," it said.

"Fill up to 10 mm below the maximum fill line, check the water level twice daily and top it up as necessary. Ensure that once a week all "This virus has snatched so many of our near ones," Modi said, choking with emotion.

He said the battle is against an "unseen" and "changing" enemy.

The parallels led the scientists to wonder whether the severity of SARS-CoV-2 could similarly lessen over time. They built mathematical models incorporating evidence on the body's immune response to SARS-CoV-2.

Analysing several scenarios and their versions set up a situation where an increasing proportion of the population will become predisposed to mild disease over the long term.

"In the beginning of the pandemic, no one had seen the virus before. Our immune system was not prepared," Adler explained.

The models show that as more adults become partially immune, whether through prior infection or vaccination, severe infections all but disappear over the next decade, the researchers said.

Eventually, the only people who will be exposed to the virus for the first time will be children who are naturally less prone to severe disease, they said.

"The novel approach here is to recognise the competition taking place between mild and severe COVID-19 infections and ask which type will get to persist in the long run," said Alexander Beams, study first author and graduate student at University of Utah.

"We have shown that mild infections will win, as long as they train our immune systems to fight against severe infections," Beams said.

However, the researchers noted that the models do not account for every potential influence on disease trajectory.

For instance, if new virus variants overcome partial immunity, COVID-19 could take a turn for the worse, they said. The team also noted that these predictions will hold up only if the key assumptions of the models hold up.

"Our next step is comparing our model predictions with the most current disease data to assess which way the pandemic is going as it is happening," Adler added.

## FIFA U-17 Women's World Cup To Be Held In India In October 2022

NEW DELHI: The U-17 women's World Cup will be held in India from October 11 to 30 next year, FIFA Council said on Thursday.

India were earlier scheduled to host the 2020 U-17 World Cup but it was postponed to 2021 before being cancelled due to the CO-VID-19 pandemic.

The governing body then hand-ed the hosting rights of the 2022 edition to India last November.

On the eve of the 71st FIFA Congress, the FIFA Council approved key dates for the international match calendars, including the dates of the 2022 U-17 world Cup in India.

"The Council also approved dates for the FIFA U-17 Women's World Cup India 2022 (11-30 October 2022), FIFA U-20 Women's World Cup Costa Rica 2022 (10-28 August 2022), as well as a 14team play-off for the FIFA Arab Cup 2021, taking place between 19 and 25 June this year," the governing body said in a statement. The FIFA Council also approved the tournament dates for the Women's World Cup Australia and New Zealand 2023 from July 20 to August 20, 2023.

"The new play-off tournament for the Women's World Cup 2023 will be held from 17 to 23 February 2023."

**BCCI Has Not Officially** Sought Any Change In Test Series Schedule: ECB

NEW DELHI: The BCCI has not made any official request to alter the schedule for India's five-Test series against England for completing the postponed IPL, the England and Wales Cricket Board (ECB) said on Friday.

British media had reported about a possible approach from the BCCI to advance the first Test, starting August 4, by a week so that the remaining 31 matches of the League could be held.

However, the England and Wales Cricket Board (ECB) said they plan to follow the original schedule since their Indian counterparts have not yet made any official request for a change.

"We talk to the BCCI on a regular basis about a wide range of issues especially as we address the challenges of COVID-19 but have had no official request to change dates and are continuing to plan for the five Test series as scheduled," an ECB spokesperson told PTI when asked about the possible change in the schedule.

The BCCI stands to lose revenues to the tune of Rs 2500 crore if the 2021 edition of Indian Premier League (IPL) is not completed.

This year's edition was postponed recently when COVID-19 cases were reported inside the biobubble for the League.

Former England captain and renowned cricket writer Michael Atherton wrore in his column for 'The Times' that the BCCI has enquired about the possibility of moving the final Test of the English summer to make room to complete the postponed IPL.

When approached, a BCCI source said the Board is certainly exploring options but the ECB has not been approached officially.

"The situation is pretty fluid now. There are options that are being explored but no official request has yet been sent. Obviously as Atherton wrote in his column.

there are some specific enquiries being made. Who said that enquiries mean official communications," a BCCI source said.

The Test series as of now is scheduled to conclude at the Old Trafford. The fifth Test will begin on September 10. The game match is expected to attract big crowd and the Lancashire county has already started selling the tickets.

If India make a formal request, the ECB will have to tweak the window for their ambitious project 'The Hundred' along with limited overs series against Pakistan.

Pakistan will play three ODIs and as many Twenty20 Internationals between July 8 and 20. The Hundred will be played between July 23 and August 22.

However if BCCI manages to convince the ECB for advancing the dates, it will be interesting to find what kind if quid pro quo is sought -- asking participation of Indian cricketers in the 'Hundred' or hosting the remainder of the IPL in England?

**Tokyo-Bound AFI Medical Commission Chairman AK** Mendiratta Dies Of COVID-19

NEW DELHI: The Athletics Federation of India's medical commission chairman Arun Kumar Mendiratta, who was set to travel with the Indian contingent for the Tokyo Olympics, died on Friday due to COVID-19 related complications at a hospital here. He was 60.

The Athletics Federation of India condoled the death of Mendiratta, who was also part of the Asian Athletics Association for over 25 years.

"He led AFI's relentless fight against age-fraud and doping. He was also the architect of our noneedles policy," AFI President Adille J Sumariwalla said in a release.

"Soft-spoken and genial, Dr. Mendiratta will be missed by the athletics community. May his soul rest in eternal peace."

Mendiratta was appointed as the chief medical officer by the Indian Olympic Association for the upcoming Tokyo Olympics.

Widely-travelled and wellrespected, Mendiratta had accompanied Indian teams at various World Championships, Asian Games, Commonwealth Games and Olympics during his long career in sports. Indian Olympic Association (IOA) took to twitter to condole his death.

"We are deeply saddened to hear about the untimely demise of Chief Medical officer of the Indian contingent at many Game, member of the IOA Medical Commission and chairman of the AFI medical Commission, Dr Arun Kumar Mendiratta," it said in a post.

"Actively involved with Asian Athletics and Indian sports, his selfless service to sports medicine and doping control for over 3 decades will be fondly remembered. "Our thoughts and prayers are

with his family and dear ones. May his soul find eternal peace."

Mendiratta was particularly well-respected for being an active campaigner against age-fraud and doping violations.

He used to attend all National Junior Championships and National Youth Championships to weed out attempts of doping and age-fudging, the AFI said.

The 31-year-old said she hopes she has done enough to impress upon the Rangers coaching setup with her performances in the last one-and-half year.

"As a professional footballer, it really felt good to train and for a big side like Rangers for a full season. I have gained plenty of experience from this stint," the Indian star said in a virtual interaction on Friday.

Bala had scored a scorcher from over 30 yards, her second goal for the Rangers, in a Scottish Women's League match on May 16.

Coming in as a substitute in the 67th minute. Bala scored in the dying moments of the game as Rangers WFC thrashed Spartans FC 5-0. She had scored her first goal during the 9-0 drubbing of Motherwell FC in December last year.

"I have an 18-month contract which is



ending on June 6 with the conclusion of the league. So what is stored in future I can't say but I will have discussions with Rangers after June 6," she said.

"I have tried to give my best and I am hopeful but you can't predict anything." Before Rangers FC, Bala had featured abroad in the Maldivian league for New Radiant Sports Club alongside state-mate and idol Bembem Devi.

Bala, who is also first Asian international footballer to represent Rangers FC, had decided to stay back in Glasgow during coronavirusforced global lockdown last year.

She has been away from her family since last year and the footballer admitted that she is definitely worried about her parents, who lives in her village in Manipur.

"I got emotional last year during the lockdown. With no games around it was tough, I didn't understand what to do. But then I realised why I came here for.

"My father has kidney problems so I am worried about him but my family has been my biggest support during the last one year," Bala said.

By her own admission, Bala is delighted to witness the global growth of women's football, especially India.

"I have been representing India since 2005 and it is very pleasing to see the growth of the game in India since 2017. With the support of the federation (AIFF), we are getting exposure.

"Women's football in India has grown by leaps and bounds. We have also grown in confidence," she said.

Bala said she would be more than happy to share her Rangers experience with her national team colleagues.

"The players who are representing India now have improved a lot. But I will definitely share my experiences with them when I play for India.'

## **Prisoners Have Fundamental Right To Access Their Medical Records: Bombay HC**

MUMBAI: The Bombay High Court on Friday said all prisoners had a fundamental right to access their own medical records.

A bench of Justices SJ Kathawalla and SP Tavade directed Maharashtra prison authorities to provide lawyer-activist Sudha Bharadwaj, an accused in the Elgar Parishad-Maoist links case, with her medical records, and said such relief must be extended to all prison inmates across the state.

The HC was hearing a plea filed by Bharadwaj's daughter last week through senior counsel Yug Chaudhry seeking medical aid and medical bail for her mother.

On Friday, however, Chaudhry told the bench that after the plea was filed, Bharadwaj was taken to state run JJ hospital and got requisite medical treatment.

Therefore, he would not press for medical bail for Bharadwaj at present, Chaudhry said.

He, however, urged HC to consider his request to direct the state to provide all prisoners with their medical records, and to permit them to have a phone conversation with family members or their lawyers after every visit to a hospital or a medical examination conducted outside the prison premises.

# China Developing Tibetan Border Villages Near Arunachal Pradesh, Bhutan, Nepal: White Paper

BEIJING: China is ramping up efforts to develop the infrastructure in remote villages located along Ti-bet's border with India, Bhutan, and Nepal, according to a white paper on Tibet issued by the Chinese government on Friday. Developing the border areas

and improving people's lives in Tibet has become important as the strategic Himalayan region shares 4,000-km long external borderline, the document titled 'Tibet Since 1951: Liberation, Development and Prosperity' said.

The inhabitants of the contiguous areas experience harsh living and working conditions and a high incidence of poverty. Governments at all levels have been making constant efforts to develop border areas and improve people's lives, it said.

The document said that under the guidance of the ruling Communist Party, the financial allocation has been increasing year by year for border development in Tibet.

The development of China's border areas by establishing new villages with added emphasis on security has been accorded a prioritv since President Xi Jinping came to power in 2012.

The India-China border dispute covers the 3,488-km-long Line of Actual Control (LAC) of which 1,126 km is located in Arunachal Pradesh. China claims Arunachal Pradesh as South Tibet, which India has firmly rejected. China also shares an over

477-km-long border with Bhutan which is yet to be delineated and 1,389 kms of border with Nepal. The border village develop-

ment was highlighted when President Xi wrote a letter to a Tibetan herdsman family in Lhunze County



close to Arunachal Pradesh in 2017 asking them to "set down roots' to safeguard the "Chinese territory" and focus on developing their hometown

"Without the peace in the territory, there will be no peaceful lives for the millions of families," Xi wrote in his much-publicised letter focussing on border development.

Particularly since Xi came to power, border villages, townships, and counties in Tibet have been granted more preferential state policies on infrastructure construction, covering water, electricity, roads, and housing, it said.

In 2017, the Plan of Tibet Autonomous Region on the Construction of Villages of Moderate Prosperity in Border Areas (2017-2020) was released, designed to ensure better access to housing, water, electricity, roads, communications and the internet, to improve education, technology, culture, healthcare and social security in border villages, and to boost industries in border areas.

By the end of 2020, first-tier and second-tier border villages had access to highways, all border townships and towns were connected to

the main power grid, and all border villages had access to postal services, mobile communications, and safe drinking water, it said.

The Tibet Autonomous Region also has built a comprehensive transport network composed of highways, railways, air routes and pipelines since its peaceful liberation in 1951 it said.

The region has built 118,800 km of highways over the decades, said the document.

"Now, 94 per cent of towns and 76 per cent of administrative villages in the region have direct access to asphalt and concrete roads." it said.

Tibet last year has announced USD 2.09 billion plan to build three new airports and the expansion of the Lhasa Gonggar Airport.

The three new airports will be built in Lhunze, Tingri and Burang counties

China has already built airports at Bamda in Qamdo, Mainling in Nyingchi, Xigaze, and in Ngari. Tibet now has 140 domestic and international air routes in operation, reaching 66 cities, the white paper said. — PTI

NEW DELHI: Several thousand coronavirus patients in India have contracted a deadly and aggressive fungal infection, compounding the country's troubles as it reels from the pandemic.

#### What is the fungus?

Mucormycosis, dubbed "black fungus", is caused by a mould found in soil and in decaying organic matter like rotting leaves, according to the US Centers for Disease Control and Prevention (CDC).

### **UGC Panel Prepares Draft Guidelines For 'Blended Teaching'** In Universities, Colleges teacher's role from knowledge

NEW DELHI: Higher Education Institutions may soon be allowed to teach up to 40 per cent of any course through online mode with an expert committee set up by the University Grants Commission (UGC) drafting a concept note on "blended mode of teaching and learning" in varsities and colleges.

The UGC has sought suggestions and feedback from various stakeholders on the draft concept note by June 6. "The UGC had decided that

HEIs should be allowed to teach up to 40 per cent of each course through online mode and the remaining 60 per cent of the concerned courses can be taught in offline mode.

Exams for teaching under both modes can be conducted online," UGC Secretary Rajnish Jain said.

According to the draft, "the advantages of blended learning for students include increased learning skills, greater access to information, improved satisfaction and learning outcomes and opportunities both to learn with others and to teach others".

The concept note has been prepared in accordance with the new National Education Policy (NEP), which the expert panel believes. gives the acceptability of many modes of learning including that of face to face learning, online learning and distance or virtual mode.

Blended learning is not a mere mix of online and face-toface mode, but it refers to a wellplanned combination of meaningful activities in both the modes. The blend demands consideration of several factors, mainly focussing on learning outcomes and the learner centred instructional environment," the draft note said.

"Given the emergence of digital technologies and the emerging importance of leveraging technology for teaching-learning at all levels from school to higher education, the NEP recommends for use of blended models of learning," it said.

"The NEP-2020 states that while promoting digital learning and education, the importance of face-to-face in-person learning is fully recognised. Accordingly, different effective models of blended learning will be identified for appropriate replication for different subjects," the note said.

Defining the role of teachers in blended learning, the draft note said, "blended learning shifts the

Chaudhry said in the absence of such an order, inmates were forced to file petitions to get access to their own medical records, pathology test results, etc.

Additional Solicitor General Anil Singh, who appeared for National Investigation Agency, and the state's counsel, YP Yagnik, opposed the request, telling the court Chaudhry had not filed a PIL so he could not seek a general order.

"This is not a PIL. You can get an order for your own case. Specific orders can be passed on a case to case basis. There are various orders passed by HC from time to time taking care of prison inmates." ASG Singh said.

The bench, however, said it agreed with Chaudhry's submission that prison inmates must have access to their own medical records under their fundamental right to life as guaranteed by Article 21 of the Constitution.

"In our view, prisoners have a right to their own medical records currently lodged in Byculla women's prison here.

Last week, Chaudhry had sought medical treatment and interim bail for Bharadwaj on medical grounds, given the activist's comorbidities and the risk of her contracting CO-VID-19 while in prison.

Chaudhry had said Bhardwaj was kept in a prison ward with 50 other women under extremely unsanitary conditions, with just three toilets for all of them.

"The ward where she is lodged is a literal death trap," Chaudhry had said at the time.

He told the court on Friday that he and Bharadwaj's family members had made numerous phone calls and written several emails to Byculla prison authorities seeking medical aid for the activist, but all these had gone unanswered. Bharadwaj was finally taken to

the JJ hospital after the present plea was filed, he said.

"We don't want bail unnecessarily but give us medical attention and our medical reports. We have a right under Article 21," Chaudhry said on Friday.

The HC disposed of the plea following Chaudhry's submissions.



## A Temple For 'Corona Devi' In Tamil Nadu

'Corona Devi' temple has Acome up on the outskirts of Coimbatore in Tamil Nadu amid the raging second wave of the COVID-19 pandemic. The temple has been built by a mutt, the Kamatchipuri Adheenam. This is like the 'Plague Mariamman Temple', dedicated by the faithful to the deity Amman seeking her protection when plague struck the district about 150 years ago.

An idol, named 'Corona Devi' has also been placed in the temple. The 1.5-foot tall black stone idol has been consecrated at the temple in the mutt area. Daily prayers are be-



ing held, seeking blessings to save the people from the deadly disease, for 48 days, sources in the Adheenam said.

It is not for the first time such a temple has come up. When plague spread across Coimbatore killing many people more than a century ago, an idol of Mariamman was installed and people had started offering prayers. The place had turned into a temple and came to be known as "Plague Mariamman Temple".

Only priests and mutt officials are allowed inside the 'Corona Devi' temple in view of the pandemic. COVID-19 guidelines like maintaining social distance are in place. The temple is strictly out of bounds for the public, the mutt officials said. A Mahayagam or special yajna, will be organised on the last day of prayers, sources said.
