48 More Deaths, 3408 **New Cases In 24 Hours**

India Reports 8,848 Black **Fungus Cases**

NEW DELHI: India has so far reported approximately cases of 8,848 mucormycosis or black fungus, one of the rapidly spreading infections observed in those recovering from Covid-19.

Taking note of the increasing numbers, the Central government has emphasised upon expediting the allocation of vials of Amphotericin-B, a key drug to treat raging mucormycosis.

In this direction, the Union minister of chemicals and fertilisers D.V. Sadananda Gowda has announced an allocation of 23,680 additional vials of Amphotericin-B.

The minister also informed that the allocation has been made based on total number of patients which is approximately 8,848 across the country.

(5,800) Gujarat Maharashtra (5,090)have been allocated the maximum number of the additional Amphotericin-B vials followed by Andhra Pradesh (2,310), Madhya Pradesh (1,830), Rajasthan (1,780), Karnataka (1,270).

Gujarat has reported maximum of 2,281 mucormycosis cases followed by Maharashtra (2,000), **→ More On P10**

SRINAGAR: A senior cardiologist said on Saturday that the patients with heart problems and uncontrolled blood pressure are susceptible to infection and conversely Covid patients also develop heart problems.

"Heart disease is ver mon among severe Covid patients," said Dr Irfan Ahmad Bhat, Consultant Cardiologist Government Medical College (GMC) Srinagar, while speaking about the impact of coronavirus infection on heart health.

He said patients with heart problems and uncontrolled blood pressure are susceptible to infection and conversely Covid patients also develop heart problems.

The senior cardiologist also said that Covid patient having history of any heart problem like heart attack, cardiac stent or any other chronic heart problem shall continue to take their prescribed medicine at optimal time He also said that no change

in medicine shall be made during Covid infection and advised heart patients to remain in touch with their personal and concerned doctors for suggestions in this regard,

Heroics Tackling Hardships In Kashmir's Third Lockdown Year

ashida Amin's unruffled morning rides are coming as a big relief to destitute class in Kashmir's third straight year of paralytic phase.

The woman in mid-twenties has adopted many households battling poverty in pandemic. With public-donor support,

she's currently saving situa-

tions from going south in many Kashmiri deprived families. Rashida's silent service is coming at a time when Kashmir is facing third consecutive year of lockdown creating a distress-

ing wave of destitution around,

especially for daily-wagers.

In absence of a substantial official relief package—as lately demanded by the battered business body of Kashmir-many welfare managers have come on the scene for the crisis management.

"Beyond what we get to hear on social media, situation is terrible on the ground," Rashid said.

"There's this old mother who lives alone in a shanty in Srinagar. She has no support left. And then there's this family of four sisters living without any earning hand. This third-year of lockdown has hit the poor families like anything."

economic losses worth Rs 6000 Crore, says Ejaz Ayoub, a budding economist from Kashmir.

as tabulated," he adds. "This means Jammu and Kashmir is losing Rs 260 Cr every day in lockdown."

This official response, experts fear, will undo the last thirty vears of economic resilience of the valley.

"At the end of the day it's more about human lives and livelihood," says Ather Khan, an economic scholar from Srinagar.

"It's one thing to live and make uneasy peace with these lockdowns as part of the plagued routine, but entirely other matter to live its longterm consequences."

Seconding Ather, Rashida says that it took Kashmir years to fight and come out of the clampdown routine of nineties.

"Take, for instance, the case of

orphans," she continues.

'We're yet to address that concern. In the name of management, we evaded our collective responsibility and diverted that crisis to orphanages than to develop a foster system and address that nascent situation in

the bud itself.' Back in the day when the destitution reared its ugly head in the valley, Ghulam Mustafa of J&K Yateem Trust became one of

the crisis-managers. The 1972-established orphanage became a strife shelter overnight and gave succor to several families in Kashmir during nineties

"We have been reliant completely on public donations to run our organization since then," says Ghulam Mustafa, the orphanage administrator.

"And years later, with the help of that community support, we've diversified our destitution plans."

The orphanage runs a program called "Wedding Assistance" in which they help orphans and destitute girls with a wedding kit comprising of ladies suits, footwear and cosmetics products worth Rs. 15,000.



Ehsaas, VMS In Collaboration With SMC To Start Wellness Centre In Srinaga

Srinagar: Srinagar Mu-Corporation (SMC) is all set to start the COVID wellness centres in collaboration with two Non-Government Organisations (NGOs)—Ehsaas Trust International and Voluntary Medicare Society (VMS)

Sources privy to the development told the news agency—Kashmir News Observer (KNO) three CO-VID wellness centres are coming up in Baba Demb, Bemina and at one more place in Srinagar.

The wellness centre at Baba Demb will be started till Monday, they said, adding that the centre will have 50 oxygen beds where only referrals from JLNM will be accepted. The wellness centre will function as an adjacent facility for JLNM hospital in Rainawari, they said.

Lateef Gabroo, member of the VMS, who also helps people at individual level, said that three such centres will come up in Srinagar while one among them will be started from Monday at Baba Demb.

He said that Ehsaas Trust International has volunteered and agreed to provide assistance in terms of oxygen concentrators, oxygen cylinders along with paramedic professionals and doctors who will be available round-the-clock in service of Covid patients.

Gabroo added that the Voluntary Medicare Society (VMS), although working in the disability sector, has committed itself to provide relief in terms of ambulatory services including wheelchairs, stretchers and others besides volunteers including paramedics.

He informed that only moderate cases from JI NM will be accommodated at Baba Demb wellness centre—(KNO)

Attendants Fight Over Oxygen Cylinder Distribution At SMHS

Srinagar: Scuffle broke out between the attendants at Shri Maharaja Hari Singh (SMHS) hospital on Saturday when they were distributing the oxygen cylinders themselves in the absence of proper arrangements by the authorities.

Officials said that no security arrangements have been put in place for the distribution of oxygen cylinders among the attendants for their patients.

A video has gone viral on social media, in which the attendants could be seen fighting over the distribution of the oxygen cylinders.

ment said that some attendants attempted to snatch oxygen cylinders by illegally stopping the vehicle carrying bulk cylinders even before it had reached the store of the hospital.

"Other than Oxygen supply from the hospital Oxygen Generation plants, additional oxygen supply (wherever required) is made through bulk O2 cylinders to the patients as per prescription of the Doctor concerned. The Hospital also maintains buffer stock to meet any emergencies. SMHS Hospital administration has taken cognisance of the attempt at hoarding by some attendants. A police complaint has also been lodged in

the matter," he said.

Militant Escape Case

Police hunting for ex-MLA

RINAGAR - A National Conference leader and former legislator allegedly involved in facilitating a militant commander in rossing the international border to Pakistan, is absconding. The police have conducted raids at several places to seek the cx-MLA. Gul Rafiqi, who represented the Hom-Shalibug constituency, but have failed to trace him. The raids were conducted at Rafiqi's residence as well as at the

homes of some of his relatives, the KNS said. Policemen in plain clothes scoured the MLA hostels in Jammu

as well as Srinagar, but failed to turn up any clues about the ex-legislators where-

abouts. Raflqi's mobile phone, too is not functioning for the past there days. According to sources Rafiqi may be trying to obtain $\hat{\mathrm{He}}$ has disappeared despite being informed that he should present himself before the police, which is now raiding his habitual

haunts and using its network of informers to track him down. A senior police officer told the KNS that a high level investigation was on in the matter of the escape of a divisional commander of

the Hizb-ul-Mujahideen from the valley. Three persons, including the Ex-MLA's then secretary, Farooq Ahmad Bhat, personal

Security Offficer Kewal Singh and driver Shyam are already in custody. Rafiqi allegedly, helped the Hizb divisional commander, MnhammadAmin Baba, escape from the Valley by taking him, to Amritsar in his own official vehicle accompanied by two personal

Baba, who had reportedly managed to get a passport on ficti-

tious Srinagar address, was allegedly escorted to Wagah border on May 2 this year where from he crossed over to Pakistan Sources said the case cae to light when the police were

investigating a mine-blast in Anantnag and arrested a suspect Javaid Ahmad. Hizb commander Baba was also a suspect and when the police questioned Javaid about him they learnt that Baba had recently crossed over to Pakistan via Amrtisar. When asked about the allegations against Rafiqi, National Conference President Omar Abdullah was quoted by news agencies as having said "if there is anything against him (Rafiqi), the law will take its course. We want an impartial probe in the matter." He however said that the Mufti $\,$ Saveed government had done nothing when militants were arrested from a minister's house. "He still remains minister. Where is the justice," he questioned.

Fighters Attack Jade Mining Town As Myanmar Sleepwalks Into Civil War

Fighters affiliated with one of Myanmar's key ethnic groups resisting the military coup in the East Asian nation have attacked army posts at the northwestern jade mining town of Hkamti, marking a major advance into new territory.

Kachin Independence Army (KIA) forces launched an assault on the military position in the Sagaing region early Saturday, as the ruling military junta struggles to contain popular opposition to its February 1 seizure of power, local media reports said.

Images published by the local Irrawaddy and Mizzima online news outlets showed columns of dark smoke rising from what they described as the scene of the attack by KIA fighters.

KIĀ spokesman Naw Bu said he was aware of the armed assault but could not share any details of the reported operation.

"The fighting is still ongoing. I can still hear the gunshots," Mizzima quoted one resident as saying, describing the scene of the attack at the site which is near a mining venture that involves the military-owned Myanma Economic Holdings Ltd.

Myanmar's military was said to be using warplanes to attack KIA forces at Hkamti, a town on the Chindwin river in a remote region rich in jade and gold that lies about 50 kilometres from the border with India.

Since the military coup, open skirmishes have resumed between the army and the KIA, which has been engaged in an armed struggle for greater autonomy for the Kachin people over the past six decades and has expressed support for antijunta protesters.

Myanmar's armed forces have conducted numerous bombing attacks on KIA positions in recent

Myanmar's army last week also attacked fighters of the Chinland Defense Force (CDF) in the northwestern town of Mindat in what was described as "some of the heaviest" rounds of fighting with local armed groups opposing the military coup. Ten people have been killed in Chin over the past week.

Those fleeing hostilities say thousands of people left Mindat after the army attacked to uproot the CDF fighters.

Last Tuesday, the UN refugee agency mentioned "reports of civilians killed and injured and civilian property damaged or destroyed."

"Access by humanitarian partners to the people fleeing violence or those still in their homes is challenging due to insecurity," said the UN Office for the Coordination of Humanitarian Affairs (OCHA).

The displacement threatens to push more people over the nearby border with India, where more than 15,000 people had sought refuge since the February coup.

Residents of Mindat, near the Indian border, had also reported intense fighting in the area earlier in the week, forcing people to hide in jungles and remote villages as the military made advances into the town after days of fierce battles with local fighters.

More than 800 people have been killed by the military since protests broke out in Myanmar against the military coup, according to the Assistance Association of Political

Shops, Cafes Reopen As Life Resumes In Ravaged Gaza Strip After Ceasefire

GAZA: Cafes reopened, fishermen set out to sea and shopkeepers dusted off shelves Saturday as Gazans slowly resumed their daily lives after a deadly 11-day conflict between Hamas and Israel.

Aid trickled into the Gaza Strip, the blockaded enclave controlled by the Islamist group Hamas, as the focus turned to rebuilding the devastated territory a day after a ceasefire took hold.

The Egypt-brokered truce halted Israeli air strikes on the crowded Palestinian territory and rockets fired by Palestinian armed groups at Israel since May 10.

Rescue workers searched for bodies or survivors in mounds of rubble after what Gazans referred to in the street as the latest "war" or "escalation" with the Jewish state.

In Gaza City's port, Rami Abu Amira and a dozen other fisherman prepared their nets before heading out to sea for the first time in two weeks.

"We need to eat," he said after
the Gaza coastguard allowed fishing
again, though adding he would stick
close to the coastline to stay safe.

"We, fishermen, are scared the Israeli navy will shoot at us. It's up to everyone to decide whether to go or not."

'All lost'

The latest round of bombardment killed 248 people in Gaza, including 66 children, and wounded more than 1,900 since May 10, the Hamas-run health ministry says.

The United Nations says more than half of those killed, the over-

whelming majority in Israeli air strikes, were civilians.

Israel says it has killed "more than 200 terrorists", including 25 commanders.

During the same period, rockets fired by Palestinian armed groups killed 12 people in Israel including one child, a teenager, an Israeli soldier, one Indian and two Thai nationals, the police say. Some 357 people in Israel were injured.

On Friday evening in Gaza, Palestinian families had rushed to seaside cafes to breathe fresh air or smoke shisha.

In a clothes store near the ruins of a ravaged tower block in the upscale neighbourhood of Rimal in Gaza City, mannequins still wore the latest 2021 trends, but they were now caked in dust.

Bilal Mansur, 29, said all his merchandise had been ruined.

"There's dust everywhere, dust from the Israeli bombs clinging to the clothes. We won't be able to sell them," he said.

Nearby store-owner Wael Amin al-Sharafa said he had stocked up his shop with new clothes to sell during the usually busy season of Eid al-Fitr at the end of the Muslim fasting month of Ramadan.

"But now it's all lost," he said. "Who will pay for all this? I have no idea."

'Two-state solution'

Convoys of lorries carrying aid began passing into Gaza Friday through the Kerem Shalom crossing after it was reopened by Israel, bringing much-needed medicine, food and fuel.

The UN's Central Emergency Response Fund said it had released \$18.5 million for humanitarian efforts.

The latest round of Israeli bombardment forced 91,000 people to flee their homes in Gaza, the UN humanitarian agency says.

It has hit 1,447 homes, completely destroying 205 residential blocks or homes, as well as ravaged electricity and water supply, according to the Gaza authorities.

The UN says three main desalination plants providing drinking water for more than 400,000 people have stopped working.

Both sides were fast to claim victory, as Egyptian state media said two Egyptian security delegations had arrived to monitor the deal.

Prime Minister Benjamin Netanyahu said Israel's bombing campaign had been an "exceptional success".

Hamas' political chief Ismail Haniyeh said they had "dealt a painful and severe blow that will leave its deep marks" on Israel, and thanked Iran for "providing funds and weapons".

The international community welcomed the ceasefire.

US President Joe Biden pledged to help organise efforts to rebuild Gaza and said creating a Palestinian state alongside Israel is the "only answer" to the conflict.

"We still need a two-state solution," he said.

Supermoon! Red blood Lunar Eclipse! It's All Happening At Once, But What Does That Mean?

The first lunar eclipse of 2021 is going to happen during the early hours of May 26. But this is going to be an especially super lunar event, as it will be a supermoon, a lunar eclipse and a red blood moon all at once.

So what does this all mean? What's a super moon?

A supermoon occurs when a full or new moon coincides with the Moon's closest approach to the Earth.

The Moon's orbit around Earth is not perfectly circular. This means the Moon's distance from Earth varies as it goes around the planet. The closest point in the orbit, called the perigee, is roughly 28,000 miles closer to Earth than the farthest point of the orbit. A full moon that happens near the perigee is called a supermoon.

So why is it super? The relatively close proximity of the Moon makes it seem a little bit bigger and brighter than usual, though the difference between a supermoon and a normal moon is usually hard to notice unless you're looking at two pictures side by side.

How does a lunar eclipse work?

A lunar eclipse happens when the Earth's shadow covers all or part of the Moon. This can only happen during a full moon, so first, it helps to understand what makes a full moon.

Like the Earth, half of the Moon is illuminated by the sun at any one time. A full moon happens when the Moon and the Sun are on opposite sides of the Earth. This allows you see the entire lit-up side, which looks like a round disc in the night sky.

If the Moon had a totally flat orbit, every full moon would be a lunar eclipse. But the Moon's orbit is tilted by about 5 degrees relative to Earth's orbit. So, most of the time a

full moon ends up a little above or below the shadow cast by the Earth.

But twice in each lunar orbit, the Moon is on the same horizontal plane as both the Earth and Sun. If this corresponds to a full moon, the Sun, the Earth and the Moon will form a straight line and the Moon will pass through the Earth's shadow. This results in a total lunar eclipse.

To see a lunar eclipse, you need to be on the night side of the Earth while the Moon passes through the shadow. The best place to see the eclipse on May 26, 2021, will be the middle of the Pacific Ocean, Australia, the East Coast of Asia and the West Coast of the Americas. It will be visible on the eastern half of the U.S., but only the very earliest stages before the Moon sets.

Why does the moon look red?

When the Moon is completely covered by Earth's shadow it will darken, but doesn't go completely black. Instead, it takes on a red colour, which is why total lunar eclipses are sometimes called red or blood moons.

Sunlight contains all colours of visible light. The particles of gas that make up Earth's atmosphere are more likely to scatter blue wavelengths of light while redder wavelengths pass through. This is called Rayleigh scattering, and it's why the sky is blue and sunrises and sunsets are often red.

In the case of a lunar eclipse, red light can pass through the Earth's atmosphere and is refracted – or bent – toward the Moon, while blue light is filtered out. This leaves the moon with a pale reddish hue during an eclipse.

Hopefully you will be able to go see this super lunar eclipse. When you do, now you will know exactly what makes for such a special sight. PTI

At White House, Life Back To Normal: Hugs Are In, Masks Are Out

WASHINGTON: A smiling crowd of unmasked people filling the largest room in the White House. A visiting head of state welcomed with pomp, circumstance and handshakes. A 94-year-old Medal of Honor recipient receiving a joyous hug from Vice President Kamala Harris.

The White House is springing back to life.

Thanks to growing availability of the coronavirus vaccine and a recent relaxation of federal guidance on masks and distancing, the Biden administration is embracing the look and feel of pre-pandemic days on Pennsylvania Avenue. More West Wing staffers are turning up there for work and more reporters will be doing so as well, as the White House spreads the message that a return to

normal is possible with vaccinations. There are lingering concerns about safety and mixed messaging — the same contradictions and confusions that are popping up across a nation that is gingerly re-opening. But the images of a reopened, relaxed White House stand in striking contrast to the days when it was the site of several Covid-19 outbreaks last year, a sign of just how far the pandemic has begun to recede in the United States.

"We're back," White House press secretary Jen Psaki declared at Friday's daily briefing. "I can confirm we're a warm and fuzzy crew and we like to hug around here."

The changes within the White House over the past week were swift and sweeping. Hugs were in, masks were (mostly) out. There was no need to stand six feet apart. And no one seemed to enjoy the shift more than Biden, the most backslapping and tactile of politicians.

The president had been happy to announce the relaxed mask guidance when he appeared in the Rose Garden on May 13 without a mask, just hours after the CDC said those who are fully vaccinated don't need to wear masks in most settings.

That cheerfulness carried over

rhat chromics carried wor this past week into a series of larger public events that would have been out of bounds earlier in Biden's presidency. For the second straight day, the White House on Friday opened the East Room — the executive mansion's largest room — to scores of outside guests. Smiling broadly, Biden awarded the Medal of Honor for the first time as commander in chief, giving it to 94-year-old retired Col. Ralph Puckett Jr. for acts of bravery during the Korean War some 70 years ago.

The White House timed Friday's ceremony to coincide with the visit of South Korea's president, Moon Jae-in, who joined Biden at the event before their policy meetings. Both world leaders repeatedly clasped Puckett's hands and crowded in for a photo with the war hero's extended family.

A day earlier, an even larger group of lawmakers and other guests were on hand to witness Biden sign legislation to counter an alarming spike in crimes against Asian Americans and Pacific Islanders. House Speaker Nancy Pelosi, D-Calif., and Sen. Susan Collins, R-Maine, were among the lawmakers trading hugs and kisses.

"The nicest part is being able to shake hands again and to see people's smiles," Collins marveled at one point.

Afterward, lawmakers who helped shepherd the legislation through Congress surrounded Biden as he signed the measure into law. The president also engaged in an act that had largely disappeared from official Washington during the pandemic: He shook hands with a few guests before leaving.

Earlier that day, he had welcomed the newest Kennedy Center honorees to the White House for a visit that marked the return of celebrity wattage to the property.

By multiple accounts from Kennedy Center Honors recipients, the White House event was high-spirited, with Biden seemingly thrilled to have visitors. Debbie Allen called the president, "so engaging and open. He spent a lot more time with us than I expected."

Joan Baez said the official visit "turned into a jolly romp," included a tour of the Rose Garden and culminated in Baez singing for Biden.

Due to social distancing guidelines, the number of journalists allowed inside the White House shrunk once the pandemic hit, with the briefing room only about a quarter full for Psaki's daily questionand-answer sessions.

Capacity is slated to go to 50 per cent soon, with the goal of a full return by summer. The daily COVID-19 testing requirement for staff and most journalists was also expected to soon be waived for the fully vaccinated. And the parking spaces around the West Wing and Eisenhower Executive Office Building have been fuller as of late. Psaki said the effort to return to a more normal vibe was part of "continuing to open the White House up, the people's house up to the American people."

But questions remain about protocol. Abiding by the safety guidelines is a matter of the honour system. And Psaki acknowledged on Friday that the White House did not have plans to verify vaccination status. Members of the administration and the Centers for Disease Control and Prevention have continued, at times, to offer confusing guidance on exactly when, and by whom, a mask should still be worn. Yet in most ways, the mood has changed dramatically.

The first image that Americans saw of Biden at the White House as president was on Inauguration Day, as he sat behind the Resolute Desk in the Oval Office wearing a mask.

Iran's Khamenei Says Israel 'Forced To Accept Defeat'

"The continuation of crimes and the ceasefire were both (part of Israel's) defeat. They were forced to accept defeat," he added, noting that Israel was "powerless against

the unified rise of Palestine".

"The readiness of the Palestinian youth and the show of power" by armed groups in Gaza "will make Palestine more powerful by the day and the usurping enemy weaker and more despicable", he added.

The ceasefire between Israel and Hamas, the Islamist movement that controls the Gaza strip, and other armed groups in the enclave appeared to be holding Friday, after 11 days of fighting.

Israeli strikes on Gaza since May 10 have killed 243 Palestinians, in-



cluding 66 children, Gaza's health ministry says.

Rockets fired into Israel from Gaza have claimed 12 lives in the Jewish state, including one child.

Khamenei also called for legal measures against the Israeli government, including its prime minister.

"All the effective elements of this regime and the criminal (Benjamin) Netanyahu must be pursued by international and independent courts and be punished," he said.

The Islamic republic does not recognise Israel, and supporting the Palestinian cause has been a pillar of Iran's foreign policy since

It Was "War Crime": Gaza Media Building Owner Complains To World Court

NETHERLANDS: The owner of a Gaza building housing international media that was destroyed in an Israeli airstrike is lodging a complaint with the International Criminal Court, his law-

yer said.

The complaint by Jawad Mehdi says that the attack on May 15 which flattened Jala Tower, housing the offices of US news agency Associated Press and Al Jazeera television, was a "war crime".

The filing, a copy of which was seen by AFP, comes after the chief prosecutor of the ICC said last week that "crimes" may have been committed during the recent violence between Israel and the Polectinians

Israel and the Palestinians.
"The owner of this building, who is

a Palestinian, has mandated his lawyers to file a war crime complaint with the International Criminal Court," lawyer Gilles Devers said in a statement.

Devers told AFP outside the court, where around 10 pro-Palestinian protesters were gathered, that Israel could show "no military objective" for the attack.

"We hear a lot that this tower could have been destroyed because there was equipment or an armed resistance team. This is something that we totally deny after studying the case," Devers said.

"International law is that you can only harm civilian property if it is used for military purposes, and that was not the case. So we say it today in front this court and in this complaint."



Devers said the complaint would be formally sent to the court by email

later Friday.

LMD Books 63 Erring Traders

Intensifying SRINAGAR: market inspections, the field executives of Legal Metrology Department (LMD) booked 63 erring traders and has also recovered a fine of Rs 1, 25,300 from them for violating Legal Metrology Laws across Kashmir in past 7- days.

During the market inspection, it was found that the drug stores were found offering for sale the Face-Masks and sanitizers which were without adequate labeling. Moreover, the department received a number of complaints of overcharging on edible oil.

In one instance, a consumer was charged Rs. 880/- for a 5 kg edible oil pack when MRP printed on the label of the pack was only Rs. 770/- The case was registered against the retailer and a penal sum of Rs. 5000/- was slapped on him for the over-charging. Under Legal Metrology Laws, it is an offence to charge more than MRP printed on the prepackaged commodities.

It is worth-mentioning here that the Govt. is not fixing prices of edible-oils in the UT of J&K.

However, in case a trader charges more than MRP printed on the label of the product by the manufacturer, the department may be contacted on the toll-free No. 1800-180-7114 during office hours.

137 Establishments Sealed **Across Kashmir**

SRINAGAR: The department of Food Civil Supplies & Consumer Affairs (FCS&CA) has realised a fine of Rs. 12.24 lac from erring shopkeepers, wholesalers and other dealers for various kinds of violations in Kashmir during the past 5 months.

FCS&CA, through its different enforcement wings carried out massive market checking across all 10 dis-

tricts and during the inspection found many dealers indulging in violations.

As many as 137 establishments were also sealed, while 40 reports were filed in different police stations against the erring shopkeepers.

During the current month up to May- 22, as many as 39 shopkeepers were penalised and a fine of Rs. 3.47 lac was recovered from them, while 28 establishments were sealed for violations during the month.

Recovery Rate Increasing, Positive Rate Diminishing In Baramulla: DC

BARAMULLA: Briefing about the latest position of Covid-19 pandemic and the measures taken by the District Administration, the Deputy Commissioner (DC) Baramulla, Bhupinder Kumar today informed that recovery rate of patients is continuously increasing whereas the positivity rate is drastically reduced from the past few days.

The DC said that this became possible by the active public cooperation who abided by the requisite SOPs and guidelines pertaining to the pandemic.

While expressing gratitude of the people, the DC hoped that the people will further cooperate with the administrative functionaries for combating the challenge of Covid-19 pandemic He said that only coordinated and joint initiatives of different stakeholders mav prove benefi cial to come out of these critical circumstances.

Enlisting various initiatives, the DC said that in the recently established 62 bedded additional ward at GMC, ventilators are being used on case to case basis which is a positive development of its kind. He also added that 05 additional Covid-19 wellness centers were also established in addition to the already existing

centers so as to cope with the growing challenge. The DC further said that

05 bedded Covid Care Centres (CCCs) are being established at the Panchayat level which apart from delivering medicare services, shall be used to disseminate necessary awareness among the masses. He said that 03 oxygen plants are currently operating in the district and efforts are afoot to augment its stock position.

When asked about the status of Covid-19 vaccination programme, the DC informed that about 70 percent of the target have been achieved and about 2.75 lakh eligible beneficiaries having age above 45 years and frontline workers, have been vaccinated.

Regarding the developmental scenario, Kumar said that work on various developmental projects is going on without any kind of disturbance. He added that workers are following all the SOPs at the working sites so as to avert any kind of exigency.

Moreover, the DC also said that various welfare measures were taken and Rs 4.42 Cr was released among 42,200 registered building and construction workers as part of ist instalment of Covid-19 relief announced by J&K administration.

Partial Re-Opening of Mughal Road: Right or Reward?

ughal road connects the twin districts of poonch and rajouri with the valley of Kashmir and reduces the distance between Shopian and Poonch from 588 km to 126 km. It is a historical route which was made functional for vehicular movement way back in 2009. It is about 84 kilometers from Bufliaz (poonch) to Hirpora (Shopian). This route is known for its beautiful sights and scenes: lush meadows, gushing waterfalls, tossing and lurching trees and chirping birds, all persuade the tourists across the country to visit this area. It is surrounded by snow laden mountains which glitter like silver throughout the year and this sight adds the charm and miraculous beauty of the area. But unfortunately, this road witnesses heavy snowfall during the winters particularly at Pir Ki Gali which makes it non-functional for vehicular movement for a period of about six months (October to April) in a year. During these months, the route is covered with heavy snow and there is no feasibility of traffic movement. The government always pursues a casual approach to make it feasible for vehicular movements throughout the year. It is pertinent to mention here that in 2019, the National Highways and Infrastructure Development Corporation Limited had hired a Spanish Consultancy firm along with an Indian private consultant company to prepare a detailed report for the construction of a tunnel on Mughal road. It apparently seemed that the companies were compiling a detailed project report to estimate its approximate cost and once it was prepared, the work on the project could be started at any time. But this is very unfortunate for the people of Pir Panjal region that till date no further development on this project could be gauged.



The benefits of transforming this vital route into an all weather road are twofold: on the one hand this route helps the tourists to explore some beautiful picnic spots and it remains a sight of attraction for them. On the other hand, it provides a sigh of relief to the people of twin districts of Poonch and Rajouri as they have received access to better educational and medical facilities in Kashmir valley by using this route. There is no denial of the fact that these districts do not have a good educational and medical infrastructure and people of the area are in pursuit of availing better facilities in the following sectors. Since the functioning of this route, the student community of this region did benefit by pursuing higher education in the valley. The medical sector of these districts also presents a gloomy picture and the patients either approach Jammu or Srinagar for receiving some

better treatments. In the past there were numerous medical casualties from this area which were referred to SKIMS Soura, whence after receiving proper treatment their recovery was made possible.

This year, the needless closure of Mughal road has compounded the plight of common man amidst this pandemic, when the COVID patients need better medical facilities to recover. As usual this year too, the snow clearance process was initiated in the month of March and around 15th April the route was made functional but the government only permitted it for vehicular movement on 20th of May after protests by people. Due to this delay and negligence from the administration, numerous precious lives have been lost. Can the present divisional and district administration compensate the families of deceased who lost their beloved only due to the lack of proper

treatment in the hospitals of these districts and restrictions on shifting them to SKIMS in the valley? This question will frequently be asked by the families of those helpless and hapless departed souls who lost their earthly existence in fighting against COVID-19 and it happened only due to the heedlessness of administration.

On the other hand, ignorance and oblivion rule over the masses of these neglected districts as they are not aware of their fundamental rights in a democratic set up. Some political forces have turned the common man into such an ignorant and innocent creature that rationality and sanity is a distant dream for him/her. There are people who are taking the credit for the partial opening of the route without taking into account that this might be insensitive given how many people have lost their lives because of the closure of this route till now.

The prerequisites of any prosperous and developed nation are its citizens having rational and logical minds as they are the pillars on which the edifice of a strong nation is built. This 'credit bearer' section of society has turned the innocent people's intellect to a minimum rational thought process and pushed them to the slough of ignorance at such a level that they are unable to distinguish between their rights and rewards or boons by someone. Had they paid any heed to being sensitive, they would have never driven the narrative of making a Right seem like a favour.

n May 15, Israeli air strikes levelled the al-Jalaa tower, an 11-storey building that housed the offices of Al Jazeera and the Associated Press in the Gaza Strip. Just a few days earlier, the Israeli military had also bombed the al-Henday, al-Jawhara and al-Shorouk towers, which together housed more than a dozen local and international news agencies.

The towers targeted by Israel were among a handful of high rises that were built in the Gaza strip in the last 20 years to meet the local population's commercial, social and educational needs.

Before the attacks, these towers were some of the very few locations in the blockaded enclave that enjoyed relatively uninterrupted services, in particular, electricity sourced by their own generators. As a result, they attracted hundreds of families as residents, and were hosting not only numerous media offices but also several local businesses, law firms, medical labs and civil society organisations. Also serving as a cultural and social hub, they were central to the daily lives of many Gazan youths.

As a result of the bombings, Gaza lost a key piece of its social and, perhaps most crucially, media infrastructure. Israel gave the journalists working at the al-Jalaa tower just one hour to evacuate their offices, forcing them to abandon much of their archives and equipment to be destroyed alongside the building.

The bombing of the al-Jalaa tower drew criticism from international organisations, rights groups and several governments, including those of Israel's allies.

The Israeli military claimed that the tower housed Hamas military intelligence assets, and therefore constituted a legitimate target. However, as recently admitted by United States Secretary of State Antony Blinken, who routinely defends Israel's actions, Tel Aviv has so far released no evidence to support these allegations. The Associated Press strongly denied that Hamas was active in the building.

However, whether or not Hamas had offices in the building, the targeting with missiles of highrise buildings located in a dense urban centre and populated by hundreds of civilians is an indefensible violation of international law. By striking these

vibrant towers, Israel once again made clear that it is determined to inflict maximum psychological damage on the strip's besieged population.

Moreover, by targeting the offices of local and international media organisations in Gaza, it announced to the world that it is now willing to do everything necessary, including using the full force of its military, to stop journalists from reporting on its crimes against the Palestinian people.

And Israel has much reason to try and silence

In recent decades, the media has become an indispensable instrument for winning wars. Victory in modern conflict is as much dependent on controlling domestic and international public opinion as it is on defeating the enemy on the battlefield.

Indeed, fact-based, on-the-ground reporting that scrutinises narratives put forward by militaries and states has been decisive in the progression and conclusion of many recent conflicts.

During the 2004 battle for Fallujah between the US military and Iraqi insurgents, for example, media reports from the field proved crucial in exposing the devastation inflicted by US air strikes and ground operations on the civilian population of the city and ultimately caused the US military to withdraw.

"The [US] Marines in Fallujah weren't beaten by the terrorists and insurgents, who were being eliminated effectively and accurately. They were beaten by Al Jazeera," wrote retired American Lieutenant Colonel Ralph Peters in the battle's aftermath. Rather than admitting the media has the

ability to hold powerful militaries to account, Peters claimed that Al Jazeera and others "lied" about the situation on the ground to prevent a US victory. "The media is often referred to off-handedly as a strategic factor," he wrote, "but we still don't fully appreciate its fatal power."

As the US did then, Israel today is struggling to combat the growing spread of accurate news about its assaults on civilians and violations of international law

Thanks to the efforts of journalists in Palestine and beyond, as well as millions of Palestinians speaking their truth on social media, the real story of Palestine is finally being heard across the world. As a result, not only is global public opinion shifting in favour of Palestinians, many international institutions and organisations that had long allowed Israel to control the narratives about the conflict are feeling obligated to speak up for Palestine.

On May 17, leading rights group Amnesty International condemned Israel's continuing assault on Gaza, saying that the Israeli military has "displayed a shocking disregard for the lives of Palestinian civilians by carrying out a number of airstrikes targeting residential buildings in some cases killing entire families – including children – and causing wanton destruction to civilian property, in attacks that may amount to war crimes or crimes against humanity".

Amnesty's damning statement came on the back of a report published by Human Rights Watch in April which asserted that Israel is perpetrating "crimes against humanity of apartheid and persecution" in its treatment of Palestinians and the international community must therefore re-evaluate diplomatic relations with the state.

Today, Israel is not only trying to stop the spread of accurate information during its assault on Gaza by bombing press offices, but also through a campaign of disinformation.

For example, last week, a spokesperson for Israeli Prime Minister Benjamin Netanyahu shared a video on Twitter which he claimed showed Hamas firing rockets at Israel "from populated areas". As the BBC stated, the clip was actually filmed in Syria in 2018 and had nothing to do with Gaza. Twitter later labelled the tweet as "manipulated media".

Beyond sharing demonstrably "fake news", the Israeli government is also trying to manipulate the international and domestic public opinion by persistently peddling the false narrative that Hamas is the aggressor in the conflict, that its military is doing everything it can to avoid civilian "casualties", that it is merely defending itself against "a terrorist organisation", and that the current escalation is not

a direct result of its illegal occupation.

The fake videos and information disseminated by the Israeli government have already resulted in many Palestinians and Palestinian citizens of Israel being attacked by far-right Israeli mobs. These false narratives are also being used by pro-Israel governments across the world to avoid condemning the demonstrably illegal actions of their ally.

The international community must take immediate action to protect journalists in the occupied Palestinian Territories and Gaza. The important and perilous work journalists do in these conflict zones is the only way of exposing the brutality of Israel's ongoing assault on Gaza and its decades-old illegal occupation of Palestine.

But, at the same time, Israel's ability to bomb Gaza's "towers of truth" with impunity should not leave those who want justice for Palestine feeling hopeless. The growing pluralisation and democratisation of sources of information mean that Israel cannot win the battle it is waging on truth. At the end of the day, it can't silence all of us, all the time.

Wait for "Better" Vaccines?

I'm over 50 and hesitant about the AstraZeneca COVID vaccine/covishield. Should I wait for better vaccines?

There's really no logical reason for someone over 50 to wait for an alternative to the AstraZeneca vaccine, like Pfizer or Moderna. If you do choose to wait, there's no guarantee when any alternative might be available, and in the interim you risk leaving vourself vulnerable

t's been well documented that there's a significant level of vaccine hesitancy. This appears to be a particular issue among adults over 50 concerning the AstraZeneca vaccine, for which this group is now eligible.

Hesitancy over the AstraZeneca vaccine, likely to be stemming largely from the very small risk of blood clots, is leading some people to ask: can't I just wait and get the Pfizer vaccine later?

Despite the mixed messaging, you shouldn't wait for a Pfizer or Moderna vaccine later. There are a number of benefits to getting the AstraZeneca

Thinking about the blood clot risk

Thrombosis with thrombocytopenia syndrome (TTS), an unusual blood clotting disorder, has been associated with the AstraZeneca vaccine.

It's important to emphasise it's not unreasonable to have concerns about the risk of a potentially serious side effect from the AstraZeneca vaccine, or any other vaccine. The challenge is in understanding the magnitude of this risk, putting this risk into perspective, and then weighing up the risks versus the benefits before making a decision.

The difficulty is your brain plays a variety of tricks on you when you try to make sense of risks like this. For example, we have a tendency to perceive the risks of very rare adverse outcomes (such as TTS) as being greater than they are.

We also tend to be more concerned about negative consequences that may arise as a result of our actions than our inactions. That is, we're generally more worried about a potential adverse outcome from taking a vaccine than any adverse outcome that may result from not taking it. This of course isn't logical, but is another one of the errors we make in processing risks.

In terms of assessing the risk of TTS associated with the AstraZeneca vaccine for over 50s, we've always known the risk is very low. This is about the same as your risk of serious injury from being struck by lightning in a year in Australia.

Importantly, as we've got better at detecting and treating this condition, the likelihood of severe outcomes from TTS have come down considerably. So the rare risk of serious illness from this syndrome looks to be even rarer than we first thought.

Weighing the risks against the benefits

The benefits of getting the AstraZeneca vaccine are considerable for over 50s, from both an individual and a community perspective.

When opting to get a vaccine, you're protecting yourself against the future risk of infection and possible severe illness. For over 50s who contract COVID the risk of severe illness and death is very real. We're also learning many people who get COVID-19 suffer with ongoing and sometimes debilitating symptoms, a phenomenon called "long

cy around the AstraZeneca vaccine is the perception the Pfizer vaccine works better. But the most recent data suggest any difference in the performance of these vaccines may be smaller than we originally believed.

Although phase 3 clinical trial data indicated the AstraZeneca vaccine had an efficacy of around 70%, new real-world data from the United Kingdom tells us it could be as much as 85%-90% effective in protecting against symptomatic COVID-19.

This is positive news and not far off the 95% figure for the Pfizer vaccine seen in clinical trials and in the real world.

And apart from effectively protecting against severe illness and death from the original strain, the AstraZeneca vaccine appears to work almost as well in protecting against more severe outcomes for variants of concern, such as the UK variant. Early signs also suggest the vaccine is working quite well to reduce transmission of the virus.

It's also important to understand — and this applies to all age groups — that we're getting vaccinated for the health of the community as a whole.

Although a great deal of the success or failure of the vaccination program has been framed in terms of reaching herd immunity, we don't need to reach a certain threshold for the community to reap benefits. Every vaccine delivered makes a difference as the greater the proportion of the population vaccinated, the more difficult it is for the virus to spread.

As we've seen in Taiwan in recent weeks, being complacent about COVID is flirting with danger.

There's really no logical reason for someone over 50 to wait for an alternative to the AstraZeneca vaccine, like Pfizer or Moderna. If you do choose to wait, there's no guarantee when any alternative might be available, and in the interim you risk leaving yourself vulnerable.

By stepping up to get your vaccine as soon as you can, you protect yourself against severe CO-VID and make a significant contribution to putting this pandemic behind us.

Education needs to go beyond giving subject proficiency

Why do schools, by and large, provide only outward efficiency to our children? If children are not taught to integrate the heart and the mind, how will they grow into better human beings? If they are not given exercises that will help them discover their values and responsibilities, how will they learn to tackle unprecedented crises in their lives? How will they line up with the new challenges of a dynamic world?

This period of pandemic is an excellent opportunity for educators to give children the most potent doses of self-knowledge and observation. This is a window for teaching our young ones how to strengthen their relationship with people, things, ideas

and nature. These lessons cannot be inculcated without exposing them to the realities and total process of human existence.

Our educational system has been doing gross injustice to them by making them believe that learning STEM alone will guarantee success in life. Pregnancy During Covid-19 Lockdown: How The Pandemic Has Affected New Mothers

or the millions of women who celebrated their first Mother's Day in May 2021, their transition into motherhood occurred in the shadow of the COVID-19 pandemic.

Preparing for childbirth can be joyful and exciting, but COVID-19 restrictions disrupted many women's prenatal care and forced some mothers to deliver their infants, without partner or family support.

Others faced separation from their newborns immediately after birth.

Expectant parents also missed out on many celebrations and rituals that commemorate the transition into parenthood: baby showers, bris and christening ceremonies, neighbours dropping by with a meal, or grandparents travelling to meet the newest family member.

Over the past seven years, our lab has studied new parents, following couples from pregnancy across the first year postpartum.

COVID-19 lockdowns last spring stopped our in-person data collection when our campus closed.

But even as it stopped our usual research in its tracks, the pandemic created an opportunity to investigate a unique form of prenatal stress in real time.

Effects of prenatal stress can last throughout life A tragic natural experiment helped spark study in the field researchers call 'fetal origins of adult disease', which explores links between pregnancy stress and later health.

At the tail end of World War II, the Nazi army cut off food supplies to the Netherlands, plunging the country into famine during the winter of 1944-1945.

Babies in utero during what became known as the "Dutch Hunger Winter" showed lifelong differences in cardiometabolic health

Because this was a clearly demarcated period of starvation, it even allowed researchers to investigate trimester-specific effects, finding that babies exposed to famine early in pregnancy showed outcomes different from those exposed late in pregnancy.

Scientists have linked other largescale societal crises like the September 11 attacks, Hurricane Katrina and the 2005 earthquake in Chile with long-term health consequences for mother and child.

The COVID-19 pandemic shares many similarities with these events, including widespread loss of life.

But it's also unique.

Communities often unite to grieve and



rebuild after natural disasters.

The need to maintain social distance during the pandemic kept many people isolated from one another especially many pregnant women, a high-risk population that may have elected to stick with stricter social distancing measures.

What happens when an expectant mother's in-person social network shrinks or disappears overnight? Social connection, mental health and COVID-19 Scientists know social support buffers the risk for mental health problems in mothers.

So our lab wondered how the sudden isolation of lockdowns coupled with the economic and health worries of the pandemic might affect pregnant women.

We sought to answer this question by recruiting 760 expectant parents (641 pregnant women and 79 fathers or partners) between early April and July of 2020 to participate in our Coronavirus, Health, Isolation and Resilience in Pregnancy (CHIRP) study.

The week of April 7, 2020 coincidentally, the same week we launched our study represented the peak of 'sheltering in place' behavior in the US, with Americans spending 93% of their time at home.

We converted our usual in-lab battery of questionnaires into an online format and posted on social media and online parenting and pregnancy groups.

Our preliminary findings are currently undergoing peer review at an academic journal.

Only about 5% of the pregnant women who responded to our survey had a suspected or confirmed case of COVID-19 as of spring 2020, and a similar number 4.7% had experienced the death of someone close to them due to the pandemic.

However, 97% reported that their community had issued a stay-at-home or shelter-in-place order.

Moreover, 61% of women reported that the pandemic had had 'very' or 'somewhat' negative impacts on their social relationships.

A majority of women estimated that at the time of the survey they had much less contact than before the start of the pandemic with neighbours and community members, co-workers, close friends and family

Up To 300% More Antibodies When Second Dose Delayed, Says Study

aced with a limited supply of shots and anxious populations waiting their turn, more countries are turning to an initially controversial strategy that's now been vindicated by scientific studies: doubling or tripling the intervals between the first and second Covid vaccine dose.

A delay in getting the second shot not only allows the existing supply of shots to be more widely distributed, it boosts their protective power by givMore Powerful

The research suggests that the first shot primes the immune system, allowing it to start making protective antibodies against the virus. The longer that response is allowed to mature, the better the reaction to the second booster shot that comes weeks or months later.

The benefits from longer dose intervals is being seen across all types

People over 80 given a powerful mRNA vaccine from Pfizer Inc. and BioNTech SE had an antibody re-



ing the immune system more time to respond to the first inoculation. Levels of antibodies produced to fight off the virus are 20% to 300% higher when the follow-up vaccine comes later, new research shows.

like Singapore, which is grappling with a rare, albeit small, rise in cases after strict mitigation measures contained the virus last year. The citystate is now extending dose intervals -- previously three to four weeks -- to six to eight weeks, in order to reach a goal of covering its entire adult population with at least one shot by the end of August. India, facing a catastrophic outbreak, is advising 12 to 16 weeks between shots.

Other nations in similar straits with few vaccine doses and antsy populations - are likely to follow.

"If I could, I would push a button that says right now, this second, we give one dose to everybody we can reach," Gregory Poland, a virologist and director of the Mayo Clinic's Vaccine Research Group. "We'll get around to second doses later.'

"In the midst of a world on fire, you put out as many fires as you can, as quickly as you can," Poland said.

The reassuring evidence on longer dosing intervals wasn't available when the vaccine rollout first started at the end of 2020. Then, countries limited their use to the highest-risk people and guaranteed a second shot was waiting for those segments. The U.K. was the first to abandon those constraints amid a massive outbreak in late 2020 - a move that was initially criticized but has now proved pre-

sponse that was 3.5-fold higher if the second shot came after three months, rather than three weeks. Other studies concluded that delaying the final shot for nine to 15 weeks averted more hospitalizations, infections and That's welcome news for places deaths, while one from Canada sug-

gested the biggest benefit came from a six month delay. There are drawbacks. The additional time between doses means it will take longer for countries to protect their populations. While one shot offers some level of benefit, people aren't considered fully immunized until several weeks after their second dose. The interval is particularly dan-

gerous when less potent vaccines are being used or more transmissible variants of the virus are circulating.

Some countries are pushing the boundaries. India's delay of three to four months between doses, among the longest in the world, means those scrambling to get vaccinated amid its current outbreak won't be fully protected until the summer or the fall.

While studies suggest the optimal spacing between AstraZeneca shots is 12 weeks, there is scant data on the impact of stretching that to 16 weeks. The British drugmaker's shot accounts for the majority of inoculations in India now.

The greater delay can also increase the logistical hurdles involved in getting millions of people to return to complete the series, especially if they feel they already have some coverage from the first shot. It's already difficult to get people in developing countries to return given transportation and communication challenges.

COVID-19: Canada Extends Flight Ban From India, Pakistan Until June 21

anada has extended the ban on direct flights from India and Pakistan by one more month until June 21 in a bid to arrest the spread of new variants of the COVID-19, according to an official announcement. The ban on flights from India and Pakistan was extended as the previous 30day ban, first imposed on April 22, was set to expire on Saturday, Canadian Broadcasting Corporation (CBC) News reported.

Cargo flights, however, will be permitted in order to maintain shipments of essential supplies, such as vaccines and personal protective equipment, it said on Friday. "The Minister of Transport is of the opinion that it is necessary for aviation safety and the protection of the public," according to a notice to airmen.

As the ban applies to direct flights from both countries, passengers can still fly to Canada from India or Pakistan by arriving via a third country. They will need to produce a negative result on a COVID-19 test taken at their last point of departure before being allowed to enter Canada, according to the report.

Transport Minister Omar Alghabra, at a government pandemic briefing, said that the restriction was put in place "based on public health advice to reduce the importation risk of COVID-19 and its variants.'

"I can say that we've seen a significant reduction in the number of positive cases of COVID-19 arriving from international flights since this restriction was put in place," he said. Alghabra said the government would continue adapting border

India's Covid Crisis Is A Warning For Other Low- And Middle-Income Countries: IMF

bserving that the ongoing "catastrophic" second wave of Covid-19 in India is a sign that the worst may be yet to come, the IMF has said. The organisation also said that the situation in India is a warning of the possible events in low- and middle-income nations that have seemingly escaped the pandemic till now.

A report co-authored by International Monetary Fund (IMF) economist Ruchir Agarwal and its Chief Economist Gita Gopinath on Friday said that under the 'business-asusual' scenario, the vaccine coverage in India is expected to remain under 35 per cent of the population by the end of 2021.

"The ongoing catastrophic second wave in India, following a terrible wave in Brazil, is a sign the worst may be yet to come in the developing world," it said.

While India's health system held up fairly well in the first wave, this time its health system is so overwhelmed that many people are dying because of a lack of medical supplies like oxygen, hospital beds, and medical care, the report said.

"India is a warning of possible events in other low- and middleincome countries (LMICs) that so far have seemingly escaped the pandemic, including in Africa," it said. For India, the report said, current

bilateral purchases of vaccine plus coverage from COVAX will cover about 25 per cent of its population by the first half of 2022. To get to 60 per cent coverage, India will need to immediately place suffi-

cient vaccine orders of about 1 billion doses through contracts that incentivise investment in additional capacity and augmentation of the supply chain. "In this context, the authorities" recently announced financing of

about USD 600 million to the Serum Institute of India and Bharat Biotech to boost production capacity in the near term is a welcome step," the



report said, adding that authorities estimate that two billion doses will be available by the end of 2021.

Efforts should be made to ensure that the projected production capacity will materialise without delay, including through securing the supply chain for raw materials - supported by international efforts to eliminate export restrictions on all critical inputs, it added.

In its report, the IMF said that an urgent focus should be to eliminate constraints on cross-border exports of critical raw materials and finished vaccines. Free cross-border flow of vaccine inputs and supplies is essential for the world to achieve its vaccination targets without delay.

Governments are taking steps to relax such constraints on raw materials, it said, citing the recent pledge by the US to facilitate greater access of critical raw material to Indian manufacturers after severe shortages emerged. However, there is scope for greater multilateral action on this front, as significant constraints still remain, it said.

The IMF report said India continues to face production bottlenecks, including due to ongoing shortages of critical raw materials, suggesting the need for further relaxation of de facto export restrictions under the US Defence Production Act.

Despite such near-term constraints, as of mid-May 2021, the authorities estimate that over two billion doses will be available by the end of the year based on companylevel supply projections publicly shared by officials.

"Therefore, while current pre-purchases of vaccines plus coverage from the COVAX AMC remains around 25 per cent, the authorities intend to meet the residual needs through the additional production," it said.

To reach a coverage of 60 per cent of the population, India will need to order roughly one billion doses of additional vaccines.

"Given the authorities are expected to comfortably use domestic resources for meeting these residual needs and are not seeking external financing for these purposes, we do not allocate additional funds for India in our budgeting exercise," the IMF said.

Indian is currently pursuing a strategy of procuring vaccines for those above 45 years of age by the Centre, while States procure vaccines for those aged 18-44.

Given the current vaccine pricing offered by domestic suppliers, and the estimated size of the younger population in India, the additional funding needs for the Centre for covering the 18-44 population is approximately 0.25 per cent of the GDP, suggesting that there is scope for the government to handle the entire procurement centrally, it said.

Apple CEO Faces Tough Questions About Application Store Competition

SAN RAMON, Calif. (AP) - Apple CEO Tim Cook described the company's ironclad control over its mobile app store as the best way to serve and protect iPhone users, but he faced tough questions about competition issues from a judge Friday about allegations he oversees an illegal monopoly.

The rare courtroom appearance by one of the world's best-known executives came during the closing phase of a three-week trial revolving around an antitrust case brought by Epic Games, maker of the popular video game Fortnite.

Epic is trying to topple the socalled "walled garden" for iPhone and iPad apps that welcomes users and developers while locking out competition. Created by Apple co-founder Steve Jobs a year after the iPhone's 2007 debut, the App Store has become a key revenue source for Apple, helping power the company to a \$57 billion profit in its last fiscal year.

The trial focuses on Epic's contention that Apple has turned its store into a price-gouging vehicle that not only reaps a 15% to 30% commission from in-app transactions, but blocks apps from offering other payment

was buying everything Cook said on the stand.

After the lawyers were done with their questioning, U.S. District Judge Yvonne Gonzalez Rogers asked why Apple can't allow rival stores to offer an in-app transaction option on iPhones, iPads and iPods that might charge lower commissions. That is something Epic is fighting to make it happen, partly because it has a still unprofitable store that imposes a 12% commission.

Gonzalez Rogers seemed particularly troubled by a survey indicating 39% of iPhone app developers aren't happy with the current distribution system. She also wondered about the fairness of a commission system requiring the makers of video games pay the bulk of the commissions, while digital services offered in other industries such as banking don't pay anything, even though they are using the technology that powers iPhones.

"The gaming industry seems to be generating a disproportionate amount of money relative to the (intellectual property) that you are giving them and everybody else? In a sense it's almost as if they are subsidizing everybody else," Gonzalez Rogers said.

Under friendly questioning from a company lawyer, Cook delivered polished remarks that sometimes sounded like a commercial for the iPhone and other Apple products.

His unease was particularly evident when pressed about the level of profits in a store that lobs initially thought would be lucky to break even. He seemed ole slightly again when when Bornstein confronted him about a deal in China that could compromise user privacy, even as the company maintains that protecting its customers' personal information is a top priority.

Cook, though, never wavered during nearly four hours of testimony from his position that Apple's grip on the app store helps it keep things simple for a loyal customer base that buys iPhones knowing they getting "something that just works.'

"They buy into an entire ecosystem when they buy an iPhone," said Cook, who wore a face shield, but no mask in an Oakland, California, courtroom that has limited access because of the pandemic.

It wasn't at all clear that the federal judge who will decide the case

Cook agreed about the subsidy, but insisted there is still a fair balance because video game makers are able to reach a wider audience of consumers who become players while visiting the store looking at other apps. He took issue with the notion that most app makers are unhappy with the store's current setup. 'We turn the place upside down

for developers," Cook said. Gonzalez Rogers also didn't

seem to buy Apple's explanation for a move it made last year when it lowered its commission on in-app commissions to 15% on the first \$1 million in revenue. Although the price cut came after Epic filed its antitrust case in August, Apple said the discount was driven by desire to provide a helping hand during a pandemicdriven recession.

"At least what I've seen so far, that really wasn't the result of competition, (but) the pressure vou were feeling," Gonzalez Rogers told Cook. Apple's app store practices are being examined by regulators and lawmakers in the U.S. and Europe while Epic pursues its case.

Gonzalez Rogers is expected to elaborate issues still weighing on her mind Monday when she plans to pose questions to lawyers on both sides while they make their final points before she takes the matter under submission. The judge said she hopes to release her decision before Aug. 13 in a written ruling that could reshape the technology landscape.

Make in India? Half of Manufacturing **Jobs Lost In Give Years** From employing 51 million people ployment to grow from 36% to 40%

Thile the employment scenario in the country has turned bleaker of late due to the pandemic after a brief spell of moderate recovery from the fathoms hit in May 2020, manufacturing, which has ostensibly received a lot of policy attention, has been losing out to other sectors and the most to agriculture as job creator

According to an analysis by the Centre for Economic Data and Analysis (CEDA) based on the CMIE monthly time-series of employment by industry, manufacturing employment in 2020-21 was nearly half of what it was five years ago.

The decline was particularly sharper in 2020-21 owing to the pandemic – on a year-on-year basis, the sector employed 32% fewer people in 2020-21 over 2019-20. Real estate & construction also also saw big fall in its share in employment in 2020-21 (see chart) and a secular decline over the five-years to 2020-21.

While there has been a secular decline in manufacturing employment across all sub-sectors, except chemical industries, all sub-sectors registered a longer-term decline.

in 2016-17, employment in manufacturing, which accounts for 17% of the country's gross domestic product (GDP), declined by 46% to reach 27.3 million in 2020-21, reflecting the severity of the employment crisis caused by the pandemic.

Similarly, the real estate and construction sector, which employed 69 million people in 2016-17, employed just 53.7 million in 2020own by a quarter. While the pandemic indeed accentuated the decline, the sector had even earlier been hit hard by inventory pile-up, delivery delays and developer delinquencies. The real estate sector had witnessed a sharp increase in employment growth in the 2004-2011 period, thanks to a boom.

According to the CEDA-CMIE study which covered agriculture, mines, manufacturing, real estate and construction, financial services. non-financial services, and public administrative services, sectors that account for 99% of total employment in the country, agriculture now employs more people than five years ago. The agriculture sector that employed 145.6 million people in 2016-17, employed 151.8 million in 2020-21, allowing its share in emduring the period. Employment in agriculture has been on the rise over the last two years with year-on-year growth rates of 1.7% in 2019-20 and 4.1% in 2020-21, indicating a marginal shift away from manufacturing, non-financial services, mining and real estate sectors to the traditional resort for livelihood.

Among the service sectors, nonfinancial services, the largest comthe employment rose over the five-year horizon to 119.7 million to 127.7 million in 2020-21, but there was a sharp y-o-y decline in 2020-21, owing to the pandemic.

As reported by FE recently, like the one a year ago, the recent lockdown also has had an immediate, telling effect on the employment scenario in the country. The country's unemployment rate, that has remained elevated for a few weeks, soared to a near one-year-high of 14.45% in the week ended May 16. While an already-high urban joblessness has turned more acute, a near-100% week-on-week rise in rural unemployment pushed the overall joblessness rate to a level not witnessed since the the week ended June 7 last year, when it stood at 17.51%.

Complied With New Intermediary Norms Ahead Of Time: Koo

NEW DELHI: Homegrown microblogging platform Koo on Saturday said it has met the compliance requirements of the new guidelines for digital platforms ahead of the stipulated deadline later this month.

On February 25, the government had announced tighter regulations for social media firms like Facebook and Twitter, requiring them to remove any content flagged by authorities within 36 hours and setting up a complaint redressal mechanism with an officer being based in the country. The government had set 50 lakh registered users as the threshold for defining 'significant social media intermediary', which will have to adhere to additional obligations and compliance under the new IT rules that seek to crack down on misuse of social media platforms.

Announcing the guidelines in February, it had said the new rules take effect immediately, while significant social media providers (based on number of users) will get three months before they need to start complying.

In a statement on Saturday, Koo said its Privacy Policy, Terms of Use

The new rules—announced earlier this year-require 'significant social media intermediaries' to follow additional due diligence, including the appointment of a chief compliance officer, nodal contact person and resident grievance officer. All three officials will have to reside in India. The players will have to publish a monthly compliance report and details of the contents removed proactively.

As per data cited by the government, India has 53 crore WhatsApp users, 44.8 crore YouTube users, 41 crore Facebook subscribers, 21 crore Instagram clients, while 1.75 crore account holders are on microblogging platform Twitter.

The new rules were introduced to make social media platforms like Facebook, WhatsApp, Twitter and Instagram—which have seen a phenomenal surge in usage over the past few years in India-more accountable and responsible for the content hosted on their platform.

Social media companies will have to take down posts depicting nudity or morphed photos within 24 hours of receiving a complaint, and will be required to disclose the first originator of the mischievous information that undermines the sovereignty of India, security of the state, or public order when asked by the court or government. — PTI

4.5 Million Passengers Hit In Massive Cyber-Attack On Air India

n a massive data breach on national carrier Air India, details of Laround 4.5 million passengers have been compromised including passport and credit card information, Air India said in a statement late on Friday

In a personal communication to those whose details were stolen, the airline said, "As part of our commitment, we would like to inform you that SITA PSS, our data processor of the passenger service system, recently notified Air India of a data security breach involving personal data of certain passengers, including yours." The identity of the affected passengers, the message said, was provided by the data processor to Air India on March 25 and April 5, 2021.

"We hereby address to you a personal communication of this data security incident. The breach involved some personal data reg-



istered between 26th August 2011 and 20th February 2021 with details that included name, date of birth, contact information, passport information, ticket information, frequent flyer data and also credit cards data," it said.

Air India's passenger service system provider SITA based out of Geneva in Switzerland faced a sophisticated cyber-attack in February leading to leak of personal data of a certain number of the national carrier's passengers.

IMA Demands Action Against Ramdev For Remarks About Allopathy; Patanjali Says Comments "False"

New Delhi: The Indian Medical Association (IMA) on Saturday demanded that the Centre should take strict action against yoga guru Ramdev for allegedly misleading people by making "unlearned" comments and describing modern medicine as "stupid science", remarks which were denied as "false" by the Haridwar-based Patanjali Yogpeeth Trust.

Resident Doctors' Associations of the All India Institute of Medical Sciences (AIIMS) and Safdarjung Hospital too condemned Ramdev's statement and demanded that "strictest steps" be taken against him.

Citing a video circulating on social media, the IMA said Ramdev has claimed that allopathy is a "stupid science" and medicines such as remdesivir, faviflu, and other drugs approved by the Drugs Controller General of India have failed to treat COVID-19 patients. The doctor's body also quoted Ramdev as saying that "lakhs of patients have died after taking allopathic medicines".

Ramdev should be prosecuted under the Epidemic Diseases Act as "untutored" statements are "a threat to the literate society of the country as well as to the poor people falling prey to him", the IMA said in a statement.

"The Union health minister, who himself is a practising modern medicine allopathic postgraduate and head of this (health) ministry, should either accept the challenge and accusation of this gentleman and dissolve the modern medical facility or boldly face and prosecute the person for his words of



arson on the sovereignty of the country and book him under the Epidemic Act to save millions of people from such unscientific utterances," the IMA said.

The IMA said it has also sent a legal notice to Ramdev seeking 'written apology' and 'recall of statements' by him.

Reacting to the controversy, Patanjali Yogpeeth Trust issued a statement, denying the comments, and said, "it is clarified that the truncated version of the video is totally out of context of what is sought to be conveyed by Swami jee."

Asserting that Ramdev has "utmost regards" for doctors and support staff who have been working day and night during such a challenging time of the pandemic, the statement signed by Trust General Secretary Acharya Balakrishna said, "Swami jee has no ill-will against the modern science and good practitioners of modern medicine. What is being attributed against him is false and nugatory.'

IMA also alleged that Ramdev

was trying to take advantage of the situation and create a sense of fear and frustration among the people at large. He is doing this so that "he can sell his illegal and unapproved so-called medicines and make money at the cost of the public at large", the association said.

The IMA said Ramdev deserves to be prosecuted for "disobeying and causing danger" to the life of many by making them believe to not to take the advice of allopathy doctors.

"The IMA demands and resolves if the minister (Harsh Vardhan) is not taking suo moto action, we will be forced to resort to democratic means of struggle to propagate the truth to the common man and knock the doors of the judiciary to get due to justice, it said and added that taking people for ransom and winning business by defaming scientific medicine are unpardonable offenses.

In a statement, the RDA of AIIMS said it "vehemently

condemns" Ramdev's comments. "On behalf of the medical fraternity, and all healthcare and frontline workers, we demand strongly that strictest steps be taken against his inappropriate conduct at the earliest to pre-

COVID-19: Education Ministry Calls Crucial Meet Tomorrow On Class 12 Boards, Entrance Exams

NEW DELHI: The Ministry of Education (MOE) has called a crucial meeting on Sunday to decide on pending Class 12 board exams and subsequent entrance examinations that were postponed due to the second wave of COVID-19, Union Minister Ramesh Pokhriyal 'Nishank' said.

The high-level meeting will be chaired by Defence Minister Rajnath Singh. Union Women Development Minister Smriti Irani as well as Minister for Information and Broadcasting Prakash Javadekar will be among those present. Education ministers and secretaries of all states and union territories have been asked to attend the meeting.

Pokhriyal also sought inputs from all the stakeholders students, parents, teachers and others through social media on Saturday.

"A high-level virtual meeting will be convened tomor-row (Sunday) with all states and union territories' education ministers, education secretaries and chairpersons of state examination boards and stakeholders to discuss the proposals for the conduct of exams for Class 12 and entrance examinations for professional courses," he said.

"I recently held a meeting with the state education secretaries in this regard. The consultative process will be further strengthened through the high-level meeting. This virtual meeting will take place at 11.30 am," he added.

In a letter to the states and UTs, the education minister has said that his ministry's Department of School Education and the CBSE were exploring options regarding the conduct of the examinations,

keeping in mind the safety and security of both students and teachers.

"The Department of Higher Education is also deliberating upon the finalisation of the dates of examinations for institutions of higher learning. COVID-19 pandemic has affected various areas including the education sector, particularly the board exams and entrance exams," the letter noted.

In view of the prevailing situation, almost all state education boards, the CBSE and the ICSE have postponed their Class 12 examinations. Similarly, the National Testing Agency (NTA) and other national exam conducting institutions have also postponed entrance exams for admissions to professional courses.

"As the conduct of Class 12 examinations impacts upon state board exams and other entrance exams across the country, and to reduce uncertainty among students, it is desirable that a considered decision based on inputs of different state governments and UT administrations is taken about Class 12 examinations in the interest of all the students across the country," the letter said.

According to CBSE sources, the possible options that can be explored are --conducting pen and paper mode exams for only major subjects, conducting all exams in two phases planned as per the COVID-19 situation in different states or districts, or cancelling the exams and announcing results as per an alternative assessment scheme.

A senior board official, however, said, "nothing has been finalised yet. A final call will only be taken by the Education Ministry after considering suggestions from all stakeholders".

The CBSE had on April 14 announced the cancellation of Class 10 exams and postponed Class 12 exams due to the surge in COVID-19 cases. The decision was taken at a high-level meeting chaired by Prime Minister Narendra Modi.

The April and May edition of the engineering entrance exam JEE-Mains were also postponed.

The board exams, which are usually conducted in February-March every year, were scheduled to be held from May 4.

The CBSE had announced that a decision on the Class 12 board exams will be taken on or after June 1. A section of students and parents have been demanding that the Class 12 exams be cancelled in the wake of the pandemic situation.

The CBSE had earlier this month announced the marking policy for Class 10 board exams.

According to the policy, while 20 marks for each subject will be for internal assessment as every year, 80 marks will be calculated based on the students' performance in various tests or exams throughout the year.

Schools across the country were closed in March last year to contain the spread of COVID-19 ahead of a nationwide lockdown.

Several states started reopening the schools partially from October last year, but physical classes were again suspended because of the rise in coronavirus cases.

Last year, the board exams had to be postponed mid-way in March. They were later cancelled, and results were announced based on an alternative assessment scheme.

Mucormycosis is a serious but rare fungal infection caused by a group of molds called mucormycetes that has been developing in Covid-19 patients. The fungal disease is commonly being observed in patients who were given steroids for a long time, who have been hospitalised for a long time, were on oxygen support or ventilator, faced poor hospital hygiene or those who have been taking medication for other illnesses such as diabetes.

If not treated on time, the black fungus infection can turn fatal. The Covid medications can leave the body weak and low on immunity. They can also escalate the blood sugar levels in both diabetics and non-diabetic Covid-19

NEW DELHI: As many as 148 athletes across all sports, including those who have qualified for the upcoming Tokyo Games, have already received their first dose of COVID-19 vaccination, according to the Indian Olympic Association (IOA).

Out of these 148 athletes. 17 have got both the doses and 131 have received their first shot. IOA president Narinder Batra said.

These 148 include potential athletes who can make it to the Tokyo Olympics which is opening on July 23. Besides this, 13 Tokyo Paralympic-bound athletes have got their first vaccine shot while two have received both doses. The Tokyo Paralympics opens on August 24.

The total number of athletes (including para-athletes), who have got at least their first dose till May 20, is 163.

Giving the 'vaccination status of Tokyo-bound Indian athletes and officials in the long list as on May 20', Batra said 87 officials have got single dose of COVID-19 vaccine while 23 are fully vaccinated.

More than 90 Indian athletes across sports have so far qualified for the Tokyo Olympics which was postponed from last year due to the COVID-19 pandemic.

The Olympic-bound shooters who are currently training in Croatia will be vaccinated there as they are expected to directly fly to Tokyo from there, the NRAI has said.

Some of them have already got their first jabs in India before departing for Croatia and they will get their second dose in that country.

Fencer Bhavani Devi also got her first jab at her training base in Italy while weightlifter Mirabai Chanu is expected to get her shots in the United States.

Srinagar Youth Completes 950 KMs Srinagar-Delhi Run In 7 days

After Fighting COVID-19, W Saha Aims Dig At IPL's **Bubble Tightness**

KOLKATA: Seasoned wicketkeeper-batsman Wriddhiman Saha has indicated that the bio-bubble for IPL-14 was not as foolproof as the one in UAE last year, becoming the first India player to publicly question, even if subtly, the tightness of the controlled environment.

The 36-year-old Saha was among the players who contracted the dreaded virus before the IPL stumbled to an abrupt halt midway into its 14th season after multiple COVID-19 cases were reported in its bio-bubble. over a fortnight-long quarantine at a Delhi hotel to make himself available for selection for the upcoming England tour.

On the bio-bubble he added, "I don't know what would have happened, but definitely I feel it would have been better off in UAE this time as well. It's for the stakeholders to look into it."

Saha had tested positive for CO-VID-19 on May 4, the day the 2021 edition of the tournament was suspended indefinitely

He said he has fully recovered now and he is not feeling any weakness.



During an interview with PTI, Saha spoke about the bio-bubble breach in India and said it would have been better if the IPL was held in UAE, like last year.

"It's the job of the stakeholders to assess it, but the only thing I would say is that there was not a single individual during our training in UAE (last year), not even a ground staff.

"Here there would be people, kids peeping from nearby walls. I don't want to comment much but we saw how the IPL went off smoothly in UAE in 2020 and then it started in India this year with cases on the rise," Saha said.

The Bengal veteran reached his home in Kolkata after completing

"I'm doing all normal activities, there's no fatigue, body ache or any weakness. But I will actually get to know how my body is coping when I get into actual match training mode."

Recalling his battle with the virus, he said: "I had a slight fever for the first couple of days, lost smell after five days but it returned within four days.

"It was about spending time with family, friends (virtually), catching up with some light-hearted movies and keeping myself in a good space. I was never mentally disturbed or down. I was just being normal.

"Currently, I'm doing some fitness routine at home but the actual fitness training will start after I join the team in Mumbai," he concluded.

Kayaking, Canoeing Training Facilities Added To Khelo India Centre In Srinagar

SRINAGAR: The Sports Ministry on Saturday decided to add training facilities for kayaking and canoeing at the Khelo India State Centre of Excellence (KISCE) here to promote the two watersports in Jammu and

The J&K Sports Council and the state government had made a request to include these two sporting disciplines.

The KISCE, which was launched in April after revamping facilities in the existing J&K Water Sports Academy, already has training facilities for rowing. "The performance of athletes

from the state in kayaking and canoeing have been impressive in international competitions such as the World Championships and the Asian Championship," Sports Minister Kiren Rijiju said in a release. "It has been decided to equip

the KISCE in Srinagar with training facilities for the two disciplines so that more sporting talent from the state have the opportunity to excel in the sport and represent India in world-class competition."

The Sports Authority of India (SAI) and the Sports Council of J&K will assess the requirements to implement training in the two disciplines, including coaching and equipment support to be added.

Speaking about the develop-

ment, Lieutenant Governor of J&K Manoj Sinha said, "We want to ensure maximum utilisation of the KISCE in Srinagar so that more athletes can be trained here.

"The addition of these two sporting disciplines will enable greater participation and also draw sporting talent from other states to train here. I am happy that the Sports Ministry and the state Government have worked together to make this possible.

The endeavour has been welcomed by senior athletes and sports administrators alike.

Speaking about the importance of this decision, Indian Kayaking and Canoeing Association secretary general Prashant Khushwaha said, "kayaking, canoeing and rowing together have a total of 63 medals in Olympics. If we can provide training to youngsters in these disciplines, India's medal haul in Olympics can go up significantly. 'The equipment of these sports are expensive and support through the Khelo India Scheme will be really beneficial. Kashmir is a strategic location for the academy since the weather matches with European countries where most competitions are held. This is a great step towards improving water sports in India."

International-level kayak from the state, Bilquis Mir said, "The decision to have the KISCE in Srinagar has historic significance. I have been attached to water sports for 21 years and it is for the first time that so much has been done to provide proper training facilities in the state.

"The launch of the KISCE and now the inclusion of kayaking and canoeing will enthuse young athletes of the sport and I am sure we will be able to attain a podium finish in the Olympics in the years to come."

PCB Plans June 5 Restart For PSL In Abu Dhabi

KARACHI: The Pakistan Cricket Board (PCB) is planning to start the PSL-6 in Abu Dhabi from June 5 and all the participating players will undergo a 10-day quarantine period before they start training.

The owner of Karachi Kings Salman Iqbal said the terms and conditions agreed between the PCB and the UAE authorities entail a mandatory 10-day quarantine period for players, officials and broad-

In between there will be regular Covid-19 tests during the quarantine period as well, Iqbal said.

A source in the PCB said plans were being made to fly the foreign and local players to Abu Dhabi by May 25 so that they can start their quarantine period and the tournament can begin from June 5.

The foreign and local players and officials will also have to undergo a three-day quarantine in Pakistan before boarding their chartered flights to Abu Dhabi.

The Board has also hired the ser-

vices of an international company, Restrata, to manage the COVID-19 bio-bubble in Abu Dhabi where the six teams will be put up at three different hotels.

The PCB has managed to get clearance from the authorities in the UAE to hold the remaining 20 matches of the PSL 6 in Abu Dhabi.

The confirmation to hold the matches came after days of suspense over whether the PCB would get clearance from the UAE government which has suspended all flights from Pakistan due to the current COVID-19 situation. A high powered delegation of the PCB has been in Abu Dhabi since last week to get the necessary clearances.

The PSL 6 was suspended on March 4 in Karachi after just 14 matches due to a rapid rise in COVID-19 cases among players and officials.

The Board had decided to hold the remaining matches in the UAE after the National Command and Operations Authority, which monitors the COVID-19 situation in Pakistan, had advised it against hosting the games again in Karachi.

2 Years? FIFA Expected To Make Big Changes

GENEVA: World of football was put on notice by FIFA president Gianni Infantino on Friday to imagine and maybe expect big changes to its international competitions in the coming years.

FIFA agreed to study whether the men's and women's World Cups could be played every two years instead of four, with Infantino asking out loud if they could alternate with continental championships to fill the calendar with annual national-team tournaments.

Infantino positioned FIFA as the protector of football's worldwide family which is prepared to upend the traditional competition calendar and formats to seek more equality.

The chance for change is there because the FIFA-managed calendar of international competitions which mandates when clubs must release players for national-team duty expires in 2024.

FIFA is now ready to consult widely on redrafting the calendar, after turmoil caused by the coronavirus pandemic delayed the process last year.

"What kind of competitions do

we need for the world?" said Infantino, also asking whether the season needed fewer breaks for national-team games.

Earlier, a Saudi Arabian football official proposing a feasibility study into biennial World Cups echoed FIFA's own oft-repeated suggestion of "fewer but more meaningful games" to protect players' health.

A biennial World Cup was first suggested more than 20 years ago by FIFA's then-president Sepp Blatter though was not seriously investigated.

It has been revived in recent years by allies of Infantino, who has consistently proposed more and bigger tournaments. A review of women's and youth competitions was also agreed Friday.

UEFA's popular and lucrative Champions League could be affected by Infantino's pet project of a 24-team Club World Cup. It was set to launch next month in China until the pandemic forced a postponement.

A biennial World Cup would clearly harm UEFA's second-tier Nations League event, and likely take commercial value from the fouryearly European Championship.

Indian Football Team Begins Training In Doha After All **Players Test COVID Negative**

NEW DELHI: All the players and support staff of the Indian football team have tested negative for COVID-19 after arrival in Qatar and have also started training ahead of the joint Qualifiers for the 2022 World Cup and 2023 Asian Cup next month.

The team, which arrived in Doha on Wednesday evening, was under compulsory quarantine and waiting for the results of their RT-PCR tests before starting their preparatory camp.

"Yes, all the 28 players and support staff tested negative in the tests done after their arrival," All India Football Federation General Secretary Kushal Das told PTI.

The team, bolstered by the return of Sunil Chhetri, will have a preparatory camp inside a biobubble here before its first match on June 3 against hosts Qatar. The other two matches are against Bangladesh (June 7) and Afghanistan (June 15).

Through the good offices of Qatar Football Association, a 10-day hard quarantine was waived off for the Indians and they began training as soon as they got the COVID-19 negative

"Gearing-up for the challenges ahead. The #BlueTigers had their training first training session in Doha, Qatar last night," the AIFF said in a tweet, along with pictures of training of players under head coach Igor Stimac.

The matches are being played in Doha in view of the COVID-19 pandemic which doesn't allow the original format of home and away matches.

The Indian team, fourth in Group E with three points, is already out of contention for a World Cup berth but is still in the reckoning for the 2023 Asian Cup The Indian players were to

SpiceJet Plane Carrying Indian Boxing Contingent Lands In Dubai Declaring Fuel Emergency, Probe Ordered

NEW DELHI: A SpiceJet plane ferrying ace pugilist Mary Kom and 30 other members of an Indian boxing contingent from Delhi was forced to hover for around 45 minutes and declared a fuel emergency before it landed safely at the Dubai airport on Saturday morning, sources said.

The Directorate General of Civil Aviation (DGCA) is investigating the entire incident, they said.

The sources said that due to CO-VID-19 restrictions, SpiceJet had got special permission from the UAE government to bring these boxers to Dubai for Asian Boxing Championship 2021 that will be held between May 24 and June 1.

However, the plane had to wait in the UAE airspace for around 45 minutes due to some confusion at the Dubai airport's air traffic control on whether the aircraft can be allowed to land or not and a fuel emergency was declared, they said.

The UAE, since April 25, has barred all travellers from India - except UAE nationals, diplomatic passport holders and official delegation letter holders – due to the second wave of the COVID-19 pandemic that has hit



the country. The flight SG142 carrying 31 boxers and six crew members departed from the Delhi airport at around 2.20 AM (Indian time) and landed at the Dubai airport at around 6.20 AM

(Indian time) on Saturday morning. Six-time world champion Mary Kom was among the boxers on board the aircraft.

Covid-19 Situation Stabilising With Positivity Rate, Daily Cases, Active Cases Reducing: Govt

NEW DELHI: The Covid-19 positivity rate has declined from 24.83 per cent on May 10 to 12.45 per cent on May 22, the Union Health Ministry said on Saturday.

Addressing a press briefing, Niti Aayog member (health) VK Paul said that though there has been an overall decline in case burden but the positivity rate is still over 10 per cent in 382 districts.

The Covid-19 situation is stabilising with positivity rate, daily cases and active cases reducing, Paul said.

Eight states have more than 1 lakh active cases while 18 states have over 15 per cent positivity rate, joint secretary in the ministry Lav Agarwal said during the briefing.

On vaccine wastage, the ministry said Covishield wastage has reduced from 8 per cent on March 1 to 1 per cent now, while Covaxin wastage decreased from 17 per cent to 4 per cent in the same period.

Paul also said that children can spread the coronavirus but they al-



most always have mild infection and mortality is very, very low in them.

On the vaccine passport issue, Agarwal said there has been no consensus vet on the matter at the World Health Organisation level, but discussions are going on.

The daily rise in coronavirus cases in India remained below the 3 lakh-mark for the sixth consecutive day, with 2.57 lakh new cases recorded in a single day, Health Ministry data showed.

With the fresh cases, India's tally of Covid-19 cases climbed to 2,62,89,290. The death toll due to the disease rose to 2,95,525 with 4,194 fresh fatalities, the data updated at 8 am showed.

The active cases further reduced to 29,23,400 comprising 11.12 per cent of the total infections, while the national Covid-19 recovery rate improved to 87.76 per cent, PTI

Ramdev Bears No Ill-Will Against Modern Science, Says Patanjali After Allopathy Remarks Draw IMA's Ire

CHANDIGARH: Patanjali said on Saturday the remarks attributed to yoga guru Ramdev condemning modern medicine for being behind "lakhs of deaths in the country" was taken out of context---a statement that comes as the remarks drew doctors' ire.


Ramdev had "utmost regards" (sic) for doctors and support staff who have been working day and night during such a challenging time of the pandemic, said the statement issued by the Haridwarbased Patanjali Yogpeeth Trust.

He was "reading out a forwarded WhatsApp message received by him and various other members who were participating in the event", it added.

the Drugs Controller General of India, have failed in treatment of COVID-19 patients.

"The Union health minister (Harsh Vardhan) who himself is a practicing modern medicine allopathic postgraduate and head of this (health) ministry, should either accept the challenge and accusation of this gentleman and dissolve the modern medical facility or boldly face and prosecute the person for his words of arson on the sovereignty of the country and book him under the Epidemic Act to save millions of people from such unscientific utterances," the IMA said.

It alleged that Ramdev is trying to take advantage of the situation and create a sense of fear and frustration among the people at large. He is doing this "so that he can



"Swami jee has no ill-will against the modern science and good practitioners of modern medicine. What is being attributed against him is false and nugatory," said the statement signed by Patanjali Yogpeeth Trust General Secretary Acharya Balakrishna.

The controversial remarks in question came from an undated video that showed Ramdev addressing an assembly. Ramdev can be heard saying clearly: "I am going to say something huge. It's possible I'd be criticised for this. Lakhs of people died because of allopathy. There were more deaths caused by allopathy than those caused by people not getting to hospitals or getting oxygen".

The remarks drew the ire of healthcare professionals across the country. The Indian Medical Association condemned the remarks as unscientific and asked the central government to take action against him.

Ramdev should be prosecuted under the Epidemic Diseases Act as "untutored" statements are "a threat to the literate society of the country as well as to the poor people falling prey to him", the apex doctors' body said in a statement

IMA quoted Ramdev as saying in the video that "allopathy ek aisi stupid aur diwalilya science hai... (allopathy is such a stupid science)".

He also says that "lakhs of people have died after taking allopathic medicines", the association said, adding that Ramdev claimed Remdesivir, Faviflu, and all other drugs, which were approved by sell his illegal and unapproved so-called medicines and make money at the cost of the public at large", the association said.

The IMA said Ramdev deserves to be prosecuted for disobeying and causing danger to the life of many by making them believe in "not to take the advice of allopathy" doctors.

"The IMA demands and resolves if the minister (Harsh Vardhan) is not taking suo moto action we will be forced to resort to democratic means of struggle to propagate the truth to the common man and knock the doors of the judiciary to get due to justice," it said.

Taking people for ransom and winning business by defaming scientific medicine are unpardonable offences, the IMA said.

Citing Ramdev's remarks, it said such "untutored and unlearned" statements are a threat to society.

Ramdev's Patanjali has been marketing its own herbal medicine called 'Coronil' against Covid-19. The medicine has been mired in controversy since the start, with IMA asking for a clarification from the Health Ministry in February this year over the company's alleged claims that the medicine has the World Health Organization's certification of effectiveness. WHO denied this, forcing the company to issue a clarification.

This came after a controversy last year forced the health ministry to say that the Patanjali Trust could only market the medicine 'Coronil' as one for immune-boosting and not for Covid therapy.

Will Have To Shut Vaccination Centres For 18-44 Age Group As Vaccine Stocks Are Over: Delhi CM

NEW DELHI: Delhi Chief Minister Arvind Kejriwal on Saturday said Covid-19 vaccination centres for those in the 18-44 age group have to be closed due to lack of doses, and wrote to Prime Minister Narendra Modi for immediate supply of jabs and increasing the quota of the city.

As the country is facing a shortage of vaccine, Kejriwal gave four suggestions to Modi, including procurement of vaccines from foreign manufacturers and inviting firms for production in India.

In an online press conference, Kejriwal said that from Sunday, all vaccination centres for youths in Delhi will be closed as stocks have run out.

Delhi requires 80 lakh doses a month to vaccinate people in three months. But it only received 16 lakh doses in May and the Centre has further decreased Delhi's quota in June to 8 lakh doses, Kejriwal said.

So far 50 lakh people have been vaccinated in Delhi. Further, 2.5 crore more doses are required to vaccinate all adults in Delhi, he said.

"With this speed of 8 lakh doses per month, it will take 30 months to vaccinate all the adults alone. By then, no one knows how many waves will arrive and how many deaths will occur," Kejriwal said urging the prime minister to raise the quota and supply to the city im-

The chief minister extended four suggestions to the central government to enhance vaccine availability in the country.

The central government should within 24 hours direct all capable companies in the country to start manufacturing Covaxin as Bharat Biotech has agreed to share its for-



mula, he said.

Vaccines manufactured abroad should be used in India and the Centre needs to procure vaccines on the behalf of states as it will be more effective in bulk procurement. Kejriwal said.

Foreign companies should be allowed to manufacture vaccines in India and the Centre should try to get vaccines from such countries that have stocks of more doses than their need, he suggested.

Vaccination of maximum number of people in the shortest time is the only way to save Delhi and coronavirus, Kejriwal asserted.

"We are arranging beds, oxygen and medicines, but vaccine is the most effective weapon of protection against the fatal virus."

Shortage of vaccine is not just

a matter of worry for the govern-

ments, common people are also

scared due to this crisis, he claimed.

Shortage of vaccine has caused a very difficult situation in the country, Kejriwal said and narrated a call he had received from an elderly mother who requested vaccine for his son foregoing the jab herself saying he needed it more than her because he had a job to take care of

"I was deeply pained hearing this. There could be nothing more painful than this 'dharmsankat' (dilemma) before a father, mother, brother or sister-whether to have the vaccine or give it up for a younger member in the family," he said. Keiriwal said it was a matter of

relief that that the speed of coronavirus spread has significantly slowed down in Delhi but cautioned that it did not mean the threat was averted and emphasised on maintaining all the precautions.

In the past 24 hours, around 2,200 cases were reported and the positivity rate is 3.5 per cent, he said. PTI

Govt Asks Social Media Platforms To Remove Content Mentioning 'Indian Variant' Of Coronavirus



NEW DELHI: The government has asked social media companies to immediately remove any content on their platform which mentions or refers to the term 'Indian variant' of coronavirus, in a bid to curb spread of misinformation around COVID-19. Digital platforms said they have received the latest advisory.

On Friday, the IT ministry wrote to all social media platforms emphasising that the World Health Organisation (WHO) has not associated the term "Indian Variant" with the B.1.617 variant of the coronavirus in any of its reports.

A notice issued in this regard by the IT ministry states that a "false statement" is being circulated online that implies that an 'Indian variant' of coronavirus is spreading across the countries. The IT ministry said the matter has already been clarified by the Ministry of Health and Family Welfare on May 12, 2021

through a press statement. The social media platforms have been asked to "remove all the content that names, refers to, or implies 'Indian variant' of coronavirus from your platform immediately".

Previously, the Ministry of Electronics and Information Technology had issued advisories regarding curbing of false news/misinformation concerning coronavirus on social media platforms. India is one of the biggest markets for digital platforms like Google, Facebook, and Twitter. As per data cited by the government, recently, the country has 53 crore WhatsApp users, 44.8 crore YouTube users, 41 crore Facebook users, while 21 crore use Instagram and 1.75 crore are on Twitter.

Earlier this year, the government had introduced guidelines to curb the misuse of social media platforms. – PTI
