



Pandemic Affects Mental Health Of Children, Elderly: Expert

SRINAGAR: The coronavirus pandemic has affected mental health of the people due to isolation, restriction on movement, social gathering and idleness which has barred people from having normal social interaction and outdoor activities, a senior psychiatrist said Wednesday.

Dr Junaid Nabi, Assistant Professor, Department of Psychiatry, Government Medical College (GMC), Srinagar said that another reason which has affected mental health is fear, stigma and isolation period of Covid positive patients.

"The fear of catching infection and the later repercussions has taken maximum toll on sound minds", said the

Psychiatrist and added that it is essential to overcome the fear psychosis with a positive mind that "the pandemic phase is temporary and this shall pass too," Dr Junaid said.

Besides, he said, the stigma attached to covid-19 infection has also affected the mental health of patients.

While speaking about the behaviour of people towards coronavirus positive patients, the senior psychiatrist said that some people don't come to help infected patients and instead they run away from them. "This behaviour is absolutely wrong," he said, while calling for a compassionate attitude

towards patients to help them out of the disease. Dr Junaid also



Here's how the brain strengthens memories during sleep

ver a long period of time, researchers have been exploring the link between memories and sleep, and in a recent study, they found that the two activities in the brain, slow oscillations and sleep spindles, help keep the memories strong. While we sleep, the brain produces particular activation patterns. When two of these patterns gear into each other, previous experiences are reactivated. The stronger the reactivation, the clearer will be our recall of past events, a new study reveals.

Scientists have long known that slow oscillations (SOs) and sleep spindles - sudden half-second to two-second



bursts of oscillatory brain activity - play an important role in the formation and retention of new memories. But experts in the UK and Germany have discovered that the precise combination of SOs and sleep spindles is vital for opening windows during which memories are reactivated; helping to form and cement memories in the human brain. Researchers at the University of Birming-

ham and Ludwig-Maximilians-University Munich today published their findings in Nature Communications.

Co-author Dr Bernhard Staresina, from the University of Birmingham's School of Psychology, commented, "Our main means of strengthening memories while we sleep is the reactivation of previously learnt information, which allows us to solidify memories in neocortical long-term stores." "We have discovered an intricate interplay of brain activity - slow oscillations and sleep spindles - which create windows of opportunity enabling this reactivation," added Dr Staresina.

Co-author Dr Thomas Schreiner, from Ludwig-Maximilians-University, Munich, commented, "Memory reactivation is specifically bound to the presence of SO-spindle complexes. These results shed new light on the memory function of sleep in humans and emphasise the importance of orchestrated sleep rhythms in strengthening our powers of recall and orchestrating the creation of memories."

Before this study, evidence of the brain's capacity to reactivate memories during sleep was scarce, but the team devised novel tests where participants were snown information before taking a nap and closely monitored brain activity during non-rapid eye movement (NREM) sleep using EEG recording. Those taking part were then tested on their memory recall after waking up, allowing the researchers to link the extent of memory reactivation during sleep to memory performance. The results revealed reactivation of learning material during SO-spindle complexes, with the precision of SO-spindle coupling predicting how strongly the memory would be reactivated by the brain. This in turn predicted the level of memory consolidation across participants and the subsequent clarity of recall.

Storytelling reduces pain, stress in hospitalised children: Study

hew research has shown for the first time that storytelling is capable of providing physiological and emotional benefits to children in Intensive Care Units (ICUs). The study was published in the Proceedings of the National Academy

of Sciences, the official scientific journal of the National Academy of Sciences of the US. It was carried out by the D'Or In-

stitute for Research and Education (IDOR) and the Federal University of ABC (UFABC). The study was led by Guilherme Brockington, PhD, from UFABC, and Jorge Moll, MD, PhD, from IDOR.

"During storytelling, something happens that we call 'narrative transportation'. The child, through fantasy, can experience sensations and thoughts that transport him or her to another world, a place that is different from the hospital room and is, therefore, far from the aversive conditions of hospitalization,' affirmed Guilherme Brockington, PhD, and lead author of the study. Storytelling is an immemorial practice of humanity. Legends, religions, and social values have spanned millennia through orality and writing. The most current bestselling cinematographic scripts and novels captivate the audiences through the same mechanism: listening to a good story is moving from one reality to another.

This movement, driven by imagination, can create empathy for events and characters that fluctuate according to the interpretation of each individual. "Until now, the positive evidence for storytelling was based on 'common sense' and taken at face value, in which interacting with the child may distract, entertain and alleviate psychological suffering. But there was a lack of a solid scientific basis, especially with regard to underlying physiological mechanisms," explained Dr Moll.

Considering the psychological and biological processes that occur during, and after listening to a story, the study investigators came up with the idea of seeking scientific evidence for the effects of storytelling on critically hospitalized children. In total, 81 children were selected, aged between 2 and 7 years and with similar clinical conditions, such as respiratory problems caused by asthma, bronchitis, or pneumonia. The children were admitted to the ICU at Rede D'Or Sao Luiz Jabaquara Hospital, in Sao Paulo, Brazil, and were randomly divided into two groups: 41 of them participated in a group in which storytellers read children's stories for 25 to 30 minutes, while in a control group, 40 children were told riddles offered by the same professionals and during the same length of time. To compare the effects of the two interventions, saliva samples were collected from each participant before and after each session to analyze the oscillations of cortisol and oxytocin - hormones related to stress and empathy, respectively. In addition, the children took a subjective test to evaluate the level of pain they were feeling before and after participating in the activities. They also performed a free word association task by relating their im-



pressions about 7 cards illustrated with elements from the hospital context (Nurse, Doctor, Hospital, Medicine, Patient, Pain, and Book). The outcomes were positive for all groups, as both interventions reduced the level of cortisol and increased the production of oxytocin in all the children analyzed, while the sensation of pain and discomfort was also mitigated, according to the evaluation of the children themselves.

However, a significant difference was that the positive results of the children in the storytelling group were twice as good as those in the riddles group. These findings led the researchers to conclude that the narrative activity was substantially more effective.

"Another highlight of this study is that it was not performed in an artificial environment, but rather within the routine of the pediatric ICU. The storytelling was done individually; the child chose which story

would be told. Among the books offered, we chose titles available in ordinary bookstores and without a pre-defined emotional bias, so that the story would not influence the child's reaction so much after the activity," highlighted Dr Brockington. Even though storytelling was already being adopted in many children's hospitals, this is the first time we are presented with robust evidence of its physiological and psychological impacts. This contributes to seeing the activity as an effective and low-cost therapeutic method, which can make a great difference in the quality of life for children in intensive care units. "I consider this study to be one of the

most important I have participated in, due to its simplicity, rigor, and potential direct impact on practices in the hospital environment, aiming at the relief of human suffering. As it is a low-cost and highly safe intervention, it can potentially be implemented in the entire public system, once larger-scale studies verify its reproducibility and effectiveness. We intend to extend and replicate it in other settings and patient groups and to support volunteering dedicated to the noble activity of storytelling, now with more solid scientific evidence," pointed out Dr Moll.

The emotional impacts of storytelling were also revealed in the results of the free word association test, done at the end of each intervention. Children in the storytelling group reported more positive emotions than in the control group, when exposed to the Hospital, Nurse, and Doctor words.

For example, the children in the control group responded to the card with the drawing of a Hospital saying, "This is the place that people go when they are sick". Children in the storytelling group reported for the same card as: "this is the place that people go to get better."

For the illustrations of a nurse and a doctor, the same pattern was observed. Children in the control group remarked "This is the bad woman who comes to give me an injection", while those who were told the stories said phrases such as: "This is the woman who comes to heal me."

Although the research had the support of trained volunteer storytellers from the Brazilian non-profit association "Viva e Deixe Viver", the authors state that storytelling is an activity that can be equally practiced by parents and educators, thus providing space for children to participate in the choice of the book and to interact with the story.



KO VIEW Stalled back-channel?

t has been some time since there has been no talk of the back-channel dialogue between India and Pakistan. The reasons are obvious. Over the last two months India has been grappling with the worst crisis since independence in 1947. Thousands of people have died since the catastrophic second Covid-19 swept over the country. The daily caseload at one time rose over 4 lakh. This threw the country's healthcare facilities into a disarray. There were no beds and medical oxygen to accommodate the growing number of patients. The situation has hardly improved, even though there has been a conspicuous drop in the number of cases. The daily cases have shrunk to around two lakh now and there is hope that going forward there will be a further drop in the number.

This terrible situation consequently seems to have paused India's foreign policy engagements, or at least their public expression. As a result, the nascent re-engagement between India and Pakistan also has moved into the background. Though there has been some occasional noise about the secret contact between the two neighbours in Pakistan, New Delhi has been tight-lipped about it.

But with the Covid-19 situation seeming to be easing in India, one could expect the leadership in India to be more forthcoming about the ties with Pakistan. As and when that happens, the two countries are expected to announce more Confidence Building Measures to improve their relationship and may be take steps to institute a formal dialogue.

But as is apparent there are some reservations on both sides as for as conducting an open dialogue. The reasons for it are both historical and the recent. The relations between the two countries have plunged to their lowest low since New Delhi withdrew Article 370 on August 5, 2019. Until before dramatic re-affirmation of the ceasefire agreement in February, it appeared unthinkable that the two countries could come anywhere near to resumption of dialogue. But they have done it, even moving a few baby steps further towards a formal dialogue.

Now, both countries are putting onus on each other to take the first step towards resuming engagement. And what that step would be is still unknown. Islamabad had earlier made any re-engagement with India conditional to New Delhi reversing the August 5 move. But Pakistan seems to have given that up, so has New Delhi its insis-

One-state solution, the way forward in Palestine

The whole premise of the two-state solution is wrong, providing Israel the immunity to continue its ethnic cleansing

> or more than 50 years, well-intentioned and more cynical, local and external actors involved in the attempts to bring peace and reconciliation to historical Palestine have religiously adhered to the two-state solution as the only way forward. The idea of partitioning Pales-

tine between the settler movement of Zionism, and later the state of Israel and the indigenous population of Palestine is not new. It was first offered by the British in 1937 and rejected by the Palestinians already then. The Zionist movement was hardly 50 years old and was already offered by the new British occupiers of Palestine, a chunk of the Palestinian homeland as a future state. This in the 1930s and 1940s would have been akin to an offer to decolonise India by partitioning it between a British India and local India or to propose the decolonisation of Algeria by dividing it between a French Algeria and a local Algeria. Neither the Indian anti-colonial movement nor the Algerian one would have ever consented to such a post-colonial arrangement; nor did the British and French dare to offer it when they reconciled with the fact that they will have to leave their colonial empires and go back to Europe.

Catastrophic Event

But even when decolonisation was achieved in India in 1947, not only the British but also the socalled civilised world through the United Nations insisted that the Palestinians should give half of their homeland to the settler movement of Zionism. The Palestinians attempted to convince the international community that the problem was not only about dispensing with half of their homeland but that the settler movement of Zionism would not be content with just half of the country and intended to take as much of it as possible and leave in it as few Palestinians as possible. This ominous prediction turned out to be chillingly accurate and true in less than a year after the UN insisted that partition was the only solution for Palestine. Under the guise of UN support, the new Jewish state took over nearly 80% of historical Palestine and ethni cally cleansed almost a million Palestinians (more than half of Palestine's population), and in the way demolished half of Palestine's villages and most of its towns in nine months in 1948; an event known by the Palestinians as the Nakba, the catastrophe.

Imposing military rule in the West Bank and the Gaza Strip after they were occupied was another means which enclaved the people there without basic human and civil rights. Imposing a version of an Apartheid regime on the Palestinian minority in Israel is another method and the constant refusal to allow the 1948 refugees to return completes the matrix of power that allows Israel to retain the land and disregard a demographic reality by which the Jews are not the majority in historical Palestine.

It is Israel that Decides

The two-state solution, offered for the first time by liberal Zionists and the United States in the 1980s, is seen by some Palestinians as the best way of ending of the occupation of the West Bank and at least the partial fulfilment of the Palestinian right for self-determination and independence. This is why the Palestine Liberation Organization was willing to give it a go in 1993, by signing the Oslo Accords. But the Palestinian position has no impact in the current balance of power. What mattered is how Israel interprets the idea and the fact that there is no one in the world that could challenge its interpretation.

The Israeli interpretation, until the rise of Benjamin Netanyahu to power in 2009, was that the twostate solution is another means of having the territories, the West Bank and the Gaza Strip, without incorporating most of the people living there. In order to ensure it, Israel partitioned the West Bank (which is 20% of historical Palestine) into a Jewish and an Arab part. This was in the second phase of the Oslo Accords, known as the Oslo II agreement of 1995. The Palestinians were forced to accept it under American and Egyptian pressure. One area, called area C, which consists of 60% of the West Bank) was directly ruled from 1995 until today by Israel. Under Mr. Netanyahu, Israel is in the process of officially annexing this area while at the same time ethnically cleansing the Palestinians living in it. The remaining 40% of the West Bank, areas A and B under Oslo II, were put under the Palestinian Authority which optimistically calls

a citizenship law, known as the nationality law, which made sure that the Palestinian citizens who live in Israel proper (which is Israel prior to the 1967 occupation of the West Bank and the Gaza Strip) and who are supposedly equal citizens of the Jewish state, will in essence become the "Africans" of a new Israeli Jewish apartheid state: living in a permanent regime that discriminates against them in all aspects of life on the basis of their nationality.

The endless negotiation on the two-state solution was based on the formula that once the two states become a reality, Israel will stop these severe violations of the Palestinian civil and human rights, wherever they are. But while the wait continued, more Palestinians were expelled and the Jewish settler community in the West Bank doubled and tripled and took over the fertile land, leaving no space for Palestinian expansion. The presence of more than 600,000 Jewish settlers, with a very high rate of natural growth, means that Israel will never consider moving them out; and without that, even a soft version of a two-state solution is impossible.

Decolonise, build a new state

The whole premise of the twostate solution is wrong and that is why it did not materialise. It is based on the assumption of parity and of framing the conflict as one fought between two national movements. But this is not a "conflict' as such. This is a settler colonial reality which began in the late 19th century and continues until today. The late scholar, Patrick Wolfe, described settler colonial movements as motivated by a logic he called "the elimination of the native" Sometimes it led to genocide, as it happened in North America, sometimes it translated to an ongoing ethnic cleansing operation, which is what has unfolded in Palestine. The two-state solution is not going to stop the ethnic cleansing; instead, talking about it provides Israel international immunity to continue it

The Arab World and the elusive two-state The only alternative is to decolonise historical Palestine. Which means that we should aspire to a state for all its citizens all over the country, based on the dismantlement of colonialist institutions, fair redistribution of the country's natural resources, compensation of the victims of the ethnic cleansing and allowing their repatriation. All this will be so that settlers and natives should together build a new state that is democratic, part of the Arab world and not against it, and an inspiration for the rest of the region which desperately needs such models to push it forward towards a better future.

tence on end to cross-border terrorism before talks begin.

Anyways if the last year's figures for infiltration and the killings of foreign militants in Kashmir are anything to go by, Islamabad has held back from supporting the local militancy. New Delhi, it seems, is unlikely to reverse the revocation of J&K autonomy. It remains to be seen whether it restores statehood anytime soon. A sustained, meaningful dialogue between the two countries has the potential to lead to a positive outcome. So, the neighbours should restore it sooner than later.

Baba in a Pandemic

n the battle against the novel coronavirus, governments must not only facilitate the adoption of scientific protocols but must also be seen to be following science unequivocally. Unfortunately, this cardinal principle of public health has not received its due from the Centre and some state governments. They have not always acted decisively against those spreading misinformation. Worse still, their failure to distance themselves from science deniers has sent out wrong signals to those waging a grim battle against a notoriously unpredictable contagion. Baba Ramdev, for instance, has sought to exploit mass anxiety by making inaccurate claims about products manufactured by his Ayurvedic pharmacy, Patanjali Ayurved. On most occasions, he has got away with a mildly worded censure. Union Health Minister Harsh Vardhan did come out strongly against the yoga guru last week after he disparaged the allopathic system as a "farce" and alleged that people had died because of allopathic medicines rather than oxygen shortage but Ramdev's own response to the public outrage against the statement on doctors was more a disclaimer than an apology.

In his propagation of yoga and indigenous cures, Ramdev may have much in common with the world view of the Sangh Parivar. But this association acquires ominous portents when key aspects of the government's response to the public health crisis bear its imprint. In February, Union ministers Harsh Vardhan and Nitin Gadkari shared the stage with Ramdev at the launch of Patanjali Ayurved's controversial Coronil care kit. And, less than a week after the yoga guru's outburst against allopathy, Haryana's BJP-led government made the Coronil kit a part of Covid care in the state — about a lakh such kits will be distributed amongst patients. Doctors and other healthcare professionals tirelessly battling the virus at the frontlines could do without such ill-judged policy. It's disturbing that a therapy with a nearly year-long history of dubious claims - from being touted as a cure for Covid to being held up as an immunity booster — has a state government's backing.

Incremental Cleansing

In 1967, Israel occupied the rest of historical Palestine, and in the process expelled another 300,000 Palestinians. Like all settler colonial projects, it had to navigate between a wish to take over indigenous territory while downsizing the number of native people living on it. It was impossible after 1948 to repeat a massive ethnic cleansing, so it was substituted by incremental ethnic cleansing (the last stage in this process was one of the root causes that ignited the cycle of violence last week — the proposed eviction of Palestinians from Shaykh [Sheikh] Jarrah, an East Jerusalem neighbourhood, as part of an overall attempt to Judaise East Jerusalem).

Incremental ethnic cleansing is not the only way of achieving the old Zionist goal to turning historical Palestine into a Jewish state. itself the state of Palestine, but in essence has no power whatsoever, unless the one given to it, and withdrawn from it, by Israel.

A Bantustanisation

The Gaza Strip was divided too. But the Jewish part was small and could not be defended from the local national movement's wrath. So, the settlers were taken out in 2005 and Israel hoped that another Bantustan, like the one in areas A and B, would be established there under the Palestinian Authority's rule and under the same conditions. But the people of Gaza opted to support a new player, Hamas, and its ally, the Islamic Jihad, which resisted this offer. They supported them not only because there was a return to religion in the face of the ongoing predicaments but also because there was big disappointment from the compliance of the PLO with the Oslo arrangements. Israel responded by imposing a callous siege and blockade on the Gaza Strip that, according to the UN, made it unliveable.

To complete its strategy that included the partition of the West Bank, its Bantustanisation, and the siege of Gaza, Israel passed in 2018

The Pursuit of Happiness

nderstandings of happiness are shifting. More and more research is finding that we cannot spend our way to happiness. Increasing incomes do not necessarily lead to increasing happiness. Even in a country such as China, average incomes have increased fourfold since the 1990s while life satisfaction has decreased over the same period.

Research is also finding that happiness is less an individual matter and more a collective endeavour. The quality of our relationships with others is pivotal. These others include those closest to us (our immediate family and friends) as well as those unknown to us but with whom we comprise a society.

In a climate-changing world, this relational understanding of happiness also has to extend to our relationship with the planet on which our survival depends.

Do you value independent, non-profit news?

The shift in understanding happiness could not be better summed up than in the words of the first elected prime minister of Bhutan in 2008:

We know that true abiding happiness cannot exist while others suffer, and comes only from serving others, living in harmony with nature, and realising our innate wisdom and the true and brilliant nature of our own minds.

In our research on economies for people and the environment, we have focused on our relationships with others. Thus, instead of happiness, we talk of "surviving well together". The idea of survival might seem too linked to material sufficiency, but for us it reframes our human-centred view of the world and locates humans as part of the web of life on Earth.

Surviving well together means taking into account not just our individual happiness and well-being but the happiness and well-being of others and the planet on which we live

Surviving well together means considering how we live our lives on multiple fronts.

The five elements of well-being

One starting point is our own wellbeing. Consistent with the research on happiness, well-being is not about mate-



rial wealth. In a comprehensive study of people in more than 150 countries, Tom Rath and Jim Harter found that there are five essential elements to well-being:

Well-being is about the combination of our love for what we do each day, the quality of our relationships, the security of our finances, the vibrancy of our physical health, and the pride we take in what we have contributed to our communities. Most importantly, it's about how these five elements interact.

This definition can help us think about what we do with our time. Are we using our time to cultivate all the elements of our well-being? Are we overworking to the detriment of our relationships, physical health and community contributions?

Downshifters are one group of people who take these questions seriously. They downsize their paid work to have more time for other kinds of "work" - for nurturing their relationships, communities, environments. Some sea changers or tree changers are likewise experimenting with ways of surviving

Surviving well is also a matter of together by ensuring that there are social supports for all – such affordable health care, education, public transport and housing reasonable working hours; and jobs that

well by moving to areas with cheaper housing and shorter commutes.

Not all of us have these options for surviving well (or what are sometimes disparagingly call "lifestyle choices"). Surviving well is also a matter of surviving well together by ensuring that there are social supports for all-such as decent and affordable health care, education, public transport and housing - safe working conditions and reasonable working hours; and jobs that are fairly paid.

With these conditions in place we can start to create societies in which all have an opportunity to achieve the five elements of well-being.

At the same time it is important that we do not forget what the late environmental philosopher Val Plumwood described as:

... the many unrecognised, shadow places that provide our material and ecological support.

As the climate crises deepens, the importance of attending to our ecological supports becomes all the more evident and pressing. Sadly, it all too often takes

We can take individual steps to care for our own well-being while insisting our governments provide social supports for all. So too, in an interconnected world, we can take individual steps to change our relationship with shadow places by considering what and how much we consume, while also pressuring governments and corporations and supporting the work of labour and environmental rights organisations.

Moving to an alternative sensibility

With the shift in understandings of happiness, various indicators and indices have been developed to more accurately reflect the well-being of nations. These include the Gross National Happiness measure devised and used by the Bhutanese government; the Genuine Progress Indicator adopted in the US by the states of Maryland in 2010 and Vermont in 2012; and the World Happiness Report, developed by the Sustainable Development Solutions Network for the United Nations.

In various ways these measures delink money from happiness and recognise that happiness is a collective rather than individual pursuit. Their downside is that they reduce the state of a nation to a single measure and lead to the inevitable ranking of nations. They have limited capacity to generate what the sociologist John Law calls "an alternative sensibility" that recognises the complexity of any given context.

We have been interested in the potential of what we call "relational metrics". These are tools such as a 24-hour clock, which people can use to track their use of time and evaluate whether it is being spent in ways that support or undermine their ability to survive well. Or the ecological footprint calculators, which people can use to assess the impact of their lives on the well-being of the planet. Or the Ethical Interconnection Checklist, which people can use to consider the shadow places that are part and parcel of how we survive well.

It is practical tools such as these that might help us shift from the pursuit of happiness to the pursuit of surviving well together.

Sarpanch, ChargingFamilies For ReleaseOf Kin, Arrested

SRINAGAR: A sarpanch was arrested on Wednesday for allegedly cheating two families and taking over Rs 1 lakh from them for securing the release of their kin who were taken for questioning by police in connection with a militancy case in Anantnag district of Jammu and Kashmir, officials said.

A police official said two suspects from Kokernag area of the south Kashmir district were called for questioning regarding a militancy crime. While they were being questioned to establish their involvement or otherwise, their families approached one Nisar Ahamd Khan of Kadipora to secure their release, he said.

In the meanwhile, the official said, the two individuals were not found involved or having any knowledge of circumstances that resulted in the commission of the crime. Accordingly, they were released.

But it was known that their families had paid money to

Khan who is a sarpanch of Gopalpora village, the official said. Khan had taken Rs 1,10,000 from the families promising the release of their kin, he added.

Khan had approached police and also sought appointment with a police officer for the same, but he was not allowed to meet the officer and instead conveyed on phone that the suspects will be sent home if not found involved, the official said.

Police have registered a case under section 420 of IPC against Khan and money paid to him has been recovered, he said, adding the sarpanch was arrested. The money recovered will be

handed over to families with due process and further investigation is going on, the official said.

He advised people to refrain from paying money to touts and unscrupulous elements and instead meet senior police officers in their respective areas for the redressal of their grievances.

Subodh Kumar Jaiswal Takes Over As 31St CBI Director

New Delhi: Senior IPS officer Subodh Kumar Jaiswal on Wednesday took over as the 31st director of the Central Bureau of Investigation (CBI), a post that was lying vacant since February, officials said.

The 58-year-old Maharashtra cadre Indian Police Service (IPS) officer joined duties in the 11th floor office of CBI headquarters in a low-key affair owing to the Covid pandemic, a day after the order for his appointment was issued by the Personnel Ministry.

He will have a two-year fixed tenure as the CBI chief. A former DGP of Maharashtra,

Jaiswal, had reportedly sought a central deputation last year after differences cropped up with the ruling Maharashtra Vikas Agadi government in the state over the transfers and postings of police officers.

He had joined the Central Industrial Security Force (CISF) as director general in January. As the CBI chief, one of the cases before him will be of his former boss and the then Maharashtra home minister Anil Deshmukh who is under probe for allegedly seeking illicit collections from bar and restaurant owners of Mumbai using police officers and favouring officers in postings and transfers.

Jaiswal who was on central deputation as additional secretary, Cabinet Secretariat, in the Research and Analysis Wing (RAW) was cherry picked to head the Mumbai Police force in 2018 during the Devendra Fadnavis government.

He was reluctantly relieved as RAW did not want to let go of an able officer like him who had spent 10 years from 2008 in the external snooping agency supervising sensitive operations. Besides his long stint at the RAW, the 'spy' has also served in the Special Protection Group, which guards the prime minister, for six years as AIG and DIG.

Starting as a rookie 23-year old IPS officer in the post of additional superintendent of police, Amravati, Maharashtra, he went on to conduct many antinaxal operations in Gadchiroli as superintendent of police.

In Maharashtra, he was incharge the Special Investigation Team (SIT); additional commissioner of police (ACP), Anti Terror Squad (ATS), Mumbai; ACP, Central Range, Mumbai; IGP Amravati Range and Commissioner of Police, Brihan Mumbai.

In his 35-year-long policing career, Jaiswal was in the thick of important cases in both overt and clandestine roles.

Jaiswal was at the helm of the probe in the Abdul Karim Telgi stamp paper scam as head of Maharashtra State Reserve Police Force in a court directed investigation, a case which was later taken over by the CBI.

He was also a part of the Mumbai ATS team that probed the 2006 Malegaon Bomb blasts case and later as DGP supervised probe into the Elgar Parishad and Bhima Koregaon cases in which several well known Left Wing intellectuals were arrested.

His experience in handling Left Wing Extremism prompted him as DGP to moot the idea of compulsory postings of IPS officers in naxal hot beds which reportedly did not find encouraging response from the Maharashtra government.

Maruti Suzuki to Install 2 Oxygen Plants in J&K

JAMMU:- Maruti Suzuki India Ltd (MSIL), the largest automobile manufacturer of the country has agreed to install two Oxygen PSA Generator Plants of 500 litres per minute capacity each in Jammu and Kashmir under Corporate Social Responsibility (CSR).

But the medic, who recently retired from the Ministry of Health Services in UAE, was not considered for the crisis-management role by the Directorate of Health Services Kashmir.

The denial prompted him to send a dispatch, with Grievance No 999002081796 generated from LG Portal, to Raj Bhavan.

"I don't have any grievance but a suggestion," Dr. Riyaz wrote in his letter to Lieutenant Governor, Manoj Sinha.

"In response to a call by the government seeking services of retired healthcare professionals interested in joining the efforts of the government to assist during this crisis time, I applied with the Director Health Services Kashmir Div. with the same intention," wrote the dialectologist, with MBBS from GMC, Srinagar and MSc Diabetes Medicine from the UK.

"But my services were not accepted and the reason given was that I have not retired from state health services. Being academically, professionally, physically, mentally and emotionally quite capable I wondered about the criteria of accepting services of a retired health care professional, albeit country of retirement."

Dr. Riyaz isn't alone volunteering for the frontline duty during the current health emergency. His colleagues who served in different parts of the world are equally enthusiastic about the service.

As one of the earliest trained medics at SKIMS Soura, Dr. Fayaz Khan from Bagaat Srinagar is equally looking forward to the Covid duty.

Apart from the community concern, his cause is fuelled by the loss of his family friend. "In this pandemic Llost someone very close expedite the efforts of Govt for more effective and efficient preparedness to tackle the current and forthcoming crisis." **Another Suspected**

The Jammu and Kashmir administration on Monday declared mucormycosis an epidemic, making it mandatory for all government and private health facilities and medical colleges to report suspected and confirmed cases to the health department through district-level officers and Integrated Disease Surveillance Program (IDSP). 19 others succumbed to the virus at various hospitals and healthcare facilities in the winter capital. With these deaths, the toll in J&K since the outbreak of pandemic last year reached 3702.

Regarding the fresh 3037 detected cases, the officials said that Jammu division reported 1089 while 1948 new cases were confirmed positive from Kashmir Valley thus taking the total number of cases to 278859. Giving district wise details, the officials said that Srinagar reported 493, Baramulla 260, Budgam 197, Pulwama 145, Kupwara 153, Anantnag 212, Bandipora 89, Ganderbal 219, Kulgam 117, Shopian 63, Jammu 445, Udhampur 83, Rajouri 126, Doda 91, Kathua 82, Samba 46, Kishtwar 35, Poonch 66, Ramban 99 and Reasi 16 new cases of Covid-19. Also, officials said, 4023 more patients have recovered-1770 from Jammu Division and 2253 from Kashmir. There are 43892 active positive case-17724 in Jammu and 26168 in Kashmir.

"Speed up the process of replacement of non-functional power infrastructure. Prioritize areas with more power consumption; put power curtailment schedules in public domain and address the issues of power outage in villages", he quoted the LG as saying.

He further said that directions were also passed to senior officials for monitoring of upgradation work of grid stations, strengthening of distribution mechanism, transmission lines, while concentrating on immediate needs of power supply, focusing on maintenance of transmission and distribution networks.

"The Lt Governor also directed the officers to take all necessary measures to reduce the transformers' damage rate, besides upgrading the infrastructure to reduce instances of disruption causing power outages," he added.

While taking the status of power supply to oxygen generation plants, Sinha, as per the official spokesperson directed the concerned officials to ensure uninterrupted power supply with backup to the oxygen plants.

"The Lt Governor further directed for making the response mechanism for power restoration prompt and more effective to ensure optimum power supply to every household in the summers," he said.

The official spokesperson further said that the LG took a detailed overview of the total Installed Transformation Capacities and peak demand met in Jammu Division during Summers 2020 and anticipated for Summer 2021.

"He further assessed the present status of category-wise power consumers, district-wise power demand & supply position in Jammu, buffer stock of distribution transformers, augmentation of receiving stations, procurement of spares & inventory, status of branch cutting/ trimming of trees," he said. entered India illegally through Bangladesh and took shelter in Jammu and other parts of the country.

According to government data, over 13,700 foreigners, including Rohingya Muslims and Bangladeshi nationals, are settled in Jammu and Samba districts of Jammu and Kashmir, where their population has increased by over 6,000 between 2008 and 2016. **Jammu First**

became the first district in Jammu and Kashmir to register over 1,000 deaths linked to the pandemic since its outbreak last year.

Jammu and Kashmir on Wednesday recorded 3,037 fresh COVID-19 cases that took its tally to 2,78,859 while 40 more fatalities pushed the death toll to 3,702, according to an official bulletin.

Jammu replaced Srinagar at the top of the Covid fatality chart among the 20 districts early this month, prompting the central government to rush a team of doctors to look into the alarming trend of high mortality among the positive patients in the province.

Jammu district is also heading the chart with 6,929 active cases in the union territory against 5,895 in summer capital Srinagar till Wednesday evening. There are a total of 43,892 positive cases in Jammu and Kashmir -- 26,168 in Kashmir division and 17,724 in Jammu division.

Among the new fatalities during the past 24 hours, Jammu district accounted for nine deaths, taking the district's tally to 1,003 followed by Srinagar at 751. So far, Jammu district had recorded 49,011 COVID-19 cases and Srinagar 63 448

families over time, in spirit of leaving no one behind.

"We have taken prompt and decisive action to support elderly, women and children. Our decision is about personal protection and mitigating vulnerability of families, which have lost their bread-earner by extending long-term assistance. The government's aim is to take care of their day-to-day lives and ensure financial security," the LG said, as per an official spokesperson.

"Our commitment to support vulnerable families is long-term. Therefore we are creating a special cell to track welfare of affected families. The pension and scholarship is only part of our assistance. Other part shall be extending all possible assistance through existing schemes and support for self employment. It is a comprehensive approach, aimed at overall support to empower these families," he added.

Apart from this, the scheme provides for scholarship of Rs 20,000 per annum for school going students and Rs 40,000 per annum for college going students. A family in distress shall be eligible for scholarship for two children, if they are not getting any other scholarship. The assistance is not limited to above. The Special Cell in the Social Welfare Department shall also explore further assistance under other existing schemes of the government for which the family may be eligible. An important element of support shall be financial assistance for self employment for any of the surviving members who wishes to start any business for livelihood support.

"The scheme announced today is in furtherance of the announcement of Lieutenant Governor regarding special assistance scheme

to me," the affable medic says.

"The poor man had struggled a lot in his life to educate his children and when he was supposed to get some relief, he became a victim of this deadly disease. He was the same guy who had shot an emotional appeal for his life on social media. If only given a chance to head a three-bedded centre, I would've saved the life of the poor soul."

Much of this confidence comes from the old schooling that Dr. Fayaz's tribe received from the veterans of the field.

"Since most of us are groomed by the likes of Dr AA Guru and other veterans, we're trained in tough medical procedures and can tackle any big health emergency," the retired surgeon told Kashmir Observer.

"But while my contemporaries understand that we're up against the invisible enemy, we can play generals for our young soldiers holding the fort right now. As someone who handled the healthcare institutions for difficult-tohandle Saudis, my tribe has an experience to deal with any health crisis."

But at the age group these doctors want to enroll themselves for the warlike situation demands a will of sorts.

"There's no question to join the pandemic duty without signing a will," Dr Fayaz says. "We understand that we may return in body bags, but we are up for it."

Mostly cooling their heels for the emergency duty right now, these medical volunteers with overseas experience exist in dozens in Kashmir valley. They say their professional insights can help restore some confidence in the region grappling with the Covid wave.

"Being a senior physician who has worked with multi-nationalities abroad, I can use my experience to deal with this Covid, which is a multi-organ affecting disease," says Dr. Mufti Azad from Srinagar.

Without boasting of miracles, the curtsounding medic says that if given a chance his tribe will be acting as per the book.

"But yes, at a time when young and inexperienced people are being tasked to handle this extraordinary situation, the experience of some of us can come in handy," he says.

Raising the same points in his letter to LG Sinha, Dr Riyaz wrote that many of these healthcare professionals are specialists in different fields of Medicine with tremendous experience at their back.

"I am sure it would be a prudent decision to seek their participation in a noble cause," the doctor wrote in his letter.

"I am sure reconsideration of recruitment criteria will definitely widen its scope and

LG Serves 8-Hour

Chairing a high level meeting to review the preparedness of Power Department for Jammu Division in view of the ongoing summer season, the LG stressed on speeding up the process of replacement of damaged transformers to avoid inconvenience to the people, an official spokesperson said. The LG, he said, fixed an 8 hour deadline for replacement of damaged transformers in urban areas, while rural areas will get transformers replaced within 48 hours.

"Adopt a futuristic approach, make procurements in advance and fix responsibilities for delays, besides taking corrective measures to provide consumers with the requisite facilities," Sinha said, as per an official spokesperson.

He said that the LG further emphasized on urgent re-examining of short-term and medium-term measures to minimize disruption in supply, network resilience, besides developing better synergy between officials at all levels.

During the meeting, which was attended by senior officers of Jammu Power Distribution Corporation Limited (JPDCL), and J&K Power Transmission Corporation Limited at Raj Bhavan, the LG passed various important directions to streamline the power transmission and distribution system in the UT.

The official spokesperson further said that in order to make the repair and replacement working more effective, the meeting decided that the transformers would get a Unique Identification number with details of installations and repairs. One month's timeline was fixed for preparing an online system for inventory management, executing a meter reading application for streamlining the process of power consumption, billing & collection.

He further said that the LG asked the concerned officers to rationalize the buffer stock of inventory in all districts in order to reduce the replacement time. During the meeting, he said, the LG also took stock of the implementation of directions passed earlier pertaining to strengthening of the Power sector in J&K.

drive at a holding centre in Kathua district of Jammu and Kashmir, officials said on Wednesday.

The drive was started on Monday and the internees were screened in batches but all those who returned positive are asymptomatic and were isolated within the holding centre as per the guidelines, the officials said.

A total of 53 Rohingyas were found positive during screening since Monday and all of them are asymptomatic. We are keeping a watch on their condition, Chief Medical Officer, Kathua, Ashok Chaudhary told PTI.

At least 220 Rohingyas, including women and children, are presently lodged in the holding centre after they were found living illegally in Jammu city during a verification drive in March.

The Jammu and Kashmir administration has already started the process of their deportation.

Fifty-eight eligible Rohingyas have already been inoculated in a vaccination drive on April 6, the officials said.

The Rohingyas are a Bengali-dialect speaking Muslim minority in Myanmar. Following persecution in their country, many of them Simugur 03, 110.

Chief Secretary B V R Subrahmanyam said the daily number of COVID-19 cases has reduced from an all-time high of 5,500 to 2,200 in the past two weeks. The same period also witnessed a reduction in the case positivity rate from 13 percent to 6.2 percent.

He, however, said more cases are now being reported from rural than urban areas and such cases are as high as 55 percent and 60 percent in Jammu and Kashmir divisions, respectively.

On May 1, Srinagar was leading the Covid fatality chart at 546, followed by 496 deaths in Jammu.

Jammu and Kashmir this month recorded 1,372 Covid-related deaths -- 865 in Jammu region and 507 in Kashmir valley. The valley is, however, ahead of the overall Covid fatality chart with 1,918 deaths compared to 1,784 deaths in Jammu province.

In the COVID-19 mortality chart in Kashmir, Srinagar is followed by Baramulla district at 248, Budgam (169), Pulwama (161), Anantnag (156), Kupwara (138), Kulgam (90), Bandipora (84), Ganderbal (67) and Shopian (54). In Jammu province, Jammu district is followed by Rajouri district at 163, Kathua (123), Udhampur (116), Samba (103), Doda (86), Poonch (76), Ramban (48), Reasi (35) and Kishtwar (31).

On May 17, the three-member central team of doctors deputed by the Union Health Ministry called for conducting genome study in Jammu, while observing that the high mortality here may be because of the double mutant Indian strain.

The team -- Deputy Director, National Centre for Disease Control (NCDC) Mahesh Waghmare; Joint Director, NCDC, Pranay Verma; and Professor, Internal Medicine, PGI Chandigarh, Navneet Sharma -- visited several Covid care facilities in Jammu and Samba districts.

Two days earlier, the Principal Government Medical College (GMC), Jammu, Shashi Sudhan Sharma said the B.1.617 variant was responsible for the surge in COVID-19 cases in the Jammu division.

In April, the percentage of UK variant dropped to 47 percent from 60 percent a month earlier and B.1.617 increased from 5.8 percent to 38 percent during the same period, Sharma said.

These two variants found circulating in the Union Territory of Jammu and Kashmir have UK and Western Coastal States as the sites where original virus mutated and their observed changed in frequency in UT is through epidemiological investigation, she had said.

The GMC Professor also urged people to follow SOPs properly and in a standard way and stressed on the idea that following SOPs doesn't mean to make your life miserable.

NEW DELHI: India's pace attack is on par with New Zealand's world class swing operators but the Black Caps batsman Henry Nicholls is more wary of the threat spinners Ravichandran Ashwin and Ravindra Jadeja may pose during the upcoming World Test Championship final.

India and New Zealand will fight it out for the inaugural title at Southampton's Ageas Bowl, one of those rare English tracks known to aid the slow bowlers for a considerable period in Test matches.

"India have a very good seam attack and also have the experienced spinners like Ashwin and Iadeia. They have been consistent in all parts of the world (of late) and bring quality (to attack)," Nicholls, who has been in good form of late in Test cricket, told PTI in an interview.

DUBAI: India skipper Virat Kohli and his deputy Rohit Sharma held on to their second and third positions respectively in the batting chart, while pacer Jasprit Bumrah remained static at number five in the bowling list of the latest ICC ODI player rankings issued on Wednesday.

Kohli and Sharma were sitting pretty with 857 and 825 points respectively in the batting list headed by Pakistan's Babar Azam with 865 points.

In bowling, Bumrah was at the 5th position with 690 points, while New Zealand's Trent Boult was atop with 737 points, followed by Bangladesh's Mehidy Hasan (725), Afghanistan's Mujeeb Ur Rahman (708) and Kiwi pacer Matt Henry (691).

Bangladesh off-spinner Hasan became only the third bowler from his country to be ranked among the top two after a fine showing in the first two matches of their ongoing World Cup Super League series against Sri Lanka.

Hasan has advanced three places to reach the second position after returning figures of four for 30 and three for 28 bowling with the new ball.

All-rounder Shakib Al Hasan had grabbed the number one position in 2009 for the first time, while leftarm spinner Abdur Razzak is the other Bangladesh bowler to have been in the top two, reaching the second position in 2010.

Left-arm fast bowler Mustafizur Rehman is another one from Bangladesh to move up the list, his hauls of three for 34 and three for 16 lifting him eight places to ninth position.

KARACHI: Controversial Pakistan batsman Umar Akmal has paid a hefty fine of 4.5 million rupees to PCB, which now entitles him to join Anti-Corruption rehabilitation program of the board.

A source in the PCB confirmed that Akmal had deposited the fine imposed on him by the Court of Arbitration for Sports (CAS) in February while disposing off cases filed by the batsman and the PCB.

"Umar has deposited the full amount of 4.5 million rupees with the board which means he is now eligible to start the rehab program of the Anti-Corruption code of the board," the source said.

"But practically it will take some time before Akmal can resume his cricket career as his rehab program will take some time since the anticorruption unit of the PCB is presently busy with the Pakistan Super League matches to be held in Abu Dhabi next month," the source said.

Earlier the board had rejected Akmal's request that he be allowed to pay a 4.5 million rupees fine in instalments to pave the way for him to return to cricket after serving a ban since February 2020 for breaching clauses of the Anti-Cor-

Akmal had pleaded with the board in an application that due to the imposed ban, he was not in a financially strong position and be allowed to pay the fine instalments.

But the PCB rejected Umar's request and directed him to pay the full fine or he would not be able to start his rehabilitation program as per the Anti-Corruption code.

Akmal, who will turn 31 this month, has not played for Pakistan since November, 2019 when he last appeared in a T20 series at Lahore against Sri Lanka while his last Test appearance for his country was way back in late 2011 while his last ODI series was in March-April 2019 against Australia

Even elder brother Kamran had offered to pay the fine to the PCB. Earlier CAS had reduced an 18-month ban on Akmal to 12 months for breaching the PCB's

Anti-Corruption code but hit him with the fine. The Lausanne-based body had disposed of the appeals of both PCB and Akmal in February.

Since Umar had already served the 12-month ban as he was suspended from February 2020 he was eligible to return to cricket after paying the fine.
