he district authorities in Budgam on Friday ordered suspension of a senior wildlife department officer following massive public outrage and anger triggered by the killing of a minor girl by leopards. Deputy Commissioner (DC) Budgam, Shahbaz Ahmed Mirza ordered immediate suspension of Suhail Qazi, Range officer, Wildlife Department Ompora for dereliction of duties. Mirza also ordered a detailed enquiry to be conducted by additional deputy commissioner (ADC) Budgam into the matter.

Earlier DC Budgam and SSP Budgam Tahir Saleem convened a meeting with Wildlife and Forest authorities in which several decisions were taken, an official spokesperson said. The meeting decided that wildlife Warden Budgam will deploy staff well equipped with machinery for elimination of the wild animal which has turned man-eater after obtaining sanctions from the competent authority. Pak Ready For Talks With India If **Given Kashmir Roadmap: Imran**

ISLAMABAD: Prime Minister Imran Khan said on Friday that Pakistan is ready to restart talks with India if Delhi provides a roadmap toward restoring the previous status of Jammu and Kashmir.

The two nuclear-armed neighbors both control parts of Kashmir but claim it in full. In 2019, India withdrew Indian-ruled Kashmir's autonomy in order to tighten its grip over the territory, sparking outrage in Pakistan, the downgrading of diplomatic ties and a suspension of bilateral trade. "If there is a roadmap, then, yes,

we will talk," Khan told Reuters at his official residence in Islamabad. Previously, Khan and his government have held that India would have to first reverse its 2019 steps for any normalization process to begin.

"Even if they give us a roadmap, these are the steps that we will take to basically undo what they did, which is illegal, against international law and United Nations resolutions... then that is acceptable," Khan said.

"In view of the above, the concerned Chief Education Officers are once again instructed to ensure implementation/ strict adherence of the orders issued from time to time in letter and spirit and also get the complaints lodged against the Private schools, redressed in the Special Cells constituted for redressal of grievances of the complainant in the time bound manner," the order said.

The separatists have also said that they do not expect much from their visit, he added.

In First For Israel, Arab **Party On Road To Joining Coalition Government**

JERUSALEM: A party represent-ing Arab citizens of Israel has for the first time joined an Israeli coalition to form a government, but many doubt the move can end decades of political marginalisation.

Arab Israeli Mansour Abbas, the head of the conservative Islamic Raam party, on Wednesday signed onto an eleventh-hour deal hoping to oust the country's longest-serving premier, Benjamin Netanyahu. An image of the lawmaker of

Palestinian descent at a table with centrist Yair Lapid and right-wing nationalist Naftali Bennett, all three grinning, captured a historic moment and circulated widely on social media. Abbas, a member of the Knesset legislature since 2019, was jubilant on Israel's army radio

on Thursday morning. "We obtained the legitimacy to influence the Israeli political system and not just to be present there in the Knesset," he said. "It opens a wide door for us to

influence policies and decisions for the benefit of all citizens of the state and especially Arab citizens." In 1992, when a peace process was underway with the Palestinians, Arab Israeli lawmakers backed a Labour coali-

NEW YORK: United Airlines announced plans Thursday to buy 15 planes from airline startup Boom Supersonic in a move that could revive the high-speed form of air travel after the Concorde was wound down in 2003.

Under the commercial agree-Boom's "Overture" aircraft once the planes meet "United's demanding safety, operating and sustainability requirements" with an aim to start passenger travel in 2029, the companies said in a joint press release.

The announcement represents a potential comeback to a once heavily-touted method of travel, although some analysts expressed skepticism, particularly over the relatively speedy timeframe.

No Evidence Mystery UFOs Are Alien Spacecraft: Report

UNITED STATES: There is no evidence that unexplained aerial phenomena spotted in recent years by US military personnel are aliens, an upcoming government report quoted by The New York Times Thursday said, but officials still can't explain the mysterious aircraft.

The newspaper, which cited senior administration officials briefed on the findings of the highly anticipated report, said they were able to confirm the unusual vessels were not the product impossible to rule out. of secret Pentagon technology.

But the review of more than 120 incidents over the past two military officials increasingly decades was unable to explain worry the phenomena could be the mysterious movements of the China or Russia experimenting

The Pentagon last year released videos taken by US Navy pilots showing in-flight encounters with the unusual aircraft.

And the mystery was further drummed up by former officials with access to classified intelligence.

"What is true -- and I'm actually being serious here -- is that there's footage and records of objects in the skies that we don't know exactly what they are," former president Barack Obama told "The Late Late Show" last month.

JAMMU: Consultant Nephrologist, Super Specialty Hospital Jammu, Dr Raju K Bhandari, has assured that all kinds of Covid vaccine are safe for kidney patients, including those having undergone recent renal transplant.

Dr Bhandari said, "Patients on steroids can take vaccines only once their dosage is below 20 mg levels. Those having been administered with Rituximab must wait for 6 months before getting vaccinated. Renal transplant patients can be administered the vaccine after 6 months post the operation." Highlighting the risks involving kidney patients, Dr Bhandari disclosed, "At least 30 percent

The pandemic has disrupted our lives in several ways. One sector which has been one of the hardest hit is the education sector. With the anticipation that the third wave is going to target children as most of the adult population has already been infected, the possibility of reopening of schools seems to be out of the question.

The impact of the closure of schools for such a prolonged period has been tremendous. There has been an uptick in mental health issues among children because of the uncertainty induced by the pandemic. The suspension of physical classes has not only taken a blow at student's education but also their physical, emotional, and mental well being.

In the case of children belonging to the marginalized sections, they have also faced nutritional inadequacies because of the non-availability of mid-day meals. This section of our society has suffered disproportionately. Lack of adequate resources and internet facilities has inhibited them from continuing their education. According to an India sped report, only 15% of rural households have access to internet facilities and this figure drops down further in the case of Dalits, Adivasis, Muslims, and women. Their education has taken a nosedive but this isn't their only concern, they have more pressing issues to deal with.

The pandemic has not only brought their education to a standstill but has also posed a threat to their lives. A UNESCO report states that children belonging to marginalized families are at an increased risk of infection due to the lack of access to water and soap and the impossibility of physical distancing. The economic hit back suffered by the marginalized section has brought a change in their priorities, their primary concern during these desperate times is to sustain themselves, and they're doing everything in their capacity to make ends meet. A Brut India report showed that many children, children as young as 4 are being pushed into child labor and child trafficking by their parents to bring food to the table. The report reveals that children are being pushed into sexual labor for something as basic as 2kg of atta/flour. This tells us a lot about the plight of the impoverished in our country. The government has several policies in place to address the needs of the marginalized sections but the stories that are emerging on social media show that there has been a failure of the execution of these wellintended policies.

AMBRIDGE - A century ago, an influenza pandemic killed more people than died in World War I. Today, the COVID-19 pandemic has killed more Americans than died in all US wars since 1945. A big difference, however, is that science did not have a vaccine for the influenza virus back then, but now several companies and countries have created vaccines for COVID-19.

A number of wealthy democracies, including the United States and the United Kingdom, have vaccinated over half their adult populations and seen a dramatic reduction in the number of new cases and deaths. Other places, such as India, Brazil, and parts of Africa, have low vaccination rates and high rates of new cases and deaths. The Economist estimates that the pandemic's true global death toll may be something like ten million people, or more than three times the official number reported by national authorities

Given these grim statistics, should leaders of wealthy countries export vaccines and help vaccinate foreigners before they finish the job at home? When former President Donald Trump proclaimed "America First," he was being consistent with democratic theory, according to which leaders are entrusted with defending and advancing the interests of the people who elected them. But as I argue in my book Do Morals Matter? the key question is how leaders define the national interest. There is a major moral difference between a myopic transactional definition, like that of Trump, and a broader, far-sighted definition.

Consider President Harry Truman's espousal of the Marshall Plan after World War II. Rather than narrowly insisting that America's European allies repay their war loans, as the US had demanded after World War I, Truman dedicated more than 2% of America's GDP to aiding Europe's economic recovery. The process allowed Europeans to share in planning the continent's reconstruction and produced a result that was good for them, but that also served

America's national interest in preventing Communist control of Western Europe.

There are four major reasons why a Marshall Plan-like effort to vaccinate people in poor countries is in the US national interest. First, it is in Americans' medical interest. Viruses do not care about the nationality of the humans they kill. They simply seek a host to allow them to reproduce, and large populations of unvaccinated humans allow them to mutate and evolve new variants which can evade the protections that our vaccines produce. Given modern travel, it is only a matter of time before variants cross national borders. If a new variant arose that was capable of by-passing our best vaccines, we would have to develop a booster targeted at the new variant and vaccinate again, which could lead to more fatalities and more strain on the US medical system, as well as lockdowns and economic damage.

Our values provide the second reason that a vaccine Marshall Plan is in America's national interest. Some foreign policy experts contrast values with interests, but that is a false dichotomy. Our values are among our most important interests, because they tell us who we are as a people. Like most people, Americans care more about their co-nationals than foreigners, but that does not mean they are indifferent to the suffering of others. Few would ignore a cry for help from a drowning person because she calls out in a foreign language. And while leaders are constrained by public opinion in a democracy, they often have considerable leeway to shape policy - and considerable

resources to influence public sentiment.

A third national interest, related to the second, is soft power - the ability to influence others through attraction rather than coercion or payment. American values can be a source of soft power when others

see our policies as benign and legitimate.

Most foreign policies combine hard and soft power. The Marshall Plan, for example, relied on hard economic resources and payments, but it also created a reputation for benignity and far-sightedness that attracted Europeans. As the Norwegian political scientist Geir Lundestad has argued, the American role in postwar Europe may have resembled an empire, but it was "an empire by invitation." A policy of helping poor countries by providing vaccines, as well as aiding the development of their own health-care systems' capacities, would increase US soft power.

Finally, there is geopolitical competition. China quickly recognized that its soft power suffered from the origin story of COVID-19 in Wuhan. Not only was there lack of clarity about how the virus originated, but in the early stages of the crisis, Chinese censorship and denial made the crisis worse than necessary before its authoritarian lockdown proved successful. Since then, China has assiduously pursued COVID-19 diplomacy in many parts of the world.

By donating medical equipment and vaccines to other countries, China has been working to change the international narrative from one of fault to one of attraction. The Biden administration has been playing catch-up, announcing that it will release 60 million doses of AstraZeneca vaccine, as well as 20 million additional dozes of Pfizer, Moderna, and Johnson & Johnson vaccines. In addition, the administration has pledged \$4 billion in funding for the World Health Organization's COVAX facility to help poor countries purchase vaccines and supports a temporary waiver of intellectual property to help poor countries develop capacity.

In short, for four good reasons consistent with America's history, values, and self-interest, the US should lead a group of rich countries in a plan to vaccinate the rest of the world now, even before the job is finished at home.

Kashmir's Spiritual Glory Prophesied In Lahore - Part 1

⁴ Shawwal, the 10th month of Islamic [Hijri] calendar, is the death anniversary of Sayyid Mirak Shah Kashani of Shalimar, the 20th century's most revered spiritual personality of Kashmir. It was on this day in 1391 Hijri (13 December 1971) - three days before the Indo-Pak War ended - that he breathed his last at the age of 76 following a brief illness. His demise was widely mourned in Kashmir and outside. Grieving people attended his funeral amidst cold weather, ongoing Indo-Pak war and dogfights in Srinagar's skies. He was buried beside the graves of his predecessors, Hadrat Abdul Qudoos and Hadrat Laal Shah Sahib. Those blessed few who had the honour of lowering his body in the grave included a 21-year old college student, Mohammad Ismail Bhat. On the day of Sayyid Mirak Shah's fateha or the congregational prayer meeting, a large number of mourners had assembled at his grave. They were ad dressed, among others, by politician Molvi Mohammad Sayeed Masoodi and Mirwaiz Molvi Mohammad Farooq.

Strangely, a day before Sayyid Mirak Shah Kashani's demise, a majzoob (absorbed ascetic), Kamal Kuchhay (also Kamal Sahib), had predicted his departure from the mortal world. Poet Mirza Arif Beg, as he had told my maternal uncle, was with Kucchay at Maisuma when he informed the ascetic, "Haekim hez draav" [The ruler has left], referring to the death of Chief Minister G. M Sadiq who had died at the Postgraduate Institute of Medical Sciences, Chandigarh that day (12 December). Kamal Sahib shot back, "Yi kusu haekim gov. Haekim ha neri pagah" [He was no ruler. The real ruler will leave tomorrow]. Mirak Saeb or Sahib, as he was fondly called, had ascended the gaddi (seat) following the demise of his murshid (spiritual anchor), Hadrat Abdul Qudoos, on 9 Zilqadah 1342 (1922 AD). He graced the Darbar-i-Kashania, as his Seat is now known, for 49 years. This year, on 9 Zilgadah, a fortnight from now, will be marked the 100th anniversary of his ascent to the Spiritual Throne at Shalimar. A very historic moment, indeed! Although he himself was from the Qadri silsila (order), he imparted teaching and spiritual practices in five orders of mysticism including Naqshbandi, Kubravi, Suharwardi, Qadri, and Chisti. Hundreds of them have profited from his guidance. Fakir-i-Millat or the Nation's Ascetic as he was reverentially addressed, Sayyid Mirak Shah Kashani's ancestor, Sayyid Habibullah Kashani, had migrated from Kashan, a city in Isfahan province of Iran. Mirak Sahib was born to Sayyid Ahmad Shah Naqash of Saraf Kadal, a quarter of old Srinagar city, on 6 September 1895. According to his genealogy published by the Darbar-i-Kashania, Mirak Sahib was a descendent of Hadrat Ali (May Allah be pleased with him), the 4th Caliph of Islam and son-in-law of the Glorious Prophet (peace be upon him). Between the two, there was a chain of 36 generations. As Mirak Sahib told Ved Mehta in 1966, his spiritual lineage, passing through Mir Sayyid Ali Hamdani, also connected him to Hadrat Ali (May Allah be pleased with him) and, eventually, to Prophet Muhammad (peace be upon him). He was orphaned in infancy. His mother died when he was only two years old. Three years later, his father also passed away. Brought up by his brothers, he did not have any formal education beyond initiation in Qur'an. Hadith (sayings of Prophet Muhammad, peace be upon him) and some Persian literature like Sheikh Sadi's Gulistan Bostan at the Ame Kaluin Madrassa (Ama Kaloo's Seminary) in the city. When his brothers insisted on his having further education he refused and began spending his time in the company of fakirs, majzoobs and galandars. He also started calligraphy of Qur'anic verses for raising some money to feed his companions. Mirak Sahib's childhood mate and a neighbor at Saraf Kadal, Late Abdul Ahad Wani, once recalled that as children they would regularly go to the Jhelum to take a bath. While the rest of the children would not take much time young Mirak Shah remained in water for long, meditating. One day, as the children had a dip in the river others came out soon but not Mirak Shah. The children were shocked, waited for some time for him to reappear but as he did not, they returned to their homes without telling anybody about the incident. Next day, pleasantly amazed, they found him with them and ready for a bath. From a very young age, he was a seeker of truth and enlightenment and, ultimately, attained a high spiritual place, arguably the highest among his contemporaries. In an interview with poet and broadcaster Ghulam Rasool Nazki recorded for the Radio Kashmir on 7 June 1967, Mirak Sahib narrated his initiation into the world of spirituality [translation]: "At the age of 10, I was drawn to the path of Allah. Molvi Mohiuddin Khan of Nihalpora was my first pir in the Naqshbandi silsila (order). Around that time, my brother had a dream in which he saw me dead. It was announced there that Ghausal Azam (title of Sheikh Abdul Qadir Jeelani meaning great help or relief) will himself bathe the body. In a moment, accompanied by four persons and riding a horse, he arrived and took his position in the room as his four companions bathed my body, wrapped it in a shroud and took it away. This was the day when Ama Sahib [Molvi Ahmadullah Shah] had succeeded [as the Mirwaiz of Kashmir] Molvi Rasool Shah. My brother went to him for interpretation of the dream. He told him that you were from the Nashbandi silsila and he was now taken by Mehboob-e-Subhani [another title of Sheikh Abdul Qadir Jeelani meaning loved by Allah, the founder of the Qadri silsila]"

Mirak Sahib's ascendency to spiritual heights was prophesied by Hadrat Fazlullah Shah Gardezi of Lahore before his birth. Gardezi was the spiritual guide of Hadrat Laal Shah Sahib. When he enthroned him and granted him permission to return to Kashmir, he told him, "The vilayat (spiritual charge) is transferred to you by a Sayyid [Gardezi] and this amanat (trust) has to reach another Sayyid whose name will be Sayyid Mirak Shah. He will be a progeny of Sayyid Habibullah Kashani. He will be born during your time but your successor will find him out." On his return, Laal Shah Sahib kept on changing his abodes till he arrived at Shalimar where he founded Takia Laal Shah Sahib which is now known as Darbar-e-Kashania after Sayyid Mirak Shah Kashani. Laal Shah Sahib passed away on 12 Rabiut Thani 1306 Hijri and was succeeded by Hadrat Abdul Qudoos Mir or Qud Sahib who was from Shalimar. On divine hint, Qud Sahib located Mirak Sahib, who had been born 12 years ago and brought him into his circle of spirituality. Meanwhile, Mirak Sahib continued his tryst with the Truth, detaching himself from worldly affairs, sharing love and serving the needy. His brothers were worried for him and put him on the family vocation of nagashi (printing of shawls). Soon, he got rid of this avocation. Now, the family thought of getting him married to bring him back to normal life. He was married and soon was blessed with a daughter.

The marriage, however, did not withdraw him from his path. He remained mostly away from home, wandering from ace to place. His elder brother admonished him for neglect ing his wife and child. The reprimand saddened him and caused tears in his eyes. He prayed to Allah to bring him out of the dilemma. During the night, his brother informed him about the sudden death of his daughter. As tears rolled down his cheeks, he prostrated and accepted the incident as the will of Allah. Meanwhile, his absence from home forced his brothers to consider divorce of the couple so that the noble lady, who suffered but never complained, could start a new life. After divorce, Mirak Sahib continued with his wanderings and once spent about 10 months in the woods of Chra-i-Sharief with an ascetic named Ahad Sahib who eventually asked him to return to the city because Sheikh Abdul Qadir Jeelani (May Allah's blessings be with him), in a vision, had ordered him to set him free, for he was not meant to stay in a forest but serve the people Mirak Sahib returned to Srinagar where he presented himself before Hadrat Qud Sahib at Shalimar who, eventually, made him his spiritual successor. Thus the amanat that Hadrat Fazlullah Shah Gardezi had transferred as a trust to Hadrat Laal Shah Sahib was finally delivered to Sayyid Mirak Shah Kashani. He ascended the gaddi at the age of 27 on the death of Hadrat Qud Sahib. Soon thereafter, his Seat attracted in hordes people in search of truth and ultimate reality or who sought healing to their spiritual or physical ailments. The visitors came from all faiths and from different places, the largest number being from the local Muslim community. There were Kashmiri Pandits, Sikhs and people from other states, and even countries, who sought his au-

blessand ings. His teachings were strictly in accordance with the Shariah and laid much emphasis on the first of the five fundamentals of Islam, namaz. When a Muslim visitor would inform him about what troubled him or her he invariably asked if he or she was punctual with namaz. "Namaz gatchi parein. Tche ti mang Khodayas bati mangas" [You must offer namaz. You pray to Allah and I will also pray for you], he would advise him or her. Several people came with varying issues like promotion or transfer, infertility and domestic discords. He told an interviewer that most of the people come to him with mundane issues and there were only a few who sought spiritual enlightenment. However, he would keenly listen to all. Once, a person complained that his cow was not giving enough milk. A person laughed at him which Mirak Sahib did not like. He told that person, "Piras wani ni teli kemis wani. Pir gov su yas yiti aasi pata zi muridas keatch tchheyi tuil chi pashas" [Who else will a murid tell his problem if not to his pir [spiritual guide]? A pir is one who knows how many hay-straws his murid's cottage roof is made of.1

Among the visitors were rich and poor - common people, businessmen, shopkeepers, government employees and housewives. Prominent political leader and former Prime Minister, Sheikh Mohammad Abdullah, was one among them. When Abdullah, as the President Muslim Auqaf Trust, decided to reconstruct the Hazratbal Shrine in late sixties he first visited Shalimar to seek Mirak Sahib's approval who, later, laid the foundation stone of the new building on 12 November 1969. Besides the Hazratbal Shrine and his own mosque at Shalimar, he laid foundation of several mosques including the Zindshah Masjid at Rainawari on 14 July 1961 and another at Sekidafar, Safa Kadal where Sayyid Qasim Shah Bukhari, religious scholar and founder of the Anjuman-e-Tableegul Islam, led Friday prayers. The Anjuman journal, Al-Tableeg, was published under his patronage. He would also organize annual Milad function at the famous Shalimar Garden to commemorate the birth of Prophet Muhammad (peace be upon him) where prominent religious scholars were invited. On this occasion, special dishes were cooked in the langar (kitchen). He also founded a darasgah (school) at Shalimar where children were imparted education in Qur'an and Hadith. Deen Mohammad, his spiritual successor, was one of the students. It is said that when he had his first lesson in Qur'an, Mirak Sahib was so happy that he himself served qahwa to the guests. Later, the school was upgraded to a high school during the time of Fakir Deen Mohammad. Kashmir was under an autocratic and oppressive rule when Sayyid Mirak Shah Kashani ascended the Spiritual Seat. Economically crushed, the people were deprived of all civil, political and human rights. Mirak Sahib could not remain unaffected by the situation and actively supported their movement against autocracy. He took part in processions and public meetings. In 1931, when about 60,000 people armed with axes, spears, lances and match-lock rifles gathered at Khanyar in a show-down with the oppressive regime, he came out of his Abode, mounted his horse with a naked sword in his hand and marched ahead of a large procession. On 31 December 1963, he arrived at the Jama Masjid Srinagar along with thousands of his supporters to attend a massive demonstration to protest the mysterious disappearance of the Holy Relic from the Hazratbal Shrine. In later years also, he was in touch with developments in Kashmir. Once he asked his disciple, Abdus Samad Khan, about what was going on in the Valley. He informed him that people were confused and concerned about their future because of the often changing political stand of Sheikh Mohammad Abdullah, who had been released from jail and was now speaking in different languages. This disappointed Mirak Sahab and the disappointment showed on his face. At that time, Abdullah arrived there and, reading Mirak Sahib's face, asked him what the reason was. He told him to ask from Khan who found himself in a difficult situation of confronting a mass leader. However, in the presence of his murshid he summoned courage and told Abdullah that his changing stand was bothering and letting people down. Abdullah tried to explain that a leader had to plan according to the prevailing situation and might even temporarily order retreat of his troops to win a larger battle. Mirak Sahib asked Khan if he was convinced. He was not but kept quiet.

Newer methods may boost gene therapy's use for more diseases

ordan Janz knew his gamble on an experimental gene therapy for his rare disease might be paying off when he returned to work and a friend sniffed him.

"He said, 'you have a normal smell, you smell good," Janz recalled. "And I'm like, 'that's probably the nicest thing you've ever said.""

The 22-year-old Canadian man's previous treatment required 40 to 60 pills a day and left him smelling like rotten eggs or stinky cheese. He was born with a flawed gene that left him unable to make a protein needed by virtually every organ in the body. Kids with this disease can throw up a dozen times a day, need eye drops every hour to prevent blindness and often kidney transplants before they're adults.

Now, Janz and a growing number of others with rare diseases have hope of not just better treatments, but perhaps a cure. Gene therapy increasingly is being used to attack the root cause of their problems by supplying the DNA they lack.

Janz was the first person in one such study at the University of California, San Diego. He and two other participants no longer need the eye drops and pills that only delayed progression of their disease and left them smelling bad. The company that developed their therapy is testing it for several other diseases by simply adjusting what gene is supplied.

Other companies are doing the same, and U.S. health officials are working on guidance to encourage the trend.

"I am very excited for the field because I feel like we're beginning to get to a critical mass," where a single method or product can be deemed safe and then adapted for many uses, said Dr. Peter Marks, head of the U.S. Food and Drug Administration center that oversees gene therapies. "You're essentially using the same rocket ship to put stuff into space dozens of times.

NOT SO RARE DISEASES

In the United States, a disease is considered rare if it affects fewer than 200,000 people, said Ron Bartek, a board member of the National Organization for Rare Disorders and whose son, Keith, died of one -- Friedreich ataxia, a progressive neurological condition.

There are more than 7,000 rare diseases and collectively, they're not so rare -- about 30 million Americans have one.

Seven gene therapies are approved in the United States and a few more are sold in Europe or elsewhere. In 2017, when the first ones were OK'd in the U.S., 854 companies were developing them. That grew to 1,085 by the end of last year, according to the Alliance for Regenerative Medicine, an advocacy group for the field. More than 400 gene therapy trials are underway now.

"It's really been an exciting couple of years," Bartek said. "We're finally looking at the possibility of profoundly beneficial therapies" for many diseases.

There's interest from not only small biotech firms but also universities and big companies such as Pfizer and Novartis, he said

DOCTORING DNA

Gene therapies often aim to supply a gene people lack. The trick is getting the new one where it needs to be without triggering other problems.

Some therapies, such as ones for inherited forms of blindness, inject the treatment into the eye. A common method for others is to remove some of a patient's blood cells, alter them in the lab to carry the desired gene, and return them through an IV.

What has scientists excited is better vectors -- disabled viruses that ferry the gene into cells -- that seem safer and more effective.

One, surprisingly, may be HIV.

the virus that causes AIDS. Doctors recently reported that a gene therapy using modified HIV from Londonbased Orchard Therapeutics gave a working immune system to 48 babies and toddlers who were born without one. Avrobio, a Massachusetts company, also is using HIV in gene therapies it is testing for cystinosis, Janz's disease, and several others.

BioMarin Pharmaceutical Inc. in California is taking a similar approach with a different virus called AAV for hemophilia, a blood clotting disorder, and several other diseases.

'The only thing that's changing is the payload, the gene," said Avrobio's chief scientific officer, Dr. Chris Mason.

THE SNIFF TEST

Janz lives in Consort, a Canadian village of 700 in Alberta. His mother called the first day of enrollment for Avrobio's study under Stephanie Cherqui, a pediatrics expert at UCSD.

People with cystinosis are unable to clear cystine, a chemical that builds up in their cells and forms crvstals that damage kidneys, eyes and other organs, and leads to muscle weakness, trouble swallowing and even breathing. The vomiting is so bad that many kids need a feeding tube placed in their stomach, and wind up being home-schooled because they're teased by classmates and their medical needs are so complex, Cherqui said.

"When you meet these families, these children are suffering every day from the disease,," she said. "I can't even imagine. It's terrible."

Gene therapy offers hope of a one-time fix. The therapy doesn't have to get into all cells to work, just enough of them to make sufficient amounts of the protein that removes cystine so it doesn't build up.

Janz was treated in 2019 and said he feels "essentially cured," though it will take longer to know if he really is, and he may need a kidney transplant someday because of dam-

age done by his disease. Tests show that crystals in his eyes, skin and muscle have greatly decreased. Instead of 54 pills a day, he just takes vitamins and specific nutrients his body needs.

"I have more of a life now," Janz said. "I'm going to school. I'm hoping to open up my own business one day" -- a deli featuring charcuterie, prepared meats such as hams and sausages. It's an interest he developed during years of frequent trips to Chicago as a young boy to try other treatments. He stayed so often at the Omni Hotel that the chef let him cook in the hotel's fancy restaurant when he was 13. The staff even bought Janz a knife kit and his own chef's hat, apron and shoes.

CHALLENGES REMAIN

Gene therapy doesn't work for everyone, it's unknown how long any benefits will last, and safety remains a concern. In the past, a couple gene therapies that used different vectors triggered cancer in a few patients who received them.

"Every time we think we have overcome the safety issues, we continue to butt up against them," the FDA's Marks said. "I have confidence that we will work through them ... but we can't get too sure of ourselves.

Marks and many other scientists think gene editing eventually may offer a long-lasting way to do gene therapy. Instead of just supplying a missing gene to cells, editing permanently alters a patient's native DNA to insert a gene or knock out one that's causing trouble.

Brian Madeux, a Phoenix-area man who is now 48, became the first person in the world to have gene editing tried inside his body in 2017 for a metabolic disorder called Hunter syndrome. Through an IV, he received billions of copies of a corrective gene and a genetic tool to put it in a precise spot.

Do I need to get tested for Covid-19 if I'm vaccinated?



o I need to get tested for Covid-19 if I'm vaccinated? No, you can skip routine testing, with some exceptions. The latest guidance from the US Centres for Disease Control and Prevention says you don't need to be tested or to quarantine if you're fully

vaccinated, even if you've been exposed to someone who was sick. An exception is if you develop Covid-19 symptoms such as fever, cough and fatigue.

The updated guidance reflects recent studies showing vaccinated people face very little risk of serious disease. Even if you get an infection. you'll be less likely to spread it to others and any symp-

toms will likely be milder. As a result, the CDC says vaccinated people can also be excluded from routine workplace screening, though many companies aren't tracking employees' vaccination status. Screening is still recommended for people working or living in homeless shelters or prisons, due to the higher risk of outbreaks.

The relaxed guidelines also don't apply to doctors, nurses

and other healthcare workers whose employers might still require testing. Guidance may vary by country.

US citizens returning from abroad also still have to present a negative Covid-19 test before boarding their flights home, regardless of their vaccination status. Anyone who tests positive for Covid-19 should still isolate for 10 days, the CDC says.

As vaccinations increase. many experts expect the CDC to further relax testing guidelines, even for vaccinated people with symptoms. Many common colds and viruses can cause symptoms resembling Covid-19, experts say, which could lead to a wave of unnecessary testing in the fall.

"As we race to open back up, a whole variety of infections that we don't routinely test for are going to cause those same symptoms," said Dr Rebecca Wurtz of the University of Minnesota.

"You should wash your hands and stay home from work, but there's no need to run out to be tested.'

RBI Assures Liquidity For Economy, Keeps Growth Revival Top Priority

he monetary policy committee of Reserve Bank of India (RBI) maintained status quo on interest rates for the sixth consecutive review meeting on Friday, indicating that reviving economic growth was top on its agenda as it decided to look through inflation pressure which are resurfacing in the economy due to a variety of factors including hardening of crude oil prices.

"The MPC also decided unanimously to continue with the accommodative stance as long as necessary to revive and sustain growth on a durable basis and continue to mitigate the impact of COVID-19 on the economy, while ensuring that inflation remains central bank will also buy bonds iswithin the target going forward," sued by state governments, unlike said RBI governor Shaktikanta Das G-SAP 1.0 that was only for central

The central bank revised the

growth projection downward to 9.5% from 10.5% for the current financial year. The projection was expected but the upward revision in inflation forecast, albeit marginal, has surprised the markets.

RBI's inflation projection for the current financial year is at 5.1%.

"The increase in inflation projection is noteworthy though we believe any policy normalization is unlikely to start before the third quarter, that is, Oct-Dec quarter of 2021. This also will be contingent on COVID curve and pace of vaccination," Sahay said.

Aurodeep Nandi, India Economist & Vice President at Nomura, said the monetary policy hand-eye coordination is becoming complicated as a second wave of Covid-19 cases is impacting growth comes at a time of rising inflationary pressures.

HC Dismisses Juhi Chawla's Suit Against 5G Tech, Imposes Fine Of Rs 20 Lakh

The Delhi High Court, on Friday, dismissed actress-environmentalist Juhi Chawla's suit which had talked about the harmful environmental effects of the 5G technology for wireless mobile broadband.

In its order, the court said that the plaintiffs had abused the process of law and imposed a fine of Rs 20 lakh.

Earlier this week, during the virtual court hearing on the lawsuit, the Delhi HC had guestioned Chawla for directly approaching the court and not the government.

"This seems to be a publicity stunt. Why have you not approached Govt before coming to us? Has Govt refused to act on the issue? How has the Govt denied you any right?" the court had observed during the hearing.



In her petition, Chawla had claimed that the 5G rollout in India will harm public health, as the radiation that it emits will be "extremely harmful and injurious to the health and safety of the people". In a statement, the actor had said she

was not "against implementing technological advancements," but added that while using wireless devices one is "in a constant dilemma" about "RF (radiofrequency) radiation from wire-free gadgets and network cell towers".

Earlier on Friday, Chawla, to clear the air, explained that her petition wasn't against 5G technology, but had sought clarity from the government over whether the technology is safe for humankind, flora and fauna.

While dismissing the petition, the court said, "Juhi Chawla's lawsuit defective, abuse and misuse of process of law, wasted court's time and filed it to gain publicity."

The court explained that the suit had been filed for publicity as Chawla had shared the web link of the hearing on social media, which led to an interruption of the proceedings by unknown people.

During the hearing on Wednesday, an attendee had disturbed the procedings by singing songs from Chawla's movies, leading the court to direct 'contempt of court' action against the troublemaker.

It was given out that the School education department has taken various initiatives to

As the visual classes are different from physical classes, it has to be made more enjoyable and more experiential so that the students can develop more interest in academics instead of getting unnecessarily tired and stressed out and in view of that Government has issued the very comprehensive policy decision and issued guidelines for stream slots time and way of communication for online classes, read the statement.

It was further informed that this will suffice both interest of students, parents and management.

As per the details it was given out there shall be 30-minute sessions for Pre-Primary Classes

and for class 1st to 8th "online synchronous learning may be undertaken not more than two sessions of 30 to 45 minutes (Approx. 1+1/2 hrs) on each day.

Besides, in the case of 9th to 12th "online synchronous learning may be undertaken not more than four sessions of 30 to 45 minutes (Approx. 3 Hrs) on each day.

Multi-agency team returns from Dominica after court adjourns Choksi case

NEW DELHI: A multi-agency team which had gone to Dominica for deportation of fugitive diamantaire Mehul Choksi returned to India in a Qatar Airways private jet on Friday after Dominica High Court adjourned the hearing, sources said.

The jet carrying the team led by CBI DIG Sharda Raut departed the Melville Hall Airport in Dominica at 8.09 PM (local time) on June 3 and arrived at the Indira Gandhi International

Airport here at 11.02 PM (IST). The team remained stationed for nearly seven days to bring Choksi, wanted in Rs 13500 crore bank fraud in Punjab National Bank, to India as legal battle continued in the courts of Dominica. On Thursday, the Dominica

High Court adjourned the hearing on a habeas corpus petition filed by Choksi's lawyers. A habeas corpus petition is

filed for producing before a court a person who is under arrest or in unlawful detention.

It is likely that the next hearing may take place after a month and the businessman will remain in Dominica, local media reported. Judge Bernie Stephenson will

decide the next date of hearing after meeting both sides, media outlet Antigua News Room said. The adjournment is to allow the lawyers of Choksi and the Dominica government to agree on the language to be used with respect to the injunction filed to prevent his removal from Dominica, it said.

Thursday's hearing was

conducted through videoconferencing with a group of protesters standing outside the High Court building in Roseau carrying placards with messages seeking to know the truth about the controversy.

"Who brought Choksi to Dominica?" read one of the placards, the photo of which was published by many media outlets.

The judge had on Wednesday ordered production of Choksi before the magistrate to face charges of illegal entry into

Dusty Winds, Rains Hit Delhi-NCR, Trees **Uprooted At 80 Locations**

NEW DELHI: The national capital witnessed a sudden weather change on Friday evening as dusty winds and rains hit several parts of the Delhi-NCR, uprooting trees at nearly 80 places and causing inconvenience to farmers protesting at the city's borders.

The rains brought a muchneeded relief to Delhiites reeling under hot and humid conditions. Netizens took to Twitter to share pictures of a rainbow that formed after the showers. Strong winds of up to 60 km/hr swept through the national capital, the meteorological office said. The winds uprooted trees at

67 places in north Delhi, including Civil Lines, Shalimar Bagh and Paschim Vihar, and at 11 locations in south Delhi, including in Kalkaji and Nizamuddin West among others, officials said.

Similar incidents were reported in east Delhi as well. It is likely to be the first time since 2014 that the city may not witness a heatwave in the sum-

mer season. No heatwave has been recorded at the Safdarjung obser-

vatory, considered the official marker for the city, till now. Delhi recorded a maximum temperature of 39.5 degrees Celsius during the day, a notch below the season's average. The minimum temperature was recorded at 26.1 degrees Celsius, a notch below normal.

Till 5.30 pm, the Safdarjung observatory had recorded 3.2 mm rainfall

Palam recorded a maximum temperature of 38.4 degrees Celsius and a minimum of 26.2 degrees Celsius along with 9.4 mm rainfall. A hailstorm was also reported at Palam at 5 pm. The Lodhi Road observatory received 1.6 mm rainfall and recorded a maximum temperature of 39 degrees Celsius and a minimum of 25.3 degrees Celsius.

The strong winds added to the woes of farmers protesting at the Delhi borders against the Centre's three new farm laws.

"Around 100 tents have been affected and damaged due to the strong winds and rains. The protesters will spend the night inside trolleys, and the tents will be erected tomorrow (Saturday) morning," farmer leader Gurmeet Mehma said.

Another farmer leader, Sarwar Singh Pandher, said food items have also been affected. "It happens every time when

Her father is sitting in a hellhole of grief, unaware about the surrounding mourners. He has let his mind drift in the jovial memories of his daughter while her mother has tucked herself into the fairy dresses of her baby doll.

With her parents numb with grief, the only person able to talk is one of her uncles, trying his best to avoid Ada's sweet memories, but he's soon cornered as a tinge of panic shot through him and with his misty eyes he responded, "Today onwards, I won't be able hear the sweet words of ourdoll!'

As soon as Ada was attacked and snatched from her family, a swift tracing operation was launched by her family members, neighbours and SDRF team, cops and Wildlife officials. In the midst of dark, the joint-team of rescuers were walking through the dense forest of Ompora and calling for Ada but there were no takers of the shrieks.

"We kept on shouting, waiting for there to be any call from Ada," said Javaid Ahmed, a neighbour who was a part of the rescue team. "But there were no replies in that darkness. Almost every one of us was dying for her glimpse."

Their disparity was such that with each unheard call, their hopes started running low and it was during this strange lightness of emotions that Ada's father stopped and cried, waiting to hear his daughter.

As they kept on trekking, someone in the roup stumbled upon an unrecognizable item.

continued. "We've already assigned five sharpshooters to neutralise these beasts as soon as possible."

Back in Mir House, life couldn't have been more brutal towards Ada and her grandfather. He's trying in his hardest ways, and always in vain, to imagine other family members who've died and whose death might've struck with him, but no grief is bigger than Ada's death.

"Please bring back my Jigar (Ada)," he loudly requested the mourners. By the time he cried these words, grief-amazingly unknown to many till then-had taken over them.

Outside this room of mourners, a septuagenarian said, "Many think that Ada's death is a small time of grief. It's a poor way of thinking. We're never finished with grief. It's part of the fabric of living. It's always waiting to happen. Innocent children like Ada help us to make memories and life precious; her grief will always remain an inescapable portion in our lives.'

Amid all this, the leopard attack has set off blame-game between residents and the officials of the wildlife department over sharing responsibility of addressing the growing Leopard attack in Ompora. But for Ada's family no department can bring back their gazelleeyed daughter anymore.

of mourners walked towards her house carrying a mauled corpse, gut-wrenching memories and a sweet child that was meant never to be heard again.

Ada was five and was playing in her kitchen garden with her brother and grandfather when three leopards barged into the partially walled side of her house on Thursday evening. She was the only one that the man-eaters targeted and wrenched her neck to its den.

Less than 12 hours later, her mauled body was found deep inside the jungle.

An hour after her funeral, the rush of

"It was quite dark and nothing much was visible, so the leading scouts pulled their torches and illuminated the lying item, and then, something terrible and grueling pinged us all," said Javaid, as he recalls the wrenching incident.

"It was a body-part," he paused before an overwhelming emotion stormed him and then he continued, "We all knew who it belonged to, and how it came there."

The lettered body part and the blood trails all belonged to Ada. It was this littered part that led the rescuers to a nursery which belongs to the Wildlife Department and then it was there when another grueling incident happened.

Other blood soaked body parts of Ada were found.

"I stopped and saw her father," said Javaid. "He apologised to her by slapping himself, tearing his clothes and shouting her name. but by then, we all knew that Ada had been hazed to death.'

The anger and frustration was such that the hunters began burning down that nursery before other members called them out and said they had found more blood trails.

And then, when each step was troubling the rescuers, Ada's mauled body was found deep inside the forest. "I wasn't able to look at her mauled body," said Javaid, as tears trickled down his eyes.

Ada's death has also driven his family and other neighbours to take on an influential system that has held sway upon the jungles of Ompora.

Despite a history of these man-eaters roaming freely in the vicinity and attacking people out of nowhere, the wildlife department, as per the residents was far too "lenient" in neutralising the five beasts that had unleashed a "reign of terror" among hundreds of families living in the densely Ompora housing Colony.

"For the last few months we had relentlessly requested the wildlife officials to take action against these leopards as they were attacking people," Farooq Bhat, a resident of the Housing Colony said.

"But, except issuing advisories for not travelling alone in the evening, the department has done nothing. Ada was killed because of their negligence.'

However, refuting allegations of inaction, wildlife warden, Ifshan Diwan said, "These are wild animals, they don't ask for permission to attack from the department. They can barge at any time. One month back, we had already issued advisories and even camped in the deep forests to find its traces but unfortunately these beasts were not found."

Ada's death has also saddened us, Ifshan

"They will take immediate steps for capturing of the roaming animal in the forests. Any laxity on this score shall be dealt with strictly,' the official spokesperson said.

The meeting, he said, also decided that wildlife Warden will immediately prepare compensation case and obtain a sanction from competent authority within three days positively, so that necessary compensation being paid to family of deceased.

"DFO, PP Division Budgam will ensure immediate removal of fallen material and other cultural operations at Ompora Forests and other risky areas forthwith in order to avoid to any untoward incident in the area. Commissioner Secretary to Govt Forest Ecology and Environment J&K has assured sanction within two days," the official spokesperson said.

He further added that DFO will immediately take steps for erection and strengthening of existing chain-link fencing at Ompora forests and will also submit DPR to the higher authorities for sanction of funds.

"He will also process the proposal/case for sanction of thinning of the forest immediately," the official spokesperson said.

He said that DC Budgam and SSP Budgam also visited the bereaved family and conveyed their heartfelt condolences to them and assured that all possible measures shall be taken to prevent such incidents in future.

sistent in their selection. "This is an extremely important and critical tour for Pakistan as we will be playing the ICC Men's Cricket World Cup Super League ODIs against England as well as the

T20Is against England and the West Indies as part of our preparations for the ICC Men's T20 World Cup.

"The Jamaica Test will count towards the ICC World Test Championship," he said.

DOHA: A 10-man India lost 0-1 to Asian champions Qatar with goalkeeper Gurpreet Singh Sandhu's outstanding performance coming in the way of a heavier loss for the tourists in their World Cup qualifying round match here.

Abdel Aziz scored in the 33rd minute in a match completely dominated by the Qataris on Thursday night.

The two sides had played out a goal-less draw in their first leg match here in September 2019, mainly due to Sandhu's impressive show under the bar that time as well.

India played with 10 men from the 18th minute onwards as Rahul Bheke received his marching orders after picking up a second yellow card for handling the ball outside the box. He had earlier received a yellow card in the ninth minute.

India are already out of contention for a World Cup berth but they are still in the reckoning for the 2023 Asian Cup.

Igor Stimac's men still have two matches in the joint qualifiers to salvage some pride and notch up at least a win. They play Bangladesh on June 7 and Afghanistan on June 15.

Group toppers Qatar, who are yet to lose a match, came up with waves of attacks and more than half their squad stayed put in the Indian half for most of the time. They had 66 per cent possession as against 34 per cent of India.

But for Sandhu's heroics, India would have lost the match by a big margin. He pulled off as many as nine saves in the Group E match played at Jassim Bin Hamad Stadium Thursday night.

In fact, Qatar had 29 shots on opposition goal as against India's none. India did have two good moves from counter-attacks but Manvir Singh failed to make them count.

India captain Sunil Chhetri, who returned to the team after recovering from COVID-19, was replaced by Udanta Singh at the resumption of second half.



Ashique Kuruniyan managed to slip past his marker and essaved it behind the defensive line for an onrushing Manvir.

But the striker's touch let him down as the Qatar goalkeeper collected the ball.

However, Qatar scored the opening goal in the 33rd minute after Mohammed Muntari found space down the left before slipping the ball to Abdel Aziz Hatim, who converted off a rebound from his first attempt.

A counter-attack on the 42nd minute gave India a sniff of a chance. Chhetri, with all his experience, shielded Bassam Alrawi as he found Manvir, whose shot was, however, blocked by a Qatari defender.

Sandhu continued to frustrate Qatar when he kept out Abdelkarim Hassan from close-range in the 47th minute and later Muntari's snap-shot from inside the box in the 53rd minute.

Qatar had their best chance of the second half with four minutes of regulation time left on the clock, when substitute Abdullah Alahraq rifled a long-ranger onto the near post.

However, the ball ricocheted off the post and went out of play.

Delhi Govt, Students Appeal In High **Court Against Order Allowing Private Schools To Charge Annual Fees**

everal appeals, including one by the AAP government, have been moved in the Delhi High Court against its single judge's decision allowing private unaided recognised schools to collect annual and development charges from students for the period after the lockdown ended in the national capital last year.

The petitions moved on behalf of the students studying in the private unaided schools have contended that the single judge's May 31 decision was based on incorrect facts and law.The single judge, in his May 31 judgement, had quashed two office orders of April and August 2020 issued by the Directorate of Education (DoE) of the Delhi government forbidding and postponing collection of annual charges and development fees, saying they were "illegal" and "ultra vires" the powers of the respondent (DoE) stipulated under the Delhi School Education (DSE) Act and the Rules.

The single judge had said that the Delhi government has no power to indefinitely postpone collection of annual charges and development fees by private unaided schools as it would unreasonably restrict their functioning. The Delhi government, in its appeal, filed through its standing counsel Santosh K Tripathi, has contended that its orders of April and August last year were issued in larger public interest as due to the lockdown people were in financial crisis.

The appeals on behalf of the students have claimed that establishment costs, like repairing of buildings, administrative expenses, rent and hostel expenses, are not applicable when the schools are closed. They have also contended that the charging of annual and development fees was only deferred and not stopped and the

schools could have charged the same once the pandemic situation normalised. The pleas on behalf of the students and that filed by DoE have also contended that the conditions imposed by the Supreme Court on Indian School, Jodhpur vs. State of Rajasthan, could not have been made applicable to Delhi, as the education laws in both

states are different. The single judge had said that schools shall collect annual fees with a deduction of 15 per cent as was allowed by the apex court in the Indian School case. The single judge had also said the amount payable by the students have to be paid in six monthly installments from June 10.The other directions of the apex court, that were incorporated in the May 31 judgement, were -- it would be open to the schools to give further concession to their students or to evolve a different pattern for giving concession, management shall not debar any student from attending online classes or physical classes or withhold exam results on account of non-payment of fees and students name for Board exams shall also not be withheld over non-payment of fees/arrears.

The May 31 decision had come on the plea moved by Action Committee Unaided Recognized Private Schools, which represents 450 private unaided schools, through advocate Kamal Gupta. The organisation had challenged the two office orders of April and August last year of the DoE on grounds that they curtail the rights of the private unaided recognized schools to fix their own fees.

The organisation had also contended that to restrict the collection of fee to certain heads or amounts was illegal and without any authority or jurisdiction. It had also said that the DoE has limited jurisdiction to regulate fees, that too only to prevent commercialisation and profiteering.

CBSE Panel To Work Out Criteria For Assessment Of Class XII Students, Submit Report In 10 Days

NEW DELHI: The Central Board of Secondary Education (CBSE) on Friday constituted a 13-member committee to work out an objective criteria for assessment of Class XII students after their board exams were cancelled. The panel will sub-

mit its report within 10 days. "In view of the uncertain conditions due to Covid and the feedback obtained from various stakeholders, it was decided that Class XII Board exams of CBSE will not be held this year. It was also decided that CBSE will take steps to compile the results as per a well defined objective criteria in a time-bound manner," said CBSE Examination Controller Sanyam Bhardwaj

"A 13-member committee has been constituted for the purpose. The panel will submit its report within 10 days," he added.

The members of the panel include--Ministry of Education Joint Secretary Vipin Kumar; Delhi Education Director Udit Prakash Rai; Kenridya Vidyalaya Sangathan Commissioner Nidhi Pandey; Navodaya Vidyalaya Samiti Commissioner Vinayak Garg; Chandigarh School Education Director Rubinderjit Singh Brar; CBSE Director (IT) Antriksh Johri and CBSE Director (Academics) Joseph Emanuel. The panel will also have one representa-

celled the CBSE Class XII Board exams amid the continuing COVID-19 pandemic across the country with Prime Minister Narendra Modi asserting that the decision was taken in the interest of students and the anxiety among students, parents and teachers must be put to an end.

The decision was taken at a highlevel meeting chaired by Modi in which it was decided that the CBSE will take steps to compile the results of Class XII students according to a well-defined objective criteria in a time-bound manner. It was also decided in the meeting that in case some students desire to take the exams, such an option would be provided to them by the CBSE as and when the situation becomes conducive.

The exams were scheduled to be conducted in May-June and were postponed in view of the second wave of COVID-19 pandemic. The CBSE has already cancelled Class X board exams and announced an alternative marking policy.

According to the policy, while 20 marks for each subject will be for internal assessment as every year, 80 marks will be calculated on basis of the students' performance in various tests or exams throughout the year.

The weightage in terms of maximum marks for schools which have conducted the tests and exams through the year will be -- periodic test/unit test (10 marks), half-yearly exam (30 marks) and pre-board exams (40 marks).

Delhi Man Held After Threatening To Kill PM Modi; Says He Had 'Wanted' To Go To Jail

22-year-old man was arrested from northeast Del-Ahi's Khajuri Khas area after he called the Police Control Room (PCR) and allegedly threatened to kill Prime Minister Narendra Modi, officials said on Friday. The accused, who has been

identified as Salman alias Arman, told police that he made the call as he "wanted" to go to jail. He is addicted to drugs and was released from a juvenile correction home, where he was sent in a murder case, in 2018, they said.

The accused called the PCR on 112 around Thursday midnight and threatened to kill PM Modi, the police said.

The number from which the call was received was immediately traced and shared with the district police unit, which then located him to Khajuri Khas, a senior police officer said. According to a preliminary investigation, Salman was under the influence of drugs at the time of making the call. He was scolded by his father around 10 pm.

During interrogation, the senior officer said, the man told police that he made the call as he "wanted" to go to jail. When asked why he wanted to go to jail, he said, "Wahin mann lagta hai mera (I like being there)." Salman also told police that he is addicted to drugs and that he took some smack around 7 pm on Thursday, he said.
