J&K Logs 1184 New Cases, 11 **Corona Deaths**

SRINAGAR: A day after recording less than a thousand covid-19 cases after two months, Jammu and Kashmir reported 1184 fresh infections during last 24 hours, even as 11 more people succumbed to the virus during the time, officials said on Tuesday.

They said 421 of the fresh cases from were recorded from Jammu Division and 763 from Kashmir Valley, taking the J&K's overall case tally to 302651.

Regarding the fatalities, the officials said that five were reported from Jammu Division and six from the Valley, taking the overall toll in J&K to 4101.

Giving district-wise details, they said that Srinagar reported 245 cases, Baramulla 109, Budgam 89, Pulwama 84, Kupwara 60, Anantnag 55, Bandipora 37, Ganderbal 29, Kulgam 42, Shopian 13, Jammu 75, Udhampur 27, Rajouri 40, Doda 74. Kathua 35. Samba 22, Kishtwar 12, Poonch 64, Ramban 37 and Reasi 35.

Saint, Sovereign, Souvenir: The Legend of Ruins

BAGH ALSHAHI Ganderbal –He may be a man of few words, but Abdul Rashid Wani's devotion for the elapsed "spiritual powerhouse" makes him a vocal countryside campaigner.

In commoner's robes, the native in his mid-fifties has been religiously traversing the heart of wilderness to prevent the royal's relic from becoming another faded piece of history.

The sharp-nosed guardian grapples with human greed, usurping attempts, and the routine rustic intrusions to safeguard the remnants of Kashmir's Mughal era.

Be it sun, snow or shower, Rashid has been making his way through the dense orchard for a



moral duty driven by the transcendent reality of the ruins.

The caretaker of crumbled heritage is also a chronicler of a devotional prince and his platonic Kashmir connection. "It was once a grandiose struc-

ture," says Rashid, the guardian bearing stark resemblance with the tumbledown Mughal-era mosque.



"But now, it has become a crumpling gallery of our glori-

Near the rumbling Srinagar-Leh highway, the Malshah Masjid sits unruffled at the foothills of lush-green Dignibal mountains. The meditative calm of the place gets sporadically shattered by the crowing of roosters and the mowing of cows.

The perfect pastoral picture, however, turns poignant with the sight of the Mughal marvelwhose multi-storey Hamam has now become a rundown glory.

The 380-year-old structure sits in the middle of a 360-kanal apple orchard and has shades of Pather Masjid of Old Srinagar.

But unlike the imposing heritage signpost on Jhelum, the Ganderbal mosque has failed to captivate attention of explorers and travellers.

In a poetic lament, this grandeur of yore seems to have long lost its soul. And what's left now is a shell shadowed by the selfstyled custodian.

The heritage demise is also visible through extensive cracks in the 'house of god' hardly

witnessing any faith footfall now. But back in the day, the heritage symbol had established a thriving hamlet by the name of Malshahi Bagh. As per Rashid,

the homestead was established

after the mosque was construct-

ed around 1650 AD. Malshah Masjid was constructed on the orders of Mughal prince Dara Shikoh for his spiritual leader, Mullah Shah Badakhshi, popular in Kashmir

as Akhund Mullah Shah, in the middle of 17th century. Legend has it that the favourite son of Mughal emperor Shah Jahan wanted to enter the Qadriya order of Sufism under

the patronage of Mian Mir, the faith-healer of emperor Jahangir, grandfather of Dara Shikoh.



Once they were in the valley, the commando's realised that only four Muslim majority districts were fighting while the rest of the valley was in no mood to revolt against India. Consequently Pakistan was left with no option but to open

other fronts to ease Indian Army pressure on trapped commandos. Gohar, who is writing his autobiography, told Islamabad daily The News in an interview. According to Gohar, then foreign minister Zulfikar Ali Bhutto had presented the report about Kashmiri disaffection with Indians to Ayub Khan, based on secret communications with

the Kashmiri leadership. Based on Bhutto's report, every commando sent to Indian Kashmir was given two rifles and additional ammunition. Each commando was supposed to keep one rifle with him

and distribute the other to the local population to fan a "massive Indigenous war against Indian occupation". Gohar, who served as foreign minister of Pakistan in 1998 is writing his memoirs and Egging into the personal diaries of his father to

unfold many secret aspects of Pakistani history from 1958 to 1974. Once in the Kashmir valley, the commandos sent back "horrifying reports" saying earlier assertions by Kashmiri leaders were "doctored" and that they (commandos) were trapped. Ayoub and the entire leadership of Pakistan feared that the Indians would slaughter the Pakistani commandos.

The Indian Army quickly captured all the major entry and exit points such as Kargil, Pirsahab and Nemil while Pakistani commandoes were stranded without any support from local Kashmiris.

Gohar said many commandos were "martyred" or captured by Indians. Some managed to escape and return to Pakistan. At one stage, the Pakistan Army was about to capture Akhnoor in Jammu and Kashmir. After then Indian Prime Minister Lai Bhadur Shastri announced Sep 4 that New Delhi would attack the international border. Ayub asked the army chief to move Pakistani troops into operational areas. But the advance in the Chamb sector had to be halted in view of the difficulty of constructing a bridge on a river that lay between the Pakistanis and the Indian city.

Gohar said his father made Pakistan join the US-backed Baghdad Pact only to wage war against India.

Pakistan was getting ammunition from Americans and its allies in the name of training but half of the ammunition was being secretly stored in Pakistan Army depots for use against India in case of a full-fledged war. Pakistan also ran short of ammunition and had to seek help of Turkey and Iran.

China To Offer COVID-19 Vaccine To Children As Young As Three

BEIJING, CHINA: China has approved the emergency use of a Covid-19 vaccine for those as young as three, the drugmaker confirmed Tuesday, making it the first country to offer jabs to young children.

Since the coronavirus first emerged in central China, Beijing has mostly managed to bring the country's outbreak under control, and has administered over 777 million vaccine doses after a sluggish start.

A spokesperson for Sinovac told AFP its vaccine had been approved for use on children.

"In recent days, the Sinovac vaccine was approved for emergency use in three- to 17-yearolds," the spokesperson said.

But he did not confirm when the young children would be able to start receiving the shots, saying the schedule for the rollout will be decided by the National Health Commission "according to China's current epidemic prevention and control needs and vaccine supply".

The company has completed early phase trials of the vaccine in children and adolescents, with results to be published shortly in the Lancet scientific journal, the spokesperson added.

State broadcaster CCTV reported over the weekend that vid-19 cases Tuesday, includan unnamed official in the State ing 19 in southern Guangdong Council's epidemic response task force had said vaccines had



been approved for children, and "the safety and effectiveness" had been proven.

A spokesperson for China's other major vaccine, Sinopharm, said that experts had demonstrated the effectiveness of its vaccine in children, but didn't confirm whether it had been approved for use.

Chinese officials have said they are aiming to inoculate 70 percent of the population of 1.41 billion by the end of this year.

The World Health Organization (WHO) has approved both the Sinopharm and Sinovac vaccines for emergency use in adults aged 18 and older, and both jabs are being administered in several countries around the world.

While the WHO does not currently recommend vaccinating children against coronavirus, the United States, Britain, Singapore and the European Union have approved the Pfizer-BioNTech vaccine for those as young as 12.

OTTAWA: A man driving a pick-up truck slammed into and killed four members of a Muslim family in the south of Canada's Ontario province, in what police said Monday was a "premeditated" attack.

A 20-year-old suspect wearing a vest "like body armor" fled the scene after the attack on Sunday evening, and was arrested at a mall seven kilometers (four miles) from the intersection in London, Ontario where it happened, said Detective Superintendent Paul Waight.

Images on social media and broadcast on the BFM news channel showed Macron approach a barrier to greet a man who, instead of shaking hands, slapped the 43-year-old across the face.



Stalled back-channel?

fter a period of some noise about a backchannel dialogue between India and Pakistan, things have gone a bit quiet. More so in India where senior ruling party leaders have stopped talking about the ongoing thaw in the relations with Pakistan. This could also be the result of the devastating third Covid-19 wave that has by now infected millions and killed thousands of people.

Pakistan, on the other hand, has taken a more overt stance about the putative secret dialogue with New Delhi. In an interview to Reuters on June 5, Pakistan prime minister, Imran Khan once again called on India to reverse the withdrawal of Kashmir's semiautonomous status for the dialogue between the two countries to resume. Short of doing that, Khan has sought "a roadmap" towards restoring the previous status of Kashmir. He called the move to repeal Kashmir's autonomy illegal and against international law and United Nations resolutions.

Significantly, there has been no response to the interview by New Delhi. Nor has there been a response to earlier effusive statements by Khan and Pakistan Army chief General Qamar Javed Bajwa who conspicuously advocated burial of the past between the two countries.

But after re-affirmation of the 2003 ceasefire agreement in February, the two neighbours have failed to build on the goodwill. There have been no further measures, nor does it look likely there will be in the near future. New Delhi seems in no hurry to do this. If anything, this only goes on to show that India feels little pressure to relent. Nor does it want to push the current engagement with Islamabad beyond a point. The unmistakable signal to Pakistan is to temper its expectation about the extent to which India can accommodate it on Kashmir. As always, India wants the terrorism to be the central issue and wants Pakistan to stop supporting militancy in Kashmir. Pakistan doesn't accept it backs terrorism.

Anyways, if last year's figures for infiltration and the killings of foreign militants in Kashmir are anything to go by, Islamabad has held back from supporting the local militancy. New Delhi, it seems, is unlikely to reverse the revocation of J&K autonomy. It remains to be seen whether it restores statehood anytime soon. A sustained, meaningful dialogue between the two countries has the potential to lead to a positive outcome. So, the neighbours should restore it sooner than later.

But the challenge once again for the two countries would be to sustain a dialogue should it start. In the past many such attempts have been aborted by a major attack in India traced to elements in Pakistan or sometimes due to the rigid negotiating positions of the two countries. It would be interesting to see how the two countries negotiate their respective conditionalities before reaching out to each other. The dialogue that will follow, as a result, will go a long to usher in peace in the region and turn the LoC into a line of cooperation.

Correcting the vaccine course

In an address to the nation on Monday evening, Prime Minister (PM) Narendra Modi declared that the Centre would take over the responsibility of procuring 75% of the vaccines (from the current 50%), and provide them free to the states for all those above the age of 18 (and thus relieve states of the responsibility of procuring and paying for vaccines) from June 21. The Centre and the states, he said, would together work out the guidelines. The Centre also imposed a 150 cap on the service charge on each dose that will apply to the remaining 25% of vaccines which can be sourced and distributed by the private sector. The new framework is a much-needed correction in the vaccine policy.

The PM's announcement marks yet another dramatic shift in the country's vaccine policy. Mr Modi said that the arrangement between January 16 to April 30 — which was based on a phased rollout for priority groups, with the Centre procuring vaccines — was altered from May 1 due to the demand of states and other stakeholders for greater decentralisation. He claimed that states then began understanding the complexities of the vaccination process and asked for a reversal to the older system, citing it as the basis for Monday's shift. But the truth is more complex, for it involves the fundamental issue of inadequate supplies, although the PM did speak of how, going forward, more vaccines will be available in the country. India did set up an expert group on vaccines last April, but did not place any advance orders for vaccines. Indian or foreign. The resulting supply crunch, most evident in May, caused the Supreme Court to criticise the government for its "arbitrary and irrational" vaccine policy.

The Prime Minister, Home Minister and other leaders of the Bharatiya Janata Party have been saying that the extension of the central laws to J&K would confer upon its people benefits. Unfortunately, the practice of depriving people of their rights persists in J&K which is only leading to further alienation.

The Forest Rights Act (FRA), 2006, was not rolled out until people protested. Instead, forest-dwellers were issued eviction notices and their properties and apple orchards damaged last year around November and December. Similarly, the Prevention of Atrocities Act, 1989, is not being rolled out in J&K and with respect to the Right to Fair Compensation Act, 2013, the government is engaging in legal deceptions by invoking an 87-year-old repealed and outdated law that applied to the erstwhile state, which is depriving marginal farmers of Kashmir their rights.

Is it not a denial of justice that the fa of J&K are being made to accept compensation for fruit trees at a rate that was applicable more than 26 years ago? In 2017, the National Highway Authority of India (NHAI) had said in a communication to the J&K government that it had no objection to paying compensation according to the central Land Acquisition Act if that law was adopted by the J&K government. But ever since this law was automatically extended to J&K after the abrogation of special status, the NHAI has not uttered a word. How can they, when there is no political will in the government to come to the aid of these farmers? The High Court of Jammu & Kashmir gave several orders asking the Government to issue fresh notification under central land acquisition law, but the Government is adamant to conclude the land acquisition proceedings in several cases under the old law (JK Land Acquisition Act 1934) which was repealed along with article 390 on October 31st 2019. Very recently the High Court division bench gave one more order in favour of affected people. Will the Govt act?

The Marginal Farmers in J&K

The farmers in Jammu and Kashmir are officially recognized as marginal. This is because of small agricultural landholdings. The average landholding in J&K as per 2015-2016 agriculture census was estimated to be around 0.55. The unofficial sources from J&K's agriculture and land revenue departments say it is much smaller (0.45 hectares) on average. In Kashmir Valley, the size is even smaller. During the 2010-2011 Agriculture Census, the average size of operational land holdings in India was 1.15 hectares. This figure was also lower, at 0.62 hectares, for Jammu and Kashmir.

Districts in Kashmir Valley had even lower landholding sizes than the state as a whole: Anantnag 0.39 hectares, Kulgam 0.39, Shopian 0.56, Pulwama 0.48, Srinagar 0.31, Budgam 0.43, Baramulla 0.51, Ganderbal 0.37, Bandipora 0.48, and Kupwara 0.51. This figure fell during the 2015-16 Agriculture Census. In the Valley, where most farmers own less than an acre of land, any government policy related to land acquisition, especially for "development projects", needs to take into account the fragile mountainous environment and climatic conditions as well.

Land Acquisition under Repealed Law

On 13 August 2020, the Financial Commissioner (Revenue) issued a communication (letter No: FC-LS/LA-4577/2017) conveying to the Divisional Commissioner, Kashmir, approval for the rates at which land would be acquired in six villages of Budgam district, namely, Gund-e-Kuzwera, Wathoora, Jawaharpora, Ichgam, Dharmuna, and

Waterwani

The Financial Commissioner (Revenue), who has been made the "competent authority" in the matter, approved the rates under the repealed 1934 Act. He did so after the awards were prepared by the Collector, Land Acquisition, Budgam. This approval was given by the "competent authority" after a gap of almost three-and-a-half years, which violates the 1934 Act and the Right to Fair Compensation Act, 2013, which is applicable in the Union Territory of J&K ever since the abrogation of Article 370.

Ironically, the approved rates are much lower than even the government's stamp rates for 2020. Section 11 of the 1934 Act mandates the acquiring authority to complete acquisition proceedings within two years of declaring an intent to acquire the land under section 6 of the Act. If it fails to do so, the notification and proceedings lapse according to section 11-B of the 1934 Act (now repealed). For instance, the notification under section 4 was issued on 20 March 2017 regarding village Wathoora in Budgam and the declaration under section 6 was made in August 2017. It was thus mandatory for the Collector, Acquisition, Budgam, to finalise the acquisition process and make an award before August 2019. It was also incumbent upon the collector to notify the award according to the repealed Act, which says, the award of the collector would be final when:

(1) Such award shall be filed in the Collector's office and shall, except as hereinafter provided, be final and conclusive evidence, as between the Collector and the persons interested, whether they have respectively appeared before the Collector or not, of the true area and the value of the land, and the apportionment of the compensation among the persons interested.

(2) The Collector shall give immediate notice of his award to such persons interested, as are not present personally or by their representatives when the award is made.

However, the Collector, Land Acquisition, Budgam, did not at any point notify the aggrieved farmers that any award was made by him in respect of their land intended to be acquired within two years beginning 1 August 2017, by the Financial Commissioner's communication dated 13 August 2020. Not even an oral notice was issued to the affected people to attend the collectorate to receive the award. Therefore, for this reason, as well, a fresh notification has to be issued for the acquisition and compensation.

Letter from DC Budgam

On 18 May 2020, an official communication (No: DCB/LAS/20/300-10) was sent by the Deputy Commissioner, Budgam, to the Divisional Commissioner, Kashmir. The letter contains a comprehensive village-wise status report about the acquisition of land for the construction of the Srinagar Ring Road.

The DC Budgam clearly discloses in his communication that in several villages, no approval of the award has been received from the competent authority. He also admits that the land acquisition proceedings for these villages have lapsed.

The Deputy Commissioner, Budgam, then seeks instructions from the Divisional Commissioner, Kashmir, to initiate fresh proceedings under the Central Land Acquisition Act in the following terms:

"Guide if the land acquisition matters of villages detailed at (a) of the communication are to be initiated afresh as per the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013."

Moreover, section 24, subsections 1 and 2, of the Right to Fair Compensation, 2013, is applicable in the Union Territory of J&K with effect from 31 October 2019, also has a similar provision:

...in any case of land acquisition proceed-

ings initiated under the Land Acquisition Act, 1894, (a) where no award under section 11 of the said Land Acquisition Act has been made, then, all provisions of this Act relating to the determination of compensation shall apply."

Pertinently, the 1894 Land Acquisition Act was applicable across India (except J&K) before the enactment of the Right to Fair Compensation Act, 2013. In J&K, the 1894 law can be equated with the 1934 Act.

Suicide in Jammi

After the abrogation of Article 370 and enactment of the J&K Reorganisation Act, 2019, several laws of J&K were repealed and some central laws, including the Right to Fair Compensation, 2013, were extended to the newly-created Union Territories, on 31 October 2019. The 1934 Land Acquisition Act, having been repealed, figures at Serial No. 73, Table 3 in Schedule 5 of the J&K Reorganization Act, 2019, while the 2013 Act, having been extended to J&K, figures at Serial No. 94, Table 1 of the same schedule.

It is important to note that the affected landowners in Jammu have already been deprived of fair compensation during the construction of the Jammu Ring Road project as the land acquisition process was completed under the repealed law when Article 370 was intact. One affected farmer, an ex-serviceman named Harbans Lal of Bishnah tehsil in Jammu, committed suicide last year as the government paid him a mere Rs. 11 lakh for his house and half a Kanal of land that fell in the way of the Jammu Ring Road.

Recent High Court stay order

Jammu & Kashmir High division bench recently in one more case stayed the proceedings of land acquisition for Srinagar Ring Road and its proposed construction. The case titled G A Paul v/s Government of J&K was listed for hearing before the division bench of Chief Justice Pankaj Mittal and Justice Vinod Chatterji Koul on June 4th 2021. The court said that until further orders the parties are directed to maintain the statusquo with regard to nature and possession of land in dispute

Conclusion

Government knows farmers in J&K have meager landholding. Technically the affected farmers / landowners here should be given more compensation during land acquisition. If affected people in Rajasthan or Haryana get 3 to 4 times more than market value of land as per the Right to Fair Compensation Act, how can marginal farmers of Budgam or Pulwama be forced to accept land compensation even less than the market rate? The fruit growers whose land is coming under the alignment of Srinagar Ring Road were forced to take compensation as per the rates applicable in 1996. They took the money under protest a few years back, but they got a stay order from high court against axing of the trees. The assessment for compensation to apple and plum trees which are to be cut down during the road project was made as per Rs 16 and Rs 13 / Kg of fruit. How can the Govt justify this? Will any Deputy Commissioner or Secretary to Government or any IAS officer accept to take salary as per the 4th pay commission applicable in 1996? If they can't do that, how can they expect the poor farmers of Kashmir would be forced to get such a meager compensation for their fruit trees?

An Era of New-age School Student Assessments

he government's decision to cancel the class 12 board examinations, conducted by the Central Board of Secondary Education (CBSE), in the backdrop of the devastating impact of the pandemic and public outrage, comes as a relief for thousands of anxious students and their parents.

The issue now is about the parameters on which students will be assessed and marked this year. Equally important is the methodology that would be used to ensure objectivity in assessment. There is an old saying — one can, albeit with difficulty, defy the effects of bad teaching, but escaping the impact of bad assessment is onerous indeed.

In the immediate context, boards can think of different permutations and combinations, prioritising student interests. It can, for example, set up panels to grade each student, and, after eliminating marks given at both the lower and higher ends, come out with an average score. To do so, it can rely on historical data of the students' performances, particularly of their best year.

Additionally, marks obtained in the class 10 boards, and in the internal assessments and practical examinations in class 12 may be looked into. Fortunately, most CBSE schools have conducted practical examinations and have uploaded the results. And in cases where all practicals may not have been conducted, it may well liberally extrapolate marks from subjects for which examinations may have been conducted. Not much would be gained by assessing performances in classes 9 and 11 as students in these grades tend to be more focused on honing their co-curricular skills and social networks. For objectivity, fairness and transparency, the results of a particular school may be required to be vetted by a partner school.

Irrespective of any decisions that CBSE may come up with, there will be dissenting voices. However, this being a unique year all stakeholders will need to deal with the outcome with patience, trust and understanding. Universities, boards and schools need to come together in the best interest of the students.

That said, given the fact that institutions of teaching and learning — both schools and colleges – will have to undergo cyclic phases of closure and opening, they may have to adhere to hybrid learning. Working out a renewed assessment and evaluation system that, in being objective, is also simultaneously flexible, to cater to hybridity, is most pertinent in the long-run.

Attempts should be made to integrate regular in-house examinations with additional parameters of assessment such as communication abilities, critical thinking, creativity, ability to use knowledge for problem-solving, as well as col-



laborative social and citizen skills. The key idea behind such an evaluation is to understand the level of a student's achievement of the objectives of the subject. While, in the early stages, these objectives could be set by teachers, students could be allowed to have some say, as they move on to higher classes. Evaluators can then correlate objectives to student performance. Multiple methods of assessments need to be used so that each child is assessed at her own level and potential, to help develop self-esteem and confidence.

The board exams will have to be flexible in their approach, dissuading rote learning. This learner development can only take place if assessment is sequential and continuous with application to real life, through case studies, open book testing, multiple choice questions, research and project-based learning.

Interestingly, the National Education Policy or NEP (2020) has provisions on regular formative assessments, designed to test conceptual clarity, analytical abilities and competence in terms of critical thinking. It also stresses on assessments, defining and identifying learning outcomes throughout the year through formative evaluation. Additionally, the provisions for stage-based assessments in classes 3, 5 and 8, in addition to board examinations in classes 10 and 12, and the idea of a national assessment centre, Parakh, to set benchmarks in standards are novel indeed.

This new-age assessment, as NEP describes it, aims to bring big shifts. But to be consistent both in approach and analysis, it necessitates multiple pedagogical approaches enabling differential learning. At the most fundamental level, however, it will be dependent on the extent to which the capacity of teachers is enhanced. Empowering them to develop internal assessment models that deal with competency-based learning, skills, attitudes and values, instead of standardised pen-paper testing systems is a must. An attempt has to be made to integrate periodic and continuous evaluation with un Google able questions which focus on critical thinking, creativity, problem-solving and decision-making skills. Most importantly, schisms have to be laid at rest, mindsets will need change, training in pedagogy, technology and classroom transaction will have to be done on a war-footing failing which we will never be able to break the stranglehold of rote-based, pencil-paper-oriented colonial systems of learning.

Evaluating the performance of students is not just an external obligation, but is increasingly motivated by those who are involved in shaping it - faculty, staff, and institutional leadership. The need to put an alternative mechanism of assessment in place, robust enough to yield results both in normal times as well as in times of exigencies, is most imperative. Let us create an assessment system that is underlined by expertise and the ethics

world is currently transfixed by the second wave of the Covid-19 pandemic sweeping through many regions, especial-Africa and South America But focused as we are on the public-health crisis, we risk overlooking pandemic-related economic problems that could plague developing countries long after the wave has receded.

At the global level, the International Monetary Fund has warned of a "Great Divergence", whereby rich countries recover strongly while others flounder. Recent evidence suggests that several advanced economies, notably the United States, and a few developing countries, like Vietnam, Thailand, and Bangladesh, seem to be pulling out of the crisis and could grow faster than they did before the pandemic. But many emerging economies and low-income countries are likely to languish for a long time.

A Great Divergence is visible even within economies. The pandemic has punished sectors such as hospitality, travel, and tourism, and boosted others like pharmaceuticals, digital platforms, and networking technology. It is therefore not surprising that many rich people, including those who are good at navigating equity markets, have actually emerged from the crisis better off, while the poor have borne the brunt of its im-

Therein lies the real danger. Unlike a pandemic that puts rich and poor alike at risk, the kind of economic crisis currently simmering in much of the developing world does not affect the rich as much and therefore does not generate headlines and is easy to disregard — that is, until it can no longer be ignored.

Sure enough, evidence of trouble is beginning to mount. Emerging economies everywhere face rising debts, and some, like Zambia and Argentina, have already defaulted. In 2020, Latin America's economy contracted by 7.7 per cent; the Philippines and India took even bigger hits, registering growth rates of -9.5 per cent and -9.6 per cent, respectively. And the World Bank estimates that the pandemic may have pushed up to 40 million people in Africa into extreme pov-

The current wave of Covid-19 that began in India became discernible only in late March. Although systematic data regarding its economic impact are not yet available, anecdotal evidence paints a gloomy picture. According to the Cen-

tre for Monitoring Indian Economy, the seven million jobs lost in April caused the national unemployment rate to jump to 8 per cent, from 6.5 per cent in March.

Moreover, youth unemployment in India already reached an all-time high of 23.75 per cent last year.

The regular reports of dead bodies being dumped into the River Ganges and washing up in small Indian towns and cities indicate the tragic severity. But they are also tell-tale signs of a brewing economic crisis. For Hindus, not being able to acquire logs and find space to cre-

mate the dead is a desperate situation. Only in cases of extreme poverty would they abandon this effort and throw corpses into the river.

Another sobering account comes from the two women who run Nanritam, a remarkable NGO that operates a school and an eye hospital in a remote part of West Bengal. They told me how registration at their school is down to nearly half its normal level. Furthermore, the nandemic has forced thousands of the region's tribal chhau dancers and jhumur singers — whose only regular income is the Rs1,000 (\$14) per month they receive from the state government — to resort to begging. When Nanritam recently announced its usual simple relief dole for the poor living around their campus. the NGO was taken aback by some who walked and cycled for miles to get it.

But, aside from such evidence, official data are also beginning to flash warning signs. Last month, Indian wholesale price inflation climbed to 10.5 per cent, the highest rate in 11 years. This reflects mismatches in demand and supply, which, if not corrected soon, could become a major crisis, causing macroeconomic imbalances that can affect trade and financial flows. India has a highly capable central bank, but many of the country's current problems will be difficult to rectify through monetary policy alone, because they arise from poor governance.

India therefore urgently needs policy blueprints for dealing with the crisis. Policymakers should recognise that when basic goods such as medical oxygen, vaccines, or food are in short supply, pure financial interventions may not work, because the rich will be prepared to spend whatever it takes to get what they need (and more as a precautionary buffer). Providing the poor with cash support to make sure they can meet their basic survival needs will mean that the price of the good rises until the rich have what they want. The poor will thus be back at square one.

We see this kind of problem at both the micro and the international levels, notably with Covid-19 vaccines. Whereas many rich countries are buying up doses to secure ample stocks that go well beyond their basic needs, poor countries, including large parts of Africa, are left

without any access to supplies. Just as national governments in India and other developing countries have a lot to do, multilateral organisations such as the World Bank, the IMF, and the G20 also must act quickly to build up policy buffers and help coordinate support. Otherwise, today's looming economic threat will be tomorrow's front-page news.

'High caffeine intake linked to increased risk of blinding eye disease'

ou might want to keep a check on your daily intake of caffeine as a new study has found that consuming large amounts of daily caffeine may increase the risk of glaucoma more than three-fold for those with a genetic predisposition to higher eye pressure.

The findings of the study were published in the journal 'Ophthalmology'.

The research led by the Icahn School of Medicine at Mount Sinai is the first to demonstrate a dietary-genetic interaction in glaucoma. The study results may suggest patients with a strong family history of glaucoma should cut down on caffeine intake.

The study is important because glaucoma is the leading cause of blindness in the United States. It looks at the impact of caffeine intake on glaucoma, and intraocular pressure (IOP) which is pressure inside

Elevated IOP is an integral risk factor for glaucoma, although other factors do

contribute to this condition. With glaucoma, patients typically experience few or no symptoms until the disease progresses and they have vision loss.

'We previously published work suggesting that high caffeine intake increased the risk of the high-tension open angle glaucoma among people with a family history of disease. In this study we show that an adverse relation between high caffeine intake and glaucoma was evident only among those with the highest genetic risk score for elevated eye pressure," said lead/corresponding author Louis R. Pasquale, MD, FARVO, Deputy Chair for Ophthalmology Research for the Mount Sinai Health System.

A team of researchers used the UK Biobank, a large-scale population-based biomedical database supported by various health and governmental agencies. They analyzed records of more than 120,000 participants between 2006 and 2010. Participants were between 39 and 73 years old and provided their health records along with DNA samples, collected to generate data.



They answered repeated dietary questionnaires focusing on how many caffeinated beverages they drink daily, how much caffeine-containing food they eat, the specific types, and portion size. They also answered questions about their vision, including specifics on if they have glaucoma or a family history of glaucoma. Three years into the study later they had their IOP checked and eye measurements.

Researchers first looked at the relationship between caffeine intake, IOP and self-reported glaucoma by running multivariable analyses. Then they assessed if accounting for genetic data modified these relationships. They assigned each subject an IOP genetic risk score and performed interaction analyses.

The investigators found high caffeine intake was not associated with increased risk for higher IOP or glaucoma overall; however, among participants with the strongest genetic predisposition to elevated IOP - in the top 25 percentile - greater caffeine consumption was associated with higher IOP and higher glaucoma prevalence.

More specifically, those who consumed the highest amount of daily caffeine- more than 480 milligrams which is roughly four cups of coffee - had a 0.35 mmHg higher IOP.

Additionally, those in the highest genetic risk score category who consumed more than 321 milligrams of daily caffeine - roughly three cups of coffee - had a 3.9-fold higher glaucoma prevalence when compared to those who drink no or minimal caffeine and in lowest genetic risk score group.

"Glaucoma patients often ask if they can help to protect their sight through lifestyle changes, however this has been a relatively understudied area until now. This study suggested that those with the highest genetic risk for glaucoma may benefit from moderating their caffeine intake. It should be noted that the link between caffeine and glaucoma risk was only seen with a large amount of caffeine and in those with the highest genetic risk," said co-author Anthony Khawaja, MD, PhD, Associate Professor of Ophthalmology University College London (UCL) Institute of Ophthalmology and ophthalmic surgeon at Moorfields Eye

'Men make more extreme choices, decisions'

ccording to a new study, men make more extreme choices and decisions in comparison to women.

This is the main finding of the new research involving more than 50,000 participants in 97 samples, published in the prestigious journal Proceedings of the National Academy of Sciences of the United States of America (PNAS).

The findings show that the more extreme choices and decisions of men can be both positive and negative.

The question of whether men and women make systematically different choices and decisions is one on the most fundamental (and controversial) questions in psychological research," Associate Professor Stefan Volk from the University of Sydney Business School said.

"We found men were much more likely than women to be at the extreme ends of the behavioural spectrum, either acting very selfishly or very altruistically, very trusting or very distrusting, very fair or very unfair, very risky or very risk averse and were either verv short-term or verv long-term focused," Volk added.

The findings could impact policies aimed at regulating extreme behaviours such as the recent GameStop trading frenzy after retail traders on Reddit heavily

shorted the stock.

"Our research suggests policies aimed at reducing extreme behaviours should be more tailored towards men," said Dr Volk.

The researchers suggest the differences might have evolutionary roots, but there are also alternative explanations for the existence of what is often referred to as greater male variability.

"Parental investment theory explains that men, in contrast to women, invest less in parenting, are less selective in their partner choice, and compete more for sexual partners," Associate Professor Volk explained.

"This evolutionary theorising suggests that men had to deviate from the average to stand out and be attractive to women to reproduce, while women were able to attract sexual partners without deviating from the average," Volk added.

"Another explanation could be norms and expectations of acceptable gendered behaviour and that men's extreme behaviours are socially constructed and reinforced,"

"This alternative theory sugts that the socially constructed patriarchy in many societies has managed to constrain women and the opportunity for them to display the same level of variability as men," Volk noted.

Associate Professor Stefan

Volk, worked with an international team to examine sex differences in altruism, cooperation, trust, fairness and attitudes towards time and risk in economic decision-making. The researchers found systematic evidence for greater male variability.

He added these gender differences in variability are difficult to detect in research focused on gender differences in average behaviours. This is why they have been overlooked in most previous research, which traditionally focused on mean gender differences rather than the range of behaviours. But we need to look at differences in extreme behaviours to understand what might be driving

The PNAS paper is the second in a series by Associate Professor Volk on greater male variability; the first was just published in the internationally leading psychological journal Psychological Science.

This earlier research involved two large-scale meta-analyses of economic decision-making studies and studies of organisational citizenship behaviour with more than 20,000 participants.

While the researchers found no differences in the degree to which men and women behaved cooperatively on average, they did find strong evidence for greater male variability in cooperation.

'Embryos of many species use sound to prepare for the outside world'

t's well known that reptiles depend on temperature cues while in the egg to determine a hatchling's sex. Now, researchers writing in the journal Trends in Ecology and Evolution sav that embryos of many different animal species also rely on acoustic signals in important ways. They call this phenomenon "acoustic developmental programming."

develop-"Acoustic mental programming occurs when a sound informs embryos about the environment they'll encounter postnatally and changes their development to better suit this environment," said Mylene Mariette of Deakin University in Australia.

Because this is a newly discovered phenomenon, the evidence is just beginning to accumulate. And, yet, it seems to be rather widespread among animals

'We have found evidence of this happening in birds, where parental calls can warn embryos about heatwaves or pred-Mariette says. "Before that, there was also evidence that cricket nymphs use male songs to predict the level of competition for mates. However, what is most striking from the evidence we've gathered is how common it is for embryos across species to rely on sound information.

"For example," she adds, "across all animal groups that lay eggs, such as insects, frogs, reptiles

and birds, embryos use sound or vibration to know when the best time is to hatch. This suggests that acoustic developmental programming is likely to happen in many animal species and for a whole range of conditions. But, until recently, we did not

know it was happening." Mariette got interested in acoustic developmental programming while studying how zebra finch parents communicate with each other through calls to coordinate parental care duties. "I noticed that when a parent was alone incubating, it would sometimes produce a strange highpitched call," she says.

She wondered if those calls had further implications for the developing embryos. To find out, she captured many audio recordings in nests and played them to eggs incubated artificially in the lab. It turned out that the finch parents only produced that particular call when it was very hot out. Upon hearing it from inside the egg, nestlings adiusted their development to prepare for the heat.

"I became very curious about how just hearing a sound before hatching could alter development, Mariette says.

She started searching for evidence in the literature of embryos using sound in other animals. She also dug into neurobiology to try and understand how it could happen. So far, it's not clear exactly how it works, but the new report identifies some likely mechanisms.

Historic Initiative To Bring A New Revolution In The Farming Sector Of J&K: LG

J&K Government Taking Reformative Measures For The Sustainable Development Of Agriculture & Horticulture Sectors: LG

SRINAGAR: Taking a giant leap in the agriculture sector & adopting environment-friendly farming practices across the UT, Lieutenant Governor, Manoj Sinha on Tuesday flagged off the first consignment of IFFCO's Nano Urea (Liquid) from Kalol area of Gujarat, through virtual mode.

"I express my heartfelt gratitude to the Hon'ble Prime Minister Narendra Modi for encouraging the agricultural scientists and farmers, for the last many years, to reduce the use of urea. His vision has made this into a reality. which will bring reforms in the agriculture sector of J&K", added the Lt Governor.

The Lt Governor also congratulated Dr. U. S. Awasthi, Managing Director, (Indian Farmers Fertiliser Cooperative Ltd) IFFCO and his entire team members for developing the world's first Liquid Nano Urea, which will enhance crop yield, protect crops from seasonal damage while maintaining soil quality. The historic initiative aimed at saving the environment and keeping the soil of the agricultural fields fertile.

It was informed that 15,000 bottles of Liquid Nano Urea are leaving Kalol, Gujrat today for the farmers of Jammu and Kashmir. Out of this, 7500 bottles will be distributed to the Jammu division and 7500 to the farmers of Kashmir division. The total consignment of liquid nano-urea will be equivalent to 675 metric tonnes of conventional urea.

While highlighting the immense scope of growth in agriculture sector of the UT and the troduction of Liquid Nano Hrea self-reliant India. In Jammu and Kashmir, along with the promotion of traditional agriculture, horticulture, emphasis is being laid on value addition farming, so that the farmers get a fair price for their crops. 70 percent population of the UT is dependent on agriculture. This liquid Nano Urea can bring about a new revolution in the farming sector of J&K, said the Lt Governor.

Citing the positives of the use of Liquid Nano Urea, the Lt Governor maintained that it will farming practices and benefit the farmers, especially those involved in traditional and high

districts, where farmers have to travel several kilometers to reach their agriculture fields. Instead of carrying a bag of urea, now the farmers have to carry only half a litre bottle of urea, he added.

The excessive use of urea is resulting in making the soil barren across the country. It has not only affected the nitrogen cycle but also harms the environment and people's health. Initially, many farmers may get benefitted due to its excessive use, but later the same urea destroys the fertility of the fields, the Lt Governor said.

On the financial aspects of the new initiative, the Lt Governor observed that the Liquid Nano Urea will subsequently bring down the cost of farming. Cost of one bottle of this urea is 10% less than that of a 45 kg of urea bag. Since, Nano Urea does not require subsidy, the government will save about Rs 27,000 crore, besides providing a benefit of Rs 28,000 crore to the farmers by reducing their cost on agriculture, he added.

In 2017, the Prime Minister had said that when India celebrates 75th anniversary of Independence in 2022, we should reduce the use of urea by half. I sincerely hope and believe that the way IFFCO is working on the call of the Prime Minister, soon we will be successful in realizing his vision, said the Lt Governor.

On the occasion, the Lt Governor also added that the J&K Government is intended to increase the productivity of Basmati agricultural land.

He further said in Kashmir, the maximum temperature is likely to remain somewhere between 31-33 degree Celsius for the next two days. However, from June 11-June 14, Ahmed said, the temperature is expected to settle around 12-14 degree Celsius.

"After June 15, we expect a temperature above 25 degree Celsius in the Valley," he said.

Last week, as the temperature started soaring in J&K, the MeT had issued excessive-heat warnings and heat advisories for the people in J&K. Following the same, the officials of the department had advised the people to take note of the given advisories.

"We have advised the people to stay hydrated, limit outdoor exposure and be mindful of any signs of heat-related illnesses such as heat stroke and heat-exhaustiveness, Ahmed said.

Giving an extended weather forecast, the MeT Deputy Director said that Kashmir is likely to have a temperature between 32 to 35.5 degree Celsius that will lead to several days of heat wave.

"A period of hot temperatures in the mid-June to early August is expected where the heat index could reach as high as 35.5 degrees. This probability for above normal temperatures will witness July as the hottest month. In this given time frame, the combination of hot temperatures and high humidity will combine to create a situation in which heat-illnesses are very much possible," he said.

He further added that unlike Kashmir, the temperature in Jammu may soar up to 44.5 degrees during the same period.

COVID-19 patients have recovered, 996 from Jammu Division and 1884 from the Kashmir, leaving the number of active positive cases to 21817 in J&K-8143 in Jammu division and 13674 in the Valley.

Also, one new confirmed case of mucormycosis (black fungus) has been reported today, bringing the cumulative cases to 17 in J&K.

Meanwhile, police on Tuesday claimed to have recovered over Rs 2 lakh fine from violators for breaching coronavirus related rules and guidelines.

In a statement issued to media here, a police spokesperson said that during the last 24 hours, police have realized a fine to the tune of Rs 2,05,400 from 1968 people throughout the Kashmir valley for violating the various guidelines, rules and SOPs regarding Covid-19.

"The special drive against the violators of Covid-19 guidelines and rules continued throughout all the districts of Kashmir Valley to ensure that people adhere to SOPs and guidelines envisaged by the government to curb COVID-19 pandemic," the spokesperson said.

"In immediate follow-up of the prime minister's announcement of these changes in the Guidelines of National COVID Vaccination programme yesterday, the Centre has placed an order with Serum Institute of India for 25 crore doses of Covishield and with Bharat Biotech for 19 crore doses of Covaxin.

"Additionally, 30 per cent of the advance for procurement of both the COVID-19 vaccines has been released to Serum Institute of India and Bharat Biotech," an official said.

In an address to the nation on Monday, the prime minister announced that the central government would take over the 25 per cent state procurement quota and provide free coronavirus vaccines to states and union territories for inoculation of all above 18 years of age from

Asserting that vaccine supply would be increased significantly in the coming days, Modi said the Centre has now decided to buy 75 per cent of jabs from vaccine makers for free supply to states, while private sector hospitals will continue to procure the remaining 25 per cent.

The government has also set the maximum price private hospitals can charge for the three COVID-19 vaccines currently available in the country -- Covishield Rs 780 per dose, Covaxin Rs 1,410 and Sputnik V Rs 1,145.

In a letter to all states and union territories on Tuesday, the Health Ministry suggested that appropriate strict action be taken against private vaccination centres for overcharging.

The maximum price of Covishield for private COVID-19 Vaccination Centres (CVCs) has been fixed at Rs 780 per dose, while that of Covaxin is Rs 1,410 per dose and Sputnik V Rs 1,145 per dose, it said.

The official said the Centre has been supporting the efforts of states and union territories for an effective vaccination drive under the "whole of government approach" since January 16 this year.

Based on various representations received by the Centre, the vaccination for all adults above 18 years of age was opened in the Phase III of vaccination strategy beginning May 1.

"Now with the aim to further universalise the countrywide vaccination drive, all citizens above 18 years of age can receive the COVID-19 vaccine doses free of cost at government health facilities," the official said.

Appointment to the Service shall be made by direct recruitment; or by promotion provided that the terms and manner of appointment by absorption shall be as notified by the Administration by a general or special order. It is further provided that the competent authority to appoint a person to the Service by absorption shall be the Administration.

However, on the date of commencement of these Rules, persons who have already been appointed substantively to a post in the cadre of J&K Employment (Subordinate) Service and finally allotted for service in the Ladakh in accordance with the provisions of section 89(2) of the J&K Reorganization Act, 2019, shall be deemed to have been appointed to the Service at the initial constitution.

It is also provided that a person appointed by a competent authority substantively to a post in the cadre of J&K Employment (Subordinate) Service on the recommendations of a Board after the appointed day shall also be deemed to have been appointed to the Service at the initial constitution and the services rendered by him prior to the commencement of these Rules shall count for the purposes of rules regulating his conditions of service.

Regarding eligibility, the age limit and other qualifications for direct recruitment shall be as prescribed by the Administration. "A person already in Government service would be required to apply through proper channel for direct recruitment against a vacant post in the Service, if he possesses the educational and other qualifications prescribed for recruitment to such posts," read the Rules.

Regarding interpretation, the notification says that if any question arises relating to the interpretation of these Rules, the matter shall be referred to the Administrative Department whose decision thereon shall be final and binding. (GNS)

Saint, Sovereign

prince Dara decided to meet him, the saint left for the heavenly abode.

The heartbroken young prince would then visit Kashmir to meet Mian Mir's successor Akhund Mullah Shah.

The revered saint known for his mystic influence on Kashmir life impacted Dara Shikoh to an extent that the young prince went to build

three massive structures in the praise of his "murshid".

The monuments came in the form of Pari Mahal at Zabarwan Hill, Akhund Mullah Mosque at Koh-e-Maran, and the third one at Malshahi Bagh.

For the next few decades, the elegant mosque

at Malshahi Bagh remained full of faithful. As the rush grew, a locality was carved out on the foothills of Dignibal mountains, thus laying the foundation of the beautiful hamlet.

However, while the other architectural pieces established by Dara Shikoh in Kashmir prospered to attract visitors till this day, the Malshah Masjid failed to overcome the negligence and fell to despair. "There weren't any human settlements here

before this masjid," Rashid continues, as he takes the walk inside the royal ruins. "People started living here under the guidance of the pious soul."

But as soon as the saint left, the locals, for whom the mosque came as a blessing, started deserting it.

"And since 18th century," the guardian says, "the mosque became defunct, with no worshipper turning up for prayer." After the mosque was deserted, it started

attracting the force of nature, in the form of bushes and grasses. The 'eco-invasion' driven by creepers soon covered the regal walls and made it look like a

haunted house in a jungle. For the next 200 years, the expanding arms of nature appeared as a mark of occupation over the once-revered structure.

But, it wasn't only nature's strike that damaged the mosque.

Post-2010, the ruined structure faced human greed. A few people tried to fence over the mosque along with its land.

"People started fencing the border first and then the mosque," the caretaker says. "It created ruckus in the area. The timely intervention of the Waqf Board

saved the mosque from being razed to the ground and its land to get encroached by some Equally alarming were the efforts to make the premises as a grazing land and shelter for

livestock. In the vicinity of the heritage structure lies the padlocked office of Waqf Board-the offi-

cial custodian of the waning heritage. "The board just earns a whopping annual amount from the apple orchard of this

mosque," the caretaker says. "They could've managed it like the Jamia Masjid of Srinagar, but they aren't willing to spend a penny on it. They could've also promoted it as a tourist destination. But they're

just sitting over it and waiting for its demise." This reporter tried to contact the board managers for the official version, but many seemed oblivious of the structure and its status, while others just passed the buck.

However, an official from the Archaeological Department said they've lately taken a notice of the mosque "but so far no plan has been formulated to conserve or revamp the mosque".

But Rashid sees no help in sight. The caretaker now fears that the medieval mosque will be eventually consumed by the

greed and apathy. However, Rashid takes solace from the past when students along with their teachers would come to see the mosque and study its history and architecture.

"But since the tumultuous 1990s, those small yet helpful educational visits have stopped too," the caretaker laments. 'Now hardly anyone turns up to see the sov-

ereign's souvenir for his saint who once founded and flourished life here."

Faf Du Plessis Defends His Quetta Team-Mate Azam Khan's Selection In Pakistan Team

ABU DHABI: Not every guy has to have six-pack abs to be successful in cricket, said the supremely fit and well-built Faf du Plessis after Azam Khan's selection in the Pakistan team raised questions about his fitness.

A controversy erupted after Pakistan last Thursday named uncapped Azam, son of former captain Moin Khan, in the T20 squad for the tours of England and West Indies, with many believing that his father is behind his selection.

That Azam weighs more than 100kg was also pointed out by the fans before du Plessis came to the rescue of the big-hitter, with whom the former South African captain shares the dressing room in Pakistan Super League franchise, Quetta Gladiators.

"When it comes to fitness, every guy has a responsibility to try and improve every day," du Plessis said at a virtual press conference in Abu Dhabi ahead of the PSL.

"That looks different for every single person. For me, at an older age, I don't stop thinking about how I can improve myself as a cricketer, how I can improve my fitness, how I can improve my body, how I can improve my mind," he was quoted as saying by 'ESPNcricinfo'.

Many in the Pakistan cricket community believe that Azam was picked because of his father who is a former national team skipper and coach of Quetta Gladiators.

Fans also questioned the fitness of the player who weighs more than 100kg.

Du Plessis said, "The difference between guys who do it for a very short period and guys who do it for longer, it's just improving, it's smaller gains right throughout your career. For someone like him (Azam), no, he doesn't have to look like me to be successful.

"It would just be small improvements every day. Right now, it might be something like fielding he could focus on, getting quicker to the ball, making sure (the) hands are good, taking all the catches and gradually putting in the work to become a better version of himself, or myself, or someone."

A clean striker, Azam hits a boundary every four balls and has so far scored 743 runs in 36 T20 matches.

"It's unfair to compare different people, we're comparing two different players. He's a guy who will always come and be a power hitter and hit it a long way.

"I'm certainly not a believer that every guy has to have a sixpack to be a successful cricketer. You work with what you have.

"You look at the greats in the game before, there's been guys long before me and after me and him, who will all look different but had the skillsets to perform," du Plessis said.

Refugee Team Of 29 Athletes Picked For Tokyo Olympics

LAUSANNE: The refugee team for the Tokyo Olympics has 29 athletes competing in 12 sports, including a medalist at the 2016 Rio de Janeiro Games who left Iran citing institutional sexism.

The team selected by the International Olympic Committee on Tuesday was drawn from 55 athletes who fled their home countries and got scholarships to train for the games in a new home country.

Kimia Alizadeh is among them five years after she became the first Iranian women to win an Olympic medal. She took bronze in taekwondo at age 18.

Alizadeh is based in Germany

after she defected from Iran and criticized wearing the mandatory hijab headscarf.

"I have a great feeling to have made a decision for my life that would definitely change my future," she told reporters in Germany in January last year.

DUBAI: Pakistan pacer Hasan Ali, Sri Lankan spinner Praveen Jayawickrama and Bangladesh wicket-keeper batsman Mushfiqur Rahim were on Tuesday nominated for the ICC men's Player of the Month award for May.

Besides, the ICC also nominated Kathryn Bryce of Scotland and Irish duo of Gaby Lewis and Leah Paul for Women's Player of the Month honours.

Ali played two Tests against Zimbabwe where he took a total of 14 wickets, while from Sri Lanka's camp, debutant Jayawickrama played one Test against Bangladesh and took a total of 11 wickets at 16.11.

Jayawickrama bowled Sri Lanka to victory in the second Test against Bangladesh with the best match figures by any Sri Lankan bowler on Test debut.

Bangladesh's Mushfiqur played one Test and three ODIs against Sri Lanka. He helped his team win their first ODI series against Sri Lanka by scoring 125 in the second ODI.

Among women, all-rounder

Among women, all-rounder Bryce is the first player from Scotland, male, or female, to make it to the top 10 of the batting or bowling lists in the rankings released recently. She played four T20ls against Ireland where she scored 96 runs and took 5 wickets with an economy rate of 4.76.

Ireland's Lewis also played four T20Is against Scotland where she scored 116 runs at 29.00 with a strike rate of 116.00. She became the leading run-scorer in the series between Ireland and Scotland, with innings of 47 in the second match and 49 in the fourth. Her compatriot Paul took nine wickets at 4.44 with an economy rate of 4.44 against Scotland and became the leading wicket-taker in the T20I series between Ireland and Scotland.

The three nominees for either category are shortlisted based on on-field performances and overall achievements during that month (the first to the last day of each calendar month), the ICC said in a statement.

ISL Clubs To Field Minimum 7 Indian Players At One Time Under New Regulation

MUMBAI: The Indian Super League's 2021-22 season will witness an increase in local players' on-field participation thanks to a new set of guidelines that mandates clubs to field a minimum of seven footballers at one time from the previous six.

A rise in the number of Indian players means one spot less for foreign stars which will now be capped at four.

"Hero Indian Super League 2021-22 season will witness an increase in number of Indian players in the playing XI, as the new Coach & Player Selection Guidelines of Football Sports Development Limited (FSDL) now mandates clubs to have a minimum of seven (7) Indian players on the field at any point of time," the ISL said in a release on Tuesday.

The inaugural edition in 2014 had witnessed a playing composition of six foreigners and five Indian players.

Over the years, the league has gradually increased the spots for Indian players, with ISL 2017-18 having a minimum six Indian players on the field, which now has been further increased to seven for the next season.

"The latest changes in player guidelines are incorporated with the League's philosophy of bringing constant improvement to India's premier football event," it said in the release.

The cap on foreign players to a maximum four is in accordance

with the Asian Football Confederation's club competitions' regulations.

With the changes, clubs can sign a maximum of six foreign players of which one is required to be from an AFC member nation.

A club also has an option to

sign a foreign marquee player within the League-approved classifications. Starting this season, FSDL

(Football Sports Development Limited, which runs the league) will mandate clubs to increase their development player signing from minimum two to four, while continuing to have two of such development players be part of the match-day squad.

"The league witnessed a significant improvement in the performance of developmental players last season with the likes of Akash Mishra, Apuia, Jeakson Singh, Rahul KP, Asish Rai, etc. delivering breakthrough performances underlining the testament to the growth of young footballers in India."

A club can have a maximum squad strength of 35 players, with three registered goalkeepers.

A club can also have an injury replacement for an Indian player (outside of the maximum 35 registered players).

The squad salary cap remains

at Rs 16.5 crore for the upcoming season.

SUNIL CHHETRI Overtakes Messi, One Goal Away From Entering All-Time Top 10

DOHA: Indian football talisman Sunil Chhetri has surpassed Argentina's global superstar Lionel Messi to become the second-highest active international goal-scorer with 74 strikes, adding another feather to his illustrious career.

The 36-year-old Chhetri achieved the staggering feat with his brace against against Bangladesh in the joint preliminary qualifying round match for 2022 FIFA World Cup and 2023 AFC Asian Cup here on Monday night.

The seasoned striker, who helped India register their first win in six years in World Cup qualifiers, now stands only behind Portugal's Cristiano Ronaldo (103) in the active international goal-scorer list.

"I do not count the number of

goals. 10 years later, we will sit together, have a chat and then count," Chhetri said after the match. Chhetri leads Barcelona star Messi by two goals and sits a place above Ali Mabkhout of the UAE, who is third on the list with 73 strikes to his name.

The India captain is also just goal away from entering world football's all-time top-10. He is behind Hungary's Sandor Kocsis, Japan's Kunishige Kamamoto, and Kuwait's Bashar Abdullah, who all have 75 goals.
