The rainfall started in the Valley on Friday evening, dipping the mercury by a few notches and bringing much sought relief to the people from the scorching sun, officials said. Srinagar, the capital city recorded a maximum temperature of 34.0 degrees Celsius, seven notches less than the temperature recorded on Thursday.

Coronavirus more likely to spread indoors through maskless interaction: Study

peaking in indoor spaces without wearing a mask poses the greatest risk of spreading SARS-CoV-2, the virus that causes COVID-19, to others, a study has found.

The research, published in the Journal of Internal Medicine on Tuesday, describes how different sized respiratory droplets emitted while speaking have a range of sizes, and can carry different amounts of virus.

According to the researchers of the study, the

most concerning droplets are those of intermediate size that remain suspended in air for minutes

These droplets can be transported over considerable distances by air currents, they

'We've all seen some spit droplets flying when people talk but there are thousands more, too small to be seen by the naked eye," said Adriaan Bax, of the US National Institute of Diabetes and Digestive and Kidney Diseases. "When the water evaporates from such speech-generated, potentially virus-rich droplets, they float in the air for minutes, like

The researchers reviewed many studies on the physical and medical aspects of aerosol droplets in virus transmission that have appeared since the start of the COVID-19 pan-

They concluded that airborne transmission of SARS-CoV-2 is not only the dominant pathway for transmitting COVID-19, but unmasked speech in confined spaces represents the activity that poses the greatest risk to

"Since eating and drinking often take place

indoors and typically involve loud speaking, it should come as no surprise that bars and restaurants have become the epicentre of multiple recent superspreading events," the authors of the study said.

They noted that next to vaccination, mitigation strategies should emphasise the use of face masks when speaking, and ensuring adequate ventilation to flush out long-lived

According to the researchers, such aerosols might otherwise accumulate in closed environments and enhance the risk of more serious lower respiratory tract infections.

Genetics, lifestyle play crucial role in Covid-19 susceptibility: Study

enetics, immunity and life-style are among the contributing factors for Covid-19 susceptibility, an analysis by an international team of scientists said on Friday.

The study was directed by Dr Kumarasamy Thangaraj, Director, Centre for DNA Fingerprinting and Diagnostics and Chief Scientist, CSIR-Centre for Cellular and Molecular Biology (CCMB), here, and Prof Gyaneshwer Chaubey, Banaras Hindu University, Varanasi, a press release from CCMB said.

With growing data, it is becoming quite clear that there are several factors, including genetics, immunity and life-style, that contribute to Covid-19 susceptibility. CCMBs expertise in population studies is proving useful in understanding

these details of the ongoing Covid-19 pandemic, Vinay Nandicoori, Director, CCMB, said.

An earlier study suggested that a specific DNA segment, strongly associated with severe Covid-19 infection and hospitalisation, was found in 50 per cent of South Asians as compared to 16 per cent of Europeans.

However, the study concluded that the genetic variants responsible for Covid-19 severity among Europeans may not play a role in coronavirus susceptibility among South Asians, the release said.

The scientists have compared infection and case fatality rates with South Asian genomic data over three different timelines during the pandemic, especially large number of populations from India and Bangladesh in the ongoing Covid-19 pandemic, but it is still unclear why symptoms and adverse outcomes than others.

The study also suggests that the genetic variants correlated with Covid-19 outcomes differ significantly among caste and tribal populations of Bangladesh.

Scientists working in the area of population studies should be more cautious to interpret their findings by differentiating caste and tribal populations, more explicitly so in the Bangladeshi population, Prof George van Driem, a renowned linguist and co-author of the study, said.

Study suggests more 'fairness' required in conservation

he findings of a new study suggests that what is often assumed to be 'fair' in conservation practice might not be considered so by the very people most affected by it.

The study published in the journal Environmental Science and Policy also found that a new approach is needed if protected areas are to be effective.

From the ARC Centre of Excellence for Coral Reef Studies based at James Cook University, Lead author Dr Georgina Gurney said considering local stakeholder conceptions of fairness in conservation is critical.

"If conservation is perceived as unfair it can lead to conflict, undermining support and cooperation," Dr Gurney said

She said it is an ethical matter and key to achieving good outcomes for people and the environment. "But what is fairness? Very few studies

have asked this question in the context of conservation, especially marine protected areas.

The researchers asked Indigenous communities in Fiji (who hold customary tenure rights to land and sea) about the fairness of five alternative approaches to distributing money paid by tourists to dive in a new comanaged marine protected area.

"Our study found local stakeholders considered the 'most fair' way to distribute money from the area was acarea," said co-author Dr Sangeeta Mangubhai, Director of the Wildlife Conservation Society Fiji Country

Program. They thought the least fair way to distribute money was according to the costs incurred to fishers who were affected by the new rules prohibiting fishing.

The findings challenge common assumptions in much of the conservation literature and practice about what constitutes distributional fairness. These often focus on equality and the forgone economic benefits of resource extraction, such as fishing. "Our findings help clarify fairness in global environmental policies and agreements," Dr Mangubhai said. Explicitly identifying what is considered fair by those most affected by conservation is important during both the planning and evaluation processes.

This practice is especially important in low- and middle-income counpolicy undertaken in these countries are often shaped by that developed in rich Western countries, which means they are underpinned by Western ideas about fairness.

"As the coverage of conservation areas is expected to grow to 30% of the world's surface by 2030, more attention should be given to what local stakeholders consider is fair with regards to related decision-making and the distribution of associated costs and benefits," Dr Gurney said.

In a notification, the Union Ministry of Environment, Forests and Climate Change has proposed that the eco sensitive zone shall be of 137.75 square kilometers with an extent 0 (zero) to 9.90 kilometers around the boundary of Dachigam National Park, Thajwas (Baltal) wildlife sanctuary and Overa-Aru wildlife sanctuary.

'The zero extent of the ecosensitive zone is towards the South and South-West side of Overa-Aru Wildlife sanctuary as the Eco-Sensitive Zone boundary passes along the important tourist destination of Pahalgam and Nunwan Camp, the base camp of the famous annual pilgrimage Amarnath Yatra.



Further, the Pahalgam area is Aru Wildlife Sanctuary and Thainfrastructural development and is notified under the Development Act as the local area for Pahalgam Development Authority. Also, the area has a sizable resident population and infrastructure," reads the notifications.



Hurriyat Being Roped In For Mid-Term Polls: Omar

SRINAGAR - National Conference president, Omar Abdullah, today said that the state was moving towards mid-term polls in view of the rap-idly changing political situation. He said that efforts were on to rope in the leadership of the Hurriyat Conference for the election which, according to him could be held either at the end of this year or the start of the next.

The NC chief attacked the PDP, describing it as a "branch of the Congress with headquar-ters in New Delhi" and held die present coalition government responsible for the death of Ghulam Mohiuddin Shah. 'The Assembly elections in the state would be announced

anytime as the political situa-tion is witnessing a rapid change. We might have to plunge in the electoral battle anytime." Omar told party workers at session held in NC head-quarters in memory of Mirza Muhammad Afzal Becig and Ghulam Mohiuddin Shah. He said that efforts were be-ing made to persuade the Hurriyat

leadership and other separatist groups to take part in the polls.

The N C president also launched a scathing attack on the moderate Hurriyat and other separatist leaders who are currently on a visit to Pakistan and Pakistan-controlled Kash-mir (PcK) for their "conflicting statements." Omar said after becoming a Union Minister, he had advised the Centre to allow the Hurriyat leaders to visit Pa-kistan to enable them to prevail upon the militant leadership there to stop bloodshed and help put an end to use of the gun in the state.

"În the Muzaffarabad as-sembly, the Hurriyat leaders talked of silencing the guns, but in a secret meeting with Syed Salahuddin, they advised the continuation of the role of the gun." the KNS quoted him as having said "They (Hurriyat leaders) .have misled the Kashmiri people."

"What was the point in meeting Syed Salahuddin in se-cret when they had publicly an-nounced that they were going to talk to the militant leadership?" he asked.

"No political party, includ-ing the National Conference can claim to be the sole repre-sentative of the state." Omar said "The participation of all political parties is essential in any negotiations aimed at resolving the Kashmir issue.'

The NC Chief said the party leadership — Sheikh Mohammad Abdullah and Mirza Mohamad Afzal Beigh had given a roadmap about 60 years ago to resolve the Kashmir issue. The ongoing peace talks be-tween India and Pakistan and

Ex-Mossad Chief Reveals Operations Against Iran In A Revelatory Interview



ossi Cohen, the ex-Mossad chief, has given a revelatory interview just days after stepping down as the head of the intelligence agency.

The ex-top spy of the Israeli intelligence agency revealed the details about the theft of Iran's

Cohen revealed that Iran's nuclear archives were stolen by and therefore "he was a target Mossad from safes in a warehouse in Tehran.

The ex-Mossad chief hinted the agency's involvement in the assassination of Iran's top nuclear scientist, confirmed that the scientist, Mohsen Fakhrizadeh, had

been in Mossad's sights for years. Cohen gave what appears to be the most revelatory interview by a Mossad Chief to journalist Ilan Dayan on Channel 12's Uvda documentary program, which was approved by Israel's military censors and was broadcasted on Israeli television on Thursday night.

Cohen was appointed as Mossad chief in late 2015 by Israeli Prime Minister Benjamin Netanyahu.

The ex-Mossad chief neither confirmed nor deny his involvement in the assassination of Iran's nuclear scientist, however, he said that Fakhrizadeh "most troubled us from the point of view of the science, the knowledge, the scientists of the Iranian military nuclear program,' for [intelligence] gathering for many years.'

"If the man constitutes a capability that endangers the citizens of Israel, he must stop existing," Cohen said as quoted by The Times of Israel.

He also added that someone could be spared "if he is prepared to change profession and not harm us any longer".

"Yossi Cohen cannot take responsibility for this action, but his personal signature is on the entire operation," said interviewer Dayan of Fakhrizadeh's

UK Says Delta Variant 60% More Transmissible Amid Rise In Covid Cases

LONDON: The British government said Friday that the new Delta coronavirus variant is 60 percent more transmissible in households than the variant that forced the country to lock down in January.

The Delta variant, which first emerged in India, has caused a rise in cases in the UK, prompting questions about whether social distancing restrictions will be lifted as planned from June 21.

New research from Public Health England "suggests that the Delta variant is associated with an approximately 60 percent increased risk of household transmission" compared to the Alpha variant identified in Kent, southeast England.

AstraZeneca COVID-19 Vaccine Linked With **Small Risk Of Low Blood Platelets: Study**

LONDON: The Oxford-Astra-Zeneca vaccine, also known as Covishield, may be associated with a very small risk of developing a blood condition characterised by low platelet counts, according to a nationwide study in the UK.

The increased risk of the condition, known as idiopathic thrombocytopenic purpura (ITP) is estimated to be 11 per million doses, similar to figures seen in vaccines for flu, and measles, mumps, and rubella (MMR), the researchers said.

A low number of platelets -- blood cells that help prevent blood loss when vessels are damaged -- can result in no symptoms or can lead to an increased risk of bleeding or, in some cases, clotting, they said.

The team, led by researchers at the University of Edinburgh in the UK, noted that people at most risk from ITP tended to be older -- a median age of 69 years old -- and had at least one underlying chronic health problem such as coronary heart disease, diabetes or chronic kidney disease.

The development raises serious questions for the US, other countries and international organisations with missions in Kabul about how to securely evacuate their personnel from landlocked Afghanistan, should fighting threaten the capital, Reuters news agency reported on Thursday.

It also appeared to dash Ankara's hopes of using the securing of Kabul airport to help improve ties with Washington – strained by Turkey's purchase of Russian defence systems – in talks set for Monday between President Joe Biden and Turkish President Recep Tayyip Erdogan.

Asked in a text message whether the Taliban rejected Turkey's proposal to keep forces in Kabul to guard and run the international airport after other foreign troops leave, the Taliban spokesman in Doha responded that they should go as well.

'Turkey was part of NATO forces in the past 20 years, so as such, they should withdraw from Afghanistan on the basis of the agreement we signed with US on 29th Feb 2020," Suhail Shaheen told Reuters.

"Otherwise, Turkey is a great Islamic country. Afghanistan has had historical relations with it. We hope to have close and good relations with them as a new Islamic government is established in the country in future," he added.

The State Department and the Turkish foreign ministry did not immediately respond to requests countries to shutter their missions. for comment, Reuters said.

Under the February 2020 deal between the Taliban and the US signed by former President Donald Trump's administration, all US forces were to be out of Afghanistan by May 1.

With violence raging, many US legislators and current and former officials fear the departure of the foreign forces and stalled peace talks are pushing Afghanistan into an all-out civil war that could return the Taliban to power.

The Pentagon says the US withdrawal is more than 50 percent complete. Turkey, with more than 500 soldiers still in Afghanistan training security forces, now has the largest foreign military contingent there.

Pakistan's National Assembly Passes Bill To Give Right Of Appeal To Kulbhushan Jadhav

The Pakistan government has rushed through the National Assembly a bill to provide the right of appeal to Indian death-row prisoner Kulbhushan Jadhav amidst ruckus and boycott by the Opposition.

The lower house of Parliament passed the ICJ (Review and Re-consideration) Bill, 2020 on Thursday. The bill is aimed at allowing Jadhav to have consular access in line with the International Court of Justice (ICJ) verdict.

Jadhav, the 51-year-old retired Indian Navy officer, was sentenced to on charges of espionage and terrorism in April 2017.

The Hague-based ICJ ruled in July 2019 that Pakistan must undertake an "effective review and reconsideration" of the conviction and sentence death by a Pakistani military court of Jadhav and also to grant consular access to India without further delay.



The Impending crisis: US exit from Afghanistan

The US has already accepted it as fait accompli that Taliban is going to take over Afghanistan again after their exit. istory may repeat itself too soon in Afghanistan. Nearly three decades back, when the last Soviet soldier left the Afghan soil, the events that unfolded then may get replicated exactly with NATO exit too. Afghanistan famously considered as a graveyard for foreign invaders due its rocky treacherous terrain, often gives undue strategic advantage to local Afghans to overpower their opponents, who are not acclimatized to fight amid such tough and testing conditions. Who would have thought then that the euphoria of Soviet exit was just an illusion for the landlocked Afghan nation as the worst was yet to unfold for them in the form of a bloody civil war that started between the local warlords from different provinces to conquer the fortress of Kabul. Historical records are testimony to this fact that more casualties of civilians were reported due to infighting between these warlords on Afghan soil than the war with Soviet forces. That ultimately paved the way for Talib's (Arabic word for students), then studying in Islamic seminaries of Frontier provinces of Pakistan to come together under the banner of a new organization called Taliban to wage a brutal war of aggression with the aid of Pak-Saudi alliance jointly funded by CIA against these warlords just to tighten its grip on the whole afghan affairs.

What followed after this was the beginning of the infamous Taliban regime. Afghanistan was rechristened from "republic" to Islamic republic of Afghanistan. Religion was forced on people under the guise of shariah law, the world was squeezed for women to four walls, public hanging for crime was endorsed and Afghanistan became the new breeding ground for many Islamic fundamentalist organisations like Al

The covid-19 pandemic has been a show of unending horror—full of suspense coupled with a certainty of danger. Those who have witnessed its grotesque reality unfold right in front of their eyes have been health care workers. We got in touch with doctors, who shared with us their experiences during the covid crisis and fears following the second wave of covid-19

ow that finally, the number of Covid cases is coming down, we have enough infrastructure to take severe cases as they come. Unlock is necessary because we have had so many people lose their livelihood during these two months and the one year previous to it. Finally, when things start going back to normal, we can get the economy somewhere back in place.

My fear regarding the lockdown is that people and the government will not learn anything from the current crisis and we will get back to the same old system. The fear is that we will forget all the learnings that we have had in these couple of months and the year that proceeded.

Vaccine definitely can be helpful during the unlock. ore the vaccination, less the severe Covid infection and more home management and certainly better outcome of the unlock phase. I think, at the moment, vaccine is the only thing that can help us go through the unlock phase and go back to a normal life.

Dr. Sabine Rafiq Kapasi Sheikh, AAM Hospital Mumbai

Unlock is a two-edged sword. It's necessary for the depleting economy but on the other end, due to negligence of people and stupid assumptions, people don't follow the rule of wearing a mask, maintaining social distancing and consequently, the infection rates go frenzy.

Vaccination is an extra sheath of protection and it's very effective in decreasing the severity of the disease. It's like wearing seat belts for preventing accidents, even though there are risks of accidents, but it does decrease the severity. Like in my case, I was diagnosed with Covid but due to 2 doses of vaccine, it wasn't very severe and I could get back to my duty within 14 days.

Dr. Sovan Kumar Subuddhi, House Surgeon, MKCG Medical College and Hospital, Berhampur Odisha

"Speaking from an economic perspective, the new guidelines announced by the government on the unlock are better than a complete lockdown. However, people need to understand that unlock is not the end of the pandemic and unlock means they will have to follow the Covid-appropriate behaviour more strictly. A few days ago I was travelling to Dalgate Srinagar and I saw a lot of people without masks. People should understand that masks are necessary. We need double masking right now and frequent sanitizing of hands.

Vaccination is also very important to complement the unlock process. People who have received one/two doses of vaccine do not get a severe infection. I have got vaccinated. My niece of 18 years got vaccinated and my mother has also got vaccinated. There is no relationship between vaccination and infertility. If you're vaccinated you might still get Covid but it would be mild. I request you all to get vaccinated and consider the mask and sanitiser as a part of your life till the pandemic is over.

Dr. Sheikh Amina, Gynaecologist

"It's the residents whom I will call the true warriors. Initially it was scary being a surgeon and that too, to deal with the medicine branch .But once you are in the ward you see the patients and their misery. You just can't help doing your best for the patients. Give them the encouragement, give patient hearing to the patients and just be compassionate towards them. But at the same time praying you should not be the source of infection for your near and dear ones. It has been mentally challenging to say the least'

Dr Natasha, surgeon, skims.

"I'm a doctor who's been working with covid patients for over a year. Everyday I see patients who don't know when this unpredictable disease will suck the life out of their lungs. Within days, a completely healthy individual with no health issues starts gasping for oxygen.

The mental anguish I see patients going through is hard to explain in words. When I get back home with a heavy heart and crave to see my three year old daughter, the one person who can bring some sunshine back in the dark time,I see her waiting patiently by the door. But I can't even give her a hug, fearing I might be carrying the infection.I can't imagine the attendant who just saw his loved one struggling for life and that compels me to tell my daughter to stay away from me.It breaks my heart every time I tell her this and the look she gives me is the saddest face in the world, worse than when I tell her she can't have an ice cream.I just hope this madness ends

Dr Shahid, Rainawari hospital

"I had been on covid duty since the first wave of covid-19. Away from family, I had no option but to put up a brave face. Being a Kashmiri, the weather has always been an enemy for us in mainland India. However, with the PPE gear as well, it was practically hell for us.

SC Rejects Plea Seeking Another Loan Moratorium, **Says Matter Is Up To Govt**

The Supreme Court Friday refused to pass direction on a plea seeking remedial measures to redress the financial hardship faced by borrowers during the second wave of COV-ID-19 pandemic, saying it is in the realm of policy decision.

"Government has many things to do. They have to spend money on vaccine, they have to spend money on migrant labourers. We cannot do it like this," the apex court said, adding that it is for the Centre and the RBI to consider the issue.

These are all in the realm of policy decision. These are are policy matters and it is for issues having financial implications and we are not the experts," a bench of Justices Ashok Bhushan and M R Shah told advocate Vishal Tiwari, who has filed the petition.

The top court was hearing the plea which sought directions to the Centre and the Reserve Bank of India (RBI) to take effective and remedial measures, including in the form of fresh loan moratorium, to redress and overcome the financial stress and hardship faced by borrowers during the stalments for a period of six second wave of COVID-19 pandemic and the lockdown.

During the hearing conducted through video-conferencing, Tiwari referred to the reports on how the second wave of the pandemic has affected the Indian economy and said the situation is much worse as compared to last year.

The bench noted in its order that the petitioner has also annexed the last month's circular by which the RBI had issued resolution of COVID-19 related stress of Micro, Small and Medium Enterprises (MSMEs).

The petitioner appearing in person submits that the circular does not sufficiently address the hardship of the borrowers. Be that as it may, the financial relief and other measures are in the domain of the government and essentially related to policy matter, the bench said in its order.

"We are, thus, of the view that no direction, as prayed in the writ petition, be passed. We, however, observe that all the issues, which are raised, the Union of India and the Reserve Bank of India to consider and take appropriate decision. The writ petition is disposed of," the apex court said.

The bench said it had dealt with similar aspects in a writ petition which was filed last year.

The plea filed by Tiwari had sought directions to the Centre and the RBI to permit the lending institutions to grant interest-free moratorium period for term loan and defer the payment of loan inmonths or till the situation from COVID-19 normalises.

Explained: China's New Law Could Be A Headache **For Foreign Businesses**

BEIJING: A new Chinese law against foreign sanctions is designed to boost Beijing's power against international pressure, but could spark compliance dilemmas for foreign businesses operating in the world's secondlargest economy. It comes just a week after US President Joe Biden expanded a blacklist of Chinese companies in which Americans are not allowed to invest.

Here is what we know about the law so far:

What is it?

law was rushed into force on fied the effect of US Iran sanc-Chinese individuals or organisations in the event that a country "uses various pretexts or its laws" to take "discriminatory" action against them.

No country is specifically named. But Beijing has accused Western nations of "suppressing" China's development, especially the United States. It has lashed out at "illegal and unreasonable" sanctions over human rights and flagged an urgent need to fight back.

What could it do?

Countermeasures listed in the law include denying visas, deportation, or seizing assets of those who formulate or comply with sanctions against Chinese businesses or officials.

It rules that authorities are not only able to target individuals and groups but can also take aim at their family members. The law is broad and "signifi-

The law will help "counteract the containment and suppression" China faces, the official added. Beijing has long complained

about US sanctions and trade restrictions affecting Chinese companies. But in recent months Biden has stepped up US criticism over intellectual property theft and alleged human rights abuses in Hong Kong and the northwestern Xinjiang region.

How much of a threat is it? Ku warned the law had "some reasonable parts, and some troubling parts".

The section allowing for retaliatory sanctions "is unprecedented compared to other countries' sanctions regimes", he said.

Foreign companies are regularly caught in the crosshairs of tension between China and Western nations, including recent nationalist attacks on fashion brand H&M for voicing concern about forced labour claims in Xinjiang.

FM To Chair GST Council Meet Today; Tax Cut On Covid Essentials On Agenda

NEW DELHI: Finance Minister Nirmala Sitharaman will on Saturday chair the meeting of the GST Council, which is expected to decide on tax relief for COVID-19 essentials and black fungus medicine.

The 44th GST Council meeting will be attended by Minister of State for Finance Anurag Thakur, besides finance ministers of states and Union territories and senior officers from Union government and states, the Union finance ministry tweeted on Friday.

The Council will discuss the report of the Group of Ministers, headed by Meghalava Deputy Chief Minister Conrad Sangma, on GST concessions on COVID-19 relief items like medical grade oxygen, pulse oximeters, hand sanitisers and ventilators, among others. Besides, GoM also looked into vaccines, drugs and medicines for

COVID-19 treatment and testing kits for its detection. Some state finance ministers in the GoM are understood to have pitched for a rate cut on COVID-19 essentials.

UP Finance Minister Suresh Kumar Khanna, who is also a member of the GoM, had on Wednesday said the state is in favour of cutting taxes on COVID-19 essentials to facilitate patients, but will accept the decision of the GST Council on tax rates.

10.35 % Population In J&K Living Below Poverty Line: Survey

SRINAGAR: At least 10.35 percent population in Jammu and Kashmir is living below the national poverty line, reveals Development Sustainable Goals (SDG) Index 2021.

A survey conducted by Niti Aayog reveals that over 10.35 percent of the population in J&K is living below the national poverty line while just 4.20 percent of households with any usual member are covered by a health scheme or health insurance.

It was also stated that Jammu and Kashmir was producing over 2339.65 kilogram hectares of rice and wheat annually in accordance with per

unit area, reveals Sustainable Development Goals (SDG) Index 2021.

The report states that the global SDG aims to double agricultural productivity by

It reveals that the indicators have been selected based on the availability of data at the sub-national level and to ensure comparability across States and UTs.

"Tamil Nadu and Delhi are the top performers among the States and the UTs. J&K stands on 7th rank among Union Territories with scoring 69 against the national average of 60," it reads.

As per the SDG index, the national poverty line in Jammu and Kashmir Union Territory stands at 10.35. Global SDG target reduces at least by half the proportion of men, women and children of all ages living in poverty in all its dimensions according to national definitions.

Further, only 4.20 percent of households with any usual member covered by a health scheme or health insurance are there in UT.

This target corresponds to the global SDG target that aims to implement nationally appropriate social protection systems and measures for all.

The Niti Aayog data reveals that 4.30 percent of households of Jammu and Kashmir were living in Kacha houses.

Within a few minutes, the holes started to melt through the panels of these structures, and the warm air inside the house rushed outward, igniting the panels and spreading the fire across the roofs.

The relative humidity, the wind speed and direction only propelled the fire straight toward other far located houses.

"After the first LPG spark," a police officer part of the rescue mission says, "there were around 4 LPG gas cylinder blasts from various houses that further abetted the fire."

Soon, it became obvious to the witnesses that the blaze was approaching from everywhere and that it was impossible to save the colony from that "It was suddenly much darker," Altaf continues.

"Everyone had their flashlights and torches on. The sky above the blazing colony had become an orange ball but waning into absolute black. The plume from the fire had billowed upward and then fell earthward again. The burning sound was more ferocious than the flames."

When the blaze thawed a bit due to "the joint efforts by the local youth, firemen, police and army", everyone could feel their mind grinding against what happened, desperate to whittle it down into a simple explanation of what went wrong, who should be blamed, what could be learned.

There were many credible answers, specific mistakes to call out. But it was easy to worry that, given the scale of this particular disaster. The principal takeaways might be only humility and terror. "No one can be blamed for this particular disas-

ter," a local standing in the backdrop of his gutted house says. "If one would've visited this locality before this

incident, it was clearly visible that there were no fire gaps maintained between residential structures and that was the reason why the fire blazed the whole of the colony."

The blaze upshot renewed mourning at the crack of the dawn.

Wailing women, crying children and sobbing men arrived in droves to see a major portion of their colony lying under the heap of ash.

Some of them removed their half-burnt essentials from under the rubbles of their memories, checking the damage of the 20 residential houses that are no more visible. Around 35 families are left without a roof overhead. "One victim of this blaze had been saving for the

last 10 years for his daughter's wedding," Ibrahim says. "And now, that money, the newly bought wedding clothes, their dreams, everything has been turned into ash just like their house." To provide relief to the victims of this blaze, the

Baramulla administration has asked the Tehsildar, Accounts Officer, Revenue Officer, and Senior Police Officers to review the damage and estimate the relief cost.

"We'll provide compensation to these families as soon as possible," Ghulam Mohammad Chopan, NaibTehsildar Baramulla told Kashmir Observer.

"For now, these victims have been provided temporary shelter by the administration with all essential services like food and medical attention in neighbouring parts of Noorbagh, Baramulla."

Even though there wasn't any damage to human life and all the affected families are together, they still feel trapped.

The slight smoke blooming erratically around the rumble of houses, the impregnable riot of burned walls, charred woods and excessive heat are enough to keep on traumatising the wailing victims, maybe forever.

The fire victims, he said, thanked the LG and his Advisor for their personal intervention and their efforts to extend immediate relief to the sufferers.

Meanwhile, the Divisional Commissioner (Div Com) Kashmir, Pandurang K Pole accompanied by Deputy Commissioner Baramulla Bhupinder Kumar, SSP Ravees Ahmad Bhat and other concerned functionaries also visited the fire affected families, the official spokesperson said.

27 Face Punishment For Hosting 'Unprofessional' Ultra-Marathon **That Killed 21 Runners**

BEIJING: Twenty-seven people, including several senior municipal government officials, faced disciplinary punishment or criminal charges after being held responsible for hosting an "unprofessional" ultra-marathon race in Gansu province last month in which 21 runners died, local authorities announced on Friday.

A 100-kilometre cross-country mountain race in the north-western province of Gansu turned deadly on May 22 as freezing rains, high winds and hail suddenly hit the competitors. Twenty-one people, including China's well known ultra-marathon runner Liang Jing, were killed in the tragedy.

"Non-standard and unprofessional event operations led to the accident," read the investigation report announced at a press conference held in Lanzhou, capital of Gansu province.

A total of 172 people participated in the mountain marathon. While eight sustained minor injuries, 151 were confirmed safe. Most competitors were wearing

Sports Ministry Launches Athlete Injury Management System

NEW DELHI: Sports Minister Kiren Rijiju on Friday launched an ambitious initiative to provide world class treatment and rehabilitation to elite athletes injured during competition or training.

The Centralised Athlete Injury Management System (CAIMS) aims to provide inputs on prevention, diagnosis and high quality treatment and rehabilitation to athletes on time and maintain records for mapping their injury via an Online Athlete Management

This system, to be run by the Sports Authority of India (SAI) in collaboration with the leading medical experts of the country, will be applied initially to the developmental group of athletes for the 2024 Paris Olympics and will broaden to others later on.

"I have seen athletes whose careers have been damaged or shortened due to lack of timely and proper treatment of even common injuries. For some injuries, treatment is not available in our country and athletes will have to go abroad. So, this is a humble beginning to address that," Rijiju said in an online event.

"I hope this initiative will lead to a system where we will have a professional way of managing



injury of athletes. It is something long desired by one and all. This is a centralised platform where we will have a common and uniform injury and rehabilitation management system."

He said sports science in India is still in a nascent state and need improvement.

"We want to be a sporting powerhouse and to have a world class injury management is an integral part of that. Injury management is a part of that (sports science). We need an excellent and professional injury management of the athletes."

"We will need upgradation and improvisation in many things and that is how we will learn to make this a success.

Indian Olympic Association President Narinder Batra lauded the Sports Ministry and the Sports Authority of India for the initiative.

"A lack of communication between athletes and medical providers leads to devastating injuries to athletes, hinders their recovery and leads to re-injury and that affects their career," Batra said.

"I would like to emphasise that the confidentiality of the injury of the athletes should be maintained and should never be made public.'

As 'A' Team Coach, Made Sure Every Player On Tour Got A Game: Rahul Dravid

NEW DELHI: Widely credited for creating India's talent pool at the under-19 and A level, former captain and NCA Director Rahul Dravid says during his stint as coach with these teams, he made sure that every cricketer who toured got a game unlike his playing days.

Dravid will be head coach of a Shikhar Dhawan-led Indian team that will tour Sri Lanka for a whiteball series next month. He doesn't travel with the A and U-19 squads any more but it was he who made sure all the squad members played on tours.

"I tell them upfront, if you come on an A tour with me, you will not leave here without playing a game. I've had that personal experience myself as a kid: going on an A tour and not getting an opportunity to play is terrible," Dravid ESPNcricinfo's 'The Cricket Monthly'.

"You've done well, you scored 700-800 runs, you go, and you don't get a chance to show what you're good at. And then you're back to square one from the selectors' point of view, because the next season you have to score those 800 runs again.

"It is not easy to do that, so there



is no guarantee you'll get a chance again. So you tell people upfront: this is the best 15 and we are playing them. This is not about the supposed best XI. At U-19, we make five-six changes between games if we can,"

Indian cricketers are now among the fittest in the world but there was a time when they did not have the required knowledge on fitness and envied the more athletic Australians and South Africans, Dravid said.

Now in charge of the National Cricket Academy, Dravid has played a key role in producing the next generation of cricketers and a reserve pool which is the envy of India's op-

In his playing days, Dravid said the awareness just wasn't there.

"Playing on the beach and playing on the road doesn't make you a cricketer. It makes you someone who loves the game. That's what we had. We had a lot of people who loved the game," Dravid said.

"Unless you give that guy a proper matting wicket or a turf wicket, unless you give him some half-decent coaching, some half-decent fitness assistance- where was all this in the 1990s and the 2000s? There was no access to it. We were starved of

"Even in terms of fitness, we used to look at the Australians and South Africans and we used to look at their fitness trainers, and what did we get? 'Don't do too much gym, your body will become stiff. Bowl, bowl and bowl. Run rounds and laps'," he recalled.

Lakshadweep Filmmaker Booked For Sedition Over 'Biological Weapons' Comments

The Lakshadweep Police on Thursday booked filmmaker Aisha Sulthana on sedition charges following a complaint by a BJP leader that she spread false news about the spread of COVID-19 in the Union territory during

The complaint was filed by the BJP's Lakshadweep unit president Abdul Khader. Sulthana hails from Chetiath island in Lakshadweep.

According to the FIR lodged by the Kavaratti police, a case under sections 124A (sedition) and 153B (hate speech) of the Indian Penal code has been registered against the filmmaker.

SC Postpones INI CET Exam 2021 by a Month



The Supreme Court Friday termed as "arbitrary" the fixing of June 16 for conducting INI CET 2021 and directed All India Institute of Medical Sciences (AIIMS) to hold the post graduate medical entrance test after one month. A vacation bench of Justices Indira Banerjee and M R Shah disposed of a plea filed by doctors seeking admission in PG medical and challenging the notification of fixing June 16 as date of INI CET 2021. The bench said that having regard to the difficulty faced by the candidates due to the examination and many placed far way due to COVID duty from the examination centre, the exam needs to be postponed.

Around 80,000 candidates are vying for 815 seats in the national level examination which is being held by AIIMS. The 815 seats are spread across 8 institutes of AIIMS and JIPMER, Puducherry, NIMHANS, Bengaluru and PGIMER, Chandigarh.

The INI CET 2021 was initially scheduled to be held on May 8 but was rescheduled to June 16 due to the COVID pandemic.

US Delays Use Of India-Made COVID-19 Vaccine Covaxin. What It Recommended

HYDERABAD: In a setback to Bharat Biotech's COVID-19 vaccine Covaxin, the US Food and Drug Administration has "recommended" Ocugen Inc, the US partner of the Indian vaccine maker, to go for Biologics Licence Application (BLA) route with additional data, nixing hopes of Emergency Use Authorisation.

Ocugen in a statement on Thursday announced that as recommended by the US FDA, it will pursue submission of a biologics licence application (BLA) for Covaxin.

Biologics Licence Application or BLA, is a "full approval" mechanism by the FDA for drugs and vaccines.

"The company will no longer pursue an Emergency Use Authorisation (EUA) for Covaxin. The FDA provided feedback to Ocugen regarding the Master File. The company had previously submitted and recommended that Ocugen pursue a BLA submission instead of an EUA application for its vaccine candidate and requested additional information and data," Ocugen said.

The development may delay the Covaxin launch in the US, Ocugen said. Ocugen is in discussions with the FDA to understand the additional information required to support a BLA submission. The company anticipates that data from an additional clinical trial will be required to support the submission.

"Although we were close to finalising our Emergency Use Authorisation application for submission, we received a recommendation from the FDA to pursue a BLA path. While this

will extend our timelines, we are committed to bringing Covaxin to the US," Dr. Shankar Musunuri, Chairman of the Board, Chief Executive Officer and co-founder of Ocugen said.

"This differentiated vaccine is a critical tool to include in our national arsenal given its potential to address the SARS-CoV-2 variants, including the delta variant, and given the unknowns about what will be needed to protect US population in the long term," he added.

Ocugen recently announced that it secured exclusive rights to commercialise Covaxin in Canada and has initiated discussions with Health Canada for regulatory approval.

The company will pursue expedited authorisation for the vaccine under the Interim Order Respecting the Importation, Sale and Advertising of Drugs for Use in Relation to COVID-19 in Canada.

In a statement issued by Bharat Biotech, the company said that "The USFDA had earlier communicated that no new Emergency Use Authorisation will be approved for covid vaccines. All applications have to follow the biological license application process, with is the standard process for vaccines."

Bharat Biotech further stated hat "Covaxin has received FLIA's 14 countries with more than 50 countries in process," adding that "No vaccine manufactured or developed from India has ever received Emergency Use Authorisation or full licensure from USFDA. When approved, it will be a great leap forward for vaccines Innovation and manufacturing from India."

With the party now gearing up for the next round of assembly polls in five states early next year, including in all important Uttar Pradesh. it is expected to take various measures to bolster its social equation.

COVID Threatens India's Regional, Global Ambitions: **Us Think-Tank**

'ndia's domestic challenges due to COVID-19 crisis have L become a threat to its regional and global ambitions, a US thinktank has observed and warned that unless it recovers with the help of allies like the United States, the pandemic could impact the geopolitical balance in the Indo-Pacific.

As such, it is in the United States' best interests to help India retain its status as a pre-eminent power in South Asia, particularly in view of China's efforts to bolster its position at the expense of the US and India, it said.

The Hudson Institute think-tank said that at the start of the pandemic. India offered medical assistance to its immediate neighbours and followed vaccine diplomacy in the first three months of 2021 which helped India to project itself as a of being a global power in waiting.

"There was optimism that India would be able to counter China's soft power with its own. Now, however, at least over the short term, India's domestic challenges have become a threat to its regional and global ambitions," wrote Husain Haggani, a former Pakistani Ambassador to Sri Lanka and the US, and Hudson research scholar Aparna Pande.

Haqqani is currently the director of South and Central Asia at the Hudson Institute. Pande is director, Initiative on the Future of India and South Asia at the think-tank.

"The recent surge of COVID-19 in South Asia challenges India's traditional ability to aid its smaller neighbours, a change that could, in turn, affect India's influence in its competition with China. Unless India can recover from this surge with the help of allies like the United States, the pandemic could impact the Indo-Pacific's geopolitical balance," the joint policy memo released by Hudson stated.

In the first phase of the CO-VID-19 pandemic, India succeeded in occupying the role of a regional

leader. But official complacency, disinclination on the part of government leaders to accept the advice of scientific advisors and reluctance to ramp up vaccine production and distribution has seriously damaged India's standing, the think-tank report said.

Haggani and Pande wrote that a year-and-a-half after the start of the COVID-19 pandemic, China's footprint in South Asia is larger than it was before. Both Pakistan and Sri Lanka are deeply in debt to China, having borrowed heavily from it due to the pandemic.

"Unless India, the United States, and the financial institutions led by the democracies provide support, the Maldives and Nepal may also turn towards China for assistance," they warned.

Bipartisan support within the US policy community for India has already mobilised Americans to help India. The Joe Biden administration has sent oxygen concentrators, medicines testing kits, ventilators, and personal protective equipment to India, and many US companies and the Indian-American community have rallied to India's support, the think-tank report stated.

The Hudson Institute recommended the Biden Administration offers Covid vaccine doses to India and other countries in need of them. In the short term, one way to help India's economy recover from the impact of the COVID-19 pandemic would be to reinstate India"s Generalized Scheme of Preferences Plus status, which the Donald Trump administration removed.

"A mini-trade deal could be offered to signal American support for India's economic recovery," the policy memo said.

Noting that India's economy underwent its first recession in 2020. contracting by 10 per cent, it said encouragement for American companies and those of other countries such as Japan, South Korea, and Taiwan, that are moving out of China, to invest in India would also aid the country in restoring its economic

Delhi Man Fakes Own Kidnapping, Demands ₹3 Lakh From Father: Police

NEW DELHI: A 23-year-old man, who allegedly faked his own kidnapping to demand `3 lakh from his father, was traced to Punjab's Jalandhar, the police said Thursday.

On June 3, Delhi's Shahbad Dairy police station received a call about the kidnapping. The police reached the spot and recorded the statement of Veer Pal Singh - the father of the man, a senior police officer said.

Mr Singh told the police that his son Aman had gone to the market on June 1 and had not returned home since, officials said.

Mr Singh told the police that he received a call from his son on June 3 who told him that he has been kidnapped and the kidnappers have demanded a ransom of ₹ 3 lakh, the officer said.

He received three calls from his son, asking him to transfer the money to his bank account, they said, adding that a case was registered following that.

During the investigation, the location of the mobile phone from which Aman had called was checked and was found to be in Punjab's Jalandhar following which a team was sent there.

The team interrogated some friends of Aman in Jalandhar. Finally, he was traced on Saturday and brought back to the national capital on Sunday, the police said.

"During the interrogation, Aman told the police that he wanted to



sell a car and discussed the matter with his friend Ankit, a resident of Jalandhar, who told him that he had a purchaser for the vehicle," Deputy Commissioner of Police (outer north) Rajiv Ranjan Singh said.

On June 1, Aman went to Hisar in Haryana where his friend Ankit, the actually owner of the car - Ravi - along with the purchaser met, the police said. The purchaser gave ₹ 2 lakh in cash to Aman but Ravi snatched the cash and fled along with the car, the police said.

The buyer then started pressurizing Aman to return his money as he had not got the possession of the car, the police said.

Aman first went back to Jalandhar along with his friend Ankit and started working in a factory as a labourer. However, since he knew that he would not be able to return the money from the salary of his job, he planned his own kidnapping, called his father, and demanded ₹ 3 lakhs from him, saying that he has been kidnapped, the police said.

Education Ministry Launches Online Module To Track, Re-Enrol Out-Of-School Children

NEW DELHI: The Ministry of Education on Friday launched an online module to compile data on out-ofschool children that will facilitate age-appropriate admissions for children in the 6-14 age group.

The ministry also said that for out-of-school children in the 16-18 age group, financial assistance will be provided for the first time in the 2021-22 session to allow them to continue their education through open or distance learning mode.

Taking care of every student of India is our government's top priority. Accordingly. The department of school education and literacy developed an online module for compiling out-ofschool children's data identified by each State/UT and map with Special Training Centres on the PRABANDH portal," Union Education Minister Ramesh Pokhrival 'Nishank' tweeted.

"Child-wise information of the identified out-of-school children and STCs must be uploaded at block level under the Block Resource Coordinator. A quarterly progress report and a user manual are shared on the portal." he said.

In a letter to education secretaries of all states and union territories, the ministry has sought that the information regarding out-of-school children, special training centres (STCs) and their progress, as uploaded by the block resource centre (BRC), be validated by the district magistrate or an appropriate officer as authorised by the DM.

"In order to facilitate age-appropriate admission of out-of-school children in the age group of 6-14 in regular schools, financial provisions are made in the 'Samagra Shiksha' scheme for arranging special training to bridge their learning gaps and mainstreaming them in schools," the letter said.

"For out-of-school children in 16-18 age group and belonging to socially and economically disadvantaged groups (SEDG), financial assistance has been made available for the first time from the year 2021-22 to continue their education through open/ distance learning mode," it stated.

The letter further said, "The ministry has developed an online module for compiling the data on out-ofschool children identified by each state and UT and their mapping with STCs on the PRABANDH Portal. The child-wise information of the identified out-of-school children and STCs is required to be uploaded at the block level under the supervision of block resource coordinator of the concerned BRC."

"For monitoring the progress of mainstreaming, the quarterly progress report is also to be uploaded on the portal. It is requested that the information regarding out-of-school children, STCs and their progress, as uploaded by the BRC, is validated by the district magistrate or an appropriate officer as authorised by the DM," it said. — PTI
