

#### **Rape Accused Lodged In Jail Dies**

SRINAGAR: A 37-year-old rape accused from Brath Kalan Sopore and lodged in a jail in Kupwara district has died, officials said on Monday. They said inmate identified as Lateef Ahmed Mir son of Hamza Mir was arrested in case FIR No 15/2021 under section 376 (rape), 342 (wrong confinement) registered at police station Sopore. Mir was under judicial custody in district jail Kupwara from February 5. "He was under quarantine after testing covid-19 positive. However, he had tested negative of late. Yesterday he was shifted to hospital and died," Superintendent of Kupwara, Shahbaz Hussain said as per news agency GNS.

### 599 New Cases Reported, **Lowest In Over 2 Months**

SRINAGAR: Jammu and Kashmir reported on Monday 599 new cases of coronavirus, the lowest ever number of cases in over two months, while nine more people succumbed to the infection across the Union Territory during the last 24 hours.

According to the officials, 438 new cases were reported from Kashmir Valley while 161 were detected from Jammu Division thus taking the total number of people infected since the outbreak of pandemic last year in J&K to 308011. The 599 cases were the lowest to be recorded in the Union Territory in the last 68 days.

Giving district-wise details, the officials said that Srinagar reported 161, Baramulla 38, Budgam 60, Pulwama 37,

### **Militant Found Dead In Soura Laid To Rest**


**Family Says Amir Was** A Kidney Patient, Suspect Renal Failure Caused His Death

SRINAGAR: A day after an Al-Badr militant's body was found abandoned near a shrine in Soura area of this capital city, his family said on Monday that their son was diagnosed with a renal failure and may have died of kidney ailments like his mother and elder brother.

22-year-old Amir Gafoor Malik alias Akhtar Bhai, an active militant of the Al-Badr was found dead outside the main entrance of the Janab Sahib Shrine in Anchar area of Srinagar's Soura. His death had triggered speculations about infighting between the militant groups.

### Basmati Truce: Pak, India Agree **To Share Ownership**

ISLAMABAD: In a rare agreement between two arch-rivals India and Pakistan, which have a history of longtime rivalry with disputes on every front from sea to land, exporters from both sides of the border have mutually agreed to share the ownership of the regions prized Basmati rice, a solution considered the most workable to reach the European markets.

"There has to be a joint owner-ship, which is a logical solution to the dispute," said Faizan Ali Ghouri, a Pakistani rice exporter.

The fight between India and Pakistan over the claim of the origin of Basmati rice has a long history, as this variety is produced largely on

both sides of the border. India has filed a claim in the European Union (EU) seeking a geographical indication (GI) tag for Basmati rice. Pakistan, on the other hand, has opposed India's claim and has filed a request for a protected GI tag.

There is no logic in both countries' claim for the sole exclusivity of Basmati rice. Although its origin is Pakistani Punjab, it is grown in both sides of the border. Therefore, a joint ownership is the only viable solution to the longstanding dispute," said Ghouri.



### **Study says depression during pregnancy** can affect mother-infant relationships

he findings of a recent study revealed that women with depression during pregnancy, or with a history of depression, have a reduced quality of mother-infant relationships.

The study was funded by National Institute for Health Research (NIHR) Maudsley Biomedical Research Centre (BRC) and its results were published in the journal 'BJPsych Open'.

In the study, researchers examined whether depression, either before or during pregnancy, affects the mother-infant relationship.

Researchers looked at the quality of mother-infant interactions eight weeks and 12 months after birth in three groups of women; healthy women, women with clinically significant depression in pregnancy, and women with a lifetime history of depression but healthy pregnancies.

The study used a sample of 131 women: 51 healthy mothers with no current or past depression, 52 mothers with depression referred to the South London and Maudsley NHS Foundation Trust Perinatal Psychiatry Services, and 28 'history only' mothers with a history of depression but no current diagnosis.

Quality of interaction At both eight weeks and 12 months, mothers and babies in the depression and history-only groups displayed a reduced quality of interaction. Specifically, at eight weeks, 62 per cent in the group of mothers with depression during pregnancy and 56 per cent in the



group of mothers with a history-only of depression scored in the lowest category of relationship quality, where therapeutic interventions are recommended, compared with 37 per cent in

the healthy group. All mother and baby groups improved in their quality of interaction between 8 weeks and 12 months which researchers say indicates that with time all mothers and their babies can become more attuned to each other.

At six days, newborn babies of mothers in the depression and history-only groups had decreased social-interactive behaviour, which, together with maternal socio-economic difficulties, was also predictive of reduced quality of interaction, while postnatal depression was not. Dr Rebecca Bind, lead author and Re-

try, Psychology and Neuroscience, King's College London, said, "Our findings suggest that perinatal mental health professionals should offer support not only to women with depression during pregnancy but also to pregnant women with a history of depression, as they may also be at risk of interaction difficulties. Future research should try to understand why a history of depression, despite a healthy perinatal period, may impact the developing relationship.'

Senior author Carmine Pariante, Professor of Biological Psychiatry at the Institute of Psychiatry, Psychology and Neuroscience, King's College London and Consultant Perinatal Psychiatrist at the South London and Maudsley NHS Foundation Trust, said, "We recommend

that healthcare professionals provide pregnant women at risk of interaction difficulties with examples of positive caregiving behaviours, and with ways to engage their babies and understand their needs, all of which could be incorporated into parenting and birth classes and health visits.'

Pariante added, "We also suggest that interventions that can help the motherinfant interaction should be made more widely available, such as video feedback, where a clinician and mother discuss what behaviours work best to engage and comfort the baby, and structured mother-baby activities, such as art and singing groups. This is especially important because we know that the early years are vital for future mental health and wellbe-

The relationship between mothers and infants was assessed using the Crittenden Child-Adult Relationship Experimental-Index which assesses 'dyadic synchrony', a term that describes the quality of the relationship as a whole.

Researchers analysed films of three-minute interactions filmed at eight weeks and 12 months postnatal. Mothers played with their babies while researchers scored the relationship based on seven aspects of behaviour: facial expression, vocal expression, position and body contact, affection and arousal, turn-taking contingencies, control, and choice of activity.

The researchers are grateful to the women and their infants who participated in the PRAM-D study and to everyone on the study team who recruited, collected, and analysed data.



### **Musharraf Envisages Rapid Accord On Kashmir**

**KUALA LUMPUR -** Stating that the Kashmir problem could be solved in "two weeks" if India and Pakistan show political will, President Pervez Musharraf

Musharraf today expressed optimism that it would be resolved in a "certain timeframe"

"1 think it can be resolved in two weeks if there is a will and we discuss the options and reach an agreement. Well, two weeks maybe...I have just said that.

The most important thing for the leadership is to have the will to reach a conclusion. I see that at this moment, the leadership does have." he told reporters here when asked if he shared the optimism of some that the Kashmir issue could be settled in a couple of years.

"Therefore." Musharraf said "I am optimistic that it would be resolved in a certain timeframe". The Pakistan President, who was on his-way to Australia, said he would love to visit Kashmir. "I would love to go there" but he would not make a formal proposal as "the time was not ripe yet."

About Siachen, he said talks were being held between the two countries on withdrawing troops and redeploy them to end the "eyeball to eyeball confrontation". He expressed optimism that an agreement would be reached on the issue. Prime Minister Manmohan Singh said yesterday that the

two countries were exploring the possibility of putting their troops out of Siachen Glacier, the world's highest battlefield and turn it into a "mountain of peace". He also refused to affirm whether he would step down in

2007 and hand over power to a civilian leader, saying "we will

cross the bridge when we come to it."

### Saudi Arabia Allows Women To Register For Haj Without Male Guardian

audi Arabia has announced that women can now regster for the annual Haj pilgrimage without a male guardian (mahram), Al Arabiya News reported on Monday.

In its registration guidelines issued for this year's Haj for domestic pilgrims, the Saudi Minisen did not need to have a male guardian to register, and could do so along with other women.

'Those wishing to perform Haj will have to register individually. Women can register without a mahram (male guardian) along with other women," the ministry said in a tweet.

The development comes days after it was announced that Saudi women can now live on their own without requiring the consent of their father or male guardian after a new legal amendment by the Kingdom.

The landmark steps erode the longstanding guardianship system that renders adult women as legal minors and allows their "guardians" — husband, father and other male relatives — to exercise arbitrary authority over them.

### **Biden Rallies NATO Against 'New Challenges' From Russia, China**



**BRUSSELS, BELGIUM -** US President Joe Biden warned Monday that NATO must adapt to new challenges posed by China and Russia as he met fellow leaders to renew Washington's "sacred" bond with its allies.

Arriving at NATO headquarters in Brussels for a summit with his 29 counterparts, Biden stressed that the alliance was "critically important" to US security.

His first visit as president to the summit has been billed as a renewal of bonds after his predecessor Donald Trump called the US commitment

"I think that there is a growing recognition over the last couple of years that we have new challenges," Biden told NATO Secretary General Jens Stoltenberg at bilateral talks ahead of the main summit.

"We have Russia that is not acting in a way that is consistent with what we had hoped, as well as China," he said.

"I want to make it clear: NATO is critically important for US interests in and of itself. If there weren't one, we'd have to invent it," he said.

And he stressed once again that Article 5 of the NATO treaty—the obligation of members to defend one another, once called into question by Trump was a "sacred obligation."

### **Palestinians Not Counting On Change As Bennett** Replaces Netanyahu

alestinian groups have dismissed the change in Israel's government, saying new Israeli Prime Minister Naftali Bennett is likely to pursue the same right-wing agenda as his predecessor, Benjamin Netanyahu.

Palestinian President Mahmoud Abbas's office called the Israeli parliamentary vote on Sunday an "internal Israeli affair" while groups in the besieged enclave of Gaza pledged to keep up their fight for Palestinian rights. Gaza has been under an Israeli air, land and sea blockade since 2007

The Palestinian Foreign Ministry, meanwhile, issued a statement saying it was "inaccurate" to call Bennett's coalition government a "government of change" unless there was a significant shift in its position on the Palestinian right to self-determination and the establishment of an independent Palestinian state with East Jerusalem as its capital.

Bennett, who heads the ultra-nationalist Yamina party and describes himself as "more right-wing" than Netanyahu, has said that the creation of a Palestine state would be "suicide" for Israel. He has also called for the annexation of most of the occupied West Bank.

As prime minister, the millionaire former high-tech entrepreneur leads an unwieldy coalition from the political right, left and centre. Analysts say Bennett's government will likely avoid sweeping moves on hotbutton issues such as policy towards the Palestinians and instead focus on domestic reforms.

### Palestinians unmoved

'This is an internal Israeli affair,' said Nabil Abu Rudeineh, spokesman for Abbas. "Our position has always been clear, what we want is a Palestinian state on the 1967 borders with Jerusalem as its capital."

In a statement, the Palestinian foreign ministry posed a host of questions to Bennett's government. 'What is the position of the new government regarding the Palestinian people's right to self-determination and the establishment of their independent state with East Jerusalem as its capital?'

"What is its position of the settlement and annexation processes? What is its position on Jerusalem and respect for the historical and legal situation there? Its position on the signed agreements? Its position on the resolutions of international legitimacy? Its position on the two-state solution and negotiations on the basis of the principle of land for peace?"

In Gaza, Palestinian groups vowed to keep resisting Israel.

"We aren't counting on any change in the occupation governments, since they are united on the policy of killing Palestinians and confiscating Palestinian rights," said Sami Abu Zuhri, a senior Hamas official.

And prior to the Israeli parliament vote, Fawzi Barhoum, a spokesman for Hamas said: "Regardless of the shape of the government in Israel, it will not alter the way we look at the Zionist entity. It is a settler occupier entity that must be resisted by all forms of resistance, foremost of

### Iran Approves First Homegrown COVID-19 Vaccine

**TEHRAN:** Iran has approved an emergency use of its first domestically developed coronavirus vaccine that could bring the hardest-hit country in the Middle East closer to inoculating its citizens against COVID-19.

The emergency authorisation was approved after the country faced problems from importing enough vaccines due to US sanctions. Health Minister Saeed Namaki

made the announcement at a ceremony in Arak University of Medical Sciences on Monday saying permission to use the Iranian vaccine COVIran Barekat has been granted.

Iranian pharmaceutical company Shifafarmed made the vaccine based on deactivated virus, and the first study of the safety and effectiveness began in late December.

Iran is also working on a vaccine in cooperation with Cuba.



Namaki said that another vaccine, produced jointly by Iran and Cuba, will join the country's vaccine package next week.

"The permit for using the Pasteur vaccine will be issued next week, and in the near future, the Razi and Fakhra vaccines will be added to the list of usable [Iranian COVID1 vaccines." the minister noted.

Iran's local vaccine research has gained urgency as officials allege that heavy American sanctions will hamper the Islamic Republic's mass inoculation efforts.

The Razi vaccine, officially known as Razi COV-Pars, is Iran's second homegrown vaccine and a product of the Razi Vaccine and Serum Research Institute, which is administered via in-

jection and inhalation. Fakhra, the third Iranian vaccine, is developed by the Iranian Defense Minis-

try's research center, formerly headed by

### Getting to dialogue

ver the last two weeks, Kashmir has been agog with all sorts of speculations about the centre mulling some more important changes with regard to Jammu and Kashmir. All anticipated changes are extraordinary: people think that the centre is mulling further division of J&K. Many say a new union territory is being carved within the Valley. On the positive side, there's hope that the centre may restore statehood to J&K. But before that, the centre would like to complete the delimitation exercise which is set to give more seats to the Jammu division, thereby bringing it politically at par with the Kashmir Valley. This is expected to be followed by the restoration of statehood and the announcement of Assembly elections.

There are also speculations about the nature of the statehood, the centre will be inclined to grant. There is an apprehension that the centre may only be inclined to restore a Delhi type statehood where the power will largely vest with the Lieutenant Governor with some local representation in the everyday governance. However, nothing is known with certainty as of now.

According to some media reports in sections of national media, the centre is set to hold dialogue with the J&K political parties including the People's Alliance for Gupkar Declaration (PAGD). The recent meeting of the PAGD which took place after a long hiatus is seen in this context. Otherwise, the PAGD had long given up the pretense of existing as an alliance which is dedicated to struggle for the restoration of Article 370 that granted J&K an autonomous status within Indian Union.

Be that as it may, it will certainly be a positive development should the centre start engagement with the political groups in Kashmir. This will certainly go a long way to address the current political vacuum in the union territory. It has been a long time since the political activity has been by and large dead in the Valley. The release of the political leaders last year, in a sense, changed little on the ground. In fact, some political leaders are still in jail and there is no telling when or if they will be freed in near to medium future.

This is where a dialogue between the centre and the J&K leadership holds some hope. This could go a long way in breaking the ice and putting the union territory on the road to a political normalcy. Every J&K citizen has a stake in such a dialogue and all would want it to reach its logical conclusion: a statehood for J&K and redressal of the local political and public grievances and aspirations.

n its meeting on Saturday, the GST Council cut tax rates for key Covid-related medicines and equipment in line with the recommendations of the Group of Ministers (GoM) formed to go into the issue. While frequent changes in tax rates create uncertainty for businesses and households, doing so now in the midst of a pandemic, for a limited time period, to provide relief to financially stressed households struggling to meet their health expenses, is a judicious move. While some had argued in favour of zero rating of these items, which is done for exports, doing so would have required an amendment to the GST Act. On the other hand, exempting these products from GST would have placed manufacturers at a disadvantage as they would not have been able to claim input tax credit.

Equally pressing is for the GST Council to address the problems that add complexity to and continue to plague the indirect tax framework. For one, the matter of the inverted duty structure needs to be addressed. Perhaps a productwise examination needs to be considered. And while this may not be an appropriate time, the GST Council must also examine the issue of rationalising the tax rates. According to an RBI study, the weighted average GST rate had declined from 14.4 per cent in May 2017 to 11.6 per cent in 2019, implying that the current GST regime is not revenue neutral. This impacts tax collections, and creates fiscal pressures for both central and state governments. Such pressures are exacerbated during economic downturns when there are greater demands on governments to provide relief to the economy. The GST Council must, therefore, move quickly to address the lingering structural issues in the GST architecture.

### **G-7 Summit Disappoints**

The 3Cs: Covid, China and Climate Change dominated the G-7 Summit. But overall the leaders were not able to present a united stand on any major issue

he 47th annual G-7 Summit, ended on Sunday last at the Carbis Bay in Cornwall, UK. Though the British Prime Minister wanted the summit to showcase his brand of 'Global Britain', after Brexit, there were terse exchanges between the French, EU and British leaders and officials on the issue. In effect, the summit turned out to be more Biden focussed and even as expectations were raised high on some real agreement taking place on the 3C's before the summit, though that was not the result ultimately.

Broadly, Biden sought to set a new tone after the unrestrained Trump years. Most G-7 leaders seemed relieved to have a return to a more predictable and traditional US administration. France's Emmanuel Macron welcomed Biden back to the "club." But the final Communiqué showed that even Biden's expectations to ensure a consensus on many of his promises fell short.

### Covid-19 and Vaccine Diplomacy

On the issue of Covid-19, the leaders of the seven most affluent western nations seemed united. but there was a difference of opinion on the way forward. Earlier, they had shown commitment to donate 1 billion Covid-19 vaccine doses over the next year to poorer countries. But in reality, the bloc fell short of its own goal --613 million new doses pledged,

instead of a billion. Even so, the vaccine effort gave Biden some help with his China push. Biden has criticised China for a transactional brand of vaccine diplomacy, where the shots are being doled out for geopolitical advantage. Biden called on democracies to counter China and Russia by donating vaccines equally and based on need, without seeking favours in return.

The COVAX facility, backed by the World Health Organization (WHO) and the Global Alliance for Vaccines and Immunisation (GAVI) aims to secure 2 billion vaccine doses for lower-income countries by the end of 2021. "We will work together with the

French President Emmanuel Macron also pushed back publicly, saying that the "G-7 is not a group that is hostile to China." Macron was one leader who sought the middle ground.

China hit back at these statements dismissively saying that the days when "global decisions" were dictated by a "small group of countries are long gone". Chinese embassy in London issued a statement saying that world affairs should be handled through "consultation by all countries". and added that the valid global system was the "international order based on the principles" of the United Nations.

The final version of the communiqué skirted B3W, instead creating a task force to study how to spur infrastructure development abroad. It made no mention of BRI, though Biden renewed his call at a press conference, and said that, "I proposed that we have a democratic alternative to the Belt and Road initiative, to build back better.'

### On Climate Change

The claim by environmental activists before and after the summit was that the world's rich nations, which caused the climate crisis, know what's expected of them - but they consistently fail to deliver in full. They asserted

mit virtually. He conveyed India's commitment to "collective" solution to global health challenges, and called for "one earth, one health" approach, which aims for unity and solidarity among the states of the world to deal with the pandemic. He also emphasised the need to keep raw materials for vaccines easily accessible.

Moreover, a good internet connection is something not available in every part of the country, specially in the rural areas, thus making the remote proctored test a difficult alternative for JEE Main.

Perhaps one of the toughest phases for students who want to pursue engi-

neering is the preparation process for both JEE Main and Class 12th board exams at the same time. Both the examinations are conducted around a few days apart and it may become an added pressure on many students. However, if planned properly it may turn out to be just the opposite.

### Manne Kaak, the Obscure, Died of **Covid. But What Killed Him?**

C Did Manne Kaak really die of Covid? Was it trials and tribulations that killed him? Or did the bottled up stress that he as a proud man of dignity hid, took his life? Did stress, mostly financial and largely emotional, diminish his executive functions and thereby worsen his chances at life?

"Wajahat Saeb, Eid chhe, kharcha gotcs (Its Eid. I need something)", Manzoor or Manne Kaak, as I would fondly call him, would quietly ask me. "Manne Kaak, Peya tratt, Kaami tsoor chuk (Manzoor, damn you, you're a shirker)", I would humorously and jovially tell him. In a stentorian tone of voice, my Manne Kaak, would equally jovially then laugh with me.

Manzoor or manne Kaaak, was not a moonlighter in the conventional sense: he had no regular job. He sometimes worked as a school bus conductor, sometimes as a day labourer, supplementing his meagre income by stitching shawls and so on. In the harsh Kashmiri winters, we(my family) would engage him to look after our house. Manne Kaak's wife was diagnosed with breast cancer a couple of years ago. The cancer worsened after he, instead of proper medical treatment, sent his wife to a local pir for what he believed would be better treatment. The entire burden of looking after the family, which includes a young school going daughter — cooking, washing, shopping and earning, fell on Manne kaak.

A handsome man with sharp and elegant features, Manne Kaak started growing weak and haggard as the burden of life and poverty fell on him. A back surgery that was performed on him due to disc issues left him incapable of doing daily wage labor. The sources of income were dwindling and life's troubles were piling up. But Manne Kaak soldiered on, battling the odds and hand dealt to him , bravely. He would never seek charity nor would he crib and complain over his condition.

"Wajahat saeb, why don't you establish a business? I would be the first person to work for you", Manne Kaak would say to me. "Here business people are ruthless. They don't care for us poor people",he would add."I will help you, Manne kaak",' I would reassure him. The prompt response from him would be an emphatic no. "No , No, Wajahat Saeb. I will not accept anything unless it is for work"

As time wore on, Manne Kaak grew weaker still. To assuage his dignity, I would send him on errands, slip a note in his pheran or kurta after he would return. Manne Kaak would loudly protest and a battle of words and wit would ensue which I would win. "Wajahat saeb, yi haz gov galat. Be chuss tuhunz kaem karaan kyazi ki tse chuk mye tott. (This is wrong. I run errands for you because I love you; not for money)", Manne kaak would protest.



Manne Kaak must have been in his mid or late forties but looked a sixty-something. Life's troubles were draining him. Looking after his sick wife and raising his daughter under great adversity added to his troubles. But society looked on. Manne Kaak bravely and courageously fought his battles alone till the day he lost his battle with life. Manne Kaak was broken within and without but he never showed it.

On the crisp 14th June morning, I was woken up by the shrill and incessant ringing of my mobile phone. A harried, sobbing woman broke the sad and tragic news to me, "Manne Kaak passed away during the night". Numb with shock, I asked,"How?". The answer was all too familiar for our times, "He complained of breathlessness, oxygen levels dipped and he died". I disconnected the call, and tried to make sense of Manne Kaak leaving us so early. Tears welled up in my eyes. "Manne Kaak, I let you down. Society let vou down. Sorry, Manne Kaak. Please forgive me", is

I suspect that Manne Kaak died of Covid that must not have been diagnosed at the right time. But, it could be something else. Did Manne Kaak really die of Covid? Was it trials and tribulations that killed him? Or did the bottled up stress that he as a proud man of dignity hid, took his life? Did stress, mostly financial and largely emotional, diminish his executive functions and thereby worsened his chances at life?

I wonder to myself, who would take care of his ailing wife and young daughter after the mourning period is over?

These are questions that I ask myself and pose to broader society: do we not owe an obligation and duty of care to our weak and vulnerable? Are they not equally human as us?

I know the answers but beyond some very sparse help to Manne Kaak, neither I nor society could do anything for him.

The Right To Disconnect
So, how does one juggle the desire to be a team player without committing to working 24/7?

ou've finished dinner, put the kids to bed, and you're about to binge-watch a television show you're likely embarrassed to admit you're even watching when a notification pops up on your screen. The message-from a younger team member who now seems to be working on a noon-to-midnight schedule—is marked urgent. Do you open it and respond?

If this scenario sounds familiar, you're not alone. In the world of remote work, what it means to be "off" is murky. Now, as some people return to the office and others go permanently remote, time off is about to get even more difficult to define and protect.

So, how does one juggle the desire to be a team player without committing to working 24/7? And should this decision be left up to employees, or is it time for leaders to take a clear stand?


### What is "the right to disconnect"?

The "right to disconnect" is a lobby that has been brewing for years. It also seems to mean very different things in different contexts.

Not surprisingly, the earliest "right to disconnect" legislation was implemented in France, also home to an envious 35-hour workweek. In 2016, the French government ruled that any company with 50 or more workers must draw up a "charter of good conduct" outlining when employees are not expected to be online responding to messages.

Since then, "right to disconnect" legislation has been adopted in a few other jurisdictions, including Spain. But rather than gain momentum as legislation, in most parts of the world, calls for the "right to disconnect" seem to be coming

from company leaders or employees. For example, in 2017, the German car manufacturer Daimler introduced a "mail on holiday policy". Under the policy, employees can opt into one of three messages before going on vacation, including a message that says that any email sent will be deleted. According to Daimler officials, the policy came as a huge relief to employees and enhanced



work-life balance.

In other cases, workers have led the charge to disconnect. One might not think about police officers when they think about online work, but there are growing demands on law enforcement officers to make themselves available outside work hours. In spring 2021, one Australian police union decided that enough is enough. The expectation, they argued, was taking a toll on officers' mental health. In response, they voted to adopt a "right to disconnect" for their

Balancing work flexibility with right to disconnect policies

In a 2018 Fast Company article, I argued that "right to disconnect" legis-

lation is unlikely to work, especially in the United States. Instead, I suggested that a holistic approach—one focused on helping employees better manage their boundaries—is the best solution.

After more than a year of remote work, I still maintain that this is the right approach. But for the approach to be effective, leaders need to provide clear guidance on when employees need to be available online and when they can log off. To begin, leaders should ask themselves five key questions:

Do you have a compelling need to have your employees available online all the time? If not, have you communicated with employees about when they don't need to be available online?

If you need some employees avail-

able 24/7, ask yourself: A) Who are these employees? B) Why are they required to be available online outside regular work hours? C) Are these employees compensated for their additional availability, and if not, could they be? D) What is their constant availability worth to you and your organisation (i.e., how much are you willing to pay for 24/7 access)?

Asking some employees to be available outside regular work hours shouldn't be a crime. However, if a leader needs to do this, it is important to be clear about who is and is not obligated to make themselves available outside regular work hours, know why one is making this "ask," and be prepared to pay for it.

For anyone who doesn't need to be

available 24/7 and likely would benefit from disconnecting, leaders are strongly advised to provide clear guidance on expectations. Leaders can also support their employees by helping them understand the power of taking time off to

# Vaccination of entire population will inhibit severity of third Covid-19 wave: Dr Abdul Rouf

RINAGAR, JUNE 14: "Everything about emergence of third Covid-19 wave, its severity and impact on children has been talked on Social Media but there is equal possibility of preventing or suppressing it, by ensuring cent percent vaccination of entire population", said Dr Rouf, Public Health consultant.

"The strategy of vaccination of entire population must be implemented properly without leaving behind any eligible individual," said Dr Rouf while emphasizing on importance of vaccination.

"This will increase defence mechanism against new infection in the body and nullify chances of catching virus again," he said while elaborating benefits of vaccination.

He said that if all the adults in a family get vaccinated, the chances of children getting infected is highly unlikely as vaccinated parents become a shield for children.

He maintained that infodemics needs to be curbed which induces fear and covid vaccination phobia among the people. He advised educated people to cross check the source of news from the Google to ascertain veracity of content of news which will help them not to fall for fake stories

He said that the research regarding covid vaccination for children is being conducted in many countries and added that if vaccination for children is allowed in near future then the process shall be taken on priority basis. This, he said, will

protect children from the deadly disease.

"The data regarding second wave shows adults as well as children have developed immunity against the virus and children remained mostly unaffected except some children with co-morbidity diseases. However, the intensity of third wave and its adverse impact depends on the mutation of corona virus and behavior of new variants viz-a-viz propagation and severity of infection," Dr Rouf explained.

Moreover, he said that people need to bring about behavioral changes in themselves corresponding to covid, like developing habit of mask wearing and washing of hands frequently. This, will protect us, in case we may have to live with covid for few more years, he added.

Dr Rouf rejected the claims of some people regarding feeling suffocation while wearing masks, saying that there was advisory for wearing double mask and it is not appropriate to make such excuses.

Public health consultant, Dr Rouf said that he has been working in the covid for one and a half year and yet he never got infected by covid because of vaccination and observance of Covid SoPs, particularly wearing of masks.

Besides, he emphasized that the covid guidelines issued by government time and again like maintenance of physical distance, wearing of mask and washing of hand with soap, shall have to be followed without any lethargy.

## Study finds three factors that may predict college students' loss of self-control

oining a club that sparks a new interest, playing a new intramural sport or finding a new group of friends may be just as indicative of a college freshman's loss of self-control as drinking or drug use, according to new research at West Virginia University.

Self-control, the ability to exercise personal restraint, inhibit impulsivity and make purposeful decisions in that first year partly depends on a student's willingness to try new things, including things adults would call "good."

That's a new finding, according to Kristin Moilanen, associate professor of child development and family studies. The study, "Predictors of initial status and change in self-control during the college transition," observed 569 first-year students ages 18-19 at five points over the course of the academic year. Participants completed the first wave of the study two weeks before arriving on campus and the other four over the course of the year.

The tendency to try new things is one of two indicators -- the other is maternal attachment -- that may gauge which students would benefit from an intervention, the study



found.

"It does suggest that one of the points of college is to go out and try new things," she said. "There may be some value in finding out who needs reining in or training in decision making that they need to slow down and think."

Students who were less interested in trying new things maintained stable control throughout the year, she said.

A first-year student's self-control tendencies also depend on the students' attachment to their par-

ents, particularly their mothers.

"They're responsive," she continued. "They tend to get along, their relationship is predictable and they know what their parents are going to do, how they're going to react. They don't hide their mistakes from their parents."

Conversely, students who were detached from their parents were more likely to tread more dangerous behavioural waters.

Moilanen said that stems from parents who were unavailable or inconsistent, making their children tend to push other people away and dismiss the importance of parental attachment.

"Their self-control erodes more than those who are more securely attached," she said.

Screening for insecure attachment and personality dimensions may be valuable for identifying first-year college students who could benefit from discrete targeted early interventions, particularly those who aren't as attached to their mothers; that student may benefit from connecting with peers and building a support system, according to the study.

A third factor, stress, is also likely to blame for college freshmen's loss of self-control, though this was not considered in the study.

"It's probably reflecting fluctuations in stress over the academic year," Moilanen said. "First-year students don't have the most accurate representation for what to expect and then they get here and they find that it's fun, but they also find it's stressful."

Stressors, even small ones, Moilanen said, can be more disruptive to self-control than people realize.

### Study finds new links between high-fat diets and colon cancer

new study has found that high-fat diets can trigger a molecular cascade of events that leads to intestinal and colon cancer.

The findings of the study were published in the journal 'Cell Reports'.

For decades, physicians and dieticians have urged people to limit their intake of high-fat foods, citing links to poor health outcomes and some of the leading causes of death in the US, such as diabetes, heart disease and cancer.

gateway that coordinates intestinal tumor formation when they adapt to high-fat diets, and elevate cancer risk. Within the ISCs are high-fat sensor molecules that sense and react to high-fat diets levels in the cells.

"We were following up on mechanisms that might be required for stem cells to adapt to the high fat diet —and that's where we came across the PPARs," said Mana. These peroxisome proliferator-activated receptors (or PPARs) trigger a cellular program that elevates cancer risk, but the exact mechanisms were unclear because there are multiple types of



According to the Centers for Disease Control and Prevention, dietary components high in saturated fats such as red meat are thought to be risk factors for colon cancer. Diet is thought to strongly influence the risk of colorectal cancer, and changes in food habits might reduce up to 70 per cent of this cancer burden.

Other known epidemiological risk factors are family history, inflammatory bowel disease, smoking and type-2 diabetes.

But out of all the risk factors that elevate colon cancer risk, diet is the one environmental and lifestyle factor that may be the easiest to control - simply by changing people's behavior and eating habits - if we knew the exact connections. "There's epidemiological evidence for a strong link between obesity and increased tumor risk," said School of Life Sciences assistant professor Miyeko Mana.

Mana added, "And in the intestine, the stem cells are the likely cell of origin for cancer. So, what is that connection? Well, diet is something that feeds into that cycle of obesity and colorectal cancer."

The new ASU study led by Mana and her team has shown in greater detail than ever before of how high-fat diets can trigger a molecular cascade of events that leads to intestinal and colon cancer.

As foods are broken down and make their way through the gut, they interact with intestinal stem cells (ISC) that lie along the inside surfaces of the gut. These ISCs reside in a series of regularly folded valleys of the gut, called

ISCs are thought to be the

PPARs, and complexities in teasing out their roles.

"There is a family of 3 PPARs, named delta, alpha and gamma. At first, I thought just PPAR delta was involved, but in order to see if that gene is really responsible for the phenotype, you have to remove it," added Mana.

Mana's team was able to explore and unmask the role of individual PPAR delta and alpha using a mouse model that controlled their activity in the cell. In her team's study, mice were given a long-term high fat or normal diet, and the activity of each PPAR was carefully monitored to study the effects on cancer risk.

In their knockout study, they first removed the PPAR delta gene.

"But when we removed it from the intestine, we still observed the phenotype. So, we wondered if maybe another PPAR was compensating and that's where we thought about PPAR alpha. Both of those (PPAR delta and PPAR alpha) appear to be required for this high fat diet phenotype within the stem cells," said Mana.

This was frustrating to Mana because she knew right away that developing a potential therapeutic to offset the PPARs just became a much taller task.

"When you think about this therapeutically, if you are incorporating a lot of fat into your diet and you want to reduce your risk of colon cancer, targeting two different factors is more challenging then if you are targeting just one," added Mana.

To further tease out the genetic complexity, Mana next turned her attention downstream of the PPARs.

## 'Listening to music near bedtime can be disruptive to sleep'

hen sleep researcher Michael Scullin, Ph.D., associate professor of psychology and neuroscience at Baylor University, realised he was waking up in the middle of the night with a song stuck in his head, he saw an opportunity to study how music and particularly stuck songs might affect sleep patterns.

The findings of the study were published in the journal 'Psychological Science'.

Scullin's recent study investigated the relationship between music listening and sleep, focusing on a rarely-explored mechanism: involuntary musical imagery, or "earworms," when a song or tune replays over and over in a person's mind

These commonly happen while awake, but Scullin found that they also can happen while trying to sleep.

"Our brains continue to process music even when none is playing, including apparently while we are asleep," Scullin said.

A 15-year longitudinal study shows that childhood insomnia symptoms that persist into adulthood are strong determinants of mood and anxiety disorders in young adults.

Scullin added, "Everyone knows that music listening feels good. Adolescents and young adults routinely listen to music near bedtime. But sometimes you can have too much of a good thing. The more you listen to music, the more likely you are to catch an earworm that won't go away at bedtime. When that happens, chances are your sleep is going to suffer."

People who experience earworms regularly at night - one or more times per week - are six times as likely to have poor sleep quality compared to people who rarely experience earworms. Surprisingly, the study found that some instrumental music is more likely to lead to earworms and disrupt sleep quality than lyrical

The study involved a survey and a laborato-

ry experiment. The survey involved 209 participants who completed a series of surveys on sleep quality, music listening habits and earworm frequency, including how often they experienced an earworm while trying to fall asleep, waking up in the middle of the night and immediately upon waking in the morning.

In the experimental study, 50 participants were brought into Scullin's Sleep Neuroscience and Cognition Laboratory at Baylor, where the research team attempted to induce earworms to determine how it affected sleep quality.

Polysomnography -- a comprehensive test and the gold standard measurement for sleep -was used to record the participants' brain waves, heart rate, breathing and more while they slept.

"Before bedtime, we played three popular and catchy songs -- Taylor Swift's 'Shake It Off,' Carly Rae Jepsen's 'Call Me Maybe' and Journey's 'Don't Stop Believin'," Scullin said.

Scullin added, "We randomly assigned participants to listen to the original versions of those songs or the de-lyricized instrumental versions of the songs. Participants responded whether and when they experienced an earworm. Then we analyzed whether that impacted their nighttime sleep physiology. People who caught an earworm had greater difficulty falling asleep, more nighttime awakenings, and spent more time in light stages of sleep."

Additionally, EEG readings - records of electrical activity in the brain - from the experimental study were quantitatively analysed to examine physiological markers of sleep-dependent memory consolidation. Memory consolidation is the process by which temporary memories are spontaneously reactived during sleep and transformed into a more long-term form.

"We thought that people would have earworms at bedtime when they were trying to fall asleep, but we certainly didn't know that people would report regularly waking up from sleep with an earworm. But we saw that in both the survey and experimental study," he said.

Participants who had a sleep earworm

showed more slow oscillations during sleep, a marker of memory reactivation. The increase in slow oscillations was dominant over the region corresponding to the primary auditory cortex which is implicated in earworm processing when people are awake.

"Almost everyone thought music improves their sleep, but we found those who listened to more music slept worse," Scullin said.

"What was really surprising was that instrumental music led to worse sleep quality -- instrumental music leads to about twice as many earworms," Scullin added.

The study found that individuals with greater music listening habits experienced persistent earworms and a decline in sleep quality. These results are contrary to the idea of music as a hypnotic that might help sleep.

Health organisations commonly recommend listening to quiet music before bedtime -- recommendations that largely arise from self-reported studies. Instead, Scullin has objectively measured that the sleeping brain continues to process music for several hours, even after the music stops.

Knowing that earworms negatively affect sleep, Scullin recommended first trying to moderate music listening or taking occasional breaks if bothered by earworms. Timing of music also is important -- try to avoid it before bed.

"If you commonly pair listening to music while being in bed, then you'll have that association where being in that context might trigger an earworm even when you're not listening to music, such as when you're trying to fall asleep," he said.

Another way to get rid of an earworm is to engage in cognitive activity -- fully focusing on a task, problem or activity helps to distract your brain from earworms. Near bedtime, rather than engaging in a demanding activity or something that would disrupt your sleep, like watching TV or playing video games, Scullin suggested spending five to 10 minutes writing out a to-do list and putting thoughts to paper.

### Record High: India's WPI Inflation Zooms To 12.94% In May

NEW DELHI: Base effect, along with high transportation fuel cost, lifted India's annual rate of inflation based on wholesale prices to record high levels in May.

Accordingly, WPI rose by 12.94 per cent in May from a rise of 10.49 per cent in April.

This is the highest rate of WPI inflation in the current series. The previous high mark was observed in April.

The monthly rate of inflation, in May 2020 stood at (-) 3.37 per cent. On sequential basis, the month over month change in WPI index for May 2021 as compared to April, was 0.76 per cent.

The high rate of inflation in May 2021 is primarily due to low base effect and rise in prices of crude petroleum, mineral oils viz petrol, diesel, naphtha, furnace oil etc and manufactured products as than primary food articles, and compared to the corresponding crude oil and natural gas recorded month of the previous year," the Ministry of Commerce and Industry said in a statement on WPI.

Last year, the Centre had imposed a full nationwide lockdown to curb the spread of the Covid-19

On segment wise basis, prices of primary articles, which constitute 22.62 per cent of the WPI's total weightage, rose at a slower rate of 9.61 per cent last month from 10.16 per cent in April 2021.

However, WPI food index rose to 8.11 per cent from 7.58 per cent reported for April.

The prices of manufactured items remained at elevated levels with a rise of 10.83 per cent from custom duties on the imports of 9.01 per cent.

### **World Has To Decouple Trade** Policy, Green Goals: Goyal At **UN Trade Forum 2021**

**NEW DELHI:** Hoping that the developed countries will not use the inter-play of trade and climate challenge "too much", Commerce and Industry Minister Piyush Goyal on Monday said the world should decouple trade policy and its green goals.

He also hoped that credit rating agencies and bodies like the IMF "which kind of dictate" the financial architecture of the world do not land up being unfairly harsh on the developing and less-developed countries as this is a time to become compassionate, more liberal and supportive to these nations.

"I think a little longer rope needs to be given even to earlier agreements or earlier commitments so that these countries (developing and less developed) have space to bring their economies back on track," Goyal said at the UN Trade Forum 2021.

Let the trade policy look for more inclusive growth all over the world and all the countries need to work towards climate justice and sustainable lifestyle.

"We do hope that the developed world will not use the inter-play of trade and climate challenge too much because I think trade should allow all countries to prosper.

"It should not create trade barriers which will ultimately become a hindrance to taking prosperity to the poorer, lesser developed countries," he said.

Goval added: "I do believe that we have to decouple trade policy and our green goals". Rather, he said, the UN and the other multilateral agencies like the UNFCCC (United Nations Framework Convention on Climate Change) should focus on getting the world together to fulfil their commitments around climate change.

there should be differentiated

responsibilities when it comes to the developing world or the less-developed countries, as they have to fulfil their commitments which they made in Paris particularly relating to capital, and technology.

Further, Goyal said the world should learn lesson from the 2008 economic crisis and the developed world should not land up in "over adventurism" in terms of fiscal proliferation.

Talking about healthcare, he said that under the Ayushman Bharat scheme, 500 million people have access to medical facilities free of charge and "we are going to expand it to 100 per cent coverage so that every citizen in India and every resident gets access to healthcare".

The government is investing in upgrading healthcare facilities and expanding them, he added.

About the forthcoming meeting of the World Trade Organization's (WTO) 12th ministerial conference in Geneva, Goyal said the members cannot prioritise only the agenda of the developed world.

It has to address issues that have been long pending such as the asymmetry in agri subsidies and finding a permanent solution to the issue of public stockholding for food security purposes, he added.

WTO Director-General Ngozi Okonjo-Iweala said the member countries have agreed for text-based negotiations of the proposal of India and South Africa for temporary TRIPS waiver to deal with the CO-VID-19 pandemic.

## Muslim Man Thrashed, Says Asked To Chant Jai Shri Ram, Police Say No Such Allegations In FIR

Ghaziabad: In a video on social media, an elderly Muslim man has accused four men of beating him up, chopping his beard and asking him to chant Jai Shri Ram in the Loni area of Ghaziabad.

The Ghaziabad police said it has already registered an FIR and arrested one man, Parvesh Gurjar, for his involvement in this alleged incident which took place on June 5 but was reported to police two days later.

Ghaziabad Superintendent of Police Amit Pathak, however, said victim Abdul Samad, a Bulandshahr resident, had not made any allegation of being forced to chant Jai Shri Ram or the chopping up of his beard, in his FIR lodged on June 7 with a delay of two days.

"How come he is making new allegations now on June 14?" asked Pathak, suspecting someone else of instigating him of making new allegations.

Ghaziabad (Rural) SP Iraj Raja said Gurjar was arrested a few days after the incident for his role in some other criminal case, but he was found involved in beating up Samad too, so he was put under the arrest in this case as well. Raia said the motive behind



the beating up of Samad by Gurjar and his associates was a dispute between the two over the purchase of an amulet.

Samad also practised occultism and had sold some amulet to Gurjar, purportedly to free one of his family members from some "evil effect" but a dispute arose between the two as there was no desired result of the amulet, Raja said.

After Gurjar's arrest, the police repeatedly summoned Samad to join the investigation, but he never came to the police, the SSP said, adding he was also summoned for Monday, but he is yet to appear.

New Delhi: The Editors Guild of India (EGI) on Monday accused the Uttar Pradesh police of passing off the death of a TV journalist as being caused by an accident, claiming they did not pay any heed even though he had informed them about the danger to his life.

In a statement, the guild said it is shocked by "the cavalier manner" in which the Uttar Pradesh police is treating the "mysterious death" of Sulabh Srivastava in Pratapgarh.

According to the police, Srivastava died on Sunday after his motorcycle rammed into a pole in Pratapgarh. He was returning from Ashrahi village under Lalganj police station area when the incident took

The journalist had recently run a story about the liquor

The guild said Srivastava, who was threatened by the liquor mafia for exposing their wrongdoings, had recently written a letter to the police expressing grave apprehensions for his life.

The journalist believed that some people were following him, it said, adding the authorities paid no heed to his fears.



Srivastava died a couple of days after writing the letter to the police, it said.

The police is passing off his death as being caused by an accident, claiming that his bike rammed into a handpump," the guild charged.

The EGI said the journalist's death comes at a time when media is facing "increasing pressures from the central and the state governments who insist that they follow the official narrative regarding the administration's handling of the pandemic".

What is further worrying is that the police and the local authorities "liberally and unjustifiably" use laws such as sedition and the UAPA to file charges and arrest journalists, the editors' body charged.

"This is against the spirit of the judgement given by the Supreme Court in Kedar Nath Singh case and reiterated in the recent sedition case against Vinod Dua," the EGI said.

It alleged that journalists and cartoonists critical of the government are also being targeted on social media as pressures are being mounted by the government on these platforms to remove such critical journalists on the specious ground that they are violating the law of the land.

"All of this is contrary to the commitments that Prime Minister Narendra Modi made at the G-7 summit to democracy, openness and against authoritarianism." the EGI said.

### **Majlis Pitches For**

Quoting data, the MMU spokesperson said that in district Srinagar, out of 7 lakh people who are 18 years and above, only 2.90 lakh have been vaccinated, which is less than even

"Out of the total Covid deaths of 798 in Srinagar, 98% were those who were not vaccinated at all. This goes to show that vaccination is a protection against Covid complications and death," he said.

Drawing a comparison between first and second corona wave quoting data, the Majlis spokesperson said that while 15 health staff members died because of Covid last year, no fatalities, pneumonia or vaccine reaction was witnessed among the 15000 health care staff and 50000 frontline workers, who received both doses of vaccine from February 2021.

"So the effectiveness of vaccination, as a means of protection from Covid 19, is well established," he said.

He said that the strategy of vaccinating the entire population must be implemented properly without leaving behind any eligible individual. This, he said, will increase the defence mechanism against new infection in the body and nullify chances of catching virus again.

Dr Rouf said that if all the adults in a family get vaccinated, the chances of children getting infected are highly unlikely as vaccinated parents become a shield for children.

He maintained that infodemics needs to be curbed which induces fear and Covid vaccination phobia among the people.

The senior medical practitioner advised people to cross check the source of news from the Google to ascertain veracity of content of news which will help them not to fall for fake stories.

He said that the research regarding Covid vaccination for children is being conducted in many countries and added that if vaccination for children is allowed in near future then the process shall be taken on priority basis. This, he said, will protect children from the deadly disease.

"The data regarding the second wave shows adults as well as children have developed immunity against the virus and children remained mostly unaffected except some children with co-morbidity diseases. However, the intensity of the third wave and its adverse impact depends on the mutation of corona virus and behavior of new variants viz-a-viz propagation and severity of infection," Dr Rouf said.

Moreover, he said that people need to bring about behavioural changes in themselves corresponding to Covid, like developing the habit of mask wearing and washing of hands frequently.

'This will protect us, in case we may have to live with Covid for a few more years," he added. Rejecting the claims made by some people that they feel suffocated while wearing masks; Dr Rouf said that there was an advisory for wearing double mask and it is not appropriate to make such excuses.

'I have been working in the Covid for one and a half year and yet he never got infected because of vaccination and observance of Covid

SoPs, particularly wearing of masks," he said. Besides, he emphasized that the Covid guidelines issued by the government time and again like maintenance of physical distance, wearing of mask and washing of hand with soap, shall have to be followed without any lethargy.

pass the detention order," the court said. "Since the material is not supplied to the (detainee), the right of the (detainee) to file such representation is impinged upon and the detention order is resultantly vitiated."

Examining the present case on the touch stone of the settled position of law and perusal of record, the court said that the detainee was not supplied the materials relied upon by the detaining authority.

"The (detainee) was provided material in the shape of grounds of detention with no other material / documents. On these counts alone, the detention of the (detainee) is vitiated, the (detainee) having been prevented from making an effective and purposeful representation against the order of detention," the court said and quashed the PSA order against Tanveer passed on 7 August 2019 and subsequently ordered his release from preventive custody "forthwith". ### **Looking At Same Points Per Test Win From Next WTC Cycle: Interim ICC CEO Allardice**

**NEW DELHI:** The much-debated World Test Championship points system is set to undergo a change during the second edition where all teams will get "same standardised number of points" for winning a game rather than the 120 allocated per series, ICC interim CEO Geoff Allardice said on Monday.

During the last cycle, the value for each series was 120 points where a two-match India-Bangladesh series had 60 points for a win while a four-match India-Australia Test series had 30 points in store per victory.

However, during the last phase with lot of series cancelled, ICC reverted to the percentage points system where a team's ranking was calculated on the basis points divided by the number of matches played.

We have looked at this at the end of this cycle as well and we have the second cycle starting in a month and a half and there will be some tweaks to the points system,' Allardice said during an interaction with select media outlets.

"...We can put in a standardised number of points for per Test match, so that it doesn't matter whether it's a two Test series or a five-Test series, so same number of points will be available for each match that's played.

"But every team will be judged on percentage of points its wins and not on total," Allardice explained.

While COVID-19 did wreak havoc on the calender, an India-New Zealand final after taking all postponements into account is a fair result, he said.

"One of the things that happened during this cycle was that it became evident that not everyone was going to complete their six series as a result of postponements

due to COVID." he reasoned. "Because we have had teams

### **ICC Reveals Prize Money For World Test Championship Winners**

**DUBAI:** The winner of the upcoming World Test Championship final between India and New Zealand will walk away with a prize money of USD 1.6 million along with the Test Championship Mace, the International Cricket Council said on Monday.

India and New Zealand will battle it out for the prestigious title at Southampton on June 18.

"The winners of the muchawaited ICC World Test Championship (WTC) Final between India and New Zealand will take home a purse of \$ 1.6 million along with the ICC Test Championship Mace," an ICC statement read.

"The losing team will get USD 800,000 for finishing second in the nine-team competition, which was played over a near two-year cycle, adding context to Test cricket and to crown the first official world champions in the longest format of the game.'



The governing body said that the team finishing third among the nine competition nations will get USD 450,000 cheque, while the prize money for the fourth-placed team will be USD 350,000.

.. the one that finishes fifth gets USD 200,000 while the remaining four teams will get USD 100,000 each," it said.

The inaugural World Test Championships saw nine teams competing over a near two-year cycle to add context to Test cricket.

The team claiming the inaugural world champions title in the longest format of the game will get the Test Mace, which was previously given to teams topping the ICC Men's Test Team Rankings.

"In case the final ends in a draw or a tie, the finalists will split the prize money for the first and second places and share possession of the Mace during the time they remain champions," the ICC said.

SOUTHAMPTON: Head groundsman at Southampton Simon Lee is aiming to produce a pacy and bouncy pitch for the World Test Championship final with some assistance for spinners later on in the game. The final will be played between India and New Zealand from June 18.

"Pitch preparation for this Test is a little simpler as we are a neutral venue, we are guided by the ICC, but we all want is a good pitch that offers an even contest between the teams," Lee told ESPNcricinfo.

"For me personally I just want to get something out that has some pace, bounce and carry in the pitch.

"It can be a hard thing to do in England as the weather doesn't help us most of the time, but the forecast in the build-up is good with a lot of sun, so we are hopeful that we'll get some pace and a hard pitch without

over-rolling it and killing it." Both the teams have high quality pace bowlers and Lee wants them

"Pace just makes red-ball cricket exciting, I'm a cricket fan and I want to produce a pitch where the cricket lovers have to watch every ball in case they miss something, be that some class batting or an amazing spell of bowling.

"A maiden over can be quite exciting if it's a battle of skill between both bowler and batter. So, yeah, if we can get some pace and bounce in the pitch, but not too one-sided towards seam movement, we'll be happy," he said.

In the spin department, India have the edge over New Zealand with Ravichandran Ashwin and Ravindra Jadeja expected to be part of the playing eleven. Lee said spinners too would come into play eventually.

"As I said, the forecast is looking okay, the pitches dry out very quickly here as we do have some sand mixed into our cricket loam, which helped it hold together when the pitches were re-laid some 10 years ago, but it can help it spin as well.

"To get to that point we'll need the seamers to bowl, some runs scored, and make some rough along the way. The pitch will always get talked about a lot, but you need the players to play their part to make a good

"...so if we produce a pitch that allows the players to show their skills at the top level and we have an entertaining game for the fans, we will be more than satisfied."

### One Goal Away From Entering All-Time Top-10 As India Play Afghanistan

DOHA: Goal-machine Sunil Chhetri will look to add to his tally and enter the all-time top 10 scorers' list as a buoyant India meet Afghanistan in the joint 2022 World Cup and 2023 Asian Cup qualifiers here on Tuesday.

While the Indian team needs just a draw from their final game against Afghanistan to secure a place in the third round of AFC Asian Cup qualifiers after Oman defeated Afghanistan 2-1 on Friday, a hat-trick for Chhetri will see him equal the iconic Pele in terms of numbers of goals scored in the international arena.

Chhetri is also just one goal off entering the all-time top-10 list of goal-scorers, something he can easily achieve against Afghanistan, if not a hat-trick.

A Chhetri-inspired India ended their winless run in international football when the captain struck a brace against Bangladesh in their previous outing. The talk since then mostly centered around the Indian talisman surpassing the legendary Lionel Messi as international football's second highest scorer among active players.

A veteran in top-flight at 36, Chhetri played down the comparisons with the Argentine global superstar, but he will certainly look to put his best foot forward come the next match and add to his tally of 74 goals. If the Blue Tigers can avoid defeat in the upcoming match, they will finish third in their group, an improvement over the fifth-place result during the last campaign.

India are already out of contention to progress further in the World Cup qualifying campaign, and is now looking to secure a berth in 2023 Asian Cup, scheduled to be held in China.

India will enter the game as clear favourites despite Afghanistan's ability to fight it out. Igor Stimac's men will be high on confidence after thoroughly dominating Bangladesh, against whom they enjoyed nearly 75% possession while completing more than 600 passes.

If they are to repeat that kind of impressive stats, India will need the duo of Chhetri and Manvir Singh to fire upfront, with Brandon Fernandes marshalling the midfield and keeping the supply chain flowing.

With Stimac reposing immense faith in him, Brandon has established himself as one of the country's top players playmakers. He has provided three assists out of the five goals India has scored in the qualifying campaign so far and he would be more than eager to continue in the same vein. Form and past record both favour India and anything less than a victory for the Blue Tigers will be seen as an upset.

As far as Afghanistan are concerned, they will take heart from their spirited performance in their previous outing against India, who were held to a stalemate at home by their lowerranked opponents in 2019.

But the recent defeat against Oman means Afghanistan are not among the top fourth-placed teams in the World Cup qualifiers and a failure to win against India would send them to the playoffs just to get into the third round of Asian Cup qualifiers.



### **Denmark Team Doctor Confirms Eriksen Suffered Cardiac** Arrest, Says 'He Was Gone'

COPENHAGEN: Denmark's team doctor said Sunday that Christian Eriksen's heart stopped and that "he was gone" before being resuscitated with a defibrillator at the European Championship. Eriksen collapsed during Denmark's opening Euro 2020 group game against Finland on Saturday and was given lengthy medical treatment before regaining consciousness.

"He was gone. And we did cardiac resuscitation. And it was cardiac arrest," said team doctor Morten Boesen, who led the work in giving Eriksen treatment on the field. "How close were we? I don't know. We got him back after one defib. That's quite fast." Eriksen was in stable condition

at a Copenhagen hospital and had spoken to teammates via video link on Sunday, team officials said. Boesen said it was still unclear what caused the midfielder's collapse.

"I'm not cardiologist, so the details about why it happened and further, I will leave to the experts," he said.

He also said the 29-year-old Eriksen may not have survived had the game not been played at a major soccer tournament with topclass medical equipment at hand.

'That was completely decisive, I think," Boesen said. "The time from when it happens to when he receives help is the critical factor, and that time was short. That was decisive."

Denmark coach Kasper Hjulmand said when he spoke to Eriksen, the Inter Milan midfielder was more concerned about his teammates' well being than his own.

"He said 'I don't remember much but I'm more concerned about you guys. How are you doing?" Hjulmand said.

"That's typical Christian. ... It was good to see him smile."

The Danish players and team staff were being given crisis management assistance as they process the incident. Eriksen fell face-forward to the ground late in the first half and his teammates formed a protective circle around him while the medics gave him treatment. The game was suspended for about 90 minutes before resuming. Finland won 1-0 after scoring in the second half.

Denmark canceled a planned training session on Sunday but Hjulmand said they would try to go back to their normal routines on Monday. He insisted the players are determined to finish the tournament, with Denmark playing Belgium next in Group B on Thursday.

"(Eriksen) would like for us to play," Hjulmand said. "We are trying to get back to some normality tomorrow. That is completely in line with what the psychologists are saying, and the way I want to try to lead this group forward."

The decision to restart the game on Saturday has been heavily criticized by many in Denmark, including former players Peter Schmeichel and Michael Laudrup.

UEFA gave Denmark the option to resume the game Sunday at noon but the players opted to finish it Saturday evening instead. A later date was not possible because Finland plays its second group game on Wednesday in St. Petersburg,

### **CBSE Panel Yet To Submit Report On Evaluation** Criteria For Class 12 Students



CBSE constituted panel is yet to submit its recommendations for the criteria to evaluate class 12 students whose exams have been cancelled in view of the COVID-19 pandemic, according to sources. The 13-member panel, set up by the board for the purpose, was supposed to submit its report by Monday. However, it is likely to take a few more days for finalising the criteria.

"The panel has not submitted its report. Widespread discussions have been held to come up with a fair and objective criteria The final recommendations will be submitted soon," a source said.

"Most panel member are in favour of giving weightage to class 10 and 11 scores besides pre board and internal exams for class 12. However, a final call is yet to be taken and the report will be submitted in a few days," the source added.

The Supreme Court on June 3 granted the central government two weeks time to devise a well-defined objective criteria for assessment of Class 12. The CBSE had on June 4 constituted a 13-member committee to work out the criteria. The panel was

given ten days to submit its report. Delhi Deputy Chief Minister Manish Sisodia has also written to Union Education Minister Ramesh Pokhriyal 'Nishank' suggesting that the result for class 12 students, whose exams were cancelled due to the COVID-19 pandemic, should be tabulated taking into account the marks scored during class 10, 11 and pre-board exams.

cancelled the CBSE class 12 board exams amid the continuing pandemic across the country, with Prime Minister Narendra Modi asserting that the decision was taken in the interest of students, and the anxiety among students, parents and teachers must be put to an end.

The decision was taken at a high-level meeting chaired by Modi in which it was decided that the CBSE will take steps to compile the results of Class 12 students according to a well-defined objective criteria in a time-bound manner.

It was also decided in the meeting that in case some students desire to take the exams, such an option would be provided to them by the CBSE as and when the situation becomes conducive.

The exams were scheduled to be conducted in May-June and were postponed in view of the second wave of the pandemic. The CBSE had already cancelled class 10 board exams and announced an alternative marking policy.

According to the policy, while 20 marks for each subject will be for internal assessment as every year, 80 marks will be calculated on basis of the students' performance in tests or exams throughout the year.

The weightage in terms of maximum marks for schools which have conducted the tests and exams through the year will be -periodic test/unit test (10 marks), half-yearly exam (30 marks) and pre-board exams (40 marks).

For class 10, schools have been asked to submit the tabulated marks by June 30 and the result is expected to be declared in July.

### **Delta Plus: New Covid Variant Identified, Experts Say No Cause Of Concern For Now**

NEW DELHI: The highly transmissible Delta variant of SARS-CoV-2 has mutated further to form the 'Delta plus' or 'AY.1' variant but there is no immediate cause for concern in India as its incidence in the country is still low, scientists here said.

The new Delta plus variant has been formed due to a mutation in the Delta or B.1.617.2 variant, first identified in India and one of the drivers of the deadly second wave. Though there is no indication yet of the severity of the disease due to the new variant, Delta plus is resistant to the monoclonal antibody cocktail treatment for Covid-19 recently authorised in India.

"One of the emerging variants is B.1.617.2.1 also known as AY.1 characterised by the acquisition of K417N mutation," Vinod Scaria, clinician and scientist at Delhi's CSIR-Institute of Genomics and Integrative Biology (IGIB), tweeted on Sunday.

The mutation, he said, is in the spike protein of SARS-COV-2, which helps the virus enter and infect the human cells.

According to Public Health England, 63 genomes of Delta (B.1.617.2) with the new K417N mutation have been identified so far on the global science initiative GISAID.

In its latest report on coronavirus variants, updated till last Friday, the health agency said Delta plus was present in six genomes from India as of June 7. "The variant frequency for

K417N is not much in India at this point in time. The sequences are mostly from Europe. Asia and America," Scaria wrote on Twitter. The earliest sequence of this genome was found in Europe in

late March this year. Noting that the travel histories for the variant are not readily available to make assumptions, Scaria said an important point to consider regarding K417N is the "evidence suggesting resistance to monoclonal antibodies Ca-



sirivimab and Imdevimab".

This cocktail recently received emergency-use authorization in the country from the Central Drugs Standard Control Organisation. Drug majors Roche India and Ciplas have priced the antibody cocktail at a steep Rs 59,750 per dose.

Similar to antibodies which are proteins that the body naturally produces to defend itself against the disease, monoclonal antibodies are artificially created in a lab and tailor-made to fight the disease they treat.

Casirivimab and Imdevimab are monoclonal antibodies that are specifically directed against the spike protein of SARS-CoV-2, and designed to block the virus' attachment and entry into human cells.

Scaria also indicated the mutation may be associated with the ability to escape the immune response against the virus.

Allaying fears, immunologist Vineeta Bal noted that while there may be some setback in the use of commercial antibody cocktail due to the new variant, resistance to the therapy is not an indication of higher virulence or severity of a disease.

"How transmissible this new variant is will be a crucial factor to determine its rapid spread or otherwise," Bal, guest faculty at the Indian Institute of Science Education and Research, Pune, told PTI.

She also noted that the quality and quantity of neutralising antibodies, responsible for defending cells from pathogens, generated in the individual infected with the new variant is unlikely to be affected because of the mutation.

"Thus in individuals catching infection with the new variant, it may not be a matter worth worrying," she added.

Pulmonologist and medical researcher Anurag Agrawal concurred. "There is no cause of concern due to the new variant in India as

of now." Agrawal, the director of CSIR-IGIB, told PTI. The scientist said the blood

plasma from many fully vaccinated individuals will have to be tested against this variant to determine whether it shows any significant immune escape.

As the Delta variant continues to evolve and acquire new mutations, there is a lot of interest in understanding its evolution. He said SARS-CoV-2 has a nearly constant rate of acquiring genetic variants, and each variant has acquired additional variants in a stepwise fashion.

"Understanding this continued evolution is of great importance in mapping the evolutionary landscape of emerging variants. Largely the virus has tried to optimise for transmission and immune escape by step-wise acquisition of new mutations," he added. PTI

### 'From Rs 2 Crore To Rs 18.5 Crore In Minutes:' **Ram Temple Trust Accused Of Land Scam Press Trust of India**

Two Opposition leaders have accused Shriram Janmabhoomi Teerth Kshetra Trust general secretary Champat Rai of buying a piece of land worth Rs 2 crore at an inflated price of Rs 18.5 crore for the Ram temple premises in the matter of a few minutes. The allegations were levelled by Aam Aadmi Party Rajya Sabha MP Sanjay Singh and a former minister in the Samajwadi government, Pawan Pandey.

Singh and Pandey have sought a probe by the Central Bureau of Investigation and the Enforcement Directorate into the land purchase for the temple premises, terming it a case of money laundering.

The leaders have alleged that Rai purchased the land at Rs 18.50 crore from the first purchaser, who had bought it minutes earlier on March 18, 2021, from its original owners for a sum of Rs 2 crore. The land measured 1.208 hectares and is located in Bag Biaisi village under Sadar tehsil of Ayodhya district.

"Champat Rai, the general secretary of Shriram Janmabhoomi Teerth Kshetra Trust with the help of Trust's member Anil Mishra bought the land worth Rs 2 crore at Rs 18.5 crore. This is a case of



money laundering and the government should get it probed by the ED and CBI," Singh told reporters in Lucknow

SP's former Ayodhya MLA Pandey backed Singh and demanded a probe into the incident.

Singh quoted entries of the registered sale deed of the land to back his claim. He said the land was first purchased by Sultan Ansari on March 18, 2021, from its original owner Kusum Pathak, wife of Harish Kumar Pathak for a sum of Rs 2 crore. A few minutes later, the same land was purchased by Trust's general secretary Rai for Rs 18.50 crore from Ansari, Singh said, again quoting entries of the second sale deed showing the transaction between Ansari and Rai.

Singh alleged that Trust mem-

ber Anil Mishra and Ayodhya mayor Hrishikesh Upadhyay testified the land sale deed as witnesses and were witnesses to the purchase of the land by Rai as the Trust's general secretary. "Prime Minister Narendra Modi and his government must initiate a thorough probe by the CBI and ED, and the corrupt persons should be sent to jail, as it is the question of faith of crore devotees of Lord Ram, who have given their hard-earned money for the construction of the Ram temple." Singh said.

Rai strongly refuted the allegations levelled against him. "Allegations of even assassinating Mahatma Gandhi were levelled on us. We do not fear allegations. I will study the allegations levelled on us, and probe them," he said.

### **Out On Bail, Rape Accused Stabs Woman To** Death In Rajasthan: Police

IODHPUR: A man, out on bail in a rape case, was arrested today in Rajasthan's Sirohi district for allegedly stabbing to death the woman he had raped last year, the police said.

The accused had been pressuring the woman for withdrawal of complaint against him since he was out on bail and stabbed her to death on Saturday night at her house in Nagani village in Sirohi district, Additional Director General (Crime) Ravi Prakash Meharda said.

He confirmed the arrest of the accused, Netram, this morning.

"He had raped the victim and a case had been lodged against him in November 2020. He had been arrested by the police and had been in judicial custody for six months," said the officer.

The accused was the victim's neighbour. She was a widow and had been working in a local anganwadi in the village After her husband's death, Ne-

tram allegedly raped her last year



under the pretext of some help following which a complaint of rape was lodged by the woman.

According to the police, Netram came out on bail in April and had been constantly threatening the victim to withdraw the case but she was not responding to his calls. On Saturday night, he barged into her house and stabbed her to death, while she was sleeping.

He also injured her younger sister, who also was present in the house, as she tried to save her sister. She raised an alarm, but the accused managed to escape from the spot.

### **Indian Man Believed To Have Headed** 'World's Largest Family' Dies

n Indian man from the northeastern state of Mizoram, who is believed to have headed the "world's largest family", has died, officials said.

Ziona Chana, 76, who headed a Christian sect that allowed polygamy for men, has left behind 38 wives and 89 children.

The sect, called Chana Pawl, was founded by his father in 1942. It has about 2,000 members, most of them living in Mizoram's Baktawang village.

On Sunday, Mizoram Chief Minister Zoramthanga announced Chana's death on Twitter.

heavy #Mizoram bid farewell to Mr. Zion-a (76), believed to head the world's largest family, with 38 wives and 89 children," he said.

Mizoram and Baktawng Tlangnuam have become major tourist attractions because of the family, the chief minister added.

According to officials, Chana, who also had 33 grandchildren, died on Sunday afternoon due to complications related to diabetes and high blood pressure, Indian media reports said.

"He was taken to a private hospital in another district and as per the reports received, he passed away today (Sunday)," Kumar Abhishek, the deputy commissioner of Serchhip dis-

trict, told Anadolu Agency. Lal Thanhawla, former chief minister of Mizoram and a se-

nior politician from the Congress party, told Anadolu news agency Chana's demise is a "very big loss to everyone".

"The family is very disciplined and there are a lot of things to learn from them," he said.

Chana married his first wife in 1959 when he was 17, reports said, and claimed he once married ten wives in a single year. His last marriage came in 2004 to a 25-year-old.

They shared a dormitory near his private bedroom, and locals said he liked to have seven or eight of them by his side at all times. Polygamy is illegal under the Indian law. However, a few tribes in India's northeast allow polygamy under their customary laws, which state authorities permit.

According to reports, the large family lives in a pink four-storey house, called the "New Generation Home". It has 100 rooms, with the wives sharing a dormitory near Chana's private room. The family was featured twice on the popular TV show Ripley's Believe It Or Not, BBC news reported.

In 2014, the family also appeared in the advertisement of leading dishwashing brand, according to India's Hindustan Times newspaper.

Despite his family's huge size, Chana told Reuters news agency in a 2011 interview he wanted to grow it even further.

"I am ready to expand my family and willing to go to any extent to marry," he said.
