J&K Sees More Covid Recoveries, Less Cases

SRINAGAR: Jammu and Kashmir reported on Friday 304 recoveries of coronavirus infected people, while one person succumbed to virus and 261 others were confirmed positive for Covid-19 during the last 24 hours.

According to officials, 304 more coronavirus infected patients have recovered in the Union Territory—115 from Jammu and 189 from the Valley during the last 24 hours. During the same time, they said, J&K reported 261 new cases of virus—115 from Jammu and the remaining 146 from the Valley, taking the total number of people infected since the outbreak of pandemic last year in J&K to 318284.

Giving district-wise details, the officials said that Srinagar reported 59, Baramulla 14, Budgam 10, Pulwama 4, Kupwara 11, Anantnag 12, Bandipora 5, Ganderbal 14, Kulgam 15, Shopian 2, Jammu 26, Udhampur 2, Rajouri 6, Doda 34, Kathua 2, Samba 2, Kishtwar 9, Poonch 8, Ramban 10 and Reasi 16 new cases of coronavirus

Also, officials said a single fatality was reported from Kashmir Vallev. taking the fatality count in J&K to 4354.

Probe Ordered Into ULB Appointments Of Last 20 Years

SRINAGAR: The Jammu and Kashmir administration have ordered a high-level investigation into the illegal appointments and regularisation of employees in the municipal bodies of the Valley during the last two decades.

According to a government order, a committee of officers headed by Director Urban Local Bodies Kashmir, Mathoora Masoom has been constituted to probe all illegal appointments made in the municipal councils and committees across the Valley since 2001. Two other members of the committee are Showkat Ahmad Mir, special secretary (legal), Housing & Urban Development department and Alyaz Ahmad Naisroo, secretary, Lakes &

Waterways Development Authority (LAWDA).

The panel would hold a detailed enquiry into all the illegal appointments/ regularisations made in the ULBs in Kashmir from 2001 till date. The Directorate of ULB Kashmir administers three municipal councils and 39 municipal committees.

This is the second such enquiry into the backdoor appointments in the ULB Kashmir in the past 15 days.

On June 23, the government ordered that Dr. Bashir Ahmad Bhat, vice-chairman, Lakes and Waterways Development Authority would inquire into the appointments done in Urban Local Bodies Kashmir by way of illegal relaxation of norms of age/ qualification etc. In the past • More On P6

Good Storytellers Get Better Health Care — But Childhood Trauma Confuses The Narrative

hen describing their symptoms, medical history and health changes at a clinic or hospital, every patient is the storyteller of their own health. Good storytellers tend to get better health care, but a history of childhood trauma plays havoc with telling your own story.

Consider Florence, as a (fictional) example: It is a hot July night and Florence is having dizzy spells again. She feels dreadful and is worried. What if it happens when she is driving? What if it doesn't get better? How can she work like this? What if it is a stroke or a tumour? She goes to the emergency department in spite of her past experience that it isn't very helpful.

The triage nurse asks what she is there for. "Well, I had this bad thing... they did tests and it was almost normal..." The nurse looks puzzled. "When was that?" "October. I was..." The triage nurse doesn't need to hear what happened nine months ago. She cuts Florence off and points her toward the waiting area.

A while later Florence meets with a doctor. She has been practising what to say while she waits. He interrupts after a few seconds to ask what Florence means she by "dizzy." Florence replies, "You know, it's like that dizzy feeling, oh I hate that, you know ..." Although it doesn't occur to either Florence or the doctor, a lifetime of difficulty — starting with violence that she witnessed and experienced as a child — is compromising Florence's

Research on the links between adverse childhood experiences (ACEs) and poor mental and physical health has made this formerly hidden risk factor for many of our most common and burdensome chronic diseases a topic of public discussion.

The numbers are mind-boggling. About 60 per cent of adults experienced at least one type of ACE as they are usually defined. About one in three children experience serious physical or sexual abuse or are exposed to interpersonal violence. It is a major public health problem.

ACEs are linked to unhealthy behaviour and experiences later in life. They increase the risk that a child will smoke cigarettes, adopt unhealthy drug and alcohol use, become obese, or experience further trauma as an adult. Because of this, and because of other effects of stress on health, ACEs increase the risk of diseases of the heart, lungs and liver, pain syndromes, and some cancers.

What Florence is experiencing in the emergency room is a further consequence of childhood adversity — one that makes it much harder to get good health care. There is

a strong relationship between unresolved developmental trauma and impaired storytelling. This is technically called "narrative incoherence.

The qualities of a good narrative were described by the philosopher Paul Grice in four maxims: have evidence for what you say (quality), be succinct, yet complete (quantity), be relevant to the topic at hand (relation) and

be clear and orderly (manner).

Psychologist Mary Main and her collaborators used Grice's maxims to describe how unresolved childhood trauma and loss can affect a person's state of mind regarding important relationships in their life. They found people with unresolved trauma could be identified by failures in the quality, quantity, relation and manner of the stories they told during an emotionally taxing interview about those relationships.

It is a short leap from that research to high-stakes conversations in an emergency department or doctor's office where someone like Florence struggles to make her condition clear and receive the help they need

There are two common patterns of incoherence in these interactions. Florence's pattern is called preoccupied. Her anxiety is obvious. She is too overwhelmed by fear to organize her thoughts. She presents events out of sequence; her thoughts are unfinished; there are too many details; it is hard to tell the signal from the noise.

As a result, it can seem like the story of Florence's health is a jigsaw puzzle and all the pieces have been dumped on the table at once. A listener feels baffled and frustrated. The doctor may start his note with the comment "poor historian." The second pattern of narrative incoherence is quite different from Florence's preoccupied pattern of providing too much disorganzied information. A person with a dismissing pattern tends to provide conclusions without evidence, and generalizations without examples. Q: "How does that feel?" A: "Same as always." Q: "How long has this been going on?" A: "A while." The conversation is short and at its end a health-care provider is unilluminated. While someone like Florence wears her anxiety on her sleeve, a person with the dismissing style keeps their cards close to their chest. A listener feels uninvited to ask more.

If Florence and her health-care providers are able to recognize that trouble telling her own story is a clue to what is going on — not just a marker that she is a "poor histo-— they can take steps to meet the challenge. Some steps Florence can take include: Bringing a friend with her who helps her stay calm and organised.

Explaining that she is anxious and needs a little time to describe the trouble.

Making notes in advance about her most important points and questions.

Even more importantly, health-care workers need to recognise the face of fear. The doctor can help Florence to organise her thoughts instead of interrupting to interrogate her. They can help each other to find the story that allows her dizziness to be understood.

Every patient is forced to be a storyteller; a health-care professional's job is to make them an excellent one.

Pandits To Join Hurriyat Conference

JAMMU- Kashmiri Pandits who were forced to leave the Kashmir Valley due to the violence there will join a conclave organised by the Hurriyat Conference in Srinagar this month.

At a meeting here between leaders of the Pandits and an emissary of the moderate faction of the APHC, it was decided that Pandits would participate in the meeting to be held at the Hurriyat headquarters July 19.

Salim Gilani, the Hurriyat representative who interacted with several intellectuals and leaders of die Pandit community here over the past few days, told a news conference Wednesday that the Hindu leaders would take part in the conference.

Pandit leaders including Rattan Lai Bhan, who represents several migrant camps in the Jammu region and was at the news conference, said they had agreed to a Hurriyat's proposal to attend the meet

Bhan said Pandits had more faith in the Hurriyat than the government. "The government cannot offer us any guarantee of our safety, whereas the All Parties Hurriyat Conference can," he said. He noted the people in the Kashmir valley responded to the calls of the Hurriyat on various issues and not to those of the

Therefore, we feel the Hurriyat's efforts for our return (to the Kashmir Valley) are more sincere and genuine," Bhan remarked. Currently, a 34-member group of various Pandit organisations is touring the Kashmir Valley to study conditions ahead of the possible return of migrants. The state government or-

ganised their trip, now in its second week.

Smoking a Crisis and Rolling an Alarm: Drug and Young in Kashmir

There is an issue of curtailment of public spaces. Social spaces such as educational institutions, public parks and picnic spots, restaurants, etc., serve as recreational places where, usually, the youth refresh themselves. As these places have been unavailable for three years due to continuous lockdowns, drug abuse has increased among the youth. And as such, it is expected to rise if measures are not taken to curtail it

n Kashmir, discourses about conflict take precedence over other important societal matters, possibly because it seems to pervade all spheres of lives here. Nonetheless, it never leaves room for us to ever get to issues such as domestic violence environmental degradation, structural problems in the education system, etc., are often overlooked. Moreover, issues that concern the youth are also not given due attention. Given this, an increasing number of the Kashmiri youth have indulged in certain harmful and unproductive activities. Activities such as reckless driving, loitering, and stalking have become frequent. Besides, more and more youth are indulging in drug abuse, which needs the urgent attention of the administration and society to control it.

The number of people who use drugs is rising at an alarming rate, and the most commonly used drug is the heroine. In 2016, only 15 per cent used heroin in the valley, and it rose to 90% by the end of 2019. What is more worrying is that a growing number of school-going children are using drugs. According to a recent study by the Institute of Mental Health and Neurosciences (IMHANS), 57% of the total respondents who used opioids were teens. It does not bear well for Kashmir that such an overwhelming number of teens are involved in drug abuse. Their involvement suggests that, in future, the social fabric of society will severely get impacted as social relations will hardly last long. The development of Kashmir is also at stake given that the youth, who often prove to be skilful, will not be able to hone and use their skills. Moreover the patterns of drug inflicted societies of Latin America and Punjab, it is prudent to argue that youth gangs would rake up. As and when these things will unfold due to continuous drug abuse, the socio-cultural identity of Kashmir will be lost. Thus, to rehabilitate the Kashmiri youth, and, at large, to preserve the socio-cultural identity of the valley, two things are essential: (I) identifying the causes of drug abuse among the youth and (II) addressing these causes by taking necessary measures.

Several social factors drive the youth to use drugs, like familial problems, failed love relations, forced marriages, etc. However, in essence, it is the political violence and its associated factors that drive the youth of Kashmir towards drug abuse. The predicament in which the youth of Kashmir find



themselves is both difficult to understand and explain. The political landscape of the valley leaves them with very few opportunities. Lack of proper functioning of schools and colleges, lack of employment opportunities, and curtailment of social spaces often force them to take paths, which otherwise, they would not have taken

they would not have taken. The ongoing conflict has a detrimental effect on the education of Kashmiri students. Most of the time, schools and colleges do not function properly. Nonetheless, students chart new ways and methods to continue educating themselves, and eventually, in exams, they pass with good grades. However, it is not the grades, but the atmosphere of educational institutions that shapes the identities of or youth. In this atmosphere, students exchange ideas, discover and create meanings of life, and are involved in certain recreational activities. Devoid of all these things, Kashmiri students/ youth cannot shape their talents and fulfil their aspirations. Besides, everyday violence puts tremendous pressure on their mental health and turns them hopeless. Given such circumstances, drugs may be seen as stress relaxant by the youth.

Even if Kashmiri students succeed in shaping their talents and completing their education, against all odds, they have few employment opportunities. Due to the ongoing turmoil, the informal sector is almost non-existent in Kashmir, and government jobs are scarce. As such, unemployment is one of the problems for the Kashmiri youth.

As per the data of a Mumbai based think-tank, the Centre for Monitoring Indian Economy (CMEI), the unemployment rate in J&K was 9 per cent in March 2021. However, it is hard to come to terms with this data as the Union Territory has been under lockdown for three consecutive years since 2019. Besides, a recent analysis highlighted that the think tank's survey method is "biased towards better-off households." Therefore, in absence of any updated and reliable data, unemployment in Kashmir can be gauged by comparing the number of job applicants with the number of available posts. In 2020, 5.3 lakh applications were received for 8000 class IV jobs across Jammu and Kashmir. These numbers suggest that nyment persists in the valley. Off late, in Kashmir, unemployment has driven the youth towards drug abuse as they become depressed and pessimistic, and consequently, use drugs as a last recourse.

As if the above-mentioned problems were less to leave the youth dejected, there is an issue of curtailment of public spaces. Social spaces such as educational institutions, public parks and picnic spots, restaurants, etc., serve as recreational places where, usually, the youth refresh themselves. As these places have been unavailable for three years due to continuous lockdowns, drug abuse has increased among the youth. And as such, it is expected to rise if measures are not taken to curtail it.

A set of constructive measures, both at the administrative and communitarian levels, are required to end the drug menace in Kashmir. The administration needs to use its capacity and resources to bust the drug networks in Kashmir. For the engagement of the youth, alternate public spaces should be made available in the absence of proper functioning of schools and colleges. In this regard, the Lieutenant Governor (LG) of J&K, Manoj Sinha, in a recent speech, hinted towards the establishment of the Youth Clubs to engage the youth; what becomes now more important is to ensure that these clubs run smoothly. Besides, mental health infrastructure should be upgraded in the valley so that people suffering from mental stress can consult experts rather than indulging in drug abuse. Also, the administration needs to set up de-addiction centres in every district of the valley. Generating employment opportunities and conducting awareness programs will also help in reducing drug abuse.

As far as the role of the community is concerned, it should put social pressure on those who indulge in poppy cultivation. Further, it needs to listen to the concerns of the youth, engage with them and help them rather than using old Kashmiri cliches such as "yim chi darbadar," they are vagabonds. In this regard, Mohalla committees need to reach out to the youth and educate them about the impact of drug abuse on society as a whole, and parents need to create a friendly atmosphere at home so that children can share their concerns with them. Moreover, parents need to regulate the amount of money they give to their school-going children, as they can use it to buy drugs. Among the ed groups, discussion and discourses should emerge as to how to end rising drug abuse. These measures are not exhaustive, but they can prove helpful to end drug abuse and other social evils that can emerge from it.

Concerning the drug abuse in Kashmir, a Kashmir-based doctor reportedly said, "we are sitting on a ticking time bomb..." Therefore, now is the time to act against drug abuse. Once the bomb explodes, the actions taken will bear little results.

ISHKEK - On July 2, the US military handed control of the vast Bagram Air Base to the Afghan government. US troops and their NATO allies are now on track to leave Afghanistan by mid-July, well ahead of US President Joe Biden's September 11, 2021, withdrawal deadline. According to a new analysis by researchers at Brown University, America's twodecade war in Afghanistan cost it nearly \$2.3 trillion. Now, Afghanistan's neighbors - Pakistan, Iran, China, India, and the Central Asian countries - are wondering just how much it will cost them to maintain security after the United

In late June, the US intelligence community concluded that the Afghan government could collapse within six months of the US withdrawal - a stark downward revision of its earlier, more optimistic assessment. As the Taliban has swept through northern Afghanistan, capturing dozens of districts and major cities, Afghan security forces have often surrendered without a fight. According to a June report from the United Nations Afghanistan Sanctions Monitoring Team, the Taliban now exercises direct control over more than half of the country's regional administrative centers, and controls up to 70% of the ter-

The tremors from these Taliban victories are already being felt across the region. Fierce fighting has occurred a mere four hours from Tajikistan's capital, Dushanbe. On June 20, Taliban militants operating in northern Afghanistan surrounded government forces in Kunduz, the country's sixth-largest city (population 300,000). Then, on June 22, the Taliban captured the Afghan-Tajik border outpost of Sher Khan Bandar without a fight.

Meanwhile, Tajikistan's border service reported that 134 Afghan servicemen had received asylum at the crossing. Another 53 Afghan border troops and local militiamen retreated from a Taliban onslaught in Afghanistan's Shortepa district by crossing into Uzbekistan; and on July 5, more than 1,000 Afghan soldiers reportedly fled across the border from Badakhshan Province into Tajikistan.

A complete Taliban takeover of the Amu Darya and Panj Rivers dividing Afghanistan from Uzbekistan and Tajikistan will likely occur within weeks. Since this outcome would allow the Taliban to control Afghanistan's international borders along this front, the risk of large refugee flows from Afghanistan into Central Asia, and then on to Russia and Europe, has sharply increased.

After clandestinely supporting the Taliban as a means to undermine the US war effort, Russia now fears broader destabilization in Central Asia and beyond. In response to recent developments in Afghanistan, Russian Defense Minister Sergei Shoigu says that, "By the end of this year, the command of the Central Military District will have to re-equip two aviation regiments with modernized Su-34M fighter-bombers and MiG-31BM fighter-interceptors." These reinforcements of Russian airpower in the region "will significantly increase the district's capabilities to engage the enemy with fire and combat cruise missiles in the Central Asian strategic direction.

Similarly, after having made nice with the Taliban, China also now fears the greater regional instability that the US withdrawal may incite. In addition to disrupting Chinese President Xi Jinping's Eurasia-spanning Belt and Road Initiative, a revitalized Taliban could reenergize the Islamist extremist threat in China's western Xinjiang province.

The prospect that Afghanistan will become a source of deepening poverty, mass migration, and instability is quickly becoming everyone's problem. But it is Central Asian governments that will be on the front lines. Still, many regional officials remain surprisingly optimistic. Following a recent visit to the US to discuss Afghanistan and regional security, the Uzbek foreign minister, Abdulaziz Kamilov, gave an extensive interview in which he argued that only Afghans, including the Taliban, can resolve Afghanistan's problems.

"We have some optimism," he explained, "Because the situation has changed. First, the two sides began di-

rect contact for the first time in 40 years. The Taliban also want direct negotiations to reach a peaceful agreement." While stressing that he is no defender of the Taliban, Kamilov pointed to an official publication on the group's website where it claims to want to build an independent, sovereign Islamic Emirate of Afghanistan without any outside interference. In this new country, the rights of women, girls, and minorities would supposedly be guaranteed.

It is hard to believe that a seasoned diplomat like Kamilov would fall for such honeyed words. Yet, in also arguing that Afghanistan should be more deeply integrated into the Central Asian economy, he is on sound strategic footing. Even the Taliban would be attracted to the idea of a renewed "Greater Central Asia" that could recreate some of the economic dynamism of the glory years of the Great Silk Road (1100-1600 AD).

With China determined to deepen its trade, investment, and infrastructure ties across Eurasia, this vision has a chance of becoming reality. But first, peace must prevail, above all within Afghanistan.

ost Covid world will be a different one in many dimensions. Politics, economics, society and government will not be transformed but will be impacted. On the level of economics, in the less developed contexts, life will be(and is)hard for the underprivileged and the vulnerable. The privileged and the laa dee daa classes will shop online and buy their Armani belts or Gucci shoes online. Oh yeah, Amazon will even return the product if it does fit a given indulgence, say a set of Burberry sunglasses with anti- glare for added effect. They will, if and when cooking by domestic help become bored, order exotic foods online. (Momos anyone? Or makhmali kebabs?). But what will the daily wage of vulnerable people do? In the context of Kashmir, can society help, while maintaining their dignity and even pride?

A lot, is the answer

In the context of Kashmir which is neither a productive economy nor an advanced one, consumption is the name of the game. But consumption takes a hit when the broader economy is reeling under pressure(s), especially extraordinary and unprecedented ones like the Covid pandemic. When this happens, the underprivileged and the vulnerable- the redi wallas(who earn on a daily basis), or the corner store that sells, say crockery or shoes, or Tupperware suffer. Given that end of the day, society is composed of 'self interested' individuals, the vulnerable actually have nowhere to go. They are already on shoestring budgets;

how much can they scrimp and save?(There's no bank account as well. The economically marginalized are excluded by banking systems).

If a crisis, like Covid, gets prolonged, what options do the vulnerable have?

Crime is one. The other is cheating. Both not only have negative social returns but also degrade both the victim and the perpetrator.

Under these circumstances, it is society that has to rise to the occasion.

How?

Not merely by charity. There are other ways to boost consumption and thereby help the vulnerable. One prudent and effective social intervention

one prudent and effective social intervention is ethical shopping. While definitions of ethical shopping vary, I will use one that is appropriate for the purpose: 'ethical shopping can be a form of consumption where a given good or service is almost superfluous to a shopper's needs but can help the seller and where the motivation and intent is to help the seller'.

How can ethical shopping work in Kashmir?

While naysayers and cynics will invent a host of reasons to discredit ethical shopping in Kashmir, but, honestly it works to the benefit of both the shopper(consumer) and the seller. What can you do as a conscientious shopper?

If you are in the precincts of Lal Chowk, for example, you can hail an auto rickshaw to Jehangir Chowk. After you hail it, don't argue and haggle with the rickshaw walla. Engage him in po-

lite conversation till you reach your destination. When you disembark, and when the auto walla fumbles for change, don't insist on it. In fact, pay 20 or 30 rupees more as a tip. Smile and wave goodbye or salaam.

Wander to Batmaloo. You'll definitely be accosted by a bag seller. Stop, inspect the bag and pay the seller – inevitably a very poor person who's probably moonlighting, the full amount. For mere effect, tell him, he's ripped you off and smile.

Return to Residency Road and stop by the vendor stalls. Pick, for example , a piece of artificial jewellery. Praise the stuff. Pick one or two items. Ask for the price. Pretend to haggle but then pay the full price.

These are just a few instances that you, as an ethical shopper, can do your bit to help. There's other stuff you can devise and help.

I am telling you, no matter how bad your day has(had) been, you'll feel decidedly better if you shop ethically. In fact, you may even feel happy. I say this from experience: I am not boasting, and I should not be stating this publicly. But I shopped ethically today. I had been on a bit of an emotional low since the past couple of days. But after taking recourse to ethical shopping, I not only felt better but I also made new friends. All, as they say, in a day's work!

Covid-19: LG Cautions Against Lowering Guard

SRINAGAR: Taking a detailed assessment of the present Covid scenario in the ÚT, Lieutenant Governor, Manoj Sinha on Friday chaired series of meetings with members of Covid Task Force, Deputy Commissioners, and SPs on Covid Containment efforts of the I&K Administration.

During the meetings with the senior officers, Div Coms, DCs and SPs, the Lt Governor was apprised about the Covid Scenario in the UT, vaccination and other measures to effectively tackle the spread of the corona virus.

The Lt Governor observed that J&K's performance is better than many other regions of the country in terms of vaccination, daily testing and sampling, and advised everyone for not lowering their guard against Covid. "We need to keep following all SoPs, Covid Appropriate Behaviour religiously with utmost sensitivity and responsibility", added the Lt Governor. Taking a strict note of people flaunting Covid protocols, the Lt Governor observed that although the Government has been successful in bringing the situation under control, we cannot afford to lower our guard at this juncture.

Underlining the importance of heightened awareness among the masses to keep the positivity rate and infection rate low, the Lt Governor directed the DCs and SPs for intensifying the awareness campaign at all tourist places ensuring full compliance of the Covid protocol and Covid appropriate behaviour by tourists and locals. "Public parks should allow entries to persons who are inoculated,

The Lt Governor directed the DCs and SPs to ensure strict adherence to the already imposed restriction. To contain the spread of the deadly virus, the Lt Governor directed the concerned DCs to focus on the Blocks with high positivity rate and increase testing in such areas with Covid containment measures. Expressing satisfaction over the vaccination percentage in 8 districts with 100% coverage and the ones near saturation, the Lt Governor directed the remaining districts which are lagging behind to adopt a more proactive approach and microlevel planning to meet the targets.

The Lt Governor said that with continuous augmentation of health infrastructure and decentralization of health system with accelerated vaccination drive, better management of patients and other crucial timely interventions, J&K Government has created a greater covid clinical management capacity reforming healthcare delivery system.

Biden Set To Sign Competition Order **Targeting Big Business**

WASHINGTON: President Joe Biden is set to sign on Friday an executive order that the White House bills as an effort to target anticompetitive practices in tech, health care and other parts of the economy while boosting workers' wages and consumer protections.

The sweeping order includes 72 actions and recommendations that the White House says will lower prices for families, increase wages for workers, and promote innovation and even faster economic growth.

The order includes calls for banning or limiting noncompete agreements to help boost wages, allowing rule changes that would pave the way for hearing aids to be sold over the counter at drugstores and banning excessive early termination fees by internet companies.

It also calls on the Transportation Department to consider issuing rules requiring airlines to refund fees when baggage is delayed or in-flight services are not provided as advertised.

In total, higher prices and lower wages caused by lack of competition are now estimated to cost the median American household USD5,000 per year, the White House said in a fact sheet outlining the order Biden is expected to sign at an afternoon ceremony.

Inadequate competition holds back economic growth and innovation.

The White House said Biden's order follows in the tradition of past presidents who took action to slow growing corporate power. Teddy Roosevelt's administration broke up pow-erful trusts that had a grip on

huge swaths of the economy, including Standard Oil and J.P. Morgan's railroads.

Franklin D. Roosevelt's administration stepped up antitrust enforcement in the 1930s. Biden's order includes a flur-

ry of consumer-pointed initiatives that could potentially lead to new federal regulations, but it also includes plenty of aspirational language that simply encourages agencies to take action meant to bolster worker and consumer protections.

The order seeks to address noncompete clauses an issue affecting some 36 million to 60 million Americans, according to the White House by encouraging the Federal Trade Commission to ban or limit such agreements, ban unnecessary occupational licensing restrictions and strengthen antitrust guidance to prevent employers from collaborating to suppress wages or reduce benefits by sharing wage and benefit information with one another.

White House press secretary Jen Psaki said earlier this week that the provision would help workers in construction, hotel services and other blue-collar industries whose ability to seek better wages is often stymied by noncompete clauses.

The Biden administration in the order also calls on the Federal Maritime Commission to take action against shippers charging American exporters exorbitant charges and the Surface Transportation Board to require railroad track owners to strengthen their obligations to treat other freight companies fairly.

The White House argues that

rapid consolidation and sharp hikes in pricing in the shipping industry have made it increasingly expensive for U.S. companies to get goods to market.

In 2000, the largest 10 shipping companies controlled 12per cent of the market. They now control about 82per cent, according to the Journal of Commerce.

The World Shipping Council, an industry trade group, pushed back in a statement that normalized demand, not regulation," is the answer to rising costs.

Eleven of the past 12 months have seen year-on-year growth of more than 10per cent, the council noted. In the 18 years before the coronavirus pandemic, the average growth rate was 4.7per cent.

There is no market concentration problem' to fix,' and punitive measures levied against carriers based on incorrect economic assumptions will not fix the congestion problems," said John Butler, president and CEO of the council.

The order also seeks to take aim at tech giants Facebook, Google, Apple and Amazon by calling for greater scrutiny of mergers, especially by dominant internet platforms, with particular attention to the acquisition of nascent competitors, serial mergers, the accumulation of data, competition by 'free' products, and the effect on user privacy.

It notes that over the past two decades the U.S. has lost 70per cent of the banks it once had, with around 10,000 bank closures. Communities of color and rural areas have been disproportionately affected.

To begin addressing the trend, the order encourages the Justice Department as well as the Federal Reserve, the Federal Deposit Insurance Corporation and the Office of the Comptroller of the Currency to update guidelines to provide greater scrutiny of mergers.

It also encourages the Consumer Financial Protection Bureau to issue rules allowing customers to download their banking data and take it with them.

The order includes several provisions that could affect the agricultural industry.

It calls on the U.S. Department of Agriculture to consider issuing new rules defining when meat can use Product of USA labels. It also encourages the FTC to limit farm equipment manufacturers' ability to restrict the use of independent repair shops or DIY repairs such as when tractor companies block farmers from repairing their own tractors.

Democratic lawmakers and union leaders cheered the order.

Marc Perrone, president of the United Food and Commercial Workers International, a private-sector union representing 1.3 million workers, said the order sends a clear message that this White House is committed to creating a level playing field for American workers.'

Sen. Amy Klobuchar, a Minnesota Democrat who serves as chair of the Senate Judiciary subcommittee on competition policy, said that Biden's executive order needs to be buttressed by congressional action.

Chief Election Commissioner Sushil Chandra, who is also part of the commission, said they had come here with an open mind.

"If we had something in mind and had decided earlier, the commission would not have come here to hear from people. We are very clear on this that nothing has been decided," he

The earlier announcement of his July 13 engagement with athletes was made on government's citizen engagement platform, MyGovIndia's twitter page.

The first batch of India's Olympic-bound athletes will depart for Tokyo in a charter Air India flight on July 17. More than 120 athletes are bound for the Games, even though the Indian Olympic Association is yet to officially divulge the strength of the contingent.

In view of the raging COVID-19 cases, the Tokyo Olympics will be held under a state of emergency in Japan without spectators from July 23 to August 8.

Sri Lanka's Data Analyst Tests **COVID Positive, Second Case After Coach Grant Flower**

COLOMBO: Sri Lankan team's data analyst G T Niroshan has tested positive for COVID-19 ahead of the limited overs series against India, the country's cricket board said on Friday, a day after its batting coach Grant Flower contracted the virus.

Niroshan is currently being treated as per the medical protocols.

"The Data Analyst of the Sri Lanka National Team, G. T. Niroshan, has tested positive for Covid 19," Sri Lanka Cricket (SLC) said in a statement

"He was found to be positive, following a PCR Test carried out among the National Players, Coaches, and Support Staff yesterday, following the identification of Grant Flower as Covid Positive.

"Niroshan is now undergoing due medical protocols."

On Thursday, Sri Lanka's batting coach Flower tested positive for COVID-19, 48 hours after the squad's arrival from England and less than a week before the home series against India.

All the other play quarantining have also been tested. Before testing negative, Sri Lanka's squad had faced an anxious wait for the results of their PCR tests on returning home, following a COVID-19 outbreak in the England squad after the final match of

their tour in Bristol on Sunday. Sri Lanka are set to take on India in

a six-match white-ball series starting July 13. Flower had been isolated from the rest of the squad which is undergoing hard quarantine on arrival. Flower is a former Zimbabwe batsman and was with the team in England where it lost both the T20 International and ODI series.

Already, three Sri Lankan players are facing an inquiry for breaching the COVID-19 protocols in UK during the tour.

England's entire ODI squad and support staff were forced into self-isolation after a number of COVID positive cases, forcing the England & Wales Cricket Board (ECB) to name an entirely new 18man squad ahead of the first ODI against Pakistan on Thursday.

Dasun Shanaka To Replace **Kusal Perera As Captain For ODI** Series Against India

All-rounder Dasun Shanaka is all set to replace Kusal Perera as the captain of Sri Lanka's limitedovers team ahead of the ODI and T20 series against India, beginning July 13. The 29-year-old, an explosive batsman and a seam bowler, will become Sri Lanka's sixth captain in less

First African American **Spelling Bee Champion Makes History With Flair**

FLORIDA: Zaila Avant-garde understood the significance of what she was doing as she stood on the Scripps National Spelling Bee stage, peppering pronouncer Jacques Bailly with questions about Greek and Latin roots.

Zaila knew she would be the first African American winner of the bee. She knew Black kids around the country were watching Thursday night's ESPN2 telecast, waiting to be inspired and hoping to follow in the footsteps of someone who looked like them. She even thought of MacNolia Cox, who in 1936 became the first Black finalist at the bee and wasn't allowed to stay in the same hotel as the rest of the spellers.

But she never let the moment become too big for her, and when she heard what turned out to be her winning word — "Murraya," a genus of tropical Asiatic and Australian trees - she beamed with confidence. It was over.

Declared the champion, Zaila jumped and twirled with joy, only flinching in surprise when confetti was shot onto the stage.

"I was pretty relaxed on the subject of Murraya and pretty much any other word I got," Zaila said.

The only previous Black champion was also the only international winner: Jody-Anne Maxwell of Jamaica in 1998. The bee, however, has still been a showcase for spellers of color over the past two decades, with kids of South Asian descent dominating the competition. Zaila's win breaks a streak of at least one Indian-American champion every year since 2008.

Zaila has other priorities, which perhaps explains how she came to dominate this year's bee. The 14-yearold from Harvey, Louisiana, is a basketball prodigy who owns three Guinness world records for dribbling multiple balls simultaneously and hopes to one day play in the WNBA or even coach in the NBA. She described spelling as a side hobby, even though she routinely practiced for seven hours a day.

"I kind of thought I would never pe into spelling again, but I'm also happy that I'm going to make a clean break from it," Zaila said. "I can go out, like my Guinness world records, just leave it right there, and walk off."

Many of top Scripps spellers start competing as young as kindergarten. Zaila only started a few years ago, after her father, Jawara Space-

time, watched the bee on TV and realized his daughter's affinity for doing complicated math in her head could translate well to spelling. She progressed quickly enough to make it to nationals in 2019 but bowed out in the preliminary rounds.

That's when she started to take it more seriously and began working with a private coach, Cole Shafer-Ray, a 20-year-old Yale student and the 2015 Scripps runner-up.

"Usually to be as good as Zaila, you have to be well-connected in the spelling community. You have to have been doing it for many years," Shafer-Ray said. "It was like a mystery, like, 'Is this person even real?"

Shafer-Ray quickly realized his pupil had extraordinary gifts.

"She really just had a much different approach than any speller I've ever seen. She basically knew the definition of every word that we did, like pretty much verbatim," he said. "She knew, not just the word but the story behind the word, why every letter had to be that letter and couldn't be anything else."

Sometimes she knew more than she let on. Part of her strategy, she said, was to ask about roots that weren't part of the word she was given, just to eliminate them from consideration.

Only one word gave her trouble: "nepeta," a genus of mints, and she jumped even higher when she got that one right than she did when she took the trophy.

"I've always struggled with that word. I've heard it a lot of times. I don't know, there's just some words, for a speller, I just get them and I can't get them right," she said. "I even knew it was a genus of plants. I know what you are and I can't get you."

Zaila – her dad gave her the last name Avant-garde in tribute to jazz musician John Coltrane is a singular champion of a most unusual bee, the first in more than 25 months. Last year's bee was canceled because of the coronavirus pandemic, and this one was thoroughly modified to minimize risk to kids and their families.

Most of the bee was held virtually, and only the 11 finalists got portion of a cavernous arena at the ESPN Wide World of Sports complex in Florida that also hosted the NBA playoff bubble last year. The in-person crowd was limited to spellers' immediate family, Scripps staff, selected media - and first lady Jill Biden, who spoke to the spellers and stayed to watch.

Euro 2020: Diverse England Football Team Wins Fans In Nation Eager For Good News

LONDON: Hannah Kumari has been an English soccer fan since childhood, but she never wanted to fly an England flag. Until now.

Kumari is one of millions of fans ecstatic that England's men's team has reached the final of a major tournament for the first time since it won the World Cup in 1966. But like many British people of colour, she's had an ambivalent relationship with symbols of Englishness. Yet embracing them has come

more easily thanks to the young, multi-ethnic squad that is on the cusp of triumph in the European Championships. After beating Denmark 2-1 in a semifinal on Wednesday that was watched by half the country's population, England faces Italy in the final at London's Wembley Stadium on Sunday.

"When I woke up this morning I thought, I'm going to buy a St. George's flag to hang out the window for Sunday." Kumari, who was born and raised in England to an Indian mother and Scottish father said the day after the Denmark game.

"I've never owned an England shirt," the actor-writer said. "Something has definitely

changed," she said. "I feel almost like that team has given me permission to feel like I

can wear an England shirt." The last few years have been hard on England and the rest of the Unit-



ed Kingdom. Britain's exit from the European Union — a decision driven in part by a backlash against immigration left the country scratchy and divided. During the coronavirus pandemic, more than 128,000 people have died in the U.K., the highest toll in Western Europe.

Euro 2020 – the name is a year out of date due to the pandemic has provided a much-needed jolt of excitement and fun. Millions weary of lockdowns and bad news are backing a team whose members speak out against racism, take a knee before games, support LGBT pride, campaign against poverty and, crucially, win games.

For decades, supporting England has been synonymous with dashed hopes. The lyrics of the country's most popular soccer anthem, "Three Lions," originally released in 1996, evokes England's 1966 triumph and the long drought that followed: "Thirty years of hurt, never stopped me dreaming." Those 30 years have become 55,

but once again England is dreaming. The country's hopes rest on a team very different from the allwhite squad of 1966. A poster created by the Museum of Migration showed what the England team would look like if players without a parent or grandparent born abroad were excluded: Just three of the 11

starting players remained. Missing were stars who included team captain Harry Kane, whose father is Irish; Marcus Rashford, whose mother is from Saint Kitts: Iamaica-born Raheem Sterling; and Buyako Saka, a Londoner with Nigerian parents.

The team is known less for wild off-the-pitch antics than for social responsibility, epitomized by 23-yearold Rashford's campaign against child poverty, which convinced the government to restore free lunches for thousands of poor children. Last week. Kane, 27, wore a rainbow armband to support LGBT pride during England's match against Germany.

The players may be young multimillionaires, but they celebrate their local as well as international roots. Rashford's childhood in a workingclass Manchester community inspires his anti-poverty work; Kalvin Phillips is a proud son of the northern city of Leeds; Sterling calls himself the "boy from Brent," after the London borough where he grew up.

For some, their success is helping to make Englishness a source of pride rather than awkwardness. The English make up 56 million

of the U.K.'s 67 million inhabitants, but English patriotism and the country's red-and-white St. George flag were long shunned by liberalminded Britons, associated with football hooligans and narrowminded "Little Englanders."

Britishness was regarded as a more welcoming identity by many U.K.born and foreign-born citizens alike. England's rugby, cricket and soccer teams have done much to strip the English flag of its negative as-

sociations in recent years. The increasing prominence of Scottish and Welsh flags and symbols as those countries gained more political autonomy over the last two decades has also made many people reflect

on what English identity means. "There has been an enormous intergenerational shift towards a civic and inclusive English identity that crosses ethnic and faith grounds," said Sunder Katwala, director of the equality think-tank British Future.

"Most migrants to Britain haven't identified as English, but interestingly, their children have." Katwala said sports teams and tournaments don't drive social change but "ratify that shift that has been happening in society."

"It's changed the public conversation about what is English," he said. Not everyone thinks the national soccer team represents all that is best about England. Some conservative commentators have derided the

players as uncomfortably "woke." Team members have been booed by some fans while taking a knee against racism before games. Home Secretary Priti Patel has criticized the kneeling, calling it "gesture politics," and declined to condemn the booing.

Victory has silenced much of the criticism, at least temporarily. Politicians have jumped on the England bandwagon. Conservative Prime Minister Boris Johnson, who has often criticized protests over racism and Britain's imperial past, attended Wednesday's game, awkwardly wearing an England jersey over his dress shirt. He's under pressure to declare a national holiday if England wins the final on Sunday.

No. 1 Barty To Face Pliskova In 1st Wimbledon **Final For Both**

WIMBLEDON: Women's singles world number one Ashleigh Barty is all set to take on eighth seed Karolina Pliskova in the final of the 2021 Wimbledon on

She is now one win from a second Grand Slam title after beating 2018 champion Kerber 6-3, 7-6 (3) on Thursday.

Barty is aiming to win a second Grand Slam crown and a maiden one at Wimbledon. Pliskova, who has reached her second Slam final, is hoping to win her maiden title.

"I've had ups and downs and everything in between and I

wouldn't change one day or one moment or one, kind of, road that we've taken in my path and my journey," said Barty, who was the 2011 junior champion at the All England Club and stepped away from tennis for almost two years starting in 2014 because of burnout. "It's been unique. It's been incredible. It's been tough. There have been so many things that led to this point." Her opponent Karolina Plis-

kova emerged from a powerhitting and serving display to come back to defeat World No. 2 Aryna Sabalenka 5-7, 6-4, 6-4.

"Super proud about the way how I handled the situation out there," Pliskova said.
