Despite Court Campaign, Doodh Ganga Dying As Drain

fter losing its 'milky' waters to chemicals, waste, plastic, and oth-Aer pollutants, river Doodh Ganga is fast becoming a drain despite World Bank funds meant to restore some of its

glory failing to come to its rescue. The liquid and solid waste ceaselessly goes directly into the river in huge quantities despite the civil society's campaign and the judicial rebuke.

And the same contaminated water is the drinkable water source to many parts of Srinagar and Budgam areas.

"The sewage and waste water is the main cause of the contamination of this water body," said Muhammad Ramzan, a resident of uptown Srinagar. "The consumption of polluted and infected water is jeopardizing our health to a great extent now.'



The inhabitants have been time and again reaching out to government due to the alarming deterioration in water quality of Doodh Ganga in the face of barrage of pollutants flowing into the water stream at different points.

Taking cognizance of the dilapidated condition of the river Doodh Ganga due to high levels of pollutants in its water, the Jammu and Kashmir High Court under a Public Interest Litigation of its own motion, ordered the directing

respondents to take necessary action for preservation of Doodh Ganga Water Stream and Doodh Ganga Water Filtration Plant located at Kralpora.

The investigation report by the JK Pollution Control Board—now Pollution Control Committee—identified 13 Srinagar Municipal Corporation (SMC)run drainage pumping stations as the main pollutant carriers, as none of these drainage stations had a sewerage treat-ment facility before throwing the effluent into the river.

The unfortunate turn of events started unfolding for the inhabitants when SMC started upgrading 49 Drainage Pumping Stations located in and around Srinagar City under a Scheme funded by the World Bank.



First Real-time Air-monitoring Station Inaugurated At Srinagar

SRINAGAR: J&K got its first real-time air-quality monitoring station with inauguration of first ever Continuous Ambient Air Quality Monitoring Station (CAAQMS) at JKPCC headquarters Rajbagh, Srinagar by Chairman J&K Pollution Control Committee, Suresh Chugh, here Wednes-

inauguration was followed by a detailed presentation by Subrat K. Kant, DGM of M/s Environment SA. which has provided the equipment and is looking after the operation and maintenance.

Terming it as a major achievement of J&K PCC, Chairman thanked all the officers and the entire team for putting in their best efforts in successful installation and commissioning of the station which saw many hiccups and delays due to Covid19 pandemic.

The CAAQMS, which was put on trial run for two months before its inaugura-

tion, is a highly sophisticated equipment that gives real time air quality data of a particular area especially the key parameters like PM10, PM 2.5, NOX, SOX, Ozone which determine the air quality of that area. The installation of CAAQMS has been mandated in all the non-attainment cities across India including Jammu and Srinagar.

Chairman informed the gathering that the air quality monitoring network shall be established and later extended to all district headquarters of J&K in due course of time. Further, two similar stations are going to be established in Jammu province.

During the presentation, it was informed that the air quality data generated by CAAQMS has been linked with CPCB portal (https:// app.cpcbccr.com/AQI_India/) and the Air Quality Index has been made public enabling any person sitting in any corner of the world to access the Air Quality of Srinagar city.

Uncertain Situation

ne more drone was spotted along the international border in Jammu's Arnia sector on Tuesday night. It returned after the BSF personnel opened fire at it Later, the security personnel launched the search of the area but found nothing. Ever since the explosives-laden drone was used to attack the Air Force Base in Jammu in June and which mercifully didn't cause any big damage, more such unmanned aerial vehicles have been spotted near the security installations. The objects haven't hit their targets because the alert security personnel have been able to pre-empt the attack. But the regular sighting of these objects has not only become a headache for the security forces but has also contributed to further deterioration of the security situation in Jammu province. The situation in the Kashmir Valley is already uneasy, although there has so far been no incident of drone spotting.

What is particularly of concern is that the current situation in Jammu and Kashmir is taking shape amid the shifting geopolitics of the region following the exit of the US from Afghanistan. Over the last two weeks, Afghanistan has plunged into a civil war. Taliban is marching from one district to another, almost unresisted by the Afghan forces. In the process, not only the ground situation is shifting in the war-scarred country but also in South Asia. It seems but a matter of time before the Taliban could be ruling the entire Afghanistan. This has huge security implications for the region including Kashmir. Many experts in India see a potential for replication of the situation of the mid-nineties when there was some spillover of the battle-hardened mujaihideen into Kashmir. Could this history replicate? As the situation is unfolding, it is difficult to rule this out.

The challenge posed by recent drone attacks has a wider dimension. It underlines a sudden re-emergence of the challenge of militancy, which otherwise has been showing signs of being on the wane over the last year. And just when we were rushing to write the epitaph of militancy, the drone attacks show that a new phase may be about to start - and this time in a new form.

Could this be pre-empted? Unlikely, if the two countries take no steps to address the issues and factors that underpin the long troubled situation. The hope that the ceasefire agreement along the LoC would be followed by a resumption of dialogue between India and Pakistan has But one expects that India and


rn to a serious and meaningful dialogue. This alone has the potential to avert what look like to be very uncertain times ahead.

The Inflation Challenge

"ndia has an inflation problem. The Consumer Price Index (CPI), India's benchmark inflation measure, grew at 6.26% in June 2021. This is the second consecutive month that CPI has landed above the Reserve Bank of India (RBI)'s upper tolerance limit of 6%. Wholesale Price Index (WPI) grew at 12.07% in June, the third consecutive month of double-digit wholesale inflation. And the prices of fuel, largely a tax-driven phenomena currently, are at a record high. An overwhelming share of Indian workers are employed in the unorganised sector. This means that their earnings are not indexed to prices. Any sharp inflationary spike, therefore, puts a squeeze on purchasing power and demand. The rise in diesel prices will have a particularly adverse effect on farm incomes for the kharif season. The minimum support prices announced by the government were based on cost estimates, which would have escalated significantly now.

he conviction and sentencing of a policeman for the murder of George Floyd signifies a major success for the Black Lives Matter movement in the United States. However, the question of why racism persists in America, despite a prolonged and serious effort made in the education system to address the issue, remains. The usual response among people who work in the field of education is that education never got a real chance to succeed. Their argument is based on the premise that for education to be successful in its social goals, there must be a consensus among political, economic and cultural policies. This may be asking for the moon, but there is some truth in the contention that education cannot work in isolation. If discrimination against a certain group is rife in the economic and political spheres, schools alone cannot remedy it. Thus far, the case is well-made, but a deeper look is necessary to appreciate the kind of effort that those involved


in education make to mitigate

Negative attitudes based on religion and caste, however, are rather different. These categories of prejudice are rooted in collective identities formed over long periods of history. It is a simplified version of the knowledge of the past that a community holds and transmits through religious activities and different cultural media.

Racist abuse of players: England loses more than just the Euro 2020 final

Pride in the new found British identity didn't last too long when push came to shove

he irony. Just before their final against Italy, the England football team took a knee on the field, a symbolic gesture that many other teams had also earlier replicated during the tournament to take a stand against racism.

But barely hours after England lost, three of its young players were the target of the most vicious racist attacks, both on social media — there are reports that almost 2000 abusive tweets were posted after the game, and offline.

The mural of Marcus Rashford, one of the players to have missed a penalty in the final was defaced and an MP had to apologise after her message saying the player should have focused on perfecting his game rather than playing politics — she was referring to Rashford's high-profile campaign for free meals for poor students in schools last year, was leaked.

"My penalty was not good enough, it should have gone in, but I will never apologise for who I am and where I come from," the 23-year-old Rashford was forced to tweet, adding that the missed penalty was playing over and over, in his head.

Defending your identity

Here is a young man who has tirelessly worked for the upliftment of children from low-income families, fighting his own demons and yet having to come out and tragically defend his identity.

Along with Rashford, Jadon Sancho and Bukayo Saka also missed penalties and their fate has been equally abusive. Just a couple of days before the final, Gareth Southgate's squad was being hailed as a 'celebration of diversity' with parents or grandparents of seven of the eleven players who started

against Denmark in the semis, born overseas. The nimble footed Raheem Sterling too moved from Jamaica when he was a child and became an MBE for campaigning against racial injustice.

But this pride in a new British identity didn't last long because when push came to shove, it dissipated into violence and abuse.

The signs were already there- some would say the signs have always been festering and not necessarily beneath the surface- when fans at Wembley Stadium booed the national anthem of the Danish team in the semi-final and shone a laser on goalkeeper Kasper Schmeichel's face just before Harry Kane took a penalty.



Former England player Gary Neville had then defended the crowd booing saying it was simply fans trying to unsettle the opponents and whether it was "really bad and disrespectful?"

Enabling racist behaviour

In the final, there was more of the same when the national anthem of Italy was played out. Incidentally Neville immediately spoke out against the racism attacks, admitting that issues exist but his dismissal of the crowd behaviour earlier is also an enabler of where the British society finds itself today.

Critics say those at the top have to shoulder a lot of the blame for this outpouring of racism. They are referring to Prime Minister Boris Johnson and Home Secretary Priti Patel — both of whom have been accused of not supporting the team's gesture of taking a knee before matches.

Patel who was herself born to a Ugandan-Indian family had earlier dismissed the action as nothing but 'gesture politics' saying England fans had a

choice to jeer players doing it.
"You don't get to stoke the fire at the beginning of the tournament by labelling our antiracism message as 'Gesture Politics' and then pretend to be disgusted when the very thing we're campaigning against, happens," lambasted footballer Tyrone Mings.

Normalising vandalism, hooliganism

The racist abuse came after the world had already witnessed images of ticketless British fans attempting to break their way into Wembley, most of those who booed the national anthem, though likely had tickets. Then came visuals of men drunk on much more than alcohol, vandalising whatever came in their way and reportedly even jumping off

What is it about England football fans that has normalised such hooliganism, there are some comments on social media dismissing the violence as just a part and parcel of the game. No, it isn't and should never have been allowed to reach this point.

Many British women have spoken out on Twitter about how English football is but a patriarchal drunk fest where any big game allows the men to lose control of which, their own women are sometimes

I shudder to think what it would have been like if the team had actually won. On the other hand, it is dystopian to think that in the same country a Wimbledon tournament was also taking place.

So, it didn't come home but what it did bring home to the world was that there is something rotten in the state of England and that the country needs to dig in deeper especially its politicians with their

casual enabling of racism. In the aftermath of George Floyd's killing and the sensitivities, their behaviour at the start of Euro seems an arrogant dismissal of the #BlackLivesMatter movement. No tweet in support of the players can change what they allowed to happen.

Tokenism, not inclusion

Football is a beautiful game and its strength also lies in the diversity on the field at any given time. Unfortunately the behaviour of some British fans has discarded that inclusion and replaced it with mere tokenism.

The support for the players though has been heartening but unless the country clamps down hard on racism and hooliganism, everything will seem a mere pretence — just an advertisement before the game.

England's wonderful quest for its first major title since the 1966 World Cup has unfortunately been overshadowed by events outside the field. Will this impact the UK-Ireland bid to host the 2030 World Cup?

Perhaps it is time to think if the country really deserves to hold international football matches till it sets its house in order, the action of some have unfortunately tarnished the innocent many. But perhaps that's the only language racism and violence will understand.

Pakistani Militant

During the search operation, he said, the civilians were evacuated to safer places and as the presence of militants got ascertained they were given an opportunity to surrender.

"However they fired indiscriminately upon the joint search party, which retaliated leading to an encounter. Due to darkness the operation was suspended, while the cordon remained intact," the police spokesperson said.

He said the militants also made a failed attempt to flee from the cordon taking advantage of the darkness.

"In the wee hours, repeated announcements were again made to hiding terrorists to surrender, but the terrorists again fired on joint search party and the fire was retaliated," he said.

As per the police spokesperson, three militants of Lashkar-e-Taiba (LeT) were killed in the ensuing encounter and their bodies were retrieved from the gunfight spot. He identified the killed militants as LeT commander Aijaz alias Abu Huraira of Pakistan, Javeed Ahmad Rather of Tahab Pulwama and Shahnawaz Nazir Ganie of Samboora in Awantipora.

As per police records, he said, all the killed militants were part of a group involved in various "terror crimes" regarding which several cases stand registered against

"The killed foreign terrorist Aijaz had a history of terror crime cases. He was also instrumental in recruiting innocent youth into terror folds besides, planning and executing several terror attacks in the area including attacks on Police and security establishments," the police spokesperson said.

"Incriminating materials arms and ammunition including 2 AK rifles and a pistol were recovered from the site of the encounter. All the recovered materials have been taken into case records for further investigation and to probe their complicity in other terror crimes," he added.

He quoted IGP Kashmir as congratulating police and central forces for conducting a successful operation without any collateral damage.

"In this connection police has registered a case under relevant sections of law and investigation has been initiated. People are requested to cooperate with police till the area is completely sanitized and cleared of all the explosive materials, if any," he added.

Meanwhile, the authorities imposed curfew and snapped internet services across the district after the killing of the three militants, reports said. Sporadic protests were also reported from the area.

Ex-Militant Arrested

Two families-both close relations-one from Nawabazar and another from Bemina area of Srinagar had left for Drang, a picturesque spot for a picnic trip but little did they know that they would be with the bodies of their daughters in the afternoon. The two deceased girls were identified as 17-yearold Utba, daughter of Muhammad Ashraf Khan, and 19-year-old Insha daughter of Bilal Ahmed Khan, aged 19.

"It was my daughter Utbas' birthday today. She insisted on a picnic trip and I couldn't say no. We decided to go to Drang," said her father Muhammad Ashraf Khan.

"She was my only child. My daughter and her cousin sister Insha requested us to allow them to take a few photographs in a nearby canal. I told them to go ahead but be careful. They were clicking pictures and all of a sudden huge discharge of water took them away. I tried to save them. I too was swept away by the water and I got stuck

With tears in his eyes, Ashraf said that he was pulled out by locals and taken to a nearby medical facility where he gained consciousness after some time.

'When I enquired about my daughter and her cousin sister, I was told they were retrieved out dead," said Ashraf. He said locals had pulled out two cousin sisters out of the water after hectic efforts.

Locals of Drang said that today's incident was the second of its kind since July this year.

"We had requested the authorities including SDM Tangmarg to close the canal given the fact the area is a tourist spot, but our pleas went to deaf ears," said Aijaz Ahmed, a local resident.

He said a timely siren and the announcement could have prevented today's tragic incident. "There is an announcement system but that is for employees only. The employees handling this power project are callous and least bothered about human lives.

Sub District Magistrate Tangmarg Sameer Jan said that he was aware of the incident at Drang.

"It's very unfortunate that two lives were lost. We have taken note of the incident and the allegations by parents of the two deceased girls. We are investigating the incident thoroughly," he said.

"There are two survivors of the incident. We will talk to them also and get their feedback as to what actually happened and who is at the fault. Action will be taken if any employee is found guilty."

A police official at Tangmarg police station said that they have registered a case and investigations have been taken up.

"Including 73 AYUSH Health and Wellness Centres inaugurated in March this year and 21 AYUSH Health and Wellness Centres inaugurated in September last year, a total of 94 AYUSH health and wellness centres have been started in Phase-I." Sinha said.

The LG as per official spokesperson also said that all these centres are running smoothly and from yoga instructors to every type of infrastructure, all have been made available there. In the second phase, the Directorate of Indian Systems of Medicine, J&K is working on 100 more AYUSH health and wellness centres.

"These centres would prove to be a milestone in creating a robust health infrastructure across J&K in the future, he added.

The LG, as per official spokesperson noted that the role of Ayurvedic College and AYUSH Centres has become imperative in maintaining the health of the people because there are so many diseases in the world for which it is difficult to find treatment and preventive care in one method alone to keep the body healthy.

"The aim of this Ayurvedic College and other wellness centres is not only to take care of overall health but also to ensure that people do not fall ill and stay healthy," the LG said.

In the last few years, under the guidance of Prime Minister, Narendra Modi, the public health sector in Jammu and Kashmir has got a new direction, new momentum for extending healthcare facilities to all the people. It was his vision, under which the Indian System of Medicine was brought into the mainstream through the National Health Policy enabling people to avoid diseases through 'Self-Care' and providing an alternate option of treatment to the needy people," he added.

The official spokesperson further said that the LG elucidated the two main objectives behind the decision of central government to develop 12,500 Ayushman Bharat Health and Wellness centres across the country under the National AYUSH Mission for providing low cost general health cover to maximum people and extending primary health care facilities while spreading awareness among people living in remote areas and said that there is also a third aspect of it, that is for the first time a policy was worked out on the preventive care of the public.

"J&K stands out as a leader in the entire country in terms of arrangement of medicines and establishment of Covid Care Centres in Panchayats to provide ample capacity of oxygen beds to the people," Sinha said.

Her counsel said Mufti had appeared before the ED on that day since there was no interim protection granted to her by the court.

Mufti, in her plea filed in March, has also challenged issuance of summons to her by the ED in a money laundering case. She has sought to stay the summons, however, the court had refused to grant the relief at this stage.

The 61-year-old leader, who was released last year after more than a year in detention following the scrapping of Jammu and Kashmir's special status, was served notice to appear at the ED headquarters in the national capital.

Initially, the ED summoned Mufti for March 15 but it did not insist for her personal appearance at that time. Thereafter, she was summoned for March 22.

Mufti has sought quashing of summons issued to her by the ED in a money laundering case.

She has also sought to declare section 50 of the Prevention of Money Laundering Act as void and inoperative, being unfairly discriminatory, bereft of safeguards, and violative of Article 20(3) of the Constitution.

Section 50 of the Act empowers the authority, that is, officers of ED, to summon any person to give evidence or produce records. All persons summoned are bound to answer the questions put to them and to produce the documents as required by the ED officers, failing which they can be penalized under the Act.

She has also sought an interim stay on the summons until the question of law in relation to constitutionality of Section 50 of the Act is decided.

Earlier, Mehta had said there was no need to issue formal notice to them as they are already appearing before the court and said they will file a short note on the issue of question of law.

Mufti, in her petition, said she has received summons from the ED under the provisions of the PMLA, purporting to call for 'evidence' on pain of punishment, whereas she is, to all intents and purposes, a subject of investigation.

"She has not been informed if she is being summoned as an accused or as a witness. She has also not been informed of what she is being summoned in connection with and the scheduled offence under the PMLA which gave rise to the proceedings in respect of which impugned summons has been issued to her. The petitioner is not the subject of investigation, nor is she an accused, in any of the scheduled offences to the best of her knowledge, the plea said.

One of the drainage ejection points on the adjacent end of the Bund at the doorstep of Bone and Joint Hospital Barzulla, is a great hazard—especially for the patients, as it stinks round the year.

In the context of river Doodh Ganga, upgradation clearly conveys more and more drainage effluent going into the water source.

"Most of the pollution takes place in Chadoora where large quantities of liquid waste get drained into Doodh Ganga," said Raja Muzzafar, an activist.

In the Barzulla belt, which the pollution board has established to be the most polluted stretch of Doodh Ganga on the basis of its water analysis report, the quantum of liquid pollutants going into the river shall increase from around 1.0 million litres per hour to staggering 10.5 million litres per hour once upgraded versions drainage stations are operated.

Amid this free flow of pollutants, the situation is shaping up as a death writ for River Doodh Ganga. And the consequences could be

"The government must take necessary steps and the SMC needs to be reined in before an environmental disaster strikes the water body," said Nadeem Oadri, a noted environmental advocate from Kashmir.

"Doodh Ganga being a very important part of ecosystem needs to be protected. We launched an online campaign, Save Doodh Ganga Canal, to create awareness. Also, the de-filtration of the river has not taken place from quite long. Hence, it has become a victim of government's apathy. Court has passed detailed orders related to conservation, protection and preservation of Doodh Ganga.'

But irrespective of the court order, Qadri said, the government seems very much non-serious about eco-restoration of Doodh Ganga canal which is very critical when it comes to flood mitigation and other ecological services.

"One of the core arguments of Public Interest Litigation is also throwing the drainage water directly into Doodh Ganga. It's not only going to change the ecological character of the river but equally contributing to the harm to the aquatic life.'

Misbah Says 0-3 Series Loss **To Second String England Has** 'Unsettled' Pakistan Team

KARACHI: Beleaguered Pakistan head coach Misbah-ul-Haq on Wednesday admitted that the 0-3 thrashing at the hands of a backup England team in the ODIs has unsettled the team and left him "very worried".

Pakistan was whitewashed in the three-match series with the biggest blow coming on Tuesday when it lost after scoring 331.

"We were satisfied that we were on the right track after doing well in the recent series but this series has unsettled us. It looks like we are standing from where we started but we have to find a way to move forward," Misbah told a virtual press conference.

why Pakistani selectors and management were ready to try players based on performances from the Pakistan Super League or on the basis of one or two matches.

He said it was not an ideal situation to be in but the process to build a pool of reliable players was on.

Misbah also defended the performance of his team insisting this same outfit had done well in recent series.

"I don't understand but we just lost our momentum coming into this series. But I believe we can definitely compete against the top four teams and we have done well in the past against South Africa at home and away."

He also felt that blaming players or coaches for the poor results



"I don't know why the team was totally off-color in this series and lost its momentum but it is a very worrying sign for me as head coach.

"How can one defend such a performance. No one can defend our performance and I think as a team we are all responsible be it the players, coaches or support staff," he stated.

England announced an overhauled 16-member squad for the series after Covid-19 cases in its original squad forced the players into quarantine.

"We just couldn't handle the conditions in the first two matches and in the third match we had a total we should have defended but overall it is very disappointing from a bowling point of view and especially our fielding standards. We dropped simple chances," Misbah rued.

The head coach conceded that the series results showed that while England had the luxury of strong bench strength, Pakistan

lacked in this area.
"First of all England has a great back up and the luxury of a strong pool of players we don't have. England had choices for this series and we have limitations at certain positions especially in the middle order spaces where no one has

settled down for a while." Misbah said this was one reason was expected but if plans are not executed by a team on the field everyone is responsible.

He admitted that the bowling was disappointing and bowlers didn't bowl to lengths and plans given to them. To a question Misbah insisted that there was no favoritism in the team by the coaches and every player played on merit and according to team requirement and match conditions.

"We don't do favors with any player...this debate goes on...we play a combination which is best and also look at our bench strength. No matter what people think, no one wants to not do well in a match."

He also defended the continued selection of non performing all-rounders, Shahdab Khan and Faheem Ashraf insisting they brought balance to the side.

Misbah said the below strength England side had beaten Pakistan purely because of its players" discipline.

Asked if he felt the long quarantine and isolation had affected the players performances, Misbah said it could be a reason but he wouldn't give this as an excuse for the poor performances of the team.

"If we have one or two poor matches, if things go wrong we can't say everything is wrong...no one talks about wins..last year's series wins...we will address our loss as the failure of everyone."

ICC Confirms New WTC Points System: 12 For Win, 4 For Draw, 6 For Tie

DUBAI: The ICC on Wednesday officially confirmed that teams will be awarded standardised 12 points for a win, four for a draw and six for a tie during the second World Test Championship cycle which kicks off with the five-match series between India and England in August.

The ICC further said that percentage of points won will be used to determine standings in the 2021-23 cycle.

Earlier, each Test series carried a value of 120 points which led to certain inequality in the table as a team winning a Test in a two-match series got 60 points compared to five-game se-

ries where a Test win is valued at 24 points. PTI had last month reported that ICC was set to introduce the new standardised points system for the second WTC cycle soon.

ICC Acting Chief Executive Geoff Allardice said the changes were made to simplify the points system while taking learnings from the disruption last year.

"We received feedback that the previous points system needed to be simplified. The Cricket Committee took this into consideration when proposing a new, standardized points system for each match. It maintained the principle of ensuring that all matches in a WTC series count towards a team's standing, while accommodating series varying in length between two Tests and five Tests," Allardice said in an ICC statement.

"During the pandemic we had to change to ranking teams on the points table using the percentage of available points won by each team, since all series could not be completed.

"This helped us determine the finalists and we were able to complete the championship within the scheduled time frame. This method also allowed us to compare the relative performance of teams at any time, regardless of how many matches they had played.

Apart from the India-England series, the Ashes later this year will be the only other fivematch affair in the second cycle which will end in June 2023. Australia's tour of India next year is the only four-Test series in the upcoming cycle. The nine Test teams will play a total of six series -- three home and three away just like the previous edition.

My Idea As A Leader Is To **Keep Everyone Together,** Happy: Shikhar Dhawan

The selectors have picked many uncapped players, including the likes of Ruturaj Gaikwad and Chetan Sakariya, and Dhawan wants the youngsters to enjoy their journey.

Of Olympic Medals **And Their Evolution**

NEW DELHI: From olive wreaths to recycled metals sourced from old cell phones and electronics, the reward for winning at the Olympics, the most sought-after achievement in an athlete's life, has come a long way, much like the Games itself.

Made of recycled electronic devices and pebble-like in appearance, the medals in the upcoming Tokyo Games will measure 8.5 centimeters in diameter, featuring the flying image of Nike, the Greek goddess of victory.

But, unlike previous years, these will be produced from gold, silver and bronze (in this case, copper and zinc) that has been stripped from over 79,000 tons of used cell phones and other small electronic devices

donated by the Japanese population. During the ancient Olympic Games, athletes who emerged victorious were awarded 'Kotinos' or olive wreaths, which were considered a sacred prize in Greece, representing the highest honour.

In 1896, the long-lost tradition of ancient Greece, the Olympic Games was reborn in Athens.

With the rebirth, new practices made way for older ones and thus the custom of awarding medals began -- silver for the winners while the runners-up received a copper or bronze medal. On the front of the medal was

Zeus, father of the gods and in whose honour the Games were held, holding Nike, while the reverse side showed the Acropolis.

It wasn't until eight years later in the 1904 St. Louis Games, where the now standard gold, silver, and bronze medals, were first used. The metals represent the first

three ages of man in Greek mythology: the Golden Age -- when men lived among the gods, the Silver Age -- where youth lasted a hundred years, and the Bronze Age, or the age

Over the next century, the coveted awards would vary in shape, size, weight, composition, and in the image they carried. In 1923, the International Olympic Committee (IOC) launched a competition for sculptors to design the medals for the Summer Games.

The Italian artist Giuseppe Cassioli's design was chosen as the winner in 1928. The obverse of the medal was embossed with Nike holding a palm in her left hand and the crown for the winner in the right, with a depiction of the Colosseum in the background and the reverse featured a crowd of people carrying a triumphant athlete.

This design continued for a considerable time.

While host cities were allowed to rework the reverse of the medal starting from the 1972 Munich Games, the obverse only changed during the 2004 Athens Olympics.

A new depiction of Nike, flying

into the 1896 Panathenaic Stadium

to bestow victory on the strongest, highest and fastest, replaced the older one. Until 1960, winners had medals pinned to them but the Rome

Olympics had the necklace-like design allowing the athletes to wear the prized possession around their necks thanks to a chain.

Four years later, the chain made way for coloured ribbons. Interestingly, the gold medals are

not made of the yellow metal entirelv. The 1912 Stockholm Games was the last time an Olympic medal was made entirely out of the metal. Now, they are just plated with it.

As per the IOC guidelines, a gold medal must contain a minimum of 6 grams of gold. In reality, silver forms the bulk of the medal

China, which hosted the 2008 Beijing Olympics, for the first time, introduced medals made of a material other than metal -- jade.

Messi To Sign New Five-Year Deal With Barcelona. **Say Reports**

BARCELONA: Lionel Messi is set to extend his stay at Barcelona by signing a new five-year deal, with the Argentine talisman set to take a wage cut, La Vanguardia newspaper and ESPN reported on Wednesday.

Messi, Barca's all-time top scorer and appearance maker, technically ended his 21-year association with the club last month and is currently a free agent after his previous contract expired.

Since Joan Laporta took over as Barca president, the club has been trying to reduce their wage bill in order to keep Messi and stay within La Liga's strict financial control rules. La Liga chief Javier Tebas said last week that

Barcelona, which has a total debt of more than 1 billion euros (\$1.18 billion), would not be shown any leniency. Messi's last contract, signed in 2017, was the

most lucrative in world sport according to a January report in newspaper El Mundo. The club have been trying to rebuild the squad with Junior Firpo, Jean-Clair Todibo and Carles Alena being sold to make way for free signings Sergio Aguero, Memphis Depay and

Messi, 34, won his first major international title with Argentina over the weekend when thev beat rivals Brazil in the Copa America final. Messi was elected the tournament's joint best player along with Neymar after finishing as the tournament's joint top goalscorer with four goals while he also topped the assists charts with five.
