District Wise Assessment of Covid Situation **People Must Be Educated About Danger of 3rd Wave: LG**

SRINAGAR: Lieutenant Governor, Manoj Sinha today interacted with Senior Officials, Deputy Commissioners and SPs to discuss Covid related situation in the UT.

During the Covid Task Force meeting, the Lt Governor took an assessment of health infrastructure, Oxygen plants and measures being taken to contain the spread of Coronavirus.

In the meeting with DCs and SPs, Lt Governor reviewed the progress of vaccination, positive cases in the districts, Covid Appropriate Behaviour (CAB) and steps taken to further strengthen the measures during post-unlock period.

Test-Track-Treat and now, Teeka are long term solutions to mitigate the spread of CoronaVirus. Panchayats with a large number of positive cases should be paid special attention to set up Micro Containment Zones, observed the Lt Governor.

He also passed specific directions for increasing RT-PCR tests in areas with high positivity rate.

The Lt Governor directed the officials to be well-prepared in advance to deal with the possible 3rd Wave of Corona Virus or any future health emergencies.

Health experts have cautioned the world against the third wave



of covid. We need to be vigilant and put our all-out efforts to save precious lives by intensifying vaccination drives, increasing testing, improving contact tracing, ensuring Covid Appropriate Behaviour being followed by the people, besides focusing improvements in all critical factors of Preventive care, effective Clinical and Patient Care management, maintained the Lt Governor.

On being informed about the 13 Districts now completed the 100% vaccination of 1st dose in 45 and above age group, the Lt Governor congratulated the DCs, Health functionaries, Frontline health workers of the respective districts for achieving the milestone and asked the remaining districts to put some extra effort to ensure that the target population would be vaccinated at the earliest.

Speaking on the efforts being made by the UT Government for the advancement and development of the health sector, the Lt Governor observed that J&K has recorded significant improvements in different health indicators. Taking strict note of the people


flaunting Covid protocols, the Lt Governor directed the DCs and SPs to ensure adherence of Covid Appropriate Behaviour, following of covid protocols like wearing face masks, and implementation of restrictions & guidelines in their respective districts, especially in tourist places.

Explore innovative ways to restrict crowding in dense areas, besides putting more focus on religious places, market & public places, added the Lt Governor.

The Lt Governor called for devising a Responsive Information mechanism so that correct and timely information shall reach the people from authoritative sources. Publicize the availability of vaccination in centres in advance for the convenience of the people, he added.

While taking stock of the functionality of Oxygen generation plants, the Lt Governor advised for utilizing available oxygen capacity for effective functioning of ICUs at District Hospitals. This will also reduce the referrals of patients to the GMCs, he added.

Further instructions to registered students shall be notified separately.



Non-Local Beggars Becoming A Common Sight In Srinagar, Despite Ban

Srinagar: Despite a ban on begging in capital city Srinagar, the non-local beggars have created a nuisance in the city particularly in uptown areas and around traffic signals. Invoking the Jammu and

Kashmir Prevention of Beggary Act,1960, the government imposed a ban on begging in 2018. An order issued in this re-

gard by the Deputy Commis-

sioner Srinagar directed police to arrest any person found soliciting alms in public and at religious places or other private premises.

The SSP Srinagar and Budgam were also asked to implement the order and report the number of such arrests on a daily basis.

But despite the ban, beggars, particularly, non-locals, are seen asking for alms in and outside Srinagar.

The residents of the city said that the beggars have created a mess on the city streets. "It is almost impossible to keep the windows down near a traffic signal in Hyderpora crossing," a resident of the area said, adding, "at least four beggars, mostly children, come around and ask for alms.'

Hyderpora and its adjoining areas have become a hub of such non-local beggars, he said.

"This has become a nuisance." another resident said, adding that the people are compelled to give them money so that they can get rid of them.'

Soldier killed by CRPF men

Mistaken for a militant after girl's murder

RINAGAR - A soldier was shot dead by CRPF personnel in an Anantnag village on Wednesday night minutes after he killed a local girl.

The soldier from the 49th RR was shot dead by a patrol party who mistook him for a militant on account of his plain clothes and furtive movements

while fleeing from the scene of his crime.

Outraged by the killing of the girl, thousands of people came out into the streets today holding protests against the security forces and demanding that the body of the RR man be handed over to them.

The soldier had sneaked into the house of Muhammad Akbar Dar in village Changoo

in Doom area through a window after climbing over a walnut tree, and demanded food and a place for the night.

Enraged when the family refused his demand, the soldier had shot and injured Dar's 19-' year-old daughter. Zahida, who fell down in a pool of blood?

The family tried to catch hold of him, but he pumped a fatal shot into the girl and managed to escape from the scene A CRPF patrol outside the village ordered the fleeing Soldier to stop, and opened fire taking him to be a militant, the KNS, quoting police sources as having said. He died on the spot after identifying the soldier, the CRPF left his body and weapons lying in the field.

The defence spokesman, Col V.K Batra, however, told the KNS that the soldier had committed suicide after killing the girl. The local population surged into the streets in a huge demonstration against the security forces, sitting on a dharna and disrupting traffic.

Demanding that the soldier's body be handed over to them, the villagers said he had entered Dar's house with evil Intentions and had molested his daughter before shooting her dead.

The senior superintendent of police in Anantnag, Aashig Hussain Bukhari, however said, that no molestation had taken place.



"Construction of Mini Academic Block" through above said NIT was shown as 600 mm diameter, while as per spot inspection con-



ducted by ACB in association with concerned experts, the same has been found 450mm in gross violation to NIT. The specification was found altered under the garb of a corrigendum which was neither



To date, which means up to the date of the US's precipitate, ignominious departure, the US has expended over \$2.26 trillion in a stillborn attempt to modernise Afghanistan's archaic tribal society. It leaves behind 5,000 troops as 'caretakers' in a war cemetery without tombstones.



Days after its troops fled their showpiece airbase at Bagram, the US government, in an act of posthumous generosity, delivered 1.4m Johnson & Johnson Covid-19 vaccines under the Covax Facility's dose-sharing scheme. Another 1.9m doses are in transit. How a rump Afghani government, besieged within its beleaguered capital Kabul, will vaccinate so many Afghans across the country no one knows, or cares.

Covid-19 is a scourge of biblical proportions. It has ravaged mankind, disturbed social orders, wrecked economies, and exposed luxurious vanities such as wedding extravaganzas and the Olympic Games.

One can understand why, in 1964, the Japanese were keen on hosting the Summer Olympic Games. They wanted to demonstrate that, within 20 years of being defeated in the Second World War, they had 'arrived', were at par with the victors. The same ambition motivated the Chinese to host the Summer Olympic Games in 2008. (Being an underdog can be a powerful, painful spur.) The Chinese are now determined to repeat their summer success at Beijing in 2008 by hosting the 2022 Winter Olympics. The Chinese should anticipate a boycott. In 1980, a sanctimonious US and 65 of its acolytes boycotted the Summer Olympics in Moscow. They condemned the Soviets for invading guess where? — Afghanistan.

The Japanese are determined to hold the belated 2020 Olympics, whatever the Covid-19 cost.



They have spent a decade planning it, expended \$15.4 billion already, but must expect only the ignominy of empty stadiums, the sulk of disappointed ticket-holders, and the chagrin of toned athletes who see years of training reduced to a virtual spectator-less spectacle.

Fighting the Covid Crises Innovatively

C Interestingly, it has been more than a vear since the virus outbreak, yet there has been no effort by the government to improve the data collecting technique. Death estimates based on statistical assumptions are creating confusion. For example, a consumer pyramid household survey based on 2,34,000 households, conducted in May-August 2020 by the center for monitoring the Indian Economy showed the covid toll could be more than twice the official reported figure

he havoc that Covid-19 induced Pandemic caused globally is known to us all. Whether the virus resulted from the lab leak in Wuhan or emerged from natural selection is a debate for specialists, however, what concerns the public is the widespread crises in health infrastructure and the (mis)management of the situation. It is in this context that we propose a few points that would help us mitigate effectively the impact of any possible pandemic in the future and improve the condition of health infrastructure. These concern the use of innovation and technology, improving basic amenities, and democratizing the social fabric of society.

Since the recent past, we have been compelled to anticipate a third wave to come and bring the entire machinery to a halt. However, conversations over the management and questions over efficacy should never stop. Thus, the policy advocates should primarily take note of the management of data and figure out ways to improve it from the current situation. First, better data collecting mechanisms should be established and coherent figures presented with highly sophisticated data-collecting technology. Currently in India, the mortality rate of covid 19 is collected by two major data collecting systems one (CRS) Civil Registration System and second (SRC) Sample Registration System, which collects monthly demise data for all population and sample population respectively. Monthly mortalitv rates are available in many urban municipal offices where death data is covered through civil registration. The sample registration system of India collects monthly mortality data for urban and rural areas, unfortunately, both the systems do not publish this data monthly. Moreover, annual reports are published only after two or three years of collection. The need is to publish this data either weekly or monthly so that

scientific estimates are available for intervention. It is equally necessary to release the data on covid 19 patients collected by the Indian council for medical research (ICMR). In 2020, the ICMR had continuously been collecting hospitalbased data. The release of this quality hospital-based data will allow researchers to investigate over covid 19 as well as to study it from a social science perspective.

For example, a consumer pyramid household survey based on 2,34,000 households, conducted in May-August 2020 by the center for monitoring the Indian Economy showed the covid toll could be more than twice the official reported figure. The Institute of Health Metrics and Evaluation, USA shows the estimated covid deaths in India are around nine lakhs, three times higher than the current report figure. This happens due to the lack of actual reports of covid victims. From this, we have to improve the data collecting strategies and program by developing technology to separate the covid patients as done by England, when covid started spreading there, they legally self-isolated 7 million people in which 5 million people were not infected which were released after testing. Similar efforts were made by many other countries to overcome this unprecedented situation.

illness to avoid discrimination; discourage people from adopting healthy behaviours; demotivate frontline personnel from carrying out responsibilities etc. The complicacy doesn't even end here, groups who experience stigma may also experience discrimination. This discrimination can take the form of either othering people, avoiding or rejecting them, or lead to problems in getting healthcare, education, housing, or employment, and so on.

Suggestions concerning eradicating stigma are aimed at enhancing positive public response. Everyone can help stop the stigma related to COV-ID-19 by knowing the facts and sharing them with others in their community or share only the authentic information available related to COVID-19 from reliable sources before forwarding any messages on social media.

The way we communicate can affect the attitudes of others, hence choosing words carefully and getting our vocabulary right with respect to the disease, its victims, and the consequences it leads to. Building psychological support and social mechanisms to establish vibrant social structures can help not only deal with the disease efficiently but also garner efforts to fight this collectively.

While appreciating the efforts of people providing essential services and being supportive of them and their families, we need to work together to promote the importance of preventive measures, early screening, testing, and treatment and to help those who are most vulnerable by keeping them safe.

India's Wicked Problem How To Loosen Its Grip On Coal While Not Abandoning The Millions Who Depend On It

India is the world's third largest emitter of greenhouse gases, and its transition to a low-carbon economy is crucial to meeting the goals of the Paris Agreement. But unfortunately, the nation is still clinging firmly to coal. Our new research considered this problem, drawing on a case study in the Angul district, India's largest coal reserve in the eastern state of Odisha.



time. Rural development agendas have been short-lived, often set within six months of an election deadline then changed or abandoned.

Skill-development programs in noncoal vocations have also been limited. This lack of viable alternatives implic-

We found three main factors slowing the energy transition: strong political and community support for coal, a lack of alternative economic activities, and deep ties between coal and other industries such as rail.

India must step away from coal, while maintaining economic growth and not leaving millions of people in coal-mining regions worse off. Our research probes this wicked problem in detail and suggests ways forward.

Why India matters

India's population will soon reach 1.4 billion and this decade it is expected to overtake China as the world's most populous nation. This, combined with a young population, growing economy and rapid urbanisation, means energy consumption in India has doubled since 2000.

The International Energy Agency (IEA) estimates India will have the largest increase in energy demand of any country between now and 2040.

An affordable, reliable supply of energy is central to raising the nation's living standards. A recent World Bank analysis found up to 150 million people in India are poor.

Alongside its massive reliance on coal, India has one of the world's most ambitious renewable energy plans, including an aim to quadruple renewable electricity capacity by 2030.

The IEA says coal accounts for about 70% of India's electricity generation. And as the nation rebounds from the coronavirus pandemic this year, the rise in coal-fired electricity production is expected to be three times that from cleaner sources.

Coal-powered generation is anticipated to grow annually by 4.6% to 2024, and coal is expected to remain a major emitter of greenhouse gases to 2040.

While India's energy trajectory remains aligned with its commitments under the Paris Agreement, the speed and readiness of its transition remains a complex, divisive issue. The World Economic Forum's 2021 Energy Transition Index ranks India 87th out of 115 countries analysed.

Bottlenecks in the transition

Our research involved visits to the Angul district in Odisha in 2018 and 2019, where we conducted focus groups and interviews. Angul is home to 11 coal mines.

We found three crucial bottlenecks to the energy transition, which arguably exist in India's other coal belts and could derail the nation's decarbonisation efforts.

First, the Odisha government has historically been very pro-business. Politicians across the spectrum support coal mining and seek to position it as the region's primary economic lifeline.

The official pro-coal position receives little pushback from Angul residents, who are largely unaware of

Odisha's contribution to national greenhouse gas emissions. Any local opposition to coal usually stems from concern about environmental degradation such as air, water and land pollution.

Most of Angul's residents felt a deep connection to coal because their livelihood depends on it. One participant told us:

even if all the water is polluted and five inches of dust settles on our well, we would prefer mining to continue as my family's survival depends on (the contract with the mining company).

Most participants considered their farming land as an asset to be sold to the mining companies for a significant sum. The money would, in turn, allow them to start a business, buy a car or arrange a marriage in the family.

Second, the heavy reliance on coal means efforts to diversify the region's economy have been grossly neglected.

In Angul, mining zones and coaldedicated railway lines passing through paddy fields mean agricultural productivity has declined over itly generates local support for coal.

And third, a suite of industries in Odisha – such as steel, cement, fertiliser and bauxite – depend on cheap coal for power. This is reflected across India, where coal has deep ties with other industries in ways not seen elsewhere.

For example, in 2016 Indian Railways earned 44% of its freight revenue from transporting coal. Indian Railways is India's largest employer and coal revenue helps keep passenger fares low. So in this way, a potential coal phaseout in India would have far-reaching effects.

The way forward

We offer these pathways to ensure a steady, just energy transition in India:

- India must help its coal regions diversify their economic activities
- bipartisan support for a coal-free India is needed. Transition champions such as Germany can show India's leaders the way
- a national taskforce for energy transition should be established. It should include representatives from across industry and academia, as well as climate policymakers and grassroots organisations
- India's coal regions are endowed with metals needed in the energy transition, including iron ore, bauxite and manganese. With improved regulatory standards, these offer economic alternatives to coal
- concerns about the coal phase-out from communities in coal regions should be addressed fairly and in a timely way.

The world's emerging economies are responsible for two-thirds of global greenhouse gas emissions. The energy transition in India, if done well, could show the way for other developing nations.

But as new industrial sectors emerge and clean energy jobs grow, India must ensure those in coal-dependent regions are not left behind.

Idea sharing increases online learner engagement: Study

ccording to a new study, sharing ideas in an online learning environment has a distinct advantage over sharing personal details in driving learner engagement in massive open online courses, more commonly known as MOOCs.

The findings of the study appeared in the 'Journal of Marketing Research'.

Online learning engagement can be increased by nearly onethird by simply prompting students to share course ideas in a discussion forum rather than having them share information about their identity or personal motivations for enrolling, said Unnati Narang, a professor of business administration at the Gies College of Business.

With less than 10 per cent of online learners completing courses, and less than 5 per cent participating in course discussions, there's a stark need for online learning platforms to identify and employ strategies that can enhance student engagement, Narang said.

"Engagement levels have tended to be really low in online classrooms simply because students may not ever get the chance to get to know each other in the way they do in an in-person, face-to-face classroom," she said.

She added, "A lot of those elements are, quite obviously, lacking in the online learning environment."

Initially, online platforms placed a lot of emphasis on having discussion forums to engage students. But over time, those efforts tended to fizzle out.

"Even if a student is posting something, it may never be read by a classmate or by the instructor, which can really demotivate students who are trying to engage in the material," Narang said.

To determine how to increase learner engagement, Narang and her co-authors analysed more than 12,000 discussion forum postings during an 18-month period and conducted a field experiment involving more than 2,000 learners in a popular online course offered by a large US university.

"We randomly nudged students to either share something personal about themselves or ideas related to the course," she said.

She added, "We thought we were going to see an increase in engagement thanks to the social aspects of identity sharing because there's so much emphasis on it in face-to-face classes for icebreakers and social introductions."

The results indicated that asking learners to share ideas related to the course had a stronger effect on their video consumption and assessment completion.

"We found that the idea of sharing knowledge outperforms identity sharing as well as the control condition of not sharing anything," Narang said.

She added, "Across diverse

metrics of learner engagement and performance, we found that what learners share plays a big role in enhancing the online learning environment, and they tended to perform 30 per cent better in terms of how many videos they consumed, how many assessments they completed and how they scored on assessments. So there's a distinct advantage to idea sharing in online pedagogy."

For educators, the implications of what the researchers dubbed the "idea advantage" in an era of increased online learning due to the COVID-19 pandemic suggests that identity sharing tends to be superficial and brief, so it's better to push students to engage more in the course content and their ideas about what they're studying.

"Just very basic getting-toknow-you introductions that instructors make in a physical classroom - who are you, where you're from, etc. - doesn't really translate into the online learning environment," she said.

"There's just too much anonymity to successfully do that when you're in a virtual classroom. The idea posts, on the other hand, tend to be much more elaborate and well-articulated. Students put more time and effort into crafting their answers. On average, an idea-sharing post was 66 words long. But an identity-sharing post tended to be roughly half as long," she added.

"Students were clearly more invested in ideas than trying to make friends in the online learning environment, thus why the idea advantage is so strong," Narang concluded.

'Air pollution exposure associated with poor academics in childhood'

Provide the exposed to elevated levels of air pollution may be more likely to have poor inhibitory control during late childhood and poor academic skills in early adolescence, including spelling, reading comprehension, and math skills, a new study suggested.

Difficulty with inhibition in late childhood was found to be a precursor to later air pollution-related academic problems. Interventions that target inhibitory control might improve outcomes.

The results of the study by researchers at the Columbia Center for Children's Environmental Health (CCCEH) at Columbia University Mailman School of Public Health and Columbia University Irving Medical Center are published in the journal Environmental Research'.

"Children with poor inhibitory control are less able to override a common response in favor of a more unusual one--such as the natural response to say 'up' when an arrow is facing up or 'go' when a light is green--and instead say 'down' or 'stop,'" said first author Amy Margolis, PhD, associate professor of medical psychology in the Department of Psychiatry at Columbia University Irving Medical Center.

"By compromising childhood inhibitory control, prenatal exposure to air pollution may alter the foundation upon which later academic skills are built," added Margolis.



PM Khan: Afghan Taliban 'sensing victory', won't listen to Pakistan

Responding to Afghan President Ashraf Ghani's allegations regarding Pakistan's role in the ongoing Afghan conflict, PM Khan said on Friday such comments disappointed him despite his country's "positive" role in the Afghan peace process

"President Ghani, let me just say that the country that is



going to be most affected by turmoil in Afghanistan is Pakistan," Khan responded to Ghani while addressing an international conference in Uzbekistan.

"Pakistan suffered 70,000 casualties in the last 15 years. The last thing Pakistan wants is more conflict," Khan said.

"I can assure you that no country has tried harder to get the Taliban on the dialogue table than Pakistan. We have made every effort, short of taking a military action against the Taliban in Pakistan," Pakistani premier said, adding: "To blame Pakistan for what is going on in Afghanistan is extremely unfair."

As well as being one of the best-known and instantly recognisable French figures, usually depicted in his frock coat and sideways hat, Napoleon is also one of the most divisive characters in the country's history.

French President Emmanuel Macron led commemorations in May for Napoleon 200 years after his death, saying "few destinies have shaped so many lives beyond their own" and that the emperor was "part of us."

Wednesday, External On Affairs Minister S Jaishankar held talks with his Chinese counterpart Wang Yi in Dushanbe on the sidelines of a meeting of the Shanghai Cooperation Organisation (SCO). During the talks, Jaishankar

firmly conveyed to Wang that prolongation of the existing situation in eastern Ladakh was visibly impacting the bilateral ties in a "negative manner" and rued that there

was no forward movement since the disengagement in Pangong lake areas in February. At the meeting, the two foreign ministers agreed to hold the next round of military dialogue at the earliest to discuss all the remaining issues.

There has been a stalemate in the disengagement process between the two militaries in the remaining friction points in eastern Ladakh after they withdrew troops and weapons from the Pangong lake areas in February following a series of military and diplomatic talks to resolve the standoff.

The data pertains to six paramilitary forces namely the CRPF, BSF, ITBP (Indo-Tibetan Border Police), SSB (Sashastra Seema Bal), CISF (Central Industrial Security Force) and Assam Rifles.

A total of 81,007 personnel of these forces have taken voluntary retirement since 2011, according to the data.

The highest among all forces --36,768 personnel -- have taken voluntary retirement from the BSF in the last decade, followed by the CRPF (26,164 personnel), the CISF (6,705), the Assam Rifles (4,947), the SSB (3,230) and the ITBP (3,193).

According to the data, of the 15,904 personnel who have resigned in the 10 years, the highest was in the CISF (5,848), followed by the BSF (3,837), the CRPF (3,366), the ITBP (1,648), the SSB (1,031) and the Assam Rifles (174).

Among those who have taken voluntary retirement, the highest 11,728 personnel made the move in 2017, followed by 11,260 personnel in 2011.

The number was 10,859 in 2012, as many as 9,355 in 2013, altogether 5,931 in 2014 and 1,686 in 2015, and altogether 6,981 in 2016.

In the last three years of the decade, 8,132 took VRS in 2018, a total of 7,611 in 2019, as many as 5,935 in 2020,

Among the total 15,904 personnel who have resigned in the 10 years, the highest 2,332 personnel took the step in 2013, 2,026 in 2015, 1,931 in 2014, 1,768 in 2012, 1,673 in 2018, 1,535 in 2017, 1,364 in 2019, 1,144 in 2016, 1,122 in 2011 and 877 in 2020.

The total strength of the six paramilitary forces is around 10 lakh.

The Central Reserve Police Force (CRPF) is deployed for assisting in internal security, law and order, operations against militants in Jammu and Kashmir and the Northeast besides for anti-Naxal operations.

The Border Security Force (BSF) is primarily deployed for guarding the India-Pakistan and India-Bangladesh borders besides in internal security duties.

The Central Industrial Security Force (CISF) is primarily deployed at vital installations like airports, metro services, atomic and key industrial plants and government buildings

despite fixed timelines notified in the extant rules and various instructions issued from time to time for concluding the selection process and operating the Selection/Waiting list, it has been observed that either the recruiting agencies do not forward the waiting list along-with the selection list thereby violating the statutory provisions or the appointing authorities consume considerable time in operating upon there commendations out of the select or wait list which often results in expiry in their period of validity.

"Further, enormous time is consumed by the recruiting agencies to decide on the withheld recommendations which often denies the candidates figuring in the waiting list opportunity from being considered for appointment against such candidature," the circular reads, adding, "Timely conclusion of the withheld recommendations assumes more significance in light of the provisions contained in SRO 60 of 2018 dated 02.02.2018 by virtue of which such cases remain alive perpetually unless decided in a time bound manner."

The appointing authorities, on their part, are required to operate the recommendations out of the waiting list immediately upon the end of 21 days allotted as joining period for the ap-pointees, it said. "Accordingly, it is impressed upon all the Recruiting Agencies/Appointing Authorities to adhere to the statutory provisions and bring the selection processes to their logical conclusion within the fixed timelines and refrain from recommending the cases laden with procedural delays for relaxation in the Rules which has to be done very iudiciously and under extremely exceptional circumstances so as to withstand the scrutiny of law," it said, adding, "So, in future, the administrative Departments shall recommend such cases of relaxation only after fixing the responsibility on erring officials/officers/Offices/Departments or cause of delay is due to any extra-ordinary reasons beyond the control of any authority or under extremely exceptional

India, Pakistan Placed In Same Group In T20 World Cup

DUBAI: Arch-rivals India and Pakistan were on Friday placed in the same group for the T20 World Cup as the ICC announced the pools for its flagship event, set to be played in the UAE and Oman from October 17 to November 14. India and Pakistan are placed

in Group 2 along with World Test Championship winners New Zealand and Afghanistan.

The Group 1 has defending champions West Indies, former winners England, Australia and South Africa. The Groups of Super 12s have

been selected on the basis of team rankings as of 20 March 2021, according to the International Cricket Council.

Two teams will join each of the groups from the qualifying rounds. Eight teams will contest the first round including automatic qualifiers Sri Lanka and Bangladesh with the remaining six who booked

their spot through the ICC men's T20 World Cup Qualifier 2019.

Ireland, Netherlands and Namibia join Sri Lanka in Group A, while Oman, PNG and Scotland will face Bangladesh in Group B.

The tournament was originally scheduled to be held in India but was moved out of the country due to an expected third wave of the coronavirus.

"There are some great match ups offered by the groups and it starts to bring the event to life for our fans as our first multi-team event since the onset of the global pandemic draws closer," ICC acting chief executive Geoff Allardice said in a release.

"Given the disruption caused by COVID-19, we selected the cutoff date as close as possible to the event to ensure we were able to include the maximum amount of cricket in the rankings which determine the groups.

"There is no doubt we will witness some highly competitive cricket when the event gets underway in just three months."

Allardice unveiled the draws in Muscat hours after the BCCI top officials -- president Sourav Ganguly and

secretary Jay Shah -- arrived in the city. Ganguly, said, "It is good to get Oman in the frame of world cricket with the hosting of the ICC men's T20 World Cup. It will help a lot of young players take an interest in the game. We know it will be a world class event in this part of the world." Shah said. "There is nothing

that separates the two groups as both are packed with sides that are highly competitive in the shortest format of the game."

This will be the first T20 World Cup since 2016 when West Indies beat England in the final in Kolkata.

"Oman Cricket has come a long way and today is a watershed moment for us to have ICC and BCCI here at Oman Cricket Academy to announce the ICC men's T20 World Cup groups!," Oman Cricket chairman, Pankaj Khimji, said.

Messi Inches Closer To Signing New Contract With Barcelona

BARCELONA: Lionel Messi and Barcelona are closer to signing a new deal that would keep the Argentina star at the Spanish club through the end of his playing career.

A person with knowledge of the negotiations between club and player told The Associated Press on Friday that Messi was prepared to accept Barcelona's offer of a five-year contract at 50% of his previous salary. The person spoke on condition of anonymity because they were not authorized to speak publicly about the negotiations.

In his previous contract, signed in 2017, Messi earned a massive 138 million euros (\$163 million) per season.

The person with knowledge of the negotiations did not indicate the other aspects of the contract still being worked out between the club and Messi's father, Jorge Messi, who acts as his agent.

Barcelona as a club has officially said nothing publicly about the details of the negotiations with the soccer

The 34-year-old Messi joined Barcelona two decades ago at age 13. Last August he stunned Barcelona by announcing that he wanted out after the 2019-2020 season ended without a title and his relationship with then club president Josep Bartomeu deteriorated.

The return of Joan Laporta to the

club's presidency in March has been key in bringing Messi back into the fold. Laporta ran Barcelona when Messi had his breakout as a teenager. A significantly lower salary for Messi is critical to keeping him at the financially troubled club following the losses sustained by the pandemic and some questionable management. Laporta admitted that a lower salary cap for Barcelona due to reduced revenues complicated his task to make all the pieces fit.

Messi's previous contract with Barcelona expired on June 30, making many Barcelona fans nervous that he could be lured away to big spenders like Paris Saint-Germain or Manchester City.

Even Barcelona coach Ronald Koeman acknowledged last week that he was concerned.

"Messi? When things don't get resolved, you have to be worried," Koeman said. "Laporta told me to remain calm because we are working hard so that he remains with us for years to come. I have complete faith in our president to work this out.

The six-time Ballon d'Or winner is currently on vacation after leading Argentina to the Copa America title last weekend, ending a long wait for a major title for his nation.

Messi has enjoyed a glittering career at Barcelona. He has won 35 club titles in 17 seasons, including four Champions Leagues, and set club records for goals (672) and appearances (778).

Dhyan Chand In Berlin 1936: Captaincy Test In Nazi Germany, Adolf Hitler Myth

NEW DELHI: When Adolf Hitler commissioned Nazi Germany's favourite film director Leni Reifanstahl to document the 1936 Berlin Olympics, he and his propaganda minister Joseph Goebbels couldn't have imagined that there would be another nation, apart from the USA, refusing to salute the Fuhrer.

The British India contingent comprised a bunch of inexperienced athletes with only shining glory being a twotime champion hockey team led by its resident magician Major Dhyan Chand. The global media's focus was the

United States of America refusing the traditional right-arm salute to Hitler during the opening ceremony but who would have thought that a contingent of amateur athletes wearing golden 'Kullahs' and light blue turban would do the unthinkable.

The contingent, with its flag-bearer Dhyan Chand, refused to salute and it was more of an emotional decision than political, taken by the team when the entire Third Reich sang the two national hymns 'Deutschland' and 'Horst Wessel Lied'

In the book 'Olympic History: The India Story', co-authored by Boria Majumdar and Nalin Mehta, they have quoted Mirza Naseeruddin Masood, a member of the gold winning team, narrating that opening ceremony. "It made a strange impression

upon the Indian contingent and not an eye was left dry. India rose before our imagination... Somehow the

spring of our national feelings was touched, and the unity and solidarity of the people in the 'Stadium' made us look with shame and regret at our poverty, destitution and discord."

Masood was an accomplished man beyond the field of hockey as he served the government of India in various capacities, which included being private secretary of independent India's first education minister, Maulana Abul Kalam Azad

He was also UNESCO Mission Chief to Australia, Consul General responsible for Muscat, Oman and finally Ambassador to Saudi Arabia.

However, one of Masood's biggest regrets was being denied India captaincy in 1936, despite being socially elite compared to Dhyan Chand. And very few people knew that Masood was actually also one of the five national selectors entrusted with the duty of picking the skipper.

Masood had, in fact, made his displeasure clear in a book he authored and published in 1937 'The World's Hockey Champions' – 1936

For Dhyan Chand, what the scoreline of India matches in that Olympics won't reveal is the tremendous pressure that he faced as media reports suggested that the defending champions were no longer invincible.

Also the fact that the 1932 Olympics, without participation of major European nations due to the Great Depression, became a sort of a sham and those who know about hockey would tell that there wasn't a lot of fight that India faced while retaining

the yellow metal in Los Angeles. The perception gained credence when India lost to a select Delhi XI 1-4 at Mori Gate ground in the national capital. It was the same Delhi XI that had been hammered 0-12 by the Indian team on its return from LA four years ago.

Dhyan Chand, in his autobiography 'Goal', which was first published in 1952 in weekly installments of the iconic 'Sport and Pastime' magazine published by 'The Hindu' group, wrote about that loss prior to the Berlin Games.

"... This particular defeat kept worrying me. For the first time I was captaining the Olympic team; will India lose the title under my charge?," Dhyan Chand's skepticism was evident in his autobiography.

Hockey Federation only had Rs 6600 in its coffers

According to the book, the Indian hockey federation needed Rs 40,000 to send the team and it required the Nizam of Hyderabad and the Gaekwads of Baroda to bail them out.

Nizam donated Rs 5000, the rulers of Baroda gave 200 GBP (Rs 3600 INR then) and, along with contributions from other princely states, ensured that the team boarded the ship. Another Rs 1700 was spent on flying Ishtiaque Dara on SOS, who played a big role alongside Dhyan Chand in the business end of the tournament. Interestingly, during the next Olympics in 1948, Dara had migrated

to Pakistan post partition and represented the new nation.

Training at Gulf of Aden

'The Statesman' sent a correspondent to cover the Games and old reports suggest that the first five days of their voyage was rough and the players, normally used to training on the deck, had to postpone their plans. Finally when the ship stopped for four hours at the 'Gulf of Aden', the Indian contingent found a brick-layered sandy field for a quick training session. Suddenly they would come to know that 5/14 Sikh Regiment posted in Aden used that field. Once the word spread that Dhvan Chand was there, the whole regiment came out to receive "one of theirs" and witness

the training session.

Two of Hitler's trusted men chief propagandist Goebbels and Reichsmarschall Hermann G?ring were there to ensure that no stone was left unturned in their quest to carry out the Fuhrer's image makeover along with the conduct of an unblemished event for which USD 30 million was being spent. Call it a classical case of contradic-

tion or irony but those who didn't want to accord Hitler with the arm salute were flocking to get autographs from two bonafide war criminals. "One day while we were in the

dining hall, who should walk in but the burly Herman Goring, clad in his military attire! We were after him in a trice to get his autograph. Later some of us obtained Dr Goebbels' autograph," Dhyan Chand had mentioned.

An eight-goal affair against Hitler's Germany

Did Dhyan Chand face media scrutiny? Of course he did. After India won the opening match against Hungary 4-0, the 'Statesman in their next day's report wrote, "Most disappointing was revelation that Dhyan Chand, world's greatest centre forward is past his best days...

Just how dominant India were in that era could be understood by the fact that even after beating USA 7-0 and Japan 9-0, the media spoke about how "if Germany wins, it will be a lesson to India that she deserves "

Worst these observations were fed by the team's manager Pankaj Gupta. However, the tone and tenor changed once France were clobbered 10-0 and after Germany were crushed 8-1 in the final. Berlin's 'Morning Post' lauded India's effort.

Legend has it that Dhyan Chand wanted better speed and mobility, and hence, wore a rubber soled sneakers sacrificing the conventional spike boots on grass field. It helped him dribble at great speed. He scored a dozen and the 'Morning Post's match report had some unforgettable lines.

Supreme Court Takes Suo Motu Note Of Delay In Release **Of Prisoners After Bail**

NEW DELHI: The Supreme Court has taken suo motu cognizance of delay on the part of Uttar Pradesh authorities in releasing 13 prisoners who were granted bail by it on July 8.

The convicts, who were juveniles at the time of offence have been lodged in Agra Central jail for periods ranging from around 14 to 22 years in a murder case.

The 13 convicts had approached the top court, claiming their detention to be "illegal" as there were clear orders passed by the Juvenile Justice Board with regard to each of them at various intervals between February 2017 and March 2021, declaring them to be juvenile at the time of murder.

The top court on July 8 had ordered their release on interim bail while granting time to the Uttar Pradesh government to verify the facts about their continued stay in jail despite orders establishing their juvenility.

Chief Justice N V Ramana took note of the reports that despite grant of bail to the convicts, whose juvenility at the time of the offence has been established, they have not been released so far

A fresh suo motu case titled as "In re Delay in Release of Convicts after Grant of Bail" has been instituted on July 13 and would be taken up on Friday by a bench comprising the CJI and justices L Nageswara Rao and A S Bopanna.

The 13 prisoners had said in their plea that they are languishing in jail despite the fact that they have been declared to be below 18 years of age at the time of commission of offence by the Juvenile Justice Board.

"The miseries are further compounded by the fact that these petitioners who are languishing in Agra central jail have already undergone judicial incarceration for periods ranging from 14 years to 22 years," the plea had said.

It said the Juvenile Justice (Care and Protection of Children) Act stipulates a maximum period of incarceration of three years and that too in juvenile homes. "However, here is the case where the petitioners languish in hardcore jail amongst hardcore criminals thereby completely negating the

purpose and objects of Juvenile Justices Act," it had said. It had said that Juvenile Justice Board, in its orders from February 2017 to March this year, had categorically held that all these petitioners were below the age of 18 years on the date of commission of offences.

"It is unfortunate that despite a categorical order declaring these petitioners as juvenile, the petitioners are languishing in central jail, Agra having undergone custody ranging from 14 years to 22 years," it had said. The top court on Friday would

also take stock of the situation in relation to its May 8 order in another suo motu case of 2020 which was meant to decongest prisons in view of the spread of COVID-19 contagion in prisons.

Taking note of the "unprecedented surge" in COVID-19 cases, a CJI-led bench on May 8 had passed a slew of directions to decongest prisons and had ordered immediate release of prisoners who were granted bail or parole last year. PromotedListen to the latest

tion of prisons housing around four lakh inmates across the country is a matter concerning "health and right to life of" prisoners and police personnel, it had said said all those who were allowed to go out on bail in March last year by the highpowered committees of states and Union Territories (UTs) be granted the same relief without any reconsideration to avoid delay.

On March 16, 2020, the top court had taken suo motu cognisance of overcrowding of prisons across the country and said it is difficult for jail inmates to maintain social distancing to prevent the spread of coronavirus.

NEW DELHI: Union Health Ministry in its weekly press conference on Friday cautioned that the next 100 to 125 days are critical in the fight against COVID-19 in India.

"Fall in cases has slowed down. It's a warning signal. Next 100 to 125 days are critical for fight against COVID in India," says Dr VK Paul, Member-Health, Niti Aayog in a Health Ministry press conference.

Member Health, NITI Aayog shared a study conducted by ICMR that analyses the vaccine effectiveness in police personnel, a highrisk category

The study shows two doses of vaccine were successful in pre-venting 95 per cent of COVID-19 deaths in the Second Wave.

"One dose of vaccine was able to reduce the mortality rate by 82 per cent. Two doses of vaccine were successful in preventing 95 per cent of deaths due to COVID-19 during the second wave," he said.

"We are moving towards a set target to administer 50 crore doses before July. We are on the path to achieving it. Govt has ordered 66 crore doses of Covishield and Covaxin. Additionally, 22 crore doses will go to the private sector," he added. Mr Paul also highlighted that

Prime Minister Narendra Modi has given them a target that there should be no third wave.

Union Health Ministry, Joint Secretary Lav Agarwal said, "Analysis shows a projected decline in the use of face masks as we resume activities. We should incorporate the use of face masks in our lives as a new normal."

Mr Agarwal noted that daily new cases in the country continue to show a decline during the second wave.

"Average daily new cases declined from 3,87,029 cases between May 5-11 to 40,336 cases between July 14-July 16," the Joint Secretary said.

ThatsApp has blocked more than two million users in India in just a month for violating its rules, the United States-based company has disclosed in its first compliance report under India's controversial new social media rules.

Most of the users were blocked for what the company called spam message abuses.

The Facebook-owned firm has put a limit on mass forward messaging in a bid to counter misinformation.

India implemented new rules in May to regulate social media companies, forcing them to disclose each month their efforts to police their platforms.

"We maintain advanced capabilities to identify these accounts sending a high or abnormal rate of messages and banned two million accounts in India alone from May 15 to June 15 attempting this kind of abuse," WhatsApp said in its report released late on Thursday. The company said its "top fo-


