An Israeli firm accused of supplying spyware to governments

has been linked to a list of tens of thousands of smartphone numbers, including those of activists, journalists, business executives and politicians around the world,

according to reports. The NSO Group and its Pegasus malware – capable of switching on a phone's camera or microphone, and harvesting its data - have been in the headlines since 2016.

# 2 BJP Workers In Police Remand For **Faking Attack**

Two Security Guards Also In Soup, Suspended

SRINAGAR: A court in Kupwara on Monday remanded two BJP workers and two PSOs to seven days police remand as probe into the firing incident at Gulgam Kupwara on Friday last has unraveled a failed attempt by men from saffron party to get their security enhanced as well as attract "more focus" from the party leadership.

So far police have arrested four persons including Ishfaq Ahmad Mir who was said to have suffered arm injury in the incident. His father Mohammad Shafi is the BJP's district president in Kupwara and the party has already placed him under

suspension after the gaffe. Police had initially said that Ishfaq was injured in misfire from his PSOs near Gulgam on July 16 night.

"In a Bollywood-style conspiracy, they tried to pass the incident as militant attack to get the security enhanced as well as get the added attraction from the party," a police officer, privy to the investigation told a local news agency GNS. In fact, the officer said, the injury was "stage-managed".

Besides Ishfaq, the police have arrested Basharat Ahmad Mir, the BJP's spokesman for the Kupwara in connection with the "conspiracy". Besides them, police have

SRINAGAR: After an alleged delay of seven years, the authorities have finally issued a tender notice for the reconstruction of a water canal in Batwudur area of Budgam district damaged by a landslide during 2014 floods.

The Chief Executive Engineer, Irrigation Division, Ompora, Budgam has issued an e-tender notice inviting registered contractors to construct and commission MS/ RCC Flume on Batwudur canal, reads an order e-NIT No 19 of 07/2021.

As per the order, the canal will be constructed at a cost of Rs 18.40 lac, including department supply. The work has to be completed in 45 days.

It is pertinent to mention

that Kashmir Observer in its widely acclaimed programme 'Inkishaaf' on June 16 reported about the failure of the irrigation and flood control department to restore a vital water body damaged by a landslide during the 2014 floods for want of approval from the higher ups.

# **SOP Violation May Lead To Corona Spread: Expert**

Advises Qurbani, Meat Distribution By Vaccinated Ones

**SRINAGAR:** Expressing apprehensions of increase in interactions, social and religious gatherings besides other activities in view of Eid-ul-Azha. a senior medical practitioner on Monday advised involvement of vaccinated people in slaughtering sacrificial animals and distributing their meat during the Muslim festival.

Dr M Salim Khan, Professor & Head Community Medicine, GMC, Srinagar said that only vaccinated butchers should slaughter sacrificial animals as unvaccinated butchers have every chance to get infected while visiting multiple houses to deliver their services and will thus act as a source to spread

infection among other families. Besides, he also said that only vaccinated family members should come in contact with the sacrificial animal and ensure that they follow SOPs like wear masks and maintain physical

Dr Salim advised that children should be kept away at the time of performing sacrifice of animals as children are not vaccinated yet.

He also suggested that only vaccinated persons should handle the affairs of distribution of meat to other families in the neighborhood or in relationships. This, he said, shall help to contain the spread of infection.

# **'Brains Process Taste Information Before Factoring In Health Information'**

ur brains process taste information first, before factoring in health information, according to a new research from Duke University. The findings of the study were published in the journal 'Nature Human Behaviour'.

"We spend billions of dollars every year on diet products, yet most people fail when they attempt to diet," said study co-author Scott Huettel, a professor of psychology and neuroscience at Duke.

Huettel added, "Taste seems to have an advantage that sets us up for failure. For many individuals, health information enters the decision process too late (relative to taste information) to drive choices toward the healthier option." The new paper described the advantage taste has over healthfulness in the decision-making pro-

"We've always assumed people make unhealthy choices because that's their preference or because they aren't good at self-control," said study co-author Nicolette Sullivan. "It turns out it's not just a matter of self-control. Health is slower for your brain to estimate - it takes longer for you to include that information into the process of choosing between options," added Sullivan. The research was undertaken when Sullivan was a postdoctoral associate at Duke. She is now an

assistant professor of marketing at the London School of Economics and Political Science.

For the study, Sullivan and Huettel recruited 79 young adults of a median age of 24.4 years. Study participants were asked to fast for four hours before the experiment to ensure they arrived hungry.

Participants were asked to rate snack foods on their tastiness, healthfulness and desirability.



They were then presented with pairs of foods and asked to choose between them - and the researchers timed their choices.

At the end of the experiment, participants were offered one of the foods they had chosen.

Study participants registered taste information early in their decision process - taking about 400 milliseconds on average to incorporate taste information. Participants took twice as long to incorporate information about a snack's healthfulness into their decisions.

That may not sound like much time. In many cases though, it's enough to alter the choice we make. "Not every decision is made quickly - house purchases, going to college - people take time to make those choices," Huettel said.

"But many decisions we make in the world are fast - people reach for something in the grocery store or click on something online," Huettel

> The authors said their findings could apply to other choices, and not just food. For instance, some financial decisions, such as saving and spending choices, may also be affected by how - and when - the brain processes different types of information. Meanwhile, all is not lost in the war against junk food cravings. Half of the study participants received a blurb before the experiment, stressing the impor-

tance of eating healthy. Those

participants were less likely to

choose an unhealthy snack. The authors also identified something simple that can help people with their food choices: slowing down the decision-making process. When study participants took longer to consider their options, they

tended to pick healthier ones. "There may be ways to set up environments so people have an easier time making healthy choices,'

# **SCERT's Five-day E-Workshop On SBA Concludes**

SBA Will Focus On Competency Development: Prof Indrani

#### **Observer News Service**

SRINAGAR: The first of its kind five day online training workshop on School Based Assessment (SBA) for teachers and teacher educators, organized by the State Council of Education Research and Training (SCERT), Jammu and Kashmir, concluded here today.

The purpose of the workshop was to make the teachers understand the concept of school based assessment as enshrined in the National Education Policy (NEP) announced by the Ministry of Education, Government of India, in 2020. The policy, whose implementing agency is the National Council of Education Research and Training (NCERT), is referred to as NEP-2020.

The workshop was, earlier, e-inaugurated by the Principal Secretary, School Education Department, B K Singh, which was attended by more than 100 teachers from all districts of J&K.

Professor Indrani Bhaduri, who heads the Educational Survey Division at the NCERT, joined the workshop from New Delhi.

Speaking on the occasion, Director SCERT, Prof Veena Pandita said that the traditional form of examination suffered from a variety of flaws putting students under a

lot of pressure. "The SBA encompasses a set of tools and techniques to assess a child's performance while moving beyond marks and grades," she maintained. She added that the assessment would be used to benchmark students' learning against criteria—process skills/learning indicators and learning outcomes— based on identified curricular aims and objectives.

Prof Pandita said the SBA

has been so thought out that it provides a comprehensive information regarding the extent of student learning vis-à-vis curricular objectives including performance in different subject areas because different children exhibit different skill sets.

Professor Indrani Bhaduri, while underlining the importance of introducing the concept of SBA, said that the National Achievement Survey (NAS) conducted in 2017 highlighted some grave issues in our education system that needed to be mitigated. She added that NEP 2020 has also made recommendations which need to be understood and implemented.

She said the SBA is aimed at facilitating the attainment of competencies of the students in order to assess efficiency of the teachinglearning process within the broader educational philosophy of assessment for learning. It is child centered and activity based pedagogy that will focus on competency development rather than content memorization, she maintained.

"It invariably puts an end to the monopoly of examination system on the education system and to think about a better practice that will make the student more interactive and expressive," she remarked. "Because the teacher is at the heart of the teaching-learning process, it's important that they undergo rigorous training to fully understand the concept and then implement it on the ground," Prof Indrani asserted.

The first of its kind workshop on SBA was organised by the Educational Research and Assessment Survey (ERAS)

RINAGAR - A station house officer (SHO) of the Kashmir police and an SRTC driver were killed and a deputy superintendent of police injured when a member of the J&K Armed Police opened indiscriminate fire on his superiors near, the Deshnami Akhara building on the Budshah Chowk here this morning.

A member of the J&K Armed Police (JKAP) opened unprovoked fire on his officers who were overseeing security arrangements for the departure of the Chari Mubarak (Holy Mac.o) from the Deshnami Akhara at around 8 this morning, the ONS said.

The station house officer of the Maisuma police station, Ghulam Nabi Parray, and an SRTC driver, Basheer Ahmad Khan, were killed on the spot, and the deputy superintendent of police '(DSP) for security, Ghulam Jeelani Baba, was injured. The driver was present at the scene in connection with yatra duty.

The injured DSP was rushed to the SMHS hospital where doctors referred him to the SKIMS. His condition was reported to be serious

The attacker, Kabeer Singh of the 9 Bn JKAP, hailing from Udhampur, was immediately taken into custody.

He had fired 23 rounds from his service carbine, and only five bullets were found in the magazine after the attack. The attack was deliberate, and the DSP was the actualtarget, the CNS quoted sources as having said. A criminal case has been registered by the police.

Heartrending scenes were' witnessed as the body of the slain driver arrived home in Gurgari Mohalla, Nawab Bazaar. The driver was a father of five children, four of them girls, and the sole earning hand of the family.

# **Pilgrims Flock To Mount Arafat In High Point Of** Pandemic-Era Hajj



ust 60,000 people, all citizens or residents of Saudi Arabia, have been selected to take part 🐪 this year's hajj, with foreign pilgrims again barred

Muslim pilgrims gathered at Saudi Arabia's Mount Arafat on Monday in the high point of this year's hajj, being held in downsized form and under coronavirus restrictions for the second year running.

Just 60,000 people, all citizens or residents of Saudi Arabia, have been selected to take part in this year's hajj, with foreign pilgrims again barred.

The mask-clad faithful, who had spent the night in camps in the Valley of Mina, converged on Mount Arafat where it is believed the Prophet Mohammed delivered his final sermon, for the most important of the hajj rituals.

After noon prayers, worshippers traditionally ascend the 70-metre high hill and its surrounding plain for hours of prayers and Koran recitals to atone for their sins, staying there until the evening.

After sunset they head to Muzdalifah, halfway between Arafat and Mina, where they will sleep under the stars before performing the symbolic "stoning of the devil."

The scene was dramatically different to past pilgrimages, which have drawn up to 2.5 million people, and this year the mountain was free of the huge crowds that descend on it in normal years.

Being one of the lucky few "gives you a feeling that our God is forgiving and has chosen us to be in this place," said Selma Mohamed Hegazi, a 45-yearold Egyptian. "God willing, our prayers will be accepted."

'My whole body is shivering," she told AFP as she stood among the other emotional pilgrims, wearing the ihram, the traditional seamless white garment worn during the hajj.

Saudi health authorities said Sunday that not a single Covid case had been reported amongst the pilgrims this year.

The kingdom has so far recorded more than 509,000 coronavirus infections, including over 8.000 deaths. Some 20 million vaccine doses have been administered in the country of over 34 million people.

The hajj, which typically packs large crowds into congested religious sites, could have been a super-spreader event for the virus.

But Saudi Arabia has said it is deploying the "highest levels of health precautions" in light of the pandemic and the emergence of new variants.

Pilgrims are being divided into groups of just 20 to restrict potential exposure, and a "smart hajj card" has been introduced to allow contact-free access to camps, hotels and the buses to ferry pilgrims around religious sites.

# **Hospitals Have Become Like Real Estate Industries Instead Of Serving Humanity: SC**

**NEW DELHI:** The Supreme Court Monday said hospitals have become like huge real estate industries instead of serving humanity in the face of Covid-19 tragedy while directing that 'nursing homes' running from 2-3 room flats in residential colonies which pay little attention to fire and building safety norms should be closed.

The apex court also pulled up the Gujarat government for extending the deadline till July next year for hospitals to rectify the building by-laws violations, and said the "carte blanche" notification was in teeth of its order of December 18 last year and people will continue to die in fire incidents.

"These hospitals have become like a huge real estate industry instead of serving the cause of humanity in the face of human tragedy.

"You (Gujarat government) have been extending the deadline, which cannot be done in view of our December 18, last year order. Hospitals are meant to provide succour to the patients in distress but instead they become money minting machines," said a bench of Justices DY Chandrachud and M R Shah.

Hospitals have become huge industries at the time of this tragedy and "these kinds of nursing homes, running from two-three room flats in a residential colony, should not be allowed to work", it added.

"It is better that these hospitals are closed and the state should provide necessary infrastructure. We cannot allow these hospitals and nursing homes to continue working. This is a human tragedy which is taking place," the bench said while referring to a fire incident in Nashik, Maharashtra, where some nurses and patients were killed last year.

The top court indicated that the Gujarat government will have to withdraw the notification, saying it appears to be in the teeth of its last year's order and sought explanation on issuance of the notification within a week.

It said that once a direction has been issued by the top court, "it cannot be overridden by an executive order and now you (Gujarat government) have issued a carte blanche saying the hospitals don't have to adhere to rectifying the violations till



July, 2022", and people will continue dying and getting burnt till then.

It also took exception to the report filed in a sealed cover by a commission on the issue of fire safety in hospitals saying that "it is not a nuclear secret but just a report. Why in a sealed cover".

It asked Solicitor General Tushar Mehta to look into the issue of notification and take it up with the Gujarat authorities and asked the state to file a comprehensive statement explaining the notification and details of fire safety audits which were conducted pursuant to the top court's order of last year.

The top court listed the suo motu case on proper treatment of COVID patients after two weeks.

On December 18 last year, the top court had directed all the states to constitute a committee in each district to conduct fire audit of COVID-19 hospitals at least once a month, inform the management of medical establishments about any deficiency and report to the government for taking follow up action.

It had said that Covid-19 hospitals, which have not obtained no objection certificate from the fire department concerned, should be asked to immediately apply for NOC and after carrying necessary inspection, a decision shall be taken in this regard.

"Those Covid hospitals who have not renewed their NOC should immediately take steps for renewal on which appropriate inspection is taken and decisions be taken. In event, Covid hospital is found not having NOC or not having obtained

renewal, appropriate action be taken by the state," it had said.

The top court had directed that all states and Union Territories should appoint one nodal officer for each Covid hospital, if not already appointed, who shall be made responsible for ensuring compliance of all fire safety measures.

The apex court had last year taken cognisance of the fire incident at a Covid hospital in Gujarat's Rajkot in which five patients had died.

It had also taken note of similar incidents which had happened earlier in other Covid hospitals.

It had taken note that Gujarat government has appointed Justice D A Mehta led commission to undertake enquiry with regard to fire in Shrey Hospital, Navrangpura, Ahmedabad, in addition to enquiry into the incident of fire in Uday Shivanand Hospital, Rajkot.

It had said that the state would extend all co-operations to the enquiry commission so that enquiry report is submitted at an early date and the appropriate remedial action be taken by the state. The top court noted that the Centre has also directed the states and UTs to update their respective local building bye laws/fire services, synchronising them in line with the 'Model Bill on maintenance of fire and emergency service, 2019', circulated by the Ministry of Home Affairs on September 16 last year.

The issue of Rajkot fire incident had cropped up in the top court which was hearing a suo motu case on proper treatment of Covid-19 patients and dignified handling of bodies in hospitals, PTI

# **Muslims Must Beat Scientific Backwardness**, Political Dependence:Khamenei



TEHRAN: Iran's supreme leader has said, successive American setbacks in Iraq, Syria and Afghanistan stem from America's "deep ignorance" about regional nations and remarked that "continued resistance is what can prevent America and other international aggressors from interfering in the affairs of the Islamic countries".

Ayatollah Sayed Ali Khamenei in his annual Hajj message released on Monday, also stressed on a "great duty and an untiring endeavor" by Muslims worldwide to bolster hope and build up determination to defeat scientific backwardness, political dependence, and economic and social problems besetting the world of Islam.

"This is the second year that the season of happiness and spiritual exaltation associated with Hajj has turned into a season of separation and regret. The tribulation of the pandemic and perhaps that of the policies dominating over the Holy Ka'bah have deprived the eyes of the eager believers from seeing the Islamic nation's symbol of unity, greatness and spirituality. Thus, this glorious, honorable summit has been covered with clouds and dust", he said.

"Hajj is an act of worship that is filled with mysteries and secrets. The exquisite formation and combination of movement and guietude in it builds the identity of the Muslims and the Muslim community and displays its beauties for the people of the world", Khamenei said.

"We who are the followers of Islam - and who enjoy a large population, vast lands, countless natural resources and nations that are aware and awake - must build the future with our assets and resources". Khamenei said. Iran leader rued that over the

last 150 years, Muslim nations have not had any role in deciding the fate of their countries and their governments. "Apart from a few exceptions, they have all been led and governed by transgressing western governments while being subject to their greed, interference and malevolence. Scientific backwardness and political denendence in many countries is the product of that passivity and incompetence."

"Today, our nations, our youth, our scientists, our religious scholars, our civic intellectuals, our politicians, our political parties and our people must make up for that dishonorable, embarrassing past. They must stand firm and resist the aggression, interference and wickedness of western powers", Iran leader said in his address to pilgrims.

"All that the Islamic Republic of Iran is saying that has caused the world of Arrogance to become despondent and infuriated is actually an invitation to this kind of resistance. This is a resistance in the face of the interference and evil of America and other transgressing countries so as to take the fate of the world of Islam in one's own hands by relying on Islamic teachings" Ayatollah remarked.

According to Khamenei, America and its "cohorts" are sensitive about the word "resistance" and have decided to show "all kinds of hostility to the Islamic Resistance Front."

"The truth of the realities in the Islamic region bolsters this hope and builds up this determination. From another perspective, the bitter events in the world of Islam, scientific backwardness, political dependence, and economic and social problems direct us toward a great duty and an untiring endeavor", Iran leader said.

Turning to what he described as resistance front, Khamenei said, "Usurped Palestine is calling for our help. Innocent, bloodied Yemen torments every heart. The plight of Afghanistan concerns evervone. The bitter events in Iraq. Syria, Lebanon and some other countries - where the interfering, malevolent hand of the US and its cohorts is completely visible – is stimulating the zeal and determination of all the young people."

He drew satisfaction at what he called, the emergence of the resistance forces throughout this sensitive region, the awakening of nations, and the motivation of the young, enthusiastic generation.

50,000 smartphone numbers believed to have been identified as connected to people of interest by NSO clients since 2016, the news organizations said, although it was unclear how many devices were actually targeted or surveilled. NSO has denied any wrongdoing.

# All Aboard The Hyperloop: How Your Commute Could Be Changing

**NEW YORK:** Think about the future of transportation, and you might envision the old animated show "The letsons," with everyone flying around in personal spaceships.

Not only did that never happen, but we are still piling into creaky old subways and buses. Josh Giegel wants to start from

scratch. The chief executive and cofounder of Virgin Hyperloop foresees us zipping between cities in minutes. a future not as far off as you may think. Giegel sat down with Reuters to talk about how this budding technology

Q: Humanity is facing all sorts of transportation challenges, so why do you think hyperloop is the right solution?

could change the way we live and work

A: We're looking at moving massive amounts of people, at the speed of an aircraft, giving them the opportunity to live where they want to live

hyperloop would move as many people and goods as a 30-lane highway.

A: We take you inside a tube, which gives you lots of advantages. It's impervious to weather, and you avoid lots of things that cause accidents, like crossings.

Inside the tube we take almost all the air out, allowing you to go at high speeds with very little energy consumption. We use magnetic levitation technology, so there is no grinding, and everything is contactless and smooth. With electromagnetic propulsion, and 20-30 passengers per pod, we could move tens of thousands of passengers per hour.

Q: You actually rode in one at your Nevada test facility, so what was it like? A: From starting this in a garage

The acceleration was similar to a sportscar, and we were giddy. The biggest piece of that test was that the world saw two people get on a hyperloop, and saw two people get off.

Until that moment, everyone wondered "Could it be safe for people?" Now we know that it is.

Q: How will this speed up travel between cities?

A: It transforms the math. Look at how long it takes you right now to get across Manhattan. Maybe 40 minutes. You could go from NYC to Washington, D.C., in less time. You could go from LA to Las Vegas in 40 minutes.

What we're doing is similar to what Roman roads, and Spanish ships, and airplanes did - shrinking the time associated with distance.

A: This is not 10 or 20 years away.

Cities can start incorporating this into their planning right now.

I couldn't put my finger on who will be the very first, but in addition to America, we are also looking at places like India, Europe and the Middle East. We are probably looking at a timeframe of 2025-27.

what has your interaction with Sir Richard Branson been like?

A: He is a consummate dreamer who believes in what we are trying to do. What I enjoy about Richard is that he not only started his own business from nothing, but he's an

The two includes Tasleema Begum wife of the deceased and her accomplice Ghulam Mohammad Dar, residents of Rengi Pattan for the murder of Muhammad Altaf Malik.

Officials said that after receiving written complaint from family members of deceased Mohammad Altaf Malik, SSP Baramullla Rayees Mohammad Bhat (IPS) constituted Special Investigation team (SIT) of senior police officers headed by SDPO Zafar Mehdi, SHO Pattan Insp. Nisar and ASI Mohammad Amin to Investigate the case.

On March 22, 2021 the deceased Muhammad Altaf Malik's brother filed a written application that he suspected that his brother had not died accidentally or of natural death but had been allegedly murdered.

Malik's body was spotted near his cowshed at Renji, Pattan on March 9.

"The body was exhumed and autopsy conducted at Government Medical College Baramulla. The autopsy revealed that the death was not natural," police officials said.

Following the autopsy report a murder case was registered under Section 302 of the Indian Penal Code (IPC) at Police Station Pattan.

During the course of investigation, in sustained questioning wife of the deceased and her paramour confessed of murdering Muhammad Altaf Malik.

Meanwhile SIT completed the investigation of the case within eighty six (86) days during which the statement of near about Fifty one witnesses was recorded and on Monday 19 July 2021 the Challan was presented against the both accused persons and they are in Judicial Custody.

# Flood warning

he Indian Meteorological Department (IMD) has issued a warning for flash floods in Jammu and Kashmir as a result of the fresh wet spell from July 19. The department also predicted waterlogging and minor floods over low-lying areas. This is troubling considering that the two days of rain shouldn't be such a cause of concern in the Valley. But that the IMD warns of flash floods in the wake of short-duration summer rain underlines the continuing vulnerability in the Valley to the calamity even seven years after the September deluge that sank Srinagar and large swathes of the Valley and Jammu. Ever since J&K, particularly the Valley has lived in dread of a repeat of yet another big flood. In Srinagar, people fear that an extended uninterrupted spell of rain might yet again lead to Jhelum spilling over its banks.

This has created a deeply disturbing situation in the Valley. We are, time and again, reminded of our hapless vulnerability to flooding whenever there are two or more days of uninterrupted rain in a warmer season. More so, in Srinagar whose new-found susceptibility to flood threatens to put a question mark on its viability as a summer capital. That is, unless we conceive and execute a course of action that drastically reduces this vulnerability.

If anything, it highlights how little has been done by way of infrastructure building to protect the Valley from flooding. Less than two days of rain creates floodlike conditions. What it means is that in the past seven years, we have not been able to increase the capacity to brave one more day of rain. The legitimate question to ask is what were the previous governments doing in these years. Or what has the dredging of Jhelum and the repairing of its embankments done in terms of enhancing our capability to resist the flood.

Now, what if the Valley once again experiences the uninterrupted two to three-day rainfall? Considering the Valley's erratic weather, such a prospect isn't unlikely. What is doubtful is the administration's ability to face up to this. And largely because the previous governments have built little defense against an extended incessant rainfall. Could Jhelum carry now more water than it did a few years earlier? Not at all. Similarly, could the spill channel carry the excess discharge than it did in 2014? The answer is again no. This is a dangerous state of affairs to be in. One can only hope that the current administration understands the enormity of the challenge and sets about in right earnest building our defences against a repeat of the 2014 scenario, which could be sooner than we are prepared for.

# Don't Look Away

"want to expose you to the raw truth — and make you a witness to it. You can look away, or stand up and ask for change," Danish Siddiqui had said in a talk last year. And till his death in a Taliban attack in Kandahar, Afghanistan on Friday, the Pulitzer-winning photojournalist was on the field doing just that — bearing witness to some of the subcontinent's most fraught conflicts, and making it hard for his audience to look away. For every crisis in the last tumultuous years in Indian political life, whether it was Delhi burning in the February 2020 riots or the long walk home of migrant workers from metropolises placed under a sudden lockdown, or the Covid-19 pandemic's brutal second wave, there is an iconic Danish Siddiqui frame telling the story.

In the best pictures that he made, the velocity of breaking news and the punishing march of history slowed down to yield the human story. A boy in a yellow-checked shirt sits atop his father's shoulders, his eyes bewildered, as a group of migrant workers walk out of Delhi, the lights of the city about to fade behind them. A young man whips out a gun and aims at anti-CAA/NRC protestors in Delhi, as policemen look on. A brother and sister break down outside a Delhi mortuary, their faces hidden, a sorrow both public and private. Siddique's images of exhausted Rohingya refugees, or of the silent homes of the victims of the Easter Sunday bombings in Colombo, or the mass pyres of coronavirus victims all convey a devastating grief — for people caught up in dehumanising forces beyond their control. In the image of a Muslim man cowering before a crazed mob during the Delhi riots, Siddiqui makes a chilling portrait of collective

Like the best of journalism, Siddiqui's work came about by turning up and being there — by pitching his body into the unforeseen moment, despite all the attendant risks. At a time of organised untruths and digital manipulation of media, the photojournalist's work has a powerful authenticity — and heart. In conflict zones — and indeed, in the hyper-partisan echo chambers of social media — the journalist walks a fine line, dodging black- and-white answers, to bring the reader face to face with a complicated, grey truth. The tragedy of Danish Siddiqui's death in one of the world's oldest conflict zones deprives us all of more such riveting, humanising encounters with the world.

# **Research Ruins**

n the absence of platforms that channelise, highlight and vocalise their concerns, Kashmiris have taken to "democratic" online platforms to flag issues that concern them. Recently, on a Club House discussion on social science research in Kashmir, speakers were of the view that Kashmir, as a society, lacks research culture and hence Kashmiris are not producing good scholarship in social sciences. Only a handful of Kashmiri social science researchers have produced books and published in international journals, and many of them are based in American and European universities, and some in mainland India. One speaker, a PhD scholar based in Jamia Millia Islamia, was of the view that while these scholars have done a good job, they have not moved beyond the theme of the 'Kashmir conflict'. And even then, they have not built theories that could challenge the euro-centric paradigms and, more importantly, counter the statist theories/perspectives that some Indian scholars have propagated on the Kashmir situation. Another speaker, also a research scholar, raised an equally important issue: that Kashmiri researchers must remain cautious while publishing their findings because their research might

Consensus of the Club House room discussants was that universities have the primary role and responsibility of coming up with socially relevant research that could serve as the guide for public policy and critique of the policies. How our universities have failed in their primary responsibilities were highlighted by citing how they did not care to respond to the economic crisis brought by the back-to-back lockdowns in Kashmir since August 2019. It was not publicly-funded institutions Kashmir University, IUST or CUK but a banker, Ejaz Ayoub, whose research helped the Kashmir Chamber of Commerce and Industries (KCCI) to come up

end up being (mis) used.

with a loss assessment report in 2019 and 2020. Ayoub also wrote a series of articles on the state of Kashmir economy (between August 2020 and May 2021) for Kashmir Observer.

I think conversations like these, where constructive criticism is shared, are a must for things to improve. Because when we acknowledge a problem, that is the first crucial step towards the redressal of the problem. But while Kashmiri scholars in general understand and have tried to highlight where the problem lies as far as the social science research in Kashmir is concerned, those at the leadership positions have shied away from taking necessary measures. Those who have power to do something have sometimes tried to impose their own policies without consultation with the larger academic community. A senior academic once told me that a bureaucrat who was holding the charge of higher education asked them to implement the existing research and bring out a monthly journal where all college lecturers would publish their latest research. What the bureaucrat did not understand was that things do not work that way in academia. How possibly can college academic staff implement the existing research? They don't have autonomy to even design the syllabus of the modules they are supposed to teach. They can hardly implement the academic calendar. Teaching load on academic staff (especially contractual college lecturers and assistant professors) is huge, and they can barely spare any time for a rigorous and time-consuming process of academic publication.

One speaker in the Club House discussion shared an interesting anecdote. He talked about how his friend (a historian by training) joined a university in Kashmir as an assistant professor but finding that he was not able to produce any research work in the university's suffocating environment he decided to leave the

job. This tells us how the problem is actually systemic. Only when the system gets reformed can we expect better performance and results in social science research from individuals.

Yet, there is another issue. Once getting a permanent position in higher education, most assistant professors tend to take it easy. Job security leads to disinterest in research. It seems that once they become APs, they stop reading. That is to say that they stop caring about research. But, is research a primary job of an AP? We cannot be sure, because we don't know what roles and responsibilities are delineated in the employment contract of an AP. In Europe or the US, when you join a university (whether tenure-track or contractual) you several pages. There are different components in the contract which clearly spell out your duties and responsibilities. And, they usually balance between teaching and research, and some administrative work. But in Kashmir, things are different, rather unprofessionally run. Those who joined the Cluster University Srinagar in 2020 as contractual lecturers were not even asked to sign the contract. They were in limbo. Can we expect them to know what they were supposed to do except for being an 'academic arrangement?' (a rather denigrating term). An employee usually molds himself/ herself into the culture of a workplace to fit in. That culture will determine how the employee will behave. If the culture of a workplace is bereft of work ethic, can we expect the employees to be any different?

# Coexistence, a unifying factor for Indians

or most political parties, sociologists and psephologists what a common Indian on the street thinks matters most. It is an insight into a common man's psyche, which allows them to strategies and formulate new plans and narratives. Though the political parties are able to set the narrative for their own narrow agendas yet they are unable to control the common perceptions and thinking among the populace.

Studies like a recent one by the US-based Pew Research Centre's Survey of Religion across India, helps not just the narrative formulators but also offers a peep into the common man's psyche. The recent Pew study based on nearly 30,000 face-toface interviews of adults conducted in 17 languages between late 2019 and early 2020 (pre-COVID-19), finds that Indians of all religious backgrounds overwhelmingly say they are very free to practice

### **Religious Tolerance**

Indians see religious tolerance as a central part of who they are as a nation. Across the major religious groups, most people say it is very important to respect all religions to be "truly Indian." And tolerance is a religious as well as a civic value: Indians are united in the view that respecting other religions is a very important part of what it means to be a member of their own religious community.

Yet, despite sharing certain values and religious beliefs - as well as living in the same country, under the same constitution - members of India's major religious communities often don't feel they have much in common with one another. The majority of Hindus see themselves as very different from Muslims (66%), and most Muslims return the sentiment, saying they are very different from Hindus (64%)

Indians, then, simultaneously express enthusiasm for religious tolerance and a consistent preference for keeping their religious communities in segregated spheres meaning they live together yet separately. These two sentiments may seem paradoxical, but for many Indians they are not.

Indeed, many take both positions, saying it is important to be tolerant of others and expressing a desire to limit personal connections across religious lines. Indians who favour a religiously segregated society also overwhelmingly emphasise religious tolerance as a core value.

In other words, Indians' concept of religious tolerance does not necessarily involve the mixing of religious communities. While people in some countries may aspire to create a "melting pot" of different religious identities, many Indians seem to prefer a country more like a patchwork fabric, with clear lines between groups.

This is what I ascribe to the syncretic Indian values, which you'll not be able to see in any western society. The Indians in spite of all differences and antagonisms try to view themselves as colours of a rainbow, which India is and this is what makes

### Dimensions of Hindu Nationalism in India

The survey reports that Hindus tend to see their religious identity and Indian national identity as closely intertwined: Nearly two-thirds of Hindus (64%) say it is very important to be Hindu to be "truly" Indian.



Most Hindus (59%) also link Indian identity with being able to speak Hindi. And these two dimensions of national identity - being able to speak Hindi and being a Hindu – are closely connected. Among Hindus who say it is very important to be Hindu to be truly Indian, almost 80% also say it is very important to speak Hindi to be truly Indian.

Overall, among those who voted in the 2019 elections, three-in-ten Hindus take all three positions: saying it is very important to be Hindu to be truly Indian; saying the same about speaking Hindi; and casting their ballot for the BJP.

#### Indian Muslims

Vast majority of India's Muslims say Indian culture is superior. Today, India's Muslims almost unanimously say they are very proud to be Indian (95%), and they express great enthusiasm for Indian culture: 85% agree with the statement that "Indian people are not perfect, but Indian culture is superior to others"

Overall, one-in-five Muslims say they have personally faced religious discrimination recently, but views vary by region. Relatively few Muslims say their community faces "a lot" of discrimination in India (24%). In fact, the share is similar to the share of Hindus who say Hindus face widespread religious discrimination in India (21%).

In addition, most Muslims across the country (65%), along with an identical share of Hindus (65%), see communal violence as a very big national problem.

Muslims' desire for religious segregation does not preclude tolerance of other groups - again similar to the pattern seen among Hindus. Indeed, a majority of Muslims who favour separate religious courts for their community say religious diversity benefits India.

The survey consistently found that people in the South (the states of Andhra Pradesh, Karnataka, Kerala, Tamil Nadu and Telangana, and the union territory of Puducherry) differ from Indians elsewhere in the country in their views on religion, politics and identity.

For example, by a variety of measures, people in the South are somewhat less religious than those in other regions - 69% say religion is very

important in their lives, versus 92% in the Central part of the country.

Hindu nationalist sentiments also appear to have less of a foothold in the South. Among Hindus, those in the South (42%) are far less likely than those in Central states (83%) or the North (69%) to say being Hindu is very important to be truly Indian. And in the 2019 parliamentary elections, the BJP's lowest vote share came from the South. In the survey, just 19% of Hindus in the region say they voted for the BJP, compared with roughly two-thirds in the Northern (68%) and Central (65%) parts of the country who say they voted for the ruling party.

### Other Contentious Issues

Most Indian Muslims opposed triple talaq. 56% said Muslim men should not be allowed to divorce this way. Still, 37% of Indian Muslims say they support triple talaq, with Muslim men (42%) more likely than Muslim women (32%) to take this position. A majority of Muslim women (61%) opposed

Similarly many Indians, across a range of religious groups, say it is very important to stop people in their community from marrying into other religious groups. Roughly two-thirds of Hindus in India want to prevent interreligious marriages of Hindu women (67%) or Hindu men (65%). Even larger shares of Muslims feel similarly: 80% say it is very important to stop Muslim women from marrying outside their religion, and 76% say it is very important to stop Muslim men from doing so.

The survey throws up many findings which may sound contradictory and unbelievable, yet they represent the true feelings of Indians, however convoluted they may be. And this contradictory yet assimilating feeling is what makes India

#### 'n the best of times, Haj is a mammoth management of crowds. But in times of Covid, only vaccinated Saudi residents aged between 18 and 65 have been allowed to perform the pilgrimage. Leaving piety and religious components aside, the cycle of Haj goes beyond the rigmarole of crowd management, advance planning, heavy-duty logistics, and technology use.

The annual pilgrimage connects the lives and livelihoods of millions worldwide in more ways than we imagine. So, it is not just about smart cards linking operations and services, electronic bracelets containing pilgrims' identities, or apps organising group dispatch. With another curtailed Haj around the corner this year, for obvious reasons, it is probably time to relive stories that make Haj global and unique.

Some of the most human and fascinating stories related to Haj unfold in faraway lands, thousands of miles away from the pilgrimage's centres in Saudi Arabia. Let's look at Indonesia, the world's largest Muslim population and also one of the largest Haj contingents in normal times. Much before they land for Haj, thousands of Indonesians, especially the low-income pilgrims have to plan their finances in advance.

As the trend to perform Haj at a young age catches up in Indonesia, a mobile app has been launched to help the country's 80 million millennials start their savings early. Remember, an Indonesian has to spend around US\$ 1,700 to pay for the Haj expenses, and the country has a growing middle-class population.

Another Haj-linked story takes us to faraway Malaysia and literally reaches most doorsteps in that country. Soon after a child is born in Malaysia, he/she is registered in the country's Haj Saving Scheme. The Management and Fund Board of Malaysia — also called Tabung Haji — runs like a corporation with the

That was a headline in 2019, describing the Makkah light rail, built and operated by the China Railway Construction Corporation. According to a Xinhua report, the CRCC won the project bid in 2009, and between 2010 and 2014, it provided service for over 15 million trips.

Just imagine the hundreds and thousands of engineers, construction workers, and other staff coming together to build infrastructure to ease travel during the Haj season. One could argue that for them, this is just another project that could have unfolded anywhere in the world. But the fact remains it's the annual congregation that brings all these expertise, skills, and enterprise.

If a full-fledged Haj means millions for businesses, a limited number of pilgrims is bound to cause heavy loss on a large scale. Somalia, for instance, used to make millions by selling cattle to Saudi Arabia for feeding pilgrims and the ritual of sacrifice. However, drastically curtailed Haj for two consecutive years has left them with all cattle and little income.

# **Research shows handwriting has certain** benefits over watching videos, typing

new study has found that handwriting helps people learn certain surprisingly skills faster and significantly better than learning the same material by watching videos or typing.

The findings of the study were published in the journal 'Psychological Science'.

"The question out there for parents and educators is why should our kids spend any time doing handwriting," said senior author Brenda Rapp, a Johns Hopkins University professor of cognitive science.

Rapp added, "Obviously, you're going to be a better handwriter if you practice it. But since people are handwriting less than maybe who cares? The real question is: Are there other benefits to handwriting that have to do with reading and spelling and understanding? We find there most definitely are."

Rapp and lead author Robert Wiley, a former Johns Hopkins University Ph.D. student who is now a professor at the University of North Carolina, Greensboro, conducted an experiment in which 42 people were taught the Arabic alphabet, split into three groups of learners: writers, typers and video watchers.

Everyone learned the letters one at a time by watching videos of them being written along with hearing names and sounds. After being introduced to each letter, the three groups would attempt to learn what they just saw and heard in different ways.

The video group got an onscreen flash of a letter and had to say if it was the same letter they'd just seen. The typers would have to find the letter on the keyboard. The writers had to copy the letter with pen and paper.

In the end, after as many as six sessions, everyone could recognise the letters and made few mistakes when tested. But the writing group reached this level of proficiency faster than the other groups - a few of them in just two sessions.

Next, the researchers wanted to determine to what extent, if at all, the groups could generalize this new knowledge. In other words, they could all recognise

the letters, but could anyone really use them like a pro, by writing with them, using them to spell new words, and using them to read unfamiliar words?

The writing group was better - decisively - in all of those

"The main lesson is that even though they were all good at recognizing letters, the writing training was the best at every other measure. And they required less time to get there," Wiley said.

The writing group ended up with more of the skills needed for expert adult-level reading and spelling. Wiley and Rapp said it's because handwriting reinforces the visual and aural

The advantage has nothing to do with penmanship - it's that the simple act of writing by hand provides a perceptual-motor experience that unifies what is being learned about the letters (their shapes, their sounds, and their motor plans), which in turn creates richer knowledge and fuller, true learning, the

"With writing, you're get-

ting a stronger representation in your mind that lets you scaffold toward these other types of tasks that don't in any way involve handwriting," Wiley said.

Although the participants in the study were adults, Wiley and Rapp expect they'd see the same results in children. The findings have implications for classrooms, where pencils and notebooks have taken a backseat in recent years to tablets and laptops, and teaching cursive handwriting is all but extinct.

The findings also suggested that adults trying to learn a language with a different alphabet should supplement what they're learning through apps or tapes with good old-fashioned paperwork.

Wiley, for one, is making sure the kids in his life are stocked up on writing supplies.

"I have three nieces and a nephew right now and my siblings ask me should we get them crayons and pens? I say yes, let them just play with the letters and start writing them and write them all the time. I bought them all finger paint for Christmas and told them let's do letters," Wiley concluded.

# **HDFC Bank Shares Tumble Over 3%** After Q1 Earnings

hares of HDFC Bank dipped over 3 per cent on Monday as the compa-Ony's June quarter earnings failed to enthuse investors. The stock went lower by 3.34 per cent to close at ₹1,470.95 on the BSE. During the day, it tumbled 3.65 per cent to ₹1,466.15.

On the NSE, it dipped 3.37 per cent to

close at ₹1,471. In traded volume terms, 4.08 lakh shares were traded at the BSE and over 1.25 crore units at the NSE during the

HDFC Bank was the biggest drag on both the benchmark indices.

HDFC Bank's consolidated net profit for the June quarter increased 14 per cent to ₹7,922 crore, but the largest private sector lender reported reverses because of the second wave of the pandemic which compressed its growth.

When compared with the preceding March quarter's ₹8,434 crore, there was a decline in the consolidated profit. On a standalone basis, the bank reported a post-tax profit of ₹7,730 crore as against ₹6,659 crore in the year-ago period and ₹8,187 crore in the January-March period.

Its core net interest income grew 8.57 per cent to ₹17,009 crore on advances growth of 14.4 per cent and the net interest margin coming at 4.1 per cent, while the other income grew 54.3 per cent to ₹4,075 crore.

It can be noted that the year-ago quarter had a deep impact on the national lockdown and the ensuing impact on economic activity, whereas the reporting quarter had an impact due to localised lockdowns.

"These disruptions led to a decrease in retail loan originations, sale of third party products, card spends and efficiency in collection efforts. The lower business volumes, coupled with higher slippages, resulted in lower revenues, as well as an enhanced level of provisioning, the bank said in a statement.

# **Govt Says Some Adani Group Cos Being Probed; Firm Denies Any Communication From SEBI**

New Delhi: Some of the companies belonging to Adani group are currently under the investigation of markets regulator Securities Exchange Board of India (SEBI), the Parliament was informed on Monday.

In a written response to a question in the Lok Sabha on the opening day of Monsoon Session, Minister of State for Finance, Pankaj Chaudhary, said that SEBI is investigating some Adani group companies with regard to compliance with SEBI regulations while the Directorate of Revenue Intelligence (DRI) is also probing certain entities under the laws

administered by it. However, Chaudhary added that the Enforcement Directorate is not probing these companies.

In response, the Adani group denied having received any communication or information requests from the SEBI recently.

"We have always been transparent with all our regulators and have full faith in them. While we have always been fully compliant with the applicable SEBI regulations, we have made full disclosures to SEBI on specific information requests from them in the past. However, we have not received any communication or information requests recently," an Adani group spokesperson said.

"With regard to the DRI matter, it issued a show cause notice to Adani Power about five years back. Subsequently, the DRI passed an order in favour of Adani Power, confirming that there is no overvaluation of equipment.

"The department has approached the Tribunal and the matter stands sub judice now. Adani group is a responsible corporate citizen and strongly believes in compliance with applicable laws and adheres to prudent corporate governance framework," the spokesperson added.

# **Govt's Excise Collections** On Petrol, Diesel Jumps 88% To Rs 3.35 Lakh Cr

The Union government's tax collections on petrol and diesel jumped by 88 per cent to Rs 3.35 lakh crore in the year to March 31, after excise duty was raised to a record high, the Lok Sabha was informed on Monday.

Excise duty on petrol was hiked from Rs 19.98 per litre to Rs 32.9 last year to recoup gain arising from international oil prices plunging to multi-year low as pandemic gulped demand.

The same on diesel was raised to Rs 31.8 from Rs 15.83 a litre, according to a written reply to a question given by the Minister of State for Petroleum and Natural Gas Rameswar Teli in the Lok Sabha.

This led to excise collections on petrol and diesel jumping to Rs 3.35 lakh crore in 2020-21 (April 2020 to March 2021), from Rs 1.78 lakh crore a year back, he said Collections would have been high-

er but for fuel sales falling due to lockdown and other restrictions imposed to curb the spread of the coronavirus pandemic, which muted economic activity and stalled mobility.

In 2018-19, excise collections on petrol and diesel were Rs 2.13 lakh

To a separate question, the Minister of State for Finance Pankaj Chaudhary said excise collections in April-June this year totalled Rs 1.01 lakh crore. This number includes excise on not just petrol and diesel but also ATF, natural gas and crude oil. The total excise collection in FY21 was Rs 3.89 lakh crore.

"Prices of petrol and diesel are market-determined with effect from June 26, 2010 and October 19, 2014 respectively." Teli said.

Since then, the Public Sector Oil Marketing Companies (OMCs) have

been taking appropriate decisions

on the pricing of petrol and diesel on the basis of international product prices and other market condi-

"The OMCs have increased and decreased the prices of petrol and diesel according to changes in international prices and rupee-dollar exchange rate," he said adding "effective June 16, 2017, daily pricing of petrol and diesel has been implemented in the entire country."

The hike in taxes last year did not result in any revision in retail prices as they got adjusted against the reduction that was warranted because of fall in international oil prices. But with the demand returning, international oil prices have soared, which have translated to record high petrol and diesel prices across the country. More than one-and-a-half dozen states and union territories have petrol at over Rs 100-a-litre mark and diesel is above that level in Rajasthan, Madhya Pradesh and Odisha.

Teli said prices vary from state to state due to freight rates and VAT/ local levies.

"The impact of the increase in prices of petrol and diesel can be seen in their impact on inflationary trend measured by Wholesale Price Index (WPI)," he said. "The weightage of petrol, diesel and LPG in the WPI index is 1.60 per cent, 3.10 per cent and 0.64 per cent respectively.

He said so far during the year, petrol price has been increased on 63 occasions and diesel on 61. The price of petrol has been cut on one occasion during this period and that of diesel on two occasions.

There was no change in the remaining days.

In the previous 2020-21, petrol price was hiked on 76 occasions and cut on 10 while diesel rates went up 73 times and were reduced on 24 occasions, his reply showed.

# **Centre Eases Stock Limits** On Pulse Traders, Lifts Them Fully For Importers



With traders and importers voicing strong opposition to the stringent stock limit on pulses imposed earlier this month, the Centre today relaxed some of the limits for wholesalers and retailers and lifted it completely for importers within days of imposing them.

There has been no change in stock holding limit for retailers which has been kept at 5 metric tonnes.

Smaller pulses such as kidney beans (rajma), kabuli chana, lobia (black-red eye beans), peas and moth have also been taken out of the purview of the stock holding limits. As per revised order, wholesal-

pulses provided one variety should not exceed 200 metric tonnes. In the earlier order issued on July 2, wholesalers could hold only

ers can now hold up to 500 tonnes of

200 tonnes of pulses. (see chart) That apart, millers can now hold stocks which are equivalent to their last six months of production or 50 per cent of annual installed capacity whichever is higher.

Earlier, millers could hold stocks equivalent to three months of their production or 25 percent of annual installed capacity whichever was higher. "The relaxation for millers will

have a down-streaming effect in terms of giving an assurance to the farmers at this crucial juncture of kharif sowing of urad and tur," an official statement said.

It added that due to the crackdown on pulses hoarders, in two

months around 8343 registrations of stocks have been made on the official portal while stocks of around 3 million tonnes have been declared.

The official statement also said that because of the various mea sures initiated by the government in the last few months, wholesale prices of all pulses except masur have fallen by 3-4 per cent in the last two months and retail prices over the same period have fallen

by 2-4 months. Earlier, this month, Food Secretary Sudhanshu Pandey had said that pulses stocks limits have been imposed despite a cooling down of prices in the last two months as in the retail markets rates are still

higher than last year "This is good news for the industry and a good decision taken by the government. The market may surge on account of increasing stock limits. But we must understand the government's initiative to control prices, which is a good cause. Since this news broke on Monday, which is the opening of the week, the market may improve but for a limited time, as they have to liquidate stocks within 30 days. Good news for Pea, Kabuli Chana, Moth, Lobia, Rajma," said Rahul Chauhan, of iGrain India, a commodity trading and research firm.

Bimal Kothari, vice chairman of Indian Pulses and Grains Association said that the move to relax the stock limits will smoothen supplies in the coming months and stabilize prices during the forthcoming festive period.

The report was published by The Wire news portal from India as also 16 other international publications including Washington Post, The Guardian and Le Monde, as media partners to an investigation conducted by Paris-based media non-profit organisation Forbidden Stories and rights group Amnesty International into a leaked list of more than 50,000 phone numbers from across the world that are believed to have been the target of surveillance through Pegasus software of Israeli surveillance company NSO

The list of phone numbers in the Israeli spyware's database was one that belonged to a sitting Supreme Court judge, the report said.

According to The Hindu, apart from China and Pakistan whose diplomats often remain under close watch in India, diplomats from several countries that India has very friendly ties with were also snooped.

'The numbers of [Pakistan Prime Minister] Imran Khan and several of his ambassadors in India appear on the list as potential targets. Dozens of other Delhi-based diplomats and ambassadors are also included, from Iran, Afghanistan, China, Nepal and Saudi Arabia," the report published on Monday in Le Monde said.

"Disruptors and obstructers will not be able to derail India's development trajectory through their conspiracies," Shah said.

He also hit out at the opposition for jumping on to the Pegasus bandwagon and asked them to understand the chronology of the scandal.

"People have often associated this phrase with me in a lighter vein but today I want to seriously say - the timing of the selective leaks, the disruptions...Aap Chronology Samajhiye!" the home minister said.

Shah's reaction came after the Congress demanded his sacking and a probe into the "role of Prime Minister" Narendra Modi in the

two days ago in which he had asked people, "I'm wondering what you guys are reading these days."

He raised the issue through social

media too. "GoI has denied resorting to unauthorised surveillance. The question this raises is, if #Pegasus is only sold to governments, which other govts (China/Pak?) are using it to snoop on prominent Indian citizens? Shouldn't the authorities call for an independent investigation." he tweeted referring to the Government of India.

The CPIM said that two years ago, the party had raised in Parliament that this "dangerous spyware" was being used in India as revealed by WhatsApp.

"The Modi government's response had not categorically denied that it engaged the services of NSO (the Israeli tech firm that created the spyware) but claimed that there is no "unauthorized surveillance". With these revelations, it is clear that this government has engaged NSO for such surveillance against its own citizens," the party said in a statement Monday.

"The Central government must come clean on what is its engagement with NSO, what are the terms and how much our public funds have been paid for this, the party demanded.

Under Indian laws, the use of cyber spy software to hack smartphones even by the government is prohibited, the party said, asking under what law the government has undertaken such "surveillance activities" over citizens.

"The right to privacy is a fundamental right as laid down by the Supreme Court, but this BJP government is prevaricating on legislating the privacy law," the party said.

The CPIM also said there have been earlier instances of hacking smartphones and computers of human rights activists and they have been exposed. It alleged that the spying toll is digitally planted on their devices.

"It is then used for their arrests under draconian laws. The 'snoop, plant, arrest' formula employed by this BJP government is a violation of the fundamental rights of Indian citizens, the CPIM said.

The TMC said it will raise the issue in parliament.

The forensic inspection of a crosssection of phones drawn from this list by Amnesty International's technical lab has confirmed the presence of Pegasus spyware in as many as 37 instruments, 10 of which are in

Gandhi's phones are not among those examined as he no longer has the handsets he used at the time that his numbers appear to have been selected for targeting - from mid-2018 to mid-2019, the report said. In the absence of forensics, it is not possible to conclusively establish whether Pegasus was deployed against Gandhi, it said.

In his remarks, Vaishnaw said, "A highly sensational story was published by a web portal yesterday night.... The press report appeared a day before the Monsoon session of the Parliament.

'This cannot be a coincidence. In the past similar claims were made regarding the use of Pegasus on WhatsApp. Those reports have no factual basis and were categorically denied by all parties.... The press report of July 18, 2021 also appeared to be an attempt to malign the Indian democracy and a well-established institution," the minister said.

The news portal said the list reveals that several people associated with the functioning of elections were also selected for potential surveillance, including Lavasa, the only member of the 3-member Election Commission to rule that Prime Minister Narendra Modi had violated the Model Code of Conduct while campaigning for the 2019 general

The leaked data also includes Hari Menon, the India head of the Bill and Melinda Gates Foundation and at least one other foundation employee, who were selected in mid 2019.

Gandhi told The Wire that he had received suspicious WhatsApp messages in the past one of the known vectors for a spyware hack and frequently changed numbers and instruments so as to make it a little harder for them to target him.

Asked for his reaction to the news that he had been placed on a list of potential targets for hacking, Gandhi told The Wire, "Targeted surveillance of the type you describe whether in regard to me, other leaders of the opposition or indeed any law-abiding citizen of India is illegal and deplorable."

"If your information is correct, the scale and nature of surveillance you describe goes beyond an attack on the privacy of individuals. It is an attack on the democratic foundations of our country. It must be thoroughly investigated and those responsible be identified and punished," the former Congress chief said.

Such was the apparent interest in Gandhi that the numbers of five of his social friends and acquaintances were also placed on the list of potential targets, the report said.

"At his behest, two youths namely Asif Lone, a resident of Khudwani in Kulgam and Ab Rashid Thoker, a resident of Hussanpora in Arwani, joined terrorist ranks," he added.

Incriminating material, arms and ammunition, including two AK-47 rifles and eight magazines, were seized from the site of the encounter, the spokesman said.

He said Inspector General of Police (IGP), Kashmir, Vijay Kumar, congratulated the joint team of police and security forces for conducting a successful operation in a professional manner by neutralising the most wanted militant without any collateral damage.

### **'Elected Govt's**

was instrumental in converting more than a dozen youth into militancy after brainwashing them, they said.

"Parray was instrumental in radicalizing youth in the classes by provoking them with his jihadi speeches. While drawing huge salary from the Government exchequer and living luxurious life, Parray helped the militants to execute their agenda,"

they said. "Parray had the backing of political leadership which was the reason that despite being named by the Intelligence agencies for his support to militants he always escaped the action", they said.

Nisar Ahmad Tantray, another Government teacher posted at Government Middle School Hanji Mohalla Batengu in Anantnag district was recruited as temporary teacher in the school after his elder brother Abdul Gani Tantray joined Hizbul Mujahideen as its district chief.

Abdul Gani proceeded on temporary leave to become the militant but because of his writ in the district, his younger brother Nisar Ahmad was recruited as temporary teacher in the same school and subsequently his services were regularized.

Raziya Sultan posted as head teacher of Government School Khiram in Anantnag district who was among the terminated employees, was appointed as a teacher on compassionate grounds in the year 2000 after her father Sultan Bhat was killed by the militants in 1996.

"Raziya Sultan was a known sympathiser of Dukhtaran-e-Millat (DeM) and Jamaat-e-Islami (JeI) in the school and security agencies had repeatedly flagged concerns about this but the previous Governments took no action which encouraged her", they said.

Sakeen Akhter is another Government teacher sacked by the Government. She was posted in Government Primary School at Gorjan Khiram in Anantnag and was appointed as temporary tead 2002 and her services were regularized in 2008.

She was closely associated with Dukhtaran-e-Millat and was instrumental in organizing gatherings of women and even children to propagate secessionist activities.

LG administration, it bears mention, has launched a crackdown on employees it says are involved in anti-national activities and Intelligence agencies have zeroed-in on nearly two dozen more such officers/ officials and were pursuing their cases before taking any action.

So far, 18 such employees have been terminated from the services, the latest being 11 including two sons of Hizbul Mujahideen supremo Syed Salahuddin.

# **ACB Seeks Records Of Past Three Years From J&K Sports Council**

JAMMU: The sleuths of Anti-Corruption Bureau (ACB) Jammu, have sought records of various construction works executed, purchases made, bills encashed and other details from the Jammu and Kashmir Sports Council. The JKSC is the highest body catering sports across the Union Territory.

Reliable sources in the Anti-Corruption Bureau said that the Joint Surprise Check (JSC) team from the Jammu wing have recently paid a visit to the office of the Jammu and Kashmir Sports Council, Jammu.

"Acting on several anonymous complaints, the ACB in connection with the probe, have sought records of construction works executed besides purchases made by the Director General in the last three years," sources said.

They said that the record has been sought for the period of 2018-19, 2019-20 and 2020-21.

However, sources said that record of works executed without tenders and through open market, payments made in the mentioned period, tender notices of all purchases, firms participating in tenders, bids made, have also been sought.

"The details of supply orders with quality tests, receipts of material, works executed by district officers besides, bills, cash books and other documents (Xerox copies) have also been sought from the Council by the ACB."

The Surprise Check team also asked the Council to provide records for head wise and year wise budgetary Allocation for these three years.

It is pertinent to mention that pledging zero tolerance towards corruption in government-run offices, Jammu and Kashmir administration has recently directed the Jammu and Kashmir Sports Council to display boards highlighting 'zero tolerance' for corruption at all the sub-units.

As per the circular issued by the Secretary, J&K Sports Council, Nuzhat Gull last week with

regard to implementation of the decisions taken in the CoS meetings chaired by the Jammu and Kashmir Chief Secretary, Dr Arun Kumar Mehta, read that various decisions were taken in the meetings to bring transparency in the working of the J&K Sports Council and they shall be implemented in letter and spirit.

However, concern over alleged corruption complaints in the department, prompted the government to issue directions to display boards at all sub-units highlighting 'zero tolerance' for corruption and installation of complaint boxes in the very first point of the circular issued.

Moreover, stern action is also to be initiated against the employees, who are indulging in Anti National activities, the circular read.

Decisions like optimum utilization of funds in lieu of valuable outcomes, effective utilization of assets created by the Council, publication of the achievements in the leading local media platforms to ensure greater public outreach, closure of old cases which cannot be resolved after considerable delay on account of various aspects, filing appropriate responses for speedy clean up of audit para's, complete character/ antecedents verification of fresh appointees in a time bound manner. were also taken in the meeting.

Besides, taking note of delay in time-bound promotions as per the fixed ladder, the government, according to the circular, has also asked the Council to convene Departmental Promotion Committees (DPC's) on regular basis to create employee friendly environment vis-vis, establishing a system for conduct of training programmes to the employees for capacity building, convening of regular governing council meetings, ensuring stable tenures on part of employees to facilitate responsibility and accountability, implementation of new guidelines for having Centrally Sponsored Schemes, adequate attention needs to be accorded to the genuine grievances raised by the general public.

**DURHAM:** Mayank Agarwal's fight to reclaim his place in Indian Test eleven starts on Tuesday when he walks out to open in a three-day game against 'County Select XI', starting in Durham from Tuesday as best friend KL Rahul gears up to keep wickets in Rishabh Pant's absence.

The match has been accorded first-class status, a first for India in many years since Mahendra Singh Dhoni took over captain. The Jharkhand dasher believed that an "official match" robbed all players from getting some game time.

However, the team management wanted a proper first-class game to get into the groove before the start of the Test series next month.

According to BCCI sources. Pant, who had tested positive for COVID-19, has completed his stipulated 10-day isolation in an acquaintance's place in London and is "recovering well" but he is yet to ioin the team bubble in Durham.

"Even if Pant would have reached in time for the practice game, he would have been given adequate rest to get back in peak physical condition. He has been asymptomatic but would need to train well ahead of the first Test in Nottingham," a senior BCCI official told PTI on conditions of anonymity.

"In any case both Pant and Wriddhiman, who is isolated as a precautionary measure will be available for first Test.'

As it had been reported earlier, KL Rahul, who has been doing keeping drills, will don the big gloves for the game.

However, it will be Mayank, whose form will be closely monitored by the team management as he is likely to partner Rohit Sharma in the first Test after Shubman Gill was ruled out of the series with shin splints.

Mayank hasn't been in best of forms in Australia and had lost his place to Rohit, who missed the first two Tests Down Under due to quarantine rules post hamstring injury break.

While Rahul has also scored bulk of his 2000 runs opening the innings, it is understood that he is being considered as a middleorder batsman and may be used later in the series in case one of the senior batters (read Aiinkva Rahane) don't get back to form.

Against a team comprising mostly of youngsters, with only James Bracey being a current England international. India might just try both Rahul and Mayank if they get a second innings. The match being a three-day affair, the probability of that isn't high.

In bowling department, Mohammed Siraj will like to give a

good account of himself and Iasprit Bumrah wouldn't mind getting a few wickets under his belt just like Ravichandran Ashwin did last week for Surrey.

# **Olympic Athletes Test COVID** Positive In Tokyo Days Before Games

**TOKYO:** A third athlete at the Olympic Village in Tokyo has tested positive for COVID-19, with the Czech Republic team reporting the case Monday of a beach volleyball player who could miss his first game.

The positive case of an American gymnast, who was not identified and is an alternate on the women's team, also was confirmed by the United States Olympic and Paralympic Committee. Olympic champion Simone Biles was not affected by the result, nor were any of the other gold medal favourites on the team.

Czech beach volleyball player Ond ej Peruši could miss his opening game on Monday after a PCR test confirmed his infection. Peruši and his playing partner are due to the begin their Olympic program against

a team from Latvia. Czech team leader Martin Doktor said in a statement they would ask to postpone the game until the infected

player is cleared to play. Peruši , who said he has been vaccinated, is the second member of the Czech delegation to test positive in Tokyo after a team official's case

was reported Saturday. He is the third athlete who was staying at the village to test positive. Two South African men's soccer players had their COVID-19 cases announced Sunday.

The players and a team video analyst who tested positive one day earlier were moved to the "isolation facility" managed by the Tokyo Olym-



pic organizing committee.

Their 21 close contacts around the South Africa team now face extra scrutiny before their first game Thursday against Japan in Tokyo. The monitoring regime includes daily testing, traveling in a dedicated vehicle, training separately from teammates not affected and being con-

fined to their rooms for meals. "Although you are a close contact, you are able to do the minimum that you need to do so that you can continue your preparation for the Games while you are being monitored," said Pierre Ducrey, the Olympic Games

operations director. Earlier Monday, before the Czech case was reported, Tokyo Olympic organizers confirmed three new COVID-19 cases, including a media worker arriving in Tokyo and a Games staffer or official in the Chiba

Both people, who were not identified, went into a 14-day quarantine,

The Tokyo metropolitan authority reported 727 new COVID-19 cases Monday, which was the 30th straight day the tally was higher than the previous week. The count was 502 last

The games open Friday with no fans in nearly all event venues, including at the opening ceremony, amid a state of emergency in Tokyo, and a slower than hoped for vaccine rollout. Japanese authorities said Monday 21.6% of the nation's 126 million population is fully vaccinated.

The total of Games-related infections was officially 58 since July 1 before the two new cases were announced. They should be added to the official tally on Tuesday.

These resulted from 22,000 people arriving in Japan since July 1 with 4,000 of those staying in the village, Ducrey said. About 11,000 athletes are scheduled to compete at the Tokyo Olympics.


