

No Leisure This: Mountain Trips Turning Toxic In Kashmir

MIDNIGHT, May 9, 2021...

Blood-curdling shrieks pierce the engulfing pitch-black night in a small, obscure hamlet of Ashpora in Central Kashmir. A few kerosene lamps come alive, and a flurry of hurtling silhouettes scurry towards the house of Abdul Majeed Gojri. His home and its compound are filled with wails of its inhabitants. There lies the limp, lifeless body of Asif, thick foam around his mouth.

"He was just eleven years old! I wouldn't wish on anyone such a horrible and gruesome death. He was weeping and writhing in pain; there was froth coming out his mouth," laments Mahjabeen, the mother of Asif who drank from a local spring and died a few days later. The spring was septic.

Over the past few years.

remote hillocked places in Kashmir have witnessed an upward tick of picnickers, campers, trekkers, off-road enthusiasts, to name a few. The rush indubitably brings significant economic value and well-being for the locals and the region.

Still, it brings with it issues that the valley is either too illequipped to deal with or not at all. It has led to situations where the ecological balance of sensitive zones gets disturbed because of the lack of comprehension of the environment.

Asif fell prey to the poisoned waters of a spring feeding his family and his community for generations. What changed within the water body that killed Asif?

The boy belonged to a remote area of district Budgam that has received overwhelming attention in the past few years. A cursory



look at the place shows it littered. Plastic wrappers and discarded bottles cover a good part of the area, thus leading to the inevitable seepage of toxins into the soil and underground water. "It's an issue with significant and terrifying consequences that will leave its impact on our environment and our lives," says Abdul Hameed, a conservationist.

Asif; he lost his life because

someone was callous enough to leave behind their trash, without even thinking twice what ramifications it shall have on the place and the people who call it their home.'

Hameed lobbies for stricter

regulations and better upkeep of ecologically sensitive areas in the valley.

"Take the holy Amarnath yatra as an instance. It's a source of massive human influx into incredibly fragile geographical

ecologically areas. speaking. During the yatra, colossal amounts of plastic waste are generated, and the same is either dumped into nallah Sindh or is left lying around the track or in meadows, not to mention the defecation in the waters of Sindh. The administration puts in little to no effort to clean the affected areas after the conclusion of the yatra. We have established a group of volunteers, and every year we visit Pahalgam and Sonamarg and other affected areas and clean the place to the best of our abilities. But we are a small group with minimal resources. We cannot do it all on our own. There is always the option to do more," he adds.

Another aspect of the excessive and unregulated human presence at the ecologically sensitive zones lends another facet to the

Older people are worse at learning to self-help, but just as good learning to help others

lder adults may be slower to learn actions and behaviours that benefit themselves, but a new research shows they are just as capable as younger people of learning behaviours that benefit others.

The findings of the study were published in the journal 'Nature Communications'.

Researchers at the Universities of Birmingham and Oxford found that youngsters, in contrast, tend to learn much faster when they are making choices that benefit themselves

The study focused on reinforcement learning - a fundamental type of learning in which we make decisions based on the positive outcomes from earlier choices. It allows us to adapt our choices to our environment by learning the associations between choices and their outcomes.

Dr Patricia Lockwood is the senior author on the paper at the University of Birmingham's School of Psychology and Centre for Human Brain Health. She said: "Reinforcement learning is one of the key ways in which humans - as well as animals and even plants - learn from and adapt to their environment."

We need to make decisions and learn all the time based on the positive or negative feedback we receive. This allows us to optimise our choices to choose the best course of action in the future from many possible alternatives. We find that older adults are worse than younger adults at learning from positive feedback on their own behaviour. However, surprisingly, when making choices that give positive feedback - money - to another person, older adults are just as good as younger adults".

In the study, the team worked with 80 younger and 80 older participants. They were each asked to make a series of choices between two symbols on a computer screen. After each selection, they received feedback on whether they got reward points from the selection they had made.



On some rounds, points translated into increased money for the participant, in others they translated into money for someone else. In a third, control condition, participants could get points but these weren't worth money for anyone.

The results revealed that, on average, the older group learned to choose the most advantageous option more slowly than the younger group when their selections would only benefit themselves.

However, when making choices on behalf of another person, older people learned equally as fast as the younger group. Across all age groups, the researchers found that learning was slowest when the points weren't worth anything.

Dr Jo Cutler, lead author and also at the University of Birmingham, said: "We recognise that in general, cognitive processes and learning ability tend to get worse as people get older. So it's really interesting to see that when making choices that will benefit others, older adults' learning ability is preserved. By better understanding what motivates older people in this way, we can contribute to strategies that promote healthy ageing."

The research programme also yielded some surprising findings in terms of differences between the young and older adults in psychopathic traits, including lack of empathy and concern for others.

The team found that these characteristics were lower in older adults, suggesting psychopathic traits are not fixed across a person's lifespan but may tail off as we age. In older adults, their level of psychopathic traits explained differences in learning speed specifically when they were learning to benefit others.



Dramatic Encounter Rattles City Centre

1 Killed, scores hurt as militants target security forces in Budshah chowk

RINAGAR - Militants struck the busy business hub of the capital city this evening setting off a fierce gunbattle with security forces in which an unspecified number of people, including five mediapersons and half a dozen

security personnel, were injured. The militants hurled a grenade at a Maruti Gypsy of BSF (JKOLE-3803) setting it on fire and later opened fire at a BSF armoured vehicle at the KMD bus stand in the close vicinity of Akhara building at around 5 pm, official sources said adding the militants then barged into the Bengal-Gujarati hotel and began firing at security personnel outside. The security forces hit back triggering an exchange of fire and the gunbattle continued till late hours Friday.

Six mediapersons—four cameramen and two press photographers-were injured in the incident while performing. Three BSF personnel, a police constable and five civilians were also injured in the initial exchange of fire which erupted when the area was teeming with people most of them heading homes after office hours and some busy shopping. The injured civilians included a woman and son of a Congress worker.

At least two militants remained holed up in Augaf building and an adjacent one. The buildings are located near the Aknara building which houses the hol mace of Hindu diety Shiva besides large number of BSF troopers.

Later both the buildings were surrounded by security forces and intermittent firing between the two sides continued as the troops were making efforts to neutralize militants till late in this evening. Al-Mansoorian and Jamiat-ul-Mujahideen militant outfits claimed responsibility for the dramatic attack in separate statements to a local news agency but gave no further details about the intended target or about the number of militants involved in the strike.

A police vehicle which was passing the area at the time of the firing was hit by a stray bullet in the petrol tank setting it on fire. The vehicle was gutted in the fire but the driver man-aged to jump out of it in the nick of time, the sources said. Fire brigade personnel rushed to the scene immediately to douse the flames

The heavy exchange of fire led to the closure of all shops and business establishments in the area and adjacent busy business centres of Lai Chowk, Koker Bazar, Gawkadal, Red Cross Road and Amirakadal.

The busy roads wore a deserted look with only security personnel moving the scene of the gunbattle as reinforcements were called in. Movement of traffic came to a standstill in the area.

This was a fidayeen attack. A group of militants fired at the paramilitary pickets in Akhara building and simultaneously a grenade was launched at a police jeep in the same area," Inspector General of Police Javaid Makhdoomi said.

'It was a coordinated terror act. The security forces foiled the attempt of the militants to enter the Akhara building, which houses a temple of Lord Shiva called Chhari Mubarak.

New Delhi: Fully vaccinated travellers from the US and European Union (EU) countries will be able to avoid a 10-day compulsory quarantine when they arrive in England, however, travellers from India still remain on the red list. Travellers from France and In-

dia will have to stick to the 10-day quarantine rules even if they are fully vaccinated upon arrival in the UK.

Currently, only people who received their Covid-19 vaccine in the UK can avoid quarantine when arriving from these "amber list" countries under the government's traffic list travel system.

"We've taken great strides on our journey to reopen international travel and today is another important step forward. Whether you are a family reuniting for the first time since the start of the pandemic or a business benefiting from increased trade this is progress we can all enjoy," said UK Transport Secretary Grant Shapps.

Taliban Surge An 'Existential Crisis' For Afghan Gov't: Watchdog

The Afghan government faces an "existential crisis" after the Taliban doubled its attacks following the February 2020 deal with the United States, a watchdog

report says. The report (PDF), published on Thursday, said Taliban attacks on Afghan targets surged from 6,700 in the three months up to the Doha agreement to 13,242 in the Septem-

ber-November 2020 period. Attacks have staved above 10.000 in each subsequent threemonth period, according to the report by the US Special Inspector General for Afghanistan Recon-

struction (SIGAR). While the rise in attacks has long been clear, data was previously available to demonstrate how intense the rebels' offensive had become.

The US agreed to withdraw all troops from Afghanistan with the expectation that the Taliban would negotiate a peace deal with the Kabul government.

Since then, the Taliban-government talks have stalled but the US has steadily pulled out troops to a level of only several hundred now, with an August 31 deadline for full withdrawal. The SIGAR report makes clear

that the Doha agreement, instead

of propelling Taliban-Kabul talks, unleashed a Taliban offensive that caught government forces unprepared and increased the number of civilian deaths.

Over the period of January to March of 2020, there were 510 civilian deaths and 799 injuries, the report said, quoting data from the US-NATO joint force in Afghanistan.

After that the numbers surged, hitting a high of 1,058 deaths and 1,959 injured in the third quarter of 2020 and continuing at high levels. The latest data, for April and May this year, showed 705 civilian deaths and 1,330 casualties, the SI-GAR report said.

"The overall trend is clearly unfavourable to the Afghan government, which could face an existential crisis if it isn't addressed and reversed," said the inspector general, John Sopko.

He said the report offered a sobering picture that contrasted with "the pervasiveness of overoptimism" that characterised US-led efforts to rebuild and strengthen Afghanistan and the cost of hundreds of billions of dollars to the US government.

"The news coming out of Afghanistan this quarter has been bleak." the report said. Afghan air force overstretched

Faced by a new Taliban offensive,

the report said, the Afghan government security force "appeared surprised and unready, and is now on

its backfoot". "Particularly concerning was the speed and ease with which the Taliban seemingly wrested control of districts in Afghanistan's northern provinces, once a bastion of anti-. Taliban sentiment.'

The Afghan air force, considered to be one of the few remaining advantages the government in Kabul has in the fight against the Taliban, is increasingly overstretched, said the watchdog.

PASSPORTS PLEASE Afghans Queue Up For Escape Lifeline

KABUL: Like thousands of his compatriots, Abdel Khalid Nabyar waited outside Afghanistan's main passport office to apply for the precious travel document that would allow him to leave the war-torn nation. With the Taliban making huge advances in the countryside as foreign forces wind up their withdrawal, many Afghans - those with the means, at least - are looking for a way out. "If the situation worsens, we might have to leave," said Nabyar, 52, who feels particularly vulnerable because he once ran a shop on a Nato military base. Not everyone will make an immediate exit, but most want the safety net - knowing they can leave at short notice. "People want to be prepared in advance in case things go wrong," added Nabvar. Dozens begin lining up at the passport office in Kabul before dawn most days, and by eight in the morning the queue already stretches for a good hundred metres. Applicants slowly shuffle forward, clutching see-through plastic folders containing their docu-

Nuku'alofa, Tonga: Cocaine worth more than \$1 million has washed up on a Tongan beach, with police scouring nearby shores for similar illicit packages on Thursday.

Residents discovered the drugs in the Pacific nation's northern Vava'u group of islands and handed them over to the authorities.

Acting deputy police commissioner Halatoa Taufa said the police were working with the navy to scour areas of interest after the discovery.

"There is a possibility that more packages may turn up on the beach and we ask any members of the public to immediately contact police if they found or knew anyone to have found further drugs," he said.

Taufa said the packages were similar to those found in Vava'u in the past. The wreck of the drug yacht JeReVe was discovered on a remote atoll in 2012, with blocks of cocaine worth up to \$120 million.

In 2017, the French navy intercepted a yacht carrying \$100 million worth of cocaine near Tongan waters. The following year, police found cocaine worth \$13 million on an outlying island.

Meanwhile, Amnesty International urged the Nigerian authorities to "immediately comply" with the court order.

In December 2015, troops launched a ferocious clampdown on the IMN when its members blocked the convoy of the army chief of staff during a religious procession.

Human rights groups said at the time that some 350 IMN members were killed during two days of clashes and later buried in mass graves.

Bodies Of Three Missing Mountaineers Spotted On Mount K2

Islamabad: The bodies of three mountaineers who died during a winter expedition on Mount K2 have been found months after they went missing while scaling the world's second-highest peak, officials said Tuesday.

The remains of Pakistani mountaineering legend Muhammad Ali Sadpara, Iceland's John Snorri and Juan Pablo Mohr from Chile were spotted Monday near "the bottleneck" -- a narrow gully just hundreds of metres from the summit.

"We are now focusing on a strategy to bring the bodies to a point from where they could be airlifted," Ayaz Shagri, an official with the Alpine Club of Pakistan, told AFP.

"The bodies of the mountaineers are intact and frozen," Shagri added, saying the climbers' remains were at an altitude of 7,800 metres



planes

(25,600 feet).

"It is very difficult to bring the dead bodies down from this high altitude," said Karrar Haidri, also from the Alpine Club, adding that the military was helping with the operation.

Shagri added.

The discovery of the bodies followed the death on Sunday of Scottish climber Rick Allen, who was killed after being hit by an avalanche.

With Pakistan's borders open and few other places to go due to the coronavirus pandemic, the country's summer climbing season is attracting a large number of alpinists.

Known as "the savage mountain", K2 has harsh conditions -winds can blow at more than 200 kilometres per hour (124 miles per hour) and temperatures can drop to minus 60 degrees Celsius (minus 76 Fahrenheit).

Police are investigating an alleged breach of virus rules after the aircraft landed in Ipoh city to pick up 36 portions of the rice dish and returned to Kuala Lumpur, 180 kilo-

Authorities have imposed a lockdown to battle a widespread Covid-19 outbreak, with people largely staying at home and travel between states banned except in exceptional circumstances.

The dish, which usually contains fish, meat, vegetables and curry sauce, is popularly known as "nasi ganja" due to its supposedly addictive nature -- although it does not contain any drugs.

Police say the red helicopter had been granted permission to fly outside the capital but only for maintenance, not to collect food.

They have taken statements from several people, including the owners of the restaurant and the helicopter, and prosecutors will decide whether to take further action.

The identity of the customer is not clear, but the helicopter owner has defended the unusual delivery.

Among them, Dr. Haseeb Mughal, Sheikh Junaid Mehmood, Altaf Ahmad Khan, Abdul Qayoom and Maqsood-ul-Zaman have held challenging assignments during their service career.

The others selected for induction have already retired from service, sources disclosed.

also disclosed They that one of the officers of 1999-batch had voluntarily opted out from being considered for the induction while another was not considered due to certain issues.

According to IPS promotion rules, the committee records its recommendations in the shape of 'Minutes' which are signed by each member and the chairperson.

These minutes are first sent to the State government concerned which in turn forward these to the central Government after its concurrence. The central Government also examines the minutes and conveys its concurrence to

the UPSC. Finally, these are placed before the Commission. The Commission conveys its approval to the Central Government which is the cadre controlling authority for the Indian Police Service. Subsequently, the MHA issues notification for induction

of officers in IPS. The proposal for induction of local officers in IPS was submitted by the J & K government to the Union Public Service Commission (UPSC) in May last year after MHA determined 28 vacancies.

The MHA had determined eight vacancies for 2010, three for 2011, eight for 2012 and nine for 2013. Later, the MHA had determined 13 more vacancies for the period between 2014 to 2019.

KO VIEW A long wait

he centre reiterated on Wednesday that Jammu and Kashmir would be granted statehood at an "appropriate" time after normalcy is restored there. Minister of State for Home Affairs Nityanand Rai stated this in a written reply to Rajya Sabha. He was replying to a question on whether the government had any proposal to "reinstate" the statehood of Jammu and Kashmir and whether some efforts have been made to end the year-long ban on different means of communication.

If anything, this means the centre has no immediate plan to restore statehood. This was also obvious from the recent meeting of Prime Minister Narendra Modi with the J&K political parties. He stressed expediting the delimitation exercise that is expected to enhance the seats of J&K assembly. More of these are believed to go to the former state's Jammu division. To this end a delimitation commission has already been in place since the last over a year and it may complete its exercise in the near future.

The enhancement of the Assembly seats, the PM's statement soon after the meeting indicated, will be followed by holding of the elections within the union territory framework. Though the PM's statement did not say it, the statehood is hoped to be followed by the elections. And it is not clear whether this statehood would be full or a truncated one where the real power would vest with the governor.

So actually the centre has more or less stayed true to its ideological course on Kashmir and ironically wants now Kashmiri leaders to be its partners in this pursuit.

The BJP has highlighted the absence of protests in Kashmir as a sign of normalcy in the UT. The fact, however, remains that while the situation in Kashmir has remained largely calm, the government hasn't been commensurate with the relaxation of restrictions and extension of rights. Also, New Delhi has been delaying the restoration of statehood to J&K.

Truth is that Kashmir has come a long way since the withdrawal of its autonomous status and the situation has held largely peaceful. This should have qualified J&K for the grant of statehood. But the centre has so far given no timeframe for it. It is hoped that since the calm has held in Kashmir for close to two years, the government will take firm steps to make J&K once again a state. In February too, the home minister Amit Shah had given an assurance to parliament that the Centre will grant full statehood to Jammu and Kashmir at "an appropriate time". And this appropriate time is now.

Don't encourage setting up of Bitumen based hot & wet mix plants

nder the United Nations Framework Convention on Climate Change (UN-FCCC), India is signatory to an agreement also known as Paris agreement. India has three quantitative climate change goals as part of its Nationally Determined Contribution (NDC). These goals are listed as under:

Reduction in the emissions intensity of Gross Domestic Product (GDP) by 33 to 35 percent by 2030 from 2005 level

Achieving about 40 % cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030

Creating an additional carbon sink of 2.5 to 3 billion tonnes of carbon dioxide equivalent through additional forest and tree cover by 2030.

Around 190 countries are party to the Paris agreement which was signed on 4th November 2016 at Le Bourget Paris. The United States had earlier withdrawn from the agreement in 2020 but after Joe Biden was elected US President, it again joined back officially on 19th February 2021. As per the official data provided by World Resources Institute (WRI), India's greenhouse gas (GHG) emissions accounted for 6.5 % of total global emissions in 2014. This made US the fourth-largest carbon emitter after China, United States and the European Union (EU). To make significant reduction in carbon emissions by 2030, India needs to work a lot. The state and UT Governments too have an important role in this regard so that international commitments are fulfilled

The Supreme Court is Right on Begging

he Supreme Court (SC), on Tuesday, refused to ban begging and issued a notice to the Centre and Delhi government, seeking their responses veeks on a petition requesting Code email nd rehabilitation of beggars. The Inbox hat it is a socio-economic problem and people are forced to beg to eke out their livelihood due to the absence of education and employment. The court's observations are in line with past judicial observations. In 2018, the Delhi High Court struck down a law that made begging in the Capital a crime, saying that criminalising begging "violates the fundamental rights of some of the most vulnerable people".

India has no federal law on begging and destitution. About 20 states have adopted the Bombay Prevention of Begging Act, 1959, which carries a penalty of detention of three to 10 years in beggar homes. Activists argue that it is an oppressive law, and allows the police to detain or arrest anyone who is poor, including nomadic communities, street performers and migrant workers

While traditionally, seeking alms was an accepted way of life in India, a shift in mindset towards the criminalisation of begging occurred during colonial rule. To the Victorians, beggars represented laziness, moral degeneration and a threat to public health. Independent India absorbed this colonial attitude. This approach lacks empathy and absolves the welfare State of failing to provide citizens with their basic minimum requirements - food, housing, education and health. Let the SC's observations mark a new conversation on begging, and how to improve the lives of India's destitute.

MINDFUL FRIDAYS Mental **Health First Aid: Anxiety Disorders**

pproximately 1 million adults (26%) in Kashmir Valley were exhibiting signs of a probable anxiety-related disorder as per reports published by MSF back in 2015 and since then there has been a further increase in the number of cases owing to continuous political turmoil as well as distress created by COVID-19 pandemic situation. Anxiety disorders are not the same as transient nervous sensations or random attacks of worry and fear. Anxiety disorders are diagnosable mental diseases that cause a person's everyday life to be severely disrupted by acute, recurring symptoms. Anxiety sufferers may experience unpleasant physical, behavioral, and psychological symptoms such as excessive irrational fear, rapid heart rate, digestive problems, and may feel distressed in ordinary circumstances. To cope with overwhelming thoughts and sensations, people with anxiety disorders are more inclined to abuse drugs or alcohol, but this just worsens their condition. Anxiety disorder symptoms might continue in someone's life eternally if not treated properly.

Anxiety disorders are associated with mental health crises such as panic attacks, suicide ideation, and self-injury. However, if a person receives mental health first aid, a crisis may be managed, and this kind of compassionate action can be the first step toward proper treatment for an anxiety problem.

Mental health first aid is a form of imme

Nausea or vomitting

- · Lightheadedness, dizziness, or fainting Hot or cold flashes
- Crying
- Rapid heart rate
- Feeling of numbness
- Chest discomfort
- Abdominal pain
- Feelings of detachment from reality Fear of losing control
- Fear of dying

ANXIETY DISORDERS: EARLY INTERVENTION

Many anxiety problems start in childhood or adolescence but aren't diagnosed or treated until later in life. Anxiety disorders aggravate if left untreated, and they can even lead to the development of other mental diseases, substance abuse disorders, or suicidal ideations.

Mental health first aid may be the only compassionate assistance a person receives if their worry goes undetected or ignored by close ones. You may offer support and comfort as a first aider, but you can also persuade someone to get professional help before their illness worsens.

HOW TO TREAT ANXIETY DISORDERS WITH MENTAL HEALTH **FIRST AID**

If someone you know is facing an anxiety spell, 1 may belo them by following the

ing are some suggestions for being a more engaged listener:

- Maintaining comfortable eye contact and open body language Restating what the other person has said
- Using minimum verbal prompts, such as "I see,"
- and "Ah Asking clarifying questions, which indicates that
- you want to understand Allowing silence and pauses in the discussion
- Practicing patience
- Be conscious of how you think and act throughout this talk.
- Don't judge the person or their emotions
- Don't try to correct or persuade them that their views are incorrect
- Don't provide useless advice like "You'll get over it" Don't fidget with and/or look at your smartphone while talking to them

GIVE REASSURANCE AND INFORMATION

An anxiety disorder can make a person feel afraid in unusual ways. They may feel out of touch with reality and may turn mad, fearing that their loved ones dislike them fearing that they able, or fearing that they are a failure.

If they be-

lieve they need assistance, talk to them about the professional help that is available in their area and urge them to use them. If the person requires assistance, volunteer to assist them.

Encourage the individual to prepare a list of questions to share with the health professional at their initial session if they decide to seek professional treatment. If the individual wishes for you to accompany them to a doctor's visit, you must not fully take over since a person suffering from depression needs to make their own decisions as much as possible.

As a first aider, you can refer such individuals to mental health professionals such as psychiatrists (medical doctors who prescribe medicines for various mental disorders) and clinical psychologists (mental health professionals who treat various mental health issues using various non-pharmacological modes of treatment such as CBT, family therapy, couple therapy etc.) available at various district hospitals or working in private at various clinics across Kashmir. Counseling if done by a clinical psychologist has been found to be very effective mode of treatment for various types of anxiety disorders. While approaching someone for counseling, try to see if the person claiming to be a professional clinical psychologist has RCI license to work as a clinical psychologist.

help that you may learn to give to someone who is going through a mental health crisis such as an anxiety spell. Although it cannot replace immediate medical treatment or long-term counselling, as a first aider, you may assist someone in regaining control after an anxiety episode.

RISK FACTORS FOR ANXIETY DISORDER

Anxiety can be triggered by perceived risks in the environment, although anxiety disorders are seldom caused by a single factor. Many different forms of long-term anxiety disorders are caused by a complex collection of risk factors, such as:

- Anxiety and extreme shyness throughout adolescence
- Traumatic life events or experiences
- A sensitive emotional nature
- Seeing the world as threatening
- Adverse childhood experiences
- Medical problems that are difficult to manage, such as heart and respiratory illnesses

People who are most likely to acquire an anxiety disorder are those who:

- Have a family history of mental illness especially any sort of anxiety disorder and/or mood disorder
- Have a family history of drug or alcohol abuse
- Struggle with drug or alcohol misuse
- Are female (Women are twice as likely as males to suffer from anxiety problems.)

SYMPTOMS OF ANXIETY DISORDER

Anxiety disorders are mental diseases that may impact every part of a person's body and every aspect of a person's life. The various symptoms of anxiety disorders include:

 Physical symptoms: Chest discomfort, hyperventilation, stomach pains, muscular aches, and tremors.

• Psychological Symptoms: Excessive or irrational fear and worry, racing thoughts, poor attention and memory, disorientation, restlessness, and sleep difficulties.

Behavioral symptoms: Avoiding people or social settings, compulsive behaviors such as checking/rechecking, fear of specific objects/situations.

Symptoms of a Panic Attack

As a person who provides mental health first aid, you should be aware of the signs and symptoms of panic attacks, which are brief bouts of intense fear that can appear in any anxiety disorder. Symptoms of panic attack are as:

- Headache
- Shortness of breath, or hyperventilation
- Excessive sweating
- Trembling, shaking or rocking back and forth

ASSESS FOR SUICIDE OR HARM RISK

You can soothe someone who is having a panic or anxiety attack using the ALGEE plan until proper help comes or can be asked for.

There are numerous forms of mental health crises associated with anxiety disorders. If the person you're helping is having a panic attack, thinking about suicide, or purposefully harming themselves, vou can offer first-aid for

- panic attacks
- Suicide thoughts and behaviours
- Non-suicidal self-injury
- Traumatic experiences

However, if the individual possesses a weapon and threatens to hurt himself or others in any of these situations, contact police or ask for online professional mental health assistance. You can start a conversation with the person and follow the rest of the stages in the ALGEE plan if they are not in an urgent crisis and there is no danger to anyone's safety.

LISTEN WITHOUT JUDGEMENT

Empathetic listening is one of the most essential aspects of mental health first aid. This reassures the individual that speaking out about their condition is appropriate and encouraged, and that others care about their problems.

Approach the person in a private place and communicate your worries about their anxiety in a polite manner to begin mental health first aid. Asking open ended questions such as, "How have you been feeling lately?" and "How long have you been this way?" can help to strike the conversation in healthy way. If they agree to talk with you, be prepared to listen calmly and patiently to what they have to say.

It's critical that you listen actively and offer compassion and understanding at this point. The follow-

ENCOURAGE APPROPRIATE PROFESSIONAL HELP

Many people are unaware of the seriousness of anxiety disorders, and they may assume that anxiety will go away with time. People who suffer from anxiety disorders, on the other hand, do not have to suffer in silence or wait for their symptoms to go away. Individuals suffering from anxiety can seek professional help.

It's critical that you know when to persuade the person to get professional help. When anxiety lasts for weeks and interferes with a person's ability to function in everyday life, professional treatment is required. Do not assume that the person's anxiety will go away on its own. Keep in mind that early treatment of anxiety is critical for the greatest results.

Discuss with the anxious individual and their caregivers how seeking professional help can be beneficial and ask the individual and his family members whether they believe it would be beneficial to them. Discuss getting professional help in a way that normalises it, such as by describing it as a natural activity to do and explaining that mental health issues are common and treatable

What if the person refuses to accept professional help?

If the person refuses to seek professional help, ask whether they have any specific reservations about obtaining professional help. They may have a misunderstanding of how treatment works or be afraid to express their thoughts to others. Reassure them that they have the right to recover from their anxiety problem, and that if they don't seek expert assistance, it may aggravate.

At the same time, keep in mind that it isn't your responsibility to resolve their anxiety, and you can't make them seek treatment. If they're still unsure after this talk, let them know you're willing to assist them if they change their minds. All you can do is offer encouragement and treatment suggestions. After obtaining your advice and first aid, it is up to the individual experiencing anxiety to determine how to proceed.

ENCOURAGE SELF-HELP AND OTHER SUPPORT MEASURES

People who suffer from anxiety disorders, fortunately, have a variety of self-help options available to them. Seeking out the help of others is one of the most helpful strategies. Although your assistance as a first aider is essential, urge the person to discuss their anxiety problem with friends, family members, or other people they trust.

You may also suggest that they try to use selfcare activities and self-help methods that will help them develop good coping mechanisms, such as:

- Daily physical exercise
- Eating a variety of fruits and vegetables
- Reading self-help books on how to manage stress in life
 - Practicing mindfulness meditation

Disagreement may be a way to make online content spread faster, further: Study

Disagreement seems to spread online posts faster and further than agreement, according to a new study from the University of Central Florida.

The findings were published recently in the Journal of Computational Social Science.

The results come from an examination of posts labelled controversial on social news aggregation site Reddit. To perform the study, the researchers analysed more than 47,000 posts about cybersecurity in a Reddit dataset that was collected by the **Computational Simulation of Online** Social Behavior (SocialSim) program of the US Defense Advanced Research **Projects Agency**

The researchers found that these posts were seen by nearly twice the number of people and travelled nearly twice as fast when compared to posts not labelled controversial.

Reddit is one of the most visited websites in the US. A post is labelled controversial by a Reddit algorithm if it receives a certain number of polarized views, or a moderator can label a post with any number of comments as controversial

The posts analysed in the study included topics that wouldn't be considered traditionally controversial but were labelled as so by Reddit, such as a personal computer giveaway offer.

The research is important because it shows that disagreement may be a powerful way to get people to pay attention to messages, said study co-author Ivan Garibay, an associate professor in UCF's Department of Industrial Engineering and Management Systems.

However, he advised caution to those inducing disagreement in their social media posts.

"There may be an incentive in

terms of influence and audience size for a social media user to consistently include controversial and provocative topics on their posts," Garibay said.

"This benefits the person posting the messages. However, controversial comments can be divisive, which could contribute to a polarized audience and society," Garibay added.

Reddit's definition of a controversial post, which tends to depend on increasing numbers of both likes and dislikes, is different from the traditional advertiser's definition of a controversial post, which would contain truly provocative or taboo messaging, said Yael Zemack-Rugar, an associ-

ate professor in UCF's Department of Marketing.

"To give this idea life, you may like a recent ad for Toyota, and I may not," Zemack-Rugar said. "This will not make it controversial. But if the ad featured Colin Kaepernick, as the Nike ad did in 2018, after he recently refused to recite the national anthem during his games, now we are talking controversial. There is an underlying tone that is much deeper and more meaningful."

Reddit posts are also more akin to word-of-mouth communication since they are user-generated and not paid to advertise, she said.

The study's findings are consistent with past research that has found that traditional controversy increases the spread of word of mouth and discussions online, especially when contributions are anonymous, as they somewhat are on Reddit, Zemack-Rugar said.

Of the more than 47,000 posts, approximately 23,000 posts were labelled controversial, and about 24,000 were noncontroversial.

The researchers found an association between controversially labelled comments and the collective attention that the audience paid to them.

For the controversial posts, there were more than 60,000 total comments, whereas, for the noncontroversial posts there were less than 25,000 total comments.

A network analysis examining the reach and speed of the posts showed that nearly twice the number of people saw controversial content compared to noncontroversial content and that controversial content travelled nearly twice as fast.

The researchers limited posts in their analysis to those that had at least 100 comments

Jasser Jasser, a doctoral student in UCF's Department of Computer Science, and the study's lead author, said the findings highlight the need to better understand why the content labelled in Reddit as controversial spreads.

"The next step in this work is to analyze the language used to induce such controversy and why it brings the attention of the social media users." Jasser said.

Study co-authors were Steve Scheinert, a senior solutions specialist with a professional services company and Alexander V. Mantzaris, an assistant professor in UCF's Department of Statistics and Data Science .

Scientists detect light from behind black hole

cientists have for the first time directly observed light from behind a black hole-a scenario that was predicted by Albert Einstein's theory of general relativity but never confirmed, until now.

The team at Stanford University noticed an intriguing pattern while watching Xrays flung out into the universe by the supermassive black hole at the center of a galaxy 800 million lightyears away

They observed a series of bright flares of X-rays-exciting, but not unprecedented-and then, the telescopes recorded something unexpected: additional flashes of X-rays that were smaller, later and of different "colours" than the bright flares.

According to theory, these luminous echoes were consistent with X-rays reflected from behind the black holebut even a basic understanding of black holes tells us that is a strange place for light to come from.

"Any light that goes into that black hole doesn't come out, so we shouldn't be able to see anything that's behind the black hole. The reason we can see that is because that black hole is warping space, bending light and twisting magnetic fields around itself," said Dan Wilkins, astrophysicist at the University.

"Fifty years ago, when astrophysicists starting speculating about how the magnetic field might behave close to a black hole, they had no idea

that one day we might have the techniques to observe this directly and see Einstein's general theory of relativity in action," said Roger Blandford, Professor in the School of Humanities and Sciences and Stanford.

The team detailed the findings in the journal Nature.

The original motivation behind this research was to learn more about a mysterious feature of certain black holes, called a corona. Material falling into a supermassive black hole powers the brightest continuous sources of light in the universe, and as it does so, forms a corona around the black hole. This light-which is X-ray lightcan be analysed to map and characterise a black hole.

As Wilkins took a closer look to investigate the origin of the flares, he saw a series of smaller flashes. These, the researchers determined, are the same X-ray flares but reflected from the back of the disk-a first glimpse at the far side of a black hole.

"I've been building theoretical predictions of how these echoes appear to us for a few years," said Wilkins. "I'd already seen them in the theory I've been developing, so once I saw them in the telescope observations, I could figure out the connection."

The mission to characterise and understand coronas continues with the European Space Agency's X-ray observatory, Athena (Advanced Telescope for High-ENergy Astrophysics). Athena's Wide Field Imager detector is expected to make new and much clearer observatations

Pandemic Pushes Digital Payments, RBI Index Up 30%

The Covid-19 pandemic and restrictions associated with it has pushed up digital transactions in the country.

An indicator to faster adoption of online payment medium is the Reserve Bank of India's Digital Payment Index. After moving at moderate pace over the years, the index has jumped sharply 30 per cent between March 2020 and March 2021.

The pandemic is one of the reason while people are increasingly preferring digital payment mechanism over physical mode. But improvement in the digital payment infrastructure has also pushed up this adoption.

The RBI had earlier announced construction of a composite Reserve Bank of India – Digital Payments Index (RBI-DPI) with March 2018 as base to capture the extent of digitisation of payments across the country.

The index for March 2021 stands



at 270.59 as against 207.84 for March 2020, announced while launching the index on January 1, 2021.

The RBI-DPI index has demonstrated significant growth in the index representing the rapid adoption and deepening of digital payments across the country in recent years, the apex bank said in a statement.

Starting from March 2018, the index stood at 153.47 in March 2019, 173,49 in September 2019. This improved to 207.84 in March 2020, 217.74 in September 2020 and further increased to 270.59 in March 2021.

No Revision In Fuel Prices For 12 Straight Days

The oil marketing companies (OMC) continued to pause fuel price revision for the twelfth consecutive day, the longest period in weeks, and decided to watch global developments and crude price for some more time before making any revisions in Petrol and diesel prices.

However, oil companies have stopped short of reducing the retail price of petrol and diesel during the week as more time will be required to study oil price movement be-



fore any downward revision. a bit for last few days and this Already, crude has firmed up could prevent price cut by

With no change in prices on Thursday, in the national capital, petrol continues to be sold for Rs 101.84 per litre, while diesel is also being sold at the unchanged price of Rs 89.87 a litre.

The pump price of fuel has been static since July 18.

One of the main reasons for pause in fuel price rise is an over 10 per cent fall seen in global oil prices with benchmark crude sliding to \$69 a barrel from a high of over \$77 barrel just couple of weeks back. It had again risen close to over \$75 a barrel on strong

demand projections.

With OPEC reaching an agreement to raise crude production, oil prices are expected to remain soft. This could make way for fuel prices in India to actually fall after a long interval.

In the city of Mumbai, where petrol prices crossed Rs 100 mark for the first time on May 29, the fuel price is at Rs 107.83 per litre. Diesel in the city is also at Rs 97.45, the highest among metros. Petrol prices in all metros

have now crossed Rs 100 per litre mark.

The week long price

pause comes after fuel prices increased on 41 days and remained unchanged on 48 days since May 1. The 41 increases have taken up petrol prices by Rs 11.44 per litre in Delhi. Similarly, diesel price has increased by Rs 9.14 per litre in the

Since April 2020, petrol prices have increased by Rs 32.25 per litre from Rs 69.59 a litre to Rs 101.84 a litre now in Delhi. Similarly, diesel prices during the period has increased by Rs 27.58 per litre from Rs 62.29 to Rs 89.87 a litre in the national capital.

All Energies Must Be Focused On Reaching An Inclusive, Broad-Based Political Settlement In Afghanistan: Pak

Islamabad: Pakistan said on Thursday that all energies must be focused on reaching an inclusive, broad-based and comprehensive political settlement in Afghanistan, amid raging violence in the war-torn neighbouring country.

Foreign Office spokesperson Zahid Hafeez Chaudhri claimed that Pakistan, a close and brotherly neighbour of Afghanistan, is the only country that has consistently emphasised that there is no military solution to the Afghan conflict.

["]Pakistan has been supporting and facilitating the peace process for achieving an inclusive intra-Afghan political settlement. All neighbours of Afghanistan including China have been supporting political resolution of the Afghan conflict," he said during a press conference here, highlighting its all weather ally China's role in the war-torn nation.

Pakistan and China are committed to facilitate and support the "Afghan-led and Afghanowned" peace and reconciliation process, he said.

China on Wednesday hosted I an Afghan Taliban delegation is led by Mullah Abdul Ghani I Baradar and praised the insurgent group as an "important I military and political force" in t Afghanistan. China also asked the Taliban to make a "clean the break" with all terrorist groups, especially the East Turkistan is Islamic Movement (ETIM) - the Uyghur Muslim militant group from Xinjiang. Chaudhri, however, accused I India of playing a role of a

"spoiler" in the Afghan peace process.

Afghanistan has repeatedly accused Pakistan of providing sanctuaries to the Afghan Taliban on its soil. Chaudhri said Pakistan consistently maintained that at this

critical juncture in the Afghan peace process, all energies must be focused on reaching an inclusive, broad-based and comprehensive political settlement in Afghanistan and reduction in violence leading to ceasefire is particularly significant in this regard. Under a deal with the Taliban, the US and its NATO allies agreed to withdraw all troops in return for a commitment by the militants that they would prevent extremist groups from operating in areas they control. US President Joe Biden has announced that American troops will be out of the country by August 31.

" We believe that China being a neighbouring country to Afghanistan does have an important role to play in the Afghan peace process, Chaudhri said.

Talking about the reported abduction and torture of Afghan Ambassador's daughter, he said a thorough investigation was launched immediately after the incident was reported.

"While a significant progress has been made in this case, we believe that the cooperation of Afghan Ambassador and his daughter is critical in concluding the investigation," he said. To a question about the pos-

sibility of the downgrading of diplomatic relations with Afghanistan, he said Pakistan believes in maintaining close, cooperative and brotherly

relations with Afghanistan. "There is no plan to downgrade our diplomatic relations with Afghanistan," he said.

To another question, Chaudhri said Pakistani Ambassador to Afghanistan is in Pakistan for his periodic visit, and to celebrate Eid with his family. "He has not been recalled and neither do we plan to downgrade our diplomatic relations with Afghanistan in any way." he said.

Talking about floods in India, he said Pakistan was deeply saddened by the loss of precious lives and injuries caused by floods and landslides to many in Kashmir and in parts of India including Maharashtra."

Director General of Police-cum-Commandant General Home Guard, Civil Defence and SDRF, V K Singh said a team comprising SDRF and NDRF personnel left Jammu at 5:45 AM by road for Kishtwar, while another joint team is leaving Srinagar shortly to join the rescue operation.

Two more teams comprising SDRF and NDRF personnel are at the Jammu and Srinagar airports waiting for the weather to improve to get airlifted, he said.

He said three teams of the SDRF have already joined the rescue effort and efforts are on to locate the missing persons.

The Indian Air Force (IAF) made an attempt to airlift one of the teams on Wednesday but returned to the technical airport in Jammu due to inclement weather.

Additional Director General of Police, Jammu zone, Mukesh Singh rushed to Kishtwar by road on Wednesday night and visited the injured persons at district hospital, a police official said.

Singh along with divisional commissioner Jammu Raghav Langer was also on board the IAF chopper which attempted to take the SDRF team to the affected village.

The Jammu and Kashmir government had announced an ex-gratia of Rs 5 lakh each for the next of kin of those who lost their lives in the incident and Rs 50,000 each and Rs 12,700 under SDRF to the grievously injured persons.

The J&K government would do everything possible to support and protect the affected families. In such trying times, it is our duty to care for those who have been unfortunately affected by these natural calamities," Lt Governor Manoi Sinha had said.

Jammu-based Army PRO Lt Col Devender Anand told PTI.

With the induction of the specialists from the NDRF and SDRF personnel along with sophisticated equipment, the rescue operation has intensified and efforts are on to locate the missing people, including nine women, the officials said, adding the chances of their survival seem bleak as they are believed to have been washed away by the strong current or buried under debris.

The officials said the success eluded the rescuers comprising police, Army, SDRF, NDRF and local volunteers from the village and adjoining areas throughout the day.

DGP-cum-Commandant General Home Guard, Civil Defence and SDRF, V K Singh said five of his teams along with NDRF personnel joined the rescue operation on Thursday.

"Two of our teams reached the scene on Wednesday itself and were joined by another team this morning. Two more teams comprising both SDRF and NDRF personnel left Jammu and Srinagar by road for Kishtwar, while another two teams were airlifted by the IAF," he said.

The Jammu Divisional Commissioner and Additional DGP, Jammu zone, rushed to Kishtwar by road and supervised the rescue and relief operation along with Kishtwar District Development Commissioner Ashok Kumar Sharma. The officials said the village, located on the banks of a stream and surrounded by mountains, can be reached by a three-hour trek from the last motorable road and is presenting a gloomy picture with wails of survivors filling the air. people in future," he said.

environmental predicament — man-animal conflict.

In the past two months, Kashmir valley has witnessed an alarming rise in the number of mauling cases. Several adults and, in some cases, a couple of young children too fell prey to wild animals. The advent of the beasts into human inhabitations isn't something new in Kashmir but this alone has seen such occurrences quadruple. Often, the beasts had to be put down, which is a significant loss on its own. The overwhelming human footprint at hill stations has opened up an alternative food supply for the animals, says Mansoor Nabi, an environmental activist and a conservationist who has worked with World Wildlife Fund. "The wild animals forage for their food in their habitats, but with the man constantly going deeper and further into the woods has established an informal supply of food for the beasts," Mansoor says. "If they get an easier food source, it's natural to expect the beast to look for more, leading to man-animal conflict. There're hotels in Sonamarg where you will find a brown bear at your window. The easy availability of food is one of the factors driving the upward spike of the said conflict and mauling of humans.' There's little to no ecological sensitisation when it comes to Kashmir, the eco-activist says. "We cannot and shouldn't make it the responsibility of the administration alone. As constituents of Kashmiri society and the world, we need to do better and more on our part." Environmental awareness and associated responsible behaviours, he says, are highly crucial for people to manage the ever-growing man-animal conflict. "We've been trying to inculcate an environmental sense of responsibility in our kids, and for that, we've conducted several campaigns and workshops in schools and colleges. The change certainly is visible on the ground, but we need to do significantly more.' An overwhelmingly unanimous agreement across the board is that there need to be stricter regulations of the hill stations, picnic spots, and camping sites. More stringent rules and a constant lookout for violations preserve the pristine nature and prevent further damage, which can be irreversible if not checked in time.

Satish Kumar Sails Into **Boxing Quarter-Finals On Games Debut**

TOKYO: India's first super heavyweight (+91kg) boxer to compete in the Olympics, Satish Kumar, eased into the quarterfinals of his debut Games, defeating Jamaica's Ricardo Brown in his opening bout here on Thursday. In the battle of the debutants,

the 32-year-old Satish prevailed 4-1, a comfortable win for him despite the split verdict. The two-time Asian Champion-

ships bronze-winner Indian, who has been a multiple-time national champion, was helped by Brown's poor footwork throughout the bout though he did end up sustaining two cuts - one on his forehead and the other on his chin.

"He got cuts because of three head butts during the bout. But it was a very measured performance by Satish, he could have been in trouble had Brown connected because he was huge and powerful," Indian boxing's High Performance Director Santiago Nieva told PTI.

Next up for Satish is Uzebkistan's Bakhodir Jalolov, the reigning world and Asian champion. Jalolov out-punched Azerbaijan's Mahammad Abdullayev 5-0 in his last-16 bout.

"He is not unbeatable. Although Satish has never won against him but the last time they fought in the India Open, it was split verdict. He ran him close," Nieva said.

Satish, also a 2018 Commonwealth Games silver-medallist, dominated with his right hand and allowed Brown to repeatedly make the mistake of lunging in with very little balance.

Brown seemed to be looking for that one big punch that could unsettle the Indian but failed miserably, owing to his inability to move quickly enough after launching into Satish.

The Indian, in comparison, was light on his feet and thereby sharper in responding to Brown's attacks. "The idea was to score and pull back because Brown's power could have been dangerous. Satish did well to tire him out by moving around the ring and it definitely helped that our boy had lighter feet," Nieva said.

The late bloomer from Uttar Pradesh's Bulandshahr is an Army man, who used to play kabaddi, and was introduced to the sport owing to his good physique by the Army coaches.

The 31-year-old Brown, who is the first boxer from his country to qualify for the Games since 1996, was Jamaica's flag-bearer at the opening ceremony.

500 People, Groups Write to CJI Seeking SC Intervention In Pegasus Snooping Matter

er 500 individuals and groups have written to Chief Justice of India (CJI) N V Ramana seeking immediate intervention of the Supreme Court in the alleged Pegasus snooping matter.

They have also sought a moratorium on the sale, transfer and use of Israeli firm NSO's Pegasus spyware in India.

They have expressed shock over media reports that the spyware was used for surveillance of women students, academics, journalists, human rights defenders, lawyers and victims of sexual violence.

Besides, the signatories to the letter have requested the top court to adopt a gender-neutral sexual harassment, data protection and privacy policy.

The letter also referred to the issue of alleged snooping on the apex court official who had raised allegations of sexual harassment against then Chief Justice Ranjan Gogoi.

For women, the Pegasus scandal is deeply concerning, for speaking out against the state and men in positions of state power has meant that their lives



are wrecked by such surveillance permanently.

COVID-19 Lockdown Negatively Impacted Women's Nutrition In India: Study

WASHINGTON: The nationwide lockdown in India in 2020 due to the COVID-19 pandemic had a negative impact on women's nutrition in the

country, according to a study conducted by a group of researchers in the US. The study by Tata-Cornell Institute for Agriculture and Nutrition in four economically backward districts of Uttar Pradesh's Maharajganj, Bihar's Munger, and Odisha's Kandhamal and Kalahandi indicate a decline in household food expenditures and women's dietary diversity in May 2020 compared to May 2019, particularly for non-staples like meats, eggs, vegetables, and fruits.

It occurred despite the special Public Distribution System (PDS), di-

rect benefit transfer and ration from aanganwadis reaching 80 per cent, 50 per cent and 30 per cent of the surveyed households, respectively, said the study published in the latest issue of Economia Politica journal.

"Our findings contribute to the growing body of evidence of women's disproportionate vulnerability to economic shocks, the impact of a staple grain focused safety net programme, and restricted markets on the access and availability of diverse nutritious foods," says the paper which makes a case for policy reforms towards PDS diversification to include nutritionrich foods and market reforms to remove supply-side bottlenecks and expansion of direct benefit transfers for healthy food access.

Active Covid Cases Register Increase In India For Second Consecutive Day

NEW DELHI: India logged 43,509 new coronavirus infections taking the total tally of Covid cases to 3,15,28,114, while the active cases registered an increase for the second consecutive day, according to the Union Health Ministry data updated on Thursday.

The death toll climbed to 4,22,662 with 640 fresh fatalities. The active cases have increased to 4,03,840 and comprise 1.28 per cent of the total infections, while

the national Covid recovery rate was recorded at 97.38 per cent, the data updated at 8 am showed. An increase of 4,404 cases has

All You Need To Know **About Assam's Border Disputes With NE States**

GUWAHATI: The division of Assam and creation of the predominantly tribal states of Mizoram, Meghalaya, Nagaland and Arunachal Pradesh left a residue of boundary problems, which continue to be evil relations between the neighbours.

Each of Assam's border disputes has its own legacy of claims and counter-claims:

Meghalaya: The problem be-tween Assam and Meghalaya started when the latter challenged the Assam Reorganisation Act of 1971, which gave Blocks I and II of the Mikir Hills or present-day Karbi Anglong district to Assam. Meghalaya contends that both these blocks formed part of the

Following recent violence in which seven people, including six policemen, were killed, Assam government has said that it will file a suit in the Supreme Court.

Nagaland: The longest-running border dispute in the North East is between Assam and Nagaland, which began soon after Nagaland became a state in 1963. The Nagaland State Act of 1962 had defined the state's borders according to a 1925 notification when Naga Hills and Tuensang Area (NHTA) were integrated into a new administrative unit. Nagaland, however, does not accept the boundary delineation and has demanded that the new state should also have all Naga- dominated area in North Cachar and Nagaon districts.



erstwhile United Khasi and Jaintia Hills district when it was notified in 1835. At present there are 12 points of dispute along the 733-km Assam-Meghalaya border.

Meghalaya bases its case on survey maps of 1872 and 1929 and certain notifications of 1878 and 1951 while Assam wants to go by the recommendations of the Churachand Committee which in turn has been rejected by Meghalaya. Joint surveys of the disputed border segments have been undertaken in part and the Chief Ministers of both the states are scheduled to meet again on August 6 at Guwahati to discuss ways to resolve the dispute.

Arunachal Pradesh: Arunachal's grievance is that the re-organisation of North Eastern states, unilaterally transferred several forested tracts in the plains that had traditionally belonged to hill tribal chiefs and communities to Assam. After Arunachal Pradesh achieved statehood in 1987, a tripartite committee was appointed which recommended that certain territories be transferred from Assam to Arunachal. Assam contested this and the matter is before the Supreme Court.

Mizoram: Prior to 2020, though a border dispute existed, the situation along the Assam-Mizoram border had remained relatively calm, barring a few instances in 1994 and in 2007. Following a border incident 2007 Mizoram declared that it does

Since Nagaland did not accept its notified borders, tensions between Assam and Nagaland flared up soon after the latter was formed, resulting in the first border clashes in 1965. This was followed by major clashes between the two states along the border in 1968, 1979, 1985, 2007 and 2014.

The Assam government had filed a case in the Supreme to resolve the border dispute and for a permanent injunction restraining Nagaland from encroaching areas within the constitutional boundary of Assam. In 2005, the Supreme Court instructed the Central government to constitute a boundary commission to settle various interstate boundary problems in the North East.

The Centre had earlier constituted two commissions, the Sundaram Commission (1971) and the Shastri Commission (1985), to settle the Assam-Nagaland border dispute. These commissions, however, failed to resolve the matter as the concerned states did not accept their recommendations.

Assam-Arunachal Pradesh: 804.1 km bordering eight districts of Udalguri, Sonitpur, Biswanath, Lakhimpur, Dhemaji, Charaideo. Tinsukia and Dibrugarh.

The two Assam-Mizoram: states share a 164.6-km border between the Assam's districts of Cachar, Hailakandi and Karimganj, and Mizoram's Kolasib, Mamit and Aizawl districts Assam-Nagaland: The two states share 512.1 km bordering four districts of Sivasagar, Charaideo, Jorhat and Golaghat. Assam-Meghalaya: The two states share 884.9 km bordering West Karbi Anglong, Dima Hasao, Morigaon, Kamrup Metro, Kamrup Rural, Goalpara, Dhubri and South Salmara. PTI

Man After Argument Over ₹ 20 **In Uttar Pradesh**
