#### **Education Dept Asks Vaccinated Staff To Attend Office**

SRINAGAR: The Jammu and Kashmir administration on Tuesday ordered all the vaccinated staff of the school education department to attend office.

The order has been issued by B K Singh, Principal Secretary to Government Education Department, following a detailed review on overall assessment of the situation pertaining to the spread of COVID-19 across J&K by the administration.

"There is significant improvement in the situation and need of further improvement in the interest of public health especially for students," reads the order.

While all schools including coaching centre(s) shall continue to remain closed for onsite or in-person teaching till further orders, all vaccinated staff shall attend Office, reads the order.

"Digital Education Programme(s) "e-Vidalaya/e-Gash" & (e-rcsources) of Ministry of Education, Gol, "anytime anywhere learning" in addition to Tele & Radio classes shall continue. A detailed survey report on impact of these classes shall be submitted weekly," the order reads, adding, "Community classes shall be taken regularly by academic staff including teachers as per prescribed guidelines in all feasible areas including Jammu and Kashmir Division."

## **Apni Party Mulls Resignation By Its DDC Members**

JK Admin Failing To Empower Local Bodies: Bukhari

SRINAGAR: The Jammu and Kashmir Apni Party, which was formed after the abrogation of Article 370 provisions in 2019, on Monday threatened that its District Development Council members will submit their resignations alleging that their work to assist people in remote areas was being hindered by the union territory administration.

Reminding the union territory administration of the promises made by Prime Minister Narendra Modi on empowering local bodies, JKAP chief Altaf Bukhari said his council members were either not allowed to

function or their movement had been completely restricted.

"We are left with no other option but to resign because the UT administration is time and again failing us and not allowing us to deliver on the ground and provide relief to the people in remote villages. I do not wish to show false dreams to the people," Bukhari told PTI here.

The Jammu and Kashmir Apni Party had won 15 seats on its symbol and independents supported by it bagged another 21 seats, taking its total to 36 out of the 280 across the union territory. Two more members from other parties had crossed over to it later.

## **HC Seeks Govt's Response On Mushroom Growth Of News Portals**

**SRINAGAR:** The High Court of Jammu and Kashmir and Ladakh has sought response from the government over the mushroom growth of news agencies on social media especially the news portals which are involved in

"circulating fake news".

The court of Chief Justice Pankaj Mithal and Justice Sanjay Dhar while hearing public interest litigation on the matter directed the respondents to file response specifically pointing out to provisions of law under such news portals if at all are required to be registered or licensed.

"And if so, whether the news portals are running with due

permission in accordance with law and whether any agency is examining the contents of the news circulated by these news portals," Court recorded.

The litigation filed through Counsel Shafkat Nazir Jammu and People's Kashmir Forum-a nongovernmental organization which works for the public cause submitted before court that there is a mushrooming growth



# Facebook developing AI, new ways to detect users under age 13

Admitting that it is not easy to detect and remove accounts belonging to people under the age of 13, Facebook has said that it is looking at ways to convince people under age 13 to not lie about their age, including using the artificial intelligence (AI) tech-

Facebook and Instagram weren't designed for people under the age of 13. so the company is now creating new ways to stop those who are underage from signing up.

"We're developing AI to find and remove underaged accounts, and new solutions to verify people's ages. We're also building new experiences designed specifically for those under 13." said Pavni Diwanji, VP of Youth Products at Facebook

Facebook is also working with operating system (OS) providers, internet browsers and other providers so they can share information to help apps establish whether someone is of an appropriate age.

"Many argue that collecting ID is the answer to this industry problem, but there are significant limitations to this approach: many young people don't have an ID, ID collection isn't a fair or equitable solution, nor is it foolproof," the company said.

It said that access to government IDs varies depending on where you live in the world, as does the information contained in an ID such as a birth-

"Some have access to IDs but don't get them unless they choose to travel, and some simply can't afford one. Indeed, lack of ID access disproportionately impacts underserved communities around the world, particularly young women," Facebook



mentioned.

Currently, when people open Facebook apps to sign up for an account, they are asked for their birthday. This is called an age screen.

But verifying someone's age is not as simple as it might sound. While age screens are common in our industry, young people can—and often do—get around them by misrepresenting

their age. The reality is that they're already online, and with no foolproof way to stop people from misrepresenting their age, we want to build experiences designed specifically for them, managed by parents and guardians,' Diwanji said in a statement.

This includes a new Instagram experience for tweens.

We believe that encouraging them to use an experience that is age appropriate and managed by parents is the right path. It's going to take a village to make this experience compelling enough so that this age group wants to use it, but we're determined

to get it right," the company emphasised.

Facebook has already developed a technology that allows it to estimate people's ages, like if someone is below or above 18.

We look at things like people wishing you a happy birthday and the age written in those messages. We also look at the age you shared with us on Facebook and apply it to our other apps where you have linked your accounts and vice versa. So if you share your birthday with us on Facebook, we'll use the same for your linked account on Instagram, Diwanji explained.

The social network said that it is focused on using existing data to inform its artificial intelligence tech-

Where we do feel we need more information, we're developing a menu of options for someone to prove their age. This is a work in progress and we'll have more to share in time, said Facebook



## Leave constitution, talk humanitarian: PM

RINAGAR - The prime minister, Atal Bihari Va-jpayee, today asked all the militant groups in Jammu and Kashmir to come forward for talks with the Centre. While rejecting the possibility of Pakistan's involvement in the peace process initiated with the Hizbul Mujahideen, he, however, made a significant departure from the oft-imposed rider of holding talks within the, frame work of Indian constitution.
"Our doors are open. I appeal to all militant groups and

organisations, which believe in peace, to join the centre's efforts for peaceful resolution of the Kashmir issue," Vajpayee told media persons here after leading a delegation of major

Asked whether Pakistan would be invited to form part of the peace process, Vajpayee said, there is no question of Pakistan's involvement." Holding Islamabad responsible for the killings, he said the absence of unequivocal condemna-tion by Pakistan makes it all the more a suspect Pakistan must come clean as its silence on the massacres would

further affect the bilateral dialogue process.

Asked whether the talks would be strictly within the framework of the constitution, Vajpayee said, "Leave the constitution. Talks should be held on humanitarian considerations that violence is stopped and no more blood is shed. To a question whether lapses insecurity led to the

killings, he said the government would order an internal inquiry to find out the reasons behind the orgy of violence. Vajpayee was accompanied by union ministers George Fernandes and Mamata Banerjee, Congress President Sonia Gandhi and her party colleague Ghulam Nabi Azad, Mulayam Singh Yadav (Samajwadi Party), Somnath Chatterjee (CPI-M), K Yerran Naidu (TDP) and Kanshi Ram (BSP). Vaipavee, who was accompanied by Jammu and Kashmir governor G.C. Saxena and chief minister Farooq Abdullah, termed as ridiculous allegation by Pakistan about the involvement of Indian security forces in the killing and rejected the possibility of instituting a judicial inquiry on the issue. The involvement of Pakistan-based Lashker-e Taiba have been proved beyond doubt other than Hizb-ul-Mujahideen being unhappy over the peace process initiated

by the centre.

Maintaining that Islamabad must unequivocally condemn the massacres, Vajpayee made it clear that violence and peace talks cannot go together. Nothing can be achieved through killings. He said if General Musharraf continued to maintain silence, then the future of resumption of bilateral parleys would become even more difficult, To a question on the issue of autonomy, Jammu and Kashmir chief minister, who was present the Vajpayee's press conference, said we are talking with the centre on the issue

## Afghanistan: Ghani Blames 'Abrupt' US Exit for Worsening Security



fghanistan's President Ashraf Ghani has blamed the country's deteriorating security on the United States deciding "abruptly" to withdraw its troops.

Presenting his security plan before Parliament on Monday, Ghani said the situation in the war-torn nation will be "under control within six months", adding that the US has pledged its full support.

"The reason for our current situation is that the decision was taken abruptly," he told Parliament, adding he had warned Washington the withdrawal would have "consequences".

The president added that "protection of the people" is a duty he

takes," said the statement. "The nation has decided to prosecute the national traitors and bring them to justice. Declarations of war, making accusations and providing false information cannot prolong Ghani's life," it said.

"His time is over, God willing." For months, the Taliban's rapid territorial gains during the final stages of the US military withdrawal have largely been in sparsely populated rural areas.

But in recent weeks, it has brought increasing pressure on provincial capitals and seized key border crossings. The capture of any major urban centre would take their current offensive to another level and fuel concerns that the army is incapable of resisting the Taliban's advances.

The government has repeatedly dismissed the group's steady gains over the summer as lacking strategic value but has largely failed to reverse their momentum on the battlefield. The Taliban has seized Afghan cities in the past but has managed to retain them only briefly.

told reporters. Noting that Iran is always ready to work with regional countries to provide maritime security, the Foreign Ministry spokesman said,

"Tehran considers the presence and interventions by trans-regional forces in the Persian Gulf waters and its littoral countries as detrimental to regional stability and security."

He dismissed US and Br statements as "contradictory", and said "if they have any evidence to support their baseless claims they should provide them".

Iran also accused them of effectively supporting "terrorist attacks against and sabotage of Iran's com-

mercial ships" through their "silence". There have been several recent reported attacks on Iranian ships that Tehran has linked to Israel.

In March, Iran said it was "considering all options" after an attack on a cargo ship in the Mediterranean, that it blamed on Israel.

In April, Tehran said its freighter Saviz was hit by an "explosion" in the Red Sea, after media reports said Israel had targeted the ship.

The New York Times reported at the time that this was an Israeli "retaliatory" attack, after "Iran's earlier strikes on Israeli ships".

Iran has also accused Israel of sabotaging its nuclear sites and killing a number of its scientists.

## **Delta Spreads 'Like Wildfire' As Doctors Study Whether It Makes Patients Sicker**

Tith a new wave of Covid-19 infections fuelled by the Delta variant striking countries worldwide, disease experts are scrambling to learn whether the latest version of coronavirus is making people - mainly the unvaccinated - sicker than before.

The US Centres for Disease Control and Prevention warned that Delta, first identified in India and now dominant worldwide, is "likely more severe" than earlier versions of the virus, according to an internal report made public on Friday.

The agency cited research in Canada, Singapore and Scotland showing that people infected with the Delta variant were more likely to be hospitalized than patients earlier in the pandemic.

In interviews with Reuters, disease experts said the three papers suggest a greater risk from the variant, but the study populations are limited, and the findings have not yet been reviewed by outside experts. Doctors treating patients infected with Delta described a more rapid onset of Covid-19 symptoms, and in many regions an overall increase serious case.

But the experts said more work is needed to compare outcomes among larger numbers of individuals in epidemiologic studies to sort out whether one variant causes more severe disease than another.

'It's difficult to pin down increase in severity and population bias," said Lawrence Young, a virologist at the UK's Warwick Medical School.

In addition, it is likely that the extraordinary rate of Delta transmission is also contributing to a greater number of severe cases ar-

riving at hospitals, the experts said. Delta is as contagious as chickenpox and far more contagious than the common cold or flu, according to the CDC report.

Shane Crotty, a virologist at the La Jolla Institute for Immunology in San Diego, said the clearest indication that the variant may cause more severe disease comes from the Scotland study, which found that Delta roughly doubled the risk of hospitalization compared to an earlier version.

The majority of hospitalizations and deaths from coronavirus in the United States are occurring in people who have not been vaccinated. But there is evidence that the shots are less effective in people with compromised immune systems, including the elderly. For vaccinated, otherwise healthy individuals, the odds are that if they contract COV-ID-19 they will only experience asymptomatic or mild disease, said Dr Gregory Poland, infectious disease expert at the Mayo Clinic.

"But they can pass it on to family members and others who may not be so lucky," Poland said. "We have to be vaccinated and masked or we will, for the fourth time now, endure another surge and out of that will come worse variants.'

Research from China suggesting that the Delta variant replicates much faster and generates 1,000 times more virus in the body compared to the original strain highlights the biggest danger of this new wave, Barron said.

"It is hard to tell if they are more sick because of the Delta variant or if they would have been more sick anyway," she said.

Other doctors said patients infected with Delta appear to become ill more quickly, and in some cases with more severe symptoms, than those they treated earlier in the pandemic.

"We are seeing more patients requiring oxygen sooner," said Dr Benjamin Barlow, chief medical officer at American Family Care, a 28-state chain of urgent care clinics.

At his clinic in Birmingham, Alabama, Barlow said that around 20% of patients are testing positive for Covid-19, compared with 2-3% a few weeks ago. Patients are assessed at that time for potential hospital admission and oxygen support.

David Montefiori, director of the Laboratory for AIDS Vaccine Research and Development at Duke University Medical Centre, said the Delta variant is more infectious and leads to faster onset of illness - particularly for the un-

#### Millions Under COVID-19 **Lockdown As China Battles Delta Variant Outbreak**

**BEIJING:** Millions of people were confined to their homes in China Monday as the country tried to contain its largest coronavirus outbreak in months including seven positive tests found in Wuhan, where the virus first emerged in late 2019.

China reported 55 new locally transmitted cases on Monday as an outbreak of the fast-spreading Delta variant reached over 20 cities in more than a dozen provinces.

The Wuhan cluster came after the official daily tally was released, but it was confirmed by state media which said the infections had been traced to a train station.

The seven were identified as migrant workers," Xinhua reported, citing Covid-19 prevention and control officials.

Major cities including Beijing have now tested millions of residents while cordoning off residential compounds and placing close contacts under quarantine.

Authorities in the capital met and agreed on the need to "raise vigilance, take strict precautions and defend (the city) to the death, sparing no expense," in comments put out by the Beijing government.

Elsewhere, over 1.2 million residents were placed under strict lockdown for the next three days in the central city of Zhuzhou in Hunan province Monday, as authorities roll out a citywide testing and vaccination campaign, according to an official statement.

"The situation is still grim and complicated," the Zhuzhou gov-

China had previously boasted

of its success in bringing domestic cases down to virtually zero after the coronavirus first emerged in Wuhan, allowing the economy to rebound.

But the latest outbreak, linked to a cluster in the city of Nanjing where nine cleaners at an international airport tested positive on July 20, is threatening that success with more than 360 domestic cases reported in the past two weeks

In the tourist destination of Zhangjiajie, famed for its national forest park, an outbreak spread last month among theatre patrons who then brought the virus back to their homes around the country.

Zhangjiajie locked down all 1.5 million residents on Friday.

Officials are urgently seeking people who have recently travelled from Nanjing or Zhangjiajie, and have urged tourists not to travel to areas where cases have been found.

Meanwhile, Beijing has blocked tourists from entering the capital during the peak summer holiday travel season.

Only "essential travellers" with negative nucleic acid tests will be allowed to enter after the discovery of a handful of cases among residents who had returned from Zhangjiajie.

Top city officials on Sunday called for residents "not to leave Beijing unless necessary".

The capital's Changping district locked down 41,000 people in nine housing communities last week.'Fresh cases were also reported on Monday in the popular tourist destination of Hainan as well as in flood-ravaged Henan province, national health authorities said.

## **Wildfires Cause Further Devastation In Turkey, Greece**

The death toll from six straight days of wildfires in L Turkey has risen to eight, while in neighbouring Greece, firefighters were attempting to contain a blaze that has destroyed houses and hospitalised more than a dozen people.

The Turkish fires have been fuelled by a southern European heatwave fed by hot air from North Africa, which has also seen chaos grip other parts of the Mediterranean in recent days.

Experts have warned that climate change is increasing both the frequency and intensity of wildfires. Prime Minister Kyriakos Mit-

sotakis warned on Monday that Greece is suffering its worst heatwave since 1987 as forecasters said temperatures could reach 45 degrees in the coming days. The intense heat has helped

fan wildfires that have destroyed more than 3,000 hectares (7,400 acres) of pine and olive groves in the country's west since Saturday.

Elsewhere in Europe, more than 800 flare-ups were recorded over the weekend in Italy, mainly in the south, the country's fire brigade said. A second straight day of wildfires in Sicily on Saturday forced people to leave their homes and saw the local Catania airport temporarily shut down.

In Spain, firefighters backed by waterbomber aircraft battled a wildfire that broke out Saturday near the San Juan reservoir, about 70km (40 miles) east of Madrid. That blaze was stabilised overnight but authorities urged people to stay away from the reservoir, a popular bathing spot for residents of the Spanish capital. Chandra Bhushan, chief ex-

ecutive officer of the non-profit International Forum for Environment, Sustainability & Technology (iFOREST) research organisation, said the wildfires were linked with extreme temperatures, a longer drought period, a low level of humidity and high wind speeds.

"There are climatic conditions being created which are so favourable for wildfires, that is why you are seeing all these incidents happening in the Mediterranean region," Bhushan told Al Jazeera.

"And all of them can be linked to climate change.'

In Turkey, two people died on Sunday in the Mediterranean coastal city of Manavgat, raising the town's death toll to at least seven, Minister of Health Fahrettin Koca said.

In recent days, at least one person has also died in Marmari

Twenty-seven people were still being treated in hospitals in impacted areas, while thousands have been evacuated from their homes. Scores of fires across several

provinces on Turkey's Aegean and Mediterranean coasts broke out last Wednesday, fanned by strong winds and scorching temperatures. While the majority have been

extinguished, responders were still tacking seven blazes in the coastal provinces of Antalya and Mugla - popular tourist areas, and in Tunceli, southeast Turkey.

Many villagers have lost properties and farm animals, while locals and tourists have fled vacation resorts in boats.

The wildfires are the worst of their kind in at least a decade, with nearly 95,000 hectares (235,000 acres) burned so far this year, compared with an average of 13,516 at the same point in the years between 2008 and 2020.

## Petraeus: US Has Abandoned Afghanistan To Civil War

LONDON: America has deserted its responsibility to protect rights and freedoms in Afghanistan, Gen. David Petraeus, the former US commander in the country, has told The Times.

With the Taliban rapidly sweeping up territories that were until recently defended by US-led coalition troops, Petraeus warned that a "medieval Islamist regime" and the return of terror-training safe havens are a realistic possibility.

Tens of thousands of Afghans have already started fleeing their homes as the Taliban start to take ground around Kandahar, the country's second city.

"The rest of the world will see that we are not supporting democracy or maintaining the values that we promote around the world — human rights, particularly women's rights, the right to education and freedom of speech and press — all very imperfect in Afghanistan, to be sure, but vastly better than if the Taliban reinstates a medieval Islamist regime," Petraeus said.

"The worst-case scenario is we they give up anything? could see a bloody, brutal civil war similar to that of the 1990s when the Taliban prevailed," he added.

"If that were to happen we would likely see the return of an Al-Qaeda sanctuary, although I don't think Al-Qaeda would be able to threaten the homeland and Europe in the near-term. And certainly, our intelligence services and military will be watching for that.

"But it would be easier for Al-Qaeda if the Taliban seize control. We would see millions of refugees flooding into Pakistan and other neighboring countries. If the Taliban do take control we will see dramatic reductions in freedoms for Afghan citizens, particularly women. I don't think this is what the world wants to see."

Petraeus said he is shocked by how Washington is closing down its military operations in Afghanistan.

"If we had shown the determination and will to stay, we would have been in a much stronger negotiating position with the Taliban. But if we tell the enemy we are going to leave, why would

"I am a little bit unclear why we didn't think we could maintain 3,500 troops to stop the Taliban from bringing back an ultraconservative Islamist theocracy, which is not in anyone's interest."

Petraeus added: "The war will go on and will get much worse. Ryan Crocker (Washington's envoy to Kabul between 2011 and 2012) once said you can get tired of a movie and leave the theater but the movie continues to roll on. We forced the Afghan government to release thousands of Taliban prisoners, and got little or nothing for it. But if we had 3,500 troops there to maintain situational awareness and help our Afghan partners, we would have been in a position to prevent the Taliban from

bringing civil war to the country." Petraeus contrasted the Afghanistan policy with the US approach to Iraq, where Washington has retained a small deployment of some 2,500

troops in an advisory role. "But they can at least help the Iraqi security forces keep an eye on the in-

"What will happen next depends most importantly on what the US will do to enable the Afghan air force to continue flying. The Afghan air force requires highly trained mechanics and supply chains and logistical support or they will not be operationally capable."

## Denial of security clearance

housands of youth are likely to be impacted by the J&K police move to deny security clearance to those "involved in crimes prejudicial to the security of the state, including stone-pelting. According to an estimate, the number of street protesters in Kashmir has swelled to around 20,000.

The fresh order has directed all CID SB-Kashmir "to ensure that during verification related to passport service and any other verification related to government services, schemes, the subject's involvement in law and order, stone pelting cases and other crime prejudicial to the security of the State be specifically looked into." The police has also called for collecting digital evidence like the CCTV footage, photographs, videos, audio-clips and quadcopter images available in the records of the police, security forces and agencies as references.

The move rather than being a deterrent to protests and stone pelting will adversely impact the future of so many youth who may have been involved in stone pelting or protests in the past. Denial of security clearance would make it impossible for them to get jobs in the government or for that matter even in private sector. Similarly, lack of passport would also make it difficult for them to leave the country for employment.

As for the move's deterrent value, such steps in the past have done have made no redeeming difference to the situation. What has done is the outreach to the youth. And the administration could have done so by extending amnesty to the people who have had stone pelting cases against them.

In past, the then J&K state governments have adopted this approach. For example, in 2017, the then Chief Minister Mehbooba Mufti had embarked on a series of measures to woo back the deeply alienated people in the Valley. And among these was the amnesty to the youth booked for participating in protests and throwing stones in 2016 and the promise of their rehabilitation. Her government had also taken up review of the cases of 'second-time offenders' - the youth who had been booked more than once for anti-government protests or on charges of alleged stone pelting. The amnesty at the time had covered around 10,000 people, a significant number of them in the age group of 15-20. Many of them were boys in their adolescence or barely out of it.

Over the last two years, the administration has adopted a hardline approach to quell the militancy and dissent in Kashmir. The result has been mixed. But fundamentally the situation remains largely unchanged. This is where the need for an outreach comes in. It is time that the government goes back to winning hearts and minds. Effort to address alienation would create more goodwill for the government and a genuine peace on the ground.

# Elusive gold: On India's Olympic quest India at the Olympics has always been about feverish hopes, bruising anguish and a few medals. Since its debut at the Games in 1900, the world's second most populous nation has ended up with either a single-digit tally or none at all. That

ended up with either a single-digit tally or none at all. That familiar tale is being repeated a week after the Tokyo Olympics commenced and India is currently assured of three medals. One, a silver claimed by weight-lifter Mirabai Chanu in the 49kg category And second, a minimum of a bronze guaranteed as boxer Lovlina Borgohain qualified for the semifinal in the welter-weight segment The bout will be held on Wednesday. Badminton star P.V. Sindhu too joined the party, seizing her bronze after defeating China's He Bingjiao 21-13, 21-15 during Sunday's third-place play-off. Through their exploits Mirabai and Lovlina, hailing from Manipur and Assam, respectively, have revealed the rich sporting ability shimmering in the North-eastern States linked to the mainland through the chicken's neck above Bangladesh. Mirabai and Lovlina owe their triumphs to their innate strength and hard work besides the obvious support from family and the Sports Authority of India. With Sindhu, they have also reiterated women-power. Sindhu, who won the silver at the previous Olympics at Rio de Janeiro, had an exceptional run till she ran into Chinese Taipei's Tai Tzu-Ying in the semifinal and then made amends with a bronze.

India had a moment to savour when its women's hockey team entered the quarterfinals. While a strong Australian outfit awaits in the knockout on Monday, the women will add to India's evergreen hockey-hopes that gained a fillip after the men defeated Great Britain 3-1 during Sunday's quarterfinal. After the 1980 gold, the men's quest to win another Olympic medal has gained impetus and the road ahead is tough but interesting. In the limited chronicle of good tidings, Kamalpreet Kaur's excellent throw of 64 metres in the discus throw event was a spark. Kamalpreet qualified for Monday's final and a lot is resting on her shoulders. While these stirring events kept India afloat, there is also the litany of heart-breaks that included Mary Kom's loss in boxing, a fact the 38-year-old failed to initially admit following her adrenaline rush The travails in shooting and archery did not add up to the original template of good form and resultant expectations. Shooters Saurabh Chaudhary and Manu Bhaker had their moments but they were not enough. The Games exert immense pressure as it is always about the athlete combining individual excellence with national pride. Tennis champion Novak Djokovic failed to even win a bronze while gymnast Simone Biles withdrew from events citing mental fatigue. It is never easy and the Indian contingent would vouch for that going into the second week

## **Pegasus: Inside the panopticon**

he allegations of governments spying on their citizens with Pegasus, a spyware developed by an Israeli firm, is an unwitting revelation of the bigotry of some of these nations. India's prime minister has claimed that democracy is an ancient tradition in this country. However, the charges of snooping, if they are true, would force India to share space with autocratic countries. That some Islamic nation states are keeping tabs on Muslim citizens with an Israeli product shows that traditional enmity can be swept aside for the sake of power. Unsurprisingly, countries suspected of using the spyware are at the bottom of the 2021 World Press

Freedom Index. The NSO Group, Pegasus's manufacturer, claims that it only works with governments and that the clients have to be approved by the Israeli State. This may not give the Indian government much room to extricate itself from the charge of using what is described as a weapon against its citizens. Significantly, the government has not used the bogey of China or Pakistan as a fig leaf. The statement released by India does not rebut the allegations but expounds on its commitment to free speech as a fundamental right while also explaining the checks and balances to prevent the misuse of phone-tapping. Spokespersons of the Bharatiya Janata Party and ts government have been casting doubts on the report by the media collective and the timing of its release — the eve of the monsoon session of Parliament — while also

aggressively suggesting that it is a conspiracy to discredit the nation.

In 2019, a lawsuit filed by WhatsApp in the United States of America had revealed the use of Pegasus against Indian citizens. In a written response to Parliament, the then minister of state for home affairs, G. Kishan Reddy, had explained the laws that govern interception and monitoring of communication. Even then, the government had not provided clarity on its role in the

The BJP government has observed that the disclosures of Pegasus usage do not specifically mention the party. Even then, does it not behove the government to be concerned about the well-being of citizens? Should it not announce a commission to determine the identities of those targeting Indians and the reasons for the use of surveillance? This is a major breach in security and the Indian government should reassess the measures that failed to prevent senior officials from becoming potential targets. Instead, the BJP is suggesting that the aggrieved parties should file police complaints. Moreover, what can one deduce from the government's claim that there has been no 'unauthorized interceptions'? That the use of Pegasus has been sanctioned by the Indian State?

Autocratic countries like China do not need to use foreign spyware to keep a tab on their citizens. Not only have they developed similar technology but the idea of Big Brother watching is integral to the notion of statecraft. The Hong Kong police has a hotline open for neighbours and families to snitch on each other. Such a system, the government claims, apprehends criminals. What happens instead is that the voicing of opinion becomes a potential crime, intimidating people into consuming and regurgitating official lines.

Information and its conversion into knowledge have always been a source of power and control. However, when governments target citizens, it creates a state of fear and people begin to self-regulate. Governments spying on their populace serves two purposes. The first is active coercion — finding critics and punishing them. The second is passive coercion — the chilling effect on citizens stemming from the knowledge that the government is watching them.

The BJP has a brute electoral majority in India. With the near absence of a counter-narrative and the alleged subversion of democracy's sentinels in this country, does the BJP government have any need for intrusive technology?

But then Shakespeare's Henry IV had bemoaned, "Uneasy lies the head that wears a crown." This is true not only for individuals but also for political parties. Complete political domination can only be predicated upon the distrust of critics and citizens alike.

## **Robust Use of Technical Education**

he use of technical education has given a new encouragement to the education of children in India during the epi-The education system of the country has now become as online as possible. Educational institutions across the country have been closed for the last one and half years. The epidemic has profoundly affected the economy and lives of school administrators, coaching center operators, temporary private school teachers and staff. On the other hand, the future of millions of students is still hanging in the balance. Anxiety about the future makes them feel depressed and stressed. The multi-faceted development of the educational institutions that have shaped the future of the students has been affected due to their long tenure! However, in the difficult times of the epidemic, it has established itself as a useful and effective education system as an alternative to online education.

It has proved to be a unique medium of teaching and learning by staying in one place and protecting oneself from the epidemic while maintaining the continuity of education. This has not only reduced the stress on teachers and students and parents, but also saved everyone's life and time. While many private and public educational institutions have rapidly embraced the virtual education medium, adapting to this form has been challenging for many institutions struggling with lack of resources and support. The epidemic has disrupted schooling around the world. More than one hundred and ninety countries around the world had to close their schools to escape the corona. According to UNESCO, the education of 137 billion students in six countries has been suspended since the launch of COVID-19. The prevalence of online education as an alternative to the disruption of schooling has grown exponentially, but it is a matter of concern that this type of education has not reached everyone A report by the Economist Intel-

ligence Unit states that the closure of schools has disrupted the education of only 100 million of the world's 16 billion schoolchildren, meaning that such children continue to study at home despite the closure. Due to lack of technology at home, their education is continuous. For these children, technology has bridged the gap between home and school. Through technology, children are also solving their own problems by participating in daily classes. But on the other hand, the future of millions of rural children far from access to online education is in jeopardy. The problem of smartphones, poor power supply, inability to buy electronic gadgets and slow internet has taken over the future of those children! In an epidemic, children are witnessing their own future being destroyed right in front of their eyes! Due to Covid-19, even in the full and current education session of 2020-21, classes are being conducted with different methods of technology.

Through smartphones, computers and laptops, WhatsApp, Zoom, Email, etc., some children have been able to overcome the lack of schooling, but the worry is that homes in the country that do not have access to these technologies, The children there are deprived of the essential syllabus of the class. But the real situation of power and power supply in the country is not hidden from anyone. A survey conducted by the Ministry of Rural Development in 2017-18 shows that 16 per cent households in the state get less than one to eight hours a day, 33 per cent households get 12 hours of electricity and only 45 per cent households get more than 12 hours of electricity. The reality is that the state of technical education and online education in government


Most of the children attending these schools belong to low-income families. They have neither the facility of a smartphone nor the status to buy an internet pack. Poverty, awareness and lack of technical knowledge in such families do not give much importance to the need for technology based education. Millions of children in the country are not taking advantage of online education even if they want to. In fact, the problem of electricity and internet is the main obstacle in the way of universal access to online education and its success. The internet has become a basic need of almost every conscious person today. The Internet has played a significant role in making life easier. It has also

become a means of radical change in society. But on the other hand, it is surprising that a large portion of the country's population is far from accessing information on the Internet. It is also difficult for a large section of the population to afford two meals a day, so it is very wrong for them to think of getting electricity and internet connection.

According to the first round of the Annual Education Status Report 2020, 39 out of every 100 students are deprived of online education because they do not have a smartphone. Only 67 per cent of the country's urban population has access to the internet, compared to just 31 per cent in rural India. According to Internet and Mobile SC Bun of India, the number of Internet subscribers in the country by 2020 was 622 million.

Maharashtra, Goa and Karnataka are the only three states in terms of internet subscribers, while Bihar, Chhattisgarh and Jharkhand are the three most backward states. It is estimated that the number of Internet subscribers in India could increase by 45% by 2025. However, the importance of the Internet in the country as well as its speed is also in question. It is customary for housewives to have cheaper mobile phones than men and to give their sons ahead of time and more expensive smartphones than their daughters expect. It also needs to change

he great Mufassirs (Exegetes) have found that man is the main focus of the Qur'an, the 'Final Revealed Book'. They contend that if one ponders upon the multifaceted discourses incorporated in the Qur'an, one can safely reach to the conclusion that the central theme and aim pursued by the Qur'an is the 'training of the human being', as a being conscious of the reason of his existence. The main aim of the Qur'an, if simplified is therefore to reinforce and accelerate the spiritual ascension, together with all the qualities of human being, towards a state of true loftiness and the dignity of which the human being is worthy for he is created in the best of the moulds (Ashraf al Makhlugat). In other words, we can say that the main purpose of Qur'an is to expound truths that are relevant to the 'life of a human being' and the exaltation of his being conducive to attain a life of true happiness. Comprehending the essence of Qur'an, it was the Prophet himself first who shaped his life on the Qura'anic precepts so much so that 'Ayesha (wife of the Prophet) symbolises his morals with the teachings of Qur'an Imbibing the char. acteristics of their Prophet, the Companions (Sahaba) strived hard to actualise their life in conformity with the Qur'an. Ali bin Abi Talib is reported to supplicate that reveals how the Holy Qur'an forms 'the chart of life for man'. He prayed: "O Allah! expand my breast with Qur'an, actuate my body with Qur'an, enlighten my sight with Qur'an, liberate my tongue by Qur'an, and help me to mould my life according to Qur'an, so long as You make me live"

Believers are expected to refer to the Quran and the Sunnah of Messenger of Allah in order to learn the secrets of the life in the world and the hereafter: they also refer to it whenever issues remain unsolved through other means. In such respect Qur'an says in Surah al-Nahl (16: 89) "We have sent down to thee the Book explaining all things, a Guide, Mercy and Glad Tidings to Muslims." However, one should not conclude from this verse that the Quran is an almanac or a book of science. It is not a book that mentions provisional scientific theories; it may furnish the clues regarding science but in essence, it is a life guide. It is a manual sent by Allah, Who created us and who knows our nature better than us: it shows us how to use our temporary body in this transient world. "This Quran is not a tale invented, but a confirmation of what went before it, a detailed exposition of all things, and a Guide and a Mercy to any such as believe", says Qur'an in Surah al-Yusuf (12:111). It is the most distinctive feature of the Quran, whose unique aim is the guidance and happiness of human beings, to use a style in compliance with this aim: "to address sometimes the mind, sometimes the feelings, sometimes the conscience and sometimes the heart of its readers, to attract attention to the previous nations, the sky and the earth, the kingdom of plants and animals, the psychological, sociological, philosophical and ethical realities and to ask its readers to think on these issues", as Said Nursi puts it. The Quran informs man of his responsibilities toward himself, his Lord, the other people and nature. It teaches those who are not aware of their responsibilities and reminds those who forget about their responsibilities.

Qur'an has a unique feature of portrayal of preceding nations. One of such communities described is that of Banu Israel. The community was honoured with the endowment of several Prophets. God bestowed them with multiple favours that were unknown to others. Qur'an abounds in ayahs with respect to the favours done to the said Nation. Thus says the Qur'an: "O Children of Israel! call to mind the (special) favour which I bestowed upon you, and fulfil your covenant with Me as I fulfil My Covenant with you, and fear none but Me. (2:40). "Children of Israel! Call to mind the (special) favour which I bestowed upon you, and that I preferred you to all other nations (for My Message) (2:47).

In fact Banu Israel turns out to be the first nation

who received the maximum number of Prophets, a fully detailed and comprehensive Law, and a comprehensive revealed scripture in the form of Torah. "And We gave Moses the Scripture, complete with the best commandments, detailing everything, and a beacon and mercy, that they may believe in meeting their" (Qur'an, 6:154). All such favours deserved obedience to God and service towards mankind. However Banu Israel ended up with Jews and Christians. The former got so intoxicated with the phrase Chosen People that they became racial (Making Yahweh Only their God) and the later held salvation as their exclusive right. They abandoned the spirit of servitude to God, instead developed the fantasies of good life here and hereafter. God had sent them constant reminders recorded in Torah and as endorsed by Qur'an: We [Allah] made a covenant with you [Children of Israel] and raised the Mount [Sinai] above you, saying: 'Grasp fervently [the Torah] what We [Allah] have given you, and bear in minds its precepts, that you may guard yourselves against evil" (Qur'an, 2:65). Stressing upon the moral and social duties God had revealed: And remember We [Allah] made a covenant with the Children of Israel (to this effect): Worship none but Allah; treat with kindness your parents and kindred, and orphans and those in need; speak fair to the people; be steadfast in prayer; and practise regular charity. Then did ye turn back, except a few among you, and ye backslide (even now) (Qur'an, 2:83). But being carried away by the shower of favours, Banu Israel (contemporary Jews and Christians) remained oblivious of the criteria of being good in the sight of their Lord. As Karen Armstrong puts it nicely, "The title of 'Chosen People' given to Banu Israel spoke more of responsibility than

Failing in the fulfilment of Covenants made with Allah, Jews and Christians were succeeded by Muslims as Allah makes it a rule to substitute the irresponsible and insensitive with the responsible and susceptible. Muhammad as a Prophet and his immediate followers (Sahaba) lived up to the spirit that was altogether missing in Banu Israel. According to Qur'anic teaching, service of Allah cannot be separated from service to humankind, or in Islamic terms, believers in Allah must honour both Haquq Allah (rights of Allah) and Haquq al-'ibad (rights of creatures). Fulfilment of one's duties to Allah and humankind constitutes righteousness, as comprehensively stated in Surah Al-Baqarah (2:177), which reads as: Righteousness does not consist in turning your faces towards the east or towards the west; true righteousness consists in believing in Allah and the Last Day, the angels, the Book and the Prophets, and in giving away one's property in love of Him to one's kinsmen, the orphans, the poor and the wayfarer, and to those who ask for help, and in freeing the necks of slaves, and in establishing Prayer and dispensing the Zakah. True righteousness is attained by those who are faithful to their promise once they have made it and by those who remain steadfast in adversity and affliction and at the time of battle (between Truth and falsehood). Such are the truthful ones; such are the God-fearing. Setting themselves right in the colour of above cited teachings of Qur'an, Prophet and his comrades in the full light of history displayed to the world that they represented the group of "chosen people" in the true sense of the word. The successors of Prophet's Companions termed as Tabiin and their successors known as TabaTabiin did their best to preserve the legacy left by the Prophet and his followers.

However as time passed, Muslims developed signs of negligence towards the ways set by their Prophet under the all wise guidance of God (Allah). The rot deepened to such an extent that Muslims like Jews and Christians felt contended with the title of Khayri-Ummat (The Best Community) and Ummat-i-Wasata (The Middle Ummah) at the cost of obligations that the titles brought with them.

In the words of Muhammad Azizan: "It must be

made clear that although the Ummat-i-Wasat of the Prophet is recognized by a specific name, they are neither a chosen group nor a saved community of faith. By virtue of exercising the final, concrete and universal form of Islam, they belong to a single community of believers. Thus the model community of the Prophet stands as the final community of the final al-Millah al Hanaffiyah (the absolute monotheistic religion). To be a Muslim today or any day as Rifat Hassan puts it is to live in accordance with the will and pleasure of Allah." She comments: Muslims often say, with joy and pride, that it is easy to be a Muslim since Islam is 'the straight path' leading to paradise. What this means, in other words, is that the principles of Islam are simple and straightforward, free of ambiguities, confusions, inconsistencies or mysteries, and that comprehending them or living in accordance with them is not difficult. The assumption here is that if one somehow comes to "the straight path" by accepting Islam, which is Allah's last and final revelation to humanity, one will fairly effortlessly arrive at the destination which is a state of eternal blessedness in the presence of Allah.

Qur'an always hosts an integrated vision that contains belief in Allah and Allah's revelation (Iman) and righteous action (amal), or regular remembrance of Allah (Salah) and discharge of one's financial and moral obligations to Allah's creatures (Zakah). Thus, to be a Muslim means in a fundamental way to be both Allah-conscious and conscious of his fellow human beings, and to understand the interconnectedness of all aspects of one's life, of the life of all creation and of our life in this momentary world to life eternal. Qur'an beautifully summarises this as: "Those who remember God (always, and in prayers) standing, sitting, and lying down on their sides, and think deeply about the creation of the heavens and the earth, (saying), "Our Lord! You have not created (all) this without purpose, glory to You! (Exalted are You above all that they associate with You as partners); give us salvation from the torment of the Fire" (3:191).

It is really unfortunate that today Muslims all over the world fail to uphold the ideas of Islam. They are in-serious towards the affairs within their own societies and the global crisis of justice, order, leadership, harmony and peace. Instead of realizing their responsibilities they appease themselves with ideas that they are the favourite Ummah of the Prophet and witness over all Ummam. They don't pay heed towards when Prophet Muhammad will say, "O my Lord! Surely my people have treated this Qur'an as a forsaken thing" (Qur'an, 25:30) or the Hadith of the Prophet like "All are entitled to Jannah except those who deny. Upon asking who will deny going Jannah, the Prophet replied those who cast his Sunnah aside (Bukhari). Instead of applying what Iqbal calls "The Principle of Movement", Ijtihad, (The greatest gift offered by Prophet to the Ummah), Muslims still live in the past mesmerizing themselves with Ideal Madinan society, Khilafat-i-Rashidah, Golden Period of Abbasids, Conquest of Jerusalem, etc. In the context of Kashmir such things turn more interesting. ## Past climate change 'tipping points' can help us prepare for future: Study

Of all the creatures on Earth, humans manipulate their environments the most. But, how far can we push it before something drastic happens? Scientists are calling for a better understanding of past extreme climate change events in an attempt to anticipate future changes.

Enter geoarchaeologist and anthropologist C. Michael Barton at Arizona State University. The School of Human Evolution and Social Change researcher, along with Foundation Professor Sander van der Leeuw and an international and interdisciplinary team, published their analysis this week in the journal Nature Geoscience.

The paper describes past abrupt climate changes, what led up to the "tipping points" for those events, and what followed.

"We've been putting a lot of chemicals into the atmosphere and changing the heat of the atmosphere for a long time, and really intensively for 150 years," Barton said. "And, things are still chugging along. Temperatures are slowly going up globally, but we haven't seen a huge, dramatic shift. However, complex systems are potentially vulnerable if you push too much.

Barton studies Earth's many systems specifically the water cycle and landscapes - and how humans alter these systems.

"People tend to look at how far you can push things before suddenly everything changes," Barton said. "And that's what's considered the tipping point.'

For a complex systems specialist like Barton, almost everything can be viewed as systems or cycles. A tree grows and dies. and the decay returns nutrients to the soil Water cycles through the Earth in different

Some of Earth's major systems include the hydrosphere (water), the atmosphere (air), and the cryosphere (ice). All these systems are connected. This research on tipping points looks at the history of these systems to quantify small changes that can lead up to an abrupt, massive change, while also measuring how one abrupt change can trigger abrupt changes in other systems.

The paper explores prior research with sediment cores in the Gulf of Alaska, dust records in North Africa and ice cores from Greenland. All of this pre-historic data gives Earth system modelers and scientists a better idea of what Earth was really like hundreds of thousands of years ago.

Scientists have also been extensively studying Earth's oceans. This includes the current levels of salt and oxygen, changes in circulation patterns, and influxes of fresh water from melting ice sheets. Current ocean conditions can be compared to historic data gathered from the composition of the ocean floor, to make inferences about past ocean currents.

The authors note past instances of extreme climate events happening so quickly that humans either had difficulties adapting, or were unable to adapt, to the new environment.

For example, about 1,500 years ago, abrupt cooling occurred in Europe, leading to changes in the vegetation. The authors note the cooling may have been caused by a natural phenomenon -- volcanic eruptions. The vegetation and farming changes were so extreme that people experienced famine and societal reorganization. This timing correlates with the transformation of the Eastern Roman Empire.



The authors note how climate events centuries ago triggered drastic changes or even collapse in ancient civilizations due to unforeseen societal vulnerabilities.

One example is the ancient city of Angkor, which was located in present-day Southeast Asia. The people living in Angkor altered the natural water cycle by diverting water to grow crops. As the city grew, the water system in that region became so strained that it passed a tipping point. The system couldn't handle more intense droughts and floods, and the city of Angkor collapsed.

Arizonans know that the last few years have been drier and hotter than usual. Barton said it's not yet clear whether we've passed a tipping point in the Southwest re-

It's normal to see slight fluctuations in precipitation and temperature year to year. But recent studies of ancient climate make Barton wonder if the drier weather patterns have become the new normal for our

Barton also noted that researchers still don't know why some weather systems change. For example, past monsoon rains have shifted without warning and for unknown reasons. This can be catastrophic for human populations, as those who depend on the monsoon experience intense drought, while others do not have the infrastructure to handle the influx of water.

There are still gaps in this field of research. More raw data needs to be collected and quantified, and some existing data lacks the precision and quality needed to create test models and simulate future abrupt changes

The researchers also call for more analysis on the interactions between environmental systems and human societies during periods of climate change.

Lastly, improvements in Earth system models will help scientists be able to simulate possible abrupt changes humans may see in the near future. Current models are very good at simulating more gradual climate change, but are not yet able to simulate well-documented past abrupt changes.

The authors hope this paper raises awareness of the field, and that more people will understand how analyzing the longterm past could help us in the near future.

For example, one component of tipping points research is identifying early warning signals. These are smaller fluctuations in a system before an abrupt change. The authors say these warning signals exist, but when the entire world is the focus, it can be challenging to trace how small changes in one system can warn of an abrupt change in another.

There is evidence of past warning signals. For example, there were abnormal shifts in the climates of the North Pacific Ocean region and around Greenland before the major melting of Earth's last ice age.

"All the components can change really. really fast," Barton said. "The whole system can drop into a different state... How do we know when we're getting too close?"

The authors leave the reader with this final thought: "As humans, we try to anticipate the future. We are now well aware that complex systems, including the coupled social and ecological systems that now dominate our planet, can undergo abrupt changes.... If we cannot model abrupt change in the past, we cannot hope to predict them in

## People show more leniency towards loved ones when they misbehave

study suggest that when people behave badly or unethically, their loved ones might judge them less harshly compared to a stranger who committed the same transgressions. However, this leniency may come at the cost of own sense of self-worth.

The findings of the study were published in the Journal of Personality and Social Psychology.

"How do we react when our romantic partners, friends or family members behave unethically? Past research tells us a lot about how we respond to a stranger's unethical behaviour, but very little about how we respond when the perpetrator is someone we care deeply about," said lead author Rachel Forbes, MA, a PhD candidate at the University of Toronto.

"When someone close to us behaves unethically, we face a conflict between upholding our moral values and maintaining our relationship. We conducted this research to better understand this conflict," added Rachel.

Researchers conducted a series of four experiments involving more than 1,100 participants. In one experiment, participants read about

he findings of a recent a hypothetical situation in which a romantic partner, a close friend or a stranger committed an unethical or immoral act, such as stealing money from a charity collection jar.

> In another experiment, participants were asked to recall a moment when they had witnessed a romantic partner, close friend or stranger commit an unethical or immoral act. In a third experiment, participants kept a log of moral transgressions they witnessed each day for 15

In each experiment, participants answered a series of questions about the person who commitand how harshly the transgressor should be punished. Participants also answered questions about how they felt about themselves, including any negative emotions they experienced and their own sense of morality

In all three experiments, researchers found participants felt less anger, contempt and disgust toward family and close friends who behaved hadly. They rated them as more moral and wanted to punish or criticize them less than strang-

However, participants also felt more shame, guilt and embarrassment and reported somewhat more negative evaluations of their own morality when someone close to them committed a moral or ethical violation.

In the fourth experiment, participants were physically paired with a romantic partner, a close friend or a relative stranger. They were then taken to separate rooms and asked to respond in writing to a series of questions about themselves. The pairs then swapped answers (via a research assistant) and were told to transcribe them into a book.

In the first round. received genuine answers, but in the second round, participants were given fake responses indicating their partner had behaved unethically, by lying, plagiarizing or acting selfishly.

As in previous experiments, participants then answered a series of questions about their partner, the transgression, how harsh the punishment should be and their feelings about themselves. The results were similar to the first three experiments, but the effect was not

## Longer study breaks lead to more stable activation patterns in brain: Study

Many of us have experienced the following: the day before an exam, we try to cram a huge amount of information into our brain. But just as quickly as we acquired it, the knowledge we have painstakingly gained is gone again.

The good news is that we can counteract this forgetting. With expanded time intervals between individual learning events, we retain the knowledge for a longer time.

But what happens in the brain during the spacing effect, and why is taking breaks so beneficial for our memory? It is generally thought that during learning, are activated and form new connections. In this way, the learned knowledge is stored and can be retrieved by reactivating the

same set of neurons.

However, we still know very little about how pauses positively influence this process- even though the spacing effect was described more than a century ago and occurs in almost all animals.

Annet Glas and Pieter Goltstein, neurobiologists in the team of Mark Hubener and Tobias Bonhoeffer, investigated this phenomenon in mice. To do this, the animals had to remember the position of a hidden chocolate piece in a maze.

On three consecutive opportunities, they were allowed to explore the maze and find their reward - including pauses of varying lengths. "Mice that were trained with the longer intervals between learning phases were not able to remember the position of the chocolate as quickly," explains Annet Glas. "But on the next day, the longer the pauses, the better was the mice's memory."

During the maze test, the researchers additionally measured the activity of neurons in the prefrontal cortex. This brain region is of particular interest for learning processes, as it is known for its role in complex thinking tasks. Accordingly, the scientists showed that inactivation of the prefrontal cortex impaired the mice's performance in the maze.

"If three learning phases follow each other very quickly, we intuitively expected the same neurons to be activated," Pieter Goltstein said. "After all, it is the same experiment with the same information. However, after a long break, it would be conceivable that the brain interprets the following learning phase as a new event and processes it with different neurons.

### Renovate At Least One **LNG Plant In Each Division: Navin To Officers**



**KO NEWS DESK** 

**SRINAGAR:** Principal Secretary Animal and Sheep Husbandry & Fisheries departments, Navin Kumar Choudhary on Monday directed the officers to renovate and upgrade at least one Liquified Nitrogen Gas (LNG) plant in both the divisions of the J&K to enhance local production here. These directions were given by him in the 32ndState Implementation Agency (SIA) meeting of the Livestock Board of Jammu and Kashmir.

The meeting was attended by Directors of Animal Husbandry of both the divisions, Dean Faculty of Veterinary Sciences, SKUAST Kashmir and Jammu, CEOs of Livestock Development Boards of both the divisions and many other officers of the department. Jammu based officers participated in the meeting through video conferencing.

The Principal Secretary asked the officers to at least reserve 10% LNG at each station for meeting out any eventuality. He also directed for constitution of a committee with members from the Agricultural Universities to study the demand and production of LNG here besides the scope of the possibility of renovation of old LNG plants here.

Navin further asked the officers to look for the possibility of introduction of 'sexed semen' for insemination so that people do not have to go to far off places for the same. He instructed that the service should be made available by the department on cost to cost basis only. He urged them to make the Pashudhan Melas a regular feature in which both buyers and sellers are aided in doing the business by the

department. The Principal Secretary asked the SKUAST administration to reorient their research programmes in consonance with the requirements of the department so that a firm policy is made on the authentic data provided by these universities. He asked the

HODs to provide research requirements of the department at the onset of the academic year to the Agricultural Universities so that the relevant data is received at an appropriate time. He advised them to conduct joint meetings regularly for ironing out the issues and meeting each others demands.

The meeting decided to carryout research projects to determine the success of new cow varieties introduced here.It was also said that the viability and economic position of big dairy farms established during the past 5 years should also be studied for the better planning and policy making for future.

The universities were also asked to introduce the short term certificate courses of the duration of 5-6 weeks on the analogy of different national institutions to provide specialization to the seekers. They were encouraged to send the students for field surveys during vacations besides introducing mandatory field training for the completion of the

The meeting was informed that artificial insemination helps in increasing the milk production vertically and department is performing the same without charging the farmers. It was given out that more than 8.5 lakh artificial inseminations(AIs) have been done in the previous year and this year an aspirational target of 13 lakh AIs has been set for the department.

The meeting was apprised that there are several CSS in progress here which would help department to achieve the target. These include Rashtriya Gokul Mission (RGM), Nation wide AI Program (NAIP), Krishi Kalyan Abhiyan (KKA), and National Mission on Bovine Productivity (NMBP). All of the schemes focus on upgrading and strengthening the bovine breeding infrastructure here and bring services to the doorsteps of farmers free of cost, as was

informed in the meeting.

## **New ATM Rules** Take Effect; Interchange Fee Increased By Rs 2



The Reserve Bank of India's new directions on raising interchange fee and making available the facility of bulk clearing round the clock have become effective from Sunday onwards.

The RBI in June raised the interchange fee for financial transactions from Rs 15 to Rs 17, while for non-financial transactions the increase was done from Rs 5 to Rs 6. These new rates have become applicable from August 1, 2021, as per the RBI's direction.

An interchange fee is a fee charged by banks to the merchant who processes a credit card or debit card payment. Besides, National Automated Clearing House (NACH) has been made available on all days of the week, effective August 1, 2021.

NACH, a bulk payment system operated by the National Payments Corporation of India (NPCI) facilitates one-to-many credit transfers such as payment of dividend, interest, salary and

It also facilitates collection of

payments pertaining to electricity, gas, telephone, water, periodic instalments towards loans, investments in mutual funds and insurance premium.

During the bi-monthly monetary policy review in June, RBI Governor Shaktikanta Das had announced that in order to further enhance the convenience of customers, the NACH will be available on all days of the week.

The facility was available only when banks were open, usually between Monday to Friday. Autodebit instructions given by the bank account holder were not processed on days the bank were closed like Sundays, bank holidays and even gazetted holidays. Further, since most companies use NACH for salary credits these also did not happen on bank holi-

Meanwhile, ICICI Bank has revised charges for cash withdrawals from ATMs, cheque books and other financial transactions from August 1. The revised charges will be applicable for domestic savings account holders including salary accounts.

## **K M Birla Offers To Hand** Over Vodafone Idea Stake To Government

NEW DELHI: Aditya Birla group Chairman Kumar Mangalam Birla has offered to hand over his stake in debt-laden Vodafone Idea Ltd (VIL) to the government or any other entity that the government may consider worthy to keep the company operational.

The billionaire businessman made the offer in June in a letter to Cabinet Secretary Rajiv Gauba.

According to official data, VIL had an adjusted gross revenue (AGR) liability of Rs 58,254 crore out of which the company has paid Rs 7,854.37 crore and Rs 50,399.63 crore is outstanding.

VIL along with Bharti Airtel had approached the Supreme Court for correction in the government calculations but their plea was rejected.

In the letter, Birla, who holds around a 27 per cent stake in VIL, said investors are not willing to invest in the company in the absence of clarity on AGR liability, adequate moratorium on spectrum payments and most importantly floor pricing regime above the cost of service.

Without immediate active support from the government on the three issues by July, the financial situation of VIL will come to an "irretrievable point of collapse," Birla said in the letter dated June 7.

"It is with a sense of duty towards the 27 crore Indians connected by VIL, I am more than willing to hand over my stake in the company to any entity- public sector/government /domestic financial entity or any other that the government may consider worthy of keeping the company as a going concern," Birla said in the letter.

There were no immediate comments from either Aditya Birla group or VIL on the issue.

Further, it could not be ascertained whether there were any other communications between Birla and the government after the June 7 letter.

In September 2020, VIL had received approval from its board to raise up to Rs 25,000 crore.

However, the company has not been able to raise the funds so far. According to Birla's letter, VIL has not yet approached any Chinese investors.

Foreign investors, mostly non-Chinese, are hesitating in making investments in the company for understandable reasons, he added.

VIL's gross debt, excluding lease liabilities, stood at Rs 1,80,310 crore as of March 31, 2021.

The amount included deferred spectrum payment obligations of Rs 96,270 crore and debt from banks and financial institutions of Rs 23,080 crore apart from the AGR liability.



## **Fate Of 19 Missing Persons Unknown**

**JAMMU:** Rescuers continued searches at Honzar village in Kishtwar district on Monday but success eluded them in finding any of the 19 persons including eight women who are missing following a cloudburst in the remote village on intervening night of July 27 and 28.

Officials said that Director General of Police Dilbag Singh also had an aerial survey of the Honzar Dachan village. He also chaired a high-level meeting during which, among others, he stressed the need for intensifying the rescue operation to trace the missing persons.

"He directed the officers to provide all necessary support and help to the affected people of the village," a police official said. While seeking reports regarding the loss and damage in the village, the top police officer of J&K emphasized upon the officers that besides, the efforts of administration, involve the local

community members for reha-

bilitation of the affected families. Success has been eluding the search teams after seven bodies were recovered and seventeen persons rescued in injured condition after the calamity on Wednesday last.

The stakeholders, including the governments of Gilgit-Baltistan and Pakistan-controlled Kashmir, had been consulted on the proposed constitutional amendment, the report quoted sources as saying.

The proposed law suggests that due to sensitivity attached to the region, it could be given provisional provincial status by amending Article 1 of the Constitution that related to the provinces and territories, the sources said.

They added that a set of amendments would be introduced to give the region representation in Parliament, besides the establishment of the provincial assembly in the territory.

The sources are confident that the constitutional amendment is in accordance with the international practice of merger of territories and it will not adversely affect the Kashmir cause in any manner, the report said.

The Pakistan government and the Opposition had reportedly discussed the move prior to last year's meeting of the political leadership with the Pakistan Army chief.

According to an Opposition leader, Gilgit-Baltistan has acquired great significance in the region due to the China-Pakistan Economic Corridor (CPEC) that is now a jugular vein for

The CPEC, which connects Gwadar Port in Pakistan's Balochistan with China's Xinjiang province, is the flagship project of Beijing's ambitious multi-billion-dollar Belt and Road Initiative (BRI).

India has protested to China over the CPEC as it is being laid through Pakistan-controlled Kashmir.

The talkers inside the teashop are expressing anguish over the "fatal consequences", making Mir melancholic over "unchecked slips" into Sindh.

"The meditative calm of this place is being shattered by these repeated drowning incidents," Mir, sipping his third teacup, says. "This has to stop for good."

Mir refers to the recent incident wherein three boys were caught in the furious waves of the swelled Sindh. The timely dive of one daredevil did save the situation but once again raised the safety concerns.

"Such incidents are unlikely to stop," Mir continues. "But that doesn't mean the government should stay quiet about it. If a treacherous Maharaja before 1947 would depute water police to check any violation or mishap in rivers, why can't present day administration post water guards in Sindh to avert these incidents?"

This demand is now gaining traction in Ganderbal as locals believe such unchecked incidents are likely to give a bad name to the captivating canal in the long run.

On June 23, 2021, Mohammad Salim Khan of Srinagar drowned in Sindh. The teenager drowned in the Kangan area, where such incidents aren't uncommon-especially in the canal tied with the Upper Sindh Hydroelectric Project (USHP), one of three government projects set up on Sindh in 2001.

"This power canal has devoured many lives due to its immense depth," says Abdul Samad, a Kangan resident. "It originates from Sumbal USHP-I, and passes through Kulan areas but the drowning prone area is USHP-II.'

Since 2018, the canal has devoured five teenagers—between the age of 14 and 19. In August 2018, Nadeem Mir, 14, drowned

market or when a video of the dead body of four-year-old girl who was mauled to death by leopard went viral on social media. So we filed this PIL to regulate them," Advocate Nazir told Kashmir Observer.

Adding that they have appealed to the competent authorities to make them accountable "like they do with registered newspapers".

It was alleged that in the region, several such news portals like Kashmir News, Kashmir Voice, Kashmir Breaking News, News Kashmir 24/7, Kashmir Business Hub and Bol Kashmir etc are operating freely without any registration or license from any authority and these news portals are not under supervision and control of any authority whatsoever.

The petitioner organization stated that on one hand people across the valley have been severely disturbed by the pandemic while on the other hand, fake journalists running Facebook, Whatsapp and Twitter pages have become a new virus that has spread everywhere in Kashmir.

"The human dignity is at the cost because of these portals. So we want the Govt to regulate them. We aren't against any Facebook page,"

Syed Nasarullah Shah, Chairman of the NGO told Kashmir Observer.

It was submitted that the pseudo journalists are carrying mics and mobile phones in their hands and harassing the employees whether government or private.

'Some people walk around government offices carrying mobile phones, mics in their hands and keep asking various nonsensical questions to the officials of various govern-

ment offices," petitioner says. It was submitted that there are multiple news agencies and whatsapp / facebook/ YouTube news channels and other electronic news agencies operating in both the regions which are actively engaged in the transmission of various types of news bulletins and reports. It is also known fact that every person with a hanging camera and holding a mic poses himself as a journalist irrespective of the fact

whether s/he is authorized and The PIL noted, that in the absence of any permission having been granted by the competent authority for running a news portal it is sufficient to infer that there is no proper, legal and regulatory mechanism in place at present with the result a state of confusion prevails on the subject as to the genuineness of any news transmitted by such channels/ portals.

"The Facebook and WhatsApp journalists have now moved a step ahead by blackmailing the government as well as private officials, civil contractors etc. on a daily basis. Such pseudojournalists not only reveal the names of juvenile offenders/victims but in one instance they revealed the names of some girls allegedly caught as a part of sex racket in Srinagar," the PIL noted.

The petitioner noted that, last year some persons holding camera and a mike publically humiliated a person posing himself a doctor in North Kashmir's Kupwara and the accused person and virtually made him to take a round in the market, thus disrespected and humiliating him while ignoring all norms of human dignity and respect.

"The episode became a subject matter of debate on social media for several days engaging the attention of the public at large with serious condemnation," the PIL noted.

It was pointed out that real professional journalists from major newspapers, news channels and news agencies follow a strict code of ethics but fake journalist bunkers continue to harass officials to create viral videos and sensational

It was further submitted that such steps also tend to tarnish the image of real journalists and media persons and therefore such vagrants need to be discouraged.

## Virat Kohli Says For India It's **Just Pursuit Of Excellence**

LONDON: India captain Virat Kohli on Monday said it takes "relentless madness" and single-minded pursuit of excellence to win a Test series in England.

Led by Kohli, India will take on Joe Root's England in a gruelling five-match Test series, beginning here from Wednesday.

"I will answer your second question first, it takes relentless madness and pursuit of excellence every day over a five-Test series, to tell yourself I want to do the hard work and I want to get into situations, which are tough in every Test match on every day.

"And you are going to be ready for that kind of workload, and that kind of mental load," Kohli told 'Sky Sports' when asked by former India wicketkeeper Dinesh Karthik on what it takes to win a Test series in England.

For Kohli personally, winning in England is nothing more than winning anywhere else and it is all about the team culture of going for a win.

"To answer your first question, for

me personally, it means nothing more than winning a Test match or a Test series anywhere else in the world.

"As I said, for me, these things are not anecdotes in my career or milestones in my career.

"We step on the field and we compete and we are looking to win every Test match, that is what matters more to me, because again that is a culture, these are results," added Kohli, one of the finest batsmen of

the modern era. "For Indian cricket it will be a huge thing and we have done it before and we can do it again, but this culture is what is more dear to me and I will do everything in my ability, even if you lose a Test match.

"I want us to go for the win and not surrender and try to save a test match on day three or day four, that for me is just not acceptable.

"So, for me as I said, milestones don't matter at all. If I had played for milestones in my career, I probably would not have half of what I have right now. My mindset is pretty clear and for us it is just pursuit of excellence," he signed off.

# ICC Responds To BCCI Request To Not Recognise Kashmir Premier League

KARACHI: The International Cricket Council (ICC) on Monday responded to a Board of Control for Cricket in India (BCCI) plea regarding Pakistan Cricket Board (PCB) organised first edition Kashmir Premier

The ICC issued the statement after reports suggested that BCCI has urged ICC not to recognise the Kashmir Premier League, set to commence in Muzaffarabad from August 6.

An ICC spokesperson told Geo News, 'The tournament is not under ICC's jurisdiction as it is not an international cricket tournament.'

ICC regulation for the sanctioning of an

event, clause 2.1.3, states that each national cricket federation shall have the sole and exclusive right to sanction the staging of domestic matches within its territory.

The ICC can interfere only, according to clause 2.1.4, if matches are to be held in the territory of an associate member's

According to a report by a Cricinfo, the letter sent by BCCI had its basis in the "disputed status" of the region. A number of former cricketers like Herschelle Gibbs, Tillekerate Dilshan are due to take part in the competition.

Former England spinner, Monty Panesar however on Monday pulled out of the tournament. He took to Twitter to reveal

"I have decided not to participate in the KPL because of the political tensions between India and Pakistan over kashmir issues. I don't want to be in the middle of this. it would make me feel uncomfortable.

The final of the tournament is set to be played on August 16. The PCB has maintained that KPL will serve as a launching pad for budding cricketers on the other side of Kashmir.

Meanwhile, former Pakistan pacer Shoaib Akhtar has announced his decision to become a "peace ambassador" for the controversial six-team tournament.

"Why such a fuss between [Kashmir Premier League] & BCCI. It's about building bridges and promoting peace," he said.

While facing Siraj, possibly the fastest bowler in the current Indian line-up, Agarwal saw the ball thudding into his helmet when he took his eyes off a short delivery. The first Test starts here on Wednesday.

"Opening batsman Mayank Agarwal was hit on the helmet while batting during India's nets session at Trent Bridge in Nottingham on Monday," BCCI secretary Jay Shah was quoted as saying in a media release.

"The BCCI Medical Team assessed him, and a concussion test was conducted. He has shown signs of concussion and is ruled out of the opening Test against England. The 30-year-old is stable and will remain under close medical observation," Shah further stated.

When vice-captain Ajinkya Rahane was asked about the fitness of all players, he did say that Agarwal sustained a head injury.

"Mayank Agarwal got hit on the head. The medical team is looking after him. All others are fit," Rahane told mediapersons.

After being hit by Siraj's delivery, Agarwal was seen in some discomfort as he removed the helmet and sat on the ground with physio Nitin Patel attending to him.

He was then seen pressing the back of his head while leaving the nets, escorted by Patel.

KL Rahul, who has mostly opened in Test matches but prefers a middle-order slot these days, could be asked to face the new ball first up in the absence of Agarwal.

The other option is Bengal opener Abhimanyu A left field selection could be Hanuma Vihari,

opening the innings, like he did in Australia.

In case Vihari opens and bowls his off-spin, seamer all-rounder Shardul Thakur could also be considered for selection.

1.500-meter heat. Amazingly, she ended up winning the

Hassan tried, but failed, to hurdle over Kenya's Edinah Jebitok, who tumbled just in front of her as runners jostled for position at the start of the final lap.

Hassan also went crashing down but rolled, quickly got back to her feet and set about chasing down the pack in an astonishing comeback.

Staring at a shock elimination, the Dutch runner sped past a couple of runners down the back straight, had reached the leading pack by the last bend, and won from Australia's Jessica Hull and American Elinor Purrier St. Pierre after powering down the home straight.

Hassan finished in 4 minutes, 5.17 seconds to qualify for the semifinals,



although she nearly paid dearly for the decision to run at the back of the field in the early stages of the race and wait for the bell to make her move. She was third-from-last at the start of the final lap and just before she fell.

Her recovery kept alive her bid for the treble in Tokvo.

Hassan had already qualified to run in the 5,000-meter final later Monday at the Olympic Stadium, although the energy she expended on that last-lap

scramble in the 1,500 heats might catch up with her when she returns in the evening session to try for her first gold of the Hassan didn't stop to speak to reporters after the 1,500 race as she rushed away to recover and prepare for the

Hassan, who was born in Ethiopia but moved to the Netherlands as a refugee, is expected to battle with two-time world champion Hellen Obiri of Kenya for the 5,000 gold, while there are three Ethiopians also challenging for a medal.

Hassan won a 1,500-10,000-meter double at the world championships in Doha, Oatar in 2019. She has said she will also run in the 10,000 meters at the Olympics. No athlete has won 1,500-, 5,000- and 10,000-meter golds at the

same Olympics. Hassan's grueling schedule means she will have to run six races in eight days in the Tokyo heat and humidity, including those two races on Monday and the 1,500 and 10,000 finals on back-to-back days on Friday and Saturday.

### Pak "Watchful" As India **Assumes UN Security Council Presidency For August**



**Islamabad:** As India assumed the rotating presidency of the United Nations Security Council (UNSC) for the month of August, Pakistan's envoy to the UN Munir Akram said they will be "watchful" during New Delhi's spell at the forum.

India on Sunday assumed the rotating presidency of the UNSC and is set to host signature events related to various issues on its agenda during August. During its presidency, India will be focusing on maritime security, peacekeeping, and counterterrorism.

Given India's monthly spell at UNSC, Pakistan's Ambassador to the UN Munir Akram was quoted as saying by The Express Tribune that, "We (Pakistan) will be watchful, but not concerned."

Back in June, India had said it desires "normal neighbourly relations" with Pakistan and the onus is on Islamabad to create a conducive atmosphere by taking "credible, verifiable" action to not allow any territory under its control to be used for cross terrorism.

During a debate on the annual report of the UNSC, India said that issues between the two countries should be resolved bilaterally. However, New Delhi also slammed Pakistan for raising the matters of Kashmir which is internal to India, during the debate.

Delivering India's statement on the report, R Madhu Sudan, Counselor at Permanent Mission of India to the UN, said Pakistan continued to indulge in threatrics not "befitting the dignity of this august Forum."

India's remarks came after Pakistan Ambassador to the UN raised the issue of Kashmir in the assembly during the debate.

India took over the presidency from France. Ambassador of India to the United Nations, TS Tirumurti thanked France Permanent Representative to the UN, Nicolas de Riviere, for steering the UN Security Council for the month

This is India's first presidency in the UNSC during its 2021-22 tenure as a non-permanent member of the UNSC. The two-year tenure of India as a non-permanent member of the UNSC began on January 1, 2021.

India will also be organizing a solemn event in memory of peacekeepers. Tirumurti apprised that the UN Security Council will also have on its agenda several important meetings including Syria, Iraq, Somalia, Yemen, and the Middle East.

UN Security Council will also be adopting important resolutions on Somalia, Mali, and UN Interim Force in Lebanon, he added.

## **24 Universities Declared Fake, Most From UP: Education Minister**

**NEW DELHI:** The University Grants Commission (UGC) has declared 24 "self-styled" institutes fake and found two more in violation of norms, Union Education Minister Dharmendra Pradhan said on Monday.

Mr Pradhan made the statement in response to a written question in Lok Sabha.

"Based on the complaints received from the students, parents, general public and also through electronic print media, UGC has declared 24 self styled institutes as fake universities.

"Besides, two more institutes namely Bhartiya Shiksha Parishad, Lucknow, UP and Indian Institute of Planning and Management (IIPM), Qutub Enclave, New Delhi are also found functioning in violation of the UGC Act, 1956. The matters of Bhartiya Shiksha Parishad, Lucknow and IIPM, New Delhi are sub-judice in the court," he added

Uttar Pradesh has the highest eight such fake universities -- Varanaseya Sanskrit Vishwavidyalaya, Varanasi: Mahila Gram Vidyapith. Allahabad; Gandhi Hindi Vidyapith, Allahabad; National University of Electro Complex Homeopathy, Kanpur; Netaji Subhash Chandra Bose Open University, Aligarh; Uttar Pradesh Vishwavidyalaya, Mathura; Maharana Pratap Shiksha Niketan Vishwavidyalaya, Pratapgarh and Indraprastha Shiksha Parishad, Noida.

Delhi has seven such fake universities - Commercial University Ltd, United Nations University, Vocational University, ADR Centric Juridicial University, Indian Institution of Science and Engineering, Vishwakarma Open University for Self Employment and Adhyatmik Vish-

### **MP Govt Acts Against Online Game Firm After Teen Ends** Life On Losing Rs 40k

**BHOPAL:** The Madhya Pradesh government has filed a police case against the developers of an online game after a 13-year-old boy killed himself in Chhatarpur district last week over the monetary loss, state home minister Narottam Mishra said on Monday.

The teen boy, a Class VI student who ended his life last Friday, had left behind a suicide note in which he stated that he was taking this extreme step after losing Rs 40,000 in an online game called 'Free Fire', police had said.

"A sad incident took place over the Free Fire game in Chhatarpur. An FIR has been registered against the company which developed this game. Superintendents of police across the state have been directed to take action against the developers of such addictive games, which are disorientating the young generation and playing with their lives. We have sought the state Law department's opinion to initiate legal action against such companies," Mishra told re-

Rajesh Banjare, in charge of Civil Lines police station in Chhatarpur, said on Monday that an FIR under section 305 (abetment of suicide of child) of the Indian Penal Code has been registered against the company that developed 'Free Fire' and the help of the cyber cell was being taken to zero in on monetary transactions in the case.

The child who ended his life, in his suicide note, had sought forgiveness from his mother for withdrawing Rs 40,000 from her UPI account and losing it in 'Free Fire' sessions, police had said.

Incidentally, a 12-year-old boy had ended his life in Dhana in the Sagar district in January after his father took away his mobile phone over the former's addiction to the 'Free Fire' game.

Free Fire is a shooter survival game based on the 'last man standing' concept in which players have to search for weapons to eliminate other participants. PTI

#### A Dog Is Made Ferocious By Circumstances & Stray Ones Aren't Dangerous By Nature: Kerala HC

KOCHI: A dog is made ferocious by the circumstances and it is a myth that a stray canine is dangerous by nature, the Kerala High Court said on Monday while dealing with the issue of poisoning of street dogs in Thrikkakkara municipality area of Ernakulam district. A bench of Justices A K Jayasankaran Nambiar and P Gopinath said killing or maiming the street dogs was not the way to make people safer and the better option was to capture the canines and rehabilitate them at animal shelters.

It also said, "This kind of dog catching using hammers cannot be done."

The court said a balance has to be maintained between the interests of the residents of the area who feel threatened by the street dogs and the welfare of the animals. It was also skeptical with regard to the municipality's claims that one of its junior health inspectors paid for the poisoning of the canines from his own pocket.

The court directed the municipality to identify in its area any animal shelters run by private organisations who would be able to capture the street dogs and shelter them in their premises.

It issued the direction while observing that it understands that presently the municipality would not be able to spend funds for setting up such shelters. The Kerala government was asked to give details of the animal shelters - run by the state and private ones — in all the districts. With these directions the court listed the matter for hearing on August 6.

The court had taken up the issue of the poisoning of the dogs after a video on the same was brought to its attention.

While seeking the stand of the municipality over its role in the entire matter, the bench had also directed the civic body to ensure no such incident takes place within its territorial limits in future and to put in place suitable machinery to ensure the same. On Monday, the municipality told the court that it had no role in the matter.

Last week, the junior health inspector - arrayed as an accused in the case with regard to killing of the canines - moved the High Court, seeking anticipatory bail and claimed that he was being falsely implicated in the case to divert the probe from the Chairperson and Secretary of the municipality and the chairperson of its standing committee on health.

He alleged in his plea that the Chairperson and Secretary of the municipality and the chairperson of its standing committee on health were the ones who allegedly hired the gang which had killed the street dogs.
