KATHUA: An Army helicopter crashed into the Ranjit Sagar Dam lake in Jammu and Kashmir's Kathua on Tuesday, prompting the authorities to launch a massive search operation to trace the missing, an official said.

The dam is located about 30 km from Pathankot in Punjab and the incident took place around 10.30 pm.

Kathua Senior Superintendent of Police (SSP) R C Kotwal told reporters that the forces and boats were mobilised for the search operation, after which some pieces of chopper were found, confirming it to be an Army helicopter.

Srinagar CNS, Aug 3: On the directions of Chief Magistrate Judicial (CJM) Srinagar, Crime Branch (CB) lodged an FIR against the then JK Bank Manager Ashiq Ahmad Malik, Branch Amira Kadal Srinagar for Criminal Breach of Trust and Cheating.

Court added that the investigation of the case will take place under the overall monitoring of the court.

As per order of the court, one customer Bilal namely Ahmad Bhat Proprietor of a firm M/s Marina traders had approached the Court of Chief Judicial Magistrate Srinagar through his Counsel Advocate Tasaduk Hussain Reshi with a written criminal complaint alleging that the then Manager of J&K Bank Branch Amira Kadal Ashiq Ahmad Malik has put an amount of 53.30 Lakhs to his personal use without any lawful authority by allowing huge withdrawals from his personal computer to the fictitious persons through fraud and forgery.

He further alleged that the said Manager in order to deceive the complainant used to grant overdrafts on his own account without any request from the complainant beyond permissible limits thereby causing huge loss to the firm.

Srinagar: Identifying and recognizing the traditional routes of two major Muharram processions in Srinagar by the J&K administration is a good sign. Itihaad-ul-Muslimeen President Maulana Masroor Abbas Ansari said on Tuesday.

Masroor however rejected any conditional permission allowing these processions on 8th Muharram and Ashura in this capital city after a blanket ban for nearly three decades.

"The procession taken out to commemorate martyrdom of Imam Hussain (AS), his family and companions is not bound to any permission. The followers of Imam have been taking out the processions for the last 30 years despite government curbs and clampdowns. And this will continue in future as well,' Masroor said, in a statement issued here on Tuesday.

Whether government allows it or not, the Shia community will not back off from its principled position and will take out the procession with zeal and vigour," he added.

"Diktat of taking out Muharram processions within 'Sarkari Chaar Diwari' is unacceptable", Masroor said adding his party has not only been defying such diktats in the past but also challenged them in the court of law.

He expressed hope that Shia clergy and the mourners would not take out the alternative processions through the bylanes of Zadibal's interiors and would instead reach Guru

He also urged the government to allow prayers at Jamia Masjid and lift ban on Eid-e-Milad-un Nabi processions as they lifted ban on Muharram processions.

Pertinently, Masroor's statement came a day after the govern-

HM Officials Meet HM Commdrs At Nehru Guest House Observer News Service

RINAGAR: For the first time since the onset of insurgency in Jammu and Kashmir 11-year-ago, the centre and Hizbul Mujahideen militants sat across the table and agreed to pursue modalities for pre-existing grounds for restoration of peace in the valley.

Union home secretary Kamal Pande, who headed the central team, said after neatly two hour meeting with Hizb team that these modalities would be pursued seriously so that the elements opposed to this process (of peace) could be identified and isolated.

He also urged members of negotiating committee from both the sides to work in a spirit of cooperation and finalise further modalities for Implementation of the ground rule: The talks, however were so fat centered mainly on working out condition- for enforcing the ceasefire declared by filth and both sides agreed to carry forward their talks.

The Hizb side was led by its nominated mediator Fazal Haq Qureshi and its deputy chief commander and Chief spokesman for Kashmir valley, Masood, Riaz Rasool and Farooq besides Musaddiq Aadil and Ghulam Muhammad Naikoo both close associates of Qureshi.

Pande said the negotiating teams for further talks shortly would be headed by M B Kaushal special secretary in the home ministry and Khalid Saifullah on the Hizb-ul-Mujahideen side.

Pande evaded reply to a question on reported threat by Hizb to call off the cease-fire on August 8, unless India agreed to unconditional bipartite talks involving Pakistan saying we have discussed modalities for restoration of peace in Kashmir with Hizb-ul-Mujahideen. Pande said the centre had a keen desire to take this initiative to its logical conclusion and appealed to the people to ex-tend their support to the peace process.

The centre firmly believed that the problem in of Kashmir could be solved only through peaceful dialogue and not through continued militancy, he said

I congratulate Hizb-ul-Mujahideen leaders on their bold and timely initiative particularly because the people of Kashmir earnestly want peace to be restored in Jammu and Kashmir, he said.

Masood said we are thankful to the government that they responded positively to our offer of cease-fire and added that teams for future talks would consist of six members on each side He also said that his side was serious about the ceasefire and process of restoring peace in the troubled state.

Afghan Army Urges **Civilians To Evacuate Besieged** City

Residents of a besieged Afghan city were urged to evacuate on Tuesday as the army prepared a major offensive against Taliban insurgents after three days of heavy fighting.

The Taliban have seized control of much of rural Afghanistan since foreign forces began the last stage of their withdrawal in early May, but are now focused on capturing provincial capitals, where they are meeting stiffer resistance.

Fighting is raging for Lashkar Gah, the capital of southern Helmand province, with the United Nations saying at least 40 civilians had been killed in the last 24 hours.

General Sami Sadat, commander of the 215 Maiwand Afghan Army Corps, told residents to get out as soon as they could.

"Please leave as soon as possible so that we can start our operation," he said in a message to the city of 200,000 delivered via the media.

"I know it is very difficult for you to leave your houses -- it is hard for us too -- but if you are displaced for a few days please forgive us," he added.

We are fighting the Taliban wherever they are. We will fight them and... we will not leave a single Taliban alive."

Officials said earlier that insurgents had seized more than a dozen local radio and TV stations in the city, leaving only one pro-Taliban channel broadcasting Islamic programming.

"Deepening concern for Afghan civilians... as fighting worsens," the United Nations Assistance Mission for Afghanistan (UNAMA) tweeted.

"UN urges immediate end to fighting in urban areas."

Rooftop chants

"Fighting was intense this morning," said Sefatullah, director of Sukon radio in the city.

He said the US and Afghan air force planes had pounded Taliban positions, adding fighting was ongoing near the city's

headquarters of police and intelligence agencies.

The loss of Lashkar Gah would be a massive strategic and psychological blow for the government, which has pledged to defend cities at all costs after losing much of the rural countryside to the Taliban over the summer.

In Herat, another city under siege, hundreds of residents chanted "Allahu akbar" (God is greatest) from their rooftops after government forces repulsed the latest Taliban assault. Afghan officials said government forces had managed to push back the insurgents from several areas of that city -- including near the airport, which is vital for resupplies. Another official said US warplanes had carried out air strikes,

'War crimes'

Washington and London lashed out at the Taliban, accusing them of committing atrocities that may amount to "war crimes" in the town of Spin Boldak, which the insurgents captured last month along the border with Pakistan.

but that could not be confirmed.

Afghanistan's Independent Human Rights Commission earlier said the insurgents had indulged in revenge killings there, leaving at least 40 people dead.

"The Taliban chased and identified past and present government officials and killed these people who had no combat role in the conflict," the group said. Top US diplomat Antony Blinken also slammed the militant leaders.

An Afghanistan without a democratic, inclusive government would be a "pariah state," he said, adding that the international recognition the group wants will not be possible if it "seeks to take the country by force and commits the kind of atrocities that have been reported." Fighting across the country, meanwhile, has displaced around 80,000 children from the start of June, humanitarian organisation Save the Children said on Tuesday, adding that many schools and hea

Ebrahim Raeisi Becomes Iran's 8th President



Agenceis TEHRAN: Iran's supreme leader of-

ficially endorsed his hard-line protege as the nation's next president on Tuesday, just two days ahead of the inauguration of Ebrahim Raisi at a sensitive time for Iran and the wider Middle East.

"Following the people's choice, I task the wise, indefatigable, experienced and popular Hojatoleslam Ebrahim Raisi as president of the Islamic Republic of Iran," Iran's supreme leader Ayatollah Sayed Ali Khamenei wrote in a decree read

out by his chief of staff. There was heightened security in Tehran for the ceremony with airports closed for two and a half hours, and traffic restrictions in place on the streets near the venue of the ceremony, the capital's Traffic Police announced.

Ex-Judiciary chief Raisi secured sixty percent of the votes cast in the country's 13th presidential election. He replaces moderate president Hassan Rouhani, whose landmark achievement was the 2015 nuclear agreement between Iran and six major powers.

Critics charge the June 18 presidential election was skewed in Raisi's favour as strong rivals were disqualified, but to his loyal supporters he is Iran's best hope for standing up to the West and bringing relief from a deep economic crisis. Raisi is not renowned for great charisma but, as head of the judiciary, has driven a popular campaign to prosecute corrupt officials.

Considered ultraconservative, 60 year old Raisi, portrays himself as a pious figure and corruptionfighting champion of the poor.

Without commenting specifically on the stalled nuclear negotiations in Vienna, Raisi stressed in his speech he would "pursue the removal of oppressive sanctions" in order to salvage the crippled economy.

"We will not (tie) the people's dining tables and the economy to

the will of the foreigners," he said. Raisi won a landslide victory in the June election, which saw the lowest in the Islamic Republic's history. He will take the oath of office in an inauguration ceremony Thursday before parliament.

Raeisi will take an oath of office in an inauguration ceremony at the Iranian Parliament (Majlis) on Thursday. Nezamoddin Mousavi, the spokesman for the Parliament's presidium, said Monday that a long list of foreign dignitaries are expected to attend the event despite the COVID-19 pandemic

He said 115 officials from 73 countries have already declared their readiness to attend the inauguration ceremony.

The list includes 10 heads of state, 20 parliament speakers, 11 foreign ministers and 10 ministers, as well as special envoys, deputy parliament speakers and chairmen of parliamentary commissions and parliamentary delegations, the lawmaker said.

UAE Lifts Ban On Transit Flights, Including From **India And Pakistan**

DUBAI: The United Arab Emirates will on Thursday lift a ban on transit flights, including from India and Pakistan, the National Emergency and Crisis Management Authority (NCEMA) said on Tuesday.

India and Pakistan are important markets for Emirates, Etihad Airways and other UAE carriers flydubai and Air Arabia. The Gulf state, a major inter-

national travel hub, had banned passengers from many South Asian and African states travelling through its airports this year because of the coronavirus pandemic. NCEMA said on Twitter that passengers travelling from countries where flights had been banned would be able to transit through its airports from August 5 as long as they present a nega-

tive PCR coronavirus test taken 72 hours prior to departure. Final destination approval would also have to be provided, the authority said, adding that UAE departure airports would arrange separate lounges for transiting passengers.

The transit ban had also included Nepal, Sri Lanka, Uganda and Nigeria.

Dubai state carrier Emirates welcomed the government's decision to allow travel to resume from the affected countries.

There was no immediate comment from other UAE airlines on the announcement, which also eased an entry ban on residents returning from countries where flights had been suspended.

NCEMA said a ban on entry to the UAE for passengers from these countries would also be lifted for those with valid residencies and who are certified by Emirati authorities as fully vaccinated.

However, they would need to apply for online entry permits prior to travelling and would need to present a negative PCR test taken 48 hours prior to departure.

Those working in the medical, educational or government sectors in the Gulf Arab state as well as those studying or completing medical treatment in the UAE would be exempt from the vaccination requirement as would humanitarian cases. Reuters

Turkey Battles Wildfires For 6th Day, 10,000 Are Evacuated

BOZALAN (TURKEY): Selcuk Sanli set his two cows loose, put his family's most treasured belongings in a car and fled his home as a wildfire approached his village near Turkey's beach resort of Bodrum, one of thousands fleeing flames that have coated the skies with a thick vellow haze.

For the sixth straight day, Turkish firefighters battled Monday to control the blazes that are tearing through forests near Turkey's beach destinations. Fed by strong winds and scorching temperatures, the fires that began Wednesday have left eight people dead. Residents and tourists have fled vacation resorts in flotillas of small boats or convoys of cars and

Firetrucks, with their sirens on, drove toward Bozalan, while villagers were seen herding cows away from the area.

On Sunday, residents were forced to evacuate the nearby village of Cokertme as flames neared. Some got on small boats and others left by cars as the fire got closer and closer – scenes that Ahmet Aras, the mayor of the nearby resort of Bodrum, described as "hell." Precautions were taken to protect two nearby thermal power plants.

An evacuation order was also issued for the town of Turunc, near the seaside resort of Marmaris in Mugla province. People carrying suitcases fled on small boats.

Tourism Minister Mehmet Ersoy said Monday that some tourists were able to return to their hotels after the threat dissipated. The EU said it helped mobilize firefighting planes from Croatia and Spain to help Turkey. Planes from Ukraine, Russia, Azerbaijan and Iran have also been fighting the blazes. Spain said it was sending two water-dumping aircraft

Japan Government Starts **To 'Name And Shame' Quarantine Rule-Breakers**

apan has carried out a threat to publicly shame people not complying with coronavirus border control measures, releasing the names of three people who broke quarantine rules after returning from overseas.

The Japanese Health Ministry said late on Monday the three Japanese nationals named had clearly acted to avoid contact with authorities after recently returning from abroad.

The announcement, the first of its kind, sparked a flurry of speculation among Twitter users about the details of those identified, such as their jobs and locations.

Japan is asking all travellers from overseas, including its own citizens, to self-quarantine for two weeks. during which they are asked to use a location-tracking smartphone app and report on their health condition.

Iran Shahr-e-Kord

On March 10, the Iranian ship Shahr-e-Kord, owned by the Islamic Republic of Iran Shipping Lines group (IRISL), is en route from Iran to Europe when its hull is hit with "an explosive device".

In a March 11 report citing US and Middle East officials, the Wall Street Journal says Israel has targeted with mines at least a dozen vessels bound for Syria and mostly carrying Iranian oil since late 2019.

Tehran is "considering all options" in response, the foreign ministry says on March 15. "Given the location of the sabotage, there is every reason to think that the occupying regime in Jerusalem is behind this operation," it says.

IN FOCUS Study: Nearly 5 Million Fewer Girls To Be Born Worldwide Over Next 10 Years

An estimated 4.7 million fewer girls are expected to be born globally in the next 10 years because of sex-selective practices in countries with a cultural preference for male offspring, a trend that could undermine social cohesion in the long term, research showed on Tuesday

e research suggested that the projected shortfall in the number of girls being born will lead to a surplus of young men in around a third of the global population by 2030, which could lead to increased anti-social behaviour and violence.

Sex-selective abortions have been on the rise for the past 40 years in countries throughout southeast Europe along with south and east Asia. with as-vet undetermined demographic impacts.

To model what short- and longterm effect sex selection will have on societies, an international team of researchers analysed data from more than three billion births over



the last 50 years.

Focusing on 12 countries where the male-to-female ratio had increased since 1970 and another 17 where that ratio was at risk of increasing due to social or cultural trends, they simulated two scenarios.

The first assumed an increase in the rate of sex selection, based on

statistical evidence. The second scenario assumed increased sex selection in certain countries, based on observed trends and decreased fertility,

but for which specific data were

lacking.

In scenario 1, countries saw a shortfall of 4.7 million in the number of girls being born by 2030. For scenario 2, the figure jumped to more than 22 million globally by 2100.

Authors of the research, pub-

lished in the BMJ medical journal, said the bias towards male offspring could lead to a "marriage squeeze" in affected countries.

'Fewer-than-expected females in a population could result in elevated levels of anti-social behaviour and violence, and may ultimately affect long-term stability and social sustainable development," they wrote.

The United Nations defines sexselective practices alongside child marriage and female genital mutilation as harmful practices targeted under the Millennium Development Goals.

The authors of the new study called for better data collection of such practices in order to stamp them out, as well as wider education initiatives.

"A broader objective relates to the need to influence gender norms which lie at the core of harmful practices such as prenatal sex selection," they wrote.

"This calls for broader legal frameworks to ensure gender equality."

"Property is an important part of life but life itself comes first," he said as he prepared to leave once again.

Agriculture and Forestry Minister Bekir Pakdemirli said on Twitter that crews were still tackling nine fires in the coastal provinces of Antalya and Mugla that are popular tourist areas. Other active fires were in the provinces of Isparta, Denizli, Izmir and Adana.

'We are going through days when the heat is above 40 Celsius (104 Fahrenheit), where the winds are strong and humidity is extremely low," Pakdemirli said. 'We are struggling under such difficult conditions." In Bozalan, Esra Sanli sobbed as she pointed at a fire raging near the village.

'There's no plane, there's no helicopter, there's no roads. How is this going to be extinguished? How?" she said.

Line under control

he number of ceasefire violations and incidents of cross border firing in Jammu and Kashmir until June 2021 stands at 664, the ministry of home affairs (MHA) told Lok Sabha on Tuesday. In January 280 such incidents were reported as opposed to the 278 in February. The month of March witnessed no incident at all. The months of April, May and June reported 1, 3 and 2 incidents, the MHA also said.

In comparison, in 2020, 5,133 such incidents were reported, while in the year 2019 it was 3,479. The year 2018 witnessed 2,140 such incidents.

The drastic drop in ceasefire violations was made possible the ceasefire agreement that was dramatically signed by the militaries of the two countries in February. The move came reportedly following an extended back channel dialogue between the two countries.

Ever since there have been more efforts to improve the relations. Over five months into ceasefire along Line of Control, there is already ample evidence of life returning to normal among border dwellers. There have been many reports about the marriage celebrations in border areas. Similarly, there have been similar reports from across the line of control.

There are, however, still apprehensions among the people that the things might go still back to square one. More so among the people living alongside the LoC. There is already an example of what happened to original ceasefire agreement between the two nations which was signed in November 2003. However, by 2010, the agreement had lost its relevance due to frequent ceasefire violations that touched an all-time high in 2020 with over 5,000 incidents of firing and shelling being recorded.

A halt to the frequent firing exchanges will make a redeeming difference to the lives of lakhs of border residents on both sides of the Line of Control. But it won't change anything as far as the situation in the Valley where militancy continues to reign supreme.

The issue of militancy can be addressed if India and Pakistan go back to dialogue. Talks could go a long way to reduce the tension between the neighbours. The calm borders had become an important factor in the normalization of the relations between the neighbours, enabling them to start one of the most promising dialogue processes through 2003-2007 which by accounts of the top leaders of the two countries who were at the helm of it was close to a breakthrough on Kashmir. We need a similar engagement between the two neighbours.

trol of Pollution) Act 1974 and Section 6 of the Air (Prevention and Control of Pollution) Act 1981. As per the guidelines, 14 members were appointed as members of newly constituted committee but ironically not even a single member belongs to Kashmir valley.

For a few days, NGOs and activists criticized this undemocratic move of the Govt but that had no effect on the Government. Mr Suresh Chugh, the Chairperson of J&K Pollution Control Board (now called PCC) told me that he had no role in the constitution of J&K Pollution Control Committee (PCC). The member secretary of PCC Mr B M Sharma also showed reluctance. I was told that the proposal went from the civil secretariat to the Central Pollution Control Board (CPCB) but how can that be?

Through a gazette notifica-tion dated 25th March 2021, the Central Pollution Control Board (CPCB) constituted a 14 member committee in J&K which includes a Chairperson and Member Secretary who are the senior Govt officers from India Forest Service.

The Central Pollution Control Board (CPCB) has been empowered to perform the functions of the State Pollution Control Board for all Union Territories (UTs) across India. There must be a division of scientific work in the J & K Pollution Control Committee (PCC). We need well equipped labs in PCC as the same were not set up for the last 34 years since SPCB was constituted. The Srinagar water lab of PCC is not well equipped to do indepth water analysis. Some minor

The World is Burning

aw a record number of natural disasemail dm ; wildfires and hurricanes which cost Inbox nomy billions of dollars in damages. Half-way into the year 2021, and it seems that almost half of the world is on fire. With what started out as wildfires in parts of the US and Canada, as temperatures soared record highs, numerous cities across the world are now alight. Since Wednesday, Turkey alone has seen 98 wildfires in its different parts, and has not been able to control 10 of them. The most serious ones have struck along the Turkish Mediterranean coast, where high temperatures and gusty winds have set forests and resort areas around Antalya and Manavgat alight.

Meanwhile, the regional countries of Greece and Lebanon have not been immune from this phenomenon either, with a pine fire in a forest across Athens damaging over a dozen homes. The global phenomenon of high and dry temperatures causing arbitrary wildfires suggests that this is likely due to climate change. Despite this, Turkish authorities have suggested that arson attacks by PKK could be behind the simultaneous fires in four locations and have launched a probe into the matter. Given that the same is being experienced by different parts of the world, the theory seems more of a diversion by the government.

In the past few months, Turkish civil society has been raising its voice against the pollution of the Marmara Sea, which has resulted in a decline in marine life and visible foaming of the sea due to industrial waste. The disregard for the environment in exchange for maximum industrial production is not new in the developing world. Lax environmental laws often allow corporations to conduct business while irreversibly damaging the country's environment and ecosystem. Climate change and global warming are very much real and the frequent occurrence of global wildfires is proof of that. It is time that countries looked to protect their environments, individually and in multilateral corporations, rather than finding scapegoats.

he Design Innovation Centre is one of the prestigious projects of the Central University of Kashmir. It was established in the year 2018 under the National Initiative of Design Innovation of MHRD, GoI with the appointment of Prof. N A Nadeem, a noted academician as its first Project Director. The DIC at Central University of Kashmir follows the Hub & Spoke model with 09 spokes established across the Kashmir valley. These

Spoke Centre's offers One-year Diploma Courses.

Ironically, the varsity has shifted all the spoke centres from these degree colleges to Green Campus of Central University of Kashmir without providing any notice to the spoke centres. This has directly affected the students of other districts of Union Territory of J&K and Ladakh. However, it was decided with the Ministry of Education before getting this project that the university will open

the spoke centres at various districts and will bridge the gap to provide an opportunity to the students.

Additionally, there are 11 ongoing 06 month Research Projects in different specializations/trades at DIC CUK. Among which 04 are senior research fellows and 07 are junior research fellows. These research fellows were admitted in the month of December 2018 but till now their research projects and prototypes were not evaluated. The university is supposed to draft/make some prototypes to submit the same with the Ministry of Education but the university failed to do the same. From the last three years no patents were filed.

The university in its first phase received 1.5 crore rupees in 2018 and then 1 crore rupees in 2021 for various research based innovative products which is the actual theme of Design Innovation Centre.

The Worrisome Chinese Space Programme

China's "Space Silk Road", forms a very crucial part of its ambitious space goals. The commissions' report further states that China has already succeeded in undercutting some US and other foreign launch and satellite providers in the international market, threatening to hollow out these countries' space industrial bases ost countries around the world whether big or small, developed or developing pursue a space programme of their own or in collaboration with advanced countries. Most aspects of these programmes are in the public domain and are targeted towards scientific and human advancement.

The spectre of a space was between US and Russia came to an end with signing of the START Treaty in 1991 between the two. However, China has emerged as a country, which pursues a very secretive space programme and may force the mankind in a space war and global dominance.

There is enough evidence to prove that China's space programme is targeted to move ahead and use space to dominate not only the US but also the rest of the planet. In terms of the US national security, and for the rest of the world also, China's space capabilities have been defined as one of the most significant future threats to the global peace.

China's plans were outlined very clearly when shortly after becoming president in March 2013, Xi Jinping made his ambitions for China's space power very clear. "Developing the space program and turning the country into a space power is the space dream that we have continuously pursued", he said. "The space dream is part of the dream to make China stronger."

China's aim is to become the world's leading space power by 2045. China Daily had editorialised in 2017 that "China will become an all-round worldleading country in space equipment and technology. By 2045, it will be able to carry out man-computer coordinated space exploration on a large scale."

US concerns

The advances and secret dimension of the Chinese space programme have been duly noted and concerns have been raised by the United States in this regard. The US-China Economic and Security Review Commission in its 2019 Annual Report to Congress stated that "China is taking steps to establish a commanding position in the commercial launch and satellite sectors relying in part on aggressive state-backed financing that western market-driven companies cannot match."

The US Defence Secretary Lloyd J. Austin III, in his written testimony prior to his confirmation hearing in January 2021 declared that Chinese and Russian space activities present serious and growing threats to US national security interests. Chinese and Russian military doctrines also indicate that they view space as critical to modern warfare and consider the use of counter-space capabilities as

both a means of reducing U.S. military effectiveness and for winning future wars.

A Pentagon report in 2020 stated that the PRC continues to strengthen its military space capabilities, despite its public stance against the weaponisation of space.... the PRC is developing electronic warfare capabilities such as satellite jammers.... and China probably intends to pursue additional antisatellite weapons capable of destroying satellites.

Chinese Space Programme

A significant aspect of China's space initiative is the Beidou Navigation Satellite system (BDS), a global navigation satellite system that provides positioning, navigation and timing, in addition to data communication. The Chinese military has created the programme in order not to be dependent on the US-controlled GPS network. A report by the Jamestown Foundation states, "In recent years, the PRC has actively sought to promote the image of Beidou as a civilian-led programme intended primarily for commercial and scientific purposes, however, the program is under overall military direction, with the People's Liberation Army in charge of Beidou's development."

Beidou can also be termed as China's "Space Silk Road", which expands China's Belt and Road Initiative (BRI) and its land-based and sea-based versions to space. Beidou makes countries participating in the BRI, dependent on China for precision navigation and other space based services.

Malcolm Davis of the Australian Strategic Policy Institute wrote in 2017 that, "Chinese provision of satellite communications, weather monitoring and earth observation add to this vision for a Space Silk Road that overarches and underpins the Belt and Road Initiative. By signing up to the BRI 'Space Information Corridor', the BRI states would become dependent on Chinese-provided space services. That would give Beijing greater power to influence the policy choices of those states, because it would control the vital space capabilities that sustain their economic growth".

We have already seen the negative impact on countries like Sri Lanka and Brazil, which participated in the land and sea versions of the BRI.

The US-China Economic and Security Review Commission further expressed caution in its 2019 Annual Report thus, "Beijing has specific plans not merely to explore space, but to industrially dominate the space.... Beijing uses its space programme to advance its terrestrial geopolitical objectives, including cultivating customers for the Belt and Road Initiative (BRI)... China's promotion of... the Beidou global navigation system under its 'Space Silk Road' is deepening participants' reliance on China for space-based services."

China's "Space Silk Road", forms a very crucial part of its ambitious space goals. The commissions' report further states that China has already succeeded in undercutting some US and other foreign launch and satellite providers in the international market, threatening to hollow out these countries' space industrial bases. The aggressive pursuit of foreign technology and talent continues to be central to this strategy and to China's space development goals in general.

China's Moon Programme

The China Daily in 2019 reported that, "The next steps in China's manned space programme will be manned exploration of the moon. We will set up bases on the moon to conduct scientific operations, expand a habitable place for mankind and gain experience and expertise for deep-space expeditions beyond the moon. The long-term goal is to send humans to Mars."

Another worrisome development is Chinese cooperation with Russia in this regard. In March, China signed an agreement with Russia to work together to build a research station on the moon, which will carry out research on exploration and crucially, utilisation of the moon. Already in 2013, China launched its first lunar rover to explore the surface of the moon, hoping, among other things, to discover rare earth minerals, which are reportedly abundant on the moon. China's Chang'e 5 lunar probe mission landed on the moon and brought back geological samples to China, which became just the third country to do so after the US and Russia.

In view of these developments it is a foregone conclusion that China will also move ahead to use space to dominate not only the US but also the rest of the world. Its plans for the future wars are space-based, in addition to utilising its large stockpile of surface to air missiles, ballistic and cruise missiles – which can strike from 500 to 5,500 kms, thus covering a major part of the globe, without putting its soldiers' boots on foreign soil and indeed it may not portend well.

Kabul's Afghan Coats, Hippie Must-Haves

he London launch of Sgt. Pepper's Lonely Hearts Club Band coats were usually plain which made them cheaper. Senior government officials, suc-

Senior government officials, successful merchants and wealthy clerics bought lavishly decorated pustins that demonstrated their status. In 1946, Maynard Owen Williams — the National Geographic Society's first field correspondent — considered the pustin to be "the ultimate in masculine chic". The archetypal Afghan man, he wrote, was "clad in red-embroidered sheepskin". was the most westernised part of Kabul. Once a domain of poultry vendors, Chicken Street became a tourist strip lined with antique shops clothing em broidery and jewellery stores, and carpet dealers. In Across Asia on the Cheap, the first Lonely Planet guide, published in 1973, Tony Wheeler described Chicken Street as "the freak centre of Kabul". Hippie capitalism became commonplace. As some travelled, they looked for local products to sell back home in the West and, if they made a good profit, imported more. Richard Neville, the Australian of Oz Magazine fame, who bought a pustincha for himself while travelling overland from Sydney to London in 1965, encouraged this commerce.

one of the first boutiques not to differentiate male from female dress. But it was men, particularly rock and pop stars, who brought Afghan jackets and coats to

Life magazine featured pustinchas sent by Ira Seret to Mallory's, worn by five female models "over bright silk jump suits and slung about with yards of Mideast jewellery". Harper's Bazaar devoted two pages to Mallory's embroidered and braided vests, again presented as womenswear.

in May 1967 was a musical and fashion landmark. While the clothes worn by all four Beatles startled the journalists and disc jockeys, John Lennon stole the show. He wore a green, frilly, flowered shirt, maroon corduroy trousers, canary-yellow socks, corduroy shoes with two particularly unusual additions. One was a leather sporran, the other an Afghan sheepskin coat, worn with the fur inside and the skin outside, which was tanned yellow and embroidered with big red flowers down its front and sleeves.

These coats became a craze with extraordinary longevity. "Afghans", as they were often called, were worn by many celebrities through the late 1960s. Then, for the best part of a decade, they became standard youth clothing — an archetypal hippie garment and emblem of the counterculture.

They had a resurgence inspired by Penny Lane's character in the 2000 film Almost Famous and remain a favourite among lovers of bohemian fashion on Instagram.

Their embrace internationally transformed where and how the coats were made and what they looked like. Yet the craze for these coats could only happen because Afghanistan's relationship with the rest of the world was changing.

Short, medium or very long

Afghan coats traditionally came in three forms — sleeveless or short-sleeved hip-length vests known as pustinchas; knee-length, long-sleeved coats known as pustakis; and ankle-length cloaks called pustins.

In a gendered division of labour, men cured the skins, tanned them yellow with the rinds of pomegranates, cut them into pieces and sewed them together, while women and girls embroidered them with geometric and floral designs, usually in red or yellow. Their skins were occasionally bear, fox or goat, but usually karakul (a long-haired breed of sheep).

Although often written about as if only men wore them, women did too, and they were such ubiquitous winter-wear they were considered Afghan national dress.

The poor could typically afford only the smaller pustinchas or pustakis. If they bought the bigger pustins, these Their prime source was Ghazni, south of Kabul. In 1955 British archaeologist Sylvia Matheson found "one shop after another offering nothing but pustin" there.

While entranced by those with white fur, Matheson rejected them as impracticable for her fieldwork that winter. Instead, she opted for a brown-furred pustincha that was still "enchanting, the yellow skin entirely covered in closely stitched flowers of pillar-box red, with

Syd Barrett of Pink Floyd and Pete Townshend of The Who also wore them on stage. Eric Burdon, of House of the Rising Sun fame, got married in his.

All four Beatles wore pustinchas inside-out in their film of the Magical Mystery Tour and on the album's cover. When the Beatles tried their hand at retail, their Apple Boutique had shelves of them. From across the Atlantic, it appeared to Life in 1968 that pustinchas had been "launched last season in Eng-

Peak pustinchas

The coats were cheap compared to most fashionable western clothes, even after Afghan makers more than doubled their prices in response to international demand. The one complaint was that they smelled foul when wet, due to a skin curing process more akin to pickling than tanning. This lead to Kabul's first drycleaners to offer "exclusive no-smell treatments".

By 1969, many more pustinchas were being worn outside Afghanistan than within it, as they maintained their appeal with the most beautiful people and became part of youth's uniform.

The enduring audience for the pustincha was, however, downmarket — their iconic status confirmed in 1971 by artist Ronald Searle in a cover drawing for the New Yorker of a long-haired, bearded, barefoot hippie with flared trousers, shoulderbag, headband and pustincha.

Their international embrace fuelled new enthusiasm for Afghan clothing among some of Kabul's elite who accepted that women should unveil but wanted Afghans to fight against foreign influences and keep Afghan customs alive.

Kabul also replaced Ghazni as the Afghan centre of pustincha production.

In 1968, the biggest sweatshop employed 30 workers. In 1970, when demand surged not only in the United States and Europe but also, for the first time, in Japan, one company employed 160 embroiderers who completed 30 to 40 coats each day. Another company built a hostel for its 250–300 embroiderers, primarily widows and young women from the provinces where there were many skilled needleworkers.

As these coats spread round the world, they fuelled awareness of Afghanistan, even if not quite as much as one Kabuli dealer boasted to the New York Times "Before no one remembered Afghanistan," he said. "Now everybody remembers."

Many more foreigners visited from the early 1960s as Afghanistan embarked on a program of modernisation which saw significant numbers of women in the country's cities unveil and find new forms of paid work.

in New York's East Village

A small number of westerners, typically older, arrived by plane, with lots to spend, prompting the Afghan government to build Kabul's first five-star hotel.

In 1969 it opened, under lease to the Intercontinental Group, with rooftop dining and dancing facilities, a cocktail lounge, brasserie coffee shop, tennis courts and swimming pool. Most western visitors were hippies who, as English poet J. C. E. Bowen put it, travelled overland "in every imaginable kind of clapped-out motor vehicle [...] through the bottleneck of Kabul on their way towards the imagined Elysium of Kathmandu".

Their prime destination was Chicken Street in the Shahr-e Naw, a garden suburb close to the city centre, which on the Hippie Trail. He advised:

Sell your western-styled jeans in Nepal, and your long leather boots in Morocco. Once you could make 500% profit bringing back sheepskin jackets from Kabul, and you can triple your money with antique robes.

Rock 'n' roll

Craig Sams, a young American who also travelled through Kabul in 1965 before settling in London, became a supplier.

His prime outlet was Granny Takes a Trip—London's weirdest, most extreme, most exotic, hippest boutique — on the King's Road in Chelsea, which soon eclipsed Carnaby Street as London's fashion centre. At first, Granny Takes a Trip sold Victorian clothes, often modified to create a slightly modern feel. By 1967, when it began stocking pustinchas, its range included Charleston dresses of the 1920s, Victorian bustles from the 1880s, Boer War helmets, African fezes, Arab headdresses and Chicago gangster suits from the prohibition era.

The pustinchas were bought by men and women as Granny Takes a Trip was land by the Beatles and their followers".

Global appeal

Abracadabra, Manhattan's first psychedelic boutique, soon followed. Its interior was lit by fluorescent tubes set on a flicker-flash sequence, which had particular impact since Abracadabra was filled with mirrors like a penny arcade. Its shop window featured a motorised hanger that made the clothes on it "rock 'n' roll".

When one hippie traveller returned from Afghanistan with five pustinchas at the start of 1968, Ira Seret of Abracadabra put them in its window where they were spotted by designer Anne Klein, who had just made leather fashionable for the New York outfitter Mallory's. When Klein asked Seret to secure more and his original provider failed to deliver, Seret went to Afghanistan himself.

That summer and autumn, pustinchas were in Bloomingdale's and Macy's and all the glossies. Vogue reported that Afghan "coats and weskits beautifully embroidered in silk floss colours" were being "shovelled out the door" by Limbo, a boutique in New York's East Village.

Four Reasons Why More People Are Not Buying Electric Cars Yet

Electric vehicles can play an indispensable role in tackling climate change. However their performance in comparison to diesel and petrol cars and lack of battery charging points is hindering them from overtaking fossil fuel vehicles.

More and more governments have set deadlines to ban fossil fuel vehicles within the next decade or so. So why haven't the number of electric vehicles increased?

Reasons vary across countries explains World Economic Forum. A survey in UK explained that 37% found lack of fast charging ports the most common reason followed by 35% concerned about range and 33% about cost.

Pew Research surveyed that two-thirds of Americans agreed electric vehicles being environmental friendly, a same proportion thought of them as expensive, and a third had concerns regarding their reliability.

Here are four reasons behind the slow adaptation of Electric Vehicles in the world.

Too Expensive

One of the main reasons for people's hesitancy is that electric cars are more expensive than petrol or diesel vehicles. In the long run electric cars are cheaper due to lower charging cost, maintenance, and servicing.

A cost comparison data issued by the comparethemarket.com website showed significant gap between prices of electric cars and petrol cars. In Spain, lowest electric car price of Nisan Leaf was at \$28,620 in comparison to petrol car price of \$17,255.

Costs could be reduced when the car's battery is leased rather than including it in the upfront price. Experts claim that a battery costs between \$69 and \$138 a month under the condition of leasing the battery with the advantage that it will be replaced at the end of its life.

Industry analysts have predicted in the near future a decline in electric cars' prices is expected due to the falling cost of lithium batteries which power them. Subsidies have helped maintain up-take of electric and hybrid cars.

Not Enough Chargers

The International Energy Agency (IEA) has reported growing installation of battery charging points globally, however, the ratio between battery charging points and electric cars on road is significantly at par.

IEA's statistic shows that among numerous countries only France, Italy, and Netherlands so far have delivered the number of charging points required by European Union's Alternative Fuel Infrastructure Direction. China is the fastest in installation of public charging infrastructure with 44% increase in the year 2020 to accumulated 310,000. According to IEA, number of Europe had 38,000 fast charger points and United States

17,000 had at the end of 2020.

Chip Shortage

There has been the assumption that you can buy electric cars anytime you want However, electric cars' deliveries have fall en short due to shortage of microchips. IHS Markit stated that production of 1.4 million cars and light vans was lost in the first quarter of 2021 alone.

Increase in production of electric cars after COVID-19 lockdowns has resulted in challenging situation for chip makers to meet the demand. The shortage will continue through out 2021 and 2022, which will have direct impact on deliveries of all types of cars

Battery fire Risk

A survey by Deloitte found that 31% of people surveyed in China showed concerns regarding safety of battery technology. Various media outlets drew attention to battery fire in electric cars. Whereas, Ola Willstrand. project manager at RISE, the Swedish State research institute, stated that there is no such evidence to indicate higher fire risk with electric cars.

Apart from all backdrops of electric cars. the sale has risen across the globe. IEA reported that electric car sale rose by 140% in the first quarter of 2021 as compared to same period in 2020. China led the way to sale half a million electric cars and Europe in the second place with sale of 450,000 electric cars.

IEA forecasted increase in electric pres ence on the world's roads from 10 million to 145 million electric cars by 2030. However, the number could increase globally with gov ernment incentives and initiatives.

The World Economic Forum took the initiative by convening the Global Battery Alliance, which brought 42 global organizations in order to increase battery production and performance. The Alliance reported that approximately 290 million charging points will be needed globally in order to complete power transition to electric vehicles by 2040, with required investment of \$500 billion.

Sebi Exempts J&K Govt From Making Open Offer In J&K **Bank Share Acquisition Case**



NEW DELHI: Markets regulator Sebi on Tuesday exempted the Jammu and Kashmir government from making an open offer to the shareholders of Jammu and Kashmir Bank following a proposed equity infusion that would hike the promoter stake by 6.06 per cent in the lender.

The directive comes after Sebi received an application from the bank on behalf of its promoter, the Government of Jammu and Kashmir, seeking exemption from the open offer obligation arising under SAST (Substantial Acquisition of Shares and Takeovers) norms due to the proposed acquisition.

The government of Jammu & Kashmir is infusing a capital up to Rs 500 crore towards equity infusion or recapitalization of the bank against allotment of equity shares.

The bank will allot 16,76,72,702 equity shares at Rs 29.82 apiece.

During the financial year 2021-22, post the preferential allotment, the proposed acquirer's shareholding will increase from 68.18 per cent to 74.24 per cent i.e., a change of 6.06 per cent, which is in excess of 5 per cent of the equity paid up capital of the bank, thereby attracting the provision of the Takeover Regulation. In its order, Sebi said there will

be no change in control of Jammu and Kashmir Bank following proposed acquisition as the change will only be in the quantum of holding the shares by the government who in fact is the promoter of the bank and will remain promoter and entity in control of the lender

The bank, pursuant to the completion of the proposed Acquisition, will however remain compliant with the minimum public shareholding requirement of 25 per cent.

Sebi, further, said the infusion of additional capital by the government is stated to be utilized to improve the capital adequacy and to fund general business needs of the bank.

Accordingly, the regulator has granted "exemption to the proposed acquirer, viz., the Government of Jammu and Kashmir, from complying with the requirements of the Takeover Regulations with respect to the proposed acquisition of 6.06 per cent equity shares in J&K Bank in 2021-22.

New ATM Rules Take Effect; Interchange Fee **Increased By Rs 2**

The Reserve Bank of India's new directions on raising interchange fee and making available the facility of bulk clearing round the clock have become effective from Sunday onwards.

The RBI in June raised the interchange fee for financial transactions from Rs 15 to Rs 17, while for non-financial transactions the increase was done from Rs 5 to Rs 6. These new rates have become applicable from August 1, 2021, as per the RBI's direction.

An interchange fee is a fee charged by banks to the merchant who processes a credit card or debit card payment. Besides, National Automated Clearing House (NACH) has been made available on all days of the week, effective August 1, 2021. NACH, a bulk payment system operated by the National Payments Corporation of India (NPCI) facilitates one-to-many credit transfers such as payment of dividend, interest, salary and pension. It also facilitates collection of payments pertaining to electricity, gas, telephone, water, periodic instalments towards loans, investments in mutual funds and insurance premium.



During the bi-monthly monetary policy review in June, RBI Governor Shaktikanta Das had announced that in order to further enhance the convenience of customers, the NACH will be available on all days of the week.

The facility was available only when banks were open, usually between Monday to Friday. Autodebit instructions given by the bank account holder were not

Amazon, Microsoft, **Google Grab 63% of \$42 Bn Cloud Infra Market**

he enterprise spending on cloud infrastructure services reached \$42 billion in the second quarter (Q2), increased by \$2.7 billion from the previous quarter and up 39 per cent from the second quarter of 2020, according to a new report.

Amazon's worldwide market share nudged back up to 33 per cent. Microsoft and Google accounted for another 30 per cent of the market and the next 20 cloud providers combined had a 28 per cent market share, the data from Synergy Research Group showed.

"This market continues to be a runaway success story for Amazon, Microsoft, Google and some other cloud providers. You would not normally expect to see growth rates actually increasing in such a huge and rapidly developing market, yet once again that is what our research has shown," said John Dinsdale, a Chief Analyst at Synergy Research Group

Amazon, Microsoft and Google in aggregate are typically investing over \$25 billion in capex per quarter, much of which is going towards building and equipping their fleet of over 340 hyperscale data centres.

"There remains a wealth of opportunity for smaller, more focused cloud providers, but it can be hard to look away from the eye-popping numbers coming out of the big three," Dinsdale said in a statement.

For the fourth successive quarter, the year-on-year growth rate increased, which is unusual for such a large, highgrowth market.

In previous quarters, Microsoft and Google had been slowly gaining ground on Amazon. but after achieving 10 per cent growth from the previous quarter, Amazon's worldwide market share nudged back up to 33 per cent, the report noted.

Public IaaS and PaaS services account for the bulk of the market and those grew by 41 per cent in Q2.

"The dominance of the major cloud providers is even more pronounced in public cloud, where the top five control 80 per cent of the market. Geographically, the cloud market continues to grow strongly in all regions of the world," the report informed.

'Edge' Of Warfare In Afghanistan Will Be Deeply Felt Not Just In Neighbourhood But Well Beyond If Left Unattended : Jaishankar

NEW DELHI: India on Tuesday warned that the "edge" of the warfare in Afghanistan, if left unattended, will be deeply felt not just in that country's neighbourhood but well beyond, and emphasised that legitimacy cannot be derived from mass violence, brutal intimidation or covert agendas,

In an address at the inaugural session of BRICS academic forum, External Affairs Minister S Jaishankar also said that the warfare in Afghanistan has "sharpened the challenge" of terrorism and therefore, all stakeholders are in the quest for a clear, coordinated and undifferentiated response to terrorism.

In his virtual address, he said structural inertia, competitive gridlocks, uneven resourcing and skewed navigation have disadvantaged the multilateral institutions, resulting in certain "gaps".

"Terrorism thrives in some of these gaps. Its nursery lies in conflict-ridden spaces made fertile for radicalisation by malign players, including states. The transition in Afghanistan that we are seeing today and the warfare that has yet again been forced

upon its people has sharpened this challenge. "Left unattended, its edge

will be deeply felt not just in Afghanistan's neighbourhood but well beyond," the minister said. "We are therefore all stakeholders in the quest for a clear, coordinated and undifferentiated response to terrorism. In the 21st century, legitimacy cannot be derived from mass violence, brutal intimidation or covert agendas. Representation, inclusion, peace and stability are inextri-

cably linked," he added. The Taliban has been making rapid advances across Afghanistan by resorting to widespread violence since the US began withdrawing its troops on May 1. The US has already pulled back the majority of its forces and is looking to complete

the drawdown by August 31. Jaishankar also called for reform of the multilateral institutions saying an "updating and recalibration" of the post-World War II multilateral architecture cannot be postponed any further.

The pandemic and the normative breakdown in its wake have "rudely" reminded us that institutions built to tackle problems of the 1940s desperately need to be upgraded and the world from the pandemic."

made fit-for-purpose for our century, he said.

He said an expansion of the permanent membership of the UN Security Council is a necessary ingredient but by itself, it is not sufficient.

"Multilateral institutions have been disadvantaged by structural inertia, competitive gridlocks, uneven resourcing and skewed navigation. The proliferation of new and smaller platforms, including of plurilateral and regional groups, is, therefore, a response to such felt gaps," he said.

"BRICS (Brazil-Russia-India-China-South Africa) itself was actually among the earliest in this regard. Too often, we obsess with one or the other response; more effort and action is actually required to fill the gaps," Jaishankar said.

On dealing with COVID-19, he talked about the imbalance between the emphasis on intellectual property rights in the pharmaceutical industry and the meeting of public health goals. Left untouched, the current practices will only delay the elimination of the pandemic by several years, he said, and added that "this is simply not acceptable. But beyond health is a larger economic lesson for

States Empowered To Release Prisoners After 14 Years Of Jail Term Under CrPC: SC

However, the top court said if the prisoner has not undergone 14 years or more of actual imprisonment, the Governor has the power under Article 161 of the Constitution to grant pardons, reprieves, respites and remissions of punishment or to suspend, remit or commute the sentence on the aid and advice of the state government and this authority de-hors the restrictions imposed under CrPC.

The observations were made by a bench of justices Hemant Gupta and A S Bopanna in a judgement by which it set aside the May 12, 2020 verdict of a single judge bench of the Punjab and Haryana High Court.

The apex court upheld the Haryana's policy of August 13, 2008 on power to release prisoners by the state government, saying it was issued in exercise of powers conferred under CrPC and in supersession of earlier order.

The earlier policy cannot be put at a higher pedestal than the policy of 2008 for the reason that it seeks approval from the Governor, it held.

Under the 2008 policy, the case of premature release is being considered by the state government and individual cases are not required to be put up before the Governor as envisaged under earlier policy. The high court had directed the Haryana government to consider the feasibility of drafting a fresh policy on premature release of prisoners particularly in respect of exercise of powers conferred under Article 161 (power of governor to grant pardon, reprieves etc) of the Constitution.

It had said the state may also consider the feasibility of having a policy with retrospective operation, provided the same does not lead to discrimination amongst substantial number of identically situated prisoners.

The high court had observed that till framing of the policy, the state government can exercise its powers under CrPC in terms of its policy of August 13, 2008 while strictly adhering to the restrictions imposed under CrPC.

We find that the directions issued by the High Court are not sustainable for the reason that the policies have to be read

keeping in view the period of imprisonment undergone by a prisoner.

The power of remission is to be exercised by the State Government, as an appropriate Government, if the prisoner has undergone 14 years of actual imprisonment in the cases falling within the scope of Section 433-A of the Code and in case the imprisonment is less than 14 years, the power of premature release can be exercised by the Governor though on the aid and advice of the State Government, the bench said.

Consequently, the directions issued by the learned Single Bench are not sustainable and are hereby set aside, it held.

Justice Gupta, writing the judgement for the bench, discussed the relevant provisions of CrPC and the Constitution and said that section 433-A of the Code starts with a clause restricting the right of the government, to suspend the sentence of imprisonment for life imposed on conviction of a person for an offence for which death is one of the punishments provided by law, that such per-

son shall not be released from

prison unless he has served at least 14 years of imprisonment. Therefore, the power of the

appropriate Government to release a prisoner after serving 14 years of actual imprisonment is vested with the State Government, it said, adding the Governor is not bound by any such restrictions, but he will have to act on the aid and advice of the state government.

The top court referred to several policies, issued in 1988, 1991, 2000, 2002 and 2008, of the Haryana on release of prisoners and agreed with the submissions of the government that they have been issued from time to time and the later policy has superseded the earlier one. So there was no hiatus when a policy of premature release was not in operation or at any given point of time, the two polices were operational, the state government said.

The policy dated August 13, 2008 has been issued in exercise of powers conferred under CrPC and in supersession of Government Memorandum of April 12, 2002 and all other policies, it said, adding that the policy of 2008 is a statutory policy.

Elsayed exited after a tense 7-6 semifinal loss to Ukrainian Parviz Nasibov at Makuhari Messe Hall. Metwally lost 9-2 to Viktor Lorincz of Hungary. They will now fight in 67-kg, 87-kg bronze medal matches, respectively.

Chinese Finish 1, 2 In **Balance Beam, Biles Takes Bronze**

TOKYO: Two Chinese gymnasts stood on the top two spots of the Olympic podium Tuesday, collecting their country's first medals in the women's gymnastics competition in its final event.

Guan Chenchen won the gold medal in the balance beam, edging out teammate Tang Xijing. They pushed American superstar Simone Biles into third place in the process.

Both gymnasts thanked their coaches, who they said guided them through injury, difficult times and anxiety.

Brazil To Face Spain For Men's Olympic Football Gold Medal

Spain's only Olympic title also came at home – at the 1992 Barcelona Games. The country's last final was at the 2000 Sydney Games, losing to Cameroon.

"Playing the final of the Olympics is a dream," said Brazil coach Andre Jardine. "The film I also saw tonight was the film of life... Everything we've gone through. Although we didn't win in the 90 minutes, we took more risks," he added.
