"Post Box Kashmir: Two Lives in Letters" provides an insight into the minds and hearts of teenage girls, one in Delhi and the other in Kashmir, undergoing momen-

tous points in history. Do only Muslims live in Kashmir? Why do girls in Kashmir do stone pelting? Can you imagine being confined to the four walls of your home POSTBOX KASHMIR Two Lives in Letters

Barzam in Kashmir - asked through letters they exchanged over almost three years.

The answers they seek are likely to be the answers that all teenagers growing up in India would ask.

Framing these letters is the detailed history and commentary provided by journalist Divya Arya, who asked them to be pen pals, which places their conversations against the backdrop of the political history and happenings in Kashmir.

"Post Box Kashmir" is the result of these conversations. Published by Penguin Random House imprint Duckbill, it is a non-fiction for teens on the history and present of Kashmir, as seen through the letters of Duaa and Saumya. The book hit stores on August

5, the second anniversary of the revocation of Jammu and Kashmir's special status.

"They had to be girls. Equally impacted but less expected to be the tellers, characters or readers of writings about conflict," Arya says about her characters.

"Women's experiences are documented less, especially in the context of issues that are not specifically about them," she adds.

Arya says to capture the impact of geopolitics, there was a need to step away from it.

Jammu and Kashmir had enjoyed the special status that was granted under Article 370 of the Constitution.

Minister of State in the Ministry of External Affairs Meenakashi Lekhi said that the "historic move" has brought an era of peace and development in Jammu and Kashmir.

"On this day two years ago, Article 370 was abrogated. The historic move has brought an era of peace and development in Jammu & Kashmir. Under the leadership of @narendramodiji & @amitshah ji we bear witness to the formation of #NewJammuKashmir #Article370," she tweeted.

In June, Defence Minister Rajnath Singh had said the decision to create Jammu and Kashmir and Ladakh as two separate union territories has bolstered national security and led to a major reduction in militant activities.

He said the meeting expressed concern over the situation in Jammu and Kashmir.

"Despite tall claims of the government, the situation since August 5, 2019 is worsening day by day. They claimed that normalcy will be restored and violence will end, but look what they have said on the floor of the Parliament recently in response to a question about statehood. The minister said that statehood will be restored only at an appropriate time when normalcy is restored,' Tarigami said.

It meant that the situation "continues to be abnormal" and the claim of restoring peace in the region has not been achieved by the measures initiated on that 'unfortunate day of August 5, 2019".

The alliance spokesperson asked where was the investment and employment opportunities the Centre claimed the revocation of J-K's special status will bring.

"If you move around whether it is Kashmir or Jammu, or even in fact in Ladakh region as well, whatever development was initiated by the previous governments even that is not yet being completed.

"They claimed that lot of investment will be made here that will generate employment, that will generate hope for the youngsters, just tell me, where are those projects, where is that investment taking place? Forget about Kashmir, what about Jammu? Ask the chamber there, ask the chamber here and ask the people in Leh," he said.

Tarigami said none of the promises made by the Centre has been fulfilled.

"Rather, implementing such laws which restrict the freedom of the press, of the people, have become an order of the day. While + there have been two lockdowns (in the wake

of COVID-19 pandemic) elsewhere (in the country), our Kashmir has continuously passed through crackdowns since August 5, 2019," he said.

'What has changed for the benefit and betterment of the people of Jammu and Kashmir, two years after the August 5, 2019 decision? "The militant activities continue to be increasing and terrorism is spreading its tentacles to Jammu region as well, he claimed. The Congress leader also said that local

The Centre had on August 5, 2019 revoked the special status of Jammu and Kashmir and bifurcated the erstwhile state into two Union territories. (PTI)

#### Aug 5 Move

The separatist amalgam said in a statement, "On this occasion, would also like to draw the attention of the citizens of India and the world at large, that the present Indian Government's actions of August 5, 2019 has only complicated the dispute further over the state of J&K.'

"This is illustrated by the fact that it ignited the flames along the Line of Actual Control (LAC) even as some measure of calm has been introduced along the Line of Control," it said, alluding to the standoff with China in eastern Ladakh.

It reiterated its strong resentment and opposition to the "unilateral and arbitrary actions" related to Articles 370 and 35-A.

New Delhi would argue, the Hurriyat said, that before August 2019 "Kashmir was the main trouble spot in the state, today it is faced with four trouble spots of Leh, Kargil and Jammu as there is disaffection in regions too". It alleged the government continues to "assault" the locals by incarcerating political prisoners and youths and "intimidating' them by arrests and bringing in arbitrary and anti-people laws. "Going forward, Hurriyat is convinced that the Government of India must accept the need to address the Kashmir dispute, engage with those who truly represent the political will and aspirations of its people, and defuse the building geopolitical pressures in the region along its northern and western borders," it said.

President Arif Alvi attended a rally in support of Kashmiris and later addressing the participants, he said that Pakistan will continue to stand by their Kashmiri brethren.

He said India was playing with fire and destroying regional peace and stability.

He also made it clear that Pakistan will not hold any talks with India until New Delhi rescinds its decision of 5th August 2019. He urged the world community of its obligations towards the lingering dispute.

Foreign Minister Shah Mahmood Qureshi, Information Minister Fawad Chaudhary, Minister for Science and Technology Shibli Faraz, Railways Minister Azam Swati and many other people from government and other segments of the society joined the rally.

Speaking to the media on the occasion, Oureshi said the entire Pakistani nation and Kashmiri people reject the "illegal and unilateral" steps of 5th August 2019 taken by the Indian government.

"We will continue to support the just cause of Kashmiri people," he said.

Protest rallies, solidarity walks and other events were organised to denounce India's move to revoke the special status of Kashmir two years ago. One minute silence was also observed across Pakistan at 0900 hours and all traffic stopped for one minute to show support for Kashmiris.

cases in their jurisdictions, besides, focusing on speedy vaccination of the eligible population towards successful containment of the COVID pandemic.

Chief Secretary, Jammu & Kashmir Dr. Arun Kumar Mehta along with Additional Chief Secretary, Health & Medical Education Department, besides Chief Secretaries/ Administrators of other Union Territories also participated in the meeting.

"It was informed that Jammu and Kashmir is conducting 1.62 lakh tests per week with 0.2% positivity rate. The UT registered 999 cases and 9 COVID-related deaths in the last week," the official spokesperson said.

The Union Home Secretary, he said, advised Jammu and Kashmir to focus on administration of vaccination to eligible population in a decentralized manner through dedicated day-specific and vaccination centre-specific targeted drives.

Bhalla, he said, stressed on speedy administering of first doses to the unvaccinated population while ensuring second dose of vaccines to eligible population in time.

"So far, Jammu and Kashmir has vaccinated approximately 50 lakh people constituting 40% of its eligible population with the first dose. The vaccinated population also includes 100% vaccination in above 45 years age category and 31% vaccination in 18-45 age category," the official spokesperson said.

Giving a brief of the measures being taken in J&K to contain the spread of COVID, the Chief Secretary, he said, informed that the Government has been vigorously enforcing COVID Appropriate Behaviour (CAB) and conducting high numbers of tests and vaccinations for early detection and containment of COVID virus.

Mehta, he said, also requested the Central Government to provide 60 lakh additional doses of vaccination so as to enable the UT to universally vaccinate its eligible population at the earliest.

"Later, the Chief Secretary directed the Health & Medical Education Department to focus on contact tracing of COVID patients and ensure quarantine of suspected cases to prevent spread of infection among the general nonulation. The Department was asked to ensure strict enforcement of CAB and imposition of graded-penalty on habitual defaulters," the official spokesperson said. Further, he said, the department was directed to undertake machinery and equipment audit and ensure their functionality along with sufficient availability of technical manpower, besides, organizing districtlevel mock drills for establishment of micro containment zones and enforcement SOPs thereof. While reviewing the COVID situation in the Union territories, the official spokesperson said that Home Secretary stated that the UTs have witnessed a constant decline in cases over the past few weeks. "The new cases reported and COVID fatalities have come down to 4,244 and 54, respectively over the last two weeks," Bhalla said, as per official spokesperson. "The Home Secretary asked the UT Administrations to remain in a state of readiness to mitigate future surges, besides undertaking a combined strategy of test-tracktreat COVID cases, micro containment of emerging hot spots, speedy vaccination, enforcement of COVID appropriate behaviour, and ramping up of COVID dedicated medical facilities for successful containment of the disease," he added.

Speaking to reporters, Mehbooba said, "Today is a day of mourning for J-K. It is unfortunate that the BJP is celebrating across the country, while Kashmir is mourning," she said.

"The existence of the people of J-K will remain only when we all will together restore our constitutional position and then resolve the Kashmir issue by forcing the Government of India to talk to the people of J-K to address the internal dimension and talk with Pakistan as well to address the external dimension," she said.

There is no other option. They are already talking to Pakistan resulting in the ceasefire which in turn resulted in decline in infiltration," she said.

Mehbooba said her party is of the view that J-K has to become a bridge of peace between India and Pakistan. She said the BJP will have to take back the decisions taken on August 5, 2019.

In Jammu also, pressing for the revocation of the August 5, 2019 decision to withdraw J&K's special status and divide it into two union territories, the party took out a protest rally from its office in Gandhi Nagar and tried to move deeper into the city, but was

It also urged the government to resume engagement with Pakistan.

The Hurriyat said it has had a long-standing policy of engagement in meaningful dialogue among all the stakeholders that sees the situation on the ground for what it is, and encourages dialogue rather than armed confrontation.

"Hurrivat is cognisant that although we cannot match the muscle of status quo powers, our political education in the last thirty years has been significant and we appreciate all platforms that give us a voice. These platforms must be created and we should be allowed to participate in them - not only to allow our voice as peoples representatives be heard, but because it is just.

"It is time that the conflict over the state of J&K is resolved so that not just Kashmir, but all of South Asia can look forward to living up to its collective potential," it added. (PTI)

It may be pertinent to refer to the certain observations from the judgment of Supreme Court in the case of 'State of Punjab and another vs. Brijeshwar Singh Chahal and another' (2016) 6 SCC 1 which have been quoted by learned Single Judge himself to point out that the Government and public bodies are free to choose the method of selecting best lawyers but such selection ought to be unaffected by any extraneous considerations and that no lawyer has any vested right to be appointed, reappointed or to seek extension of term and that all such claims should be considered on merits uninfluenced by political or other extraneous consideration. The engagement of any lawyer if done in any arbitrary fashion without adopting the transparent method of selection would be amenable to judicial review but it would be limited to examine whether the process is affected by any illegality, irregularity or perversity but the Court exercising judicial review would not sit in appeal and reassess the merit of the candidates.

In view of the above legal position and the facts and circumstances of the case, when no appointment/engagement of lawyers has been made by the Government, the Court exceeded its power of judicial review and to pass a stop-order on the appointments which is apparently without jurisdiction as at one place the Court refers the matter to the Chief Justice for treating it as a Public Interest Litigation and, at the other, makes observations on the merits so as to pass the interim order. 5 LPA No. 82 of 2021

Accordingly, we call upon the respondents to file response, if they so desire, and direct this appeal to be listed with WP(C) PIL No. 6/2021 which has been registered in pursuance to the order impugned and, in the meantime, the effect and operation of the interim order stopping fresh appointment of Law Officers except that of Advocate General shall remain stayed but subject to any order that may be passed in the above referred Public Interest Litigation.

Inaugurates Modernised And Upgraded Government Silk Weaving Factory Rajbagh

Revamped Silk Factory To Have The Capacity Of Producing 4,50,000 Meters Of Silk Fabric Per Annum

SRINAGAR: Lieutenant Governor, Manoj Sinha Thursday observed that the government will begin the branding of Kashmir silk to provide it an international market. "We will soon launch Rajbagh Silk as a new brand for Kashmir silk. Moreover, the Tourism Department will work in tandem with the department of Industries and Commerce to ensure ease of access to Kashmir silk market for our tour-

ists," he said. He inaugurated the Modernized & Upgraded Government Silk Weaving Factory at Rajbagh, Srinagar marking an important step towards the revival and holistic development of the silk industry in UT.

Government Silk Weaving Factory was established in the year 1937 and has been in operation since then. Over a period of time, most of the machinery had become obsolete and the factory suffered huge damage to the infrastructure in the floods of 2014.

As part of the revival plan, the Century-old Government Silk Weaving Factory Rajbagh has been upgraded and modernized with a project cost of Rs.23.54 crores under the World Bank Funded Jhelum Tawi Flood Recovery Project. Under the upgradation plan, a new factory with state-of-the-art preparatory and weaving machinery has been installed.

The revival plan of Jammu Kashmir Industries Limited (JKI) is being implemented focusing on making the organization as a profitable and viable entity, besides providing livelihood support to the marginalized sections of the society, especially those associated with the cocoon rearing and production of wool, the Lt Governor said.

The revamped Government Silk Factory would provide a cocoon consumption market to approximately 50000 cocoon growers/ farmers of the Kashmir Division. Pertinently, in absence of such a big consumption Centre for the local cocoon, the farmers were exploited by middle men and major quantity of cocoon would get exported to other parts of the country without any value addition.

He held several meetings with engineers and even promised its completion long ago. Now that the work is complete, no minister is available to Commission Bridge.

ongress leader Rahul Gandhi's Tuesday breakfast meeting with the leaders from 15 opposition parties has set the ball rolling for the opposition unity. As of now, the BJP looks still the favourite to win the national polls, despite political setback of the second Covid-19 wave. Though opposition looks to have found its bearings, more so, after Mamata Banerjee swept Bengal polls, it has a long distance to go before it is counted as a competitor. One good thing is that Rahul has shown some promise to rise up to the challenge, even though his image makeover is still a project in works. Gandhi's speeches now carry more conviction. He has paid attention to his communication style: he now frames his arguments in a way that generate a bigger ideological contestation with the BJP- albeit, he has still way to go to match Modi's overarching ideological challenge.

But the truth is it wouldn't be sufficient to dislodge Modi from his position. That seems still very unlikely. The fact is that India's larger secular opposition is still in tatters and fighting over scraps. Gandhi may be a better challenger now, but there is no major pan-India leader in sight to take on the Modi.

The saffron party offers a deft blend of ideology and a development rhetoric. It has Modi as an overarching leader. If the opposition fails to gets its act together, the BJP could even get a stronger majority than it did in

## A Covid Warning

n the past four days, the Union Ministry of Health and Family Welfare has released a set of sobering figures on the Covid-19 pandemic. The decline in the country's caseload, after the second wave peaked on May 9, slowed down considerably in early July because the infection had not abated in Kerala and other pockets in the country. Data now shows that the virus is rearing its head again. On Tuesday, the health ministry reported that the R-value — the rate at which an infected person transmits the disease — has gone beyond the danger threshold of I in seven states and UTs other than Kerala: Himachal Pradesh, Tamil Nadu, Mizoram, Karnataka, Jammu and Kashmir, Lakshadweep, and Puducherry. Though only 44 districts have a positivity rate above 10 per cent, the fact that the country's weekly caseload spiked by 7 per cent in the last week of July should warrant a rise in vigilance levels. The Centre has asked states to consider local-level containment strategies in districts witnessing a surge. Their prime objective should be to stop crowds from gathering at busy urban centres — the Delhi government's crackdown on markets that violated Covid protocols in late June could be a good example to follow.

The uptick in the country's Covid cases comes at a time when the US, Japan, Southeast Asia and parts of Europe are confronted with a fresh surge. Random changes in the contagion's genetic code are threatening to undo the progress made in containing the pandemic's spread. There is, however, enough evidence that the current crop of vaccines, globally in use, blunt the virulence of the new variants, limit the number of people falling gravely ill. Though India has done well to meet its July target of administering 13-crore shots, the country's Covid challenge demands a quickening of the pace of inoculation. A little more than 55 per cent of people over the age of 60 have received one shot — about 27 per cent have received both doses. This means that a significant number of people, most vulnerable to the lethal ways of the virus, are still unprotected against the pathogen.

## Mindful Fridays Mental Health First Aid: Panic Attacks

ccording to data released by MSF in 2015, over 1 million adults (26%) in the Kashmir Valley were showing indications of a possible anxiety-related disorder, and the number of cases may have increased since then due to ongoing political upheaval in addition to the distress caused by the ongoing COVID-19 pandemic scenario. Anxiety disorders are diagnosable mental illnesses that create substantial disruptions in a person's daily life due to acute, recurrent symptoms. Anxiety patients may exhibit unpleasant physical, behavioural, and psychological symptoms such as irrational fear, fast heart rate, digestive issues, and distress in everyday situations.

In addition to its core symptoms, anxiety disorders can also lead to an intense spell of anxiety called panic attack. People with this condition may have difficulties in their socio-occupational functioning as a result. Depression, anxiety, and other mental health difficulties, as well as drug abuse disorders, may emerge as a result of these issues.

Mental health first aid can be used to help people who are having panic attacks to help them to keep calm and manage their symptoms until they are taken to a mental health professional. A person who provides mental health first aid can offer encouragement as well as referral information so that longer-term services can be established. #### What is a Panic Attack?

A panic attack is a brief period of extreme anxiety, fear, or discomfort that begins suddenly and usually ends within 10 minutes. Several of the following symptoms are present during the attack:

• Palpitations, pounding heart, or rapid heart rate

- Sweating
- Trembling and shaking
- Shortness of breath, sensations of choking or smothering
  - Chest pain or discomfort
  - Abdominal distress or nausea
- $\bullet$  Dizziness, light-headedness, feeling faint or unsteady
- Feelings of unreality (derealisation), or being detached from oneself
- Fears of losing control or going crazy
   Fear of dying
- Numbness or tingling
- Chills or hot flushes

#### Causes of a Panic Attack

Numerous variables such as inheritance and genetics, severe life stressors, and sensitive emotional temperaments can all contribute to causing panic attacks in someone. While the onset of a panic attack may be surprising at first, it is generally caused by particular stimuli over time.

- The following factors may increase your chances of having a panic attack:
- Family history of anxiety disorders, panic attacks, or panic disorder
  - Death or illness in the family.



similar to those of a heart attack or other medical conditions. It's impossible to know for sure whether or not someone is having a panic attack. If it's something more serious, only a medical professional can tell. If the client has never experienced a panic attack and does not believe they are having one now, you should administer physical first aid.

Apply physical first aid principles if the victim loses consciousness. Check for breathing and pulse before calling an ambulance.

#### What to do if you are sure someone is having a Panic Attack?

Before assisting someone incase of panic attack, it is critical to assess for suicide or harm. Once you are sure the situation is not dangerous for them, try to have an empathetic listening to their trouble. Empathetic listening is one of the key components of mental health first aid. Listening without passing judgment demonstrates that you care about the person and will not pass judgment on their mental health issues. The capacity to listen to them without passing judgment will encourage them to talk openly and honestly about their situation. Inquire about the person's needs and allow them to tell you what would be most beneficial to them.

Educate the individual that they are having a panic attack. It is critical that you maintain your composure and do not panic yourself. Be patient when speaking to the person in a comforting yet strong manner. Use short, clear words while speaking clearly and gently.

Don't make assumptions about what the individual requires; instead ask them directly what they believe might help. Don't dismiss the person's experiences. Make them feel that you know that their anxiety and associated discomfort is genuine, but reassure them that, while terrifying, a panic attack is not life threatening. Help them deal with their fears by assuring them that they are safe and such as:

- Participating in everyday physical activity
- Keeping a balanced diet
- Mindfulness practices, such as meditation, are beneficial.
- Practicing daily gratitude
- Using anxiety management techniques at home and at work
- Taking a mental health day when necessary as a form of self-care

#### What to say when the panic attack has subsided?

Ask the person if they know where they can acquire information on panic attacks when the panic episode has passed. If they don't know, give them some ideas.

Tell the person that if the panic attacks continue to bother them, they should seek help from a qualified mental health professional such as a clinical psychologist and/or psychiatrist. You should be aware about the help available in your area so that you are able to guide them to a mental health professional. Assure the sufferer that effective treatment in the form of medicines and therapies for panic attacks and panic disorder are available. Psychiatrists prescribe various medicines that have a calming effect, however their usage can occasionally result in undesirable side effects such as tolerance, dependency, and withdrawal.

Clinical Psychologists are considered one of the core mental health professionals who can help people with panic attacks. They try to understand the various causal factors behind somebody's panic attack by taking a detailed history, looking into childhood issues such as adverse childhood experiences, family dynamics, and various other psycho-social issues and then accordingly prepare their treatment plan using various therapeutic modalities such as CBT, ACT, DBT, psychodynamic approac etc. in order to make the person competent enough to deal with symptoms, and the underlying issues such as poor self esteem, low frustration tolerance problems in family dynamics, lack of assertiveness and issues with problem solving strategies. Depending on the severity of the condition, the person may get benefitted either by taking help of a clinical psychologist alone or by seeking combined help from clinical psychologists as well as psychiatrists. Psychiatrists will help them to deal with symptoms while as clinical psychologists can help to deal with issues and thus the patient may eventually feel recovered and be competent enough to live a productive life and realize the potential endowed to them by God almighty.

#### What to do if someone is seemingly having a Panic attack?

If you feel someone is having a panic attack because they are experiencing the aforementioned symptoms, you should first ask them if they are aware of what is going on and if they have ever experienced a panic attack. If they indicate they've had panic attacks in the past and feel they're having one now, ask if they need any assistance and provide it. Introduce yourself if you are assisting someone you do not know.

#### How can one tell a panic attack from a heart attack?

Panic attacks might have symptoms that are

that the symptoms will eventually subside.

By doing the following, you may improve your empathetic listening skills:

- Maintaining strong eye contact
- Maintaining an open and relaxed body language
- To demonstrate understanding, reflect back what the other person has said and ask questions.
- Being calm and patient while the person is crying, silent, and is trying to discuss difficult issues
- Encourage the individual to seek out additional sources of support, such as family, friends, or any communities in which they participate.
- You may also encourage the person to practice self-care routines and techniques that will help them develop good coping skills,

## People are selfish with masses and generous to individuals

#### Agencies

he general public in recent years has steadily lost their confidence in economic authorities, financial institutions, and particularly corporate managers. They think that economic actors will go to any length for-profits, which includes harming fellow human beings and large groups.

Yet, modern behavioural economics and psychology tell a completely different story. Laboratory data has shown that people willingly share monetary gains with others, dislike inequality, and are very often generous. Recent evidence shows that dishonesty levels as measured in certain laboratory tasks are surprisingly low. The message is that people are prosocial and, if given the opportunity, cheat just a little. These findings have been published in the journal 'Nature Human Behaviour'.

Opportunity to rob half of the gains from others

How can both observations be simultaneously true? Are high-level economic actors simply different? To find out, Carlos

Alos-Ferrer, NOMIS Professor for Dec sion and Neuroeconomic Theory at the University of Zurich and his team designed the Big Robber Game, an experimental setting with 640 participants in a standard student sample. Students were placed in groups of 32, where all subjects were engaged in some remunerated activity and earned the same amount of money. Half of the participants, the robbers, were given the opportunity to anonymously steal half the earnings of the other 16 members of their group (and one of the 16 robber's decisions was actually implemented), which corresponded to more or less 100 Euros. But they could also steal less, say one-third, or one-tenth or nothing at all. So, what did they do?

Overwhelmingly ruthless in anonymous groups

More than half of all robbers went to the extreme and took the maximum possible, which was half of the earnings of all others. Over 80 per cent took one-third or more and almost nobody declined to rob. The students revealed an overwhelming willingness to inflict significant monetary harm to a large group of others. Furthermore, the decision to take the maximum was taken on average more quickly than the decision to refrain from it, revealing a weaker moral struggle in the former case. However, the very same study participants displayed predominantly prosocial behaviour in standard bilateral games. When asked how they wanted to split 10 Euros with just one other participant, they voluntarily transferred some money, even when the other person was powerless to retaliate if no money came. In general, their actions revealed that they disliked inequality.

"Thus, the very same people displayed selfishness in the large high-impact decisions affecting a large group and generosity in the small bilateral, low-stakes interactions", Alos-Ferrer resumes. "This behaviour arose spontaneously within our student population, with no significant differences due to gender or field of studies. Therefore, there is no need for arguments about high-level economic actors being different. The roots of corporate scandals seem to be in all of us."

Tradeoff between personal gain and other-

regarding concerns

The finding that people behave selfishly toward a large group while being generous toward individuals suggests that harming many individuals might be easier than harming just one, in line with existing evidence that people are more willing to help one individual rather than many.

According to the authors, the study also reflects the tradeoff between personal gain and other-regarding concerns: When facing an individual in a bilateral game, appropriating a given monetary amount can result in a large interpersonal difference. When appropriating income from a large group of people, the same personal gain involves a smaller percentual difference, and hence it is more likely to offset the inequality aversion. Alos-Ferrer: "In economically relevant situations, many human decisionmakers might be willing to inflict significant harm on a relatively large number of people for personal gain, as long as that gain is of sufficient magnitude. Even more strikingly, in Western societies, 100 Euros might already be enough.'

## HC Stays Interim Order Stopping Appointment Of Law Officers

**IAMMU:** A double bench of High Court of Jammu and Kashmir and Ladakh has stayed the effect and operation of interim order of Single bench issued in response to a petition stopping fresh appointment of Law Officers except that of Advocate General, even as it accepted to treat the petitioned matter as Public Interest Litigation. The Double Bench compris-

ing Chief Justice JK&L High Court Justice Pankaj Mithal and Justice Puneet Gupta stayed the interim order but subject to any order that may be passed in the above referred Public Interest Litigation. The Double Bench was hearing

the Letters Patent Appeal (LPA) directed against the order dated 29.06.2021 of the learned Single Judge passed in Writ Petition (C) No. 1087/2020 'Sushil Chandel Vs. Union Territory of Jammu and Kashmir and others' with the following observations

The learned Single Judge in the said order after making certain observations on the merits of the petition vis-a-vis that "I am, therefore, of the considered view that the Policy of the engagement of Government Lawyers at all levels deserves fresh look and it is imperative that these engagements are merit based and do not fall foul of Article 14 of the Constitution of India" directs the petition to be treated as Public Interest Litigation (PIL) and as such observed to place it before the Chief Justice for listing before the appropriate Bench in terms of Rule 24 (8) of the Writ Proceeding Rules, 1997, but in doing so the single bench has further

sidered by the Bench dealing with the PIL, no fresh appointments shall be made of the Law Officers except the Advocate General.

In other words, while recusing to hear the writ petition and directing it to be treated as a Public Interest Petition and laid before the appropriate Bench dealing with the PIL, the Single Judge proceeded to comment on the merits and passing interim order stopping all appointments of Law Officers in the Union Territory except the Advocate General.

The submission of Sh. D. C. Raina, learned Advocate General is that the interim order passed by the Single Judge is patently without jurisdiction which could not have been passed once the Single Bench has declined to hear the writ petition and has directed it to be treated as a Public Interest Litigation.

RD Singh Bandral, appearing for the respondent vehemently contends that the appointments of the Law Officers should be transparent and that the criteria laid down under the impugned advertisement is faulty and does not bear any nexus with the object sought to be achieved. Therefore, the advertisement has to be quashed and declared ultra vires to SRO 98 of 2016 with direction for framing fair and reasonable rules in terms of the prevalent law.

It may be pertinent to mention here that the Deputy Legal Remembrancer, Department of Law Justice and Parliamentary Affairs, issued an advertisement inviting applications for engagement of Standing Counsel which inter alia provide that an Advocate may apply in the prescribed form against the forty (40) vacancies for the districts of Jammu and Srinagar and two each for other districts meaning thereby

that the proposed appointments of Standing Counsel are in context with the districts courts and not the High Court. In addition to above, it lays down the eligibility criteria and provides for 30 marks for the Experience, 10 marks for Higher Qualification than the Degree of Law, 50 marks on the basis of legal work done in courts such as instituting suits/filing of defence and 10 marks for the professional achievements, awards etc.

SRO 98 of 2016 issued in exercise of powers under Section 124 of the erstwhile Constitution of Jammu and Kashmir read with Section 492 of the Code of Criminal Procedure (Cr.P.C.) Svt. 1989 (1933 A.D.), the Government notified the Rules known as Jammu and Kashmir Law Officers (Appointment and Conditions of Service) Rules 2016.

In the writ petition, it was contended that the criteria laid down in the aforesaid advertisement has no relevance, are illegal and ultra vires to the above Rules.

The learned Single Judge in passing the impugned order accepted that the petitioner had neither himself applied nor does he seek his appointment and engagement as Law Officer, either at the district level or in the High Court. Single Judge further observes that the advertisement prima facie is not bad yet conditions therein would pose practical difficulties in its application and, therefore, 4 LPA No. 82 of 2021 requires reconsideration. There is no rationale for allocation of marks for the qualification higher than the Degree of Law when the Chief Justice of India and the Judges of Supreme Court and the High Courts can be appointed with the simple qualification of LLB only. | More on P2

"Basically everyone was keen to see how Misbah managed the team in the T20 series in West Indies as calls grew for the PCB to review his position as head coach in white ball formats," one reliable source told PTI.

He said that the board had started to look for other options as the cricket community was upset after Pakistan lost the threematch one-day series to a second string England side and than the T20 series with some key players missing from the home side.

"The feeling developed that perhaps Misbah was not the right man or didn't have the coaching experience to take Pakistan into the T20 World Cup," the source said.

## **India Win Olympic** Silver In Wrestling & **Bronze In Men's Hockey**

**TOKYO:** India on Thursday bagged two Olympic medals at Tokyo Games 2020 with Ravi Kumar Dahiya clinching the silver medal in 57kg freestyle while India men's hockey team won bronze by defeating Germany. With these victories India's medals tally

at the Games swelled to 5, which includes 2 silver and 3 bronze medals.

Dahiya became only the second Indian wrestler to win a silver medal at the Olympic Games. There were huge expectations from Dahiya for a gold medal after his phenomenal semifinal victory but the reigning world champion Zavur Uguev of Russian Olympic Committee dashed those hopes with a comfortable 7-4 win the men's freestyle 57kg title clash.

Dahiya had lost to Uguev at the 2019 World Championship also.

Meanwhile, the Indian men's hockey team rewrote history as it claimed an Olympic medal after 41 years, defeating a plucky Germany 5-4 to win the bronze in an edgeof-the-seat play-off match.

Simranjeet Singh (17th, 34th minutes) scored a brace, while Hardik Singh (27th), Harmanpreet Singh (29th) and Rupinder Pal Singh (31st) were the other goal getters for world no.3 India.

Determined to clinch a medal, the Indians made one of the most memorable comebacks in the history of the game, fighting back from a two-goal deficit to turn the match in their favour.

There were tears and hugs on the field



as the Indians led by Manpreet Singh and coached by Australian Graham Reid savoured the historic moment.

It is India's third hockey bronze medal in the history of the Olympics. The other two came in 1968 Mexico City and the 1972 Munich Games.

His two other compatriots, Rahul Rohilla (1:32:06) and K T Irfan (1:34:41) brought up the rear at 47th and 51st with disappointing performances under hot and humid conditions.

#### **Golfer Aditi Ashok Advances After Blemish-Free Second Round**

TOKYO: Indian golfer Aditi Ashok was in contention for a historic Olympic medal after carding a flawless five-under 66 in the second round of the women's competition at the ongoing Games here on Thursday.

The 23-year-old rolled in five birdies, which included three in her last four holes, on yet another steamy day at Kasumigaseki Country Club to lie tied second on nine-under 133 with Danish duo. Nanna Koerstz Madsen (64) and Emily Kristine Pedersen (63).

Aditi, playing her second Olympics with her mother, Maheshwari, as her caddie, trails leader – world no.1 Nelly Korda of USA – by four shots.

#### **Heartbreak For India** Wrestlers Deepak Punia & Vinesh Phogat

TOKYO: In men's freestyle 86kg category, Deepak Punia came agonisingly close to winning a bronze medal on his Olympic debut but conceded a take-down in last 10 seconds of the play-off against San Marino's Myles Nazem Amine to miss out on achieving the feat.

Top seeded Vinesh Phogat had no answer to the supreme defence of Vanesa, who got her revenge from the Indian at the biggest stage after suffering a similar embarrassing defeat 'by fall' earlier this year in Ukraine.

Later, Vanesa lost her semi-final to China's Qinyu Pang on criteria after scores were tied 2-2, a result that brought curtains on Vinesh's campaign at the Tokyo Games.

#### **Belgium Wins Shootout To** Take Men's Hockey Gold

TOKYO: Belgium, a 2016 Olympic runner-up, defeated Australia in a shootout to win gold in men's field hockey. The score was tied 1-all at the end of regulation before Belgium won the shootout 3-2. Alexander Hendrickx scored the penalty stroke that put Belgium ahead in the shootout and Vincent Vanasch got the clinching save. India won bronze earlier in the day with a 5-4 victory over Germany. It was India's first field hockey medal since 1980.

TOKYO: American David Taylor scored a double-leg takedown with 17 seconds remaining to beat Iran's Hassan Yazdani 4-3 and claim wrestling gold in the men's freestyle 86-kilogram class. Yazdani, the No. 1 seed, won the 74kg class at the 2016 Olympics.

San Marino's Myles Amine defeated India's Deepak Punia 4-2 for bronze. It was the first-ever Olympic wrestling medal for the country with about 34,000 people.

In the other bronze medal match, the Russian Olympic Committee's Artur Naifonov defeated Uzbekistan's Javrail Shapiev 2-0.

#### Sandra Sánchez **Of Spain Wins First Olympic Gold In Karate**

TOKYO: Spain's Sandra Sánchez defeated Japan's Kiyou Shimizu in the final matchup in women's kata to claim first ever gold medal in karate. The 39-year-old Sánchez scored a 28.06 in the final bout while Shimizu's score was 27.88.

Sánchez has dominated her discipline in Europe for the past seven years, making her a fitting first champion in the Olympic debut of karate. The martial art is in the Olympic program on a temporary basis in Japan after a half-century of attempts to gain Olympic recognition.

Grace Lau of Hong Kong, China, and Viviana Bottaro of Italy won bronze.

#### **Chinese Teenagers Sweep Women's 10-Meter Platform Diving**

TOKYO: Chinese teenagers Quan Hongchan and Chen Yuxi have swept the top two spots in women's 10-meter platform diving.

The 14-year-old Quan took gold with 466.20 points and the 15-year-old Chen grabbed silver with 425.40 as China completed a golden sweep of the women's diving events.

Melissa Wu of Australia claimed the bronze medal with 371.40 points.
