Army Veterans Discuss Changing Scenario In The Region And Its Possible Impact On Kashmir

SRINAGAR: In a searing summer day in Srinagar this year, Lieutenant General DP Pandey addressedprobably, for the first time-what security analysts had long termed as "elephant in the room".

With US President Joe Biden setting the final deadline for ending "forever war" in Afghanistan, LG Pandey, the General officer Commanding (GoC) of Srinagarbased Army's 15 Corps, perhaps became the first serving general to

talk about the consequences of an impending Taliban victory.

There's a possibility that US forces pullout from Afghanistan may push some militants into Kashmir," the general said on the sidelines of a passing-out parade at JAKLI Regimental centre Rangreth in Srinagar, on June 25.

"If at all any such thing happens," Kumar, flanked by GoC Victor-Force, Rashim Bali, told scribes on August 21, "I as a police officer assure the people of Kashmir that police, army and the other security forces will deal



Govt Orders Demarcation, Verification Of Waqf Properties

SRINAGAR: The government of Jammu and Kashmir has ordered demarcation and verification of Waqf properties across the Union Territory and has asked the divisional commissioners to ensure comple-

tion of the process within a month. In an order issued here, the government has said that in the process of digitization and geotagging of Waqf properties, it has come to notice that there are a large number of properties which require demarcation or where encroachments have taken place.

"Accordingly, in order to conduct demarcation, verification and removal of encroachments. Tehsildar concerned shall organise verification and demarcation of each of the Waqf properties while associating a representative of the CEO Waqf Kashmir/Special Officer Auqaf,"

the order reads.

"Specific focus shall be on those Waqf properties that could not be geo-tagged with reference to the data uploaded on the Waqf Management System of India (WAMSI) portal.

The order reads that the Deputy Commissioners shall constitute teams for 100% cross-checking of the demarcation and encroachment reports. "The necessary entries of waqf properties in Revenue records shall also be made.'

It reads that the Deputy Commissioners will send reports along with copies of relevant records to the CEO Waqf Kashmir/Special Officer Augaf who shall certify that the properties have been verified as per the records and duly reconciled with the revenue records and undertake digitisation/geo-tagging of the • More On P10



10 Burglars Operating In **Military Fatigue Arrested**

Srinagar: The Jammu and Kashmir Police in Kashmir capital Srinagar busted a gang of burglars who would loot houses donning combat uniforms, using dummy weapons and iron rods.

A police spokesperson said that Police received a couple of complaints from West area of city, wherein complainants had looted during cordon and search operations by men donning army uniforms.

One such complaint was regroup of people donning combat uniforms raided his house and during the raid, gold, cash and incidents," he said. cell phones were looted.

Divulging information about these incidents, SP West Perbeet said that one such incident occurred in Maloora area on 4 May this vear.

"We have recovered gold ornaments worth 22 lakh, cash 3.50 lakh, a vehicle which they had purchased from the stolen money, 6 combat dresses, 5 dummy AK-47 rifles, 4 dummy pistols and some iron rods which they used to break the locks," SP Mr

Villagers thrashed, shops looted as SF run amock

IED Blast Wounds 5 Soldiers, 2 Women

SOPORE: Tension gripped the highway village of Patukah 6 km from here; after security forces allegedly went berserk injuring civilians, smashing vehicles and ransacking shops and houses following an IED explosion in which five of their men and two local women were injured this morning. Vehicular - traffic on the highway was disrupted for several hours while the villagers and shopkeepers have fled from the spot out of fear.

According to reports, five army jawans of 29 Rashtriya Rifles (RR) were injured, some of them seriously, when suspected militants detonated a powerful improvised Explosive device (IED) planted in a bag under handcart near filling station eat Patukah at about 11 an today. It was believed to have been triggered through a remote control device. Two local women, identified as Shamima w/o Bashir Ahmad Hallam and Misra w/o Abdul Ahad, were also injured. A CNS report said the Hizbul Mujahideen had claimed responsibility for the blast.

Eyewitnesses said the impact of the explosion was such that the one tonne vehicle the army jawans were travelling in was hurled a distance of several yards and smashed into a moving civilian truck. The vehicle as well as the truck, bearing registration No JKC 3908 and carrying timber, suffered extensive damage. Those injured in the incident were immediately rushed to hospitals. While two of the injured soldiers were discharged after first aid, the other three were stated to be out of danger. However, a KPS report said two of the injured soldiers succumbed to injuries at the base hospital at Badamibagh, Srinagar. Soon after the incident, according to reports, troops in strength swooped on the village and allegedly ran amock, beating everyone they could catch hold of. They smashing the petrol pump belonging to Feroz Ahmad Pandit s/o Habibullah Pandit of Sopore and his Maruti car bearing registration No JK 04 / 2757. Pandit was injured due to thrashing by the securitymen.

A little ahead, the jawans beat a bandsaw owner; Ghulam Muhammad Khuroo, and his labour, Muhammad Hannan Hajjam, resulting in serious injuries to both. They were rushed to Srinagar in a critical condition. A horse cart puller, Muhammad Arif r/o Inzar. Shrakawara, fractured his leg due to severe beating and he too was rushed to Srinagar. Several others were also beaten. Meanwhile, reports said, all the villagers deserted their homes and hearths in panic while the shopkeepers left their shops. The security forces immediately laid siege to the village and allegedly went about looting and ransacking the shops with gay abandon. They also conducted house-to-house searches to flush out the suspects.

Mumbai, August 24: Union minisover his remarks about slapping Maharashtra Chief Minister Uddhav Thackeray for what he claimed was the latter's ignorance of the year of India's independence.

Rane was taken into custody by police in coastal Ratnagiri district, where he is travelling as part of the Jan Ashirwad Yatra, an official said.

Rane was taken to the Sangameshwar police station after being taken into custody, the official said. There were reports that the BJP leader complained of high blood pressure and sugar levels and a doctor was called to examine him.

"It is shameful that the chief minister does not know the year of independence. He leaned back to enquire about the count of years of independence during his speech. Had I been there, I would have given (him) a tight slap," Rane said in adjoining Raigad district on Monday.

The former chief minister claimed Thackeray forgot the year of independence during his August 15 address to the people of the state. Thackeray had to check the year of independence with his aides midway during the speech that day, Rane said. Rane on Tuesday defended his remarks against Thackeray, saying he hasn't committed any crime by making them.

On media reportage of his 'imminent arrest' in the case, Rane saidhours before his arrest—that he was not a 'normal' man and cautioned the media against such reportage.

"I haven't committed any crime. You should verify and show it on TV or else I will file a case against you (media). Despite not committing any crime, the media is showing speculative news about my 'imminent' arrest. Do you think I am a normal (ordinary) man?" Rane said.

Rane's remarks drew sharp reactions from Shiv Sena, whose workers put several posters in Mumbai and other places, calling him a in Santacruz (West) in the morning 'kombdi chor'

Sena activists poured petrol, brought by them in bottles, on the posters installed outside the office and set them afire around noon. They also hurled stones at the office.

Heavy police security was deployed outside Rane's residence in Mumbai in the wake of his remarks against Thackeray, an official said.

Srinagar: The government on Tuesday asked Department of Law, Justice & Parliamentary Affairs to put a centralized mechanism for vetting the draft replies or stand of the Government through a single window system to avert any delay in filing the same before courts and forums.

"With a view to ensure submission of timely, well-considered and uniform stand/replies of the Government Departments/HoDs/Organizations/ Bodies/Societies etc. before respective adjudicating forums, there is an imminent requirement to consult the Department of Law, Justice & Parliamentary Affairs for opinion and vetting of the draft replies/objections before filing the same in the Courts/Forums," reads a government order.

Further, he said, the cases involving more than one departfinalize a consolidated reply and

return the duly vetted consolidated reply or objections to one of the departments, to be decided by it, which shall file the timely reply on behalf of all the departments, unless there are specific directions from the Court and Forum for filing of separate replies by each department. In such a scenario also, the government said, the replies must be vetted through Law Department to ensure coherence and consistencies with each other.





New tourist season

ith the waning of the second Covid-19 wave, tourists are returning to the Valley. On an average 30 flights operate at Srinagar International Airport daily with seven to eight thousand people travelling to and from Kashmir. The people associated with the tourism sector are pinning hope on the upcoming autumn and the winter thereafter to draw more holidaymakers to the Valley, just like the corresponding period from October to April had done last year. According to government figures, 1.13 lakh tourists had arrived in Kashmir during the period, a figure that the then union tourism minister Prahlad Singh Patel had told the parliament at the time had broken the record of the past 16 years.

To woo travellers back, hotels and houseboats are providing huge discounts with prices reduced by as much as 50 percent. The tourism department has taken several measures to ensure that the fear of the Covid-19 contagion doesn't scare away the visitors. According to government data, so far 80 percent of its tourism service providers have been vaccinated and are safe to welcome travellers from far and wide. Government is also in the process of identifying new tourist destinations to accommodate more tourists and offer them more places to visit. Recently, a meeting chaired by the advisor to governor Baseer Ahmad Khan listed out parameters to identify these places and the adventure spots.

Sounding a note of caution though, the tourism in Kashmir is not only about whether the pandemic is on or gone. The security situation is a factor too. While the Covid-19 lockdown may have been responsible for shutting the Valley off over the last one year, the security situation too has not been good.

At the best of times, the situation in the Valley remains uneasy and uncertain. And sometimes a big local event could make the region a site of geopolitical tension just like the Pulwama attack did. Truth is that while tourism is a boon for Kashmir it needs a peaceful environment to thrive, something that the Valley has lacked for the past thirty years. And considering the ongoing state of affairs, fundamentally the situation remains the same.

So, while we look forward to a fresh season of tourism, it is important that the state of siege that has more or less prevailed since the repeal of Article 370 in August 2019 is lifted. And this siege is not about the lockdown or the denial of internet and phones but about the political uncertainty and unpredictability.

rime Minister Narendra Modi's decision to ask the MEA to brief all parliamentary parties on the Government's actions in Afghanistan comes as questions grow about the Government's planning for contingencies there, with the Taliban's takeover. In the s built considerable interests, including major infrastructure projects and ongoing development projects, helped script the Afghan Constitution and conduct of elections, as well as enabled the training and education of the next generation of officials, soldiers and professionals. It seems unfortunate, therefore, that this bank of goodwill came to naught as the Government decided it was safer to pull up stakes, emulating neither the U.S. and European countries who relocated their diplomatic outposts to the Kabul airport, nor Russia, China and Iran, which decided not to

vacate their embassies there. Going forward, the Government must explain how it expects to approach the new regime in Afghanistan once it is formed. It is still unclear whether this will be merely a repeat of the brutal regime seen from 1996-2001, or whether negotiations are under way for a more inclusive coalition, including several former leaders of Afghanistan, will fructify into a transitional government. The rise of Taliban power and that of the group's Pakistani backers is a particular security concern as groups such as the LeT and the JeM could use Afghanistan as a staging base for terror attacks in India. Finally, the Government must explain how it will approach the Afghan people, especially those whose lives could be in danger, including Embassy staff and associates, those working on Indian projects, minorities, including those Islamic sects such as the Hazaras who have been targeted, as well as women. A more open, liberalised visa policy, and more swift processing of the newly launched special "e-Emergency X-Misc" visas would reassure both Afghans and the international community that India's exit from Afghanistan is not permanent, and it will retain its traditional and historic interests in the country and its people, despite

They are an integral part of human lives and preach the same message of peace and brotherhood. Islam is also one of the monotheistic and major religions in the world having an enormous following of 1.8 billion Muslims in the world. Prophet Muhammad (SAW) is the founder of Islam in Arabia. With the passage of time, the companions of Prophet SAW played a great role in the spread of Islam in the world facing a lot of hardships day-in and day-out.

The messenger of Allah sent his companions every right, left and centres to convey the divine message of one God to the people of the world in order to show them a real path of eternal religious prosperity.

History is replete with the facts at although Islam had reached Kashmir very early, but the practical aspect was missing thereof. Kashmir was once a non-Muslim land where people were accustomed to non-Muslim practices and were mostly Hindus. Thus, there came an intervention in their lives. Whether, we call it divine or by chance, Islam arrived to make its roots permeate into the lives of the

masses of the valley of South Asia.

It was initially Hazrat Syed Sharafud-Din Abdul Rahman(RA), a Sufi from Turkistan also known as Syed Bulbul Shah(RA) who provided the idea of Islam in Kashmir. Unfortunately, there have been little literary forays into his life, although few references to him form a part and parcel of the historical narratives of the medieval Kashmir. He was thus the first Islamic missionary to Kashmir who laid the foundation of Sufi order here. He played a catalytic role in the spread of Islam to concretise the societal transformation at large. According to historical sources, many people in Kashmir embraced the creed of Bulbul Shah.

After this great saint, there arrived the descendent of Prophet Muhammad (SAW), known as Hazrat Mir Syed Ali Hamadani (R.A), a Sufi of Kubrawi order from Hamadan, Iran from central Asia along with 700 Sayyids in Kashmir to enlighten the masses with the glorious Islam and its practical aspects through his teachings. He was a Shafi Muslim scholar from an educationally well-off family. He was born in 1314 A.D. at Hamadan, Persia from parents namely Syed Shihab-Ud-din and Saiyidnah Fatima.

Shahi Hamadan R.A. came to

Kashmir thrice with a noble mission of spreading the religion of Islam and arrived in Kashmir for the first time in 1372 A.D. and left for Mecca afterwards. Thereafter, he again arrived in Kashmir and stayed briefly and left vale again. Finally, he again came to Kashmir in 1383 and remained in Kashmir for a short span of time and left this earthly world towards eternal heavens afterwards and Tajikistan became the epicentre of his eternal bodily stay.

Shahi Hamdan is also known as Ali Sani (Second Ali) in Kashmir and revered by one and sundry with a linked genealogy through Imam Husain (R.A.) traced back to fourth Caliph, Hazrat Ali (R.A.). He contributed not only Islamic tenets and principles based on the Islamic philosophy for the people, but also contributed the dual elements of art and crafts in Kashmir. He contributed subjects like ethics philosophy, jurisprudence, theology, poetry and prose immensely in Kashmir. He also profoundly impacted the architecture in Kashmir through construction of Khanqahas and tombs.

The arrival and influx of Shahi Hamadan (R.A.) in Kashmir brought a socio-cultural and religious revolution. Shah-i-Hamadan was also an author and a poet par excellence who wrote books like, Zakhiratul Muluk and Muwwadatul Quraba. Zakhiratul Muluk dealt with his political ideology, the duties of rulers and the responsibilities of the people. Besides, he also authored several books spanning religious and spiritual aspects.

Awrad-E-Fathiya is a major case in point. It is the collection of religious prayers of great religious people which is recited every morning after the Fajr prayers in almost all the Hanafiya School of thought mosques reflecting the faith and deep commitment in one God laying emphasis on the the unity of God and His attributes. Another important poetic collection of Shahi Hamadan (R.A) is Chahlul Asraar .Every year prior to Eid Ul Adha, the Urs of this great saint Shah Hamdan (R.A) is celebrated on the 6th of Zil Haj of the Muslim calendar at few sacred abodes of his shrines, including Seer Hamdan Dooru Shahabad, Tral and Srinagar as a mark of deep reverence and regard for the unrelenting efforts of this saint for the upliftment and prosperity of the people of Kashmir.

The inroads of Shahi Hamadan (R.A.) into Kashmir without any regard for the rewards makes the point clear that the great saint as a mark of

legacy of the mission of his dynasty of Prophet Muhammad SAW cared about the people of Kashmir and yearned to stabilise their lives socially, religiously and culturally. Today, when Kashmir is at the crossroads of uncertainty, whether politically or otherwise, if we follow the paths of their great religious saint, time will not be far when divinely support to our problems will annihilate them and a valley of scenic beauty will restore and regain its charm again and metamorphosize our pains into peace. Together, by following the charted discourse of Shahi Hamadan R.A, our lives will blossom both here and hereafter. How India Came to Love Colonial Cricket

riginating in England, cricket came to India with the East India Company – an English company formed to develop

According to British sailor Clement Downing's "A History of the Indian Wars," written in 1737, the first cricket match in India was played between sailors like him in 1721 in Khambhat, near India's western seaboard, only 55 miles from the stadium where Trump gave his speech.

The introduction of English traditions and sports helped the colonizers affirm their supposed cultural superiority and justify their rule. Some Indians, however, were actively involved in making the foreign sport their own.

The Parsis, an ethnic minority, who were enterprising traders with close ties to the British, for example, were particularly enthusiastic about the sport. By the mid-1800s, they had formed their own cricket teams.

Thereafter, English sports began to surpass traditional Indian games in popularity, such as local forms of wrestling. Other pastimes, such as "Kabaddi" - a team sport involving chasing and tagging opponents - started to be organized like English sports in the 1920s with rules, formal competitions and federations.

However, leading up to India's



independence in 1947, fierce debates raged over this British influence. Student protesters saw the cricket contests between different Indian groups as "a slow poison given to the rising

Indian generation and blockading the path to independence."

Cricket fans, however, continued to flock to local contests, including the Bombay Pentangular, an annual tour-

nament between teams consisting of Europeans, Parsis, Hindus, Muslims and other minority faiths.

From colonialism to commerce

A major stepping stone in cricket's rise to a national sport was India's 1971 triumph in England. The Indian cricket team defeated the former colonizers at their own game, on their own turf.

Then again, in 1983, India won the cricket World Cup at Lord's Cricket Ground in London - the original home of the sport, once called the "cathedral

In addition to its success in international competition, India has also turned cricket into a multi-billion-dollar industry. The Indian Premier League, inaugurated in 2008, features a fast-paced variety of cricket known as Twenty20. As opposed to traditional "test matches" between national teams that last up to five days, Twenty20 matches are typically completed in three hours and encourage

ccording to new University of California San Diego research, curated product recommendations during online shopping can change whether people buy a product they had been considering.

The findings of the study were published in the journal 'Frontiers in Neuroscience'.

The study by Uma R. Karmarkar, assistant professor at the UC San Diego Rady School of Management and School of Global Policy and Strategy, found that display items that come from the same category as the target product, such as a board game matched with other board games, enhance the chances of a target product's purchase.

In contrast, consumers are less likely to buy the target product if it is mismatched with products from different categories, for example, a board game displayed with kitchen knives.

The study utilised eye-tracking – a sensor technology that makes it possible to know where a person is looking – to examine how different types

of displays influenced visual attention.
Participants in the study looked at their target product for the same amount of time when it was paired with similar items or with items from different categories; however, shoppers spent more time looking at the mismatched products, even though they were only supposed to be there "for display".

"What is surprising is that when I asked people how much they liked the target products, their preferences didn't change between display settings," Kar-

markar said.

"The findings show that it is not about how much you like or dislike the item you're looking at, it's about your process for buying

the item," Karmarkar explained.

"The surrounding display items don't seem to change how much attention you give the target product, but they can influence your decision whether to buy it or not," Karmarkar added.

Karmarkar, who holds PhDs in consumer behaviour and neuroscience, said the findings suggest that seeing similar options on the page reinforces the idea to consumers that they're making the right kind of decision to purchase an item that fits the category on display.

"When the information is mismatched, it changes the scope of the decision. A mismatched display is comparable to shopping in a store with more variety," she said.

"You may consider a featured board game but if you can see other products to buy, this board game may not be the first kind of purchase you want to make. The mismatched items draw additional attention and compete with the category you were considering," she added.

The study involved 58 participants, ages 18 to 40, who had to make 36 online shopping decisions for real products with real money.

The findings showing differences in purchase rates replicate a set of studies Karmarkar published in 2017. In the new research, she was able to measure what parts of the display were engaging more or less attention.

In addition, the upcoming paper shows that matched displays increase purchase rates even when they include more attentiongrabbing information, like details about price.

Karmarkar talked with industry experts about product recommendations systems, which shaped her approach to these questions.

Products can be shown with "mismatched" displays when retailers are using cross-promoting tactics based on prior customer behaviour or inventory they may want to sell more rapidly.

The board game example Karmarkar often uses is based on a real experience she had while shopping online during the month of October.

"I had been browsing games like 'Bananagrams' and when I reloaded the product page, a Halloween costumes display popped up," she said.

"Given my search history, the store probably estimated I had a family. So while I'm sure they wanted me to buy the game, they also knew they had an active shopper who might be interested in the Halloween costumes that needed to sell by the end of the month," she added.

"It looks like a win-win, but our work suggests that creating this mismatched situation could have lowered the chance that I would add the game to my cart," she explained.

While the study is useful for online retailers to know the benefits of showing same-category options on a specific product page, the research is valuable to consumers as well.

"This shows how outside forces shape our decisions in ways we might not recognise. If a shopper is looking for something specific, they are likely to focus their attention, regardless of recommender displays," she said.

"But when people are just browsing stuff online," different page designs can create different patterns of attention. Store displays can change what we choose, even when they don't change what we like," she concluded.

New Delhi (PTI): The Supreme Court Tuesday directed DoT not to invoke the bank guarantees (BGs) of Bharti Airtel for three weeks for recovering Rs 1,376 crore in AGRrelated dues of Videocon Telecom Ltd (VTL) which had sold its spectrum to the Bharti group.

The top court, which refused to entertain Airtel's plea that VTL dues are not payable by it, permit-



ted the telecom major to approach the Telecom Disputes Settlement and Appellate Tribunal (TDSAT) with the grievances.

to deal with the Taliban," a senior sleuth told Kashmir Observer, "our focus will be on narrative control.

Analysts say the ripple-effect of the war-torn country always tends to travel to the strifezone. Following the American departure from Afghanistan, the valley is abuzz with arguments about the possible arrival. What makes these assertions credible for some is the recent statement by military expert, Ayesha Siddiga: "After victory in Kabul, JeM [Jaise-e-Muhammad] has started to talk about Kashmir again. Looks like after the two victories: USSR and US, now it is India's turn."

Indian military veterans don't entirely negate this case scenario.

Seconding Siddiqa, former army chief, General Shankar Roychowdhury, remarked that Pakistan—reinforced by the recent Taliban victory—"will make a fresh bid on Kashmir using groups, such as Jaish-e-Muhammad.

"The victory in Afghanistan is being seen as a Pakistani victory and an Indian defeat," said the general who commanded 16 corps at the height of militancy in Jammu and Kashmir.

"We have to organise ourselves for a renewed offensive by elements like the JeM and have to be prepared for Pakistani intentions (covert operations) supported by radical ele-

ments here." Advising political dispensation in New Delhi to change the tack on Kashmir, the general who currently heads a strategic think tank 'Research Centre for Eastern and Northeastern Studies' said: "We have to step up our outreach to Kashmiris, we also have to re-assure them that India will continue to be a secular democracy".

Throwing weight behind his senior's remarks, the general under whose watch the 2016 surgical strikes were conducted said the militant groups operating in Kashmir will have certainly received a psychological boost with the Taliban takeover of Afghanistan.

"There could be some increase in the infiltration attempts, but the border and the Line of Control is strongly held and I do not see a sudden influx of militants who could destabilise the security situation in Kashmir," Lt Gen (retd) DS Hooda, the former General Officer Commanding-in-Chief of the Indian army's Northern Command told Kashmir Observer.

India today has a much stronger frontier posture and presence as compared to the late 1980s when some Afghan fighters entered Kashmir, he said, "The internal security grid is robust enough to deal with any threat."

Besides, Pakistan isn't in a position to divert any fighters from Afghanistan to Kashmir, the general remarked.

"It carries risks for Pakistan not only from India, but also from the international institutions like the Financial Action Task Force (FATF) that is already keeping an eye on Pakistan. India has also demonstrated that it will react strongly to any major militant attack emanating from Pakistan.'

However, there could be efforts to try and exploit the situation while attention seems elsewhere, warned Lieutenant General (retd.) Syed Ata Hasnain.

"Any situation in Afghanistan always has an effect in Jammu and Kashmir," said the General who used "heart as weapon" doctrine during his Kashmir posting.

"However, our ground domination will ensure this does not manifest negatively or leave any impact. What we need to be careful of is the immediate period before winter this year. Pakistan has a well-oiled recruitment and infiltration system and would wish to put this in

With the Taliban's rise, a number of fighters got freed from responsibilities of fighting in Afghanistan, he said. "Since weapons are freely on sale now, we cannot rule out those who were once part of the Afghan National Army joining in nefarious activity for survival either."

Kashmir will very much be in the loop of violence and counter-violence, if Taliban wishes to aggregate militant groups to Afghanistan, give them safe havens and "sponsor terror" in the region with the help of Pakistan, Hasnain said.

"Much depends on the line that the Taliban adopts. But it is too early to say anything. The Taliban is seeking international legitimacy and its behaviour and attitude may just be different. We have to keep all options open and must not disturb our grids at this time.'

Most of these military vets said that Islamabad has certainly emerged in a position of "stronger influence" in its "strategic depth".

This is a dynamic situation, Hasnain said, and will keep progressing.

"We need agile diplomacy of which we are quite capable," he said. "Taliban is no monolith, it has factions and cliques. We could establish linkages with them and continue to deliver goodwill and soft power to the people."

Earlier, the senior leaders of alliance parties addressed a gathering and discussed the political and security situation in the Union Territory as fallout of August 2019 action. PAGD is a five party conglomerate, including National Conference (NC), Peoples Democratic Party (PDP), Communist Party of India-Marxist (CPI-M), Jammu and Kashmir Peoples Movement (JKPM) and Jammu and Kashmir Awami National Conference (JKANC) spearheading a campaign for the restoration of I&K's semi-autonomous status.

This run of river project is being implemented by Chenab Valley Power Projects Limited, a joint venture of the National Hydropower Company and Jammu and Kashmir State Power Development Corporation (JKSPDC).

"As a responsible upper riparian state, India is committed for full utilisation of its rights and believes in an amicable resolution the issues raised by Pakistan side in letter and spirit of the treaty.

"Pakistan's objections on this project may come up for discussions in the next meeting of the Permanent Indus Commission scheduled this year in Pakistan. In the forthcoming meeting, the Indian side will explain its position and hope that Pakistan will appreciate the same and its apprehensions will be addressed through discussions," Saxena said.

The treaty provides Pakistan the right to raise objection on Indian design within three month of the receipt of the information. India has supplied the information on this project in Iune to Pakistan.

Under the IWT signed between India and Pakistan in 1960, all the waters of the eastern rivers -- Sutlej, Beas, and Ravi -- amounting to around 33 million acre feet (MAF) annually is allocated to India for unrestricted use. The waters of western rivers -- Indus, Jhelum, and Chenab -- amounting to around 135 MAF annually has been assigned largely to Pakistan.

According to the treaty, India has been given the right to generate hydroelectricity through run-of-the-river projects on the western rivers subject to specific criteria for design and operation. The treaty also gives right to Pakistan to raise objections to designs of Indian hydroelectric projects on the western rivers.

India is permitted to construct the run of the river plants on western rivers with limited storage as per criteria specified in the treaty, Saxena said.

Earlier this year, during the meeting between Indus Commissioner of India and Pakistan, Shah also raised objections on the designs of Pakal Dul and Lower Kalnai hydropower projects in Jammu and Kashmir. To this, India said the designs are fully compliant with the treaty.

Pakistan has also raised objections on hydropower projects in Chilling (24 MW), Rongdo 12 MW) and Ratan Nag (10.5 MW) are in Leh; while Mangdum Sangra (19 MW), Kargil Hunderman (25 MW) and Tamasha (12 MW) are in Kargil. India had said the designs of these projects are also fully compliant with the

official spokesperson.

Global football players' union FIFPRO thanked the Australian government for making the evacuation of players, team officials and family members possible, with work continuing to help more leave Afghanistan.

These young women, both as athletes and activists, have been in a position of danger and on behalf of their peers around the world we thank the international community for coming to their aid," the union said in a statement.

The Afghan team was created in 2007 in a country where women playing sport was seen as a political act of defiance against the Taliban.

"The last few days have been extremely stressful but today we have achieved an important victory, former team captain Khalida Popal said.

Popal is among a team of FIFPRO lawyers and advisors who have worked with authorities in six countries, including Australia, the U.S. and United Kingdom, to get athletes and their families on to evacuation lists and flights to safety.

"The women footballers have been brave and strong in a moment of crisis and we hope they will have a better life outside Afghanistan," Popal said.

FIFPRO general secretary Jonas Baer-Hoffmann said evacuations had been an incredibly complex process.

"Our hearts go out to all the others who remain stranded in the country against their will," he said.

Shaheen's 6-51 Puts Pakistan On Top In 2nd **Test Vs West Indies**

KINGSTON: Fast bowler Shaheen Afridi took a career-best 6-51 as Pakistan established control of the second cricket test against the West Indies on the fourth day Monday, placing itself in a position to level the two-match series.

Left-armer Shaheen joined with Mohammad Abbas, who took 3-44, to rout the West Indies for 150, giving Pakistan a commanding 152-run first innings lead. Pakistan captain Babar Azam

then made a bold declaration of its second innings at 176-6 more than an hour before stumps, setting the West Indies a chase for 329 in around 130 overs to win the match and series. The West Indies suffered an-

other blow when opener Kieran Powell was run out for 23 less than 30 minutes from stumps. Captain Kraigg Brathwaite carried his team through to the close when he 17 not out and the West Indies were 49-1, still 280 runs behind. "It was a (helpful) wicket and

Kyle Mayers next ball as the West Indies slipped to 105-6.

Abbas tested Bonner with several deliveries angled into the stump, then caused one to nip away on off stump which took an edge and carried to wicketkeeper Mohammad Rizwan. He then went round the wicket to Mayers who, low on confidence, played at a full length ball angling across him and gave Rizwan another simple catch.

Mayers, grappling with a serious form slump, made a firstball duck in the first innings of the first test and a four-ball duck in the second innings. Blackwood fell to Shaheen

for 33, fending a short ball from the shoulder of the bat to Fawad Alam at gully when the West Indies were 109-7.

Jason Holder led some late resistance, making 26 in just under an hour before also falling to the Shaheen-Rizwan double act when he was beaten by a full ball which moved away late and gave Shaheen his fifth wicket.

Shaheen ended the innings when he removed Kemar Roach, lifting his tally of wickets for the series to 14. He took 4-59 in the first innings of the first test and 4-50 in the second innings, giving him 14 wickets for 160 runs at an average of 11.4 for the series when the West Indies first innings ended.

Pakistan appeared bent on an early declaration when it began its second innings, rushing to 176-6 from 27.2 overs at 6.4 runs per over. The Pakistan top order all made starts but were out relatively cheaply: Imran Butt made 37 and Abid Ali 29 in a 70-run opening partnership; Azhar Ali 22, Babar 33 and Hasan Ali 17 also contributed. Babar had the longest stay at the crease at 73 minutes.

Virat Kohli Heaps Praise On Mohammed Siraj Ahead Of Leeds Test, Says Pacer 'Can Get Anyone Out At Any Stage'

LEEDS: Mohammed Siraj's meteoric rise is hardly a surprise for India skipper Virat Kohli who says the pacer's confidence has now risen to a level where he believes that he can get any batsman out at any point of the game.

The youngest in a lethal quartet also comprising Mohammed Shami, Jasprit Bumrah and Ishant Sharma, the 27-year-old Hyderabad pacer has taken 11 wickets in the first two Tests of the series against England. His impeccable line and

length and control has troubled the home batsmen consistently. Eight of his 11 wickets came at the Lord's Test that India won by 151 runs.

Kohli said the tour of Australia took his confidence to another level.

"I was not surprised at all (with his growth) because have seen him from close quarters. He is a guy who has always had the skill. You need the confidence to back that skill, the Australia series provided him with that boost and confidence," Kohli said at



a virtual media interaction on the eve of the third Test.

"He is walking around knowing he can get anyone out at any stage and the belief in his game has been elevated to another level, hence you see results of what he is doing," the skipper added.

Kohli also said that Siraj's confidence makes him flamboyant.

"I am really happy to see him coming into his own, he is going to be this kind of bowler, who is in your face and who is looking to get guys out and who is not scared, he is not going to take a backward step.' Kohli was also full of praise for his openers -- Rohit Sharma and

KL Rahul -- and expected them to continue their good form. Rohit (36, 12, 83 and 21) and Rahul (84, 26, 129, 5) have given India a solid platform so far in the series.

"The opening combination, when you are playing overseas, is one of the most important factors. So, the way KL Rahul and Rohit Sharma have played, has been outstanding and we hope that they continue in the

Asked if it seems that rival

"I don't know what an individual mindset is? You can make mistakes and planning at any given stage of the match, it does not necessarily mean you are under pressure.

"To set out the right platform from where the team can build on and that is what they provided us in both the Tests so that is definitely a big boost for us," a pleased captain said.

Kohli also said that he expected a different wicket at the Lord's than what the team eventually encountered.

"We were quite surprised to see the pitch the way it was, honestly I did not expect it and I thought there would be more grass. Anything is possible, we name a 12 and on the day, we have a look at the pitch, accordingly, we will go in with the right combination.'
