Afghan Situation Raises New Questions: Rajnath Says Militancy In Kashmir Will End Soon


CHANDIGARH: Defence Minister Rajnath Singh said on Monday that Jammu and Kashmir will soon see an end to militancy as Article-370 and Article-35 A fuelling separatism is over now.

"I believe that the remaining terrorism in Kashmir will also end. I have this belief because the strength and oxygen that the separatist forces used to get there due to Articles 370 and 35A are over now, said Singh.

He was addressing virtually the third Balramji Dass Tandon Memorial Lecture organised by Panjab University on the issue of national security. He said the Modi govern-

ment neither does politics nor allows it to happen on issues related to national security, and added that a free hand has been given to the security forces in performing their duties.

"How high the confidence and morale of the army and



security forces can be guessed from the fact that in the last seven years, they have not allowed a single major terrorist incident in the hinterland of India, he said.

India is not only taking action against militancy within the borders of the country, the brave soldiers of our army have done the work of destroying terrorist hideouts by crossing the border if needed, he said,

referring to the surgical strike after the Uri terror attack and the Balakot air strikes after the Pulwama attack.

'Today we can say that Pakistan-supported model of terrorism is getting demolished in India, he said.

Singh also said that there was a trust deficit between India and Pakistan and the country needed to be vigilant of this fact from the point of view of national security.

Singh said Pakistan had un-derstood that they would not make any gains from violations of ceasefire agreements.

An agreement was signed between the Director General Military Operations (DGMO) of India and Pakistan to maintain ceasefire along the Line of Control in February this year, he said.

2 Infiltrators Shot Dead On LoC

JAMMU: Two militants were killed as Army troops foiled an infiltration attempt along the Line of Control (LoC) in Poonch district of Jammu and Kashmir early on Monday, a defence spokesperson said.

Jammu-based Defence Public Relation Officer Lt Col Devender Anand said the operation is still underway in the area. "In the early hours of August

30, terrorists from across the Line of Control made an attempt to infiltrate in the Poonch Sector. Alert Army troops detected the infiltration bid by effective use of the integrated surveillance grid," he said.

"Two terrorists attempting to infiltrate across the LoC have been successfully neutralised by the troops of the Indian Army who remain ever-vigilant in discharging their duties." he said.





'Stress signals from fat cells can protect against cardiac damage caused by obesity'

stress signal received by the heart from fat help protect against cardiac damage induced by obesity, a new study led by the University of Texas Southwestern Medical Centre researchers suggests. The finding, published online

in Cell Metabolism, could help explain the "obesity paradox," a phenomenon in which obese individuals have better shortand medium-term cardiovascular disease prognoses compared with those who are lean, but with ultimately worse long-term

'The mechanism we have identified here could be one of many that protect the heart in obesity," said study leader Philipp E. Scherer, Ph.D., Professor of Internal Medicine and Cell Biology at UTSW who has long studied fat metabolism.

Ph.D., Assistant Instructor of Internal Medicine at UTSW, explained that the metabolic stress of obesity gradually makes fat tissue dysfunctional, causing its mitochondria - the cellular organelles that generate energy - to shrink and die. Eventually, this unhealthy fat loses the ability to store lipids generated by excess calories in food, poisoning other organs through an effect called lipotoxicity.

Some organs, including the heart, appear to mount a preemptive defence to protect against lipotoxicity. But how the heart senses fat's dysfunctional state has been unknown.

In their study, Dr Crewe, Dr Scherer, and their colleagues used a genetic technique to speed the loss of mitochondrial mass and function in mice. When these animals ate a high-fat diet and became obese, the researchers found that the rodents' fat cells vesicles filled with small pieces of dying mitochondria.

Some of these mitochondrial snippets travelled through the bloodstream to the heart, triggering oxidative stress, a state in which cells generate harmful free radicals.

To counteract this stress, heart

cells produce a flood of protecantioxidant molecules. This protective backlash was so strong that when the scientists injected mice with extracellular vesicles filled with mitochondrial snippets and later induced a heart attack, the animals had significantly less damage to their hearts compared with mice that didn't receive an injection. Further research using fat tissue sampled from obese patients showed that these cells also release mitochondria-filled extracellular vesicles, Dr Crewe said, suggesting that the effects observed in mice also take place

the heart and other organs in obese individuals become overwhelmed by lipotoxic effects, leading to many of obesity's comorbidities. However, learning how to artificially generate the protective mechanism identified in this study could lead to new ways to buffer obesity's negative consequences.

This knowledge could even suggest strategies to protect the heart against damage in lean individuals as well.

"By better understanding the distress signal from fat," Dr Crewe said, "we may be able to harness the mechanism to improve heart health in obese and non-obese individuals alike." Other researchers who contributed to this study include Jan-Bernd Funcke, Shujuan Li, Nol-

wenn Joffin, Christy M. Gliniak, Alexandra L. Ghaben, Yu A. An, Hesham A. Sadek, Ruth Gordiland Christine M. Kusminski, all of UTSW; Dmitri Samovski and Samuel Klein of Washington University School of Medicine in St. Louis; and Pamela Fischer-Posovszky of Ulm University Medical Centre in Germany.

Dr Sadek holds the J. Fred Schoellkopf, Jr. Chair in Cardiology. Dr Scherer is the Gifford O. Touchstone, Jr. and Randolph G. Touchstone Distinguished Chair in Diabetes Research and the Touchstone/West Distinguished Chair in Diabetes Research.

Virtual reality reduces pain, anxiety in children "We can actually reduce pain withmately long-term health outcomes.

Engaging in virtual reality can significantly reduce pain and anxiety in children undergoing intravenous catheter placement, suggest the findings of a new study.

The findings of the study were published in the journal 'JAMA Network Open'.

It isn't a matter of one needle puncture. Many children coming through the doors of Children's Hospital Los Angeles are seen for chronic conditions and often require frequent visits. Painful procedures -- like a blood draw or catheter placement -- can cause anxiety and fear in patients. The study has shown that virtual reality can decrease pain and anxiety in children undergoing intravenous (IV) catheter placement.

For nearly two decades, Jeffrey I. Gold, PhD, an investigator at The Saban Research Institute of Children's Hospital Los Angeles, has been investigating the use of virtual reality (VR) as a technique to help children undergoing painful medical proce-

His research has shown that technology can have powerful effects. VR works so well that Children's routinely for blood draws.

"Some patients don't even realize that their blood is being drawn," said Dr Gold, who is also a Professor of Clinical Anesthesiology, Pediatrics, and Psychiatry and Behavioral Sciences at The Keck School of Medicine of USC

"Compare that to a child who is panicking and screaming, and it's a nobrainer. We want kids to feel safe," added Dr Gold.

In his recent publication, Dr Gold's team reports the results of a study to test whether VR could prevent pain and distress for patients undergoing peripheral intravenous catheter (PIVC) placement.

The game is simple but requires focus and participation. Patients in one group used VR throughout the procedure, while those in another group received standard of care, which includes simple distraction techniques and the use of numbing

The patients who used VR reported significantly lower levels of pain and anxiety.

The mind is incredibly powerful at shifting focus and actually preventing pain from being registered. If we can tap into that, we can make the experience much better for our kids," added Dr Gold.

If, on the other hand, the patient plays a virtual game while undergoing the procedure, she may relax and experience less pain, improving the overall experience for the child, the family, and the healthcare pro-

"Stress actually causes veins to con-



But the story is bigger than that. This is one of the first studies to analyse the effects of VR not only from that of the clinician and the patient's family or caregivers.

All three of these groups reported a more positive experience with the use of VR. Dr Gold calls this triangulation of data -- gathering information from three perspectives in order to improve the patient experi-

"We started this as a way to mitigate pain and overall distress in children. But caregivers and healthcare providers are also reporting improved outcomes. Effectively treating the patient clearly has a ripple effect," added Dr Gold, Consider a typical scenario in which

a child has a chronic illness and must routinely receive PIVC placement. A patient experiencing anxiety

about her procedure may tense up, making it more difficult for the clinician to find a vein and insert the catheter.

If multiple attempts are necessary, a child's fear may amplify, causing a snowball effect, which in turn may impact medical adherence and ulti-

India launching global media blitz on Kashmir

WASHINGTON: India is launching what has been described as "a global-scale media blitz" against Pakistan projecting the Indian interpretation of the 'reality' in Kashmir.

The multi-pronged campaign launched through print, electronic and cyberspace media in some 20 languages will coincide with the UN's millennium session. The idea is to embarrass Pakistan during General Musharraf's visit to New York and to help Indian PM Vajpayee plead India's case.

Full-page colour advertisements are being sought to be published in leading publications like The New York Times, The Washington Post, The Los Angeles Times, USA Today, The Wall Street Journal, The Chicago Tribune, The Times (London), The Straits Times (Singapore), The Bangkok Post, The Jerusalem Post, The Japan Times, The Sunday Times (London), The International Herald Tribune, the Economist, Time, Newsweek, The Financial Times and BusinessWeek, says a report in rediff, an online newspaper. It claims that 1 funds for the campaign are being raised from Indians the world over through contributions. However, a multi-million dollar campaign at this level cannot be launched without the support of the India government, say observers.

The campaign is likely to accelerate the ongoing India-Pakistan conflict to feverish heights, extending it to cyber warfare. The advertisements will project the theme 'jehad' for Pakistan, agony for India' and portray /peace-loving' India's patience even in the face of increasing casualties on its side in J&K, says report. Also in the pipeline are advertisements In French, German, Swedish, Italian, Dutch, Portuguese, Spanish) Finnish/Turkish, Malay, Bahasa Indonesia, Russian, Chinese, Japanese, Bengali, Korean, Norwegian/Thai, Sinhalese and Arabic. The report says this will be complemented with campaigns in cyberspace via an exclusive Web site, agonyofindia. com & e-mails. The full-page advertisements quote the utterances of Pakistan's Chief Executive General Pervez Musharraf to prove Pakistan's involvement in Kashmir militancy.

Reportedly, The Financial Times has expressed reservations about publishing the advertisement, It is claimed that leading ad agencies have been hired in New York and other major cities of the world to handle the latest campaign in multiple languages.

Taliban-led Afghanistan

n Sunday, US forces launched a drone strike in Kabul, targeting a suicide bomber in a vehicle who had been planning an attack on the airport. This was the second such strike since the Thursday suicide bomb blasts at Kabul airport which killed over 200 people - including 13 American troops - and came just two days shy of the US leaving Afghanistan. The Pentagon said that the strike killed two "high-profile" IS-Khorasan planners and facilitators and wounded another.

Taliban has said that after August 31, the US will have "no right" to carry out attacks in the war-torn country. Meanwhile, in a signal that the world is making a tentative effort to engage with the Taliban, the United Nations Security Council has dropped the Taliban reference from a paragraph in its statement on terrorist attacks near Kabul airport that called on Afghan groups not to support terrorists "operating on the territory of any other country".

Also in a reconciliatory signal to New Delhi, a member of the Taliban leadership in Qatar has said that India is very important for this subcontinent and that his group wants to continue Afghanistan's cultural, economic, political and trade ties with India "like in the past".

India would certainly like to test the Taliban's intentions. New Delhi's earlier attempt to reach out to the Taliban in Qatar didn't lead to any positive outcome. Indian current approach towards Taliban is still dictated by the group's previous rule in the country. In its new avatar, the Taliban has signalled it has changed. They have promised an "inclusive government" which respects the rights of women and the minorities. It also granted amnesty to enemies and promised that the people would be allowed to leave Afghanistan safely if they wanted to. The government staff has been asked to return to work. What is more, the Taliban even held a press conference. The spokesman Zabihullah Mujahid said the group won't allow Afghan soil to be used against any other country.

The situation will certainly change for the good if the Taliban translate their promises on running an inclusive government into reality. And if it convinces the world that it has changed. Pakistan, which is regarded as the benefactor of Taliban, is also approaching the issue with some caution. The Taliban is yet to form the government. It will take another few months for the Taliban to settle down. It also remains to be seen whether and what form the resistance to the Taliban will take. And until then, we can only keep our fingers crossed.

Sharia — Nightmare or Salvation? -1

n the Koran, the term sharia means something like "the way (paved by God)", "the way to the source". The term "sharia" encompasses the entire Islamic doctrine of norms. This has developed over 1,400 years – in diverse writings by scholars and institutions, and increasingly in the form of state regulations.

Sharia includes provisions on fundamental beliefs and religious practices, such as prayer rituals, dietary and dress codes, as well as legislation. It also includes aspects of religious ethics – for instance, how to treat the needy and the world around us. At its core, sharia is a very complex, sophisticated, yet flexible system of establishing and interpreting norms.

Due to the denominational split between Sunnis and Shias, as well as differences within the denominations themselves, various schools have emerged that differ considerably in their understanding of sharia. On the one hand, this creates uncertainty, but on the other, it allows for diversity of opinion. In a good tradition, scholars attempt – to the best of their ability and in all humility – to glean the right knowledge, without laying claim to exclusivity. In other words, they recognise the validity of each other's interpretations.

The insistence by extremists of all kinds, past and present, that they are the only ones to have recognised the divine truth points to a lack of education and excessive hubris. Often enough, extremists instrumentalise sharia for very superficial political purposes. Prominent examples can be found in the current religious rgimes of Iran and Saudi Arabia.

Does anyone have interpretative sovereignty? Sharia also draws a distinction between religion (the relationship between God and man in the afterlife) and law (the rules of human co-existence in this world). The religious components of sharia are often regarded as immutable, but they also require interpretation.

Will the Taliban Spillover Reach Kashmir? -Part 2

he official data indicates that not many Afghans had entered the Kashmir insurgency in early 1990s. Data on foreign militants who have been arrested or killed during the years when the Taliban was ruling Afghanistan (1996-2001) is hard to come-by. The South Asian Terrorism Portal (SATP) website used to feature a separate dataset on foreign militants in Kashmir, but that information is no longer available on the website, for unknown reasons.

Most commentators and analysts, therefore, have been using quantifiers instead of specifying the exact numbers or giving rough estimate. For example, journalist Barkha Dutt, in her recent Hindustan Times column (20 Aug) writes: "In the late 1990s and the early part of the 2000s, there was a graveyard in Srinagar, where only foreign terrorists

persons were killed in Kashmir, including 533 security personnel and 2995 insurgents. While the fatalities among the security forces had seen an uptick following the Taliban takeover, the insurgent (and overall) fatalities witnessed a downward trend. How is one to explain this data in relation to the claim that the Taliban takeover in 1996 had a spillover in Kashmir? Based on the parameters chosen (fatalities of security personnel or overall fatalities) the data can be interpreted either way.

Some analysts have corelated the increased conflict-related fatalities after 1989 to the advent of foreign fighters in Kashmir, but one of the main reasons for high fatalities among security personnel was that India's counterinsurgency grid was relatively weaker in the early phase of insurgency and the guerrillas had an upper hand. But since then,

but it will be the only option left with the government if the situation becomes progressively worse. The government should not wait to take action when the push comes to shove. It will be prudent to impose some restrictions now, to prevent the situation from deteriorating. Non-essential travel has mainly contributed to the spike, while it is essential for restoring economic growth but some restrictions must be imposed to keep

the cases under control. The occupancy in hotels, cafes, and restaurants must be slashed to 50%. Restricting travel will eliminate the risk of a disastrous surge without crippling the

economy.

It is important to understand this virus will not vanish into thin air, a complete lockdown is not an option, it will destroy livelihoods. A vaccine shot is not a remedy as well. Though it will play a huge role in mitigating

the severity of the virus, it doesn't eliminate the possibility of its contraction and transmission. As stated by the WHO chief António Guterres, we must learn to live with this virus, complying with the SOPs and refraining from carelessly venturing out will keep the virus at bay.

Job Seeking: The Religious Pilgrimage of 21st Century

A phrase that jobseekers often use to deal with rejection is: "It wasn't meant to be." This evokes a divine plan, where the invisible hand of the market echoes the hand of God.

t's the journey, not the destination" seems like a modern proverb, because it emphasises experiences over results and promises personal transformation. However, millennia ago, theologians like Saint Augustine described life itself as a pilgrimage through the world, returning to God by purifying the self.

While many people still conduct religious pilgrimages, today that outlook can perhaps more commonly be found in a less obvious place: among those looking for work. From the "ranks of the unemployed" and the "dole queue" we've moved to the image of active jobseekers, polishing their CVs, always networking and discovering opportu-

Of course, the reality is often more than the image, but in the face of uncertainty, we rely on models and metaphors. These stories shape how we interpret our experiences, and often come with a lot of historical baggage. Pilgrimage means more than the fairytale phrase "off to seek your fortune"; it implies suffering, doubt and selftransformation, making jobseeking into a trial of the soul.

For the last decade I have interviewed unemployed people about their experiences of looking for a job. My sociological approach combines qualitative interviews and historical illuminations of the present to find out how people view the process of job-seeking.

What has become clear is that people don't understand job-seeking as a simple labour market where supply meets demand. Instead, moral judgements surround unemployment, and all too often people internalise stigmatising ideas derived from politics about "skivers" or "spongers" – stereotypes repeatedly refuted by research.

Surprisingly, Christian pilgrimages provide an unacknowledged model for making sense of complex job-seeking experiences. Medieval people undertook pilgrimages individually, travelling to distant shrines as a penance to purify themselves of sin, to transform themselves through a trial of faith.

On the way, they interpreted the world as full of signs and symbols, tests and temptations which they struggled to overcome to ensure their salvation. Today, we interpret the labour market similarly. It is a place of pilgrimage, where people seek guidance, decipher clues and purify themselves until they reach the salvation of a job.

A religious quest

Modern society considers itself secular, with religious beliefs confined to matters of personal morality or community customs, or even derided as superstitions without rational founda-



tion. However, dismissing religion out of hand as antiquated and irrelevant may mean that we repeat it unbeknown to ourselves.

In my research I've interviewed dozens of jobseekers who describe their efforts at finding work in peculiar ways. A phrase that jobseekers often use to deal with rejection is: "It wasn't meant to be." This evokes a divine plan, where the invisible hand of the market echoes the hand of God.

Jobseekers are not fatalistic but reapply themselves relentlessly to a pilgrimage of self-purification, where the difficulties of being unemployed are a test of faith. Beyond simply listing their qualifications and experience on a CV and slinging it into any relevant application, they struggle to interpret their experiences and reorient their efforts in complex ways.

I interviewed "Bob" several times since he was made redundant from a mechanical job and unemployed for several years after the 2008 financial crash. He carefully tailored each job application and noticed the manner of rejection - whether being ignored or issued a standard letter.

Once, he received a letter which was signed by hand and made reference to his long experience and volunteering as valuable - he took this as a sign that he was "on the right road". Once he found a job, combining administrative and gardening work, he felt that everything had "come together", even though he had often verged on despair while unemployed, but had never given up.

As a substitute teacher, "Rachel" experienced repeated rejection. Each morning she was ready to work from 7am and waited hopefully for a call until 9pm. From then until the next morn ing, when she would repeat the process, she looked for ways to improve herself – wrote other job applications, did web-based professional development. Yet, when called to interview for a permanent full-time job, another applicant succeeded, and Rachel blamed her own lack of confidence and skills and resolved to gain more experience.

These stories reflect a pervasive narrative. Rather than a labour market where supply and demand meet, individuals tend to interpret the hiring process as a personal test. They look for clues, about the terrain ahead but also as feedback that tells them how to improve themselves. Rather than shrugging off repeated rejection as simply inevitable, it is taken as a form of suffering which purifies the individual. In short, the imaginary journey through the labour market is interpreted as a pilgrimage towards personal salvation.

Signposts on the pilgrim's road

In the welfare office and beyond, job seeking is often presented in implicitly or even explicitly religious terms.

The author of the best-selling international guide to job seeking What Colour is your Parachute? was Episcopalian clergyman Richard Bolles. Notably, he positions job seeking as a job in itself, a vocation, deserving as much time, attention and hard work as any employment.

Rather than sticking to simply filling out job applications or handing in CVs to potential employers, Bolles vision of job seeking is all-consuming. Friends and family are considered a network, a resource for information or recommendations. At every waking moment, the jobseeker should be alert for clues and leads that might alert them to their opportunities.

Perhaps unsurprisingly, Bolles expresses his religious faith, saying that seeking work is not just hoping to gain a salary, but a search for a way of life. He acknowledges that becoming unemployed is difficult but suggests that it is a trial sent by God. Such suffering must be endured patiently, despite personal doubts. Having faith in one's potential,

being willing to learn and trusting that the world will reward honest effort are supposedly bound to lead to success.

Bolles is not alone. Consider the title The Gift of Job-loss, which positions unemployment as an opportunity for personal transformation. While such religious language might well be expected from the US, where Christianity still plays a prominent role in public and political life, it can also be detected

For instance, writer Christine Ingham's self-help book Life Without Work describes unemployment as a test, for which the reader should consider themselves specially selected:

the difficulties we are given are there to help us grow, and that we are never given problems that are more than we can cope with. This is so hard to appreciate at first when we are being tested by the new challenges that face us.

Considering challenges as a means of refining character strongly echoes the test of individual faith in biblical epistles

My Christian brothers, you should be happy when you have all kinds of tests. You know these prove your faith. It helps you not to give up. The man who does not give up when tests come is happy (James 1:2-5).

Whether the career advisor is familiar with these verses is less important than recognising that they have become commonplace advice for job-

Online sources have now largely replaced such books, with advice proffered by official government sites like Find a Job or companies like Monster. Whether the advice is actually useful or not is unclear; since it is available to everyone, it scarcely provides any strategic advantage.

Although very brief and technical, these guidebooks encode religious models. Readers are asked to examine themselves, to find their weaknesses and work upon them, akin to confession. Unemployment is positioned as a trial to be overcome by constant effort. The labour market is a mysterious world to be deciphered, searching for clues, even taking rejection and failure as a signal of how to transform oneself.

Religious hangovers like pilgrimage give meaning and coherence to difficult experiences, providing hope. However, they also reconcile individuals to inequitable systems and make the unemployed personally responsible for the lack of jobs. Culturally, and especially in terms of social policy, we need to stop presenting job-seeking as a personal test of finding yourself and focus on providing decent work, or real alternatives in education

et's kick things off with a story: The Schizophrenic It was back in secondary school. I was n the upper annex of the library talking with a few non-Muslim classmates about Tongue of Liberty the Charlie Hebo attack, which had only happened

a matter of days ago and was still fairly fresh in the news cycles. Whilst emphasizing my disapproval of the attack I also contextualized the events; addressing the marginalization of Muslims in France - particularly Moroccans and Algerians – and my equal disgust with the cartoons the magazine had published, telling them about how dear the Prophet (PUBH) was to all Muslims... My thoughts were dismissed as an insensitive justification for the attack. Fast-forward to the morning after the Paris at-

tacks. In the school's canteen, I found those same classmates of mine laughing incessantly at memes mocking the victims of that mass shooting... which somehow wasn't insensitive?

One could go on about the double standards and inconsistencies of liberal ideals of free speech till judgment day. Time and again, the discussion around free speech proves to be fruitless and the romanticized notion of the subject is ever vapid and shallow.

The recent incident at Batley Grammar, and the sensationalized coverage of the peaceful protest by Muslim parents expressing their protective love for God's final apostle (), sadly, seems a run-of-themill event by this point in the UK and Europe more broadly. Setting aside my own disdain for the act which set off the protests - which the regular readers of Traversing Tradition will undoubtedly share - there is a curious aspect of the scare-mongering by mainstream media outlets and the quixotic champions of laïcité in light of this and the wider cultural context in the digital age which is worth noting. Not only for the contradictory nature of free-speech discourse, but for a host of reasons, the least of which being how deep-seated these contradictions are in the public psyche. This is what I mean by schizophrenic.

The aforementioned story is just one personal anecdote, and with the rise of cancel culture in the years that followed, there is a galaxy of examples demonstrating similar inconsistencies. What began as a movement through which victims of sexual harassment and assault - disillusioned with the state's ability to provide justice - turned to social media for support, has rapidly grown into an umbrella for a series of boycotts on public figures [for their speech as well other actions]. These boycotts appear at once both disjointed yet oddly selective.

To take some examples from the literary world, comments by author Liu Cixin justifying the persecution of the Uvghurs, or Nobel Laurette Peter Handke's denial of the Bosnian genocide, inspired a lukewarm response in the digital public. Contrast these, for instance, with J.K Rowling's remarks on transgenderism which caused a social media storm from which her reputation amongst life-long fans is yet to recover. Whilst the first two cases weren't exactly lauded or defended for their views/comments, their expressions clearly had little to no consement upon your own civil liberty.

While one may well draw analogies to further highlight these hypocrisies and double standards; 'would you defend the teacher's freedom to use the N-word in class?," "would you defend their freedom to insult Jews?" etc., these analogies have been drawn before. The fact of the matter is that for such self-righteous pundits, those contradictions don't matter. Recognizing them would mean recognizing the façade of their notion of free-speech. It would mean acknowledging that not all speech is equal and that moral frameworks and cultural sensibilities define what's deemed acceptable. That even if

quences for them (Cixin's acclaimed novels are still slated for a Netflix adaptation by the producers of Game of Thrones).

A deeper irony of free speech trumpery is the elitist exclusivity with which the subject is valorized. More often than not, the most impassioned pundits for defending their free expression tend to be those who've never had said freedom hampered in any significant way. It's the comedians who sell out stadiums, the celeb journalists, and the talk show hosts who have the largest soapboxes money can buy. It's that same class of people and the institutions they represent who take the greatest offense to reactions such as what we've seen at Batley Grammar. All of the news and entertainment media wants to convince you that somehow, one group freely expressing themselves in a manner supposedly safeguarded by the legal system is an infringewe tokenistically acknowledge the "right" to offend, that doesn't mean we tolerate it from everybody.

Fundamentally speaking, there are certain types of speech that, one might observe, are almost universally discouraged. Should a news network, for instance, be allowed to publish lies under the banner of "free speech"? Whether or not some do is out of the question, but in principle, we expect honesty as a default courtesy from one another. Respect is another basic expectation, one which apparently bears no relevance in this ideal of free speech. What critics of the Batley protests - as well as all other instances of expressing offence on religious grounds - mean when they invoke "free speech" is that their right to insult you is more precious than your right

to be respected. More bluntly, "our speech matters more than yours". These critics are often the last to show

any concern for the expression of Muslims being curtailed by the state and other forces. Where was the outrage from these partisans of liberty when a 4-year-old Muslim boy was referred to Prevent over a reference to the game Fortnite, or when a Muslim girl is sent home from school for wearing a long skirt? The pundit class that laments against the "tyranny" which dampens their free speech are not coming from a community that lives that reality. They speak from an ivory tower built on blind eyes turned away.

This is in fact quite run-of-the-mill for any paranoid majority; demanding conformity from a minority community in order to legitimize their presence, even if it be at the expense of said minority's values. The UK's pluralism is a conditional one, in that it only allows nominal differences to the status quo.

Despite several decades of significant presence in the country, the Muslim community is still faced with having to dilute its own expression in compliance with a Westphalian standard of what is and isn't appropriate conduct. It's a half-baked tolerance; we are expected to tolerate disrespect hurled towards us but shouldn't respond in a way that might challenge the values that enabled such disrespect. To borrow from Sara Sherbaji:

You're expected to live your life acquiescing to the moral standards of the West and they can't spend a minute entertaining the legitimacy of yours without accusations of inferiority.

The champions of free speech choose to disregard understanding and chant the mantra of liberty instead of considering the fact that not everybody sees the world in the same way as they do. That not everybody has the same sensibilities as them, that they might not share the same paradigm and have different taboos altogether. But of course, asking to take such things into consideration would be 'tyrannical' and 'P.C'

Pakistan's Borders Are Secured, Prepared To Meet 'Any' Challenge: Gen Bajwa

ISLAMABAD: Pakistan Army chief General Qamar Javed Bajwa on Monday assured lawmakers that the country's borders are secured and his forces are prepared to meet "any" situation, amid the evolving situation in neighbouring Afghanistan.

Briefing members of parliamentary committees on internal and external security, including Kashmir, at the General Headquarters (GHQ) in Rawalpindi, Gen Bajwa also highlighted the importance of restoration of peace in war-torn Afghanistan for sustainable development of the region.

"Due to our timely steps for western zone border management, today despite challenges Pakistan's borders are secure and we are prepared to meet any situation," Gen Bajwa was quoted as saying by the Inter-Services Public Relations (ISPR), the media wing of the army.

The delegation comprising members of the Parliamentary Kashmir Committee, Defence Committees of the Senate and National Assembly was given detailed briefing on the security environment, including the situation on the borders and army efforts for

peace and stability. The delegation also had an exhaustive interactive session with General Bajwa.

It was the first security briefing by the military authorities to parliamentarians since the Taliban took over Afghanistan in mid-August and the deadly terrorist attacks carried out by the socalled Islamic State in Khorasan Province (ISKP) in the neighbouring country, Dawn reported.

The Taliban seized power in Afghanistan on August 15, two weeks before the US was set to complete its troop withdrawal after a costly two-decade war. This forced Afghan President Ashraf Ghani to flee the country to the UAE.

Gen Bajwa also said that peace without resolution of the Kashmir issue was not possible.

'The world must know that without a peaceful resolution of the Kashmir issue, peace and stability will remain illusive," Gen Bajwa said as he reiterated the army's support and commitment to Kashmir cause and people of Kashmir.

The briefing session concluded with resolve to continue the struggle against violent extremism through a synergetic, wholeof-the-nation approach, according to the ISPR statement

Earlier in the day, Interior Minister Sheikh Rashid Ahmed had said that Pakistan Army is present along the border with Afghanistan to defend every inch of the country. "Around 2,690 kilometres of Pak-Afghan frontier has been fenced."

Pakistan People's Party (PPP) Senator Raza Rabbani had demanded that instead of the GHQ, the briefing should be held in the Parliament House.

On July 1, a similar briefing was given to parliamentary leaders of political parties at the Parliament House during which military and intelligence leaders had called for avoiding divisive politics on issues of national interest and cautioned that strategic challenges and related policy shift in external relations could have repercussions for the country.

The previous briefing was reportedly given by Inter-Services Intelligence (ISI) Director General Lt Gen Faiz Hameed to parliamentary leaders, including Opposition Leader Shehbaz Sharif, on the spectrum of possible threats and regional environment - the situation that was emerging in Afghanistan at that time in the wake of US troop withdrawal and the stalemate in peace talks.

the neighbouring nation has taken place ever since the agreement was signed.

Pakistan understands that it is not in position to do much in Kashmir, especially after the nullification of Article 370, he said.

He said Pakistan had suffered defeats in 1965 and 1971 wars and these defeats completely proved that it was not in a position to launch a full scale war against India.

"What is happening in neighbouring Afghanistan is raising new questions in terms of security and our government is constantly monitoring the developments there," Singh

Along with the security of Indians, he said, "Our government also wants that anti-national the border by taking advantage of the develop-

"We have some more concerns which can become challenges from the point of view of national security," he added.

The Taliban took control of Afghanistan on August 15, capturing all major cities in a matter of days, two weeks before the US was set to complete its troop withdrawal after a vexatious two-decade war. Earlier this week, an Islamic State suicide attack outside the Kabul airport killed over 180 people.

Singh said that the Narendra Modi government was alert and capable of dealing with any

The defence minister laid stress on continuously upgrading and updating the national security system to face new challenges and said that some new threats have emerged because of the development of modern technology. He referred to the dropping of two bombs

using drone at the Jammu air force station earlier this year.

"We have to continuously update and upgrade the national security system for new challenges, said Singh.

He said the government's aim is to make the country prosperous, strong and secure. Such an India that does not scare anyone but develops a sense of security among small nations and that India's growing power is not a threat to them,"

which the armies of both countries follow to conduct patrols. Referring to the clashes in eastern Ladakh last year, Singh said Chinese forces had ignored the agreed protocols.

In the first deadly clash in the border area in nearly five decades, 20 Indian soldiers were killed on June 15 last year in the Galwan Valley in fierce hand-to-hand combat with Chinese troops, triggering a large deployment of troops and heavy weaponry by both armies at the friction points in eastern Ladakh.

In February, China officially acknowledged that five Chinese military officers and soldiers were killed in the clashes with the Indian Army though it is widely believed that the death toll was higher.

In a significant forward movement towards the restoration of peace and tranquility in the region, the Indian and Chinese armies completed the disengagement process and restored the pre-standoff ground position in Gogra in eastern Ladakh after 15 months.

The development came after the 12th round of military talks between the two sides on July 31 at the Chushul-Moldo meeting point in eastern Ladakh.

Earlier, the Indian and Chinese frontline troops had conducted the first synchronised disengagement at the south and north banks of the Pangong lake in February.

The Army is trained to press the trigger on seeing the movement of the enemy, but the Indian Army has shown both courage and restraint while working with great maturity, Rainath Singh said.

The number of active cases rose to 1,264 in the union territory, while 3,19,582 patients have recovered so far, the officials said.

The death toll in the union territory due to the pandemic was 4,407 as no fresh death was reported in the past 24 hours.

Meanwhile, the officials said, there were 44 confirmed cases of Mucormycosis (black fungus) in the union territory as no fresh case was reported since Sunday evening.

They noted that the number of available sequences of C.1.2 may be an underrepresentation of the spread and frequency of the variant in South Africa and around the world.

The study found consistent increases in the number of C.1.2 genomes in South Africa each month, rising from 0.2 per cent of genomes sequenced in May to 1.6 per cent in June and then to 2 per cent in July.

"This is similar to the increases seen with the Beta and Delta variants in the country during early detection." the authors of the study said. According to the study, C.1.2 lineage has a

mutation rate of about 41.8 mutations per year, which is about twice as fast as the current global mutation rate of the other variants. Over half of the C.1.2 sequences have 14 mutations, but additional variations have been no-

ticed in some of the sequences. "Though these mutations occur in the majority of C.1.2 viruses, there is additional variation within the spike region of this lineage, suggesting ongoing intra-lineage evolution."

the authors of the study noted. About 52 per cent of the mutations in the spike region of the C.1.2 sequences have previously been seen in other VOCs and VOIs.

The spike protein is used by the SARS-CoV-2 virus to infect and enter human cells, and most vaccines target this region.

The mutations N440K and Y449H, which have been associated with immune escape from certain antibodies, have also been noticed in C.1.2 sequences. "While these mutations are not characteristic of current VOCs/VOIs, they have been asso-

ciated with escape from certain class 3 neutralising antibodies," the authors wrote. They noted that these mutations together with changes in other parts of the virus likely help the virus evade antibodies, and immune

Clinches India's 2nd Gold In Paralympics With Stunning World Record Show

avelin thrower Sumit Antil clinched India's second gold at the ongoing Paralympics, shattering the men's F64 category world record multiple times in a stunning Games debut performance here on Monday.

The 23-year-old from Sonepat in Haryana, who lost his left leg below the knee after he s involved in a motorbike accident in 2015, sent the spear to 68.55m in his fifth attempt, which was the best of the day by quite a distance and a new world record.

In fact, he bettered the previous world record of 62.88m, also set by him, five times on the day. His last throw was a foul. His series read 66.95, 68.08, 65.27, 66.71, 68.55 and foul. Australian Michal Burian (66.29m) and Sri Lanka's Dulan Kodithuwakku (65.61m) took the silver and bronze respectively. The F64 category is for athletes with a leg amputation, who compete with prosthetics in a standing position. A student of Delhi's Ramjas College, Antil was an able-bodied wrestler before his accident which led to the amputation of his leg below the knee. A para athlete in his village initiated him to the sport in 2018. He also competed against Olympic champion Neeraj Chopra in the able-bodied Indian Grand Prix series 3 on March 5 in Patiala.

He finished seventh with a best throw of 66.43m while Chopra shattered his own national record with a big effort of 88.07m.

He won a silver in the F64 javelin throw at the 2019 World Championships in Dubai. Shooter Avani Lekhara had claimed the women's 10m Air Rifle Standing SH1 event gold in the morning.
