SPOT LIGHT

Kashmir's Islamic Geometrical Designs Are 'Secular In Appeal' – How?

f you can wrest your eyes away from the harlequin colours of the intricate Papier-mâché hand-painting on Srinagar's Khanqah-e-Moula's front deck, and look inside the halls of this venerated sanctum, your eyes will be enraptured by intricately carved khatamband hand-painted in jewel tones.

Besides being one of the oldest mosques in Kashmir, Khanqah-e-Moula is a study into Islamic design and its radical experiment in geometry and form practiced in the Islamic world spanning from Persia, the Middle East, Central Asia, North Africa, Iberia and parts of India from the 8th Century onwards.

With Kashmir's history being interlaced with erstwhile Persia and its cultural as well as religious practices, the influx of what is now an open air encyclopaedia of Islamic design is hardly surprising.

The Islamic world's contribution to mathematics is pivotal in the advancement of the subject with scholars bringing the worlds of Indian and Greek

mathematical developments together. One of the most celebrated achievements of Islamic mathematicians lies engraved on the walls of Islamic religious institutions across the world in the form of complex geometric patterns on mosques, shrines, seminaries, and residential buildings, amplifying mathematics to an immortal art form.

"Any element of design which features prominently in Islamic Muslim religious architecture can be defined as Islamic design," notes Hakim Sameer Hamdani, Design Director at INTACH Kashmir and a PhD scholar in Islamic Architecture.

"One of the easily identifiable markers is the refrain from using figural depiction; it's not a total exclusion, but generally there's a tendency to make things more abstract and to avoid such depictions anywhere.

Geometry, Hamdani says, is something that's very well-established



across regions, and timeframes in the body of the Muslim civilisation.

It's in geometry that the mathematical elegance of Islamic design takes root. But unlike the complex visual outcomes of these designs, the foundation is elementary; no matter how intricate the design, they can all be conceived on the parma, the trace of the design, with the help of a pair of compasses, an iron nail, and a thread. "A good part of it [Islamic design] is dedicated to mathematics," Hamdani continues.

"There're certain motifs which

couldn't have been worked about without a very precise understanding of geometry and mathematics. You've a geometrical form, so there're innumerable expressions that you can give to it."

The designs on the walls of the Alhambra in Spain to the Selimiye Mosque in Konya or, closer home, the Khanqah-e-Moula are visual evidence of the infinite design opportunities that are contained in simple geometric forms, made possible with elementary tools.

But to simplify Islamic design and break it down to just figures would be undermining hundreds of years of craftsmanship and excellent design.

For it's the intelligently calculated mathematical puzzle, variations and repetitions (known as tessellation) in geometric shapes, and abstraction that result in the bewitching designs that inspire wonder and contemplation.

"At the end," Hamdani says, "it's the variation in terms of one single motif." Islamic design essentially is a composition of • More On P10



From KO Archives Census Held I Div Com Cajoles Union Leader

SRINAGAR: The second and final Phase of the census operation in Kashmir, scheduled to begin today, failed to take s off with most government employees detailed for the purpose not reporting for duty following militant threat to eliminate those taking part in the exercise.

Director census of Jammuand Kashmir Feroz Ahmad said he had not received any information about the progress of the operation till 1500 hours , today. He said the operations had begun in Jammu and Ladakh regions. "I can't say if the operation had begun in Kashmir valley. I can't even say that the operation had not begun at all", he told reporters.

However, he said the job of the directorate of census is to dispatch the material to the concerned wards which has been completed in time. In Srinagar, the material had not been received by the staff in 15 segments, He said the position would become dear in a few days.

Official reports reaching here said the employees did not receive the material and did not take part in the operation. But officials in the divisional commissioner's office here

claimed, that, employee turned up to collect the census material in Budgam. Anantnag and Kupwara districts.

"The exact information from all over the Kashmir valley is not known, especially in Srinagar", the officials said adding the director-of census has been summoned to obtain information about progress of the operation.

A PTI reporter who visited the directorate of census and other areas in the city found that out of 98 employees in Brain-Nishat in ward number one, only five employees turned up to receive the material for the area.

Two prominent government employees unions, State Employees Con-ference and Employees and Workers Confederation had directed the staff not to endanger their lives by participating in the operation in view of militants' threat to train their guns on those taking part in the exercise.

Over 22,000 enumerators were trained to conduct the census, to be concluded on September 30, he said adding the first phase was undertaken from May 16 to June 5 this year. House listing with the civic and other amenities available at the household and locality levels was done during the first phase which, however, went off without any problem.

An official handout issued here today said the divisional commissioner had a detailed discussion with the representatives of some employees' organisations and assured them the government would take all possible steps to ensure their security. The j statement claimed the representatives informed the divisional commissioner that "they had neither issued any statement to boycott the census duty nor have intention to do so".



STATE **NC Leader Wazir Cremated In Jammu**

JAMMU: Thousands of people including former Jammu and Kashmir chief minister Omar Abdullah on Saturday attended the last rites of prominent National Conference leader T S Wazir here as various organisations demanded a CBI probe into his murder in Delhi.

Wazir, 67, a former member of the Jammu and Kashmir Legislative Council, was found dead in a flat in West Delhi's Moti Nagar Thursday morning. Police are looking for two suspected persons who are believed to be behind his assassination.

A case of murder was registered in the matter and the investigation was transferred to Delhi Police's Crime Branch with the force's Special Cell to assist it.

As the body of the deceased reached his Gandhi Nagar residence here from Delhi, thousands of mourners turned up to pay their last respects to the deceased. Wazir was a leading transporter who was also the chairman of All J-K Transport Welfare Association and Jammu District Gurdwara Parbandhak Committee (DGPC).

Senior National Conference leaders including vice president Omar ing Jammu DGPC have demanded a CBI Abdullah and provincial president probe into the killing of Wazir.

Devender Singh Rana also took part in the funeral which was also among others attended by senior BJP leader and former deputy chief minister Kavinder Gupta and senior

former minister Raman Bhalla. Abdullah was seen consoling the bereaved family of the deceased including his wife and son who were in Canada and returned after the news of Wazir's death.

Wazir was a leader with qualities of heart and mind, who served the people in his different capacities. With his death, the National Conference has lost a public spirited leader and the vacuum created will be difficult to fill, Rana said, expressing solidarity with the bereaved family. Wazir reached Delhi on September 2 and was scheduled to leave for Canada to visit his son. However, his highly decomposed body with his head wrapped in a plastic bag was found in the washroom of the flat after his family approached police to know his whereabouts

Husband Among Three Arrested For Murder Of Woman In Kishtwar

JAMMU: A man, along with his brother and mother, was arrested for allegedly

killing his wife in Jammu and Kashmir's Kishtwar district, police said on Saturday.

The woman was strangled by the trio under a well-planned conspiracy hatched to pave the way for another marriage of the husband of the deceased, a

police spokesman said. He said police started inquest proceedings into the death of Neetu Devi, a resident of Horna village of Mughal Maidan, after her body was found hanging at a committee hall on July 11.

Her in-laws had started performing her last rites without informing her parents who lodged a police complaint.

Initially, the in-laws of the deceased woman stated that she has committed suicide by hanging herself, but during the course of enquiry, some foul play into the matter was

Numbers Behind Numerics

Facade of University Rankings

n NIRF-2021 (National Institutional Ranking Framework) rankings, University of Kashmir has received an overall score of 44 points, and accordingly ranked at 76th position among the universities and higher education institutions all over India. But in near identical media headlines, which appear more like public relations, emphasis is placed on the part that Kashmir University has been adjudged as one of the top-50 universities. On 10 September, the Valley's largest English newspaper. Greater Kashmir, wrote: "The [Kashmir] University has ranked at 48th position among universities assessed under NIRF-2021." In truth, the story is a bit different, and complicated.

In NIRF, there are 5 key parameters: Teaching, Learning and Resources (TLR); Research and Professional Practice (RP); Graduation Outcome (GO); Outreach and Inclusivity (OI); and, Perception (PR). These broader parameters are further divided into 15 sub-parameters. And it is here the story becomes more complex.

The KU has performed reasonably well with respect to 6 sub-parameters: student strength, facultyteacher ratio, faculty with PhD and experience, university examinations, women diversity, and facilities for physically challenged students.

However, the university's score on 8 out of 15 sub-parameters has been quite poor. For Intellectual Property Rights and Patents, it has received zero. For sub-parameter Economically and Socially Challenged Students, its score is 0.86 out of 20. Its Peer Perception ranking is 2.18 out of 100

Perception component is measured by NIRF "through a survey conducted over a large category of Employers, Professionals from Reputed Organizations and a large category of academics to ascertain their preference for graduates of different institutions.

The university's score on 8 out of 15 subparameters has been quite poor. For Intellectual Property Rights and Patents, it has received zero. For sub-parameter Economically and Socially Challenged Students, its score is 0.86 out of 20. Its Peer Perception ranking is 2.18 out of 100

Comparatively, Perception ranking of Jamia Millia Islamia (JMI) is 20.25, while for Aligarh Muslim University (AMU) it is 27. Private institution. Lovely Professional University, has a Perception

ranking of 20.70. In some media reports, KU's NIRF-2021 ranking has been hailed as "continuing...march towards academic excellence." A top KU official has been quoted as saying, "Besides the top research, KU has been improving in every aspect to provide advanced and quality education to its students.

In truth, in many aspects KU needs serious rethinking and strategic planning to improve. March towards academic excellence is nothing but a cliched marketing line. Based on the NIRF assessment. KU's research performance is not at par. Out of the score of 35. KU has received just 7.34 score for Publications (PU), and 10.30 score

for Quality of Publications (QP). For the sub-parameter Footprint of Projects and Professional Practice, the university has received a 1.86 score out of 15.

In comparison, PU score of AMU is 15.84, while its QP score is 20.94. JMI's PU score is 16.60 and QP score is 19.93. In NIRF-2021 rankings, Lovely Professional University is ranked at 81st position, while Kashmir University is ranked 5 points ahead at 76th. But even LPU has a slightly better score in Research parameters than Kashmir University. LPU's Publication score is 7.47 and Quality of Publication score is 10.98.

Similarly, Pondicherry University is ranked at 87th position in NIRF-2021, but its PU and QP scores are far better than KU at 13.45 and 15.23. In fact, Pondicherry University has scored 1 out of 15 in Intellectual Property Rights and Patents, while KU has scored zero,

despite Pondicherry University having lesser resources and fewer faculty (339) than Kashmir University (552).

In the financial year 2019-20, while KU received over 36 crore rupees (actual amount 364048918) on account of sponsored research, PU received only 9 crore (actual amount 91337282). KU paid over 250 crores in salaries to teaching and non-teaching staff, PU paid 137 crores. In the same period, KU spent over 27 lakh rupees on Seminars/Conferences/Workshops, while PU spent 16 lakhs. For new equipment for laboratories, KU spent over 9 crore rupees, while PU spent only 2 crores. In terms of financial resources, KU definitely fares better than PU, and yet on research parameters a new university like PU (established in 1985) has better performance than KU.

In some of my columns published in these pages, I have highlighted the broader issues besetting research at KU, particularly in social sciences. Instead of threatening a critic with a legal suit, it would serve the KU admin and faculty well if they take constructive criticism in the right spirit and focus on the areas that need restructuring and redressal. You will know the problems if you see them, but if you choose to bask in a false glory (of being among the top-50) decay awaits you. The NIRF-2021 has provided an assessment of KU's overall performance, and there are more than 8 parameters that need immediate attention. Public relations is fine, but finding imaginative solutions to the problems is what takes institutions forward and makes them leaders and harbingers of change and progress.

The New York Times Magazine published a feature article profiling a former FBI agent who was imprisoned by the US for exposing the rampant abuses in the government's domestic "war on terror". In the piece, Terry Albury recounted the FBI's systematic harassment and intimidation of American Muslims, its spying on the community, and its prosecution of many of its members under the guise of combatting terrorism.

Upon joining the FBI shortly after the attacks of September 11, 2001, Albury recalled, "It was made very clear from day one that the enemy was not just a tiny group of disaffected Muslims. Islam itself was the enemy." Its uniquely candid and self-reflective tone notwithstanding, there was little in this account that would come as a surprise to most American Muslims.

Twenty years on from the launch of a war that would place an entire minority population under a cloud of suspicion, it is worth examining how the lives of American Muslims have been irrevocably transformed. As securitised subjects, they have existed on one of the many front lines in the global war on terror, forced to reassess their identity and core values in the name of belonging.

Islamic traditions, beliefs and practices were sloppily anatomised by an emergent class of self-proclaimed "terrorism experts", talking heads with questionable qualifications who coined flashy buzzwords like "Islamofascism" and warned that Sharia was little more than a pathway to Or wellian totalitarianism.

At the same time, Muslims became an increasingly racialised category subjected to forms of discrimination that parallelled the treatment of targeted minorities throughout US history. More than 80,000 Muslim immigrants were called in for questioning by federal agents and required to enrol in a national registry. Tens of thousands more were searched and interrogated at airports and prevented from travel through the use of no-fly lists. Simply wearing a headscarf or growing a

cally targeted in several waves. In the initial phase authorities singled out prominent community leaders and institutions.

A community transformed

As the mass securitisation of American Muslims became a permanent fixture of daily life, one had to wonder how any faith community could continue to meet its basic needs under such conditions. In time, American Muslim communal identity became practically inseparable from the war on terror's rhetorical machinery. In his 2005 book Good Muslim, Bad Muslim, Mahmood Mamdani argued that US imperial power distilled the entirety of the Islamic faith into these binary categories "to cultivate the former and target the latter"

Consequently, an Islam redefined largely in response to systemic Islamophobia compelled some American Muslims to reframe their ethical commitments to suit the demands of formal acceptance. After having silenced its leadership, weakened its institutions, and targeted its most vulnerable, the domestic war on terror's third phase was marked

can Muslims "do more" to condemn violence committed by any Muslim anywhere in the world had visibly reshaped the community's priorities. Not only were American Muslim institutions pressed to remain silent in the face of abuses committed against their own community, but they were also constrained from offering critiques of an American imperial project that was devastating

much of the world, for fear of being labelled terrorist sympathisers.

Instead, many community organisations refashioned their agendas to accommodate the government's Countering Violent Extremism (CVE) programme. Millions of dollars in funding went toward enlisting American Muslim groups in some of the domestic war on terror's most egregious practices.

These CVE projects included surveillance and mapping of communities and counter-radicalisation initiatives that pathologised Muslims as predisposed to violence by labelling basic Muslim ritual practices as suspicious.

As more communities welcomed FBI agents into their spaces, an investigation by the American Civil Liberties Union in 2011 revealed that federal agents used so-called "community outreach forums" to spy on American Muslims.

In the early days after 9/11, to suggest that the war on terror would actually serve as a pretext to demonise and target an entire faith and its adherents while pursuing US imperial aims would be met with derision and vociferous denials. Two decades

Yet American Muslim institutions have hardly acknowledged the transformations within their community or the practices that brought them about. Such has been the disciplining effect that whatever critiques they offer are limited to societal Islamophobia or the excesses of the Trump presidency.

Few efforts have been made to identify and challenge structural Islamophobia and the imperial practices it supports. If anything, the community has witnessed an alarming rise of internalised Islamophobia, as indicated by a 2018 survey which revealed that American Muslims were more than twice as likely as any other faith community to express the belief that Muslims are "prone to negative behavior"

What hope exists to challenge this prevailing narrative stems from a rising youth movement that has voiced poignant critiques of older generations of American Muslim professionals they view as complicit in their own securitisation. These young activists have drawn strength from forming linkages with broader struggles against structural racism and anti-immigrant hostility among communities of colour.

More recently, they have also latched onto the cause of Palestine solidarity within the broader progressive movement – ironically an issue that was historically at the core of American Muslim political mobilisation until it became one of the domestic war on terror's numerous casualties.

As American Muslims reflect upon the pain and loss endured over the past 20 years, it is vital that the lessons of those experiences not be forgotten nor ignored. Indeed, their survival as a faith community depends on it.

Gender Equality in Islam Realities vs 'Misconceptions'

In Islam, biological division between man and woman is part of divine purposeful planning; otherwise both are accorded the same respect, dignity and honor as human beings, and are complements, not duplicates, of one another

rom an intellectual point of view, the last two decades of the 21st century (as we are presently passing through the third decade) have witnessed, though not abruptly but having roots deep in the history, various debates and discourses of varied nature. Many of these debates are squarely focused on Islam and Muslims vis-à-vis modern developments and discourses, and one of the crucial and controversial debated topics/ issues, falling in the socio-cultural domains, is the status, position, and role of women in Islam—both past and present.

Like other scholars, across the globe, Muslim scholars of India have also contributed, and are contributing, to the discourse of women in Islam, or more specifically to gender equality/ equity/ parity/complementality—or what I term as "Gender Equ(al)ity". Some significant (selected) works by Indian Muslim scholars and academicians on issues related to women vis-à-vis Islam in general and Muslim Women in India in particular include the works by Sayyid Jalaluddin Umari, Maulana Wahid dudin Khan, Muhammad Yasin Mazhar Siddiqui, Asghar Ali Engineer, Seema Kazi, Mohammad Akram Nadwi, Yoginder Sikand, Maulana Khalid Saifullah Rahmani, Abul Hasan Ali Hasani, Abdur Raheem Kidwai, Muhammad Raziul Nadwi, and many others.

Within this ambiance and in this context, this article is intended to present an assessment and appraisal of four (4) books on 'Women in Islam', so that to get a clear picture of the rights, status, contribution, and role of women in the light of Quran, hadith, Seerah (Prophet's biography) and Islamic history, and problems, issues, and challenges (social, educational, political, intellectual, etc.) faced by (Indian) Muslim women in the current times. These books are discussed and outlined under three (3) major thematic headings, viz. 'Status and Role of Women in the light of the Islamic Foundational Sources (Quran and Sunnah)-an evaluation of Khan's Woman in Islamic Shari'ah (2018) and Kidwai's Women in Islam—What the Quran and Sunnah Say (2020); 'Women during the Prophetic Period-Role, Responsibilities and Contribution' and Siddiqui's Prophet Muhammad (pbuh) and Women-A Social Study (2006); and 'Muslim Woman in Theory and Practice: Issues and Challenges'-Content Analysis of Kidwai and Gupta's edited volume on Muslim Woman. Here, in this part, I will try to cover the first major thematic section.


and many booklets such as Polygamy and Islam (2001), Concerning Divorce (2008 [2001]), and Hijab in Islam (2011 [2001]).

His Woman in Islamic Shari'ahactually gleaned and extracted from his Women between Islam and Western Society-consists of eleven (11) chapters and discusses the status of women in Islam in the light of teachings of the Quran and hadith, womanhood in Islam, qualities of (or to be possessed by) Muslim women, rights and duties of husband and wife in first five chapters, and presents a detailed discussions on concepts and issues related to divorce, polygamy, dowry, hijab, etc. in the light of Islamic teachings and history in chapters 6-10, and ends with a chapter on the "success in marriage"

He begins the 'Foreword' (pp. 11-14) with Edward William Lane's (Selections from Kuran, 1982, p. XC) statement that "the fatal point in Islam is the degradation of woman". For Khan, this "ill-considered observation" gained such currency in the succeeding centuries that it became "an established fact" and instead of having elapsed this conviction has rather "deepened". In this backdrop, he, thus, asserts: "To interpret the Islamic concept of woman as 'degradation' of woman is to distort the actual issue. Islam has never asserted that woman is inferior to man: it has only made the point that woman is differently constituted" (p. 11). This is precisely the main theme and thesis of this book.

Quoting numerous Quranic verses (like Q. 2: 228; 3: 195; 4: 7, 19, 124; 9: 71; 16: 97; 30: 21; 40:40) as well as Ahadith related to women, Khan (in chapter 1, "Qur'an and Hadith", pp. 15-19) affirms that both the foundational sources of Islam "give detailed commandments regarding women, and also lay down clear guidelines for the relationship between men and women" and they "highlight the most important aspects of feminine virtue and the standing which a woman should have vis-à-vis her husband and father" (p.15).

In the second chapter, "The qualities of a believing woman" (pp. 20-27), he refers to the 'Basic Attributes of Men and Women' as depicted in Q. 33: 35 and Q. 66 (pp. 21-24). These qualities, taken together, "constitute an ideal, not just for men, but for both sexes"; they "form the basis of Islam" (p. 25). In this chapter, he further asserts that just as "men function on different planes of religiosity, so do women have their own separate spheres of religious effectiveness"; and besides the domestic sphere, it is possible for a "talented women to further the cause of religion when the right opportunity presents itself" (pp. 25, 26). In this case, he cites the examples of Aishah (RA) and Binte Imam Abu Jafar al-Tahavi and their contribution to the religious knowledge showing "the nature and extent of the contribution which can be made by believing Muslim women to the cause of Islam" (p. 27). Similarly, in 3rd chapter, "Womanhood in Islam" (pp. 28-37), Khan quotes Q. 4: 1 ("Mankind, fear your Lord who created you from one soul and created man's mate from the same soul") and demystifies the notion that "Eve was created from Adam's rib" in its explanation, saying that it is a "biblical explanation [Bible, Genesis, 2: 21-23], not a Quranic one", for there is not a single verse which supports this notion. On the contrary, the fact is that "Eve was created—not from Adam himself-but from the same species as Adam", as is elucidated in several verses like Q. 16: 72; 30: 21; and 42: 11, wherein the word for "Soul (nafs) has been used to mean 'species'" (pp. 28-29). He summarizes this discussion aptly in these words: "women and men are from the same species. Biologically speaking, women have not been extracted from the bodies of their male counterparts. God fashioned them according to His Will, just as He fashioned men in accordance with His Almighty Will and Power" (p. 30). In the explanation of the Ahadith, like "women have been created from a rib" and "a woman is like a rib. if you try to straighten it, it will break", he mentions that it



should be "taken metaphorically, not literally" for it refers to "the delicacy of women's nature" (pp. 31, 33).

In the 4th chapter he highlights "The status of woman" (pp. 38-48) and stresses, in unequivocal terms, that "a woman enjoys the same status as that of a man" in Islam, as is evident from Q. 3: 195 ("You are members, one of another"). "There is no difference between man and woman as regards status, rights and blessings both in this world and in the hereafter. Both are equal participants so far as the carrying out of the functions of daily living is rned" (p. 38). He further mentions that the "biological division of human beings into male and female is the result of purposeful planning on the part of the Creator. ... Man and woman in the eyes of Islam are not the duplicates of one another. but the complements" and the "Islamic precepts for men and women are based on their respective, natural constitutions" (pp. 38-39; italics added for emphasis). Similarly, in the explanation of Q. 4: 34, "Men are the protectors and maintainers of women, because God has made some of them to excel others", Khan writes that it is "an additional, not a superior quality" (p. 46; italics added), because the Arabic word Fadilah is "used in the scriptures to indicate the additional. masculine quality of protectiveness. For a household to be properly run, it should, of necessity, have a guardian. Guardianship is rightly entrusted to the family member who is best qualified to undertake this responsibility-namely. the husband, for protectiveness is a virtue which has been granted by nature in greater measure to men than to women. Far from mentioning absolute masculine superiority, the abovequoted verse only implies that man is the master in the home because of the additional attributes with which he has been endowed by nature" (pp. 46-47). Thus, he translates the Arabic phrase Faddala ba'dahum 'ala ba'd as "excelled some on other", which occurs several times in the Qur'an, as in Q. 13: 4 which refers to the various kinds of crops and fruits growing from the same soil and water, "Yet We make some excel others in taste". "Just as two different kinds of fruit will differ in color, taste, shape and texture, without one being superior or inferior to the other, so also do men and women have their different qualities which distinguish the male from the female without there being any question of superiority or inferiority. If men and women have been endowed with different capacities, it is so that they will play their respective divinely predetermined roles in life with greater ease and effectiveness." (p. 48). In the 5th chapter, he discusses "Muslim Women" (pp. 49-78) in Islamic history, and argues that they have "played significant roles and, by their feats, have demonstrated not only the vast arena which Islam affords them for the performance of noble and heroic deeds, but also the exaltedness of the position accorded to women in Islamic society" (p. 49). In his support of this argument, he presents the examples of various women "who played an effective role in Islam" (p. 50): e.g., Aishah (RA) is presented as a "woman of notable intelligence, whose intellectual gifts were fittingly utilized in the service of Islam"; the example of Mary, the mother of Prophet Isa/ Jesus (AS) and Khadijah bint Khuwaylid (RA), the Prophet's (pbub) first wife are presented as "Two face and hands, and should not become an attraction in itself. Neither should it be thin, nor tight. It should not accentuate the body ... [and] should not suggest fame" (pp. 144, 147).

The book ends with a chapter on "Success in marriage" (pp. 151-159), in which the author suggests that the "success and failure of married life depends entirely upon the bride's willingness or unwillingness to adapt" to a "conciliatory stance" (p. 152) and he illustrates this with two examples, one each of a failed and successful marriage (pp. 152-53).

Keeping in view the overall subjectmatter and the issues and topics it highlights and deliberates upon, it is fair to assert that Woman in Islamic Shari'ah indeed highlights the real status, position, role, rights and responsibilities given to women in Islam and thoroughly discusses the crucial (and mostly misunderstood and misinterpreted) concepts and issues related to women—like divorce, polygamy, dowry, hijab, etc. In sum, the book makes a significant contribution to this much hyped (but misconstrued) subject.

Abdur Raheem Kidwai-Professor of English and Director, UGC-HRDC and K. A. Nizami Centre for Quranic Studies, Aligarh Muslim University (AMU), India-has contributed significantly to Islamic scholarship, especially to the varied aspects of Qur'anic studies including the 'gender studies' aspects. His Women in Islam (which draws mainly, and is gleaned, from his book chapter on same theme, "Is the Quran a Male-Centred Religious Text?", featuring in his 2019 co-edited volume, Muslim Woman: this book will be evaluated in Part-II of this write-up) is a succinct and slim volume highlighting the rights, status, role, and contribution of Muslim women in the light of foundational Islamic texts as well as demystifying and deconstructing the misconceptions and misconstructions on the vital but sensitive issue of 'Gender Parity'.

Divided into three main sections, preceded by a 'Preface' (vii-x) and ending with Index (pp. 170-80), it attempts to providing readers with an "opportunity to consider some of the references to women in authentic Islamic sources in order to shape an informed view" as well as to "let readers appreciate the high status that women enjoy in Islam" (p. vii). A simple compilation of those pas-



An Evaluation of Women in Islamic Shari'ah (2018) and Women in Islam (2020)

Maulana Wahiddudin Khan (d. 2021) an Indian Muslim (spiritual) scholar, a Quran commentator, an ardent advocate of peace, harmony, pluralism, gender justice, interfaith dialogue and social harmony, and the founder of 'Centre for Peace and Spirituality' in 2001 (New Delhi)—has authored over 200 books on Islam and its diverse aspects—ranging from Quran, prophet's biography, theology, morality, spirituality, non-violence, peace/peace-building, to Islam and modern science gender studies.


On the subject under study, significant books to his credit are: Khatoon-e-Islam/Muslim Women published in 1987 and reprinted in 2017: its Arabic version was published from Cairo in 1994 and its English version, Women between Islam and Western Society, was published in 1995 (republished in 2014); Woman in Islamic Shari'ah (2018; originally published in 1995); Aurat: Maemaar-e-Insaniyat/ Woman: The Builder of Humankind (2008; originally published in 2004);



Remarkable Women' who "subordinated their own wills to that of Almighty" (pp. 49, 50-51). In this chapter, he also refers to the examples of women of his own family who "in times of dire distress, were totally Islamic in their conduct" (p. 70). All this is thus expounded to reveal that the "position of women in Islam ... is a matter neither of conjecture, abstract theory nor of ancient history ... [but] is a matter of actual fact", to which the author himself is a witness (p. 69).

In the 6th chapter he discusses the "rights of husband and wife" (pp. 79-94) and argues that the "rights of men and women, in reality, are not a matter of legal lists, but rather a matter of good living" (p. 93).

These are followed by a detailed discussion, in the light of Islamic teachings and historical evidences, on concepts and issues "concerning divorce", "polygamy and Islam", "Dowry", and "Hijab in Islam" in chapters 7-10, respectively (pp. 95-114, 115-24, 125-,40, and 141-50) and the important points derived from these discussions are: "divorce should be sought only under unavoidable circumstances" as it has been described in the Traditions as "the most hateful of all lawful things in the eyes of God" (pp. 100-101); "lawful polygamy of Islam" is the solution to the "imbalance" of number of women over men which permits women "to opt on their own free will for marriage with anyone who can give them fair treatment to more than one wife" (p. 124): the "custom of dowry [Jahez in Urdu] is not Islamic" practice, but is (specifically) practised by Muslims of the Sub-Continent; however, Islam sanctions mahr (dower)—a sum of money handed over by groom to the bride at the time of marriage—which is "a token of his willing acceptance of the responsibility of bearing all necessary expenses of his wife" (pp. 125, 130); and on Hijab (veil) or Purdah in Urdu, where he mostly relies on the views and opinions of Shaykh Muhammad Nasiruddin al-Albani, he maintains that "it is preferable for a woman to cover her face, it is not compulsory for her to do so" and that "hijab in itself should not be a source of attraction" or "become a display of finery referred to in the Quran as tabarruj", as in Q. 24: 31 and 33: 33; and the "garment should cover the entire body of a woman except the



sages from the Quran and hadith collections which 'refer to or address women specifically', it highlights the "Islamic stance on womanhood: her existence as a creation of Allah, her purpose of life as a slave of Allah, her capacity for attaining self-development and proximity with Allah and her accomplishments". and brings into the sharper light the fact that in the Quran "men and women are both accorded the same respect, dignity and honour as human beings", and both are repeatedly addressed and urged "to be active, positive stakeholders in the construction of God-conscious society and for attaining salvation as pious individuals" (pp. viii, ix; italics added for emphasis). Maulana Khan also highlights similar statements.

Khan's and Kidwai's Books in Sum: Considering the overall subject-matter and the issues and topics highlighted and deliberated upon in these books, it is fair to assert that (taken together) Woman in Islamic Shari'ah and Women in Islam make significant contribution to the literature depicting the status/role/ position of women in Islam in its real perspective/ context and in defying and expunging misconceptions regarding the role and responsibilities bestowed to women by their Creator-and thus are valuable works on brining into sharp light the real perspective of 'Gender Equ(al)ity' in Islam. {Contd.}



Forex Reserves Rise USD 8.895 Bn To Record High Of USD 642.453 Bn

MUMBAI- The country's foreign exchange reserves increased by USD 8.895 billion to reach a record high of USD 642.453 billion in the week ended September 3, RBI data showed.

In the previous week ended August 27, the reserves had surged USD 16.663 billion to USD 633.558 billion, mainly due to a rise in Special Drawing Rights (SDR) holdings. International Monetary Fund (IMF) had made an allocation of SDR 12.57 billion to India.

For the week ended September 3, the increase was on account of a rise in foreign currency assets (FCAs), a major component of the overall reserves, Reserve Bank of India's (RBI) weekly data released on Friday showed.

FCA rose by USD 8.213 billion to USD 579.813 billion in the reporting week, according to the data.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves were up by USD 642 million to USD 38.083 billion in the reporting week, as per the data.

The special drawing rights (SDRs) with the IMF rose by USD 29 million to USD 19.437 billion.

The country's reserve position with the IMF increased by USD 11 million to USD 5.121 billion in the reporting week, the data showed.

Advisor Baseer Visits Banihal

Reviews RDD And Other Developmental Activities

RAMBAN: Advisor to Lieutenant Governor, Baseer Ahmad Khan, on Saturday conducted an extensive tour of Banihal Sub-Division of district Ramban to take stock of various ongoing development projects, winter preparedness made by JPDCL, Covid mitigation efforts and disaster management.

Advisor also interacted with several deputations led by the DDC Chairperson, Dr, Shamshad Shan, President MC, Beopar Mandal, PRIs who apprised him of their demands and grievances seeking an early redressal of the same.

Baseer Khan was accompanied by Deputy Commissioner, Mussarat Islam, BDC Chairperson, Rashida Begum, DDC members, Chief Engineer, JPDCL, AK Sachdeva, Director Rural Development Jammu, Kishore Singh Chib, Director Tourism, BDC Chairpersons, ADC Harbans lal, ACD Zameer Rishu and other senior officers of the district.

The Advisor inspected 10 MVA Receiving Station at Banihal with an additional capacity of 6.3 MVA. He also inspected various ongoing Rural development works.

He inaugurated Footbridge at Thachi -Wagan besides reviewing infrastructure being developed in the district to provide better facilities to the people.

Speaking on the occasion, the Advisor said that the Government is committed to provide adequate power supply to the people of UT by capacity enhancement in transmission, distribution and power generation. The aim is to reduce the power curtailment time especially in ensuing winters across the UT, he added.

The Advisor directed the Chief Engineer JPDCL to conduct survey in the district for the replacement of wooden and damaged electric poles, wires, conductors and other material required for smooth supply of electricity and in the process involve the PRI's also. He added that the funds have already been released in this behalf to create a robust electricity network in the UT. He also directed the Chief Engineer to replace all wires wherever required to improve power supply in the district besides electrifying the

uncovered areas. Responding to the demands of people, the Advisor directed the Director Tourism and Deputy Commissioner to explore the new tourist destinations and trekking routes in the district.

He also directed Director Tourism to renovate the way-side amenities and other facilities to boost tourism activities in the area. While talking to the members of three tiers system of Panchyati Raj, the Advisor asked them to work in coordination to ensure effective execution of development projects and implementation of other beneficiary oriented schemes.

He directed the Director RDD to identify development works to generate more man days to provide more job opportunities to locals besides ensuring training programmes for DDC and BDC members for their capacity building. He also directed the District Administration to identify state land at panchyat levels to be made available to RDD so that play fields in all the panchyats are developed. This would channelize the energy of youth in the development of the nation, he added.

Responding to the demand of Beopar Mandal to develop Bus Stand, the Advisor directed the District Administration to identify suitable land and prepare a plan for the construction of Bus Stand and submit the proposal to the concerned department. Regarding the issues of sanitation highlighted by the delegation, the Advisor directed the Urban Local Bodies and the Deputy Commisioner to have the sanitation concerns resolved and construct a community toilet complex in the Banihal town.

It said the coaching centres for civil services or engineering or NEET examinations would be permitted with limited in-person teaching for fully vaccinated staff and students.

It said the higher educational institutions would be permitted to commence limited inperson teaching subject to 100 per cent vaccination of staff and students and specific permission of the Deputy Commissioners. (KINS)

triangles, rectangles, squares, circles, etc., which are basic geometric figures, he explains.

"But the overall idea is how varied a pattern can be designed. It gives multiple opportunities for the craftsman. It's that variation in the pattern, that appeals to the human eyes and the sense of aesthetics to a large extent."

In the case of Kashmir, geometric shapes are omnipresent in pinjras, some of the most intricate ones to be found in shrines.

"If it's an octagonal star, you'll find that in eight different windows," the design director says. "You have eight different patterns."

But, because of that unified theme of geometry, he says, one doesn't seem to be different from the other visually, but what commands visual attention is how each pattern is unique to that one single window.

The understanding of geometry in Islamic design has been passed from generation to generation wherein artisans work with a certain basic module with most of them traditional and unchanged over time.

But with dwindling numbers of skilled artisans in Kashmir, there're doubts of whether hand-done pinjrakari or the traditional Khatamband will see through the test of time.

Atif Lone, 28, is a pinjrakari artist based in Downtown Srinagar who's one of the few young people willing to learn the craft and become its next generation of torchbearers.

Lone left his commerce degree to become a first-generation pinjrakari artist to introduce new designs and revitalise the art in local households.

While he may be using CAD for making some of his designs, his basis remains the grids of a graph paper, pencil, and a set of compasses for sketching out hundreds of innovative pinjrakari designs, further demonstrating how geometry makes for Islamic design's polestar.

While geometric shapes are sacrosanct to most Islamic religious institutions, the essence of its design remains universal and timeless.

Hamdani believes that geometry, being equivocal in nature, is open to any culture: "It's a basic arithmetic solution to a certain problem, so it's not religious, but very secular in its appeal."

India's IPL Stars Off To Dubai After Second Negative RT-PCR Report

MANCHESTER/DUBAI: The Indian cricketers, contracted to play the Indian Premier League (IPL), left for the UAE in chartered and commercial flights after returning negative RT-PCR tests for the second time in two days.

The travel arrangements were made by players' respective franchises.

The players began their early departures for the remainder of the IPL, starting September 19, after India's fifth Test against England was postponed indefinitely following COVID-19 out-break in the Indian camp. The players, led by Virat Kohli,

refused to take the field despite testing negative for the virus as they had apprehensions that playing members could contract the virus after assistant physio Yogesh Parmar tested positive just ahead of the final game.

The good news is that all the players and support staff members have now tested negative for the RT-PCR for the second time. The reports arrived late on Friday evening and most of them are already on their way to Dubai for the IPL," a senior BCCI official told PTI. "Two non-IPL players Abhimanyu Easwaran and Arjan Nagwaswalla will be flying out on Monday with the rest of the support staff. They will be flying to their respective Indian cities via Dubai and will take a commercial flight," the senior official said.

The players started departing in clusters -- some in charter flight arranged by their franchises like Mumbai Indians and Sunrisers Hyderbad while Chennai Super Kings cricketers took commercial flight. "Mumbai Indians flew in

three of its Indian contingent members, captain Rohit Sharma, Jasprit Bumrah, and Suryakumar Yadav, to Abu Dhabi on a private charter flight. The trio, along with their families, arrived today morning and will now undergo six days of hard quarantine, starting today as per the IPL's guidelines," MI issued a statement.

"All members had returned negative RT PCR results before departure. A new RT PCR test was undertaken upon arrival at Abu Dhabi, which are negative as well." it also stated.

RCB captain Virat Kohli and his premier pacer Mohammed Siraj also took a charter flight from Manchester.

"Keeping the safety and security of our players as the utmost priority, Royal Challengers Bangalore have arranged a special charter flight for captain Virat Kohli and Mohammed Siraj to ensure their safe transit to the UAE. "The players will be flying out at 11.30 PM (UK time) on Saturday and will arrive in Dubai early Sunday morning. Both, Virat and Siraj will undergo 6-day quarantine in Dubai before joining the team bio-secure bubble." RCB said in a release.

Bairstow, Malan & Woakes Pull Out Of IPL, **Citing Personal Reasons**

Sunrisers Hyderabad opener Jonny Bairstow, Punjab Kings batsman Dawid Malan and Delhi Capitals all-rounder Chris Woakes have pulled out of the upcoming Indian Premier League (IPL) due to personal reasons. The England and India players were supposed to fly into UAE from Manchester together in a bubble to bubble transfer but COVID-19 cases in the visitors' camp forced IPL teams to make their own arrangements.

The fifth Test between India and England was also postponed indefinitely after a junior physio tested positive for the virus ahead of the game. Other members of India's support staff, including head Ravi Shastri, were already in quarantine after they tested positive for the virus during the fourth Test at the Oval.

All players arriving in Dubai now have to do a six-day quarantine and that could be the reason behind Bairstow and Malan pulling out.

A BCCI official told PTI that both the players won't be part of the IPL resuming September 19. The Guardian reported on Woakes' unavailability.

"They won't be boarding the flight to UAE. One of the reasons for their pull out is the six-day quarantine which they didn't need to do earlier," said the official.

While Bairstow is a regular in the Sunrisers line-up, world number one T20 batsman Malan made his IPL debut with Kings earlier this year.

Bairstow had made 248 runs at strike rate of 141 plus in seven games earlier this season. Bairstow, Woakes and Malan were part of England's Test squad in Manchester.

Bubble life has taken a toll on players and with the T20 World Cup to follow in UAE, not playing the IPL would allow more family time to Bairstow and Malan.

All three are also part of England's Ashes plans but the tour Down Under is also currently in doubt with Australia imposing some of the harshest restrictions in the world on incoming travellers in the COVID times.

New Zealand Cricket Team Arrives In Pakistan After 18 Years

Reports: Afghan Board Signals Women Could Still Play Cricket

KABUL: Women could still be allowed to play cricket, the chairman of Afghanistan's Cricket Board has claimed to an Australian broadcaster in an apparent backflip on the Taliban's hardline stance.

Azizullah Fazli said the governing body would outline how this would happen "very soon", adding that all 25 of the women's team remained in Afghanistan and had chosen not to leave on evacuation flights.

"We will give you our clear position on how we will allow women to play cricket," he told SBS Radio Pashto late on Friday, the broadcaster reported on its English-language website.

"Very soon, we will give you good news on how we will proceed."

His comments appear to contradict the deputy head of the Taliban's cultural commission Ahmadullah Wasiq, who told the same broadcaster on Wednesday that it was "not necessary" for women to play sport.

Those remarks saw Australia threaten to cancel a historic maiden men's Test between the two countries, set to take place in Hobart in November.

Australian Test captain Tim Paine turned up the heat on Friday, saying he believed teams could pull out of next month's

Football Legend Pelé Remains In Intensive Care After Surgery

SAO PAULO: Legendary Brazilian football star Pelé remained in intensive care on Friday as he recovered from surgery to remove a tumour on the right side of his colon. Hospital Albert Einstein in Sao Paulo said in a statement that 80-year-old Edson Arantes do Nascimento was recovering "in a satisfactory manner," though still in intensive care. The hospital said on Monday that Pelé was expected to be

moved to a regular room on Tuesday. The hospital also said Pelé is "awake, actively talking and keeing his vital signs in normality."

The three-time World Cup champion also said on his Instagram that "each day I feel a little better."

He went to the hospital for routine exams at the end of August when the tumor was found. The hospital said in a statement then that the tumor was identified during routine cardiovascular and laboratory exams. It added it collected samples to be analyzed but has not released the results.

Pelé, the only male player to win three World Cups, has had mobility problems since a failed hip replacement surgery in 2012. He has been forced to use walkers and wheelchairs in public. He has also been admitted to several hospitals in recent years for kidney and prostate procedures.

Pelé won the 1958, 1962 and 1970 World Cups, and remains Brazil's all-time leading scorer with 77 goals in 92 matches.

In the next over Bhanuka Rajapaksa was out to the first ball, trapped lbw by left arm spin bowler and captain Keshav Maharaj. Charith Asalanka (6 off 19) tried to increase the scoring rate and was caught in the deep by Dwaine Pretorius off left arm wrist spinner Tabraiz Shamsi.

Chandimal remained not out for his career-best 66. His 54-ball innings included five fours and two sixes.

Maharaj took 1-19 in four overs in his first T20I, claiming the wicket with his first delivery.

Shamsi, Pretorius, Bjorn Fortuin and Anrich Nortje all took a wicket each.

The second T20 is on Sunday.

Tax Probe Attempt To 'Stifle' **Independent Journalism:** Newslaundry, Newsclick

NEW DELHI: Online news platform Newslaundry on Saturday said it does business "honestly and with integrity" while another such portal Newsclick said investigation against it by various agencies including the latest Income Tax Department survey is an attempt to "stifle" independent journalism.

The tax department surveyed the office of Newslaundry located at Sarvodaya Enclave in south Delhi on Friday along with that of Newsclick in Saidulajab area (south Delhi) on charges of alleged tax evasion.

"We have nothing to hide and have done everything by the book and are not in any breach or violation of any law. We conduct our business honestly and with integrity," Newslaundry co-founder Abhinandan Sekhri said in a message posted on his Twitter handle.

He said the tax team told him he "cannot" speak to his lawyer and the law requires him to comply "without seeking legal advice" adding that the officials were courteous and professional.

He said "no signed hash value of the data copied" was provided to him and that he considered this as violation of his fundamental right to privacy.

A hash value is a numeric value that uniquely identifies data.

Hash values represent large amounts of data as much smaller numeric values, so they are used with digital signatures.

Sekhri said the tax team comprising 6-7 people arrived at their office around 12.15 pm and left around 12.40 am on Saturday.

"They searched and looked through all computer devices at the premises. My personal mobile phone, laptop and a couple of office machines were taken control of and all the data on them downloaded by the IT team," he said.

Sekhri said this was the second visit by the tax authorities to his office, the first being in June, and they had given "all documents related to our funding and accounts" to the officials then.

"We will cooperate in whatever way we are required to by the law.

We will also continue to practice public interest journalism which is why we exist," he said.

Our support comes from people who value public interest news and chose to subscribe to Newslaundry, not through government or corporate advertisements or public relation exercises, Sekhri said, adding that the online portal is proud of the model it has chosen and championed.

Tax officials had said that separate survey operations on the two news portals were conducted to verify certain tax payment details and remittances made by the organisations.

As part of a survey operation, carried out under Section 133A of the Income Tax Act, 1961, tax officials cover only the business premises of an assessee and those linked to it and not their residential addresses.

However, they are authorised to seize documents, computer and electronic devices as part of the surprise action.

Newsclick said the tax team "recorded the statement of its Editor-in-Chief Prabir Purkayastha; impounded his phone; and took away documents, what they called "loose papers from the premises".

"They also took email dumps of Prabir, editor Pranjal, and various administrative and financial accounts related to Newsclick," it said in a statement posted on its Twitter handle.

Around 30 employees and support staff of Newsclick were in the office throughout the survey and their phones were temporarily seized, and they were not allowed to use their computers and work, it said.

Newsclick said the latest action against them "appears to relate to the same false and unfounded allegations being investigated by the Enforcement Directorate and the Economic Offences Wing, Delhi Police. We have these alle-

gations challenged in the courts". "These investigations by various agencies, and these selective allegations, are attempts to stifle the independent journalism of media organisations, including

Newsclick," it said. Tax officials who reached the Newsclick office around noon on Friday left at midnight.

Newsclick, Purkayastha and other executives were raided by the Enforcement Directorate (ED) earlier in February under provisions of the Prevention of Money Laundering Act and that investigation is linked to alleged dubious foreign funding received by its registered company, which runs the news portal.

Marriages Can Be Registered In Virtual Presence Of Parties, **Rules Delhi High Court**

NEW DELHI: Marriages can be registered in the virtual presence of parties, the Delhi High Court has ruled, saying that in the present times, citizens cannot be prevented from exercising their rights because of a rigid interpretation of law which calls for "personal presence".

Hearing a plea by a US-based Indian couple seeking to register their marriage here through video-conferencing, Justice Rekha Palli opined that not treating physical presence as a mandatory requirement would also encourages parties to easily get their marriages registered.

"I have no hesitation in coming to the conclusion that the term 'personal appearance' in Clause 4 of the Registration Order has to be read to include presence secured through Video Conferencing. Any other interpretation, would not only frustrate the very purpose of this beneficial legislation, but, it would also undermine the use of this important and easily accessible tool of Video Conferencing," the judge said in

her order dated September 9. She said the Delhi (Compulsory Registration of Marriage) Order, 2014 is welfare legislation, promulgated at the instance the Supreme Court to encourage the registration of marriages. The insistence of physical

appearance even when their personal appearance can be easily secured through video conferencing, will definitely make it more cumbersome for parties to come forward for the registration of marriages. This will negate the very purpose of enactment of the Registration Order and cannot be permitted," the order further reads.

The court allowed the couple to mark their "personal appearance" before the Registering Authority through video conferencing after submitting their application for the registration of marriage through their counsel/Power of Attorney Holder in physical form alongwith copies of all supporting documents duly notarized, either by the notary public in the United States of America or by a notary public here

It directed that the two witnesses would appear physically before the Registering Authority with their original ID proofs on the date notified by the Registering Authority.

The Authority will then expeditiously register the marriage and issue the Marriage Registration Certificate within a period of two weeks' from the date of receipt of the application, the court added.

In the present case, the couple claimed that their marriage was solemnised in 2001 as per Hindu rituals, but they did not get the same registered as they moved abroad prior to the introduction of the Delhi (Compulsory Registration of Marriage) Order, 2014.

Considering that their application for a green card was now not being processed in the United States for want of a marriage certificate, the couple approached the local authority here for issuance of a marriage certificate, who maintained that physical presence of the parties was a mandatory requirement.

The couple, represented through senior counsel Vibha Datta Makhija, moved the high court after their representation to the authority concerned for virtual appearance remained unanswered.

The court observed that while the "universe has undergone a sea change" since the time when the Registration Order was notified, the Registering Authority was "refusing to recognize the reality that with the technology as is available today, web portals and Video Conferencing have become almost the norm".

Acknowledging the acceptance of video-conferencing even in the judicial system in this country, the court said that "these aspects appear to have been simply overlooked by the Registering Authority, who is continuing to insist on that the parties must remain present physically before him".

The National Eligibility cum Entrance Test (NEET) -Postgraduate was held at 679 centres in 270 cities of the country on Saturday with 1.6 lakh candidates appearing for it following COVID-19 protocols.

The exam was rescheduled twice in view of COVID-19.

Congress leader Shashi Tharoor, in a tweet, claimed that some students have complained to him about a last-minute change of exam centre that has led to their inconvenience.

When asked about it, the Executive Director of the National Board of Examinations in Medical Sciences (NBEMS) Professor Pawanindra Lal said two centres each in Sonipat and Panipat were changed on September 8 and 9 respectively due to security issues and the candidates were moved to new centres in Delhi.

Tagging screenshots of a tweet about change in exam centre, Tharoor wrote on the microblogging site: "Over a hundred NEET-PG, 2021, aspirants have written to me because the government doesn't respond!

"The exam is tomorrow and they are in crisis. The latest complication: many students have been informed at the last

minute of a change of centre (one day before the exam); many haven't got admit cards,' he said in the tweet.

However, Professor Lal said. "All care was taken to inform each and every candidate individually by phone calls, emails and SMS to ensure they download and print the new admit card with new centres and are able to reach the venue on time.' Initially, the NEET-PG was scheduled to be held on January 10

but was rescheduled for April 18 because of the COVID-19 situation. "It was again rescheduled be-

cause of the second Covid wave on the orders by the PMO. In those orders, it was mentioned that the exam would be held after August 31. Then the earliest possible date was announced for September 11," Professor Lal said.

He said 1,66,259 candidates appeared for the NEET-PG on Saturday and all were provided protective gears comprising a face shield, mask and hand sanitiser for the safe conduct of the exam.

On the day exams were held, the Delhi-NCR region received heavy rainfall leading to waterlogging and traffic jams in several parts of the city.
