SRINAGAR: Former Jammu and Kashmir Chief Minister, Mehbooba Mufti on Tuesday accused army of ransacking houses and thrashing members of a family in south Kashmir's Pulwama district, a charge strongly contested by police.

Taking to micro-blogging site twitter, the Peoples Democratic Party (PDP) chief hit out at the army for allegedly beating the civilians in the village.

"Army from Yagwani camp in Tral ransacked homes &

ruthlessly thrashed a family last night. The daughter owing to her serious injuries was admitted to hospital. Not the first time that civilians from this village have been beaten up by army in this area @ChinacorpplA @adgpi" Mehbooba posted on her official Twitter handle.

Disputing Mehbooba's claims, a senior police officer told Kashmir Observer that the incident took place between 8:00 to 9:00 PM on Monday when a patrolling unit of army zeroed in on a suspected house and questioned some people.

Pakistani Militant Captured In Uri: Army Operation Over, 7 Militants Killed Since Sept 18: Maj Gen Vats

SRINAGAR: A 19-year-old Pakistani militant belonging to Lashkar-e-Taiba was captured alive during an anti-infiltration operation along the Line of Control on Uri sector of Jammu and Kashmir in which one militant was killed and three Indian soldiers sustained injuries, the Army said on Tuesday.

The operation was launched on September 18 after the Army noticed suspicious movement along the LoC, GoC 19 Infantry Division, Major General Virender Vats told reporters at a briefing in Baramulla district.

He said an encounter took



place when the infiltrators — believed to be six — were challenged.

While four of them were on the other side of the fence, two had come on our side of the territory.

"The four terrorists, who were on the other side, took

advantage of the dense foliage and retreated back into Pck. The remaining two sneaked in.

"One of the infiltrators was killed in the encounter on the morning of 26th while another one pleaded **More On P6**

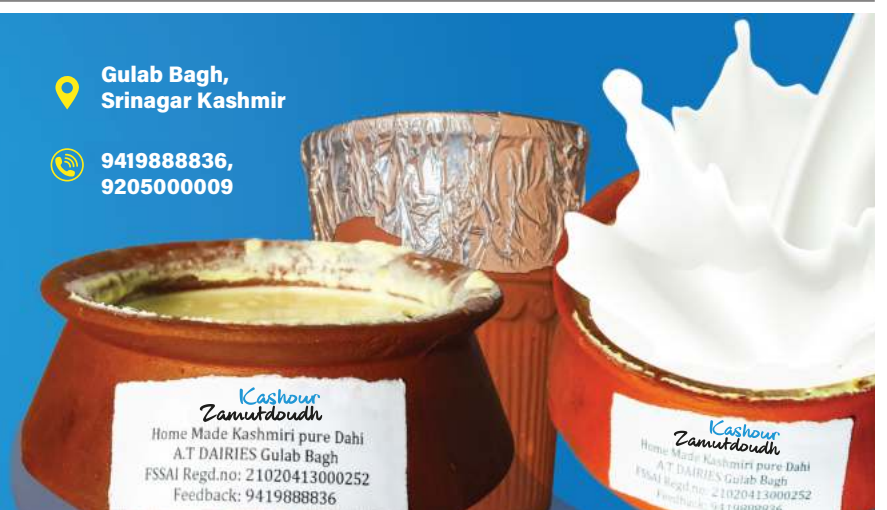

Delhi orders 'complete ban' on sale, bursting of firecrackers till January 1

New Delhi: In a bid to curb high air pollution, the Delhi Pollution Control Committee (DPCC) on Wednesday banned the sale and bursting of firecrackers in the national capital till January 1, 2022. Citing the directive from the National Green Tribunal, DPCC said it is planning a comprehensive program for the prevention, control and abatement of air pollution.

"There will be a 'Complete Ban' on bursting and sale of all kinds of firecrackers up to 01.01.2022 in the territory of NCT of Delhi," the order reads.

Delhi government had already announced a ban on the sale, use and storage of firecrackers in the national capital this Diwali. In a series of tweets, chief minister Arvind Kejriwal said that the ban was an-



nounced in view of deteriorating air quality over the past three years.

"Last year, the complete ban was imposed late, after looking at the rising pollution levels in the city. Because of this traders had already bought stock and they had to face losses. This time, traders are requested not to stock up on crackers," he had tweeted.

Delhi's air quality takes a major dip during the winter season when the particulate matter concentration,

PM2.5 and PM10, goes much beyond the prescribed standards. Pollutants from stubble burning in adjoining states, vehicular pollution, particulate matter from construction work majorly contribute to the decline in air quality which is further exacerbated by firecrackers during Diwali and New Year celebrations.

DPCC said that large scale celebrations by the bursting of firecrackers will result in violation of social distancing norms, which could lead to another Covid-19 surge. It further noted that the firecrackers would result in a high level of air pollution leading to serious health issues in Delhi, "which under the prevalent pandemic crisis situation is not favourable for the cause of larger community health."

6 months visa to be granted to Afghan soldiers being trained in India: Report

New Delhi: India would grant six months e-visa to around 180 Afghan soldiers and cadets being trained in the different military academies in the country after they complete their courses here.

However, around 140 of these Afghan soldiers and cadets have applied for visas for western countries including Canada, England and Germany. "E-visas for six months would be given to all the Afghan cadets and soldiers who are training in our academies. They have the option of deciding upon their course of action regarding their future in this period," government sources told ANI.

Around 140 of them have applied for asylum in different countries mostly in the west including Canada and Europe. Many of them also want to stay in India and they have been put in touch with agencies who have been working with Afghans already living in the country, they said. The future of these cadets became uncertain as the Taliban are strengthening their control over areas in Afghanistan.

India decided to allow around 180 of these cadets to complete their respective courses in the military academies of defence forces here. The Indian defence forces have been training Afghan soldiers as part of the capacity-building programme.

As many as 180 Afghan military personnel are being trained at different institutions, with a bulk of them at the Indian Military Academy (IMA) at Dehradun, the Officers' Training Academy (OTA) at Chennai and the National Defence Academy (NDA) at Khadakwasla in Pune.

24 Killed In 24Hrs

SRINAGAR Twenty-four people including 18 militants and four security personnel were killed in different gunbattles in Jammu and Kashmir over past 24 hours, a defence spokes-man said today. Five foreign militants of Jaish-e-Muham-mad were killed in an encounter with security forces at Hill Kaka sector (Surankote) The deceased were identified as Shaheen R/o Multan, Abdul Rouf R/o Sahiwal, Pakistan, Chacha Sadiqi R/o Multan, Jameel Muhammad R/q Kotli and Abdul Rasheed R/o Nakyal, Pck, official sources said.

"Five more unidentified militants were killed at Kam-alHump post, Tangdhar in Knpwara district. Three AK-47 rifles, 3 magazines and 6 hand grenades were recovered from their possession, official sources said.

He said the army gunned down two more militants in an encounter at Chowkibal in Kupwara district last night, adding some arms and ammunition were recovered from the killed militants. Security forces last night cordoned village Mangwani, Achabal in Anantnag district, police sources said adding militants hiding there fired upon the search party belonging to 7 Rashtriya Rifles (RR). The fire was returned and in the ensuing encounter one jawan and one militant were killed. The army jawan has been identified as Gurnail Singh and the militant as Shah Din alias Shakeel of Pakistan. An SPO namely Inayatullah Mir of Chitti Bandy in Bandipore area of Baramulla district was killed when militants fired upon security forces during the preceding night, police sources said. One army jawan lost his life and three others sustained injuries when militants triggered off a mine blast at Pather Post area, sector Drass in Kargil. "The vehicle they were travelling in also was damaged in the blast, defence sources said.

An Ikhwani was killed in Pattan today when suspected militants sprayed bullets on him in bazar. The deceased was identified as Nazir Ahmad Wani S/o Ghulam Ahmad Wani. Five more militants were killed in different incidents of violence in Poonch sector. Two of them were affiliated with Hizb-ul-Mujahideen while one of Lashkar-e-Taiba. The identity of two others could not be ascertained.

Unidentified gunmen shot dead one Nissar Ahmad S/o Gulab Din of Hill Top, sector Darhal in Kargil, Police has taken cognizance.

Talk To Farmers

Bharat Bandh called by the Samyukt Kisan Morcha, the umbrella body of over 40 farm unions spearheading the farmers' agitation, to mark the first anniversary of the enactment of the three controversial farm laws on September 27 generated good response across the country. The bandh was held from 6 am to 4 pm during which all government and private offices, educational and other institutions, shops, industries and commercial establishments as well as public events and functions were closed in many parts of the country. The opposition political parties and the governments of Tamil Nadu, Chhattisgarh, Kerala, Punjab, Jharkhand and Andhra Pradesh extended their support to the bandh, and the protest evoked response in these states. The Bandh also garnered support from more than 500 farmer organizations, 15 trade unions, and varied sections of society.

Farmers held rallies and the major mandis and markets remained shut. The protesting farmers were seen squatting on railway tracks at many places.

The farmers' protest began last year on November 26 against the three farm laws: Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020; the Farmers Empowerment and Protection) Agreement on Price Assurance and farm Services Act 2020 and the Essential Commodities (Amendment) Act, 2020. While the centre has defended the laws as major reforms in the agriculture sector that will remove the middlemen and allow farmers to sell their produce anywhere in the country, the farmers contend that the legislations would eliminate the safety cushion of Minimum Support Price and do away with the "mandi" system. They also fear that the laws would bring on the scene the corporates who would monopolize the trade and feel empowered to determine the market prices.

The farmers leader Rakesh Tikait termed the bandh successful, saying it had the support of all farmers. He added that the farmers were ready for talks with the central government, but no talks were happening right now.

But the government, on the other hand, is showing no signs of backing down. Early this year, the central government had offered to suspend the farmer laws for one and a half years. Farmers, however, rejected this offer. They want nothing short of the repeal of the laws. It remains to be seen how the government responds to the bandh and mounting protests. It would be great if the government shelves the laws and then engages farmers in a discussion about them to mobilize support for their re-enactment in future.

On PM Modi's Speech At UNGA

For the third consecutive year in a row, and his fourth such speech since he was elected in 2014, Prime Minister Narendra Modi addressed the UN General Assembly, outlining his outlook on India's place in the world. Referring to India's large population, he said that the world grows when India grows, and transforms when India reforms, pointing to examples of the country's progress and impact: in the area of vaccines and pharmaceuticals, particularly to counter COVID, green technology and the promise of 450 GW of renewable energy by 2030, and poverty alleviation. He also enumerated how many Indians had been provided water connections, banking access, insurance coverage, health services and homes, although his claim that these "all-inclusive" development goals had been achieved only in the "last seven years", struck a politically partisan note that was out of place. Moving to regional matters, Mr. Modi pointed to the contrast between India's actions and those of Pakistan and China in veiled references. In an apparent message to Pakistan, he linked events in Afghanistan, where the Taliban have taken control, to the problem of "regressive thinking" that leads to the use of terrorism as "a political tool". He also called for safeguarding the maritime sphere from the "race of expansion and exclusion" and referred to the need for investigating the "origins of the coronavirus", subjects China is sensitive about. Addressing the UN directly for its own shortcomings, the PM said that time waits for no one, urging the UN to speed up the reforms process that has been flagging for more than a decade, which would include an expanded Security Council. This, he explained, is the only way to restore the credibility of global governance institutions.

Mr. Modi's strongest words came at the beginning of his speech, where he launched a defence of the state of Indian democracy, which has come in for some criticism over the past few years. He said India had been named the "mother of democracy" for its adherence to democratic values, symbolised by its diversity, pluralism, inclusivity, and equality, that allowed someone like him, who had once worked at his father's tea stall, to become the country's leader. The PM's words appeared to be a response to comments made during his Washington visit, where U.S. President Joe Biden and Vice-President Kamala Harris stressed the need to strengthen democratic processes internally. Even as he addressed the UN, protesters outside criticised his government for actions against activists, NGOs, the laws on agriculture and citizenship, and incidents of lynching and mob violence. While the PM's commitment to India's "great tradition of democracy" was heartening, it will be measured not by words at the world body, but by answers and actions on the ground in India.

AUKUS vs. QUAD: A Reality Check

India It Seems Has Been Left Out In The Cold On The Issue Of Maintaining Regional Security In The Asia-Pacific Region After The Formation Of AUKUS By The US

The past week saw the US's hard push to contain China in its own backyard, by the formation of a new defence agreement known as AUKUS, with no precedent in diplomatic world, as the regional might of the new alliance is already covered by an old alliance named Quad.

AUKUS-named after Australia, United Kingdom and United States proclaims to bring hard military power to support the order built by the United States in Asia, and "sustain peace and stability in the Indo-Pacific region", as per a statement by the White House.

Observers are quite perplexed by this new American action, as it has no parallel in the modern day diplomatic history. Some describe it as Anglo-phonic camaraderie. Through AUKUS, for the first time in history the US will share its nuclear technology with any country. The new agreement will deliver 60 attack submarines, including six nuclear attack submarines to be built by the UK and technology provided by the US.

In fact, AUKUS demonstrates the seriousness with which the US views the Chinese activities in the South China Sea and adjoining islands, China has claimed most of the territories in the South China Sea, defying a 2016 decision by the Permanent Court of Arbitration at The Hague declaring it as without legal basis.

It has also built artificial islands in the South China Sea and constructed massive runways and shipping docks, while also reportedly installing missile systems on the Spratly Islands. It has rejected competing claims from Brunei, Malaysia, the Philippines, Taiwan and Vietnam in the South China Sea.

Chinese Reaction

Chinese President Xi Jinping has warned against "interference from external forces" in the region, as Australia shrugged off Beijing's growing anger about AUKUS. In an address before the Shanghai Cooperation Organisation (SCO), Xi urged heads of state to "absolutely resist external forces to interfere [in] countries in our region at any excuse, and we hold the future of our countries' development and progress firmly in our own hands".

China's state-owned publication Global Times also described Australia as "a pawn of the US" and called it "naive" for financing "America's cold war gambit". "Australia could face the most dangerous consequence of being cannon fodder in the event of a military showdown in the region."

French Reaction

AUKUS has caused much consternation and anger in France—because Australia terminated an earlier deal with Naval Group, a state-controlled French company, to build a dozen diesel-powered submarines.

French Foreign Affairs Minister Jean-Yves Le Drian, who laid out his own vision for the Indo-Pacific in a July visit to Washington, called the announcement a "stab in the back" and ordered a recall of the French ambassadors from Washington and Canberra.

In their responses, French officials and some commentators have cast the announcement as an indication of a major strategic shift, particularly

larly on the part of Washington. The move, they assert, represents a kind of geopolitical infidelity by the United States that demonstrates it does not take France (and by extension, they hasten to add, Europe as a whole) seriously as a partner.

The announcement has also fuelled fears that Europe is being cut out by Washington, with EU nations still smarting over the way the US handled the withdrawal from Afghanistan

The EU has complained that it was kept out of the loop on a new military partnership between the US, UK and Australia, as Brussels was planning to lay down its own strategy for the Indo-Pacific on 17 September.

"We regret not having being informed, not having been part of these talks," EU foreign policy chief Josep Borrell said.

The 27-nation bloc is looking to strengthen ties in the vast region where it says it is "already the top investor, the leading development cooperation partner and one of the biggest trading partners".

But Borrell insisted the strategy was "one of cooperation, not confrontation" with China.

Australian Defence

In a series of media interviews, Morrison said his government was reacting to changing dynamics in the Asia-Pacific region, where territory is increasingly contested and competi-

tion is rising.

Morrison said Australia is "very aware" of China's nuclear submarine capabilities and growing military investment, he told Channel Seven television. "We are interested in ensuring that international waters are always international waters and international skies are international skies, and that the rule of law applies equally in all of these places," he said.

Morrison told Australian media that the defence alliance had been "well-received" in his discussions so far with leaders in Japan, India, Singapore, New Zealand, Fiji and Papua New Guinea.

India's Predicament

For New Delhi, AUKUS isn't good news, either. The new accord raises questions about the importance of the Quad—the four-nation alliance of the United States, Australia, Japan and India. In particular, New Delhi will worry that the United States is concerned only with pushing back against China, leaving its concerns about Pakistan and the western Indian Ocean unaddressed. India also felt left out of the regional political dynamics when it was not invited to join the Doha talks with Taliban alongside the US, Pakistan and Qatar.

Indian PM in the US

Meanwhile the Indian Prime Minister Modi met the US President Biden and Japanese and Australian PMs at the

White House in Washington for the first Quad summit on 23rd face to face and discussed the priority areas for Quad.

Biden said this is a grouping of "democratic partners who share a world view and have a common vision for the future" and are "coming together to take on key challenges". Evolving a common approach to emerging technologies, cyber security and addressing the challenge of climate change and space cooperation, and Covid vaccination. This means that Quad will act as a socio-economic organisation and the region's defence will be led by AUKUS, which leaves India in the cold regarding its concerns of Chinese aggression in the North China Sea and Indian Ocean.

Before the Quad meeting Biden and Modi met separately to discuss bilateral issues, Mr Modi laid stress on issues such as trade, technology, climate challenge and Covid management.

However, Mr Modi's bilateral meetings with the POTUS and the VP regarding AUKUS and Quad didn't result in any benefit for India. Instead, he got lessons on maintaining democracy, democratic traditions and democratic institutions by both the American leaders, whatever little the US media reported revealed and that might have forced him to change his address at the UNGA on the theme of democracy in the region.

Reinvigorating Multilateralism

The United Nations' Global Consultation Last Year Showed That The Vast Majority Of People Want More International Cooperation To Address Problems Like Pandemics And Climate Change. To Meet That Demand, World Leaders Must Commit To Strengthening Multilateral Institutions, Starting With The UN Itself.

MADRID – Last year, the United Nations conducted a worldwide consultation involving more than one million people from 193 countries. The feedback pointed to some important facts. And this year's UN General Assembly must respond by bolstering rules-based multilateralism.

For starters, the consultation found that the expectations and hopes of the world's women, men, girls, and boys are strikingly

similar. People want better access to basic health care, sanitation, and education. They also want to see more solidarity with those hit hardest by the pandemic and with those living in poverty. Respondents' top concern over the longer term is the twin crisis of climate change and accelerating biodiversity loss. Almost 90% of participants agree that global cooperation is vital to deal with today's challenges, and a majority believe that



the pandemic has made international cooperation even more urgent. Especially encouraging is that young people worldwide clearly want more international cooperation.

Last year's consultation was a call to action. Now, UN Secretary-General António Guterres has released Our Common Agenda, which follows on the UN75 Political Declaration adopted by all UN member Heads of State and Government one year ago. The new agenda sets out a bold plan for how we can tackle the challenges of today and tomorrow.

The threat of breakdown must be viewed as an opportunity for a breakthrough. That is why we are committing to step up our countries' support for the secretary-general's efforts to translate the UN's ambitious agenda into reality.

The COVID-19 pandemic, which we are still battling at the global level, has driven home the message that we live in an interconnected and interdependent world. Moreover, in the last few months, we have

seen record numbers of people affected by heat waves, devastating floods, and some of the largest wildfires in recent history, confirming once again the unparalleled threat posed by our changing climate.

The UN is the heart of the international system. The fact that the world came together 76 years ago to create an organization to "achieve international cooperation in solving international problems" is extraordinary in itself. But even more striking is that this organization, despite its challenges and shortcomings, has endured. It has shown that the path to a better, more peaceful, and sustainable future is paved with cooperation, not zero-sum competition. However, the world's international organizations were built primarily to resolve inter-state challenges, not problems that transcend borders, such as financial crises, pandemics, terrorism, crime networks, threats to our oceans, or climate change. We therefore must

modernize our multilateral institutions, making them fit for purpose and better equipped to deal with the global and cross-generational challenges we face.

Having observed the stark differences between the world of the UN's founding generation and the world of today, we decided last year to revive the debate about reforming the UN Security Council, and to continue the work of revitalizing the General Assembly and strengthening the Economic and Social Council. In line with the Joint Statement that we signed on November 10, 2020, in Madrid, we see three areas of action that should be emphasized in order to advance our common goal of reinforcing multilateralism.

First, we need a renewed commitment to international cooperation. Multilateral organizations must be furnished with the means and the mandate to make a difference on the ground. Cooperation among the UN, regional organizations, and international financial institutions must im-

prove at both the policy and the operational level. The multilateral system needs to be more open and inclusive to give young people, civil society, the private sector, academia, and others a spot at the table.

We are already putting this into practice. On the margins of this year's General Assembly, we have organized the virtual event "Delivering the UN Common Agenda: Action to Achieve Equality and Inclusion" in collaboration with the Pathfinders for Peaceful, Just, and Inclusive Societies initiative. We intend to ensure that all voices are heard.

Second, we must act on the secretary-general's agenda of bold steps to revive and strengthen our capacity to tackle poverty and inequality; ensure inclusion, equal participation, and justice; address the climate crisis and accelerating biodiversity loss; and equip ourselves for future threats of pandemics.

We have learned from the COVID-19 crisis that we need to strengthen our collective ability to anticipate, prevent, and manage complex risks such as disease outbreaks, new wars, massive cyberattacks, environmental disasters, or other unforeseen events.

We therefore welcome the secretary-general's suggestions for how to strengthen global foresight and risk-management capacity, including the proposal for a new global "Emergency Platform." Lastly, we welcome the proposal for a Summit of the Future in 2023, and we should use that opportunity to step up our efforts to strengthen international cooperation. In today's world, with so many issues reverberating across borders and generations, we must seize this moment to create a more agile, effective, and accountable multilateral system that delivers for all citizens and enables us to tackle the global challenges we face.

We want to be at the forefront of this endeavor. Together, we can and must reinvigorate rules-based multilateralism, with a stronger and more inclusive UN at its core. This is the great political task of our times.

One in three of the world's tree species are at risk of becoming extinct, according to a recent report by the Global Tree Assessment – the first attempt to estimate the conservation status of all of Earth's trees.

Well-known species, including magnolias, oaks and maples are among those at risk. More than 400 species have fewer than 50 individuals remaining in the wild, and 142 tree species are already extinct. Human activity is the overwhelming culprit, especially forest clearance for farming, logging for timber and the spread of invasive pests and diseases.

When myself and colleagues first came up with the idea of a worldwide assessment of tree species in 2015, it seemed like an impossible task. Back then, nobody even knew how many there were, let alone how they were all faring. The first task was to make a list of all tree species that have been described in scientific literature. It turns out there are nearly



60,000, most of which live in tropical forests, and scientists continue to describe new species each year.

We then had to determine which of these are under threat of extinction. Given the huge number of species, this was a much bigger task than any conservation assessment undertaken previously. We created a global network of more than 500 experts, each assessing the species they were most familiar with, and the report is the result of that enormous collaborative

effort which took five years to complete.

There are twice as many threatened tree species globally than threatened mammals, birds, amphibians and reptiles combined. But trees are also food and habitat for at least half of the Earth's known land-based plants and animals. Losing tree species can cause cascades of extinction among the many species that depend on them.

Trees are very valuable to people too. More than one-fifth are used as a source of food, fuel, timber or medicine. Others have important cultural and religious value. Worryingly, some of the most useful and significant species are among those facing extinction. Here are five of them.

Dipterocarps

THERE ARE TWICE as many threatened tree species globally than threatened mammals, birds, amphibians and reptiles combined. But trees are also food and habitat for at least half of the Earth's known land-based plants and animals. Losing tree species can cause cascades of extinction among the many species that depend on them

from the island of Borneo alone, where 182 species are threatened with extinction, including the tallest known tropical tree, Shorea faguetiana.

Agarwood

Agarwood is fragrant and produces a highly valuable resin called aloes, used in perfumes and incense. It is one of the most valuable raw materials in the world, worth up to US\$100,000 a kg and with a global trade valued at US\$32 billion.

The production of this resinous wood is stimulated when these trees are attacked by a fungus. Overharvesting of the resin has led to more than 20 species being threatened, including the main source of agarwood, Aquilaria malaccensis.

African Cherry

Prunus africana has bark containing a range of compounds which can reduce inflammation, making it useful for treating a range of diseases, including malaria, kidney disease and prostate disorders. The international trade in the bark is valued at US\$200 million, but overharvesting has meant this species is threatened throughout its range in central and southern Africa.

Mahogany

Swietenia macrophylla is one of the most valuable tropical hardwoods, valued for making furniture and musical instruments such as guitars. Mahogany wood is durable and has a beautiful colour. A single tree can be worth many thousands of dollars.

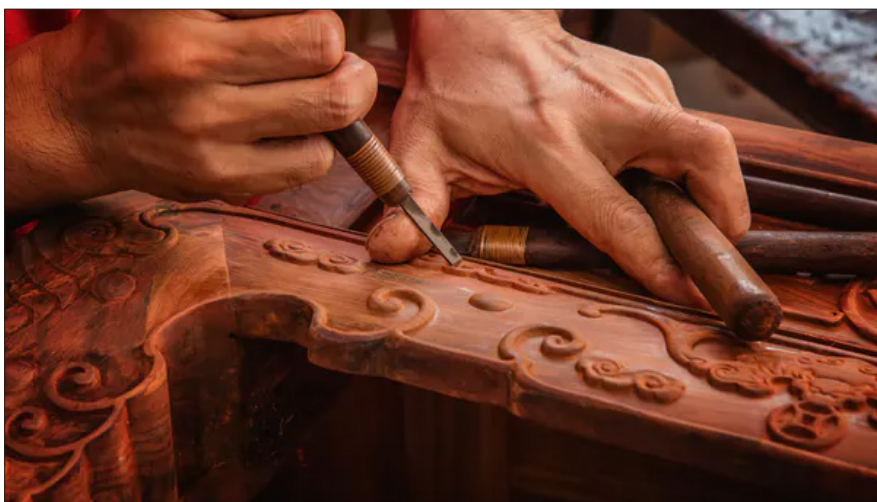
Native to the tropical forests of the Americas, mahogany was one of the first



trees to be listed as an endangered species, owing to widespread illegal logging.

Pacific yew

Taxus brevifolia is the source of the anti-cancer drug Paclitaxel, which has a global trade worth over US\$100 million. Native to the Pacific Northwest of North America, this evergreen conifer is now categorised as Near Threatened by the International



Union for the Conservation of Nature (IUCN), primarily because of logging. Other yew species, which are also a source of this drug, are even more threatened, such as Taxus contorta in the Himalayas.

While individual trees are important for both humans and wildlife, the collective value of forest ecosystems is far higher. Forests cover approximately 31% of the

world's land surface and their total economic value has been estimated at around US\$150 trillion. Forests contain around 50% of the world's terrestrial carbon and help provide 75% of its accessible freshwater. These benefits could be lost if tree species go extinct.

As well as supporting wildlife and people, tree diversity can help forests cope with disturbance. For example, having a diverse range of tree species in a forest reduces the damage that plant-eating insects can do, and makes the ecosystem more resilient to drought.

As tree species die out, forest ecosystems are placed at greater risk of collapse. Con-

serving both forests and the tree species they contain can combat climate change and preserve biodiversity. The world must urgently protect threatened trees, restore degraded forests and ensure that the harvesting of useful tree species is sustainable.

JCCI Meets Union Minister; Bats For Setting Up Of New PSUs In Railway, Defence In Jammu Region

JAMMU: The Jammu Chamber of Commerce and Industry (JCCI) on Tuesday met Union Minister of State for Finance Pankaj Choudhary here and battled for establishing new public sector undertakings in railway and defence sectors in the Jammu region.

A delegation of JCCI met Choudhary here and submitted a memorandum, which, among other things, demanded setting up of new public sector undertakings by the government to generate employment and give fillip to the economy of the Union territory.

Led by JCCI President Arun Gupta, the delegation also sought refund of SGST to industrial units and benefits of

new industrial policy to existing unit holders while opposing any move by big companies to open stores in the retail sector in the Jammu region.

"There is a dire need for establishing new public sector undertakings in the Jammu province; and in this regard, the industries of railway and defence sectors are the best options.

"Such units should be established by the central government as it will undoubtedly generate huge employment opportunities for the youth besides giving a fillip to the UT's economy," Gupta told the minister.

The Union minister reached Jammu on Monday as part of the central government's public outreach programme and held a series of meetings with

government officials besides interacting with BJP leaders and various delegations.

On September 22, the JCCI sponsored a strike in the Jammu region against alleged "directionless policies" of the government detrimental to the interests of the business community.

Among other things, the chamber expressed its resentment against the decision of the lieutenant governor administration to stop the 'Darbar move' under which the government used to rotate its seat between the twin capitals for six months each.

The Gupta-led delegation sought refund of SGST to industrial units of UT of J&K and also demanded the benefits of the recently announced New

Industrial Policy to the existing industrial units of the Jammu region, the JCCI said in a statement here.

Expressing resentment over the opening of retail stores by big companies in Jammu, the JCCI said "if this happens then the small shopkeepers of Jammu will be ruined and their shops will be closed".

The delegation also pitched for tapping of the huge tourism potential in Jammu province, the statement said.

The JCCI said the delegation also discussed various other issues, including stopping of darbar move, clarity on land and labour policy, completion of pending projects, delay in payment to contractors, issues of wine traders, sand mining and crushers and brick kiln trade.

Sebi Clears Frameworks For Gold, Social Stock Bourses, Changes To Delisting Norms

MUMBAI: Sebi on Tuesday approved frameworks for gold and social stock exchanges, and changes to delisting norms to make M&As more rational as well as to superior voting rights and various other proposals, mainly aimed at deepening the securities market.

The Sebi board at its meeting here decided on a framework for the social stock exchange (SSE) for fundraising by social enterprises.

After the board meeting on Tuesday, Sebi Chairman Ajay Tyagi said that SSE will be a separate segment of the existing stock exchanges.

Social Enterprises (SEs) eligible to participate in the SSE should be entities -- Non-Profit Organisations (NPOs) and for-profit social enterprises

-- having social intent and impact as their primary goal.

The framework for the Social Stock Exchange (SSE) has been developed on the basis of the recommendations of a working group and technical group constituted by the regulator.

The Sebi board also cleared a proposal for setting up a gold exchange wherein the yellow metal will be traded in the form of electronic gold receipts and the bourse will help in having a transparent domestic spot price discovery mechanism.

The instruments representing gold will be called Electronic Gold Receipts (EGRs) and will be notified as securities, Tyagi said.

"EGRs will have the trading, clearing and settlement features akin to any other securities," he said.

Any recognised stock

exchange, existing as well as new, can launch trading in EGRs in a separate segment. The denomination for the trading of EGR and conversion of EGR into gold can be decided by the stock exchanges with the approval of Sebi.

The gold exchange, encompassing the entire ecosystem of trading of EGR and physical delivery of gold, is expected to create a vibrant gold ecosystem in India, Sebi said in a statement.

In a move to help new-age technology companies, the market regulator decided to relax the framework governing the issue of shares with superior voting rights (SR shares).

Sebi said promoters who have a net worth of over Rs 1,000 crore can have superior voting rights in their companies, raising it from the current Rs 500 crore.

Work on Zojila

Leh-Ladakh region to Srinagar.

Terming the Zojila tunnel of significant importance for both Kashmir and Ladakh, Gadhkari said that extensive road networks in the Himalayan region will help boost the tourism sector in the area.

The Minister gave the detailed information about the two tunnel projects and said that the Central Government has given a new impetus to the construction of new highways, tunnels and bridges which will bring transformative changes in the lives of people and will create huge employment opportunities to the local people.

"He said that the Zojila tunnel project will provide all weather connectivity to Ladakh. He assured that work on the Zojila Tunnel is in full capacity and NHIDCL is geared up to continue the work in winter months. He stressed for putting in every effort in place to complete the project well before the scheduled date," the official spokesperson said.

Gadhkari, he said, expressed his satisfaction on the work progress and said that the Zojila tunnel is of a significant importance to the development and tourism for both UTs of J&K and Ladakh as it will provide round the year connectivity to Ladakh region.

Pertinent to mention that, once completed the Zojila tunnel will be India's longest road tunnel and Asia's longest bi-directional tunnel. Several bridges are being constructed along this route and a connecting tunnel from Z-Morh in the National Highway-1 to Zojila tunnel will be constructed in the Zojila Ghats between Sonamarg and Kargil. The entire work is divided into two divisions in the 33 km span.

This project coming up at an altitude of 11,578 ft will provide all-weather connectivity to Ladakh against just five months access with the Srinagar-Kargil highway closed from mid-November to April, cutting off this entire region from the rest of the world.

This pass will also provide easy movement of the Army vehicles.

Stressing upon the state of art infrastructure in the tunnel projects, Gadhkari said that appropriate security measures have been kept in place including vertical shafts at three places and adequate security and lighting measures with CCTV, fire alarm and heat detection systems at par with international standards.

"He further highlighted various important tunnel, rail and road projects of the country that were completed on priority by the Government keeping in mind border security alongside development and said various infrastructure development projects are going on in full swing throughout Jammu and Kashmir," he added.

"The present site location falls into seismic zone IV and all precautionary measures have been provisioned to safeguard the structures provisioned in the project," he said.

He further said that earlier the Minister also reviewed the progress on Tunnel 1 and Tunnel 2 at Nilgrar site and Z-Morh site.

LAHORE: Pakistan's former captain and most capped player Inzamam-ul-Haq had to undergo an emergency angioplasty at a private hospital here after complaining of heart-related issues and breathing difficulty.

A family member said that Inzamam felt uneasy and complained of having difficulty in breathing on Monday.

He was taken to a private hospital where, after several tests, it was revealed that he might have had a minor heart attack. Doctors advised him to undergo an emergency angioplasty and well-known heart surgeon, Professor Abbas Kazim, performed the procedure.

"Inzamam is now doing much better and will be released soon from hospital. He is okay now," one family member said.

The 51-year old, who played 120 Tests and 378 One-Day Internationals during an illustrious career, also served as chief selector between 2016-2019 and it was in his tenure that Pakistan won the ICC Champions Trophy final against India in 2017.

He was, however, unceremoniously told to step down in late 2019 after the World Cup by a new Pakistan Cricket Board management.

The former top batsman also coached the Afghanistan team in the 2016 World Cup T20.

Indian cricket icon Sachin Tendulkar wished him a speedy recovery.

"Wishing you a speedy recovery @Inzamam08. You've always been calm yet competitive, and a fighter on the field. I hope and pray that you'll come out stronger from this situation as well. Get well soon," he tweeted.

Warner's absence from the team dugout did not go unnoticed and fans wondered about his whereabouts underneath an Instagram post by SRH.

Responding to the queries, Warner posted, "Unfortunately won't be again but keep supporting, please."

Warner has been woefully out of form this season, having

accumulated just 181 runs in eight matches so far at an average of 24.37. His strike rate, at present, is the lowest in all his IPL stints, making it his worst season in the league.

The 34-year-old joined SRH in 2014 and captained the side to its maiden IPL title in 2016.

Dropped from the leadership role after the 2018 ball-tampering scandal, he came back as skipper in 2020.

He was again removed as captain during the first leg of this season due to the team's poor run and differences with Team Director Tom Moody and head coach Trevor Bayliss.

"We can't make the finals, so we made a decision that we want the youngsters to experience not just the matches, but time at the ground and around the set-up," Bayliss had said at the post match press conference on Monday when asked about Warner staying back at his hotel room.

IPL sources have revealed that he will be released at the end of the season and go back to the auction pool.

BCCI Delay Domestic Season Due To Heavy Rain, Cyclone Alert

NEW DELHI: The start of India's domestic season has been delayed by two days with the Under-19 events for boys and girls pushed back to September 30 due to a cyclone alert in south Odisha and north Andhra Pradesh coasts.

"Owing to the incessant rain and the cyclone alert issued by MET, the BCCI is compelled to postpone the start of the group stage from 28.09.2021 to 30.09.2021," wrote Dhiraj Malhotra, BCCI General Man-

ager — Game Development — in his letter to the seven host associations.

Following this change in schedule, there will be no rest days and all matches will be played back-to-back from September 30 to October 4.

"There will be no change to the knockout stage and venue. This decision has been taken to ensure that all the matches are played and there is no loss due to the inclement weather.

"Keeping the upcoming ICC Under 19 World Cup 2022 in mind, we need to ensure that the players get maximum opportunity and exposure to showcase their talent and make an earnest effort to be selected for the country," he wrote.

The last domestic season was hit by COVID-19 with Ranji Trophy cancelled for the first time ever in 87 years history of the tournament while the age groups were also not held.

Iran Book Historic Ticket For Women's Asian Cup Finals

NEW DELHI: Indonesia joined four other countries, including first-timers Iran, in qualifying for the AFC Women's Asian Cup to be hosted by India in January-February next year.

Indonesia topped Group C in the qualification tournament in Dushanbe, Tajikistan on Monday to ensure their fifth appearance in the tournament while Iran emerged Group G winners for their debut participation.

Former champions Thailand, South Korea and the Philippines also qualified for the 12-team continental women's showpiece to be held in India for the second time after 1979.

The tournament, which will also serve as the final stage of Asian qualification for the 2023 FIFA Women's World Cup in Australia and New Zealand, will be held in Mumbai, Navi Mumbai and Pune from January 20 to February 6.

South Korea, who had finished third in 2003 as their best performance, will be making their 13th appearance after topping Group E, while the Philippines won Group F for their 10th participation.

Thailand, who won the 1983 edition, topped Group H for their 17th appearance in the tournament.

2-Time Taekwondo Gold Medallist Arrested For Robbery In Delhi

NEW DELHI: A 28-year-old national-level two-time gold medallist taekwondo player, who also participated in TV show Indian Idol, was arrested in west Delhi for allegedly being involved in over 100 cases of snatching and robbery, police said on Monday.

The accused has been identified as Suraj alias 'Fighter', a resident of Vikas Nagar, Uttam Nagar, they said.

On Wednesday, police were patrolling at Najafgarh Road, Rama Road, Moti Nagar and saw a suspicious person on a scooter, following which he was intercepted. Police checked and found the scooter was stolen from Kirti Nagar area, a senior police officer said.

During interrogation, he confessed to snatching many mobile phones and robbing of 2.5 kg gold articles from the area of Subzi Mandi police station in north Delhi, police said.

He committed robbery with his two associates by using a country-made pistol and a knife on a motorcycle. He also confessed to committing over 100 snatching in different parts of Delhi, especially in west, outer, central and north districts, the officer said.

One country-made pistol, along with one live cartridge, 55 mobile phones and five two-wheelers were recovered from his possession, police said.

Out Of Turn Land Allotment To Sourav Ganguly: Calcutta High Court Imposes 'Token Cost' On BCCI Chief

KOLKATA: The Calcutta High Court on Monday imposed a token cost of Rs 10,000 on Board of Control for Cricket in India (BCCI) president Sourav Ganguly and imposed a cost of Rs 50,000 each on the West Bengal government and a state-owned corporation over out of turn allotment of land to the cricketer hero in New Town area close to Kolkata to set up a school.

Passing the order, a division bench comprising Acting Chief Justice Rajesh Bindal and Justice Arijit Banerjee said there is need to have a defined policy to guide on all issues so that there is no arbitrary exercise of power by applying pick and choose formula.

The bench, in its order, said though the plot of land had been returned by the allottees, for the conduct of the state in generating litigation by an arbitrary exercise of power which runs contrary to the law laid down by the Supreme Court, a cost of Rs 50,000 each was imposed on the state and West Bengal Housing Infrastructure Development Corporation (WBHIDCO).

The bench imposed a "token cost of 10,000" on the former India cricket captain and the Ganguly Education and Welfare Society "for the reason that even they should have acted in accordance with law specially considering the earlier judgement whereby arbitrary allotment of plot in their favour was set aside by the Hon'ble the Supreme Court."
