haunting darkness wrapped the old-fashioned lawns of the Shah House in Srinagar when a dreadful knock on the door raised an alarm.

The clock was yet to turn past 6 pm, but the last night's melodrama and the vicious verbal abuse was still pounding Shahana's restless heart. Like a recluse waiting for her proportion of a peaceful life, she already forgave his sins. But one fussy accusation simply shook her up: "You're a bloody barren!"

Deep down, she was thinking that it was her existence that had been thrown into an indictment, but it was nothing new for her.

For the past few years, Shahana's in-laws had already turned the torrent of abuse into a normalcy in her life but the latest indictment proved to be the last nail in the coffin of dreams as it came from her

There were marriages in her family that had fallen



apart quite easily, as if they had been perforated from

the very beginning but that wasn't the case with her life.

marriage had proved to be a "subtle art of a healthy relationship" but then, the bracing relation adopted an ugly side. The couple tried every medical solution, but to their chagrin, it proved nothing more than a debacle.

And then the childless woman became the freshly inducted sight of taunts. Her relatives asked her to sit far from their children, her in-laws called her barren-even as the test reports had proved otherwiseand her husband termed her

As the nerve-jerking insult of the previous night was still sinking in her, she opened the door. In a flash, a weary man with sunken eyes rushed inside. As he stepped inside home, Shahana was once again forced to bear the normalised verbal abuse. "You should be ashamed of yourself," she was greeted. "It's you who has forced me to do this!"

She was confused over how to react to her husband's words but stood there staring at him nonchalantly. • More On P10

...J&K BANK LOAN FRAUD CASE

ED Attaches 145 Cr Assets Of Spices Company

DELHI: The Directorate Enforcement (ED) has attached assets worth over Rs 145 crore of a Bengaluru-based spices company in a money laundering probe linked to an alleged loan fraud in the J&K Bank.

The agency said in a statement issued on Wednesday that a factory building, shops, flats and lands of the company, S A Rawther Spices Pvt Ltd, and others were provisionally attached under the Prevention of Money Laundering Act (PMLA).

The total value of the attached properties is Rs 145.26 crore, it said.

The ED case stems from an FIR filed by the anti-corruption bureau of the J-K Police against the company and its promoter director Anish Rawther, the then



manager of J&K Bank branch located at BU Infantry Road in Bengaluru and other officials of the same bank, in August, 2019. "In the FIR, it was alleged

that S A Rawther Spices Pvt Ltd defaulted loan and was declared NPA (non performing asset) in September, 2017. Net amount of Rs 285.81 crore was outstanding with the company besides unapplied interest of Rs 66.91 crore against mortgaged col lateral property of • More On

110 New Cases, **153 Recoveries In 24 Hours**

SRINAGAR: Jammu and Kashmir reported on Thursday 110 fresh cases of novel coronavirus while 153 more patients have recovered from the deadly infection in the Union Territory during the last 24 hours.

Officials said that 84 new cases of Covid-19 were reported from Kashmir Valley and the remaining 26 from Jammu division, taking the total num-ber of people infected since the outbreak of pandemic last year in J&K to 329430.

Giving district-wise details, officials said, Srinagar reported a maximum of 45 cases followed by Baramulla with15, Budgam 7, Anantnag and Bandipora 5 each Ganderbal 4, Kupwara 2, and Kulgam one new case of coronavirus. No fresh case was detected in the twin districts of Pulwama and Shopian in south Kashmir.

Moreover, the officials said that 153 more patients have recovered-26 from Jammu Division and 127 from K

ATS Gujarat Arrests 2 Kashmiris in 15 Year Old Case

AHMEDABAD: The Gujarat Anti-Terrorist Squad (ATS) on Thursday arrested an accused wanted in a 2006 'terror conspiracy case" along with another man from the Union Territory of Iammu and Kashmir, a senior official said here.

Bilal Ahmed Dar, who was on the run for 15 years following a bomb blast at Kalupur railway station in Ahmedabad in 2006, was arrested by an ATS team from Baramulla district, said Gujarat Director General of

Police Ashish Bhatia. The ATS also arrested Hussain Ali Dar, a resident of Anantnag who had allegedly sent 108 kg of charas to Gujarat before 2009 and was

suspected to have used the money to fund anti-India activities. Both the accused were being

brought here, the DGP added. A blast at Kalupur railway station, the main station of Ahmedabad, in February 2006 left several persons injured though no one was killed.

"Investigation revealed that two men from Kashmir -- Aslam and Bashir -- incited some youngsters studying at a Bharuch-based madrasa by showing them videos of post-Godhra violence and brainwashed them into spreading terror in the country as a revenge," Bhatia told reporters.

Bilal Dar was studying at this madrasa in 2006, he added. Subsequently, • More On P10

SRINAGAR: In order to address the grievances related to Migrant properties filed by the Kashmiri migrants in different categories, the District Administration Srinagar has resolved as many as 660 complaints till date since the launch of dedicated Online

Grievance Portal for migrants. Giving details about the grievances addressed in the district so far, the Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Asad said that till date 660 grievances have been received by the District Administration, out of which 390 grievances alleging alienation by fraud or

distress sale were resolved. Similarly, 129 grievances alleging encroachments on migrant properties were also verified and resolved. Out of grievances of encroachment, the necessary demarcation of 20 cases has been done and necessary eviction notices have also been issued, though 12 of them are sub-judice before

the High Court. The DC further said that 16 cases of tampering of revenue records were also verified and replied back to the complainants. Cognizance has been taken and action being initiated against officials involved in tampering of Revenue records. While 18 cases of trespassing were also verified, out of which

few were found lacking the exact details of the properties and the same have been sought for final resolution"

he added. He also said that some trespassing cases involved pending rentals with security forces and lack of compensation by the R&B (PWD) Department. In three cases of illegal trespassing the necessary follow up action has already been initiated, the DC further added.

Israel Foreign Minister In Bahrain For Landmark Visit

srael's foreign minister has arrived in Bahrain for the highest-level official Israeli visit to the Gulf state since the countries established ties last year.

An Israeli foreign ministry statement said Yair Lapid, who had been invited by his Bahraini counterpart, will inaugurate the Israeli embassy in Manama on Thursday and is "expected to sign a list of bilateral agreements".

"This will be the first official visit by an Israeli minister to (Bahrain)," the statement said.

The Israeli foreign minister touched down at Manama airport over an hour before a Gulf Air A320 took off in the opposite direction for the first commercial national cause. They saw it as an

proud to represent Israel in an official and historic first in the kingdom. Thanks for the warm reception," Lapid said on Twitter. Lapid met later with his Bahraini counterpart Abdullatif al-Zayani.

"We talked about the cooperation between our countries and about taking the official peace between us and turning it into an active, economic, security, political and civic friendship," he tweeted.

Following negotiations spearheaded by former US President Donald Trump, the United Arab Emirates, followed quickly by Bahrain and Morocco, last year became the first Arab states in decades to normalise relations with Israel.

The deals enraged the Palestinians, who felt a betrayal of their

Over 100 Killed In Ecuador's Latest Prison Violence

GUAYAQUIL, ECUADOR: The death count from bloody clashes between rival gangs in an Ecuador prison has surpassed 100, with 52 more wounded, the government prison authority said Wednesday, as soldiers surrounded the facility -- one of the country's many overburdened and understaffed jails.

Inmates went to war armed with guns and grenades on



Tuesday at the Guayaquil prison complex: a clash between prisoners believed to be linked to Mexican drug gangs -- mainly the Sinaloa and Jalisco New Generation cartels.

Soldiers and a tank guarded the complex Wednesday as police on horseback patrolling the perimeter were confronted by worried family members of the men locked up inside.

"We want information because we don't know anything ous riots at four jails including about our families, our sons,' said one woman, who would not

give her name. "I have my son

Tuesday's violence was the latest in a series of bloody prison clashes that have claimed the lives of about 180 inmates in Ecuador so far this year.

The SNAI prison authority said in a tweet that the death of "more than 100" prisoners had been confirmed, with 52 more wounded.

At least six were beheaded, the national prosecutor's office said earlier in the day, adding that two police officers were wounded in the operation to retake control of the prison.

Officers were attacked by inmates with guns.

President Guillermo Lasso announced on Twitter that he was declaring a "state of exception." which will allow him to suspend rights and use public force to restore calm.

Lasso said that he would head a security committee in Guayaauil to control the emergency, but also guaranteed protection of "human rights for all those involved."

A police charge on the prison had prevented "more deaths," said the police chief for the city of Guavaguil, Fausto Buenano.

Ecuador's prison system has become a battleground for thousands of prisoners with ties to powerful Mexican drug gangs.

On February 23, simultane-Guayaquil left 79 inmates dead, several of them beheaded.

China, US In Talks On Military **Relations Amid Strained Ties**

BEIJING: Defense officials from China and the U.S. have held two effort to responsibly manage the days of talks in a small sign of competition between the U.S. and progress amid a continuing sharp downturn in relations.

The secure video conference held Tuesday and Wednesday was led by Maj. Gen. Huang Xueping, deputy direct of the People's Liberation Army's Office for International Military Cooperation, and U.S. Deputy Assistant Secretary of Defense for China Michael Chase.

Chinese Defense Ministry spokesperson Wu Qian on Thursday said the sides "exchanged in-depth views on relations between the two countries and the two militaries and issues of common concern."

However, he blamed "continuous provocation and containment" of China by the U.S. for the "considerable difficulties and challenges" between the two militaries.

"China's sovereignty, dignity and core interests brook no violations," Wu said at a monthly briefing. "Regarding the relationship between the two armed forces, we welcome communication, welcome cooperation, face differences and oppose coercion."

In a statement issued in Washington, Department of Defense spokesperson Lt. Col. Martin Mein- tained a tough line on China, but

During the talks, he said the two sides held "a frank, in-depth, and open discussion on a range of issues." Both sides reaffirmed consensus

Military-to-military ties have been characterized by deep mistrust, with the U.S. accusing China of a lack of transparency as it massively upgrades the capabilities of the PLA, the military wing of the ruling Communist Party.

China has been angered by the Navy sending ships to sail close to islands it controls in what Washington calls freedom of navigation operations, along with U.S. support for Taiwan.

President Joe Biden has main-

ers said the meeting was "an im- has sought better communication with Beijing. The talks between Harris administration's ongoing Huang and Chase are believed to mark the first direct high-level contact between defense officials under the Biden administration.

The talks also follow revelations that the top U.S. military officer, Army Gen. Mark Milley, made a pair of calls to his Chinese counterpart on Oct. 30 and Jan. 8 to reassure him during the waning days of the Trump administration.

Milley, chairman of the Joint Chiefs of Staff, said Tuesday he was responding to a "significant degree of intelligence" that China was worried about a U.S. attack. He said that such military-to-military communications are critical to prevent war between great powers that possess nuclear weapons.

China has not commented on the calls.

Wu also reiterated China's opposition to a three-way strategic defense alliance announced by Australia, the U.K. and the U.S. that includes building nuclear-propelled submarines for Australia. Beijing views the arrangement as firmly directed at containing its development.

"China urges the three countries to abandon their Cold War mentality and zero-sum game thinking, revoke the mistaken decision to develop nuclear submarine cooperation," Wu said.

Top Rohingya Leader In Bangladesh Shot Dead

sailants shot dead a top Rohingya community leader in a refugee camp in the Bangladesh resort district of Cox's Bazar on Wednesday.

Mohibullah was talking with other refugee leaders outside his office after attending prayers when four assailants came to the spot and shot him dead, according to a police spokesman.

"Four to five unidentified assailwas declared dead at a hospital in the camp," he said.

He added that police and an armed police battalion tasked with ensuring security for the country's 34 Rohingya camps, had stepped up security, deploying hundreds more armed officers.

No one was arrested.

'We are conducting raids in the area," the official said, adding Mohibullah had not alerted police of any threats from any group. Mohammad Nowkhim, a spokes-

man for Arakan Rohingya Soci-



ants shot him from close range. He (ARPSH), said Mohibullah was talking to other Rohingya leaders outside the ARPSH office at Kutupalong, the world's largest refugee settlement, when an unidentified assailant shot him three times.

"He was in a pool of blood. He was brought dead to the nearby hospital," Nowkhim said from a hideout, adding that many Rohingya leaders had gone into hiding after the killing.

Israeli Fire Kills Three **Palestinians Including Woman**

Palestinians were killed Thursday by Israeli fire, including a woman who tried to stab officers in Jerusalem, an insurgent shot during West Bank clashes and a Gazan who approached the border fence.

The violence comes days after an Israeli raid on so-called insurgents in the occupied West Bank left five Palestinians dead.

At dawn in Jerusalem, the sound of gunshots rang through the Old City, with the body of a woman lying on a stone street that leads to the Al-Aqsa mosque, an AFP journalist said. She was later draped in a survival blanket

A Facebook-Funded Flight Was **Suddenly Packed With 155 Extra Afghans**

Donors from Silicon Valley including LinkedIn co-founder Reid Hoffman, as well as Facebook Inc., had agreed to fund an evacuation flight for 188 journalists, aid workers and others who were suddenly in danger after the Taliban's quick capture of Kabul. They hoped to get most of those evacuees to Mexico City, via Abu Dhabi, to start a new life.

Those plans largely ceeded. But amid the chaos in Afghanistan, they also took an unexpected turn.

Shortly before their flight left on August 30, the airline -- Kam Air -stuffed the half-empty plane with at least 155 additional passengers -- its employees, their families and more, according to US officials and organisers of the flight. The 11th-hour surprise created

Integrated Kashmir

n a renewed push to complete the Zojila tunnel, Road Transport Minister Nitin Gadkari inspected the west portal of the tunnel in Baltal on Tuesday. The work on the showpiece infrastructure project had halted in 2018 after the IL&FS, the big-time infrastructure lender, went bust. Now the government is making an effort to complete the tunnel by December 2023 so that PM Modi can inaugurate the tunnel before Republic Day of 2024. The tunnel will reduce the distance from Baltal to Minamarg to 13 km from the present 40 km and the travel time will be cut by an hour and a half. Also, at 14.15 km, the Zojila tunnel will be India's longest road tunnel, and Asia's longest bi-directional tunnel. There is one more tunnel close to Zojila: the 6.5 km long Z-Morh which will connect Gagangir with Shetkari. The tunnels between them will ensure that Ladakh no longer will remain an inaccessible, remote region cut off from the rest of the world for six months through winter.

There are other important infrastructure projects in progress whose completion will enhance the connectivity in J&K and Ladakh. On Wednesday, Jammu and Kashmir Lt Governor Manoj Sinha laid the foundation stone for four national highway projects worth Rs 3,612 crore in Jammu and Kashmir, including the Srinagar Ring Road project. Speaking on the occasion, Sinha said that Kashmir will be connected to Kanyakumari by train by next year-end. He said that 11 tunnel projects have been approved for J&K in one year alone.

And once completed, the railway line and the roads will stitch Kashmir together with concrete and asphalt and connect places and people alienated from each other by geography. In recent years, efforts have been ongoing to connect Kashmir Valley all year round with Poonch in Jammu province through a viable road. It is called Mughal road. Efforts are also on to connect district Doda with Valley through shorter all-weather routes. However, what remains a cause of worry is the long gestation period of these projects which are set back by the tough terrain and the inordinate official delay in their execution. There is thus an urgent need to expedite the work on these projects to realize the goal of a truly integrated J&K with its limitless opportunities for trade and travel. The government also needs to rethink the wisdom of closing the cross-LoC routes like Srinagar-Muzaffarabad and Poonch-Rawalakot which promoted trade and travel between divided parts of Kashmir.

Rethink Fuel Prices — It Is A Negative Stimulus

etrol prices were increased by 0.20 per litre in Delhi on September 28. This rise in prices comes after a more than two months of stable or falling prices. Diesel prices have risen four times, by an aggregate of 0.95 per litre since September 24. This rise has come in the backdrop of Brent - the international benchmark of crude petroleum prices – reaching \$80 per barrel after three years. Private analysts such as ones at Goldman Sachs expect petroleum prices to remain elevated.

This is not good news for the Indian economy. Fuel prices are already at a record high in India. If crude prices were to rise further, oil companies are likely to raise fuel prices, and headline inflation will start rising once again. This is bound to hurt purchasing power and mass demand. It will also generate headwinds for the ongoing economic recovery.

India's fuel inflation story is not entirely a result of external factors. Fuel prices would be much lower if the tax component were to come down to pre-pandemic levels. Higher taxes on essentials such as petrol-diesel are a negative fiscal stimulus to the economy. Recently, there have been discussions on the Centre's fiscal situation being better than expected, with higher direct tax collections. Such claims need to be seen in the context of the fiscal buffer from what are inflation-enhancing taxes on petrol-diesel. To be sure, both the Centre and the states are gaining a fiscal windfall from taxes on fuel. In the interest of a sustainable economic revival and preventing inflation and, more importantly, keeping inflation expectations from increasing further, both the Union government and the states must agree to reduce taxes. This is exactly what the Monetary Policy Committee of Reserve Bank of India had asked them to do in August.

he life and teachings of the Prophet of Islam and the Quran demonstrate the inclusive, merciful and compassionate nature of Islam. Within the holy life of the Prophet itself, we come across incidents where the Prophet embraced not only marginalised and oppressed but his enemies and the enemies of Islam too, with the spirit of extending the canopy of mercy to all. This tradition has lately waned away and what we see is stark and ugly growth of ideology in the guise of Islam that is interested in exclusion more than inclusion - a circle under implosion. When one talks of Islam, one is inadvertently driven to the institution of the mosque and the overt and covert manifestations of exclusion in this Islamic institution of primary social importance. to accept humans as humans with all their fallacies and shortcomings. It is very much antithetical to the spirit of Islam to engage in "moral profiling" and ignore those who do not fit into these profiles. The need is instead to open hearts for those who stand in need of support and guidance, those who want to turn to their creator, mend their ways and rebuild themselves but are not shown acceptance at the Mosques or by religious clerics. This has had a regressive impact on how our youth engage with religion and in emselves. The exclusion and reeir behavioural patterns and havbeen deprived of their right to

mercy, participation and inclusion, they end up messing ther lives, the lives of people around them and the society at large. This is not increby hypothetical construct, but a real life issue which plays out in society now and then. It is not the prerogative of fallible humans to enumer-

ate the criteria for inclusion/exclusion and then classify people into either of these classes. The realistic and only acceptable attitude for a preacher (Da'ee) is to leave open all portals of mercy and all avenues of inclusion. The transformation that the Prophet ushered by embracing those who were otherwise apparently not eligible for the same initiated one of the greatest revolutions in human history. A historian has described the companions of

the Prophet as "nursery of heroes", but when one looks at their pre-Islamic career, they appear to be no more than ordinary tribesmen, at perpetual war with one another. Thus Islam is an alchemy of transformation, transforming the baser humans into paragons of humanity. It is not intelligible to Islam to preclassify people into pious and wicked and prefer former over latter in an attempt of social Reformation and moral upliftment. It is an eyeopener to those religious men of our times who behave otherwise and in so doing tamper the spirit and essence of religion and scripture.

The last century has seen the sprouting of various religious movements in Islam emphasising inclusion and participation of one and all in the marathon of salvation. In the wake of these movements, the Mosques turned more inclusive, participatory and liberating, extending themselves to socially marginalised, religiously oppressed and underprivileged. In this way, the Mosques to some extent restored their social functionalism and cultural dynamism. But a crass misgiving characterising these movements was that like their predecessors, they paid little or no attention to gender inclusion and left out of the religious sentiments and issues of half of the population unaddressed. The fact was glossed over and forgotten that Islam rose to the occasion as an emancipatory and inclusive movement, including within the horizons of its messages all diversities of Cast, Creed, Gender, Geography and Ethnicity. But the passage of time blinded Muslims to these brighter of their religion and Muslim obsession with issues of little importance blinded them to the compassionate and ever embracing aspects of religion.

Worrying C-Section

propos the news report ti-tled "I Feel Like Crying: C-Section Making Life Painful for Kashmiri Mothers" published by this newspaper on 15 December 2020; the report highlighted a very serious issue that needs our urgent attention. Last year, National Family Health Survey - 5 (2019-20) fact sheet was released for Jammu and Kashmir which contains some perturbing data on the increasing rate of C-Section deliveries in the UT. A total of 41.7% of deliveries are done through C-Section in both Private and Public Health facilities. Public health facilities carry out 42.7% deliveries through C-section while for private health facilities it is 82.1%, which is almost double that of public health facilities. This is up from NHFS-4 (2015-16) when 33% of total deliveries were done through C-Section-- 35.5% for public health facilities while 75.5% for private facilities.

Private clinics seem to put almost every mother under the surgical knife. This is at least true for the urban areas of I and K where C-Section delivery rate is 91% in private health facilities. Normal deliveries here are an exception. World Health Organization guidelines insist to limit the rate of "C-Section" deliveries between 10-15% in any region but we

there is no evidence that mortality rates improve." The guidelines further advise that C-Section should only be performed if either the baby's or mother's life is in mortal peril because C-Section surgeries have some serious short and longterm consequences that affect both the child and the mother as the news report cited above mentioned some problems that the mothers in Kashmir face after going through the surgery.

have normal deliveries being limited to this rate. According to WHO statistics "when caesarean section rates rise towards 10% across a population, the number of maternal and newborn deaths decreases" but "when the rate goes above 10%, there is no evidence that mortality rates improve." The guidelines further advise that C-Section should only be performed if either the baby's or mother's life is in mortal peril because C-Section surgeries have some serious short and long-term consequences that affect both the child and the mother as the news report cited above mentioned some problems that the mothers in Kashmir face after going through the surgery.

The news report published in this newspaper states that women opt voluntarily for C-Section deliveries out of fear of labour pain. Even the gynaecologist cited in the report is blaming women for Googling the complications associated with natural birth and then opting for the C-Section surgery to avoid those complications. Even if this is true, it is surprising that the women should not have known about the postpartum short and long-term complications that they and their babies will have to go through after the delivery It also raises serious doubts about the consent that the hospitals take from such patients before the surgery. As far as informed consent is concerned. the patients should have been informed about these complications. If the mothers had been informed about the whole list of side effects that the C-Section surgery brings with it, they might have preferred

the labour pain over the habitual backache, the hair fall and weakening of uterus. These mothers would not have been complaining about all this if informed consent had been obtained from them. Even though there is a vast network of ASHA workers that are responsible to provide medical assistance to pregnant women but given the data of C-Section deliveries they do not seem to assist the expecting mothers in picking up a procedure for their delivery based on informed choice. ASHA workers along with doctors should be made responsible to tackle this concern. ASHA workers should especially be mandated to overlook C-Section surgeries in private hospitals where the doctors seem to encourage C-Section deliveries for financial gains as the Doctors Association Kashmir had alleged in April 2017 when it had come all out against the rising number of C-Section deliveries in Kashmir. It is not about trivializing the labour pain or prohibiting the people from choosing their preferred procedure for the delivery, but the concern is that they should be allowed to choose the option only after informing them about the benefits and drawbacks of various procedures that are available.

The Mind-Heart-Body Connection

OVID-19 pandemic has created devastations across globe by claiming millions of lives and infecting millions over the world. The current pandemic has a devastating impact in terms of case numbers and deaths, and thus the pandemic is regarded as the greatest challenge the world has faced since World War II. However, heart disease still remains to be one of the leading causes of morbidity and mortality worldwide as well as in India, particularly in the former state of Jammu & Kashmir. Accord-

of a person can have an impact on the other two. Systemic body factors and illnesses, such as diabetes, hypertension, and hyperlipidemia, are widely known to have negative effects on the heart and the broader circulatory system. The development of CVD, such as myocardial infarction (MI), heart failure, stroke, or the requirement for coronary revascularization, can also lead to a decline in psychological wellbeing. Although stress-induced cardiomyopathy, is the most obvious example of how a psychological state can adversely and immediately affect the heart, a growing body of evidence suggests that a broader, long-

Hostility and anger might elicit an unfavourable fight or flight response as body might feel threatened. One study found that inducing angry rumination in individuals was associated with increases in cardiovascular reactivity as measured by heart rate, diastolic blood pressure, and systolic blood pressure. Anger may also acutely increase the risk of adverse cardiovascular events, including MI/acute coronary syndrome, stroke, and ventricular arrhythmia, in the 2 hours after an outburst of anger. Research has also found that long-term exposure to personality traits of hostility and anger characteristic of Type A personality can result in the development

have a single universal definition. Positive psychological health, entails the existence of positive psychological elements such as happiness, optimism, gratitude, a feeling of purpose, life satisfaction, eudaimonic (virtuous) wellbeing, and mindfulness. Positive psychological health entails

more than just the absence of negative psychological elements like despair, anxiety, and pessimism, and the absence of psychological pain does not always imply that people are actively experiencing psychological well-being.

Optimism

Optimism is defined by a sense of hopefulness and confidence that things will turn out well in the future, as well as anticipating the greatest potential outcomes. Several studies have revealed that optimism is connected with healthier behaviours such as increased physical activity, avoiding smoking, a healthy food choice, improved sleep quality, and higher cardiovascular health status. An optimistic view of life has been linked to healthy ageing and a lower risk of CVD, including stroke and heart failure. According to one study, women with higher optimism levels had slower progression of atherosclerosis in their carotid arteries.

A recent study including 220 391 participants discovered that higher levels of optimism were related with a 35% lower risk of incident CVD events. More optimistic individuals had a 10% longer life expectancy and a higher possibility of surviving to 85 years of age.

Optimism has also been associated to better cardiovascular outcomes in people who already have CVD. Higher optimism was related with a lower incidence of hospital cardiac readmissions in the GRACE research (Gratitude Research in Acute Coronary Events), which measured optimism in 164 patients with Acute Coronary Syndrome (ACS) and then tracked

these individuals for 6 months. **Sense of purpose**

A sense of purpose can be defined in a variety of ways, but it is commonly thought of as finding meaning in one's daily life and being inspired and guided by one's values and life objectives. Adults with a greater sense of purpose, like optimistic adults, have more favorable lifestyle and cardiovascular risk factors, such as less smoking, more physical exercise, less alcohol and substance misuse, and better glucose control. A stronger sense of purpose in life has been linked to improved cardiovascular health, longevity, and a lower risk of CVD, including a lower risk of MI and stroke. A study involving over 130 000 people discovered that having a greater sense of purpose in life was related with

a 17% lower risk of both CVD events **Positive Affect and Happiness**

Happiness is a type of positive affect that is defined by a sense of well-being and contentment. People that are happy tend to sleep better, exercise more, eat better, and do not smoke. Individuals who were evaluated as having a stronger positive affect by trained observers had a 22% decreased incidence of incident CHD in one study. Other research has discovered that positive affect prevents disease progression in the context of diabetes and other cardiometabolic disorders.

Gratitude is the trait of being thankful for and appreciative of persons and situations in one's life. Small clinical trials examining a gratitude intervention (for example, gratitude journaling) found improvements in blood pressure, sleep, inflammatory biomarkers, and heart rate variability, thus

What are the ways to have sound mental health in order to have healthy heart? We can have the following interventions that might help us to improve both our mental health as well as cardiovascular outcomes.

resulting in better heart health.

Psychotherapy

Gratitude:

Several trials have employed psychotherapy to treat depression in people with heart disease. The ENRICHD (Enhancing Recovery in Coronary Heart Disease) experiment, the largest intervention trial for depression in heart disease patients, investigated the effects of cognitive behavioural therapy (CBT) after MI. When compared to the control condition, CBT alleviated depression. Cognitive behavioural treatment was also related with significant improvements in depression and other mental health outcomes in patients with heart failure who had serious depression. When compared to standard care, cognitive behavioural therapy was also related with lower possibilities of hospitalisation after one year.

Some research looked at psychotherapies aimed primarily at lowering anxiety and stress. Three such studies investigated the efficacy of psychotherapy to alleviate stress and increase health in heart disease patients. One such experiment looked at individuals who had been hospitalised in the previous 12 months for MI, percutaneous coronary intervention, or coronary artery bypass graft surgery. They were enrolled for a group-based cognitive behavioural therapy programme for a year, and it was found that CBT intervention had reduced probability of fatal and nonfatal first recurrence of cardiovascular events by 41%. Another trial of a group-based psychosocial intervention programme focusing on relaxation training and coping skills found that the intervention group had lower mortality.

Mindfulness-Based Interventions and Meditation Training

Meditation has been shown in certain studies to reduce various forms of psychological and psychosocial distress such as perceived stress, anxiety, and negative affect; boost smoking cessation rates; and modestly lower systolic and diastolic blood pressures. A recent comprehensive analysis of 16 research studies indicated that mindfulness-based therapies improved negative psychological outcomes (e.g., decreased anxiety, sadness, and stress) and reduced systolic blood pressure. A study of meditation interventions in patients with heart failure discovered significant improvements in depression and symptom management. A 2019 study on effects of meditation trials in CVD patients demonstrated significant benefits in anxiety, perceived stress, depression, and systolic blood pressure with mindfulness-based therapies.

In conclusion, current findings of studies on psychological health and CVD can be summarised as follows:

- 1. CVD should not be seen as a separate entity, but rather as one component of a larger system in which the mind, heart, and body are all interconnected. Both positive and negative psychological status appears to have a direct impact on cardiovascular health and prognosis.
- 2. For individuals with or at risk of CVD, psychological health is an important component of wellness/
- There is a substantial body of high-quality data showing clear associations between psychological health and CVD and risk.
- 4. There is growing evidence that psychological health may be causally linked to behaviours that contribute to CVD and risk.

5. The overwhelming body of evidence suggests that psychotherapies to improve psychological health such as cognitive behavioral therapy (CBT) can have a positive influence on cardiovascular health. Simple screening tools for patients with or at risk of CVD should be utilised by health care practitioners to assess psychological health status and if any psychological disorder such as depression or anxiety or any psychosocial issue is found to be the predisposing, precipitating or perpetuating factor for cardiovascular events, such patients should be referred to a mental health professional such as a clinical psychologist to work on psychological issues.

ing to a study conducted by the Global Health Research Institute, 29.6 percent of deaths in J&K are attributable to heartrelated diseases. According to the survey, 25 percent of deaths occur between the ages of 25 and 69. 32.8 percent of these deaths occur in cities, whereas 22.9 percent occur in rural regions.

Traditional cardiovascular risk factors, such as smoking, high blood pressure, high cholesterol, and diabetes, do not fully account for or explain the population's disproportionate and increasing burden of CVD. Most of the times, medical professionals concentrate their whole efforts on the patient's cardiovascular disease rather than the patient's psychosocial state as a predisposing factor, triggering factor or even as a maintaining factor in the their bad heart condition. Psychological health and how it affects physical health and disease have received less attention. In cardiovascular medicine, there has been an understandable focus on using pharmaceutical and device-based therapy to address specific heart problems. However, there is now a growing recognition that psychological health can contribute not only in a negative way to cardiovascular disease (CVD), but also in a positive way to improved cardiovascular health and lower cardiovascular risk.

To describe and capture an overall state of health, a variety of phrases have been used from time to time. The term wellbeing is one among them. The term "well-being" refers to how people value various aspects of their lives, such as their physical and mental health, their financial situation, their social supports and sense of community, their opportunities for growth and ability to achieve their goals, and a general sense of purpose and satisfaction with their life course. We must remember that a patient is more than one or more physical disease states: he or she is a human being who does not have only physical aspects but also psychological aspects of being human. Hence, we must work to reduce negative aspects of psychological health while promoting a positive and healthy overall state of being.

The mind, heart, and body are all interconnected and dependent on one another. Factors, situations, and disease states (both physical and psychological) that affect one of these three aspects term relationship exists in which a person's psychological health (mind) can positively or negatively affect cardiovascular health, cardiovascular risk factors, CVD event risk, and prognosis of various cardiovascular diseases. This interconnected pattern of relationship between heart, body, and mind can be called the

mind-heart-body connection. IMPACT OF NEGATIVE PSYCHOLOGI-CAL WELLBEING ON HEART HEALTH

According to well established research, negative psychological factors, personality traits, and mental health disorders can all have a negative impact on cardio-

Social Stressors and Chronic Stress

Life events that are stressful daily stressors, and high levels of perceived stress have all been found to have an impact on heart health. Psychological stress can be caused by a variety of factors, including work-related problems, poor-quality or insufficient relationships, financial hardships, and discrimination. Aside from these forms of stressful events, persons may be subjected to traumatic stress if they experience or witness events with a threat to their sense of safety and security. According to research, both cumulative exposure to regular stressors on daily basis and catastrophic stress can increase the risk of CVD. Workrelated stress was found to be associated with a 40% increased risk of incident CVD in a study published in 2011. Social isolation and loneliness, both major sources of stress, have also been related to an increased risk of CVD, with some studies showing a 50% increased risk of incident CVD events. Childhood stressors can have far-reaching consequences on cardiovascular health. Childhood maltreatment. social isolation, and socioeconomic hardship have all been related to increased inflammation and metabolic risk factors later in life. Posttraumatic stress disorder (PTSD) is another mental health condition that develops after experiencing a potentially traumatic life experience and is characterized by significant psychological discomfort. Two studies of relationship between PTSD and CVD have been published, the most recent one in 2018 151 144 individuals. In these studies, PTSD was found to be connected with a 61% increased risk of Coronary Heart Disease.

Hostility and anger

of Coronary Vascular Disease prematurely. **Anxiety**

Anxiety is defined by the American Psychological Association as "an emotion marked by feelings of tension, worried thoughts, and physical changes such as elevated blood pressure," implying the possibility of a relationship between anxiety and CVD risk. Anxiety can occur as a temporary mood or as a general tendency (i.e., trait-like), or it can be a symptom of a clinical disorder such as generalised anxiety disorder (GAD) when experienced frequently or repeatedly at high intensity and in inappropriate contexts. Anxiety may be a risk factor for hypertension, excess adiposity, and smoking, all of which can inherosclerosis Several studies on the relationship between anxiety and CVD have found that anxiety was related with an increased risk of CVD mortality.

Depression Numerous studies have indicated that those who suffer from depression are more likely to develop and die from CVD. Several studies done on association between depression and CVD have been published, including one from 2014 that included 893 850 participants from North America, Western Europe, and Asia. Depression was linked to an elevated risk of Myocardial Infarction and incident CHD in this study. Based on these findings, the American Heart Association released a scientific statement in 2014 proposing that depression be considered a risk factor for recurrent cardiovascular events. The increased CVD risk seen in patients with depression may be driven partially by elevations in traditional cardiovascular risk factors such as obesity because depression can lead to sedentary life style which may increase the possibility of obesity and obesity in turn may lead to increased risk of CVD.

Pessimism

Pessimism is defined by a tendency to expect negative outcomes or to consistently explain events in a negative manner. A pessimistic explanatory style has also been associated with a sense of hopelessness. These factors have been related to an increased risk of cardiovascular disease. Strife, Stress,

Even before she could sense a storm that was about to be unleashed, her husband declared: "I've married someone else!"

Behind the pomp and show with which people are performing weddings in Kashmir, an elephant in the room is devouring the same sacred institutions in the name of infertility.

The doctors are aghast over the various reasons of the growing crisis raised by the new boogeyman and some have also pointed fingers at the lifestyle changes but, above all, the cases and statistics reveal a different cinema of the augmenting crisis in the valley.

As per the data available in the latest yearly Census of India report—which many refer to as "canary in the coal mine"—the total fertility rate in Jammu & Kashmir has collapsed from an all-time high of 2.400 in 2005 to a record low of 1.600 in 2018, raising the strong apprehensions of an existential crisis for the Kashmir lineage.

The infertility rate has soared in Kashmir, especially over the past two decades where it was first recorded at 12 per cent, and has now gone up to 18 per cent.

I called Dr. Bilquees Jameel, one of the leading gynaecologists of Kashmir who has an experience of more than five decades, to ask if there was any good news hiding behind those brutal numbers.

Is Kashmir's lineage really at risk of extinction? She failed to comfort me.

"The what does it mean question means extrapolating beyond your data," Dr. Bilquees told me, "which is always a tricky thing. But you can ask, what does it take when a lineage is in danger? When is our existence threatened? And we are definitely heading towards that path."

That path in its darkest leads to no more naturally conceived babies and potentially to no

babies at all, the matron medic said. "And maybe," she added, "the final generation of Kashmir will roam the valley knowing they will be the last of their tribe. There is a clear and present alarm now."

Out of every 10 cases that Dr. Bilquees receives, five are related to infertility with the higher side depicting female infertility. This is because, she explained, numerous women are suffering from polycystic ovarian syndrome (PCOS), anovulation, endometriosis and

"If we are half as fertile as the generation before us, why haven't we noticed? One answer is that there's a lot of redundancy built into reproduction: You don't need 200 million sperm to fertilize an egg, but that's how many Kashmiri men might devote to the job. Most Kashmiri men can still conceive a child naturally with a depressed sperm count, and those who can't have a booming fertility-treatment industry ready to help them," the noted gynaecologist

"And though lower sperm counts probably have led to a small decrease in the number of children being conceived, that decline has been masked by sociological changes driving birth rates down even faster. Our people in this concurrently developed Kashmir are choosing to have fewer children, and they are having them later. The obscure crisis is an astonishing and terrifying claim that, were it to be true, would justify the apocalyptic tenor of some of the false claims.'

Apparently, this "apocalyptic tenor" that Kashmiris have been ignoring for the past one decade has silently swept its roots into the families and distraught the relations within the blink of an eve

One pacific floor of the Lal-Ded hospital in Srinagar houses the Assisted Reproductive Centre. The unit is populated not with doctors and researchers hunched over mass spectrometers and gel imagers and the like, but with new parents. I was there to talk to one of the leading

gynaecologists in Kashmir. After talking me through the crisis, she mentioned the growing infertility among males and females, and reproductive health. "The fertility in Kashmir is in full-blown crisis," she began on an alarming note.

"Here in Kashmir, there's an epidemic of infertility. Out of 100 male infertility cases, 25 cannot father children, even In-Vitro Fertilization (IVF) [where the egg is fertilised outside the womb] treatment won't help."

In an attempt to understand more about the infertility in Kashmir through documented data, I approached the Medical Superintendent of Lal Ded hospital, Shabir Siddique, but five minutes down in the conversation suggested that even the doctors are less cautious about embracing any proper explanation on the crisis than expected

"There's no data on infertility available," his reply created a sense of shock in the room. "But, one thing is quite sure, infertility is a new destructive force in Kashmir."

Perhaps, the same destructive force had played a dominant part in a quadragenarian's life who had come to a clinic to collect her latest "Fertility" test report.

As a wooden door opened into an archaic clinic, a young woman whispering some prayers stepped in. She walked towards the centre-placed reception inside the wooden grilled square. In that sad beige waiting room there were no normal persons but only the deflated faces. She stopped her stride, took a good luck of the sad settings around and started

praying relentlessly as if the world would have ceased to exist if her lips would've stopped uttering those prayers.

Her face had a stark resemblance with the weathered appearance of that clinic. Her voice was trembling like well-water in a goatskin bucket and her eyes had been apparently pushed into the desolation of an unlit lamp. Among the gallery of test reports lying near the foot of that wooden reception, one thin sheet embraced her name. "Do I've something to cherish upon?" the young woman tremblingly asked the receptionists. "Yes!" pat came the

Clad in a cream Shalwar-Kameez, she looked like any other frown face but the moment she received her wished reply, a shriek of cry broke the barriers of her parched lips. She was no longer a doomed mother waiting to birth a child.

"It's been more than six years since my husband and I tried to conceive a baby but to our shock, I was found infertile to conceive," Ruksana Zargar, the woman in the clinic, said with a dejected tone. "Since then, we've tried almost every doctor's cure but nothing worked."

Almost half a decade back, Ruksana was diagnosed with PCOS—a condition where a woman skips ovulation known as anovulation leading to infertility—and obesity, but she totally sidelined the urgency to get married as had been recommended by a doctor, when the extremely painful periods and continuous breast dis-

charge had become a new monthly compulsion. But, at 35, she was married to Javaid who was five years younger than her, and thus began their struggle to conceive a child.

"Javaid has accepted the fact that we'll always remain a childless couple but I cannot," said Ruksana. "I always wanted to have a child and my last resort was IVF treatment. So, perhaps, Javaid was wrong... We're no longer the childless couple!"

The late marriage menace that doctors believe is a major reason for growing infertility issues in the region, has become extremely common in Kashmir and perhaps adding a considerable share of trouble in the making of the

"Late marriage is the biggest contributor to the infertility crisis in Kashmir," Dr. Bilquees Jameela continued, a bit defensively.

Bilquees, who had been so gracious and engaged with managing the crisis at her clinic, began to sound a little tired. She rallied that families even after knowing about their daughter's PCOS problem, still sideline the urgency of her early marriage and then blame her for failing to conceive a child.

"Kashmiris acknowledge that male reproductive health is essential for the survival of the species, but at the same time, the taboo regarding female reproductive health should end. given the alarming rise of fertility decline," the veteran doctor said.

Many of these are attributable in part to the conflict, which as per Dr. Bilquees acts as a silent killer.

"Undoubtedly," she said, "conflict creates an impact on the reproductive health of women. In fact, the data has shown that the impact of conflict in any given region is mostly on women because they are more concerned about the safety of their families."

Perhaps, similar kinds of apprehensions were found to be factual, when in 2015 National Family Health Survey showed around 61 per cent of married women in Kashmir reporting one or more reproductive health problems – remarkably higher than the national average which stood at 39 per cent.

The study further suggested that 73 per cent of Kashmiri women tend to have reported one reproductive health problem.

When I caught up with Dr.Bilquees later, she wasn't nearly as dismissive as she had sounded earlier. She agreed that there was a big question that infertility was rising but even embraced some of the direst predictions of doctors on IVF treatment.

"The IVF treatment may be one of the only cures available against this problem," she told me, "but that isn't a full-time cure for infertility. Globally, its success rate stands at around 40 per cent and when we talk about a region like Kashmir, one can only imagine the meager success rate of IVF treatment here."

When even the skeptics are scared, it's probably time to pay attention to a natural way of conceiving—early marriages, PCOS awareness and reproductive inbound healthy lifestylerather than waiting for late marriages to destroy everything, the doctor suggested.

However, the fact that Dr. Bilquees didn't mention was how Kashmir's barren couples who've surfaced almost every nook and corner of the valley in a bid to be able to cherish the sentimental journey of conceiving a child, have

apparently found a new door to knock on. In the bustling urban pocket of Srinagar, Majid and Nida are among the dozens of other couples sitting on the perch of a godman's

The young couple endearingly looks at the wall of delighted faces of those holding them inside that five decade old monument in Saida Kadal area of the city. The waiting space in the holy man's dwelling gradually fills in with apparently tired strangers connected by their physiological conditions, befriending each other and within no time, a bond of friendship is

The tranquil space that is bustling with hope and expectations for a joyous future is conspicuously avoided by a visibly older couple. Majid and Nida have been sitting secluded with an air of a steady resolve around them, evidently, both softened with hope and prospect of their wish being granted.

After seventeen years of childless marriage with one failed IVF attempt, the couple had travelled about fifteen kilometres to meet the godman, whose 'dast-e-shifa' (prayers)—as per the word of mouth-had apparently helped several infertile cases.

When the couple's turn came, the godman's buoyant words paved a way towards a cheerful future. "So, what if science has failed," he defensively told the couple. "Almighty won't let you down! He's ghafoor ur raheem!

Hearing these words, Nida could no longer control her emotions and broke into tears. For her, it felt as if the man sitting in front of her knew exactly what was going wrong.

"Medical science is there to help us but what if that too fails," the goodman who called himself Sajad Sa'eb, comforted the crowd. "When everything fails, then the only support we have is our creator."

Couples need to be psychologically, physically as well as emotionally patient, godman Sajad with a sound academic background would tell

me.
"Once they get psychologically and emotionally affected, they may go into a prolonged phase of anovulation, which can lead to infertility," he said.

its retail price by Rs 1.25 paise per litre in Delhi. Diesel prices were raised on Friday by 20 paise per litre and again 25 paise per litre each on Sunday, Monday and Tuesday

Petrol prices had maintained stability since September 5 but oil companies finally raised its pump prices this week given a spurt in the product prices lately.

The OMCs had preferred to maintain wait and watch policy on global oil situation before making any revision in prices. This is the reason why petrol prices were not revised for the last three weeks. But extreme volatility in global oil price movement has now pushed OMCs to effect the increase.

The wait and watch plan of OMCs had come to the relief of consumers earlier as no revision came during a period when crude prices were on the rise over shortfall in US production and inventories and a pick up in demand. This would have necessitated an increase of Rs 1 in price of petrol and diesel.

In Mumbai, the petrol price increased by 21 paise per litre to Rs 107.73 per litre while diesel rates increased to about Rs 97.50 a litre.

Across the country as well petrol and diesel prices increased between 20-30 paisa per litre but their retail rates varied depending on the level of local taxes in the state.

Fuel prices in the country have been hovering

performed by the BSF troops on the LoC as at record levels on account of 41 increases in its retail rates since April this year. It fell on few occasions but largely remained stable.

After rising over three year high level of \$80 a barrel earlier this week, global benchmark has now come down to \$78 a barrel. Oil rates are up two per cent for the week and this is the fifth weekly gain. Since September 5, when both petrol and diesel prices were revised, the price of petrol and diesel in the international market is higher by around \$6-7 per barrel as compared to average prices during August.

Under the pricing formula adopted by oil companies, rates of petrol and diesel are to be reviewed and revised by them on a daily basis. The new prices become effective from morning

The daily review and revision of prices is based on the average price of benchmark fuel in the international market in the preceding 15-

days, and foreign exchange rates. But, the fluctuations in global oil prices have prevented OMCs to follow this formula in totality and revisions are now being made with longer gaps. This has also prevented companies from increasing fuel prices whenever there is a mismatch between globally arrived price and pump price of fuel.

CB Charges Man

During the course of investigation, the CBK said, it came to fore that the cell number was being used by Firdous Ahmad to contact Superintending Engineer PMGSY Srinagar, Executive Engineer R&B Division Kupwara, Tehsildar Uri and Chief Education Officer Ganderbal respectively. "He introduced himself as MoS for R&B and Revenue department, and stated to them that they might be transferred unless they pay money to him," it said, adding, "The investigation thus conducted has established that the accused Firdous Ahmad has used the cell number by using a spoof call application, which displayed the cell number of concerned ministers on the cell phone of the receiver of such calls/SMS's, and impersonated himself as Minister of concerned departments in order to cheat them and extract money from them against their transfer or post them as per their choice.'

During the course of investigation, offences U/S 511-420, 419, 468, 201 RPC, 66-D IT Act were established and the Final Report (charge sheet) of the instant case was produced before the court of 13th Finance, Srinagar on September 29.

Beijing 2022 Winter Olympics Will Not Allow Foreign Spectators: IOC

BEIJING: A 21-day quarantine for nonfully vaccinated athletes, officials and workers will be in force at the 2022 Beijing Olympics, the IOC said.

Daily testing for vaccinated people and no tickets will be sold to anyone living outside China as Olympic venues open their doors again.

Restrictions imposed to control the COVID-19 pandemic at the next Winter Games in February were announced on Wednesday by the International Olympic Committee. While not imposing a vaccine mandate, organizers in Beijing plan stricter rules than applied at the Tokyo Olympics where vaccination was advised though not demanded within a strict regime of testing.

"Games participants who are not fully vaccinated will have to serve a 21day quarantine upon arrival in Beijing," the IOC said in a statement.

Olympic athletes can ask to avoid quarantine, the IOC said, for a "justified medical exemption" – a phrase that appeared to exclude ideological objections to vaccines. It will be the second straight Olympics during the pandemic where families of athletes cannot visit the host country to watch the events.

Qatar To Host F1 Race For First Time In November

DOHA: Qatar will host a Formula One race for the first time in November and for 10 years from 2023.

Oatar takes the remaining slot left vacant on this year's reshuffled calendar. The race will start under floodlights at 6 p.m. local time on Nov. 21 at the Losail International Circuit.

As the 20th of 22 races this season, it will be followed by the inaugural Saudi Arabian GP in Jeddah on Dec. 5 and the season-ending Abu Dhabi GP on Dec. 12.

"There was a strong will from Qatar to be helpful to F1, and in the course of this process, the vision for a longer partnership was discussed and agreed," F1 said in a statement on Thursday.

"The vision for F1 to be the showcase for Qatar after the (soccer) World Cup in 2022 was the driving force." There will not be a race in Qatar next year because of the World Cup so the 10-year deal starts the following year.

The 5.4-kilometer (3.4-mile) circuit, which holds 8,000 fans, is north of Doha and has hosted the MotoGP series since 2004. It is not yet clear whether Losail will continue to host F1 from 2023. as the circuit will need to be altered, so there is a strong possibility another location could be chosen. F1 said only that it was in discussions. The cancellation of the Japanese GP set for Oct. 10 amid t he government's coronavirus concerns triggered off changes.

More Than 10 Boxing Bouts Manipulated For Money In 2016 Olympics

NEW DELHI: More than 10 bouts in the 2016 Rio Olympics boxing competition were manipulated for "money" and other "perceived benefits", an independent investigation has revealed, prompting the International Boxing Association (AIBA) to promise a "tough" selection process for referees and judges at the upcoming men's world championship.

The first phase report of the McLaren Global Sport Solutions' independent investigation into boxing, which was accessed by PTI, has been handed to AIBA and revealed that "a system for the manipulation of bouts by officials existed at Rio". In all, 14 bouts came under the scanner, including two finals.

The damning findings of the investigation stated that conspiracy to manipulate Rio results dated back as far back as before the London Olympics of 2012 and that a trial run was carried out during the qualifying events for the 2016 edition.

"Bouts were manipulated for money, perceived benefit of AIBA, or to thank National Federations and their Olympic committees, and, on occasion, hosts of competitions for their financial support and political backing," it stated.

'The investigation to date has concluded that such manipulation involved significant six figure sums on occasion. The manipulation methodology relied upon corruption within the cadre of corrupted R&Js (referees and judges) and the Draw

Commission," it added. The AIBA promised a thorough clean-up and more stringent mechanism to appoint referees and judges.

Congress Leaders Slam 'Hooliganism' Outside Sibal's House



NEW DELHI: Senior Congress leaders Ghulam Nabi Azad and Anand Sharma, along with some of their G-23 colleagues, on Thursday strongly condemned and termed as "orchestrated hooliganism" the Congress workers' protest outside Kapil Sibal's house after he raised questions over the party's functioning, with Sharma asking AICC chief Sonia Gandhi to take strong action against those involved.

Former Punjab Chief Minister Amarinder Singh also criticised what he said was an "attack" at the house of Sibal by the Congress workers only because he "chose to express views that were not palatable to the party leadership".

This does not augur well for the party, Singh was quoted as saying by his media adviser Raveen Thukral.

Azad, former leader of Opposition in Rajya Sabha, also strongly condemned the "orchestrated hooliganism" at Sibal's residence.

"He (Sibal) is a loyal Congressman fighting for the party both inside and outside Parliament. Any suggestion from any quarter should be welcomed instead of suppressing, hooligan-ism is unacceptable," tweeted Azad, who along with Sibal is part of the 'Group of 23' which last year had written to Gandhi seeking organisational overhaul of the party.

Asserting that differences of opinion and perception are integral to a democracy, Sharma, also a part of the G-23, said intolerance and violence is alien to Congress values and culture.

"Shocked and disgusted to hear the news of attack and hooliganism at Kapil Sibal's house. This deplorable action brings disrepute to the party and needs to be strongly condemned," Sharma said in a series of tweets. He asserted that the Congress

has a history of upholding freedom of expression.

Those responsible must be identified and disciplined, Sharma said

"Urging Congress president Sonia Gandhi to take cognisance and strong action," he said in a tweet.

Taking to Twitter, Congress MP from Punjab, Manish Tewari, unequivocally condemned what he said was "orchestrated hooligan-

ism" at Sibal's residence last night. "Those who masterminded the assault must bear in mind that he fights for @INCIndia both

inside and outside courts of law. You may find his views uncomfortable but that can not be a license for violence," Tewari, who was among the 23 leaders who wrote to Gandhi for an overhaul of the party, said.

In another tweet, he said, 'Those who are trying to defend the 'command performance' last night. This is what happened @ KapilSibal's house 'They damaged the car. Stood on top, so it caved in. Threw tomatoes both outside and inside the house'. If this is not hooliganism then what else is it".

Responding to Tewari's tweet, Tharoor, who was part of the leaders who wrote to Gandhi, tweeted, "That is shameful. We all know @ KapilSibal as a true Congressman who has fought multiple cases in court for @INCIndia."

"As a democratic party we need to listen to what he has to say, disagree if you must but not in this way. Our priority is to strengthen ourselves to take on

the BJP!" Tharoor said. Also responding to Tewari's tweet, Congress leader Vivek Tankha tweeted, "Never to a person who has fought and saved so many Cong governments and persons and unmake opposition government."

"People may disagree with him. Even protest. But not damage his car. At least in my life I never encouraged or promoted hooliganism," Tankha said.

Hours after he raised questions over the functioning of the Congress, Sibal on Wednesday came under attack from several quarters with party workers also protesting outside his house here.

In the wake of several Congress leaders quitting the party and its Punjab unit in turmoil, Šibal has demanded that an immediate meeting of the Congress Working Committee (CWC) be convened and wondered who in the party was taking decisions in the absence of a full-time president.

Sibal said at a press conference that the G-23 grouping is "not a Jee Huzur 23" and will continue to put forth the views and will continue to repeat the demands

Carrying 'Get Well Soon Kapil Sibal' placards and raising slogans against Sibal, Delhi Pradesh Congress Committee (DPCC) workers had protested outside his Jor Bagh residence, saying they were "hurt" by his remarks.

Border Incidents With China Will Continue Till Boundary Pact Is Reached: Army Chief

NEW DELHI: Border incidents between India and China will continue to occur till a boundary agreement is reached between the two countries, Army Chief General M M Naravane said on Thursday.

Recent developments in Afghanistan "have definitely been the focus" of the Indian Army that continues to evaluate threat perceptions and formulate strategies accordingly, the Army chief added while addressing a gathering at the PHD Chamber of Commerce and Industry.

Discussing China, he said, ". we have an outstanding border issue. We are again well prepared to meet any misadventure that may occur as we have demonstrated in the past."

"Such kinds of incidents will continue to occur till such time that a long-term solution is reached, and that is to have a boundary agreement. And that should be the thrust of our efforts so that we have lasting peace along the northern (China) border," he stated during the annual session meeting of the industry body.

Referring to Afghanistan, he said the Indian Army "or the armed forces for that matter continue to carry out periodic evaluation of threat perceptions".

Based on those evaluations, the Indian Army formulates strategies and doctrines that are needed to meet future threats, he noted. This is a continuous process

"We have a very dynamic counterinsurgency and counterterrorist grid in Jammu and Kashmir. It is a dynamic grid and it is based on threat perception and the escalating levels of attempts by our western neighbour (Pakistan) to push in more and more terrorists," he said.

Based on ups and downs, we also recalibrate our levels of operations, he added.

The current border standoff between the Indian and Chinese armies erupted in May last year following a violent clash in the Pangong lake area. Both sides grad-ually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

The row escalated after the Galwan Valley clashes on June 15 last year. Twenty Indian Army personnel laid down their lives in the clashes that marked the most serious military conflicts between the two sides in decades.

In February 2021, China officially acknowledged that five Chinese military officers and soldiers were killed in the clashes with the Indian Army though it is widely believed that the death toll was higher.

As a result of a series of military and diplomatic talks, the two sides completed the disengagement process in Gogra area last month.

In February, the two sides completed the withdrawal of troops and weapons from the north and south banks of the Pangong lake in line with an agreement on disengagement.

Each side currently has around 50,000 to 60,000 troops along the LAC (Line of Actual Control) in the sensitive sector.

In 2017, Indian and Chinese troops were engaged in a 73-day stand-off in Doklam tri-junction which even triggered fears of a war between the two nucleararmed neighbours.

The India-China border dispute covers the 3,488-km-long LAC. China claims Arunachal Pradesh as part of southern Tibet while

Not Joining BJP But Won't Stay In Congress: Capt Amarinder **After Meeting Amit Shah**

NEW DELHI: Scotching speculation, former Punjab Chief Minister Amarinder Singh on Thursday made it clear that he was not joining the Bharatiya Janata Party (BJP) but said he had no intention of continuing in the Congress, which he said was going downhill with senior leaders being completely ignored.

Singh said he would leave the Congress as he had been "utterly humiliated" and was not trusted.

I will resign will not stay in the Congress party, he said, adding that he was still thinking through his options in the interest of Punjab, whose security was the predominant priority

Singh had resigned as chief minister on September 18 after accusing the Congress of humili-

ating him. I will not be treated in this humiliating manner I will not take such insults, he said, adding that his principles and beliefs do not allow him to stay in

the Congress any longer. senior Terming the Congressmen as thinkers who were critical about the future of the party, the former chief minister said the younger leadership

should be promoted to implement the plans, which the senior leaders are best equipped to formulate.

"Unfortunately, the seniors were being completely sidelined," he said in a statement. Singh said this was not good

for the party. Slamming Navjot Singh Sidhu, Singh said he was a mere crowdpuller and does not know how to

carry the team along. Singh also condemned the attack on Kapil Sibal's house by Congress workers only because he had chosen to express views that were not palatable to the

party leadership. Expressing the hope that Punjab would vote for the future of the state, he said his experience showed that the people of the state tend to vote for a single party/force, irrespective of the

number of parties in the fray. Misgovernance in Punjab would give Pakistan an opportunity to create trouble in the state and in the country, he said, adding that his meeting with NSA Ajit Doval this morning centred

around this issue. Singh had raised security concerns with Home Minister Amit Shah too, along with the farmers' issue, during his meeting with the latter on Wednesday.
