## **Bindroo Pharmacy Owner Among 3 Civilians Shot Dead In Span Of 1 Hour**

**SRINAGAR:** A prominent Kashmiri Pandit pharmacist, a street vendor from Bihar and Hajin taxi union head were shot dead in three back to back attacks within an hour in this capital city and north Kashmir's Bandipora district, setting alarm bells ringing in the security establishment.

The first killing occurred around 7:20 pm Tuesday when suspected pistolborne militants entered Bindroo Healthzone, Iqbal Park here and fired multiple shots at the owner Makhan Lal Bindroo, leaving him collapsed behind his counter in a pool of blood, officials said.

## 'This Is An Insult': A Missing Name Creates Political Anguish In Ladakh

wo years after hailing the Government of India's move to abrogate the Article 370 in Parliament, Jamyang Tsering Namgyal raised the concern over "the growing political anguish" in Ladakh.

The Member of Parliament from Ladakh lost his cool after spotting the missing name of his **Executive Councillor for Minority** Affairs, Ladakh Autonomous Hill Development Council (LAHDC),Leh, Ghulam Mehdi, on the plaque of a road inauguration on October 1.

Mehdi represents the BJP in LAHDC fromTartuk area.

The young lawmaker had arrived along with Lieutenant Governor of Ladakh, RK Mathur; Chief Executive Councillor(Leh), Tashi Gyalson; Defence Secretary, Ajay Kumar and Director General Border Roads,



Lt Gen Rajeev Chaudhry, to carry out the sod-turning ceremony for the construction of Hanuthang-Handanbroke-Zungpal-Turtuk road, which will reduce the 395 km

Leh-Turtuk journey to 61 km. "This is an insult," Namgayal

lashed out at the authorities. "The culprit should be punished. How come the names of those per-

sons who don't represent this area are on the plaque, while those who represent this area were skipped?" Interestingly, this is the second time within a week when political names of the ruling party were found missing on the plagues.

Earlier on September 25, when Anurag Thakur, Information and Broadcasting Minister, inaugurated high power transmitters at one of the highest Radio Stations in the world at Humbatingla in Kargil, Feroz Ahmed Khan's name was reportedly missing on the plaque.

Notably, Khan, who's chief executive of LAHDC, Kargil, was accompanying Thakur throughout his Kargil visit.

"All the government agencies including CID, IB and RAW present here must send this message to PM Modi and Home Minister that people are being insulted in Ladakh," Namgyal said.





## **J&K Team For Tibet To Find Truth Of 'Shahtoosh Threat'**

SRINAGAR- Chief Minister Farooq Abdullah today said the centre would be approached to seek China's permission for facilitating the visit of a team to Tibet to find if continuing shahtoosh trade threatens antelope.

Speaking at a function held in observance of the mil-lennium's first wildlife weak hare this afternoon, the chief minister said the team will comprise wildlife officials and representatives of shahtoosh traders whose trip would be sponsored by the government. "If the team feels threat to antelope as genuine, the shahtoosh traders will have nothing to do with it", he said, adding that with this the controversy

over the issue would end once for all. The chief minister said that as a result of measures taken to preserve wildlife, their population is on increase in the state. He stressed for creating awareness among the people especially students about the need for protecting wildlife and said that two zoos would be set up at Manda in Jammu and Dachigam in Srinagar for people to see nature's fauna. He asked for prepar-ing comprehensive plans for conservation of various sanctuaries like Hokersar, Hygam and Mirgund.

Abdullah called for evolving a mechanism and adopt-ing an integrated programme for making use of dead wood as fuel by those living near forest while stringent measures would be taken for preserving the green trees. Steps have to be taken for bridging the gap between ener-gy-need and energy source. This has become imperative in view of growing pressure of forest resource since other sources of energy like electricity and LPG have become costlier and scarce. He made .a fervent appeal to the people for making judicious use of electricity, generation of which is affected during winter due to lesser water flow.

## 'Taliban killed 13 members of Hazara ethnic group'

The Taliban killed at least 13 members of the Hazara ethnic group, including a 17-year-old girl, in the central province of Daykundi, shortly after they took power in Afghanistan, according to a new report from Amnesty International.

On August 30, a convoy of 300 Taliban fighters entered Khidr district and killed at least 11 former members of the Afghan National Security Forces (ANSF), nine of whom were taken to a nearby river basin where they were executed shortly after having surrendered, the rights group said in its report pub.

fighters in Ghazni province in July before the group captured power, Amnesty reported on August 19.

Both the Taliban and their rivals, the Islamic State Khorasan Province, ISKP (ISIS-K), an ISIL affiliate, have been accused of targeting the Hazara people, who make up the majority of Afghanistan's Shia population.

By September 1, the Taliban had denied the killings. Saidqullah Abed, the Taliban appointed police chief for Daykundi, would only confirm that one of their fighters had been injured in the crossfire.

A teenager, identified by the name of Masuma, was killed in crossfire after the Taliban targeted Afghan forces who were attempting to flee the area. Another civilian, Fayaz, a newly-wed in his 20s, was also among those killed in the crossfire.

The ANSF members who were killed ranged in age from 26 to 46, Amnesty said. All the victims were Hazara, who were persecuted during the Taliban's first stint in power between 1996 and 2001.

It is the second killing of Hazaras documented by Amnesty. At least nine Hazara men were killed by Taliban member of Parliament for the province, also verified Amnesty's report to Al Jazeera, saying the events of August 30 amounted to "inhumane mass killings" carried out by the Taliban.

She said what transpired in Khidr was in direct violation of the Taliban's claims of a nationwide general amnesty for former security forces and government workers.

"These cold-blooded executions are further proof that the Taliban are committing the same horrific abuses they were notorious for during their previous rule of Afghanistan," said Agnes Callamard, Amnesty International's secretary-general.

## No two-finger test on the female officer who alleged rape: IAF chief

New Delhi: Indian Air Force chief Air Chief Marshal V.R. Chaudhari on Tuesday said that no "two-finger test" was done on a female officer who had accused a colleague of rape.

Addressing the annual conference ahead of the IAF Day on October 8, he said: "No two-finger test was done. The information regarding the two-finger test is misreported. Air force law is very strict. Actual fact is this test was not done... disciplinary action will be taken based on report of inquiry."

The rape victim had alleged that she was subjected to the banned test and questioned about her sexual history in the rape case against a fellow colleague.

The woman officer had registered an FIR on September 20 in Tamil Nadu's Coimbatore alleging that she was raped by a Flight Lieutenant under the influence of alcohol on September 10. She alleged that she suffered an ankle injury on September 10, for which she had

taken a painkiller. Later that night, she had two drinks with a group of friends when the accused had served her one of the glasses. The woman officer claimed that even as she was in a subconscious state, she saw the accused enter the room and sexually assault her

She told the National Commission for Women that she was subjected to a twofinger test at the Air Force Hospital later.

In a press note, the NCW said it has taken cognisance of the woman Air Force officer being subjugated to the two-finger test, and "strongly condemned" the action of Indian Air Force doctors.

"The NCW expressed utter disappointment and strongly condemned the action of Indian Air Force doctors for violating the right to privacy and dignity of the victim," it said.

NCW Chairperson Rekha Sharma had also written to the IAF chief to look into the matter and "impart necessary knowledge to the Indian Air Force doctors".

# Fully Ready To Deal With "2-Front" War Scenario Against Pak, China: Air Force Chief

New Delhi: The Indian Air Force is committed to the theaterisation programme and the initiative needs to be taken forward considering various key aspects involving the three forces, Air Chief Marshal Vivek Ram Chaudhari said today.

Addressing a press conference ahead of Air Force Day on October 8, he said the Indian Air Force or IAF is fully prepared to deal with any security challenge in eastern Ladakh and that new infrastructure created by the Chinese side in the region will not affect India's combat readiness

The Chief of Air Staff said India is fully ready to deal with a "two-front" war scenario involving China and Pakistan and that the focus

has been to enhance the IAF's overall combat capabilities.

On the ambitious theaterisation programme, he said the Indian Air Force is fully committed to it but added that discussions are required before new structures are put in place.

"Various options are being discussed among three forces," the IAF chief said.

forces," the IAF chief said. The theatre commands are being planned to integrate capabilities of the three services and to ensure optimal utilisation of their resources.

He said the IAF's strike capability has become more potent with induction of Rafale jets and various weapons.

# Priyanka says detained beyond 24 hours without FIR, Cong leaders claim drones monitoring her

Sitapur/Lucknow: Why has the person behind the killing of four farmers in Lakhimpur Kheri not been arrested while she has been under detention for 28 hours without an FIR, Congress leader Priyanka Gandhi asked on Tuesday as her colleagues alleged that she was not being allowed to meet her lawyers.

Priyanka Gandhi and other Congress leaders have been in detention beyond 24 hours and a drone camera deployed over the 2nd Battalion PAC guesthouse in Sitapur where they have been kept, Congress office-bearers claimed.

"She is not being allowed to meet her lawyers and the administration is not telling her reasons for her detention," Congress media and communication vice chairperson Pankaj Srivastava said.

Besides Priyanka Gandhi, state Congress president Ajay Kumar Lallu, national secretary Dheeraj Gurjar, Youth Congress national president BV Srinivas, party MLC Deepak Singh are also under detention, he said.

The Congress general secretary was detained in Sitapur on Monday on her way to Lakhimpur Kheri, where eight people died and several others were injured on Sunday in the bloodiest clash since the farmers" protest over the Centre's agri laws began last year.

On Tuesday, she shared a video on Twitter purportedly showing a group of protesting farmers being mowed down by an SUV.

"The government is so scared of Priyanka Gandhi that even after keeping her under detention, it is using a drone to keep an eye on her," he tweeted in Hindi.

As several Congress leaders took to social media, party workers staged demonstrations till late Monday night and slept on the pavement outside the PAC battalion complex.

## **Nobel Physics Prize To Two Climate Experts, Italian Theorist**

Stockholm, Sweden: US-Japanese scientist Syukuro Manabe, Klaus Hasselmann of Germany and Giorgio Parisi of Italy on Tuesday won the Nobel Physics Prize for climate models and the understanding of physical systems, the jury said.


The Nobel committee said it was sending a message with its prize announcement just weeks before the COP26 climate summit in Glasgow, as the rate of global warming sets off alarm bells around the world.

"The world leaders that haven't got the message yet, I'm physics theory," said chair of the Nobel Committee for Physics, Thor Hans Hansson.

Manabe, 90, and Hasselmann, 89, share one half of the 10-million-kronor (\$1.1-million, one-million-euro) prize for their research on climate models, while Parisi, 73, won the other half for his work on the interplay of disorder and fluctuations in physical systems.

"Syukuro Manabe and Klaus Hasselmann laid the foundation of our knowledge of the Earth's climate and how humanity influences it," the Nobel Committee said.

## **Bombshell Book: Trump Staffers Wallowed in Gifts on 1st Saudi Trip**

Washington: In her new bombshell book, ex-White House Press Secretary Stephanie Grisham says former US officials may have violated federal law Arabia by illegally accepting and not declaring gifts from their hosts, when president Donald Trump paid a visit to Saudi Arabia in May 2017 on the first leg of his maiden foreign trip.

"The rooms were paid for by the Saudi government," Grisham wrote in her forthcoming memoir titled "I'll Take Your Questions Now," adding that "we were told we could order anything we wanted on the room service menu."

She added that the offer was in violation of the Foreign

Gifts and Decorations Act, but much of the former White House staffers on Trump's entourage were unaware of the basic protocol.

"It was the first and only time that happened, because we

came to find out that it was against the rules," Grisham continued. "I don't know if the state department ended up paying for staff rooms, but I imagine they did."

Normally, US officials are trained to remain vigilant

Normally, US officials are trained to remain vigilant about foreign gifts, and must report anything worth more than \$415.

"At the time we didn't know, or maybe didn't care, that

it wasn't allowed and that any gifts given to us had to be reported and turned in so they could be assessed for value before we were given the option to purchase them," Grisham wrote.

Grisham then described Jared Kushner, Trump's son-in-

law and one of the most influential figures in his administration, as "Rasputin in a slim-fitting suit."

"I have no idea what the end result was or if true, but I

remember some people talking about the fact that Jared and his staff had been gifted Rolex watches, ornamental swords, and various textiles," she said.

## Mark Zuckerberg Loses \$6 Billion In Hours After Facebook Outage

ark Zuckerberg's personal wealth has fallen by more than \$7 billion in a few hours, knocking him down a notch on the list of the world's richest people, after a whistleblower came forward and outages took Facebook Inc.'s flagship products offline.

A selloff sent the socialmedia giant's stock plummeting 4.9% on Monday, adding to a drop of about 15% since mid-September.

The stock slide on Monday sent Zuckerberg's worth down to \$121.6 billion, dropping him below Bill Gates to No. 5 on the Bloomberg Billionaires Index. He's down from almost \$140 billion in a matter of



weeks, according to the index.

On Sept. 13, the Wall Street Journal began publishing a series of stories based on a cache of internal documents, revealing that Facebook knew about a wide range of problems with its products - such as Instagram's harm to teenage girls' mental health and misinformation about the Jan. 6 Capitol riots - while downplaying the issues in public. The reports have drawn the attention of government officials, and on Monday, the whistleblower revealed herself.

In response, Facebook has emphasized that the issues facing its products, including political polarization, are complex and not caused by technology alone.

"I think it gives people comfort to assume that there must be a technological or a technical explanation for the issues of political polarization in the United States," Nick Clegg, Facebook's vice president of global affairs,

## French Bishops Seek Forgiveness After Damning Church Sex Abuse Report

aris: French clergy have sexually abused more than 200,000 children over the past 70 years, a major investigation released on Tuesday found, and its authors accused the Catholic Church of turning a blind eye for too long and urged it to reform.

The revelations in France are the latest to rock the Roman Catholic Church, after a series of sexual abuse scandals around the world, often involving children.

The church had shown "deep, total and even cruel indifference for years," protecting itself rather than the victims of what was systemic abuse, said Jean-Marc Sauve, head of the commission that compiled the report.

Most of the victims were boys, he said, many of them aged between 10 and 13.

The church not only did not take the necessary measures to prevent abuse but also failed to report it and sometimes knowingly putting children in touch with productors he said.

with predators, he said. Speaking just after Sauve at the public presentation of the report, the archbishop of Reims and head of the French conference of bishops, Eric de Moulins-Beaufort, spoke of shame, asked for forgiveness and promised to act.

The commission was established by

Catholic bishops in France at the end of 2018 to shed light on abuses and restore public confidence in the church at a time of dwindling congregations. It has worked independently from the Church.

Sauve said the problem was still there. He added that the church had until the 2000s shown complete indifference to victims and that it only started to really change its attitude in 2015-2016.

CHURCH URGED TO REFORM

The Catholic Church's teaching on subjects such as sexuality, obedience and the sanctity of the priesthood helped create blind spots which allowed sexual abuse by clergy to happen, Sauve said, adding that the church needed to reform the way it approached those issues to rebuild trust with society.

## Russian Film Crew Docks At International Space Station For First Movie In Orbit

oscow: A Russian actress and director on Tuesday arrived at the International Space Station (ISS) in a bid to best the United States and film the first movie in orbit.

The Russian crew is set to beat a

Hollywood project that was announced last year by "Mission Impossible" star Tom Cruise together with NASA and Elon Musk's SpaceX.

Actress Yulia Peresild, 37, and film director Klim Shipenko, 38, took off from the Russia-leased Baikonur Cosmodrome in ex-Soviet Kazakhstan as scheduled.

But they belatedly docked at the ISS at 1222 GMT after veteran cosmonaut Anton Shkaplerov switched to manual control.

"Welcome to the ISS!" Russia's space agency Roscosmos said on Twitter.

The crew travelled in a Soyuz MS-19 spaceship for a 12-day mission at the ISS to film scenes for "The Challenge".



## Politics Over Farmers

he killing of eight people, four of them protesting farmers, after being run over by a vehicle allegedly driven by the son of the Union Minister of State for Home Ajay Mishra has snowballed into a major political issue. With the elections in Uttar Pradesh and Punjab looming, the opposition parties have made the incident a rallying point to take on the government in UP and New Delhi. The top Congress leader Priyanka Gandhi rushed to UP but was detained on the way to the site of the accident. She later sat on a hunger strike. Samajwadi Party chief Akhilesh Yadav was also detained by the police from outside his residence in Lucknow where he staged a sit-in after being stopped from visiting Lakhimpur Kheri district.

The killings have also given fillip to farmers' protest which has now been going on for the past ten months. But the union government has stood its ground on the laws. Least that the government has been willing to do is to suspend the three controversial farming laws for 18 months. But the farmers want a complete repeal of the laws. They argue that the laws will only hurt their livelihoods and will only benefit large corporations. The situation remains deadlocked. The farmers, meanwhile, continue their siege to New Delhi, blocking its main entry points. The government, it seems, has now fewer options left but to accede to farmers' demand. More so, with crucial UP elections round the corner. If this happens this will be the first time that the Narendra Modi government will be forced to withdraw any of the laws it has passed so far.

One of the biggest charge against the BJP-led union government is that it is unilaterally passing far-reaching laws with a bearing on the lives of millions of people. This started with sudden demonetisation of Rs 1000 and Rs 500 notes in November 2016 that plunged the country into a virtual chaos. Then followed the GST reform which crushed the small businesses. This was followed by the revocation of Article 370 that granted J&K its semi-autonomous status within the Indian Union. The move's fallout is still playing out in J&K and Ladakh, the former parts of J&K state, now downgraded into two union territories. Following this, the centre came up with Citizenship Amendment Act that ensured that only non-Muslim refugees from the neighbouring countries are entitled to Indian citizenship. Now the farmers' protest is taking place despite the pandemic. The best course for the government is to address the anxieties of the farmers and do everything to assure them that their livelihoods will not be threatened.

nce upon a time, there was a woman with a story to tell. Along came a man, rewrote her stories, and sold it to the public as his own. Research on the rovenance of fairytales by Ruth B. Bottigheimer of Stony Brook University, New York, has revealed that the first edition of fairy tales by the likes of Giambattista Basile, Charles Perrault and the Grimms cited women – grandmothers, society matriarchs — as the original spinners of these stories. Unsurprisingly, under the male gaze of the new chroniclers, the original narratives were tweaked, transforming rich reflections on the experiences of women of flesh and blood into unimaginative, but socially conformist, plots. For instance, before the Grimms waved their wand of propriety over the tale of Rapunzel, she and the prince were said to have spent most days together in her tower of isolation, until the princess remarks to her foster mother that her clothes fit more tightly than before, indicating premarital pregnancy. Bibbidi-bobbidi-boo went the Grimms and turned Rapunzel into a damsel in distress, waiting to be rescued by the proverbial — male — knight in shining armour.

Hearteningly, women writers – fairies with pens – are now reclaiming storytelling. From Amazon's recent retelling of Cinderella, where she seeks salvation not in the arms of a prince but through her own creativity in fashion designing, to books like Fierce Fairytales and Girls to the Rescue, women screenwriters and authors are reimagining fairytales in a more egalitarian light. Purists will no doubt gasp and reach for a poisoned apple at the prospect of such alterations, arguing that this spells doom for the fables that have been passed down through the generations. But in reality, feminist retellings of fairytales might be seen as a reclamation of the original spirit of fairytales that were not so biased in favour of men. In fact, a recent study conducted by The Washington Post showed that while earlier adaptations of fairytales by Disney divided dialogues equally between princesses and princes, heroines were given fewer and fewer dialogues since the 1980s and '90s.

At their core, however, fairytales are about much more than who saves whom from the ivory tower. Little wonder then that Sleeping Beauty's beau found it perfectly acceptable to kiss a sleeping woman without her consent.

# Global Opinions | Trudeau's Win In A Divided Canada

ustin Trudeau has won a historic back-to-back third election in Canada, and is now in the elite company of prime ministers. However, he had won the third term through a snap election, by dissolution of the parliament in August 2021. An early opinion poll before the dissolution had kept his Liberal Party ahead, but that soon changed with O'Toole's CPC moving ahead. Although, he had been positive about his campaign as he thought that his management for Covid was

"It looks like nobody wanted an election and no one got what they wanted," said the Toronto Star political columnist Chantal Hebert as results came in, reflecting the peculiarity of the election. When it comes to his first term, it was often tainted as scandal ridden and shambolic.

For the second time since 2019, Trudeau has been handed a minority government by Canadians, meaning he will have to reach across the aisle to work with smaller parties in order to govern. For his critics, however, this snap election was for 'nothing'.

During the campaigns, he had been plagued by protestors at every stop, who made bounderish gestures and shouted rude words, which was not normal for him before.

The parliament had been largely mirroring the 2019 result. His rival, O'Toole had accused him of engineering a 'quick power grab' and being carefree about high deficits. Back then in 2019, by not coming in the majority, his brow had darkened, both literally and figuratively. But he still managed to form the government. Eventually, he started wearing a beard as a reflection of the gloomy new times.

Son of former liberal prime minister Pierre Trudeau, Justin's advocacy of a more moderate brand of conservatism, nevertheless, seems to have gone down well with many, even if it may puzzle some in the CPC's traditionally hard-line support base.

For his supporters, Trudeau had been looking too obviously good with his policies, after six years in power. He was also getting the hang of that Chrétienesque opportunism which can sometimes help win snap elections for weakened governments, but it can also taint by looking down at weaker opposition parties at the same time. This stance can also backfire. The Liberal risk is that, as Gord Downie sang, "there's nothing uglier than a man hitting his stride.'

O'Toole's recent repositioning by tilting towards the centre, and shunning the far right, had also opened up

space for the populist People's Party, campaigning on an anti-vax, climatechange-sceptic, pro-gun, pro-oilindustry platform. Several of its policies have been termed as xenophobic and racist. On the other hand, Greens failed to make an impact coming with a disappointing fourth.

However, several populist activists in Canada, quite lately, seem to have lost their nerve for normal civil conduct of Canadian politics. Rowdy disruptions of Liberal rallies by them have become counter-productive. Part of them are vulgar mobs, who are more organised than ever on social media. Actually, there is a rise of far-right extremism in Canada, which is putting its politics in a loophole. Canada is now a 'home of far-right extremism', according to Oped writer David Moscrop, because political parties in Canada, mainly the Conservatives have failed to repudiate extrem-

ists and drive them out of the tent. Infact, far right elements have been welcomed by the party. For instance, in 2015, then-Prime Minister Stephen Harper fought an election campaign in which his party floated the idea of a 'barbaric cultural practices' snitch line. He then lost the contest to Prime Minister Justin Trudeau. In 2016, one of the faces of that policy, Chris Alexander, admitted the error as he prepared to run for the leadership of the party, but the damage was done. In 2018, then-Conservative senator Lynn Beyak was removed from caucus for defending residential schools, but the time it took to remove her was telling. She has recently quit the senate. In 2019, then-leader Andrew Scheer gave a speech to 'extremist yellow vests', part of the Canadian perversion of the French populist movement on Parliament Hill and then defended his decision to do so. Even the recent

expulsion of Derek Sloan, a Conservative member of Parliament - "because of a pattern of destructive behaviour involving multiple incidents and disrespect towards the Conservative team for over a year," according to O'Toole – raises the question of why that pattern was allowed to develop in the first place. Thus, it has become important for a pivotal party, such as CPC, to come clear, be persistent and unambiguous on extremism lurking in its shadows.

This, at the same time, also doesn't mean that if Canadians rebuke the Conservatives for stirring several controversies, it makes everything which Liberals do as right.

By the time September came, with its frantic culture of protesters outside hospitals and gravel falling on campaigners, the election result reflected that it was too late to get back to simply governing. It reflected how Liberals in Canada had telegraphed confidence for too long. The election result is a madness in a way, as Canadians are in the middle of multiple national crises.

There is also Americanisation of Canadian political media, which focuses on party leaders, and not on representatives which common people actually vote for. Journalism like that can mislead, but this is how things are

Joseph Brean in the National Post had also shared some interesting anecdotes in his Oped. He compared Trudeau with a parable of a foolish prince, and wrote: 'The reason for this gamble was simple. Trudeau wanted to lock in his approval. Things were fine for him, as prime minister, but they could be better. It is a familiar storyline. Canadians recognise it. Sure enough, he was a first-born political prince, not unprivileged as folk heroes usually are, and he did not seem exceptionally humble or clever like these heroes, but he had a strong and diverse team and a cabinet with half women, including an Indigenous justice minister. Now, many argue that Trudeau's political career has fallen just like seen in familiar plotlines that reflect rash confidence, pride and failures in recognising the structural qualities of a decision.

There has been a certain unCanadian behaviour during this election, which makes it understandable that Trudeau is in a pit of his own digging, as his failure to ensure a majority also asserts his political defeat and a depletion of his political capital.

If you have been following recent press reports about the effects of social media on young people, you may well believe this. But there is no scientific evidence to support such extreme claims.

The real story is far more complex. It is very difficult to predict how social media will affect any specific individual - the effect depends on things like their personality, type of social media use and social surroundings. In reality, social media can have both positive and negative outcomes.

Media reports that compare social media to drug use are ignoring evidence of positive effects, while exaggerating and generalising the evidence of negative effects. This is scaremongering – and it does not promote healthy social media use. We would not liken giving children sweets to giving children drugs, even though having sweets for every meal could have serious health consequences. We should there-

fore not liken social media to drugs either. For a claim to be proved scientifically it needs to be thoroughly tested. To fully confirm The Independent's headline that: "Giving your child a smartphone is like giving them a gram of cocaine, says top addiction expert", you would need to give children both a gram of cocaine and a smartphone and then compare the effects. Similarly, you would need to provide millennials with social media, drugs and alcohol to test The Conversation's headline that: "Social media is as harmful as alcohol and drugs for millennials". But ethical guidelines at universities were put in place so that such

#### studies will never be done. The diversity of social media

But maybe news headlines should be discounted - as exaggerations are often used to grab the readers' attention. But even when ignoring these grand claims, the media coverage of social media is still misleading. For example, reports that talk about the effects of social media are often oversimplifying reality. Social media is incredibly diverse - different sites providing a

host of different features. This makes it extremely difficult to generalise about social media's effects.

A recent review of past research concluded that the effect of Facebook depends on which of the platform's features you use. A dialog with friends over Facebook messenger can improve your mood, while comparing your life to other people's photos on the Newsfeed can do the opposite. By treating all social media sites and features as one concept, the media is oversimplifying something that is very complex.

## Focusing on the negative

Past media coverage has not only oversimplified social media, but has often only focused on social media's negative aspects. But scientific research demonstrates that there are both positive and negative outcomes of social media use. Research has shown that Facebook increases self-esteem and promotes feeling connected to others. People's physiological reactions also indicate they

react positively to Facebook use. By contrast, it has also been found that

social media can decrease well-being and increases social anxiety. An analysis of 57 scientific studies found that social media is associated with slightly higher levels of narcissism. This array of conflicting evidence suggests that social media has both negative and positive effects. Not just one or the other.

## The amount matters

The effect of social media also depends on the amount of time you spend using it. In a recent study we conducted of more than 120,000 UK teenagers, we

found that moderate social media use is not harmful to mental health.

abstinence do not appear to fare better. Recent media reports may have made parents unnecessarily anxious about their child's use of social media. ## 'Our choices may be making us more individualistic'

new study has attempted find the impact of the explosion of choice on the psyche of the individual, and further, society as a whole.

The findings of the study were published in the journal Proceedings of the National Academy of Sciences'.

"America is called the republic of choice,' said Shilpa Madan, assistant professor of marketing in the Pamplin College of Business

"Just go into the supermarket -- there are a mindboggling variety of just cookies," Madan added.

In the last three decades, the number of products in the average supermarket increased from an average of nearly 9,000 to almost 47,000, according to the Food Marketing Institute, a trade group.

While having a variety of choices is widely seen as a positive consequence of economic development, what impact does this explosion of choice have on the psyche of the individual, and further, society as a whole?

In this study, Madan illustrates how this salience of choice alone can have a range of powerful psychological effects, including empowerment of the individual.

thinking "Just about making choices makes people more independent and more concerned about their self-interests. It makes people more individualistic," Madan explained.

Madan noted that these choices don't need to be life-altering decisions to have an impact.

"The actual choices could be trivial. Maybe you woke up this morning and chose to eat cereal for breakfast instead of egg," Madan said.

You chose to like a few posts on Instagram but ignore several others. This mere sense of choice that you are in the driver's seat, makes people feel that they are independent and impor-



tant. It is said that we make choices that shape our environment, but most of us don't realise how our choices shape us," Madan added.

"This focus on the self isn't necessarily bad. In fact, it can have a range of positive consequences for the individual. When people think of themselves as independent, they are less likely to tolerate harassment or discrimination, more willing to raise their voice, and more willing to negotiate better conditions for themselves," Madan continued.

However, the increase in individualism can potentially have negative consequences for the collective well-being. "Choice is good for

the individual but could be bad for society. As people become more independent and more individualistic, more self-interested, it becomes more difficult to take collective action," Madan explained.

As Madan stated, we are potentially seeing those negative consequences now during the COVID-19 pandemic, as people are increasingly choosing to assert their independence and act in their own best interests, for example, by not wearing masks or not getting vaccinated.

"The challenges the world is facing right now -- the COVID-19 pandemic, climate change, discrimination, bias. and inequity -- need collective action, need people to work together for the greater good,"

Madan said While the United States of America was founded on the ideals

of individualism, what about more collectivist societies? Does the salience of choice have the same impact on people in nations where individualism is not as prolific?

According to her research, the impact is the same, no matter the culture.

"It replicates across cultures. From America, which is already very individualistic, to Singapore and India, which are both collectivistic countries." Madan said.

One look down a supermarket aisle or at a Netflix home screen shows that our choices are only growing. So, what can be done to ensure that our focus on individualism does not come at the cost of the greater good?

According Madan, this requires further research.

Madan added, "As research scientists, we are trying to find interventions for specific contexts where we can attenuate this negative effect of choice on collective wellbeing. What are the kind of interventions we can create to make people wear a mask, or get vaccinated, or make them care for the environment?"

the interim, Madan reiterated that choices are meant to be made deliberately and consciously. She referenced the Virginia Tech motto to ensure we are making the right decisions both for ourselves and for our community.

"Virginia motto, Ut Prosim (That I May Serve), speaks to this. Make choices that are not just self-serving but good for those around you," Madan concluded.

# Petrol, Diesel Prices Surge To Record-High Levels

**NEW DELHI:** Petrol and diesel prices on Tuesday surged to alltime high levels as rates were increased again after international oil prices hit the highest mark

Petrol price was hiked by 25 paise a litre and diesel by 30 paise, according to a price notification of state-owned fuel re-

This sent the petrol price in Delhi to its highest-ever level of Rs 102.64 a litre and to Rs 108.67 in Mumbai. Diesel rates too touched a record high of Rs 91.07 in Delhi and Rs 98.80 in Mumbai.

Prices differ from state to state depending on the incidence of local taxes

The sixth increase in fuel rates in a week's time has sent petrol prices above Rs 100 in most major cities of the country.

Similarly, the ninth increase in prices in less than two weeks has shot up diesel rates above Rs 100 mark in several cities in Madhya Pradesh, Rajasthan, Odisha, Andhra Pradesh and Telangana.

International oil prices rallied to a near seven-year high following a decision by OPEC+ to maintain its planned gradual increase of supply, despite the market facing an energy crunch.

However, with no respite from surging international prices, OMCs have started to increase the retail selling price of petrol and diesel with effect from Sep-Brent tember 28 and September 24 re-

Since then, rates have gone up

by Rs 2.45 paise per litre and petrol price has increased by Rs 1.50.

Prior to the July/August price cuts, the petrol price was increased by Rs 11.44 a litre between May 4 and July 17. Diesel rate had gone up by Rs 9.14 during this period.

The relentless increase in fuel prices has been criticised by opposition parties who have de-manded that the government cut record excise duty on the two fuels to give relief to consumers. The government has so far not

agreed to the demand. Oil Minister Hardeep Singh Puri on Saturday refused to even

comment on the high fuel prices.

Asked about the fuel prices at his ministry's event in the national capital on Saturday, Puri said, "chodo (please leave it)" before walking away.

## **Rupee Slips 13 Paise To** 8-Week Low Of 74.44 **Against US Dollar**

**MUMBAI:** The rupee fell 13 paise to hit its weakest closing in nearly eight weeks at 74.44 against the US dollar on Tuesday, weighed down by the strengthening of the greenback in the overseas market and rising crude oil prices.

At the interbank foreign exchange market, the local currency opened on a weak note and witnessed an intra-day high of 74.41 and a low of 74.63 against the US dollar in day trade.

The local unit finally settled at 74.44 a dollar, down 13 paise over its previous close. This was the rupee's lowest closing level since August 11.

The Indian rupee depreciated for seven out of last eight days and plunged to a twelve-weeks low. Local currency remained under pressures as crude started trading above USD 78 barrel along with rally in dollar index," said Dilip Parmar, Research Analyst, HDFC Securities.

Widening trade balance data and dollar outflows also weighed on rupee, Parmar added.

According to Parmar, the near-term outlook for rupee remains bearish and sustainable trading above 74.75 lead to further weakness towards 75 odd levels while near-term support has been shifted to 73.95 levels.

# Chilli Peppers And Hugs: This Is What Inspired Nobel Medicine Prize Winners


**WASHINGTON:** David Julius was browsing a supermarket aisle filled with chili pepper sauces when he turned to his wife, a fellow scientist, and said he thought it was time he finally solved how certain chemicals cause the sensation of heat.

"Well then, you should get on it," came her reply.

Ardem Patapoutian, meanwhile, had long been driven to unlock the neglected mysteries of touch, which govern everything from how we discriminate between objects and how we feel when we hug another person, to how our bodies intuitively "know" where our limbs are, without looking.

Both American molecular biologists won the Nobel Medicine Prize for their groundbreaking advances, conducted independently of each other in the late 1990s and 2000s, that are now being turned towards developing treatments, especially of pain.

Julius, of the University of



California, San Francisco told reporters he had always been fascinated by how people interact with natural products in their environment, and by how certain plants contain chemical irritants, such as spice.

Prior research had shown capsaicin was important as an activator of neurons involved in pain -- but the underlying mechanism was unclear.

He then turned to compounds from menthol and mint to identify similar "receptors" responsible for cold, and used molecules from wasabi to learn about inflammatory pain.

"I like doing experimental science because you get to work at the bench with your hands while you're also thinking, and that gives you an opportunity to really sort of enjoy what you're doing day to day, almost like a hobby," he said.

"There's a time when you make a discovery, where you're the only person on the planet, or at least you think you're the only person on the planet who knows the answer to a particular question, and that's a really thrilling moment."

A number of drug candidates to stop chronic pain are in the pipeline, but have so far come up against challenging side effects.

Patapoutian, of Scripps Research, also made discoveries

linked to temperature, but his investigations into pressure stood out even more.

Specifically, he found two genes responsible for converting pressure into electrical signals through tests on lab-cultured cells.

 $I\bar{t}$  is pertinent to mention here that M.L Bindroo started his career from his father's shop in Hari Singh High Street in 1970's and later on went to rise as one of the most successful Chemists in the valley.

As per several locals, it was M L Bindroo who'd first started procuring the medicines from the international market and sold them at affordable rates in Srinagar. While he used to stay at his pharmacy in Iqbal park, his wife used to look after the daily affairs of their other shop at Hari Singh High Street.

"The medicines that one couldn't find anywhere in the Valley were only available at Bindroo's shop." Surinder Hakoo, a teacher told Kashmir Observer.

A resident of Iqbal Park, M.L Bindroo owned a shopping complex there where he operated

Bindroo's uncle, Roshan Lal Maava was also shot dead by suspected militants during the peak of militancy in 1990's outside his shop in

terror crime incidents," a police spokesperson said.

Echoing similar views, the People Conference Chairman, Sajad Lone termed the killings outrageous and unacceptable.

"The fatal attack against the owner of Bindroo medicates is outrageous and unacceptable. I knew the gentleman personally. He never left the valley. And terrorists made him pay for that. May he live in peace," Lone wrote on his official Twitter page.

"Two more killings. Truly shocked at these brutal acts of violence.

I don't know what the killers want to achieve. We have seen this blood shed for 3 decades. Apart from sufferings we have achieved nothing," he wrote in another Tweet.

Apni Party President, Syed Mohammad Altaf Bukhari termed the incidents as extremely barbaric, reflecting the inhuman nature of perpetrators behind these attacks.

In a statement issued here, Bukhari condemned the killings of M.L Bindroo, a wellknown pharmacist store owner in Lal Chowk, a non-local street vendor Virender Paswan from Bihar and another civilian identified as Mohammad Shafi from Shahgund Hajin area of Bandipora districts who were shot dead in cold

"There are no words to condemn these killings. Our heads hang in shame. Mr. Bindroo never left his homeland even in the worst of turmoil and had continued to make the life saving drugs available to humanity in this part of the world. Is this how he has been repaid for his public services?" Bukhari asked.

Similarly, Bukhari said that killing of non-local labour in Lal Bazar and another civilian from Hajin is highly disgraceful as no words can ever compensate for the pain felt by their families.

"What logic can be given to the children who lost their breadwinner father in this senseless bloodshed? No words can deliver solace to them and nothing can bring back their loved ones," he remarked.

He urged the administration to ramp up the investigations and nab the culprits who seem to be adamant on disturbing the peaceful environment in Jammu and Kashmir.

He also demanded that security of the vulnerable persons need to be reviewed and efforts must be made to avoid such ominous incidents in the future.

In a statement issued here, CPI (M) leader Mohammad Yousuf Tarigami condemned Bindro's killing.

"Late Bindroo stayed here in trying and difficult times and continued his service to the locals despite odds. It was a household name in Kashmir. His unfortunate death has sent shock waves. ## Gavaskar **Slams Umpiring** Standards In IPL

**DUBAI:** Former India captain Sunil Gavaskar has slammed the standard of umpiring in the ongoing Indian Premier League.

Gavaskar made his comments after umpire Anil Chaudhary changed his decision from no ball to wide during the game between Delhi Capitals and Chennai Super Kings on Monday. The delivery by Dwayne Bravo landed outside the pitch.

"That was clearly a no-ball. We've had a couple of decisions from TV umpires, which in these circumstances can make the difference between winning and losing, and that shouldn't happen," said Gavaskar while doing commentary on Star Sports.

"These kinds of decisions should not change the game. It's a good thing Delhi won because that could have changed the game," he added.

LONDON: All-rounder Sam Curran has been ruled out of the ICC T20 World Cup with a lower back injury, which he sustained during an Indian Premier League game for Chennai Super Kings, the England & Wales Cricket Board said on Tuesday.

He will fly back to the UK in the next couple of days and will have further scans and a full review later this week by the ECB's medical team.

"Curran complained of back pain after Chennai Super Kings Indian Premier League fixture on Saturday against Rajasthan Royals. Results of the scan revealed the injury," the ECB stated.

Curran's brother, Tom, has been drafted into England's squad for the World Cup. In addition, Surrey's left-arm seamer Reece Topley has been added as a travelling reserve. Topley will join the England party

The 23-year-old Curran had a forgettable IPL, scoring only 56 runs from nine games and picking up nine wickets at an expensive economy rate of 9.93.

"Unfortunately I have received a gutting news that I will unfortunately be missing the remainder of the IPL season and the World Cup. Extremely gutted... absolutely loved my time with Chennai this season." Sam Curran told CSK.
