### No Plans to Capture Pak Kashmir for Now, Says Top IAF Commander

## Will Have Whole Of **Kashmir Someday: IAF**

SRINAGAR: A top Air Force officer on Wednesday said there was no plan "at the moment" to capture Pakistan-controlled Kashmir (PcK), but expressed the hope that someday India will have the "whole of Kashmir".

Speaking to reporters at an event here to mark the 75th anniversary of the Indian troops' Budgam landing, Air Officer Commanding in Chief (AOCin-C) of Western Air Command, Air Marshal Amit Dev, also said the people on the other side of LOC are not being treated very fairly by the Pakistanis.

### Centre Files Plea In SC To Transfer Mehbooba's Petition


**NEW DELHI:** The Centre Wednesday informed the Delhi High Court that it has filed a plea before the Supreme Court seeking the transfer of PDP leader Mehbooba's Mufti's petition which challenges the Constitutional validity of a provision of the Prevention of Money Laundering Act (PMLA).

The counsel representing the Centre told a bench of Chief Justice D N Patel and Justice Jyoti Singh that the transfer petition is likely to come up for hearing before the apex court within a week -- on October 29.

The high court listed the matter for further hearing on December 23.



The Centre had earlier told the court that several petitions concerning various provisions and scheme of PMLA are pending in the Supreme Court and the matter has been assigned to a special bench and parties have exchanged certain queries, one of which is directly • More On P10

## Gulf Arab States, **Squeezed By Climate** Change, Still Tout Oil

RIYADH: The global energy transition is perhaps nowhere more perplexing than in the Arabian Peninsula, where Saudi Arabia and other Gulf monarchies are caught between two daunting climate change scenarios that threaten their livelihoods.

In one, the world stops burning oil and gas to cut down on heat-trapping emissions, shaking the very foundation of their economies.

In the other, global temperatures keep rising, at the risk of rendering unlivable much of the Gulf's already extremely hot terrain.

The political stability of the six Gulf states - Saudi Arabia, the United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, is rooted in profits from fossil fuels.

This includes exports that energy-hungry China and India will want even more over the next two decades.

"Climate action, it's almost an existential problem for an absolute monarchy based on oil exports," said Jim Krane, author of "Energy Kingdoms: Oil and Political Survival in the Persian Gulf."

"They need climate action to succeed without wrecking the oil market. That's a tough needle to thread."

In pledging "net-zero" emissions targets as Saudi Arabia, the UAE and Bahrain have done this month. greenhouse gas emissions would be cut within their borders, while maintaining fossil fuel exports abroad.

Saudi Arabia, which supplies about one-tenth of the world's oil demand, made its announcement this week while hosting its first major climate change forum.

Crown Prince Mohammed bin Salman set 2060 as Saudi Arabia's target.

It was an important announcement for a country with an estimated 265 billion barrels of oil reserves worth \$22.5 trillion at current prices.

Saudi Arabia has expressed determination to pump oil until the last drop, but it could find little use for its greatest natural resource in a world that runs on cleaner forms of renewable and solar energy.

Gulf monarchies have used oil revenue to maintain domestic support, buy regional clout and expand influence.

The money has built up national armies and provided citizens with cushy public sector jobs, free health care and higher education, subsidized fuel, land to build homes on, marriage dowries and generous pensions.

Without this patronage system, Gulf monarchies might have to allow greater political participation or turn more repressive, said Krane, an energy studies fellow at Rice University's Baker Institute for Public Policy in Texas.

Gulf Arab states pledging "net zero" emissions are positioning themselves to be part of the multi-trillion-dollar clean energy industry, even as they keep earning from oil and gas.

### 'Vaccinated But...': Delay In Covaxin **Approval By WHO Hits Indian Travellers**

Pandalam: Stuck in a village for nine months and unable to return to his job in Saudi Arabia, Sugathan P.R. is hoping the World Health Organization will approve the COVID-19 shot Covaxin, paving the way for his trip back.

Like Mr Sugathan, millions of Indians have taken Covaxin and many have complained of travel struggles as the vaccine has not been recognised for international travel by several countries.

"I cannot continue to remain idle here any further," said 57-year-old Sugathan, who returned to Pandalam village in Kerala in January to be with his family after missing his father's funeral last year when the pandemic disrupted flights.

"I had the option of going to Saudi and taking (additional doses of) Covishield after a four-day institutional quarantine, but I was not sure of its implications on my health," said Mr Sugathan, refer-



ring to AstraZeneca's vaccine.

"If the Covaxin approval does not come, I will take the risk of going and taking a Saudi-approved vaccine," he added, sitting in his spacious two-storey house fronted by paddy fields.

WHO Chief Scientist Soumya Swaminathan said after a meeting on Tuesday that its independent experts had sought "additional clarifications" from Covaxin maker Bharat Biotech for a final assessment on Nov. 3. The global agency has been

deliberating on data supplied by Bharat Biotech since early July but has said it cannot "cut cor ners" in making a decision.

Without a WHO nod, the twodose Covaxin is unlikely to be accepted as a valid vaccine globally and would complicate travel plans for Indians who have taken it.

Rajan Pallivadakethil Unnunni, 59, who worked in Kuwait as a welder for two decades before flying to India late last year, has been unable to go back as Kuwait does not recognise Covaxin.

He is now struggling to repay his \$20,000 bank loan selling chicken at a small stall in Kerala and making \$4 a day.

"If I cannot go back to Kuwait, I will not be able to repay the loan and complete the education of my children," said Rajan, seated on a plastic stool in front of his shop.

"I can buy a ticket to Kuwait only if the Kuwait government app shows a green signal."

## 'Climate catastrophe': World faces 2.7C temperature rise

urrent commitments to cut greenhouse gas emissions put the planet on track for a "catastrophic" average 2.7-degree Celsius temperature rise this century, the United Nations has said, the latest stark warning ahead of crunch

Just days before the COP26 climate summit in the Scottish city of Glasgow, the UN's Environment Programme (UNEP) said on Tuesday national plans to reduce carbon pollution amounted to "weak promises, not yet delivered".

"The G20 countries are responsible for 78 percent of all emissions so the 'to do item' lies with them," Inger Andersen, executive director of the UNEP, told Al Jazeera.

"The developed countries have a special responsibility to really step up, but actually everyone does - all 193 member states.'

Andersen said much of the pledged action by countries is delayed until 2030, which scientists warn will be far too late to halt the worst ravages of climate change on the planet. "Action is needed



Governments will be in the spotlight at the COP26 conference next week to meet a deadline of this year to commit to more ambitious greenhouse gas cut promises, in what could be the last chance to put the world on track to limit warming to 1.5C (2.7 Fahrenheit) above pre-industrial levels.

### ISIL Attack On Iraqi Village Kills 11 'Defenceless Civilians'

Baghdad: At least 11 people have been killed and others wounded in an ISIL (ISIS) attack on a village in Diyala province in eastern Iraq, according to the country's security forces.

The attack on Tuesday targeted 'defenceless civilians" in the village of al-Hawasha, near the town of Muqdadiya, the Joint Operations Command said in a statement.

The Associated Press news agency cited two officials as saying that ISIL fighters had kidnapped two villagers earlier and then raided the village when their demands for ransom were not met. The dead and wounded were all civilians, they added.

In a Twitter post, Iraqi President Barham Salih denounced the attack as a "despicable attempt to destabilise" Iraq. He said the country needed to boost its security, address security gaps and "not underestimate the threat of

At its peak, ISIL controlled vast swaths of territory in Iraq and neighbouring Syria under its selfproclaimed "caliphate".

Attacks targeting civilians have become rare in Iraq since ISIL was largely defeated in the country in 2017, although it remains active through sleeper cells in many areas.

A United Nations report published early this year estimated that about 10,000 ISIL fighters remained active across Iraq and Syria, and still conduct operations, often targeting security forces, power stations and other infrastructure.

A roadside bomb attack targeted a suburb of the capital, Baghdad, in July, killing at least 30 peo-



ple and wounding dozens of others at a crowded market.

In January, twin suicide bombings ripped through a busy market in Baghdad, killing at least 32 people and wounding dozens. Iraqi officials blamed ISIL for those attacks

### Germany To End National 'Epidemic' Situation Next Month

BERLIN: The German parliament will not extend the "epidemic situation of national scope" when it expires next month, but will keep in place certain measures to check the spread of the coronavirus, lawmakers said on Wednesday.

Leading members of the country's parliament, or Bundestag, said that although coronavirus infections have been rising again recently, they did not see the need to prolong the "epidemic situation" which it was first declared in March 2020 and has been repeatedly extended since then. They said that the situation had fundamentally changed due to the fact that about twothirds of the population had been vaccinated against the virus.

The health emergency situation declaration had enabled federal and state governments to order key coronavirus measures without the approval of the national and regional parliaments.

"There will no more be school closures, lockdowns or curfews again," said Dirk Wiese, the deputy head of the center-left Social Democrats parliamentary group. He added that the pap demic still needed to be handled responsibly, but that restrictions on civil rights needed to be eased again.

Despite the Nov. 25 expiration of the "epidemic situation," some measures like obligatory mask wearing in public spaces, restrictions on entry to certain venues to only those who have been vaccinated or financial support for workers who have been hit hard by the pandemic will stay in place until March. In addition, individual states can still decide to again implement stricter measures if needed.

Members of the three parties that hope to form Germany's new government announced the country's new direction on the pandemic to reporters in Berlin.

Germany held national elections last month. The Social Democrats, environmentalist Greens and the pro-business Free Democrats opened formal coalition talks following a preliminary deal earlier this month, and said they hope to announce a deal for a new government in early December.

If the negotiations succeed, the new government will send Chancellor Angela Merkel's center-right Union bloc into opposition after 16 years at the helm. Her likely successor would be Olaf Scholz of the center-left Social Democrats, her vice chancellor and finance minister since 2018.

## 'First known exoplanet' spotted in another galaxy

'n a groundbreaking scientific development, astronomers are believed to have found the first known planet in another galaxy-- beyond ours, according to media reports.

The potential called M51-ULS-1b, orbits both a massive star and a dead star in the Whirlpool or Messier 51 galaxy, about 28 million lightyears from Earth, reports Science News

The object's existence, if confirmed, suggests that there could be many other extragalactic exoplanets waiting to be discovered, astronomers report in a study published in Nature Astronomy on October 25.

Nearly 5,000 "exoplanets" - worlds orbiting stars beyond our Sun - have been found so far, but all of these



have been located within the Milky Way galaxy, according

The possible Saturn-sized planet discovered by Nasa's Chandra X-Ray Telescope is in the Messier 51 galaxy.

"We probably always assumed there would be planets

in other galaxies", said astrophysicist Rosanne Di Stefano of the Harvard-Smithsonian Center for Astrophysics in Cambridge, Mass. "But to actually find something, it's a beautiful thing. It's a humbling experience.

Exoplanets are defined

as planets outside of our Solar System. Until now, astronomers have found all other known exoplanets and exoplanet candidates in the Milky Way galaxy, almost all of them less than about 3,000 light-years from Earth, says Nasa.

"We are trying to open up a whole new arena for finding other worlds by searching for planet candidates at X-ray wavelengths, a strategy that makes it possible to discover them in other galaxies," said Stefano, who led the study.

There is no reason to think that other galaxies do not also host planets. But the most popular exoplanet hunting techniques are difficult to do with such faraway stars, which blend together too much to observe them

one by one.

## An Integrated South Asia

n a visit to Saudi Arabia, Pakistan prime minister Imran Khan at a function talked at length about India, Pakistan relations. He once again expressed his desire to have better relations with India but said that Kashmir issue was in the way. "There is only one issue between India and Pakistan and it is the issue of Kashmir. If only we are able to get it out of way, we will be good neighbours," Khan said. Pakistan premier once again dangled the carrot of the access to Central Asia to India. should the two countries be able to normalize their relations. In an obvious call for India to take bolder steps to resolve its issues with Pakistan, Khan said that the most successful business people are those who look ahead and take risks. "The ones who go on the trodden path never really become outstanding in any field, let alone business," he said.

Whatever New Delhi makes of Khan's observations, his vision of an integrated, peaceful south asia is too tempting to ignore. However, this is not the first time the prospect of regional connectivity has been laid out whereby India and Pakistan are foreseen to not only trade with each other but also with central Asia, In Kashmir, China's Border Roads Initiative project has drawn a lot of attention for its alleged potential to boost regional connectivity which in the long term may also help aid India, Pakistan reconciliation. Many observers have predicted that the China Pakistan Economic Corridor will have very consequential impact on the overall framework of India-Pakistan relations. The project, as it progresses is expected to introduce new geo-political factors which in the near or long term will help shape the future of South Asia..

Already, the new factors being unleashed by the project are straining existing geo-politics of the region. However, for now, we are only witnessing the beginnings of this shift. And considering India and Pakistan have not been able to mend their relations over the past seven decades, the prognosis for the future of their relations can't be optimistic. But who knows new geopolitical factors and the great possibilities of a normal bilateral relationship might force a decisive rethink after all. Here's hoping that India and Pakistan do go back to dialogue and engagement and, for once, try to seriously sort out their longstanding issues. And for that the leaders of both the countries need to act in a statesmanlike way.

## Ducking

rirat kohli has a social media following that the country's political parties would be envious of. Other cricketers in India's World T20 squad are also Alisted influencers. But when their long-time mate, Mohammad Shami, an India regular in charge of a new ball for close to a decade, was targeted and abused, and his faith was invoked after the loss to Pakistan, those eagerly followed timelines remained silent. The team that gets into a tight huddle before every game, a reassuring picture of solidarity in a diverse nation, didn't form the same ring of support for Shami. Hours before, however, the images of Kohli and his teammates congratulating Pakistani players sent out a heartwarming signal — that sportsmanship and grace could be found in defeat; that an India-Pakistan cricket match did not have to be overshadowed by bitter enmity. Surely, then, a statement from the team would also have been an eloquent rebuttal to those who saw in Shami only his faith.

In the polarised world of social media, debate usually means extremists on either side hijacking the discourse. Add to this the potent mix of cricket, India, Pakistan and majority vs minority, and it's not difficult to see why many may see silence as a preferred option. But India's sporting icons, from Neeraj Chopra to Virat Kohli, can send out the much-needed message of inclusion to the young. The cricketers' silence stood out, especially when the team collectively supported the ICC's anti-racism stand by taking the knee, the protest posture made famous by the Black Lives Matter movement. A long list of former players did react but many missed the point. Calling Shami a committed, world-class bowler, Sachin Tendulkar tweeted: "He had an off day like any other sportsperson can have." But a player doesn't deserve civility based on the runs he concedes in the game. And this was a day when India was thrashed by 10 wickets, openers Rohit Sharma and K L Rahul went for single digits, finishers Ravinder Jadeja and Hardik Pandya failed to fire at the end and the world's top bowler Jasprit Bumrah was blunted by Pakistan's sauntering openers. It was not difficult to see why the digital mob had targeted Shami.

The BCCI, the richest board with the deepest social media reach, too, must be mindful of its responsibility. England's Football Association was quick to throw its weight behind their players - Marcus Rashford, Jadon Sancho and Bukayo Saka after they faced racist abuse on missing penalties against Italy in the Euro 2020 final. Indian cricket's footprint is now global. The IPL is a growing tent that attracts a diversity of talent. How players behave in such situations amplifies a vital message to the next generation — that ambition and talent go hand in hand only if they are inclusive. That the team chose to be silent when a colleague was the target of hate is not only disappointing, it also dents Indian cricket.

## Bleached Girls

## The Obsession With Fair Skin

"Let's scrub out that tan" is a common refrain in beauty parlours in India, where girls grow up with constant reminders that only fair skin is beautiful.

From Sunday classified ads touting the marriageability of an "MBA graduate. 5-½ ft. English medium. Fair complexion" to elderly aunties advising young women to apply saffron paste to "maintain your skin whiter and smoother", the signs are everywhere.

Even sentiments like, "She got lucky he married her despite her [dark] complexion" are still whispered around India in 2017.

Younger generations are now starting to push back. On July 7, 18-year-old Aranya Johar published her Brown Girl's Guide to Beauty on Youtube. The video, a spoken-word poem containing lines like "Forget snow-white/say hello to chocolate brown/I'll write my own fairy-tale" went viral, reaching 1.5 million viewers around the world in its first day alone.

Johar's candid slam came just before Bollywood actor Nawazuddin Siddiqui



used Twitter to indict the Indian film industry's racist culture.

His post recalled the vehement pushback of actress Tannishtha Chatterjee, who was was bullied for her skin tone on live TV in 2016.

Though many Indians still feign ignorance about social discrimination based on skin colour, the country's obsession with whiteness can also be violent. In recent years, fear of black and brown skin has also spurred harassment and attacks on African students living in India.

Why do Indians so hate their own colour?

#### **The bleaching syndrome** Indian history offers some answers.

Throughout medieval and modern history, the Indian subcontinent has been on the radar of various European settlers and traders, including, from the 15th to 17th centuries, the Portuguese, Dutch and French. The subcontinent was invaded and partly ruled by the Mughals in the 16th century, and colonised by the British from the 17th century onwards until independence in 1947. All these foreign "visitors" were of relatively fair complexion, and

many claimed to be superior.

Being subject to a succession of white(ish) overlords has long associated light skin with power, status and desirability among Indians. Today, the contempt for brown skin is embraced by both the ruling class and lower castes, and reinforced daily by beauty magazine covers that feature almost exclusively Caucasian, often foreign, models.

It's been the dark man's burden in this majority-non-white nation to desire a westernised concept of beauty, and post-colonial activism has not been able to change this.

According to a study we conducted from 2013 to 2016, 70% of the 300 women and men we interviewed reported wanting a date or partner with someone who had light skin. This colourism is what pushes so many Indians to lighten their skin, creating a phenomenon termed "bleaching syndrome".

Bleaching syndrome is not a superficial fashion, it's a strategy of assimilating a superior identity that reflects a deep-set belief that fair skin is better, more powerful, prettier. And it's not

limited to India; skin bleaching is also common in the rest of Asia and in Africa.

#### A thriving bleaching market

An inventive and growing market of creams and salves has cropped up to fill this demand, which now pulls in over US\$400 million dollars annually. Some of the most widely-sold products include Fem, Lotus, Fair and Lovely and its gendered-equivalent Fair and Handsome. Most of these appealingly named creams are in fact a dangerous cocktail of steroids, hydroquinone, and tretinoin,

the long-term use of which can lead to

health concerns like permanent pig-

mentation, skin cancer, liver damage and

mercury poisoning among other things. Nonetheless, a 2014 marketing study found that almost 90% of Indian girls cite skin lightening as a "high need". These young women are willing to overlook the after-effects of bleaching, and the advent of online sales allows them to use these products in the privacy of their own homes.

Initially focused on feminine beauty, the fairness creams market now also caters to Indian men. Products marketed to men promise to fight

sweat, give them fairer underarms and attract women.

And Bollywood stars with huge followings, including Shahrukh Khan and John Abraham, regularly endorse and promote skin bleaches.

#### Bleaching backlash

The brand Clean and Dry took bleaching to new levels in 2012, when it began heavily advertising for a new wash to lighten the vagina.

This time, women had had enough. In 2013, the activist group Women of Worth launched their Dark is Beautiful campaign, which was endorsed by the Indian theatre actress Nandita Sen.

With other feminist groups, the women compelled the Advertising Standards Council of India to issue guidelines in 2014 stating that "ads should not reinforce negative social stereotyping on the basis of skin colour" or "portray people with darker skin [as]... inferior, or unsuccessful in any aspect of life particularly in relation to being attractive to the opposite sex".

This guidance is in keeping with the Indian Constitution, which provides for equality for all (article 14) and prohibits discrimination on the grounds of religion, race, caste, sex or place of birth (article 15).

Unfortunately, the law can do little to stop the subtler forms of racism and bigotry present in Indian society. And, to date, that vagina bleaching product is still on the market.

The "bleaching syndrome" goes far beyond skin colour, with Indian women also questioning their hair texture and colour, speech, marital choices and dress style, raising real concerns about female self-esteem.

As Aranya Johar rhymed on Youtube, "With the hope of being able someday to love another/let's begin by being our own first lovers".

## A Look At The Absence Of God From The Contemporary Wave Of Spirituality

woman sits cross-legged, poised, shoulders back, her eyes closed and a smile on her face, it's a smile just wide enough to indicate that she's not happy (who wants to be happy? Happiness is so 1990s). She is content, she is self-accepting. She is the modern 'spiritual' woman, and she is meditating (the contemporary secular equivalent to religious prayer), but you mustn't say such things out loud as this new form of spirituality has absolutely nothing to do with God or religion.

The absence of God from spirituality is a relatively new concept that has come to existence and can take many forms, the most popular being that of contemporary mindfulness. Mindfulness is defined as a lifestyle that places the concept of moment-by-moment awareness at its core. The idea is that if you pay attention to nothing but this very moment in time, you will experience feelings of peace and calm. There is A LOT of scientific research out there that backs this claim, contemporary mindfulness has been shown to decrease levels of anxiety and depression, as well as increase feelings of empathy and nurture virtues such as forgiveness and honesty. The message is, you don't need God to feel complete, you just need to be at one with yourself. You need you.

What's more, the idea of being spiritual but not religious is often portrayed as a progressive reaction to the realisation that science and capitalism have failed to live up to their expectations. They have not given us answers to the BIG questions that plague every single one of us, questions like 'what are we doing here?', 'how did we end up here?' and 'why are we here?' and we have come to accept that no amount of 'Black Friday buy-one-get-one free' offers are going to fill the hollowness and aching we experience at the centre of our chest when we contemplate the worth of our existence. Both science and capitalism have failed to provide us with meaning or reassurance, so the woke contemporary individual has no choice but to turn to modern spirituality for inner peace and meaning.

## THIS UNDISPUTED POWER AND

freedom given to the self has meant that the effectiveness of modern spirituality has been questioned. Can someone really become spiritual without a rigid moral and ethical system to take them to account? And can it be done whilst being embedded and loyal to a capitalist and colonialist structure that seeks to enslave us all to a system of inequality?

But the way this modern spiritual narrative sells itself can be highly misleading given that a lot of the core practices and concepts found in narratives that are labelled as 'secular spirituality' resonate in and originate from religious traditions, including Islam. And so this modern spirituality can sound a lot like the very institutions and systems it claims to be separate from. Essentially, it sounds like a religion. Take the contemporary concept of mindfulness popular amongst western white middle classes; it makes the claims to being a 'secular' practice, despite the fact that its concepts and meditative techniques originate from the Buddhist tradition. Within the Buddhist tradition mindfulness is at the centre of a very complex system that includes



moral and ethical commitments, including speaking and doing good and espouses detachment from worldly desires at its core, all with the aim of ending human suffering. It is hard work and requires commitment, not simply 'paying attention to the moment'. The Islamic equivalent to what has been done to the Buddhist tradition in the context of contemporary secular mindfulness would be encouraging people to carry out the five daily prayers as a form of meditation and stipulating that the belief in other Islamic concepts including God is irrelevant to achieving peace through prayer. I imagine that narrative would annoy a few people, as it has in the contemporary mindfulness context, where some critics (and not just those who adhere to the

Buddhist tradition) have criticised the contemporary secular take on mindfulness as being another example of a colonialist 'take over'. This is when Eastern traditions are whitewashed and re-packaged to suit western temperaments with little respect or regard for their origins. This observation has earned mindfulness the nickname 'Mc Mindfulness', due to opponents seeing it as nothing short of a covert continuation of existing western capitalist ideals, where emphasis is on a 'fast service' that appeals to as many people as possible to maximise returns.

The capitalist modernist undertone is most glaringly obvious in its selling point – no God. As in true secular capitalist fashion, 'the self' has taken on that role. The self is in charge, it decides which parts of spiri-

tual philosophy are followed and when, it decides what is right and wrong and so in essence it is what is being worshipped; it has taken on the role of God. Since people turn to spirituality to gain a sense of self-worth and acceptance, the capitalist narrative plays on this emotion by placing the gratification and exploration of the self as a core concept. The self then becomes both the means and the ends. This is at odds with spiritual development concepts found in world religious philosophies as well as ancient philosophies, where emphasis is placed on self-control and freedom is found in self-denial.

"Self-worship is the cornerstone upon which our post-modernist, capitalist societies are built on. We are constantly encouraged to shamelessly 'flaunt it', we are constantly bombarded with adverts that glorify the self, rendering it all sufficient and all powerful. You simply have to take a look at the Nike adverts that pitch the likes of you and me as being the missing hero in the Avengers line-up. If only we just had belief in ourselves and ran a couple of times around the block (in Nike gear-obviously) how life would be different for us and the world!

Perhaps this 'new wave' of spirituality is not 'new' at all, but simply another attempt at side-lining God and/or religion from worldly narrative, where capitalist ideals work to encourage philosophies such as this modern wave of spirituality and contemporary mindfulness practice in an attempt to 'take over' the wider ethical and social concerns that are associated with religion and communities. The understanding here is that capitalist ideals will work to prey upon the feelings of disillusion that people may have towards institutionalised religion and offer something similar (a sense of self-worth and meaning) but different (i.e. you're God).

So, perhaps it is high time that people of faith and belief in God were more mindful of the narratives that seek to undermine and replace the beliefs that are important to them and became more aware of the ways that secular contemporary narratives may have unintentionally crept into their subconscious, disrupting their wellbeing. I think it is time that we start talking about God and religion and the ways in which we can integrate these concepts into worldly narratives, so that we can start living life in line with our consciousness, with feelings of fullness and peace.

Until then I'm afraid it's either God or your Nikes (I'm 99.999% certain I'm not destined for the Avengers, so I'm sticking with God).

## **Study Suggests To Better Understand** Speech, Focus On Who's Talking

uring a recent study, researchers have found that matching the locations of faces with the speech sounds they are producing significantly improves the ability to understand them, especially in noisy areas where other talkers are present.

In the Journal of the Acoustical Society of America, published by the Acoustical Society of America through AIP Publishing, researchers from Harvard University, University of Minnesota, University of Rochester, and Carnegie Mellon University outline a set of online experiments that mimicked aspects of distracting scenes to learn more about how we focus on one audio-visual talker and ignore others.

"If there's only one multisensory object in a scene, our group and others have shown that the brain is perfectly willing to combine sounds and visual signals that come from different locations in space," said author Justin Fleming, "It's when there's a multisensory competition that spatial cues take on more importance."

The researchers first asked



participants to pay attention to one talker's speech and ignore another talker, either when corresponding faces and voices originated from the same location or different locations. Participants performed significantly

better when the face matched where the voice was coming from.

Next, they found task performance decreased when participants directed their gaze toward a voice

Finally, the researchers showed spatial alignment between faces and voices was more important when the background noise was louder, suggesting the brain makes more use of audio-visual spatial cues in challenging sensory environments.

The pandemic forced the group to get creative about conducting such research with participants over the internet. "We had to learn about and, in some cases, create several tasks to make sure participants were seeing and hearing the stimuli properly, wearing headphones, and following instructions," Fleming said.

Fleming hopes their findings will lead to improved designs for hearing devices and better handling of sound in virtual and augmented reality. They look to expand on their work by bringing additional realworld elements into the fold.

"Historically, we have learned a great deal about our sensory systems from studies involving simple flashes and beeps," he said. "However, this and other studies are now showing that when we make our tasks more complicated in ways that better simulate the real world, new patterns of results start to emerge."

## **LPG Price May Be Hiked Next** Week; Petrol, Diesel Rates Up Again

NEW DELHI: Cooking gas LPG prices may be hiked next week after under-recovery on the fuel widened to over Rs 100 per cylinder, sources said insisting that the rate hike, including the quantum of increase, is dependent on government permission.

If allowed, this will be the fifth increase in cooking gas rates across all categories households using subsidised gas for cooking and heating purposes, non-subsidised fuel and industrial-sized gas.

LPG rates were last hiked by 6, taking the total increase in rates since July to Rs 90 per 14.2-kg cylinder.

Sources with direct knowledge of the matter said stateowned oil marketing companies have not been allowed to align retail selling price with the cost, and no government subsidy has so far been approved to bridge the gap.

The under-recovery or losses on LPG sales have mounted to over Rs 100 per cylinder after international energy prices soared to multi-year high, they said. While Saudi LPG rates have

Consolidated revenue from operations stood at Rs 20,551 crore in the second quarter, as compared to Rs 18,756 crore in the year-ago period, it added. Total vehicle sales were down 3 per cent at 3,79,541 units in the second quarter, as against 3,93,130 units in the corresponding period last

Domestic sales were at 3,20,133 units in the second quarter, as against 3,70,619 units in the year-ago period.

Exports were, however, the highest ever at any quarter in the company's history at 59,408 units in the second quarter, as compared to 22,511 units in the same period last fiscal.

### **Rupee Declines By 7 Paise To** 75.03 On Month-End Dollar **Demand**

MUMBAI: The rupee weakened by 7 paise to end at 75.03 against the US currency on Wednesday due to month-end dollar demand from importers and a muted trend in the domestic equities.

A stronger dollar in overseas markets and suspected RBI intervention ahead of IPOs also weighed on the local unit, according to analysts.

"The Indian rupee depreciated following month-end dollar demand and a stronger greenback against major currencies. Weakness in Asian currencies and risk-off sentiments weighed on the local unit," said Dilip Parmar, Research Analyst, HDFC Securities.

"Going Ahead, the rupee is expected to consolidate between 74.70 and 75.30 following expectation of fund inflows from a series of IPÔs starting from tomorrow," Parmar added.

At the interbank foreign exchange market, the local currency opened at 75.02 and later witnessed a high of 74.90 and a low of 75.05 against the US dollar in the day trade.

The 61-year-old leader, who was released last year after more than a year in detention following the scrapping of Jammu and Kashmir's special status, was served notice to appear at the ED headquarters in the national capital.

Initially, the ED had summoned Mufti for March 15 but it did not insist for her personal appearance at that time. Thereafter, she was summoned for March 22.

Mufti, in her petition, said she has received summons from the ED under the provisions of the PMLA, purporting to call for 'evidence' on pain of punishment, whereas she is, to all intents and purposes, a subject of investigation.

"She has not been informed if she is being summoned as an accused or as a witness. She has also not been informed of what she is being summoned in connection with and the scheduled offence under the PMLA which gave rise to the proceedings in respect of which impugned summons has been issued to her. The petitioner is not the subject of investigation, nor is she an accused, in any of the scheduled offences to the best of her knowledge, the plea said.

It claimed that ever since Mufti was released from the preventive detention following the formal abrogation of Article 370 of the Constitution, there have been a series of hostile acts by the State, against her, acquaintances and old family friends, who have all been summoned by the ED and a roving inquiry about her personal, political and financial affairs was made, in the course of which their personal devices have been seized.

Earlier, Solicitor General Tushar Mehta and advocate Amit Mahajan, representing the ED, had said there was no need to issue a formal notice to them as they are already appearing before the court and said they will file a short note on the issue of question of law.

## 'Unilateral Move': India **Criticises China For New Land Border Law**

**NEW DELHI:** India on Wednesday hit out at China for its "unilateral" decision to bring about a new land border law and said it is a matter of concern as the legislation can have implications on the existing bilateral pacts on border management and on the overall boundary question.

External Affairs Ministry Spokesperson Arindam Bagchi said India expects that China will avoid undertaking action under the pretext of the law that could unilaterally alter the situation in the India-China border areas.

Xinhua news agency reported last week that the law, which becomes operational from January 1 next year, stipulates that "the sovereignty and territorial integrity of the People's Republic of China are sacred and inviolable".

"We have noted that China has passed a new 'Land Boundary Law' on October 23. The law states among other things that China abides by treaties concluded with or jointly acceded to by foreign countries on land boundary affairs," Bagchi said.



He said such a "unilateral move" will have no bearing on the arrangements that both sides have already reached earlier -- be it on the boundary question or for maintaining peace and tranquillity along the Line of Actual Control (LAC).

Last week, China's national legislature adopted the new law on the protection and exploitation of the land border areas, which could have bearing on Beijing's border dispute with India.

"China's unilateral decision to bring about a legislation which can have implication on our existing bilateral arrangements on border management as well as on the boundary question is of concern to us," Bagchi said.

He was replying to a media query on the matter.



He said the legislation also has provisions to carry out reorganisation of districts in the border areas. The MEA spokesperson noted that India and China have still not resolved the boundary question and that both sides have agreed to seek a fair, reasonable and mutually acceptable resolution to it through consultations on an equal footing.

He said both sides have also concluded several bilateral agreements, protocols and arrangements to maintain peace and tranquillity along the LAC in India-China border areas in the interim.

The spokesperson said India expects that China will avoid undertaking action under the pretext of this law.

"Furthermore, the passage of this new law does not in our view confer any legitimacy to the socalled China Pakistan 'Boundary Agreement' of 1963 which government of India has consistently maintained is an illegal and invalid agreement," he said.

# No Bail For Aryan Khan: Arguments To Continue Today

The Bombay High Court will continue hearing the bail plea of Aryan Khan, the son of Bollywood actor Shah Rukh Khan who has been arrested in a drugs case, on Thursday when the NCB will present its arguments. Justice N W Sambre began hearing the bail application on Tuesday. On Wednesday Aryan

Khan's counsel Mukul Rohatgi, co-accused Arbaaz Merchant's lawyer Amit Desai and advocate Ali Kaashif Khan Deshmukh who appeared for Munmun Dhamecha completed their arguments.

After the hearing which went on for over two hours, Justice Sambre said he would hear Additional Solicitor General Anil Singh, who is representing the Narcotics Control Bureau (NCB), on Thursday. "Tomorrow we will try to finish it," the judge said.

Arvan Khan (23). Merchant and Dhamecha were arrested along with others on October 3 following a raid by the NCB on a cruise ship off the Mumbai coast and alleged seizure of drugs.

They approached the HC last week after a special court for NDPS Act cases rejected their bail pleas.

### **Qazi Claims Wankhede Was Muslim At The Time Of His** First Marriage; NCB officer Says He Never Converted

MUMBAI: The Qazi who had performed the first marriage of Sameer Wankhede, the Mumbai zonal director of the Narcotics Control Bureau (NCB) in 2006, on Wednesday claimed the officer belonged to a Muslim family otherwise the 'nikah' would not have been solemnised as per

The Qazi's claim came in the backdrop of Maharashtra

minister and NCP leader Nawab Malik's allegations that Wankhede was born Muslim, but forged documents, including a caste certificate, to show that he belonged to the Hindu SC category to get a job under quota after clearing the UPSC examination.

"I had performed the 'nikah' of Sameer Wankhede and Shabana Qureshi. Her father had approached me to perform the

marriage in the Lokhandwala complex area of Mumbai. The groom's name was Sameer Dawood Wankhede who married Shabana Qureshi," Maulana Mujammil Ahmed told a news channel.

When asked about Wankhede's claim that he is Hindu the Qazi said had Sameer Wankhede been a Hindu the 'nikah' would not have been performed.

## **Delhi HC Issues Summons to Ramdev for Sreading Misinformation**

he Delhi High Court, on Wednesday, issued summons to Baba Ramdev on a lawsuit by several doctors' associations for allegedly spreading misinformation against allopathy amid the COVID-19 pandemic, saying the plea was not frivolous and a case for its institution was "definitely" made out.

Justice C. Hari Shankar granted four weeks to Ramdev to file his response to the suit.

The judge clarified that he was "not expressing any opinion" on the merits of the allegations in the plaint against the Yoga guru and the issue of grant of any relief, interim or otherwise, shall be looked into subsequently.

"I have seen the video clips (of Ramdev). From the perusal of the video clips, your client is scorning the allopathic treatment protocol. He has literally gone to scorn at the prescription of steroids, people going to hospitals. From the perusal of the clips, there is definitely a case for the institution of the suit. They (plaintiffs) may have nothing for an injunction but the case is not frivolous," the judge told senior counsel Rajiv Nayar, appearing for Ramdev.

The senior lawyer said while he had no objections to the issuance of summons in the matter, he opposed the allegations made in the case.

"There are three parts to the suit—Coronil, defamation, and hesitancy against vaccination. The court may restrict notice to only defamation," Nayar urged the court.

"I am not passing any order. You file your written statement. Say there is no case," the judge responded.

"Permission to institute the suit is allowed. Let the plaint be registered as a suit. Let summons be issued in the suit," the court ordered and posted the next hearing in January.

Apart from Ramdev, the summons was also issued and a response ought from Acharya Balkrishna and

Avurveda on the suit.

The court also issued notice to social media platforms Google, Facebook, and Twitter.

Three resident doctors' association of the All India Institute of Medical Sciences at Rishikesh. Patna and Bhubaneshwar as well as association of resident doctors, Post Graduate Institute of Medical Education & Research, Chandigarh; union of resident doctors of Punjab (URDP); resident doctors' association, Lala Lajpat Rai Memorial Medical College, Meerut, and Telangana junior doctors' association, Hyderabad had moved the high court earlier this year.

They alleged that Ramdev was misleading and misrepresenting to the public at large that allopathy was responsible for the deaths of several people infected by COVID-19, and insinuating that allopathic doctors were causing the deaths of the patients.

Senior counsel Akhil Sibal, representing the associations, had argued that amid a pandemic, the Yoga guru made unsubstantiated claims on Coronil being a cure for COVID-19, contrary to the licence granted to the drug for merely being an "Immuno-booster".

In their plea filed through advocate Harshavardhan Kotla, the associations had submitted that the yoga guru, who is a highly influential person, was sowing doubts in the minds of the general public concerning the safety and efficacy of not only allopathic treatments but also COVID-19 vaccines.

The plea alleged that the misinformation campaign was nothing but an advertisement and marketing strategy to further the sales of the product sold by Ramdev, including Coronil which claims to be an alternative treatment for COVID-19.

Earlier this week, the court had stated that the doctors' plea deserved consideration and could not be "thrown out" at the first stage as, at the present stage, it needed "to see if allegations in the plaint make out a case to be entertained".
