"In the subject of the invitation to the seminar, it was mentioned 'Gendered Resistance to Indian Occupation in Kashmir'. By mentioning this phrase, the organisers of the webinar have depicted the forceful occupation of Kashmir by the Indian government and this phrase has questioned the integrity and unity of the country," the complaint read. • More On P10

PULWAMA: The death of a would-be- bride due to a heart attack on Saturday plunged Rahmoo village of south Kashmir's Pulwama district into grief and mourning. 26-year-old

Sumaya Qadir suffered a massive heart attack at her home in Astanpora on Saturday afternoon, minutes after she returned from her paddy fields, a close relative said. Sumaya, who was scheduled to get married on November 16/17, he said, instantly collapsed on the ground and breathed her last.

"She was working at her paddy field throughout the day. Around 4:15pm, she returned home and complained of pain in her legs. In a jiffy, she collapsed on the ground," the relative said.


ISLAMABAD: Security officials in Pakistan are shocked after it emerged that members of the banned Tehreek-i-Labbaik Pakistan party reportedly used sub-machine guns (SMGs) against policemen during anti-government protests, prompting the authorities to conclude that the hardline Islamists had been turned into a "militant group", a media report said on Saturday.

Mobile phone footage, which showed members of the party firing 80 rounds of SMGs at policemen in Kamoke, in Pakistan's Punjab province, on Thursday, was



presented during a highlevel security meeting, the Dawn newspaper reported.

Other incidents of attacks were also recorded, which showed two policemen succumbing to bullet wounds, while 16 others sustaining injuries from the shots fired by TLP members, • More On P10





# **In New Pandemic Milestone, US Clears Pfizer Shot For Children Aged 5-11**

Washington: The United States on Friday authorised the Pfizer Covid vaccine for children aged 5 to 11, paving the way for 28 million young Americans to soon get immunized.

The decision came after a high-level medical panel advising the government this week endorsed the shots, ruling that the known benefits outweighed



the risks of side-effects.

The United States follows only a handful of other countries including China, Chile, Cuba and the United Arab Emirates that are inoculating vounger children with various vaccines

"As a mother and a physician, I know that parents, caregivers, school staff, and children have been waiting for today's authorization." said acting Food and Drug Administration chief Janet Woodcock in a statement

"Vaccinating younger children against COVID-19 will bring us closer to returning to a sense of normalcy."

The vaccine rollout should begin in earnest after the Centers for Disease Control and Prevention (CDC) convenes a panel on Tuesday to further discuss clinical recommenda-

Pfizer and its partner BioN-Tech announced this week the US government had bought 50 million more doses as it works to protect children, including eventually those under five.

In a clinical trial involving more than 2,000 participants was found to be more than 90 per cent effective at preventing symptomatic disease.

The vaccine's safety was also studied in more than 3,000 children, and no serious side effects have been detected in the ongoing study.

In this age group, the vaccine is given as two shots three weeks apart, dosed at 10 micrograms -- a third what is given to older age groups.

Severe Covid is rarer in children than adults, but far from non-existent

According to the CDC. there have been 8,300 Covid hospitalizations of children aged five-to-11 since the start of the pandemic, and 146 deaths.

There have also been more than 5.000 pediatric cases of multisystem inflammatory syndrome in children (MIS-C), a rare but highly serious postviral complication, including

On Friday, U.N. Secretary-General Antonio Guterres voiced alarm that the climate meeting might see leaders fail to deliver on promises, leaving humanity facing a "calamitous" rise in global temperatures.

# **Prevent Mass Starving** In Afghanistan, UN Aid **Chief Urges G20** Press Trust Of India

Geneva: The UN humanitarian chief had a dire message for leaders of the world's 20 largest economies meeting this weekend: Worry about Afghanistan because its economy is collapsing and half the population risks not having enough food to eat as the snows have already started to fall.

Martin Griffiths said in an interview with The Associated Press that the needs in Afghanistan are skyrocketing.

Half the Afghan children under age five are at risk of acute malnutrition and there is an outbreak of measles in every single province which is a red light and the canary in the

WFP appealed this week for \$200 million to finance its operations until the end of the year, and Griffiths urged countries that suspended development assistance for Afghanistan after the Taliban takeover on August 15, including the United States and European countries, to transfer that money for desperately needed humanitarian aid. He noted that the European Union already shifted about 100 million euros to humanitarian work.

Griffiths said the current crisis is the result of two large droughts in the past few years, the disruption of services during the conflict between the Taliban and the Afghan government and the collapse of the economy

mine for what's happening in society, he said.

Griffiths warned that food insecurity leads to malnutrition, then disease and death, and absent corrective action the world will be seeing deaths in Afghanistan.

He said the World Food Program is feeding four million people in Afghanistan now, but the UN predicts that because of the dire winter conditions and the economic collapse it is going to have to provide food to triple that number, 12 million Afghans, and that is massive.

So, the message that I would give to the leaders of the G20 is worry about economic collapse in Afghanistan, because economic collapse in Afghanistan will, of course, have an exponential effect on the region, he said. And the specific issue that I would ask them to focus on first, is the issue of getting cash into the economy in Afghanistan, not into the hands of the Taliban, into the hands of the people whose access to their own bank accounts is not frozen.

### Syria Says Air Defenses Repelled Daytime Israeli Aggression On Damascus Countryside

Damascus: The Syrian military says the country's air defenses have in a rare daytime strike intercepted missiles fired from the di-

The latest attack came just a few days after the Syrian media said Israeli helicopters had hit three targets on the outskirts of the town of al-Baath as well as other locations in southern Syria.



rection of the Israeli-occupied territories at Damascus countryside.

Citing a military source, Syria's official news agency SANA said Saturday that the Israeli regime launched missiles from the northern side of occupied Palestine and targeted some points in Damascus countryside around 11 a.m. local time.

The source said that the country's air defense systems were activated against "hostile targets from the direction of occupied lands," and a number of the missiles were "repelled."

The source also said the aggression injured two soldiers and caused some material damages.

Syrian state television had earlier reported of explosions heard in the countryside surrounding the capital.

Two of the sites targeted on Monday were observation posts reportedly used by the Lebanese resistance movement Hezbollah, while the third target was a site next to a Syrian military facility. The strikes caused "material damage," but there was no immediate word on casualties.

Israel frequently targets military positions inside Syria, especially those for Hezbollah. which has played a key role in helping the Syrian army in its fight against the foreign-backed terrorists.

The Tel Aviv regime mostly keeps quiet about its attacks on Syrian territories, which many view as knee-jerk reaction to the Syrian government's increasing success in confronting terrorism.

# US Spy Agencies Say They May Never Be Able To Identify Covid Origins

Agencies

Washington: US intelligence agencies said on Friday they may never be able to identify the origins of COVID-19, as they released a new, more detailed version of their review of whether the coronavirus came from animal-to-human transmission or leaked from a lab.

The Office of the US Director of National Intelligence (ODNI) said in a declassified report that a natural origin and a lab leak are both plausible hypotheses for how SARS-COV-2 first infected humans.

But it said analysts disree on which is more likely or whether any definitive assessment can be made at all. The report also dismissed

suggestions that the coronavirus originated as a bioweapon, saying proponents of this theory "do not have direct access to the Wuhan Institute of Virology" and have been accused of spreading disinformation. The report issued on Fri-

day is an update of a 90-day review that President Joe Biden's administration released in August, amid intense political infighting over how much to blame China for the effects of the global pandemic rather than governments that may not have moved quickly enough to protect citizens.

Former Republican President Donald Trump - who lost his bid for re-election as the pandemic ravaged the US economy - and many of his supporters referred to COV-ID-19 as the "China virus.

Some US spy agencies had strongly favored the explanation that the virus originated in nature. But there has been little corroboration and over recent months the virus has spread widely and naturally among wild animals.

The ODNI report said four US spy agencies and a multiagency body have "low confidence" that COVID-19 originated with an infected animal or a related virus.

But one agency said it had "moderate confidence" that the first human COVID-19 infection most likely was the result of a laboratory accident, probably involving experimentation or animal handling by the Wuhan Institute of Virology.

### Iranian Journalist Survives **Kabul Assasination Bid**

Tehran: Gunmen on a motorcycle brandished small arms and fired on a broadcast journalist in his car in the Afghan capital of Kabul late on Friday night, lightly wounding him.

Ali Reza Sharifi, a journalist for Islamic Republic of Iran Broadcasting, survived the attack, Taliban deputy spokesman Bilal Karimi told The Associated Press.

"We are investigating to find the perpetrator," he said. No immediately claimed responsibility for the attack

The assault comes just days after an Afghan media watchdog reported more than 30 instances of violence and threats of violence against Afghan journalists over the last two months, with nearly 90 per cent committed by the Taliban.

# **Needle-Free Covid Vaccine Patches Coming Soon, Say Researchers**

Effective vaccines, without a needle: Since the start of the Covid pandemic, researchers have doubled down on efforts to create patches that deliver life-saving drugs painlessly to the skin, a development that could revolutionize medicine.

The technique could help save children's tears at doctors' offices, and help people who have a phobia of syringes. Beyond that, skin patches

could assist with distribution efforts, because they don't have coldchain requirements - and might even heighten vaccine efficacy.

A new mouse study in the area, published in the journal Science Advances, showed promis-

ing results. The Australian-US team used patches measuring one square centimeter that were dotted with more than 5.000 microscopic spikes, "so tiny you can't actually see them," David Muller, a



virologist at the University of Queensland and co-author of the paper, told AFP.

These tips have been coated with an experimental vaccine, and the patch is clicked on with an applicator that resembles a hockey puck. "It's like you get a good flick

on the skin," said Muller. The researchers used a so-

called "subunit" vaccine that reproduces the spikes that dot the surface of the coronavirus. Mice were injected either

two minutes, or with a syringe. The immune systems of those who got the patch produced high levels of neutralizing antibodies after two doses,

# **Silly Point: On Linking Cricket To Patriotism**



eople who allegedly celebrated the victory of Pakistan against India in a T20 cricket World Cup match brunt of the state. All of them are Muslims. In Rajasthan, a young schoolteacher has been terminated by a private school and the police have charged her under IPC Section 153B for 'imputations, assertions prejudicial to national integration'. In Jammu and Kashmir, the police have registered two cases against unknown persons under the Unlawful Activities (Prevention) Act (UAPA) and other sections. In Uttar Pradesh, three students from J&K have been charged under IPC Sections 153A (promoting enmity between groups), 505 (creating or publishing content to promote enmity) and, later, Section 124A, sedition. The wisdom, propriety or acceptability of celebrating Pakistan's victory is beside the point. From moral, tactical, and practical perspectives, this sweeping policing is unwise. No democracy, least of all a country of India's size and diversity, can demand unyielding uniformity and conformity from its population, on all questions and at all times. It is unlikely that any of these charges will stand judicial scrutiny, but that only makes this spectacle a ridiculous distraction for the stretched law enforcement system. Far from enforcing national integration as the purported aim of this heavyhanded police action is, it will only brew more resentment and social disharmony apart from derailing young lives.

An unremitting loyalty test of citizens can be a selfdefeating pursuit for a country like India that has global ambitions. People of Indian origin live around the world with split loyalties. There are U.S. citizens who chant victory for India at gatherings in their home countries addressed by the Indian Prime Minister, and there are British and Australian citizens who boo their own country in favour of India during sporting events. Sports teams around the world have members of foreign origin. Infusion of toxic hyper-nationalism in sports is bad in such a world; more so for India. While the BJP has been championing this link between cricket and nationalism, other parties are not far behind as the incident in Rajasthan, a Congress-ruled State, shows. AAP in Delhi was one step ahead and questioning the Narendra Modi government for allowing the cricket match with Pakistan. Had all this been on account of an unspoken link between cheering for the national cricket team and support for a united India, the police would have also charged those who mercilessly trolled Mohammed Shami, a Muslim in the Indian cricket team. True, it would have been wonderful for the Indian cricket team to enjoy the unqualified support of the entire nation, but, surely, there is no reason to charge those who support another team with sedition. The Indian state looks silly now, and the whole episode bodes ill for cricket, and the country.

# A Saviour Or A Predator?

Recent Allegations Against Facebook Force Us To Ponder Over The Benefits Of Social Media In Real Terms

he details published by The Washington Post of a misinformation campaign pursued by Facebook against the Covid vaccine, also outlines other irregularities committed by the tech giant. A consortium of media organisations, including The Washington Post, reviewed the information, which was disclosed by the lawyers of Ms Frances Haugen, a former Facebook employee, to the US Securities and Exchange Commission and the Congress.

These documents included the company's internal communications on various aspects of running the app and monitoring the content. The Wall Street Journal had previously reported on some of the pandemic-related revelations in the papers, including how Facebook struggled to police anti-vac-

### The Controversy

According to the information available, Facebook researchers allegedly had deep knowledge of how coronavirus and vaccine misinformation moved through the company's apps. It allegedly itself conducted multiple studies and produced large internal reports on what kinds of users were most likely to share falsehoods about the deadly virus.

However, allegedly this information was not shared timely and properly with the academics and lawmakers though the White House urged Facebook for months to be more transparent about the misinformation and its effects on the behaviour of its users, the company refused to share much of this information publicly, resulting in a showdown with the Biden ad-

Taken together, the documents underline just how extensively Facebook was allegedly studying coronavirus and vaccine misinformation on its platform as the virus tore across the world, unearthing findings that concerned its own employees.

### **MEANWHILE, AMID REPORTS THAT IN THE** current year Facebook has earned \$9bn despite the whistleblower

scandal, came news that Facebook is going to change its name to Meta. Zuckerberg says he's chosen Meta, because of its meaning in Greek - "beyond". It also alludes to the "Metaverse", an online virtual oasis that he wants to build

Yet, in public blog posts and in congressional testimony, executives focused on more positive aspects of the social network's pandemic response, such as how many pieces of misinformation it had taken down and its work to help its users find vaccine clinics near them.

The disconnect between what was known and shared bolsters demands from lawmakers, who are increasingly amenable to proposals to force greater transparency from tech giants, with some directly supporting Haugen's assertion that a separate regulatory body is needed to study algorithms and internal research and keep an eye on the social media platforms.

### **Facebook's Influence**

How Facebook, which is particularly popular with older Americans, has affected perceptions around vaccines has been a key part of discussion about the pandemic. In July, as the disease's delta variant triggered a massive new surge and the rate of new vaccinations levelled off, the White House began placing some of the blame on the social media channels, President Biden told reporters that Facebook was "killing people", though he later backed off

Haugen left Facebook in May, before the public fight between the company and the White House. so it's unclear what kind of information the company had during that time. But employees were looking into the

issue well before the public spat. Employees noted that algorithmic dynamics created "self-reinforcing" feedback loops, where vaccine-sceptical posts were overwhelmingly supported in the comments and reactions. Antivaccine comments got boosted with

many "like" and "love" reactions, while people who posted pro-vaccine content were met with derision in the form of "angry," "sad" or "haha" reactions, the researchers wrote.

Among other things, the reports have claimed that Facebook allegedly sat on research that showed Instagram harmed teenage mental health, and struggled to remove hate speech from its platforms outside the US.

In addition, Frances Haugen who is currently in the UK has told British MPs that Facebook is "unquestionably making hate worse", as the MPs consider what new rules to impose on big social networks.

While talking to the Online Safety Bill Committee in London, Ms Haugen said Facebook safety teams were under-resourced, and also warned that Instagram was "more dangerous than other forms of social media".

She said while other social networks were about performance, play, or an exchange of ideas, "Instagram is about social comparison and about bodies... about people's lifestyles, and that's what ends up being worse for kids. She said Facebook's own research allegedly described one problem as "an addict's narrative" - where children are unhappy, can't control their use of the app, but feel like they cannot stop using it.

The Online Safety Bill Committee is fine-tuning a proposed law that will place new duties on large social networks and subject them to checks by the media regulator Ofcom in the UK.

Ms Haugen also urged the committee to include paid-for advertising in its new rules, saying the current system was "literally subsidising hate on these platforms" because of their algorithmic ranking. And she also urged MPs to require a breakdown of who is harmed by content, rather than an average figure - suggesting Facebook is "very good at dancing with data", but pushes people towards "extreme content".

Ms Haugen also warned that Facebook was unable to police content in multiple languages around the world - something which should worry UK officials, she said. She further said that dangerous misinformation in other languages affects people in Britain and the US also. "Those people are also living in the UK, and being fed misinformation that is dangerous, that radicalises people," she warned.

"When I worked on counter-espionage, I saw things where I was concerned about national security, and I had no idea how to escalate those because I didn't have faith in my chain of command at that point," she told the committee.

Similar problems plague Facebook's Oversight Board, which can overturn the company's decisions on content, she said. She repeated her claim that Facebook has repeatedly lied to its own watchdog, and said this is a "defining moment" for the Oversight Board to

This is not the first time that Facebook has come under criticism and allegations of interfering in other country's internal politics. In the past it has been charged with interfering in two US presidential elections, parliamentary elections in the UK and India and the role played by it during last year's Delhi riots.

### Facebook's Future

Meanwhile, amid reports that in the current year Facebook has earned \$9bn despite the whistleblower scandal, came news that Facebook is going to change its name to Meta. Zuckerberg says he's chosen Meta, because of its meaning in Greek - "beyond". It also alludes to the "Metaverse", an online virtual oasis that he wants to build.

Critics believe Facebook has done this because the brand has become toxic. Further, Zuckerberg seems to be more interested in creating virtual worlds, which he thinks will transform the human experience. However, we'll have to wait and see whether people will go along with it.

But meanwhile questions why Facebook alone amongst all tech and social media giants was targeted have also started being aired. Various anti and pro lobby's are being identified for this but just like whether the Corona pandemic is really a pandemic and not a plandemic, these questions might be answered in the future, by which time we might have experienced the Metaverse.

# Glasgow, Greta And Good Intentions

oth anxiety and hope are increasing in the run-up to the United Nations Climate Change Conference (COP26) in Glasgow. There is anxiety because, barring a handful of the willfully blind, we can all see the damage we are doing to the planet. Fires, floods, and rising sea levels are creating havoc around the world, while environmental destruction and the resulting conflict are triggering large-scale refugee movements that evoke biblical images.

But there is also hope, because some - not least the climate activist Greta Thunberg, with her longstanding and heartening call for more ambitious action - recognize the scale of the challenge facing humanity. In that spirit, the European Union has launched the European Green Deal, which aims to make the EU carbon-neutral by 2050.

Yet, despite these efforts, the fact is that we started out late in combating climate change and now need to accelerate corrective action if humans are not to go the way of the dinosaurs. The climate

crisis is a global issue and requires action from all countries, but many developing economies, including some of the most climate-vulnerable ones, lack the financial wherewithal to do enough on their own. Some emerging economies, including South Africa and much of South and Southeast Asia, are hugely reliant on coal, and will have to undergo a disruptive green transition.

We therefore need a collective commitment to design support systems - financial and scientific - to help all countries do their part. The 2015 Paris climate agreement was a diplomatic success, marshaling the support of almost 200 countries. But the world is falling woefully short of meeting the target – limiting global warming to 1.5° Celsius, relative to preindustrial levels - that was agreed in Paris.

Will the gathering in Glasgow catalyze genuine action? Thunberg recently warned that "the leaders will say we'll do this and we'll do this, ... and then they will do nothing."

Such despair is natural. When we see climate action trail so far behind rhetoric, we inevitably wonder if all the talk is just hypocrisy.

But it need not be. If we want to bequeath a livable planet to future generations, it is crucial to understand why there may be a disjuncture between what each person intends to do and what the group actually delivers. Iconic games like the prisoner's dilemma have shown this to be the case in the domain of selfish decision-making. Mobilizing the determination and commitment needed to address the climate crisis is a problem for the social sciences and moral philosophy as much as it is for

It is therefore a mistake to equate collective action with the sum of individual intentions. When people say they want to do everything to avert climate disaster but do little, this may not be hypocrisy. They may be in the grip of what I have described in a recent paper as "Greta's Dilemma."

In this game, a group of people initially pursue their own interests, with no concern for how the environmental damage caused by their actions will harm future generations. If people then become environmentally conscious


and take corrective action, traditional economic models would predict that such a shift will lead to improvements in future generations' welfare.

But in the complex, strategically connected world that we inhabit today, the outcome may be different. Greta's Dilemma illustrates the paradoxical result whereby individuals who become environmentally conscious collectively do greater damage to the environment. Akin to one of those paradoxical paintings by M.C. Escher, it is the intertwining of small individual steps that lead the group to a destination they did not seek. Far from helping future generations, they end up hurting them.

Admittedly, this game is crafted deliberately to highlight the paradox. But it shows that, in today's complex global economy, we need to devote much greater attention to the strategic foundations of human interaction in order to design policies that can help us turn away from the brink of climate disaster.



Here are some classics that you can reread or just read if you haven't read them before:


Wuthering Heights:

One Hundred Years of Solitude




You thought I was going to go E.M Foster on this list, didn't you?

feminist revision of the classic fairy tale, updating the well-known story to reflect contemporary attitudes towards gender. But Cinderella has always been a feminist text. You might have heard of figures like Charles Perrault, the Brothers Grimm and Walt Disney, each playing a key role in popularising the folk story for a new generation. But behind their versions of the classic fairytale lies an untold story of female storytellers like Marie-Catherine D'Aulnoy and the Comtesse de Murat.


Before the Grimms, these pioneering women were drawn to Cinderella not because they felt the story needed updating or revising, but because they were attracted by the culture that birthed it – a storytelling network created by and for women.

### Cinderella's origins

Cinderella began its life as a folk tale, passed orally from household to household. The earliest recorded copy dates back to China in 850-860. This version of the story probably entered into Euro-

pean society by the women working on the great Silk Road.

At a time when only men could be writers or artists, women used folk tales as a means of expressing their creativity. Female labourers and housewives passed the stories onto one another to dispense shared wisdom, or else to break up the boredom of another working day as they toiled away from the prying eyes of men.

These storytelling traditions echo to this day. It is where we get the notion of the old wives' tale. According to feminist writers like Marina Warner, it is also why we have to come to associate gossip with women. Cinderella reflects these customs. It is a story about domestic labour, female violence and friendship, and the oppression of servitude. Perhaps most significantly, it is a story about female desire in a world where women were denied any role in society.

The precise story of Cinderella has always been in flux. In some, she still has a mother. In others, the stepsisters resort to slicing off their heels to win the heart of the prince. But whatever incarnation, Cinderella has historically been a story about women and for women. So what happened to poor Cinders to make her so powerless?

Well, men. As the story became increasing popular, male writers and artists became interested in adapting the tale. But in doing so, they found in Cinderella not a story of female wish-fulfilment but a more general sense of escapism.

It was Perrault who introduced the famous pumpkin and the glass slipper, giving the tale its two most iconic features. The Grimms turned the stepsisters ugly, as well as removed the fairy godmother in favour of a magical wishing tree. These adaptations reflected unconscious misogyny, stripping the story of much of its feminist potential and making it instead

about enchantment over representation.

### Cinderella goes to the cinema

These traditions continue in Cinderella's cinematic adaptations. The first person to adapt Cinderella for the big screen was the French magician turned film director Georges Méliès. In his hands, the character became little more than a passive, frightened waif, her job seemingly to stand in the corners of the shots and look amazed at the latest special effect appearing on screen.

Decades later, Walt Disney used Cinderella as part of the studio's strategy of mining European folk tales for popular entertainment, a tradition begun with Snow White and the Seven Dwarfs (1937). Released in 1950, Disney's Cinderella reflected the conservative values of US society at the time. The figure of the wicked stepmother took on a supervillainesque quality in the form of Lady Tremaine. While the figure of the stepmother had been the antagonist in most versions of the folk story, Disney's Tremaine was a villain to rank among the studio's many infamous examples of monstrous women. In Disney's hands, an often nuanced character within the original tale was turned into a vivid caricature of feminine power and greed.

The most recent live-action remake starring Cate Blanchett as Tremaine did little to change these preconceptions of the folk tale, as Cinderella became a nostalgic symbol not only for childhood storytelling but for Disney as its most popular storyteller. The role of women in the creation of Cinderella as we know it was lost to animation and special effects.

So what is the moral of the story of this particular fairy tale? If anything, it's that Cinderella is not a story that needs a complete reinvention. Instead, the story needs reclaiming from the hands of those who would dismiss it as just a fairy story or would use it as a vehicle for spectacle at the expense of the story buried beneath.

NEW DELHI: Maruti Suzuki India (MSI) on Saturday said it expects an adverse impact on production at its two plants in Haryana and parent Suzuki's Gujarat plant in November on account of supply constraint of electronic components due to

semiconductor shortage. Terming the situation as quite dynamic, the country's regulatory filing that as per current estimates the total vehicle production volume across both locations in Haryana next month could be around 85 per cent of normal roll-out.

"Owing to a supply constraint of electronic components due to the semiconductor shortage situation, the company is expecting an adverse impact on vehicle

# India To Build Rs 1,200 Crore Ship For Hi-Tech Research, Study On Continental Shelf

CHENNAI: India is all set to build its first deep sea, hi-tech research vessel at a cost of about Rs 1,200 crore for purposes including exploration and it would also be used for efforts aimed at securing for the nation its rightful additional continental shelf, a top official said here on Saturday.

It is the first time that such a deep sea vessel, with advanced capabilities like a feature to send seismic signals into deep ocean depths would be built in India.

The new ship, under the Make in India initiative and the Deep Ocean Mission, is expected to be completed by three years from the date of placing the order, he said.

The ship building yard is yet to be finalised but it is expected to be done by next March. Secretary, Ministry of Earth Sciences, M Ravichandran told journalists on board ORV (Ocean Research Vessel) Sagar Nidhi.

Union Minister of State, Science Technology, and Jitendra Singh on Saturday sailed in Sagar Nidhi from Chennai Port and interacted with scientists on various projects. On Friday, he launched here India's first manned ocean mission 'Samudrayan.'

Sagar Nidhi is a premier research vessel of the National Institute of Ocean Technology.

The new vessel is for purposes including survey and exploration of resources, oceanography and would feature radar, seismic components as well and it could study characteristics of



the sea bed. "We have got approval. We have to initiate now. We have made a design.

An important aspect of the proposed vessel is that its seismic components could send seismic signals to understand the properties of rocks, soil, the overall seabed that would help ascertain presence of minerals, oil, hydrothermal vents and so on, the official said answering a question.

The seismic sensors or equipment may, however, have to be imported, and the utility of the radar includes forecast for

cyclones. The proposed new ship, which would cost about Rs 1000 to Rs 1,200 crore, is also a replacement for the 38-yearold vessel ORV Sagar Kanya.

The Central government had approved the deep ocean mission to be implemented by the Ministry of Earth Sciences at a total budget of Rs 4,077 crore for 5 years.

Ravichandran said that India's continental shelf now extends to 200 nautical miles and to claim beyond that, sediment thickness of about a kilometer (depth) to validate its Indian inland origin has to be established according to the United Nations convention.

Seismic signalling in the proposed ship, to be inbuilt in the hull, would help establish the sediment extension from Indian inland region, he added.

"Now we are trying to establish sediment thickness beyond the 200 nautical miles. We want to prove that sediments has gone from India (including the Himalayas) and that it (indication of seabed/submarine areas) belongs to India," he said.

In the west, "we have already claimed roughly an area corresponding to the size of Maharashtra and Madhya Pradesh.'

# Street vendors have fundamental right but can't impinge upon others' rights: HC

New Delhi: No right is absolute and it needs to be balanced with others' rights, the Delhi High Court observed Saturday, saying street vendors do have a fundamental right but when they use a public way, they impinge on someone else's right to walk.

Hearing a batch of petitions on the Street Vendors Act, 2014, a bench of justices Vipin Sanghi and Jasmeet Singh said hawkers should get proper places to sit and proper kiosks in every market.

"They should have a proper licence. Then you don't have to pay 'hafta' to the police," the court said. The court asked what was the

Ralli, appearing for New Delhi Traders Association, which represents shop owners and operators in the Connaught Place (CP) area, explained to the bench previous judgements on the issue and how the things have proceeded before the courts.

Ralli, along with advocate Mohit Mudgal, while referring to a previous judgment, said no hawker can defeat the rights of other citizens.

When some of the counsel tried to intervene and make submissions, the court said, "We want to first see what judgments were delivered, then in that context we want to see how the Street Vendors Act came about. We do not want to lose our focus."

"This is a dynamic situation. What we are looking at is the Act which came in 2014 and its implementation... There are more and more areas. There may be more people who may be allowed to vend. So we will have to see the Act and the scheme but firstly, the street vending plan has to come, it said, adding that, "We are not coloured by any picture or paint."

# MP: Woman Forced To Undergo 'Purification' For Marrying Dalit Man

Betul (MP): A 24-year-old woman from Madhya Pradesh's Betul district was allegedly forced to undergo a "purification" ritual by her father and other relatives wherein she was forced to take bath in the Narmada river, her hair trimmed and her clothes discarded for marrying a Dalit man, police said on Saturday.

Police have registered a case against the woman's father and three of his relatives on Saturday after the woman lodged a complaint, said Betul Kotwali police station in-charge Ratnakar Hingve.

On Friday, the woman submitted a complaint to Superintendent of Police (SP) Simala Prasad.

The complainant alleged that she had married a Dalit man in March 2020. She said her family members filed a missing person complaint in January 2021, though her father knew about her whereabouts and used to meet her.

### **AIIMS Launches App** To Help Physicians Provide **Care To Stroke Patients**

The neurology department of the AIIMS has launched mobile application, 'SMART-India App', as part of a research project aimed at helping physicians at district-level hospitals provide quality care to stroke patients.

"One of the major challenges is to deliver adequate healthcare in rural India where more than twothirds of India's population live. There is severe shortage of specialists in rural areas with one of the lowest physician/population ratios in the world," Dr M V Padma Srivastava, chief of Neurosciences Centre at AIIMS, said.

There is only one neurologist per 1.25 million population.

Dr Vishnu V Y, Associate Professor of Neurology at AIIMS, said, "Two innovative solutions to this problem include training physicians at district hospital to diagnose and manage acute stroke (stroke physician model) or use lowcost telestroke model. We developed the SMART-India App

providing a low-cost telestroke services of a neurologist and physiotherapist to physicians in district hospitals.

Besides, two other strokerelated initiatives -- IMPETUS and CARE-DAT -- were also launched to improve the quality of life of disabled persons who have suffered a stroke through

newer technological advances. World Stroke Day is observed on October 29.

Centre for Advanced Research and Excellence in Disability and Assistive Technology (CARE-DAT) is a joint research project developed by AIIMS-New Delhi and the Indian Institute of Technology (IIT), Delhi to study the role of assistive technologies in optimizing functional recovery post stroke with special emphasis on hand function and its validation of sustenance and long-term clinical impact, said Dr Suhas Murali, who is do-

ing stroke fellowship at AIIMS. Stroke is the second leading cause of chronic disability and mortality with 102 million disability adjusted life years lost

### **Complaint Against JNU, Organisers Over 'Anti-India' Reference In Webinar**

Delhi-based lawyer on Saturday filed a police complaint against the JNU's Centre for Women's Development Studies and organisers of a webinar, for allegedly using the phrase "Indian Occupation in Kashmir".

Advocate Vineet Jindal, in his complaint to Delhi Police Commissioner Rakesh Ashtana, stated that the webinar titled 'Gender Resistance and Fresh Challenges in Post 2019 Kashmir' was to be organised by the Centre on October 29, at 8.30 p.m. and the details were also available on the JNU website.

"In the subject of the invitation to the seminar, it was mentioned 'Gendered Resistance to Indian Occupation in Kashmir'. By mentioning this phrase, the organisers of the webinar have depicted the forceful occupation of Kashmir by the Indian government and this phrase has questioned the integrity and unity of the country," the complaint read.

It further said the phrase 'Indian Occupation to Kashmir' is clearly perceived to be the forceful occupation of Kashmir by Indian government which is surely not true.

The complaint filed against JNU under section 121A,124 A,505 OF IPC AND 74 OF IT ACT 2008, also attached the screenshot of the proposed online seminar in the petition.

"The phrase also indicates the intention of the organisers that in the pretext of this webinar it was purposefully used to publicise the idea, provoke and instigate people against the Indian government," it stated.

The webinar was cancelled after the protest by certain people as the subject of the webinar was found questionable and objectionable, which clearly proves that the organisers had mala fide intentions against the integrity of the country or some other hidden agenda.

"Kashmir is an integrated part of India just like any other state of India, so calling or publicly popularizing it as an occupied state is an anti-national act, which not only instigates the common man but also provokes communal disharmony among the masses.

"The subject of Kashmir has always been a delicate and sensitive one due to the involvement of the other neighbouring countries who wish to create national discord, so stating the said phrase accounts to an intentional act of creating disturbance among the citizens of the countries and the states which is not acceptable in any manner and must be dealt with an iron hand by lodging FIR against the organisers of the webinar," it added.

### **Novel Drug Treatment For COVID-19 Identified**

esearchers have identified Ra potential new drug treatment that suppresses the reproduction of the SARS-CoV-2 virus, that causes COVID-19, in infected cells. To multiply, all viruses infect cells and reprogramme them to produce novel viruses, the researchers said.

The study, published recently in the journal Metabolites, shows that cells infected with SARS-CoV-2 can only produce novel coronaviruses when a metabolic pathway called pentose phosphate pathway is activated.

The researchers from the University of Kent in the UK and Goethe-University in Germany found that the drug benfooxythiamine, an inhibitor of this metabolic pathway, suppressed reproduction of SARS-CoV-2, and infected cells did not produce coronaviruses.

"This is a breakthrough in the research of COVID-19 treatment," said Professor Martin Michaelis from the University of Kent.

"Since resistance development is a big problem in the treatment

that use different targets is very important and provides further hope for developing the most effective treatments for COVID-19," Michaelis said.

The researchers found that benfooxythiamine also in-creased the antiviral activity of '2-deoxy-D-glucose', another drug that modifies the host cell's metabolism to reduce virus multiplication.

This shows that pentose phosphate pathway inhibitors like benfooxythiamine are a potential new treatment option for COVID-19, both on their own and in combination with other treatments, they said.

The researchers noted that the drug's antiviral mechanism differs from that of other potential COVID-19 drugs such as remdesivir and molnupiravir. They noted that viruses resistant to these drugs may, therefore, be sensitive to benfooxythiamin.
