

## 'Alpine Girl' From Bengaluru Treks To 50 High-Altitude Lakes In Kashmir

SRINAGAR: Braving arthritis, a Bengaluru woman created a record of sorts by trekking to 50 high-altitude lakes, located about 10,000 feet above sea level, in Kashmir within a span of four months, earning the sobriquet of 'Alpine Girl'.

Probably the first female to trek to these high-altitude lakes, Namratha Nandish, who stays in the Bengaluru's Bellandur area, started with Tulian Lake. which is sandwiched between

the Pir Panjal and the Zanskar mountain ranges in South Kashmir's Pahalgam area, and concluded with Shilsar Lake in the higher reaches of the Anantnag-Kishtwar area. Alpine lakes are located above

10,000 feet from sea level. "Nothing was predetermined.

### It all started with an idea of my husband, Abhishek, adding a visit to Srinagar in the previous winters. He wanted to see the frozen Dal Lake," says Nandish. The couple embarked on their

journey to the Kashmir Valley on January 26 and checked into a local hotel.

### THE PEOPLE ARE SO HOSPITABLE AND **WARM** here that I want to spend more and more time with them. I don't feel like going as the people here made me feel one among them."

"I had done my homework and had decided to trek 33 lakes during the season as a birthday gift to myself," Nandish, who turned 33 this year said.

An HR manager in an information technology company, the work from home facility, due to the COVID-19 pandemic, came in handy for her to reach her goal during the trekking season, which started in mid-June. "Work hard and play hard. On

### **Corona Cases** Shoot Up, 165 **Test Positive Observer News Service**

SRINAGAR: Coronavirus cases continue to shoot up in Jammu and Kashmir as 165 more people tested positive for virus on Sunday, even as no fresh fatality was reported from the Union territory during the last 24 hours.

According to the officials, 156 new cases of Covid-19 were reported from Kashmir and nine from Jammu division, taking the number of people infected since the outbreak of pandemic last year in J&K to 33076.

Giving district-wise breakup of positive cases, the officials said that Srinagar reported highest 87 cases, Baramulla 26, Bandipora and Ganderbal 13 each, Budgam 9, Pulwama and Kupwara three each and one new case each

Anantnag and Kulgam districts. Shopian was the only district in the Valley where no fresh case was reported on Sunday. In the winter

capital, officials said, Jammu reported a maximum of

four cases, Doda two, and one new case each was detected from Kathua, Poonch and Reasi districts. Udhampur, Rajouri, Samba, Kishtwar and Ramban reported no fresh cases.

Moreover, 103 more COVID-19 patients have recovered and been discharged from various hospitals including 05from Jammu Division and 98 from Kashmir Division," they said.

The officials also said that no new case of Mucormycosis has been reported today.

## **Policeman Shot Dead In Srinagar**

SRINAGAR: Suspected militants on Sunday shot dead a policeman in Batamaloo area of this capital city.

29-year-old Tawseef Ahmad was shot at and injured by suspected militants from close range outside his home in SD Colony, Batamaloo on Sunday evening, officials said. Ahmad, who sustained serious injuries in the attack, was removed to the nearby SMHS hospital for treatment.

However, the doctors there declared him brought dead.

"He had received a single bullet injury on the left side of his head. He was dead when brought to the hospital," Medical Superintendent SMHS, Kanwaljeet Singh told Kashmir Observer.

Soon after the attack, a joint team of police and CRPF reached the shootout spot and launched a search operation to nab the assailants.

Meanwhile, police in a hand-out issued on Sunday night said that preliminary investigation has revealed that "terrorists" fired upon Constable Tawseef Ahmad Wani, a resident of S.D Colony Batamaloo around 8:15 pm.

"In this terror incident, he had sustained grievous bullet injuries and was shifted to nearby hospital for the treatment, where he succumbed to his injuries and attained martyrdom," he said.

He further said that police has registered a case in this regard under relevant sections of law and investigation is in prog-ress to work to establish the circumstances which lead to this 'terror crime".

The police spokesperson further said that senior police officers reached the spot and the area has been cordoned off and search was going on.

Ahmad's killing is the first casualty in the month of November so far.

### **DGPs Conference To Discuss Kashmir Situation**

NEW DELHI: The internal security scenario in the country, situation prevailing in Jammu and Kashmir, and a key role played by the police during COVID-19 pandemic are some of the issues to be discussed at the annual DGPs and IGPs conference to be held in Lucknow on November 20-21, officials said.

New-age crimes like cyber terrorism, radicalisation of youth and violence perpetrated by Maoists will also be discussed at the top police officers' conference to be attended by Prime Minister Narendra Modi and Union Home Minister Amit Shah.

About 250 officers in the rank of DGP and IGP from all states, union territories and central government will take part in the meet, organised by the Intelligence Bureau (IB)

An overview of the internal security situation in the country will be presented to the Prime Minister and the Home Minister and discussions will be held on how to improve the overall security scenario with more people-friendly initiatives, an official said.

Pakistan-sponsored militant activities in Jammu and Kashmir, the role of police as frontline warriors during the pandemic will be part of the two-day deliberations.

The state police chiefs are expected to share their experiences in handling the pandemic and how the police have helped distressed people during the health crisis, another official said.

According to an estimate, over one lakh police and paramilitary personnel were infected by the COVID-19 in the country and nearly 1,000 of them succumbed to the virus.

Among the infected include about 40,000 paramilitary personnel and 30,000 police officials in Maharashtra, one of the worst hit states in India.

**MBBS in Pakistan: Police Seeks Sanction To Prosecute 8 Persons**

SRINAGAR: The Jammu and Kashmir Police has moved the home department for granting sanction for prosecution against nine people, including a leader of a Hurriyat constituent and an advocate from South Kashmir, in a case related to "selling" of MBBS seats in Pakistan to Kashmiri students and using the money to support and fund militancy, officials said on Sunday.

The case was registered by the Counter Intelligence Kashmir (CIK), a branch of the police's CID, in July last year after receiving information through reliable sources that several unscrupulous per-sons, including some Hurriyat leaders, were hand in glove with some educational consultancies and were "selling" Pakistan-based MBBS seats and seats in other professional courses in many colleges and

universities. At least four people were arrested by the CIK in August and it also named two of their accomplices who are at present in Pakistan and its controlled Kashmir areas.

The CIK, after a thorough investigation, moved the Jammu and Kashmir home department and sought sanction for prosecution against the nine people under the stringent Unlawful Activities (Prevention) Act (UAPA), mandated according to the act.

According to the officials, more evidence has surfaced

during the probe in which it was also found that the money gathered from admissions had been passed on to some miltiant groups as well as secessionist groups for promoting enmity and waging war against the country.

Significantly, the case could come in handy in carrying out with the provisions of banning hardline Hurriyat Conference Hurriyat leaders to avail the "programme", a brainchild of Pakistan's external snooping agency ISI, aimed at incentivising militancy by compensating the family of killed militants by way of providing free of cost MBBS and engineering seats, the officials said.

However, there have been instances where such families were disappointed as mon-

## Low blood pressure linked to increased death risk following stroke

Even though high blood pressure or hypertension has been a well-established risk factor for stroke and for deaths, it turns out that having low blood pressure is just as great a risk factor for death after stroke.

A new study suggests that stroke pa-tients with low blood pressure and non-cardiovascular conditions, such as cancer and dementia, have a higher risk of death after stroke. These findings appear in the journal Stroke. "Lower average blood pressure, measured in the outpatient setting, was associated with increased risk of death after a stroke event. In addition, this higher risk of death appeared to happen particularly in patients who were smokers, or had a diagnosis of cardiac disease, cancer or dementia," explained correspond-ing author Hugo J. Aparicio, MD, MPH, assistant professor of neurology at Boston University School of Medicine and an investigator at the Framingham Heart Study.

Current national guidelines recom-mend treating high blood pressure after stroke, but the timing of this treatment and whether to treat patients in a normal, low or mildly elevated range of blood pressures have been debated.

The researchers identified nearly 30,000 Veteran patients with a first ischemic stroke who had outpatient blood pressure measurements within the previous 18 months prior to the stroke. They divided this group by blood pressure categories and

followed them over time for the outcomes of all-cause and cardiovascular mortality, with the hypothesis that both very high and very low blood pressure values contribute to higher mortality risk.

They found that persons with lower blood pressure had the highest mortality, especially when they looked at a subgroup of patients

with at least one comorbidity of smoking, cardiovascular disease cancer or dementia. "Our study suggests that stroke patients with a history of low to low-normal blood pressures, some 10 per cent of stroke patients, are at high risk of mortality," said Aparicio. The researchers hope that by inves-tigating the factors that contribute to

death after stroke, patients, families and practitioners can better understand and recognize conditions, like low blood pressure, that may predict their health outcomes. "Ideally, this information can encourage better prevention, diagnosis, and treatment of risk factors such as smoking, heart disease, and cancer, so that if a stroke does occur patients have a better chance at recovery and survival," he added.

## **'Sleep Problems Affect Children's Reading Ability'**

According to new research, it has been observed that sleep problems may affect children's reading ability. In the study published in the British Journal of Educational Psychology that included 339 children aged four to 14 years, parents were asked to complete questionnaires about their children's sleep, while the children completed a test of word reading efficiency. Children whose parents reported increased sleep-disordered breathing, daytime sleepiness, and a short time for children to fall asleep (which is generally associated with increased

tiredness) had poorer performance on reading tasks for both words and nonwords.

"Being a good reader is a strong predictor of academic success and improved life outcomes, so we recommend screening children with sleep problems for reading difficulties, and children with reading difficulties for sleep problems," said corresponding author Anna Joyce, PhD, MSc, of Regent's University London.

Anna added, "Screening and treat-ing sleep and literacy difficulties at a young age could help to improve life outcomes for all children."

## **Third Person Succumbs**, **Manhunt On For Two Accused Including Cop**

was among two persons critically injured in a shooting incident here, succumbed to injuries on underway. Sunday, raising the death toll in the incident to three, officials said.

Babar Chowdhary, a historysheeter who had served two jail terms under the Public Safety Act (PSA) in the past, succumbed to injuries while being shifted from GMC hospital to a hospital in Punjab for specialised treatment, the officials said.

### **Testing For Dengue Virus Started At** Srinagar's **JLNM Hospital**



poverty, it is important to unearth the flaws which are rooted deep within the patriarchal society. The stigmatized society has enclosed the women, young girls, and non-binary individuals in a societal prison, in front of the sneering faces of financial pressure, cultural shame, and poor hygiene accessibility.

For example, menstruating young girls are deemed as "eligible" for marriage, resulting in child marriages. Due to the lack of adequate sex education most people are not comfortable to talk about periods. As a result, the taboo embracing it hugs this issue tighter.

Period poverty also follows when a poverty-stricken household cannot afford sanitary pads and instead has to use alternatives. The price lapanies richer, and the poor poorer.

To combat period poverty, we have to dismantle and destroy the taboo and stigma that have had society in their grip for generations. However, eradicating the pink tax on sanitary pads cannot alone solve this problem.

To build some traction against period poverty, it is imperative to arm pre-adolescent boys, girls, and their peers and knowledge about menstruation and why it is a vital part As the "pink tax" lurks in- of a woman and a girl's health so that they can manage their periods with confidence.

all know that guilty feeling when we realise we have let something go mouldy, and hastily move it from the refrigerator to the rubbish bin. We have seen food recall notices at grocery stores following manufacturing errors. It is easy to assume such mistakes and mishaps are the main causes of food waste. But food waste is not only caused by forgetful consumers and accidents in food supply chains. In fact, food systems research has shown that food waste is a core, and even profitable, feature of food systems today. But as it is so often the case with environmental hazards, the profit motive trumps preventive action, and the is-/aste is only superficiall\ addressed. Industrial food systems create industrial-scale food waste. Currently, up to half of the food produced globally is never eaten, representing a whopping 8-10 percent of global greenhouse gas emissions. None of us wants to think that our food systems might be designed to be wasteful, especially given that the world's resources are being depleted at an alarming rate, and that up to a quarter of our fellow humans are going hungry. The abundance of calories produced by our food systems (in the United States, up to 4,000 calories per day for each person) presents a glaring contradiction to the scarcity and hunger manufactured alongside it. For decades, food companies have been donating their excess to charity in an effort to resolve this contradiction, but neither food waste nor hunger has been significantly decreased as a result of these efforts. Is the answer, then, just to urge companies to redistribute more surplus, and perhaps tweak their supply chain processes a little harder? The messaging of this year's United Nations' Food Systems Summit (UNFSS) would suggest as much. The summit, held in New York on September 23, envisaged setting the stage for "global food systems transformation



That so much food is being wasted while so many are going hungry is an undeniable sign that our economies of food are lacking justice. But it is misguided to suggest the problems of hunger and food waste can simply be resolved if we invest more in food redistribution.

to achieve the Sustainable Development Goals [SDGs]".

SDG Target 12.3 aims to halve global food waste by 2030. Achieving this goal would require eliminating waste from farm to fork, but solutions on offer tend to be focused on "downstream" consumer and retail food waste rather than "upstream" waste prevention in the food supply chain.

The UNFSS continued this trend. The summit's Action Track 2, titled Shift to Sustainable Consumption Patterns, focussed partially on the issue of food waste. But it stated "eliminating wasteful patterns of consumption" and "building consumer demand for sustainably produced food", as the main goals in this arena, rather than addressing root causes of wastage.

Investigative research and campaign group Feedback Global's executive director, Carina Millstone, blames the summit's shortcomings around the issue of food waste and the tood system in general on the disproportionate role corporations played in its organisation.

corporations control the conditions of trade, including prices, aesthetics, cancellation and volumes. Farmers. especially those growing monocultures, are therefore pressured to meet strict buyers' requirements, and overproduce.

Despite all this, the UNFSS showed a preference for public-private partnerships employing a voluntary "targetmeasure-act" approach to food waste reduction over regulatory intervention that can more effectively tackle food waste, but that may threaten profitability. While we applaud companies that are making investments in reducing waste across their supply chains, the UNFSS's limited framing of food waste downplayed the scale of transformation and solutions needed to achieve a genuinely sustainable and fair food system.

That so much food is being wasted while so many are going hungry is an Share campaign, tackling root causes of food waste and hunger means tackling global wealth inequalities while preventing further corporate control over our food sources.

Emily Mathiesen of FIAN International notes that "[the UNFSS] overlooked structural inequalities and human rights abuses that perpetuate food insecurity and hunger".

What would a genuinely fair and sustainable food system transition look like? Many farmers, Indigenous groups and social movements who boycotted the UNFSS are calling for policy mechanisms that support diverse and smaller-scale food production and stronger Right to Food legislation. Foregrounding the values of agroecology and food sovereignty, such policy envisages a circular food economy that protects farmer livelihoods and designs waste out, while valuing food as a right rather than a

However, companies which have labelled women and free sanitary pads and other girls through the colour "pink" menstrual hygiene products through the pink tax have to make them accessible and made it financially distressing convenient for the women and for menstruating individuals to girls in society. afford their basic human needs. Even though many countries have banned the pink tax and many families cannot afford menstrual products and use uproot the social stigma and old clothing, according to Unicef.

## A dangerous 'truce'

...A little over a month ago, Prime Minister Imran Khan had revealed in an interview to Turkish state television that Pakistan was already in talks with some factions of the militant group also known as the Pakistani Taliban. These talks have apparently led to 'results' and the government is set to release up to two dozen "foot soldiers" - whatever that term means in the context of a dangerous terrorist outfit that has killed tens of thousands of people in the country. Indeed, the "just a spate of attacks" the prime minister had referred to in that interview has not ceased, with security personnel being frequently targeted.

The TTP's bloodletting cannot be whitewashed. Neither can the government afford to turn a blind eye to the group's predilection for violating peace deals as the past has shown. What assurance do our rulers have that an organisation which left no stone unturned to carry out ferocious attacks against all - the military, government officials, ordinary people – and that has been accused of colluding with RAW is just a misguided force that is now willing to tread the path of reform? What guarantee can they give that the release of those they see as minor operatives won't be a precursor to amnesty for top-ranking TTP commanders and masterminds? Indeed, what evidence do they have that the truce just agreed to will last?

It is true that political unrest and dire economic circumstances at home, as well as an unstable situation in Afghanistan, have made Pakistani officials doubly anxious to resolve the TTP challenge. Across the border, the Afghan Taliban, a nationalist force that fought against the recent foreign occupation of Afghanistan, face greater tests as they grapple with the task of governing a war-torn country. Besides they may feel beholden to the TTP, with whom they share tribal links, for having sheltered them when they were driven out of their country post 9/11. That may explain their role as mediator. But is this exercise, shrouded in such secrecy, the way to a durable solution?

Millstone was part of the food waste working group of Action Track 2, but she says she realised early on that the group was dominated by a "handful of organisations intent on promoting voluntary, business initiatives and citizen action for food waste above all else". Like hundreds of others that boycotted the summit, Feedback Global, which has worked on food waste issues since 2013, stepped aside "as it became clear the recommendations would skirt around identifying and addressing the root causes of food waste - profit-driven corporate agribusiness".

Research has already identified these root causes. Several studies have shown that large-scale food waste is an inevitable outcome of the competition, speed, and growth-driven market mechanisms which rely on overproduction to generate profit at the expense of people and the environment.

At the farm level, research by Feedback Global showed how unfair trading practices and power concentration in food systems allow major agribusinesses to transfer the risks and costs of food waste to farmers. The consolidation of the manufacturing and retail sectors ensures that large food

undeniable sign that our economies of food are lacking justice. But it is misguided to suggest the problems of hunger and food waste can simply be resolved if we invest more in food redistribution.

The UNFSS presented the redistribution of surplus food as a "gamechanging solution" to food waste, with the Global Foodbanking Network positioned as exemplifying best practice in charitable donation.

However, promoting the global expansion of charitable solutions like food banks cannot fix the underlying economic inequalities that produce hunger. In what food security expert Andrew Fisher calls the "hunger industrial complex", food waste, hunger and corporate interests collide to maintain the status quo. Beyond the laudable efforts of thousands of volunteers, extensive corporate sponsorship of the global expansion of food banking hints that this model is not about transforming and preventing wasteful systems, but primarily managing, perpetuating and even justifying excess.

Moreover, research shows that food charities in many countries often struggle to handle large-scale donations due to a lack of sufficient storage, cooling and transport infrastructure.

As the global advocacy group This Is Rubbish highlights in its Plenty To

We celebrate the inclusion of regenerative food futures, particularly agroecology and food sovereignty, in the UNFSS's messaging. Thousands contributed to pre-summit consultations with alternative food system visions that prioritise ecological boundaries, equitable food access, and demodratic participation. But these must not become corporate greenwashing. We join other scholars, activists, and food actors in challenging the inertia and narrow lenses that prevent governments and businesses from addressing waste and hunger at their roots. We hope that future international dialogues will do this.



## Are Hydropower Dams The Clean Source Of Energy?

The dams are drivers of climate change as they emit methane that is over 28 times more potent than carbon dioxide, say studies.

month before the United Nations Climate Change Conference began in Glasgow, more than 300 organisations across 69 countries urged governments not to use climate funds for "false climate solutions" such as new hydropower dams. They urged that these dams be removed from all the Nationally Determined Contributions targets pledged under the 2015 Paris Agreement that aims to combat global warming.

The appeal included 26 environment groups from India, which has been promoting hydropower projects in the belief that they are clean and sustainable. Environmentalists point to studies (here and here) conducted in the past decade that have shown that hydropower dams are major emitters of methane, a greenhouse ane. Research also shows that reservoirs experience more fluctuation in water levels than natural lakes, and a fall increases the amount of methane released into the atmosphere.

India's push for hydropower projects as an environment-friendly option is thus misguided, said Shripad Dharmadhikari, an analyst at the research organisation Manthan Adhyayan Kendra. "But unlike coal where emissions are proportional to the capacity of the thermal plant, in hydropower dams, the methane emission differs between plants. In the Himalayas, one suspects that emissions would be high because a lot of environmental degradation has taken place because of dams."

In a Lok Sabha reply in March, the Minister of New and Renewable Energy RK Singh claimed that one of the measures the government took to transition away from coal to clean energy was by declaring hydropower dams as renewable energy sources. vironment Research and Action Collective.

"Most hydropower plants in the Himalayan region fall in climatically vulnerable and ecologically fragile regions of Kinnaur, Chamba or Lahaul-Spiti. These run-of-the-river dam projects involve large-scale construction on both the surface as well as underground, with drilling machines [being used] on an already vulnerable terrain," Asher said. "This has escaped environmental scrutiny at multiple levels."

Large dams have also failed to rehabilitate the communities they displaced. The Pong dam, one of the several large dams built in India in the 1970s, the Hirakud dam, independent India's first large dam project and the Sardar Sarovar dam on the Narmada River are all projects where the rehabilitation of those displaced remains incom-

In 2019, India declared large hydropower plants as "renewable energy" resources – earlier, only projects smaller than 25 MW were deemed as renewable energy resources – thereby providing incentives to developers such as easier debt repayment terms and funding for associated infrastructure like roads and flood defences.

In August, the environment ministry also recommended restarting the construction of seven under construction hydropower plants in the Himalayan region that had been halted for various reasons.

Experts have, however, pointed out that hydropower dams pollute and also precipitate natural disasters. "The idea of clean, green, sustainable hydropower, as an alternative to coal, has no truth to it," said Himanshu Thakkar from the South Asia Network on Dams, Rivers and People, one of the signatories to the appeal.

A Supreme Court-appointed committee looking into the 2013 floods in Uttarakhand's Kedarnath area, which is believed to have killed 5,000 people, had asked for proper environmental studies on hydropower development in this "disaster-prone" region. It argued that these dams significantly amplify the damage caused by natural disasters.

India has 4,407 large dams, the third-highest number in the world after China (23,841) and the United States (9,263), with an installed hydroelectricity capacity of 46 gigawatt, which would suffice to provide nearly twice the daily peak power demand of Maharashtra. Most of this (112 gigawatt or 78%) is concentrated in the northern Himalayan states. Further, 38 large hydropower projects are under construction as of November 2020.

India has set an ambition of installing 450-gigawatt renewable energy capacity by 2030, so far it has installed 146-gigawatt that includes large hydro (31%), solar and wind capacity (69%).

#### Methane emissions

How do hydropower dams become sources of methane emissions? According to studies, decaying vegetation beneath the reservoirs generates emissions.

Also, rivers flowing into reservoirs deliver not only significant amounts of organic matter and sediment from upstream but also nutrients like nitrogen and phosphorus from agricultural activities, fertilisers and human waste, driving algae growth and providing more material for microbes to break down and convert to meth"In 2000, the World Commission on Dams, a global multi-stakeholder body established by the World Bank, was the first to investigate the effectiveness and performance of large dams around the world," said Thakkar. "The body concluded that dams are not environmentally friendly and there are enormous financial, environmental and human costs associated with them."

While methane emissions are second to carbon dioxide in contributing to global warming, its warming effect is 28 times-34 times that of carbon dioxide, we reported in August. Further, greenhouse gas emissions from reservoirs are 29% higher than previously estimated, and "much of the increase in emissions comes from previously unaccounted for methane degassing, a process where methane passes through a dam and bubbles up downstream", according to an analysis by scientists at Washington State University and the University of Quebec at Montreal.

#### Socio-economic impacts

During the Chamoli disaster in Uttarakhand in February, large glacier chunks had fallen 1,800 metres from the Ronti Peak in the upper Himalayas and cascaded down the mountain. This had then mixed with rock and sediment, resulting in a massive debris flow that destroyed roads, bridges and hydropower dams. Nearly 200 people lost their lives in this disaster.

"Our understanding of what is 'clean' comes from a very limited and narrow notion that dams do not emit smoke," said Dharmadhikari of Manthan Adhyayan Kendra. "But large dams have caused much larger social and ecological damage like deforestation, loss of biodiversity and displacement of communities that are often neglected."

In India, a slew of run-of-the-river hydropower projects – which, unlike conventional dams, do not have large reservoirs and thus exert less strain on the immediate environment – were built from 2000 onwards. These were driven by subsidies for the private sector available through the UN Clean Development Mechanism under the Kyoto Protocol, an international treaty that commits states to reduce greenhouse gases, said Manshi Asher, a researcher at the Himdhara Enplete, we reported in December 2020.

Several projects have also been aborted or delayed because they are entangled in land conflicts, forest and environmental clearance issues, rehabilitation and resettlement issues, geological uncertainties, funds constraint, and so on, as per the Standing Committee report on energy submitted in Lok Sabha in August. The committee further noted that the time overrun in 24 hydropower projects currently under construction ranges from 12 to 189 months and cost overruns up to 473%.

"The Indian private sector has refrained from building hydropower plants because it is economically non-viable given the large investments," said Thakkar. "But public sector units have been stepping in to carry on these projects." In September, the public sector company NHPC Limited offered to take over four hydropower projects of 6,000 MW capacity from private companies.

#### Available options

The main purpose of hydropower dams was to balance the grid because of the intermittency of renewable energy supply. "A lot of existing hydropower dams are not performing that function," said Dharmadhikar of Manthan Adhyayan Kendra. "They are running all the time rather than on peak load to balance the grid. With cheaper, more reliable and more environmentally benign alternatives such as hydrogen storage and battery storage systems available, we will not even require dams anymore."

In October, the power ministry invited suggestions for creating a comprehensive policy on energy storage that would "absorb the largescale integration of the renewable energy into the system during the coming years". Renewable energy is intermittent and can cause the grid to trip, so backup power is needed and stored hydropower is being promoted as a potential solution.

India's 1,115 ageing dams, over 50 years old by 2025, are becoming more expensive to maintain and less functional due to sedimentation. India must conduct a cost-benefit analysis of these dams, and conduct timely reviews of their operational and ecologicalical safety, as well as the safety of those living downstream, we reported in February.

We sought comments from the Ministry of Power on why large hydropower dams were declared as renewable energy projects given their socio-economic and environmental costs. We will update when we receive a response.

### **Prisoner Dies, 30 Cops** Injured In Clash At UP Jail

FARRUKHABAD: A prisoner was al-legedly killed and about 30 policemen injured in a clash at a district jail here on Sunday after the death of another man due to dengue.

prisoners allegedly The hurled stones at the policemen and started a fire in the jail after hearing about the death of an inmate, identified as Sandeep Yadav, in Saifai Medical College due to dengue.

The police, however, claimed that another prisoner, Shivam, who died later, was also suffering from an ailment and lost his life while being taken to the hospital on Sunday.

But in a purported video which surfaced on social media, Shivam claimed before his death that he suffered a bullet injury.

The incident took place on Sunday morning, when the inmates started pelting stones at the policemen after they learnt about the death of Yadav, who was admitted to Saifai Medical College a few days ago as he was suffering from dengue.

The video purportedly showing Shivam claiming that he was hit by a bullet fired by the jailor while he was trying to close the gates of the barrack surfaced later in the afternoon.

"Around 8.45 am, the district jail officials requested for police force. On reaching the jail, senior officials learnt that one Sandeep Yadav, who was undergoing life imprisonment in a dowry case since 2012, had got infected by dengue on November 5. He was referred to Saifai Medical College, where he died yesterday (Saturday). Today, when tea was given to the inmates around 8.30 am, they attacked the deputy jailor.

"Subsequently, there was stone pelting and arson in the

barrack, and this was done by inmates with a criminal mindset. The police force then managed to control the situation. In this, 30 policemen were injured, and the deputy jailor, too, was attacked by the inmates," Superintendent of Police Ashok Kumar Meena told reporters earlier in the day.

A fire brigade had to be called after the inmates resorted to arson. Heavy police force was deployed to control the situation, police said.

Director General Jail Anand Kumar, when contacted, told PTI, "The DIG Jail is conducting an administrative inquiry. Judicial inquiry as per CrPC will also take place since an inmate has died in the incident in the jail."

District Magistrate Sanjay Kumar Singh said the guilty be punished after will investigation.

Deputy Inspector General (Prisons) VP Tripathi arrived at the jail in the evening and said the entire matter will be investigated and action will be initiated against those found guilty.

Meanwhile, addressing the 'Janadesh Maharally' held in Ambedkarnagar district on Sunday, Samajwadi Party president Akhilesh Yadav highlighted the incident, and

said, "Those who were running the 'thoko neeti' (encounter policy) did not know who is killing whom. Is this called law and order, when the son of the Union minister of State for Home, runs his vehicle over farmers. Today in Fatehgarh (Farrukhabad) jail, the inmates did not know whom to 'thoko', and they in-

jured the (deputy) jailor.

ITBP Deploys Own Engineering Wing To Construct India-China Border Roads, Foot Tracks

NEW DELHI: The Indo-Tibetan Border Police (ITBP) has taken a first-time decision to deploy its specialised engineering wing for constructing certain roads and foot tracks along the Line of Actual Control to speed up connectivity projects with its posts in Ladakh and Arunachal Pradesh. The move, which was ap-

proved by the Union home ministry, comes amid a military standoff with China in the eastern Ladakh area.

Official sources told PTI that the border force, ITBP, has taken up the "challenge" to construct four out of the 32 roads under phase-II of the India-China Border Roads project and two out of the total 18 foot tracks sanctioned to it by the government.

They said the roads of varying lengths of about one to two kilometres, connecting ITBP border posts in the Himalayan ranges, are in the Ladakh region's 3,488-km-long Line of Actual Control (LAC) with China while the foot tracks, which are used by troops during patrols, are in the Arunachal Pradesh area.

The engineers and supervisors of the ITBP wing will "plan and monitor" the entire work, and a ground force comprising labourers and masons will be hired according to

government norms, sources said. Traditionally, road construction projects along these areas are carried out by the Border Roads Organisation (BRO), the Central Public Works Department (CPWD) and other such agencies. Officials said the engineering

wing of the force, an essential component of the ITBP since its raising in 1962, has been roped in for the

task in order to speed up the border posts connectivity work.

In these high-altitude and remote areas, getting contractors and construction workers is not that easy and hence, the work of border road construction remains slow, an officer explained.

The government has stressed on the need to ensure connectivity through roads so that rations, transportation of troops and other logistics along the LAC can be easily moved. Therefore, this maiden attempt of engaging the ITBP engineering wing has been made, he said.

The ITBP engineering wing, restructured over the years, is tasked to "take care of the construction of operational structures, including border outposts, residential and office buildings, solar lightings, power units and water heating systems, improvised micro-hydel power projects and green houses in snow-clad border areas apart from devising strategic defences around a border post.' Currently, the government

has initiated the phase-II of the

India-China Border Roads (ICBR) project that covers several roads, foot tracks and border posts.

The first phase of ICBR was launched in 2005 under the overall supervision of the Ministry of Home Affairs (MHA) and work on a number of roads, helipads and troop bases of this period is underway.

According to official data, 538.50 kilometres of road have been laid along the China border till November last year. Union Minister of State for Home affairs Nityanand Rai had recently said during the 60th ITBP raising day on October 24 that the process to sanction new border battalions for the ITBP is in the "last stages".

He was referring to the last year central government sanction of 47 new border posts and a dozen staging camps (operational bases for troops undertaking border patrol) to the mountain-warfare trained paramilitary force. The about 90,000 personnel-strong ITBP was raised in the aftermath of the 1962 Chinese aggression.

Since 2014, these conferences have a twin focus of national security as well as core policing issues, including prevention and detection of crime, community policing, law and order, improving police's image, etc., the official said.

Earlier, the conference was Delhi-centric with officers coming together only for the conference. Residing in the same premises since 2014, over a period of 2-3 days, has served to build a heightened sense of unity amongst officers of all cadres and organisations. Direct interaction of the top brass of police with the head of government has resulted in convergence of views on crucial challenges faced by the country and emergence of doable recommendations, the official said. In the past few years, the topics have been selected after detailed discussions with the highest echelons of the police service. Once selected, several iterations of presentations are made before committees of DGs in order to encourage participation and to incorporate ideas from the field and from younger officers.

whip in August and arrested Bhat and three others for "selling" MBBS seats in Pakistan to Kashmiri students and using the money to support and fund militancy.

During the probe, it surfaced that MBBS and other professional degree related seats in many cases were preferentially given to those students who were close to family members or relatives of killed militants.

There were also cases where the quota allotted to individual Hurriyat leaders were sold to anxious parents who wished their children to have MBBS and other professional degrees in one way or the other.

More than 80 cases were studied in which either the students or their parents were examined for academic years between 2014-18.

Searches were undertaken in about a dozen premises in the Kashmir Valley.

The officials said that Bhat's brother Altaf Ahmad Bhat and another arrested person's brother Manzoor Ahmad Shah, were coordinating from across the border and facilitating the admissions.

The two, who have been named accused in the case, had exfiltrated to Pakistan during the early 1990s for arms and ammunition training and have settled down on the other side.



"At our voluntary women's initiative, we have been promoting outdoor activities for women and coming across Namratha was such a motivating moment," Rashid said.

Nandish feels nostalgic as she packs her bags for her return journey to her hometown but is happy that she is being referred to by the trekking community as 'Alpine Girl'.

"I have trekked around 460 kms over 31 days during this year's season and that too when I had a full-time job at hand," she said.

She said she wanted to do only 33 lakes as a birthday gift to herself but then "yeh dil mange more (the heart desires for more), I decided to reach the feat of 50 lakes.

Nandish, who was a hesitant traveller to Kashmir initially, is now reluctant to leave. "The people are so hospitable and warm here that I want to spend more and more time with them. I don't feel like going as the people here made me feel one among them," she said.

Today Nandish, after performing several solo trips to Alpine lakes, feels that she is a much more confident woman.

'During my last visit I suffered Acute Mountain Sickness (AMS) as the height was around 13,000 feet at Murgan top. But then my inner strength and support of Tahir and my family made me achieve it.

She, however, carries a regret that not many women are involved in he trekking business in the Kashmir valley and also agreed with the thoughts shared by Mantasha that more and more participation should be encouraged.

"Kashmir is a wonderful tourist destination and involving more and more women as guides to trekking groups would definitely increase the number of women visitors into the valley and this can become an alternative business for the local women in the valley," she opined.

### **Policeman Shot**

In the last month, 20 militants, 12 soldiers and 13 civilians were killed in different militancy related incidents, including encounters and targeted killings.

The killing of 13 civilians in a month, most of them nonlocals, is the highest death toll in the last two years and the fourth-highest since 2012.

Majid Gojri, of Chattabal was the first civilian to fell to bullets on October 2.

Two days later, three more people were shot dead by unidentified gunmen in Srinagar and Bandipora districts.

Among the deceased was prominent pharmacist Makhan Lal Bindroo, Virendra Paswan, a street vendor from Bihar and Muhammad Shafi alias Sonu, the president of Sumo Stand Haiin.

On October 7, Supinder Kour and Deepak Chand, both government school teachers, were killed in a brazen broad daylight attack in the Eidgah area of the Old city

## **Increased Temperatures Can Contribute To More Cases Of Kidney Disease: Study**

he world's largest study of the link between temperature changes and kidney disease has revealed that 7.4 per cent of all hospitalisations for renal disease can be attributed to an increase in temperature.

The findings of the study were published in 'The Lancet Regional Health - Americas' journal.

In Brazil - where the study was focused - this equated to more than 202,000 cases of kidney disease from 2000-2015

The study, led by Professor Yuming Guo and Dr Shanshan Li, from Planetary Health at Monash University, for the first time, quantifies the risk and attributable burden for hospitalisations of renal diseases related to ambient temperature using daily hospital admission data from 1816 cities in Brazil

The study comes as the world focuses on the impact of climate change at the COP26 conference in Glasgow from October 31.

In 2017, a landmark article in 'The Lancet' declared renal diseases a global public health concern, estimating that almost 2.6 million deaths were attributable to impaired kidney function that year. Importantly the incidence of death from kidney disease had risen 26.6 per cent compared to a decade previously, an increase that this study may indicate was, in part, caused by climate change.

The study looked at a total of 2,726,886 hospitalisa tions for renal diseases recorded during the study period. According to Professor Guo, for every 1 degree Celsius increase in daily mean temperature, there is an almost 1 per cent increase in renal disease, with those most impacted being women, children under 4 years of age and those 80 years of age.



The associations between temperature and renal diseases were largest on the day of the exposure to extreme temperatures but remained for 1-2 days post-exposure

In the paper, the authors - who are also from the University of Sao Paulo - argue that the study "provides robust evidence that more policies should be developed to prevent heat-related hospitalisations and mitigate climate change. In the context of global warming, more strategies and policies should be developed to prevent heat-related hospitalisations."

The authors advise interventions should be urgently incorporated into government policy on climate change, including particularly targeting specific individuals, including females, children, adolescents, and the elderly, as they are more vulnerable to heat with regard to renal diseases.

'Moreover, attention should be paid to low- and middle-income countries like Brazil, where reliable heat warning systems and preventive measures are still in need," Professor Guo added.

## **Urban Planning Might Affect Cognitive,** Motor Dev In Children: Study

new study from the Barcelona Institute for Global Health (ISGlobal), a centre supported by the 'la Caixa' Foundation, has provided further scientific evidence of the health benefits of well-designed urban planning.

The study published in Environment International suggests that the built environment, green space and air pollution can affect cognitive and motor function in children.

According to numerous studies, the urban environment can influence neurodevelopment from conception onwards, for example through exposure to air pollution. However, previous research has not evaluated the impact of multiple exposure groups simultaneously using an early-life exposome approach.

A team from the European HE-LIX project, coordinated by ISGlobal, set out to analyse the impact of 13 urban exposures on the cognitive and motor function of nearly 5,500 children in seven European urban areas--Bradford, United Kingdom; Nancy and Poitiers, France; Gipuzkoa, Sabadell and Valencia, Spain; and Heraklion, Greece--using data from the birth cohorts Born in Bradford, EDEN, the INMA Environment and Childhood Project, and RHEA, respectively.

The new study analysed urban residential exposures from pregnancy until age three years. The analysed factors include the built environment (building density, proximity to public transport, facility richness, etc.), natural spaces, and air pollution from nitrogen dioxide (NO2) and fine particulate matter (PM2.5). Cognitive function (verbal and non-verbal abilities) and motor function (fine and gross motor functions) were assessed using validated tests when the children were four to five years old. The findings showed that exposure to some built environment design factors, natural spaces and air pollution was associated with children's cognitive and motor function at five years of age. Specifically, higher exposure to greenness within 300 metres of the home during pregnancy was associated with higher verbal abilities. In contrast, greater connectivity (density of street intersections) and land-use diversity during pregnancy were associated with lower verbal abilities.

"The health of the population--especially the most vulnerable groups, such as children--should form the basis of urban planning," she concluded.

DUBAI: Bangladesh and Afghanistan were assured of a direct entry into the Super 12s in next year's T20 World Cup in Australia but two-time champions West Indies and former winners Sri Lanka will have to play the additional qualifying round.

The automatic qualifiers for the Super 12 stage next year were determined to be the winner and runner-up of the ongoing T20 World Cup, alongside the next six highest ranking teams.

Going into Saturday's action, the current top six teams on the basis of rankings -- England, Pakistan, India, New Zealand, South Africa, Australia -- had they would not slide out of those positions at the cut-off date of November 15.


