## 'Stay Home' Syndrome Returns As Cold-Covid Leaves Kashmir 'Breathless'

ying on a hospital bed in the SMHS triage ward, Sahil Gulzar, 24, from Pattan, Baramulla is breathing with the artificial air of an oxygen cylinder.

Sahil has a ventricular septal defect (a hole in his heart). With this life-threatening condition, his daily life gets paralysed during winter.

As winter comes with the baggage of viral flu stretching from the common cold to increasing the risk of Covid nowadays, breathing problems get more aggravated in the valley.

The great drip in his oxygen levels leaves Sahil to survive on artificial support frequently for more than three months every year.

"Summertime is far better than winters," said his sister, sitting beside him. "His condition is stable. But winter is hard for the whole family."

Doctors have ruled out surgery for him and have strictly advised Sahil to avoid going out during winters.

With Sahil's already serious situation, Covid was an add on, due to which he has to stay indoors through the year.

Not only Sahil but there're thousands of people in the valley for whom winter is bad news. One among them is Saima Shah, an asthmatic patient from Srinagar. Saima has been diagnosed with asthma four years back, which for her was not sudden as it is an inherited disease.

"My mother has been an asthmatic patient and my father also has breathing issues," says Saima. For asthma sufferers, winters



have always proven to be the worst period of the year. And Saima has been a first-hand witness of it as she has seen her mother suffering more during the cold season due to asthma

since childhood. But now the scenario has changed as she, no longer, is a witness but herself a sufferer. "In winter my condition gets deteriorated due to the shifts in the weather as it irritates my airways," expressed Saima.

She's on medication and has been taking proper precautions. Earlier she used to take inhalers. She believes that if proper precautions are taken, a patient to some extent can be stable during winters. "Also, me and my whole family every year take flu shots as recommended by our doctor," said Saima.

Apart from all other precautions, taking flu shots is a vital part of the survival game. "For patients with lung-related diseases flu shots are a must. It's an extra layer of protection for them," said Dr.Suraya A. Farooq, Associate professor, GMC Srinagar.

But now, for patients like Saima and her mother, Covid-19 has proven to be the last straw.

"Covid-19 situation has increased our fears a lot." expressed Saima's mother."We've taken precautions more than needed, but the constant fear is always lingering in our lives." Dr. Suraya added that

patients who have suffered from Covid-19 earlier are at a high risk of getting post-Covid fibrosis. For which she suggested such patients mostly stay indoors.

The already distressing situation has increased due to the Covid scenario. People with underlying conditions now have to take Covid precautions alongside their own precautions. One such person is Rabia, a tachycardia (fast heart rate) patient.

Rabia suffers from breathing problems throughout the year, but her problems increase to a great extent during winters.

"I have already been suffering from breathing issues and now wearing masks is an add on. It gets suffocating to wear a mask but one can't help it," says Rabia. Winters have never been Rabia's favourite

## **DHSK** walks a mile ahead, orders transfer of MS LD hospital

#### Agencies

Srinagar: An order of transfer of Medical Superintendent LD hospital issued by Director Health Services Kashmir has raised eyebrows as it said that order is an intrusion into the area of responsibility of Principal GMC Srinagar.

Dr Shahir Ahmad Sidiqui, Consultant Anaesthesiology, presently looking after the charge of the post of Medical Superintendent, Lal Ded Hospital, Srinagar is transferred and is directed to report in the Directorate of Health Services Kashmir for working as Nodal Officer for the establishment of Intensive Care Units (ICUNICU/PICU) in all the District Hospitals of Kashmir Division." Reads the order issued by Director health services of Kashmir on dated November 10.

Dr Muzaffar Hussain Sherwani, Medical Officer, presently looking after the charge of the post of Medical Superintendent, District Hospital, Budgam is transferred and posted in Lal Ded Hospital Srinagar. "He shall also look after the charge of the post of Medical Superintendent, Lal Ded Hospital, Srinagar till regular arrangement is made. Dr Mohd Ayoub Fateh Khan, Medical Officer, District Hospital Budgam shall look after the charge of the post of Medical Superintendent, DistrictHospital Budgam, in addition to his own duties, till regular establishment is made," the order reads.

It further states that the arrangement in respect of these doctors is made purely on temporary basis and shall not confer any right on these doctors to claim preferential treatment at the time of promotions/regularizations, which shall be made strictly in accordance with the rules. "The arrangement shall be without prejudice to the outcome of writ petitions, if any, pending before any competent court of law," the order adds further.

However, on October 12, the same order was issued by Additional Chief Secretary Health and Medical Education Vivek Bhardwaj.

Dr Mir Mushtaq spokesperson of directorate of health services Kashmir told KNO said that Medical Superintendent LD is basically an employee of the health department and the director can repatriate him back on directions of Additional Chief Secretary Health and Medical education.

## **Police alerts SMC about 277** alleged illegal constructions

'Corporation turning blind eye to violations'

Srinagar: In a disclosure which could lift the veil about huge illegal constructions in J&K's summer capital, Srinagar police have sent a list of 277 buildings to the Srinagar Municipal Corporation (SMC), which are being allegedly constructed illegally.

Sources told the news agency that the police have sent a list of 277 buildings to Srinagar Municipal Corporation, which the public alleged were being constructed illegally.

"The police have asked the SMC whether these constructions have requisite permission," an official told KNO.

He disclosed that these buildings are being constructed in different parts of Srinagar, but SMC has turned a blind eye towards these alleged violations. "The SMC has preferred to remain silent instead of taking action against these alleged illegal constructions," he claimed, adding that this police report is just the tip of the iceberg about illegal constructions in Srinagar.

'50 percent Indians are corrupt'

\*EW DELHI: Almost 60 per cent of Indians using government ser¬vices end up paying bribes, according to a recent survey commis¬sioned by India's Central Vigilance Commission (CVC). But only 20 per cent actually filed complaints against such corrupt practises.

The study was carried out by the Centre for Media Studies (CMS), which interviewed 2,576 visitors to government offices in five cities across the country from October 31 to November 4.

More than 60 percent of respondents said the problem of cor¬ruption was not being tackled seriously and that the judiciary was largely ineffective. Most of the respondents agreed the offices for securing driving licenses and civil supplies were the most corrupt in all five cities - New Delhi, Lucknow, Madras, Hyderabad and Pune

One-third of respondents admitted to using "influence or fa¬vour" to get the service they needed. The survey noted that mem-bers of the business community and the self-employed topped the list of bribe givers. According to the survey, the government departments in Lucknow and Hyderabad were the most corrupt. About 42 per cent of people said the departments operated "Middle men" who acted as a paid conduit between the public and officials. The public departments covered by the survey included electricity and telephone boards, civil supplies, driving license and local and I urban development offices. So far, the talks have not come close to achieving any of the U.N.'s three announced priorities for the annual conference, called COP26.

One is cutting carbon emissions by about half by 2030 to reach the goal Guterres alluded to.

The other two are getting rich countries to fulfill a 12-year-old pledge of providing \$100 billion a year in financial climate aid to poor nations and ensuring that half of that amount goes to helping developing nations adapt to the worst ef-

tional leaders would need to come up with new pledges next year and in 2023 during high-level meetings. He said it is "very important" that nations update their goals and send top leaders to the climate talks every year, at this point. However, Guterres would not say at what point he thinks the 1.

5-degree goal would have to be abandoned.

"When you are on the verge of the abyss, it's not important to discuss what will be your fourth or fifth step," Guterres said.

"What's important to discuss is what will be your first step. Because if your first step is the wrong step, you will not have the chance to do a search to make a second or third one.'

### US Journalist Detained By Myanmar Junta Sentenced To 11 Years In Prison

YANGON. MYANMAR: A Myanmar junta court on Friday sentenced an American journalist to 11 years in prison on charges of unlawful association, incitement against the military and breaching visa rules, his employer and lawyer said.

The military has squeezed the press since taking power in a February coup, arresting dozens of journalists critical of its crackdown on dissent, which has killed over 1,200 people according to a local monitoring group.

Danny Fenster, who had been working for local outlet Frontier Myanmar for around a year, was arrested in May as he tried to leave the country to see his family.

He was sentenced to 11 years for incitement, unlawful association and breaching visa rules, his law-



yer Than Zaw Aung told AFP. His client had not decided wheth-

er he would appeal, he added. A junta spokesman did not respond to AFP's request for comment. Fenster, who has been held in Yangon's Insein prison since he was detained, also faces charges of sedition and terrorism, which could see him jailed for life.

"Everyone at Frontier is disappointed and frustrated at this decision," Frontier Myanmar said in a statement. "We just want to see Danny released as soon as possible so he can go home to his family."

Ming Yu Hah, Amnesty International's Deputy Regional Director for Campaigns said the ruling was "a reprehensible outcome in a case that has been deeply flawed from the start." 'Outrageous'

The sentencing was based on evidence from the junta-appointed information ministry that

showed at the time of his arrest Fenster had been working at local outlet, Myanmar Now, which had its licence revoked shortly after the coup, Than Zaw Aung said.

Fenster's team were barred from cross-examining the ministry's permanent secretary, he said, and the court did not consider tax evidence

that Fenster had already left the outlet and was working for Frontier. Crisis Group Myanmar senior advisor Richard Horsey described the sentence as "outrageous".

"It sends a message not only to international journalists... but also Myanmar journalists that reporting factually on the situation is liable to get them many many years in prison," he told AFP.

He noted US diplomats were working to get him released.

"It will be resolved through diplomatic channels and hopefully very quickly," he said. "But obviously this sentence is a big setback to US efforts."





## **Quad 2.0:** Why The US, UAE, India And Israel Have Joined Forces

inilateralism - a byproduct of increased regionalism - seems to be the order of the day. A recent example came at the conclusion of a virtual meeting of foreign ministers from the US, UAE, India and Israel last week, where they opted to launch an economic cooperation forum. They also discussed joint ventures in transportation, technology and trade, among other areas.

The meeting highlighted the extent of the transformation in West Asian geopolitics since the signing of the Abraham Accords last year. Washington, Abu Dhabi, Delhi and Tel Aviv already have strong relations among each other. Israel is one of the largest arms suppliers to India, while the Emirates is vital to India's energy security. The UAE also hosts millions of Indian workers, thus contributing massively to India's remittance inflows. India is already a member of the Quad with the US, Australia and Japan, based on shared interests in East Asia. The US-Israel relationship needs no elaboration, and the signing of the Abraham Accords between the UAE and Israel is revealing in itself.

All four countries have already stepped up cooperation in trade and investment, and they have shown staunch support for each other on critical political issues. Earlier this year, the Emirates tried to defuse tensions between India and Pakistan, and Dubai recently inked an agreement with Delhi to build infrastructure - which would include IT towers, logistics centres and a hospital - in Indian-occupied Kashmir.

**Responding to China's rise** Though the "new Quad" claims to have a limited security agenda and there is no visible military component, it does seem to have strategic undertones aimed at encirclement and containment.

While the recent US withdrawal from Afghanistan suggested that Washington might finally be scaling back its presence in West Asia, Washington subsequently entered the Aukus alliance in September. The trilateral arrangement between Australia, the UK and the US is very much aimed at limiting Chinese expansion in the Indo-Pacific.

The formation of the new Quad also seems connected to the Biden administration's China containment policy. With Beijing increasing its engagement with the UAE and Israel, Washington is now actively responding to China's rise

on multiple fronts: military, political and economic. The new alliance signals Washington's desire to propel Abu Dhabi and Tel Aviv away from Beijing. A similar motive seems to be driving India. Relations between Beijing and Delhi, especially after their border standoff last year, have not been at their best. There is now a growing recognition in Indian policymaking circles that this threat must be countered.

In addition, the flight of former Afghan President Ashraf Ghani represented a major setback for India in Afghanistan, while giving Pakistan renewed prominence in the country. This has given Delhi a further push to form new alliances, and with the UAE and Israel emerging as powerful technology hubs, they would make valuable partners.

#### Increasing pressure

It is also important to note that since Iran and China signed a comprehensive strategic partnership in March, Tehran officially became a part of the multibillion-dollar Belt and Road Initiative (BRI). Peace in Afghanistan could lead to an extension of the China-Pakistan Economic Corridor, bolstering China's global footprint and the stature of all countries linked to the BRI, including Pakistan and Iran. The new Taliban regime in Kabul has already called China its "most important partner" and expressed interest in being part of the CPEC. This is something none of the Quad 2.0 countries would welcome.

At the same time, the new alliance will increase pressure on Saudi Arabia to formalise ties with Israel. It will also push China, Iran, Pakistan and Turkey to increase economic and security cooperation. And it shows that the fight for the Palestinian cause is all but forgotten: though US officials have said the Abraham Accords do not replace a negotiated settlement, Washington's tepid response to the building of new settlements in Palestine speaks volumes.

While it remains to be seen what shape this new alliance between India, Israel, the UAE and the US will take, it is clear that it signifies a new phase of the global economic race.

## More Than Just A Wife And Diarist **Sophia Tolstoy And Her Fiction**


n 1910, Russian writer Leo Tolstoy abandoned his family and walked out of his estate. He was convinced that the domestic existence hindered his desire to live without material possessions and worldly afflictions. Unfortunately, he left home on a night of heavy rainstorm and met his tragic end within a week after catch-ing pneumonia. Following his death, Sophia Tolstoy came to be viewed as the reviled woman who had driven her husband to death. In the public imagination, she was a wife who bickered with Tolstoy over finances, mired him in family disputes and prevented his creative genius from flourishing.

In the 1990s, the recuperative endeavours of feminist scholars resuscitated her reputation. She was now seen as the suffering wife, who copiously copied the manuscript of War and Peace eight times. However, in all accounts, including the sympathetic ones, Sophia remains overshadowed by Tolstoy's fame. Victim or villain, popular narratives have rendered her a mere wife.

Later biographies establish her merit as a prolific diarist and perceptive photographer. However, a diarist is inevitably tied to her gender, and diary writing becomes a private and "feminine" mode of expression, and not something meant for a wide readership. Thus, it is a constricting literary genre, often appreciated but seldom read.

I will consciously move away from Sophia's diaries, for which she is most well-known, and turn attention to her two novellas, Who's Fault and Song Without Words. Though scant, her oeuvre reveals a polemical feminist ethos. "Sofiya was imbued with many talents. She could draw exceedingly well; she was a fine musician; she left the world hundreds of unique and original photographs; she had a fine appreciation for words, and she herself was a writer," writes Ekaterina Tolstoya.

Sophia's foray into fiction has barely received any scholarly or popular attention for several reasons. Firstly, Tolstov himself refused to read and acknowledge Sophia's writings, and their son felt her novellas would damage her reputation as a mother and wife. She,

too, chose to circulate them among only close family and friends. The Tolstoy family concealed the manuscripts from the public eye, and it was in 1994, nearly a century after she wrote them, that they reached readers. And it was not until 2014 that an English translation was first published. Written as counternarratives to Tolstoy's most provocative work, The Kreutzer Sonata (1889), the works reveal her literary imagination and the ability to challenge Tolstoy in the territory he had mastered.

The Kreutzer Sonata is a confessional tale of a man who freely commits adultery but grows jealous when his wife develops a meaningful friendship with a musician. The narrator murders the wife in a fit of rage but escapes imprisonment after successfully proving her infidelity. The novella was instantly successful but remained controversial due to its explicit discussions on sex, adultery, murder, and violence.

Following its publication, specula-

tions around Tolstoy's tumultuous marriage intensified. The readers saw The Kreutzer Sonata as an autobiographical text wherein Tolstoy empathised with the narrator and urged the readers to forgive his transgressions because the wife is duplicitous and incapable of fulfilling his sexual needs. Indeed, Tolstoy's extra-marital affairs throughout their married life were hardly a secret from Sophia. But she responded to public allegations around her role as a wife and countered Tolstoy's views on women, sex and marriage through the counter novellas. It seems to be a battle between David and Goliath, but she engages with him fearlessly, and the novellas reflect her literary genius.

In Who's Fault. Anna is a beautiful, carefree and lovestruck teenager when she instantly draws the attention of Prince Prozorsky, a flirtatious nobleman twice her age. The writer describes the prince's attraction to-

wards Anna as purely physical, and his sexual advances terrify and confuse her. When the two are eventually married, the prince does not attempt to develop emotional intimacy and sees her purely as a sexual commodity. When she resists his advances, he grows cold, indifferent and begins affairs with several women. Anna is left to fulfill her domestic duties as a wife and mother. She becomes pregnant over and over again until she finally resorts to contraception. In a passionate outburst, she exclaims.

"Does a woman's calling really consist only in this," Anna wondered, "to go from serving the physical needs of a nursing infant to meeting those of a husband? Taking turns- always! But where is my life? Where am I? That genuine self which at one time aspired to the sublime, to serve God and my ideals?...I'm tired and worn out, languishing. I have no life of my own- neither earthly, nor spiritual.'

In Song Without Words, the protagonist Sasha has lost all zest for life after marriage. Her husband loves her but refuses to see her as anything more than his wife. Eventually, a frustrated and insipid Sasha finds herself falling madly in love with her musician neighbour – a man who acknowledges her talents.

"Only in her (Sasha) imagination did she devise the most insane scenes of mutual love between herself and Ivan Ilych. She dreamt that she would inspire him and together with him would serve that art they both loved so much. Never once did the possibility enter her head that she would betray her husband- she did not consider this love a betrayal; her husband remained her husband and she remained his honest wife who loved him after a fashionbut her relationship to Ivan Ilych was something special, poetically artistic, a spiritual celebration, a gift from on high...'

Apart from her views on sexuality and adultery, Sophia primarily indicts the destruction of women's literary and artistic abilities in the confines of matrimony. The protagonists in both counter-narratives are despondent women who pine for intellectual companionship in their respective marriages. While Anna is lured into marrying an abusive and philandering nobleman, Sasha experiences mental fragility and alienation after marrying a man who takes no interest in her musical talent.

Sophia constructs her protagonists as artists and exonerates their adultery by establishing women's intellectual deprivation in marriage as opposed to men who cheat to satisfy carnal desires. She reveals the complexity of the two women's emotions as they are torn between staying faithful in their loveless marriages or committing adultery to find spiritual, intellectual and psychosexual fulfilment. Moreover, a sustained reading of Sophia's fiction has the potential to rescue her from the binaries of passive victimhood and villainy.

## **Covid-19 Pandemic Generated Eight Million Tonnes Of Plastic Waste: Study**

OS ANGELES: The CO-VID-19 pandemic has generated more than eight million tonnes of plastic waste globally, with over 25,000 tonnes of it entering the oceans, according to a study

The research, published in the journal Proceedings of the National Academy of Sciences, found that a significant portion of this ocean plastic debris is expected to make its way onto either beaches or the seabed within three to four years.

A smaller portion will go into the open ocean, eventually to be trapped in the centres of ocean basins, which can become garbage patches, and accumulate in the Arctic Ocean.

The researchers noted that the COVID-19 pandemic has led to an increased demand for single-use plastics such as face masks, gloves, and face shields.

The resulting waste, some of which ends up in rivers and oceans, is intensifying pressure on an already out-of-control global plastic problem, they said.

The team led by researchers at Nanjing University in China and University of California (UC) San Diego, US, used a newly developed ocean



plastic numerical model to quantify the impact of the pandemic on plastic discharge from land sources.

They incorporated data from the start of the pandemic in 2020 through August 2021, finding that most of the global plastic waste entering the ocean is coming from Asia, with hospital waste representing the bulk of the land discharge.

The study stresses on the need for better management of medical waste in developing countries.

"When we started doing the math, we were surprised to find that the amount of medical waste was substantially larger than the amount of waste from individuals, and a lot of it was coming from Asian countries,

ocean, degraded by sunlight, fouled by plankton, landed on beaches, and sunk to the deep," said Zhang.

The researchers found that most of the global plastic waste from the pandemic is entering the ocean from rivers


Asian rivers account for 73 per cent of the total discharge of plastics, with the top three contributors being the Shatt al-Arab, Indus, and Yangtze rivers, which discharge into the Persian Gulf, Arabian Sea, and East China Sea.

European rivers account for 11 per cent of the discharge, with minor contributions from other continents, the researchers said.

While most of the pandemicassociated plastics are expected to settle on beaches and the seafloor, a smaller amount will likely end up circulating or settling in the Arctic Ocean.

The model shows that about 80 per cent of the plastic debris that transits into the Arctic Ocean will sink quickly, and a circumpolar plastic accumulation zone is modelled to form by 2025, the researchers said.

The Arctic ecosystem is already considered to be particularly vulnerable due to the harsh environment and high sensitivity to climate change, they said.

## The older you are, the more antibodies you have: Study

ith the emergence of SARS-CoV-2 variants worldwide, the pandemic's spread is accelerating. A research team led by Joelle Pelletier and Jean-Francois Masson, both professors in Universite de Montreal's Department of Chemistry wanted to find out whether natural infection or vaccination led to more protective antibodies

being generated. In their study published in Scientific Reports, they observe that those who received the Pfizer BioNTech or AstraZeneca vaccine had antibody levels that were significantly higher than infected individuals. These antibodies were also effective against the Delta variant, which wasn't present in Quebec when the samples were collected in 2020. Masson, a biomedical instruments specialist, and Pelletier, a protein chemistry expert, were interested in an understudied group: people who have been infected by SARS-CoV-2 but were not hospitalized as a result of the infection.

pitalier de l'Universite Laval 14 to 21 days after being diagnosed through PCR testing. This was in 2020, before the Beta, Delta, and Gamma variants emerged.

"Everyone who had been infected produced antibodies, but older people produced more than adults under 50 years of age. In addition, antibodies were still present in their bloodstream 16 weeks after their diagnosis," said Masson.

Antibodies produced after an infection by the original, "native" strain of the virus also reacted to SARS-CoV-2 variants that emerged in subsequent waves, namely Beta (South Africa), Delta (India), and Gamma (Brazil), but to a lesser extent: a reduction of 30 to 50 per cent

## Air Quality In Delhi-NCR On Brink Of Emergency, People Advised To Limit Outdoor Activities

**NEW DELHI:** Authorities on Friday advised people to limit outdoor activities and told government and private offices to cut vehicle use by at least 30 per cent as air quality in Delhi-NCR inched towards the emergency level amid a rise in emissions from farm fires and unfavourable meteorological conditions.

Over 4,000 farm fires, accounting for 35 per cent of Delhi's pollution on Friday, played a major role in pushing the 24-hour average Air Quality Index (AQI) to 471 by 4 pm, the worst this season so far. It was 411 on Thursday.

A sub-committee on Graded Response Action Plan (GRAP) said meteorological conditions will be highly unfavourable for dispersion of pollutants till November 18 and agencies concerned must be fully ready to implement measures under 'emergency' category.

The Central Pollution Control Board (CPCB) said the 24-hour average concentration of lungdamaging fine particles known as PM2.5 in Delhi-NCR crossed the 300 mark around midnight and stood at 381 micrograms per cubic metre at 4 pm on Friday, over six times the safe limit of 60 micrograms per cubic metre. The PM10 level was recorded at

577 micrograms per cubic metre, over five times the safe limit of 100 micrograms per cubic metre.

According to GRAP, the air quality is considered to be in the 'emergency' category if the PM2.5 and PM10 levels continue to be above 300 micrograms per cubic metre and 500 micrograms per cubic metre respectively for 48 hours or more.

After reviewing the situation, the sub-committee on GRAP said, "Government and private offices and other establishments are advised to reduce vehicle usage by at least 30 per cent (by working from home, carpooling, optimising field activities etc). People are advised to limit outdoor activities

and minimise their exposure. "Concerned agencies must be in complete readiness for implementation of measures under 'emergency' category as per GRAP (Graded Response Action Plan)," an order issued by the committee read.

The GRAP -- a set of anti-pollution measures followed in Delhi and its vicinity according to the severity of the situation comes into force in mid-October when air quality levels start worsening.

The measures to be followed in the 'emergency' situation include stopping the entry of trucks in Delhi, ban on construction activities and introducing the odd-even car rationing scheme. CPCB Member Secretary

Prashant Gargava observed that in view of unfavourable meteorology, stubble burning and poor dispersion resulting in accumulation of pollutants, the coming week is critical regarding Delhi-NCR's air quality.

The CPCB said an action-taken report is received daily from Uttar Pradesh and Haryana Pollution Control Boards but these are awaited from Delhi Pollution Control Committee and Rajasthan State Pollution Control Board.

According to an analysis by the Delhi Pollution Control Committee, people in Delhi breathe the worst air between November 1 and November 15 every year. The city has recorded severe air quality on six of the last eight days after Diwali.

Faridabad (460), Ghaziabad (486), Greater Noida (478), Gurgaon (448) and Noida (488) also recorded severe air quality at 4 pm on Friday.

An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe".

A layer of eye-stinging smog lingering over Delhi-NCR thickened on Friday, giving an orange tint to the sun and lowering visibility to 200 metres at several places in the region.

India Meteorological Department officials said moderate fog and low temperatures in the morning -- a low of 12.6 degrees Celsius on Friday -- and

calm winds have been trapping pollutants close to the ground.

"Visibility levels at the Indira Gandhi International Airport and the Safdarjung Airport dropped to 200-500 metres due to moderate fog. It intensified on Friday due to high humidity," an official said. Green think tank Centre for Science and Environment (CSE) has said the ongoing smog episode is a public health emergency and could be the longest in four years. In another report, it said vehicles accounted for more than 50 per cent of Delhi's pollution from October 24 to November 8.

According to the Ministry of Earth Sciences' air quality forecasting agency SAFAR, stubble burning has accounted for at least 25 per cent of Delhi's PM2.5 pollution for nine days on the trot, starting November 4.

Gufran Beig, the founder project director of SAFAR, said stubble burning generally contributes to PM2.5 but this time its coarser particles in PM10 are also becoming a lead pollutant at several locations in Delhi.

"This is a new feature in the winter. This is mainly because of the particle growth mechanism due to high humidity at night and increased humidity during the day probably due to water sprinkling which increases the holding capacity of the air. Since the flow is regular, many PM2.5 particles are growing towards PM10 (sic)," he said.

The share of farm fire in Delhi's pollution had increased to 48 per cent on Sunday, the highest since November 5, 2018, when it was 58 per cent.

Last year, the share of stubble burning in Delhi's pollution had peaked at 42 per cent on November 5. In 2019, it accounted for 44 per cent of Delhi's PM2.5 pollution on November 1.

Delhi Environment Minister Gopal Rai on Friday launched the second leg of the campaign to control dust pollution. On Thursday, he had launched a month-long campaign to prevent the open burning of waste and biomass in the city.

"However they fired indiscriminately upon the joint search party. The joint teams ensuring safety of civilians rescued and shifted all the civilians to safer places. The fire was retaliated leading to an encounter," he said.

"In the initial exchange of fire, although one terrorist was killed, however due to darkness the operation remained suspended throughout the night," he added.

In the wee hours, the police spokesperson said that repeated announcements were again made to the hiding militant to surrender. However, the holed-up militant, he said, again fired on the joint search party which retaliated leading to the elimination of the militants.

He further said that the bodies of both the killed militants were retrieved from the site of encounter. He also said that incriminating materials, arms & ammunition including 01 AK-rifle & a Pistol were recovered from encounter site

"All the recovered materials have been taken into case records for further investigation. Police have registered cases under relevant sections of law and investigations have been initiated," he said.

Pertinently, three militants have been killed by government forces in two separate encounters in Kulgam and Srinagar since Thursday morning.

The police spokesperson also quoted IGP Kashmir, Vijay Kumar as congratulating the joint teams for carrying out both the operations in professional manner resulting in elimination of three militants including a most wanted militant

"He also congratulated Police/SFs for working with great synergy and coordination on the ground that lead to the elimination of 133 terrorists including many top commanders during tant outfit for fidayeen attack.

Giving details of the operation, the police spokesperson said that acting on specific input about possible attack and movement of militants in Bemina area, a joint checkpoint was established to thwart such evil designs.

In the meantime, he said, militants attacked a checkpoint established near Bund Bemina which was retaliated leading to an encounter.

"The further reinforcement was rushed to the spot, 2RR and Valley QRT CRPF also joined the operation. In the ensuing encounter, one terrorist of proscribed outfit Mujahideen Gazwatul Hind was eliminated and his body was retrieved from the site of encounter," he said.

The police spokesperson claimed that one AK-rifle was recovered from the Bemina encounter site.

#### NIA Arrests Two

investigation has revealed that the arrested accused persons are terror associates/Over Ground Workers of various proscribed terrorist organisations and have been providing logistical and material support to terrorists, the NIA said.

The NIA registered the case on October 10 with regard to a conspiracy to undertake violent militant acts in Jammu and Kashmir and other major cities by cadres of terrorist organisations Lashkar-e-Taiba (LeT), Jaishe-Mohammed (JeM), Hizb-ul-Mujahideen (HM), Al Badr and their affiliates such as the Resistance Front (TRF) and the People Against Fascist Forces (PAFF).

The spokesperson said the case relates to conspiracy both physically and in cyberspace for undertaking violent militant acts and the agency arrested 27 people in the case till now. "These terresticts and cadras descent

"These terrorists and cadres have effected several terrorist acts including killings of numerous innocent civilians and security personnel, unleashing a reign of terror in the valley of Kashmir, thereby challenging the writ of the state, the NIA said.

Three days after the registration of the case, the NIA carried out searches at 18 locations in Kashmir Valley and arrested nine militant associates. Four more arrests were made during searches at 11 locations on October 20.

On October 22, eight more militant operatives were arrested during searches at 10 locations, while two arrests each were made in multiple raids on October 29 and 30.

"During summer my mother sometimes doesn't even remember she is asthmatic, but with the onset of winter her complaints about breathlessness increases a lot," said Saima.



## If Army Can't Move Its Missile Launchers Upto Indo-China Border, How Will It Fight War: Centre To SC

The Centre on Thursday told the Supreme Court that if the Army cannot move its missile launchers, heavy machinery upto the northern Indo-China border, then how will it defend it and fight a war, if it breaks out. Trying to allay the concerns of

General Bipin Rawat said. A lack of "trust" and growing "suspicion" is coming in the way of resolving the border dispute between the nuclear-armed neighbours, General Rawat said late Thursday. Last month, the

13th round of border talks between Indian and Chinese military commanders ended in a stalemate as both sides couldn't agree on how to pull back from the border.

Prime Minister Narendra administration has Modi's shifted its strategic focus from long-time rival Pakistan after the deadliest India-China fighting in four decades erupted last summer. 20 Indians and at least four Chinese soldiers were killed in hand-to-hand combat in a clash along the 3,488-kilometer border last June.

Since then, China and India have been adding to infrastructure. troops and military hardware along the Himalayan frontier, General Rawat said. "India is prepared for any misadventure along the border and in the sea," he added.

His comments coincided with India's Foreign Ministry's criticism of new Chinese construction in areas that both sides claim. The Defence Chief said the Chinese are building villages along the Line of Actual Control, as the disputed but de facto boundary between the two countries is known.

## **Hindutva And Hinduism** Are Two Different Concepts, Says Rahul Gandhi Amid Khurshid Row; BJP Hits Back

NEW DELHI: Congress leader Rahul Gandhi on Friday maintained that Hinduism and Hindutva are "different things" and slammed the ideology of the BIP-RSS alleging it has spread hatred in India, drawing a sharp retort from the BJP which claimed that the Congress leadership nurses a "pathological hatred" for Hinduism.

Observing that his party's ideology is alive and vibrant and is like a "beautiful jewel" with an unending power inside it, but it has been overshadowed by the BJP, Gandhi also said in today's India, ideological fight has become very important. "Is Hinduism about beating

a Sikh, or a Muslim. Hindutva, of course, is. In which book is it written? I have not seen it. I have read the Upanishads. I have not read it," Gandhi said, as he sought to draw a distinction between Hinduism and Hindutva, a term widely used by the Rashtriya

Swayamsevak Sangh(RSS). "What is the difference between Hinduism as we know it and Hindutva. Are they the same thing. Can they be the same thing. If they are the same thing, why don't they have the same name. Why do they have a different name. Why do you use the word Hinduism, why not just use Hindutva if they are the

## same thing. They are obviously different things'

"robust version" of Hindutva to the iihadist Islam of terror groups such as the ISIS and Boko Haram. Khurshid, who stood by his remarks made in his new book on Ayodhya verdict, had come under attack on Thursday from the BIP as well as his party colleague Ghulam Nabi Azad.

### **6-Month Separation Period Not** Valid If Couple Seeks Divorce **Mutually: Rajasthan HC**

The Rajasthan High Court in a significant decision has said that 'if a husband and wife seek divorce with mutual consent, six month separation period will not be valid'.

The court was hearing a case on Thursday from Pratapgarh in which the Udaipur Family Court had fixed a six months separation period for divorce and had rejected application for instant divorce. The High Court in its order clearly said in the case that it was not appropriate to give six months' time to the couple seeking divorce mutually.

In this case, an applicant

Monika Sharma, a resident of Dhariyavad had filed a petition in the High Court stating that she is living separately from her husband, Rahul Sharma, resident of udaipur, since 2019.

Both of them had applied for divorce in the family court of Udaipur with mutual consent, but were

given six months' separation time. "Both of us have been living separately since 2019. The appeal for hand-to-hand divorce was rejected by the family court," said Monica in her application while her counsel told the court that the Supreme Court had earlier removed the requirement of six months' separation in a case.
