Competitive Exams Becoming Tall Order For Kashmiri Students, Why?

Awannabe doctor from Srinagar, Tabiya Toufiq, 18, believes that competitive exam preparations in the valley differ in many aspects in comparison to that outside.

Kashmiri students she says

Kashmiri students, she says, lack avenues like career counselling, public libraries and economical coaching centres.

"Due to this, they lose time, money and even their mental balance," Tabiya said. "All these factors are an additional burden when there's already a pressure to qualify the exam. It takes a heavy mental toll on students."
Competitive exams are the first step towards career-building for students. They go through various hurdles and prepare for months or even years to qualify for a single examination.

But in Kashmir, lack of educational infrastructure—like absence of a proper public library — isn't bringing Kashmiri students at par with the students outside the valley. "Even if one finds a public library,



it lacks relevant books," said Service Selection Board exam.
Sadaf Shah, preparing for a The lack of career counselling

at the crucial stages of one's career is equally playing a spoil-sport and forcing students to make a compromise in the name of unpopular career choices. Most of the students feel compelled to do that in order to save their academic calendar year.

"I always knew that I wanted to be a doctor but due to the lack of career counselling I didn't know how to approach the path," said Sarmad Ali, who's preparing for NEET (National Eligibility cum Entrance Test) for two consecutive years. "It's

a top career choice in Kashmir and everyone is aware of it, but then career counselling is very much needed in it."

From the beginning itself, students don't know about the options or backups.

"Whatever little knowledge I've about the opportunities and competitive exams is from the experience and learning as I grew," said Shaheen Bhat, a NEET aspirant. "Moreover, we don't have many career options here."

38 Pak Militants On Radar Of Security Agencies

NEW DELHI: The security forces have identified 38 Pakistani militants active in the Kashmir valley and a coordinated operation will be launched soon to neutralise them, the sources in the intelligence grid have said.

The sources said on Friday that out of 38 ultras, 27 belong

No Major Snow Forecast Till Month End

SRINAGAR: The director of Meteorological Department Sonam Lotus Saturday said that there is no forecast of any major snowfall spell till the end of this month.

"No Forecast of Any Major Snow Spell till ending Nov. in both UTs.. J-K and LADAKH," said Sonam Lotus in a tweet.

Meteorological Centre Srinagar tweeted: "Weather most likely to remain dry till 20th. A feeble Western Disturbance is likely to affect the region during 21-23rd Nov. Which may cause light to moderate snow over higher reaches especially northern parts of Kashmir,"

Meanwhile, a thin layer of fog engulfed several areas in Kashmir on Saturday as most places in the valley experienced sub-zero night temperature, even as the Srinagar city recorded the coldest night of the season, officials said.

Ladakhi Leaders Up The Ante For Statehood

Announce Mass Agitation, Call For Strike On December 6

KARGIL: Accusing the BJP-led central government of being non-serious towards the issues and concerns of the people of Ladakh, prominent leaders from the union territory on Saturday announced a mass agitation to press for their four main demands including full statehood and constitutional safeguards for the region.

The Leh-based Apex body of People's Movement for 6th Schedule and the Kargil Democratic Alliance (KDA) jointly called for a general strike on December 6 followed by public rallies and mass contact programmes in both Leh and Kargil districts in March coinciding with improved weather conditions .

Announcing the programme at a joint press conference after the third round of talks



between the two powerful bodies of the region, chairman Apex body and former MP Thupstan Chhewang and co-chairman of KDA Asgar Ali Karbalai said they decided to step up agitation in support of their demands, which also include one more Lok Sabha seat and two Rajya Sabha seats besides a special recruitment drive for the local youth to fill up over 10,000 vacancies in Ladakh.

Both the Apex body and the KDA, which is a separate amalgam of socio-religious, political and youth organisations of Leh and Kargil districts, were formed after the August 5, 2019 development when the Centre abrogated the special status of Jammu and Kashmir and bifurcated it into union territories of J-K and Ladakh. The BJP Ladakh was also part of the Apex body but later distanced • More On P10

9000 Get Jobs On Fast Track

Jammu: Over 9,000 vacancies in different departments have been filled up under fast track recruitment in Jammu and Kashmir, officials said on Saturday.

The selection for 5,000 more posts would be finalised by the end of this year, they said.

The government has initiated the "largest ever" recruitment drive in the union territory in a transparent manner, they said, adding an accelerated committee was constituted for identifying gazetted, nongazetted and class 4 posts.

Nirmal Gets Relief, Tribunal Stays Demolition Order

JAMMU: In a major relief to former deputy chief minister Nirmal Singh, the Jammu and Kashmir Special Tribunal has kept in abeyance an order issued by the Jammu Development Authority for demolition of his house on the outskirts of the city within five days.

The tribunal, headed by judicial member Rajesh Sekri, ordered that the impugned order dated November 8 shall remain in abeyance and the parties were directed to maintain status quo till December 7.

The Jammu Development Authority (JDA) had served a notice to the BJP leader, asking him to demolish his palatial bungalow near the Army's ammunition sub-depot in Ban village of Nagrota.

Singh and his family had moved into the building on July 23 last year, even though the high court had in May 2018 directed the authorities to ensure "strict implementation" of a 2015 notification barring general public from carrying out any construction within 1,000 yards of defence work.

Underground Water Well Within Safe Limits In J&K: Govt Study

JAMMU: Jammu and Kashmir's underground water resources are safe with less than 70 per cent groundwater extraction, a central government-backed study said.

The study, however, recommended judicious use of underground water through suitable scientific interventions for optimal agricultural and domestic use, besides a review of subsidised electricity policy to farmers, suitable water pricing policy and crop rotation for judicious cultivation of water extensive

and non-extensive crops.

In its report, 'National Compilation on Dynamic Ground Water Resources of



India, 2020', the Union Ministry of Jal Shakti said the ground water resources of Jammu and Kashmir have been assessed for valley areas and outer plains in all 20 districts.

The total annual groundwater recharge has been estimated at 4.68 bcm (billion cubic metre) and the annual extractable groundwater resources is 4.22 bcm. The total • More On P10

LG Moots Six-Fold Strategy To Tackle Pandemic

JAMMU: The Jammu and Kashmir Lieutenant Governor, Manoj Sinha on Saturday proposed sixfold strategy of testing, tracing, treatment, Covid-Appropriate Behaviour (CAB), vaccination, and micro containment, and termed it as the most effective way to tackle the pandemic.

Chairing the weekly meeting to review public health response to tackle coronavirus situation with the DCs and SPs, the LG on Saturday directed the officials for pre-emptive Covid management and said that all districts must take these steps to prevent any new surge in cases, an official spokesperson said.

The LG, he said, also directed the Deputy Commissioners and



Health officials to also intensify preventive measures to contain Dengue and work in close coordination and synergy with the civic bodies.

"Small changes like strict adherence to Covid-Appropriate Behaviour can make a bigger difference," Sinha said.

While chairing the meeting, the official spokesperson said that the LG stressed the need to focus on Six-fold strategy of Testing, Tracing, Treatment, Covid-Appropriate Behaviour (CAB), Vaccination, and Micro Containment, as the most effec-

tive way to tackle the pandemic.
During the meeting, he said,
the DCs apprised Sinha about
the Covid protocol enforcement
efforts, implementation of micro

containment zones, testing and contact tracing being undertaken in their respective districts.

"Emphasizing on ensuring strict implementation of Covid Containment measures, the Lt Governor asked the DCs, SPs to firmly implement Covid protocols. He further instructed them to increase Information Education Communication (IEC) activities, testing, and sampling to contain the Virus," the official spokesperson said

the official spokesperson said.

He further said that the LG also directed the Deputy Commissioners and health officials to bridge the gap of number of due second doses as per the targets and prepare themselves with a robust strategy in order to prevent the possible third wave in the UT. • More On P10

She said that both girls chose the issues they wanted to write about. "Duaa wrote on stone pelting, shutdown, life of women in the conflict ridden valley and Saumva asked her about the calls for azaadi in the valley," she said.

Power Crisis In City

Adhere to approved curtailment schedules: MD, KPDCL to officials

SRINAGAR: The Managing Director (MD) KPDCL, Dr. Basharat Qayoom on Saturday convened a review meeting of circle 2nd Srinagar.

Speaking on the occasion, MD impressed upon all the Engineers to work towards better, reliable and quality power supply to consumers especially during upcoming winter seasons.

He also impressed all the officers to adhere to approved curtailment schedules and provide information regarding unscheduled power cuts/ faults to the general public by using social media and other means. He also impressed upon them to make swift responses to faults.

MD emphasised on quality and reliable power supply to consumers. He took sub-division wise detailed review on issues of Revenue Realisation. Reduction in AT&C loss, status of all works under various schemes like B2V / District Capex/ UT Capex/ Winter



preparedness, progress of ongoing works, DT Buffer reclamation, Inspection details (month wise).

While discussing the revenue realisation progress of Sub Divisions of Circle 2nd, MD KPDCL highlighted the issue of high AT&C losses in O&M Division Budgam and Division 3rd Srinagar.

Divisional and Sub-Divisional heads directed to improve their performance and monitor losses feeder-wise and fix the target for reduction of the same by 10 percent during the current quarter. Also Superintending Engineer and Executive Engineers were directed to make Feeder managers and other staff accountable on set parameters including reduction in AT&C losses and set a deadline.

During discussion the chair highlighted the less revenue recovery from the all category consumers from some of the Sub Divisions and they were directed to take every possible effort for recovery of the revenue

On the issue of power theft and illegal connections MD was informed that regular inspections and action taken reports are sought. MD expressed dissatisfaction in terms of inspections and corrective measures taken by the Sub Divisional officers of ED 3rd and Budgam. Sub-Divisions with poor performance were given time bound targets to improve their performance.

During the meeting MD issued strict directions to all the officers to stress upon reducing DT damage rate upto 10 percent during the winter months through extreme inspections / taking all preventive measures

Superintending Engineer circle 2nd Srinagar informed the chair that advance planning and activities have already been started for winter preparedness. Reclaimable DT buffer has been readied by all divisional workshops and work in on double shifts as per the orders issued by the Chief Engineer Distribution Kashmir.

'1500 militants active in North Kashmir

Observer News Service

RINAGAR: Around 1500 militants, mostly foreign mercenar¬ies are operating in North Kashmir districts of Kupwara and Baramulla, a BSF official said. There are 1500 active militants, mostly foreigners, in North Kashmir and the largest group belong to Pakistan based Lashker-e-Toiba, the local component is much less. Inspector General of BSF, B N Chatervedi told reporters at Baramulla, here yesterday.

He said though infiltration has declined in Kashmir region in view of stringent security measures adopted on the borders, militant activities have increased in Jammu region.

Chatervedi, who was briefing reporters about the seizure of big cache of arms and ammunition from a militant hideout at Mangdon forest, near line of Control (LoC), said the hideout here served as a transit camp for the militants.

The arms and ammunition which were being smuggled from Pakistan used to be dumped in the hideout and later distributed to other areas of the Kashmir valley, he said He said BSF troops raided the militant hideout on October

Hotter, drier conditions over the past four decades are decreasing the body size of the rainforest's birds while increasing their wingspans, a study published in the journal Science Advances said Friday.

The changes are thought to be a response to nutritional and physiological challenges, especially during the June to November dry season.

"The biggest takeaway for me is that this is happening far from direct human disturbance, such as deforestation, in the heart of the world's biggest rainforest," Vitek Jirinec, an ecologist at the Integral Ecology Research Center and the paper's lead author told AFP.

"That is something to ponder on the last day of COP26," he added.

Jirinec and colleagues analyzed data collected on more than 15,000 birds that were caught, measured, weighed, and tagged over the

course of 40 years of field work. They found that nearly all the birds had become lighter since the 1980s.

Most species lost an average of two per cent of body weight every decade, meaning a bird species that would have weighed 30 grams in the 1980s would now average 27.6 grams.

The data was not tied to a specific site but rather collected from a large range of the rainforest, meaning the

phenomenon is ubiquitous. More efficient flight In all, the scientists investigated

77 species whose habitats ranged from the cool, dark forest floor to the sunlit and warmer midstory-the forest's middle layer of vegetation.

The birds at the highest sections of the midstory, which fly more and are exposed to heat for longer, had the most pronounced changes in body weight and wing size. The team hypothesized this was

an adaptation to energy pressures for example decreased availability of fruit and insect resources-and also to thermal stress.

"There's good theoretical reasoning why a smaller size is beneficial under climate warming-you can cool yourself better-but the larger wings are more difficult to explain,"

"That's why we proposed the 'wing loading' hypothesis," he added. Longer wings, and a reduced massto-wing ratio, produce more efficient flight-similar to how a glider plane with a slim body and long wings can soar with less energy.

A higher mass-to-wing ratio requires birds to flap faster to stay aloft, using more energy and producing more metabolic heat.

Jirinec added that the study was not designed to tell whether these differences were driven by natural selection resulting in genetic changes, or whether they were the result of different growth patterns based on

Turkey Stops Air Travel For Europe Bound Refugees



WARSAW: Turkey on Friday halted airline ticket sales to Iraqi, Syrian and Yemeni citizens wanting to travel to Belarus, which in recent months has become a key launching point for migrants and refugees trying to enter the European Union illegally.

The move, announced by Turkeys Civil Aviation Authority, follows EU pressure on airlines to stop bringing people from the Middle East to Minsk, the capital of Belarus.

Starting from there, thousands of asylum-seekers have managed to slip into EU member nations Poland, Lithuania and Latvia since the summer, though many others have also been kept from entering or pushed back.

The crisis involving a large number of migrants stuck at the EUs border threatens to become a humanitarian crisis as winter approaches. It is also creating another point of tension between the West and Belarus authoritarian regime.

On Friday, Russia sent paratroopers to the Grodno region in Belarus, which borders Poland, in a show of support for its ally. That follows Russia's sending nuclear-capable strategic bombers to patrol over Belarus for two straight days this week.

Among the migrants are Iraqi Kurds and Syrians fleeing conflict, persecution or poverty. Many aim to reach Germany or other western reunite with relatives already set-

UK Imposes Export Bar On Gold Ornament From Tipu Sultan Throne

gold jewelled tiger head, which once belonged to the gold-covered throne of Mysore ruler Tipu Sultan in 18th century India, was on Friday placed under a temporary export bar in an attempt to find a UK buyer for it.

The finial, or a crowning ornament, is worth around GBP 1.5 million and the export bar placed by the British government is used to allow time for a UK gallery or institution to acquire the piece of historic value. The finial is one of eight gold tiger heads that adorned the throne of the ruler, famously known as the "Tiger of Mysore".

"This fascinating finial illustrates the story of Tipu Sultan's reign and leads us to examine our imperial history." said UK Arts Minister Lord Stephen Parkinson.

"I hope a UK-based buyer comes forward so that we can all continue to learn more about this important period in our shared history with India." he said.

The finial, made of gold and set with rubies, diamonds and emeralds, is described as a rare example of fully documented 18th century South Indian goldsmiths' work and its existence was unknown until 2009. Its marble pedestal is unique among the five surviving finials known, and the meaning of its gold inscription is still a mystery.



The decision on the export licence application for the finial has been deferred until February 11, 2022, which may be extended until 11 June 2022 if a serious intention to raise funds to purchase it is made at the recommended price of GBP 1.5 million.

The minister's decision follows the advice of the Reviewing Committee on the Export of Works of Art and Objects of Cultural Interest (RCEWA), which agreed that it is an important symbolic object in Anglo-Indian history in the last years of the 18th century.

"Tipu Sultan's golden and bejewelled throne (c.1787-93) was broken up by the British army's Prize Agents after Tipu's defeat and death in defence of his capital, Seringapatam, in 1799. This tiger's head is one of the original eight which were placed on the balustrade of the octagonal throne," said RCEWA Member Christopher Rowell.



Wise Men Fear The Fury Of God

he recent World Heavy
Weight boxing contest
between British Tyson
Fury and American Deontay Wilder is symbolic for many reasons. In their
pre-match encounter before
their previous contest in 2018
Wilder appeared to suggest he
was possessed by spirits in the
ring. Fury replied:

66WE LIVE IN

an evil world, the devil is very strong at the minute, very strong, and I believe the end is near. The Bible tells me the end is near. The world tells me the end is near. Just a short few years, I reckon, away from being finished."

"I don't believe in that stuff at all. Because Jesus Christ is my savior. And I don't believe in other spirits and alter-egos. And even mentioning stuff like that on TV... you're getting it! Honestly, if God is with me, nobody can be against me. If you're entering spirits into your body, you can't win, you've already lost. I'm sitting here today as a sincere man who hides nothing behind no curtains."

As Fury spoke, Wilder began to shout hysterically. He looked possessed. Then, the ultimate hubris: "It's gonna be your God against mine!"

The fight on 9 October was the third of a boxing trilogy. Both men were knocked to the ground several times during the contest but Fury, who had a strong lead on points, knocked out his opponent in the eleventh round. Most pundits, including former world champion Mike Tyson (after whom Fury was named), agreed it was one of the greatest boxing matches of all time. But there is something epic and

even spiritual about this contest. Fury's greatness as a boxer is not so much his capacity to throw knock-out punches but, rather, his capacity to stand up after being knocked down in spectacular fashion by Wilder in the second fight.

Wilder whacked Fury with a lefthook; Fury's head bounced off the canvas. Everyone thought the fight was over. Wilder began to gloat over his enemy. Then, to everyone's surprise, Fury got up on the 6th count. Wilder couldn't believe his eyes. He looked as if he had witnessed a miracle. Later in an interview, Wilder admitted that this moment may have been a sign from God:

"When I saw him rise up, in my mind I was like... I'm looking at his eyes rolling in the back of his head like the sun setting. You know, it's over. When I'm seeing him rise up like he did, you know, one of the things, while me opening my mouth being surprised, another thing went through my head like: If you don't believe in God, this is the reason you should."

Fury went on to win the fight. Wilder seemed to get the divine message but it didn't convert his proud heart. Before their final showdown in Las Vegas on 9 October, the American sent Fury a message on Instagram quoting unspeakable obscenities about the Virgin Mary from a rap song written by Tupac Shakur. It proved that Fury's description of Wilder as a

"bum" was remarkably apposite.
Tupac Shakur was a gangster rapper and convicted rapist bought and paid for by Jewish money. According to Ayo H. Kimathi, wealthy American Jews such as Jay Heller promoted gangster rap among the black community.

Gangster rap was a divide and conquer strategy of class rule. It helped turn the black man into a violent commodity, which could be hurled at the white working-class instead of towards wealthy Jewish elites. Tupac was eventually assassinated. It is widely suspected that the men who created him decided to 'take him out of the ring'.

Tackling Taliban-Run Afghanistan

Difficult Path Ahead

t the third regional meeting of national security advisers or secretaries on Afghanistan, that was held in New Delhi earlier this week, the absence of both Pakistan and China underscored the lack of regional unanimity in dealing with the developments in that country in the aftermath of the capture of power by the Taliban around three months ago. Further differences between the eight participants became apparent when Russia issued a separate statement, despite it having signed onto the joint Delhi Declaration. Russia watered down some of the language on combating terrorism and safeguarding the "human rights" of children, women and the minorities.

While some of the Russian back-pedalling may have been due to their own concerns about international interference in Russia's internal affairs using human rights arguments, there appeared also a desire not to overly criticise the Taliban. Russia has been engaging the Taliban and is set to attend the Troika-plus meeting in Pakistan, a day after the Delhi meet, at which, unlike in Delhi, Taliban representatives will also be present. Thus, there are several regional initiatives on tackling the geostrategic and humanitarian ramifications of Afghanistan under the Taliban.

Other than India, Iran and Russia, the meeting was attended by the five Central Asian nations. The eight nations issued a joint Delhi Declaration, with twelve sub paras stressing, recalling, condemning or emphasising the salient issues. The opening point reiterated support for a peaceful, secure and stable Afghanistan

Furthermore, it seeks respect for the sovereignty, unity and territorial integrity of Afghanistan. However, all eight may have disparate levels of concern on the different aspects. For instance, Tajikistan, which falls in the Persian

cultural footprint, unlike the Turkic legacy of some of the other Central Asian republics, has a greater convergence of interests with Iran. As a result, as during the 1990s, the leaders of the Tajik ethnic minority of Afghanistan have sought refuge there. That includes the son of the late Tajik strongman Ahmed Shah Massoud, who was assassinated

days before 9/11. This special role of Tajikistan was apparent as on the very eve of the Delhi meeting the United States managed to extricate over a hundred Afghan pilots and technicians who had managed to fly in their planes to Tajikistan as Kabul fell. Similarly, Uzbekistan sheltered the Turkic minorities of Afghanistan, including soldiers of erstwhile Afghan National Army who fled across the Amu river rather than surrender to the Talihan

The concerns that are shared and reflected in the Delhi Declaration are: drug trafficking; refuge to terrorist organisations and their leaders; the impending humanitarian crisis due to the onset of winter and the paucity of resources with the Taliban regime. Also related to this is the need for the Taliban's domestic conduct to become more acceptable to the international community. That would require for ethnic minorities to be included in the

straightaway, preferably even recognise the regime. To counter this, the Delhi Declaration desires that humanitarian assistance is allowed to be delivered in an "unimpeded, direct and assured manner". The Taliban would want all assistance to be canalised through their offices, thus giving them legitimacy within Afghanistan and abroad.

On terrorism too, the position of the regional powers remains nuanced. Pakistan, China and it seems Russia as well do not want to hold the Taliban regime to public accountability on the question of them severing links with terrorist groups. China has concerns about Uyghurs but would rather handle the matter bilaterally or by using Pakistan's good offices.

India has met the Taliban representatives on the sidelines of regional meetings but has been cold to any direct contacts after the elevation of a representative of the Haggani clan as interior minister. India made a token gesture by attempting to send grains overland to Afghanistan via Pakistan, which was not allowed by Pakistan. But that was more to make a political point about Pakistan blocking even humanitarian aid. In the past, India has used the maritime-cum-land route via Iran to send similar assistance.

That brings up the question of Iran. India having merrily joined the new "Quad" with Iran, the UAE and the United States, Iran would resent an even closer shift by India into the American corner. That is perhaps one of the factors why Iran did not invite India for its regional meeting on Afghanistan recently. Iran is critical to any Indian strategy to bring pressure on the Pakistan-sponsored Taliban government. The Iranian and Indian interests converge on the need for an inclusive government. Iran has twin interests in Afghanistan — to ensure protection for Shia Hazaras and have the Tajiks accepted as partners in the governance structure, in keeping with their second largest minority status after the Pashtuns. At the moment, the first question is still not certain and the second clearly unavailable. But Iran's geo-strategic interests, unlike in the 1990s, are primarily focused on two other issues.

One is how to get the nuclear deal resurrected after former President Donald Trump withdrew the United States. Two, how to safeguard its predominant position amongst the Shias to its west. This is what distinguishes its priorities now as compared to those it had when the Taliban first rose in the 1990s. The proclivity of the Narendra Modi government to get drawn into US-sponsored alliances thus clouds the outlook for strategic India-Iran cooperation on Afghanistan.

What then was the gain from the New Delhi meeting? It showed that all neighbours, other than Pakistan and China, share in varying degrees India's concerns regarding the Pakistan-sponsored Taliban regime running Afghanistan. They are mindful of the humanitarian crisis brewing there but are not in a hurry to ignore their concerns about the Taliban and rush aid. But so far, the Taliban has not yet faced a political challenge domestically. The Tajik resistance was quickly overcome in the Panjshir valley with active Pakistani military support. Tajik leaders who fled to Tajikistan haven't yet got the kind of international support that Ahmad Shah Massoud had till he was assassinated in September 2001. The NSAs of eight nations resolved to keep in touch and meet again next year. The fact that Russia, in its separate statement, kept the next meeting date unspecific indicates the difficult path that lies ahead.

HE measures taken by the governments across the world, to tackle the spread of Covid infection, has once again renewed the old debate- whether the public should be allowed to choose for themselves or should the expert opinion prevail? In a democracy, the public has the right to express diverse points of view on the issues that concern them and they expect their elected representatives to properly represent their views. Therefore, public sentiment, as such, is one input to political decisionswhether it is to make the masks and the vaccination mandatory or whether to impose a lockdown. On the other hand, one could argue that decisions such as these are best taken by the experts based on evidence, and not subject to, say, a referendum or mass opinion. But what happens if the public feels a certain way but experts disagree, what view should win out? The pandemic further complicates the problem because it is a matter of life and death and because of the nature of the virus, it does not only concern a particular person but it concerns the whole community. One person choosing not to wear a mask or refusing to follow social distancing or choosing against getting vaccinated does not only endanger their own lives but the lives of all those around them. So, it raises the question of how we should navigate such complicated issues.

People are usually skeptical of their governments. When China decided to lockdown Wuhan in January 2020, Western media, especially the US-based media, highlighting its democratic credentials, carried reports and news items that raised concerns over the lockdown and suggested that it amounted to human rights abuses. On January 22, 2020, The New York Times published a report

that said "By limiting the movements of millions of people in an attempt to protect public health, China is engaging in a balancing act with a long and complicated history fraught with social, political and ethical concerns." It further quoted an expert who said, "the shutdown would almost certainly lead to human rights violations and would be patently unconstitutional in the United States.' After the Covid positive cases and the number of resulting deaths surged in Italy in early March 2020, their government decided to lock down the country. Italian philosopher, Giorgio Agamben, best known for his work on the concepts of state of exception, vehemently attacked these stringent containment measures imposed by the government. In an opinion piece published in Quodlibet, Agamben wrote that the measures once again manifested the government's "tendency to use a state of exception as a normal paradigm." He further wrote, "It is almost as if with terrorism exhausted as a cause for exceptional measures, the invention of an epidemic offered the ideal pretext for scaling them up beyond any limitation." There are many cases across the world where Agamben's words ring true. In India, the long-running Shaheen Bagh protest site was cleared on the pretext of curbing the spread of Coronavirus. Similarly, in Kashmir, the government used Covid restrictions to stop returning mili-

tants' bodies to their families. It all started in Sopore where a JeM militant's body was returned to his family on April 9, 2020. A few hundred people participated in the funeral, following which an FIR was lodged against unknown persons who participated in the funeral of the militant for violating the Covid-19 protocols. Since then no militants' bodies have been returned to their family.

It is true that such "states of exception" can be used by the governments to target their opponents and crush dissent but does that mean that the government must not have any right to impose any kind of restrictions, even if it is a matter of life or death. When the whole world was months into wearing masks, President of the United States Donald Trump refused to wear a mask and refused to introduce a nationwide mandate that would make wearing masks mandatory because he wanted people to have "a certain freedom." Despite the world's top public health experts in the US repeatedly recommending wearing masks based on evidence, the issue deeply divided the country with the political debate going on for months. Many lives would have been saved if the government and the public had heeded the experts. Incidentally, today (on July 18, 2021) China's Foreign Ministry spokesperson Hua Chunying tweeted a rhetorical question to the US, "How about the rights of 600,000+ Americans who died in the pandemic?'

Unfortunately, it is too late to ascertain the opinion of all those people who died in the US on whether they would have temporarily preferred the "bare life" while sacrificing the normal social, political and economic conditions or would they have preferred "a certain freedom" even if it led to their death.

Some governments like China, with their good intentions of saving people's lives, can be criticized and accused of human rights abuses for locking down the country without involving the public's opinion in decision-making while other countries like the US can get away by putting the same measures in place but after months of debate and huge loss of life. Further, it is a fact that there would always be some governments who would use illegitimate political power disguised as expertise to consolidate their power in order to prolong their survival. Keeping in view all these facts, is it really necessary to include public opinion in decision-making, on issues like a pandemic-which is a matter of life and death- or should the government just heed the experts? Since the pandemic is receding and the focus is now on vaccination, it becomes more interesting. Most of the countries have made vaccination mandatory for international travel and colleges and universities across the world are making vaccination mandatory for their students. But there is still a substantial proportion of the population that is vaccine-hesitant. Should the governments take their concerns into consideration or should they heed the experts?

ow many of our kids can relate to a white girl in a frock-dress and a pinafore?

Does it ever strike us that a child's first encounter with representation can be alienating? Children's books which have been canonised over generations have often been either western or monolithic in their representation of reality. This leads to a disjuncture in a child's immediate surroundings and that which they see represented in books. Even if books are tailored for a South Asian readership, it is still bound to be unrepresentative.All books come with their biases. This is especially true of Children's books which often show the representation as a norm or an aspiration. They regurgitate existing stereotypes present in society under the pretext of representing what is widely held to be "true". For instance, many children's books show a dark-skinned woman to represent what is considered to be "ugly". This reproduces existing biases in our society

Why mustn't children's books cater to local sensibilities when they're taught to impart elementary education? A child must recognise words that are used around, a picture that is true to what they witness in everyday life. A vocabulary that they can immediately apply. This can be achieved through an awareness of how symbolism, metaphors and words need to align rather than alienate.

In Kashmir, Children's books that have been in wide circulation have participated in this mass culture trend of canonised children's literature. However, some locals are now stepping up to address this issue creatively. Grace Paljor is a child educator, poet and creative artist, who is currently the Principal of Saint Paul's International Academy. She's authored a compilation of Children's books under the name "Sheene Pipin" published by KBD. Kashmir Observer got

in touch with her regarding the intricacies of having localised children's literature. Here are some takeaways from the conversation:

What inspired you to compile and write these Children's books? One of my first encounters with Kashmiri language and culture was through my grandmother. As a child, Sheene Pipin had mesmerised me. However, recently, upon finding that many Kashmiri children do not recognise these words, I knew we'd failed somewhere.

My purpose of setting out to endeavour for these books was to fill the gaps that available Children's literature had kept. Do you think it is difficult for children to understand things that they do not find around themselves?

Our children are taught about trees like the Peepal tree and the Banyan tree which don't exist in this part of our world. I think it is important for our children to learn about their environment and learn about trees like Chinar, willow and poplar.

This is basic pedagogy, to take a child from unfamiliar to familiar, but in our textbooks a poor Kashmiri child only learns the unfamiliar.

Why is it important for Children's books to be as localised as possible?

There is an essence in contextualisation. For children, meaning making will only be possible if they can relate and contextualise what they're taught.

Kashmir is very different from most parts of mainland India. The variation ranges from geography to culture as well as language. It makes little sense to teach children irrelevant information. For example, Kashmir has four distinct seasons but the many children's textbooks include the monsoon season which is irrelevant to us.

There is a need for children to learn what they are already surrounded with and they can learn other things eventually.

Tell us about the books you have written and compiled?

I have written the Sheene Pippen series which comprises three books with children specific content. It contains poems, folktales and a dictionary of various categories. For instance, the books have a dedicated glossary of Kashmiri terms for relevant flora, fauna, animals, insects and even places.

We've also integrated Kashmiri words within the English content to present to Children a texture that they find familiar.

Was it easy to find publishers for your books?

I am thankful to Kashmir Book Depot (Ali Mohd & Sons) who saw the potential in it and agreed to publish it. Initially, it was difficult for them to understand the motive behind this project. This wasn't an unexpected response as this aspect is largely untapped in Kashmir. Children's literature is an unexplored area in Kashmir. Even academicians haven't ventured much into it or provided a decent impetus to inspire action in this direction.

Yes, J&K Board had tried to introduce some Kashmir tailored content but they'd merely scratched the surface.

What more needs to be done keeping in mind the lack of Kashmir specific content in Children's books?


A lot needs to be done in this regard. I have done my small bit. We need to upgrade our curriculum and make Kashmir specific children's literature a part of it. Academicians, writers, scholars and civil society need to mobilise people to generate Kashmiri children specific content. Schools should be at the forefront of such projects.



Is your electric car as eco-friendly as you thought?

lectric vehicles (EVs) are a powerful weapon in the world's battle to beat global warming, yet their impact varies hugely from nation-tonation and in some places they pollute more than gasoline models, data analysis shows.

In Europe, where sales are rising the fastest in the world, EVs in Poland and Kosovo actually generate more carbon emissions because grids are so coal-reliant, according to the data compiled by research consultancy Radiant Energy Group (REG).

Elsewhere around Europe, however, the picture is better, though the relative carbon savings depend on what supplies grids and the time of day vehicles are charged.

Best performers are nuclear and hydroelectric-powered Switzerland at 100% carbon savings vis-a-vis gasoline vehicles, Norway 98%, France 96%, Sweden 95% and Austria 93%, according to the study shared with Reuters.

Laggards are Cyprus at 4%, Serbia 15%, Estonia 35% and the Netherlands 37%. An EV driver in Europe's biggest car manufacturer Germany, which relies on a mix of renewables and coal, makes a 55% greenhouse gas saving, the data also showed.

In countries like Germany or Spain with big investment in solar and wind, lack of renewable energy storage means the amount of carbon saved by driving an EV depends heavily on the time of day you recharge.

Charging in the afternoon - when sun and wind are more prevalent - saves 16-18% more carbon than at night when grids are more likely to be fuelled by gas or coal.

The analysis, based on public data from Europe's transmission system operator transparency platform ENTSO-E and the European Environment Agency (EEA),



came ahead of Wednesday's discussions on transport at the COP26 summit.

It showed how the auto industry's ability to reduce emissions depends on finding better ways to decarbonise electricity grids and store renewable energy - challenges many European countries have not yet overcome.

Lithium-ion batteries are only able to store energy at full capacity for up to around four hours, meaning even countries sourcing significant amounts of solar and wind power during the day struggle to keep it on tap for nighttime charging.

Footprint disparities

Until consistent, low-carbon energy is available across the region, EV drivers keen to reduce their footprint and engineers designing charging infrastructure need to take these disparities into account, the Germanand U.S.-based REG researchers said.

"Electricity has the capability of decarbonising transportation in a way that internal-combustion engines never will," said researcher Sid Bagga.

"But the carbon impact of electrification varies dramatically depending on a country's energy mix ... Countries must adopt credible and achievable electricity decarbonisation strategies if the EV transition is to be a success." The gulf in emissions between electric and gasoline-powered vehicles has fallen in recent years as automakers cognisant that they would need to meet EU carbon reduction targets while still selling majority internal combustion engine cars made their engines more fuel-efficient.

As a result, the carbon intensity of newly-registered gasoline-powered cars in Europe fell an average of 25% between 2006 and 2016, according to EEA data.

EV sales in Europe are propelled by government subsidies and regulations against new internal combustion engine (ICE) cars from 2035. One in five vehicles sold in Europe last quarter were electrified, and consultancy Ernst & Young expects sales of zero-emission models to outpace ICEs in absolute terms by 2028.

Parliamentary Panel Members Suggest Resuming International Flights

NEW DELHI: Some members of a parliamentary panel have expressed concern over high cost of international air travel and suggested to the Civil Aviation Ministry to consider resuming scheduled international passenger flights as the entire world is opening up after the COVID-19-induced closure, sources said.

The members of the Parliamentary Standing Committee on Transport, Tourism and Culture also questioned top officials of the ministry over rising prices of international flights, the sources said.

The pandemic-induced suspension of scheduled international passenger flights, which started in March 23, has been extended till November 30. However, special international flights have been operating under the Vande Bharat Mission since May 2020 and under bilateral "air bubble" arrangements with around 28 countries since



Civil Aviation and the Chairman of the Airports Authority of India (AAI) deposed before the parliamentary panel on Friday.

Some panel members from different parties questioned them about high prices of international flights, and food and beverage not being served in domestic flights of a duration less than two hours, the sources said.

Several MPs specifically suggested them to resume international flights as the world is opening up after increasing vaccination against COVID-19. The officials responded that they will look into the matter, sources said.

The MPs also asked them on what basis the number of international flights to be allowed to one specific country is decided Civil Aviation Secretary Rajiv as the demand for international Bansal, the Director General of travel is on the rise, they said.

RBI Asks Banks Not To Standardise Bad Loans On Just Getting Interest Payments

MUMBAI: In a significant move, the Reserve Bank has tightened the norms for recognition of dud assets and directed lenders not to standardise an NPA account after getting only interest payment as well as to mandatorily mention the due dates along with details of interest and principal amounts.

The monetary authority has from time to time been issuing new/revised norms on dud pretation. asset classification as systemwide NPAs began to balloon.

IIP Growth Slips To 3.1% In Sep **On Waning Low Base Effect**

NEW DELHI: Industrial production growth slipped to 3.1 per cent in September, mainly due to the waning low base effect while mining and manufacturing sectors performed well.

The manufacturing sector, which constitutes 77.63 per cent of the Index of Industrial Production (IIP), grew 2.7 per cent in September, according to the data released by the National Statistical Office (NSO) on Friday.

generation increased 0.9 per cent.

The factory output recorded double-digit growth in the four months prior to September this year.

In September 2021, the IIP stood

at 127.9 points compared to 124.1 points in the same month last year. The index stood at 122.9 points in September 2019, as per the NSO data.

Thus, the data showed waning of the low base effect. The IIP growth witnessed double-digit growth from May onwards this year, mainly due to the lower base effect.

NEW DELHI: India's forex reserves decreased by USD 1.145 billion to USD 640.874 billion for the week ended on November 5 on a fall in currency and gold assets, the Reserve Bank said on Friday.

The overall reserves had increased by USD 1.919 billion to USD 642.019 billion for the previous reporting week.

Foreign currency assets, a major part of the overall reserves, decreased by USD 881 million to USD 577.581 billion for the reporting week, the RBI said in the weekly data.

Expressed in dollar terms. the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Value of the gold reserves decreased by USD 234 million to USD 38.778 billion in the reporting week, the data showed.

The special drawing rights (SDRs) with the International Monetary Fund (IMF) decreased by USD 17 million to

USD 19.287 billion. The country's reserve position with the IMF decreased by USD 14 million to USD 5.228 billion in the reporting week, the data showed. (PTI)

No Physical Classes In Delhi Schools, Colleges For 1 Week As Pollution Hits Emergency Level

NEW DELHI; Schools, colleges and educational institutes in the national capital will be closed for physical classes for a week from Monday because of the deteriorating air quality, the Delhi government announced on Saturday after an angry Supreme Court termed the rise in pollution an "emergency situation".

Online teaching and learning will continue in schools and colleges.

Schools in Delhi had reopened for all classes from November 1, after nearly 19 months of closure due to COVID-19.

"All schools, colleges and educational institutes in Delhi to remain shut next week as pollution levels hit emergency level," Deputy Chief Minister Manish Sisodia said.

Welcoming the Delhi government's decision, Aparajita Gautam, the president of the Delhi Parents Association, said, "Students were already at risk due to COVID-19 and suddenly cases have begun rising too. To put students at further risk due to the pollution would have

been dangerous".

Anshu Mittal, the principal of

MRG School in Rohini, said they were geared up to open from November 15 after prolonged closure due to the pandemic.

"The school was all geared up to open from November 15 for nursery to class eight. We were excited to welcome back our students and also aligned the arrangements as per the Covid norms. Activities enhancing student-teacher dynamic and some parent-students activities were also planned.

"However, we applaud the Delhi government's move in ensuring students and teachers' health and welfare. Poor air quality can have serious and long-term effects on the lung health of individuals.

"One of the major concerns that remain is preparation for upcoming board exams which was planned with mock-up classes and remedial sessions. This will be hampered due to delay in school opening and will have to be transformed completely online for the time being," she told PTI.

However, Modern Public School, Shalimar Bagh's principal Alka Kapur had a different view about the suspension of physical classes. "I agree that the health of children should be of primary concern. But we must realise that schools had just opened after a long period and it has affected studies. I believe some alternative steps should have been worked out like suspension of outdoor activities rather than completely closing schools," she

Kartik Singhal, Founder of O2 Cure and Director at Zeco Aircon Limited, said taking requisite measures against inhaling poisonous air resulting from various pollutants in outdoor as well as indoor environments has become the need of the hour.

"Such adverse changes in the air quality are resulting in significant health implications, leading to decrease in life expectancy. If such conditions persist, Delhi residents might start exploring options for employment in surrounding areas along with migration for better living as well," he said.

On Saturday, Delhi's air quality remained in the severe category for the third consecutive day with the 24-hour average air quality index being recorded at 437, a marginal improvement from the day before.

No Mosque Damaged, No Rape, Death In Tripura; Fake News Circulating On Social Media: MHA

NEW DELHI: The Union Home Ministry on Saturday said news circulating on social media about damage and vandalisation of a mosque in Tripura is fake and complete misrepre-

sentation of facts.

It also said that there is no report of simple or grievous injury or rape or death of any person in any such incidents in Tripura as alleged in some social media posts.

In a strongly worded statement, the Ministry of Home Affairs (MHA) said there is no reported case of damage of the structure of any mosque in Tripura in the recent past and

that people should maintain calm and should not be misguided by such fake reports.

"There have been news reports that have been circulating that a mosque in Kakraban area of Gomati district in Tripura has been damaged and vandalised. These news reports are fake and are a complete misrepresentation of facts," it said.

The home ministry said the mosque in Dargabazar area of Kakraban has not been damaged and the Tripura Police in Gomati district is working to maintain peace and tranquillity.

The home ministry said that in Maharashtra, there have

been reports of violence and unsavoury statements that are aimed at disturbing peace and harmony based on fake news regarding Tripura.

"This is very concerning and it is urged that peace is maintained at all costs," it said.

The home ministry made it clear that there is no reported case of damage of the structure of any mosque in Tripura in the recent past.

"There is no report of simple or grievous injury or rape or death of any person in these incidents as alleged in some social media posts," it said.

There have been violence in

some parts of Maharashtra following rallies taken out by Muslim organisations on Friday to protest against incidents in Tripura.

In Amravati, over 8,000 people had gathered outside the district collector's office on Friday to submit a memorandum demanding that atrocities against the minority community in Tripura be stopped.

Violence was reported in Amravati, Nanded, Malegaon, Washim and Yavatmal.

Police have so far arrested 20 people and detained four others by registering 20 FIRs under various charges, including rioting, in connection with Friday's incidents.

Restore Provision For Train Fare Concessions To Accredited Journalists: Press Association

New Delhi: The Press Association on Saturday welcomed the Centre's decision to restore passenger train services to pre-Covid levels and demanded that the provision for giving train fare concessions to the accredited media persons should also be stored.

The Railways on Friday issued an order to discontinue the 'special' tag for mail and express trains and revert to

pre-pandemic ticket prices with immediate effect. In a letter to the zonal railways, the Railway Board said trains will now be operated with their regular numbers and fares will revert to normal pre-Covid prices.

"The Press Association welcomes the decision of the government of India for restoring the operations of all mail and express trains to their earlier schedule and reverts to pre-pandemic ticket prices with immediate effect," the journalists' body said in a statement.

"Press Association also reiterates its long-pending demand to restore concessions to the accredited media persons as existed during the pre-Covid-19 period," it added.

It said the Press Council of India, a quasi judicial body set up under the Act of Parliament, has already written to the Ministry of Railways for restoration of the train fare concessions granted to the accredited journalists.

"Concessions (in train fares), withdrawn during the peak of the Covid-19 pandemic and subsequent lockdown, were used to be given to the accredited media persons for travel required to perform their professional duty, barring once in a year for personal visit," the association added.

implication on widening the generation gap between children and parents. One such instance is related to Sajid Mir's messy academic life.

Sajid was always interested in Physics and knew from the beginning that he could excel in the subject, but his parents didn't support him. "I used to solve Advanced Physics papers

in 12th standard but now I struggle with one numerical," Sajid said. "Had there been career counsellors available, my parents would've understood and let me choose my career path."

Moreover, there's also an issue with expensive coaching centres in Kashmir. Students coming from lower economic backgrounds don't get a chance to prepare as much as their competitors.

"There're brilliant students out there who cannot afford coaching and due to that a lot of potential gets wasted," said Haziq Misgar, a NEET aspirant. "I believe it needs to be changed. We don't lack in hard work and talent, we lack in resources."

The hiccups also stem from Kashmir's disorganized education system lacking proper infrastructure. On top of that, frequent closure of educational institutions due to various situations adds to the disorganization.

"We've to grapple with frequent and sudden connectivity issues and other conflicting situations in Kashmir, creating hurdles in the preparations for these entrance exams," said Basit Nazir, a JE aspirant.

"Due to fear of night raids, cordons and encounters, I've to turn off the lights at around 11pm and can't even burn the midnight oil for these exams."

While the people of Leh have welcomed the fulfilment of their long pending demand of the UT status and later formed the apex body in support of the demand for implementation of the sixth schedule of the Constitution to safeguard their culture and identity, the KDA was not in the favour of the UT status and raised the demand of full statehood to Ladakh.

However, on August 1, the ideologically different representatives of Kargil and Leh districts joined hands to seek full-fledged statehood along with constitutional safeguards for the region — some eight months after their

historic meeting last year.

The entire Ladakh region is united in support of our jointly chalked out four-point agenda the government of India has not shown seriousness to address the desire and demands of the people of Ladakh, prompting us to review our strategy and go for mass agitation, Karbalai said.

He said nearly three months have passed since the delegations of the two bodies met visiting union minister of state for home Nityanand Rai in Leh on August 28 and raised their demands but there was no headway, barring accepting the demand for issuance of Ladakh Resident Certificate at par with the previously held permanent resident certificate to facilitate recruitment in government jobs.

The visiting minister was not initially willing to meet the KDA and the Apex body but was forced to review his decision after people of Ladakh observed a strike on the call of the leaders of the two bodies, he said, adding attempts are continuously being made to break the alliance between the two districts.

We have decided to go for mass agitation and are calling for a complete strike on December 6. It will be followed by mass public rallies in the twin district headquarters of Leh and Kargil and public mobilisation from block to village level to reach out to every household, he said.

Karbalai said though full statehood to the region remains the top on the agenda of both the bodies, the meeting decided to oppose any move by the UT administration to fill up nearly 12,000 jobs in various government departments by promotion quota.

We will strongly oppose any such move or any attempt to outsource jobs to daily wagers. It will be a great injustice to the educated unemployed youth, he said, urging the UT administration to show seriousness and fill up the vacancies without any further delay.

The KDA leader asked people to remain cautious as attempts are being made by the BJP to break their alliance and create confusion among the minds of the public.

The BJP is the only party which is outside the KDA and the Apex body. We are hopeful that the local leadership will see reason and become part of the joint alliance in near future, be said.

Karbalai said the Kargil Buddhist Association has also joined the KDA and attempts would be made to address all the concerns and issues raised by the religious organisation.

Chhewang said, we have no personal interests and our struggle is for the people of Ladakh and for our coming generations.

We will go from village to village and mobilise the public to defeat the designs of those working against the interests of the people, he

In order to expedite the selection process on a fast track recruitment basis, he said government instructions were reiterated to refer all vacancies as on December 31, both Gazetted and Non-Gazetted, to the PSC and SSB by January 15, next year.

The recruiting agencies were also directed

to finalise the calendar for conduct of various examinations well in advance so that the selection process could be completed within a period of one year, the spokesman said.

He said the meeting was informed that the

largest ever written test examination has been conducted by SSB wherein 3.5 lakh candidates participated for class 4 posts this year.

Special consideration by way of additional weightage was given to candidates, including

weightage was given to candidates, including those who worked as casual workers for five or more years and widows, divorced women, judicially separated women, orphan girls and others whose family member has not been in government service.

Within a record time of seven days, more than 4,600 appointment orders of class 4 posts have been issued, the spokesman said.

He said 2,119 selections for gazetted posts have been made by JKPSC in various departments and 726 selections are in progress.

JKPSC has also recommended promotions of 287 officers in the year 2020 and 769 officers during the current year, the spokesman said.

The increase in annual groundwater recharge is due to the additional recharge from canal seepage, return flow from irrigated fields, tanks and ponds, lakes and other surface water bodies, the report said.

port said.

Chairing a meeting here on Friday to discuss the findings of the report released in June this year, Jammu and Kashmir chief secretary A K Mehta entrusted the Jal Shakti department with the task of preventing depletion of identified groundwater resources in the Union territory.

territory.

The Jal Shakti department was also asked to undertake extensive information, education and communication (IEC) activities and promote water conservation efforts through enhanced public participation in Jal Jeevan Mission, which aims at providing functional tap water connection to every household, an official spokesman said.

Regarding the quality of the underground water across Jammu and Kashmir, he said the meeting was informed that groundwater aquifers are safe for use.

Mehta directed testing of water from these resources on 16 defined parameters along with checking the presence of heavy metals as per defined protocol, the spokesman added.

Curfew in Maharashtra's Amravati As Fresh Violence Erupts

curfew was imposed in Maharashtra's Amravati city on Saturday after a mob hurled stones on shops during a bandh allegedly organised by BJP in protest against rallies taken out by members of a minority community the day before against the purported communal violence in Tripura, police said.

Police resorted to lathicharge to control the situation, an Amravati Police official said.

On Saturday morning, hundreds of people, many of them holding saffron flags in their hands and raising slogans, came out on streets in Rajkamal Chowk area of this east Maharashtracity, located around 670 km from the state capital.

Some members of the mob hurled stones at the shops and damaged them in the Rajkamal Chowk and some other places, the official said, adding that the police lathicharged the protesters to bring the situation under control.

Against the backdrop of back to back incidents of stone-pelting on Friday and Saturday, officiating police commissioner Sandip Patil issued orders imposing a curfew in the city limits of Amravati under sections 144(1), (2), (3) of the CrPc to avoid any untoward incidents.

Except for medical emergencies, people are not allowed to come out of their houses. Similarly, a gathering of more than five people is not allowed, as per the order.

The curfew will remain in force till further notice.

On Friday, various cities in Maharashtra had witnessed stone-pelting during rallies taken out by some Muslim organisations protesting against the purported communal violence in Tripura.

These incidents were reported from Amravati, Nanded, Malegaon, Washim and Yavatmal districts.

Police have so far arrested 20 people and detained four others by registering 20 FIRs under various charges, including rioting, in connection with Friday's incidents.

In Amravati, over 8,000 people had gathered outside the district collector's office on Friday to submit a memorandum demanding that atrocities against the minority community be stopped.

When people were leaving after submitting the memorandum, stone-pelting took place at three places between Chitra Chowk and

Cotton Market under the limits of the Kotwali police station.

Meanwhile, launching a veiled attack on opposition BJP, Shiv Sena MP Sanjay Raut on Saturday said the violence in Amravati and other places is aimed at destabilising the MVA government.

Speaking to reporters in Aurangabad, Raut said the state government is firm in the saddle and that the real faces of the perpetrators of violence will be exposed soon.

"The violence that is taking place in Maharashtra is aimed at destabilising the MVA government. Raising the bogey of violence, they (Opposition) will meet the state governor and write letters to the Union home ministry claiming that the (law and order) situation in Maharashtra is deteriorating. This will happen in future too. But the state government is firm in the saddle," Raut said.

He said the "real faces" behind this violence will be exposed in the inquiry of the state Home ministry.

The Shiv Sena, NCP, and Congress are the constituents of the Maha Vikas Aghadi government.

A day after the bandh was observed by Muslim organisations, Amravati district guardian minister Yashomati Thakur said some anti-social elements are trying to vitiate the atmosphere by throwing stones on shops.

"The state government will take necessary action. However, some people are using this for political gains," she said and appealed to people to not believe in rumours.

AlMIM MP Imtiaz Jaleel has also condemned the violence in Amravati.

"I want to question those leaders in the state who came to power by taking the votes of Muslims and why they didn't condemn the violence in Tripura. If this violence in Maharashtra is a 'tit for tat' by any political party then this is the example of irresponsibility," he said.

Opposition leader Devendra Fadnavis said it was wrong to organise rallies in the state for an incident that "never occurred" in Tripura and appealed to people to exercise restraint.

The Tripura government and local police have clarified that no religious place of a minority community was burned down. They have issued pictures of the same as well. I appeal to both the communities to observe restrain, the former chief minister told reporters in Mumbai.

Army Col Killed With Wife, Son in Manipur Ambush

colonel Viplav Tripati, the Commanding Officer of Khuga Battalion of Assam Rifles, his wife and son, besides four personnel of the paramilitary force were killed in an ambush in Manipur on Saturday morning, in fresh eruption of militant violence in the border state, officials said.

Tripathi's convoy was targeted at Sehkan village in Churachandpur district by suspected militants of the People's Revolutionary Party of Kangleipak (PREPAK), a militant group in Manipur demanding a separate homeland.

Improvised Explosive Devices (IED) burst, shattering tenuous peace in Manipur hills, before the Assam Rifles personnel engaged the militants in a firefight.

"In the firefight which followed with the Militants (Suspected PREPAK/ PLA cadres) the Commanding officer and three QRT (quick response team) personnel lost their lives on the spot. The family of the Commanding officer (wife and 6 yr old son) also lost their lives. The other injured personnel were admitted at Behianga health care center," Assam Rifles said in a press statement.

However, Defence Minister Rajnath Singh, who promised "justice" to the affected families, indicated one more personnel of the force had died. "The cowardly attack on an Assam Rifles convoy in Churachandpur, Manipur is extremely painful & Defence ample. The nation has lost 5 brave soldiers including CO 46 AR and



two family members. My condolences to the bereaved families. The perpetrators will be brought to justice soon," he tweeted.

Though the defence minister's tweet indicated one more personnel was killed, there was no immediate confirmation from Assam Rifles, the oldest paramilitary force in the country raised in 1835 under the British rule.

It is under the administrative jurisdiction of the Ministry of Home Affairs (MHA) but operational control of the Indian Army. Assam Rifles euologised the

Assam killes euologised the slain officer who had previously served in Mizoram until his transfer to Manipur in July 2021.

The Assam Rifles statement said it suspected that the insurgent group responsible for this massacre "must be from PREPAK cadre as the PREPAK remembrance day is celebrated on 12/13 November 2021".

'Ban Salman Khurshid's Book On Ayodhya': Hindu Sena Chief Writes To Shah, Kejriwal

Right-wing group Hindu Sena, on Friday, demanded a ban on Congress leader Salman Khurshid's book 'Sunrise Over Ayodhya: Nationhood in Our Times', alleging that his statement comparing Hindutva to the jihadist Islam of terror groups harms social integrity and hurts the religious sentiments of Hindus.

In a letter to Union Home Minister Amit Shah, Delhi Lieutenant Governor Anil Baijal and Chief Minister Arvind Kejriwal, Hindu Sena president Vishnu Gupta said the comparison made in the book is an attempt to demonise the Hindu religion.

Two advocates have already filed complaints with the police against Khurshid's comments, while several BJP leaders have sought action against him.

In his letter, Gupta said, "This book comparing Hindutva/ Hinduism to terror outfit ISIS and Boko Haram is an attempt to demonise the Hindu religion. These kinds of statements in a book can give publicity to the book but this harms the social integrity and hurts the sentiments of millions of Hindus residing in the country and all over the world."

"Therefore, I request you to

kindly look into the matter and put a stay on publication/circulation and sale of the book and also ban the book or take appropriate action as per Indian laws applicable," he wrote in the letter.

In a chapter titled 'The Saffron Sky', Khurshid writes: "Sanatan Dharma and classical Hinduism known to sages and saints were being pushed aside by a robust version of Hindutva, by all standards a political version similar to the jihadist Islam of groups like ISIS and Boko Haram of recent years."

According to Gupta, the excerpts from the book, besides being "instigating and provoking", hurt the religious sentiments of a large number of people who follow the Hindu religion.

"Our Constitution provides every citizen of India with the freedom of speech and expression but not for misuse of the right when it threatens and shakes the harmony of the country," he claimed.

He also said the Supreme Court, in a 1995 judgement, laid down the proposition that "Hindutva is not a religion it is a way of life and state of mind"

a way of life and state of mind". The 354-page book, which claims to analyse the juridical history and consequences of the long-standing Ayodhya dispute, was released on Wednesday.

'Bheek' Remarks: Strip Kangana Of All National Awards, Demands Shiv Sena

The Shiv Sena on Saturday demanded that actor Kangana Ranaut be stripped of all her national awards over her comments that what India achieved in 1947 was "bheek" (alms) and the real freedom was attained only in 2014 when Narendra Modi became the Prime Minister, which it said amounted to "treason".

The editorial in Sena's mouthpiece 'Saamana' said the country will never tolerate such insult to Independence which was attained through blood, sweat, tears and the sacrifice made by countless Indians.

"The Modi government should strip Kangana of all her national awards," the Sena said. Taking potshots at BJP, Sena said Ranaut's comments have exposed its "fake nationalism".

"Nobody had insulted India's freedom fighters in such a manner before Kangana. Recently she was honoured with the Padma Shri award which had earlier been conferred to freedom fighters. It is unfortunate that Kangana was honoured with the same award," the editorial said.

Referring to Ranaut's comments, the Sena said the actress' "present political ancestors" were nowhere in the scene during the process of the county's freedom struggle.

"Our freedom was achieved through blood, sweat, tears and the sacrifice made by countless people of India. Calling it 'bheek' is a case of treason," the Sena said, adding that the "statue of Sardar Patel (the first home minister of India) must be crying after hearing these comments".

Pollution Board Warns of Delhi Air Emergency

Authorities Advise People To Limit Outdoor Activities

India's pollution control body warned of a looming health emergency in New Delhi as deteriorating air quality in the capital turned the sky a murky grey.

The city is ranked one of the world's most polluted, with a hazardous mélange of factory emissions, car exhaust fumes and smoke from agricultural fires settling in the skies over its 20 million people each winter.

On Saturday, levels of harmful

PM 2.5 particles topped 300 on the air quality index. That number is more than 10 times the safe daily limit set by the World Health Organization.

A reading over 300 for 48 hours would initiate emergency measures in the capital, including the closure of primary schools and severe traffic restrictions.

The Central Pollution Control Board on Friday told New Delhi residents to "limit outdoor activities and minimise their exposure" and advised government authorities to prepare "for implementation of measures

under 'emergency' category".

It added the poor air quality would likely run until 18

November due to "low winds with calm conditions during the night".

On Saturday, the Supreme Court suggested imposing a pollution lockdown on Delhi to help with the air quality crisis. "How will we live otherwise?" Chief Justice N.V. Ramana said. The burning of agricultural

The burning of agricultural waste in Delhi's neighbouring states -- largely behind the megacity's pollution levels every winter -- has continued despite a Supreme Court ban.
