## 12.58% Population In J&K Living Below National Poverty Line: NITI Aayog Zaid Bin Shabir



As per this report, 12.58 percent of the total population in J&K including Ladakh is poor.

Pertinently, as per survey by Sustainable Development Goals (SDG) Index 2021, at least 10.35 percent population in Jammu and Kashmir was living below the national poverty line with the rural areas holding more poverty than the urban areas. The figures were revealed by the economic survey report, based on the state-specific poverty lines and

estimates of poverty for rural and urban areas of the states. The MPI report has further

revealed that more than 47 percent of the population in J&K is deprived of proper sani-tation. As per the report, J&K also has a gruelling number of malnourished people who are deprived of nutritional food. 'The percentage of the total population who are deprived

Development Department, Managing Directors, Jammu/ Kashmir Power Distribution Corporation Limited, Chief Engineers, and other senior officers of the Department attended the meeting.

In the meeting, the official spokesperson said, it was



informed that in the current financial year so far, Kashmir registered 64,588 million units of energy consumption, which is 7.98% higher than the previous year's consumption of 59,796.19 million units. "Similarly, there is a 17.33%

increase in the peak load consumption in Kashmir which indicates the rapidly increasing demand for electricity and its peak load over last year," he said.

**SRINAGAR:** Coronavirus claimed the lives of four more people in Jammu and Kashmir on Friday while 174 fresh cases of virus were reported across the Union Territory during the last 24 hours.

According to officials, three more people succumbed to the deadly virus in Kashmir Valley while one person died of Covid-19 related complications in Jammu division, taking the overall fatality count to 4470 persons—2185 in Jammu and 2285 in Kashmir.

Of the new cases, officials said, 131 were registered in the Valley and the remaining 43 from different districts of Jammu division.

In the Valley, officials said, Srinagar reported the highest 63 new cases of virus, Baramulla 23, Budgam 17, Kupwara 13, Bandipora 9 and Ganderbal 6. The four districts of south Kashmir, including Kulgam, Anantnag, Pulwama and Shopian reported no new cases of virus. More on P10

## Mirwaiz's quit notice to India, Pak stirs debate

SLAMABAD: Pakistan will not offer any comment on reports that a senior member of the All Parties Hurrivat Conference (APHC) had asked India and Pakistan to end the occupation of Kashmir and reunite the disputed territory, a senior Foreign Ministry official said on Monday

The official was asked to comment on remarks by APHC leader Mirwaiz Omar Farooq whose interview was carried by a foreign news agency on Monday, quoting him as saying that Pakistan's occupation of one-third of Kashmir was also illegal and must be discussed in peace talks. The official said he would not comment on the interview, apparently on the grounds that it might or might not be as accurate as reported. But he seemed to be willing once the situation would be clear.

The official was also cautious because in the past, certain statements attributed to individuals by wire agencies or newspaper staffers on which different government officials had given ments, were contradicted the next day. Diplomatic circles, however, received the contents of the

interview with surprise and while some thought that Omar Farooq might have said what was reported, others disputed it, 'arguing that he could not possibly have said that.

Some local leaders, belonging to various Kashmiri groups also chose to wait rather than jump to any conclusions. The Kashmiri leaders are due to resume their unfinished meeting on Wednesday to further discuss India's ceasefire offer. The last meeting had remained inconclusive although the cease-fire offer was described as a positive step.

An Associated Press (AP) report had quoted the Mirwaiz, Maulvi Umar Farooq having said in an interview on Monday "India and Pakistan should both end their forced occupation of Kashmir and reunite the disputed valley.

Mirwaiz Maulvi Umar Farooq, Kashmir's highest Islamic lead¬er and one of the key decision-makers of the APHC, said his group welcomed Prime Minister Atal Bihari Vajpayee's offer for talks and said it was waiting for New Delhi to formally invite them.

Vajpayee announced on November 19 that the Indian army would cease military action in occupied Kashmir during Rama-zan, except in cases of self-defence. Indian officials say they, in turn, are waiting for the separatists to approach them for talks aimed at ending the 11-year violence.

Mirwaiz said that Pakistan's occupation of one-third of Kashmir was also illegal and must be discussed in peace talks.

## **South Africa Detects New Covid** Variant With 10 Mutations

Agencies cientists in South Africa said Thursday they had detected a new Covid-19 variant with as many as 10 mutations, blaming it for a

surge in infection numbers. The number of daily infections in Africa's hardest-hit country has increased tenfold since the start of the month.

"Unfortunately we have detected a new variant which is a reason for concern in South Africa," virologist Tulio de Oliveira told a hastily-called news conference. The variant, which goes by the scientific lineage number B.1.1.529,

"has a very high number of mutations," he said, expressing hope that the World Health Organization will give it a Greek name on Friday. "It's unfortunately causing a resurgence of infections," he said.

The variant has also been detected in Botswana and Hong Kong among travellers from South Af-

rica, he added. The WHO said it is "closely monitoring" the reported variant and is try's provinces including Gauteng, expected to convene a technical meeting on Friday to determine if

## **Furious France Scraps UK Migrant Talks After** 'Unacceptable' Letter

PARIS: France on Friday scrapped planned talks with the UK about migrant crossings after an "unacceptable" letter from British Prime Minister Boris Johnson, pushing relations to new lows after 27 people died in the Channel.

The anger in Paris was sparked by The Africa Centres for Disease Control and Prevention (Africa CDC) said it will soon meet South African experts to discuss the variant.

There are so many variants out there but some of them are of no consequence on the trajectory of the epidemic," Africa CDC head John Nkengasong told a news conference on Thursday.

After a rather slow start to South Africa's vaccination campaign, Last year South Africa also detected around 41% of adults have received at least a single dose, while 35% are fully vaccinated. Analysts say the lack of trust and goodwill will make it more difficult to mount a coordinated response to the growing numbers of people seeking to cross the narrow but treacherous waterway separating the countries.

## Islamophobia Is Not A 'Phobia'

slamophobia awareness month occurs every year. I didn't actually know that was a thing until last year, and then I forgot again, until this year. I suppose like all groups who face structural violence and hatred, Muslims have now been granted a month in which public bodies and liberals should affirm their sense that they care for marginalised people. I am certain that many confronted by "Islamophobia Awareness Month" feel sure they are aware of Islamophobia already though. Therefore it comes as a reminder to perhaps just vocalise (predominantly online) that one opposes Islamophobia because it is cruel, perpetuates stereotypes, and es denouncing anyway because it's that thing done by white working-classes and the Daily Mail (who we can all bond over denouncing !). Whilst it is important to recognise the abusive Islamophobic rhetoric of the tabloid press and it is essential to pay more attention to verbal and physical harassment faced predominantly by Muslim women in public spaces; Islamophobia is so much more than such classist analyses allow for. Whilst we do need to bring more attention to street harassment caused by Islamophobia - and I remain consistently antagonised by feminists who continue to be silent on the issue of gendered Islamophobic violence and assault - I believe we also need to understand such acts of violence as more than interpersonal prejudice. Reduction of Islamophobia to "phobia" and prejudice enables people to feel they have no connection to and are not invested in Islamophobia. It enables a false understanding of Islamophobia. By calling Islamophobia structural what I mean is that it is a way of thinking and understanding that now formally informs the way public bodies, the mainstream media, and government act and treat Muslims. We have reached a stage where Muslims in total and Islam in itself are seen as threatening and potentially criminal in Britain. In academic terms this is called the "securitisation of Islam" - this refers to the way that countering terrorism has actually come to be about being suspicious of all Muslims due to understanding violence as something that any Muslim could potentially perpetrate. This is essential to understand. The counter-terrorism strategy doesn't "counter" "terrorists". That's not my opinion, the proof is unavoidable; you will have noticed that since the beginning of the War on Terror both abroad and "at home", there has been no lack of violence. That's because counter-terrorism and

counter-radicalisation strategies do not actually deal with the cause of violence. The strategies assume that violence is, in the end, caused by the fact that someone is Muslim to start with. Therefore, anyone who is Muslim could be violent. Even if you believe that "terrorists" are only a "minority" of Muslims with a "warped" definition of Islam... you still justify suspicion and surveillance of all Muslims, since how else will you know which Muslims are the violent ones? Here you can see how all the current frameworks we use to understand violence reduce its cause to simply the initial fact of someone being Muslim. That's why you get the situ where the more "Muslim" someone seems to "act" or visually appear, the greater inclination to violence we assume they have and the more suspicious of them we are. A man with visible traits that we associate with Islam who leaves his bag momentarily unattended on a train arouses much more suspicion and backlash than someone else. This is because him being/seeming Muslim is the actual crime, rather than leaving the luggage unattended. Whilst train tannoys now tell you that "if you see something", you should "say something", I think we all know that there are some seen things worth saying something over, and others that we don't count as suspicious because of who is doing them... I say all of this because it is only once we understand that being Muslim - exhibiting behaviour, practice or any visible trait associated with Islam - is worthy of making someone a target of suspicion; and that this suspicion is formally embedded in the way our government says it is trying to protect it's citizens from violence; is formally embedded in legislation; is formally enforced in councils, prisons, the NHS, schools and Universities who must report "suspicious" behaviours; is daily reproduced in the media's discussions of Muslims... it is only once we understand all of this, that we can begin to give right meaning "Islamophobia".Islamophobia is not a "phobia", it is more than interpersonal prejudice. It is the formal, encoded and systematic understanding of Muslims as inherently criminal; the understanding that "Muslimness" is the cause of violence. This understanding means that the rights of Muslims can be eroded and violently violated way beyond the "yob" on the street that Islamophobia is so often scapegoated onto, and this can be done without much outcry from the general public.

to counter and mitigate the challenges that life is open to with emancipated and thoroughly trained mind. But what do we discover instead that now a large band of our educated youth fail to secure the basic livelihood, they fail to attend even their minimal needs and this, most of the time lends them to psychological misadventures of all sorts, turning their life into living hell. What is emphasised here isn't the failure of youth in securing their economic independence (Though that is important too) but their utter failure to handle the resulting crisis and to yield to situations as if wet clay in the hands of porter. What should surprise us is that if our education system doesn't prepare and train us to handle these slight ups and downs in our lives, how shall it be expected to produce men of versatility who can steer nation and civilization to newer ideological and material heights. What is more ironical is that sometimes students commit suicide out of their academic pressure, which they find beyond their tolerance band. What an irony does it constitute that education that has often been equated to life and light shall sharpen the depressive and suicidal tendencies in students. It is in an attempt to understand this irony that we shall explore the premises which underlie our educational superstructure through a comparison of it with the educational system of Finland. "Why Finland?", one might ask. Finland is dominantly considered a benchmark for education and this claim is also augmented by its promising high PISA (The Program for International Student Assessment) rankings. However, in this comparative endeavour, we need to be very clear about one thing. Firstly, the comparison doesn't imply that what works for Finland will work for us too, nor does it mean that we ignore the economic/ logistic disparities between Finland and ours and expect, in vague, to pursue their standardization.

To begin with, Finland has no standardized testing. Does it mean that there has to be no system of evaluation and students are to be let free while promoting them from one class to another at the same time? No. that is not the answer at all. What is desirable is to develop customized and student specific test strategies and methodologies. This is possible only with the deep involvement of the teacher with the class, who can then go for student specific evaluation strategies. These aren't utopian goals but are realisable. It will not only bring the best out of students but will also augment their interest, channelize their abilities and turn them into individuals with sufficient academic resources at their disposal to improve not only their own lives, but the structure of society at large. Our education system, right from the beginning fosters in children the spirit of competition and pits them against each other as academic rivals. This concept, which underlies the foundation of our entire education system, is fallible and deleterious on many accounts. It is no hidden fact that individuals are gifted differently and vary in their capabilities. This diversity is a blessing for humanity. However, when we have a set standard of academic excellence, students tend to lose their individual talents, specific potentials and instead end up being robotic copies of non-workable prototypes.

It is also a common observation from our lives that we don't survive by competing with each other, instead our survival is guaranteed by how perfectly and amicably we compliment and cooperate with each other in accomplishing any task. This is the precise reason why when most Americans and other countries see the educational system as one big Darwinian competition, the Finns see it differently. Ironically, this attitude has put them at the top of the international pack.

In line with their spirit for a Non-Darwinian type cooperative educational vision, the Finns place high emphasis on making basics the priority of their education system. It includes, but is not limited to, using education as means of removing social inequality, providing free meals to all school-going students, ease of access to healthcare, psychological counselling and most importantly individualised guidance. Now, when one retrospectively puts to analysis the educational system in place in our own countries and states, it is observed that not only are these basic priorities missing, but those trivial aspects are emphasised which lead students further away from these basic privileges.

Yet another feature of this educational system which stands diametrically opposite to ours is the age at which students are admitted into a school. Here, in a society like ours, parents and school owners are equally driven hysterical to admit children to schools at the earliest possible age, so much so, that even a year old toddler is subjected to rigid disciplinarianism of kindergartens, till it squeezes childhood off the child and prepares them for the robotic role of material production – so dearer to modern industrialist capitalist society.

Here, the Finns again start by changing very minute details. Students start school when they are seven years old. They're given free reign in the developing childhood years to not be chained to compulsory education. It's simply just a way to let a kid be a kid. There are only eleven years of comprehensive school education that Finnish children are required to attend. Everything past the ninth grade or at the age of 16 is optional. Just from a psychological standpoint, this is a freeing ideal. Although it may be anecdotal, many students really feel like they're stuck in a prison. Finland alleviates this forced ideal and instead opts to prepare its children for the real world.

Although the details referred to in aforesaid lines can be expanded and extended upon, a revaluation of our education system even in the light of these minimal principles can take us a long way and be a guiding torch for us. What remains to be seen is that having seen the technological boom and nightmares thereof, do we still aspire to prepare students, who like robots, can fit like parts in a machine? Or do we, in the spirit of egalitarianism, eclecticism and humanitarianism, aspire to create individuals to lead themselves and the world at large out of the thraldoms that confront humanity – everywhere, every time.

**6** The failure of the education system" has now been an ageold dictum. From educationists to industrialists, the cry has been raised time and again that our edu-

cational curriculum is not catering to the real life demands and most of our students, even from well ranked institutions, aren't trained well enough to meet demands of the employers' market.

This concern isn't specific to technical education alone. Even in the social sciences, we don't fare well. All our modules of understanding and approaches of analysis in social sciences are either borrowed from Western academicians or somehow influenced by their verdict. It has been ages now that South East Asian Countries have been consumers, not only of Western technology, but their ideas and ideology too, having discovered itself in the slough of ideological stagnation. Talking of educational scenarios in SAARC will possibly throw us off the track and we will therefore concern ourselves here only with the educational scenario in India with special reference to Kashmir.

Let's begin from the beginning. What do mean when we say that our educational system has failed and what are the contours of this failure? Does it mean as some contest that education has failed to instil in us and inspire our highest moral and ethical ideals or does it peg around the failure of education to produce individuals of industrial, administrative, academic and social girt and merit. The first premise I.e. the failure of education to inspire ethics and morality of high order is both historical and contested and therefore doesn't interest us and the context we are talking about. What bothers us and therefore our society is that education doesn't seem to bring with it the freedom and independence it stands for and it guarantees by its intrinsic nature. But what is the nature of this freedom and independence? The independence referred to encompasses in its fold the ideological and economic primarily, and also an ability

## *New Variant Of Concern?* How Dangerous Is The New Covid-19 Variant B.1.1.529

new variant of the coronavirus that causes Covid-19 – called B.1.1.529 – has been identified in South Africa, with officials there saying it's of concern. Fears a new strain could fuel outbreaks in many countries, straining health systems, potentially evading vaccines and complicating efforts to reopen economies and borders, sent a wave of risk aversion across global markets Friday. Here's what we know so far.

#### What's different about this Covid-19 variant?

Scientists say B.1.1.529 carries a high number of mutations in its spike protein, which plays a key role in the virus' entry into cells in the body. It's also what is targeted by vaccines. Researchers are still trying to determine whether it is more transmissible or more lethal than previous ones.

#### Where did it come from?

There's only speculation so far. One scientist at the UCL Genetics Institute in London said it likely evolved during a chronic infection of an immuno-compromised person, possibly in an untreated HIV/AIDS patient. South Africa has 8.2 million people infected with sequencing institutions at two South African universities. In neighboring Botswana, officials recorded four cases on Monday in people who were fully

HIV, the most in the world. The beta variant, a mutation identified last year in South Africa, also may have come from an HIV-infected person.

#### How widespread is it?

As of Thursday there were almost 100 cases detected in South Africa, where it's become the dominant strain among new infections. Early PCR test results showed that 90% of 1,100 new cases reported Wednesday in the South African province that includes Johannesburg were caused by the new variant, according to Tulio de Oliveira, a bioinformatics professor who runs gene-

vaccinated. In Hong Kong, a traveler from South Africa was found to have the variant, and another case was identified in a person quarantined in a hotel room across the hall.

#### What's the reaction been?

News of the new variant roiled markets Friday, with travel-related stocks in Asia among the biggest decliners as investors anticipated the negative impact it will have on travel. The U.K. issued a temporary ban on flights from six African countries, and Australia said it wouldn't rule out tightening border rules for travelers from southern Africa if the situation escalates. India stepped up screening of incoming travelers from South Africa, Botswana and Hong Kong. The yen, typically seen as a safe haven asset, rose 0.4% against the dollar, while the South African rand slid to a one-year low.

#### How worrisome is this?

It's too early to say. The World Health Organization said there are fewer than 100 whole genomic sequences of the new variant available, which could add to the time it takes to study it as well as how well current vaccines work against it. Viruses mutate all the time, with the changes sometimes making the virus weaker or sometimes making it more adept at evading antibodies and infecting humans.

What should we look out for next? The WHO called a meeting on Friday to discuss B.1.1.529 and decide if it will be officially designated a variant of interest or concern. If it does, it will receive a Greek letter name under the WHO naming scheme, likely the letter "nu." Governments will likely also be taking action on border and travel controls in response to news of the variant.

## **Maulana Azad's Non-Violent Activism And Its Relevance In Current Times**

Alvi's Is A Significant Work Which Presents A Positive, Tolerant, And Peace-Loving Picture Of Islam Amid A Scenerio Inundated With Negative Stereotypes Of Islam And Muslims

n the contemporary times, Islam is discussed from different and diverse perspectives by different scholars through different scholarly approaches. However, Islam is broadly debated and interpreted through two main prisms/ versions: fundamentalist/ extremist/ violent interpretations and the reformist/ liberal/ non-violent version. Though in the post-9/11 world, the scholarship on the extremist trend and violent activism has seen a proliferation through the debates, discussions and in the form of scholarly and analytical works, but the fact is that the reformist trend and the non-violent activism is no less significant, for a number of significant works have been devoted to the later trend as well.

A number of prominent voices, both in the past as well as in the present times, have made remarkable attempts in highlighting the non-violent activism vis-à-vis Islam and Islamic tradition. One such prominent and renowned figure from the Sub-continent is Abul Kalam Azad (1888-1958): a renowned Muslim scholar, journalist, political leader and educationist. Though in most writings on him, Azad's role as a freedom fighter/ political leader, journalist, religious scholar or the Quranic exegete is discussed and highlighted, but a significant (but somehow ignored) aspect of his life and thought is his role as a propagator, preacher, and practitioner of non-violent activism-an aspect of his multidimensional personality in which he was highly influenced by the philosophy of Mahatma Gandhi and his practice of Ahimsa (nonviolence) and Satyagraha (civil disobedience).

The book under review "Non Violent Activism in Islam: Message of Abul Kalam Azad",

written by Hayat Alvi (Associate Professor in the National Security Affairs Department at the U.S. Naval War College, USA), "tells the story and explains the Islamic legal precedent of the nonviolent civil disobedience that Mualana Azad undertook in the face of British repression" (p. ix) Consisting of five (5) main chapters, excluding Introduction and Conclusion, the main purpose of Alvi's book is to 'illustrate the legal basis for nonviolent activism in Islam', as propounded, practiced, promoted, and exemplified by Maulana Azad with the hope that contemporary leaders and activists can learn lessons from his example, which 'can be an argument against blind dogma, extremism, and militancy in the modern era'. In other words. Alvi highlights and discusses the nonviolent activism (NVA) of Azad as an anecdote or a remedial measure for the Islamist extremist interpretations of Islam in the current times.

Alvi is a staunch "Gandhian", and by that way a staunch supporter and follower of Azad's NVA, and is fed up with the "spread of intolerant, militant ideologies (both secu-lar and religious) that inspire acts of violence" (p. viii) or with the "militant interpretations of Islam" and has thus focused on, and given attention to, the "nonviolent interpretations of Islam especially in the context of political activism in the pursuit of social justice" (p. viii; italics in original). In other words, the book intends to provide, as Alvi puts it, "a counterargument to violent Islamist extremism/ jihadism by means of educating the reader about Islam's nonviolent principles and how they can be used to fight against Islamist extremism and militancy" (p. 16; italics in original). Her work makes a substantial contribution due to two main reasons: (i) mostly Azad's ideas about nationalism, educational philosophy, religio-political thought, Quranic exegesis are the aspects which have been

given much importance and hype in most of the writings on Azad; and (ii) most of the current scholarship on Islam is devoted to the extremist interpretations of Islam, or political Islam, and thus NVA (reformist and liberal interpretations) find little space. Thus, Alvi rightly argues that focusing on building awareness about "nonviolent aspects of Islam in today's environment is equally invaluable" (p. 16). Alvi puts forth the focus, purpose and objective of the book very boldly as: "The focus of this book is the moral, religious, and judicial comparisons between Maulana Azad's endorsement (as renowned Islamic jurisprudential authority) of nonviolent activism in the Islamic context-which provides the legal and theological precedents-and the violent acts and beliefs of Islamist extremists, which are immoral and unjust particularly in targeting innocent civilians, and hence un-Islamic, despite their rigorous claims" (p. 16)

"struggle against injustice under the British Raj is a prime model for nonviolent activists to follow for exacting justice and eliminating oppression" (Ibid.).Azad, as a religious scholar, possessed many attributes and beliefs, including firm belief in inter- and intra-Islamic unity, pluralism, and secular democracy.

Azad set the religio-legal precedent in modern history of Islam for "nonviolent civil disobedience" by strongly counterarguing against "violent jihadism and Islamist extremism", and thus his principles and message can be "used in any nonviolent activism with ample evidence and historical examples, serving as ideological and intellectual amunition against violent Islamist extremism and militancy" (p. 142). Azad, as a renowned religious personality and a significant historical figure, not only adopted and practised nonviolence and civil disobedience (Gandhi's principles of Ahimsa and Satyagraha), but his "embrace and implementation of these concepts and strategies indicate that they are wholly compatible with Is-lam" (pp. 142, 143). Azad's adoption and practice of nonviolent activism

for succesful conflict resolution, as well as the greater likelihood for peacem tolerance, and security for all" (p. 143).

struggle against violent Islamist extremism" (pp. 137-38).

"Azad's moderate orientation in Islamic teachings and nonviolent practices" are much helpful in reversing the current "negative stereotypes of

Islam and Muslims" (p. 139). Azad and his like-minded figures, like Gandhi and Dr Martin Luther King Jr., have found "inspiration for nonviolent activism from their respective faiths", and their "faithbased messages to the massed proved effective in mobilising them to participate in their respective morally credible causes" (p. 139).

Nonviolent activism usually results in conflict resolution and changes in laws and policies toward more just social and legal codes", whereas "violent conflicts" cause terrible violence having negative consequences on all aspects of human life (p. 141).

Azad's idea and practice of nonviolence is clear cut refutation of the "violent Islamist extremists" argument that "oppression has to be countered with violent jihad" (p. 141).

Narrating and relating the story of Azad is one of the most effective of ways to release Islam from the "trappings of the extremists" who have "hijacked" Islam in the current times (p. 142)."Azad stood for Hindu-Muslim unity, tolerance, and peaceful coexistence": criticized intra-Islamic schisms; detested Taqlid (blind imitation) and advocated Ijtihad (reinterpretation); acknowledged and appreciated the "potential impacts of modernization on Islam, and the fact that Muslims need to adjust to changing times" (Ibid.). "Maulana Azad is a proof that nonviolent activism in Islam exists with full legitimacy and offers the formula for succesful conflict resolution, as well as the greater likelihood for peacem tolerance, and security for all" (p. 143).

is indeed an "exceedingly important mission" which provides "the blueprint for moral courage and credibility in the face of injustices and oppression" (p. 143).

Overall the theme and subjectmatter of Alvi's book-appended by pictures/ images and Azad's speeches (both in original Urdu and translations in English)-touches upon a crucial and significant issue which needs to be given more space amid the 'extremist' atmosphere so that a real picture of Islam is presented. Alvi deserves much appreciation for highlighting nonviolent activism, both in theory and practice through historical events (especially with reference to Azad), and for highlighting the relevance of nonviolent activism in the 21st century, a century of extremism, violence, protests, and uprisings.

All in all, Alvi's Nonviolent Activism in Islam is a significant work which presents a positive, tolerant, and peace-loving picture of Islam in a scenerio which is inundated with negative stereotypes of Islam and Muslims. In sum, it is a remarkable work and a must read for students and scholars interested in nonviolent activism in Islam.

## **Study Explores How School Attendance Data Could Help In Targeting Mental Health Support For Pupils**

#### Agencies

Poor school attendance impacts a child's future, not just through their educational achievement, but also socially and developmentally.

Pupils with mental and neurodevelopment disorders or who selfharm are more likely to miss school through absenteeism and exclusion than their classmates

Now researchers say these absences are potential indicators of current or future poor mental health and could be used to target vital assessment and potentially life-changing early intervention.

A study led by Swansea University's Professor Ann John, highlighted the importance of integrated schoolbased and healthcare strategies to support young people's engagement with education.

Professor John said: "Children with poor mental health, who are neurodiverse or who self-harm often struggle at school.

"Health and educational professionals, services and policymakers should be aware that children with poor attendance may be experiencing emotional ill health, whether this is diagnosed in school or early adulthood.

"Absences and exclusions may provide a useful tool to identify those who require additional support. Early intervention will not only reduce immediate distress and difficulties for the young person but also may also interrupt poor life trajectories and improve outcomes in later life." The new study saw research-

ers from Swansea, Cardiff and Cambridge Universities and NHS Wales, examine the association between attendance (absences and exclusions) and neurodiversity, mental health and self-harm in 437,412 Welsh school pupils aged from seven to 16 between 2009 and 2013.

Published in The Lancet Psychiatry, their paper highlights that children and young people with a neurodevelopmental disorder, mental disorder, or who self-harm diagnosed and recorded before the age of 24 are much more likely to miss school than their peers.

School absenteeism and exclusion rates were higher after the age of 11 in all children but disproportionally more so in those with a recorded disorder

The study also found individuals with more than one recorded disorder were more likely to be absent or excluded and this was exacerbated with each additional disorder.

There are many ways attendance may be impacted by neurodevelopmental disorders, mental health problems and self-harm. From disruptive behaviours resulting in exclusion or somatic symptoms such as stomach pain and headaches leading to authorised absences to symptoms

associated with anxiety and depression, family and peer problems such as bullying.

If absence results in social isolation and poorer academic performance, this could go on to exacerbate mental health and attendance issues.

The study also identified important differences among genders: "Within the diagnosed populations, girls with neurodevelopmental disorders, depression and substance misuse were more likely to be absent, and boys were more likely to be excluded.

Professor John added: "This aligns with a view that boys express their mental distress through their behaviour which in turn impacts the school environment resulting in their exclusion, whereas girls, especially with emotional disorders or delayed diagnosis of neurodevelopmental disorders, tend to be more anxious and withdraw from social contact."

## Will We Ever Cure Dementia?

there is one dreaded word uttered by doctors to rival cancer, it's dementia.

Patients the world over fear its impacts: the lack of independence; the higher likelihood of ending up in a nursing home. As with cancer, there is currently no "cure" for dementia.

But the prognosis is not entirely bleak. It's now becoming more apparent we may be able to prevent or delay the onset of dementia symptoms by living more healthily in our earlier years.

An often forgotten and more pressing need is how do we care for people living with dementia? Doing so will require investment both now and into the future.

Meanwhile, a large section of the scientific community is squarely focused on the search for effective treatments. Millions of dollars have been invested over the last three decades in search of a "holy grail"

This despite the reality that dementia is a complex condition, an enigma to researchers.

For two important readementia cannot be "fixed" quickly and with great effectiveness - like a heart attack or angina is with a stent, or like some cancers can be with surgery. First, it's a cumulative condition with multiple causes that impact on the brain at various times dur-

ing a person's life span. Second, dementia creeps up on a person with changes in the brain beginning decades before a person actually starts to show symptoms.

For most people, there is not a single cause behind their dementia symptoms, at least for the commonly seen progressive loss of memory and other functions in older age.

In fact, some of the most comprehensive autopsy studies conducted in large populations find the majority of people dving with dementia show a variety of different types of brain changes probably occurring over a few decades.

Not only is there a build-up of proteins in the brain called amyloid and tau that are traditionally regarded as markers of Alzheimer's disease, but also changes seen in other conditions such as Parkinson's disease, and importantly. evidence of damage from poor cardiovascular health such as strokes People are more likely to

show symptoms of dementia during life if they have a combination of these brain changes rather than just one of them, suggesting that a little of each may add up over time.

## Lassipora Unit Owes **5 Crore to PDD**

**SRINAGAR:** An industrial unit in Lassipora, Pulwama owes around 5.50 crore rupees to Power Development Department (PDD).

An official from PDD department said that the unit has not paid electricity bills for the last 5 years. The power supply to the unit was taken off in the year 2016.

a copy of which lies with Kashmir Observer, the unit which goes by the name of Mir Steel Rolling Mills in Pampore, Pulwama owes 54123364 till August 2021.

Assistant Executive Engineer (AEE), Lassipora, Mushtaq Ahmad confirmed that the unit owes more than 5 crore rupees to the department and has violated a clause of power agreement. He said the department then took "tough action" against the unit by deinstalling the power supply in 2016.

The owner was illegally running the induction / arc furnace section in his factory in violation of the clause 9 of the sanction order. So we disconnected his power MV power supply monthly.

supplies in 2016," Ahmad said. He said the owner approached the High Court of Jammu, Kashmir and Ladakh but the department also took a tough stand against him and refused to restore the power supply. Talking to Kashmir Observer,

Shafeeq Mir, owner of the Mir Steel Rolling Mills said that since the power supply of the factory was disconnected by the PDD, the According to a monthly PDD bill, unit stands difunctional.

"When we don't work because of no electricity how can we pay the bills," Mir said.

He refuted the claims of PDD officials that he has violated the clause 9 of the agreement. "The designated committee has given us the approval for the clause. How could we violate when something has been approved," he added.

Mir said, he installed the power unit in 2009 and used to pay lakhs of rupees as fee monthly. "But then the department disconnected the power supplies-making the unit, which is dependent on electricity—dysfunctional," he added. He said his unit would take 250

## **Attorney General K K** Venugopal Suggests Creation Of Court Of Appeals

**NEW DELHI;** Right to access of justice within reasonable cost and time is a fundamental right and a period of 30 years taken in disposal of a case till the apex court cannot be reasonable, Attorney General K K Venugopal said on Friday while advocating four courts of appeals in four parts of the country to relieve Supreme Court of its huge workload.

He opined that the apex court's current role should be overhauled and it should be made a purely Constitutional court hearing only cases involving issues of Constitutional interpretation.

The Attorney General, while speaking at the Constitution Day function organized by the Supreme Court, said four "courts of appeal" should be constituted to hear appeals from High Courts, tribunals, and other matters which are currently heard by the Supreme Court, adding that it would cut down the pendency of cases to a great extent.

would envisage at least about four regions - the north. the south, the West, and the East, each having a court of appeal with 15 judges. Pendency would be reduced so that you will be able to get the cases disposed of within a period of three or four years." he said.

Pendency in Supreme Court will reduce then. For Supreme Court, it will not need these 34 judges. 15 judges sitting in three constitution benches of five judges each will be enough. Judges will be able to hear patiently and write excellent judgments," the AG opined.

Shedding light on the high pendency and time taken in disposal of cases, the top most law officer said it needed a bold person to file a case in the lower court as he or she may not enjoy the fruits of the litigation after 30 years and suggested that the judiciary and the executive should come together to address the issue rather brushing it under the carpet.

He spoke about the sufferings litigants go through when their cases are adjourned by six

months. We find that in the Supreme Court list, there are criminal cases pending from 2008, civil cases pending from 2009. This should mean that when finally justice is done, a total period of 30 years has elapsed, Venugopal said at a function attended by Prime Minister Narendra Modi.

It should be remembered that so far as the right to access to justice is concerned, it is a fundamental right, and being a fundamental right, it means that they should have access to justice at a reasonable cost and within a reasonable period of time. 30 years is not a reasonable period of time, he said.

The top law officer compared this to the western apex courts where he claimed that the cases are disposed of within two years. Venugopal added, "One can-

not allow today's situation to continue because we are not really doing justice. We are ignoring a fundamental right, perhaps violating the fundamental right by allowing the structure of courts to remain.

The Supreme Court Bar Association (SCBA) President Vikas Singh, who was also part of the event, was of the view that the appointment of most meritorious people to the higher judiciary is the constitutional mandate as the judiciary plays an interface between the Constitution of India and the citizens.

I am of the opinion that a suitable legislation in the form of a Bill to regulate the Collegium system can be brought within the said limitation which will facilitate the appointment of judges to the High Courts as well as to the Supreme Court, he said.

Singh stated that the Bill should provide a Permanent Secretariat both at the High Court and Supreme Court level, to assist them in the matter of appointment of judges, adding that the members of the Collegiums both at the Supreme Court as well as the High Courts, being senior judges of their respective Court do

not have enough spare time for this onerous responsibility.

## NATO Chief Warns Russia Of "Costs" If It Moves On Ukraine

BRUSSELS: NATO Secretary-General Jens Stoltenberg warned Russia Friday that any attempt to invade Ukraine would have costs, as concern mounts about a Russian military buildup near its former Soviet neighbor's borders.

Ukraine says Moscow kept about 90,000 troops near their common border following massive war games in western Russia earlier this year. The Ukrainian Defense Ministry said units of the Russian 41st army remain near Yelnya, about 260 kilometers (160 miles) north of the border.

Moscow denies that it's planning any invasion and refuses to provide details about troop movements on its own territory. If Russia uses force against Ukraine that will have costs, that would have consequences, Stoltenberg said, ahead of a meeting of the 30-nation military organization's foreign ministers in Latvia Nov. 30-

Dec. 1. where Russia's activities will be high on the agenda. He did not say what those costs would be.

This is the second time this year that Russia has amassed a large and unusual concentration of forces in the region, Stoltenberg told reporters. He said it includes tanks, artillery, armored units, drones, and electronic warfare systems, as well as combat-ready troops.

This military buildup is un-provoked and unexplained. It raises tensions and it risks miscalculations, Stoltenberg said. He conceded that there is no certainty about the intentions of Russia but said that this is a military buildup by a country that has invaded Ukraine before.

Russia annexed Ukraine's Crimean Peninsula in 2014 after the country's Moscow-friendly president was driven from power by mass protests. Weeks later, Russia threw its weight behind a separatist insurgency that broke out in Ukraine's east.

Ukraine and the West accused Russia of sending its troops and weapons to back the rebels. Moscow denied that, saying that Russians who joined the separatists were volunteers. More than 14,000 people have died in the fighting that devastated Ukraine's eastern industrial heartland known as Donbas.

A 2015 peace agreement brokered by France and Germany helped end largescale battles, but efforts to reach a political settlement have failed and sporadic skirmishes have continued along the tense line of contact.

NATO would not be able to provide Ukraine with any substantial military support in time to make a difference against Russian forces, so economic measures like Western sanctions are more likely to be used to inflict a financial cost on Moscow.

To make public grievance redressal prompt and efficient, especially in times of power failure, the official spokesperson said that the department was asked to publicize the helpline numbers established in this regard and issue SMS alerts and notifications to such consumers whose mobile numbers are available in the PDD database; on all scheduled and unscheduled power cuts.

"Further, the Department was also asked to fix the responsibility of unauthorized connections/ power pilferage especially from feeders reporting electricity load above the permissible limit; on the concerned line staff and take disciplinary action for their inefficiency in taking corrective measures," he said.

"The Divisional and District Administrations will also be involved in the enforcement efforts. It was further directed that responsibility be fixed for transformer outages," he added.

The official spokesperson further said that the Chief Secretary directed regular surveillance and enforcement drives to disconnect illegal power connections so that consumers are able to get power without undue interruptions.

## **India To Resume Scheduled** International **Flights From December 15**

NEW DELHI: Scheduled international flights to and from India will be resumed from December 15, the Civil Aviation Ministry said on Friday. Due to the COVID-19 pandem-

ic, scheduled international flights have been suspended in India since March 23 last year. However, special passenger flights have been operating since July last year under air bubble arrangements with around 28 countries.

The Civil Aviation Ministry wrote a letter to aviation regulator DGCA asking it to take "further necessary action" for the resumption of scheduled international flights.

"The matter of resumption of scheduled commercial international passenger services to and from India has been examined in consultation with the Ministry of Home Affairs, the Ministry of External Affairs and the Ministry of Health and Family Welfare and it has been decided that scheduled commercial international passenger services to and from India may be resumed from December 15, 2021.

"Resumption of commercial international passenger services would imply reversion to bilaterally agreed capacity entitlements and termination of air bubble arrangements," the Civil Aviation Ministry said.

If a country wants to operate scheduled passenger flights to another nation, a bilateral air services agreement has to be negotiated to decide how many airlines, ports of entries and total flights (or seats) weekly can be allowed between the two.

The Directorate General of Civil Aviation (DGCA) issued a formal notification about the resumption of scheduled international passenger flights after the receipt of the Aviation Ministry's letter.

The countries that the Health Ministry has identified as not "at-risk" of COVID-19 will get "full capacity entitlements according to the bilateral air service agreements", the Aviation Ministry noted. In a circular on Friday, the

Health Ministry has put countries in Europe, including the United Kingdom, and South Africa, Brazil, Bangladesh. Botswana, China, Mauritius, New Zealand, Zimbabwe, Singapore, Hong Kong and Israel under the 'at-risk' category.

The Aviation Ministry said if a country has been identified to be "at-risk" of COVID-19 and has an air bubble agreement with India, then "75 per cent of pre-COVID scheduled international flight operations of Indian or foreign carrier whichever is higher or a minimum of seven frequencies per week subject to availability of entitlements under bilateral agreements will be permitted". For a country that has been identified to be "at-risk" of COVID-19 and does not have an air-bubble agreement with India, then only "50 per cent of bilateral capacity entitlements or 50 per cent of pre-COVID operations of Indian or foreign carrier, whichever is higher", will be permitted.

Ûnder an air bubble agreement between the two nations, airlines of both countries can operate special flights between their territories with certain restrictions.

fter 40 years of the inci-Adent, the Lucknow bench of Allahabad High Court has declared a 56-year-old accused as a juvenile, sentencing him to the punishment already undergone in a case of culpable homicide not amounting to muraei The HC decided the plea of juvenility of the convict on the direction of the apex court and the order was passed by a bench comprising Justice Ramesh Sinha and Justice Vivek Varma. The Juvenile Justice Board (IIB). Ambedkar Nagar, in October 2017, had declared the convict, Sangram, a juvenile, but while deciding the appeal finally on October 11, 2018, the HC did not consider this fact. The HC, in fact, had partly allowed the appeal of convicts Ram Kumar and Sangram by upholding the conviction, but modifying the sentence under Section 304 (1) of IPC sentencing them to undergo 10 years of jail term. Sangram challenged the high court verdict in the Supreme Court, pleading that the high court committed grave error in deciding the appeal against him without considering his plea of juvenility that can be raised at any stage of the criminal proceedings.

# India To Tighten Covid Testing For Tourists Amid New Variant Concerns

NEW DELHI: India issued an advisory to all states to rigorously test and screen international travellers from South Africa and other "at risk" countries amid concerns over a new coronavirus variant, after easing some of its travel restrictions earlier this month.

The federal health ministry said reports of mutations in the new variant, identified as B.1.1.529, had "serious public health implications". "This variant is reported to

have a significantly high number of mutations, and thus, has serious public health implications for the country in view of recently relaxed visa restrictions and opening up of international travel," health secretary Rajesh Bhushan said in a letter to states late on Thursday. While some major Asian

countries rushed to tighten border controls and restrict travellers. India had not vet issued a notification, a senior government source said.

"This has not been studied fully by Ministry of Health," the source told Reuters, declining to be identified in line with policy.

The federal health and foreign ministries did not respond to a Reuters request for comment on whether India will ban foreign travellers. On Friday, the UK Health Security Agency said the new variant has a spike protein that was dramatically different to the one in the original coronavirus that COVID-19 vaccines are based on. And it could make existing vaccines less effective.

Britain has banned flights from six African countries, and asked returning British travellers from those destinations to quarantine. India, the world's

second-worst affected country by COVID-19, posted the smallest rise in new cases in one-and-a-half years this week, due to rising vaccinations and antibodies in a large section of its population from previous infections.

The country's total cases of the coronavirus reached 34.56 million on Friday. India's daily caseload has halved since September and the country reported 10,549 new cases on Friday.

Earlier this month, India identified 10 countries "at risk" that includes Europe, Britain, China, South Africa, and New Zealand, among others. And has opened its borders to 99 countries overall. Indian shares tumbled more

than 2% on Friday, as investors fled risky assets panicking over the impact of the new variant. The losses were in line with steep falls seen in markets across Asia.

## **Farmers In Hundreds Descend On Delhi-UP Border On Protest Anniversary**

GHAZIABAD: Hundreds of farmers in tractors started arriving at Ghazipur on the Delhi-Uttar Pradesh border as Friday marked one year of the ongoing farmers' protest against the central laws. Many of them brought along

vegetables, sacks of flour and lentils, spices and cooking oil on their tractor-trollies, saying they had come prepared for a long haul. Bhartiya Kisan Union (BKU),

an influential farmers' union from western Uttar Pradesh, has been leading the charge at the Ghazipur border since November last year.

The BKU is part of the Samyukta Kisan Morcha (SKM), a farmers' collective, which is spearheading the protest for withdrawal of three contentious farm laws and for legal guarantee on minimum support price (MSP) of crops.

"It has been a year of unmatched struggle mixed with happiness and sadness. We are fighting and winning. We will fight and win. MSP law is farmers' right," BKU national spokesperson Rakesh Tikait tweeted in Hindi. The outfit's office-bearers claimed the police had been

strengthening the barricading at Ghazipur border - both on the Delhi-Meerut elevated highway patch and at the UP Gate down below it - since Thursday, even as they said the crowd would swell at the protest site by Friday evening. "We have a meeting of the SKM on Saturday and the future

course of our action will be decided only after that. "We have planned a march

towards Delhi on November 29. but the SKM will take a call about it on Saturday," BKU spokesperson Saurabh Upadhyay said.

He said, "Supporters in large numbers started reaching the border on Friday morning and by evening we are expecting over 50,000 people at Ghazipur alone."

A BKU supporter who reached Ghazipur in the morning from Muzaffarnagar on a tractor in a group said they had come to the protest with arrangements for food and accommodation.

"It has been a year, the farmers can continue the protest for their rights for several years," the villager, draped in a shawl and a muffler, said.

Modi had last week announced his government's decision to withdraw the contentious laws. PTI

**CAN'T CAST DOUBT ON VACCINATION** SC On Plea Seeking Probe On Deaths Linked To Vaccine

The Supreme Court on Friday said it cannot send a wrong message on the ongoing Covid vaccination and emphasized that the WHO has also spoken in favour of the vaccines A bench comprising Justices D.Y. Chandrachud and A.S. Bopanna said: "We cannot send a message that there is some problem with

the vaccination. The WHO has spoken in favour of vaccines, countries across the world are doing it! We cannot just cast doubt on it."

Justice Chandrachud further added that the revised guidelines also provide another channel for tracking serious and minor AEFI (adverse event following immunisation) through the 'peripheral health staff', which includes Asha workers. Citing monthly progress reports, he reiterated that at this juncture, it is not correct to cast a doubt on vaccination. Senior advocate Colin Gonsalves. representing the petitioners, submitted that there were hundreds of reported deaths across the country, linked to the vaccine, at the time this petition was filed. He contended that healthy people going for vaccination are collapsing and dying.

Justice Chandrachud replied it may not be attributed to the vaccine and queried, "What is the correlation? Gonsalves replied, "Maybe. But,

we must have a monitoring system to record this...". He added that 2015 AEFI guidelines were revised in 2020, which only provides for passive surveillance -- relying only on the complaint of a person concerned or the family affected.

Justice Chandrachud remarked. "We cannot say, we haven't formulated guidelines for AEFI in India. We do have a system. There are always bound to be dissenters, but we can't fashion our policy as per them.'

He added that the court has to see the good of the nation as a whole. "The world was in the throes of an unprecedented pandemic the likes of which we have not seen in our life. It is of the highest national importance that we vaccinate." he said. Iustice Chandrachud further added that there will always be studies, either five or ten years down the lane, but, at this stage, "We cannot afford the price of laxity, of not vaccinating. We have to keep the people safe and reduce fatality.'

Justice Chandrachud emphasized, "When you have guidelines, why should the court interfere at this crucial stage of vaccination? Every country in the world has multiple vaccines...look at the developed world, the US."

After detailed hearing in the argument, the bench asked Gonsalves to serve the petition in the office of the Solicitor General. The petitioners, Ajay Kumar Gupta and others, sought direction to the Centre to follow up, record and advertise instances of death occurring within 30 days of immunisation.

The bench said, "We have a few things in our minds," and scheduled the matter for further hearing after two weeks.

der in Ibrahimpur police circle, Faizabad, and hence convicted them with life imprisonment.

The two had preferred appeal in the high court in 1981 against the said conviction and sentence. During pendency of the appeal on a direction of the high court, the JJB submitted its report before it on October 11, 2017, that Sangram was juvenile and aged about 15 years when the crime was committed in 1981.

Considering the matter after the remand order passed by the SC, the high court bench said, "Opinion was formed by the JJB on Transfer Certificate of Sangram pertaining to Class 5 and it was proved by the headmaster of the concerned school by placing relevant documents. No appeal has been filed by the complainant and even the state has not objected to the said finding of the IB."

"Thus, we are of the view that the report dated October 11, 2017, passed by JJB, after making thorough inquiry, is liable to be accepted and we, accordingly, accept the same," observed the bench.
