Govt Mulls Crackdown On Unregistered NGOs

JAMMU: Taking strong note about the reports of the alleged illegal adoption and sale of Covid orphans in south Kashmir's Pampore town, the Jammu and Kashmir government on Thursday directed the home department to increase surveillance and inspect the orphanages, non-governmental organizations and hospitals.

These directions were passed by the Chief Secretary, Dr.Arun Kumar Mehta on Thursday while chairing a high level meeting to review the progress made in nabbing the culprits involved in the case involving alleged adoption and sale of Covid orphans in Pampore recently, an official spokesperson said.

Mehta, he said, also considered the administrative measures being taken by the Social Welfare Department and the law enforcement agencies to prevent occurrence of such incidents in future.



Sedition Charged Kashmiri Students Move HC For Bail

PRAYAGRAJ: Three Kashmiri students, studying engineering in an Agra college and arrested on sedition and cyber-terrorism charges, have moved the Allahabad High Court directly for bail, saying that lawyers in the Taj city have refused to take up their case for bail in the sessions court.

The three students were arrested in October this year for cheering Pakistan following the neighbouring country's victory in a T20 Cricket World Cup match against India.

In their bail pleas to the high court, the three students have also sought transfer of their trials to Mathura, saying that the entire bar of Agra is not ready to appear on behalf of the applicants before the court and defend the case"

A bail plea is first made to a magisterial court in the district and then to a sessions court and subsequently to the high court following its rejection by the lower courts.

The three Kashmiri students Arsheed Yusuf, Inayat Altaf Sheikh and Showkat Ahmed Ganai are students of an engineering college in Agra and were arrested on October 27, 2021 by the Agra police.

They were booked under sections 124 A (sedition), 153-A (promoting enmity between different groups) and 505 (1) (B) of the Indian Penal Code (IPC) and 66-F (cyberterrorism) of the Information Technology Act for allegedly sending WhatsApp messages "against the country" after the match.

The matter will come for hearing in the high court in a few days. More on P10

Kashmir Witnessing Brisk Tourism Season Over 1L Tourists Visited Valley In Nov, Highest Footfall In 7 Years

SRINAGAR: After bearing brunt of three back to back lockdowns, the tourism industry in Kashmir is witnessing a highest-ever tourist footfall in 7 years bringing much sought relief to the people associated with the industry.

After seven years, Jammu & Kashmir tourism sector has hit an emboldening number of tourists for the month of November, crossing more than a lakh number of travelers arriving till now in the valley. Early indications suggest that they have been trickling back to Kashmir, the top J&K destination city for both national and international tourists.

But many businesses that depend on tourism, including hotel operators and restaurants,



see signs that even more tourists could start streaming in as the year-end winter season approaches, providing a badly needed boost as the valley's tourism stakeholders are still struggling to recover from the pandemic.

The tourism industry has

once again sought to increasingly become a pillar of Kashmir's economy. A record of 1, 27,605 travelers have visited the valley this November, and perhaps, their spending supported thousands of jobs,

ason Naseer Ahmad is busy repairing the old walls of the St. Luke's Church at Dalgate Srinagar. As he cements the dislodged bricks of the valley's "oldest Church", he's taken down the memory lane to his childhood days where he sees himself coming to the church out of curiosity to

discover a Christian prayer. "I've been brought up in this locality," says Naseer who lives in the adjacent Daesil Mohalla. "During my childhood days, I remember myself coming here as a child and peeping through the

entrance of the Church." The St. Luke's Church served as an important religious place for Protestant Christians. Setup by Church Missionary Society of England, the foundation stone was erected by Dr. Ernest and Dr. Arthur Neve.

"TO THE GLORY OF GOD AND AS A WITNESS TO KASHMIR" dedicated by "The Bishop of Lahore" on September 12, 1896 remains engraved on a marble stone on the inner wall of the church.

The J&K Tourism Department is renovating and restoring the church under the Smart City Project. Officials say the renovation of the church is in its last phase.

"Officials have told us to speed up the work," Naseer says."We're doing our bit but it seems very unlikely to be complete by



Christmas. I have been working at Church for last one month." For Naseer working at the

church has been exciting and a new experience in itself. "In the past I have worked at



a Hindu temple but for the first time I am renovating a church. It is exciting and gives a different

feel. I think it is important to revive our old structures; they are part of our legacy."

For the miniscule Christian minority in Kashmir, it's a matter of happiness and joy. Rev. Eric, Priest In charge of All Saints Church expressed his happiness and gratitude to the government for the renovation work. "There is excitement in the

Christian community that our Church is getting renovated. We are thankful to officials who are helping us in getting the Church renovated," he said. "We could not have managed to do it on our own. The authorities took us on board and the Church is being to its original glory."



UN Projects Soaring Humanitarian Needs In World In 2022



The United Nations is predicting that a record 274 million people who together would amount to the world's fourth most-populous country will require emergency humanitarian aid next year in countries like Afghanistan, Ethiopia, Myanmar, Syria and Yemen which face a raft of challenges including war, insecurity, hunger, climate change and the coronavirus pandemic.

The Office for the Coordination of Humanitarian Affairs, in its annual overview of future needs, is projecting a 17% jump in the number of people who will need urgent assistance in 2022, and is appealing to donors to provide a record \$41 billion to help 183 million people who are the most in need.

The climate crisis is hitting the world's most vulnerable people first and worst. Protracted conflicts grind on, and instability has worsened in several parts of the world, notably Ethiopia, Myanmar and Afghanistan, said Martin Griffiths, the head of OCHA. The pandemic is not over, and poor countries are deprived of vaccines.

The appeal pulls together needs from an array of UN agencies and their partners, and is likely to fall short of its ambitions. This year, donors provided over \$17 billion for projects in last year's Global Hu- and said he was very worried about manitarian Overview from OCHA, but funding has been less than half of the UN request for 2021.

This year, Griffiths said, "We reached 70 percent of the people that we wanted to. We're aware that we're not going to get the \$41 billion, much as we will try hard."

Humanitarian aid matters, said Griffiths. We were able to stop famine affecting half a million people in southern Sudan...we delivered health care to 10 million people in Yemen...we've helped vaccinate millions in Myanmar.'

OCHA says more than 24 million people require life-saving assistance in Afghanistan, driven by conflict, political turmoil, the coronavirus, economic shocks and the worst drought in more than a generation.

We never left Afghanistan. And we are there now with a projected programme for 2022, three times the size of the programme for 2021 because of the various needs and circumstances that you know so well, he said.

That appeared to be an allusion to the ouster of the internationallybacked Afghan government by Taliban fighters in August, and surge of humanitarian needs in the country including the fight against famine and hunger since then.

Griffiths said the situation in Ethiopia, where the government has been battling fighters from the Tigray region, is the most worrying in terms of urgent, immediate need a possible siege by fighters on the capital, Addis Ababa.

The capacity to respond to an imploded Ethiopia is almost impossible to imagine, he said.

The omicron variant of Covid-19, first identified in South Africa, has now been detected in countries from the U.S. to South Korea, underscoring the difficulties of curtailing contagious new strains.

Most infections stem from travelers carrying the disease across borders. Israel, for instance, said a confirmed case who arrived from Malawi rode on a bus from Tel Aviv. Italy's first case traveled around the country for days before testing positive. The first omicron case was confirmed in the U.S. in a person who returned from South Africa, the Centers for Disease Control and Prevention said.

Researchers worldwide are racing to understand the full impact of the new strain, and governments have banned travelers from South Africa and nearby countries on concerns omicron could evade the protection of vaccines and fuel new surges.

Iran Says Nuclear Deal 'Within Reach' If West **Shows Goodwill**

ran's top diplomat says an agreement to revive his country's nuclear deal with world powers was "within reach" but that this depended on the goodwill of the West.

Foreign Minister Hossein Amir-Abdollahian said on Twitter on Thursday that negotiations in the Austrian capital, Vienna, were "proceeding with seriousness" and that the removal of sanctions was a "fundamental priority".

"Good deal within reach if the West shows good will. We seek rational, sober and result-oriented dialogue," said Amir-Abdollahian.

The talks aimed at reviving the 2015 nuclear deal between Iran and several world powers - Britain, China, France, Germany, Russia and the United States - resumed on Monday after Iran paused them in June following the election of President Ebrahim Raisi

The US, which unilaterally pulled out of the deal in 2018, is only participating in the talks indirectly at Iran's insistence.

The goal of the deal, formally known as the Joint Comprehensive Plan of Action (JCPOA), is to make it practically impossible for Iran to build an atomic bomb while allowing it to pursue a ci-

vilian nuclear programme. Under the pact, Tehran limited its nuclear programme in exchange for relief from US, EU and UN economic sanctions.

Iran submits proposals Separately on Thursday, Iran provided the European powers involved in the deal with two drafts on sanctions removal and nuclear commitments, Iran's top nuclear

negotiator said. "We have delivered two proposed drafts to them \dots Of course they need to check the texts that we have provided to them. If they are ready to continue the talks, we are in Vienna to continue the talks," Ali Bagheri Kani told reporters.

A European diplomat confirmed draft documents had been handed over.

Al Jazeera's Ali Hashem, reporting from Vienna, said the proposals seemed to indicate "solid" progress at the talks.

"We understand from an Iranian diplomatic source that one of these proposals will be about lifting the sanctions, and the other will be on Iran rolling back the measures it took after the United States withdrew from the nuclear deal," he said.


Washington: President Joe Biden will announce Thursday a winter campaign against Covid-19, with new testing requirements for travelers and a surge in vaccination efforts -- but no clear path to defeating the pandemic he was elected to confront.

Biden has brought steady leadership after the chaotic Donald Trump years, but the mutating coronavirus continues to defy him, helping drive his approval ratings deep underwater.

In a speech from the National Institutes of Health research center outside Washington, Biden is set to list a raft of actions designed to tamp down Covid-19 during the winter as the latest Omicron variant spreads worldwide. The first US case was detected

Top of the list will be an announcement that toughened rules on testing for travelers will take effect within days, a senior administration official said.

Meghan penned the five-page letter to Markle following a collapse in their relationship in the run-up to her wedding, which her father missed due to ill health and after he admitted posing for paparazzi pictures.

The paper, which published extracts in February 2019, argued Markle wanted the letter public to respond to anonymous comments by Meghan's friends in interviews with the U.S. magazine People.

Pre-Empting Omicron

n a welcome decision, the Jammu and Kashmir administration has decided to make RT-PCR testing mandatory for all foreign travellers to the Union territory at airports to tackle the coronavirus variant Omicron's threat. The travellers will be allowed to enter J&K only if they test negative. If the report is negative, the travellers will be sent to home quarantine for seven days and re-tested on the eighth day. And those who test positive will be sent to institutional isolation centres for 15 days and their samples sent for genome sequencing at ICMR-approved laboratories.

The decision follows the sudden advent of the new Covid-19 strain Omicron in South Africa which the World Health Organization has described as a variant "of concern." This has already persuaded the union government to review its strategy of letting in foreign travellers. In a two-hour long recent meeting with senior officials, Prime Minister Narendra Modi directed officials to review plans for easing of international travel restrictions. The PM said travellers must be tested on arrival as per guidelines and called for a particular focus on countries identified "at risk". He laid emphasis on increasing coverage of the second dose of the vaccine so that adequate immunity is achieved against fresh infections. The PM also urged people to adopt masking and social distancing to prevent the infection from spreading.

Meanwhile, Omicron poses a serious threat to the world economy which was beginning to rebound from the lockdowns of the last one and a half year. The new strain is believed to be deadlier than the previous strains including the Delta. A South African communicable diseases expert has said that Omicron "will outcompete Delta". Even though, the countries are putting strick checks in place for the fresh visitors, some infected persons are slipping through the checks. Saudi has confirmed its first case of Omicron variant coming from a north African country. So, there is fear that the new strain will be difficult to contain despite the restrictions.

For now, however, India has no cause for alarm. On Wednesday, India reported reported just 8,954 new coronavirus cases and 267 related fatalities. The national recovery rate currently stands at 98.36 per cent, which is the highest since March 2020. The active cases in the country standd at 99,023 or 0.29 percent of the total cases. But the country can't afford to let its guard down. So, while strict restrictions should be in place for the travellers at the airports, the union and the state governments have to also enforce SOPs to ensure there is no fresh surge in delta related cases.

Road To Recovery: On Sustaining Growth

he latest GDP and GVA estimates from the National Statistical Office have affirmed that the economy is now on the path to recovery after last fiscal's record contraction. Second quarter gross domestic product expanded 8.4%, rebounding from the year-earlier period's 7.4% contraction. While the statistical advantage from the base effect surely aided the expansion, the economy appears to have gathered just enough momentum for GDP to post a marginal 0.3% growth even when compared with the second quarter of the pre-pandemic 2019-20 fiscal year. The gross value added figures, which capture the extent of activity across the eight major formal sectors of the real economy, too underscore the improvement, with the July-September 2021 GVA figure of 32.89-lakh crore registering a 0.5% expansion from the July-September period of 2019. Five of the eight sectors posted growth not just from the year-earlier quarter but also surpassed the pre-COVID-19 performance. Manufacturing, which has the second-largest share of GVA, appears to have regained traction and was the bulwark of GVA, logging a 3.9% expansion from the pre-pandemic second quarter of fiscal 2020. The key employmentproviding services categories, however, are yet to fully recover from the pandemic's devastating impact, and along with construction, another major provider of jobs, lagged pre-pandemic levels by a cumulative 77,000 crore. With the potential impact of the Omicron variant a big unknown, the outlook here may stay hazy for now.

A disaggregated view of the GDP data also reveals areas of concern that could undermine the recovery. Private final consumption expenditure that measures spending on everything from essentials to luxury goods and the entire gamut of services by all consumers, and has the largest share of GDP at 55%, is still treading water. The uncertainty induced by the pandemic, coupled with reduced or lost incomes, continues to depress demand and is mirrored in consumer spending still remaining 3.5% shy of the pre-COVID level. Government consumption spending, which has often been a reliable alternative source of demand with a capacity to serve as a multiplier, is also well below the fiscal 2020 second quarter, possibly by design as the Centre seeks to consolidate its fiscal position. Unless aggregate demand strengthens, the heartening uptick in business investment, as reflected in the 11% year-on-year jump in gross fixed capital formation, could come to naught with capacity additions remaining underutilised and corporate captains yet again tightening their purse strings. Manufacturing PMI data by IHS Markit has another salutary warning: rising input costs could force manufacturers to raise prices adding to the general inflationary pressures in the economy and undermine the recovery. Policy makers need to ramp up demand-supportive measures including increasing government spending to ensure that the recovery sustains and gains traction.

THACA – Until a few months ago, talk of inflation was little more than a murmur: dry data from the statistical office, reports tucked away in the newspaper, and an occasional commentary. Now the discussion is urgent and anxious, as news of rising price levels comes in from economies around the world, including Argentina, Brazil, Turkey, India, and, most important, the United States.

The surge in inflation in the US, the world's largest economy, is causing the greatest concern because its spill-over effects are invariably far-reaching. The trouble is that – in a debate bookended by Paul Krugman and Olivier Blanchard – no one fully understands what is happening. Krugman thinks the current inflationary pressure is a short-term episode triggered by supply-chain disruptions, while Blanchard sees it as the result of the large spending under President Joe Biden's American Rescue Plan, and as a prelude to a longer battle.

a prelude to a longer battle. Unlike Krugman, I believe that rising US inflation, currently at a 30-year high of 6.2%, is caused by this big spending package. But I also believe, contrary to Blanchard, that Biden's policy intervention was right, and that higher inflation is a price worth paying for the benefits the rescue plan has brought, particularly to the most vulnerable Americans.

This relief is reflected in the latest US data. During three months preceding September, the US saw higher wage increases than any time in the last 20 years. Workers have gained a stronger bargaining position, and have even stayed away from the labor market when their wage demands have been unmet.

To be sure, US policymakers will have to navigate some difficult terrain ahead, because the COVID-19 crisis has left many open wounds. A recent University of Michigan survey found that one-quarter of Americans expect their financial situation to worsen in the near term, a level of pessimism not seen since the Great Recession of 2008-09. All this is cause for global worry, because a US slowdown with elevated inflation will have adverse effects worldwide.

The US Federal Reserve will likely have to raise interest rates more sub-

stantially than it is currently indicating (which no doubt reflects a desire to discourage speculative dollar appreciation). But the US has expertise enough to pull out of this inflationary period, and its monetary and fiscal policies are broadly on the right track. Other important economies, such as Turkey and Brazil, face a direr situation. Turkey currently has an alarming annual inflation rate of 19.9%. Making matters worse, President Recep Tayyip Erdo an has strong (and wrong) views about how to control inflation. He believes the right response is to reduce interest rates. This can very occasionally be the right policy, such as when there is a lot of carry trade. But it is not the correct response now. It is thus not surprising that the Turkish lira has been losing value sharply, prompting some to warn of a currency meltdown.

Brazil has recently joined the list of countries with double-digit price growth, with annual retail inflation of 10.7% causing huge hardship for the poor. Moreover, inept policymaking by President Jair Bolsonaro's government – the Economist recently criticized its "fiscal incontinence" – has stoked fears that the economy is on the verge of a technical recession.

Unlike in many previous global inflationary episodes, what is remarkable this time is how different the cross-country experiences have been. The reason is probably that, while the current inflationary trends have a common cause, namely, the rebound from the pandemic-induced slowdown, countries' diverse responses to this novel crisis have led to varied economic performance.

India, for example, faces an especially tricky inflation problem. Retail inflation is elevated but not at the level seen in many other economies. It rose to 4.5% in October, up slightly from 4.4% in September, and has been hovering around this range for several months. But wholesale price inflation, which increased sharply to 12.5% year on year in October, from 10.7% in the previous month, is getting out of hand and has reached its highest levels since the late 1990s.

This poses an unusual policy challenge. The wide divergence between wholesale and retail infla-

tion is evidently squeezing small manufacturers, the self-employed, and workers. Those who buy from the wholesale market and sell on the retail market are seeing their profits tumble. They are cutting back on production and this, in turn, is adversely affecting workers. If the government allows this divergence to persist on the grounds that

gence to persist on the grounds that consumers are not being badly hit, growth will likely decline as small businesses, already under strain, reduce output and cut employment - and possibly shut down. On the other hand, if the government tries to narrow the gap by letting retail inflation rise, consumers will be hit hard. Given that India was among the world's worst-affected economies during the pandemic and is only now beginning to recover, this would be a huge setback for many citizens. The only reasonable way out is for policymakers to tackle wholesale price inflation directly. This will require a combination of fiscal and monetary measures, like reducing the high tax on fuel that helps to fund government expenditures and slashing all non-essential spending (while supporting those hit hardest by the pandemic). It may also be time for the Reserve Bank of India to consider hiking interest rates.

Inflation management is no easy task. We do not fully understand the links between the world of money and liquidity, on one hand, and that of goods and services on the other. Policymakers must therefore rely on a combination of science – based on the regularities observed in the vast amounts of data available to central banks and treasuries – and judgment. But there is one thing we do know: politics must be kept out of it.

Shy Or Socially Anxious?

oes your child or adolescent find it challenging to socialize with other kids or join in groups? Is it difficult for them to have a small group of friends? Do they tend to avoid social situations in which they might be the centre of attention or stand out from the crowd, such as asking or answering questions in class? In social situations, do they appear withdrawn and take other's comments too seriously especially in social situations?

If this is the case then your child or adolescent may be developing or has developed social anxiety.

It's easy to miss signs of social anxiety especially among preschoolers or those who have recently joined school. This is due to the fact that in preschool or school, children with social anxiety are often quiet and obedient. They may not express their fears or concerns and thus social anxiety may remain unnoticed.

Physical symptoms of social anxiety include nausea, stomach aches, flush-

ing, and trembling.

Social anxiety disorder affects some children and teenagers. This is when a child's social anxiety has been present for more than 6 months and has a substantial impact on their life. SAD is characterised by intense fear and anxiety in social situations, resulting in considerable levels of distress. A child or adolescent with SAD is afraid of offending others, shame from exhibiting anxious symptoms in public, and public scrutiny and negative evaluation. SAD patients often have a high level of distress that is out of proportion to their actual social situation.

Signs Among Children

Many situations that require interaction with other people may be avoided by children with social anxiety disorder. Talking on the phone, joining teams or groups, and answering questions in class are examples of these scenarios. Severe and prolonged crying episodes, tantrums, sobbing, freezing, clutching, or withdrawing, being unable to speak in social circumstances may be the first signs of SAD in children. Somatic complaints are common (e.g., "My stomach hurts," "I have a headache"). Some children have a history of numerous physician sessions and evaluations in response to these somatic complaints. Children as young as four years old might be diagnosed with social anxiety disorder.

Signs Among Adolescents

Excessive concern before a social function or excessive preparation for a class presentation may be the earliest signs of social anxiety disorder in teens. Avoidant behaviours (e.g., refusing to attend school, refusing to attend parties, refusing to eat in front of people) may be present in the teen's life.

Adolescents with Social anxiety disorder are afraid of embarrassing themselves in front of their classmates by providing the wrong response, saying something inappropriate, becoming ashamed, or even vomiting. In certain circumstances, social anxiety disorder may develop as a result of a humiliating event. Children may refuse to chat on the phone or even leave the house in extreme circumstances. Symptoms of SAD can interfere with all aspects of a child's life, including relationships, friendships, educational pursuits etc.

Social Anxiety Behind The Scenes

SAD usually manifests in infancy or adolescence. The cause and maintenance of SAD are influenced by a number of interconnected factors such as genetic predisposition, temperament, parental factors, and environmental impacts.

Genetic Factors

There are genetic factors that might contribute to the development of SAD. A positive association has been found between development of SAD in children who have parents with SAD. When occurring at important developmental phases of life, such as infancy or adolescence, environmental stresses such as child abuse, parental separation, or early trauma may alter genetic expression of anxiety. As a result, a kid or adolescent may have important periods of susceptibility to unique environmental stresses in addition to inheriting genetic inclinations for SAD.

A growing body of evidence suggests that early personality traits are linked to the development of social anxiety later in life. Behavioral inhibition is a personality trait that makes a child feel distressed and worried in new situations. Shyness around strangers and withdrawal from new places are examples of behavioral inhibition in children. High behavioral inhibition has been found to be strongly linked with an increase in social anxiety symptoms in children. Behavioral inhibition can be seen in newborns and toddlers, and it lasts for a long period. As toddlers get older, they learn to react more rationally to new events and individuals. However, some children and adolescents will exhibit anxious behaviors throughout their lives and well into adulthood. The fear of anxiety-related physi-

cal sensations is known as anxiety sensitivity. Children and adolescents with SAD may show higher levels of anxiety sensitivity and may be more likely to see events with unclear social threats as anxiety triggering. Children and adolescents with social anxiety disorder feel that physical symptoms of anxiety would be noticed by others, resulting in embarrassment, mental incapacitation, illness, or higher anxiety level. Individuals with anxiety sensitivity not

including physical punishment and verbal aggression such as severe criticism or humiliation, has been linked to insecure attachment and an increased likelihood of social anxiety.

Research has found a pattern of maternal overprotection, paternal rejection, and decreased emotional warmth linked to SAD. Overcontrol by mothers has been linked to greater levels of social anxiety symptoms and increased chances of SAD rates during adolescence. Other negative parenting practices (for example, lack of affection, poor communicaplicit guidance on how to handle difficult peer situations. Parental modelling helps children acquire social skills including how to welcome new people.

When a child experiences a fear, a parent's natural reaction is to acknowledge the fear and protect the vulnerable child from harm. However, protecting children from fearinducing, ambiguous situations might stifle social development and increase fear. Overprotection, while well-intentioned, may prevent a youngster from being exposed to new and challenging social situations. Although there are no perfect formulas for parenting a child with social anxiety risk factors, a balance must be struck between warmth and excessive care.

Sibling Relationships:

Siblings play an important role in socialization, understanding emotions, and developing empathy. During infancy, children spend more time with siblings than with parents and friends. Research has found that adolescents who had a same-sex twin with high levels of anxiety symptoms were more likely to have

increased anxiety themselves 1 year later. In settings where children had low sibling companionship reported more psychological symptoms of SAD. Furthermore, strong sibling relationships characterized by warmth and closeness buffered the negative effects of interparental conflict and subsequent emotional insecurity and had lower chances of developing SAD.

Home Environment

Without examining the family context, a discussion of family factors

Parenting

When a child has a stable and trustworthy relationship with his or her parents, they are more likely to become independent, trust other people, and overcome difficult childhood events. Insecure parental attachment, on the other hand, leads to poorer levels of social competence in areas such as social skills, peer interactions, and social status. An insecurely attached youngster learns that they can't rely on their care-giver to be available or responsive. Insecure attachment is characterised by a wide range of negative emotion expressions, displeasure with touch, clinging, and obsession with the parent. Infants born to mothers who themselves suffer from social anxiety have higher rates of insecure attachment. Research has found that high levels of behavioral inhibition and insecure attachment significantly predicted social anxiety in teenagers. Social anxiety can be exacerbated by the separation of the mother, father, or both parents throughout childhood due to illness or marital problems. Children who repeatedly experience that their parent is unavailable or untrustworthy develop a maladaptive attitude toward future interpersonal situations or relationships based on the belief that others will not meet their demands.

Harsh parenting by either parent,

only exaggerate the significance of tion limited autonomy, and a lack of impacting the development of SAD humour) contribute to social anxiety in teenagers by inducing low self-esteem and inefficient ways of handling emotions.

Parents who themselves suffer from SAD may unwittingly contribute to their children's social anxiety. Maternal overprotection induced by their own anxiety can increase social anxiety in adolescents, whereas parental emotional warmth due to a stable emotional atmosphere can reduce chances of SAD among children and adolescents. Parental rejection and poor family climate all contributed to loneliness and decreased friendship quality and hence more chances of SAD.

Though children who are subjected to abuse may suffer from a variety of mental health issues, however, emotional abuse (defined by being screamed or yelled at, outright shaming, being put down or humiliated, or being made to feel unimportant) has been particularly found to be a significant predictor of the development of social anxiety.

Higher degrees of parental social support and acceptance have been linked to reduced levels of social anxiety, in contrast to negative parenting styles. Adolescents who have a strong bond with their mothers and fathers have reduced levels of social anxiety. It has been found that fostering open communication, including children in personal activities, and reinforcing positive behaviors can help parents reduce anxiety sensitivity in their children.

When fathers use strategies to push their young children's boundaries playfully, encourage them to step outside of their comfort zones, and employ innovative ways to play with toys, it may lead to a higher sense of self-esteem and, hence, a lower risk of social anxiety later in life.

Adolescents have been found to have lower levels of social anxiety when their parents provide ex-

would be incomplete. Childhood stressors with a significant social component, such as family interpersonal conflict, can contribute to the development of social anxiety symptoms. Conflict between the parents has been demonstrated to enhance social anxiety symptoms in children, potentially affecting their peer relationships. Witnessing violence, family mental illness, significant injury or illness of a parent, parental divorce, relocation to a different school, and separation from one or both parents have all been found to have an impact on the development of SAD. Children or adolescents who have had numerous stressful life experiences or a single, severe experience during childhood are more likely to develop SAD. Adolescents who do not have a solid family environment or who have bad parental ties are more likely to engage in conforming behaviours with their peers, which can lead to victimisation, rejection, and heightened social anxiety. Emotional intimacy and frequent interaction with family members, especially immediate family members, grandparents, and other relatives, has been shown to protect children and adolescents from developing SAD. Peer acceptance and support has been demonstrated to reduce social anxiety. In adolescence, higher teacher support has been linked to reduced chances of social anxiety and more assertive behavior with peers. Finally, providing cumulative emotional support to children and adolescents across many contexts such as family, friends, and school has been identified as a method for reducing loneliness and social anxiety.

Vaccines? Booster Jabs? Economic Crisis? What's Next For Covid Pandemic

he world could see the Covid pandemic begin fading next year into an endemic disease like others humanity lives with, unless glaring inequality in vaccine access drags it out and worse variants emerge.

Even as countries scramble to address a new worrying virus variant and Europe battles a winter resurgence, health experts say that taming the pandemic over the next year is possible.

All the know-how and tools needed to bring the virus under control exist, with ballooning stocks of safe and effective vaccines and new treatments becoming available.

But it remains unclear if we will make the hard choices needed, or allow the pandemic to continue to rage, potentially opening the way to a far worse situation.

"The trajectory of this pandemic is in our hands," Maria Van Kerkhove, the World Health Organization's top expert on the Covid crisis, told reporters recently.

Can we "reach a state where we have gained control over transmission in 2022? Absolutely," she said. "We could have done that already, but we haven't."

A year after the first vaccines came to market, more than 7.5 billion doses

have been administered globally.

And the world is on track to produce some 24 billion doses by next June -more than enough for everyone on the planet. But a dire lack of vaccines in poorer countries and resistance among some to get jabs where they are available have left nations vulnerable as new, more transmissible variants like Delta have sparked wave after wave of infection.

And so the scenes of intubated patients in overcrowded hospitals and long lines of people scrambling to find oxygen for loved ones have continued.

Images of improvised funeral pyres burning across a Delta-hit India have epitomised the human cost of the pan-

Officially, more than 5.1 million people have died worldwide, although the



WHO says that the actual toll is likely two to three times that figure.

In the United States, which remains the worst-affected country with close to 800,000 deaths, the constant flow of short obituaries on the FacesOfCovid Twitter account include many who did not have the jab.

"Amanda, a 36-year-old math teacher in Kentucky. Chris, a 34-year-old high school football coach in Kansas. Cherie, a 40-year-old 7th-grade reading teacher in Illinois. All had an impact in their communities. All deeply loved. All unvaccinated," read a recent post.

'Part of the furniture'

Two years after the virus first surfaced in China, countries are still bouncing between opening up and reimposing restrictions.

Anti-vax protests are rocking a number of countries in Europe, once again the pandemic epicentre, amid fresh lockdowns and looming mandatory vaccination.

Despite such scenes, many experts suggest the pandemic phase will soon

Covid will not fully disappear, but will become a largely controlled endemic disease that we will learn to live with, like the flu, they say.

It will basically "become part of the furniture", Andrew Noymer, an epidemiologist at the University of California

Top US infectious disease expert Anthony Fauci has also said increased vaccination should soon get us to a point where Covid "might occasionally be up and down in the background but it won't dominate us the way it's doing

right now". 'Mvopic'

But glaring inequity in vaccine access remains a towering challenge.

About 65 percent of people in highincome countries have had at least one vaccine dose, but just over seven percent in low-income countries, UN numbers show

Branding the imbalance a moral outrage, the WHO has urged wealthy countries to refrain from providing booster shots to the fully vaccinated until the most vulnerable everywhere have received their first jabs -- but to no avail.

Health experts stress that allowing Covid to spread unabated in some places dramatically increases the chances that new, more dangerous variants could emerge, placing the entire world

Putting such fears even more in focus was the emergence last week of Omicron, a new concerning Covid variant first detected in southern Africa.

The WHO has warned it poses a "very high" risk globally, although it remains unclear if it is more contagious, dangerous or better at dodging vaccine protections than previous variants.

ith Bitcoin, there is a limited amount of bit-coins in the system (21 million) and the rewards for mining decrease over time, although miners are still incentivized because they can receive a portion of the transaction as a fee. "The ideal goal of Bitcoin was one vote per CPU. That has ultimately been subverted," says Juels. "People are using specialized mining hardware to participate in the system." As bitcoin mining heated up, people developed and burned through specialty hardware, guzzling up electricity and creating tons of waste.

"Proof-of-work still functions according to the original principle of requiring an investment of resources in order to participate in the system to mine blocks," Juels notes. Meanwhile, in proof-of-stake

systems, you pay to play, and have to stake tokens as a resource investment to participate, like putting in a security deposit that you get back once the transactions you added to the blockchain are approved by the network. The system chooses a staker who is online at the time randomly and they get to validate the transactions and receive the rewards. Because it doesn't require solving puzzles, in theory, it should use

"In Bitcoin, your participation in the system is proportional to the amount of computation you do," says Juels. 'In a proof-of-stake system, it's proportional to the amount of cryptocurrency you hold in the system."

"Typically the way that [both proof-of-work and proof-of-stake] systems work is that the rights to create the next block is determined randomly in a kind of lottery where your chances of winning the lottery are proportional to your resources," he adds.

efficient, many experts have concerns about its stability and the barriers to entry. "In Bitcoin, you can just start mining, in principle, with your laptop. You wouldn't do very well, but you can join the system without any type of previous investment of resources," says Juels. "In the case of these proof-ofstake systems, you need to go buy some coins to participate, or be assigned the coins at the outset of the protocol. There are some people who object to the need to obtain coins in order to participate to begin with, but that is a necessity.'

Alternatively, a cryptocurrency project called the XRP ledger uses a consensus protocol unlike proof-of-stake or proof-of-work that's almost democratic-but validators do not receive any rewards.

What about proof-of-storage? There's another concept to know, too. Proof-of-storage (otherwise known as proof-ofspace) is where you're committing an amount of space for storage in the network. "The idea initially was digital preservation-we want to record everything, so at least we can use the disk space for a good purpose. It turns out it's less needed than we thought," says Christin. "There's a need for digital preservation but it doesn't scale as quickly as a currency would." Juels proposes that these systems could potentially be useful for storing data from NFTs. One project testing out this concept is Filecoin.

Russia Sends Missiles Near Pacific Islands Claimed By Japan

Moscow: The Russian military has deployed coastal defense missile systems near Pacific Islands also claimed by Japan, a move intended to underline Moscow's firm stance in the

The Bastion systems were moved to Matua, a deserted volcanic island in the middle of the Kuril Islands chain. Japan claims four southernmost islands.

Russia's Defense Ministry posted a video Thursday showing massive missile carriers moving ashore from amphibious landing vessels and driving along the coast of the volcanic island to take firing positions as part of drills.

The ministry said the deployment involved setting up living quarters for personnel, hangars for the vehicles and other infrastructure.

The Bastion is capable of hitting sea targets at a range of up to 500 kilometres (270 nautical

The deployment followed a series of moves by Russia to beef up its military presence on the Kuril Islands,

In 2016, it stationed the Bal and the Bastion coastal defense missile systems on two of the four southernmost Kuril Islands. In the following years, it followed up by sending top-ofthe-line air defense missiles systems there and setting up an air base on the Iturup Island where fighter jets were deployed.

Japan asserts territorial rights to the four southernmost islands of the Kuril chain and calls them Northern Territories.

The Soviet Union took the islands in the final days of World War II, and the dispute has kept the countries from signing a peace treaty formally ending their hostilities.

The oval-shaped, 11-kilometre-long (6.8-mile) island where the Russian missiles were deployed hosted a Japanese military base during WWII.

After the Soviet takeover of the Kuril Islands, Matua was home to a Soviet military base that was closed amid funding shortages in the wake of the 1991 collapse of the Soviet Union.

Asked about the missile deployment, Kremlin spokesman Dmitry Peskov said that Russia has a sovereign right to deploy its military forces wherever it deems necessary on its territory.

At the same time, he noted that Russia values relations with Japan and remains committed to efforts to negotiate a settlement of the dispute.

Back In Spain, Ancelotti Has Madrid Back On Title Track

MADRID: Relying on Karim Benzema's feet and Thibaut Courtois' hands, Real Madrid is back on course to winning titles in its second stint under veteran coach Carlo Ancelotti.

Madrid's 1-0 victory over Athletic Bilbao on Wednesday increased its lead of the Spanish league to seven points over defending champion Atlético Madrid and surprise chaser Real Sociedad.

On Saturday, Ancelotti's side travels to San Sebastián with the mission of leaving Sociedad even further behind and adding to its streak of seven consecutive victories across all competitions.

"The fact that we've won seven games in a row doesn't come down to luck," Ancelotti said. "When we can't use our quality in one area we can use another quality.'

Benzema's goal just before halftime took his league-leading tally to 12 in 14 games. Courtois did the rest by making several good saves to frustrate a Bilbao side that outplayed Madrid



in the second half.

"Courtois is playing out of his mind," said Ancelotti, comparing him to other great goalies the Italian has coached in his long career. "We've got Courtois and

we should relish that," Ancelotti said. "It's difficult

to say who is the best goalkeeper I've played with. I've got a list of great goalkeepers: (Iker) Casillas, Diego López, (Gianluigi) Buffon, (Manuel) Neuer and (Petr) Cech. Courtois is right up there at the moment."

It was a mild surprise

June when Madrid president Florentino Pérez picked Ancelotti to replace Zinedine Zidane following the team's first trophyless season in more than a decade. Pérez fired Ancelotti in 2015, a year after he led Madrid to its 10th European Cup. Since then he appeared to have fallen out of the European coaching elite with his last job being at Everton.

Despite an embarrassing home loss to Moldavian side Sheriff i n the Champions League, Ancelotti has so far succeeded in getting Madrid back on track.

The visit to Sociedad will start an intense run of three games in eight days for Madrid. Madrid will host Inter Milan on Tuesday to determine which will advance as the winner of their ChampionsLeague group. following weekend Atlético visits the Santiago Bernabéu in a Spanish capital derby that promises to prove important to the domestic title fight.

"It's non-stop," Courtois said, "and we're going to try to get some rest as we look to keep on winning."

Israel Halts Controversial Tech To Track Omicron Variant

JERUSALEM: Israel said Thursday it was halting the use of a controversial phone tracking technology to trace possible cases of the new coronavirus variant.

Earlier this week, the government approved travel restrictions and authorised the country's internal security agency to use the phone monitoring technology for contact tracing people infected by the omicron variant in Israel.

Prime Minister Naftali Bennett's office said in a statement that emergency measures authorising cellular monitoring" of people who are infected by omicron, and those who might have been in contact with those cases, would expire at midnight.

The decision to reverse course on the Shin Bet's tracking came after the Cabinet approved the practice under an emergencv measure on Tuesday. A government ombudsman had spoken out against implementing the technology, arguing that it was ineffective. Health Minister Nitzan Horowitz said on Twitter that from the beginning I noted that use of this tool would be limited and brief for a few days, in order to get urgent information to halt infection with the new, unknown variant.

He said that alongside protecting health, we must protect privacy and human rights, even in a time of emergency."

Israeli rights groups had decried the use of the technology, which can track where a person has been and whom he has met, as a violation of privacy rights. The Supreme Court ruled earlier this year that its use be limited.

Mehta, he said, also stated that human trafficking almost always has a narco/drug dimension. which has been seen to have linkages with terrorism in the UT.

Expressing his concern at the incident, Dr Mehta, as per the official spokesperson directed that joint teams of social welfare education department, Magistrates from DC office and police be set up to verify the records of nari ashrams, bal ashrams, concerned NGOs and trust and orphanages and asked the social welfare department to coordinate the synergised departmental response in the matter.

He said that the Secretary, social welfare department informed that the matter has been taken up with IGP, Kashmir to ensure immediate legal action under the relvant laws.

"It was further informed that child welfare committees have been asked to meet Covid orphans identified by the department and submit a report to the department," the official spokesperson said.

Mehta, he said, directed social welfare department to conduct audit of the numan re source and the accounts of these centres for the last 5 years.

"He asked the social welfare department to obtain the report regarding the welfare of covid orphans from the field and share it with his office by Thursday evening," he said.

"The Chief Secretary asked the Home department to ensure that every such centre was inspected by the nearest police station in the UT and a report shared by them with the Home department by evening," he added

According to the official spokesperson, Director I&C. Jammu informed the meeting that there are around 6000 such NGOs registered in I&K that deal with child and women welfare in the UT,

He said it was further informed that post reorganisation of the J&K State into UTs of J&K and Ladakh, the department has begun the process of re-registering these societies under the central act. "So far less than 1000 societies have been re-

registered and their details are also available on the Darpan portal," the official spokesperson said, adding "Dr Mehta also advised the I&C department to share the list of all NGOs operating in the space with the SWD and police department.

The Chief Secretary, as per the official spokesperson also directed that the SWD should get the verification of 6000 NGOs done in concert with district administration and PRIs within a month and shared the findings with the government.

"The Chief Secretary asked the I&C department to put all those NGOs, which have not reregistered, on notice stating that if they do not re-register within 15 days, they will no longer be allowed to operate," he said.

"He also directed I&C department to share the details of those NGOs, which don't re-register, with the district and divisional administration so that appropriate law enforcement action is initiated against them," he added.

According to the official spokesperson, the Chief Secretary asked the SWD to take steps in consultation with the health department to verify all the children's hospitals/gynecological sections/ neonatal sections of the hospitals in the UT within the next fifteen days.

Mehta, he said, also directed the Law Department to seek details of the trusts operating in the space for the last 10 years from the judiciary for the purpose of their verification.

"The Chief Secretary laid emphasis on tracking cases of child/women trafficking in the cyber domain and asked the Home department to ensure proper cyber surveillance though anti trafficking units of the police department

in both the divisions," he said "Stating that begging and trafficking

Replying to another related question as to what has changed in J&K since August 2019; the LG said that 11000 candidates have secured government jobs in the most fair and transparent recruitment process in the history of I&K. He also said that average income of farmers in J&K is around Rs 19000, which is fifth highest in the country.

Back In Spain, **Ancelotti Has Madrid Back On Title Track**

MADRID: Relying on Karim Benzema's feet and Thibaut Courtois' hands, Real Madrid is back on course to winning titles in its second stint under veteran coach Carlo Ancelotti. Madrid's 1-0 victory over Athletic Bilbao on Wednesday increased its lead of the Spanish league to seven points over defending champion Atlético Madrid and surprise chaser Real Sociedad. On Saturday, Ancelotti's side travels to San Sebastián with the mission of leaving Sociedad even further behind and adding to its streak of seven consecutive victories across all competitions.

"The fact that we've won seven games in a row doesn't come down to luck," Ancelotti said. "When we can't use our quality in one area we can use another quality.'

Benzema's goal just before halftime took his league-leading tally to 12 in 14 games. Courtois did the rest by making several good saves to frustrate a Bilbao side that outplayed Madrid in the second half.

"Courtois is playing out of his mind," said Ancelotti, comparing him to other great goalies the Italian has coached in his long career.

"We've got Courtois and we should relish that," Ancelotti said. "It's difficult to say who is the best goalkeeper I've played with. I've got a list of great goalkeepers: (Iker) Casillas, Diego López, (Gianluigi) Buffon, (Manuel) Neuer and (Petr) Cech. Courtois is right up there at the moment.'

It was a mild surprise in June when Madrid president Florentino Pérez picked Ancelotti to replace Zinedine Zidane following the team's first trophyless season in more than a decade. Pérez fired Ancelotti in 2015, a year after he led Madrid to its 10th European Cup. Since then he appeared to have fallen out of the European coaching elite with his last job being at Everton.

Father's Responsibility Of Child Continues Till Adulthood: Supreme Court

NEW DELHI: The Supreme Court on Wednesday said that in a dispute between husband and wife the liability and responsibility of the father to maintain the child continues till the son attains the age of majority.

The top court, which exercised its plenary power under Article 142 to confirm the divorce decree awarded to the husband and wife by the family court and the High Court directed that the child be provided 50,000 maintenance by the father.

It also noted that the estranged couple has not been staying together since May 2011 and therefore it can be said that there is an irretrievable breakdown of the marriage between them.

A bench of Justices MR Shah and AS Bopanna said, "therefore, in the facts and circumstances of the case and in the exercise of powers under Article 142 of the Constitution of India, the decree passed by the Family Court, confirmed by the High Court, dissolving the marriage between the appellant-wife and the respondent-husband is not required to be interfered with on account of irretrievable breakdown of marriage".

It said that at the same time, the husband, an Army officer, cannot be absolved from his liability and responsibility to maintain his son till he attains the age of majority. "Whatever be the dispute between the husband and the wife, a child should not be made to suffer. The liability and responsibility of the father to maintain the child continues till the child/son attains the age of majority. It also cannot be disputed that the son has a right to be maintained as per the status of his father", the bench said.

The top court noted that the mother is not earning anything and she is residing at her parental house at Jaipur and therefore, a reasonable/sufficient amount is required for the maintenance of her son including his education and other expenses which shall have to be paid by the husband, irrespective of the decree of dissolution of the marriage between the wife and the husband.

It further noted that the amount which was being paid under the order passed by the Army authorities on November 15, 2012, has also been stopped by the respondent-husband since December 2019.

"The respondent-husband is directed to pay Rs.50, 000 per month with effect from December 2019 to the appellant-wife towards the maintenance of the son as per the status of the respondent herein. The arrears @ 50,000 per month from December 2019 to November 2021 shall be paid within a period of eight weeks from today", it said.

Govt Decides Not To Resume Scheduled Int'l Flights From Dec 15

The government on Wednesday decided not to resume scheduled international flights from December 15, less than a week after announcing the decision in the wake of rising concerns over the coronavirus variant Omicron.

Aviation watchdog DGCA said the effective date for resumption of scheduled commercial international passenger services will be notified in due course. Scheduled international flights remain suspended since March 23, 2020, due to the coronavirus pandemic.

The latest move also comes after Prime Minister Narendra Modi on November 27 asked officials to review the plans for easing international travel restrictions amid concerns over Omicron.

In a circular on Wednesday, DGCA said in view of the evolving global scenario with the emergence of new Variants of Concern, the situation is being watched closely in consultation with all stakeholders.



"...an appropriate decision indicating the effective date of resumption of scheduled commercial international passenger services shall be notified in due course," the Directorate General of Civil Aviation (DGCA) said.

The watchdog also referred to its circular issued on November 26 wherein it was decided that scheduled international flights will resume from December 15.

On November 28, a day after the Prime Minister's directions regarding the easing of international travel curbs, the

government had said the decision to resume the services will be reviewed.

While no cases of Omicron have been reported in India so far, the authorities have put in place stricter norms for international passengers.

On November 29, Civil Aviation Minister Jyotiraditya Scindia said the situation was being closely monitored and reviewed in consultation with other ministries regarding "any further decision" on resuming scheduled international passenger services.

India Hits Out At UN Body For Comments On Khurram Parvez

NEW DELHI: India on Thursday hit out at the UN human rights body for its "baseless" allegations against it over the arrest of an activist in Jammu and Kashmir, and asserted that the comments "betray" a complete lack of understanding of the security challenges in the region in view of cross-border terrorism.

Arindam Bagchi, the spokesperson in the Ministry of External Affairs (MEA), said authorities in India act against violations of law and not against legitimate exercise of rights.

Bagchi's comments came in response to a statement made by the Spokesperson of the Office of the High Commissioner for Human Rights (OHCHR) over the arrest of Kashmiri rights activist Khurram Parvez.

"We have seen the statement made by the spokesperson of the Office of the High Commissioner for Human Rights (OHCHR) on specific incidents in Jammu and Kashmir.

The statement makes baseless and unfounded allegations against law enforcement authorities and security forces of India," he said.

On Wednesday, OHCHR spokesperson Rupert Colville expressed deep concern over the arrest of Parvez and even called for "prompt, thorough, transparent" investigations" into the recent incidents of killings of civilians in J and K. "We are deeply concerned at the arrest of Kashmiri human rights defender Khurram Parvez under Indian counter-terrorism legislation, the Unlawful Activities Prevention Act (UAPA)," Colville said in a statement.

Rejecting the comments by the UN official, Bagchi said as a democratic country, with an abiding commitment to promote and protect the human rights of its citizens, India takes all necessary steps to counter cross-border terrorism.

"It also betrays a complete lack of understanding on the part of the OHCHR of the security challenges faced by India from crossborder terrorism and its impact on the most fundamental human right, 'the right to life' of our citizens including in Jammu and Kashmir," he said.

"Referring to proscribed terrorist organisations as 'armed groups' demonstrates a clear bias on the part of OHCHR," the MEA spokesperson said.

Bagchi said national security legislations, like the Unlawful Activities (Prevention) Act, 1967 (UAPA) were enacted by Parliament to protect the sovereignty of India and ensure the security of its citizens.

"The arrest and subsequent detention of the individual referred to in the statement was done entirely as per provisions of law," he said

Delhi Schools To Be Closed Till Further Orders Due To Pollution

NEW DELHI: Delhi Environment Minister Gopal Rai on Thursday said physical classes in schools in the national capital would be suspended from Friday till further orders in view of an increase in the air pollution levels.

The decision came after the Supreme Court on Thursday pulled up the Delhi government for resuming physical classes in schools amid a rise in the air pollution levels in the city.

"We had reopened schools considering the forecast that air quality would improve. However, the air pollution levels have increased again and we have decided to shut schools from Friday till further orders," Rai said.

After remaining shut since November 13, physical classes in schools, colleges and other educational institutions had resumed from Monday. PTI

In-Person Student Attendance In Schools May Drop By 14 Per Cent Due To Omicron Threat

NEW DELHI: Schools in India are likely to see a 14 per cent drop in students attending in-person classes due to concerns sparked by 'Omicron', the new variant of coronavirus, according to a nationwide survey.

The findings of a nationwide survey conducted by online platform LocalCircles indicate the number of parents not sending their ward to school for in-person classes are likely to rise.

"In a week, over 25 countries have reported the presence of Omicron with scientists confirming that it is more transmissible than the Delta variant and could evade vaccines up to some extent.

"The survey, which received 15,875 responses from parents residing in 308 districts of India, finds that schools in the country are likely to see a 14 per cent drop in students attending in-person classes," it stated. The survey mentioned that doctors in South Africa, where the 'Omiron' variant was first reported, have found a higher number of Covid cases of the new variant in the population aged under 25 years.

The World Health Organisation has designated the new SARS-Cov-2 variant as a 'variant of concern'.

According to the survey findings, 58 pc of parents will be sending their children for inperson classes till this week.

The remaining 32 per cent are parents mostly with younger children and for about 10 per cent of parents, schools that their children go to have not resumed in-person classes yet, it said.

Furthermore, of the 58 per cent of parents sending children to school, 14 per cent will stop doing so because of the Omicron threat.

"While no case of Omicron has been traced in India yet, once the first case is reported in India, another five per cent of parents are likely to stop sending children to school. Once multiple cases are reported another five per cent are likely to do so leaving only 34 per cent of parents still sending children to school.

Army To Introduce New Combat Uniform From Next Year

NEW DELHI: The Army is set to introduce a light and more climate-friendly combat uniform for its personnel from next year, people familiar with the matter said on Thursday.


The new camouflage uniform will be based on a "digital disruptive" pattern and they are expected to be showcased at the Army Day parade on January 15, they said.
