Coronavirus: JK reports two deaths, 181 new cases

Kashmir Friday reported two deaths and 181 fresh positive cases taking the number of total active cases in the Union Territory to 1,708.

With two more deaths, the death toll in the UT stands at 4,479 and 181 fresh positive cases reported on Friday have pushed the tally of positive cases to 337,444. Of the exact number of

337,444 cases, 212,187 are from Kashmir division and 125,257 from Jammu division. Officials said that among 181 new cases, 124 belong to Kashmir division while as 56 are from Jammu division, adding that the total number of positive cases in Kashmir division have reached to 212,187 including 208,588 recoveries and 2,294 deaths while as total number of positive cases in Jammu division have reached to 125,257 including and 31 from Reasi," officials 122,669 recoveries and 2,185 deaths

total number of active cases in Jammu and Kashmir are 1,708 including 1,305 from Kashmir division and 403 from Jammu division.

With 168 more recoveries, the tally of total recoveries in Jammu and Kashmir has reached 331,257 which is 98.17 nagar, 25,529 including 288 percent of the total cases.

RT-PCR test mandatory for all international arrivals

Srinagar, Dec 3: Amid the threat of a new Covid variant, authorities have made the RT-PCR test mandatory for all international arrivals at Srinagar International Airport and samples of positive cases must be sent for genome sequencing. Moreover, authorities have asked the people arriving from "At-Risk" nations to remain in home quarantine for seven days after testing negative for Covid-19, besides persons coming from not at risk nations after testing negative must monitor themselves for at least two weeks carefully. An order issued by State Executive Committee under section 24 of the Disaster Management Act, 2005, reads that rigorous screening and conduct of Covid-19 RT-PCR test shall be made mandatory at the Srinagar International Airport for International arrivals as per the guidelines issued from time to time by MoHFW. "Any person found Covid19 positive shall be

PDP sought votes to keep BJP away, joined hands with same party later: Azad

Jammu, Dec 3: Senior Congress leader Ghulam Nabi Azad Friday said that PDP sought votes from people of Jammu and Kashmir to keep BJP away but later the same party entered into an alliance with the BJP in 2018 and the results are well before the masses.

He said perhaps J&K is the only place that has been under Governor and Lieutenant Governor's rule most of the time in India. Addressing a gathering at Rajour, Azad said that almost all the political leaders have deceived people of J&K by raising hollow slogans and breaking the promises made to the

"Today, we have reached a stage where a common citizen of J&K is totally unhappy with the political leaders and is angry as well," he said.

He said that it was because majority



of the political leaders while playing the politics of deceit to become Chief Miniser, MP, MLAs mislead people.

"When we are witnessing LG rule, the political leaders who cheated people are silent," he said. He said that PDP sought votes from people to keep BJP away from

political arena but later joined the hands with the same party to form the government in 2018. "Results are well before people of J&K," Azad said.

He said that during Governor and LG rule, it is the bureaucracy that rules the people actually. "But in a democracy, there is no place for bureaucracy to rule people," Azad said.

He said there is inflation across J&K and the example was during Congress rule cooking gas cylinder would cost Rs 450 but today the same is sold at Rs 1100. "Petrol, diesel, vegetables, fruit, oil prices are touching new heights, Azad said, adding that unemployment is rising each day.

He said termination of government employees should stop, eviction of people from forest and state land should also

Three years on, 25 per cent work still pending at GMC Baramulla

Srinagar, Dec 3: Despite passing of nearly three years, the Jammu and Kashmir Projects Construction Corporation (JKPCC) has completed only 75 percent of work of Government Medical College (GMC) Baramulla.

The corporation is likely to miss the deadline for the completion of the project.

Till November-2021, JKPCC was yet to complete around 25 percent of the works.

The Divisional Commissioner Kashmir, P K Pole in a meeting held earlier this week was informed that the revised completion deadline of the project was December-2021. "However, only 75 percent of progress has been achieved till date and work on the project is in full

In the meeting, Pole was also apprised that out of eight blocks, four will be ready by the end of December-2021.

Sources said that the concerned authorities have informed the Divisional Commissioners office that army authorities have raised objections to the construction of a multi storied



administration building.

"The army authorities, JKPCC and the District Administration are on board and will take some time for its resolution," the concerned authorities told Pole

Stop politics on oxygen shortage: Mandaviya to opposition

New Delhi, Dec 3 (PTI): Union Health Minister Mansukh Mandaviya on Friday asked the opposition parties to stop playing politics over oxygen shortage during the second wave of COVID-19 infections and take note of the Centre's efforts to ramp production of the life-saving gas to meet the surge in demand.

Addressing the Lok Sabha during the Question Hour, he said the Union government made "all possible efforts" to ensure the availability of oxygen and increased its production following a rise in demand during the second wave of the pandemic.

"Sadly, even in such a situation, many people did not refrain from playing politics... I appeal, take note



of our honest efforts. This is not a subject of politics," he said in reply to a question on the issue raised by Congress MP Suresh Dhanorkar.

Mandaviya also hit out at the opposition over claims about deaths due to oxygen shortage during that period, saving the Centre sought from states data on the matter and only the Punjab government replied that there were four suspected cases of such deaths and a probe into them was underway.

"I want to say that Prime Minister (Narendra Modi) had said at the chief ministers' meeting that there was no need to hide the number of deaths due to shortage of oxygen shortage. It (numbers) should be reported,' the Union Health Minister

The Centre wrote to states thrice, requesting them to provide data on the number of people who died due to shortage of oxygen, Mandaviva said.

"A total of 19 states responded and it's only Punjab which stated in writing that four suspected deaths were there (in the state) and that too being investigated. We made it public. Still, politics is happening," he added.

Man lynched in **Jharkhand** village, 4 held

Giridih, Dec 3 (PTI): A man was allegedly lynched by a group of people in a village in Jharkhand's Giridih district on suspicion of being a thief, police said on Friday.

The incident took place in Khetko village on Tĥursday night, they said.

Four people have been taken into custody in this connection as per directions of Giridih Superintendent of Police, Amit Renu, an officer said.

Bagodar Police Station in-charge Saroj Kumar Choudhary said three people suspected to be thieves had entered the village on Thursday, but two of them managed to escape.

The deceased could not be identified yet, he said, adding, further investigation is underway.

Deep depression intensifies into Cyclone 'Jawad', to make landfall around Puri on Dec 5 intensify into a severe cy-

New Delhi, Dec 3 (PTI): A deep depression in the Bay of Bengal has intensified into cyclonic storm 'Jawad', the India Meteorological Department said on Friday.

The cyclonic storm is likely to reach the westcentral Bay of Bengal off the coast of north Andhra Pradesh and Odisha by Saturday morning, IMD Director General Mrutyunjay Mohapatra said.

Thereafter, it is likely to recurve north-northeastwards, move along the coast of Odisha and adjoining Andhra Pradesh and touch the coast around Puri by December 5 noon, according to the weather department.

The name of the cyclone 'Jawad' - has been proposed by Saudi Arabia.

A low-pressure area had developed over the Andaman Sea on November 30. It intensified into a depression on December 2 and further into a deep depression on Friday morning. It turned into a cyclone on Friday noon, the IMD DG said.

rainfall is likely to increase on Saturday, he said.

Air quality panel for Delhi issues new orders, edu institutions to be shut

New Delhi, Dec 3 (PTI): In a new set of directions to prevent further deterioration of air quality in Delhi and the National Capital Region (NCR) the Centre's air quality panel on Friday ordered shutting of educational institutions, allowing only online mode of education. The Commission for

Air Quality Management (CAQM) also directed that industrial operations and processes in NCR, not running on Piped Natural Gas or other cleaner fuels, shall be allowed to operate only up to eight hours a day from Monday to Friday and shall not be allowed to run on

weekends All schools, colleges and educational institutions in the NCR shall remain closed, allowing only online mode of education, except for the purpose of conduct of examinations and laboratory practical, the commission said.

It also said its earlier di-



rections on industries shall continue. According to these directions, all industries in NCR, still using unapproved fuels, shall be closed by the governments respective with immediate effect. Also the NCR states and the Government of National Capital Territory of Delhi (GNCTD) shall enforce a strict ban on use of diesel generators, except for emergency services.

In its new directions, the commission also stopped the entry of trucks in Delhi, except the electric ones and those running on Compressed Natural Gas, besides trucks carrying essential commodities

The commission directed that the chief secretaries of the respective states and the Delhi government shall ensure implementation of these directions.

Strict enforcement of these directions as also the directions/orders issued by the commission from time to time since its inception shall be ensured by the respective agencies and implementation, compliance of the same shall be monitored by the

Pertinently, during the recent UT level review of National TB Elimination Programme by the Lieutenant Governor emphasis was laid on preparation of detailed action plan (micro level) from block to UT level besides conducting TB testing, notification of TB cases and disbursement of DBT under Nikshy Poshan Yojana and holding detailed reviews twice in a month along with CO-VID assessment.

MD, while discussing action plan for TB Elimination in the UT, exhorted upon the concerned officers to ensure implementation of decisions taken in the review meeting chaired by Lieutenant Governor.

He directed the officers and officials associated with TB control programme to launch a massive door to door aware-

ness campaign regarding Tuberculosis simultaneously with the ongoing Har Ghar Dastak campaign being carried out for COVID vaccination and distribution of Ayushman Bharat Golden Card. He also asked for involving panchayats, youth clubs and schools in the campaign of conducting household surveys for Tuberculosis.

M.P Singh, who heads the Income Tax Department in Jammu & Kashmir and Ladakh as the Principal Commissioner of Income Tax, Srinagar (PCIT). The District Magistrate of Pulwama, Baseer ul Haq Chaudhary and officers of the CGST Department were also present.

The interaction was with repre-

sentatives of the local youth, representatives from the trade community, industrialists, saffron growers, small shopkeepers & businessmen in large numbers. Along with spreading awareness amongst the taxpayers regarding Income Tax Slab rates, the PCIT urged the audience to contribute to the process of Nation Building as honest and proud tax payers.

Principal Commissioner of Income Tax further emphasised that economic development without financial discipline cannot bring self respect among people. The first step towards



financial discipline is to pay their due taxes and file their ITRs which is a very essential process. The department accepts the ITRs as such in 99% cases and in the territories like J&K, less than 0.2% returns are scrutinised that too under the watchful eyes of senior most authorities. He reiterated that there is no scope of any bias or harassment any more under the new transparent and accountable tax regime.

He further spoke about the Faceless Scheme under which all scrutiny proceedings would be conducted online to ensure smooth compliance and transparency of the proceedings. Shri M.P Singh emphasised that for redressing the genuine grievances of the tax payers, officers are resolved to go the extra mile, sit for late hours and are actually doing so.

Beyond this foodback from the

Beyond this, feedback from the people was taken by the officers regarding taxation issues and their aspirations from the Union Budget. The local traders and small shopkeepers were also informed about sections of the Income Tax Act, 1961, under which they can avail of the presumptive taxation scheme under which no books of accounts are required to be maintained and taxable income is calculated on presumptive basis.

With regard to the Union Budget the locals gave their ideas and suggestions, centric to Pulwama district. Increased focus on industrialisation of Pulwama along with tax benefits for the same was highlighted by the locals. In this regard, the District Magistrate of Pulwama intimated that various subsidies to the tune of Rs. 3600 crore are given to the industrial sector, which has created employment opportunities for more than 37000 people.

Why the suspended MPs will not apologise

he Opposition came to the Winter Session with the hope that, for once, the government would honour Parliament and its ethos by engaging in debate and discussion about the issues affecting the lives of Indian citizens. The customary all-party meeting held by the government and the short speech made by Defence Minister Rajnath Singh fed that hope. Some of us wondered whether such a significant all-party meeting held such little regard for the Prime Minister that it could be skipped. Our surprise was short-lived because we have now learnt from our collective experience since 2014, that under Modiji, Parliament and its proceedings do not require much attention. His presence in the House is so rare that even the treasury benches make it a point to vociferously cheer and applaud him on the rare occasions that he

On the morning of the first day of the session, the PM proudly claimed, in a public address, that he and his government would answer all questions and issues raised by the Opposition. The promise proved hollow. The government passed the farm laws' repeal bills without any discussion in both Houses on the same day. It justified this action by claiming that a discussion was not required as the repeal had long been demanded by the Opposition. But our reading of parliamentary procedure tells us that once a bill is introduced. it becomes the property of the House. In pursuance of that principle, the Opposition vehemently demanded a discussion and debate. It appears that this government believes that bills can be passed in Parliament without discussion or scrutiny — and they can be repealed in the same manner.

After the repeal of the anti-farmer Acts, the government cleverly planned a diversionary tactic. It brought a motion to suspend 12 MPs, including me, from the House. It is quite unusual that in the name of events in the previous session, disciplinary action is being taken in the current one. Government voices are now justifying the suspension based on the report of a "committee" that was constituted to look into the events of August 11. However, the said committee's functioning was unknown to anyone and neither it, nor its report, finds any mention in the resolution.

Assuming the committee existed, not one suspended MP was given the opportunity to be heard, violating all principles of natural justice.

Such abuse of parliamentary practices are not exceptions under the BJP government. Parliament has been turned into a law-making factory where the brute force of majority overpowers all norms and procedures. The "disrupted" Monsoon Session has been strategically placed at the door of the Opposition, while forgetting that for the entirety of the session, the Opposition demanded, through every parliamentary tool available, debates and discussions on issues such as the farm laws, price rise, mismanagement of Covid, and Pegasus. On August 11 came the General Insurance Business (Nationalisation) Amendment Bill, 2021. Though the nomenclature of the original act talks about nationalisation, the 2021 amendment bill sought the annihilation of public sector insurance companies. Despite the Opposition's repeated pleas to send the bill to a Select Committee, the government passed the Bill in under 30 minutes. It was this draconian bill and unparliamentary action that was being opposed on the last day of the previous session.

It is worthwhile here to note the words of late Arun Jaitley, as leader of Opposition in 2011: "Parliament's job is to conduct discussions. But many times, Parliament is used to ignore issues and, in such situations, obstruction of Parliament is in the favour of democracy. Therefore, parliamentary obstruction is not undemocratic." The government conveniently forgets the fact that "disruptions" happened only because of its dictatorial ap-

As the suspension prevails, many people talk about settling the issue through apologies. The Opposition collectively holds the view that such a step cannot even be considered as we strive to raise our voices in solidarity with the peasants and workers and for the defence of the great values of democracy — for the real spirit of "Aatmanirbhar Bharat". In such a situation, no self-respecting political party or its worker will tender any sort of apology. We have learnt our politics from a different school than that of Savarkar.

Monetization of railways could be a much-needed game changer

he announcement by the Union Government to usher in major changes by way of the National Monetization Pipeline (NMP) plan on the 23rd of August 2021 has triggered polarizing debates and discussions on the possible implications of this policy. Projected revenue from railways is expected to be 1.5 lakh crores and will contribute to 25% of the overall pipeline of 6 lakh crores. It is important to remember that asset monetization is a measure to generate additional capital for new infrastructure creation in the country without sale on any public asset. NMP merely provides a mechanism for enabling private companies to lease and operate infrastructure owned by the Government. Against this backdrop, it would be worthwhile to analyze the ways in which this measure could impact the country's railways in times to come.

Owing to a network of 121,407 km of total track over a 67,368 km route, the Indian railways is the fourth largest in the world in terms of size and employs more than 1.3 million people. The freight trains are particularly significant from the perspective of commerce and transport more than 90% of the coal that provides 50% of the country's power requirement. However, since the railways has been primarily dependent on government support since independence, it was challenging to generate adequate funds for capital expenditure. Bulk of the funds continued to besubsumed under operating expenses. Infrastructure and funding challenges in railways manifested in the form of collisions, derailments and level crossing accidents. Besides, in thelast fiscal COVID induced disruption resulted in a revenue loss of Rs. 38,017 crore in the passenger segment. Considering the increasing focus on augmenting railway infrastructure to facilitate freight and passenger movement, significant investments are needed to address capacity constraints.

The year 2014 was a watershed moment as the Union Government initiated bold reforms by not only allowing private investments in railways but also permitting 100% FDI in railways infrastructure sector. Consequently, ten areas/activities that were listed under the category of Construction, Operation and Maintenance permitted 100% FDI through the automatic route. As per the data released by DPIIT (Department for Promotion of Industry and Internal Trade) for railways and associated sectors, the FDI inflows stood at US\$ 1.23 billion from April 2000 to March 2021and constitutes only 0.23% of the total FDI inflows in India. So, asset monetization in this context assumes significance as it will pave the way for greater influx of funds by private players. And in recent years, we have already witnessed an uptick in investor sentiment in 2015 General Electric won a \$2.6-billion contract to supply 1,000 locomotives (100 locomotives on yearly basis for 11 years). Since India's railways is a lifeline for more than 30 million citizens who use it every day modernizing the facilities and enhancing the speed



will go a long way towards making our workforce more

To keep pace with other leading economies of the world, India will have to expand its high-speed railway network. The Indian Railways Vision 2020 report highlighted that our railways has to match the speed and efficiency of trains in countries like US, France, Japan, and Germany in aspects like – speed (average train speed is 60 kms/hour in India) and route-kms per million population served- which are metrics to gauge the level of rail connectivity in a country. To address these challenges, the National Infrastructure Pipeline and the Draft National Rail Plan (NRP) 2020 provide a detailed asset-level plan for the development of the railway sector. The NIP envisages a total capital expenditure of Rs 13.7 lakh crore by both the Centre and States over FY 2022-25, of which Rs 1.6 lakh crore is expected through the PPP mode. The Draft NRP 2020 laid out a strategic roadmap for the sector for the next three decades, which includes an increase in the modal share (freight) of railways from 26% to 45%, while continuing to provide best-in-class services for passengers

An efficient implementation of NMP will ensure huge influx of funds that could vastly upgrade the infrastructure and operational logistics for passenger trains, revamp railway stations, freight terminals, railway colonies, and railway tracks. In this context, it is important to realize that the bulk of our railway assets have been lying either unutilized or underutilized since independence. Take the case of the land along railway tracks – it could be leased out to telecom com panies for laying cables. Likewise, it would be prudent

to enable the utilization of freight terminals as logistics park for private companies and generate another revenue stream. Robust investments by the private sector will facilitate the achievements of ambitious targets set by the government - that includes achieving 100% electrification by 2023, Net Zero Carbon Emission network by 2030, ease of ticket booking, online freight services and suchlike. Niti Aayog's analysis pegs the monetisation value for railway infrastructure development at Rs 76,250 crore from FY22 to FY25, while for passenger train operations, the value is pegged at Rs 21,642 crore.

Importantly, it is worth noting that the move towards asset monetization has happened in a gradual manner. A similar model was adopted in the case of major toll roads in the country. Per estimates the redevelopment of 125 stations along with the development of real estate would cost approximately Rs 50,000 crore. Further, another challenge emanates from the under capacity of passenger trains that is evidenced by the fact that 15% ticket holders on an average are waitlisted. In 2018-19 alone over 8.84 crores of passengers couldn't travel as they were waitlisted. To mitigate this problem, 12 clusters have been earmarked in high-demand routes and it is expected to bring in 30,000 crores worth of private investments with the potential of adding 150 modern trains along 109 routes. Thus, the monetization of railways is based on an exhaustive study of the challenges plaguing the sector and supported by a sound economic rationale and is likely playbook for other sectors to emulate.

For example, remote identity verification via smartphones, digital passports, and electronic travel authentication using layers of AI security will enable seamless touchless travel. Another trend is of zero-Trust, which means the increase in digital identity proofing tools to verify employee remote logins and devices giving the remote workforce the least privileged access - the minimum permissions they need to fulfill their function.

Rise of tech designed for remote-work As a quick response to the pandemic organizations across the globe implemented work-from-home, and have been surprised by its success. Remote work is here to stay as companies across the globe adopt a 'hybrid work culture. While the world retrofitted tech from the pre-pandemic era to fit their needs, 2022 will see technology leaders innovate to achieve continuous business success and support employee productivity using technology designed specifically for hybrid remote work. For example, ramping up/ innovating battery performance is key to an 'untethered' experience when it comes to remote work. It allows devices to last longer and charge faster, driving a seamless and sustainable device experience. The politics-policy disconnect in India

here's a breakdown between politics and policy in India. Decision-making on virtually all gov ernance issues is disconnected from politics and the mobilisation of public opinion. The repeal of the farm laws is thus a notable instance of politics and policy coming together, although in conflict. What is striking, however, is that the politics came from farmers' groups, not political parties. The manner in which the government rammed through the three bills, tried to bully and delegitimise the prodid the government not attempt to build consensus in favour of the bills, but that the channels of feedback from the ground were themselves not functioning properly. The Opposition was supportive of the protests but, with some notable local exceptions, had little role to play in the actual mobilisation of public opinion on the ground. The Opposition speaking in one voice in the Parliament helped, but the heavy lifting of organising in the villages and sustaining the protests was done by the farmers' groups.

This disconnect between politics and policy is not a recent development, though it manifests differently across political divides. The liberal side has a policy-first lens but is unable to articulate its ideas in a manner which makes for good politics, repeatedly couching its ideas in a bureaucratic framework disconnected from political organisation. The impetus for a bureaucracy-first policy framework stems from the desire to remove local political discretion, which is assumed to be anti-people; the result, however, is to increase the distance between the policy initiative and the political organisation and thus the conduit for outreach and communication with the public. Moreover, bureaucracy is downstream from politics and this approach rather than curbing the state may have instead contributed to undermining the democratic process of political accountability since the political class is, by design, not central to the policy in the first place.

The right, on its side, has a politics-first lens but it derives its politics largely from its social agenda instead of issues of governance. In India, the right has a conception of a Hindu India but it lacks conceptual clarity and a governance agenda for the state. The policy imperatives, if any, are ad hoc and appear to be driven by the demands of running the political apparatus instead of a clear governance agenda. Instead, the right mobilises public opinion around cultural and community issues where the expectation from the state is not necessarily governance but patronage and protection for preferred social groups. Despite these differences, what is common across parties is the apolitical harnessing of the state as a disburser of different kinds of economic largesse, especially just before elections, as political parties cast about for simple ideas for easy mass

There are many reasons for this wholesale breakdown of our political process. Indian politics and the state are weakly institutionalised to begin



with, which leads to an all-around fuzziness in the relationship between politics and policy. However, this is as much an effect as it is cause, with the direction of change towards greater deinstitutionalisation instead of the opposite. Another contributing factor is that traditional sites of consensus-building such as media, civil society, and political parties have developed pathologies which have rendered sustained consensus-building almost impossible. Consequently, even on issues at the centre of public imagination, we are unable to coalesce around a way forward for constructive action.

One reason is of particular interest because it raises the bar to use democratic representation to mainstream new ideas to an impossible height: The excessive centralisation of power in party platforms and the head of the government (state and national). This renders the individual elected representative extraneous to governance even in their own constituency, where their raison d'etre is to provide representation and oversight. This causality requires its own larger argument but there are two incontrovertible consequences of this centralisation. First, elections can be used to change regimes but not to extract political accountability since there is no clear channel for "representation"; and the consolidation of partisanship, which has hijacked public interest, leaving no room to construct a majority on any issue outside of party lines. An added consequence of this congealed partisanship is that party supporters too lack leverage over their party to initiate new ideas or

There's too much at stake to allow such a state of affairs to continue. We have the largest youth population in the world, yet in many ways, the political process in our country is especially ill-equipped to respond to the challenge of giving our young a positive sense of purpose or engagement. It is important to rescue public interest from partisanship and cut through at least some of the bad-faith crosstalk across partisan divides. There are many issues which lend themselves to cross-cutting collaboration outside of ideological affiliations. Institutional reforms are required to create such a space but public-spirited individuals across political divides can lay the foundation for such collaboration through issue-based discipline, moderation and intellectual independence

WHO RUSHES EXPERTS' TEAM TO S AFRICA TO HELP COMBAT COVID-19'S NEW VARIANT OMICRON

Johannesburg, Dec 3 (PTI) The WHO has rushed a team of experts to South Africa's Gauteng province, the epicentre of the new Omicron variant of COVID-19, to ramp up surveillance and contact tracing efforts as the country grapples with rising cases of infections.

Omicron, which was first identified in South Africa exactly a week ago, now has been detected in at least 24 countries around the world, including India.

We are deploying a surge team in Gauteng province to support surveillance and contact tracing, World Health Organisation's Regional Emergency Director for Africa Dr Salam Gueye said in a media briefing on Thursday.

A team is already working in South Africa on genomic sequencing, he said.

The Gatteng province, which is the economic hub of South Africa, has accounted for almost 80 per cent of the infections over the past week.

Some 11,500 new infections were registered on Thursday, a sharp rise from the 8,500 cases confirmed on



the previous day.

In contrast, daily infections were averaging between 200 and 300 in mid-November in the country, according to health officials.

The National Institute for Communicable Diseases (NICD) said at the same briefing that around 75 per cent of samples tested positive for the new variant.

For the month of November, we had 249 sequences and $\,$

of those, 183 have been considered to be Omicron, said NICD clinical microbiologist professor Anne von Gottberg.

According to the Africa Centers for Diseases Control and Prevention, the continent recorded 52,300 new COVID-19 cases compared to the previous week, a 105 per cent increase.

WHO's Africa director Dr Matshidiso Moeti said on Thursday that countries must adjust their COVID-19 response and stop a surge in cases from sweeping across Africa and possibly overwhelming already-stretched health facilities

health facilities.
Gauteng Premier David
Makhura confirmed in a separate media briefing that the
province was on the cusp of a
fourth wave.

We are monitoring the situation very closely; getting feedback from our clinical

teams also on the full impact of this. As we see the (rising) numbers every day, we are very concerned about it, Makhura said, as he made a plea to residents of the province to step up to get vaccinated.

The premier said that since Monday, there were over 50,000 vaccinations a day from the low of 30,000 daily before the announcement of the new variant.

If we sustain the daily vaccination of 50,000 throughout this period into the festive season, it will help us to reach at least another half a million people before they leave Gauteng, he said.

Makhura was referring to the annual exodus to rural areas outside the province by workers in Gauteng as business and industry shuts down from mid-December for several weeks until early in the new year.

We need to catch people here in Gauteng and vaccinate them because we know that during the festive season millions of people leave our province. We don't want people to be carrying this variant to other provinces, especially those who are not vaccinated, he explained.

Joining Makhura at the briefing was Gauteng CO-VID-19 Command Council chairperson Dr Mary Kawonga, who said the province was already seeing a spike in

The rate at which cases are increasing and the fact that we actually two days ago passed the seven-day rolling average that was the threshold for the third wave means that we are in a resurgence, and we need to behave like we are already in the (fourth) wave, without waiting for the technical definition, she said.

Kawonga said the peak of the fourth wave was expected in about two weeks, with about 45,000 active cases and about 4,000 hospitalisations at the peak.

Remember, this is the modelling and the prediction. Depending on how we are able to vaccinate and how we adhere to non-pharmaceutical interventions, it is very possible that whatever is predicted might not come to pass, she opined.

Solomon Islands politician wants diplomatic ties with Taiwan

Taipei, Dec 3 (AP) The head of the most populous province in the Solomon Islands said the country would likely switch diplomatic ties back to Taiwan if the prime minister is ousted from his post following next week's no-confidence vote, after looting and violent protests shook the capital city last month.

Daniel Suidani, the premier of Malaita, said Friday he thinks the Solomon Islands should partner with Taiwan because they share democratic values.

Prime Minister Manasseh Sogavare angered many in 2019, particularly leaders of Malaita, when he cut the country's diplomatic ties with Taiwan to recognise China instead. Suidani said the switch was done without adequately consulting the public

The Solomon Islands faced violent protests and unrest last week as long-simmering tensions over economic issues boiled over. The National Parliament building, a police station and businesses were set alight during two tumultuous days in which police failed to control a mob as it wrecked parts of the capital city.

The dispute over the nation's foreign policy is just one of several issues on hand.

Suidani called for national dialogue to resolve the issues causing ongoing unrest in his country, and said the reasons for the violence are longstanding domestic issues over the economy and land rights, not foreign interference.

He said that increasing corruption, unemployment and informal settlements, or slums, were among the major factors leading to the violence in recent days. He also accused the central government of blocking economic development in Malaita.

He said he supports further protests on Monday but will encourage people to do it through legal avenues.

In 2020, the US government pledged a 25 million aid package to Malaita, which has been viewed by some as an attempt to gain influence in the country. Suidani, who was wearing a red T-shirt with a prominent USAID shirt logo on the front on Friday, said the package was a request from the Solomon Islands government.

He denied receiving financial aid from Taiwan, though he said the province received COVID-19 protective gear and health equipment during the pandemic from the country.

US steps up disclosure pressure on Chinese companies

Washington, Dec 3 (AP) Chinese companies will have to disclose more information about audits and whether they are controlled by a government or else leave US stock markets under a rule approved by securities regulators.

The rule approved on Thursday by the Securities and Exchange Commission steps up a long-running standoff between Washington and Beijing over how much information companies with US-traded shares must disclosed.

Companies that used an audi-

tor in a foreign jurisdiction will be required to confirm they are not owned or controlled by a government entity there, according to the SEC. Companies also will be required to disclose additional information in annual reports.

Trading prohibitions can be imposed on some companies, the SEC said.
Other governments cooperate

with US demands for more financial details from companies to pre-



vent false reporting. But Beijing, citing security concerns, refuses to allow the US Public Companies Accounting Oversight Board to review work of Chinese auditors.

China's government criticized the move and warned it might block American investors from access to fast-growing companies.

The measure is an attempt to politically suppress Chinese com-

panies and contain China's development, said a foreign ministry spokesman, Zhao Lijian.

We are firmly opposed to that, Zhao said.

Hundreds of Chinese companies have raised tens of billions of dollars in US financial markets, but their status is a matter of growing dispute with Beijing.

The latest rule applies to audit

firms the PCAOB is unable to inspect or investigate, the SEC said, a group that would be mostly Chinese.

Separately, the US government earlier barred Americans from investing in the stocks, bonds and other securities of Chinese companies deemed to be linked to the ruling Communist Party's efforts to upgrade its military technology. (AP)

UAE agrees to buy French warplanes as Macron visits Gulf

Nice (Fance), Dec 3 (AP) France says the United Arab Emirates has purchased 80 Frenchmade Rafale warplanes for 16 billion euros.

made Rafale warplanes for 16 billion euros. There was no immediate confirmation of

the deal from Emirati officials.

The French Defense Ministry described the deal as France's largest-ever weapons contract for export. French President Emmanuel

Macron is in the Emirates on the first stop of his two-day visit to the Gulf.

Macron's two-day visit to the United Arab Emirates, Qatar and Saudi Arabia comes a month before France assumes the rotating

Emirates, Qatar and Saudi Arabia comes a month before France assumes the rotating European Union presidency and ahead of the French 2022 presidential election where Macron is expected to seek a second term.

Returning from the Gulf with a contract to

sell French fighter jets to the Emiratis, a deal that Paris and Abu Dhabi have discussed for almost a decade, would boost France's defense industry after the collapse of a 66 billion contract for Australia to buy 12 French submarines.

And the red carpet treatment Macron can expect from Gulf political heavyweights would present France as the EU powerhouse in the Gulf and Middle East since Britain's exit from the bloc.

Macron stands out among European Union leaders with his willingness to be in the spotlight, to drive the foreign policy and push things ahead, said Silvia Colombo, an expert on EU-Gulf relations at the International Affairs Institute in Rome.

But, primarily, Macron is pursuing French business interests, Colombo said. He has a very clear idea that he has to go where the business community wants to be, where France can make economic gains.

Macron's keen interest in forging personal relationships with leaders like Mohamed bin Zayed Al Nahyan, the crown prince of Abu Dhabi, and his counterpart in Saudi Arabia, Mohamed bin Salman Al Saud, makes him a welcome guest. Both Gulf leaders value a degree of pragmatism when discussing democracy and human rights issues on which their

countries have been heavy criticized by rights groups and European lawmakers while pursuing business opportunities.

France has deep ties to the United Arab Emirates, a federation of seven sheikdoms on the Arabian Peninsula, particularly since the Sept. 11, 2001 attacks.

The UAE opened a French naval base in 2009 at Abu Dhabi's Port Zayed. French warplanes and personnel are also stationed at Al-Dhafra Air Base, a major facility outside the Emirati capital of Abu Dhabi that's also home to several thousand American troops.

Months after Macron was elected in 2017, he traveled to the UAE to inaugurate Louvre Abu Dhabi, built under a 1.2 billion agreement to share the name and art of the world-famous museum in Paris.

museum in Paris.

In September, Macron hosted Abu Dhabi's crown prince at the historic Chateau de Fontainebleau outside Paris, which was restored in 2019 with a UAE donation of 10 million euros (11.3 million).

rican nation, was currently in quarantine along with his family members, the official said.

The Sri Lankan government on Novem-

ber 28 had announced that arrivals from South Africa, Botswana, Zimbabwe, Namibia, Lesotho and Eswatini are required to undergo mandatory quarantine.

Herath said that the detection was made possible by the continued surveillance carried out by the health authorities having warned the public on the new variant weeks ago.

As of Thursday, the total number of CO-VID-19 infections since March 2020 stood at 5,65,471 with 14,399 deaths.

WHO says measures against delta work for omicron variant too

World Health Organisation officials in the Western Pacific say border closures adopted by some countries may buy time to deal with the omicron coronavirus variant, but measures put in place and experience gained in dealing with the delta variant should remain the foundation for fighting the pandemic.

While a few regional countries are facing surges, COVID-19 cases and deaths in many others have decreased and plateaued, WHO Regional Director for the Western Pacific Dr. Takeshi Kasai told reporters Friday in a virtual news conference broadcast from Manila, Philippines.

Border control can delay the virus coming in and buy time. But every country and every community must prepare for new surges in cases," Kasai said. The positive news in all of this is that none of the information we have currently about omicron suggests we need to change the directions of our response."

Much remains unknown about the new variant, including whether it is more contagious, as some health authorities suspect, or if it makes people more seriously ill, and whether it can thwart the vaccine.

US will resume policy for asylum-seekers to wait in Mexico

San Diego, Dec 3 (AP) Migrants seeking to enter the United States will again have to stay in Mexico as they await immigration hearings, as the Biden administration has reluctantly announced plans to reinstate the Trump-era policy and agreed to Mexico's conditions for resuming it.

Revival of the Remain in Mexico policy comes even as the Biden
administration manoeuvres to
end it in a way that survives legal scrutiny. President Joe Biden
scrapped the policy, but a lawsuit
by Texas and Missouri forced him
to put it back into effect Thursday,
subject to Mexico's acceptance.

Mexico's foreign relations secretary said in light of US concessions Mexico will allow returns, expected to begin next week, for humanitarian reasons and for

temporary stays.

Mexico's conditions include
COVID-19 vaccinations for migrants, more protection in danger-

ous Mexican border cities, better access to attorneys and quicker resolution of cases. About 70,000 asylum-seekers

have been subject to the policy, which President Donald Trump introduced in January 2019 and which Biden suspended on his first day in office.

Illegal border crossings fell sharply after Mexico, facing Trump's threat of higher tariffs, acquiesced in 2019 to the policy's rapid expansion. Asylum-seekers were victims of major violence while waiting in Mexico and faced a slew of legal obstacles, such as access to attorneys and case information.

Migrants are expected to be returned starting Monday in one border city, which has not been identified. It will eventually be done in seven locations: San Diego and Calexico in California; Nogales, Arizona; and the Texas border cities of Brownsville, Eagle Pass. El Paso and Laredo.

The Homeland Security Department said Thursday that it was acting to comply with a court order but that Secretary Alejandro Mayorkas believes the policy has endemic flaws, imposed unjustifiable human costs, pulled resources and personnel away from other priority efforts, and failed to address the root causes of irregular migration.

Deeply flawed, White House press secretary Jen Psaki said Thursday when describing the policy. "We're working to implement under the court order, she said.

The dual announcements follow intense discussions between the US and Mexico after US District Judge Matthew Kacsmaryk, a Trump appointee in Amarillo, Texas, ordered the policy be reinstated, subject to Mexico's participation.

The policy's new iteration, outlined in a briefing for reporters

and a court filing Thursday, promises major additions and changes that Mexico demanded.

All migrants subject to the pol-

All migrants subject to the policy will be vaccinated against CO-VID-19. Adults will get the Johnson & Johnson vaccine, which requires only one shot. Children who are eligible under US guidelines will get the Pfizer shot, with second shots when they come to the US for their first hearings.

The US will try to complete cases within 180 days, a response to Mexico's concerns that they will languish. The Justice Department is assigning 22 immigration judges to work on these cases exclusively.

US authorities will ask migrants if they fear being returned to Mexico instead of relying on them to raise concerns unprompted. If the migrants express fear, they will be screened and have 24 hours to find an attorney or representative.

The Biden administration is working to ensure migrants' safety when they travel to and from court, including within Mexico. Some migrants returned from Eagle Pass, Laredo and Brownsville, where Mexican border cities are especially dangerous, will be moved to locations farther inside Mexico.

The policy will apply to migrants from Western Hemisphere countries, except Mexicans, who are exempt. US officials haven't said how many will be processed daily. The administration has kept in place another Trump-era policy that allows it to return Central Americans to Mexico on the grounds of preventing the spread of COVID-19.

Migrants will have an opportunity to meet with attorneys before each hearing. The State Department is working with Mexico on locations for video and phone access to attorneys in the US

Need collective global action for effective regulation of technology: FM

New Delhi, Dec 3 (PTI): Finance Minister Nirmala Sitharaman on Friday called for a "collective global action" for effective regulation of ever-change ing technology and tech-driven pay ment systems.

So far, regulators are only "catchingup" in regulating ever-evolving technology and hence there is no one point formula with which it can be regulated,

Her comments also come against the backdrop of the government preparing to come out with legislation to regulate cryptocurrencies.

"Even as we are thinking about at a national level, there should simultaneously be a global mechanism through which we are constantly monitoring the movement of technology, so that whether it is your cryptocurrency, whether it is tech-driven payment system, data privacy, whether it is ensuring that data is used ethically.

'When you are looking at data as one of the revenue generating options, to regulate it will have to be a collective effort," Sitharaman said



Speaking at the InFinity Forum 2021, she said technology respects no physical borders and has the power to sweep through borders. "... It means that global action is the only way with which you can regulate effectively.

India is working on a new Bill on cryptocurrency which will take into account the rapidly changing dimensions in virtual currency space and will be brought in Parliament during the ongoing session, which will end on Decem-

The Cryptocurrency and Regulation of Official Digital Currency Bill, 2021, seeks to "create a facilitative frame-

work for creation of the official digital currency to be issued by the Reserve Bank of India. The Bill also seeks to prohibit all private cryptocurrencies in India, however, it allows for certain exceptions to promote the underlying technology of cryptocurrency and its

Replying to a question on how regulation keeps pace with technology amid discussion on cryptocurrency in India, she said since these are evolving areas, there is no clear pointed answer.

"Regulation, both legislative and executive, ... at least till now have only been catching up with technology and rapid movement of technology. So as long the executive and legislature are only catching up, you will never be on top of it. And with technology, I am not sure they (regulators) can ever be on top of this kind of situation, because it is ever changing and ever evolving," Sitharaman said

She said India has seen digital revolution for the past years and financial inclusion has achieved the social norms of empowering the poor.

Govt seeks Parliament nod for Rs 62K crore infusion in AIAHL



New Delhi, Dec 3 (PTI): The Government on Friday sought Parliament's nod to infuse over Rs 62,000 crore into the company that holds residual assets and liabilities of Air India after its privatisation, as part of over Rs 3.73 lakh crore additional spending planned in the current financial year.

The extra spending would include Rs 58,430 crore by way of additional crore towards payment of pending export incentives and Rs 22,039 crore to rural development ministry for transfer to National Rural Employment Guarantee Fund.

Minister of State for Finance Pankaj Chaudhary tabled the second batch of supplementary demands for grants tabled in Lok Sabha envisaging a net cash outgo of over Rs 2.99 lakh crore and Rs 74,517 crore extra expenditure would be matched by savings by different min-

As per the document, Rs 62.057 crore would be given to the Civil Aviation Ministry for equity infusion in Air India Assets Holding Company (AIAHL) for re-payment of past government guaranteed borrowing and past dues/liabilities of Air India.

Besides, an additional Rs 2,628 crore would be given

towards loans and advances to Air India for recoupment of advance from Contingency Fund of India.

The additional fertiliser subsidy include Rs 43,430 crore on account of payment towards indigenous and imported Phosphatic and Potassic (P&K) Subsidy and Rs 15,000 crore towards urea subsidy scheme Besides, the Department

of Food and Public Distribuditional Rs 49,805 crore for meeting expenditure towards various schemes of food storage and warehousing.

About Rs 2,400 crore would be given to Department of Commerce for meeting expenditure towards subsidies under the 'Interest Equalisation Scheme', and Investment under the Export Credit Guarantee Corporation (ECGC) scheme,

among others. Another over Rs 5,000 crore and over Rs 4,000 crore has been earmarked for additional spending by the Ministries of Defence and Home, respectively.

The 2021-22 Budget had projected government's total expenditure at Rs 34.83 lakh crore. But this is expected to overshoot considering the two batches of supplementary demands for grants presented

by the government so far.

IMF says chief economist Gopinath to replace Okamoto as no. 2 official

Washington, Dec 3: The International Monetary Fund named its chief economist Gita Gopinath to become its second-ranking official replacing First Deputy Man aging Director Geoffrey Okamoto who will leave the global lender in early 2022. Goninath had beer

scheduled to leave the global lender to return to Harvard University in January, but decided to stay on in the wide-ranging policy role under IMF Managing Director Kristalina Georgieva, the IMF said. Georgieva said Gopinath

was "universally recognized as one of the world's leading macroeconomists" and had precisely the expertise needed for the No. 2 job, given the increased macroeconomic challenges facing IMF member countries as a result of the COVID-19 pandemic.

"Indeed, her particular skill set" combined with her years of experience at the Fund as Chief Economist - make her uniquely well qualified. She is the right person at the right time, Georgieva said She said the IMF would

realign some roles and responsibilities in its senior management team, with Gopinath to oversee sur veillance activities, and research and flagship publications, while working to "foster the highest quality standards for Fund publica-

The United States, the largest shareholder in the IMF, welcomed the pick of Gopinath, and the move to restore job responsibilities that had been shifted under Okamoto, a source familiar with Treasury's thinking

Gopinath, the first woman to serve as the fund's chief economist, has played a key role in broadening the role of the IMF's research



department, creating a new analytical approach to help countries respond to international capital flows, and also worked on a detailed IMF plan to end the pandem ic. she said.

Okamoto said he would return to the private sector after over a decade of "intensive public service," but gave no details about his next position.

A dual citizen of the United States and India, Gopinath is due to start her new role on Jan. 21, shortly after the IMF releases an up date to its World Economic Outlook. The IMF board is expected to approve the move in coming weeks.

The leadership changes come on the heels of an independent report commis sioned by the World Bank, which claimed Georgieva then the CEO of the World Bank, and other senior of ficials had pressured World Bank staff to alter data to favor China.

IMFexecutive The board cleared Georgieva of any wrongdoing in October, but U.S. Treasury Secretary

Janet Yellen said Washington viewed the allegations as legitimate and serious, and demanded the IMF take proactive steps to ensure the integrity of IMF data and protection of any whistleblowers.

Services activity grow robustly in Nov as price pressures intensify

Bengaluru, Dec 3: Activity continued to grov at a robust pace last month supported by a strong recovery in domestic demand, a private survey showed, but elevated price pressures remained a major concern.

Asia's third-largest economy expanded at the fastest pace among major economies last quarter, boosted by coronavirus vaccinations and stronger government spending. The economy grew 8.4% annually during the July-September quarter. That positive momen-

tum seems to have been largely sustained in the first two months of this quarter. Services Purchasing Managers' Index, compiled by IHS Markit, eased to 58.1 in November from 58.4 in October, but last month's rate of growth was the second-best in over a decade and well above the 50-mark separating growth from con-

Indian banks behind on digital adoption, it's time to wake up: Uday Kotak passports and persons of Indian morning mentioned the most im-

Mumbai, Dec 3: Indian banks have ceded the payment ground to financial technology companies but it is time to "wake up!", said Uday Kotak, managing director and chief executive officer (CEO) of Kotak Mahindra Bank on Friday.

He was speaking at the inaugural InFinity Forum organised by International Financial Services Centres Authority (IFSCA) and Bloomberg. The topic of the event was "FinTech Beyond Boundaries · A Banker's Perspective.

When it comes to adopting digital, "Indian banks have been behind the curve," Kotak said.

"Indian banks have allowed the growth of Unified Payment Interface (UPI) payments and essentially, they've been monopolized by key players - Google Pay and PhonePe - and they have got 85 per cent mar ket share." while the Indian banks dragged their feet in the space expecting not enough income in payments. "It's a wake-up call for Indian banking. Wake up! Large parts of the traditional financial markets

are moving out," he said. "Bankers were short-sighted over past years. Their standard response was 'Oh!, there is no money in payments," and they let the payments market effectively be taken over by these two or three companies," said Kotak

Consumer technology companies have revenue models outside finance, for example in the advertising space. However, banking regulations prohibit banks from having non-financial businesses.

"There are serious issues about how to draw the lines and simultaneously there's an issue about financial stability. All that I'm saying is we need to make sure that in the name of competitive ser-

vice, we don't have a systemic and



a stability challenge at the same time," said Kotak

On fintech companies allowing deposit mobilisation through their platforms, the veteran banker said the terminal issue was the risk of "who is raising the deposit? Is it the consumer tech company, which is the apparent front engine which is going to the customers and marketing deposits, and who runs the risk of the underlying asset?"

"So we need to make sure that as we vote for FinTech, you must also be clear that we do not betray trust. The Prime Minister this

portant aspect of the digital growth is consumer trust that has to be protected at all costs.

Banks must have the ability to feed the enormous data being churned out by the financial system into analytics and machine learning. Especially, the turnaround time for micro-small and medium enterprises (MSME) must enable an MSME to get clarity on a loan in minutes, if not seconds.

"I think that revolution is on us. The whole lending and the platform which will develop will make it possible for MSMEs to raise money, at least within the same day, rather than having to wait for a few weeks before they know whether they're going to get the money or not."

The banks are working towards that transformation beyond Aadhar, UPI and India Stack.

"I would love to see how we can export it globally. The European Club Association's executive board met in Paris and cited "the worsening public health situation" as the omicron variant of the coronavirus spreads. The group called for talks with FIFA, which manages the calendar for international soccer games and forces the release of players

Before the pandemic, there were no national team games scheduled in January 2022.

playing catch up with postponed tournaments and World Cup qualifying matches

The 24-nation African Cup will held be from Jan. 9-Feb. 6 in Cameroon after a oneyear postponement. Dozens more players based in Europe will also head to North America, South America and Asia for World Cup qualifiers in a new Jan. 24-Feb. 2 window FIFA created to help get games played.

Those make-up dates arrive amid an aggressive new variant of COVID-19 that clubs fear could be brought back by their players.

Tension over virus protocols has seen

some European clubs previously refuse to release South American players, and a marquee Brazil-Argentina game became a fiasco within minutes in September when health officials

entered the field to remove players.

The ECA said its board will "engage urgently with FIFA to ensure all necessary precautions are in place to protect players and club interests as the health situation continues to deteriorate in an alarming manner.'

The group aims for constructive talks with FIFA at the same times as its more than 240 members are fighting against the world body's push to win approval for a biennial

Opponents of the plan were joined Thursday by European lawmakers from 47 nations in a report on sports published by the Parliamentary Assembly of the Council of Europe, known as PACE.

"It considers that such a change would have disastrous consequences for European football," the lawmakers said in a document that will be debated in January

Among other sport's governance issues raised in the PACE report were ensuring host nations of major sports events respect human rights and ensure gender equality.

COVID-19 hits Junior Hockey WC, one person tests positive

Bhubaneswar, Dec 3 (PTI) COVID-19 hit the ongoing FIH Junior Hockey World Cup here after an incidentfree week with one positive case being reported on Fri-

Despite being held inside a bio-bubble and all media persons covering the event subjected to RT-PCR tests every 48 hours, one person, who has been accessing the media centre at the Kalinga Stadium, tested positive in RT-PCR test conducted on Thursday.

According to a member of the local organising committee, the person who tested positive is a social media team member of Department of Sports and Youth Services (DSYS), Odisha government.

The development created a sort of panic among the organisers, who made it mandatory for the journalists covering the event to undergo RT-PCR test on Friday, failing which they would be barred from entering the media centre.

"RT-PCR test is mandatory for all today who want to access the media centre and cover the rest of the tournament. It is being conducted every 48 hours but has been made compulsory after a member of DSYS social media team tested positive," the local official said.

"He has been accessing the media centre daily and hence contact tracing is on and today's test is mandatory for all those who have been using the media centre.'

The showpiece junior tournament, which started on November 25, had remained incident-free till Fri-

day's case. While the Junior World Cup is being held inside a bubble without any spectators, media persons have been allowed to attend the event under strict COVID-19 safety protocols.

Despite being held behind closed doors, all matches involving India have seen crowd turning up to watch them. Around 3,000 spectators attended the home team's quarterfinal win against Belgium on Wednesday.

The emergence of Omicron, which is said to spread faster than the earlier Delta variant, in multiple countries including India has triggered widespread alarm all over the world.

The variant was detected and flagged to the world by South Africa and as things stand now, there have been multiple hospitalisations in the Gauteng province, where Johannesburg, the venue of the first two Tests beginning December 17, is located.

Team India are slated to leave for Johannesburg early on December 9 but as of now, there's lack of clarity on whether the tour is on, shelved or curtailed.

India are slated for a full tour comprising three Tests, three ODIs and four T20Is. Although the series is not part of the meeting's official agenda, it can be brought up during the Future Tours Program discussion.

During their last tour to England in September, India, leading 2-1 going into the final Test in Old Trafford, could not field a side following a COVID outbreak inside the team bubble and the match had to be rescheduled to July 2022.

Taking that into account, the Board members would certainly deliberate long on the issue which has now emerged as the priority with less than a week left for the team's departure.

At present, the team is in South Africa and the Board is still continuing with that assignment.

Skipper Virat Kohli, who is due for his milestone 100th Test in Cape Town, sought further clarity on the tour on the eve of the second and final Test against New Zealand in Mumbai on Thursday.

...you want to have clarity and you want to be in a situation where you know exactly what is going on. We have to be realistic as well. We cannot just ignore the things that potentially could put you in a confusing place. And no one wants to be there," he had said.

UN urges truce during winter Olympics in Beijing

United Nations, Dec 3 (AP) The UN General Assembly has urged all nations to observe a truce during the Bei jing Winter Olympics starting in February, saying a halt to conflicts during one of the world's premiere sporting events can be a tool to promote peace, dialogue and reconciliation

A resolution adopted by consensus by the 193-nation world body on Wednesday recalled the ancient Greek tradition of ekecheiria, calling for an Olympic Truce, to encourage a peaceful environment and ensure safe passage and participation of athletes in the games, thereby mobilising the youth of the world to the cause of peace

The resolution urges members states to observe the Olympic Truce, individually and collectively from the week before the start of the 24th winter Olympic games in Beijing until the week after the Paralympics. The Olympics run from Feb 4-20 next year followed by the Paralympics from March

The assembly resolution underlined the importance of cooperation



among UN member states in implementing the values of the Olympic truce around the world and emphasised the importance of work promoting this by the International Olympic Committee, International Paralympic Committee and the United Nations.

The General Assembly revived such calls for an Olympic Truce in 1993 after an appeal from the International Olympic Committee allowed athletes of war-torn Yugoslavia, which was on the brink of breaking up, to participate in the 1992 Barcelona summer games. General Assembly President Ab-

dulla Shahid told the assembly before the resolution's adoption that sport brings together people of every religion, race, ethnicity, and political background to celebrate humanity's athletic prowess and potential.

It diverts energies from hostility and conflict towards friendly competition (and) it promotes an active lifestyle and supports our mental and physical well-being, he said. It can instill the spirit of camaraderie, support quality education, and relieve the psychological stress of the COVID-19 pandemic, which has taken a big toll on our collective psyche and left us so

Shahid said the pandemic has taught the world that all of humanity shares a common destiny and urged people everywhere to acknowledge their obligations to others and to the planet, and to reflect on the pointless ness of conflict and aspire for peace.

China's UN Ambassador Zhang Jun introduced the resolution, saying it had 173 co-sponsors and sends a powerful message of unity and cooperation to overcome the pandemic

He said the government is making every effort to ensure the health and safety of all athletes and participants at the Olympics and Paralympics.

He said China is promoting the truce ideal in primary and secondary schools nationwide, while working to make the games as clean and pure as ice and snow. (AP)

World Tour Finals: Srikanth loses to Lee, bows out of tournament

Bali, Dec 3 (PTI) India's Kidambi Srikanth bowed out of the season-ending BWF World Tour Finals after losing to second seeded Malaysian Lee Zii Jia in straight games in his third and final group B match here on

The former world no. 1 Indian was no match for Lee, the reigning All England champion, going down 19-21 14-21 in 37 minutes to end his campaign.

It was Srikanth's second loss to the world no. 8 Malaysian, who had defeated the Indian at Hylo Open in straight games.

Srikanth trailed 0-3 at the start but made his way to a slim 9-8 lead at one stage. An alert Lee, however, ensured a two-point advantage at the interval.

A six-point burst helped the Indian to again grab a 17-15 lead but he let it slip as Lee pocketed the opening game.

Srikanth made a good start in the second game, moving to 7-3 advantage but Lee once again turned the tables, jumping to 13-9 and kept his nose ahead to eventually shut the doors on the Indian.
