PDD Strike Leaves People Shivering In Cold

JAMMU: Power outages during the ongoing sub zero temperatures has sparked a wave of anger with sporadic protests reported from many areas across Kashmir and Jammu even as the strike by power development department employees against privatisation and other issues entered second day with no resolution in sight.

Over 20,000 power sector employees had boycotted work around midnight on Friday in support of their various demands, including shelving of a proposed joint venture between the and Kashmir lammu Power Transmission Corporation Limited and the Power Grid Corporation of India Limited.

The employees, from all unions and associations, from linemen to senior engineers, decided to go on indefinite strike after failure of talks with the government, and staged demonstrations in the twin capital cities besides in district headquarters for the second day on Sunday, a spokesperson of the coordination committee of power supply employees said.

Officials said many parts of the Union Territory witnessed total blackout due to the ongoing strike, as a result of which people are facing tremendous hardships due to non-availability of electricity and water supply, leading to protests by angry residents in Jammu city and other districts who are reeling under severe cold wave

The spokesperson said they had presented a four-point formula to the government, but it failed to accept their demands, including a white paper on nonfulfillment of the recommendations of the

unbundling report and the failure to create positions as mandated by the committee at gazetted and nongazetted levels, regularisation of daily wagers and all power development department engineers. More on P6

Army Takes Over Power Stations In Jammu

rmy was deployed at Avarious power stations in Jammu division on Sunday after authorities failed to reach an amicable agreement with thousands of striking employees of the Power Development Department (PDD).

Divisional Commissioner Jammu had earlier in the day requisitioned the assistance of the army to man electric installations/supplies in Jammu division.

For the last 24 hours, almost the entire Jammu city and the rural areas have remained plunged into darkness as the striking employees of the PDD refuse to man duties until the government reverses its decision to privatise the power sector in the UT.

After the daylong discussions with the representatives of the striking employees failed to persuade them to return to their duties, the administration on Sunday



evening requisitioned the army to man electric power supply in the Jammu division. In a letter to the Defence Divisional Ministry,

Commissioner, Jammu, Raghav Langer wrote: "It is to bring to your kind notice that due to strike by electric department personnel in the UT of J&K, essential services have been severely affected in the Jammu region.

"We would like to hereby requisition the Indian army to assist in the restoration of the said essential services by provisioning manpower to man critical electricity stations and water supply sources."

Many areas across Kashmir and Jammu witnessed power outages and during the nighthours, there was a blackout in nearly 50 per cent of areas across J&K. More on P6

Cold Wave Sweeps Kashmir

Pahalgam Shivers At Minus 8.7 Degree Celsius **Press Trust Of India**

SRINAGAR: Cold wave conditions continued in Kashmir as most places experienced the coldest night of the season so far, with the weatherman forecasting further dip in mercury over the next few days, officials said on Sunday.

The temperature on Sunday night was several degrees below the freezing point, they said.

Srinagar recorded a low of minus 6 degrees Celsius on Sunday night, same as the previous night, which is the lowest minimum temperature of the season so far in the city.

The minimum was 4.5 degrees below the normal for this part of the season.

Gulmarg in north Kashmir's Baramulla district recorded a low of minus 7.5 degrees Celsius. The officials said Pahalgam recorded a low of minus 8.7 degrees Celsius. The resort was the coldest recorded place in the valley.

The mercury in Kupwara in north Kashmir settled at a low of minus 6.1 degrees Celsius.

Qazigund recorded minus 6.5 degrees Celsius, while Kokernag recorded a low of minus 6 degrees Celsius.

The cold wave conditions led to freezing of water supply lines in many areas of the valley as well as the fringes of severai water bodies, the officials said. More on P6

Situation In J&K Worsened After 2019: Mehbooba

JAMMU: Peoples Democratic president Mehbooba Mufti on Sunday claimed the situation in Jammu and Kashmir has worsened after the abrogation of Article 370 and called on the people of the union territory to stand up for their "snatched" rights.

Addressing a party convention in Poonch district, Mehbooba termed the Centre's decision to revoke Article 370 "wrong, unconstitutional and undemocratic" and alleged it played with the dignity and honour of the people of Jammu and Kashmir.

She also cast doubts on the Centre's intention to hold assembly elections in Jammu and Kashmir.

The Centre revoked the special status of the erstwhile state of Jammu and Kashmir



and split it into two union territories on August 5, 2019.

"In view of the prevailing situation, the biggest responsibility lies with the youth. The situation has worsened after the abrogation of Article 370 and they (Centre) are not only taking away our land and jobs but have also played with our honour and dignity. They will not stop till they finish our existence," Mehbooba said. If people want to keep

J&K Reports 136 New Covid Cases, 1 Death

SRINAGAR: As many 136 more people tested positive for coronavirus in Jammu and Kashmir on Sunday while one more person succumbed to the deadly infection in the Union Territory during the last 24 hours.

According to officials, Kashmir reported 114 new cases of Covid-19 on Sunday while the remaining 22 were detected in various districts of Jammu division, taking the total number of people infected since the outbreak of pandemic last year in J&K to 339827.

In the Valley, officials said,

Srinagar reported the highest 50 new cases of coronavirus, Baramulla 19, Ganderbal 11, Budgam and Kupwara 10 each, Bandipora 7, Pulwama 4, Anantnag 2, and Kulgam 1.

Shopian was the only district in the Valley where no fresh cases were registered. In the winter capital, the officials said that Jammu registered a maximum of 8 new cases of

virus, Doda 5, Ramban 4. Poonch 3 and one new case each in Samba and Reasi districts. No fresh cases were detected in the four districts of Udhampur, Rajouri, Kathua and Kishtwar. More on Pe

Can Oily Fish, Cherries Or Milk Help You Sleep? Here's What The Evidence Shows

lmost one-in-five British people report they don't get enough sleep each night. The problem is so bad that in total the UK public are losing around a night's worth of shut-eye each

There are a lot of popular beliefs about foods and drinks helping people get a good night's rest, but many of them are not based on scientific evidence. Here's what we know.

Chemistry of food and sleep

Our diet has an influence upon sleep patterns by affecting the sleep hormone melatonin. For example, foods rich in the essential amino acid tryptophan are commonly cited as helping sleep, as tryptophan helps produce melatonin. Additionally, some vitavitamin D, magnesium and zinc.

Oily fish: Evidence suggests the more oily fish, such as salmon or herring, you eat the better you sleep. Oily fish contain healthy fats such as omega-3 oils which have been shown to improve sleep in children and are involved in serotonin release. Serotonin, a brain chemical linked to mood, also regulates the sleep-wake cycle which may also explain how eating oily fish can help.

Tart cherries: A number of studies have looked at consumption of tart cherries, usually in the form of a drink, and sleep. Evidence suggests that tart cherries improves sleep in older adults, probably due to their ability to increase melatonin levels. And tart cherries are also rich in nutrients, including magnesium, which also may improve your

ing you sleep is mixed. One study suggested four weeks of kiwi fruit consumption improved multiple sleep measures, while another, admittedly in sufferers of insomnia, found no effect. Based on these findings it is not clear yet that eating kiwi fruit will benefit sleep for most people.

Oysters: In 1888 W F Nelsom wrote "He who sups on oysters is wont on that night to sleep placidly...".

There is some evidence to back up this statement, with zinc-rich foods, including oysters, being reported to benefit sleep. However, on balance eating oysters before bedtime is unlikely to be beneficial to your night's sleep.

Alcohol and other drinks Alcohol causes brain activity to slow down



feelings of relaxation and sleepiness. But consuming alcohol is actually linked to poor sleep quality and duration. Although drinking alcohol may cause more rapid sleep onset, this can affect the different stages of sleep, decreasing overall sleep quality. If you want a good night's sleep, avoiding alcohol is sound advice. But are there any non-alcoholic drinks that might help? Warm milk: Research conducted in the 1970s suggested that a glass of warm milk

before bed could improve sleep quality. This research was performed in a very small group, however, and little research has been done since. Drinking milk does increase melatonin levels which could help. But there isn't enough evidence to support the claim that a glass of warm milk definitely makes you nod off.

Vitamin D Supplements May Reduce The **Duration Of The Common Cold**

After a couple of years of maskwearing, social distancing and hand sanitising, the common cold is back. And – according to some people – back with a vengeance.

Some are calling it a "super cold" – others, "the worst cold ever". Fortunately, there may be a way to reduce the duration of a cold: vitamin D supplements.

We may suffer more common colds during the winter because we spend more time close to each other indoors. But vitamin D levels might also influence the risk of getting a cold. There are more colds during winter when vitamin D levels are lowest, and fewer colds during summer when vitamin D levels are highest.

We get most of our vitamin D from the sun's rays (80-100 per cent) and only a small amount from our diet. For people living at latitudes above 30 degrees, such as in the UK, there is a higher risk of having low vitamin D levels (vitamin D insufficien-

People who spend most of their time indoors, or with their skin covered, are also at a higher risk of vitamin D insufficiency. More than half of the UK population is considered to have insufficient vitamin D

levels in winter. In the UK, the sun's rays are too weak to provide enough vitamin D between October and March. This means that from October until March, people's vitamin D levels are

likely to fall. Research shows that vitamin D influences the risk of catching common colds and other respiratory infections. People with lower vitamin D levels are more likely to have a common cold, and people supplemented with vitamin D are less likely to get a common cold.

As well as reducing the chance of getting a common cold, our recent research shows that vitamin D supplementation reduces the severity and duration of common colds. First, we found that vitamin D-sufficient military recruits were less

likely to have a common cold than vitamin D-insufficient recruits during 12 weeks of basic military train-

Then we examined the effect of vitamin D supplementation during winter on common colds. We supplemented recruits with either simulated sunlight (UV radiation by a whole-body irradiation cabinet) or oral vitamin D3 tablets (1,000 IU per day for four weeks to restore vitamin D to normal levels and then 400 IU per day for eight weeks to maintain healthy vitamin D levels). similarĺy supplements achieved vitamin D sufficiency in almost all recruits.

We found that vitamin D supplementation did not reduce the likelihood of getting a common cold, but it did reduce the number of days a participant had a common cold by 36%. It also reduced the peak severity of common cold symptoms by

It is not possible to get enough sunlight in the UK between October and March, so it's advisable to take a 10 microgram vitamin D supplement daily during this period (this value is sometimes shown as 400 IU on the label)

If you can't get any sunlight at all, or you have not supplemented with vitamin D from October onwards, you may need to take 25 micrograms (1,000 IU) of vitamin D for four weeks to restore your vitamin D to a healthy level.

To ensure that you get enough vitamin D during the summer, make sure you get short periods of regular sunlight exposure. Safe sunlight exposure for people living at latitudes between 30 and 60 degrees north involves being in the sun for 15 minutes between 10am and 3pm while wearing a T-shirt and shorts. Looming Omicron Threat

VER since the advent of Omicron, the virus strain has triggered a worldwide alarm. First to be spooked were the global markets which went into a tailspin - albeit, they have since recovered after the reassuring news that the impact of the new variant is still under control. But the preliminary findings about the virus have revealed that it is highly transmissible and could cause havoc if no Standard Operating Procedures are followed. England is the first country that has acknowledged the enormity of the challenge. In a televised statement, the British prime minister Boris Johnson has warned that his country could be staring at 75,000 deaths by April with 'tidal wave' of Omicron. Britain has launched an ambitious Covid booster shot program to stop the virus' spread. Britain is also the first country to officially announce death from the virus mutation. According to the British Prime Minister, Omicron has accounted for about 40 percent of the cases in London, and hospital admissions were rising

On the other hand, according to World Health Organization the Omicron coronavirus variant is more transmissible than the Delta strain and reduces vaccine efficacy. It, however, is said to cause less severe symptoms according to early data. The WHO has said that Omicron is now present in 63 countries and can become dominant in Europe soon. However, all is still not known about the virus. The understanding about it is still evolving. On a positive note, hospitalizations have so far been less.

India has witnessed so far a lesser number of Omicron cases but there is every possibility that the number can dramatically jump. On Sunday India reported five new Omicron cases, taking the tally of the cases of the new variant in the country to 38. Meanwhile, India logged 7,774 new Covid-19 cases and 306 deaths in the last 24 hours which shows a continuing downward trend.

Acknowledging the gravity of the situation, the Prime Minister Narendra Modi in a recent meeting directed officials to review plans for easing of international travel restrictions. The PM said travelers must be tested on arrival as per guidelines and called for a particular focus on countries identified "at risk". He laid emphasis on increasing coverage of the second dose of the vaccine so that adequate immunity is achieved against fresh infections. The PM also urged people to adopt masking and social distancing to prevent the infection from spreading.

Similarly, in a welcome decision, the Jammu and Kashmir administration has decided to make RT-PCR testing mandatory for all foreign travellers to the Union territory at airports to tackle the Omicron threat. The travelers will be allowed to enter J&K only if they test negative. If the report is negative, the travelers will be sent to home quarantine for seven days and re-tested on the eighth day. And those who test positive will be sent to institutional isolation centres for 15 days and their samples sent for genome sequencing at ICMR-approved laboratories. These are good measures and should be helpful in containing the spread of the new variant

By not standing up to a virtual summons from government, Election **Commission undermines itself**

constitutional democracy is held up as much by its individual and separate institutions as by the terms of their relationship with each other. The respect and dignity they give to, and demand from one another, may sometimes be intangible, but is nevertheless crucial. In India, the Election Commission discharges its constitutional mandate of conducting free and fair elections but it does more than just that. It also forms the core of a sprawling electoral system in which, except the odd aberration, even those who lose an election by a hair's breadth seldom question the results, or the credibility of the poll monitor. The EC's reputation for independence and fairness is not just its individual attribute, but also forms an inalienable part of the system's legitimacy, the people's trust in supervisory institutions, as winners and losers come and go. The EC, therefore, must especially be accorded its due dignity and respect — much depends on it. That is why there is reason to pause on the wording of a letter from an official of the law ministry to the poll panel last month. As this newspaper has revealed, it effectively summoned the CEC to a meeting chaired by an official in the PMO. There is reason, also, to ask why, after the CEC had made known his "displeasure" at the tone of the letter, and stayed away from the meeting, all three election com-

missioners bent immediately


thereafter, joining an "informal

interaction" with the PMO official. Questions must be asked of the PMO, law ministry and the EC – not because any meeting between them is controversial, but because the lack of form and propriety in the entire exchange matters. It speaks of larger and

disquieting things. The strength of institutions, or the balance between them, is a changeable thing, varying and wavering over time. The EC was not always the formidable body that it is today. Much of the ground for its current standing was laid by the leadership of TN Seshan, whose tenure in the 1990s was widely seen to rouse a sleepy institution. CEC Seshan gave new force to the EC's role of upholding the rules of the game, including the Model Code of Conduct. Similarly, the equilibrium between institutions has not remained the same. In fact, ever since a single party won a majority at the Centre after over two decades in 2014, there has been mounting pressure on unelected institutions to bend and bow to the elected and their "mandate" The EC has not always stepped up to the watchdog's rising challenge. Several decisions, from the delay in announcing the election schedule in Gujarat, 2017, to the prevarication in banning campaign activity amid the second Covid surge in West Bengal this year, were seen to favour the Centre's ruling establishment.

OCKDOWN may have put a break on common man's movement, but there seems to be no break on the movement of beggars looking for alms in our localities. What I have concluded after acutely observing class of population, who have turned this begging into a livelihood profession from past few years is that, there is no check on the credibility of these people at any level — government or community

If a person is healthy and hale what is prompting them to choose this ostracized profession needs to be questioned. We can't go on ignoring this elephant in the room. In fact, our silence has led to legitimization of this begging as a profession. Even today amid these tough times, these people seem to be breaching every barricade set by authorities to invade the privacy of our homes only to put their own and others' lives at

From past decade, our valley has seen an exponential rise in the menace of begging. I wouldn't be exaggerating in calling Kashmir a "beggar's paradise". One might not to be certain here about earning livelihood by working as a daily wager in unorganised sector but one is sure to get pocket full of money at the end of day, courtesy of begging in markets, mosques, hospitals, highways and offices. Such is the sad state of our

Political uncertainty and conflict ruling the valley from last three decades has not decreased the inflow of panhandlers across the tunnel irrespective of gender and age from hinterlands of other parts of country to our valley. Unfortunately, there seems to be no check on the movement of these mendicants even in the times of a

Two years back, J&K government had banned begging at public and religious places in Srinagar but that order has remained confined to just paper and with authorities have lowered their guard against beggars with time. Therefore, things have remained unchanged on

Now what this huge inflow of beggars has done is that our own population has succumbed to this alternate route of earning livelihood too now. They seem to have taken cue from these outsiders which has inturn given birth to a new breed of home-grown beggars, who are healthy and hale. Yet they are opting for this much disliked way of

According to our religion, begging was prescribed for those people who had lost their organs of working by birth or accidently, thus rendering themselves helpless at the mercy of others to earn their living. With time, begging has been turned into a money minting profession with people who could have easily earned their living by using their own hands instead of preferring begging over it. As the time passes, these people get addicted to it to a level of no return. What prompts them to take this profession to earn their bread and butter is the assured hefty amount at end of the day without any

A few days back, I was preparing to take my routine sleep on our veranda after midday prayers when I saw a gentle voice of a young boy wearing a blue skull cap and matching shalwar kameez approach me. With the first glance itself, I could conclude from his face that he would have been close to twelve years. He was holding a bundle of few old notes in the close fist of his right hand and a few laminated documents of some orphanage institution under his left armpit. His pockets on either side of shalwar

kameez had visibly bulged out due to weigh of coins. Before I could to check his credentials, he started his memorised sermon when I intercepted him in the middle to check his credibility. When I enquired from him as to who gave him the authority to collect money in the name of the orphanage, he became silent. I could see the lines of discomfort growing on his face with his colour fading to pale. When I asked him for the contact number of the head of institution he was claiming to represent, he sensed trouble and pulled away his documents from my hand and ran away - but not without passing a comment at me, Agar hass deon chi thaa dee,Eoutha chena police enquiry asee Karan (if you want to give me something then give, the amount of enquiry you are doing even the police doesn't do it with

As he left, I began to ponder over

Our society needs to cure the menace of begging through actively arranging destitute management. For instance, revered and respected Islamic scholar Maulana Tariq Jameel who recently started his clothing MTJ brand to run his Islamic institution. 'n all his 90 years, Mohammad Nengroo, also known as Mum Nengroo, had never imagined that he would one day be denied the right to bury members of his family in his

But that was exactly what happened to him this year when the land around his hamlet of Nengroo Basti was fenced by the Jammu and Kashmir Forest Department, forcing him to bury his brother Ghulam Ahmad Nengroo and another relative, Mala Begum, on the premises of the village mosque instead.

The Nengroo family are forestdwellers. In Jammu and Kashmir, many communities such as Gujjars, Bakerwals and others are traditional forest-dwelling tribes. Their way of life had remained reasonably undisturbed for centuries. But since October 31, 2019, when the Union government extended to J&K the Forest Rights Act (FRA) of 2006, a progressive piece of legislation that ensures the land tenure, food security and livelihoods of traditional forest dwellers, the majority of communities like that of the Nengroos have actually been treated more harshly than they ever had been before.

The forest officials have fenced off our entire habitation," said Mum Nengroo, distraught by this attack on his community's way of life. "We are not even allowed to bury our loved ones here. The 15 families who live in Nengroo Basti did not encroach on this land but had been shifted here by the state government 14 years ago after landslides destroyed our own village. Why have they not provided us with land for a graveyard? People like me have grown up in these forests and today we are called encroachers and jailed. This is unacceptable.'

Anticipation and apprehension

Mum Nengroo and his ailing wife worry that when they pass away, they will not be given the kind of burial the forest-dwelling communities of J&K consider proper.

But in January 2021, when a public outcry to implement the FRA in J&K ensured that the legislation was finally put into effect, the residents of Nengroo Basti, located in the Charar Sharief tehsil of central Kashmir's Budgam district, had rejoiced, just like many other communities of forest-dwelling people.

"We were told on radio and TV programmes by government officers that the FRA would entitle us to several rights, including the right to have a graveyard in our village and the right to acquire land for a school and health centre. But this seems to be a distant dream for the people living in this remote place," said Akram Nengroo, a resident of Nengroo Basti.

Not only has the rollout of the FRA not provided the nomadic communities with the Act's promised benefits, but its extension to J&K has actually made life more difficult for them because the staff of the union territory's Forest Department appear to feel that the legislation challenges their authority.

For the last couple of years, the fordepartment has rigorously fenced many forest areas in the union territory. People living in villages near forest areas allege that state-owned land and even grazing land (khahcharai) is being fenced by the forest department. Last year in Kanidajan village, six km from Nengroo Basti, forest officials axed 8,000 apple trees which they claimed had been grown on forest land. This was reported on several national and international media platforms, including the BBC.

'The forest department was not so harsh with forest dwellers before the rollout of the FRA," said Rouf Malik, director of the Srinagar-based NGO Koshish, which works for the education of tribal children. In the last year, the NGO has also focused on building awareness about the FRA

'They [the forest officials] are under the misconception that the FRA will let people take control of forest land. Thus the forest officers are directing their staff on the ground to ensure that there is no encroachment of land," Malik explained.

Although the J&K legislative assembly had passed a resolution recommending ST status for Chopans nearly 20 years ago, that file has been gathering dust in the offices of the Union Ministry of Tribal Affairs ever since.

Meanwhile, in Nengroo Basti, residents worry about the graveyard that the FRA ought to have given them but which the Forest Department has taken away.

The families who reside in Nengroo Basti actually hail from Sani Darwan village, two km away. After massive landslides hit Sani Darwan in 2007, completely destroying the homes and land of 15 families, the government settled these families on a patch of land between Sani Darwan and Chalyan villages. This place later came to be known as Nengroo Basti because most of the families have Nengroo as their surnames. The land in Nengroo Basti falls under the territorial jurisdiction of Darwan village, which itself is divided into two habitations, Sani Darwan and Wagen Darwan.

Each family in Nengroo Basti was allotted about seven marlas of land (roughly 1,905 square feet) by the government and the same amount of land was allotted for a mosque and a school. However, no land was allocated for a graveyard. When this was pointed out a patch of forest land as a graveyard, but there was no official order permitting the families to do so.

While the families did select and use a patch of forest land as a graveyard, burying several children there who had died in the village five to six years ago, the Forest Department came down on them harshly when the FRA was rolled out in J&K and has disallowed the use of that piece of land since then. Some people allege that the Forest Department, especially the J&K Social Forestry Department, has even fenced off the village common land.

Rights under the FRA

Under the FRA - officially the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 - the STs and other traditional forest dwellers (OTFDs) have three important sets of rights: Individual Forest Rights, Community Forest Rights and Community Forest Resource Rights.

The FRA recognises the rights of the forest-dwelling tribal communities and OTFDs to forest resources on which these communities are dependent for a variety of needs, including livelihood, habitation, and other socio cultural needs. This includes the right to land for graveyards, religious places, schools, community centres, panchayat (village self-governing bodies) buildings, health centres and so on.

Individual rights provided by the Act include the rights of self-cultivation, habitation, grazing, fishing, and access to water bodies in the forests. Community rights include the right tion of their rights to the villagers.

The event, held in a remote forest village called Surkabadi in Ranpur block of Nayagarh district, located about 100 km from Odisha's capital city of Bhubaneswar, had played out like a festival. Hundreds of women, men and children in their traditional colourful clothes had assembled in a field as early as 9 am on November 22, hours before the ceremony was to begin in the afternoon. So enthusiastic were the people that they were happy to wait for hours in the scorching sunshine for their MLA and other officers of the administration to arrive.

When the event finally began, Satyanarayan Pradhan, the MLA of Ranpur, and Nazir Ahmad Khan jointly presented the Community Forest Rights titles to the villagers in the presence of officers from the forest, revenue and tribal affairs departments.

The community rights conferred on the 24 villages included a joint title for a group of villages to collect and use firewood and household implements within and outside the traditional boundaries of the local forests. The villagers now have the right to collect, process, use and sell minor forest produce such as bamboo, kendu leaves, tubers and so on. They are also allowed to add value to this produce and store and transport it. The 24 villages have also, finally, been given rights to the water bodies in the forests, along with fishing and grazing rights. In the past, many residents of these villages had been jailed under the Indian Forest Act of 1927 for encroaching on forest land.

None of the residents of the 24 villages have any desire to take advantage of the rights granted to them so recently. For the past 24 years, the people who live around the Ranpur forest area in Nayagrah district have been working for the conservation and protection of their forests and forest resources, including wildlife, under the banner of Maa Maninag Jangal Suraksha Parishad (MMJSP), which is a confederation of 132 community-based forest protection groups from 132 villages in the

Now 73 years old, Arkito Sahu, secretary of the MMJSP, had not needed legislation to know that the forests of India need protection. Instead, he had prodded the residents of 132 villages in Nayagrah district to work together to conserve the forests they depend on.

To give them institutional support, V. Giri Rao, the director of the Bhubaneswar-based NGO Vasundhara, ensured that the great work done by the MMJSP was documented and that women were included in the forest committees. Since the enactment of the FRA in 2006. Vasundhara and the MMJSP have been working more rigorously to ensure that all the benefits of this legislation reach the forest dwellers of the Ranpur block.

Wrong agency in charge?

How does Odisha manage to use the FRA so effectively while the union territory of Jammu and Kashmir does

The answer may lie in the agency that oversees the implementation of the legislation in J&K.

At the national level, the Ministry of Tribal Affairs oversees the implementation of the Act. Various states have made their Tribal Affairs Departments the nodal agencies for the implementation of the FRA. But in J&K, the administration helmed by the Union

to intellectual property, traditional knowledge and so on.

Thus the FRA empowers the forest dwellers to access and use forest resources in the manner that they have traditionally been accustomed to and also to protect, conserve and manage forests and protect themselves from unlawful evictions. The Act also provides for basic development facilities for communities of forest dwellers, such as education, health, nutrition, infra-

The FRA in Odisha

While forest officials in J&K seem to be struggling to understand the FRA, the story is completely different for Odisha's forest dwellers.

structure facilities and so on.

Just last month, two dozen villages in Ranpur block of Odisha's Nayagarh district received about 14 community forest right titles from the government. None of the residents of these villages are classified as scheduled tribes. Instead, they are classified by the FRA as OTFD.

While implementing the FRA, most states have focused on providing the benefits of the Act to their scheduled tribes, leaving the OTFDs side-lined. So when Odisha provided these 24 villages with community forest rights, it was a historic occasion, marked with a ceremony on November 22.

I had been invited by the organisers of the ceremony to Ranpur, along with Nazir Ahmad Khan, the chairman of District Development Council (DDC), Budgam, J&K, to witness the presentagovernment has made the forest department the nodal agency to implement

"How can a divisional forest officer or range officer tell forest dwellers that they have certain rights to forests and forest produce?" asked Giri Rao. "The law is clear. The Tribal Affairs Department has to be made the nodal agency for FRA implementation. The J&K administration has committed a huge blunder by assigning this task to the Forest Department. This needs to be rectified."

Since the FRA was extended to the UT, the J&K Forest Department's actions have been so contrary to the intentions of the legislation that it is almost a joke. While the FRA recognises the rights of the forest-dwelling tribal communities and other traditional forest dwellers to forest resources, J&K's Forest Department deprives them of these rights.

When J&K's Lt Governor Manoj Sinha gave a speech for a programme titled 'Agenda' organised by the India Today media group, he said that the FRA had given the people of J&K new hope.

But the situation on the ground at this time tells a story of no hope.

Afghanistan Will Become 'Biggest Man-Made Crisis' If World Fails To Act, Pak PM Imran Warns At OIC Summit

ISLAMABAD: Pakistan Prime Minister Imran Khan on Sunday warned that Afghanistan could potentially become the "biggest man-made crisis" if the world failed to act in a timely manner as representatives of the Muslim-majority nations agreed to establish a humanitarian trust fund and to launch a food security program to help the people of the war-torn nation.

Addressing the 17th extraordinary session of the Council of Foreign Ministers of Organisation of Islamic Cooperation (OIC) here, Khan highlighted the collapsing hospitals, education sector, and the deteriorating humanitarian situation in Afghanistan and called for the world to take immediate action as the Taliban-ruled nation was heading towards chaos.

"If the world doesn't act, this will be the biggest man-made crisis which is unfolding in front of us, Khan said.

The chaos in Afghanistan mean the end of the government which would strengthen the ISIS, enabling it carry out acts of global terrorism, Khan told the gathering, which included the Taliban regime's Foreign Minister Amir Khan Muttaqi, representatives from 57 Muslim nations and delegates from the US, China, Russia, the European Union and the UN.

Khan urged the US to delink its policy towards the Taliban from the 40 million people of Afghanistan.

He also said that the Taliban would also have to understand that formation of an inclusive government, respect for human rights, particularly women, and disallowing the use of



Afghan soil for terrorism in other countries would pave the way for international aid to Afghanistan.

Afghanistan's economy is facing a major crisis after the Taliban seized power in Kabul in mid-August, amid a chaotic US and NATO troops withdrawal from the war-torn country.

Following hardline Islamists assuming power in Afghanistan, the international community froze billions of dollars' worth of assets abroad and stopped all funding to the country.

According to UN figures from early November, almost 24 million people in Afghanistan, around 60 per cent of the population, suffer from acute hunger. That includes 8.7 million living in near-famine. Increasing numbers of malnourished children have filled hospital wards.

Khan also raked up the Kashmir issue in his speech. Later, the OIC representative

stressing that the menace of terrorism remains a grave threat to Afghanistan, regional countries and the international community and asserted that the Afghan territory must not be used as a base or safe haven for any terrorist group. The resolution emphasised the

importance of establishing inclusive governmental structures to adopt moderate and sound domestic and foreign policies, with a friendly approach towards neighbors of Afghanistan, aimed at realising the shared goals of durable peace, security, safety and long-term prosperity of Afghanistan and the region.

It emphasised the importance of meaningful participation of women in all spheres, and upholding human rights, including for women, children and minorities.

It also urged the international

against the possibility of incitement and the role of spoilers, both inside and outside the country, to derail efforts aimed at peace and stability in Afghanistan.

The resolution underscored the need for concerted efforts to rebuild the necessary capacity of the relevant state institutions of Afghanistan to address challenges posed by terrorism, narcotics, smuggling, money laundering, organised crime, and irregular migration.

Briefing reporters along with OIC Secretary General Hissein Brahim Taha, Foreign Minister Shah Mahmood Qureshi later said that the conference agreed to establish a humanitarian trust fund and it also agreed to launch a food security program.

The participants also agreed to "unlock financial and banking channels, he said.

To a question about pledges, Qureshi said that some countries

wanted to donate but they needed an account and some mechanism for it. "So we have decided that the Islamic Development Bank will open an account to facilitate the donations and then pledges will be made," he said.

He also mentioned that there was a positive statement by US special representative Tom West who said that he has a mandate to engage with the Taliban and he also met with the Taliban leaders present in Afghanistan.

"West also said that humanitarian assistance would not be made conditional, Qureshi said, adding that West also indicated that USD 1.2 billion unutilized funds available with international institutions could be

Qureshi also said the meeting discussed how the aid should be provided. It was also agreed that the OIC secretariat should engage with the WHO to get COVID-19 vaccines and medicines for Afghans.

He said that it was a view as well as a call by the participants for the international community that sanctions on Afghanistan should not impede the provision of humanitarian aid and economic resources should be made available without letting the sanctions come in the way of aid being given to Afghanistan.

To a question about recognition of the Taliban government, Qureshi said that "there is no appetite for recognition. That stage will come (later on)."

Oureshi also shared that in his interaction with Afghan foreign minister, he urged him to create a conducive environment so that the world should recognise their government.

Martin Griffiths, head of the Office for the Coordination of Humanitarian Affairs (OCHA) speaking on the behalf of the UN Secretary General, Ant nio Guterres, painted a very alarming scenario of the Afghan problem.

"The Afghan economy is in free fall, needing urgent steps About 23 million people are facing hunger, he said, adding that the world should come forward to help the people of Afghanistan.

He also called for international engagements with the de-facto authorities in Kabul.

Qureshi said that Pakistan has decided to provide USD 30 million to Afghanistan in help in addition to essential goods.

PDD Strike Leave

They are also demanding delinking their salary from grant-in-aid and releasing a regular budget for all PDD employees on deputation to different corporations and a white paper of service condition of PDD employees on deputation to the Chenab Valley Power Projects Private Limited (CVPPL) and similarly situated employees deputed from the NHPC.

An official spokesman said the government of J&K, taking a sympathetic view of the issues raised, has engaged in several rounds of talks with the coordination committee of the power

During each round of talks, the government representatives have appealed to the power employees to call off their strike as people in both Jammu and Kashmir divisions are suffering. In the wake of COVID-19 contagion and nail-biting cold in both the divisions, the coordination committee of the power employees is requested to end its strike, the spokesman said.

Reacting to the situation, Union minister Jitendra Singh expressed hope of a peaceful resolution to the issue at the earliest.

The administration is on the job the time cannot be stopped as we have to keep pace with development in the rest of the country. The employees are part of the society and if they feel insecure, it is the responsibility of the rulers to address their concerns and move forward along with them, he told reporters here.

National Conference vice president and former chief minister Omar Abdullah asked the government to leave privatisation decisions to an elected government.

The J&K administration may be able to claim the constitutional authority to privatise the assets of J&K, but it completely lacks the political authority. Decisions of this nature with far reaching consequences should be left to an elected government, he wrote on Twitter.

The striking employees have made it clear that the repairs and restoration work would not be undertaken at all unless the feeder is supplied to any hospital.

Senior BIP leader and former legislator Devender Singh Rana also expressed concern over many parts of the Jammu city as also peripheries plunging into darkness and urged the administration to take earnest measures in resolving the issues with the striking employees, especially during these chilly days.

He hoped that all concerned will act responsibly as the stakes are very high, not only in terms of restoring electricity in the affected areas, but also to ensure that students do not suffer as they are solely dependent on online classes and examinations.

Failure in power supply is impacting the internet services, he added.

Jammu and Kashmir Apni Party president Syed Mohammad Altaf Bukhari also expressed serious concerns over the indefinite strike in opposition to a government decision that intends to privatise grid stations.

Over 20,000 electrical employees are currently on a strike due to which numerous areas across J&K are facing prolonged power blackouts and lingering of essential repair works. All of this is happening in the harsh cold winter season which is exponentially adding to the existing woes of the general public, he observed.

Bukhari demanded that the government review its decision at an earliest to resolve this deadlock with the concerned employee's association in order to avoid further inconvenience to the people.

They have already created many parties and their only intention is to gain a majority in the assembly so that they can ustify the August 5, 2019 decision," she said.

"They want to weaken our case against the August 5 development in the Supreme Court," she said.

Mehbooba also defended her father Mufti Mohammad Sayeed's decision to join hands with the BJP to form the government in Jammu and Kashmir, saying his only desire was to end the bloodshed and resolve the Kashmir issue.

"We have not lost hope and will continue to strive for the resolution of the Kashmir issue to usher in peace and development in J&K," she said, adding "we acceded to Gandhi's India and not his assassin Godse's India".

Referring to the anti-encroachment drive, Mehbooba said people are being "deprived" of land they have had for generations "on the pretext that it is state's land".

This land is being used for construct-

ing buildings for the security forces in the

presence of the trapped militant was ascertained, he was given ample opportunities to "However, he denied the surrender opportunities and fired indiscriminately upon the joint

search party which was retaliated leading to an encounter," he said. In the ensuing encounter, the police spokesperson said that the trapped militant was killed and his body was retrieved from the site of the encounter. He identified the killed militant as

Safiulla alias Abu Khalid, alias Shawaz resident of Karachi Pakistan. As per police records, he said, Saifulla was a categorized Lashkar-e-Taiba (LeT) militant and had infiltrated in year 2016 via Bandipora Sector and later on sneaked into district Srinagar on the directions of Pak based Commanders of LeT for intensifying militant related activities in Pulwama, Srinagar, Ganderbal and Budgam

districts. "It is pertinent to mention that the killed terrorist Saifulla was working as Group Commander of proscribed terror outfit LeT in District Srinagar as he was operating earlier in District Srinagar & was familiar with the topography of District Srinagar/Pulwama and its outskirts. He has also been involved in receiving

new groups of FTs after infiltration," he added. The police spokesperson further said that the killed militant was wanted by law for his complicity in "terror crime" cases which include attacks on Police/SFs and civilian killings.

Giving more details, the police spokesperson said that Saifulla and his associates were involved in an attack on an army convoy along Bemina bye-pass near JVC Hospital on April 1, 2017 in which 3 soldiers were injured. Besides, he said, the killed LeT militant was also the mastermind behind the attack carried out by his associates at Lawaypora Srinagar in which 2 security personnel were killed and one AK-47 rifle was also snatched.

"He was involved in an attack on a police party of PS Bandipora at Gulshan Chowk Bandipora in which 2 police personnel were martyred. Besides, attacks on Police/SF he was also involved in civilian killings which include killing of BJP President Waseem Bari, his brother and father on 08/07/2020," he said.

Moreover, the police spokesperson said that Saifulla was also mastermind behind the revival of militancy by luring the gullible youth and a number of fresh recruitment of local youth into "terrorist ranks". The killed militant, he said, was also instrumental in reactivation of hard core militant associates of LeT outfit in the areas of district Srinagar and District Pulwama besides police district Awantipora.

"Incriminating materials, arms & ammunition including 01 AK-47 rifle, 03 Magazines and 01 grenade were recovered from his possession. All the recovered materials have been taken into case records for further investigation," he said.

The police spokesperson also quoted IGP Kashmir as congratulating the joint team for conducting successful operation without any collateral damage.

The IGP said that with the killing of Saifulla, 3 Pakistani militants have been killed so far in Srinagar City within almost a month who were involved in several cases including attacks on government forces and civilian killings which clearly shows that Pakistan is "hell-bent" to disturb the peace in Kashmir valley especially in Srinagar City.

Meanwhile, police have registered a case under relevant sections of law in this regard, the spokesperson said.

He also urged people to cooperate with Police till the area at the encounter site is completely sanitized and cleared of all the explosive materials, if any.

India Squad For U-19 World Cup Announced

NEW DELHI: Delhi batter Yash Dhull will lead a 17-member Indian squad in the Under-19 World Cup, which is scheduled to be held in the West Indies from January 14 to February 5, the BCCI announced on Sunday.

Four-time winners India are clubbed with South Africa, Ireland and Uganda in Group B.

Dhull's appointment was on expected lines as he was also named captain for the upcoming Asia Cup, to be held in the UAE from December 23.

Dhull will have Andhra's SK Rasheed as his deputy for the premier tournament in the Caribbean.

"The All-India Junior Selection Committee has picked India's squad for the upcoming ICC Under-19 Men's Cricket World Cup to be played in the West Indies from 14th January to 5th February, 2022 across four host countries," the BCCI said in a press release.

The 14th edition of the tournament will see 16 teams competing for the trophy across 48

India are the most successful team having won the title four times - 2000, 2008, 2012 and

India have also been runnersup in 2016 and in the previous edition of the tournament held in 2020 in New Zealand.

Dhull, a right-handed mid-

dle-order batter, was a leading run-getter in the Vinoo Mankad Trophy earlier this year. He averaged 75.50 for his 302 runs for the Delhi Districts & Cricket Association (DDCA) in the five matches that the team played

during the tournament. Delhi player Dhull thus joins the great Virat Kohli in captaining the junior side in the marquee tournament. He has previously led the Delhi U-16, U-19 and India 'A' U-19 sides.

Rasheed was also impressive in the Vinoo Mankad Trophy, including scoring a match-winning century.

The format will see the top two teams from each of the four groups advance to the Super League while the remaining teams feature in the Plate across 23 days of competition.

India will begin their campaign against South Africa at the Providence Stadium in Guyana on January 15.
