SRINAGAR: Coronavirus cases continue to show surge in Jammu and Kashmir as 141 more people tested positive for Covid-19 on Friday in the Union Territory, while one more person succumbed to the deadly infection during the last 24 hours.

According to officials, 118 fresh cases of novel coronavirus were reported from Kashmir Valley and the remaining 23 from various districts of Jammu division, thus taking the number of people infected since the outbreak of pandemic last year in J&K to 340434.



### 2 Covid Pills - But Who **Should Get Them? The New Dilemma**

he US has cleared its first two Covid-19 treatment pills, and now comes another hurdle -- deciding who should get which one.

Merck & Co.'s molnupiravir was authorised Thursday by the Food and Drug Administration for use in adults at high risk of severe cases who have no other treatment option, though it is not recommended for pregnant women. Still, the US will soon have 3 million courses available.

Meanwhile, Pfizer Inc.'s Paxlovid - authorised earlier this week --showed stronger clinical trial data with President Joe Biden hailing the pill as "a promising new treatment". It will be available in limited quantities at first as Pfizer grinds through a monthslong manufacturing process.

Regulators are signaling they prefer Pfizer's pill, which they've bought more of, but the US will have a lot more early on of Merck's pill, which regulators say is better than no treatment. The coming weeks will see states and physicians hash out who gets what.

The US will have hundreds of thousands of Merck courses available immediately, and 3

Conversely, the US is expected to receive just 265,000 courses of the Pfizer treatment by the end of January, up to 2 million a month by spring and a total of 10 million by July. The initial shipment is just 65,000 courses, or about 3,180 for New York, for instance.

Mr Biden, speaking to ABC News this week, acknowledged that the Pfizer supply "won't be enough to get to all the hospitals" at first but that the government has ordered all that Pfizer can make so far. "If people get the shots, they get their two shots and a booster, they're not going to be in a position where they actually need such a pill," he said.

The National Institutes of Health's guidelines committee is putting together a list of recommendations on how to allocate treatments, and the US government will distribute the pill through channels that have been used for existing treatments -- sending them on a per-capita basis to states while also sending them to other entities, like federally qualified community health centers, in a bid to minimise any race gap in availability.



## Guns fail to fall silent

RINAGAR: Hours after the Ramadhan ceasefire an¬nounced by the Prime Minister, Atal Bihari Vajpayee, came into effect, reports of escalated violence have come in from various areas shattering the prospects of unilat¬eral truce. Eighteen people, including six security person¬nel, were killed and 23 others were injured in separate in-cidents across the state since early morning today.

In a major incident, four security personnel were killed and 14 others were injured when a powerful explo-sion ripped apart the vehicle they were travelling in at Nowpora-Dooru, 74 km from here on Srinagar-Verinag road in the south Kashmir district of Anantnag this afternoon, official sources said. Condition of most of the wounded sol¬diers were reported to be crtitical. The incident took place around 2 p.m. Officials said militants detonated the improvised

explo¬sive device (IED) immediately after the army vehicle car¬rying jawans of 36 Rashtriya Rifles (RR) passed over it. The explosion was possibly triggered by using a remote control device. The vehicle was blown up killing four jawans and injuring 14 others. All the wounded soldiers were rushed to the base hospital here.

Soon after the incident, the security forces laid scige to the entire area after which fear gripped the people. But no searches had been carried out till the reports last came in.

Hizb-ul-Mujahideen has claimed responsibility for the incident and said they would intensify the attacks during the month of Ramadhan. Hizb spokesman, Salim Hashmi, telephoned reporters in Srinagar to claim the responsibility for the blast.

The unilateral ceasefire announced by the Indian government is not a serious effort, but an attempt to ward off international pressure on it to resolve the Kashmir issue," he alleged.

A NAFA report said a foreign militant identified as Tan¬zeel-ur-Rahman alias Abu Zareen, belonging to Lashkar-e- Taiba was killed in an encounter with the troops of 28 RR at Atri Naribal in Rafiabdd area of Bammulla district today.

Rajinder Singh reports from Jammu: Barely an hour after the ceasefire came into force, nine people, including two security personnel and five militants, were killed in a gun battle at Dhana-Sawjian village in the border district of Poonch. Eight civilians were also injured in the encounter.

**BETHLEHEM:** The biblical town of Bethlehem is gearing up for its second straight Christmas Eve hit by the coronavirus with small crowds and grey, gloomy weather dampening celebrations Friday in the traditional birthplace of Jesus.

### 11 Dead As Ship Carrying **Migrants Sinks Off Greece Coast**

**ATHENS:** The death count from a migrant boat sinking off Greece rose to 11 on Friday, as scores of others, including dozens of children, were rescued, the coastguard said.

The boat carrying migrants ran aground on an islet north of the Greek island of Antikythera on Thursday evening. Eleven bodies have been recov-

ered so far and another 90 people stranded on the islet were rescued overnight, an official from the coast guard told AFP.

Those rescued include 27 children, 11 women and 52 men.

"The search and rescue opclear how many were on the boat before it sank," the official said.

In an order, the UT's Home department has ordered creation to them. The standing committee in of the "witness protection fund" for meeting expenses incurred on the implementation of the protection order(s) passed by the competent authority and related expenditure.

The fund shall be operated by the director general of police, who shall also initiate proceedings for recovery of the expenditure incurred from the witness under their charge as provided protection fund in cases of false complaint(s), the order states.

The move comes after the J&K government ordered that the witness protection scheme shall be deemed come into force in UT from December 5, 2018.

## **Road Accidents Claimed** 713 Lives In J&K

**SRINAGAR:** As many as 713 people lost their lives in Jammu and Kashmir in road accidents, a figure which is eight times more than those killed by bullets in the conflict ravaged region, official data reveals

As per the data compiled by the J&K Traffic Police Department, 5036 accidents happened in J&K from January to November in 2021, in which 713 persons were killed and 6447 were injured.

"589 accidents were reported fatal and 4447 non-fatal," the figures reveal, adding that 3278 accidents happen only in Jammu, in which 521 persons were killed and 4241 injured. "102 persons were killed and 1175 injured in Jammu district, 76 killed and 536 injured in Kathua, and 63 persons were killed and 313 injured in Ahmed Mir said that rash driving Ramban," the data reveals.

In Kashmir, the figures suggest that 1758 accidents took place since January 2021 in which 192 persons were killed and 2206 injured. "36 persons were killed and 333 injured in Srinagar, 25 accidents which at times turn fa- will definitely help bring down

killed and 340 injured in Anantnag district," the data states.

The figures state that in 2017, 926 were killed and the injured persons were 7419. "In 2018, 984 people were killed and 7845 injured. "In 2019, a total of 996 persons were killed, 7532 were injured. In 2020, 728 people were killed, while 5894 were injured," the figures reveal.

Pertinently, the deaths caused by road accidents in J&K in 2021 are much higher than those killed by bullets. The figures revealed in the Parliament recently stated that 75 people including 40 civilians and 35 security forces personnel were killed in militancy related in Kashmir in the year 2021 (upto November 31).

Superintendent of Traffic Police for Rural Kashmir Manzoor and violation of traffic rules are the basic reasons for rising accidents in rural areas of Kashmir. The Motor Vehicle Department (MVD) should play a major role as it is the only department that has a right to suspend the licence," he said, adding that "MVD has a Road Safety Cell under Road Safety Policy (RSP) that is not being implemented. Police don't have funds to create awareness."

## Flying The Coop

ith the curtain about to ring down on the government's half-yearly sojourn in the summer capital, the somewhat pretentious official-dom, politicos included, of the state is all set to take its soothing ministrations to the more conducive climes of Jammu in a seemingly endless repetition of an ante-diluvian practice. Obviously, the chill descending this side of the Pir Pantsal range freezes the creative and innovative currents within our masters, and they need warmer air to keep their beneficent and benevolent souls going

Jammu and Kashmir has the distinction of being the only state with two capitals with the government migrating between them after every six months. In between, it helps itself with a neat 10day break as if after a 'tiresome' performance in either region even as the drain on public exchequer in the shape of inconsequential touring and resultant expenses on petrol and allowances goes on without any respite. In fact, some kind of a 'seasonal' inertia sets in throughout the move offices about a month earlier as the officials begin packing up for the bi-annual trek up and down the highway. The files and records of various move offices are a mute witness to the common refrain during these days: "put up after durbar move." Thus, by any calculation, the state government remains in a comma for about a month in every six months. It hardly matters if by the same token the government gives an emphatic lie to its own claim of being "a government that works every day". In the process, the near-empty state exchequer is made to cough up a few crores of borrowed money to sustain a patently primitive tradition of 'durbar move' the erstwhile Dogra ruler, Maharaja Ranbir Singh, had initiated 133 years ago, in 1872.

Remember, in the eighties, the then happy-go-lucky chief minister, Dr Farooq Abdullah, had taken a bold decision to dispense with the time-consuming and expensive practice only to spark off massive protests in the winter capital which forced him to lick the dust by withdrawing the order. Apparently, the main argument put forth to retain the practice is that it promotes emotional integration between the Muslim-dominated Kashmir region and Jammu having a substantial Hindu population. Partly, it also contributes a great deal in boosting trade and commerce in Jammu region. Over the decades, however, both the pleas have become almost totally irrelevant. The emotional integration between Kashmir and Jammu is just a farce as the two regions are not always on the same wave length in respect of quite some crucial issues.

The rise and groundswell of regional groups like the Jammu State Morcha has left nobody in doubt that the disturbingly saffronised regional and separatist sentiments are eating into the shrinking secular base, particularly in the two and a half districts of Jammu, Kathua and Udhampur. The growing influence of the RSS and its Hindutva outfits like the Shiv Sena and Bajrang Dal is no music for Kashmiris and certainly cannot even tolerate, leave alone nourish, any emotional bonds between the two regions. It is an open secret the RSS has been organizing regular shakhas in certain areas while the Bajrang Dal distributes trishuls to militarize the Hindu mind against Muslims.

It is no wonder that the Congress and the National Conference, who have lost no opportunity in making a travesty of their secular credentials at the regional and the national levels for the petty profits of power, should hold on to a tenuous artifice, a fig leaf, rather, to flaunt a virtue both have sacrificed time and again for the spoils of office. So, sensing themselves lacking in moral authority in deciding an issue on hard practical sense, they try to compensate by keeping up appearances. As both are deeply compromised in dealing body blows to the foundations of the nation's philosophy, they have no other option but to keep up outdated notions to avoid having to grapple with hard facts.

Otherwise also, the half-yearly migration of the government out of the problem zones affects its performance rather adversely leaving the deserted areas' people high and dry. The sooner the practice is abandoned, the better it would be for the entire state and its people. Indeed, in an era when the entire world has been reduced to a global village, the government can evolve a mechanism through which to administer the state quite effectively and efficiently without having to move between two capitals. It goes without saying that most ministers and top functionaries even otherwise keep routinely flying between the two capitals regardless of where the seat of power happens to be.

## **Erasure Of Mystical** Heritage In Kashmir


The Untoward Leaning Of Our Orientalised Minds

was once asked by a friend of mine if I had read the famous novel '40 Rules of Love' by Elif Shafak. I replied in the negative. He praised the work for its 'beautiful portrayal of Sufism' and insisted that I read it too. I did read it eventually, after the circulation of its praises felt overwhelming, only to feel utterly betrayed. This sense of betrayal is not something I believe was exclusive but in fact, is the same for anyone who is familiar with the subject in its authenticity. The only thing that errs us though is that we don't want to seek authenticity anymore.

Our land Kashmir is often hallmarked as 'peer'i waer' or 'resh waer' -'the valley of saints', for the history of its close and interwoven relation with mysticism. Even before the advent of Islam, it had the influence of Trika Shaivism which shared its resemblance with Islamic mysticism in its monistic philosophy. We can trace its history from Lal Ded, the most remembered Shaivite mystic of 14th century, to Syed Mirak Shah Kashani, a revered 20th century Sufi saint. This history doesn't only entail a mere abundance of mystics, or of their literary contribution to our language but most notably, it entails their interwoven relation with the people and how that relation has shaped our ethos and culture. Mystics have been at the locus of religio-ethical sphere of our society. Their position in history is seen as that of personages of harmony, mutual-understanding and love among the people of diverse faiths. One of the reasons of Islam's flourishing in Kashmir was because of the emphasised perpetuation of its spiritual dimension -tasawwuf by the early Sufis that came to Kashmir in the 14th century, the earliest of them being Syed Sharf-ud-din Abdul Rahman Shah or, as commonly known, Bulbul Shah. He is credited as the earliest missionary of Islam to Kashmir who invited and converted the then ruling king Rinchen Shah to

This spiritual fecundity and with that the knowledge, canons of art and literature that followed is what we are home to. The literature produced by poets and mystics alike is nothing short of remarkable. Lal Ded's 'vaakh' that impart esoteric truths and advices, Noor-ud-din Noorani's 'shru'ik' which address and advise people collectively, Rasool Mir's unparalleled eloquence in romantic poetry or Wahab Khaar's profound expounding on Sufi thought; all of these are examples of a rich and bounteous canon of literature produced over the centuries, inspired by tasawwuf, the reality which connects us with the central Asian and other Muslim regions.

Instead of being conscious of such realities, we give in to the orientalist tropes that are perpetuated by popular authors time and time again. We have forfeited our literature, and the wisdom that it would entail now only remains in the memories of the past. The thirst of spiritual readings now is being quenched by readings of orientalist works. The fact that a novel like '12 Rules of Love' is highly encouraged and entertained among our young generation speaks of our orientalised mentality. We are so distant and detached from our own history culture and identity that we can't discern what Shafak has produced in the novel, which is nothing short of a watered-down version of Islam and Sufism to match the appetite of western readership. Two of the most respected figures in the history of Sufism, Mawlana Rumi and Shams Tabriz are reduced down to mere agents of 'love' in a 'feel good' manner

while they're de-contextualised from their religious foundations. Any taste for Islam is strongly negated and we, as deficient as we are, play along the whole narrative like mindless minions. The cover of the book every now and then circulates in a Dal lake reel or a Naseem Bagh photo-shoot in an attempt to please the aesthetic vocations of a severely attention deficient society. While Shafak does claim no expertise on the subject of Sufism, we still subliminally sketch a skewed image of the subject in the process of reading her. Therefore, the main lies not with the author but with the readership, especially the readership which shares some identity with the subject.

Shafak is only one of such authors that are among the perpetrators of the 'New Age spiritualism' -the secular attempt of replacing the spiritual aspect of religion without having to deal with the religion itself. Although

this wave has seen momentum in the West, it's unfortunate that its fringes are caving in the eastern world as well. Coleman Barks, an American Poet revered for his 'translations' of Rumi's Masnavi has helped in making Rumi the 'best-selling poet of America'.[1] Although the contribution is commendable, he is often severely criticized for the misrepresentation of Rumi's ideas. Regarding these new age 'translations' Omid Safi, a professor of Asian and Middle Eastern Studies at Duke University states that he views it as a type of 'spiritual colonialism', an ongoing process of erasing, and occupying a spiritual landscape lived by Muslims from Bosnia to South Asia.[2] Not so surprisingly, Barks who wrote for the American readership, has found his works being read and championed in the Muslim world too. This includes Kashmir as well. Just like '12 Rules of Love', Barks' translations have found a good wave of readership among the young generation here. The idea of 'Hoor', which originally had much deeper and diverse meanings in religious context will now exclusively mean 'a perfect satisfaction of all our sexual wanting'.[3] The reality of Sufism is now being moulded away from its bedrock foundation, i.e. Islam into the 'new age spiritualism' and clearly, even we Kashmiris, the inhabitants of 'resh waer' are aiding in the process.

The spiritual and the religious has lost meaning for us. What now remains of them is their aesthetic symbolism. We have reduced our places of spiritual meaning and healing, khanqas, dargas, to mere props in the frames of our social media posts. The devotion, longing and emotions of devotees mean to us only as much as it would to create a 'beautiful', 'woke' and 'meaningful' frame on the internet. Their essential significance now remains in the memories of our ancestors and we are deliberately replacing the essential with the aesthetic, denying ourselves the spiritual legacy we rightfully inherit. If anything, we like our spiritual ethos only for its 'love and kindness' while we ignore its emphasis on self-purity, submission and devotion to religion just like the New Age spiritualists.

The reasons for this untoward leaning of ours can be much explored and debated. However few things remain clear: that we are the active agents in the erasure of our Mystical Heritage and that we have adopted for ourselves, either knowingly or unknowingly, the outsider's gaze upon our much nurtured reality.

Cloned like her fellow participants in a similar attire and an identical smile pasted so tightly as though world peace depended on it, 21-year-old Harnaaz Sandhu's Miss Universe crown came after she had answered some challenging questions including one where she gave cat calls in response to being asked to impersonate an animal.

Seeing her stroll on a stage rolling a giant umbrella in her hand was a big slice of dystopia. The last two years have encouraged the need to cut the clutter - superficial, toxic and sometimes even personal. Necessity or invaluable distraction are the two reset buttons on our remotes of life. Where then do beauty pageants fit in, when they have already long outlived their sell by date?

**Interesting timing** The timing of this title is interesting. The win for India after 21 years at the Miss Universe pageant comes after a stunning IPO by e-commerce company Nykaa that sells

beauty and fashion products.

The success of the IPO was a revelation that the Indian woman consumer had been quietly lapping up beauty, online. Was it time to focus the attention back on a market that was once spearheaded by a flurry of crowns that suddenly dried up as though the job was done? Is the Indian beauty

queen at the mercy of economics? The existential question surrounding beau-

Forget for a moment the harsh standards of beauty these pageants extract- stipulations that a contestant must be below the age of 27, single and unmarried are extremely jarring- and try and align a global movement focusing on body positivity with a contest that still objectifies women. At the Indian intersection, it also allows for casual sexism.

The last two years should have allowed for some re-think. It has been a time when unfettered access to social media has been at the hands of idle minds, when time stuck indoors has been spent doom scrolling and simultaneously perfecting an image online by imitating those who never show their real face.

While Covid has cost jobs, it has also been a boom time for the new age professional- influencers have been busy selling everything from perfection to products that promise the fairy tale. 'Mirror mirror on the wall,' is no longer a question.

Inspiring the social media audience

Beauty pageants inspire the predominantly young Instagram audience to take the short cut home when the last thing needed in these unsettling times is a resurgence of toxic beauty. Families have been shattered, incomes have disappeared, and footholds need to be found again

Judging on the basis, of physical beauty in-

stead of setting examples of admiring the inherent strength or inner beauty when it could not be a life less ordinary all around is tone deaf. Contests like these increase expectations they are also a push back for inclusiveness especially in a country that is still struggling at the base with body neutrality. Far from being embraced, plus sizes in our country are still looked at with embarrassment.

Bollywood is largely responsible for promoting body stereotypes where the comic element is always the overweight character and where the dusky girl never finds a groom until she uses 'Fair and Lovely' cream. As a social media user pointed out, activism over global matters doesn't quite sync with a Karan Johar movie which is where a number, of our beauty queens ultimately end up. Despite promises of change on the world stage, from Aishwarya Rai, Lara Dutta to Priyanka Chopra, beauty queens don't offer a

murmur as they get pigeonholed in Bollywood. Impossible physical standards For decades the failure to match the perceived notions of conventional beauty has

been internalised as humour and the impos-

sible physical standards are promoted even by families and relatives whether subtly or openly. Ever wondered why young girls are just drinking warm water at parties?

Contrary to an overwhelming belief, body shaming cannot be dismissed as something that is 'just a phase' or a 'figment of someone's imagination.' Teenagers today are paying the price for this problematic conviction that is insidious and compounded now by the desperation of social media validation. They believe, they get just one shot, refusing to believe that for every Harnaaz there are countless others who didn't make the cut.

More than a handful of schoolgirls have told me how feeling physically inadequate they resorted to self-harm. Harnaaz's win is welcome for aspirational small- town India, but in school and college corridors, the claws of anorexia, bulimia and depression are not unfamiliar. Alicia Machado who won the title in 1996 opened, up last year about her battle with anorexia during the year she was Miss Universe as a 19-year-old.

The winners may make themselves believe that the times are unchanged and a beauty pageant is a platform for activism, but their own lack of choice on that stage is a giveaway.




FALSE ALLIES: India's Maharajahs in the Age of Ravi Varma

India and Asian Geopolitics: The





Midnight's Borders: A people's History of Modern India




#### The Fractured Himalaya: India, China, Tibet 1949-1962

## **Academic Education Can Positively Affect Aging Of Brain: Study**

he benefits of good education and lifelong learning extend into old age. The initial findings of a longterm study show that certain degenerative processes are reduced in the brains of academics. Their brains are better able to compensate for age-related cognitive and neural limitations.

A good education is an excellent way to embark on a successful career and develop your personality. But can education also have a positive effect on our brains as we get older? A team of researchers under the University Research Priority Program "Dynamics of Healthy Aging" led by Lutz Jancke, professor of neuropsychology at the University of Zurich, has now explored this question in a long-term study.

more than 200 senior citizens for over seven years. The study participants are not affected by dementia, have average to aboveaverage intelligence, and lead highly active social lives. They were examined neuroanatomically as well as neuropsychologically using magnetic resonance imaging at regular intervals. Based on complex statistical analyses, the researchers were able to show that academic education had a positive effect on age-related brain degeneration.

In her PhD thesis, first author Isabel Hotz used novel automatic methods among others to study so-called lacunes and white matter hyperintensities. These degenerative processes showed up as "black holes" and "white spots" on the digital images. The reasons for this are not yet known and may have to do with small, unnoticed cerebral infarcts, reduced blood flow or loss of nerve pathways or neurons. This can limit a person's cognitive performance, in particular when degeneration affects key regions of the brain.

The findings revealed that over the course of seven years, senior citizens with an academic background showed a significantly lower increase in these typical signs of brain degeneration. "In addition, academics also processed information faster and more accurately - for example, when matching letters, numbers of patterns. The decline in their mental processing performance was lower overall," summarizes Hotz.

The findings add to the initial findings of other research groups, who have found that education has a positive effect on brain aging. Previous studies also suggest that mental processing speed depends on the integrity of neural networks in the brain. If these networks are affected, mental processing speed decreases

Even though no causal link between education and reduced natural brain degeneration has so far been found, the following at least seems likely: "We suspect that a high level of education leads to an increase in neural and cognitive networks over the course of people's lives and that they build up reserves, so to speak. In old age, their brains are then better able to compensate for any impairments that occur," says neuropsychologist Lutz Jancke. It is also possible that brains that are active well into old age are less susceptible to degeneration processes, adds the neuropsychologist, though this would have to be verified in the further course of the ongoing long-term study.

## **Covid-19 Takes Sheen Off Entrepreneurial Activities** In India: Survey

**AHMEDABAD:** The COVID-19 pandemic has taken its toll on the entrepreneurial activities in the country with the total early-stage entrepreneurial activity declining to 5.34 per cent in 2020-21, as compared to 15 per cent in the previous year.

According to the Global Entrepreneurship Monitor (GEM) India Survey conducted by Entrepreneurship Development Institute of India (EDII), the entrepreneurial intentions among individuals have declined due to the setback of the pandemic.

The survey was conducted in over 45 countries of the world, of entrepreneurs and entrepreneurial perceptions. EDII, Gandhinagar conducted this GEM India survey with a sample size of 3,317 adults and national level experts.

'The survey has found out that the major indicator of entrepreneurial activity - the TEA - has declined significantly due to the COVID-19 pandemic. Of the total population in the work age group in 2019-20, TEA was 15 per cent which has declined to 5.34 per cent," EDII Director General and team leader of GEM India Sunil Shukla told PTI.

### **RBI Extends Card Tokenisation Deadline By 6 Months Till Jun-End**

MUMBAI: The Reserve Bank of India (RBI) has extended the sion, Payments Council of India card-on-file (CoF) tokenisation deadline by six months to June 30, 2022, in view of various representations received from industry bodies.

Card-on-file, or CoF, refers to card information stored by payment gateway and merchants to process future transactions. The earlier deadline was December 31, 2021.

"In light of various representations received in this regard, we advise...the timeline for storing of CoF data is extended by six months, ie., till June 30, 2022 and post this, such data shall be purged," RBI said in a notification addressed to all payment system providers and payment system participants.

In addition to tokenisation, it said. "Industry stakeholders may devise alternate mechanism(s) to handle any use case (including recurring e-mandates, EMI option, etc.) or post-transaction activity (including chargeback handling, dispute resolution, reward/ loyalty programme, etc.) that currently involves/requires storage Avenues, Vishwas Patel said.

### Of 183 Omicron Cases **Analysed, 87 Fully Vaccinated With 3 Having Booster Shots, Says Govt**

NEW DELHI: Of the 358 cases of the Omicron variant of coronavirus reported in India so far, 183 were analysed and it was found that 87 of them were fully vaccinated with three having received booster doses while 70 per cent were asymptomatic, the government said on Friday.

Two were partially vaccinated, seven people were unvaccinated while 16 were ineligible to receive vaccine doses in the country's national vaccination programme. The vaccination status of 73 is still unknown, Union Health Secretary Rajesh Bhushan said at a press conference.

"Of the 183 Omicron cases analysed so far, 87 cases were fully vaccinated with three -- two in Delhi and one in Mumbai -- having received booster shots, 70 per cent were asymptomatic and 61 per cent were males," he said.

Bhushan said 121 cases had foreign travel history, while in 44 cases the infected had come in contact with foreign travellers and information about 18 people were still not available.

ICMR Director-General Dr Balram Bhargava said, "The predominant strain in India continues to be Delta, including the recently identified clusters. Therefore, we need to continue with the same strategy of following Covid-appropriate behaviour and ramping up vaccination."

Infection due to Omicron variant "does not necessarily lead to severe symptomatic clinical disease". In India, about a third of all the detected cases were mildly symptomatic and the rest were asymptomatic, he underlined.

Therefore, I want to emphasise that the treatment for Omicron infected symptomatic individuals remains the same. It does not change from that for Delta, Alpha or the Beta variant."

Noting the world is witnessing a fourth surge in Covid cases, the government on Friday cautioned people against lowering the guard, particularly during year-end festivities, even as it underlined that infection due to Omicron does not necessarily lead to severe symptomatic disease.

Of the 358 cases of Omicron variant detected so far in 17 states and Union Territories, 114 have recovered or migrated, according to the Union Health Ministry data updated at 8 am.

The country has 244 active cases of the omicron variant of coronavirus.

# With China, Vajpayee sought modus vivendi: Jaishankar

**NEW DELHI:** Atal Bihari Vaipavee introduced policy corrections that reflected the end of the Cold War and the new global balance, External Affairs Minister S Jaishankar said on Friday and noted that the former prime minister sought a modus vivendi with China that was based as much on mutual respect as on mutual interest.

Jaishankar also said the winds of change are most apparent in the Indo-Pacific and it is there that the diplomatic creativity which Vajpayee inspires should be most strongly applied.

"We are looking at a complex set of transformations that are simultaneously underway. The Indo-Pacific is witnessing both multipolarity and rebalancing," he said in his opening remarks at the Second Atal Bihari Vajpayee Memorial Lecture which was delivered by Michael Fullilove, the Executive Director of the Lowy Institute of Australia.

The Indo-Pacific is seeing great power competition as well as "middle power plus" activities, and orthodox politics including territorial differences are in sharper play, side-by-side with currencies of power like connectivity and technology, Jaishankar said.

In fact, no other landscape illustrates better the widening of our definition of national security, he said.

said, "If we are to look at the essence of his approach to international relations, it is evident that this focuses on responding effectively to global changes.'

Where the United States was concerned, former prime minister Vajpayee introduced policy corrections that re-flected the end of the Cold War and the new global balance.
"At the same time, he kept India's

course steady vis- -vis Russia despite the turbulence of that era. With China, whether as Foreign Minister or as Prime Minister, he sought a modus vivendi that was based as much on mutual respect as on mutual interest," Jaishankar said.

With Pakistan, Vajpayee strenuously tried to dissuade them from their path of sponsoring cross-border terrorism, he said.

"All this, of course, was underpinned by his belief that India must develop deeper strengths at home. This found expression in the exercise of the nuclear option as it did in the economic modernisation that he presided over," the external affairs minister said.

In his lecture on "Australia, India and the Indo-Pacific: The need for strategic imagination , Fullilove compared diplomacy with cricket, saying the game of cricket is in many ways similar to the great game of the relations between states.

"Like foreign policy, cricket is a long game. A Test match can take up to five

diplomacy. Sometimes a draw can be a win, cricket and foreign policy requires many of the same qualities including intelligence, skill, patience, discipline, toughness and imagination," he said.

Fullilove said wealth and power are shifting eastwards toward India and Australia.

"Impressive Asian economic growth in recent decades has transformed the region and lifted more than a billion people out of poverty. Emerging Asia is the most dynamic part of the world, accounting for more than half of global growth despite representing only a third of the global economy," he said

"Bilateral relationship between New Delhi and Canberra has the character of a long innings, we started slowly but now that we have settled in we are taking our shots and the runs are flowing," Fullilove said.

He suggested establishment of a high level economic dialogue between Australia and India. The two countries should improve the interloperateability between thei armed forces, Fullilove said listing a slew of suggestions to strengthen partnership.

Citing a study, he said neither the US nor China would be able to wield undisputed primacy in the Indo-Pacific region.

"A bipolar future beckons. In this future, the decisions made by other Indo Pacific powers including Australia and India will be highly consequential. Our actions may well constitute the marginal difference," he said.

### **Security Breach Alleged During President's Thiruvananthapuram Visit**

Thiruvananthapuram: The Central agencies are probing the alleged security breach that happened during President Ram Nath Kovind's visit here, official sources said on Friday. The security breach occurred when Thiruvananthapuram Mayor Arya Rajendran's car allegedly tried to become part of the President's convoy which was heading towards the venue of the President's programme in the city on Thursday, they said.

The Mayor's office, however, denied the allegations, saying they were not aware of such an incident. They said they came to know about the incident through the media reports.

The state government has not reacted to the developments. The President was in the state capital on Thursday for unveiling the statue of P N Panicker, considered the father of library movement in Kerala.

Sources said the central agencies are also probing the allegations that water connection was not provided to the rest room arranged for the President at the venue. Terming it as a serious issue, BJP state president K Surendran today urged the government to take action against the Mayor and the officials for their alleged lapses during the President's visit.

Concluding his four-day Kerala visit, the President left for New Delhi this morning.

## **US To Lift Omicron-Linked Travel Ban On Southern Africa**

Washington: The U.S. will lift travel restrictions on eight southern African countries that it imposed to try to blunt the spread of the COVID omicron variant, the White House announced Friday. The variant, which was first detected by scientists in South Africa, has since spread around the world. The World Health Organization and

leaders in southern Africa criticized the travel ban as ineffective and unfairly damaging to local economies.

The November 29 ban barred nearly all non-U.S. citizens who had recently been in South Africa, Botswana, Eswatini, Namibia, Lesotho, Malawi, Mozambique and Zimbabwe. The restrictions will be lifted on New Year's Eve. White House spokesman Kevin Munoz said on Twitter that the decision was recommended by

the Centers for Disease Control and Prevention. Munoz said the temporary travel bans bought scientists necessary time to study the new virus variant and conclude that the current vaccinations are effective in blunting its impact. Omicron is now spreading rapidly throughout the U.S., including among the vaccinated, but a huge majority of those being hospitalised are

Much about the omicron coronavirus variant remains unknown; scientists say omicron spreads even easier than other coronavirus strains, including delta. The government reports that 73% of new infections nationwide are from the omicron variant. But while breakthrough infections among vaccinated people have become common, they have rarely led to severe illness or hospitalisation.

The rapid advance of omicron, along with more people gathering indoors during winter, has led to a major infection spike. The seven-day rolling average for U.S. COVID-19 cases climbed past 160,000 this week, according to data collected by Johns Hopkins University. That's more than double the average in late November.

sion has been pronounced on it yet. "That is why...we are going to the Supreme

Court. Others have also gone," he said. On Minister of State in the PMO Jitendra Singh claiming after the Delimitation Commission meeting of December 20 that he and other NC members were satisfied, Abdullah said, "What did he (Singh) expect us to do. Fight? We are not goondas. We have no voting rights, we can only listen and put our objections which they have allowed us to do. And they have given us time till December 31. Our report will be there

before that with our objections." He said since the report is preliminary, the commission will see the upsurge that has taken place among various communities in Jammu and Kashmir, and reiterated his demand for holding the delimitation exercise after the next census.

Referring to the reservation of nine seats for Scheduled Tribes and seven seats for Scheduled Castes in the preliminary report of the commission, the NC leader said, "We are not against the Scheduled Tribe reservation. Without reservation also, they had 15 members. So there is nothing new.'

So criticism is part of this life and we do not get worried by criticism. They (critics) give us strength. Because we participated, we realised what is in it and what have they done? How have they done?"

Asked about his participation in a meeting chaired by Congress president Sonia Gandhi in Delhi recently, Abdullah said, "The unity is essential if we want to save this nation, (protect it from) further division and further damage to its existence.'

"The unity is a priority and luckily Gandhi's efforts are to that effect. We should appreciate that she has taken this step. It is a good beginning and I am sure this will culminate in a good unity before the 2024 election. I am sure more meetings will take place, bringing more people together as we alone cannot beat the communal forces. She has to be part of (the united opposition)," Abdullah said.

On the differences between the Congress and the Mamata Banerjee-led Trinamool Congress, he said things have to be ironed out and "those will be ironed out, there is no doubt about it."

"Past has to be put behind us if we want to work on the future," he said, expressing hope that "there will be unity of purpose" among the opposition parties.

"So this is what our intentions are that we

### **Harbhajan Singh Retires From All Forms Of Cricket**

**NEW DELHI:** Veteran off-spinner Harbhajan Singh, who became the first Indian bowler to grab a Test hat-trick in a memorable international career, announced retirement from all forms of cricket on Friday, saying that he is finally communicating what has been on his mind for the past few years.

The 41-year-old from Punjab took 417 wickets in 103 Tests, 269 wickets in 236 ODIs and 25 scalps in 28 T20Is in his illustrious career, which began in 1998.

"All good things come to an end and today as I bid adieu to the game that has given me everything in life, I would like to thank everyone who made this 23-yearlong journey beautiful and memorable," he tweeted. "From the narrow lanes of Jalandhar to becoming the Turbanator of Team India, it has been a beautiful journey of past 25 years," he said.

Harbhajan, who made his India debut during an ODI against New Zealand at Sharjah in 1998, last played for the country in March 2016 during a T20I against the

He said he harboured hopes of



retiring in India colours but that could not materialise.

"Like all cricketers, I too wanted to bade adieu in Indian jersey but fate had something else in store for me," he said in a YouTube video posted alongside his tweet.

...there comes a time when you have to take some tough decisions and have to move on in life. Mentally I had retired long back but couldn't announce it. I haven't been active in cricket," he added.

Harbhajan had featured in a few matches during the first phase of last IPL for Kolkata Knight Riders but didn't play in the UAE leg of the league. One of the most memorable moments in his international career was when he snapped 32 wickets in three Tests, including the first Test hat-trick by an Indian, against Australia in March 2001. That historic Test triumph is one of most iconic moments in Indian cricket.

match at Burnley, the Premier League said Friday. It's the third match of the Boxing Day lineup to be postponed as part of a Sunday program that still

features six games. The Premier League has now called off 13 matches

because of coronavirus issues in two weeks, with players having to isolate after testing positive or if they are unvaccinated and a close contact of a COVID-19 case.

Everton had asked for the postponement citing virus cases and injuries, and the league's board "regrettably approved" the request. "The Board reviewed the club's request today to postpone the match following further injuries to their squad. They concluded that the club will not be able to fulfill their fixture this weekend as a result of an insufficient number of players available to play due to COVD-19 cases and injuries,"

the league said in a statement. On Thursday, coronavirus outbreaks at Leeds and Watford forced postponements of their Sunday matches. Leeds was scheduled to travel to Liverpool and Watford was set to play at

"While recognizing a number of clubs are experiencing COVID-19 outbreaks, it is the clubs' and the league's collective intention to continue the current fixture schedule where safely possible," the league said.

### **Juventus Lost Their DNA After Ronaldo's Arrival: Buffon**

TURIN: Juventus great Gianluigi Buffon said Cristiano

Ronaldo's arrival at the club in 2018 ultimately led to them losing their "DNA of \_ being a team". Ronaldo, now back at chester United for a second spell, scored 101 goals in 135 appearances for Juventus and won Serie A twice but the club did not progress beyond the Champions League quarter-final stage during his

three years there. Buffon returned to his first club Parma in June after nearly two decades at Juventus – he spent the 2018-19 season at Paris St Germain - where he won 10 Serie A titles.

"Iuventus had the chance to win the Champions League the first year he arrived, which was the year I was at Paris St Germain, and I couldn't figure out what happened," Buffon told American broadcast network.

### FIR Lodged Over 'Hate' Speeches At Dharma Sansad In Haridwar

**Dehradun:** No arrest has been made yet in connection with alleged hate speeches delivered at a "Dharma Sansad" held in Uttarakhand's Haridwar recently to incite violence against the minorities, police said on Friday.

An FIR has been lodged against Jitendra Narayan Tyagi, who was earlier known as Waseem Rizvi, and others in connection with the event on the basis of a complaint filed by a Jwalapur resident, Haridwar Kotwali Station House Officer (SHO) Rakinder Singh said, adding that an investigation in the matter is underway.

Tyagi changed his name from Waseem Rizvi after converting to Hinduism earlier this month, he said

"We have also received some rootage of the event from the complainant, which are being looked into." the SHO said.

Asked whether arrests are likely to be made, he said that may happen only after the conclusion of the probe.

Superintendent of Police (city), Haridwar Swatantra Kumar also said the investigation in

the case is on. The FIR has been registered under section 153A of the Indian Penal Code (promoting enmity between different groups on grounds of religion, race, place of birth, residence, language etc. and doing acts prejudicial to mainte-

nance of harmony), he said. Extremely provocative speeches were allegedly made by the participants at the threeday event held at the Ved Niketan Dham in Haridwar last week.

On Thursday, a senior Trinamool Congress (TMC) leader demanded immediate action against the organisers and the speakers of the event.

TMC's national spokesperson Saket Gokhale submitted a complaint at the Jwalapur police station, asking the SHO to register an FIR in the matter within 24 hours.

Gokhale, who shared a copy of his complaint on Twitter, also set a deadline of December 27 for the police to arrest the organisers of the "Dharma Sansad" and those who allegedly delivered inflammatory speeches against Muslims and other minorities at the event.

If an FIR is not registered against those involved within 24 hours, a plaint will be submitted to the judicial magistrate, the TMC leader said in his complaint to the SHO.

At the event, several speakers allegedly made inflammatory and provocative speeches, calling for the killing of the members of minority communities and asking people to take up arms and shoot a former prime minister of the country.

Gokhale also shared links on Twitter of video clips purportedly of the hate speeches delivered at the event

The "Dharma Sansad" was organised by Yati Narasimhanand Giri of the Juna Akhada, who is already under police scanner for making hate speeches and inciting violence against the minorities in the past. --- PTI

# World Witnessing 4th Covid Surge: Govt Cautions People Against Lowering Guard

NEW DELHI: Noting that the world is witnessing a fourth surge in COVID-19 cases, the government on Friday cautioned people against lowering the guard, particulary during yearend festivities.

It urged people to avoid crowding and unnecessary travel and stressed on COVID-19-appropriate behaviour and expedited vaccination.

Addressing a joint press conference on the pandemic, a senior official said the predominant strain in India continued to be Delta, including in recently identified clusters.

India has so far reported 358 cases of the Omicron variant, of which 183 were analysed and 121 of them were found to have foreign travel history. Of the 183 Omicron cases

fully vaccinated with three having booster shots, 70 per cent were asymptomatic, and 61 per cent were males, the government said. Citing the World Health Organisation's findings, the

analysed so far. 91 per cent were

government said Omicron has significant growth advantage over Delta and is spreading fast through communities with a doubling time of 1.5 to 3 days.

The world is witnessing a fourth surge in COVID-19 cases and having an overall positivity rate of 6.1 per cent.

The government said the COVID-19 case positivity rate in Kerala and Mizoram is much higher than national average and a cause for concern.

It said 20 districts across country were reporting a weekly positivity rate between 5 and 10 per cent and two districts over 10 per cent.

The government cautioned people against lowering the guard, particulary during Christmas and New Year festivities.

It said about 61 per cent of India's adults are fully vaccinated against COVID-19 and 89 per cent have been administered the first dose.

In view of the emergence of the Omicron variant, the government appealed to the private health sector to be ready as it has to play an important role in managing the pandemic.

According the Union Health Ministry data updated at 8 am, India recorded 6,650 new coronavirus infections, taking its tally of cases to 3,47,72,626, while the count of active cases has declined to 77,516.

The death toll due to the disease has climbed to 4,79,133, with 374 daily fatalities being

### 85-Year-Old Farmer **Acquitted After 400** Hearings In 35 Years


SHAMLI (UP): Dharampal Singh, 85, has finally been acquitted for want of evidence by Additional Chief Judicial Magistrate.

It took him 35 years of a legal battle and more than 400 hearings to prove his innocence. He was booked in 1986 for allegedly making pesticide illegally in his house.

Dharampal Singh, a farmer from Haran village in Shamli district, said after his acquittal, "It feels like a huge burden has been lifted from my shoulder.' His brother, Kunwarpal, was a co-accused but he died five vears ago.

Another person, Liyaqat Ali, booked in the case was earlier declared an absconder by court. "I have lost my reputation,

money and mental peace during the long legal battle. It took long to get justice, but now I am happy that truth has prevailed. I would like to thank the honourable court for giving me relief. I have lost a lot of money and time



making rounds to court for appearing in nearly 400 hearings n the case," he told reporters.

In November 1986, Thana Bhawan police booked two brothers, Dharampal and Kunwarpal, and one Liyaqat Ali for allegedly making pesticide without licence. Police had also claimed to have recovered 26 bags of pesticide while they were being loaded into a truck.

The three were booked under various sections of IPC, including section 420, and arrested them. After spending 18 days in jail, the three were released

### **Tamil Nadu Doctors Reportedly Taking Covid-19 Vax Booster Doses In Secret**

CHENNAI: Several doctors in Tamil Nadu are reportedly taking booster doses of coronavirus vaccine---yet unauthorised by the government---in secret, sources said.

Sources in the Health Department said that many doctors are taking booster doses from private hospitals, while some of them are taking the boosters from government hospitals themselves using the vials that remain unused.

A senior doctor at a private Chennai hospital said: Global studies in latest medical journals reveal that the antibody levels even after the second dose of vaccines are much less and hence, booster doses are necessary." Some doctors also said that it was the doctor community who had taken the first dose of the vaccine and the duration of Covishield vaccines was "low".

However, state's Director of Public Health, Dr. T.S. Selvavi-

nayagam, said that the Central Government has approved only two doses of vaccine and "taking more doses will be a violation of the Government of India

On the other hand, doctors say that they have co-morbidities and have for long been waiting for government approval.

"We have waited for long for the government approval to booster doses. This will lead to us curtailing our work as we have several co-morbidities and require a booster dose," a senior doctor, who is the former Head of the Department of Medicine at a leading state government medical college, said.

Many doctors are taking Covishield as a booster dose if they had taken Covaxin earlier and vice versa. Doctors said that mixing two different vaccines has increased the antibody levels of the person and immunology studies conducted by the Indian Council for Medical Research (ICMR) have also shown that mixed vaccines have a better effect.

## Third Covid Wave In India May Peak In Early Feb: IIT-Kanpur Study

**NEW DELHI:** The third wave of the Covid-19 pandemic in India may peak by February 3, 2022, claims a modelling study by researchers at the Indian Institute of Technology Kanpur. However, the forecast is based on the assumption that India will follow the trends of rise in cases seen in many countries glodally driven by the Omicron variant of coronavirus.

The yet-to-be peer-reviewed study, posted on the preprint repository MedRxiv on December 21, used a statistical tool named the Gaussian Mixture model to forecast

the third wave. In their study, the researchers used data from countries such as the US, UK, Germany, and Russia that are already facing the third Co-

vid-19 wave. They modelled the daily data of cases in these countries to predict the impact and timeline for the

third wave in India. The study also used the data from the first and second waves in India, considering the number of

cases with respect to time

The model forecasts India's third wave of Covid-19 to peak in the beginning of February 2022. "The cases start rising around 15

December 2021 and the peak of the

third wave will occur on Thursday, 3 February 2022," they wrote in the research paper. The authors of the study noted that the conclusions are based on the assumptions that "a third wave

of Covid-19 may hit the country, and will follow the trends happening around the world. However, the researchers noted that the exact peak number of cases cannot be estimated accurately with

the study as it did not consider the vaccination data of the population. The research team comprised of Sabara Parshad Rajeshbhai, Subhra Sankar Dhar, and Shalabh, all from the Department of Mathematics

and Statistics at IIT Kannur The authors noted that the vaccination campaign by the union government is a good initiative but it will take some time to reach "100 per cent efficacy".

"In many countries like the US, UK, Germany, Russia, the majority of the people have been vaccinated but still they are currently facing the third wave," the authors explained.

"So, India and other countries have to build up the defences and be prepared for another wave so that it is not as devastating as the earlier ones," they added. According to the National Co

vid-19 Supermodel Committee, the

third wave of Covid-19 is expected

to peak in early next year but would be milder than the second wave. The members of the committee said last week that daily caseload in India is expected to increase once Omicron starts displacing Delta as

the dominant variant. India on Friday recorded 122 cases of the Omicron variant of coronavirus in a span of 24 hours, the highest so far, pushing its tally in the country to 358.

Overall, the country reported 6,650 fresh Covid-19 cases, increasing the country's caseload to 3,47,72,626, the Ministry of Health and Family Welfare said. --- PTI
