## Weekend **Curbs Imposed** in J&K

#### **Press Trust Of India**

**JAMMU:** The Jammu and Kashmir administration on Saturday imposed "complete restriction on non-essential movement" during weekends in the Union Territory amid a surge in Covid cases that rose by 2,456 a day earlier.

Announcing the decision of the State Executive Committee (SEC), which met under the chairmanship of Chief Secretary A K Mehta, officials said night curfew and online mode of teaching in schools and colleges will continue.

After a weekly review of the COVID-19 situation, Mehta said there was a need for additional steps besides continuing with the existing Covid containment measures in all districts given the uneven trend in daily cases

as well as rising positivity rate. "There shall be a complete restriction on non-essential movement during weekends in entire Jammu and Kashmir," Mehta said in his latest order.

However, asymptomatic people arriving in the Union Territory by air, rail and roads would not be required to undergo RT-PCR or Rapid Antigen test on arrival if they have a valid and verifiable final certificate report of COVID-19 vaccination or a valid verifiable negative RT-PCR report done within 72 hours of arrival.

"RT-PCR or RAT Covid tests shall, however, be conducted on symptomatic incoming passengers by air, rail and road," the order said.

Inner-state movement of passenger vehicles of State Road Transport Corporation and of private buses shall be permitted for fully vaccinated people with verifiable RT-PCR More on P10

## **Govt Announces Rules** For Land Conversion

**JAMMU:** The Jammu and government Kashmir on Saturday announced rules for converting agricultural land into non-agricultural land beyond the already stipulated 400 square metres which was allowed for only residential purposes. The facility of land conver-

sion is believed to become pivotal for the union territory's industrial growth that had largely been impeded by non-availability of land for the industrial purposes. An official statement said:

"The Revenue Department framed Jammu and Kashmir Agricultural Land (Conversion for Non-Agricultural Purposes) Regulations which empowered land owners to convert agricultural land for non-agricultural purposes beyond 400 square

metres for residential purposes. "The concerned district development commissioner will head the committee which will examine the plea for conversion of agricultural land into non-agricultural and grant permission after recommendations from the Committee.

"The Committee will have the Assistant Commissioner (Revenue) as the Member Secretary and will include senior most officers in the districts of Public Works (R&B), Irrigation & Flood Control, Power Development, Pollution Control Committee (if required), Agriculture, Industries and Commerce, Development Authority of the district, Forests and any other member(s) coopted by the Chairman.

"The district level Committee will meet every week on a fixed day to consider cases for change of land use. The District Collectors will, however, be empowered to call additional meetings to dispose of the cases.

"The Government has listed certain conditions on which the permission for conversion of land use will be granted. The grant of permission shall be subject to the provisions of the Jammu and Kashmir Land Revenue Act and Rules framed. The land shall not be used for a purpose other than that for which permission is granted.

"If the applicant does not commence non-agricultural use applied for within one year from order of the date and up to the maximum period of two years from first date of permission, the permission granted shall be deemed to have lapsed. The Assistant Commissioner Revenue/Sub Divisional More on P10

## **Study Finds Non-English Language Science May Save Biodiversity**

#### Agencies

According to recent research, non-English language science may hold untapped information which might be crucial for the conservation of global biodiversity.

The research has been published in the 'PLOS Biology Journal'.

Few studies to date have quantified the contribution of science written in non-English languages to scientific communities and the application of science. These researchers scrutinized over 400,000 peer-reviewed papers in 326 journals published in 16 languages, identifying 1,234 studies that provided scientific knowledge on saving species and ecosystems. Importantly, the number of such

non-English-language studies being published is increasing, particularly in geographic areas and for species where English-language knowledge is scarce, including Latin America and other regions where conservation is needed the most.

These findings have important implications for global efforts to tackle the biodiversity crisis, where lack of



evidence is an issue commonly faced when trying to implement evidencebased conservation. The authors demonstrated that incorporating non-English-language studies can expand the availability of scientific evidence on species and ecosystems into 12-25 per cent more areas and 5-32 per cent more species.

This can be a game-changer," said Dr Tatsuya Amano at the University of Queensland, Australia.

Most global studies and assessments on biodiversity reported significant gaps in the availability of scientific knowledge, quite often without having explored science written in non-English languages.

rinagar Even after the government orders biometric attendance, the biometric attendance is still in place at Government Dental College Srinagar.

Doctors while talking with the news agency said that biometric attendance is still in place irrespective of government orders, "there by principle is putting the lives of doctors at risk.

They said the hospital is mostly run by post graduates and senior residents and risking their lives needs strict intervention from higher authorities.

They said that since the resurgence of Covid-19 through the past one week or so, many of them have returned as Covid positive.

'We are still being forced to come to the hospital for marking our biometric attendance as there are verbal orders that the isolation period will be marked as 'on casual leave" means our salary deduction," they said.

'You can imagine that one doctor being Covid positive, coming to mark their attendance at an already congested biometric attendance point, begins the chain and you can enquire about the number of doctors returning positive over the last one week in GDC," they said.

They alleged that many of their contacts who are symptomatic don't want to get tested just for the fear that their isolation period would be marked as absent or on casual leave.

Meanwhile, Principal Government Dental College Srinagar Riyaz Farooq termed the allegations baseless and said that they have already processed and are processing the leave as per SO issued by the government on this behalf.



Jain said 68 and 65 polling was recorded in Mehdhar and Balakote blocks of Poonch dis¬tricts respectively, while it was about 78 percent in three blocks of Rajouri district.

He said counting was in progress and the results were expected by late evening.

Police said, barring one in¬cident of altercation between two groups during which some polling boxes were damaged in Aruni village of Poonch district, polling was peaceful.

A report from Tangdhar block said two women — 120-yearold Tahira Begum and 108-year-old Yakdob Bibi polled at the booth



## **Republic Day Parade: Only 24,000 People** To Attend, No Foreign Dignitaries

## Srinagar In Decay - II

midst the Srinagar Municipal Corporation's utterly dismal showing on the garbage disposal front come reports of yet another triumph in dereliction of duty - legally designated residential enclaves are to be declared commercial areas in abject capitulation before galloping violations of the famed Srinagar Master Plan.

The distinction between purely residential and commercial areas had already become blurred due to unregulated sprouting of business outlets in zones meant exclusively for habitation. The unchecked shopping complex syndrome which has been allowed to straddle the city indiscriminately has turned Srinagar into a vast market place with no demarcation of business and private zones. Markets are taking over even the few enclaves specifically planned as exclusive residential zones. And the commercialization of other residential areas, which do not enjoy the luxury of being designated as such, has overturned the very basic character of the once quiet and peaceful localities.

Every city worth the name has maintained clearly demarcated business districts to spare residential areas the unwelcome intrusion of commercial activity. Even in the case of New Delhi, that appeared to have lost the battle with indiscriminate commercialization, a turnaround has been witnessed with the government putting its foot down and upholding the sanctity of residential areas by a series of strict measures. Centralized and localized shopping malls, closing down of commercial spaces in residential areas and other such steps have restored a semblance of sanity to Delhi. But how do the bright sparks of Srinagar respond to the city's crisis? By simply caving in to the fait accompli. Sparing themselves the headache of thinking out a Srinagar-specific way out, our illustrious rulers take the shortcut of a legal artifice: let us solve the problem by one stroke of the pen and declare the mongrelized residential areas as commercial zones. The turmoil of the past years is often cited as the reason for the many ills plaguing government functioning, but no attempt is made to explain the booming commercial sector which has put such tremendous pressure on civic infrastructure. Taking a differential element for analysis, the case of Lal Chowk could prove particularly illuminating. This commercial hub of the city had begun showing unmistakable signs of saturation over two decades ago. But civic and government agencies have responded by choosing not to act. The message from Lal Chowk was clear - the demand for commercial space was growing at an incredible pace, and what was happening in the heart of the city would definitely be replicated in other parts of Srinagar. One of the several possible ways to address the need would have been to plan a satellite commercial district, even a series of them, that could absorb the overflow from Lal Chowk and other major markets of the city. The top-heavy and ugly construction in the city's markets and the resulting intractable congestion, not to speak of traffic flow disasters, could have been avoided by the admittedly cost-intensive, but in the long run, cheaper, alternative of developing segregated, exclusively commercial zones. The daily needs of residential areas can always be met by planned and centralized shopping arcades or malls that would leave the peace of these zones largely undisturbed. True, city planning cannot be carried out in isolated segments, but has to be a holistic exercise including social, economic and other factors. But that is precisely what the bloated officialdom of the state is being paid for. But, instead of applying its mind to the pressing issues, the ruling class and its complicit bureaucracy is content with merely going through the motions of administration. Kashmir has had a singular set of rulers whose frequent jaunts outside and abroad have left them totally untouched and innocent of any desire to learn or be influenced by successful civic models elsewhere. Not a single ruler has ever voiced even the feeble wish of developing Srinagar on sane, practical and environmentally-sound lines. While the city is literally gasping for survival, all it gets as treatment is inaction on the bureaucratic front in the face of runaway commercialization and civic failure, and grandiose schemes on the rulers' front like golf courses and tulip gardens -a classic case of asking a bread-starved people to eat cake.

IGHER education is at the top of education pyramid and is considered as the backbone of any society. Menace of inbreeding has not only made institutions of higher learning bereft of academic growth, productivity and mobility but also has led to a rise of "Yes-Man" culture in these institutions. Those candidates who have the ability of making good connections with faculty members after securing admission in their respective PG courses get top ranks/Gold medals and also make sure there are no hurdles when they apply for research programmes irrespective of their worth.

In rare cases, inbreeding maybe beneficial to academic institutions but in society like ours where having any "channel" can do wonders for you, benefits of academic inbreeding are almost negligible.

Another practice – rather a menace -- that is marring our academic institutions is nepotism. Throughout our academic journeys, we all have experienced nepotism



in one form or another. Nepotism is the practice of people in high positions or possessing power to favour their own friends and family

instead of those who may be more qualified or talented. Institutions of higher learning, especially universities, where recruitments for faculty positions are done by respective university boards, meritocracy becomes the main casualty. Various independent studies have shown that people in power have adjusted their immediate family members or friends on top posts irrespective of their ability or worth for that very post due to ever increasing menace of nepotism thereby guaranteeing their career advancement regardless of their merit. At times even eligibility criteria is modified so as to give edge to their kinship.

Let us try to understand this by a case study where in a candidate despite having qualified NET/JRF got less points than the person having NET and SET only in a particular subject. Rules were modified in such a manner that for NET with JRF only 7 points were earmarked while " and this illegitimate and unethical practice continues for generations to establish hierarchy of such lobbyists. On certain occasions some posts have been exclusively created in academic council meetings to adjust their siblings or immediate family members by relaxing usual rules and norms.

These practices not only raise questions on the organizational or institutional integrity but also breeds distrust among other colearners and outside learners of similar learning stages, and dampens their motivation ultimately quality and productivity. Likewise, if some candidates somehow manage to secure their placements on merit, cronyism becomes their enemy which means close friends and family members of politicians are given preference against merit system. Despite giving sermons of upholding merit, governments/ authorities at the helm of affairs have failed to discourage such illegitimate and unethical practices in these academic institutions thereby deflating motivation among skilled/ talented and deserving pass outs.

## What Will Our Long-Term Peace With Covid-19 Look Like?

n New Year's Eve I watched revelers navigate crowded sidewalks on the fringes of San Francisco's financial district, headed to events like a Gatsby-style bash with bottle service and a Black & White Ball in a mall.

The day before, the city had registered 1,820 new cases of COVID-19 - just two weeks after the 7-day rolling average was still hovering below 200. These partygoers likely realized what they were risking. Yet here they were, determined and decked out in evening wear.

A few days later and a bit further to the south, a line of people waiting for CO-VID-19 tests stretched six city blocks. The surge was official. Yet, the mayor refrained from triggering any new restrictions.

We seem to be making a volatile peace with the pandemic. Taking more of what we can in bursts of "normal" life and accepting existential uncertainty in return.

The idea of simply eradicating COVID-19 like smallpox seems more unattainable every day. Instead, a growing familiarity with the disease, effective vaccines that make it possible to record fewer deaths, and political considerations have nudged us away from a hot war and closer to a stalemate.

opinion piece published last week by former members of US President Joe Biden's transition COVID-19 advisory board contends that leaders need to start clearly spelling out their goals for the "new normal' of life with COVID-19."

"In delineating a national strategy," the former advisers wrote, "humility is essential."

Some people have been wondering aloud or in print if they should just give up, allow themselves to get Omicron, and be done with it (answer: no).

It's unclear whether anyone in the 14th century suggested they might just give up and catch the Black Death. Yet, depleted populations somehow managed to adapt to and move past a disease that also disproportionately killed older people and those with pre-existing conditions.

That early version of the plague, a scourge that persists into the present, spurred initial attempts at international disease control like the first quarantine. It also helped people grasp the importance of basic hygiene and social distancing for containing disease, and spawned early precursors of international health authorities.

#### Being proactive as the pandemic 'burns itself out'

"Ultimately, all pandemics burn themselves out," Dr. Anthony Fauci, the top infectious disease expert in the US, said in an interview this past November. The choice with COVID-19, he added, is whether we want to let it kill and infect a lot more people in the process – or get more proactive. In order to be proactive in the new normal, the former Biden advisers wrote in

their opinion piece, real-time information systems will be necessary to more closely track COVID-19. The US, for example, still relies on imprecise estimates of the disease's spread, projections, and limited monitoring of the genetic changes causing new variants, they wrote.

Vaccine mandates will also be necessary to cope, former Biden advisers wrote in a separate opinion piece.

That's because at least 90% of the population will probably need immunity for a genuine "return to normalcy," they wrote, and few countries have ever managed to hit a vaccination rate like that without requirements. According to one tally, only a few countries have so far reached 90% in terms of people receiving at least one COVID-19 vaccine dose: the UAE, Cuba, and Chile. Evidence suggests vaccination may remain a reliable way to limit fatalities as COVID-19 endures. In Canada, for example, the death rate from the disease fell from 2.95 per million in 2020 to 0.42 per million in 2021, as the country recorded one of the highest vaccination rates in the world.



Fit Into Aussie Working Holiday Visa

## There Is No Cap On Applicants. Prior To The Pandemic Annual Numbers Were Greater Than 100,000

everal weeks ago I wrote about the revelation from the Australian Bureau of Statistics that Australia's birth rate has fallen to its lowest ever level. I argued that a major factor in this drop was the exorbitant cost of housing in the country, especially in Sydney and Melbourne. The inability of young people to feel financially secure and to plan their lives effectively inhibits the desire to have children. This in turn limits the country's capabilities – its ideas, the industries it has, its cultural output, and also its ability to defend itself.

Fewer children also means that the country's median age is set to increase. Australia's median age is currently 37.5 years old. This is quite good in comparison to some of its OECD peers – Japan's median age is 48.4 years, while Germany's is 45.7. The importance of the median age is that the state is looking for as many taxpayers as possible to off-set the costs of those who are not paying taxes yet (children) and who are no longer paying as many taxes (retirees). The higher the median age, the more unfavorable this dependency ratio is.

So with birth rates declining, Australia has to start considering what mechanisms it has to maintain a healthy median age. Over the past few decades Australia has increasingly relied on its immigration program to meet its immediate need for people. However, there is one specific visa that provides the country with an important stream of young and educated people. Most countries would consider this opportunity too good to be true, yet Australia seems carelessly ambivalent about it.

This is the Working Holiday visa. This visa offers people between the ages of 18 and 30 from a number of European,



North American, and East Asian countries the ability to live and work in the country for a year (French, Canadian, and Irish citizens can access it up to age 35). The visa holder can then reapply for subsequent visas up to three years total. There is no cap on applicants. Prior to the pandemic annual numbers were greater than 100,000.

The visa is colloquially known as the "backpacker" visa, as it is often used by people who are looking to take some time off after school and before university to travel around Australia and work periodically to finance their trip. Yet given the age brackets of the visa, it is also accessed by those who have completed degrees and are looking to utilize their skills in Australia as a way of advancing their careers, or indeed to find a way of migrating to the country more permanently.

The beauty of this visa is that other countries bear the cost of education while Australia reaps the rewards. pendency ratio, and delivers the country exactly what it needs – young, skilled people with an enthusiasm for Australia. Given Australia's declining birth rates, and the potential problem of a higher median age, it would make sense for Canberra to try and vacuum up as many of these people as possible. The question that should be at the forefront of the government's mind is this: How to make it easier for these people to transition to longer term visas, permanent residency, and citizenship?

Three years living in a country is long enough to put down roots. It is long enough to understand one's future prospects in the country, and to develop important social and personal bonds. Yet the visa designed to accommodate these personal bonds is so aggressively expensive that its actual goal is to disincentivize people from applying for it. Australia's partner visa costs \$5,650, a significant financial burden for young people (and also those not so young). In comparison, partner visas cost \$830 in Canada, \$325 in the United States, \$223 in Sweden, and \$112 in France.\*

This high bar is built on the assumption that a great many people applying for partner visas will be attempting to scam the system. It's also a belief that those in genuine relationships will have no problem paying such costs. The Australian government sees this as a test of love, but in reality it is a tax on love without any awareness of the social implications.

This is where the real problem for Australia lies; the tension between its culture of suspicion around its border and the things that are actually beneficial to the country. As we are currently witnessing with the saga around Novak Djokovic – as well as the ongoing offshore detention centers in Nauru and Papua New Guinea – this suspicion leads to farcical scenarios that defy practicality and work against the country's own interests.

While issues like birth rates, median ages, and dependency ratios can seem distant and abstract, disconnected from the lived realities of most people, the solutions to these macro policy problems come from micro responses. Governments need to recognize that a country's social health is reflected in its bureaucratic hurdles, and that social health improved when it establishes rules that are clear, attainable, and built on positive objectives rather than mistrust and fear.

## **Infants With Low-Risk Deliveries May Not Need Antibiotics At Birth: Study**

team of researchers has found that infants born through uncomplicated aesarean delivery. without labour or membrane rupture before delivery and no concern for infection, should not need antibiotics at birth.

The research has been published in the 'Pediatrics Journal'.

"Given the risks associated with early-onset sepsis in infants, it isn't surprising that newborns are often administered antibiotics immediately after birth," said first author Dustin D. Flannery, DO, MSCE, an attending neonatologist and clinical researcher at Children's Hospital of Philadelphia.

"However, our study shows that it is safe to withhold antibiotics in infants, including those born preterm, with low-risk de-

livery characteristics. Such infants are unlikely to be infected at birth, and can be spared the potential complications of systemic antibiotic exposure," he added.

Newborn infants are at risk for early-onset sepsis (EOS), a life-threatening infection that can occur within 72 hours after birth, due to exposure to bacteria during the birthing process. Predicting which infants will develop EOS, however, is challenging.

This has led to an order of magnitude higher rate of antibiotic use compared to the rate of infants with confirmed infection. Prolonged antibiotic use among newborns is associated with serious adverse outcomes among preterm infants and potential longstanding complications

among full-term infants, underscoring the need for a better way to assess infection risk.

Since the primary way a newborn is exposed to bacteria is through the delivery process, the researchers decided to analyse delivery characteristics to see if they could help providers identify infants at the lowest risk of EOS. In a retrospective study, they assessed all infants born between 2009 and 2014 at two Philadelphia birth hospitals who had blood or cerebrospinal fluid culture obtained within 72 hours after birth.

They examined medical record data for confirmed infection and for delivery characteristics, defining a "low-risk" delivery as a caesarean section, without rupture of amniotic membranes prior to delivery; an absence of labor or attempts to induce labour; and an absence of suspected or

confirmed maternal intraamniotic infection or foetal distress.

The researchers also included infants born across the gestational age spectrum. Prior studies have assessed EOS risk in both extremely preterm (less than 28 weeks gestation) and fullterm (37 weeks or more) infants, but few have analysed the risk among late and moderately preterm infants (28-36 weeks' gestation), despite the fact that these infants m natal int admissio

## **CBI Books GAIL Director In Alleged Bribery Case, Arrests 5**

PSU, officials said Saturday. Following the registration of the case on Friday, the CBI conducted searches at about eight locations in Delhi-NCR including the office of Ranganathan at Bhikaii Kama Place in Delhi and his residence in Sector 62, Noida.

Ramakrishnan Nair who had allegedly collected bribes, businessmen Saurabh Gupta and his Panchkula -based company United Polymer Industries and Aditya Bansal and his company Karnal-based Bansal Agency, they said.

"CBI laid a trap and apprehended a private person (Gaur) and a director of a private company (Kumar) based at Delhi when the alleged bribe of Rs 10 lakh was received by the private person from the said director of private company allegedly on behalf of director (marketing) GAIL, (Ranganathan)," CBI spokesperson RC Joshi said. The agency has so far arrested

five persons but Ranganathan has not vet been taken into custody. Searches at this premises are still on, sources said.

"Subsequent, searches were conducted at the premises of accused at Delhi, Noida, Gurgaon, Panchkula, Karnal etc, which led to recovery of Rs.84 lakh(approx), so far which include recovery of Rs 75 lakh from Gurgaon based private person. Searches are continuing at the premises of public servant," Joshi said.

It is alleged that Ranganathan was "indulging into corrupt and illegal activities in criminal conspiracy" with Gaur and Kumar who is also director of Rishab Polychem Pvt. Ltd based at Bahudargarh Road, Delhi. Kumar and Gaur allegedly

acted as Ranganathan's middlemen, by obtaining bribe from the private companies buying petro chemical products marketed by the GAIL, the FIR alleged.

It said sources informed the CBI that at the direction of Kumar, Gaur had asked Ranganathan for allowing some discount to the buyers on petro chemical products being marketed by GAIL in return of illegal gratification.

It is alleged that Kumar and Gaur met Ranganathan at his Noida residence on December 11 last year for discussing the proposal, the FIR alleged. Two days later Gaur informed Kumar that proposal of discounts is being considered in GAIL, the FIR alleged.

In order to arrange bribes, Kumar got in touch with other prospective beneficiaries of discount, after the final decision is taken in GAIL on issuance of the discount order. Gaur, Kumar and Ranganathan again met at a five star hotel in Delhi on December 14 to discuss it further.

He asserted that the morale of the soldiers deployed on snow-capped mountains for the country's security was sky-high.

"Our patience is a sign of our self-confidence, but no one should make the mistake of testing it," Gen Naravane said.

"Our message is clear, the Indian Army won't let any attempt to unilaterally change status quo along country's borders to succeed.'

The armies of India and China are locked in a military standoff in eastern Ladakh since May 5, 2020, after a violent clash erupted in the Pangong lake area. Both countries have conducted 14 rounds of military-level talks to resolve the standoff.

After May 5, 2020, both Indian and Thinese militaries gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

Northeast, are jointly giving shape to the 'Act East' policy of the central government, Gen Naravane noted.

He said the Indian Army is taking concrete steps to modernise itself so as to face current challenges and fu-

This move, the statement read, in which a group of journalists self-appointed itself as an "interim body," is uncivil, illegal, unconstitutional and without any precedence. It has been taken at a time when the process of registration is still pending before the authorities.

The journalist bodies have also appealed to the press bodies across the night, the official said.

Magistrate concerned can take action for any violation under provisions of the Act.

"For conversion of agricultural land, the owner will be charged a fee equivalent to Rs 5 percent of market value of the land as notified for the purpose under the Stamps Act. If subsequently land use is changed for a purpose other than that for which permission has been given, then the fee, if applicable on differential market value, shall be charged after permission for the purpose is accorded by the concerned District Collector.'

The statement went on to say that the Revenue Department has fixed a 30 days time limit for grant of permission.

"If no decision/comment is conveyed within a period of 30 days after receipt of application complete in all respects, the District Collector shall, deeming due consideration, grant permission exercising the powers vested on him and report details with explanatory notes to the Revenue Department. The timeline of 30 days shall be counted from the date of addressing all deficiencies as may be communicated by the District

The statement claimed that the "disgruntled" journalists had barged into the valley's premier press club and had held the office members as 'hostage".

"On January 15, the day when the administration had declared weekend lockdown in view of Covid surge, a group of journalists barged into the club office and forcibly took control of the club by keeping the office members hostage." The joint statement reads. "Large number of police and paramilitary personnel were deployed beforehand for this highly condemnable and completely illegal move.'

Expressing anguish over the "illegal and arbitrary" takeover of KPC, the statement further reads that "the administration, by allowing a few disgruntled elements to hoodwink the Club constitution, bylaws and flout all norms of law, has set a wrong and dangerous precedent".

The authorities, the statement further reads, had already communicated about the mandatory re-registration, which was initiated by the KPC management, but it took authorities more than six months to verify the

country including Press Council of India, Press Club of India, Federation of Press Clubs and Editors Guild of India to take a strong note of how the "local administration is supporting lawlessness and throttling a demo-cratic media body". "If such incidents are allowed to happen with a Press Club in Kashmir this can be precedent for the future." the statement ends.

Notably, on Friday, The Jammu and Kashmir administration had suspended the registration of Kashmir Press Club citing an adverse report by the Criminal Investigation Department (CID) of J&K Police.



akistan has decided to offer a permanent residency scheme for wealthy foreign nationals, including Sikhs living in the US and Canada, Afghans and Chinese, to attract investment and boost its flagging economy and national growth, it emerged on Saturday.

Information Minister Fawad Chaudhry through an overnight tweet announced that the new scheme was in line with the new National Security Policy, which was formally launched by Prime Minister Imran Khan on Friday.

"In line with new National Security Policy, through which Pakistan declared geo-economics as the core of its national security doctrine, the government has decided to allow permanent residency scheme for foreign nationals, the new policy allows foreigners to get permanent resident status in lieu of investment," the tweet said.

The Express Tribune newspaper reported that while sharing the background of the scheme, a key federal minister said that one of the purposes of opening the PR scheme was to attract rich Afghans, who were moving to Turkey, Malaysia and some other countries following the fall of Kabul last August.

"They needed to be incentivised," Chaudhry said.

In addition, the minister said, the scheme targets the Sikhs living in Canada and USA, who were willing to invest in religious sites, especially in Kartarpur Corridor but had no option to do so.

He said the third objective of the scheme was to incentivise the Chinese nationals, who wish to move or establish industrial units in Pakistan.

## **Added Safety Rules** For Some Boeing 787 Landings Near 5G Service

S. Federal safety officials are directing operators of some Boeing planes to adopt extra procedures when landing on wet or snowy runways near impending 5G service because, they say, interference from the wireless networks could mean that the planes need more room to land.

The Federal Aviation Administration said Friday that interference could delay systems like thrust reversers on Boeing 787s from kicking in, leaving only the brakes to slow the plane.

That "could prevent an aircraft from stopping on the runway," the FAA said.

Similar orders could be issued in the coming days for other planes. The FAA has asked Boeing and Airbus for information about many models. Boeing said it is working with its suppliers, airlines, telecom companies and regulators "to ensure that every commercial airplane model can safely and confidently operate when 5G is implemented in the

might be vulnerable to spectrum interference. The agency said this week it expects to estimate the percentage of those planes soon, but didn't put a date on it.

"Aircraft with untested altimeters or that need retrofitting or replacement will be unable to perform low-visibility landings where 5G is deployed," the agency said in a statement.

The order regarding Boeing 787s covers 137 planes in the U.S. and 1,010 worldwide. The 787 is a two-aisle plane that is popular on longer routes, including many international flights.

The FAA said that based on information from Boeing, the 787s might not shift properly from flying to landing mode if there is interference, which could delay the activation of systems that help slow the plane.

AT&T and Verizon have twice agreed to postpone activating their new networks because of concerns raised by aviation groups and the FAA, most recently after the FAA and Transportation

The order for the Boeing jets comes a day after the FAA began issuing restrictions that airlines and other aircraft operators will face at many airports when AT&T and Verizon launch new, faster 5G wireless service Wednesday.

The agency is still studying whether those wireless networks will interfere with altimeters, which measure an aircraft's height above the ground. Data from altimeters is used to help pilots land when visibility is poor. The devices operate on a por-

tion of the radio spectrum that is close to the range used by the new 5G service, called C-Band. This week's FAA actions are

part of a larger fight between the aviation regulator and the telecom industry. The telecom companies and the Federal Communications Commission say 5G networks do not pose a threat to aviation. The FAA says more study is needed.

Secretary Pete Buttigieg weighed in on the aviation industry's side. Buttigieg and FAA Administrator Stephen Dickson warned that flights could be canceled or diverted to avoid potential safety risks.

Under an agreement with the telecom companies, the FAA designated 50 airports that will have buffer zones in which the companies will turn off 5G transmitters or make other changes to limit potential interference through early July.

The 50 include the three major airports in the New York City area – LaGuardia, JFK and Newark Liberty – O'Hare and Midway in Chicago, Dallas/Fort Worth International, Bush Intercontinental in Houston, Los Angeles International and San Francisco.

That concession by the telecoms was modeled after an approach used in France, although the FAA said last week that France requires more dramatic reductions in cell-tower reach



## North Korea Hackers Stole \$400m In Crypto In 2021

WASHINGTON: North Korean hackers stole around \$400 million worth of cryptocurrency through cyberattacks on digital currency outlets last year, blockchain data platform Chainalysis said on Thursday.

Pyongyang is under multiple international sanctions over its atomic bomb and ballistic missile developments but analysts

say the North has also built up its cyber capabilities with an army of thousands of welltrained hackers who extract finances to fund the state's weapons programs.

In 2021, the hackers launched seven attacks on crypto platforms, extracting assets from "internet-connected 'hot' wallets" and moving them to North Korean controlled accounts, according to Chainalysis.
