SRINAGAR: A policeman had a narrow escape on Friday after an unidentified militant fired upon him from close range in Batamaloo area of this capital city.

Around 3:50 pm Friday, Constable Munir Meraj was returning home from a market when an unknown militant fired at him from close range in SD Colony of Batamaloo, eyewitnesses said. Meraj, who was also carrying his child in his lap escaped unhurt in the militant attack.

"He was returning home from the market when an unidentified gunman fired a single shot towards him. He got a bruise in his ear and survived miraculously," an eyewitness said.

He said the unidentified gunman quickly escaped from the spot after firing at the police constable. Meanwhile, soon after the

shootout, police and paramilitary CRPF personnel cordoned off the area and launched a search operation to nab the attacker, an official said.

# **Principal Secy H&UDD To Exercise Powers**

**SRINAGAR:** Amid over constitution of real estate regulatory authority, the Jammu & Kashmir Government has designated Principal Secretary, Housing & Urban Development as regulatory under the Real (Regulation Estate Development) Act-2016.

Lieutenant Government of Jammu & Kashmir has empowered Principal Secretary, H&UDD as regulatory under the real estate regulation law.

"In exercise of the powers conferred by third proviso of sub-section (1) of section 20 of the Real Estates (Regulation and Development) Act-2016, the Lieutenant Governor is pleased to designate Principal Secretary to Government Housing and

Development Department as the regulatory authority for the purposes of the said," reads a

notification issued by H&UDD. Under the law, until the establishment of a regulatory authority, the appropriate government shall, by order, designate any regulatory authority or any officer preferably the Secretary of the department dealing with Housing, as the regulatory authority for the purposes under this Act.

The I&K administration had last year initiated the process for constitution of the Real Estate Regulatory Authority (RERA) under the Real Estate (Regulation and Development) Act, 2016.

#### **BSF To Get Over 100 Steel Fabricated Habitats Along LoC**

NEW DELHI: The Border Security Force will soon get over 100 steel fabricated composite habitats along the Line of Control (LoC) in Jammu and Kashmir, officials said on Friday.

According to the officials, the BSF is in the process of setting up over 100 steel fabricated containers in high altitude Forward Defence Localities (FDLs) along the LoC to protect its troopers from the inclement weather, with an attached kitchen and toilets. The total cost of these will come to around Rs 35 crore, they added.

"These steel fabricated living accommodations will be insulated from inside, have bunk bed facilities and will have both solar and generator power supply," a senior BSF official said, adding that the locations of these FDLs will range from 8,000 feet to 15,500 feet. → More On P10

## **Cyber Police Recovers Rs 30L From Online Scamsters**

SRINAGAR: Cyber Police in Kashmir have recovered Rs 30 lakh which were in the process of being converted into foreign currency by online scamsters.

"Cyber Police Station Kashmir received a complaint from a senior citizen of Srinagar city, stating therein that an amount of ?11 lakhs has been fraudulently withdrawn from his bank account regarding which he has no knowledge. Accordingly, Cyber Police Kashmir started investigation promptly into the matter," a police spokesman said here on Fridav.

He said preliminary investigation revealed that the said Rs11 lakhs were transferred into the bank account of complainant's nephew.

The complainant's nephew disclosed that he came in touch with scammers over social media sites and they motivated him to invest in online trading to receive hefty



returns and direct credit to his bank account.

He also disclosed that apart from the said amount of Rs11 lakhs, he has also withdrawn an amount of Rs19 lakhs from his father's bank account and invested the same in online trading/investment, resulting in huge financial loss of Rs 30 lakhs.

# Late Arrivals, Desperate Lifts And The 'Nexus'—Bumpy Ride In Kashmir

Daily commuting in Srinagar has become a slog and shame for Fayaz Ahmad being rebuked for reporting late in office these

He faces the regular humiliation from his superiors despite leaving home early.

After arriving on time at Pantha Chowk, this Ananthag resident struggles to keep pace with his daily movement.

"Since Sumo cabs have been barred from entering the city, I'm forced to board the slow available transport," he said. "And it proves a daily bumpy ride for me.'

Frustrated over the existing traffic scenario, another commuter from north Kashmir said that he has to regularly wait at Parimpora Chowk to find



another transport to enter the

summer capital.

"If the government wanted to streamline traffic in Srinagar, they should've provided alternate to public," Gowher Ahmad, a resident of Pattan, said. "Just banning entry of Sumos into Srinagar won't resolve the issue, they've to think about people as well.'

Many passengers Kashmir Observer that they've been facing hassles from the last three months now when from different routes were stopped at various entry points - Nowgam, Parimpora, Hyderpora and PanthaChowk.

The stringent manning and drop-gates make the availability of public transport "scarce" and due to which the passengers including students and patients have to wait for hours to find a ride.

"Entering Srinagar in Sumo has become a penalised act," said Nazir Ahmad, a sumo driver from south Kashmir.

"I was lately fined Rs 2000 for my regular ride in the city. I now tread with caution. We know people face issues in finding transport to commute, but we too are helpless. While those blocking roads and sideways with their personal cars go scotfree, we poor souls are facing the music for the heck of it."

However, Muzaffer Shah, Senior Superintendent of Traffic Police, said his department is only implementing the 2017 J&K High Court order barring Tata Sumos and taxis coming from the south and north Kashmir beyond the PanthaChowk and Parimpora bus stands.

"Srinagar has more vehicles than its carrying capacity and the illegal Sumo stands were creating a traffic mess," SSP Shah said.

"We're only streamlining the traffic in Srinagar. There was a nexus at play where Sumos from different districts were given patronage and allowed to create a traffic mess inside the city. I've talked to all the Sumo stands associations all over the valley and they assured full support to my decision.

# **Weather Improves As** 'Chillai Kalan' Nears End

SRINAGAR: Dry weather prevailed in most parts of Kashmir valley with sunny day Friday. However cold wave intensified as minimum temperatures across Kashmir plunged below the freezing point.

Srinagar recorded a low of minus 3.6 degrees Celsius down from minus 1.3 degrees Celsius the previous night, they said.

Gulmarg recorded a low of minus 10.4 degrees Celsius slightly down from minus 10.0 degrees Celsius the previous night.

Pahalgam recorded a low of minus 11.8 degrees Celsius down from the previous night's minus 10.9 degrees Celsius, they said.

The officials said Qazigund recorded the minimum of minus 4.0 degrees Celsius, while the nearby south Kashmir town of Kokernag recorded a low of minus 4.9 degrees Celsius.

The mercury in Kupwara in north Kashmir settled at a low of minus 4.6 degrees Celsius.

Clear skies overnight resulted in a rare day of bright sunshine at the peak of winter in the valley.

Kashmir is currently under the grip of the 40-day harshest winter period known as 'Chilla-i-Kalan' which began on December 21 last year.

# **Study Finds English Songs Are Effective For Learning Vocabulary**

A team of researchers conducted a quantitative meta-analysis to examine the effect that teaching with English songs has on L2 vocabulary learning in second and foreign language classrooms.

The study has been published in the 'Language, Culture and Curriculum Journal'.

For this study, Dr Dennis Murphy Odo, an Associate Professor at Pusan National University, extracted data from 27 well-designed research investigations--comprising 28 studies and 1,864 participants--published between 1990 and 2020. Upon defining the study characteristics and effect sizes, he analyzed the data using a random-effects model.

The findings were highly encouraging, revealing that learners who received instruction through English songs outperformed other learners by learning more L2 English vocabulary. Interestingly, songs from the pop music genre were found to be more effective at promoting L2 vocabulary than textbook songs. The appeal of pop songs might be attributed to their quality of music and their relatability to the audience.

Dr Murphy Odo also observed that students benefit most upon listening to English songs for neither too long nor too short of a duration of instruction (in the study, this is defined as



students and teachers in the long run. between Sino-Tibetan languages and

more effective for adult learners than

for children, which can be attributed to adults' higher ability to comprehend songs and greater overall background knowledge.

These results will encourage teachers to use songs not just as a fun activity to fill time in their lessons, but also as a helpful way to reinforce learners' knowledge of new vocabulary in English. This work can give language teachers and learners confidence that using songs in the second or foreign language learning classroom will help them to learn English vocabulary more effectively,' commented Dr Murphy Odo, summarizing the long-term implications of



# **SMC Draws Flak From Netizens For** 'Vandalizing' Carts Of Street Vendors

Srinagar: Srinagar Municipal Corporation (SMC) has come under severe criticism from netizens after several of its teams on Friday allegedly vandalised many carts during an anti-encroachment drive here in summer capital.

The Drive was launched in Maharaja Bazar, Hari Singh High Street and its adjoining areas and was conducted under the supervision of Commissioner SMC Athar Amir.

In several videos that went viral on social networking sites, street vendors were seen screaming for help after their goods were vandalised and carts were bundled away by the officials of SMC's antiencroachment squad in Jahan geer Chowk and LD (hospital) areas of Srinagar city, hours before the commencement of weekend lockdown.

"Look how they (SMC officials) are snatching our livelihood, where will we go? I've a family to feed. What will we do?" one of the street vendors' can be seen screaming loudly in a video clip.

"I'm a father of four girls, what wrong I've done to you, please don't do this, where will I go," another street vendor

Upon being asked of the resentment over the 'way' to handle the situation, he said that vendors were warned on a daily basis in the past too but they haven't bothered.

He said the goods and other things seized by the squad will be released and handed over back to the vendors after payment of due fine and completion of other paperwork.

The official further informed that a separate space has been sanctioned for radiwallas near Khalsa school in Saraiballa. "Hopefully the modalities on it are worked out soon.'

Speaking to reporters on the sidelines of the anti-encroachment drive SMC Commissioner Ather Aamir said that the anti-encroachment team conducts these drives on a daily basis.

According to the analysis, the total assets declared by the seven national and 44 regional parties during the financial year amounted to 6,988.57 crore and 2,129.38 crore, respectively.

Among the seven national parties, the highest assets were declared by the BJP (Rs 4847.78 crore or 69.37 per cent), followed by the BSP (Rs 698.33 crore or 9.99 per cent) and the Congress (588.16 crore or 8.42 per cent), the ADR report said.

Among the 44 regional parties, the assets of the top 10 parties were worth 2028.715 crore or 95.27 per cent of the total declared by them all combined.

In the FY 2019-20, among the regional parties, the highest assets were declared by the Samajwadi Party at 563.47 crore (26.46 per cent), followed by the TRS at 301.47 crore and the AIADMK at 267.61 crore.

Fixed Deposits/FDR constituted the largest share of 1,639.51 crore (76.99 per cent) of the total assets declared by regional parties in the FY 2019-20.

Under the FDR/Fixed Deposits category for the financial year, the BJP and the BSP declared 3,253.00 crore and 618.86 crore, the top two among all national parties, while the Congress declared

# Hindu Yuva Vahini Gets **Active Again To Campaign For** Its Founder Yogi Adityanath

The Hindu Yuva Vahini, which was formed nearly two decades ago to spread the message of nationalism among youths but was almost dormant for the past few years, has become active again to canvass for its founder Yogi Adityanath in the Uttar Pradesh polls.

After the BJP declared Mr Adityanath's candidature from the Gorakhpur Urban constituency, members of the youth organisation got into action, and have been fanning out up to booth level to garner support for him.

Working in coordination with local BJP leaders, Vahini members have been using social media too to highlight the development works of the government under "Maharaj ji" (as it refers to Yogi Adityanath).

The organisation that came into existence in 2002 had quickly gained prominence, particular in Gorakhpur, with a large number of youths becoming its part. Mr Adityanath had formed the Vahini after falling out with the BJP.

The outfit has served as a power machine for Adityanath to influence poll outcomes in the assembly constituencies in the district.

## Man Gives Away Daughter To 'Godman'



**MUMBAI:** A girl is not a property that can be given in donation, the Aurangabad bench of the Bombay High Court observed, while taking strong objection to a case wherein a man had given his 17-year-old daughter in "daan" to a self-styled godman.

A single bench of Justice Vibha Kankanwadi made the observation earlier this month while hearing a bail application filed by the godman Shankeshwar Dhakne and his disciple Sopan Dhanke, arrested for allegedly raping the minor girl.

The two accused lived in a temple at Badnapur in Jalna district along with the girl and her father. The girl on August 2021 filed FIR against the duo for allegedly raping her, following which they were arrested.

Justice Kankanwadi in her order took note of the prosecution's case that in 2018, a document styled as "danpatra" on a stamp paper of 100 was executed between the girl's father and the Dhakne.

"It is stated that the father of the girl has given his daughter on donation (daan) to the baba and it is stated that the said 'kanyadan' has been made in the presence of god. When the girl as per her own statement is minor, then why the father, who is in all respect guardian, to the girl, give the girl as Daan?" the court said in its order. "A girl is not a property, which can be given in donation," Justice Kankanwadi said, adding

that this was a disturbing fact. The court noted that it was concerned about the future of the minor girl and "cannot shut



# The Free Press Principle

ree the press! It is a familiar refrain, one that grows louder year-on-year yet never loses relevancy. Why should a free press even be up for discussion? Are we failing to get the message across?

The simple answer is that the press equals power, and wherever power lies there are those who seek to control or influence it. By nature, a free press is untamed; capable of speaking unfiltered to public opinion, it has always been a vital conduit for free expression. It has therefore been a constant target. As we increasingly embrace our digital citizenship, the tyrants who oppose free speech are quickly learning how to act as digital oppressors. Targets are more numerous, attacks more complicated and diverse. Our awareness and vigilance must adjust with similar voracity. Impunity for the killers of journalists extends also to those who murder bloggers. Censorship does not discriminate between editorial platforms.

Prisons are built for those who "offend", regardless of media. It is impossible to prevent the oppressors of free speech from eroding our basic freedoms. And they do, as the press freedom indexes show frequently and without heed for the consequences.

Our right to seek, receive or impart information through any media may be enshrined in international human rights law, yet the media must fight daily to remain a bulwark against intrusions on free speech. As a check on power, an independent press acts as society's window through which the abuses, digressions, untruths and self-interests of the powerful are revealed for public scrutiny.

According to corrupt governments, violent criminals, and fundamentalists of every description, this window would be better permanently bricked-up.

Take Mexico, for example, where journalists face a violent, often deadly reception. The wider effects are devastating. "A climate of fear grows and it becomes better to remain silent than speak out about events that may pose a threat," says journalist and writer, Anabel Hernández "This leads to self-censorship, which affects freedom of expression, which in turn affects the quality and depth of information that society receives. If society does not know the reality that surrounds it, who can make decisions?"

Wherever you live, whatever you do, pause for a moment and reflect on what kind of a society would be in front of you, were it not for the presence of an inquisitive media. Who makes decisions on your behalf, and just how transparent is the process? This, ultimately, is why we defend journalists and a free press worldwide.

Yet the Internet is undeniably raising the stakes. Checks and balances that provide the counterweight to power, of which traditional media were for so long custodians, are shifting rapidly beyond media-defined parameters.

The Internet invites censors into our homes, often unwittingly, and in the process has made freedom of expression a concern for anyone who signs on to social networks, communicates via email, and owns a smartphone or tablet device.

Or at least it should be of concern. Paradoxically, the great digital revolution that has introduced a truly globally connected age provides yet another mechanism for control, an opportunity for speech to be curtailed. Online news media, forewarned by the experiences of the written press, may be better prepared to combat this. But are we as individuals?

Online and off, new challenges or familiar threats are no less shocking. Each year heralds a roll call of journalist casualties, imprisoned media professionals or publications threatened, intimidated or financially strangled to the point of closure.

Above all, with a sense of solemn reflection, 3 May is an occasion to remember colleagues targeted for their work, especially those killed in the line of duty.

That 'duty' was not simply to bring us the news. Their work – by nature risky, sometimes dangerous, yet always outspoken – went beyond the headlines that became unintentional obituaries. Their work signifies a belief in a principle, exhorted by democracy and made tangible with every article, picture or broadcast.

It is that principle behind which we stand proud. It is upon that principle that our industry is founded, and that journalism thrives.

# An (Un)Holy Alliance?

Renewing Turkey-Israel Relations On Erdogan's Cards May Appear New But Turkey Has Always Been Close Yet Unreliable With Israel

urkey is desperately trying to rehabilitate its ties with Israel. Turkey's President Recep Tayyip Erdogan and Israel's president Isaac Herzog have talked thrice since the latter assumed office in July 2021. Erdogan, this week, told reporters that Herzog may visit Turkey soon. The Turkish president also expressed a revival of interest in the transportation of Israeli natural gas to Europe through Turkey. The comments on the EastMed pipeline by Erdogan came days after the US withdrew its support from the project which consisted of Israel and a group of countries, including Turkey's historic rival Greece. The pipeline was controversial as Turkey and Israel had previously planned to cooperate on the project but the negotiations failed in 2016 after Turkey condemned Israel's actions in Gaza Strip. Israel went ahead with an alternative that excluded Turkey, outraging Ankara over the plans to bypass it.

This warming up to Israel by Erdogan follows a year of Turkey's battered economy. Further, even though Turkey is formally a NATO ally, its relations with the US are in deep crisis. The US recently imposed CAATSA sanctions on Turkey over the purchase of the Russian S-400 missile system. Historically, Turkey has been oriented towards the West but it is now trying to reshape its foreign policy to suit it to the multipolar system of the world that is seeing the rise of powers like China and Russia. It is in this context of striking the balance between the West and the East that Turkey's relations with Israel come in.

Turkey was the first Muslim majority country to recognize the state of Israel. It formally recognized Israel nine-months after it came into existence in March 1949. Turkey also happened to be the first country in the Middle East and Asia to recognize Israel. This relationship between the two countries was solidly based on mutual interests and common strategic goals. The circumstances in which Israel came into existence and its quest for legitimacy made it important for Israel to have relations with Turkey. Therefore, Israel viewed the non-Arab Muslim majority Turkey in the vicinity, as a key to breaking its isolation. For Turkey's rulers, relations with Israel were politically expedient. At that time, the relations with Israel were the bellwether of its commitment to Western orientation. Hence, the reasons for the establishment of relations with Israel included help in Turkey's relations with the West and access to American credit mechanisms.

Turkey-Israel relations went into a deep freeze in 2010 when Israeli commandos stormed and killed ten Turkish citizens on board the Mavi Marmara, a ship that was part of an aid flotilla trying to breach the blockade of Gaza. Israel later apologized and provided compensation to the

families of those who were killed. Bilateral relations were normalized in 2016 but when the US recognized Jerusalem as the capital of Israel in 2018, relations again deteriorated with Turkey expelling the Israeli ambassador and withdrawing its ambassador from Tel Aviv.

Despite all these confrontations, Israel holds an important position in Turkey's politics and economy. The bilateral trade has been decoupled from politics.

As is evident from the chart on bilateral trade, the political issues between the two countries did not affect the trade. Politically, Turkey's relations with Israel are expedient. When Turkey feels it has something to gain from the friendship with Israel, it normalizes ties and when it thinks it can profit from snapping ties with Israel, it downgrades relations with Israel. It can be said that there is an inherent tension that has always defined Turkish-Israeli relations. On the one hand, Turkey used Israel's leverage in corridors of power, particularly in the United States, to accrue benefits in state interests, stra-

tegic priorities and security. On the other hand, the Turkish public has always been sympathetic to the cause of Palestinians. Therefore, due to domestic pressure, the politicians in Ankara cannot ignore the Palestinian issue completely. Right now, as Erdogan reaches out to Israel for mending relations, the leaders in Israel are wary that Erdogan wants to leverage the normalized relations to improve the economy of the country as well as his image. After achieving these goals, Erdogan may do with the relations whatever he wishes depending on the kind of issues he would be facing. In the case of domestic politics, normal ties with Israel will not be helpful but in the case of international issues, friendship with Israel can always pay off.

# The Economic Costs Of Closed Minds

EW YORK – This year began amid widespread despondency about the resurgent COVID-19 pandemic and the struggling global economy, as well as premonitions of heightened political conflict in Eastern Europe, the Middle East, and even the United States. True, there is now some hope that the Omicron variant may be the pandemic's last hurrah. But troubling questions remain about the economic and political legacy of the crisis.

The World Bank's latest biannual Global Economic Prospects report, released last week, points to some possible answers. Produced by a team of talented economists, the report is one of the best summaries of the current outlook for the world economy. And while the report uses the diplomatic language of multilateral organizations, it nonetheless packs a powerful cautionary punch.

less packs a powerful cautionary punch. For starters, the World Bank forecasts that global economic growth will slow to 4.1% in 2022, from 5.5% last year. With debt burdens rising, supply-chain bottlenecks impeding the flow of goods and services, and inflation picking up, governments are losing the capacity to provide further fiscal support. The report warns that the surge in debt caused by countries trying to soften the "pandemic-induced global recession" means that several economies are now "at high risk

of debt distress." Some may need relief.

The report also predicts that energy prices, which surged in the second half of 2021, will increase further – and by more than the World Bank was projecting six months ago.

Finally, the report's tables of summary statistics contain a lot of interesting information – in particular, data on major economies' recent GDP growth and forecasts for the next two years. The fastest-growing economies in 2021 were Argentina, Turkey, and India, which expanded by 10%, 9.5%, and 8.3%, respectively. But growth after a crash needs to be interpreted carefully. Much of last year's growth merely reflected the

depth of the pandemic-induced downturn of 2020, as economies climbed back toward their earlier GDP level. In 2020, Argentina's economy contracted by 9.9% and India's by 7.3% – making them, along with Mexico, the worst-performing major economies that year.

Usually, emerging market and developing economies, helped by their lower base, grow faster than advanced economies. But, according to Global Economic Prospects, the prognosis for EMDEs through the end of 2023 is worse than for advanced economies, because EMDEs have limited policy space to provide additional support and face greater risk of hard landings. Moreover, the pace of recovery is likely to vary significantly between countries. Once the dust settles after the current turmoil, therefore, there will most probably be new winners and losers.

One of the main reasons for the uneven recovery has more to do with politics than economics. From advanced economies

such as the United States to EMDEs like Brazil, support for aggressive nationalism has grown sharply in recent years. This is bound to play a major role in determining how these economies perform.

While there are exceptions, hypernationalism is usually disastrous for an economy in the long run. This stands to reason, because strident nationalism leads to bloated egos and blurry thinking. Countries in its grip try to become self-sufficient by raising barriers to trade, capital, and ideas from elsewhere.

A striking historical example is Argentiana, which was among the world's fastest-growing economies during the early decades of the twentieth century and was widely expected to overtake the US. That changed in 1930, when a military coup resulted in the installation of the hypernationalist Lieutenant General José Félix Uriburu as president. Tariffs subsequently rose, together with barriers to immigra-

tion. Argentina's open economy, now closed to the world, soon stagnated, and the US surged ahead.

The lesson seems even more relevant today. In a globalized world, with new ideas and research emerging everywhere, countries that succumb to nationalist solipsism and pull down their economies' and societies' shutters will be anything but great.

One of the remarkable achievements of post-independence India was that its founding fathers and early thinkers, like the first prime minister, Jawaharlal Nehru, and the author Rabindranath Tagore, were passionate advocates of openness to the world of ideas. They stood out, not just in India but globally, for their commitment to absorbing the best, from wherever it or they came, and to upholding a common human identity.

I remember a friend of my father's, who visited us regularly and held forth on the need for more strident nationalism. He was critical of Indian thinkers who, while opposing Western colonialism, argued that India must keep its doors open to the best of the West – in science, literature, and philosophy. One day, angry at his failure to persuade us, he thundered, "My motto is: the West does not follow us, so we must not follow the West."

I was in elementary school, but even then, I could see that his aggressive nationalism had blurred his thinking into adopting a motto that contradicted itself. At a time when policymakers are confronting an ongoing public-health crisis, and in some cases the threat of violent turmoil, countries that succumb to hyper-nationalism lay the foundations of their own failure.

# Some Insights Into The Rise And Fall Of Muslim Intellectualism


"God does not change the condition of a people [for the worse] unless they change what is in themselves" (Qur'an, Surah al-Ra'd, 13: 11)

VER THE YEARS, one of the disturbing questions that has both intrigued and fascinated me-and resulting in the present book-is: Islam, as a civilization, has seen a 'classical' and 'golden age', but how, where, and "What Went Wrong" in the Islamic civilization—speaking from the perspective of intellectual legacy-that there has aroused a need of "Radical Reform"? Why, and how Muslims—who are heir to a great intellectual legacy-have faded away from the 'intellectual map' of the present world? What were the reasons that led the Muslims to miss their track/ route to such an extent that there is no recognition of them in the scientific field now? These questions, though very perturbing and most worrying, are not new, but have worried many Muslims, students and scholars equally, both in the past and in present as well.

For instance, looking at the intellectual map of Muslims, one observes that back in 1980s Ismail Raji al-Faruqi (d. 1986) described "the malaise of thought and methodology", and the state of education in Muslim societies, as a "crisis". In the same era, Syed Ali Ashraf (d. 1998) pointed towards the "Crisis in Muslim Education" and accordingly proposed the theory of "New Horizons in Muslim Education", while as Syed Muhammad Naquib al-Attas (b. 1931) provided a "framework for an Islamic Philosophy of Education"

Moving directly to the first decade of the 21st century, one sees that in 2003, the Arab Human Development Report highlighted that there is a "knowledge deficit" in the Muslim world, especially in the Arab societies, and thus proposed for "Building a Knowledge Society". In the second decade of third millennium, there have been 'calls' for the 'revivification of Islamic knowledge and thought' or 'reforms in Islamic Education', because the picture presented by "the state of education in Muslim countries", is very "catastrophic"; and, thus, there is cry for the 'reform[ation] of Muslim education' vis-à-vis 'intellectual renewal'. Looking at this grim situation and abysmal state there are 'calls' for a comprehensive and an extensive "Education Reform" through the 'Integration of Knowledge' process. The reason is simple but genuine, as Ziauddin Sardar puts it very powerfully as: it is "through education" that a civilisation not only "passes on the accumulated skills, knowledge and wisdom of the past to future generations", but "preserves the cultural identity and historical legacy of a society" as well as "ensures its survival as a distinct entity".

Though these 'calls'—appeals and pleas—for the 'reformation' of educa-

The Muslims believe that the Qur'an is the basis of Islam, and things Islamic, including the Islamic education system. From the very first word of the first revelation (Q. 96: 5), "the Message of Islam focuses upon the education of human being". Moreover, the frequent Qur'anic references to knowledge, learning, wisdom, observation, thinking, or to pen, etc., reveal the significance of knowledge/ education—and by that way of the 'intellectualism'. It is striking to note that the word 'Ilm (knowledge), in its different forms, occurs over 800 times in

the Qur'an. It is this concept of 'Ilm—as Franz Rosenthal puts it beautifully in his magnum opus Knowledge Triumphant—which has "dominated Islam and given Muslim civilization its distinctive shape and complexion"; and it is the concept of 'Ilm "that has been operative as a determinant of Muslim civilization in all its aspects". Fazlur Rahman also puts it briefly, but very eloquently, as: "for the Qur'an, knowledge—that is, the creation of ideas—is an activity of the highest

possible value". In between 8th and 13th centuries CE, Islamic civilization produced a great intellectual legacy, a 'classical age', a legacy described as "one of the brightest chapters in the intellectual history" of the world, or "one of the most brilliant civilizations in the history of humanity". During this 'Golden Age', a period of over 500 years, "the spiritual, intellectual, commercial and military accomplish-

ments of the successive Muslim empires were striking" and "the distinguishing feature of Muslim civilization was the pursuit and celebration of knowledge in all its forms: exact, experimental, and human sciences". But it has not remained so powerful and dominant in the succeeding centuries: from 13th century onwards, especially with the Mongol invasion of Baghdad ('Fall of Baghdad') in 1258 CE, Muslim world has passed through "a subsequent collapse". This 'collapse' was due to many reasons, both internal and external, and ranged from "long periods of instability, doubt and fear of competing civilizations and empires" to "favoring", in time of crisis, "legislation and the imposition of limits", etc. Such a miserable situation not only had "a negative impact of Islamic thought" but it formed "the main obstacles to an intellectual, scientific, and artistic renaissance" as well.

Considering the above context and scenario, the question that comes to mind is: How can an Ummah, for which knowledge ('Ilm) has been given such an extraordinary status, and which was leading the whole world, for many centuries, in the intellectual field and scientific discoveries, can meet such a reprehensible failure? For Muslim intellectuals, the question of Muslim intellectual collapse has long been worrying, yielding repeated efforts to analyse and diagnose various factors responsible for this stagnation and decline. A number of Muslim intellectuals, in many eras, have attempted to analyse the causes and factors responsible for the overall decline of the Muslim, and two main reasons they mention, which are relevant in the context of present study, for the decline of Muslims after 12th century-or what I term as 'Muslim intellectual deficit'-are "loss of dynamism in Islam after the rise of dogmatism and rigidity; [and] decline in intellectual and scientific activity". The present work, focusing exclusively on the 'Decadence of Muslim Intellectualism'-makes a modest attempt and substantial effort to find answer(s) to these (disturbing) questions. The major objective of this book is to look, meticulously, on the various aspects of the theme of Muslims back-







# **How a Simple Math Equation Can Transform Your Productivity**

woke up in the middle of the night, utterly confused.

I had been dreaming—of an equation. I was in a classroom, and on the blackboard, there was a simple equation written in chalk: 0.8 \* 0.2 = 0.16.

To be clear: I rarely ever dream about math. When I do, it's often a nightmare about bombing a theoretical physics final in college.


Even though this was no nightmare, the equation really bothered me. The middle-school math checks out: 0.8 multiplied by 0.2 in fact equals 0.16. What bothered me was the underlying implication: The product of two numbers could be less than each number (0.16 is less than both 0.8 and 0.2).

The outcome makes sense to the astrophysicist in me. But in the dream, I was staring at this equation as a mathematical beginner, completely befuddled by the result. How could that be? If you multiply two numbers together, shouldn't the result be greater than each part?

Dreams are written in disappearing ink. But this one lingered with me for a while, as if there was a message embedded within that I needed to learn.

And then the message hit me. When we operate at a fraction, we compromise the output.

Most of us go through life operating at a fraction in everything we do. We check email during Zoom meetings. We shove a sandwich into our mouth with one hand while scrolling through our phone with the other. When we work, we think about play. When we play, we think about work. We exist in this in-between state—we're neither



fully here nor there—constantly operating at a 0.2 or a 0.8 instead of a

As a result, our output suffers. What we produce becomes less than what we put in. We achieve only an

iota of what we're capable.

When people meet a great leader, they often say, "She made me feel like I was the only person in the room." Imagine giving that type of complete attention to everything you do—and making that thing the only thing in the room.

Not just deep work. But deep play. Deep rest. Deep listening. Deep reading. Deep love. Deep evervthing.

This mindset requires being aware of your own limitations. When I write, for example, my output begins to significantly drop after about two hours. By the fourth hour, I'm operating at a 0.2 at best. If I keep pushing, I know I'll write gobbledygook that isn't even worth editing. I'm much better off taking my hands off the keyboard and giving my attention to something else.

This isn't just about being mindful of what you're doing. It's choosing one activity over others. It's approaching everything you do with intention. Often, we're operating impulsively, moving from one notification to the next, one email to the next, living our lives in a frantic blur. But if you slow down for just a

moment and intentionally choose to give your full attention to what you're going to do next, you'll trigger your internal defibrillator that can jolt you back alive and bring you closer to your full capacity.

It's like the way a great leader might shake your hand and greet you. Hello activity. It's great to meet you. I'm choosing to engage with you. I'm going to treat you like you're the most important person in the room and ignore everyone else.

It serves as a constant reminder to live deep and suck out all the marrow of life, as Thoreau put it, instead of living at a fraction of what I'm capable.

# Lifetime Workplace **Exposure To Pesticides Linked To Heightened COPD Risk: Study**

oxic effects by pesticide exposure have been known to range from mild symptoms, like minor skin irritation or other allergic symptoms, to more severe symptoms, like strong headache, dizziness, or nausea.

Now, a large population-based study. published online in the journal 'Thorax', found that lifetime workplace exposure to pesticides is linked to a heightened risk of COPD, the umbrella term for a group of

included spirometry, a lung function test that measures the amount and/or speed of air that can be breathed in and out in one forced breath.

Among the 502,649 participants who provided the full complement of personal data, 457,282 (91 per cent) also



respiratory diseases that cause airflow blockage and breathing problems.

The findings are independent of kev risk factors for COPD (chronic obstructive pulmonary disease): smoking and asthma.

Workplace exposures are important preventable causes of COPD, with recent estimates indicating that around 14 per cent of all such cases are related to work, said the researchers.

It can be challenging to pinpoint which jobs and exposure levels might have the most impact because of the need for studies to include sufficient numbers of participants, with full employment histories, and tracked over a sufficiently long period of time.

researchers The managed to get round these difficulties by drawing on data from the UK Biobank, a large population-based study of over half a million men and women recruited between 2006 and 2010 throughout the UK.

They invited a random sample of more than half a million 40-69-vearolds from among NHS patients who lived within specified distances of 22 health assessment centres in the UK to take part in their study.

At entry to the UK Biobank, personal data, including age, sex, lifetime smoking history, current employment, and doctor-diagnosed asthma, were collected and measurements of physical health taken.

These measurements

took the spirometry test. The lifetime job his-

tories of these participants were collected and coded using OSCAR, a validated web-based tool, used to categorise paid employment for a minimum period of 6 months. And a job exposure matrix was used to

code three levels of ex-

posure from 0 (none) to 1 (low) and 2 (high) to 10 categories of workplace agents.

These included biological dusts, mineral dusts, gases and fumes, herbicides, insecticides, fungicides, aromatic chlorinated solvents, solvents, other solvents, and metals--plus two composites of the above, to include all pesticides and vapours, gases, dusts, and fumes.

The final analysis was based on 94,514 people for whom full data, good quality lung function tests, and complete job and smoking histories were available.

Most participants had never smoked (55,574; 59 per cent) and only a few were current smokers (5298; 5.5 per cent). About 11 per cent of participants had been diagnosed with asthma. The prevalence of COPD, identified by spirometry, was 8 per cent, corresponding to 7603 cases.

Unsurprisingly, the prevalence of COPD was higher among current smokers (17 per cent) than among former smokers (9 per cent) and never smokers (7 per cent).

Relatively few participants had been exposed to pesticides alone during the course of their work: just over 4 per cent among those with COPD and 3.5 per cent among those without. But nearly half of those with (48 per cent) and without (47 per cent) COPD had been exposed to a mixture of several agents.

## Apple"s Holiday iPhone **Sales Surge Despite Supply Shortages**

**SAN RAMON (US):** Apple shook off supply shortages that have curtailed production of iPhones and other popular devices to deliver its most profitable holiday

The results posted Thursday for the final three months of 2021 help illustrate why Apple is looking even stronger at the tail end of the pandemic than when the crisis began two years ago.

At that point, Apple's iPhone sales had been flagging as consumers began holding on to their older devices for longer periods. But now the Cupertino, California, company can't seem to keep up with the steadily surging demand for a device that has become even more crucial in the burgeoning era of remote work.

IPhone has never been more popular," Apple CEO Tim Cook crowed during a conference call with analysts. The company's Mac computers and, to a lesser extent, iPads also continue to proliferate. With the iPhone leading the way, Apple disclosed it now has more than 1.8 billion devices worldwide now in use.

Apple's inability to fully satisfy the voracious appetite for iPhones stems from a pandemic-driven shortage of computer chips that's affecting the production of everything from automobiles to medical devices. (AP)

#### **SC Grants 3 Weeks To** Spicejet To Resolve Financial **Issues With Swiss Firm**

**NEW DELHI:** The Supreme Court Friday granted three weeks to SpiceJet to resolve financial dispute with Swiss firm Credit Suisse AG and stayed the Madras High Court order on its winding up, saying that it was a serious matter and the airlines cannot say it is a busy

organisation and would not pay. A bench headed by Chief Justice N V Ramana, while staying the publication of winding up notice and the order directing the official liquidator attached to the Madras High Court to take over the assets of the low-cost airline, questioned the approach of SpiceJet.

The bench, also comprising Justices A S Bopanna and Hima Kohli, took note of the submissions of senior advocate Harish Salve that SpiceJet would try to resolve the issue with the Swiss firm.

Senior counsel Harish Salve sought three weeks' time for trying to resolve the matter and Mr K V Vishwanathan (appearing for the Swiss firm) also agreed to the adjournment. Meanwhile, the high court order is stayed for three weeks, the bench said in its order. (PTI)

### **Rupee Closes Almost Flat** At 75.07 Against US Dollar

MUMBAI: The rupee snapped its three-day losing streak to close 2 paise higher at 75.07 against the US dollar on Friday amid expectation of better dollar inflows from upcoming IPOs.

However, the rebound in the rupee was restricted amid weakness in domestic equities, analysts said.

Forex traders said geopolitical tensions, elevated crude oil prices and hawkish US Fed stance also weighed on the local unit.

At the interbank foreign exchange market, the rupee opened at 75.12 a dollar and witnessed an intra-day high of 74.88 and a low of 75.13.

The domestic unit finally settled at 75.07 against the American currency, up 2 paise over its last close of 75.09. Meanwhile, the US dollar index, which mea-

sures the greenback's strength against the basket of six currencies, rose 0.11 per cent to 97.35.

"The Indian rupee managed to stabilise after sharp sell-off in the last three days and retraced from one-month low on expectation of better dollar inflows from upcoming IPOs and position downsizing ahead of the Union Budget," said Dilip Parmar, Research Analyst, HDFC Securities.

# **DU Issues Notification** to Discontinue M.Phil from next

**NEW DELHI:** The Delhi University has issued a notification stating that M.Phil will be discontinued from the next academic session in line with the National Education Policy-2020.

The university will be implementing the policy from 2022-23. However, a section of teachers criticised the move to discontinue the degree, saying it will be disadvantageous for students who are not economically strong and even for women.

In a notification issued on January 27, the varsity said M.Phil programmes being run in various departments of the University of Delhi will be discontinued from 2022-23 in line with the National Education Policy (NEP), 2020.

There won't be any new admissions to M.Phil programmes while students who are already enrolled will continue to study the course, according to a university official.

Former Executive Council member Abha Dev Habib said, "NEP-2020 is all about widening the gap between the haves and have nots. Either commit to doing a Ph.D or remain without a research degree. The NEP, which is floating on advertisement of 'choice', is taking away real choices which students had. Students with disadvantageous backgrounds looked up to M.Phil as a research degree they could afford before going towards teaching jobs."
"This degree (M.Phil) is be-

ing discontinued not because of any organic need of the system but because of NEP-2020," she said.

Habib said as opposed to Ph.D, M.Phil is a short-term research degree for students, which provides them an exposure to research work and adds to their curriculum vitae.

Social scientists believe that students with M.Phil did better in their Ph.Ds, she said.

professor Ayesha Kidwai, in a Facebook post, said there is a gender dimension to the M.Phil abolition as well.

She said that since 2012 2013 M.Phil, enrolment has consistently had a majority of women, currently verging on about 60 per cent.

"This is also the one degree that the NEP-2020 recommends must be eliminated from the education system, with immediate effect, without any pretence even at consultation with stakeholders," Kidwai

"M.Phil. is often the only research degree that women (as well as other disadvantaged sections) can pursue... Ph.D degrees require an investment of time and a loss of earnings that patriarchal society lets only a few afford and the need for its immediate abolition is difficult to fathom," she said.

Questioning the rationale behind the discontinuation of M.Phil, she said the announcement signals how women's participation in formulating and studying research questions and in the labour force of the education sector is of little significance to educational policy-makers.

Academic Council member Mithuraaj Dhusiya said that the M.Phil course, over several generations, has played an important role in the Delhi University and other Indian universities in developing re-search aptitude through robust course work and introduction to higher research.

"M.Phil research degree has been a degree by itself separate from and at the same time above Master's degree. It is extremely unfortunate that the NEP-2020 discontinues M.Phil," he added.

# Determination of inadequate representation of SC/STs in govt jobs discretion of State: SC

**NEW DELHI:** The Supreme Court Friday refused to "lay down any yardstick" for granting reservation in promotion to Scheduled Castes and Scheduled Tribes in government jobs saying determination of their inadequate representation is the discretion of the State.

The top court said it is neither legal nor proper for the Courts to issue directions or advisory sermons to the executive in respect of the sphere which is exclusively within their domain under the Constitution.

"Determination of inadequate representation of SCs and STs in services under a State is left to the discretion of the State, as the determination depends upon myriad factors which this Court cannot envisage...

"Laying down of criteria for determining the inadequacy of representation would result in curtailing the discretion given to the State Governments. In addition, the prevailing local conditions, which may require to be factored in, might not be uniform," a three-judge bench headed by Justice L Nageswara Rao said.

The apex court said it should leave the decision-making to other branches of government after directing their attention to the problems rather than itself entering into the remedial field.

Referring to its verdict in the M Nagaraj case, the bench said that this Court made it clear that the validity of law made by the State Governments providing reservation in promotions shall be decided on a case-to-case basis to establish whether the inadequacy of representation is supported by quantifiable data.

Therefore, we are of the opinion that no yardstick can be laid down by this Court for determining the adequacy of representation of SCs and STs in promotional posts for the purpose of providing reservation," said the bench, also comprising Justices Sanjiv Khanna and B R Gavai.

The top court said the percentage of posts reserved for Backward Classes, as prescribed by the State, has to be strictly followed and cannot be varied or changed simply because some members of the Backward Class have already been appointed/promoted against the general seats.

The vacancies arising in the cadre, after the initial posts are filled, will have to be filled from amongst the category to which the post belonged in the roster, it said.

The bench said that it had observed in earlier judgements that the appropriate Government has to apply cadre strength as a unit in the operation of the roster to ascertain whether a given class/ group is adequately represented in the service.

"The entire service cannot be considered to be a cadre for the purpose of promotion from one post to a higher post in a different grade. Promotion is made from one grade to the next higher grade, in relation to which cadres are constituted," the bench said.

It said before providing for reservation in promotions to cadre, the State is obligated to collect quantifiable data regarding the inadequacy of representation of SCs and STs.

"Collection of information regarding the inadequacy of representation of SCs and STs cannot be with reference to the entire service or 'class'/'group' but it should be relatable to the grade/category of posts to which promotion is sought.

"Cadre, which should be the unit for the purpose of col-lection of quantifiable data in relation to the promotional post(s), would be meaningless if data pertaining to the representation of SCs and STs is with reference to the entire service," the bench said.

The top court noted that there is near unanimity amongst the counsels that the data collected to establish the inadequacy of representation, which forms the basis for providing reservation for promotions, should be reviewed periodically.

"We are not inclined to express any view on discontinuation of reservations in totality, which is completely within the domain of the legislature and the executive. As regards review, we are of the opinion that data collected to determine inadequacy of representation for the purpose of providing reservation in promotions need to be reviewed periodically.

"The period for review should be reasonable and is left to the Government to set out," it said.

The bench said collection of quantifiable data for determining the inadequacy of representation of SCs and STs is a basic requirement for providing reservation in promotions and the State should justify reservation in promotions concerning the cadre to which promotion is made.

'Taking into account the data pertaining to a 'group', which would be an amalgamation of certain cadres in service, would not give the correct picture of the inadequacy of representation of SCs and STs in the cadre in relation to which reservation in promotions is sought to be made. Rosters are prepared cadre-wise and not groupwise," the bench said.

The top court had earlier said that it would not reopen its decision on the issue of the grant of reservation in promotion to SCs and STs and said it was for the states to decide how they are going to imple-

# **SBI Tweaks Recruitment Rules For Pregnant Women Candidates**

New Delhi: The country's largest lender State Bank of India (SBI) has put in place new rules wherein a woman candidate with more than three months pregnancy will be considered 'temporarily unfit" and can join the bank within four months after delivery.

The move has elicited criticism from some quarters, including from the All India State Bank Of India Employees' Association.

In its latest medical fitness guidelines for new recruits or promotees, the bank said a candidate would be considered fit in case of pregnancy which is less than 3 months.

"However, if pregnancy is of more than 3 months, she will be considered temporarily unfit and she may be allowed to join within 4 months after delivery of child," as per the medical fitness and ophthalmological standards for new recruits and promotees dated December 31, 2021.

For recruitment, it said, the policy will be effective from the date of approval December 21, 2021. The revised standards in respect of promotion will be applicable with effect from April 1, 2022, it said.

Earlier, women candidates with up to 6 months of pregnancy were allowed to join the bank subject to various conditions.

The conditions include furnishing a certificate from a specialist gynaecologist that her taking up bank's employment at that stage is in no way likely to interfere with her pregnancy or the normal development of the foetus, or is not likely to cause her miscarriage or otherwise to adversely affect her health.

The revised rules have attracted criticism from some quarters, including from the bank's staff.

An e-mail sent to SBI seeking comments on the guidelines did not elicit any immediate response.

CPI Rajya Sabha MP Binoy Viswam has written to Finance Minister Nirmala Sitharaman demanding immediate withdrawal of medical fitness circular issued by SBI pertaining to the guidelines for the recruitment of pregnant women, saying "it undermines women's rights.'

According to the All India State Bank Of India Employees' Association General Secretary K S Krishna, the union has written to SBI management urging it to withdraw the guidelines.

"The proposed amendment by the bank is fundamentally prejudicial and against womanhood. The proposed amendment will be unconstitutional as it discriminates against women, by treating pregnancy as a disease/disability.

"It cannot be forced upon a woman to have a choice between bearing a child and employment as it interferes both with her reproductive rights and her right to employment and such an action cannot have any place in the present modern era," he said.

In this regard, he said, the union has also submitted that the stipulation of 6 months itself must be removed and no pregnant women if willing to take up employment at any stage must be debarred from employment.

In 2009 also, the same proposal was mooted by the bank but was withdrawn after a lot of hue and cry, he added.

The proposal for these units has been sent to the Ministry of Home Affairs which has approved it in principle. A further process for financial sanction is underway.

The BSF officials have already contacted senior officials of the Ministry of New and Renewable Energy in Delhi to get solar power projects sanctioned for these FDLs which has

also been approved. At present, all activities at these locations including cooking and daily ablutions, are carried out using power sourced from kerosene and diesel, they said.

These upcoming habitats will accommodate at least 12 troopers at a time and the attached kitchen will have all facilities to serve freshly cooked food in even the most inclement and harsh conditions. The kitchen and toilets will be attached to the main living huts.

As of now, the troops at these icy locations at altitudes ranging from 8,000 feet-16,000 feet, live in corrugated galvanized iron sheetmade hutments along with their rations and weapons, exposing them to the sub-zero temperatures. The BSF has already finalized the design of these steel huts which will be provided with entertainment systems too. They expect that the construction work can start from

May-June onwards. They said that before finalizing the design, they evaluated the composite Border Out Posts (BoPs) of the Indo-Tibetan Border Police and that of the Army deployed on the higher altitudes to equip them with modern facilities.

The BSF move came after the visit of Director General Pankaj Kumar Singh to these locations in November last year and a proposal was sent to the MHA for approval and the MHA has approved it. The solar power panels that will be installed by the New and Renewable Energy Ministry will help in reducing the carbon footprint and pollution generated because of heavy use of diesel and kerosene by the troopers for their cooking and other needs.

# **Indian Family That Froze** To Death At Canada-US **Border Identified**

fficials in Canada say they have confirmed the identities of four Indian nationals whose frozen bodies were found in Manitoba near the Canada-United States border last week.

The High Commission of India in Ottawa on Thursday released a statement saying the four who died were Jagdish Baldevbhai Patel, a 39-year-old man, Vaishaliben Jagdishkumar Patel, a 37-year-old woman, Vihangi Jagdishkumar Patel, an 11-year-old girl, and Dharmik Jagdishkumar

Patel, a three-year-old boy.

The family's immediate relatives have been informed, the High Commission said in its statement, highlighting the need "to ensure that migration and mobility are made safe and legal and that such tragedies do not recur"

Investigators say the family of four had attempted to cross over the border by foot on January 19 during severe winter weather they had picked up a group of Indian nationals on the US side.

One of the individuals, Steve Shand of Deltona, Florida, was found with a backpack full of items for an infant. He told investigators he was carrying the backpack for a group that got separated from them.

Investigators have said they believe the deaths are linked to a human trafficking scheme. Shand faces counts of trans-

porting or attempting to "transport illegal aliens". He was released on conditional bail on Monday. Meanwhile, six people run-ning a travel and tourism com-

pany in the western state of Gujarat have been arrested in connection with the deaths, said police official AK Jhala in the state capital, Gandhinagar.

"We are now trying to nab the human traffickers who managed to send this family and others abroad via illegal channels," he added.

Ashish Bhatia, director general of police in Gujarat, said

# 11 Arrested After Delhi Woman 'Gang-Raped, Paraded In Streets'

leven people including several women have been arrested after a young mother was allegedly abducted, gang-raped and then paraded through the lanes of Delhi in broad daylight, Indian police said on Friday.

The incident, the latest to spotlight sexual violence in India, drew widespread condemnation including from the Delhi Commission for Women and Delhi's chief minister, who called it "shameful".

Footage on social media, which could not be independently verified, showed the victim - her face blackened with ink and her hair chopped off — being pushed and heckled by several women as onlookers cheered and filmed with their phones.

Sathiyasundaram,

deputy commissioner of police, said the incident in the Shahdara district of east Delhi on Wednesday was a result of "previous enmity" among neighbours.

He gave no further details but media reports said a 16-year-old relative of the perpetrators had killed himself by jumping in front of a train after the married 21-year-old woman rejected his advances.

"All 11 arrested including two minors, who can't be tried as adults, belong to a single-family and the videos clearly show that the women were at the forefront," Sathiyasundaram told AFP.

The victim told police that she was abducted by members of the family before being raped by several men and minors – egged on by the women and then beaten with sticks and paraded outside.

"We are examining the videos to identify others who were involved and there will be more arrests," Chinmay Biswal, additional commissioner of Delhi police, told AFP.

The woman, who has a two-year-old child, is now receiving counselling after the incident, which reportedly took place barely 50 metres (yards) from a police booth that was unmanned at the time.

India's rape laws were overhauled after a notorious 2012 gang rape in New Delhi but the number of offences remains high, with more than 28,000 rapes reported in 2020.

Many more are thought to go unreported and police have long been accused of not doing enough to prevent violent crime and failing to bring sexual assault cases to court.

# **Rockets Hit Baghdad** Airport Compound Near US Airbase

t least three rockets have landed in the Baghdad Alanueu in the Airport compound and near an adjacent US airbase, damaging one disused civilian aeroplane, Iraqi police sources said.

The rockets hit Baghdad International Airport's runways or parking areas, a source at the interior ministry said, noting that a "civilian plane has been hit and damaged". The attack was not immediately claimed.

The officials did not report any other damage or any injuries in Friday's attack, adding that the damaged Iraqi Airways aircraft was out of use.

Iraq's state news agency reported, citing the country's aviation authority, that there was no disruption to travel.

On its social media pages, Iraqi Airways posted pictures of the damage, consisting of a hole near the nose of the plane. No flights were affected by the

attack, the airline added. The US airbase, known as Camp Victory, is located around the perimeter of Baghdad's civilian airport.

Rocket attacks, which the United States and some Iraqi officials blame on Iran-aligned Shia armed groups who oppose the US military presence in the region, have regularly hit the complex in recent years.

Earlier this month, at least four rockets targeted the US embassy in Baghdad's heavily fortified Green Zone, wounding two civilians, according to

two Iraqi security officials. Three of the missiles struck within the perimeter of the embassy, while another hit a school located in a nearby residential

complex, injuring two people. The Green Zone hosts most foreign diplomatic missions, including the US embassy and the Iraqi prime minister's house.

It has been repeatedly targeted by rocket attacks since the killing of Iran's General Qassem Soleimani and Iraqi commander Abu Mahdi al-Muhandis in a US drone attack in January 2020.

The armed groups have pledged revenge for Soleimani's killing and have conditioned the end of the attacks on the full exit of American troops from the country.

Baghdad and Washington agreed in a fourth and final round of the strategic dialogue on July 26 to withdraw US forces from Iraq by the end of 2021.

Some 2,500 soldiers will remain as the coalition shifts to an advisory mission to continue supporting Iraqi forces.

On January 3, US forces downed two armed drones that targeted the coalition at Baghdad airport, according to a coalition source.

# Pak Boy, 14, Shoots Dead **Entire Family Under PUBG Influence: Police**

**LAHORE:** A 14-year-old boy shot dead his entire family, including mother and two minor sisters, allegedly "under the influence" of online game PUBG, police in the capital of Pakistan's Punjab province said on Friday. Nahid Mubarak, a 45-year-

old health worker, was found dead along with her 22-yearold son Taimur and two daughters aged 17 and 11 in Lahore's Kahna area last week.

Her teenage son who remained unhurt and is the lone survivor of the family turned out to be the murderer, police said in a statement.

'ThePUBG(PlayerUnknown's Battlegrounds) addict boy confessed to have killed her mother and siblings under the influence of the game. He has issues because of spending long hours of the day playing the online game," the statement said.

Police said Nahid was a divorcee and often used to admonish the boy for not paying attention to his studies and spending most of his time playing PUBG.

"On the day of the incident, Nahid scolded the boy over the matter. Later, the boy took out her mother's pistol from a cupboard and shot her and his three other siblings dead in their sleep.

"Next morning, the boy raised an alarm and the neighbours called the police. The boy that time told police that he was on the upper storey of the house and did not know how his family was killed," the statement said.

The licensed pistol was acquired by Nahid for her family's protection, police said, adding that the weapon is yet



to be recovered from a drain where the boy had dumped it.

The blood-stained cloth of the suspect has been recovered, they said.

According to a report in Dawn newspaper, this is the fourth such crime related to the online game in Lahore. When the first case surfaced in 2020, the then capital city police officer Zulfiqar Hameed game to save lives, time and the future of millions of teenagers.

Three young players of the game have died by suicide in the last two years and the police in its reports declared PUBG as the reason behind the deaths, it said.

# **UN Human Rights Chief Allowed To Visit Xinjiang After Olympics**

Thina has agreed to allow United Nations High Commissioner for Human Rights (UNHCR) Michelle Bachelet to visit Xinjiang in the first half of 2022 after the Beijing Winter Olympic Games, according to an exclusive report in the South China Morning Post newspaper, which cited unnamed sources.

Rights groups have accused China of perpetrating widescale abuses against Uighurs and other minority groups in its cluding mass detention, torture and forced labour.

The United States has accused China of genocide in Xinjiang, and an unofficial and independent UK-based tribunal has ruled that Beijing is indeed guilty of genocide.

Beijing denies all allega-tions of abuse of Uighurs and other Turkic Muslims and has described its policies as necessary to combat religious "extremism".

Bachelet has been pursuing negotiations with China for a visit to the region since September 2018.

"No one, especially the world's leading human rights diplomat, should be fooled by

the Chinese government's efforts to distract attention away from its crimes against humanity targeting Uyghurs and other Turkic communities," Sophie Richardson, China Director at Human Rights Watch, told the Reuters news agency in an emailed statement on Friday.

United Nations experts and rights groups estimate more than a million people, mainly from the Uighur and other Muslim minorities, have been detained in camps in Xinjiang in recent years.

The United States and many of its allies, including the United Kingdom, Canada, Australia, Japan and Denmark, have said they will not send official diplomatic delegations to the games in protest against China's human rights record.
