# Building New Infra In J&K On Unprecedented Scale: LG



He made these remarks after inaugurating 22 power transmission & distribution projects costing Rs. 216 Cr at Samba.

According to the spokesperson, the LG said that J&K's power infrastructure, which remained dilapidated for the last several decades, is being transformed at a fast pace.

Terming the occasion as historic for the people of Samba, the LG, as per the spokesperson said that the Samba district has also received a dedicated grid station after a long wait of 15 years.

power infrastructure in every district of J&K UT," the LG said.

"To address the current power deficit and to meet the needs of our expanding economy, the government is upgrading transmission & distribution infrastructure that will also enable us to generate productive employment opportunities for youth," he added.

## Cop Suspended For 'Smuggling' Mobile Phone Into Jail

**JAMMU:** A policeman was suspended on Monday following a complaint by the Jammu and Kashmir Prisons' Department that claimed he was smuggling a phone inside the high-security Srinagar Central Jail, officials said.

The suspended policeman, selection grade Constable Mutazir Abbas of 6th battalion of the J&K Armed Police (JKAP), was caught in the act during an in-house surveillance initiated by the Prisons' Department last month, they said.

The officials said Director General of Prisons B Srinivas reported the matter to the Home Department which repatriated him to his battalion before placing him under suspension and ordering a time-bound departmental inquiry against him.

In an order issued by the Home Department on Monday, Principal Secretary tShaleen Kabra said Abbass had been placed under suspension and an inquiry was ordered in reference to the January 25 communication of the director general of police, prisons.

"...the government, in exercise of the powers conferred by Rule 31 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 read with Rule 353 of the Jammu and Kashmir Police Rules, 1960 hereby places Abbass under suspension with immediate effect," the order read.

## **Loneliness Widespread At Problematic Levels In Many Countries, Says Study**

No matter how many times it has been said, it is an undeniable fact that the COVID-19 pandemic was one that spiralled out of control and brought about not only loss of loved ones, but also an increase in loneliness amongst other things. A recent analysis found that loneliness was widespread at a problematic level in many countries.

The analysis of evidence from 113 countries and territories during 2000-19 was published in 'The BMJ'.

The findings identified important data gaps, particularly in low and middle-income countries, and substantial geographical variation in loneliness, with northern European countries consistently showing lower levels compared with other regions.

Existing evidence showed that loneliness not only affected mental health and wellbeing, it was also linked to a range of physical health problems and early death.

A recent estimate by US researchers suggested that one-third of the population in industrialised countries experienced lone-liness, and one in 12 people experienced loneliness at a level that can lead to serious health problems. But it was still unclear how widespread loneliness was on a global scale.

So, a team of Australian researchers led by the University of Sydney set out to summarise the prevalence of loneliness globally to help decision-makers gauge the scope and severity of the problem.

They trawled research databases and found 57 observational studies reporting national estimates of loneliness from 113 countries or territories during 2000-19.

Data were available for adolescents (12-17 years) in 77 countries or territories, young adults (18-29 years) in 30 countries, mid-



dle-aged adults (30-59 years) in 32 countries, and older adults (60 years or older) in 40 countries.

Data coverage was notably higher in highincome countries (particularly Europe) compared with low and middle-income countries.

Overall, 212 estimates for 106 countries from 24 studies were included in the meta-analysis. For adolescents, pooled prevalence of loneliness ranged from 9.2 per cent in South-East Asia to 14.4 per cent in the Eastern Mediterranean region.

For adults, meta-analysis was conducted for the European region only, and a consistent geographical pattern was found for all age groups

For example, the lowest prevalence of loneliness was consistently seen in northern European countries (2.9 per cent for young adults; 2.7 per cent for middle-aged adults; and 5.2 per cent, for older adults) and the highest in eastern European countries (7.5 per cent for young adults; 9.6 per cent for middle-aged adults; and 21.3 per cent for older adults).

Data were insufficient to make conclusions about trends of loneliness overtime on a global scale, but the researchers point out that even if the problem of loneliness had not worsened during their search period (2000-19), covid-19 might have had a profound im-

pact on loneliness. In this context, they say "our review provides an important pre-pandemic baseline for future surveillance."

They acknowledged that their review was subject to limitations, such as different sampling procedures and measures adopted by studies. And they noted that the data gaps in low and middle-income countries raised an important issue of equity.

However, considering the negative effects of loneliness on health and longevity, the authors said, their findings reinforced the urgency of approaching loneliness as an important public health issue.

"Public health efforts to prevent and reduce loneliness require well-coordinated ongoing surveillance across different life stages and broad geographical areas," they wrote. "Sizeable differences in prevalence of loneliness across countries and regions call for in-depth investigation to unpack the drivers of loneliness at systemic levels and to develop interventions to deal with them," they concluded.

Loneliness is costly to individuals and society and should be a political priority, argued Roger O'Sullivan at the Institute of Public Health in Ireland and colleagues, in a linked editorial.

They pointed out that the pandemic dispelled the myth that loneliness was just an older person's problem and said public health interventions must now take this into account and take a life course approach.

This meant addressing the social and structural factors that influenced risk of loneliness, including poverty, education, transport, inequalities, and housing - as well as increasing protective measures, such as public awareness campaigns that deal with stigma and stereotypes around loneliness, valuing community involvement and participation.

## Kids Find It More Difficult Than Adults To Recognise Faces Behind Masks

Children are having a difficult time recognising faces that are partially covered by masks due to Covid-19 pandemic and tis could potentially impact social interactions with peers and educators, as well as the ability to form important relationships, according to a new study.

The research shows children's face-perception abilities are not only profoundly impaired when people are masked, but their level of impairment is greater than that experienced by adults.

Children have about a 20 per cent impair-

ment rate for recognising masked faces

compared to about a 15 per cent rate for adults.

"Faces are among the most important visual stimuli. We use facial information to determine different attributes about a person, including their gender, age, mood and intentions. We use this information to navigate through social interactions," said Erez Freud, Assistant Professor, at York University.

The study by researchers at Universities of York and Ben-Gurion in Israel, looked at 72 children, ages six to 14, to see if their experience was similar to that of adults. Faces were presented with or without masks, both upright and inverted.

The study also revealed children process faces differently when the face they are looking at is masked, compared to one that's not. Their ability to holistically process faces, which is necessary for face perception, was disrupted and became more analytical. Typically, humans process the face as a whole rather than by its individual features. In the study, published in the journal Cognitive Research: Principles & Implications, the team used the kids' version of the Cambridge Face Memory Test -- the most validated measure of face perception abilities in humans -- to test the ability of schoolaged children to recognise faces with and without masks, both upright and inverted.

"If holistic processing is impaired and recognition is impaired, there is a possibility it could impair children's ability to navigate through social interactions with their peers and teachers, and this could lead to issues forming important relationships, Freud said.

"Given the importance of faces to social interactions, this is something we need to pay attention to." With children back to school with mask mandates once again, future research should explore the social and psychological ramifications of wearing masks on children's educational performance, Freud noted.

## LG's Assurances

rying to dispel the growing apprehensions about the work of the Delimitation Commission in Jammu and Kashmir, Lieutenant Governor Manoj Sinha on Saturday said that the Commission would not err and he had full trust in its transparent functioning. He also downplayed the voices of protest against the Commission's draft proposals that seek to drastically redraw the Assembly and parliamentary constituencies in Kashmir. He said that the Commission is a constitutional body and it was improper for anyone to question or comment on its decisions. The LG tried to further allay fears by saying that the Commission had so far only proposed changes saying it had only given the draft only to its Associate members. "If they wish so, they can give their opinions or objections pointing out 'discrepancies," the LG said adding that the draft would subsequently be put in the public domain and the common people would be asked to give their opinions and make suggestions.

As for the Assembly elections, the LG Sinha repeated the assurances of the union home minister Amit Shah. If we go by the sequence of the steps to be followed before the statehood is restored, the completion of the delimitation exercise would lead to the holding of the elections within the union territory framework. And statehood would be a third step in the process. But this sequence is unacceptable to the major J&K parties including Congress. Likewise, the parties are unhappy about the home minister's condition that statehood would be restored once the situation in J&K is "normal." The logical question that follows is who will decide Kashmir is now normal now, the local parties are asking. The parties are thus unsure that the centre is serious about restoring statehood even after elections are held and a government is in place. The centre, it appears, would first like to see the behaviour of the elected government before taking a call on returning the statehood.

Going forward, the situation looks very uncertain. It is unlikely that space for a normal political activity will open up anytime soon. The centre is in no mood to engage with Kashmiri establishment parties after their meeting with the prime minister last year. The harsh truth is that if at all, the centre will engage, it will do so on its terms and offer little accommodation to the demands of the major regional parties like the National Conference and the PDP. However, it makes sense that we take the LG Sinha's assurances on their face value and hope the Delimitation Commission's recommendations will be to the satisfaction of both Kashmir and Jammu regions.

## Friendly Pitch

he gift of a cricket bat, signed by former Indian captain Virat Kohli, from the External Affairs Minister Subrahmanyam Jaishankar to his Australian counterpart Marise Payne last week might suggest ties between Delhi and Canberra are stuck with the cliches of "cricket, curry and Commonwealth". But the story of India's Australia ties today is anything but. If Delhi and Canberra found it hard to get along in the past, they have become highly valued partners for each other, thanks to unprecedented political commitment in both capitals to rapidly transform bilateral relations. If Cold War geopolitics divided India and Australia, the new strategic dynamic in Asia driven by China's quest for regional dominance — is pushing the two nations toward each other. Equally important is the new convergence of commercial interests and deepening diasporic links.

That the US Secretary of State Antony Blinken and the Japanese foreign minister Yoshimasa Hayashi joined Jaishankar and Payne at the Melbourne cricket ground at the end of their talks in the Quadrilateral format may not have much political significance. Blinken and Hayashi, with no interest in cricket, were merely indulging their cricket-crazy partners in the Indo-Pacific. Fifteen years ago, Delhi and Canberra were deeply sceptical of the Quad framework proposed by Tokyo and backed by Washington. India and Australia are now active champions of the forum. Delhi and Canberra, which were too deferential to Beijing in the past, are now ready to stand up to Chinese pressures. It was not too long ago that China dismissed the Quadrilateral forum as "sea foam" that is here now but gone the next moment. But as the Quad consolidated itself, Beijing's tone has become harsher. As the Quad foreign ministers gathered in Melbourne, a spokesperson of the ministry of foreign affairs in Beijing attacked the group "as a tool to contain China" and called on its members to shed their "Cold War mentality".

There is more, however, to the India-Australia relationship than the Quad and the Indo-Pacific geopolitics. Jaishankar and Payne reviewed the growing bilateral cooperation in a range of areas from tourism and critical minerals to defence and security cooperation. The two ministers also launched the first India-Australia cyber framework dialogue. Australia is raising its profile in the subcontinent as part of its effort to coordinate regional policies with India. Delhi, in turn, is leveraging its Canberra connection, to strengthen its outreach to the strategic South Pacific Islands. Jaishankar and Payne also welcomed the rapid progress in the trade talks between the two sides. In New Delhi, after his talks with the visiting Australian trade and tourism minister Dan Tehan, commerce minister Pivush Goyal announced that the two sides are pushing hard to conclude an early harvest trade deal within the next month. During his visit, Jaishankar spent time with representatives of the Indian diaspora that has rapidly grown to about 700,000 and is making major contributions to Australian society. During the Cold War, cricket, curry and Commonwealth were just not enough to overcome the geopolitical distance between Delhi and Canberra; today, they will not only become more salient, but also reinforce the deepening strategic partnership between India and Australia.

## **India State Of Forest Report 2021**

Reflections For Jammu & Kashmir

orest Survey of India is the premier organisation of Government of India which maps, prepares inventory and publishes the report on the Forest resources of country every two years since 1987. The organisation has done great job in generating useful database for policy makers over years to take informed decisions in managing forests of India. The present report titled ISFR-2021 is 17th such report published by the organisation. Despite the criticism regarding various aspects of the report like definition of Forests the data compilation and mapping exercise of such a large and diverse landscape is a magnanimous job. The present writeup on the report is to have an insight into the report, to bring clarity on various aspects which are vigorously deliberated upon and to reflect on what the report has in it for Jammu & Kashmir.

#### **Definition of Forest as per ISFR:**

The Forest Survey of India for the purpose of the report defines 'Forest Cover' as all tree patches having canopy density of more than 10% and area of 1 Hectare or more irrespective of land-use, legal

Now the issue that is most debated is whether it includes orchards, private plantation etc under the forest cover. The answer to this question is 'Yes'. But is FSI transparent about this the answer is again clear 'Yes'. The data generated and given by FSI for various UTs and States clearly reflects it and as it is with any scientific data you have a basis and accordingly you need to interpret it. The report clearly mentions the Forest Cover within the Recorded Forest Areas (Legal Forest) and Forest cover outside Recorded Forest area i.e., private plantations & orchards having area more than 1 Hectare. Thus, it is for researchers and policy makers to interpret the same rather than simply generating the narratives.

#### Insights for Jammu & Kashmir from the report:

By going through the report many threads can be picked regarding the direction in which green cover of Jammu & Kashmir is progressing. There are many green flags to get encouragement from, red flags of concern and yellow flags to pause, reflect and act for J&K. The inferences drawn are purely on the data available in the report and are open to scrutiny.

#### The Green Flags:

#### The Forest Cover within the **Recorded Forest Area:**

Area (Recorded Forest Area is the legal forest managed by Forest Department & duly demarcated) has shown an increasing trend and as compared to last report. The area under forest cover within RFA has shown an increase of 954 sqkm from the last report. Further the area under Very Dense, Moderately Dense & Open Forest has increased. A comparison is given below:

The tree cover outside Recorded Forest areas included plantations, orchards and other scattered trees grown on farmlands etc. This is cause of great concern as the area under trees or green cover outside the Recorded Forest Areas has tremendously fallen and at an alarming rate. The tree cover outside RFA has fallen by 6658 sqkm since last two years which is huge and can be catastrophic to the environmental resilience, livelihoods and sustainable development needs of J&K. A comparison of same is given below:

legal decisions over years. The government has taken right step in this regard by constituting the Poplar commission and hopefully they will take note of this and give right direction to poplar cultivation in J&K and give confidence to people in taking this up again. Poplar is not only insurance crop of rural economy but also it is most important tree which helps in conservation of natural forest by taking the demand away from them for timber. Other reasons can be rapidly happening urbanisation especially the horizontal expansion, reducing the areas occupied earlier by trees.

There are many yellow flags or the areas in which we need to pause, reflect and then act with renewed wisdom. These give us an opportunity to refine our policies and shape them for improving

An interesting inference regarding regeneration of forest can be drawn by comparing the trees by diameter class in ISFR-2019 and ISFR-2021 and it can be corroborated by any field forester. The tables for same are given below:

If we compare the trees in Top 5 Pinus wallichiana (Kail) and Cedrus deodara (Deodar) have improved their rankings while as Abies pindrow (Fir) has gone

down. If we critically examine it further the number of stems for Pinus wallichiana and Cedrus deodara have almost doubled while as for Abies pindrow has remained static. This indicates the Kail & Deodar Forest are having very good health. While as forests dominated by Fir are not recruiting new stems and should be our area of focus. The Fir forests have not great regenerating potential and need special attention and further they are under huge grazing pressures since they occur in higher reaches frequented by graziers. Unless the Fir forests are freed from anthropogenic pressures and supplemented by Artificial regeneration it will remain cause of concern. The department has taken special projects on Fir regeneration but it will need massive efforts and research backing by universities like SKUAST to solve this problem as it is more of scientific problem than a managemental one. The department needs to pay attention to developing Fir planting stock and knowing the nurseries we have for other conifers especially Kail & Deodar we can do a good job here too. 2. The Grasslands:

The report is focussed on Trees however it gives an indication on the extent of Grasslands we have. As per the report the grassland area of JKUT is around 4437.70 sqkm. Grasslands need detailed study and we have to ensure we are not increasing the tree cover at the expense of grasslands. The dwindling grasslands means reduced herbivores and increased mananimal conflict. Further reduced grasslands means reduced grazing grounds for nomads, cattle herders etc which will bring great amount of conflict, affect livelihood and in turn the economy. Also, the unique biodiversity of these areas will be put in red.

3. Defining a degraded forest:

The department has done tremendous job in increasing the green cover despite of the difficult decade in which forests were most hit. Most of the forest areas lost have been reforested and the trend has always remained on positive side. However now is the right time to define where we want to take this Forest Cover which has become synonymous to tree cover. We have to define what is a degraded forest based on whether it has lost capacity to provide ecosystem services or others due to degrading factors like deforestation. Should we go on planting trees on all forest areas devoid of trees. Whether the ecosystems like scrublands, shrub dominated areas, grasslands occurring naturally are not important ecosystems which harbour diverse and unique flora and fauna. We need to have a course correction and focus on restoring landscapes and keep intact the natural ecosystems, their composition rather going ahead with only tree plantations. We need to define what is a Degraded Forest.

J&K has already sufficient area under Forest cover what we need to work on now is improving the health of these ecosystems by having scientific studies at micro-level and planning for each forest ecosystem in a holistic manner. We need to move from bird's eye view to worm's eye view for restoring our natural forest ecosystems.



We are living in the fast age where people are suffering from ADHD (attention deficit hyperactivity disorder), we scan and skim, picking out headings, sentences and single words. Knowing that, we must communicate with extreme efficiency.

It's amazing how what was written in 1602 seems to be so relevant today. Today brevity is not only desirable but is a virtue. In the times that we are living in, where everything is on the go, from grabbing a sandwich to a coffee to workouts in 7 minutes.

If someone is writing a speech, he may be struggling to cut down his total time to fit within the timeframe. He needs to know that it's the quality and not the quantity that matters and to keep his writing short and to the point. In another situation, in which someone was giving a very long and boring speech, making the audience yawn with boredom, one audience member may turn to another and sarcastically say, "brevity is the soul of wit" as a way of complaining. This phrase refers to the idea that keeping thoughts to the point sound smarter and wittier.

Why is it that people like to use long



sentences where the essence of the matter is lost and the listener bored (maybe confused too). Take pride in simple word choices, rather than flowery phrases.

Use provides, rather than is designed to provide, use because, rather than due to the fact that, use if, rather than in the event of.

People need to get over their love affair with flowery phrases and verbosity. The purpose is to communicate not complicate and bore. With shortage of resources, the most valuable one being time, to waste someone's time in long drawn talks should be made an offence.

I had decided way back in 2003 that I will make brief conversation and if it was a slightly long one, it should either be of serious interest to the listener or be humorous (we all can do with a laugh). Our life is our biggest teacher. When I was laid up in bed for over 2 years, I had some people who would come and make the most mundane conversation, I would be stifling my yawns and nodding politely. ## **Govt Blocks 54 More Chinese Apps Over Security Threat, Privacy Risks**

**NEW DELHI:** India on Monday blocked 54 more apps with Chinese links, including Tencent Xriver, Nice Video baidu, Viva Video Editor, and gaming app Garena Free Fire Illuminate, citing security and privacy concerns.

According to sources, these 54 apps allegedly obtain various critical permissions and collect sensitive user data. The collected real-time data are being misused and transmitted to servers located in a hostile country, they added.

The banned apps were allegedly engaged in activities prejudicial to the sovereignty and integrity of the country, also posing serious threat to security of the state and defence of India, the sources said.

IT ministry has issued interim directions for the blocking of 54 apps, the sources said.

In a statement, Google said: "On receipt of the interim order passed under Section 69A of the IT Act, following established process, we have notified the affected developers and have temporarily blocked access to the apps that remained available on the Play Store in India."

The list of banned mobile apps include Beauty Camera: Sweet Selfie HD, Beauty Camera - Selfie Camera, Rise of



Kingdoms: Lost Crusade, Viva Video Editor, Tencent Xriver amongst others. Other apps that have been banned, as per fresh orders, include Garena Free Fire Illuminate, Astracraft, FancyU pro, MoonChat, Barcode Scanner - QR Code Scan, and Lica Cam.

The crackdown marks the first such step taken this year after a massive sweep against the Chinese apps in 2020.

In June 2020, the government had banned 59 apps with Chinese links, including the hugely popular TikTok and UC Browser, saying they were prejudicial to sovereignty, integrity and security of the country. The 2020 ban -- that had come

in the backdrop of stand-off along the Line of Actual Control in Ladakh with Chinese troops -- was also applicable for WeChat and Bigo Live, besides Helo, Likee,

CamScanner, Vigo Video, Mi Video Call Xiaomi, Clash of Kings as well as e-commerce platforms

Club Factory and Shein. Thereafter, the government banned 47 more Chinese apps that were clones and variants of the apps blocked earlier.

In September the same year, the government blocked 118 more mobile applications, including the popular gaming app PUBG, terming them prejudicial to the sovereignty, integrity and defence of the nation. The banned apps in that lot included Baidu, Baidu Express Edition, Tencent Watchlist, FaceU, WeChat Reading and Tencent Weivun, besides PUBG Mobile and PUBG Mobile Lite.

On Monday, the sources said the IT ministry received a request for the blocking of 54 apps from the Ministry of Home Affairs (MHA) under the emergency provision envisaged in Section 69(A) of the Information Technology (IT) Act.

As per the report shared by MHA, these apps are either the cloned version or having similar functionality, privacy issue and security threats as alleged in previously blocked 267 apps by the government in 2020.

The government had initially blocked 59 apps on June 29, 2020 followed by 47 related/cloning apps on August 10, 2020 and 118 apps were blocked on September 1, 2020. Another 43 apps were blocked on November 19, 2020.

The sources said the real-time data collected by these apps are being misused and transmitted to servers located in a hostile country. This will enable them to compile huge personal data to mine, collate, analyse and profile by the elements who are hostile to the sovereignty and integrity of India and for activities detrimental to national security, they added.

In addition, there are other serious concerns as some of these apps can carry out espionage and surveillance activities via camera/microphone, accessing fine location (GPS) and do malicious network activity similar to previously blocked apps, the sources said.

# It's Like Munna Bhai MBBS Movie, All Patients Are "Hale, Hearty": SC On Medical College Inspection

New Delhi: The Supreme Court on Monday came across a Bollywood movie 'Munna Bhai MBBS' moment while dealing with a case of cancellation of permission for admission of additional students in a medical college, owing to surprise inspection on grounds that patients in the wards were "hale and hearty and no serious in-patient was found in paediatric ward.

National Medical Commission (NMC) told the top court that permission for admission of additional students was cancelled as there were no operation theatre and no X-RAY machines in the college besides other deficiencies.

A bench of Justices DY Chandrachud and Surya Kant said, It is shocking. It's like a Munna Bhai movie. All the patients in the ward were found to be hale and hearty. In the paediatric ward, there was no serious patient. We can't tell what else we found in the inspection report. We were surprised.

Senior advocate Abhishek Manu Singhvi, appearing for Annasaheb Chudaman Patil Memorial Medical College, said that the inspection was carried out by the NMC without any notice and that too on a public holiday that is on the day of the festival Makar Sankranti', which is prohibited.

The bench told Singhvi, Illness does not stop on Makar Sankranti'. Your client (college) did not say that there were no patients.

The bench was hearing appeals filed by NMC and the medical college, which is situated in Dhule district of Maharashtra, against the Bombay High Court order, which had directed for fresh inspection of the college by the commission and allowed the admission of students.

Solicitor General Tushar Mehta and advocate Gaurav Sharma said that NMC can take surprise inspection under the law and what the High Court order did was that it allows 100 MBBS students, to take admissions "in this type of college", which was the initial capacity.

There is no operation theatre and no X-Ray machines, Mehta said, adding that students need not to be worried as they would be accommodated in other colleges after consultation with the government.

Mehta said, Only one thing I need to point out, 100 were given the permission and 50 was new and what this order does is that they continue with 100 but don't admit new so that new kind of institution. Now, if we cancel their recognition, those students will not suffer, as in consultation with the government we will distribute them in other colleges. But they cannot now start adding new students in this kind of institution.

Singhvi said that this college has been running since 1992 with 100 MBBS seat capacity and therefore NMC has no power to withdraw the permission for admission to these seats.

He said that NMC did not give permission for additional 50 seats based on the inspection report.

Senior advocate Nidesh Gupta, also appearing for the college, said that the infrastructure which has been flagged in the inspection report by the NMC has been in existence for decades, and then there was no issue about it.

The bench set aside the orders of Aurangabad bench of Bombay High Court and asked it to consider afresh saying the High Court having not dealt with the merits of the rival contention, we set aside the impugned order of the High Court dated January 25. 2022 and February 2, 2022, and restore admission before the High Court.

In the meeting, he said, it was informed that the government has been regularly reviewing the Covid situation in the Union territory and has now decided to resume offline teaching by reopening all educational institutions.

The Chief Secretary stated that the COVID positivity rate in the UT has been contained to 0.7% and impressed upon the Heads of all educational institutions to remain vigilant to any signs of infection especially among unvaccinated students below the age of 17 years, besides ensuring adherence to COVID appropriate behavior, SoPs and protocols; proper social distancing; and hand hygiene provisions, and compliance to UGC guidelines in the mat-

Mehta, the spokesperson said, asked the Vice-Chancellors of universities, Principals of colleges, and Heads of all schools to submit Covid prevention and mitigation plans taking into account capacity of class rooms with 6 feet norm, staggered teaching plan, Covid protocols, vaccination, screening, and emergency SoP; within two

days.
"Further, to enhance effectiveness of COVID mitigation and management, the Chief Secretary advised the educational institutions to base their COVID management plans on the model UGC guidelines," he said. According to the spokesperson, the

education institutions were further asked to regularly screen their students and ensure that symptomatic students are tested timely and isolated to prevent the spread of infection.

Meanwhile, the Health and Medical Education Department was also asked to address the health-related needs of all schools, colleges, and universities in a time-bound manner, through the concerned divisional and district administrations.

Considering the educational institutions in Jammu & Kashmir are reopening for offline classes after a hiatus of almost two years, Mehta, the spokesperson said impressed upon the concerned to ensure proper maintenance, upkeep, and cleanliness in the institutions along with functional electricity and water supplies as well as proper sanitation facilities therein.

The Chief Secretary, he said, impressed upon the institutions to build on the experience of online classes and adopt an ideal blend of IT-based offline teaching curriculum to boost students' learning outcomes and successfully train them for national-level examinations.

"The academic year 2022-23 shall be the year of educational transformation for Jammu and Kashmir", Mehta said, while emphasising that each head of the Institution shall be personally responsible for Covid management and healthy teaching environment.

"There should be no tolerance for unhealthy activities in places of learning,"

Mehta said, as per the spokesperson. Additionally, he said, the Higher Education Department and School Education Department were asked to fully implement the National Education Policy across Jammu and Kashmir during 2022, thereby making the Union territory, the first among in the country to do so

opening of educational institutions across the union territory. Students of classes 9 to 12, dressed in uniforms and carrying vaccination certificates, were seen thronging their institutions in Jammu and other districts of the region on Monday morning, officials said.

In an order issued on Sunday, the state executive committee had said all universities, colleges, polytechnic institutes and ITIs, and classes from 9 to 12 can commence their routine offline teaching by following Covid Appropriate Behaviour and standard operating procedures from February

However, most of the educational institutions, including universities and colleges, remained closed and are likely to resume activities in a day or two after making necessary arrangements.

The officials said the attendance in both private and government high and higher secondary schools on Monday was low, but it was expected to pick up in the coming days.

A Jammu University official said since the order was issued on Sunday evening, they were finalizing the arrangements to reopen the university.

"The University should be ready, in all respects, to reopen for on-campus classes on March 1. All necessary SOPs shall be immediately notified in this regard and circulated among the faculty and students for compliance," Prof Talat, as per varsity PRO said.

He urged strict adherence to Covid Appropriate Behavior (CAB) to ensure smooth conduct of academic activities.

Prof Talat also called upon students to focus on their studies and examinations with renewed vigour to fast compensate for the disruptions caused by the Covid19 pandemic.

The panel's recommendations are borne out of an Act that is a "Constitutionally suspect" law. In legal parlance, if any Act is under judicial custody and the apex court is seized of the matter, it can be termed as a Constitutionally suspect law.

The party said the principle of Constitution propriety demands that such a law should not be implemented and all the limbs of the state and their institutions should, out of deference to the top constitutional court, desist from implementing such law till its constitutionality is determined.

The party also accused the Delimitation Commission of "departing from its laid down norms and practices".

The party said the population criteria, which is being followed across the country, has "taken a back seat" while finalising the share of seats in Jammu and Kashmir.

Citing Article 81 of the Constitution which states "each State shall be divided into territorial constituencies in such manner that the ratio between the population of each constituency and the number of seats allotted to it is, so far as practicable, the same throughout the State...", the National Conference said even this basic principle stands violated by the Delimitation Commission.

The party pointed out that as per the census of 2011, the average population criteria was placed at 1.36 lakh but the reorganisation and distribution of seats presents a different picture altogether.

Seven seats in the Jammu region which included newly carved out Paddar, Mata Vaishodevi and Bani have less than one lakh population as against three in Kashmir that include a newly carved out Kunzer assembly

The Delimitation Commission, after receiving representations from Associate members, had handed over a draft report in which an overhaul of assembly and Lok Sabha constituencies in Jammu and Kashmir had been proposed.

The voluminous report has proposed redrawing of Anantnag Parliamentary seats by including Rajouri and Poonch from Jammu region with it besides carrying out massive changes in Kashmir division, they said. Many of the assembly seats in erst-

while Jammu and Kashmir state vanished including Habba Kadal, a seat which was seen as a traditional bastion of migrant Kashmiri pandits. Barring Khanyar, Sonwar and

Hazratbal assembly seats of Srinagar district, all other seats have been redrawn and merged with new assembly seats being carved out like Channapora and Srinagar South, the officials said.

## No Jammer, Ambulance Facilities For Former J&K CMs In Srinagar

SRINAGAR/NEW DELHI: The security cover of four former Jammu and Kashmir chief ministers has been scaled down further with the Union Territory administration's decision to stop deployment of jammers and ambulances during their movement within Srinagar district, according to officials.

On Saturday, veteran politician and Lok Sabha member Faroog Abdullah, was seen offering prayers at the famous Hazratbal shrine and Dastgeer Saab in downtown Srinagar but there was neither an ambulance nor were there jammers, which, among other things, also blocks signals in cases where militants have planted an improvised explosive device that can be triggered by remote control.

The ambulance is provided to attend to medical emergencies during travel. However, the officials, said dur-

ing inter-district movement of former chief ministers Faroog Abdullah. Ghulam Nabi Azad. Omar Abdullah and Mehbooba Mufti jammers and ambulances will continue to be deployed.

This comes in the wake of the recent decision to downsize the Special Security Group (SSG), which had been created under a law enacted by the assembly of the erstwhile state of Jammu and Kashmir for protection of chief ministers and former chief ministers.

Subsequently, the SSG cover for the four former chief ministers was withdrawn and their protection entrusted to the security wing of the Jammu and Kashmir Police, which will be backed by central armed paramilitary forces.

The Jammu and Kashmir administration had withdrawn SSG protection after it was decided to downsize the elite unit established in 2000. This move came over 19 months

after the Centre issued a gazette notification Jammu and Kashmir Reorganisation (Adaptation of State Laws) Order, 2020, on March 31. 2020, under which it amended the Special Security Group Act of the erstwhile Jammu and Kashmir government by omitting a clause that provided former chief ministers and their families with SSG cover.

The officials said the SSG was in the process of being "right-sized" by reducing number of personnel in the elite force to "bare minimum" and that it will be headed by an officer below the rank of superintendent of police as against a director, who is in the rank of an inspector general of police or above.



#### **Don't Think Kohli Going** Through A Lean Patch: Rathour

KOLKATA: Virat Kohli's prolonged lean patch is not a concern for the Indian team, batting coach Vikram Rathour said on Monday, expressing confidence that the superstar batter would be back among runs in the upcoming T20I series against West Indies here.

The 33-year-old, whose tenure as India captain across formats came to an end last month, had a disappointing run in the recently-concluded three match ODI series with a total score of 26 runs at an average of 8.6 with a best of 18.

Rathour said it does not mean lack of form as Kohli has been doing well in the nets.

"I don't think he's going through a lean phase. I understand he had a poor series against the West Indies (in ODIs) but no conversation as such," Rathour said in a media interaction in the build-up to the three-match T20I series beginning at the Eden Gardens on Wednesday.
Across formats, Kohli is yet to

score an International century in more than two years. His last century came against Bangladesh in India's first pink ball Day/Night Test at Eden Gardens here in November 2019.

In ODIs, Kohli last scored a century against the West Indies in August 2019, in Port of Spain and since then, he has had 10 50-plus scores but failed to convert them into a ton. In the last 12 months, he has tralia," he said.
