the current forecast, the official said, is expected between the intervening night of February 22-23



Delhi HC Orders 3 Retired KP Officers To Vacate Govt Quarters

NEW DELHI: The Delhi High court has dismissed the petitions moved by three retired central government officials refuting their claims.

The petitioners sought permission to retain the government accommodation claiming they are Kashmiri migrants. They had challenged the eviction orders issued by the Central government.

Justice V Kameswar Rao dismissed the petitions observing, "The petition are devoid of merit, the same is dismissed.



The bench directed, "The petitioners shall vacate the government accommodation allotted to them on or before March 31, 2022 and an undertaking shall be filed in the court within one week." The High Court said in a recent order that the plea advanced by the counsels for the petitioners that they are entitled to the benefit of retention of the house for three years is unmerited.

The court said that the petitioners being ineligible under the office memorandum of March 28, 2017, cannot rely on the order of 7 October 2021, as they were not covered under the scheme, and such were not entitled to the retention of the government accommodation at all.

Matric Results: Most Govt Schools Fail Again

All Students Fail In Eight Schools, 30 Percent Pass In 75

SRINAGAR: The class 10th results announced by the Jammu and Kashmir Board of School Education (BOSE) have once again displayed the dismal performance of government schools which saw a pass percentage of 67.25 as compared to 91.18 percent by the private schools in the Valley.

Data available with the Kashmir Observer suggested that the government schools failed for the fourth time in a row to perform better than the private schools.

As per the official figures, in year 2021, a total of 38,721 students appeared in the Class 10th examination and 26,040 qualified. On the other hand, the pass percentage of the private



schools was 91.18 percent. Out of 33,963 students who appeared in the examination, 30,967 passed the exam.

Similarly in 2020, the pass percentage of the government schools was recorded at 62.76 percent. Out of 41026 students who appeared in exams, only 25749 qualified. The pass percentage of private schools was 89.82, as out of 34106 students who wrote the exams, 30635 qualified. During the year 2019, the

pass percentage of the govern-

ment schools was recorded at

62.96 percent while that of private schools was 86.26. In 2018, the pass percentage of the government schools was

recorded at 63.71 and private schools 85.85. The data clearly indicates the poor performance of govern-

ment schools in the Kashmir

Sources in BOSE told Kashmir Observer that around 75 government high schools (GHS) recorded less than 30 percent results in class 10th examination, eight among them with

zero percentage. On 19 February, the government suspended around 17 teachers in three government schools in Anantnag zone after all their 30 students failed in the matric exams.

Reports said for the 2nd

Kashmir's Anantnag District registered zero pass percentage in 10th standard results. The government had an-

nounced 30 percent relaxation in the syllabus for classes 10th to 12th in their annual regular 2021 examination. The relaxation was given because of the Coronavirus pandemic.

54 Foreigners Among 4900 Lodged In J&K Jails

SRINAGAR: Around 54 foreigners are among more than 4900 persons lodged in different jails of Jammu & Kashmir Union Territory, official data reveals.

According to reports, as on December 31, 2021, 54 foreign nationals were lodged in different jails of UT.

Among the foreign prisoners, 10 are convicts, 39 undertrials, four detenues and one in other category.

According to the data, 4970 persons were lodged in different jails of J&K as on December 31, 2021. Of them 4916 were Indian nationals and remaining 54 foreign nationals.

Among the Indian nationals, 176 were convicts, 4492



undertrials and 248 detenues. Detenues are those who

are lodged in jails under the Public Safety Act- a law which empowers the government to detain a person for a period ranging from three months to two years on apprehensions of being threat to law & and order and security of the State.


rinagar: Police Saturday traced missing Hajinyouth within 48 hours from Srinagar city.

Highlighting the benefits of the Land Pass Book, the DC said the Land Pass Book prescribed by the Revenue Department is true to the Revenue record and can be generated online without any hassle.

The DC further said Land Pass Book is an evidently valid entity carrying the same evidentiary value as if being certified copies of Record-of-Rights for all intents and purposes before Courts and Financial institutions. He said Land Passbooks issued to every landholder contains entry from the Jamabandi in Revenue Estate, so as to enable the landholder to make its use for Credit facilities and for other matters connected

The DC added that each Land Pass Book has a unique ID and QR code as an additional security feature, and with the help of QR code any institution, individual or an agency can verify the credentials and authenticity of the Land Pass Book.

"It is going to be a tool for redressal of various grievances, litigations, disputes at various forums and for reference", he added. He said Land passbook is an identity card for the Land ownership.

Among others, Tehsildar South Srinagar, MoeanKakroo, concerned NaibTehsildars and other concerned Officers were present on the occasion.

Meanwhile, similar functions were also held in other Tehsils of Srinagar District including Panthachowk Khanyar, Srinagar North, Channapora and Eidgah during which Land Passbooks were issued to the legal land owners.

Hajj Pilgrim Held Up For Not Bribing CID

RINAGAR Refusal to 'bribe' a police department sleuth has cost an intending Hajj pilgrim the final green sig¬nal to proceed to the holy land. Even after travel documents, including pilgrim pass, had been issued to the pilgrim, au¬thorities have dashed his hopes of performing the Hajj and asked him to stay put at his Kupwara home.

According to a NAFA report, Habibullah Kashi s/o Budullah r/o Anwarabaad, Salkot (Kupwara district) had been se¬lected for this year's Hajj vide serial No 4478. He was scheduled to fly to Jeddah tomorrow. His flight has to take off from here at 10.30 a.m. He has already re¬ceived his pilgrim pass and other travel documents.

Surprisingly, the authorities have stopped his departure for the holy pilgrimage at the last minute. He has been asked not to leave his home. The di-visional commissioner who is also the convener of the state Han committee is understood to have informed him that he would not be allowed to be proceed before CID clearance. His frantic efforts to reach the in-spector general of police, CID failed as the letter's office avoided him.

Family sources told NAFA an official from the CID had ap-proached Habibullah in connection with verification and allegedly demanded Rs 500. He expressed his inability to bribe the 'official as he was proceeding for a holy pilgrimage. The official might have forwarded an adverse report, they suspected.

Interestingly, report said, Habibullah Kashi visited Pakistan-controlled Kashmir in October 1999 on a valid passport bearing number A-6579375. The passport had been issued only; 'after proper verification of his antecedents. "If the CID didn't have any objection for his visit to Pakistan or Pakistan-controlled Kashmir, why did they withhold clearance on my pilgrimage for Hajj which is mandatory for the eligible Muslim", he asked.



NEW DELHI: A Public Interest Litigation (PIL) has been filed in the Supreme Court seeking direction to the Centre and the Election Commission to take steps to regulate poll manifestos and make political parties accountable for promises made therein.

Filed by advocate Ashwini Kumar Upadhyay, the PIL seeks direction to the Election Commission (EC) to seize the poll symbol and deregister/derecognise the political parties that fail to fulfil their promises made in their manifestos.

Ashwani Kumar Dubey, contended that the Centre and the Election Commission have not taken steps to regulate political parties' manifesto.

"Petitioner submits that election achieve the particular goals if the political party gets elected. It is a published declaration of the intentions, motives and views of the political party and government," the PIL began.

SC Declines Urgent Listing Of Plea By Sulli **Deals App Accused**

NEW DELHI: The Supreme Court on Friday declined to entertain a plea seeking urgent listing of petitions seeking clubbing of various FIRs across the country in connection with offences related to the app 'Sulli Deal of the day' in which scores of Muslim women were put on "sale".

Advocate Sahil Bhaliak mentioned the plea before a bench, headed by Chief Justice N.V. Ramana, submitting that multiple FIRs have been filed against his client and sought urgent listing of the subsequent FIRs with the first FIR, plea. "It is covered by T.T. Anthony's judgment," he said.

At this, the Chief Justice said: "If you have committed a crime. You'll have to face it. Covered or uncovered will be decided at the date of hearing."

The plea by accused Aumkareshwar Thakur, filed on January 24, prayed for clubbing of various FIRs filed throughout the country with respect to offences relating to the app. The petitioner is accused in 3 FIRs registered in New Delhi, Noida, and Mumbai.

The app had created a major uproar last year for targeting Muslim women and uploading their images without their consent. The 'Bulli Bai' case appears to be a clone of the 'Sulli Deals' app.

The plea said: "The relief sought in the present writ petition is in terms of the judgment passed by this court in T.T. Antony vs. State of Kerala for quashing of all the same or similar FIRs except the first onea and that a single investigation may be proceeded with. In the alternative, the petitioner prays for clubbing of all the in their custody," added the plea.

US Firm Makes Real Rifles For Children

WASHINGTON: A US gun manufacturer has unveiled a semiautomatic rifle for kids modeled on the AR-15, which has been used in a number of deadly mass shootings, sparking condemnation from gun safety groups.

The gun dubbed the JR-15 is being marketed by maker WEE1 Tactical as "the first in a line of shooting platforms that will safely help adults introduce children to the shooting sports."

The company's website says the rifle "also looks, feels, and operates just like Mom and Dad's gun.

The JR-15 is only 31 inches (80 centimeters) long, weighs less than 2.5 pounds (one kilogram) and comes with magazines of five or 10 rounds of 22 caliber bullets. It was released in mid-January with

The adult model, the AR-15, is the civilian version of a military-style weapon and has been used in multiple mass killings in the United States, including in schools. Mass shootings are a recurrent scourge of the United States, where the right to own weapons is

Attempts to regulate their sale is often blocked in Congress, where the powerful gun lobby -- in particular the National Rifle Association -- wields great influence. On December 14, 2012, a young man used an AR-15 to kill 26 people, including 20 children, at Sandy

Hook Elementary School in Newtown, Connecticut. An AR-15 was also used in a Las Vegas attack in 2017 that left 58 people dead, making it the deadliest shoot-

ing in recent US history, and in the Parkland High School shooting in Florida that killed 17 in 2018. -AFP

Skype Users Can Now Call 911 From Desktop



kype has announced that its US users can now use the platform to dial 911 from their home computer and that its software can share their location with emergency services if required. According to The Verge, the US is the latest addition to the list of regions with a

Skype emergency service calling feature.

Until now it was only available in Austra-

lia, Denmark, Finland, and the UK. This move from Skype to enable 911 calls comes with a few limitations, but could be crucial for users who still have an adequate Internet connection when they lose access to a cellphone or landline in an emergency.

In a 'Notice and Disclosures' warning that appears before opting in to location-sharing, Skype cautions that the service doesn't operate the same as a traditional phone call. Users are encouraged to not make an emergency call through Skype when outside of their home region since the call could potentially be rerouted elsewhere. It also made clear that a Skype outage, internet problems, or power outage in the area could cut off calls in situations where a traditional telephone would still work. In addition to making 911 calls with Skype 8.80, users can now leave a five-minute voice message instead of capping off at two minutes.

As per The Verge, users will also notice the choice of light or dark mode while they're on a call, can send custom reactions, and have the ability to zoom in or out when they share their screen. -ANI

It said that he and his companions come back every evening till around 5/6 pm, but on Feb 17, 2022, Mushtaq Ahmed Mir did not return and his mobile number 19149745999 was also blocked.

"When they searched for Mushtaq Ahmed Mir, they found a dead body lying in a sack on the side of the road from Ferozepur to Mallawal. The body was of Mushtaq Ahmed Mir, with blood oozing from his mouth."

Apni Party Seeks PM, HM's Intervention Over Panel's Draft Report

IAMMU: Jammu and Kashmir Apni Party president Syed Altaf Bukhari on Saturday expressed hope that Prime Minister Narendra Modi and Home Minister Amit Shah would pay attention to the voices of concern over the delimitation commission draft proposal.

He also sought the resignation of the five parliamentarians from Jammu and Kashmir three National Conference and two BJP members -- for their alleged failure to safeguard the interests of the people despite being the associate members of the commission.

The Delimitation Commission, in its draft report, has proposed an overhaul of assembly and Lok Sabha constituencies in Jammu and Kashmir, triggering massive protests in the Union territory. The draft report was circulated on February 4 to the associate members who had submitted their objections on February 14.

We are hopeful that after the elections in five states, the prime minister and the home minister, on first priority, will pay their attention to the voices of concern over the draft proposal of the delimitation commission so that a catastrophe, injustice and disenfranchisement of vast majority of voters is stopped and a message conveyed to the people that their voices matter, Bukhari, a former minister, told reporters here.

Dismissing the draft proposal as disempowerment of the public Bukhari said the report needs to be withdrawn in the interest of the people and the country.

In the constitution of India, we have equal rights the interest of the people remains supreme and no party is supreme over the security of the country, he said.

Criticising the five MPs from J&K, the Apni Party leader said, They were supposed to represent the people instead of their parties, but they failed to represent the interests of the people of I&K.

Understanding Budget 2022

Following Is The Transcript Of An Interview That KO Did With Economist Ejaz Ayoub About The Union Budget On 7Th Of Feb, 2022

inance Minister Ms Nirmala Sitharaman announced the Union Budget 2022 at the beginning of this week. Now, everybody doesn't seem too happy. The opposition has called out the apathy of the union budget towards the poor and the salary class. As is obvious, the party in power, especially PM Modi, have stood behind the union budget and have gone on to call it people friendly and progressive. Today on Kashmir Observer, we are going to analyse the budget for you to understand. Here from Kashmir, I am joined by Economist Ejaz Ayoub to see what really is going on behind the numbers.

The Interview

OVERVIEW

Has the union budget been promising or has it been underwhelming?

From a policy point of view, there's a lot of status-quoist nature of the budget. By that, I mean to say that sometimes you must have seen budgets are populists wherein a lot of benefits are given to the common people, be it middle class or sometimes to the farmers and sometimes for MSMEs too. We say Budget as a populist, wherein nothing substantial seems to be. Sometimes the budget is growth oriented wherein it's seen that maybe the government tries to speed up demand, the government tries to speed up particular sectors to maybe explore or something. Where, particular focus is laid on annual growth but here the budget presented, has quoist hues in it, which means the government seems to be, which might not be correct or which can be correct, with whatever is happening with the economy in terms of recovery.


So, India's GST collections have been getting a bit better. Job creation has been a problem, but to some extent the government seems to be happy with that. So in these areas, the government hasn't changed much in the budget. No changes in direct or indirect taxes. One highlight though that is to be mentioned is that the capital expenditure has increased by 35%, which is very substantial about which we'll talk about in detail later on. But about the expectations that people had, given the state of the Indian economy, nothing important seems to have been addressed in the Union Budget. For example, India's prime problem of unemployment, which is at its 48 year high according to a 2019 report, and we're going even downhill since. Meanwhile the policy decisions taken, apart from the capital investment, nothing has been done. Instead, in some of the schemes that helped in creating employment in rural areas, e.g., MGNrega, the allocations have been reduced which is very unfortunate, food subsidy has been reduced because "we are still in the pandemic". Likewise, the subsidy on fertilisers has been reduced, which supported a large portion of farm and farm based jobs. If we talk about healthcare, keeping in mind that we are still in the pandemic and this pandemic is not something which happens after 10 years, in even healthcare the government is lacking proper action. Governments across the globe have been beefing up their health care budget. They have been investing a lot in creating capacities wherein they can support the emergency events that are happening globally. Unfortunately, as compared to the last year's budget, this year's budget for healthcare is in fact reduced in real terms, if we add inflation.

My first disappointment, apart from the middle class income tax thing, was the government's totally negligent attitude towards unemployment. They gave a supposed vision of '25 years', a very long vision. There is a difference between intention announcement and delivery and the speech was filled with intention announcement but when it comes to delivery, the announcement doesn't match with it. For example, Tooba, you must remember, you must have heard about '100 smart cities'. We heard about a five trillion economy. We heard about doubling farmers' income, right? These were all announcements and intentions, very good and important intentions and announcements but when it comes to delivery there has been a very bad track record in the last five, seven, eight years. We have not seen such things happening. Similarly, if we now talk about the current 25 year vision as proposed by the Finance Minister, She talked about 'Amrit Yug' or something, for the next twenty five years for 100 years. In terms of rhetoric and in terms of the announcement and intention, it sounded very nice. But we have some immediate problems that need immediate attention rather focussing on a long term vision and talking exclusively about that. We should also have oversight very much towards problems like unemployment, problems like inflation, which are eating away households' income etc. So it was very disappointing.

Do you think that the same status quoist approach has been replicated in J&K's budget?

J&K's budget in itself has not been announced yet, because whatever has been announced in the government of India's budget, that is a revenue support, for example, our budget is, let's say, one lac crores. We have resources in terms of taxes and other income taxes, let's say 70,000 crores, these are just numbers that I'm using as an example. About the gap of 30,000 crores, we are kind of centre support status in those things. It's not just J&K they're supporting, they're supporting a lot of states, the north-eastern states, even U.P. government, a big state with a huge population and good revenue. Bihar has a lot too. So this is one of the components that every year the union government covers some revenue shortfalls of states. About 35 thousand crores now are accredited to Dal and Nigeen, and also 500 crores for the capital expenditure. This is largely for the revenue gap, very minute things. So this is nothing substantial, for example, talking about J&K's economy, since 2019 August it's in a lockdown phase which has resulted in a severe decline in demand. Tourism is recovering a bit though. We saw many challenges in agriculture, for example, recently the 8-9 thousand crores apple industry was shadowed by the import of Iranian apples. Our Trading sector, which is the largest after the agricultural sector, gives employment to a large portion of people. This sector depends on markets. When markets are open then and only transactions can happen, and that's how the trading sector creates value in the economy and creates jobs. Since we're in a lockdown since 2019, we're seeing reports that are not very positively indicative. E.g., the recent CMI report reveals the unemployment rate of J&K for the last 5-6 months has been very high, yesterday January's data came in and indicates 15% employment, So, this is because our economy is in a decline. The manufacturing is shut, they are not able to pay the EMIs for their loans. They are at the verge of collapse. So, the chamber of commerce, the trade federation etc. repeatedly were voicing their demands in open mainstream media, in the hopes that some kind of rehabilitation package would be given in their favour. But this didn't happen. Their demands were perfectly valid and they were asking for what was their right, and I'll explain how. See, the government is the custodian of its assets. When someone in the state does business, he pays taxes -in the form of GST, etc. Under normal conditions when all this money reaches the government, it supposedly uses it for the benefit of the people. However when the same businesses are unable to stay afloat financially due to reasons which are out of their hands like lockdown, pandemic etc., the government has a constitutional responsibility to bailout these businesses because they're the custodians. Unfortunately we don't see the responsibility being fulfilled by the government.

If we look at last year's revenue grant, that wasn't up to the mark

either. Something like 1000 crores or 800 crores, I don't remember the exact figure. This year, there is no mention of any kind of support, no rehabilitation package or anything, which has been very disappointing. Although people don't say it openly, trade bodies were expecting some support.

Now they are pinning hopes on the UT government. The UT government will come up with its own budget with the money that is already earmarked for us, like 35000 crores, including that money. We can only hope that maybe the UT government will come up with some kind of package, which will rehabilitate businesses and households. Tooba there is one important thing which is very essential to address for J&K, that its poverty is increasing drastically. No surveys are being conducted but the anecdotal evidence suggests it very strongly. The reasons for this are inflation and unemployment. When something like this happens, there is one important responsibility of the government, which is to provide social security to the people under a welfare system called 'Welfare Net'. For example you must have heard, funds which widows used to get, scholarships for students, discounts for the poor, subsidised ration etc. These things are very important for people of J&K. In the upcoming UT Budget, we hope not just businesses, but also households below the poverty line will get support from the government.

IN RETROSPECT

Have the middle class been largely ignored?

There are three, four categories of middle class. Salaried people don't constitute much of the middle class most likely, given the fact that only about 5% of the people pay income taxes. There's an income drop in the middle class. There was an Oxfam report recently which detailed that the incomes of the top 20 richest people has increased by around 40% in the last 5 years and the bottom 20% strata's income has decreased by 53% which means the rich are getting richer and the poor poorer. The income of the middle-class, instead of growing, has gone down by 7-8%. So it's a two edged sword going down their chest: on one side unemployment is on the rise and on the other those who have jobs are wit-

nessing a decrease in their incomes. Now what can the Government do about the middle-class? This is the meat of the electoral thing, middle-class are significant in terms of demand in the market, e.g., demand for two-wheelers, four-wheelers, consumer durables, apparel, food items. This is like the meat of your demand and these people are electorally important because they make the large strata of votes. breaks happened, it was in February of 2019 February, why? Because it was an election year. So if we follow the pattern, these populist decisions are always done right before elections. They contribute to the 'recency effect'. We are still one or two vears away from elections and most likely the government is saving these decisions

One more thing that is important to mention is that the government gave some tax breaks in 2019 September to corporations, in corporate tax, which relates to the report we earlier mentioned of rich getting richer and the poor poorer. These tax breaks for corporations are not exactly justified, given the fact that they are very able to pay the taxes without these breaks. On the other hand there's no tax incentive for middle-class and the poor are steeping lower due to inflation and unemployment, both of which the government is neglecting again and again. All of this contributes to making the country's structure very unhealthy. More wealth is concentrated with fewer people and the majority of people are living in misery.

So, it was hoped that maybe in this budget the tax policy will be designed to avert all this. Maybe corporate taxes would increase and that money would be used in subsidies, employment schemes like MGNrega. But none of this happened and the reason is that the government wants to reserve these populist decisions for election year, so I don't see anything happening anytime soon for these middle and lower strata of society.

What would you say about the job scenario right now? And has the budget really addressed the jobs crisis at all and have done anything to sort of create a scope for job creation?

See when this dispensation, which is ruling the country came into power, they said they will provide two crore jobs every year. So that was the slogan. And now the latest speech says 12 lacs. So it has come down drastically, meeting with reality. If we check the Labour Ministry website, they've estimated, which is still a very conservative estimate, that 1.3 crore people are looking for jobs and they don't have jobs and there are only 2 lac jobs available in the system, so this this the ratio of unemployment. So the government has largely underestimate the scale of the problem here. In this budget, they promised 12 lac jobs each year for the next 5 years, which is around 60 lac jobs, but every year the number of people like graduates, engineers, people who have attained the age of working, who hit the job market, are around 50 lac, and we know that already, 20-40 lac people are already unemployed.

In addition to that, there's one more important aspect, Tooba which we need to understand. When the pandemic initially hit, a lot of people from industries and service sector working in urban centres and semi-urban centres, went back to agriculture. So there was a very strange data point that came into existence that the labour force increased in agriculture which was like going back to the primitive economy. Normally, when the economy is advanced, it traverses from agriculture to industry, and from industry to services. And as the skills and education increase, working people go into more corporate sectors, but because of the pandemic the people went back to agriculture. Now that they went back, obviously they will be attaining education and they'll also look now for jobs. There will be people from the farm sector coming back to look for jobs.

So the number of people looking for jobs will be much higher and there's a complete mismatch between what is promised and what reality is.

So what happens now is that people go into poverty just because of the lack of Jobs. The entire India can be seen through a lot of indicators. When these very people, when they go out to buy stuff. Demand is created. Now that they don't have jobs, they don't go out as much as they would to buy stuff, just because they are not earning, and so the whole economy is affected. Same thing replicates, at a very aggressive scale in J&K because a lot of people have lost jobs and they don't have money and you don't see markets buzzing. Even if it's some festivity, or marriage season, you don't see that much demand in the market. So the government's ambition that through Capex, (which they increased by 35% for constructing roads and bridges, and railways etc.) they'll create jobs, is a very short-sighted ambition. Another data example, when India was growing fast in economy, from 2000 to 2012, India's average job creation per year was seventy five lac non-farm jobs. That is when India was going cruising like anything and after that this has dropped drastically, I think, from 2014 till now, India is creating only 29 lac jobs per year. Because of that there's a large imbalance in job creation and supply and demand. That is what is happening and the budget has not addressed that, and it's the core problem of India.

Has healthcare gotten its due?

Indians created a new policy in 2017, 'National Health Policy', a very comprehensive document. National Health policy targeted a goal for the government for combating the poor healthcare infrastructure. As a result, it was to be implemented that 2.5% of your GDP should be spent on health care. So the government followed suit, except now it has been 5 years since that policy and still no visible effect is seen in the national healthcare infrastructure. Last year's budget, along with the current budget, it's still 1.3%. So the scope of investment in healthcare in India, I think it's the lowest in emerging market economies like BRICS (Brazil, Russia, India, China, South-Africa), India is lowest in spending on healthcare with respect to the percentage of GDP. That's one.

One more important thing to mention is that normally healthcare is a State subject, not Union's, but 80% to 85% of your state's expenditure which is spent on health is the revenue expenditure, which means, salaries of paramedics, doctors, cost of medical supplies, electricity etc. They are not able to spare a lot of money to create new facilities, like creating new blood sugar hospitals, e, vou must have seen in I&K there's still that Soura, there is still that SMHS and you still have old hospitals. You don't have hospitals coming every five years or something. So normally this is where the union government chips in. They come up with capital expenditure. they come up with big hospitals like AIMS etc. like they've announced re-

cently, although can't tell when the work on that will be started. That is where health care has been very disappointing. And importantly, like I said in the beginning, we are still in the middle of the pandemic. It's not gone yet, there is no quick fix solution. We still don't have a working vaccine for it. The budget for healthcare has somewhat increased since last year but inflation is happening at a faster rate, as a result, it has remained near to the same as the last year, which is very disappointing for healthcare. And the government is acting as if the pandemic is over and "we need to look forward to something else", but the pandemic hasn't left yet. People's lives and jobs have been devastated. People are still not able to invest in the private sector. No restaurant owner is thinking of expansion, right? Or no factory owner is thinking of expansion, because the pandemic is still at people's throats but the government is acting as if it is over.

One important thing which I liked about the budget is that there has been an increase in investment in the education sector, there has been a substantial jump in the education sector. Yet the 12 lac vacancies of teachers are still pending across India, which is still not being covered. But the allocations have been increased as compared to last year's budget. Also, the government's approach towards other things like e-commerce, I.T., telecom, has been positive because of the increase in allocations.

DIVING DEEP

The recent unexpected taxation on crypto-currency has gotten everybody to question the status of crypto-currency, whether it's legal or not?

So whenever the government taxes something. It means that it has accepted it. For example, lotteries or gambling are allowed to operate in India, but they are taxed heavily. So the same is the case with cryptocurrencies. For example, you have liquor or you have smoking and all. They are allowed to sell these products but the government looks towards them as sin products and they are taxed heavily as a revenue stream. They have been very careful regarding crypto-currencies, and they have also included a lot of other things, including NFTs and all. So this is an acknowledgement of legality of an asset which is something to be very happy about for the crypto investors but there's still some ambiguity. For example, they talked about digital form of assets, Gold ETF is also a digital form of asset. For example, the gold that we digitally buy. Does the 30% tax imply it too? So a lot of things are not clear but for crypto-investors. This is good news for them because the apprehension that crypto exchanges will be banned is over since it's a part of mainstream, very important policy document, fiscal policy of the government and it's looking towards it as a revenue stream, which means it is partially legalised and it's a part of now the fiscal entire thing. Yes of course there is a big disappointment that it's heavily taxed, But the thing is, it's better than not getting identified by the government or recognised by the government. Paying heavy taxes is better than that.

Capital expenditure, which has increased by about 35%. What do you think that does to the health of the economy?

That is one of the very bright spots in the entire budget. It is a substantial jump in the capital expenditure. First thing, despite having profits, most of the private investment by big corporations is held back because of ambiguities, because of uncertainty and all. But the moment the government starts pouring in money in the system and with this much of scale, private investment also gets an impetus. It's like they also jump in. So this is very important. And the core sector will benefit more, which we saw when the announcement happened, the steel and cement companies, their stocks increased. So there are core sectors and labour intensive sectors. A large portion of it 20,000 crore will be given to create 25,000 kilometres of highways.

There's a possibility of increased engagement of the farm sector given the fact that because of this investment a lot of money will go into private hands, contractors, corporates then trickle down to the labour class and other skilled and semi-skilled people. So it's a very important thing for India's growth. J&K also needs to kind of be aggressive in demanding its share. Why? Because J&K is a landlocked place. Our connection with the rest of the world is through the Jawahar tunnel. So in case we can, we should benefit from the government asking to spend a share in constructing roads and railways here. That will be something, because our market linkages will increase, our raw material access will increase, and because of an all-weather connectivity our export potential will express itself which is held back. So in my opinion, it's definitely a good thing for India but the J & K government should take a stand with the Indian government in seeking a good share of the investments which will benefit its economy.

What would you have to say about the collapsing MSME?

Yeah, MSME is the backbone of India's employment. 6-7 crore people work there. Big potential for a generation of employment. Normally, there's a traditional path of developed economies which I talked about earlier. First there is the agrarian economy, and the industries and then services. Services have a lot of potential, it absorbs growth, so this is how economies grow, in parallel. Likewise production in agriculture increases because of technology.

Industries create finished foods and help in export as well as help in domestic demand. The problem with both India and J&K as well is that this transition from agriculture to industries happened too quickly. Our people directly shifted from agriculture to services. So the middle section between these two sections didn't develop well, like J&K's factories, there only a workforce of 45 lac and in J&K only 1.5 lac people are absorbed, and among that 1.5 lac 80% are migrants. That is very small, but the capacity of industries to absorb human resources is quite large. Last year, we saw a scheme initiated during the pandemic, which was purely based on credit, bank loans were given without mortgage, moratorium was increased, and MSMEs were supported a little. That scheme worked ok but it was not enough, because mainland India's problems were different compared to J & K. The span of lockdown in J&K was quite large. That credit worked for us, because we were already indebted to banks and now the government came with more credit through banks, they had no ability to repay their loan. As a result, you must have seen, repeatedly, Industries Federation Commerce Industry of Kashmir repeatedly they came on newspapers and they said, "We are going to wind up, we are going to collapse", because their debt profile increased very much, and the market didn't open because of which the income flow would've started.

Now, what should have this budget done, maybe it should have come up with some kind of relief, maybe like many kinds of reliefs like GST support, or, rental support, the electricity support. Little incentives which could've helped a factory owner save some money. But this didn't happen. MSME is also a large vote bank for the government and these populist policies, in my opinion, are reserved by the government for elections. Last year, they said that they'll divest the money from selling government companies. They had to divest only half of it, meaning only 1.78 lac crore, of which only 75,000 crores are divested till date, which means 1 lac crores still fall short on part of the government. So they don't have the resources.

Another interesting thing is Tooba. They increased the Capex, do you know where this money is coming from? It is coming from our pockets. How? Because the majority of our taxes on petrol and diesel, amounts to a large amount of money as compared to the amounts collected via direct taxes, i.e., corporate taxes, which they reduced back in 2019. So the taxes on fuel is what is directed to CAPEX. Like they reduced shares for MGNrega, subsidies etc.

Overall, there have been mixed reviews about the union budget. Some have called it underwhelming, there have been others who called it surprising and some have called it ambitious as well. Now you started with saying that it did more or less status quoist and might move on to become populist by 2024. Now who do you think does the Union Budget target or favour the most?

The meat of the budget goes towards infrastructure, and as a result, the corporations directly deal with the government in terms of developing these highways. Steel companies, cement companies, they are going to benefit a lot. Like I said, you must have seen the way stocks of these companies started behaving the moment the budget came out so these companies are going to directly get benefitted. Of course, there will be spill-over benefits to the economy in terms of job creation and other things, the capacity increasing of the economy. But another thing which is also important is that the government did not fiddle with the corporate tax, which was expected kind of because maybe that money will be used for social welfare and other things. So the corporate sector will again be happy because their corporate taxes were not increased which was drastically reduced back in September 2019.

The third thing, no taxes were increased for the superrich. So in my opinion, a small section of people which have big companies, influential companies which have a lot of wealth, which have huge income, they'll be happy with the budget. And about the people that come below this class who are directly related to farms etc.

There are two more things which I kind of missed, which are really good for common people. One is, there is this housing Pradhan Mantri Awas Yojna, a housing scheme for low income groups. The government has put a substantial amount of money in that, 48000 crore. That is one good thing for the lower strata of the people and increased allocations for Jal Jeevan Mission, an initiative for providing lower class with Tap water. These two things are very important for the lower strata of society besides the corporate thing. But yes, unemployment has not been addressed. Not a word about Inflation although it's a monetary policy, a domain of RBI but something as important as this should have been addressed. That was very, very surprising and similarly the lack of concern about healthcare has been very disappointing.

Vloggers Of Valley

MAD came out to capture the carpeted landscape in its alluring form the moment it snowed in Kashmir this winter.

The Srinagar-based content-creator has been picturing the quaint valley in all shades and seasons for years now. His ability to take his 'surging' social media audience on the regular visual tours has made Imad one of the celebrated content creators of the contemporary Kashmir.

Hailing from Lal Bazar locality and holding an MBA degree, Imad Ur Rehman began capturing meadows and mountains as an avid vlogger during his home

But after wrapping up his work outside and returning to his homeland in 2018, he started making You-Tube videos and eventually became a name in adventure vlogging. His YouTube channel features vlogs in which Imad is seen travelling across sprawling landscapes of the valley.

After building his digital following in a place where internet goes off suddenly due to situational twists, Imad is currently earning a decent living.

"But still," he says, "it's difficult to vlog in Kashmir as compared to other places."

As a vlogger, Imad says, he has to face frequent checks and queries about his work-driven forest forays

and summit scaling. Using drone footage of the valley's pristine locations has been an important feature of Imad's vlogging. "I became popular because of my drone photography

only," says Imad. "As an adventure-vlogger, I travel to far-off places and carry cameras, drones and other equipment. Government forces often question my heavy gadgetry in

no-man's land. But then, challenges are part of life." The "conservative" society, he says, has equally be-

come a challenge for content creation. "In other parts of the world, people take content creation as a profession but Kashmir is a challenging place where people look at us with suspicion,"

International Space Station

How Nasa Plans To Destroy It And The Dangers Involved



ambridge- Nasa has announced plans for the International Space Station (ISS) to be officially decommissioned in 2031. After dozens of launches since 1998 got the station up and into orbit, bringing it down will be a feat of its own the risks are serious if things go wrong.

Nasa's plans for the decommissioning operation will culminate in a fiery plunge into the middle of the Pacific Ocean a location called Point Nemo, also known as the spacecraft graveyard , the furthest point from all civilisation.

Finding Point Nemo will be the final stop in a complex and multi-staged mission to transition the operations of the ISS to new commercial space stations, and to bring the remaining structure safely down to Earth.

Originally commissioned for a 15-year lifespan, the ISS is outliving all expectations. It has already been in operation for 21 years, and Nasa has given the go-ahead for one more decade, thereby doubling its total planned time in orbit.

Purpose of the ISS

The ISS has enabled one giant leap for science and collaboration across mankind, involving five different space agencies (US, Russia, Europe, Canada and Japan). The modules and parts of the ISS have been built progressively by many different countries, only coming into contact for the first time in space.

The monumental conglomerate structure now stretches the length of a football field and is the largest human-made object in space. It is visible by the naked eye from Earth while it completes its 16 daily orbits, passing 400km above the Earth's surface.

Research in the so-called microgravity environment of the ISS has yielded breakthroughs in drug discovery, vaccine development and medical treatments in the last decade. The ISS also helps to monitor Earth's ecosystems and natural disasters in real time. It is used to test future spacecraft technologies and to study health effects of long term spaceflight for the possibility of future human exploration of the solar system.

Despite onboard research gaining momentum, Nasa has noticed signs of infrastructure and components slowing down. For every orbit around the Earth, the ISS gets scorched by so-

lar radiation on one side, and freezes on the other. These thermal extremes cause cyclic expansion and contraction which wears the material. Space radiation chars the transparent glass on the solar cells which are used to power the station, and repeated docking and undocking causes gradual structure degradation, which will ultimately lead to its demise.

The rise of flying space junk also poses unplanned and catastrophic risk of destruction. In 2016, a fly-away speck of paint chipped a window, and just last year, ISS crew went into evacuation standby when Russia obliterated a dead satellite with a missile, causing thousands of pieces of debris to fly by the station at 5km per second. Despite this, Nasa assesses there is high confidence the station will see it through to the end of 2030.

The decommissioning operation

While Nasa has committed to maintaining the station until 2030, its partner organisations are yet to officially sign on, meaning the final decision to de-orbit will depend on politics as much as engineering.

If degradation or unplanned damage occurs before the official decommissioning, a free-falling ISS poses serious dangers. In fact, it would not be the first space station to fall out of the sky. In 1979, Nasa's Skylab station was not re-fuelled in time and came crashing down, out of control, leaving chunks of the station scattered across Australia. While no one was harmed, this led to reforms and design for demise guidelines.

Design for demise is an important principle for the engineering of satellites and other orbiting space infrastructure. Objects that fall freely from orbit must disintegrate into tiny pieces to make sure they don't pose a danger to people on the ground

The ISS is too large to satisfy the design for demise principle, which is why we need special operations for de-orbit. Experts estimate that if it were to crash down uncontrolled in a metropolitan area, the worst case scenario could be on the scale of a 9/11 event . However, this is highly improbable.

In the planned, controlled, de-orbit operation for the ISS, newly built modules will first detach from the main structure and remain in orbit to eventually recombine as parts of future space stations. The ISS will then be gently decelerated by onboard thrusters, causing its orbiting altitude to gradually lower over the course of a few months.

The remaining descent will be more rapid, but controlled by a series of spacecrafts sent to attach and steer the structure as it begins to plummet towards Earth. As it re-enters the atmosphere the majority of the structure will burn away, however the remaining mass should remain on a targeted trajectory to its deep-sea resting place.

A Russian space station was previously brought safely down in the same way, however the ISS is approximately four times larger, so an operation on this scale remains untested.


New era

Before complete de-orbit in 2031, the ISS will first undergo a transition phase to sustain the crucial scientific research currently being conducted, and to form the basis of new industries in space.

Jeff Bazos' Blue Origin recently announced plans to replace the ISS with the company's privately-operated space station. Other key players include Northropp Grumman and Axiom Space (partnered with SpaceX) who have a contract to start building modules off of the existing ISS as early as 2024.

There are also plans for a Russian space station which is likely to comprise of modules detached from the existing ISS. Meanwhile China launched the first module of their independent Tiangong Space Station last year, and plan to complete its expansion in the coming months.

At present, Nasa and its partner agencies oversee the use of their jointly owned infrastructure and are consulted on operations due to their governing expertise. However, times are changing and Nasa now purchases seats on board spacecraft owned by SpaceX. Ultimately, Nasa will become just another customer of commercial operators.

India-UAE Trade Pact To Boost Apparel Exports, Employment, Say Exporters

NEW DELHI: Implementation of the comprehensive free trade agreement between India and the UAE would help boost the country's exports and creation of lakhs of jobs, according to exporters.

Welcoming the signing of the Comprehensive Economic Partnership Agreement (CEPA) between India and the United Arab Emirates (UAE) on Friday, Apparel Export Promotion Council (AEPC) Chairman Narendra Goenka said that it will further strengthen India's dominant position in the UAE.

"With India supplying \$1,515 million of apparel to the UAE as against its total imports of \$3,517 million, Indian apparel exports contribute a decent share of 43 per cent. The trade pact would result in a drop of 5 per cent import duty for Indian readymade garments. This will further strengthen the dominant position of Indian apparels in the UAE," Goenka said.

He added that Indian apparel exports to the UAE also cater to the needs of Saudi Arabia, Ku-

wait, Bahrain, Oman and the UK. Federation of Indian Export Organisations (FIEO) President A Sakthivel said that the pact will be beneficial to Indian exports particularly for the labour-intensive sectors like agriculture and processed food including meat and marine products, gems and jewellery, apparel and textiles,

leather and footwears. "Having a large Indian diaspora, the UAE consumes a large quantity of Indian cereals, fruits and vegetables, tea, spices, sugar, etc. Indian companies will gain in services like travel and tourism, transportation, IT and ITES and construction services," he said.

The agreement, dubbed as the Comprehensive Economic Partnership Agreement (CEPA) is likely to come into force in May and will open doors to about 90 per cent of products of interest to India for export to the UAE "right from Day one", the minister told reporters after the signing of the pact.

The commerce and industry minister and the UAE Minister of Economy Abdulla bin Touq Al-Marri signed the pact during a virtual summit held by Prime Minister Narendra Modi and Crown Prince of Abu Dhabi Sheikh Mohammed bin Zayed Al Nahyan. The two countries also unveiled a roadmap for the expansion of

The agreement will provide and UAE businesses, including enhanced market access and reduced tariffs. It is expected that the CEPA will lead to increase in bilateral trade from the current USD 60 billion to USD 100 billion in the next five years

In September last year, India and the UAE formally launched negotiations for the trade agreement. The negotiations for the 881-page agreement were concluded in record 88 days in December. Goyal said this is a comprehensive and "balanced" trade

Retail Inflation For Farm, Rural Workers Rises To 5.49 Pc, 5.74 Pc In January

New Delhi- Retail inflation for farm workers and rural labourers rose to 5.49 per cent and 5.74 per cent, respectively in January mainly due to higher prices of certain food items, official data showed on Friday.

Rate of inflation based on CPI-AL (consumer price index for agricultural workers) and CPI-RL (consumer price index for rural labourers) stood at 4.78 per cent and 5.03 per cent, respectively in December 2021.

In January 2021, rate of inflation based on CPI-AL and CPI-RL stood creased by 2 points and 1 point at 2.17 per cent and 2.35 per cent, a labour ministry statement said.

Food inflation for farm workers stood at 4.15 per cent and for rural labourers at 4.33 per cent in January 2022 compared to 2.99 per cent and 3.17 per cent, respectively in the previous month. In the year-ago



period, food inflation was 1.02 per tively mainly due to decrease in cent and 1.22 per cent respectively.

The all-India CPI-AL and CPI-RL numbers in January 2022 deto stand at 1,095 and 1,105 points, respectively as compared to that in December 2021.

Major contribution towards the fall in general index of agricultural labourers and rural labourers came from food group to the extent of 4.65 points and 4.17 points, respecsition stood at the bottom, it stated.

Police Suspect Same Persons Behind Planting Of IEDs In Ghazipur And Old Seemapuri In Delhi

NEW DELHI: The Delhi Police investigating the recoveries of IEDs in Ghazipur and Old Seemapuri has found that the design and component of the explosives were same and that a stolen motorcycle was parked near both the spots.

Investigators believe that the same persons were behind planting the IEDs within a month. The sketches of two suspects who claimed to be students hailing from Uttar Pradesh have been prepared, a senior police officer said, adding that efforts are being made to identify and nab them at the earliest.

The explosives recovered at the two spots in Delhi were similar in make and design to those that were recovered from Punjab two months ago, police said.

"Though the explosives recovered from Punjab and Delhi's Old Seemapuri and Ghazipur were of similar make and design, those recovered in Punjab were explosives of lightweight and those in Delhi have a metallic covering," the officer said.

Another officer said "we cannot rule out the possibility of the involvement of Pakistan's ISI which might have made such sophisticated design and sent it to Punjab and Delhi." The investigators are looking into it, the officer added.

According to the police, the owner of the house in Old Seemapuri where the explosive weighing 2.5 to 3 kg was found and a property dealer were being questioned.

The sketches of suspects prepared are of two people who told the house owner that they were students and hailed from Uttar Pradesh.

The two suspects stayed at the house for the last two months. The house owner had claimed during interrogation that he had

collected their identity proofs but the police said they were yet to recover any of it.

The IEDs found in the Old Seemapuri house on Thursday and in the Ghazipur flower market on January 17 were prepared with the intention of carrying out blasts at public places across the city, Delhi Police Commissioner Rakesh Asthana had said on Friday. Such activities are not possible without local support, he had added.

The investigation revealed that both IEDs were made with a mix of ammonium nitrate and RDX, the senior police officer said. Both explosives were defused in a controlled manner and no one was injured.

In a CCTV footage collected from near the Ghazipur spot, a black Hero Splendor motorcycle was seen parked nearby.

And after the IED recovery in Old Seemapuri, the police recovered a similar motorcycle from near Dilshad Garden Metro Station. It was found to be stolen and investigators believe it is the same motorcycle seen in the CCTV footage collected from the Ghazipur spot.

The recovery of the IED at the Ghazipur flower market came ahead of Republic Day celebrations on January 26 for which the security apparatus in the national capital was on high alert. Delhi Police chief Asthana earlier said the Special Cell and other teams were investigating the case.

The investigators are probing forward and backward linkages. "We are trying to preempt every such incident in Delhi and expose any local and foreign network," he added.

Officials from the National Investigation Agency and the Uttar Pradesh Anti-Terrorist Squad had on Friday visited the scene of crime in Old Seemapuri as multiple agencies have been working on the case.

Dubai Ruler's Daughter Tells UN She Is Well, Year After "Hostage" Videos

GENEVA: An Emirati princess, who last year said she was being held "hostage" in a palace, has assured the UN rights chief Michelle Bachelet that she is well during a meeting in Paris, the High Commissioner said

The meeting, which took place on an unspecified date at Dubai Sheikha Latifa's request, took place a year after she said was being held hostage and feared for her life, in videos released by British media in February 2021.

"Latifa conveyed to the High Commissioner that she was well & expressed her wish for respect for her privacy," UN High Commissioner for Human Rights Bachelet said in a tweet, which included a picture of the two women on a Paris street.

Bachelet's office didn't respond to an AFP request for details of the meeting, or whether Bachelet took the princess' comment at face value.

The tweet added that Latifa's legal advisor had organised the meeting and that the UN rights commissioner and Latifa had met in private.



Sheikha Latifa, 36-year-old daughter of Dubai's ruler Sheikh Mohammed bin Rashid Al-Maktoum, had said back in June last year that she was free to travel.

Sheikh Mohammed is vice president and prime minister of the United Arab Emirates, of which Dubai is one of the seven members.

Latifa made an unsuccessful attempt to flee the emirate in March 2018, escaping by boat with the help of friends before being hauled back. In Gebruary 2021, the BBC

Survey To Assess COVID-19 Impact On Delhi Govt School Children Soon

New Delhi: The Delhi government will soon commission a study to assess the impact on the mental health and emotional well-being of students due to the closure of schools, COVID-19 and the shift towards online education, officials said on Saturday.

Schools in Delhi were closed following lockdown in March 2020 and were opened this

The planning department of the Delhi government on Friday issued a request for proposal (RFQ) to hire a suitable agency to conduct the study covering government school students, parents and teachers. The study is designed to as-

sess the emotional well-being and mental health of all types of students, boys and girls, from different classes, age groups, social and economic backgrounds, which will provide an insight into how students from different backgrounds responded, adapted and handled the effects of COVID-19, the document stated.

As many as 44.80 lakh students had enrolled in Delhi schools during 2020-21. A total of 8,400 students, 1,680 parents and 1,680 teachers will be

surveyed for schools across 28 zones in Delhi, it said.

The sample data of students, teachers and parents will be provided by the government. The study will be conducted for students of Class I to XII as well as parents and teachers through personal interview from all 28 education zones of Delhi.

Separate questionnaires have been designed for each group of students by the Directorate of Education in consultation with the planning department. The questionnaires for teachers and parents have been designed irrespective of groups.

The selected agency will require to form survey teams of minimum 30 surveyors with each completing 15 surveys per day in a span of 30 days, including buffer period, to cover the selected students, parents and teachers, the document said. As per the RFQ, an agreement with the agency selected through bidding will be signed by March 21 and field work of survey will be wrapped up by April 29.

The data collected digitally will be compiled and analysed and a draft report will be submitted to the government by May 17. The final report of the study will be submitted by May 27, according to the document.

Hezbollah Drone Flies 40-Minute Tour Of Northern Israel, Returns To Lebanon

BEIRUT: A drone flown by militant group Hezbollah has managed to cross into northern Israel on a 40-minute "reconnaissance mission", triggering air defences and the scrambling of fighter jets before returning to Lebanon. Iran-backed Hezbollah, which

fought a month-long war against Israel on the Lebanese border in 2006, said Friday's flight carried out a successful required mission. Earlier this week, its leader, Sheik Hassan Nasrallah, said his militant faction had been manufacturing military drones in Lebanon and had the technology to turn thousands of missiles in



their possession into precisionguided munitions.

"Despite the enemy's multiple and successive attempts to shoot it down, the 'Hassan' plane returned from the occupied territories safely," it said.

The incident comes just a day after Israel shot down what it said was another drone, allegedly from Hezbollah, that had crossed into its airspace.

The Israeli military said in its statement that the incursion set off air raid sirens in the north of the country, and that Iron Dome interceptors were deployed and fighter jets were patrolling the skies.

"After a few minutes, radar contact was lost with the aircraft," it said, adding that the event was under investigation and that "civilian life in northern Israel has returned to routine".

Hours later and roughly 100 kilometres to the north, a thundering roar was heard in Lebanese capital Beirut, caused by an Israeli fighter jet flying at very low altitude, jolting residents, rattling windows and setting off some car alarms.

All 117 Seats in Punjab, 59 in UP Go To Polls Today

LUCKNOW: Voting for 59 assembly constituencies spread across 16 districts of Uttar Pradesh will take place on Sunday in the third phase of the polls.

Campaigning for the third phase of the state elections ended on Friday, with senior leaders of the parties making a final effort to woo voters.

As many as 627 candidates are in the fray in this phase, in which over 2.15 crore people are eligible to vote.

Districts where polling will be held are Hathras, Firozabad, Etah, Kasganj, Mainpuri, Farrukhabad, Kannauj, Etawah, Auraiya, Kanpur Dehat, Kanpur Nagar, Jalaun, Jhansi, Lalitpur, Hamirpur and Mahoba.

The Karhal assembly seat, from where Samajwadi Party chief Akhilesh Yadav is contesting, will also go to the polls in the third phase on Sunday.

The BJP has fielded Union minister S P Singh Baghel from the seat.

Polling on Sunday will also seal the fate of the Samajwadi Party chief's uncle Shivpal Singh Yadav, who is contesting from his traditional Jaswantnagar seat.

Before the campaigning ended for the third phase on Friday, Congress general secretary Priyanka Gandhi Vadra undertook a door-to-door march in Kanpur, Kal-



pi, Jalaun and Hamirpur, while BSP chief Mayawati addressed election meetings in Jalaun and Auraiya. Samajwadi Party patriarch Mulayam Singh Yadav sought votes for his son Akhilesh Yadav in Karhal.

The BJP had approached the Election Commission seeking deployment of paramilitary forces at all booths in Karhal.

Among the prominent faces in the fray in this phase are BJP's Satish Mahana (Maharajpur in Kanpur) and Ramvir Upadhaya (Sadabad in Hathras) and Louise Khurshid, who is contesting on the Congress' ticket from Farrukhabad Sadar. Louise Khurshid is the wife of senior Congress leader Salman Khurshid.

Former IPS officer Asim Arun is contesting from Kannauj Sadar on the BJP ticket, while Uttar Pradesh minister Ramnaresh Agnihotri is also in the fray in this phase.

In the 2017 elections, the BJP had won 49 of the 59 seats while the SP had settled for nine. The Congress had got one seat, while the Bahujan Samaj Party (BSP) drew a blank. Polling will begin at 7 am on Sunday

and continue till 6 pm.

58 Girls Suspended From College In Karnataka For Wearing Hijab, Holding Protest

BENGALURU: Girl students in many parts of Karnataka were denied entry into their respective educational institutions on Saturday as they arrived in hijabs, despite a court order, as the issue showed no signs of abating after its flareup about a fortnight ago that prompted the government to close down colleges and institutions for a couple of days.

As many as 58 students at Shiralakoppa in Shivamogga district who had refused to remove their hijab and staged a demonstration against the government pre-university college administration were suspended.

They were suspended on Friday and were told that they should not come to the college, a student told reporters. On Saturday too, they came to the college, raised slogans and demanded their right to wear hijab. However, they were not let in.

"We came here but the principal told us that we have all been suspended and there is no need for us to come to the college. Even the police told us not to come to the college but we came here. Today, no one spoke to us," the students complained.

Despite a government order and the Karnataka High Court's interim order restricting the students from wearing hijab or saffron scarves inside classrooms, the girls came to schools and colleges donning the headscarf.

In the SJVP College at Harihar in Davangere district, girls wearing hijab were denied entry. The pupils refused to go inside without the scarf, stressing that it was as important as education and they

cannot give up their right. In Vijay Paramedical College in Belagavi district, students complained to the reporters that a holiday was announced by the institution for an indefinite period due to the hijab issue.

"We will not sit without headscarves. Let the college realise how it affects our education. The principal is not listening to us," a student told the media.

In Ballari, a group of girls were not allowed inside the Sarala Devi College, which has been witnessing protests from the day the controversy erupted and the government had ordered that no one should wear clothes that could disturb peace, harmony and, law
