Says, Delimitation Exercise About To Be Over

SRINAGAR: Union Home Minister, Amit Shah said on Monday that assembly elections in Jammu and Kashmir will be conducted within six to eight months after the delimitation exercise concludes.

"The delimitation exercise is about to get over. After this, whatever will be the reasonable timeframe – about six-eight months – the elections will be held. There should be no confusion about that," Shah told in an interview with Network 18.

Early this month, the Delimitation Commission proposed an overhaul of assembly and Lok Sabha constituencies in Jammu and Kashmir in its draft report which was handed over to five associate members from the Union Territory.

According to the draft proposals, the Assembly seats in the Jammu division were increased from 37 to 43 and in Kashmir from 46 to 47. Almost all parties expressed strong resentment over the panel's proposals and rejected it.

The Commission headed by retired Supreme Court judge Justice Ranjana Desai with Chief Election Commissioner Sushil Chandra and state election commission K K Sharma was set

up on March 6, 2020 and was granted an extension of a year on March 6, 2021, which will come to an end next month.

SRINAGAR: The Jammu & Kashmir Government has set the ball rolling for the appointment of chairman and member(s) of the Board Entrance of Professional Examinations (BOPEE).

To begin with, the government has invited applications from the citizens of India for the position of chairman and member(s) of the BOPEE.

Official Documents reveal that the General Administration Department (GAD) has issued an advertisement notice for filling these key positions in the coveted body responsible for conducting entrance examinations for professional courses.

"The appointment of the candidate as chairman or member(s) shall be made on tenure basis up to a maximum period of two years and the candidate shall be eligible for re-appointment for another such term or until he/she attains the age of 65 years, whichever is earlier," reads the notice.

As per the eligibility criteria, the chairman shall be an academician of high repute having served for not less than 25 years or has held the post of a secretary to government or equivalent.

Similarly, the member(s) shall be an academician of a repute having served in the Union Territory of Jammu & Kashmir for not less than 20 years or a person having served as special secretary to More on P6

Night Temp Drops To Below Freezing Point In Valley, Minus 2.2°C In Srinagar

SRINAGAR: Weathermen on Monday forecast widespread light to moderate rain and snow, during February 22-23 even as night temperature dropped to below freezing point in Kashmir Valley, officials said.

"Widespread light to moderate rain/snow, mainly over higher reaches most likely during February 22-23 with main activity on February 22 (night) and February 23," said a meteorological department official here, adding, "It may affect highways like Jammu-Srinagar, Sinthan Top, Sadhna Top etc." After this spell, the official said, there's no forecast of any major rain or snow for the next 10 days.

Meanwhile, the official said Srinagar recorded a low of minus 2.2°C against last night's 0.1°C. The temperature was below 3.1°C than the normal for this time of the year, he said.

Qazigund recorded a low of minus 2.8°C against minus 0.8°C on the previous night, he said.

Kokernag, also in south Kashmir, had a low of 3.0°C against minus 2.6°C on the previous night, the official said. Pahalgam recorded a low of minus 6.0°C against minus 4.3°C last night, he said.

Gulmarg recorded a low of minus 8.0°C, same as on the

previous night, he said. The temperature was 1.3°C below normal for this time of the year in the famous resort in north Kashmir's Baramulla district, he said.

Kupwara town in north Kashmir recorded a low of minus 3.0°C against minus 2.3°C on the previous night, the official said. More on P6

However, it does not mean that the virus will vanish completely, Melita Vujnovic was quoted as saying in an interview with TASS news agency.

"It's hard to make predictions at the moment but we hope that if nothing else happens, the pandemic may end in 2022.

HC Junks Plea Seeking Ban On Animal Sacrifice

SRINAGAR: The High Court of Jammu and Kashmir and Ladakh on Monday dismissed a Public Interest Litigation (PIL) petition seeking a ban on the practice of slaughtering animals as part of 'religious sacrifices'.

The plea was moved by Jammu lawyer, based Ankur Sharma on behalf of his client, Tek Chand from Kathua in the capacity of a Public Spirited Pujari of a Hindu Temple for a direction to declare Section 28 of the Prevention of Cruelty to Animals Act, 1960 as unconstitutional.

The plea came a year after

the High Court refused to entertain a PIL seeking direction to the government to enact a law prohibiting cow slaughter in the Union Territory. The PIL had also sought a

direction from the court to make the slaughter of cows in J&K a cognizable offence with strict punishment.

In the fresh plea, the Court noted that the petitioner had failed to disclose how he is the publicspirited person or the kind of activities taken by him in the past in public interest to recognize him as a publicspirited person. The Bench of Chief Justice Pankaj Mithal and Justice Sindhu Sharma

It later went on to become a pan-Indian movement termed Trika' (The Trinity) by its great exegete, sage Abhinavagupta, and particularly flourished

2,250 Square Km Of Forest Land Degraded In J&K: Govt

JAMMU: Over two thousand square kilometres of forest area has been degraded in Jammu and Kashmir even as the forest department restores 100-200 sq km on an average annually, officials said Monday.

Principal Chief Conservator of Forests (PCCF), Mohit Gera told a meeting here on Monday that out of total of 20194 sq km of the forest area in J&K, around 2250 sq km forest area has degraded, an official spokesper-

son said Monday. Gera, he said, added that the department on an average restores 100-200 sq km of the degraded forest area in a year.

The PCCF was made these comments in a meeting chaired by the



Chief Secretary, Dr Arun Kumar Mehta to review UT capex of the forest department in which administrative secretary, forest and other senior officers of the forest departments were present.

According to the spokesperson, the Chief Secretary urged

the forest department to replenish the denuded forest cover, increase plantation outside forest areas and repair the neglected water bodies using both traditional ecological knowledge and modern practices in convergence with More on P6

Researchers Link Transient Blood Pressure Rise To Learning In Brain

It is natural for people to get stressed in their everyday work, but at times, this stress can lead to an increase in blood pressure. Recent research has revealed that minor everyday rises in blood pressure due to short-term stressors can be linked to a brain area that controls conscious and learned motor skills.

This discovery, presented by University of Gothenburg researchers, paved the way for a chance to influence the rises in blood pressure and, in the long run, prevent hypertension. The study was published in 'Scientific Reports'.

In roughly half of all people with hypertension — persistently high blood pressure (BP) — there is no known cause. One plausible theory is, however, that hypertension might be the result of a long period of many recurrent BP peaks. Hundreds or thousands of microstress events may occur daily the telephone ringing, a car horn sounding in the street — with BP spiking every time as a result.

For nearly 20 years now, a University of Gothenburg research group has been investigating how this kind of micro-stress affects nerve signals to our muscles and the throughput (perfusion) of blood in their vessels (muscle vasculature). In half of the over 150 men included in the group's studies to date, the pattern of their reaction system leads to BP peaks, while for the other half the reactions taking place in their bodies do not bring about any change in BP. For the study, 20 men aged 19-45

were examined. The experiment involved triggering a response in the nervous system with unexpected electric shocks that emulate the sudden and/or stressful stimuli to which we are exposed daily. The researchers combined two measurement methods. In one, a traditional research technique called microneurography, very thin needle electrodes are used to probe the signalling in nerve fibres (specifically, mus-



cle sympathetic nerve activity, MSNA) directed to the vascular bed (blood vessels) of the muscles. The other was a modern brain-imaging technique known magnetoencephalography

For the first time, the researchers could link the increased susceptibility to micro-stress to a reflexlike signal in the brain. The brain area (the "rolandic area") that activated the signal-controlled several conscious brain functions. This finding opened the question of whether the BP peaks may be learned and could therefore also,

with training, be eliminated. "We see a surprisingly strong connection between the peripheral autonomic vascular reaction, which takes place subconsciously, and a reaction pattern - one that was already previously well known — in a part of the brain

where emotional impressions and motor skills undergo conscious interpretation. This raises questions about how independently the 'autonomic nervous system', as it's called, really works," said Mikael Elam, Professor of Clinical Neurophysiology at Sahlgrenska Academy, University of Gothen-

burg. The idea that the discovery might come to be used to prevent hypertension was not unrealistic, but much research was needed.

"If we can develop ways of boosting the signal-to-noise ratio, in the future, it may be possible to extract the relevant brain signals from a regular electroencephalogram [EEG], which is available in every Swedish hospital today. That would enable us, at an early stage, to identify people who react with BP spikes before they develop hypertension. Many other opportunities for preventive measures and research would then follow," said Justin Schneiderman, Senior Lecturer in experimental multimodal neuroimaging at Sahlgrenska Academy, University

of Gothenburg. Interestingly, our environment seemed to matter more than our genetic code when it came to which reaction pattern we developed, and thus whether we experience many daily BP spikes or not. An earlier study by the research group on identical twins showed that basic activity in the twins' blood-vessel-regulating autonomic nervous systems was very similar, while their stress-

triggered reactions diverged. "One may speculate that today, many people have learned to suppress the primitive fight-or-flight response, since it's not that relevant in modern society. It's an im-

pulse that prepares us for action, by reducing the vasoconstrictor nerve activity and thereby increase blood flow in the muscles. In terms of long-term health con-sequences, it might be beneficial to preserve the old flight-or-fight impulse in response to sudden stressors," Elam pondered. The research group hoped to be able to facilitate studies at the

population level, monitoring large groups of people over a long period. This would enable investigation of, first, whether individuals with reaction patterns that cause many peaks in blood pressure during the day are indeed at increased risk of developing hypertension later in life and, second, whether influencing this reaction pattern is feasible.

Quality Of Antibodies Improves For Months After Covid-19 Vaccination: Study

Antibodies produced by immune cells become steadily more formidable and precisely targeted against the SARS-CoV-2 virus for at least six months after Covid-19 vaccination, according to a study.

The researchers at Washington University School of Medicine in the US assessed the antibody response to the Pfizer-BioNTech vaccine in

detail in people. The findings, published on Tuesday in the journal Nature, suggest that declining antibody levels in the months after vaccination primarily represent a shift to a sustainable immune response.

The researchers also noted that even quite low levels of antibodies would continue to provide some protection against disease, as long as the virus does not change. "If the virus did not change,

most people who got two doses of this vaccine would be in very good shape." said senior study author Ali Ellebedy, an associate professor at Washington Univer-

sity. "The antibody response we saw is exactly what we would expect from a robust immune response. We never thought that six months following that second injection, many people would still be actively improving the quality of their antibod-ies, Ellebedy said. The researchers collected

blood from 42 participants and lymph node samples from 15 participants before each person received their first dose of the Pfizer Covid-19 vaccine and at weeks three, four, five, seven, 15 and 29 afterwards.

They also obtained bone

marrow samples from 11 participants 29 and 40 weeks after the first vaccine dose.

Eight people provided all three kinds of samples, allowing the researchers to track the development of the antibody response over time within those individu-

The researchers found that B cells, a family of immune cells that produce antibodies, targeted against SARS-CoV-2 persisted in the germinal centres of all participants for months.

Six months after vaccination, the antibodies were noticeably better than they had been in the beginning,

In one set of experiments, the researchers found that only 20 per cent of early antibodies bound to a protein from the virus. Six months later, nearly 80 per cent of antibodies from the same individuals bound to the viral protein, they said.

"When you look at antibodies, quantity should not be

The more time B cells spend in germinal centers, the more potent their antibod-

ies get. Germinal centers had been thought to last only a few weeks, so finding these boot camps still training B cells in a majority of people so long after vaccination was a surprise, Ellebedy said.

'Give Us Citizenship or Deport Us': Kashmir's 'Stateless' Women Protest

Srinagar: The Pak-origin wives of erstwhile militants staged a protest demonstration on Monday at Press Colony, Srinagar demanding travel documents.

The protestors said if the government cannot provide them with travel documents, they should be given Citizenship. The women protestors were holding placards and were accompanied by their children.

Leading the contingent of protestors was MisbahJunaid. She is among the few hundred Pakistani women of Kashmiri origin who returned to Kashmir along with their spouses, young Kashmiris who had crossed the LoC for arms training but gave up the idea there.

Having returned to Kashmir under the 2010 surrender and rehabilitation policy she remains stateless as she sans citizenship documents.

Misbah and other women have continued to protest and press for their demands for travel documents and other identity papers but to no avail.



"If the government is not ready to provide us legal documents, they are free to deport us," said Misbah amid sloganeering.

"We met the Lieutenant Governor and submitted a memorandum as well but we received no response from the administration" she said.

SimranAhmad, a seventeen year old protestor said she has never been to her maternal home.

"In absence of travel documents I can't travel to my maternal home. I appeal the administration to allow us to go back so that we can meet our relatives". She said.

It is pertinent to mention that protesting women had addressed a press conference on 29th November, 2021 to press for their demands

If There Is Hell On Earth, It Is Here

RINAGAR - The devil himself could not have conceived of tortures more horrible. Security forces drenched a local imam of Rafiabad with kerosene, set him alight, and flung him half-dead into his home, with a dire warning of consequence! still more hide ous if the family let out even a chirp about the incident. As the cleric hovers between life and death in hospital, his relatives say police have refused to reg¬ister a case

Locals say the 35-year-old imam, Ghulam Hassan Kumar, of Shalakot, Rafiabad, was arrested by personnel of the 28th Rashtriva Rifles (RR) last Wednesday evening, i.e. the 14th of February, when he was on his way to the mosque. The RRpatrol which picked him up had accused him of signaling away some foreign mili¬tants, who they said, had been working near the place of wor¬ship.

Residents of the area and the imam's relatives and neighbours say that Kumar's captors had torn off flesh from his arms and legs during his eleven-day-long 'detention'.

He was flung into a blazing fire, and when he crawled out badly burnt, he was put through another ordeal: kero¬sene oil was poured on his chest, and set on fire again.

When he miraculously sur¬vived the torture, the RR major set him free on February 15. Dumping the imam near his home, he was warned neither to go to a hospital nor to inform anyone else. Ghulam Hassan had been l suffering his agony in silence, but seeing his condition deteriorate, some villagers and relatives mustered courage and shifted him to the Baramulla hospital. He is said to have sustained 90 per cent burns and doctors say his condition is critical. Relatives say they had tried to register an FIR but the police had refused to do so

upon the prevention and curability aspects of drug de-addiction so that youth would remain far away from the consumption of narcotic substances and simultaneously they are guided and rehabilitated under different selfemployment schemes. The DC emphasised for better co-

ordination among all the line departments, stakeholders and Drug law enforcement agencies to keep a check on drug trafficking and related issues and ensure prompt sharing of inputs within all enforcement units so that timely action is taken against the drug peddlers.

He further stressed on the need to make joint efforts to break the supply chain and demand for drugs in the district.

The DC said that District Administration Srinagar is launching "Mission Waapsi" aimed at full-fledged war against drug abuse. Rehabilitation of victims of Drug addiction shall be the key to provide them dignified livelihood through proper handholding and guidance under Government self-employment schemes.

The DC also directed the CEO and other concerned to ensure proper vigil in and around the schools to keep check on supply and use of drugs across the district. He was also asked to ensure effective implementation of COTPA Act around the educational institutions so that students do not resort to Tobacco based products.

SSP Srinagar Rakesh Balwal also spoke on the occasion and said that a dedicated anti-drug unit of Police is working to track the drug trafficking modules besides tracing their source. He also stressed upon the need for close coordination between the Civil Administration, Police and all other stakeholders to save the youth of the district from the menace of the drugs.

Earlier, HoD Department of Psychiatry/Incharge Drug De-addiction Centre, SMHS, Hospital Dr Yassir

shared his clinical experience in handling victims of substance abuse. Mr Shabbir of Rahat centre also gave valuable inputs to the forum. They also suggested several preventive measures to combat the drug menace and monitoring of Drug Trafficking. They said taking vigilant efforts to check drug trafficking will help in creating deterrence.

Meanwhile DC also sought cooperation from the family particularly from parents to overcome the menace among the youth which also leads to other social evils and crimes. He said parents have an important role to keep the youngsters away from the use of drugs and also the family support for the affected people could lead them towards normal life once again.

Ukraine Crisis

ith every passing day, the west and Russia are getting closer to confrontation over Ukraine. In an extraordinary development on Friday, US president Joe Biden said he was now "convinced" that Russia has decided to invade Ukraine. He added that the US believes Russian forces intend to attack Ukraine "in the coming week" or sooner and that an attack will target the Ukrainian capital of Kyiv. The US and the other western nations have already warned of putting Russia under severe economic sanctions should it proceed with the invasion. Vice President Kamala Harris who was in Munich, Germany, also warned of "swift, severe and united" consequences for Russia in the event of an invasion. The stalemate, however, continues. According to White House, Biden will hold a National Security Council meeting on Ukraine. On the other hand, in a positive development, France and Russia have agreed to defuse the Ukraine crisis and Putin and Biden are likely to meet. Whether this hectic diplomatic activity will succeed is anyone's guess. But one thing is Russia has thrown down the gauntlet at the west.

And this is not the first time Russia has done it. A few years ago, Russia's intervention in Crimea had brought back the geopolitics of cold war. Russia's increasing defiance of the west and the China's inexorable rise has confronted the US and the EU with a new existential crisis. The new and more powerful global enemies like Russia and China could help create a new geo-political narrative and also its fallout will have implications for the world as a whole.

In South Asia, India and Pakistan will also be hardpressed to grapple with the new geopolitical reality should the war break out. They will find themselves in a difficult position of choosing sides. More so for India which has drawn close to the US over the past two decades. Washington's priorities with India are no longer regional in their nature but their scope is the larger geopolitics. In recent years, the US-India engagement has also been about the remaking of the global power equation with India not not possible the proposition of the global power in its own right but also as a countervailing force to China, effectively the world's No 2. It goes without saying that India's 1.3 billion population with a value addition of a burgeoning middle class has become an ultimate attraction for the west.

Russia is the new entrant to this game. Having substantially recovered from a drastic power meltdown following the collapse of USSR in 1989, Russia has again thrown its hat in the ring. And it isn't bound by its old equations and associations with the countries of the region, including India. Russia is now getting closer to Beijing and even Islamabad, a prospect that hasn't been to the liking of New Delhi.

Here's hoping that diplomacy wins the day over Ukraine. The war, should it break out, could easily take on global proportions. And it will be a nightmarish scenario.

Gaming And Banning: On Ban On Online Games

et another legislative attempt to prohibit online gaming has failed under judicial scrutiny. The amendments brought to existing regulations on betting and gambling in Karnataka have been struck down by the State's High Court. Last year, the Madras High Court invalidated similar amendments that targeted online rummy and poker. What is common to both cases is that the legislature assumed a paternalistic role, arguably with the laudable aim of protecting the people, especially the youth, from the temptations of online gambling. However, the resulting provisions failed to make a distinction between games of skill and games of chance, and sought to bring under the proscription all games played online, regardless of the extent to which skill was required. Further, the Karnataka High Court has rejected a key submission that it could be upheld as a 'public order' law. It referred to "the menace of cyber games" of epic proportions, and the registration of about 28,000 cases by the police in the State in the last three years. The government did have a point when it said many have taken their own lives and families ruined as a result of gaming addiction and indebtedness. However, as the court has pointed out, if the objective was to curb the menace of gambling, the government should prohibit activities that amount to gambling as such, and not the games of skill. While enacting the extreme measure, it did not consider the feasibility of regulating wagering on games of skill.

While the idea of betting and gambling conjures up the image of a 'bucket shop' associated with dingy gaming-houses frequented by hustlers, there is an element of 'information, expression and entertainment' that has constitutional protection. And gaming platforms are also a legitimate business that enjoy the freedom of trade when used for online versions of games of skill. The court has drawn attention to the fact that what such bans do is to create "a wholly new category of medium-based regulation, when chance of medium per se does not alter the true nature and content of the games". In other words, what is targeted is not the gambling part but the 'online' part. Also, the amendments contradicted a general exemption in the original law to 'games of skill' by making all online gaming punishable even if they involved skill. It is clear that an absolute embargo on games of skill involving money or stakes could not have been upheld by the court, as the line between individual freedom, both to carry on the business and to participate in it as a consumer, and state action could not have been obliterated. All legislation that assumes that sections of society require the hand of the state to guide and support them have some populist appeal. And there is an addictive element to online gaming, but that does not mean there is no individual freedom and choice at all.

Is Indian Federalism Under Threat?

Despite All The Criticism That These Laws And Schemes Drew, It Appears That The Government Did Not Violate Indian Federalism. Why Else Would States Accept The Jurisdiction Of The Center In All These Matters?

ver since the current central government led by Narendra Modi came into power in 2014, there have been concerns that the government is sounding a death knell for federalism in India. Certain policies brought by this government have given rise to this concern. These concerns reached a crescendo recently when the Ministry of Home Affairs' extended the jurisdiction of BSF from 15 Kilometers to 50 Kilometers from the international border. This move brought a large area of border states of Punjab, Assam and West Bengal under center's jurisdiction and drew harsh criticism from the opposition parties. Before that, the GST regime brought by the Modi government was criticized for its assault on Indian federalism. Besides, the implementation of the "One nation, One ration card" scheme also drew criticism from different opposition ruled states because it went against the idea of federalism. Further, Narendra Modi is often seen advocating "One nation One election" and "One nation, one voters' list" under which his government has proposed to hold simultaneous elections across different levels using a single electoral list. Despite all the criticism that these laws and schemes drew, it appears that the government did not violate Indian federalism. Why else would states accept the jurisdiction of the center in all these matters?

Indian federalism is considered sui generis. At the time of constitution-making, there were three competing arguments on the location of poweranti-statists, Gandhi and his supporters, argued for a Village Republic while advocates of centralization, Ambedkar and Nehru, argued for a strong center and others who advocated considerable autonomy for the regional units. It is often claimed that a concentrated authority was preferred in an effort to prevent secession or "Balkanization of India". However, as Madhav Khosla argues, the "existence of a centralized state involved a turn to modernity" and "to distance power from local actors meant that power

could be exercised progressively." Ambedkar complemented this argument with several examples. He illustrated that the central legislation banning untouchability would find resistance in several regions

and it would remain unexecuted if the center does not have its force. Similarly, Ambedkar argued that laws concerning child marriage and labour legislation will remain unexecuted if the centre does not have enough authority. Hence, the founders of the Indian Constitution preferred a strong center in order to ensure compliance of regional units with the laws made by the parliament.

Even though there is formal partitioning of power between the center and regional units and both enjoy exclusive powers of legislation, there are certain features of a unitary state in the Indian Constitution, like- regional units have not been granted independent political identity, they can be territorially altered without their consent by the parliament, unequal representation of

states in Upper House, Rajya Sabha, and the existence of strong emergency provisions. Therefore, the framework of the Indian Constitution is not straightforwardly federal. K. C. Wheare refers to this framework as "quasi-federal".

Although the Indian Constitution is quasi-federal in its framework, the Seventh Schedule of the constitution specifies distribution of power and responsibilities between the state and the center. State legislatures enjoy exclusive jurisdiction over 61 subjects under the State List of the Seventh Schedule of the Constitution of India. Earlier there were 66 subjects under the State List but five subjects were transferred to the Concurrent List by the 42nd Amendment, 1976. Regarding the Concurrent List, both the Union and State legislature can legislate on subjects contained in the list but in case of a conflict between the state and union law on the same subject, Union law prevails over State law.

The concern right now is that a majority (more than half) of the states and the union territories are ruled by the BJP, which is also ruling at the center. This provides little resistance against the central government's attempts to usurn the rights of the states Therefore, concerns about the current government at the center trying to create a "unitary state" are genuine because the same party is in power at the center as well in the majority of the states. However, there is hope in the fact that Indian voters differentiate between state and national elections. Rahul Verma argues that the verdict in assembly polls may not indicate the possible results of the Lok Sabha polls or the vice-versa because voters keep different issues in consideration while voting for the assembly elections and the national elections. In the case of assembly elections, regional issues matter more to the voters while in the case of national elections, voters keep national issues in mind.

Facilitate Drug De-Addiction

recent study conducted by Srinagar based Institute of Mental Health and Neuroscience (IMHANS) in a Drug De-addiction centre in Srinagar, found that over two-third of patients in the study had started substance abuse in the age group of 11-20 years. The most common substances of abuse identified included nicotine (94.4%), medicinal opioids (65.7%), cannabis (63.6%), benzodiazepines (45.5%), other prescription medications (43.4%), alcohol (32.5%), inhalants (11.1%), and cocaine (7.5%). The study revealed that poly-substance abuse was found in 91.9% of the studied patients. Inhalant use was seen predominantly among adolescents (54.5%) whereas nicotine (50.2%), cannabis (49.2%), alcohol (51.1%), opioids (58.4%), and benzodiazepines (53.48%) were more predominant in the age group of 21 to 30 years. According to a survey conducted by

the Ministry of Social Justice and Empowerment (MoSJE) in February 2019, 600,000 people, i.e. 4.6 percent of the total population of Jammu and Kashmir use opioid drugs, 80 percent of the drug addicts in Kashmir use heroin and morphine.

The Kashmir disputes such as political turmoil, armed conflict, Militancy, violence, terrorism, psychological distress, unfavorable environmental conditions and rapid socio-economic problems like poor industrial and infrastructural development, massunemployment, corruption, poverty, underdevelopment etc. have leading a rising number of drug addicts in Kashmiri society.

The use of tobacco, charas, Ganga, cocaine, heroin, opiates cannabis, alcohol and inhalant substances etc. has been growing rapidly among the adolescents in Kashmir. The use of these illicit drugs posing a big threat to humanity,by deteriorating adolescentsmentally and physically, damaging family relations, spoiling potentiality, dreams, degrading the social and moral values and becoming a hindrance in shaping their career as well as progress and development of the societies

The measures of drug abuse are critical, because drug use, at its core, is a health issue. Unless we reduce demand for illicit drugs, we can never fully tackle cultivation, production or trafficking. Governments have a responsibility to counteract both drug trafficking and drug abuse, but communities can also make a major contribution. Families, schools, civil society and religious organizations can do their part to rid their communities of drugs.

Businesses can help provide legitimate livelihoods. The media can raise awareness about the dangers of narcotics. We can succeed if we reinforce our commitment to the basic principles of health and human rights, shared responsibility, a balanced approach to reducing supply and demand, and universal access to prevention, treatment and support. This will foster communities free of drug-related crime and violence, individuals free of drug dependence who can contribute to our common future and a safer world for

It is high time to save our generation from drug abuse and If we do not take concrete steps now, then after some years, the young generation of Kashmir will be destroyed. Police taking action against drug abuse is not enough. We as a society have to act responsibly.

WELLBEING: How Living Well Together Works For The Common Good

he World Health Organization (WHO) describes mental health as "a state of wellbeing in which an individual realises his or her own abilities, can cope with the normal stresses of life, can work productively and is able to make a contribution to his or her community"

In its definition, the WHO emphasises the importance of environment and community for mental health and wellbeing, and that they should be promoted and protected. But the fact remains that mental health and wellbeing are mostly seen as states of individuals.

A different view might start from a sense that wellbeing is social: people need social connections to thrive. But it also means recognising that social institutions and organisations systemically affect health and suffering. Institutional racism and sexism, for example, contribute to suffering in both direct and indirect ways.

Health and illness are at once deeply personal and affected by the social situation of the sufferer. In other words, depending on their circumstances or their place within the society, some people are distinctly at a disadvantage. Being poor, for example, puts people's health at risk in a multitude of ways.

My work explores the concept of wellbeing in different cultural settings across the world. In my latest research, I reviewed work by anthropologists who consider the importance of conviviality and care in the communities they study.

Community and conviviality

Conviviality refers to the art of living well together. Researchers see it as particularly important for understanding how people in certain small communities strive to live well when state institutions and other organisations are a relatively remote presence in their lives.

Many Amazonian peoples, for example, strive to

with the communal bathhouse offering a muchneeded space for socialising and reconnecting.

Living well with others requires skilful effort in modern cities, especially, perhaps, where neighbourhoods are made up of people of different backgrounds. It also entails figuring out how to live with other species - from animals and plants to even the microbes living in our gut.

Care makes us who we are

CONVIVIALITY AND CARE DRAW OUR attention to the fact that wellbeing is not only social, but deeply relational. It is not simply what an individual feels about their life, somehow enclosed within a body. It plays out in the relationship with one's surrounding environment: with materials, with tools and technologies, with human and non-human beings

live well by caring for others in their community, by sharing resources and cultivating particular emotional conditions such as tranquillity. Close and intimate bonds are created through sharing food; one becomes kin by eating together, or estranged by eating apart.

Until a few decades ago, when many Japanese houses did not have a bathroom, neighbourhood communal baths were abundant. Even now, bathing with friends or family members is not unusual,

In my own research with older Japanese people in the city of Osaka, I observed that although caring for ageing relatives is still a strong family value, many older people were worried about growing increasingly dependent and a burden on their children.

They were active in providing care themselves, and looking out for one other in all kinds of ways, from arranging a visit to the dentist to recommending a hairdresser. It became clear that vari-

ous forms of care worked in interconnected ways: looking after elders and children required looking after mothers, who were often the carers for both. Care, I concluded, is at its best in circulation, continually being "paid forward" between people in numerous ongoing relationships.

Conviviality and care draw our attention to the fact that wellbeing is not only social, but deeply relational. It is not simply what an individual feels about their life, somehow enclosed within a body. It plays out in the relationship with one's surrounding environment: with materials, with tools and technologies, with human and non-human beings.

The way we think about these relationships affects others and their wellbeing and health, which in turn reflects on us. Witnessing the suffering of others, for instance, or living in a deteriorating environment, is likely to affect us negatively.

It is not inconceivable that our current mental health crisis is intertwined with our witnessing of large-scale suffering and neglect of humans, nonhumans and the natural world. Treating mental health as internal, or as pertaining only to the individual, may be inadequate for addressing these kinds of issues.

We not I

How then to think about wellbeing in the context of environmental crisis and rising inequalities? We need to start treating wellbeing as a process of connecting with others – or even a form of "commons".

Commons refer to resources used collectively and shared, like water. Similarly, the emotional or "affective" resources (such as resilience, friendship or care) that promote wellbeing do not merely pertain to individuals, but emerge in relationships, spaces and communities. Unlike scarce resources such as trees or urban spaces, wellbeing and the qualities that underpin it are not finite. Like the care between generations of Japanese families, they thrive in circulation.

A good example is hope. Being faced with hopelessness can be trying, while surrounding ourselves with optimistic people might make us more hopeful. In this sense, affective states like optimism can be contagious. Who we surround ourselves with matters. Perhaps it's time to think of wellbeing as a commons that we must cultivate together: the more it thrives for others, the more it benefits us.

takes a decision on the matter everyone should accept it. On the issue of imple-


mentation of the Citizenship Amendment Act (CAA), Shah said there was no question of going back on it.

ICCR To Offer Online Courses On Indian Epics, Vedas, Art, Heritage; Portal To Be Launched Soon

NEW DELHI: Aiming to disseminate traditional Indian knowledge, including about its art, architecture, timeless epics and Vedas, among the world community, the Indian Council for Cultural Relations will soon start online courses, and a dedicated portal is likely to be launched on April 2, ICCR president Vinay Sahasrabuddhe said on Monday.

Addressing a press conference at Azad Bhawan here to share details about the Ministry of External Affairs' (MEA) plans to hold celebrations under the 'Azadi ka Amrit Mahotsav', he also said that a three-day crafts fair 'Coalescence', will be hosted in the city from February 23-25, wherein artists and craftspersons from 11 states will showcase traditional art forms.

The MEA has already hosted events like 'GenNext Democracy Programme' Network November 2021) and many more programmes are lined up as part of the 'Azadi ka Amrit Mahotsav' celebrations, to which delegates from various democratic countries have been invited, he said.

When asked by a reporter if Pakistan was an invitee, he replied, "As I said, only democratic countries have been invited".

On a question regarding several Afghan students who had received ICCR scholarships, wanting to come to India, Sahasrabuddhe said,"These are issues which are inter-disciplinary, involving MEA and the Ministry of Home Affairs. And, it is their job, whether to give or extend visas. Our job is limited that way to offering scholarships and facilitating their entry into India, and that we are are doing whenever they get permission.'

The situation in Afghanistan has changed since the Taliban takeover of the government last August, leaving the fate of many students in limbo.

The MEA has planned multiple celebrations in the coming days as part of the 'Azadi ka Amrit Mahotsav' celebrations. Due to COVID-19, the schedule was impacted, but by early April, the situation is expected to be better, he said.

During the ongoing celebrations to mark 75 years of India's Independence, "We are also going to start Universalisation of Traditional Indian Knowledge System or UTIKS, as part of which people living in foreign countries will be able to learn about traditional knowledge of our country through online courses, and appreciate our art, culture and epics like Mahabharata and Ramayana,' Sahasrabuddhe said.

When asked about the courses to be offered, Sahasrabuddhe, also a Rajya Sabha member, said, "This will be our own way of running an edX or a Coursera on traditional Indian knowledge.

'There will be short-term and long-term online courses, ranging from four hours to 40 hours, on everything under the sun about the Indian culture. From recipe for rosogullah to fundamentals of Warli paintings, Madhubani art, appreciating the art of Ajanta and Ellora caves, understanding the basics of Vedas, introduction to Ramayana and Mahabharta, life

of Babasaheb Ambedkar, among other subjects," he said.

The academic partner for this programme is Savitribai Phule Pune University, he added.

"Other institutions may join later, but to begin with, Savitribai Phule Pune University is our partner. This permanent course is open to all, and there is no bar on age or anything else. And, fee will be very nominal," Sahasrabuddhe said.

The ICCR president said a portal for UTIKS is ready and it is likely to be launched on April 2. Asked who will launch the portal, he said, "We have requested

our foreign minister for it." The portal will allow people across the world to register themselves online and enrol for these courses. One can complete

too, the Rajya Sabha member As part of the celebrations, the ICCR will also offer an 'Indian alumni i-card' to those foreign students who have learnt music or musical instruments from 'gurus' in India, and completed

their learning, he said. On the crafts mela, he said, this is perhaps for the first time in the history of ICCR that an event of such a nature been hosted by it, as "art and culture is essentially depicted in soft diplomacy through music and dance forms"

A senior official of ICCR said, Union Minister of State for External Affairs and Culture Meenakshi Lekhi is slated to inaugurate the event at Bikaner House. Several diplomats have been invited for the event.

The opening ceremony will be witnessed only by the diplomatic community and general visitors can visit the fair later, he said.

Craftspersons from 11 states will exhibit several forms of traditional art and craft forms like bamboo art, textiles, traditional and folk art, beauty aromatics and recycled products. On all three days, participating artisans in turn will give 45-60 minute talks with demonstrations of the skill or show videos to explain their creative processes to visitors, said the ICCR, the cultural wing of MEA.

The lecture demonstration will be on Gond art of Madhya Pradesh; miniature art from Rajasthan; bamboo craft from Delhi; Kalamkari art from Telangana; moonj grass baskets from Uttar Praesh; Warli art form from Maharashtra and natural dye-cotton from Gujarat, among others, it said.

The 'Craft Mela' is to highlight how India's craft practices can help balance the ecology of the planet while sustaining India's cultural heritage, local livelihoods and meeting the Millennium Development Goals, the ICCR president said.

The 'mela' has been curated by Jaya Jaitley of Dastkari Haat Samiti, New Delhi, the ICCR said.

Many private schools in the city with large enrolment have decided to hold physical classes for the students in two shifts to ensure strict adherence of the COVID-19 guidelines and Standard Operating Procedures.

Shortlisted Health Educators Allege Delay In Promotions

India Climb To Top In ICC T20 Rankings After Series Sweep Over WI

Rohit Sharma's men eased to a dies in the third and final T20 of the series on Sunday in Kolkata and in the process, clinched an emphatic 3-0 clean sweep.

The triumph helped India catapult England at the top of the T20 team rankings, with the side now matching the top rating of 269. India last attained the number one spot back in 2016, a reign that lasted a little over two months.

While England and India both have the same rating across 39 international matches in the current rankings period (269), India has a total of 10,484 points, 10 more than England's 10,474.

Wasim Akram Formally **Inducted Into PCB Hall** Of Fame

ormer cricket captain and fast **d**bowling icon Wasim Akram was formally inducted into the Pakistan Cricket Board's (PCB) Hall of Fame on Sunday.

West Indies batting legend Sir Vivian Richards inducted Akram by presenting him with a commemorative cap and plaque before the start of the Pakistan Super League (PSL) match between Karachi Kings and Quetta Gladiators in Lahore.

In a press release, the PCB noted that Akram had taken a total of 916 wickets and scored 6,615 runs during his international career from 1984 to 2003.

"Akram is one of the eight Pakistan stalwarts who are members of the PCB Hall of Fame. Others are Abdul Qadir, Fazal Mahmood, Hanif Mohammad, Imran Khan, Javed Miandad, Waqar Younis and Zaheer Abbas, who will be formally inducted into the prestigious group in the coming days," the press release said.

Commenting on the achievement, Akram said: "I feel privileged to have received this great [he] proved me right," he said. honour from Sir Vivian Richards, one of the most iconic figures in cricket, and at a venue that re-

mained my home ground during my playing career.'

He also appreciated the PCB for launching the initiative to "recognise and acknowledge the contributions of former cricketers". "It has been an honour to rep-

resent Pakistan over 18 years during which I played in 460 international matches. Every wicket and every run I scored in these matches was priceless," he said. "I want to thank all my fans

who have been my greatest strengths. Their support has been invaluable. I also want to thank my family and friends who stood beside me during this incredible journey," Akram said.

Meanwhile, Richards said that he felt "delighted" to have been given the opportunity to formally induct Akram into the PCB Hall of Fame.

"My first encounter with Akram was in 1985 in Australia, and in the twilight of my career, I was happy I would not be facing him much. I clearly remember telling my junior partner that he will cause a lot of problems for his generation of cricketers and

He added that Akram had been an "outstanding cricketer" and a "great ambassador" for the sport.
